Srinagar- Sixteen more people tested positive for the novel coronavirus in Kashmir on Wednesday, taking the number of the Covid-19 patients across Jammu and Kashmir Union Territory to 581, said officials.

"Sixteen new cases have been reported from Kashmir in the last 24 hours," the officials said, adding that equal number of patients have recovered and were discharged from various hospitals.

Among fresh cases, nine are from Anantnag, four from Budgam and one each from Srinagar, Baramulla and Kulgam districts

Govt Allows Conditional Movement Of Stranded People

NEW DELHI- Migrant workers, tourists, students and other people, who are stranded in different parts of the country, were on Wednesday allowed to move to their respective destinations with certain conditions.

In an order, Union Home Secretary Ajay Bhalla said buses shall be used for transport of such groups of stranded people and these vehicles will be sanitised and will have to follow safe social distancing norms in seating.

"Due to lockdown, migrant workers, pilgrims, tourists, students and other persons are stranded at different places. They would be allowed to move," he said in an order issued to all states and union territories.

But as the virus is spreading, many people are viewing each other with apprehension. "It's a basic human tendency to become overly cautious in times like this," says WasimMisgar, a research scholar from Pulwama. "But humanity should not lose its true meaning.

However, in Kashmir, where rumour-mongering is one of the biggest social problems, Covid-19 has created many stigmas in the society.

"The problem of rumour-mongering is adding to the ongoing troubles created by the existing health crisis," says Younus Khan, 28, a trader from Srinagar, who had to earlier gone into quarantine mode after one of his family members turned positive case.

"We Kashmiris exaggerate a lot and get hyper very quickly," Khan says. "In absence of authentic news and proper awareness, misinformation campaign is only taking us for a ride."

The long-drawn-out kill-switch on the highspeed internet, Khan believes, is clearly aggravating the current pandemic by fuelling rumours amid sluggish flow of the right news.

What's equally aiding this mindless campaign is a growing nonchalance of officials and reluctance of locals to talk and share facts.

While locals want to steer clear of any controversy in times of dreadful virus, the officials appear bent on imposing information embargo, apparently to keep bad press in check. Earlier, the same motive, many say, forced union territory movers and shakers to bar medics from reporting to media.

"Even as some babus are actively sharing their tweets on the situation, right and clear information is unforthcoming in Kashmir," says AtifDhar, 29, a banker from Sopore. "We're largely dependent on news coming from outside." But such news has its own side-effects.

Much of the misinformation and the current community confusion is being attributed to the national media's covid coverage.

"The corona pandemic has brought about the best in many, but also the worst in some," Dhar continues. "While the rightwing media made TableegiJamat members as corona villains, it conveniently ignored other big gatherings and human issues during the current crisis. Such a toxic TV coverage has changed the perspective of the people negatively."

Barring Tableegi factor, some perceptive barriers have cropped up in the society which was traditionally nown for community spirit and support.

"These rights under Article 19(1) (a) and (g) cannot be said to be curtailed by reduction in the speed of the internet, as has been alleged by the petitioner in the petition/application under reply," says the reply.

The PIL filed by the Foundation for Media Professionals had challenged the J&K government order of 26 March, restricting the internet speed to 2G in the Union territory.

The plea was moved on the grounds that such an order violates the right to equality before law, the freedom of speech and expression, the right to life and liberty, and the right of children to free and compulsory education, granted under Articles 14, 19, 21, and 21A of the Constitution.

In another plea, an association of more than 2,200 schools across Jammu and Kashmir, have challenged the government order as being violative of the fundamental right to education. especially since the lockdown for containing COVID-19 has led to home-bound virtual classes. The plea filed by the 'Private Schools Association J&K' stated that the "internet" is now a "medium of imparting education," especially after the nationwide COVID-19 lockdown was announced by Prime Minister Narendra Modi.

The J&K Government has stated in its reply that "current discourse of social media" suggests that "Pakistan is aiming to incite violence amongst college and University students" and that an increase in internet speed will lead to the "swift uploading and posting of provocative videos and other heavy data files.

"Many hash-tags are being used by Pakistani handles to glorify Pakistan Army and terror outfits/terrorists and portray them as "fighters" for Kashmir's "struggle". Shadow handles, believed to have been "inspired" by/or at the behest of Pakistan Army try to allure people from Kashmir and living outside the country, to organize violent protests and rallies at their respective places and also participate in social media campaigns to further their anti-India propaganda," says the J&K Government in its reply, as per the report published on BarandBench.com.

One of the other reasons stated for the restriction in the internet speed is "misuse of data services, applications like WhatsApp and Facebook for mobilizing crowds by anti-national elements", which the government believes has the potential to cause large scale violence, disturb public order and "indeed threaten the security of the country."

Further, the reply mentions that the COVID-19 pandemic has had "absolutely no impact whatsoever on chronic anti-national activities from across the border" and that "there has been a surge in terrorist incidents, post pandemic, most recent being on 05.04.2020, in Keran sector. Kupwara where 5 security personnel were martyred having successfully foiled infiltration bid along the Line of Control by 5 terrorists and killing them." The reply mentions that Fixed-line Internet connectivity with Mac-binding is available without any speed related restriction. "For any activity dependent on heavy network usage, the broadband and fibre internet connectivity is available throughout the UT of J&K. It is noteworthy that access to social media has been allowed and the white listing of the URLs has been done away with," the J&K Government reply reads.

Association, Junior Resident Doctors Association GMC Jammu and Doctors Association of Kashmir through Dr. Nisar-ul-Hassan, the court said no representation has been received from them. Monika Kohli, Amicus Curiae, submitted that she would contact the representatives of these associations and ascertain their stand on the examination being conducted by the Court. She also filed a comparison of the legislations enacted by the various states but sought more time to examine the matter in more detail.

"We would request Ms. Kohli to also examine the definition of healthcare personnel and the healthcare institutions as defined in the various legislations," the court said and posted the matter for further consideration on May 5.

Regarding removal of the lockdown, the court said it has not received any report "on this important issue.'

"We had called upon the Secretary, Health and Medical Education; Social Welfare Department; Director, Information and Member Secretary, JKSLSA to take appropriate action. Director Information was directed to place an action plan before us. This has not been done," the court said and ordered directions made by it be "positively complied with" before the next date of hearing.

The court closed its consideration regarding the internet. The direction followed perusal of status reports including one on April 15 filed by T. M. Shamshi, Assistant Solicitor General, stating that the internet facilities are fully functional in Ladakh.

Irshad Ahmad, Additional Secretary Home Department placed a copy of the 9 April order passed by the Supreme Court of India in Foundation for Media Professionals vs. Union Territory of I&K.

"We are informed that apart from this writ petition, two other writ petitions being Private Schools Association, J&K vs. Union Territory of J&K and SoayibQereshi v. Union Territory of J&K are pending consideration before the Supreme Court," the court said, adding, "In view of the matter pending before the Supreme Court of India, we close our consideration of this issue in this writ petition."

As regards the issue of stranded tourists, Divisional Commissioner Jammu SanjeevVerma in a report submitted that there are no stranded tourists in the districts.

So far as migrants and contract labourers, the Deputy Commissioners said that he was personally attending to the requirement and needs of these labourers who are being provided all the necessary assistance and food. He also confirmed that there was no reported distress or nutritional crisis.

Apart from the district administration, he said, efforts of the regional and district red-cross societies and volunteers are being utilised for handling grievance and distress promptly and efficaciously. Additionally, he said, that over the gradual opening of industrial and other establishments including brick kilns, that migrants and contract labourers have been gainfully engaged in productive activities. However, the Divisional Commissioner, Kashmir had not filed report on this issue and he been asked by the court to do it before the next date of hearing. "Civil Authorities of (J&) shall continue to ensure that there is no distress to any of these persons. "In view of the above, these two issues do not need to detain this court any further. So far as the consideration of these issues by this court is concerned, some are closed," the court said, adding, "In case any difficulty is faced, it shall be open to the DG Prisons to approach this court for appropriate directions." Face Masks

Few weeks ago, when a group of Kashmiri medical students returned from Bangladesh, they faced the wrath of their neighbours.

Fearing "potential corona carriers" at their doorsteps, they alerted the authorities and packed their "freaked out" neighbours to quarantine centres.

Although informing authorities about the travel history of the people coming from outside is a welcome gesture, it has also drawn some flak from a section of society, alleging that many people are becoming informers in guise of community whistleblowers.

"All this is being done to apply social distancing in letter and spirit," Dhar, the banker, says. "But then, social distancing does not mean cutting off a person from the society."

It's a mutual cooperation among people, which is the key element in the fight against Covid-19, says Dr. ShakeelSofi, a physician serving at the frontline today.

"Physical distancing should not stop various channels of communication with the Covid-19 infected patients, neither should it ostracise them," the medic says.

Have Right to Curb Internet Freedom..

I&K Govt order dated March 26 where the internet speed was restricted to only 2G. The lead petitioner in the matter is the Foundation for Media Professionals.

The government has informed the top court that not only is the Right to internet not a fundamental right, but that the freedom of speech and expression and the freedom to carry on any trade and profession through the internet can be curtailed.

"Right to access the internet is not a fundamental right and thus the type and breadth of access for exercising the right to freedom of speech and expression under Article 19(1)(a) and/or to carry on any trade or business under Article 19(1)(g) of the Constitution of India (CoI) through the medium of internet can be curtailed. It is submitted that the sovereignty and integrity of India, the security of the State, public order or incitement to an offence, would certainly warrant curtailing the freedom of speech and expression, under Article 19(2)," reads the J&K Government reply. Similarly, the government has added that the "right to carry on any trade or business can be restricted in the interest of the general public under Article 19(6) of our Constitution."

Violence against Healthcare Professionals, the court sought status report regarding The Epidemic Diseases (Amendment) Ordinance, 2020.

"The same is not on the record before us. 11. Let the status report in this regard be brought before us on the next date of hearing," the court said.

The court also directed Sharma to file before it the concerns and objections of the Ministry of Home Affairs to the Healthcare Service Personnel and Clinical Establishments (Prohibition of Violence and Damage to Property) Bill, 2019 ("Draft Bill") which had been proposed by the Ministry of Health and Family Welfare.

Amid Lockdown, J&K records 16 cases of rape, 64 incidents of molestation

Srinagar: The Jammu & Kashmir Government has informed the High Court that 16 cases of rape and 64 incidents of molestation were reported during the lockdown period in the Union Territory.

According to a report, submitted by the Social Welfare department,16 cases of rape, 64 cases of molestation and one case of eve teasing have been reported in Jammu and Kashmir during the lockdown period.

As many as 1314 calls have been received from the affected persons on the emergency number 181 from 24th March, 2020 to 24th April, 2020, out of which 65 are related to violence against women, the government submitted.

The remaining 956 calls were reported by migrant labourers, who were in distress on account of the lockdown, it further said. As per the government, Rs 10 lakh for each district of UT of J&K has been sanctioned out of SDRF fund for COVID-19 containment for victims of domestic violence for providing temporary accom-



modation, food clothing, medical care etc.

"Additionally, the department of Disaster Management, Relief, Rehabilitation and Reconstruction (DMRR) Government of J&K has issued directions to all the Deputy Commissioner for designating 10 beds in each District Quarantine Centre exclusively and accessible for victims of domestic violence in the J&K," the High Court order reveals.

The High Court has directed the government to consider notifying appropriate spaces so that women in difficulty have easy access to them. "Women in distress would not have easy access to the Anganwadi Work-

ers. Ease of access has to be a primary concern for notifying an authority, especially in the urban areas.

It may not be correct that women as a rule would be uncomfortable in making a complaint against the violence to male members of the society. It is essential for the Social Welfare Department to consider ease of access of the women in distress, as a basis for notifying the authority," a bench comprising Chief Justice Gita Mittal and Justice Rajnesh Oswal observed.

"So far as designation of informal safe spaces for women for reporting domestic violence/ abuse without alerting the

perpetrators is concerned, the Social Welfare Department has informed that it has notified Anganwadi Workers for the reason that women/complainants would not be comfortable in expressing their personal issues with the male members of the society.

We had cited the example of grocery stores and pharmacies in foreign countries being notified as such safe spaces for the reason that every family is accessing grocery stores and pharmacies even in the lock down period," it further observed.

The Court also directed the department of Social Welfare and member State Legal Services Authority examine the requirements and steps necessary to mitigate the complaints and difficulties of victims of elderly abuse; child violence; violence against disabled and transgenders in the UTs of Jammu and Kashmir as well as Ladakh.

"A report of measures in place; steps under way and those contemplated regarding them be placed before us before the next date of hearing," the Court directed-(KNO)

223 released from J&K prisons from **April 1 to 22: Prisons department**

Srinagar: The government order states. has informed the High Court that 223 persons were released from different prisons of Jammu & Kashmir from April 1 to 22. According to report submitted by DG Prisons V.K. Singh, 223 prisoners have been released from jails of Jammu and Kashmir.

"Mr. V. K. Singh has informed this court that between 1st April 2020 to 22nd April 2020, the High Powered Committee has released a total of 92 under trial prisoners; 11 persons who had been arrested under Sections 107, 109, 151 CrPC; 24 prisoners have been released on parole and 96 more prisoners have been released," the The Court has been informed that 15 prisoners are lodged in District Jail, Karnal and 2 in District Jail, Jhajjar. "Additionally, the report received from Director General of Prisons, Haryana regarding prisoners from Jammu and Kashmir who are lodged in Haryana has been placed be-

fore us. We are informed that 15 prisoners are lodged in District Jail, Karnal and 2 in District Jail, Jhajjar. Mr. Singh has informed that all detenues of Jammu and Kashmir lodged in Harvana are being screened by medical team twice a day; that the health status of all these detenues is thus mon-

itored daily and they have been found normal till 21st April 2020," it further states. The Court was informed that there are prisoners of J&K in six jails in UP.

After perusing the reports by jail authorities, the Court observed that "it would appear that the jail authorities are conscious of the responsibility regarding the health and safety of the residents of the Jammu and Kashmir and Ladakh who are lodged in prisons in other parts of India". "The DG Prisons shall continue to monitor their well -being and ensure that the health and safety is not compromised in any manner," the court directed—(KNO)

Selling meat for Rs 600/kg **Police arrest butcher in Srinagar**

Srinagar: Police arrested a butcher for selling meat at exorbitant rate in Batamaloo area of Srinagar city. Taking advantage of prevailing situation emerging out of Coronaviurs, vegetable sellers, vendors and butchers loot people at will while the lack of regulation has emboldened them. Almost every butcher is selling meat, on a rate of their own.

A police official told KNT that people com-

plained that a butcher identified as Waseem Ahmed Shigan son of Manzoor Ahmed Shigan, a resident of SD Colony is selling meat at Rs 600 per Kilogram.

A police team rushed to spot and found the complaints true. "The butcher was arrested and an FIR vide number 54/2020 under section 188, 34 Essential Commodities Act was registered against him," he said.



US government panel on religious freedom has called for action against India for its treatment of minorities, A for action against india for its treatment of inmontees, ranking it among the "countries of particular concern". This is the first time India has got such ranking after 2004, marking the drastic slide in religious tolerance in recent years. Though recommendations of the US Commission on International Religious Freedom (USCIRF), a bi-partisan group, are non-binding on the US government, the lower ranking for India amounts to a stark show of disapproval of the prevailing anti-Muslim atmosphere in the country, particularly the new divisive new citizenship law.

Significantly, the panel has called on the US to impose punitive measures, including visa bans on Indian officials believed responsible and grant funding to civil society groups that monitor hate speech. It has also highlighted the revocation of the autonomy of Kashmir in August last. The US, however, is un-likely to initiate any action against India given their close ties. US president Donald Trump visited India in February and addressed a massive gathering at a stadium in Gujarat. That time he refused to criticize India's new citizenship law that bars Muslim refugees from several neighbouring countries from becoming India's citizens while seeking to fast-track Indian citizenship of non-Muslims. Trump said the law was India's internal matter. He also refused to talk about the Delhi riots that broke out during his visit.

That said, the US religious panel's report dent's India's global image. New Delhi has thus slammed it as "biased and tendentious". It said the report was "misrepresentation" at "new levels". New Delhi, however, cannot wish away the panel's report. There has certainly been drastic downturn in religious freedom in the country over the past several years and it can be traced to increasing assertiveness on the political scene of the right-wing political groups, with ruling party not doing enough to reign them in. Though an agenda for growth has been the pivot of the Prime Minister Narendra Modi's broader political project, it hasn't stopped his party from purveying its ideology, sometimes in crudest terms possible And this ideology is a majoritarian vision of India where minorities would keep their place in the society at the pleasure of majority.

Unlike India's brand of secularism which has its own serious flaws, the majoritarianism sanctions a hierarchical community relationship, with minorities formally subservient to the majority. And this is what should be most troubling for the minorities in India, most specifically the Muslims, the hate for whom undergirds the new ruling politics. But will the PM Modi transcend this? So far other than some half-hearted statements he has shown no serious concern for the state of minorities in the country. Here's hoping that the PM pays more attention to their plight and ensures their security. Only he can make a real redeeming difference

Syrian and Afghan refugees have been compelled to breath in unlivable camps at the mercy of global donors! Rohingyas are floating on overcrowded boats in search of shelter and food! Kashmiris imprisoned in their own houses! Indian Muslims are being labelled as 'Corona Jihidist' and discriminated in hospitals. All these tragedies prove that virtues are rapidly diminishing from the world! Ways of opening up

n Monday, Prime Minister Narendra Modi held another video conference with state chief ministers to discuss the ongoing battle against the coronavirus, and to plan ahead. This, the fourth such interaction, was held amid growing signals of the government preparing for a gradual easing of the national lockdown as economic concerns begin to loom larger – with the prime minister himself noting that "we have to give importance to the economy as well as continue the fight against COVID-19". This signals a cautious shift in strategy. As the lockdown has progressed, with the disruption in economic activity intensifying, its toll becoming more visible, the stark debate of lives vs livelihoods is being steadily recast and reframed. Among several state governments too, as the fiscal strain is beginning to show, the mood seems to be shifting from unqualified support for a nationwide lockdown to a push towards a gradual and calibrated exit.

To be sure, as states are on different infection trajectories, each one will have to firm up separate plans for easing and exit. States with lesser number of infections, or with a better grip over the spread of the virus, are likely to press for easing more restrictions so as to allow economic activities to resume, at least in the green zones. Yet even the modalities of the exit from the lockdown in the green zones will have to be worked out carefully. One thing is clear: Both Centre and states must work together to figure out ways to allow economic activities to resume while minimising the health fallout – even as any such joint strategy will need to take into account, and make space for, the differences across states and the varied emphases of state governments. As the number of cases mounts during a meeting of state chief secretaries, the central government projected the number of infected in the country to reach 65,000 cases by May 15 - and the capacity of the healthcare system of the country comes under more strain, coordinated action at various levels of government will become more urgent to ensure continued expansion of the institutional capacity - setting up of containment wards, production of ventilators, ensuring adequacy of testing equipment.

During the course of the interaction on Monday, the prime minister also spoke of the need to usher in reforms that touch the lives of common citizens. While fiscal and monetary support will be needed to nurse the economy back to health, given the collapse in economic activities, the need to push through contentious but required factor market reforms that address the long-standing structural issues that plague the economy, cannot be overstated.

ducation means a lot in one's life as it facilitates learning, knowledge and skill. It completely changes ones outlook and personality and helps attain set goals. One thing that pinches the conscience of any concerned individual is the commercialisation of education. The education has now become a profitable business with the involvement of all type of traders in the field. Every year 4-5 schools are opened within the area of two km radius across India. Many newly opened schools boast of modern facilities and hi tech infrastructure to lure parents.

It seems very easy and smooth going process in the Kashmir Valley as if there is no criteria set by the government for opening a school. This is very much detrimental for the society in the long run. The mushroom growth should be checked because it can erode the quality education system.

Back in the 90s, education never pinched the pockets. Most of the time, parents never considered it a part of monthly expenditure, except when they had to pay a bulk amount during the beginning of a session or on purchase of uniform. However, the case is no longer the same now. Over the years, the schools have grown, the facilities have increased and so have the fee structure. Charging of exorbitant fees in private schools is a major cause of concern now. Steep hike in tuition fees along with additional costs such as transport charges, fee for extracurricular activities and sports are added costs and a burden on parents.

Regulating school fees is one of the most significant legal and administrative challenges policymakers in Kashmir face. Schools justify their fee hike as the costs of maintaining a fully functional private school with quality teaching and worldclass infrastructure are quite steep. In this context, balancing the autonomy of private schools and their public welfare function becomes a contentious issue.

Can Schools Arbitrarily Hike Fees? The constitutional basis for regulating the fees charged by private schools was considered by the Supreme Court in T.M.A. Pai Foundation v. State of Karnataka (2002). The Supreme Court held that "regulatory measures imposed on private schools must ensure the maintenance of

According to the CAG report, it is found that many private schools collect money from parents under false heads, while at the same time, teachers are being underpaid, and accounts misrepresented. The state should clearly articulate the objectives behind regulating fee. It must be acknowledged that schools are free to set their fee structure and the state can only verify whether the fee charged is reasonable and does not amount to profiteering.

There is a need for transparency in private school finances. For instance, we can add a requirement for extensive disclosure on each school's website giving all fees, staff qualifications, details of infrastructure, strengths and weaknesses for parent to know before selecting a school.

The measures such as regular government supervised audits, generating capacity in State-level Departments of Education, regular inspections, and stricter sanctions for fraudulent reporting could be considered.

A fee hike should be used for improving the quality of education and not for profiteering.


It is also crucial that a regulation strikes a balance between protecting the interests of students and parents, and preserving the autonomy of schools.

The efforts should continue and state must come up with at least a fee framework that can be implemented by both the government aided schools and the unaided private schools. That is the least they can do. Ironically there is no framework, which in turn leads the schools to decide their own fee structure over which the parents have absolutely no control.

This transparency will ensure an end to financial malpractices. And while governments should remain regulators, they need to remember that this is not a longterm solution. The problem of an acute mismatch between demand and supply of schools has happened because the government has not been able to fulfil its role of providing high quality education. And while regulation and efforts at transparency should continue – governments across the country need to pull up their socks and improve public schools. If high lative efforts have made an incomplete quality is available free of cost, why would assessment of the deeper problems with anyone pay exorbitant fees for the same? an 'influential' woman pilgrim bypassed high security vigil at Srinagar Airport and subsequently became the first Covid-19 positive case in Kashmir on March 16, it reminded many of a veiled Kashmiri woman returning from a plague-ridden Rawalpindi on a tonga in 1903, and becoming the epidemic trigger in the valley.

Then, as now, Kashmir witnessed an emergency response to tackle an emergency situation. The contact tracing, quarantine quarters, the fear of community transfer were as


When plague struck Kashmir in 1615, Emperor Jahangir was told that 3000 houses bearing three circles burnt and ended the epidemic.

But the emperor called it a strange affair in his memoirs.

"It certainly does not agree with the canons of reason," he wrote, "and my intellect cannot accept it."

na's Rajatarangini talks about Luta, a Sanskrit word for spider during the time of Jayapida (779-810 AD).

Luta-disease, writes Dr MA Stein in his translation of Kalhana's treatise, was "contagious and fatal".

But how did that spider become the epidemic epicenter is something which Rajatarangini doesn't explain beyond a point.

However, Kalhana's claim is being challenged by medical science today, as it believes that spider-bite is unlikely to cause epidemic disease like plague.

The Killer Grass

During the reign Mughal Emperor Jahangir, the outbreak of plague in 1615 had killed many Kashmiris.

One day, Jahangir writes in his Kashmir Memoirs, a dead body was thrown on grass.

"It chanced that a cow came and ate some of the grass," the emperor notes. "It died. And some dogs that had eaten its [cow's] flesh also all died."

Things had come to such a pass, Jahangir notes, that due to fear of death, fathers would not approach their children, and children would not go near their fathers.

In 1901, as plague spread, medical examination of all visitors before entering Kashmir was made mandatory by the British Resident in Srinagar.

As nearby Rawalpindi and Jammu had become epidemic hotbeds, the examination was being done to keep plague away from Kashmir Valley.

It kept the valley safe, until a veiled and influential woman came from plague-ridden Rawalpindi on a tonga along with her two servants on November 13, 1903, and passed through the check post. Five days later, one of her servants, Ghulam Mohammed, was found at the gate of State Hospital in Srinagar with symptoms suggesting plague. He was quickly quarantined in a tent away from city.

"He had been severely ill before coming from Uri and staying at the house of Subhan Bhat, a landlord relative of the woman, living at Kralpura," Dr. A. Mitra, a Bengali-man, the then Chief Medical Officer Kashmir writes in The Indian Medical Gazette.

At Bhat's place, the servant's health deteriorated and was brought to the hospital by another servant. A day after, Ghulam Mohammed became the first dead case of pneumonia plague in Kashmir. **Torched House**

Soon, a group of coolies were vaccinated and en-

gaged for disposal of dead and disinfection work. They buried Ghulam Mohammed's body in a 10 feet deep grave with 2 feet of carbonate of lime surrounding it. All of his articles were burnt.

Soon, Subhan Bhat's house was also burnt along with the grains kept in the compound of the house by various dealers.

The woman, her other servant, and all members of Bhat house, the pony-man who brought the patient to the hospital, and all suspected contacts were quarantined in another camp.

Soon, news came about death of several persons in two houses in Srinagar.

The first house belonged to the deceased cop, where two persons died. And the second one was the house of another cop who had visited the first house. Five people had died there.

Nobody was sure how did this community transfer began.

"There're two possible explanations here," Mitra writes. "Either the relatives of deceased policeman had exhumed his body and reburied



An Erring Cop

Four cops posted to guard the tent where the body of patient was kept were strictly instructed not to go inside. But one of them soon died of plague. Despite his family protest, his body was buried in a deep grave.

The dead cop in connivance with his healthcare worker brother, the investigation later revealed, had gone into the tent to steal things from the body. Some say he put his mouth on the finger of the

deceased to bring out a ring, biting it with his teeth. "If this story is correct," writes Mitra in his report, "[then] plague commenced in Kashmir from

Death on the Run

The dead cop's health worker brother who had escaped quarantine had somehow reached village Geru. He soon died there, but not before becoming a super-spreader of infection.

Among his victims were the village headman and his three sons. Mourners from many villages participated in their funeral and returned home carrying back infection.

'Till the news reached to me," Dr Mitra writes, "nobody survived in the village to tell the true story."

Altogether 1,116 children and their families from Turku participated in the study starting when the children were 7 months of age. The study was published in the journal Lancet Child and Adolescent Health. Half of the children were randomly assigned to a group that received dietary counselling promoting a hearthealthy diet according to the nutritional recommendations. Childhood Obesity: Can Malnutrition Make Children Obese?

The other half were assigned to the control group who received only the basic health education given at Finnish maternity and child health clinics and school health care. The regular counselling that started in infancy ended when the participants turned 20. According to Assistant Professor and vice-principal health markers is less common is the active counselling", sums Pahkala.

How Creativity Blooms In People Of Different Ages

There are two different life cycles of creativity, one that hits some people early in their career and another that more often strikes later in life, a study of the Nobel Prize winners in economics has found.

The early peak was found for laureates in their mid-20s and the later peak for those in their mid-50s, according to the study published in the journal De Economist. The study supports previous

work by the researchers that found similar patterns in the arts and other sciences.

"We believe what we found in this study isn't limited to economics, but could apply to creativity more generally," said Bruce Weinberg, a professor at The Ohio State University in the US.

"Many people believe that creativity is exclusively associated with youth, but it really depends on what kind of creativity you're talking about," Weinberg said in a statement. The study involving David Ga-




lenson, a professor at the University of Chicago in the US, found that the Nobel Prize winners who did their most groundbreaking work early in their career tended to be "conceptual" innovators.

These type of innovators "think outside the box," challenging conventional wisdom and tend to come up with new ideas suddenly.

Conceptual innovators tend to peak early in their careers, before they become immersed in the already accepted theories of the field, Weinberg said. However, there is another kind of creativi-

ty, he said, which is found among "experimental" innovators. These innovators accumulate knowledge through their careers and find ground-breaking ways to analyse, interpret and synthesise that information into new ways of understanding.



With Over 58,300 Deaths, US' COVID-19 Deaths Cross Country's Vietnam War Fatalities

The number of people infected by the coronavirus pandemic in the US crossed the one million-mark on Tuesday, while the fatalities spiked to over 58,300, exceeding the number of American soldiers who lost their lives in the two-decade-long Vietnam War.

According to the US National Archives, 58,220 American soldiers died in the Vietnam conflict, which began in 1955 and ended in 1975.

The US became the first country in the world to have more than one million cases of coronavirus. It accounts for nearly one-third of the 3.1 million cases globally.

With 58,355 deaths so far, the US also accounts for one-fourth of the over 213,000 global fatalities.

"We continue to pray for the victims as well as for those Americans who are grieving their lost ones and their loved ones. There's never been anything like this. We suffer with one heart but we will prevail. We are coming back, and we're coming back strong,"US President Donald Trump said at the White House during his remarks on the Paycheck Protection Programme.

"Now that our experts believe the worst

days of the pandemic are behind us, Americans are looking forward to the safe and rapid reopening of our country," he said.

"Throughout this ordeal, millions of hard-working Americans have been asked to really make tremendous, tremendous sacrifices. It is sacrifices like nobody thought would even be possible; nobody thought we would ever be talking about something like this," Trump said.

Meanwhile, several states have initiated the process to reopen their economies.

In California, Governor Gavin Newsom outlined the phased reopening of his state. "We are not going back to the way

things were until we get to immunity or a vaccine. We will base reopening plans on facts and data, not on ideology. Not what we want. Not what we hope," he told reporters.

US Says Would Recognise Israel Annexation

Washington - The United States on Monday said that it was ready to recognise Israel's annexation of much of the West Bank but asked the new unity government also to negotiate with the Palestinians.

Prime Minister Benjamin Netanyahu, who has reached a power-sharing deal to remain in office after three inconclusive elections, has vowed to press ahead with annexations that the Palestinians say will shut the door to a twostate solution.

A Middle East "vision" unveiled in January by US President Donald Trump gave a green light to annexations, but Netanyahu's coalition deal with centrist Benny Gantz said the cabinet would consult Washington before moving forward.

"As we have made consistently clear, we are prepared to recognise Israeli actions to extend Israeli sovereignty and the application of Israeli law to areas of the West Bank that the vision foresees as being part of the State of Israel," a State Department spokesperson said.

The step would be "in the context of the Government of Israel agreeing to negotiate with the Palestinians along the lines set forth in President Trump's Vision," she said.

Trump, whose evangelical Christian base is staunchly pro-Israel, has granted a wish-list to Netanyahu over the past three years.

His Middle East plan would let Israel annex Jewish settlements in the West Bank — which the rest of the world considers illegal — and exert sovereignty all the way to Jordan.

US GDP report to show a damaged economy sliding into recossion

Washington-The US economy began 2020 riding the crest of a record-long expansion with every expectation that its 11th year of growth would not be its last.

Then the economy screeched to a sudden halt. And now it's in free-fall.

On Wednesday, the government will offer a glimpse of how dark the picture has grown and how much worse it could get as the coronavirus pandemic inflicts



stores are shuttered. Home sales are falling. Households are slashing spending. Consumer confidence is sinking.

As the economy slides into what looks like a severe recession, some economists are holding out hope that a recovery will arrive quickly and robustly once the health crisis has been solved — what some call a V-shaped recovery.

Increasingly, though, analysts say

they think the economy will struggle to regain its momentum even after the viral outbreak has subsided.

Many Americans, they suggest, could remain too fearful to travel, shop at stores or visit restaurants or movie theaters anywhere near as much as they used to.

In addition, local and state officials may continue to limit, for health reasons, how many people may congregate in such places at any one time, thereby making it difficult for many businesses to survive. It's why some economists say the damage from the downturn could persist far longer than some may assume.

"The recession will be worse than the one we went through from 2007 to 2009," said Sung Won Sohn, economics and business professor at Loyola Marymount University in Los Angeles, referring to the downturn that came to be called the Great Recession because it was the worst slump since the Great Depression of the 1930s.

Iran Tells US Not To 'Plot' Against It Amid Gulf Tensions



TEHRAN - Iran's President Hassan Rouhani on Wednesday told the United States it "should not plot against the Iranian nation every day", amid fresh tensions between the arch foes in the Gulf.

Tehran and Washington have traded barbs over a spate of incidents in the past year involving their forces in the sensitive waters of the Gulf. Their latest high-seas confrontation came on April 15, when the United States said 11 Iranian boats harassed its navy ships in what it described as the international waters of the "Arabian Gulf".

US President Donald Trump then tweeted that he had ordered the US Navy to "shoot down and destroy any and all Iranian gunboats if they harass our ships at sea".

Iran's president on Wednesday replied that "the Americans should know that this gulf is called the Persian Gulf, not the New York Gulf or the Washington Gulf".

"They must understand the situation by that name and by the coastal nation that has protected this waterway for thousands of years," Rouhani said in a televised address during a cabinet meeting. "They should not plot against the Iranian nation every day.

"The soldiers of our armed forces in the guardians of the Revolution, the army, Basij (paramilitary organisation) and the police have always been and will be the guardians of the Persian Gulf."

Iran and the United States have been at loggerheads for decades. Tensions between them have escalated since 2018 when Trump unilaterally withdrew the US from a multinational accord that froze Iran's nuclear programme and reimposed crippling sanctions on its economy.

The arch enemies have appeared to come close to a direct military confrontation twice since June last year, when Iran shot down a US drone in the Gulf. On that occasion, Trump cancelled retaliatory air strikes at the last minute.

Trump also opted not to take any military action in January after Iran fired a barrage of missiles at US troops stationed in Iraq.

Iran launched the missiles after a US drone strike near Baghdad airport killed QasemSoleimani, the general who headed the Revolutionary Guards' foreign operations arm, the Quds Force.

Covid-19 could lead to 7 million unintended pregnancies: UN study

United Nations:Ongoing lockdowns and major disruptions to health services during the Covid-19 pandemic could leave 47 million women in low and middle-income countries unable to use modern contraceptives, leading to seven million unintended pregnancies in the coming months, according to data released by the UN Population Fund (UNFPA) and partners.

The agencies estimate that the number of women unable to access family planning or facing unintended pregnancies, genderbased violence and other harmful practices, could "skyrocket" by millions due to the crisis.

"This new data shows the catastrophic impact that Covid-19 could soon have on women and girls globally," UNFPA Executive Director Natalia Kanem said on Tuesday.

"The pandemic is deepening inequalities, and millions more women and girls now risk losing the ability to plan their families and protect their bodies and their health," Kanem said.

As a clear view of the toll of the Covid-19 pandemic is only beginning to take shape,



experts estimate that the human cost could be extraordinary.

The economic and physical disruptions caused by the disease could have vast consequences for the rights and health of women and girls, the new analysis by the UNFPA and partners noted.

Globally, around 450 million women across 114 low and middle-income countries use

contraceptives, the study said.

The pandemic is also expected to cause significant delays in programmes to end female genital mutilation and child marriage, resulting in an estimated two million more cases of FGM over the next decade than would otherwise have occurred.

These delayed programmes, on top of growing economic hardships globally, could result in an estimated 13 million more child marriages over 10 years.

There also will be 31 million additional cases of gender-based violence during the same period, with a further 15 million more cases expected for every three months the lockdowns continue.

These figures—produced in collaboration with partners Avenir Health, Johns Hopkins University (USA) and Victoria University (Australia)—are rough estimates. The analysis said while a great deal is still unknown about how the pandemic, and the response to it, will unfold around the world, the projections offer an alarming view of the future that could confront women and girls if efforts are not urgently made to secure their welfare and ensure their rights.

Boris Johnson, fiancée announce birth of 'healthy baby boy'

Symonds had taken to Twitter earlier this month to express her relief at Johnson's discharge from hospital with a series of clapping hands emoticons alongside a picture of a rainbow, which has emerged as the symbol of support for the country's NHS through the course of the pandemic fightback.
