2 Militants Killed In Overnight Encounter

SRINAGAR: Two senior army officers and a Sub-Inspector of police were among five security forces personnel killed in a gunfight with militants in Chanjimulla Handwara, in north Kashmir's Kupwara district, on Sunday. Two militants were also killed in the gunfight which broke out at around 3:45 p.m. on Saturday.

According to the reports after an initial fierce firefight, there was a lull following which five security mena Colonel, a Major and two soldiers of 21 Rashtriya Rifles besides a Sub Inspector of J&K Police's Special Operations Group -moved close to a cowshed near the house where the militants had taken refuge after escaping from nearby Rajwara forests on Friday afternoon. However, there was a standoff between them and militants amid inclement weather. The five men lost contact with colleagues on 'tour of duty'.

SRINAGAR: As the Jammu and Kashmir government increased its testing capacity, 35 fresh cases of COVID-19 were reported on Sunday taking the tally of total number of positive cases to 701. Government spokesman, Rohit Kansal in a tweet said that the Jammu and Kashmir has increased

the testing capacity, saying that over 2500 people were tested in a day, thereby the target of 2000 tests a day stands broken.

He said that the positive cases have crossed 700 mark 35 more people tested positive today, taking the toll of positive cases to 701, adding 648 among them belong to Kashmir division

"Finally J&K breaks the 2000 tests a day barrier. Over 2500 tests conducted in a day. New positives

All of them are from Bihar and they have now given up the hope of returning to their homes. "Earlier (when the lockdown began) we were very desperate to go back to our homes, but we couldn't get any transport," said Anup Kumar, a Biharilabourer.

"Now, we think it is all the same if we stay here or go home. The situation is same everywhere," he added. According to Kumar, there

those from elite para forces to the area in a bid to "rescue the men with whom contact was lost and to neutralise the militants." The operation, they said, was suspended for the night for "obvious reasons" amid inclement weather as it was raining heavily in the area.

At the first light on Sunday, the worst fears of the security establishment came true as all the five of their men were found dead. Army officers Col Ashutosh Sharma and Major Anuj Sood besides Naik Rajesh Kumar and Lance Naik Dinesh Singh and SOG Sub-Inspector Sageer Pathan alias Qazi were among the deceased, reports said.

An army officer confirmed the casualties and said that the bodies of two militants were also recovered. The officer said that a soldier namely Shinbe Mangesh sustained injury in his right leg and was hospitalised.

A senior police officer said that the "operation has been concluded" as bodies of the slain militants have also been recovered along with two weapons and other "warlike stores". He said that both the militants were foreigners and their group affiliation and identities were being ascertained.

"In this connection, a case under relevant sections of law has been registered and further investigations were taken up," the officer said.

Pertinently, a search operation was started by the army's 15 and 21RR besides 9 para commandoes and police in Rajwar and Mawar forest areas of Handwara on Friday afternoon amid reports that a group of militants was hiding there. The search team had also fired several warning shots during the cordon and search operation following which an encounter ensued. The militants later took shelter inside a residential house in nearby area and army and police cordoned off the village and sealed all possible entry and exit points to prevent the militants from escaping.

Officials from SKIMS said that out of 24 cases tested positive at SKIMS, six are in the age group of 3 and 14 years while as officials from GMC Srinagar said out of ten new positive patients, 2 are of age of 3 and 14 respectively.

Officials from Kupwara said all new 11 cases belong to Gonipora village and are contacts of earlier positive cases. They said that with new 11 cases total number of active cases in district have reached to 43.

Officials from Anantnag said that out of 10 tested positive on Sunday, 9 are females and one is male. "The ages of females are 3, 14,26, 30, 31,31,55,66 years while age of male is 33 years," they said, adding that total number of positive cases in district have reached to 109 including one death and one recovery.

Officials from Shopian said that out of 145 samples tested 04 were found positive who all belong to Hirpora village and total number of positive cases in district have reached to 81.

Officials from Pulwama said that a seven year-old granddaughter of a couple who were tested positive three days before was found positive on Sunday.

Officials from JVC Bemina said that 27 more patients were discharged from the hospital after their recovery and were advised to go for quarantine for 14 days.

Among 27, 19 belong to Bandipora, 7 to Baramulla and 1 from Budgam, they said, adding that so far 77 patients were discharged from the hospital after their recovery and 96 patients are undergoing treatment at the hospital.

Officials from the Jammu said that a new case is from Samba belonging to Saroor area and with new case total number of positive cases in district have reached to 07 including four recoveries.

Pertinently with new 35 cases, the total number of positive cases in Jammu and Kashmir has reached to 701 including 61 from Jammu and 640 from Kashmir division.

Out of 26,038 the number of samples tested negative stands at 25337 while as 701 have been tested positive, among them 406 are active and 287 persons have recovered and 8 persons have died.

All those who will enter the UT without prior permission will be compulsorily sent to institutional quarantine in Lakhanpur, Kathua for 21 days, the Chief Secretary emphasised.

Keeping in view the risk of transmission of the virus, it was decided that 100 per cent testing of all such people would be done to ensure their and others' safety.

All the Deputy Commissioners were asked to coordinate with the health department so that medical teams are deployed for the collection of samples, the spokesperson said.

Asserting that nodal officers have been appointed by the administration for ensuring smooth entry and movement of people, the chief secretary asked the divisional commissioners to ensure that proper computerised record of all the returnees is maintained and a system is evolved so that the entire exercise is carried out smoothly.

The chief secretary also reviewed quarantine facilities in the districts and directed the deputy commissioners to create additional quarantine facilities at the village level by utilising all available infrastructure and involving panchayat members and Anganwadi workers.

To arrive at an exact number of the students and migrant labour stranded in different parts of the country, the chief secretary said that data is being compiled and would be shared with the districts so that all necessary arrangements are made for their stay.

but, there are reports that most of them continue to live in groups in very small rooms in various places like in Shalteng and HMT Srinagar. This might prove dangerous for both the migrant labourers as well as the population considering what globally acclaimed health experts and organisationshave been emphasizing about social and physical distancing.

Thousands of skilled and unskilled labourers come to Kashmir every year from states like Bihar, UP and Punjab. Earlier, they used to be confined to Srinagar and other major towns only, but now they find work opportunities in villages as well and work as labourers, carpenters, masons and painters. So, they are found in good numbers in every town and most of the villages in Kashmir.

With a massive growth in Kashmir's lower middle class and middle class, large-scale construction of residential houses in Kashmir and the huge cultural changes in recent years in the region, local labour force has declined considerably within Kashmir valley. It is because of this reason that services of labourers from Bihar and other places are now even used in packaging of apples, Wazwan (a way of preparing different mutton dishes unique to Kashmir and the forte of people with specific skills in Kashmir only) wood carving, paddy plantation, paddy harvesting, and several other sectors. Construction work in Kashmir is largely dependent on migrant skilled and unskilled labourers in Kashmir and dependence on them in other sectors is only increasing with the social and economic changes taking place within this region.

Though not a lot of labourers had arrived in Kashmir when the lockdown began, official estimates say that around 22,000 migrant labourersare still stuck in Kashmir. Most of these labourers rent rooms in groups in order to make the monthly rent affordable for themselves. If seven-eight people stay together in a small room, it means each of them pays somewhere around 150 rupees every month as his share of the total monthly rent.

Accordingly, Director Agriculture, Kashmir filed an application before the Registrar, Geographical Registration Industry Chennai in December, 2019 under Class 30 under the Fourth Schedule as per Geographical Indications Rules 2002.

The requisite documents including the Statement of Case, Logo, Documentary Evidence, Specification and Description of G.I product, List of producers of Kashmir Saffron, Traditional Practices adopted and Method of production were submitted to the Registrar, Geographical Registration. On completion of the formalities, a Consultative Group was constituted by the Dv. Registrar Geographical Indications. Government of India. for ascertaining the correctness of the particulars furnished by the Agriculture department in G.I application.

Violent Upsurge Claims 11

RINAGAR - In stepped up attacks on political activists in Jammu and Kashmir, the head of the Pattan municipal committee, a block president of the Pradesh Con-gress- Committee and three policemen were shot dead on Tuesday, even as the security forces claims to have killed 6 militants on Monday night in foiling an infiltration-attempt in Poonch. Fifteen people, including two STF personnel, were injured in a grenade blast in Pulwama district today.

Gunmen, who police said were militants, opened fire on, the chairman of the Pattan Municipal Committee, Muhammad Ramzan Mian, in the town market at around 11:30 a.m., critically injuring him, his two security guards, a civilian, and a policeman who was standing nearby.

The injured were rushed to hospital, where Mian and his two personal security, guards, Zahoor Alunad and Riyaz Ahmad were declared brought dead. The police constable, Altaf Hussain, succumbed to his injuries later

A civilian Basheer Ahmad Bhat with whom Mian had been in conversation at the time of the attack, was also injured in the firing. He has been shifted to the SKIMS in a critical condition.

Mian had been inspecting developmental works in the market and had stopped for a chat at the shop of Pattan beopar mundal president when the attack took place, the CNS said.

According to one report, the attackers made off with two service rifles of Mian's security guards after the firing.

Security guards deployed with political workers have been put on alert following the killings.

In another incident, a group of unidentified gunmen intruded into the house or one Abdul Ahad Ganai at Shangran near Doom in Anantnag district in the wee hours today and shot dead the block president of

Pradesh Congress CommitteeJabbar Ahmad Khanday. A contractor by profession, Khandav died instantly and his gunmen fled the scene.

Gunmen also shot at and critically injured the village head of Zainapora, Ali

Muhammad Wani outside his house in Shopian area of Pulwama district this morning.

Another civilian Bashir Ahmad Dar was also injured in the firing and both were hospitalized.

The security forces shot dead six suspected militants as they were trying to sneak into Jammu and Kashmir through the Line of Control (LoC) in what is being called the biggest infiltration attempt this year

Media in Kashmir

his World Press Day, the media in Kashmir has little to cheer about. The day comes in the immediate wake of the FIRs against three journalists Gowhar Geelani, Masrat Zahra and Peerzada Ashiq, first two of whom were slapped with Unlawful Activities Prevention Act. Though the government has not arrested them it has not withdrawn the cases. However, the recent FIRs are not the only problem the press in Kashmir is facing.

Both, the local newspapers and the reporters working for the various national and international publications have faced their toughest time in discharging their professional duties over the past nine months. The security lockdown and the communication blockade that followed the revocation of Kashmir's special status has hit the Kashmir media hard. Journalists struggled for an internet connection to get their stories out. The newspapers have found it difficult to get the content to publish. It was days after nullification of Article 370 that the government put together 'Media Facilitation Centre', initially only with just four computers. Though communication gag has been eased since, with the media given access to internet, this hasn't made a large difference to the prevailing pathetic state of journalism in Kashmir. Logistically, the situation may have eased, in terms of freedom of expression it has progressively worsened as recent FIRs bear this out.

Overall the challenges for Kashmir media are formidable and structural. The media in Kashmir, comprising a robust English and vernacular press has a particularly unenviable job to do. The problems faced by it are both universal to the conflict situations and unique to the region. One of the major problems bedeviling the freedom of expression in Kashmir is the economic sustainability of the local newspapers. Being a place with only a fledgeling private sector and little industrial presence, government advertising is a predominant source of revenue for the newspapers. This gives government enormous power to influence news agenda. This renders the local press prone to the pulls and pressures from the administration and various other interests in the region. Until August last, however, the local media had managed to skirt such pressures and done a largely excellent job of covering the prevailing extraordinary situation.

But the situation has now become extremely difficult and one can only hope that the things become easier in the weeks and months to come. Much will depend on how government seeks to pursue the cases against journalists it has booked in recent times. Withdrawal of the cases will certainly be a victory of freedom of expression, in turn also for the government. For a journalist to report on the ongoing situation is his profession. Government can have questions about the accuracy of the reports and hold the journalist responsible for any lacunae thereof. This can't be held against the professional. Government, therefore, needs to revisit its current approach to journalists and journalism.

By and large, only those students who can afford posh 'private coaching' advance through the entrance tests to the popular engineering and medical colleges.

When the whole world is trying to impart education through online mediums India is lagging way behind in this race. It is the time when India should try investing in the educational sector & promote online education which will eventually help masses of students. Diversity of online study material in the form of videos and texts will encourage students to adopt online education platforms & online courses at UG or PG level are much more affordable than traditional programs. The pace at which the economic shockwaves from the plague has hit developing countries is dramatic. Self-Isolated

t is almost two decades after liberalisation, when private enterprise took the initiative from state enterprises. In that time, privately-owned and for-profit hospitals took the burden of disease over from a moribund system of publicly-funded hospitals. But the Rs 2.4 lakh crore private health care sector is faltering in the face of a public health crisis, whose burden is being borne by government hospitals, their doctors and nurses. Private enterprise owns almost three out of every four hospital beds in India, and almost eight out of 10 ventilators, but they are handling less that 10 per cent of those critically ill with novel coronavirus. States like Bihar, where private capital owns about twice as many beds as government hospitals, have seen the private sector in complete rout. The reluctance to engage is so great that they have been turning away coronavirus patients and other patients in need of aid. In Delhi and Maharashtra, the state government has had to issue orders so that they do not turn any more away.

As a series of reports in this newspaper showed, numerous factors have been at play in this failure — pay cuts, employee reluctance, the fear of sealing, the future consequences to brand value of hospitals identified with the pandemic, the lack of established protocols and protective gear, and bureaucratic instructions, like those issued in Telangana, to refer viral patients to government facilities. Underlying all this is the economic reality of falling revenues and footfalls, accompanied by new expenses and risk. While the central and state governments should offer to underwrite the risk, the fact remains that a sector which has benefited hugely from government concessions and encouragements, and which has tried to take over healthcare in India, has abdicated its public responsibility and remains isolated from the national effort.

The pandemic offers an opportunity to policymakers to revalue the virtues of public versus private healthcare, and those of free facilities versus insurance-backed care. But both must continue to exist and the present system, however flawed, must carry the nation through the crisis. To retain its perceived value, it is imperative for the private sector to do its public duty now, and be seen to be doing so. In a crisis in which every citizen is pulling together according to ability, financial excuses for withdrawing appear to be pusillanimous and morally wrong. In their long-term interest, abstaining private hospitals must reconsider this divestment from the national effort. *Indian Express*

Watching Shikara In Kashmir

- the expulsion of Kashmiri Pandits from the Valley in 1990 – has strongly resonated with people. It has played to an audience long weaned on Pandit story, now a staple in the national political discourse. More so, over the past several years, due largely to its politicization by the BJP and also to its increasing use to counter the Azadi narrative in Kashmir.

Shikara is thus seen as a welcome Bollywood recognition of the Pandit tragedy and an ode to the community's resilience on the 30th anniversary of the exodus. Criticism, if any, has generally been about the movie not being explicit enough about the atrocities perpetrated on community in the Valley forcing them to flee.

hat is it like watching Shikara in Kashmir? It certainly is not the same as watching the movie outside the Valley where its subject

But in Kashmir, on the other hand, Shikara has become contentious for its politics and the portrayal of the events that led to the exodus. Being without cinemas and high-speed internet, Kashmir isn't the place where you can see new movies. Only fewer people have been able to watch Shikara by downloading its cinema print at selective facilities for broadband internet. But the media buzz around the movie which has largely framed the Pandit migration as the organized expulsion of the community by Kashmir's Muslim majority has offended people. What has riled them even more is that Shikara is seen to faithfully reproduce the Pandit account of the exodus, passing over the Muslim side of the story.

Holding Kashmiri Muslims responsible for Pandit expulsion is like blaming the victims of a tsunami for those affected by a storm.

Kashmiri Muslims have an alternative narrative on the exodus, which disputes the version of Pandits and some of the terms used by them to describe their expulsion like 'genocide', 'holocaust' and for that matter even 'exodus'. Kashmiri Muslims never tire of quoting the official Pandit casualty figure of 209 spanning the period from 1989 to 1994. Ever since, according to figures quoted by a former J&K minister Raman Bhalla in the then state Assembly in 2010, no Kashmiri Pandit has lost his life in the ongoing conflict in the region. Similarly, as for exodus, Kashmiri Muslim hate to be accused of forcing out Pandits, arguing the revolt in the nineties wasn't a communal riot between the two communities which could have created conditions for Pandit exodus but a struggle against New Delhi's rule over J&K as it has been ever since.

Both narratives reflect only a part of the truth. Or highlight only the convenient parts of it. And over the years the two accounts have become so sacrosanct that one can only them challenge them at one's risk. But it is also very important that it is done. It is true that many Pandits were killed by the militants for being alleged informers of the security agencies but so were Muslims and in much more numbers. If we go only by the official number of the killings in Kashmir, around 42000 people have lost their lives in past thirty years – unofficial figure routinely quoted by media is twice this number- among them 14,038 civilians, almost all of them Muslims. And they have died in cross-firings, grenade attacks, massacres and custody killings by se-

curity forces and of course a significant number was killed by militants for being alleged informers.

It is also true that the mosque loud-speakers crackled with slogans through the nights as rightly shown by Shikara. But these slogans were meant to be a part of the protest against New Delhi as their meaning would amply demonstrate. People chanted slogans like 'Hum Kya Chahte, Azadi (We want freedom)' and Ae Zalimo, Ae Jabiro, Kashmir Hamara Chor Do (O, oppressors, leave our Kashmir)'. The oppressors here meant New Delhi and its security agencies in J&K. The slogan is still chanted in Kashmir.

From the outbreak of the armed separatist campaign in the middle of 1989 until January 19, 1990, the day now observed as the exodus anniversary by Pandits, there was no communal riot in the Kashmir Valley. In fact, there has rarely been any in the Valley in the decades preceding 1990. Fewer that have been were localized and limited in scale.

But yes, there was every reason for Pandits to be terrified of the evolving situation in the Valley. As the 1990 rung in a new decade, Kashmir was sinking into a deeper turmoil with every passing day. More and more youth were taking up arms against New Delhi and more and more protesters were hitting the roads, which often continued through the night. And here was a community caught unenviably between the expectations of a majority community seeking Azadi and its own allegiance to New Delhi. This severely tested Pandits' efforts to negotiate the divide and after a point they gave up the effort. Random killings of the members of the community only further accelerated this end of the road feeling. They couldn't support the demand for an independent Kashmir or its accession to Pakistan but they were nevertheless dying alongside Muslims as part of the ongoing struggle.

It was this dynamic that precipitated the Pandit exodus than an organized Muslim campaign against the community as is being projected. That said, the Pandit exodus remains a darkest chapter in Kashmir's troubled history of the past three decades. The community's suffering has been enormous. What is more, the community is beset by a real prospect of an ethnic extinction.

But tell it to Kashmiri Muslims, they will readily acknowledge the Pandit suffering, albeit they remain contemptuous of the blame for the community's exodus, and occasionally charge the then J&K Governor Jagmohan for encouraging the community to leave. They say they are victims of a far bigger and an ongoing tragedy, pointing also to the current siege in the Valley. Some contend that both Kashmiri Muslims and Kashmiri Pandits are victims of the lingering conflict over Kashmir. Or as a journalist friend of mine remarked holding Kashmiri Muslims responsible for Pandit expulsion is like blaming the victims of a tsunami for those affected by a storm

J&K Internet Curbs Vs Press Freedom

t first reading, the recent judgment by the Supreme Court on the call by Anuradha Bhasin, the editor of Kashmir Times, who demanded the restoration of the internet in Jammu and Kashmir and inter alia of press freedom, appears to be, in part, an affirmation of the right to internet and media freedom.

The three-member bench laid down, in considerable detail, the approach to guide the assessment of the proportionality of governmental action while imposing restrictions on constitutionally guaranteed fundamental rights, such as the freedom of speech and expression, on grounds of national security.

Yet, in our view, the court stopped short of making it a ringing (and stinging) ruling by giving the government a window to review. The Centre then went on to reassert its view that the time was not ripe for such openness. In addition, the judgment did not apply the very test of proportionality that it spoke of so eloquently to the blanket curbs imposed in Jammu and Kashmir since its constitutional status was changed in August 2019.

Indeed, the latter was the main prayer with which the petitioner had approached the court. Interestingly, the court did not admonish the administration for failing to produce all orders imposing blanket bans across Jammu and Kashmir despite repeated demands. Bhasin argued that the blackout was a "direct and grave violation of the people's right to know about the decisions that will impact them", denied public access to parliamentary debates and the prime ministerial address on the issues critical to the future of people in Kashmir, and was "wholly excessive and unconstitutional". She contended that the fact that the order placing the restrictions was not made available in the public domain, and had not been widely published and circulated, made it illegal and an abuse of State power.

India is a signatory to the International Covenant on Civil and Political Rights, which recognizes "right to know" as an inalienable human right. Bhasin argued that the communications shutdown disabled reporters from giving news inputs for print; the action of the State amounted to trampling over press freedom and is "arbitrary, unreasonable, and constitutes an abuse of State power". The blockade had caused financial and opportunity loss for the Kashmir Times could not be published.

people's access to the internet in Jammu and Kashmir. This is seen in the Kashmir Press Club's demand for immediate restoration of internet access to media houses and journalists without discrimination. Journalists are forced to give an undertaking that they will provide access to their professional files - violating the right to privacy — to the police and other government agencies and the latter seek it as a precondition for restoring internet access.

blackout that the local administration had imposed across Assam after protests broke out over the Citizenship (Amendment) Act. The high court found that the blackout was without sufficient cause. We regard this difference in approach as perhaps responsible for the seeming impunity with which the administration continues to control freedom of expression in Jammu and Kashmir.

Even more perplexing is the apex court's acceptance of the Centre's justification of terrorisminsurgency for its blanket ban on internet access. It is not as if militant groups suddenly emerged to pose a critical threat to national security around the time the legislation to downgrade the status of Jammu and Kashmir was introduced in Parliament. Militancy has ebbed and flowed since 1989. The disinclination of the court to make a connection between the change of status and the imposition of the communication blackout is surprising.

It also left unanswered the question of whether access to the internet itself was a constitutionally guaranteed fundamental right. The 2011 report of the United Nations special rapporteur on free speech calls upon member states to ensure people's access to internet at all times, including times of political or social unrest.

The special rapporteur found the use of blocking technologies frequently used by States to be violative of their obligation to guarantee the right to free speech and expression under the ICCPR to which India acceded in 1979. Therefore, it is duty-bound to ensure its implementation across the country, including Jammu and Kashmir.

Another crucial element missing in the arguments on the blanket ban on internet access was the very basis of the internet as an enabler of the freedom of the press. Peoples' right to know what governments do in their name is the foundation stone in a functional democracy, which is strengthened by the freedom of the press.

This question of law has been kept open for another judicial challenge of State actions restricting fundamental freedoms.

Although the Supreme Court's ruling falls short of several expectations, there remains some hope: its guidelines require the publication of all ban orders for the people's knowledge. There is a duty placed on the administration to conduct a weekly review of such bans so long as they are in force.

Civil society must use the Right to Information Act to demand details of all such decisionmaking processes.

Scientists Using Algae To Produce Low-Cost COVID-19 Test Kits

esearchers in Canada are using algae to rapidly develop low-cost serological test kits for COVID-19 that they say would determine if someone has been infected with the novel coronavirus.

Geneva: The World Health Organisation has praised China for its handling of the coronavirus pandemic, and said that other countries need to learn from Wuhan on how the epicentre of the virus was bringing the society back to normal, a day after US President Donald Trump likened the global health body to a public relations agency for Beijing.

Trump on Thursday said the WHO should be "ashamed" of itself, as he compared the UN's health organ to a public relations agency for China amidst the coronavirus pandemic after it originated in the central Chinese city of Wuhan.

The Trump administration has launched a probe into the role of the WHO on coronavirus, and has temporarily suspended the US' financial assistance to it.

Many countries, including Germany, Britain and Australia, are blaming China for the spread of coronavirus, that has killed over 2,35,000 people globally, including 64,000 Americans, and has infected 3.3 million.

Noting that there are zero COVID-19 cases in Wuhan, Maria van Kerkhove, the technical lead for the WHO's Health Emergencies Programme at a virtual press briefing in Geneva, aid, "that's very very welcome news to hear that there are no more severe cases, no more patients in Wuhan."

in December last year, said all COVID-19 cases were cleared from hospitals on Sunday.

The Hubei province and its capital Wuhan have not reported coronavirus cases for 28 consecutive days since April 4, the local health commission said on Saturday.

Amid criticism of under reporting of cases, Wuhan on April 17 revised its death toll by 50 per cent, taking the number of fatalities to 3,869. The death toll in China stood

Hundreds Of Rohingya Muslims Stuck At Sea With 'Zero Hope'

Bangkok: Somewhere in turquoise waters, perhaps where the Bay of Bengal meets the Andaman Sea, wooden boats filled with Rohingya refugees are listing, adrift now for

more than 10 weeks. They were prevented from docking in Malaysia, their preferred destination, and Bangladesh, their port of origin. As of this week, rights groups that had been trying to track the boats by satellite lost sight of them. Each boat - there were at least three - carried hundreds

of Rohingya Muslims desperate for sanctuary and at the mercy of human traffickers. "I feel like crying, realising

the situation of my brothers and sisters who are still floating in the deep sea," said Mohammad Yusuf, a chief imam in one of the refugee camps in Bangladesh, where about 1 million Rohingya have taken refuge after fleeing waves of persecution and violence in

neighbouring Myanmar. The boats had been caught in what the United Nations has called a dangerous "game of human Ping-Pong." The government Bangladeshi balked at accepting them, arguing that it has already taken in many Rohingya and borne a far greater share of the bur-

den in the refugee crisis than

any other nation. But with Malaysia refus-

ing to allow the boats to dock amid a national coronavirus lockdown, and a xenophobic mood sweeping the region, the boats had nowhere else to go. "Bangladesh has shoul-

dered very heavy responsibilities for the Rohingya refugees and must not be left alone to deal with these challenges,' said Steven Corliss, the UN refugee agency's representative in Bangladesh. "But turning desperate people away cannot be the answer.'

The deadly results of such a rejection became clear on April 15 when another Rohingya boat that had been prevented from docking in Malaysia was rescued by the Bangladeshi coast guard. Nearly 400 malnourished and dehydrated figures, many of them children, emerged from the hold, where they had been kept by human traffickers.

The UN refugee agency, which assessed the refugees' condition, did not quantify how many Rohingya perished on the journey, saying simply that "many died and were tossed overboard." A significant number had suffered physical abuse at the hands of the traffickers, the agency said.

The Rohingya who survived that journey are now in quarantine for the coronavirus at a temporary camp in Bangladesh.

Stateless and traumatised

The human traffickers who smuggle the Rohingya from internment camps in Myanmar, or refugee camps in Bangla desh, prey on some of the most vulnerable people on earth. Mostly stateless and traumatised by decades of persecution by the Myanmar military, many Rohingya are desperate to get to Malaysia, where they can find work as undocumented labourers. About 100,000 are registered with the UN refugee agency, and many more live in the margins of society with no paperwork at all.

A trade in Rohingya women and girls supplies wives to the Rohingya men, ensuring that an already disenfranchised community continues to suffer in another country.

Hundreds of Rohingya have died trying to get to Malaysia. Some were thrown overboard from overloaded boats when the journeys lengthened because countries refused them safe harbour. Others were buried in mass graves in the jungle when their families could not afford trafficking fees that suddenly increased during the trip, a common tactic by human smugglers to squeeze more money out of the trade.

Iran To Reopen Mosques Tomorrow As Lockdown Eases

Tehran: Iranian president Hassan Rouhani said mosques would reopen across large parts of the country on Monday after they were closed in early March amid the Middle East's deadliest novel coronavirus outbreak.

Rouhani said 132 counties. around one-third of the country's administrative divisions, would "reopen their mosques as of tomorrow"

Islamabad: Pakistan's coronavirus tally crossed 19,000 on Sunday after 989 new patients were diagnosed in the last 24 hours.

The Ministry of National Health Services said 23 patients died in this period, taking the total toll to 440. So far, 4,817 people have recovered from the deadly virus, the ministry said.

Out of the total 19,103 virus patients in the country, Punjab has reported 7,106 cases, Sindh 7,102, Khyber-Pakhtunkhwa 2,907, Balochistan 1,172, Islamabad 393, Gilgit-Baltistan 356 and Pakistan-occupied Kashmir 67 cases.

The authorities so far have conducted 203,025 tests, including 8,716 in the last 24 hours.

Prime Minister Imran Khan on Saturday night said he was not sure when the vaccine against Covid-19 will be available and expressed fears that "we may have to live with the coronavirus for six months or (even) a vear"

Khan said the war against the pandemic can be won by wisdom and not by using force to shut down the masses.

London: The United Kingdom's COVID-19 death toll rose by 621 to 28,131 as of May 1, just short of Italy which has so far had the world's second most deadly outbreak of the disease after the United States.

As Britain shadows Italy for the grim status of being the worst hit country in Europe, Prime Minister Boris Johnson is facing criticism from opposition parties who say his government stumbled in the early stages of the outbreak. Housing minister Robert

Indian-American physician launches study to find if prayers could heal Covid patients

ansas City: An Indian-American physician in Kansas City has begun a study to find if something called remote intercessory prayer might initiate God to heal those infected with the coronavirus.

Dhanunjaya Lakkireddy launched the four-month prayer study on Friday, which involves 1,000 coronavirus patients who are in intensive care.

In the study, none of the patients' prescribed standard care will be changed. They will be divided in two groups of 500 each and prayers will be offered for one of the groups. Also, neither group will be informed about the prayers.

The four-month study will investigate "the role of remote intercessory multi-denominational prayer on clinical outcomes in CO-VID-19 patients," according to a de-



scription provided to the National Institutes of Health.

Half of the patients, randomly chosen, will receive a "universal" prayer offered in five denominational forms -- Christianity, Hinduism. Islam. Judaism. and Buddhism - while the other patients will constitute the control group.

All the patients will receive the standard of care prescribed by their medical providers and Lakkireddy has assembled a steering committee of medical professionals to oversee the study.

that power of prayer and divine intervention change the outcomes in a concerted fashion? That was our question." he said.

The investigators will assess how long the patients remain on ventilators, how many suffer from organ failure, how quickly they are released from intensive care and how many die, Lakkireddy said.

He describes himself as "born into Hinduism," but said he also attended a Catholic school and had spent time in synagogues, Buddhist monasteries, and mosques.

The physician said he cannot explain how people praying remotely for someone they don't know (or a group of people,) could actually make a difference in their health outcomes, and acknowledged that some of his medical colleagues have had "a mixed reaction" to his study proposal.

Misery Of Migrants: 14 Labourers 'Rescued' From Concrete Mixture Truck

BHOPAL: The 'reverse migration' triggered by coronavirus pandemic has unfolded many a tragic tale involving migrant workers of Madhva Pradesh.

Traffic cops manning the Indore-Ujjain highway at Panth Piplani on Saturday could not believe their eyes when they spotted 14 labourers being carried inside a concrete mixture making machine to their native place of Lucknow from Pune in Maharashtra to beat the lockdown provisions.

"The movement of the vehicle carrying the machine sparked suspicion among us since no construction work was going on in any part of the country due to the nationwide lockdown.

We heard feeble noises com-

ing from the container when we went closer to it. Later, we found 14 labourers inside it", one of the traffic policemen who rescued the labourers said.

Just a couple of days ago, a 46-yearold man, a resident of Maharajganj district in Uttar Pradesh collapsed at Bijasan in Barwani district, while cycling around 400 km from Bhiwandi in Maharashtra along with a group of 11 people to return home.

The deceased identified as Tabrat Mansoori felt uneasy and collapsed, according to in-charge of Bhairavgarh police station V S Parihar. Mansoori died of cardiac arrest.

In the wee hours of April 19, three labourers including a woman were run over by a speeding truck when they were sleeping roadside at Un-

her-Mohanpura in Ujjain district. They were part of a 12-membergroup who had begun their journey to home in Mohanpura in Ujjain district from Jaisalmer in Rajasthan. The labourers were dropped at

the Madhya Pradesh border by a bus arranged by Rajasthan government to send them to their homes. The migrant workers were tired and slept on the roadside, leading

to the tragic incident. "The migrant labourers preferred to die in the arms of their family

members rather than die in an alien land. The fear psychosis created by all kinds of rumours involving coronavirus outbreak had prompted them to return their homes without bothering that it would cost

their livelihood", noted food rights
