

# **3 CRPF Personnel Killed In Militant Attack In Handwara**

Physically Challenged Teenager Dies In Cross Fire

SRINAGAR: Two days after five security personnel were killed in an encounter in Handwara, a militant strike left three CRPF personnel dead in Qaziabad area of the same town falling in the frontier Kupwara district.

According to reports, unidentified militants fired upon the personnel of CRPF 92 battalion at Wangam area around 5:32 pm Monday. The paramilitary troops, returned the fire triggering off an encounter.

In the exchange of fire, two CRPF men were killed and three others injured. One among them succumbed before he could be taken to the hospital for treatment, reports said.

When the gunfire ceased, body of a teenager was spotted around half a kilometre from the shootout site. He was identified as a 14-yearold boy Hazim Shafi Bhat, a student

of 7th standard, of Khipora village. "He along with other boys in the area had taken animals for grazing. While others fled, he could not as he was physically handicapped. He could not even properly talk and would occasion-

SRINAGR- The Jammu and Kashmir administration on Monday announced a night curfew from 7 pm to 7 am everyday during the third phase of the ongoing lockdown to curb the spread of COVID-19 in the Union Territory.

"Prohibitions (Curfew) on movement in ALL areas between 7 PM and 7 AM. No movement without

activities during the lockdown period from Monday to May 17. "The movement of individuals

for all non-essential activities between 7 pm and 7 am is barred. District Magistrates shall issue specific prohibitory orders in this regard under Section 144 of CrPC," the order said.

# India Protests Pak Court's Order **On Gilgit-Baltistan Polls**

NEW DELHI: India has conveyed its protest to Pakistan over an order by that country's Supreme Court allowing the conduct of general elections in Gilgit-Baltistan.

The Ministry of External Affairs said Pakistan was told that entire Jammu and Kashmir and Ladakh, including areas of Gilgit and Baltistan, are an integral part of India and that Islamabad should immediately vacate the areas under its "illegal occupation".

In a recent order, the Pakistan Supreme Court allowed the amendment to the Government of Gilgit-

Baltistan Order of 2018 to conduct the general elections in the region. "India demarched senior Pakistan diplomat and lodged a strong protest to Pakistan against Supreme Court of Pakistan order on the so-called 'Gilgit-Baltistan'," the MEA said in a statement. **PAGE 02**

When Trolley Became Bier: Post-Script Of Two Pregnant Kashmiri Women

SHERBAGH, ANANTNAG - Old towners stood dazed on their windows on 3 May 2020, as dirges sung by some passing women on street shattered the plagued silence of their strife-battered neighbourhood. Held hostage in homes by pandemic, the weary residents saw a trolley being pushed by a howling family, heading home as pallbearers.

The mourners were carrying their dead daughter, Shakeela Akhtar of Salai Panzmulla area of Anantnag, along with the unborn child in her womb. She was 30.

As dawn rose on Sunday, she developed a minor complication in the labour room in the sub-district hospital (SDH) Seer, and was shifted to the Maternity and Childcare Hospital (MCCH), Sherbagh.

Shekeela's inconsolable cousin blamed doctors for delaying her emergency treatment. "By the time she was shifted to MCHH, she was declared brought dead,' her cousin said.

And with that, what was supposed to be a merrymaking occasion became a mourning event.

The devastated family shortly stepped out on the streets with their daughter lying pale and lifeless on a became an instant rage

found almost half a kilometre from his residence.

The family termed reports dubbing him as militant as "very unfortunate." "He could not properly walk or talk. How can he be a militant," Bhat said

PRO CRPF Kashmir Assistant Commandant Junaid Khan said that two of his men were killed on the spot while one more died later on the way to the hospital.

A police officer said the teenager was killed in "cross-firing" between militants and the security personnel

The officer identified the CRPF men killed in the attack as Constable Santosh Mishra, Constable Chandra Shekhar and Ashwani Kumar Yaday.

Soon after the attack, additional reinforcement of army, SOG and CRPF rushed to the spot and launched a massive search operation to trace out the militants.

The CRPF killings came two days after five security personnel including, an army colonel, a major and two soldiers, along with a SOG sub-inspector, were killed in one of the deadliest operations for the security forces in the Valley.

The 12-hour operation took place in Handwara also in Kupwara district.

Earlier seven soldiers were killed in two separate encounters in North Kashmir this month.

Five soldiers were killed in a fierce encounter with militants on April 4 in Keran sector of Kupwara.

North Kashmir had by and large remained peaceful till last year when Kashmir was striped of its semi autonomous status and state downgraded into a union territory.

was seriously affected due to militant activities. Matters of policy should not be interfered and it must be left to the government, Venugopal said.

Solicitor General Tushar Mehta said that the restrictions were necessary and moreover, internet was working in the UT through land lines which is traceable and cannot be misused for anti-national activities.

Mobile phones are used and thrown away, he said, adding that the review committee will take the decision on the restoration of the 4G.

The law officer said initially there was complete lock down and later movement is being allowed to some extent and the decisions are being made at the ground level by persons concerned.

Ahmadi, appearing for one of the petitioners, referred to the orders passed by the UT administration on curbing of internet speed and said nothing substantial can be done by using 2G.

The senior lawyer said that doctors are unable to access information about COVID treatment in the UT, where there was 701 COVID cases as on date.

The right to access information is inherent under Article 21 and deprivation of fundamental rights has to be judged in the light of the fact that there was a pandemic and the rights of persons to access doctors and of children to access schools are restricted, he said.

The bench said there was no dispute with regard to the fact that 4G is very fast as compared to 2G, but the legal question was of balance.

There are health concerns and security concerns and the government was raising security concerns, the bench said.

It said that the authorities have said that the people can rely on landline broadband connections which are more than one lakh in the UT.

Ahmadi alleged that rights to livelihood and access to telemedicine have been affected and people have been denied the right to connect with their friends and family.

The Union Health Ministry had classified four districts of Jammu and Kashmir - Srinagar, Bandipora, Anantnag and Shopian — in red zone.

The Centre has allowed the administration of States and Union Territories (UTs) to classify additional districts as red or orange zones. However, States and UTs are not allowed to lower the zone classification of a district.

As per the order issued by the Jammu and Kashmir administration, entire Kashmir valley, which comprises ten districts has been declared as red zone.

In Jammu region, three districts of Jammu, Samba and Kathua are in red zone, it said.

While four districts of Jammu region - Udhampur, Reasi, Ramban and Rajouri - are in orange zone, Doda, Kishtwar and Poonch are in green zone.

The other guidelines issued by the chief secretary were more or less based on the MHA order issued on May 1 for the third phase of lockdown from May 4 to May 17.

As per the guidelines, the government has allowed movement of individuals in vehicles only for permitted activities, with a maximum of two passengers, besides the driver in fourwheelers, and with no pillion rider in case of two-wheelers.

Intra-district movement of individuals is also allowed in orange zone in individual vehicles with similar restriction of passengers in four and two-wheelers, on the basis of passes issued by the district authority. Taxi and cab aggregators are permitted to ply with one driver and two passengers only while e-commerce activities (home delivery etc) are permitted for essential services and goods," the order said,

"Private offices can operate with up to 33 percent strength as per requirement with remaining persons working from home, the order said.

In green zone districts, all activities which are permitted in orange zone, will be allowed, it said.

Other activities permitted in green zones included opening of all shops except those prohibited across the Union Territory. The activities which will remain prohibited in the entire UT include all domestic and international air travel of passengers, except for medical services, air ambulance, security purposes or for purposes permitted by the Ministry of Home Affairs.

All schools, colleges, universities, educational and training coaching institutions etc. will also remain closed across the UT till March 17 but online and distance learning will be permitted.

All passenger movement by trains, except for security purposes or for purposes permitted by the MHA will remain prohibited, the order said.

As per the government order, all cinema halls, shopping malls, gymnasiums, sports complexes, swimming polls, entertainment parks, theatres, bars, liquor shops, restaurants, auditoriums, assembly hails and similar places will remain shut.

The movement of individuals for all non-essential activities has been prohibited between 7 pm and 7 am.

The order said district magistrates will issue specific prohibitory orders under Section 144 of CrPC. However, persons above 65 years of age and those with co-morbidities, pregnant women and children below the age of 10 years will stay at home except for meeting essential requirements or for health purposes.

Hospitality services other than those used for housing health, police, Government officials, healthcare workers, stranded persons and quarantine facilities will remain closed. All social, political, sports, entertainment, academic, cultural, religious functions and other gatherings will remain prohibited in the entire UT. All religious places and place of worship

will be closed for public. Religious congregations are strictly prohibited, it said.

#### 2-Year-Old, ATM Guard And Six Kin Among New Cases...

District Magistrate Poonch Rahul Yadav said that the teenager was residing at Chandigarh and had gone to Srinagar to see his brother. All those who tested positive in Baramulla district are from two families, one comprising of seven members including 39-year-old ATM guard, his wife, two sons, daughter-in-law and two brothers from Sheerbagh Kanlibagh area while other is from Hardchillo Tanmarg-8-year-old girl, 50-year-old man and his 22-year-old son besides two males, one of them aged 32 and other 40 respectively, news agency GNS reported. Deputy Commissioner Baramulla Dr G N Itoo said that the ATM guard at Gulnarpark and his entire family was already under quarantine while contact tracing has been started. Regards four persons who tested positive in Budgam, sources said include 24-year-old man from Haproo Nagam while three others—boy (11), 24-year-old youth and 35-year-old man are from Charari Sherief, all contacts of previous patients. Shopian district's positive cases include 23-year-old and 21-year-old youth from Heerpora, one of the most affected areas in the southern Kashmir district. The Bandipora district reported two cases-one of them a 2-year-old boy and other a 32-year-old man from Naid Khai, both contacts of previous COVID-19 patients. The Jammu district also reported a fresh case from Satwari area, they said. With these cases, Bandipora has 130 positive cases followed by Srinagar and Anantnag have 109 cases each, Baramulla 103 , Shopian 83, Kupwara 66, Budgam 30, Ganderbal 14 (no active case), 11 Kulgam and Pulwama 9. Similarly, Jammu has 27 positive cases and all but one of them have recovered followed by Udhampur 20, Samba 7, Rajouri 4 while Kathua, Kishtwar, Ramban, and Reasi districts have one case each and except for Kishtwar all of them are 'active positive' Over 77,000 people have been kept under surveillance including those who are either in government established quarantine facilities or in home isolation

# Order On Gilgit-Baltistan... "It was clearly conveyed that the entire Union Territories of

Jammu and Kashmir and Ladakh, including the areas of Gilgit and Baltistan, are an integral part of India by virtue of its fully legal and irrevocable accession," it said.

The MEA said the government of Pakistan or its judiciary has no locus standi on territories "illegally and forcibly" occupied by it.

"India completely rejects such actions and continued attempts to bring material changes in Pakistan occupied areas of the Indian territory of Jammu and Kashmir," it said.

"Instead, Pakistan should immediately vacate all areas under its illegal occupation," it added.

The MEA said Pakistan's recent actions can neither hide the "illegal occupation" of parts of union territories of Jammu and Kashmir and Ladakh by it nor the "grave human rights violations, exploitation and denial of freedom" to the people residing in these areas for the past seven decades.

# Pak Rejects Indian Protest, Says GB Disputed Territory. efforts to bring "material change" to territories under its "il-

In a recent ruling, the Pakistan Supreme Court allowed the government to amend a 2018 administrative order to conduct general elections in the region. The Gilgit-Baltistan Order of 2018 provided for administrative changes, including authorising the Prime Minister of Pakistan to legislate on an array of subjects.

In Islamabad, the Foreign Office said in a statement that a senior Indian diplomat was summoned to convey Pakistan's rejection of India's baseless and fallacious contention against the apex court verdict on Gilgit-Baltistan.

It said Pakistan clearly conveyed that the Indian statement over Jammu and Kashmir as an 'integral part' of India" had no legal basis whatsoever".

"The entire state of Jammu and Kashmir is a 'disputed' territory and is recognised as such by the international community, the FO added.

#### **Army Chief Warns Pak Over Any Cross-Border Misadventure**

laid down their lives saving civilians from militants at a village in Handwara in north Kashmir on Saturday night.

"I would like to emphasise that Indian Army will give proportionate response to all acts of infringement of ceasefire and its (Pakistan's) support to miltiancy. The onus remains with Pakistan to bring peace in the region," the Chief of Army Staff said.

"Unless Pakistan gives up its policy of state sponsored terrorism, we will continue to respond appropriately and with precision," he added. After the Pulwama attack, India effected a doctrinal shift in its counter-terror policy by bombing a Jaishe-Mohammad facility deep inside Pakistan.

Gen Naravane said the recent infiltration attempts by Pakistan along the Line of Control in Jammu and Kashmir showed that Pakistan is not interested in battling the coronavirus pandemic and is still following its "own myopic and limited agenda of pushing militants inside India.

"Even in the hinterland, Pakistan backed militants are resorting to targeting innocent civilians with an aim to coerce them into following their Azadi narrative. Pakistan claims to be a friend of Kashmiris; I want to ask what sort of friend resorts to killing and spreads fear," he asked.

There have been frequent incidents of ceasefire violation by Pakistani side since India announced its decision to withdraw special status of Jammu and Kashmir and bifurcate the state into two Union Territories in August last year.

On implementation of recommendations of anti-terror watchdog FATF by Pakistan, Gen Naravane said the country has sought to "blindside" the international community by making superficial changes and amendments to its "non-existent" checks on terror financing and money laundering.

"It still continues to employ proxies to inflict terror and violence not only inside India but also in Afghanistan where it supports the Taliban militarily and financially," he said.

The shocking incident soon became a rallying cry for justice, with National Conference Member of Parliament from Anantnag Justice (retd) Hasnain Masoodi demanding time-bound inquiry and action warranted in light of the results of the inquiry.

"There should be no eye-wash or cover-up as due to willful negligence of the doctors, a mother and a vet to be born baby have lost their lives," CPI (M) leader Mohammad Yousuf Tarigami, said, demanding an FIR against the culprits without any delay.

The Congress party and Jammu and Kashmir Apni Party (JKAP) also demanded a time-bound and a fair probe into the incident.

Perils of Red Zone

The word "Red Zone" may hunt 35-year old Javid Ahmad Paddar throughout his life.

He vividly remembers how the word echoed in Anantnag's MCCH on April 25, where his wife delivered dead twins and, shortly died, leaving the family devastated.

Around 6AM that day, Paddar's 32-year old wife had developed a severe pain.

Padar's brother-in-law, Mohammad Ashraf, along with few women relatives rushed to the local gynecologist who used to treat her throughout pregnancy.

"He kept his phone off but we managed to reach to his house," Ashraf told Kashmir Observer.

"To our utter shock the doctor refused to treat her saying that she belongs to Red Zone."

Following this, the family somehow contacted the higherups directing the doctor to do the surgery at the Doroo hospital. "Even then the doctor stood adamant, and told us to take

the patient to MCCH, Sheerbagh," Ashraf recalled.

The family without wasting any more time rushed to MCCH, Sheerbagh. It was around 7:30 AM, Ashraf remembered.

"As soon as the hospital authorities came to know that we came from Red Zone, they create hue and cry. Everybody began cursing us," Ashraf recalled.

The family was locked-up into two separate rooms and the patient was shifted to general ward.

For over two hours, Ashraf said, no doctor, nurse or any paramedical staff came to see her.

"Even her blood pressure wasn't checked," he said. "We were treated as Acahoot (untouchable)."

Ashraf's wife was somehow allowed to be with the patient and quoting his wife, he said, the patient delivered the first child at 12:30 PM without any surgery, followed by another one. They died soon, along with their mother.

She left behind two daughters, aged 5 and 7.

"Following her death, my wife was forced to clean the bedsheet where my sister had delivered babies," Ashraf said.

When the doctors came to know that the deceased was from a Red Zone, they took her samples for tests. A day after, reports declared the deceased woman as Covid-19 positive.

By then, the hospital had already handed over the body to the family. A large number of people attended her funeral in Kharpoora, now a declared as "hotspot" in Anantnag.

Hospital administration now faces allegations of mismanagement in what are clear violations of WHO guidelines. An enquiry is already underway, Principal Government Med-

Although the Union territory is under a lockdown since the third week of March, the local administration had spruced up the city to welcome the LG's administration to Srinagar.

The lane markers on the city roads were given a fresh coat of paint, while the dust and mud accumulated for the past several months had been removed.

The Civil Secretariat and other Darbar Move offices function in Srinagar for six months of summer and in Jammu, for the remaining six months of the year.

The practice was started by Maharaja Gulab Singh 148 years ago to escape the extreme heat of Jammu during summers and biting cold of winters in Srinagar.

However, the practice has been continued by elected governments post-Independence in order to provide access to the people of both regions -- by turns -- to the seat of power in the state.

The state government spends crores of rupees to shift voluminous records between the two capital cities twice a year, besides paying a similar amount as allowance for the several thousand employees who shift base with the government.

There have been demands from various quarters to abolish the practice and set up permanent civil secretariats in Jammu and Srinagar cities so that people can get redressal to their problems round the year while saving substantial amount of the public exchequer.

He also referred to Pakistan removing names of "hardcore militants from the watch list", saying it proves that Islamabad still believes in exporting militancy as an instrument of state policy.

"The low priority given to the Pakistani citizens by its own government and the army is apparent by the exponential rise in cases and massive shortages of medical equipment and supplies in Pakistan," he said.

Gen Naravane said even during an India-initiated SAARC video conference, Pakistan's "narrow-mindedness" was on full display when it used the platform to complain about "non-existent" violations of human rights in Kashmir instead of finding ways to keep its citizens safe from the pandemic.

"The increased intensity of ceasefire violations by the Pakistan army, where its targets innocent civilians on the LoC, just shows that the country is a global risk and is not interested in providing relief to its own citizens," he said.

The Army Chief also said that Pakistan has been trying to mislead the international community on the situation in Kashmir. "It is unfortunate that while the world has got together to fight the COVID-19 pandemic, Pakistan has resorted to firing heavy calibre artillery and killing of innocent Kashmiris to garner international attention," he said.

# LG asks for prioritizing Wular dredging, resuming flood protection works

Srinagar: Lieutenant Governor, GC Murmu on Monday chaired a high level meeting of officers to review flood preparation and response mechanism in place in Kashmir division.

Speaking on the occasion, Lieutenant Governor stated that the Government shall have to be fully prepared to deal with any eventuality that may arise due to a flood like situation. He called upon the Irrigation & Flood Control department, Divisional Administration, Srinagar Municipal Corporation and SDRF to devise flood management and mitigation plans immediately. LG impressed on taking proactive measures to augment effective flood preparation and response

Stressing on foolproof flood preparedness, the LG directed concerned to take up all urgent works immediately to ensure that works are completed in time for prompt flood response. Instructions were also given on raising of embankments at all vulnerable spots, dredging of flood channels and stocking of sand bags and keep men and machinery in ready mode to deal with flood like situation emerging anywhere in the Valley.

LG urged for strengthening of flood monitoring system with installation of solar operated CCTVs, advanced flood alertness, installation of automatic rain recording and flood gauges at identified locations.

Directions were passed for strengthening of 24x7 flood control room with all arrangements for prompt relief and rescue operations. LG said that the capacity of Emergency Operations Centre (EOC) at Hari Niwas should be augmented, made fully functional and it should be connected with other control rooms through hot line communication facility.

While reviewing pace of execution of flood related works, LG directed resuming work on Sharief-abad and Naid khai bridges at an earliest, which would help remove obstructions in the flow of water, he asked for facilitating the contractors by mobilizing manpower and material supplies for these projects to ensure that work is commenced im-



mediately while taking all necessary precautions like social distancing, providing masks and protective gear to the work force.

LG emphasized on resumption of dredging work in all water bodies including flood spill channel, river and lakes and removal of encroachments on water channels. He directed on prioritizing dredging of Wular lake and asked the concerned to ensure manual dredging under MGNREGA to generate mandays days for locals during Covid-19 lockdown.

In view of social distancing protocol, presently in place, he directed concerned to increase capacity of evacuation centres used as rescue shelters for the affected people at the time of floods. He instructed for putting in place all the arrangements including masks, sanitizers and other supplies of personal hygiene. Special teams including that of doctors shall be designated for all vulnerable areas and rescue shelters in advance. SDRF was instructed to ensure training of personnel from Police and Home Guards for prompt response during floods.

During the meeting, SMC was directed to ensure immediately de-clogging of all rain storm drains in the city besides installation of solar powered high mast lights in all flood prone areas for the hassle-free evacuation during floods. Instructions were given for procurement of disinfectants to be used in the event of floods to contain water borne diseases.

He also directed for printing of SOPs in a book-let form with contact details of all concerned officers, officials and designated teams.

He said that CAMPA funds can be used for building check dams in catchments areas to prevent flood like situations.

As advance flood mitigation plan, LG instructed concerned to ensure that all installed machinery is shifted to upper floors of hospitals and other essential government buildings in low lying areas including civil secretariat. Regarding protection of important installations like Telephone Exchanges, and other Lifeline buildings, LG instructed that important equipment be relocated so that critical equipment does not get submerged in the event of floods.

Speaking on the occasion, Chief Secretary directed the concerned departments to activate the advance warning systems pertaining to weather alert,

evacuation alert. He stated that the capacity of Rescue Shelters has to be augmented with all critical equipment like tents, standby power, fuel and essential items like ration, drinking water. He said that rescue teams should be in high level of preparedness and mock drills should be conducted. Chief Secretary said that a senior Secretary-level officer based in Srinagar shall be assigned the task of monitoring the flood preparedness activities of all concerned departments. He said that manpower plan outlining officials to be put on job, duties assigned and their contact numbers should be prepared.

Earlier, Commissioner Secretary, Jal Shkati Ajeet Kumar Sahu, through a power point presentation deliberated upon the flood preparation, mitigation and response plan. He said that there is advanced flood alert system in place and work on increasing intake capacity of water bodies is being focused across the valley. He informed that Flood Plain Zone mapping is being completed and it would be shared with the concerned Departments. He added that the Jhelum's carrying capacity has been raised from 32000 cusec to 42000 cusec and the target is to take it to 60000 cusec.

# **Easing The Lockdown**

rom May 4 onwards, India has started third phase of lockdown for another two weeks. According to latest figures, the total number of coronavirus cases have passed 40,000 with as many as 1,306 fatalities. So, the flattening of curve that was expected to come about in the forty days of lockdown hasn't happened prompting the government to extend the cessation of activity for another two weeks. The new lockdown order, however, states that only

The new lockdown order, however, states that only a limited number of activities will remain prohibited across the country, irrespective of the zones, including travel by air, rail, metro and inter-state movement by road; running of schools, colleges, and other educational and training and coaching institutions. In addition the government has barred social, political, cultural, religious and other kinds of gatherings.

The movement of individuals in all zones for all nonessential activities has been strictly prohibited between 7 pm and 7 am. Local authorities, the order states, shall issue orders imposing Section 144 and ensure strict compliance.

As is apparent, unlike phase 1 and phase 2 lockdowns, the government has taken steps towards a graded reopening of the economy. Industrial activities have been allowed under strict instructions to observe of social distancing. Similarly, all agricultural activities – sowing, harvesting, procurement and marketing operations in the agricultural supply chain are permitted.

These are important relaxations as it's not possible for the government to completely shut down the economy. At stake are crores of jobs. The micro, small and medium enterprises (MSME) which across an estimated 5 crore units employ around 11 crore people have been hardest hit. The MSMEs also constitute a large part of the manufacturing in the country as also the exports. This makes up a big chunk of the Gross Domestic Product. So, the government has to not only let this sector gradually reopen but also provide it a significant stimulus support.

Also, with the three successive extensions of the lockdown, the government's options to go for a further extension are limited. However, the upcoming week will be crucial in terms of the trajectory of pandemic in the country in the country. A diminishing number of cases will make it easier to plan an exit strategy. And in any case, the government can't ignore the growing urgency to reopen the economy. And to start with the best strategy would be to considerably ease the lockdown from the least affected areas of the country, as the effort seems to have been now. At the same time, government can't afford to further delay the stimulus package that should

The he catastrophe triggered by COVID-19 has spread fear like no other event in recent memory. It has put the spotlight on indecisive leadership, bumbling governments, and misguided priorities. Right now, the daunting task is to stop the spread of the virus, and helping the sick and the needy.

But few occurrences offer more potent ground for a rethinking of what is human security. That security lies in reducing poverty, providing growth, and opportunity, access to education, affordable health care, a cleaner environment, and human rights. The crisis offers a chance to fashion human security in the lives of the people and not in the weapons that states have. In short, improved conditions for the human family.

More and more, the shatterig events over the last few weeks infection, death, lock-downs, hunger, and economic meltdown have tested the traditional concept of national security. That people are secure when states have military, political, and economic power. The crisis proves that existing security structures cannot protect citizens against a rare threat that transcends borders, devastates countries, and disrupts lives. Yet despite the worldwide disruption, the cost of the pandemic in human and material terms will be nowhere near the ravages of wars in Iraq, Afghanistan, and Syria. Looking back at it, the uncontrolled defense spending and unbridled militarism have been a criminal extravagance. The trillions spent on national security haven't made people safer. Expensive and lethal weapon systems lie idle while hospitals grapple with a lack of ventilators, doctors, and masks. Both major arms sellers and buyers are paying a big price for their unpreparedness for a pandemic.

It is a fact that even the wealth of rich countries hasn't come to good use either. Like never before, global economic inequalities are evident laying bare the hollow claims of economic progress. In all nations, millions of the most vulnerable are suffering from the economic impact of the crisis. And the health crisis will sink multi-million more people into poverty as growth rates plummet exposing the basic weaknesses of the least ready countries.

There is an instant need for social safety net for people impoverished and marginalized by sudden and severe health and economic crises. The longer-term remedial measures are re-starting the economy by supporting businesses, employment, and incomes, protecting workers in workplaces, and finding solutions between government, workers, and employers. Additionally, poverty reduction, checking the excesses of capitalism, and conflict resolution can play a role in offsetting the inequalities of globalization and reduction in the human costs of violent conflicts More important than ever is that democracies must avoid an escalation of political demagoguery. This leads to polarization, scapegoating, and xenophobia. It fans the flames of political and religious divisions. Right now open societies have a good opportunity to offer a contrast to the furtive behavior of authoritarian states. States like China and Iran where negligence and concealment have worsened the spread of the pandemic. The same restraint holds in international relations. In the last century, already savaged by the Second World War, the U.S.S.R. and the United States started a new military and political confrontation. The Cold War polarized the world into US and Soviet client states. It encouraged adversarial responses, authoritarian tendencies, and interventionist impulses round the globe. This era ended with the dissolution of the Warsaw Pact, and the U.S.S.R. allowing freedom to the people under communist rule.

Unlike the hostile actions during the Cold War which endangered humanity, this is a time to pursue the principles of nonaggression, non-interference, respect for independence, equality, and peaceful co-existence. Being a common threat, COVID-19 has given another chance to countries with the same or different social systems to build and grow friendly relations. To create a balanced order in which no power can act with impunity, states find effective ways to find peaceful solutions to outstanding historical issues and disputes in the world and commit to solidarity and cooperation. To paraphrase Aaron Sorkin, a world without walls doesn't need men with guns to guard it. The effort to improve human security needs a merging of resources. It requires a common try and united fight rather than every nation is for itself. It is unlikely, though that altruistic motives will suddenly drive elites who control the global agenda to change the irrational priorities so cruelly exposed by the pandemic. The main reason for this is, of course, is that it would mean a reduction in their monopoly on power. Our collective challenge is to find the political means to challenge the entrenched status quo to have a safer world.

# Changing Colours

n May 1, the Union home ministry extended the nationwide lockdown — scheduled to end on May 3 by two weeks. The third phase of the lockdown will, however, be less stringent than that experienced by the country in the past 40 days. In 603 of the 733 districts, designated green and orange zones, markets other than malls can re-open, factories and industrial units can resume operations, self-employed people such as domestic helps and barbers can go back to work, and e-commerce in non-essential items can recommence. But the fine print of the relaxation measures has left several states dissatisfied. Their grouse largely pertains to the red zones, the 130 districts which have been deemed as COVID-19 hotspots and therefore, placed under the maximum restrictions stipulated in the home ministry's directive. Punjab Chief Minister, Amarinder Singh, for instance, has contended that several areas that have no COVID-19 cases, Nabha for example, have found themselves ineligible for relaxations because they happen to be located in red zone districts. The West Bengal government has also termed the Centre's assessment of such zones in the state as "erroneous". And Delhi Chief Minister Arvind Kejriwal has argued against designating entire districts as red zones — only the containment zones, areas with a high caseload in hot spot districts, should be subject to strident restrictions, he said.

That 319 districts, more than half the districts in the country — green zones — have not had a single COVID-19 case in three weeks does testify to the success of the lockdown from a healthcare standpoint. A further 284 districts do not have a high caseload, the orange zones. However, epidemiologists have consistently emphasised that lockdowns do not frame the endgame in the battle against the virus. Hotspots can change, the infection can recede from some areas and spread to new ones. Kejriwal, too, underscored the need to view the pandemic from such a dynamic perspective when he said that "what is a green zone today can turn red". The Centre does allow states to re-designate green zones as orange and red zones. It also allows them the freedom to classify red areas as orange zones. But it does not give them the flexibility to relax the lockdown in areas within the hotspot districts. The Delhi CM underlined the limitations of this approach when he asked: "If a district has 50 villages and 40 cases emerge in one, why should the entire district be declared a red zone?'

States and local authorities dealing with the infection at ground level are the best placed to understand its spatial vagaries. It's, therefore, imperative that they have a say in drawing the boundaries of the areas that have to be opened up. The details of the red, orange, green zone scheme need constant review and revision from such a perspective.

# **Domicile Fears!**

hough it was obvious after stripping of the autonomous status of J&K in August 2019 that New Delhi was eying something big on Kashmir front but no one would have imagined that it would do so when the whole world was battling the spread of a invisible enemy Covid-19.

On first of April 2020, Ministry of Home Affairs brought up new domicile law which grants permanent residency rights, access to owing and buying property, jobs for anyone who has resided in the erstwhile state for a period of 15 years. This new domicile law added a new dimension of uncertainty and added to anxiety and insecurity of the people of Kashmir. Many youth indeed took to social media to express their fears of losing livelihood.

Following a backlash from youth and more importantly from Hindu dominated Jammu province, including from BJP and the newly formed Apni Party (JKAP), the law was changed overnight to reserve all types of jobs for domiciles but that was all pre-planned act by New Delhi to give political leeway to newly formed JKAP and to make youth less angry in BJP's own constituency of Jammu.

The hastily amended new domicile law allows permanent residency rights and jobs to those who have resided in the erstwhile state for last 15 years or studied for a period of seven years and appeared in class 10 or 12 examinations in educational institutions located in the region. It also allows permanent residency rights to central government officials and their children who have served the erstwhile state for 10 years. With this one thing which comes out as more worrying and is raising eyebrows is, how transparent will be the process of issuing domicile certificate in one of strife torn J&K where corruption is almost institutionalised.

It is to mention that the jobs were never an issue behind the abrogation of Art 370. Many believe the real motive was to induce demographic change in the India's only Muslim majority state. Indications are that New Delhi will gradually move more IAS and other higher rank officers in the territory administration who will keep necessary files with them and reduce the influence of local officers and people to minimal.

This appears to be a classic example of settler colonialism where a country first robs the aspirations, then land, culture, environment and finally identity.

# **Over Parenting, Under Parenting- How** We Make Children Suffer

Is it simply an act of being a caregiver to a gamete which resulted in a child? Or do they perceive it as something more than that? As the distance develops, solving the issues becomes even more difficult for the child, because the development of the feeling of not being listened to and not being understood already impacts the developing psyche of the child leaving a mark and a grudge against parents forever.

Parents usually seem to be complaining about the fact that their children do not listen to them, that they do not follow what they are asked to, so the fault lies with children's behaviour, that they do not listen to and follow

But why does this happen? There would be a reason for it for sure, but instead of finding out the reason our parents usually start the blame game, use harsh words, even beat up children at times, and behave harsh and rude, but does that help? Do their children start behaving well?

No, instead they shift to more aggressive and non-conforming behaviours, they indulge in antisocial activities, drug abuse, substance abuse, get involved with wrong peer group. A child while growing up passes through different levels and different types of stresses and pressures, be it family pressure, peer pressure, educational pressure, or any other type of stress, and in all that stress, all a child needs is someone who can hold his/her hand and guide him/her through.

Can we not simply treat them as humans by asking them to do things by being kind, generous and loving? Is loving and being kind to one's own child that difficult?



## Pak summons senior Indian diplomat over Gilgit-Baltistan issue

Islamabad: Pakistan on Monday summoned a senior Indian diplomat to convey its rejection of what it called India's "baseless and fallacious contention" regarding a verdict by Pakistan's Supreme Court on the holding of general elections in Gilgit-Baltistan.

The move came hours after India said it has conveyed its strong protest to Pakistan over Islamabad's efforts to bring "material change" to territories under its "illegal and forcible" occupation after the country's top court allowed holding of elections in Gilgit-Baltistan.

In a recent ruling, the Pakistan Supreme Court allowed the government to amend a 2018 administrative order to conduct general elections in the region. The Gilgit-Baltistan Order of 2018 provided for administrative changes, including authorising the Prime Minister of Pakistan to legislate on an array of subjects.

The Ministry of External Affairs in New Delhi said on

Monday that a demarche was issued to a senior Pakistani diplomat lodging a strong protest over the court ruling and clearly conveying that the entire union territories of Jammu and Kashmir and Ladakh, including the areas of Gilgit and Baltistan, are an integral part of India.

The MEA said the government of Pakistan or its judiciary has no locus standi on territories "illegally and forcibly" occupied by it.

In Islamabad, the Foreign Office said in a statement that a senior Indian diplomat was summoned to convey Pakistan's rejection of India's 'baseless and fallacious" contention against the apex court verdict on Gilgit-Baltistan.

It said Pakistan clearly conveyed that the Indian statement over Jammu and Kashmir as an 'integral part' of India" had no legal basis whatsoever'

"The entire state of Jammu and Kashmir is a 'disputed' territory and is recognised as such by the international community," the FO added.

#### Sikh Doctors In UK Complain **About Forced Beard Shaving**

London: British Sikh doctors are campaigning for a better procurement strategy by the National Health Service for personal protective equipment required on the frontlines of the coronavirus pandemic in hospitals after a number of them were forced away from key roles due to their beards.



The Sikh Doctors Association had reports of at least five Sikhs being moved out of their usual shift rota at the NHS hospitals for refusing to shave their beards and failing a socalled fit test of critical facial protective gear.

These doctors got in touch with us in some distress for being forced out of their usual roles, which was causing tension among colleagues as they had to cover their work," said Dr Sukhdev Singh, chairperson of the Sikh Doctors Association.

The problem arose due to a shortage of specialist facial protective masks called Powdered Air Purifying Respirators PAPRs), which is a hood respirator required in critical areas such as intensive care units. The fit tests' and equipment need to be geared towards all staff needs, including orthodox Sikhs with turbans and beards, he said.

All the individual cases of the five British Sikh doctors have since been resolved through acquisition of PAPRs, a more expensive but reusable kit costing around GBP 1,000.

The association is now working with individual NHS Trusts and more widely with the NHS England to ensure there is greater awareness around procuring such specialist protective gear in sufficient quantities well in time. The regular cloth FFP3 masks would not work with beards, a factor that could impact other communities such as Muslims as well.

The system of procurement cannot continue blindly. There has to be greater interaction and surveys done to ensure that specific staff requirements are taken on board so that there is sufficient stock of the right kind of PPE available in times of crisis such as a pandemic, added Singh.

Sikh Council UK has also been liaising with the NHS England alongside the association over the issue and had written to Sir Simon Stevens, chief executive officer of NHS England, last month seeking his intervention over greater clarity on fit tests and taking religious sensitivities into account.

**MUMBAI:** Equity benchmark Sensex plummeted 5.94 per cent or 2,002 points on Monday, tracking massive selloffs in global markets amid rising US-China tensions.

After a highly volatile session, the 30-share BSE index settled at 31,715.35, plunging 2,002.27 points, or 5.94 per cent.

Similarly, the broader NSE Nifty suffered a heavy loss of 566.40 points, or 5.74 per cent, to settle at 9,293.50.

ICICI Bank was the top laggard in the Sensex pack, sinking over 10 per cent, followed by Bajaj Finance, HDFC, IndusInd Bank, Axis Bank and Maruti.

Shares of Reliance Industries fell over 2 per cent after the oil-to-telecom conglomerate on Thursday posted its biggest ever drop in quarterly net profit.

Its net profit in January-March dropped 37 per cent to Rs 6,546 crore, the lowest in three years.

Meanwhile, earlier in the day, Silver Lake - one of the world's largest tech investors - agreed to invest Rs 5,655.75 crore to buy a 1.15 per cent stake in Jio Platforms.

Bharti Airtel and Sun Pharma were the gainers in the BSE index.

NEW DELHI: The Union government will facilitate the return of Indians stranded abroad, the process for which will begin from May 7 in a phased manner.
