

## **Extension Of Mehbooba Mufti's Detention 'Cruel & Retrograde': Omar**

SRINAGAR: National Conference leader Omar Abdullah on Tuesday said the decision to extend the detention of PDP president Mehbooba Mufti was "unbelievably cruel" and "retrograde".

"Unbelievably cruel & retrograde decision to extend @Mehbooba-Mufti's detention. Nothing she has done or said in any way justifies the way the Indian state has treated her & the others detained," Omar tweeted.

He was reacting to the Jammu and Kashmir authorities' deci-



sion to extend the detention of the former chief minister by an- other three months.

"For a government that is making tall claims about normality in J&K the last few days coupled with the extension of Ms Mufti's detention is proof enough that Modi ji has single handedly pushed J&K back decades," Omar added.

Most of the top mainstream leaders, including Mehbooba, Omar and sitting Lok Sabha member from Srinagar Farooq Abdullah, and separatist leaders were detained a day ahead of the Centre's announcement of abrogation of article 370 of the Constitution thereby repealing the special status of Jammu and Kashmir in August last year.

several aspects which arise on account of the implementation of the Durbar move in the UT....we have also noted the several steps on which we have no information at all, say, for instance, the cost incurred on the security forces and the police utilised for ensuring" the move.

"We are sure that these costs will be equal to, if not more than the expenditure which has been disclosed to us," Justice Mittal and Justice Rainesh Oswal said in the judgement.

However, the court expressed its inability to pass an order saying it had listed its "limitations on the extent of our jurisdiction whereby we stand precluded from making a declaration on the permissibility or the continuation of the practice of the Durbar Move.

Deferring this task to the "best wisdom of those on whom the Constitution of India bestows this solemn duty", the division bench asked that the judgement be served on Union home secretary and chief secretary of the UT "with the direction to place the same before competent authorities for examining the issues raised and taking a considered decision

The judgement began with a question raised by the division bench asking "whether any government can afford the annual expenditure of at least Rs 200 crores (as disclosed and many more hundreds of crores of rupees of undisclosed costs) for shifting of its capital two times a year, a practice which started in 1872 from the discomfort of the then ruler of Jammu and Kashmir with the harshness of the winter in Kashmir?"

"More so, is this acceptable in a hopelessly fiscally deprived UT with severe underdevelopment and people deprived of bare basics which are essential part of their fundamental right of life guaranteed under Article 21 of the Constitution of India," the court asked.

Kohli drew attention of the court to a report that the Centre had already released around Rs 24 crore for purchase of hardware and software for the Civil Secretariat and also released funds for digitisation of official records.

She had submitted before the court that government records ought not be taken out of its safe holdings and it should be properly secured and preserved at a proper place.

Calling for urgent revisit of old paradigms Kohli gave a historical perspective of the biannual shifting and said the then Maharja Ranbir Singh made the arrangement of shifting the Durbar from Srinagar to Jammu to escape severe winter in the Valley and Jammu heat in the summer.

"The discomfort on account of change of weather in either city, is, today compensated by efficient and modern environment control mechanism as air conditioning, heaters etc in

both Jammu as well as Srinagar," she said. She argued before the court that both the cities were well connected by air and road and said, "It is clearly logical that the consideration of extreme weather in support of the Durbar move does not hold weight today.'

The court, in its judgement said, "It is necessary to bear in mind that the Darbar move requires moving government records out of the safe spaces of offices where they are maintained, packing in fragile trunks, loaded into vulnerable hired transportation and exposed to the risk of theft, pilferage, destruction and damage, as they are ferried on the public roads and the National Highway for over 300 kms in all kinds of weather conditions.

"These records would be including sensitive documents and old archives which cannot tolerate exposure of any kind... Such documents may be on matters of security of the country as well as of the Union Territory. This security ought not be compromised for any reason whatsoever," it said.

status of the erstwhile state and bifurcated it into two union territories -- Ladakh, and Jammu and Kashmir.

Having spent over eight months in detention at two government facilities that were designated as sub-jails, Mufti was shifted to her home on April 7 as a partial relief to her.

Mufti heads the Peoples Democratic Party (PDP) which was in power in Jammu and Kashmir in alliance with the BJP till Iune 2018.

Initially, she was taken into preventive custody. Later on February 5 this year, she was slapped with the PSA along with Omar Abdullah, who was released in March. Farooq Abdullah had been released early last month.

Earlier, Mufti was lodged a government guesthouse in Chashma Shahi and a bunglow on Maulana Azad Road near Lal Chowk.

Daughter of Mehbooba, Iltija has moved a habeas corpus petition before the Supreme Court in February challenging her mother's detention.

A three-judge bench had issued a notice to the Jammu and Kashmir administration seeking its response on the plea and posted the matter for a hearing on March 18. However, the petition was not taken up for hearing due to the coronavirus

"Thanks to the team inside Kashmir," Gary Pruitt added, "the world was able to witness a dramatic escalation of the long struggle over the region's independence. Their work was important and superb.'

Channi Anand, AP's Jammu photographer, said the award left him speechless.

"I was shocked and could not believe it," he said, calling the prize-winning photos a continuation of the work he's been doing for 20 years with the AP."

People across the valley are showering love and respect to these "larger than life" photographers who chose to essay their story to the world in their way and let Kashmir depict its story via them.

Yasin says their prize-winning work has both professional and personal meaning to him.

"It's not the story of the people I am shooting, only, but it's my story," Dar said. "It's a great honour to be in the list of Pulitzer winners and to share my story with the world."

The prizes, considered the most prestigious for US journalism, are associated with the Columbia University's Graduate School of Journalism where the judging is done and is announced, although this year it was done remotely.

Besides a certificate, the prizes carry a cash award of \$15,000, except the public service category for which a gold medal is

Soon as the family's happy frame went viral on social media, the entire Kashmir erupted in joy.

A resident of Fateh Kadal in old Srinagar, Khan was born in the year 1979. As a passionate photographer since his childhood, he comes from a well-to-do family where all his brothers inherited established family business spread beyond Jammu and Kashmir.

He despite being youngest and darling of the family opted out and chose the "tough and challenging" profession at the height of insurgency in Kashmir.

In his two decade long career, Khan has extensively covered Kashmir Conflict and its myriad shades. Before joining AP in 2000, he worked as Kashmir Observer

staffer for over three years.

"I learned a lot at Kashmir Observer," Khan, who acquired photography skills from another noted photo journalist Rafiq Maqbool, said. "The friendly newsroom atmosphere boosted my confidence. We would daily discuss pictures like story

He said the editor-in-chief of the daily would give his pictures prominent space in the newspaper.

Last summer, Khan along with his colleagues covered Kashmir amid complete lockdown which included a sweeping curfew and shutdowns of phone and internet services.

"It was very difficult time for my tribe to work in the field after the abrogation of Article 370 on 5th August." Khan said.

"We would click pictures and reach the Srinagar airport. where we would convince Kashmiri passengers to drop photo chips to our Delhi office. There was lot of pressure but we had to show the ground reality to the world and I believe we did our job honestly."

It was the time when journalists were falling in lines for internet connection in government-run "Media Facilitation Centre" in Srinagar.

Previously, Khan bagged the Commonwealth Photography award and Atlanta Photojournalism award.

The news of Pulitzer Award came at a time when the jour-

# Rise in Jhelum water: Advisor Baseer inspects arrangements at EOC

Srinagar:-: Advisor to Lieutenant Governor, Baseer Ahmad Khan Tuesday reviewed the arrangements at Emergency Operation Centre (EoC) established here at Hari Niwas in the backdrop of rise in Jhelum Water Level.

The government has established the Emergency Operation Centre to deal with any eventuality that may arise due to flood like situation.

The Advisor directed for establishing more Emergency Operation Centres (EoC); stocking up of sandbanks at the vulnerable Jhelum and Doodganga embankments; building stores for dumping of essential commodities; besides constituting teams comprising health, sanitation, revenue, police and SDRF for deployment at these centres to deal with any kind of emergency situation.

Expressing his satisfaction over the arrangements made at Hari Niwas EoC.

the Advisor said the need is to create more such facilities and evacuation centres with all basic amenities including essential supplies for safety of evacuated persons and families as and when need arises.

He said that the whole plan has to be dovetailed with transport and evacuation plan and making the provision of boats.

Noting that usually lakhs of population get affected during flood like situations, he said it is imperative that two more such (EoCs) centres are established in a bid to have sufficient arrangement.

"Besides, there is a need of mockdrills with the designated mohallah level-teams and volunteers at the local level," he said.

He directed the concerned to make sure that every centre shall have a camp commander, who should be abreast with all the information including inventory, bedding capacity and stock position of essentials available at the centre.

Baseer Khan directed for sufficient stocks and supply of essentials like ration, drinking water, chlorine tablets, baby food items, female sanitary items, besides, critical equipment like tents.

The Advisor said besides stock up plan, an immaculate evacuation plan also needs to be put in place to avert any kind of loss in case of a natural disaster. He said boats should be kept ready at all the times around EoCs so that in case of flood like situation people would be immediately rescued.

Baseer Khan also directed for strengthening of river embankments, stocking up of sand bags at the identified vulnerable points of river bodies especially Jhelum and Doodganga. Men and machinery should always be kept in ready mode to deal with flood like situation emerging anywhere in the Valley, the Advisor said.

Besides, using drone, and the cameras placed at Nehru Park and Shankara-

charya, the Advisor said five to six more cameras should be installed at vulnerable spots especially at Lasjan and Bemina so that monitoring could be done from one place.

Earlier, the Advisor was briefed about various arrangements put in place at EoC and the steps taken to mitigate the threat of flood like situation in Valley by the officers of the Disaster Management, Relief, Rehabilitation, and Reconstruction Department (DMRRR).

The department also conducted a mock drill where the State Disaster Response Fund (SDRF) team exhibited their skills while rescuing a drowning

The Director DMRRR Amir Ali briefed the Advisor that besides, other arrangements put in place, the team would also be using drone services which would provide the images in real time. He said it would greatly reduce the risk of human losses in case of floods.

## Tsunami theory has "support" in Kashmir

**Observer News Service** 

RINAGAR - The report on April 17 that a retired Atomic Energy Department scientist had attributed the Asian tsunami to planetary alignment has come as a boost for those who believe that cosmic changes influence events on earth.

A Kashmiri Naqash Ghulam Jeelani who says he has written about the phenomenon of interplanetary and cosmic forces having a bearing on what happens on earth as far back as IW1, feels vindicated by the report. Also, he

takes issue with the view by some scientists

I hat (he earthquake which caused the Asian tsunami might have changed the earth's spin, Naqash says: "My point is that if at all there is a connect ion between earth's spin, wobble, axial till and the tsunami, then the wobble, or change in spin or axial tilt must have occurred first, causing the Asian tsunami.

"Because, primarily my opinion is based on the observation that cosmic changes or forces, and interplanetary changes affect intra-planetary activities and phenomena." Naqash says that he has neither the resources nor the

equipment to collect data about natural disasters but his opinion stems, among other things, from "observations" about the varying frequency of incidence of events such as earthquakes, appearance of comets, cyclones and forma-tion and extinction of geographical features, "which have sometimes occurred at a high rate of movement and sometimes at a comparatively low rate.

Paramahatnsa Tewari, the retired Atomic Energy Department scientist, had said that his conclusion about the causes of the tsunami stems from his theory that all spinning cosmic objects including the sun develop electric fields that repel each other. According to Tewari on December 26, 2004 when the

Saturn, Moon. Earth and the Sun were perfectly aligned, there was an imbalance of these electrical forces on Earth, because the repulsive force due to Sal urn was reduced as it as shielded by the Moon which does not spin, while the Sun, which was on the other side exerted its force on Earth. Tewari had said that the imbalance pushed solid earth

away from the sun causing sc water to overflow due to its fluidity, causing the tsunami. (Kashmir Observer, 06 May, 2005)

# Honour for Kashmir journalism

ulitzer prize for feature photography for three J&K photo-journalists is a recognition of the merit of Kashmir journalism by the world. It has put Kashmir journalism on global map. Three recipients Dar Yasin, Mukhtar Khan and Channi Anand deserved the honour for their great images that reflected the situation in the Valley during the lockdown following the revocation of Article 370 in August last. Kashmir was under security blockade and communication blackout during the period. But despite that Kashmiri journalists were out on the roads discharging their professional duty. They covered the extraordinary situation for the world at great personal risk.

Photographers through their images gave the world a feel of what was happening on the ground. Among them were three Pulitzer recipients who continued their work undaunted by the impossible situation. The Kashmir they captured is unfiltered and unmediated by the words or a fleeting video and their implicit and explicit politics. People got to see and experience the situation in Kashmir like it is, not how it has to be seen and experienced. Their confronted the state's narrative with its biggest challenge. They took the viewer into the lanes and bylanes of Srinagar and further afield into the countryside, its moffussil villages, orchards and fields, into the homes and kitchens of the people, all under lockdown.

Like others the awardees had no means to send their images to their offices, so they would go to Srinagar airport and plead with flyers to carry their memory cards and flash drivers to New Delhi. Clicking the pictures or covering a story was also a big ordeal. It required getting past roadblocks and security checks. But journalists in Kashmir broke all the barriers to tell the story, using keyboards and cameras. Pictures were an unmediated reflection of the situation in the Valley. It is their directness and raw quality that made the world notice the extent of crackdown in Kashmir. And now with the Pulitzer committee honouring the three J&K photo-journalists, it is the recognition of not only the coverage of the lockdown but the decades of the toil of reporting Kashmir. Despite the unhelpful environment, Kashmiri journalists have produced an impressive body of work and in turn a historical record of the past three decades. So, Pulitzer for Yasin, Khan and Anand is an occasion to savour and celebrate. And it is also an occasion to renew our commitment to highest standards of journalism.

# The challenge of lockdown 3.0

he first day of lockdown 3.0 has shown the challenges involved in the graded opening up of the country. On Friday, the Union government came up with a complex order — which categorised the country into red, green and orange zones; prohibited a set of activities nationally; and allowed other activities, in varying degrees, in the different zones. This made sense. India needed a calibrated loosening up to ensure that there wasn't an immediate surge in cases.

But for this approach to succeed, there were two prerequisites. The first was proper bureaucratic implementation — and this was always going to be difficult because of the inability of local police officials or district authorities to distinguish between what was permitted and prohibited, and who to allow and who to stop. But the second, more important prerequisite was citizens exercising a high degree of responsibility.

On day 1, this was missing. The most egregious reflection of this was in liquor shops. People lined up in hundreds, often without masks, jostling with each other, to buy cases of alcohol. The police authorities had to, in some cases, resort to lathi-charge or close shops. Liquor is an important source of revenue for state governments. Given the dire straits of public finances, as well as popular demand, opening stores made sense. But if citizens behave with such irresponsibility, then don't rule out a revision of rules in the future. In times of the pandemic, it is not just about drinking responsibly — but also purchasing it responsibly. It is about maintaining social distancing and knowing that the right to step out comes with responsibilities.

# **PANDEMIC Of Misinformation**

Misinformation Campaign & Easy Rescue in context of COVID-19 Pandemic

IRUSES are always in news for their morbidity and mortality. These tiny creatures despite having such a bad reputation can sometimes be very friendly to the humans, as they can be used as therapeutic agents by reprogramming them to treat the various diseases. Owing to their complex nature, Andre Lwoff- the French microbiologist and Nobel laureate rightly stated that "viruses are viruses".

Currently, "SARS-CoV-2" (severe acute respiratory syndrome coronavirus 2) with the very little genetic information is ruling the world rendering masses sleepless as this nanoparticle is now traversing all latitudes and longitudes. But, the misinformation campaign is going more viral than the virus itself, thereby creating a parallel pandemic of misinformation.

Many conspiracy theories are being propagated. Some pinpoint a passage from 1981 book 'The Eyes of Darkness' by Dean Koontz. Some exaggerate the Simpson & Nostradamus predictions, some doubt the Wuhan Institute of Virology and say it is an artificially created bioweapon. Some believe in the hypothesis that bats passed on this virus to an intermediate host and then it passed on to humans and the uncertainty goes on.

Though the current pandemic is very threatening because of high infectivity and transmission rate, it is not going to end the world. The way information is presented by the media regarding this pandemic depicts that losses loom larger than gains, and so when the options are framed in terms of deaths rather than cures, we get more fearful and accept more risks to try to avoid deaths. Although it is always better to stay overactive than non-reactive while dealing with a pandemic, overwhelming oneself by the negative emotions will in no case prove fruitful. Everyone is magnifying the deaths but no emphasis is given on the fact that most COVID-19 cases are mild and recovering and that the mortality rate of this disease is just 3.4% as reported by the World Health Organization (WHO).

In such circumstances we have to stay rational and put into action all the precautionary measures like practicing of social distancing which will eventually break the chain of transmission. But, the misinformation chain also needs to be dealt with by acting with responsibility. Instead of storming people with biased news, necessary information needs to be conveyed to them with absolute objectivity. It's very unfortunate that sometimes the virus is given a communal colour merely on the basis of self-fulfilling prophecies, which as per Robert Merton (1968) are false definitions of the situation that evoke a behavior which makes the originally false conception to come true. Merton emphasizes that people with racial prejudices may treat people of other races in a way that leads to the confirmation of their prejudices. A classic example in this regard is reflected in Shakespeare's play - Macbeth, in which the witches tell Macbeth that he will become the king, he believed so blindly that he choose to be a murderer and then used prediction of witches as the base for his actions. In quite the similar way, some sections of media are using their prejudices as a base to attribute the spread of virus to a particular community. A diverse set of realities has been created for diverse people based on the type of the media accessible to them.

Now as death is dancing in the streets, it is better time for all of us to bid good bye to the prejudices and draw our attention towards the rights of people who are under isolation & quarantine because of the ongoing pandemic. Isolation is about separating persons who have tested positive for a disease from those who are not sick or may be sick because of some non-contagious disease. Quarantine separates or restricts movements of people who were exposed to the contagious disease, in order to check if they become sick. If we don't follow these practices in their essence both will be rendered useless. Quarantine is ethically more problematic than isolation because it involves the confinement of individuals who may not be necessarily infected. Besides, it

forces people to be in spatial proximity with the infected ones, so here the fulfillment of principle of collective easy rescue gathers scope.

Easy rescue means that if someone is doing something to yield significant benefit to others, it is his moral obligation to practice it. In other words, if you can prevent something very bad from happening by making only a moderate sacrifice, then it would be wrong not to do so. Peter Singer has very aptly explained it by saying "If I am walking past a shallow pond and see a child drowning in it, I ought to wade in and pull the child out, this will mean getting my clothes muddy, but this is in-

significant, while the death of the child would presumably be a very bad thing". In this context people are morally bound to declare travel history and opt for self-quarantine in case they have recently arrived from the affected regions. Willingly opting for quarantine has a psychological advantage over being enforced to go for the quarantine.

The present crisis calls for a collective easy rescue duty. Administrative bodies have to be very careful about providing safety to the quarantined people because there are chances that in developing countries they may not get access even to the basic facilities like water and sanitation. In some cases they may not be placed away from the positives which is as necessary as preventing their contact with the susceptible. Besides, considering the highly contagious nature of the disease, healthcare workers may face the dilemma whether to prefer patient care or self-care.

A moral theorist may say that health profes-

sionals have a duty to treat just like firefighters have the duty to fight fires and hence the personal attributes of the patient in the form of nature of disease should not become a base for discrimination. In line with this notion, the current pandemic demands special positive duties from the health professionals because risk is the part and parcel of profession of medicine. If someone has chosen to enter the public safety roles, society expects him to accept the risk attached to the same. But the medical professionals here have the right to dissent as they have not given any consent to the employer, for bearing the risks associated with treatment of infectious disease and all the physicians are not infectious disease specialists. A research study carried out in western settings by Alexander and Wynia (2003) reported that among the one thousand physicians associated with American Medical Association, only about half of the respondents believed that they have duty to treat even in case of the outbreak of unknown deadly disease. The same may or may not hold true in the context of Jammu & Kashmir, but we cannot assume that they have given the consent to treat infectious diseases by default and thereby do nothing for the sake of their rescue.

As the health care workers are leading from the front to deal with the COVID-19 pandemic, effective steps need to be taken by the administrators. Before the situation in our hospitals gets out of control, enough of personnel protective equipments (Goggles, face-shields, masks, gloves, gowns, head covers and shoe covers) need to be procured for preventing the break down of health care system, as the pandemic advances. The administrative bodies, health professionals, academicians, media and the people need to create a point of intersection where from the efforts can be channelized properly to deal with the pandemic in a planned manner.

# India has over 500 million active Internet users: IAMAI

New Delhi: An estimated 71 million children aged between 5-11 years in India access the Internet on devices of their family members, constituting about 14 per cent of the country's active Internet user base of over 500 million, according to the Internet and Mobile Association of India (IAMAI).

According to IAMAI's 'Digital in India' report, India had 504 million active Internet users, who logged onto the web at least once in the last one month, at the end of November 2019.

"Of the overall Internet population, 433 million are of the age of 12 years and above, and 71 million are in the age ber of accessing Internet daily had grown by 30 million from March 2019, it added.

Interestingly, close to onethird of users access Internet for 'more than one hour' on Sundays/holidays versus a normal working day.

The time spent on the Internet continues to be higher in urban India compared to rural parts of the country.

According to the report, 26 million new female Internet users were added in November 2019. This is an increase of 21 per cent, higher than the 9 per cent rise seen in number of new users (male).

"While the proportion of male Internet users in rural India is more than double than



bracket of 5-11 years who access the Internet on the devices of family members," the report added.

The data has been curated by Nielsen, based on IRS data.

The report noted that nearly 70 per cent of the active Internet population in India are daily users with nine out of 10 Internet users in urban India accessing Internet at least once a week.

In rural India, the num-

female Internet users, usage of Internet among females is growing at a fast clip," it said.

Mobile phones continued to remain the device of choice for accessing Internet in both urban and rural parts of the country.

Given the affordability of mobile devices along with the availability of cheaper data plans, accessing the Internet through a mobile device has clearly become the first choice, the report said. PTI

# Boys Locker Room: Student detained, 22 identified in controversial chat group case

New Delhi: Soon after the Delhi Police swung into action in order to probe the Boys Locker Room controversy, one school student has been detained by the Cyber Cell in connection with the Instagram chat group where rapes were glorified and photos of underage girls were shared and they were objectified.

The one who has been nabbed so far is a 15-year-old student of a prominent school in South Delhi. "22 other boys have also have been identified and they would be called for investigation," the police said on Tuesday. The detained accused would be produced before the Juvenile Justice Board (JJB)

Leaked screenshots of the private Instagram chat group stirred up a storm over rape culture in India after numerous boys were allegedly seen sharing photos of underage girls, objectifying them, and planning "gang rapes".

A case was registered under section 465 (forgery), 471 (using forged document), 469 (Forgery for purpose of harming reputation), 509 (intending to insult the modesty of any woman) of the IPC and 67 and 67A of the Information Technology (IT) Act at cyber cell of Delhi police.

Earlier on Monday, the police received a complaint from the principal of a prominent school in South Delhi's Saket at the Saket police station requesting for a probe into the matter, the same was forwarded to the Cyber Cell thereof.

Apart from this, another complaint was filed at a police station in North Delhi by a parent in connection with this Instagram group.

On Monday, the police had asked photo sharing app Instagram to share the details of all the participants of the said group where photos of underage girls were being shared and they were being objectified.

Speaking to IANS over the phone Deputy Commissioner of Police (DCP) Cyber Crime, Anish Roy said, "We have asked Instagram to share the details of the members and admin of the said group including their name, IP addresses etc."



# India's unemployment rate soars to 27.11 amid COVID-19 crisis CMIE

Mumbai: The COVID-19 crisis has led to a spike in the country's unemployment rate to 27.11 per cent for the week ended May 3, up from the under 7 per cent level before the start of the pandemic in mid-March, the Centre for Monitoring Indian Economy (CMIE) has said.

The Mumbai-based think tank said the rate of unemployment was the highest in the urban areas, which constitute the most number of the red zones due to the COVID-19 cases, at 29.22 per cent, as against 26.69 per cent for the rural areas.

Analysts have been warning about the spectre of unemployment ever since the country was put under a lockdown on March 25 by Prime Minister Narendra Modi to arrest the spread of the virus infections.

infections.

Scenes of migrants fleeing urban centres like Delhi

and Mumbai only confirmed the long-held concerns on their employment as the economic activity came to a grinding halt.

The government has so far announced income and food support to the vulnerable people as part of a Rs 1.70 lakh crore fiscal stimulus to the economic, financial and possibly humanitarian crisis, and is also mulling a second round of measures soon.

The US has seen a huge spike in unemployment as over 26 million people have claimed for state support because of losing their jobs. Experts often rue the absence of a good gauge of jobs in India, which is predominantly an unorganised-sector led economy.

CMIE's weekly series of data pointed to a steady increase in unemployment since the start of the COV-ID-19 pandemic in India, with the week to March 29 showing the sharpest spike to 23.81 per

As per CMIE's data, the monthly unemployment rate in April stood at 23.52 per cent, up from March's 8.74 per cent.

As of the end of April, Puducherry in South India had the highest number of unemployment at 75.8 per cent, followed by neighbouring Tamil Nadu 49.8 per cent, Jharkhand 47.1 per cent and Bihar 46.6 per cent.

Maharashtra's unemployment rate was pegged at 20.9 per cent by the CMIE, while the same for Haryana stood at 43.2 per cent, Uttar Pradesh at 21.5 per cent and Karnataka at 29.8 per cent.

Hilly states had the lowest incidence of unemployment as of April, the think tank said, pointing out that the rate in Himachal Pradesh stood at 2.2 per cent, Sikkim at 2.3 per cent and Uttarakhand at 6.5 per cent. PTI AA MKJ

## Social Distancing Norms Tossed Aside As Crowds Throng Liquor Shops - Again

New Delhi/Amaravati: Undeterred by steep price hikes or the urgent need to maintain distance, impatient crowds were back outside liquor vends on Tuesday, pushing and jostling in many places as they sought to lay their hands on a bottle of their favourite tipple.

A day after lockdown curbs were eased and liquor shops opened across large parts of India, triggering near riot situations, lakhs of people lined up or gathered outside from early morning, counting the hours for the shutters to go up and then more hours till they reached the counter.

The scenes played out in towns and rural centres in states such as Andhra Pradesh, Karnataka, Maharashtra, West Bengal and Delhi, just as they did on Monday, the fear of COVID-19 eclipsed by the eagerness to access alcohol after more than 40 dry days.

On Tuesday, the Andhra Pradesh government enhanced prices by 50 per cent, over the 25 per cent hike it had imposed the day before. Late on Monday, the Delhi government announced a 70 per cent 'special corona fee' on alcohol.

But it clearly didn't matter much, not to casual drinkers who wanted to stock up their bars and not to the more serious tipplers and addicts reduced to despair without any alcohol. The price, whether of premium scotch or wine or of humbler spirits, was of no consequence it seemed.

"It's not the cost. It's the availability that matters right now. See the crowd even though the shop has not opened yet," said Prateek Singh, a student, pointing to the crowds outside a liquor shop in east Delhi's Shakarpur locality early in the morning.

Ayush, who works in a private company was waiting near him to buy his booze. He said he was not a regular drinker and the price did not really matter.

"Everything is costly during lockdown. Prices of food items are more than usual. The hike is exorbitant but still I am here to buy because it has been more than a month since I had a drink," he said nonchalantly.

New Delhi: Air India will operate 64 flights from May 7 to May 13 to bring back around 15,000 Indian nationals stranded abroad amid the COVID-19-induced lockdown, Civil Aviation Minister Hardeep Singh Puri said on Tuesday.

The minister, while addressing a virtual press conference, said private Indian airlines may join the repatriation effort after May 13.

Those availing the repatriation flights will be charged, Puri said.

A passenger on a London-Delhi flight will be charged Rs 50,000 and on a Dhaka-Delhi flight Rs 12,000, the aviation minister said.

On arrival from abroad, all passengers will be screened and put under quarantine for a period of 14 days as a COVID-19 precautionary measure, Puri said.

These 64 flights would be conducted by Air India and its

subsidiary Air India Express to repatriate Indians from 12 countries such as the UAE, the UK, the US, Qatar, Saudi Arabia, Singapore, Malaysia, Philippines, Bangladesh, Bahrain, Kuwait and Oman.

India will conduct 10 flights to the UAE, seven flights each to the US and the UK, five flights to Saudi Arabia, five flights to Singapore and two flights to Qatar to repatriate Indian nationals between May 7 and May 13,

During this time period, India will also conduct seven flights each to Malaysia and Bangladesh, five flights each to Kuwait and Philippines, two flights each to Oman and Bahrain, Puri said.

## Vijay Mallya files appeal against extradition order

Monday filed an application seeking leave to appeal in the UK Supreme Court, exactly two weeks after the embattled liquor baron lost his London High Court appeal against an extradition order to India on charges of fraud and money laundering related to unrecovered loans to his now-defunct Kingfisher Airlines.

The 64-year-old businessman had 14 days to file this application to seek permission to move the higher court on the High Court judgment from April 20, which dismissed his appeal against a Westminster Magistrates' Court extradition order certified by the UK home secretary.



"The leave to appeal has been filed. We have until May 14 to respond," said a spokesperson for the UK Crown Prosecution Service (CPS), which represents the Indian authorities in the legal process of the extradition.

The leave to appeal to the Supreme Court is on a point

of law of general public importance, which according to experts is a very high threshold that is not often met.

"The High Court effectively ruled that even if the approach of the chief magistrate was wrong, her decision was not wrong. It is therefore clear that Mallya now faces

a significant hurdle in getting it to the Supreme Court," notes Toby Cadman, cofounder of Guernica 37 International Justice Chambers and an extradition specialist.

As a further step, in principle, Mallya can also apply to the European Court of Human Rights (ECHR) to prevent his extradition on the basis that he will not receive a fair trial and that he will be detained in conditions that breach Article 3 of the European Convention on Human Rights, to which the UK is a signatory.

The threshold for an ECHR appeal is also extremely high, with very limited chance of success in Mallya's case because he would also have to demonstrate that his arguments on those grounds before the UK courts have been previously rejected.

# Branded as witches, 3 women forced to drink urine in Bihar; 9 held

uzaffarpur Three women in Muzaffarpur district, Bihar, were allegedly forced to drink urine and their heads tonsured by a group of people who branded them as witches, following which nine people were arrested, police said on Tuesday.

The arrests were made on Tuesday, a day after the incident took place, a police official said.

A video of the purported incident went viral on social media. Opposition party Rashtriya Janata Dal (RJD) also shared the video, which is 2.20 minutes long, on Twitter.



"The incident occurred in Dakrama village of the district on Monday. Of the 10 people named in the FIR, nine were arrested," Additional Superintendent of Police (ASP) (East) Amitesh Kumar said.

"Police are conducting raids to nab the remaining accused, who apparently had tonsured the heads of the women," he said.

Kumar said neither the victims nor the villagers informed the police about the incident.

"It is a very serious matter. The police acted swiftly and arrested nine people after they came to know about the incident from the media," he said, adding that more details would be available after investigation.

Sub-Divisional Officer (SDO) (East) Kundan Kumar said, "The police will take action as per the law after the probe." PTI



## **Activists aim to counter** Trump's 'disinformation'

WASHINGTON: A political action committee has launched to counter false and misleading statements about the coronavirus pandemic from US President Donald Trump with a wide-ranging, tech-infused social media campaign.

Defeat Disinfo, which started last week, plans to use "a sophisticated set of tools that allows us to spot misinformation just as it's beginning to go viral on social media," according to a statement.

It also aims to promote the "truthful counter narrative" about Covid-19 with tweet-fortweet responses to limit the impact of inaccurate informa-

Curtis Hougland, director of the committee and head of a technology firm which has worked to counter online propaganda from Russia and extremists of the militant Islamic State group, said artificial intelligence would play a role in the effort.

The technology "uses techniques such as natural language processing and machine learning classifiers to determine the emotions, themes and messages animating the conversation in a predictive way," Hougland said.
"The technology is unique

in its ability to geo-infer the location of data to understand the attitudes of voters in states such as Wisconsin or Arizona.

We also have the ability to identify who has interacted with or been exposed to disinformation." He said this technology "was incubated and tested at the front-line of ISIS propaganda" and has been updated for the latest initiative.

The committee is not aligned with any candidate but argues that Trump "is denying the facts on his administration's coronavirus response,' adding that "we're holding him accountable." "President Donald Trump is the largest amplifier of disinformation in the United States," said Hougland. "People are dying as a result of his political agenda." The effort is already in full swing with messages aimed at pointing out the danger of Trump's comments suggesting injecting disinfectant could help fight the coronavirus.

## **US Internal Report Suggests 3K Coronavirus Deaths Per Day By June 1**

Washington: The number of coronavirus deaths in the US will jump to over 3,000 and new cases to about 200,000 per day by June 1, an internal draft report has said, even as more than two dozen American states announced to open up their economy amid the health crisis. The US is the worst-hit country from the pandemic. By Monday, more than 1.2 million Americans tested positive for the COV-ID-19 and the total number of fatalities increased to more than 69,000.

The country's economy has come to a standstill and over 30 million Americans have applied for unemployment benefits.

Multiple media reports on Monday quoted the draft report projecting the horrifying figures of about 200,000 confirmed cases per day accompanied with 3,000 daily deaths by June 1.

The numbers underscore sobering reality: while the United States has been hunkered down for the past seven weeks, not much has changed. And the reopening to the economy will make matters worse, The New York Times reported.

#### World will be worse after 'banal' virus, says French writer

PARIS: Controversial French writer Michel Houellebecq said on Monday that he believes the world will be just the same after the coronavirus only worse.

The novelist, seen by his fans as a modern prophet of a nihilistic, individualistic age, poured cold water on those who see the pandemic as a possible turning point.

"I do not believe for a halfsecond the declarations that 'nothing will be like it was before'," said Houellebecq who rose to international fame through his 1998 novel "Atomised"

"We will not wake up after the lockdown in a new world. It will be the same, just a bit worse," he said in an essay for French public radio. "The way this epidemic has panned out is remarkably normal," he argued.

He described Covid-19 as a "banal virus" with "no redeeming qualities...It's not even sexually transmitted." But he warned that the self-distancing and "home-working that the epidemic has brought' would accelerate the technological push to isolate and atomise people.

It was a great excuse, he said, to push further the "obsolescence of human relationships".

he ridiculed writers who had compared the moment to his apocalyptic 2005 novel, "The Possibility of an Island", when the human race is on its last legs.



"The West has not the eternal divine right to be the richest and most developed zone in the world. "It is no scoop to say that, it has been all over for a long time," said the novelist, who is married to Qianyun Lysis Li, a Chinese student of his work 34 years his junior.

Even the death toll reflected the world as we have known it, he claimed.

"France is coming out of it better than Spain and Italy but not as well as Germany. No big surprise there." Houellebecq also poked fun at a string of French literary stars for pronouncing on the crisis from the comfort of their country or seaside retreats, without clarifying if he had remained holed up himself in his home in a Paris tower block.

## **Iran Parliament Approves Currency Overhaul Bill**

Tehran: The Iranian parliament has approved a bill to allow a major overhaul in the country's currency rial.

Lawmakers in the Majlis on Monday approved articles and subarticles of the Bill to Reform the Country's Monetary and Banking Act, a law which has dominated financial and economic exchanges in Iran since 1972.

The first article of the bill passed on Monday stipulates that Iran's currency would be new currencies could simultaneously circulate in Iran for a maximum of two years.

It also said that forex rates under the new currency will depend on the amount of Iran's currency reserves and other factors.

The bill also requires the government to pass and announce laws for implementation of the currency overhaul scheme within the next three months.

Iranian authorities have rejected the notion that currency redenomination could offset the negative impacts of the American sanctions on the economy.

## **China Slams Pompeo Over Lab Theory**

BEIJING: China's state broadcaster CCTV on Monday attacked US Secretary of State Mike Pompeo's "insane and evasive remarks" over the origins of the coronavirus pandemic, further fuelling Sino-US tensions.

Pompeo on Sunday said "enormous evidence" showed the virus originated in a lab in China, doubling down on previous claims that have been repeatedly denied by the World Health Organisation and various scientific experts. The theory has been heavily pushed by the Trump

Two further commentaries published on Monday by state newspaper People's Daily attacked Pompeo and former White House strategist Steve Bannon as a "pair of lying clowns", and blasted Bannon as a "Cold War living fossil".

Bannon last week said on a US far-right talk show that China had committed a "biological Chernobyl" against America and advocated the theory that the virus originated in the Wuhan Institute of Virology, echoing recent White House rhetoric.

In the past week, CCTV has repeatedly slammed Pompeo as the "common enemy of mankind" and accused him of "spreading a political virus" over his repeated claims that the pandemic originated in a lab.

China and the US have repeatedly traded barbs over the virus' origins in an escalating war of words.

#### **Britain outpaces Italy with Europe's** highest official coronavirus death toll

London: Britain has overtaken Italy to report the highest official death toll from coronavirus in Europe with more than 32,000 deaths, figures released on Tuesday showed.

The high death toll could increase political pressure on Prime Minister Boris Johnson, who waited longer than other European leaders to order a lockdown to curb the spread of the virus in March.

Weekly figures from Britain's national statistics office added more than 7,000 deaths in England and Wales, raising the total for the United Kingdom to 32,313.

The figure is one of several methods for calculating deaths and difficult to compare with other countries. but it offers the clearest sign yet that Britain could emerge as the worst-hit country in Europe, despite being hit later than other countries.

RUSSELS: Celebrities, world leaders philanthropists pledged some 7.4 billion euros (\$8.1bn) on Monday for research into coronavirus vaccines, treatments and testing during an EU-led video conference that was snubbed by the United States.

Commission European chief Ursula von der Leyen, who hosted the conference, said a vaccine was the best chance of beating Covid-19, which has so far killed nearly a quarter of a million people around the world — 140,000 of them in Europe.
