tioned an amount of Rs 223.00 He said that the **PAGE 02** NEW DELHI: A Delhi court on Monday extended till June 16 the judicial custody of Jammu and Kashmir Police officer Davinder Singh, who was arrested earlier this year while ferrying two Hizb-ul-Mujahideen militants in a vehicle on the Srinagar-Iammu Highway.

Singh was produced before the court via video conferencing which extended his custody for a month, his advocate Prashant Prakash said.

Special judge M K Nagpal had earlier directed the jail authorities of Hira Nagar Jail in Jammu and Kashmir, where Singh is currently lodged, to produce him before the court here today.

The judge had also issued production warrants against three other accused Javed Iqbal, Syed Naveed Mushtaq and Imran Shafi Mir arrested in the case. The court extended their custody as well till June 16.

where he was admitted for several days after he tested positive for the disease initially, reports said.

Later, he was taken to SMHS for an emergency procedure known as tracheostomy-which involves creating an opening in the neck in order to place a tube into a person's windpipe to allow air to enter the lungs. It was there when his fresh sample, known as tracheal aspirate rather than the ordinarynaso/oropharyngeal— swab was taken.

The test returned positive following which he was again taken to CD hospital where he died, the report added.

"He was continuously on ventilator from last eight days. He was suffering from Pneumonia. Last week a tracheostomy procedure was done on him at SMHS hospital." Medical Superintendent CD hospital, Dr Salim Tak said.

Hours after his death, a woman from the neighbouring Kulgam district also died of Covid-19 at the hospital to become 15th victim of the dreaded disease.

"A 65-year-old female from Kulgam, who was admitted in Surgical ICU in SMHS Hospital as case of sub dural haemorrhage (SDH) tested positive for COVID today morning and was shifted to CD Hospital Srinagar where immediately after admission she had cardiac arrest and instantly died," Dr Salim, concerned nodal officer said.

The third victim devoured by the deadly disease was a 75-year-old woman suffering from thyroid cancer.

The three deaths in a single day comes a day after a 29-yearold woman with underlying ailments died at the CD hospital here. She was the youngest victim of the dreaded disease in I&K so far.

With the latest fatality, 16 persons have died due to the disease so far in Jammu and Kashmir—13 of them in Kashmir and two in the Jammu division.

The Srinagar district has reported 5 of the deaths, highest in any district, followed by Baramulla and Anantnag with three deaths each while one each has been reported in Bandipora, Budgam, Kulgam, Udhampur, and Jammu. (with GNS inputs)

"There is no policeman from district police Anantnag. The DPL Anantnag is a collection point and all the 55 personnel are from armed police," a senior police officer said. Among them, he said, one is a SP ranked officer.

Official sources said that five doctors whose samples returned positive include a 30-year-old from Bemina Srinagar (posted at SKIMS MCH), 27-year-old from Asham Sumbal andipora (posted in Orthodontics dental college Srinagar 46-vear-old from Ladakh (Consultant ENT SMHS), 42-vearold from Mahjoor Nagar Srinagar (Consultant ENT SMHS) and Registrar ENT SMHS, a 30-year-old doctor. Among other patients who have tested positive at CD hospital's covid-19 testing lab include 50-year-old woman from Bemina Srinagar, admitted to isolation ward in SMHS. The others including 75-year-old woman of Kokernag, 55-year-old man from Fateh Kadal Srinagar, 65-year-old woman from Kulgam. 56-year-old from Kargil, 70-year-old woman from Budgam, 55-year-old man from Pattan Baramulla and 27-year-old from Sallar Anantnag were also admitted to SMHS hospital. The 55 armed policemen who tested positive are aged between 25 to 56 years old and maximum among them are in 30s, they added. The new cases in a day brought the tally to 1,289 in Jammu and Kashmir, they said. "Of these, 1129 are in Kashmir, while 160 are in the Jammu region," the officials added. A total of 609 people (549 in Kashmir, 60 in Jammu) have recovered from the infection, leaving 665 active cases in the Union Territory – 567 in Kashmir and 98 in the Jammu region. The UT has witnessed 16 coronavirus-related deaths, including the three that took place on Monday. Meanwhile, the media bulletin issued by the government today said that out of 88601 test results available, 87312 samples have tested as negative till today. "Additionally, till date 114788 travellers and persons in contact with suspected cases have been enlisted for surveillance, including 29208 persons in home quarantine, 89 in hospital quarantine, 665 in hospital isolation and 18300 under home surveillance. Besides, 66511 persons have completed their surveillance period," the bulletin added. (With Inputs From GNS)

The order by BVR Subrahmanyam said that it will require detailed assessment of the spread of COVID-19 in Jammu and Kashmir.

"In exercise of the powers conferred under section 24 of the Disaster Management Act, 2005, the undersigned (BVR Subrahmanyam) in (the) capacity as chairman of the State Executive Committee here by order that the guidelines/instructions issued vide order ...dated 03. 05.2020 shall continue to remain valid till 19.05.2020."

earlier letters, I would like to reiterate again that States and Union Territories cannot dilute restrictions imposed vide the aforesaid guidelines issued by MHA. States and UTs, based on their assessment of the situation, may prohibit certain other activities in various zones, or impose such restrictions as deemed necessary.

"I would urge you to ensure compliance of the new guidelines and direct all concerned authorities for their strict implementation," Bhalla said in his letter to the chief secretaries on Sunday night.

He said under the new guidelines effective from Monday, the states and Union territories will categorise "red", "orange" and "green" zones taking into consideration the revised guidelines issued by the Ministry of Health and Family Welfare on Sunday. Inside the "red" and "orange" zones, containment and buffer zones will be identified by the district administration and local urban bodies with technical inputs at the local level and by taking into consideration the health ministry guidelines.

Within the containment zones, strict perimeter control shall be maintained and no movement of persons will be allowed across the zones, except for medical emergencies and maintaining the supply of essential goods and services, the letter said.

The home secretary said a limited number of activities will continue to remain prohibited throughout the country.

The ongoing nationwide lockdown to curb the spread of coronavirus was extended till May 31 by the National Disaster Management Authority on Monday.

New guidelines on lockdown measures have been issued in supersession of the earlier lockdown orders, except the Standing Operating Procedures (SOPs) issued on movement of persons.

In order to facilitate the movement of persons, various modes of transport have already been opened up in accordance with the SoPs issued by the MHA and all other activities will be permitted, except those specifically prohibited under these guidelines.

However, only essential activities shall be allowed in the CO-VID-19 containment zones, as mentioned earlier.

The lockdown announced by the prime minister came into effect on March 25 for 21 days initially. It was first extended till May 3 and then again till May 17. On Monday, the lockdown was extended till May 31.

Act and sections 465, 467, 468, 471, 120-B RPC, resulting in loss of Rs. 223 crores to the Bank. Accordingly, FIR No. 04/2020 P/S ACB was registered and investigation taken up," the Bureau statement said.

During investigation, the ACB spokesperson said it has been found the accused Hilal Ahmad Mir had managed to get issued a fake and fictitious Registration certificate bearing Registration No. ARK/SS/3, dated 31.03.1994 and on the basis of that fake and fictitious Certificate of Registration loan to the tune of Rs. 223 crores was sanctioned in favour of the non-existent society without adhering to the codal formalities and without any proper security.

"The loan amount was disbursed into the accounts of the land owners but the land has not been mortgaged to the bank. Further, investigation conducted by the Bureau has been successful in unearthing the siphoned out funds to the tune of Rs. 223 crores and amount to tune of Rs. 187 Crore have been frozen by ACB," the statement said.

It said that during investigation, the accused man person Hilal Ahmad Mir was arrested on 14-05-2020 to affect the recovery of documents required in the case which are purportedly lying in their possession and also to unearth the modus operandi, and the end use of funds and quid pro quo if any obtained.

"He was remanded to police custody till 18-05-2020. The interrogation of the accused person is in progress to ascertain further leads in the matter. More arrests are likely as the investigation progresses in this case," the Bureau statement

Mushtaq, along with other militants of Hizbul Mujahideen. were planning to execute militant attack in Delhi and other parts of the country and targeted killings of protected persons, police had told the court.

Delhi Police had filed an FIR under Section 120B of IPC. The FIR said that the youths of Jammu and Kashmir and Punjab are being trained for carrying out militant activities.

Three other trusts, namely Aathrout, Tawheed Forum and Muslim Baitulmaal operating in the city, also refuted Shah's false claims

"We've a fact-checking team on ground, who verified the claims of the person," said Bashir Ahmad, an official from the Aathrout Charitable Trust. "I can tell you honestly that the accused fooled people. He was provided every sort of help by many charitable organizations."

After the man's cover was blown by the NGOs, people demanded penal action against him, besides "his account should be seized".

Journalist's Role

Following the outrage, a Srinagar-based lawyer Mohammad Amin Najar filed a complaint before Chief Judical Magistrate (CIM), Srinagar saying that the man and his media accomplice are liable to be punished.

"They have willfully and intentionally concealed the real facts and managed to dupe general public," Najar said in his complaint.

The video according to the complainant was shot by the "Journalist" Aquib Dar, correspondent at Young Bites (News Agency).

"He is in league with the person so as to gain illegally and unlawfully," the complaint said. "He has played a pivotal role in misleading, defrauding, deceiving and cheating the general public."

The complainant has sought criminal proceedings against the accused under section 415, 416, 417, 420, 424, 23, 25, 505 (1) IPC & sessions 03 of Epidemic Diseases of 1897, Section 66 D of Information and Technology Act, Section 54 of Disaster Management Act 2005, Section 68-72 of Central Excise & Customs Law (Amendment At. 1991).

"The accused person drives a van for livelihood and also owns some property at his native village," the complainant said. "He has also previously taken Rs 75,000 from the concerned MLA and Rs 50,000 from his in-laws."

Probe ordered

Taking cognisance of the claims, CJM, Srinagar on Saturday directed police to investigate the complaint against Shah and his alleged accomplice.

"I've perused the complaint and given my thorougful consideration over the contents and the submissions made by the complainant," the order copy reads.

"In order to ascertain the truthfulness or otherwise, I deem it proper to get the complaint investigated through SHO police station concerned u/s 202 CRPC."

The detailed report is to be submitted by or before the next date of hearing."

A Brazen Audacity

Soon after his cover was blown, the accused went to the office of Authrout at Nawa Kadal on May 16.

"He had the same old story to tell, 'Kids have not eaten anything since last seven days, no one helping him', so on and so forth," Mohammad Afaaq Sayeed, a civil society member active on charity front during pandemic lockdown wrote on his Facebook wall.

"He [Shah] perhaps takes the whole Kashmiri population as emotional fools. He has been handed over to the police." **Growing Paranoia**

The case has already cautioned many to be careful about the social media charity works.

"It takes one bad apple to spoil the barrel," said Zameer Mir,

eligible to get the domicile certificates from the designated authority which in all cases are tehsildars of different areas in J&K or other officials those may be notified by the government.

"Those in possession of the permanent resident certificates do not need any other document to get the domicile certificate. A person who has resided in the Union Territory for 15 years or studied in Jammu & amp; Kashmir for seven years and has appeared in class 10th/12th examination in an educational institution located in Jammu & Kashmir.

"Or who is registered as a migrant by the relief and rehabilitation commissioner (Migrants) in the union territory of Jammu and Kashmir as per procedure prescribed by government for migrants and displaced persons.

"Or who is a child of central government official, all India services officers, officials of public sector undertakings and autonomous body of central government, public sector banks, officials of statutory bodies, officials of central universities and recognised research institutes of the central government who have served in the UT of Jammu & Kashmir for a total period of 10 years are eligible to get domicile certificates", the spokesman said.

He also said a child of parents who are resident outside the UT of Jammu & amp; Kashmir in connection with their employment or business or other professional or vocational reasons but who fulfill any of the conditions described in clauses (a) or (b) of the notification are also eligible for domicile certificates.

"To make the entire process transparent the designated authority will have to issue the certificate within 15 days of receiving the application. There is also an appellate authority that will dispose off appeals against the decision of the designated authority within a period of seven days," the spokesman said.

"A designated officer shall be bound by the decision of the appellate authority failing which a penalty of Rs 50,000 will be imposed on the designated official and this will be recovered from his/her salary", Kansal said.

SRINAGAR, MAY 18: In order to strengthen public transport system, Principal Secretary Transport, Asgar Samoon, today, has said that radio taxi service on patterns of (Ola & Uber) will be started soon across the Union Territory of Jammu and Kashmir.

This was stated by the Principal Secretary while chairing an officers' meeting here convened to review establishment of IDTR(Institute of Driving Training and Research) at Kot Balwal and Budgam and ICC(Inspection and Certification Centre) at Harwan in Srinagar and at Samba in Jammu.

Stressing on the strengthening public transport services across J&K, Mr Samoon said that radio taxi service shall ensure better transport facility with safety of passengers besides creating employment avenues for locals. He said that technocrats, drivers, owners of taxis and auto rickshaws will be roped in this service, which will operate through a Google enabled app on patterns of Ola and Uber services. He said that Taxi service rules have been notified already and all related work is in progress to launch it soon in J&K.

Directions were also passed by the Principal Secretary to the management of SRTC to ensure early procurement of new buses including electric-ones. He asked them to deploy bus services on various routes including Gurez, La-

PRC For Admission To CET

Govt Says BOPEE Notification Not In Tune With Reorganization Act

Srinagar: The Government on Monday informed J&K High Court that a notification by BOPEE, seeking Permanent Resident Certificate (PRC) from candidates for participation in CET-2020, was not in consonance with the Jammu & Kashmir Reorganization Act 2019.

In the first week of this month, the High Court had issued a notice to J&K government, seeking its response on whether or not PRC has lost its relevance following abrogation of Article 35(A) by BJP-led government last year.

"After threadbare examination of the matter, the General Administration Department has advised the BOPEE vide communication dated 16.05.2020 that notification No. 003-BOPEE of 2020 dated 10.03.2020, issued by BOPEE is not in consonance with the Jammu & Kashmir Reorganization Act. 2019 and the same is required to be modified in order to bring it in conformity," Additional Advocate General, F. A. Natnoo, submitted before a bench of Justice Rajnesh Oswal.

Natnoo who appeared on behalf of BOPEE as well as stated that the BOPEE is going to act upon the advice "very soon".

"The statement of Mr. Natnoo is taken on record," the court said as per global news service. "In view of the statement, nothing remains in this writ petition for adjudication," the court said and disposed it of.

The petition was filed by one Aradhay Gupta through his counsel who contended that petitioner was born in Jammu and he has undergone all his studies in the erstwhile State of Jammu and Kashmir. He said that authorities were demanding PRC so as to enable him to participate in the CET-2020. He had further contended that with the abrogation of Article 35(A), the concept of PRC has lost its relevance and as such the same cannot be demanded by the authorities.

Article 35A of the Indian Constitution empowered erstwhile state's legislature to define "permanent residents" and provide special rights and privileges to them. The erstwhile state defined these privileges to include the ability to purchase land and immovable property, ability to vote and contest elections, seeking government employment and availing other state benefits such as higher education and health care. However on 5 August 2019, the President Ram Nath Kovind issued a Presidential Order, whereby all the provisions of the Indian Constitution were made inoperative while J&K was placed under unprecedented security and communication lockdown. Mounting Economic Loss

ashmir has suffered Rs 8416.2 crore loss over the first two months of the Covid19 lockdown, a report by Kashmir Trade Alliance has revealed. The general trade has suffered the highest loss of Rs 1620 crore followed by that of the industrial sector at Rs 1248 crore. The lockdown over coronavirus scare has come as a double whammy for Kashmir Valley. Following immediately after the six month long siege in the wake of the revocation of Article 370 in August last, the lockdown has inflicted a crushing blow to the state turned union territory's economy.

According to an estimate by Kashmir Chamber of Commerce and Industry (KCCI), the Valley's economy suffered a loss of more than Rs 18000 crore during post Article 370 lockdown. Tourism, one of the mainstays of the local economy came to a halt and is unlikely to emerge from the slump in a long time. This has hit the hotel industry and travel operators hard. The handicrafts sector has been crushed. The fledgling IT industry and the startups have been wiped out. Horticulture, a Rs 6500 crore industry, that employs around three million people has suffered the heaviest loss. A significant portion of fruit has rotted on trees. Also, a significant portion lies stored in the cold storage house in the Valley. According to a news report, there are still 80,000 metric tonnes of apples lying in Kashmir, one lakh tonnes of apples which are in cold storage in Kashmir and may rot during the coronavirus lockdown. Reports have also pointed out how the inclement weather conditions, coupled with low temperatures throughout April, have hit the horticulture sector. Continuing wet weather conditions have also delayed timely spraying of tree oil and pesticides. This doesn't augur well for the sector.

This has created a depressing situation. More so, with uncertainty deepening over the world's and especially India's ability to control the pandemic in near future. Kashmir economy is thus in desperate need for a government support. It needs a bit of help over and above what has been given to country's economy in recent stimulus. Kashmir has now been more or less shut for more than nine months. So, the region can hardly endure the closure of businesses any more.

Kashmir is now looking forward to a post-Coronavirus period and hope it remains peaceful. The region has already been through a long period of disruption, so businessmen are pinning hope on near future. We can only hope that world is able to get a handle on this deadly virus and we get

The Political Economy Of Class And Social Power In Kashmir

Life for the deprived classes has been nasty and brutish in Kashmir. It was perhaps only with the incipient advance of Kashmiri nationalism that a new constellation of classes and castes emerged but this was a relatively small class that called for both social and economic reform.

ORDS and their etymology are powerful in their own right but they are also signifiersof class, status and power in a given society. Kashmir and its social mix and constituents are no exception in this regard. Words such as 'khoje' (upper class wealthy person), 'waatal' (roughly the sweeper and the cobbler class), doomb (the lowest classes), peer (the priestly class), 'haenz'(the boat people of Kashmir, who live almost in a different world and zone), 'groos'(peasant) and so on are signifiers of social class in Kashmir suggesting the class or caste(used interchangeably here) of persons in what was and is a deeply hierarchical society. All these words have, over time, acquired pejorative connotations as well. But, this is the least of the issues. The real problem begins when such signifiers assume dimensions that can either hold back a person (or persons) or even advance them in a social hierarchy.

Consider the pirs and khojas of Kashmir first. The former stood on a higher social pedestal because of their monopoly on/of religion and learning thereof. The latter owed their prestige to either ownership of land or monopolization of the trades and crafts of Kashmir. Both fed on the lower, uneducated classes of Kashmir and the peasants- the pirs were held in awe by the groos and others. This politicosocio-economic condition held and endured almost throughout the rule of various rulers of Kashmir with each class instrumentalized by the rulers for pure reason d' etat. For example, the doombe, because of their lower status were associated with a degree of crudeness and rudeness formed the constabulary and informants of the various rulers. The khojas and the pirs, held to be the polite castes or the 'shareefs' of Kashmir, served as intermediaries of the governing classes.

Life, under these conditions for the deprived classes, was nasty and brutish in Kashmir. It was perhaps only with the incipient advance of Kashmiri nationalism that a new constellation of classes and castes emerged but this was a relatively small class - an educated cohort that assumed a new consciousness and thereby called for both social and economic reform. The Land to Tiller reforms instituted by Sheikh Muhammad Abdullah, under socialist influences, aimed to empower the groos (peasant) altered the social dynamic. (But, it was only after land prices skyrocketed in Kashmir that the groos reaped financial benefits. The unintended effect was



that the groos landowner and land holder who was supposed to reap fruit from the land and contribute to agricultural efflorescence of agriculture promptly sold his land as a get rich quick scheme).

It was in marriages that class or caste configurations also were reflected; these were almost endogamous. Corresponding to the typology and category of, say Khojas- the wealthy elite- married into Khoja families, the waatals into waatal families, the pirs into pir families and so on.

But, like in other societies, of course, in varying degrees, did education and the crystallization of the state structures alter these social and class dynamics in Kashmir? Not fundamentally is the answer. This is primarily because in the initial days access to the state and thereby was monopolized by the privileged classes who continued to be extractive and exploitative toward the lower classes. The same held true for businesses and trades till Bakhshi Ghulam Muhammad, for political reasons, created new classes in Kashmir. For example, by giving bus and taxi licenses to tongawallahs, Bakhshi derived political patronage from these classes and other allied ones. Access to resources of the state was, for instance, contingent on patronage of the wealthier classes. Forest lessees and so on for example, were given rights for lumbering, denuding Kashmir's forest and green cover in the process.

By and large, the condition of the waatals, the doomb, the haenz and so on remained the same till the eruption of open militarized conflict in Kashmir. This opened all the fault lines of Kashmir and the social order got inverted. The aspiration of the lower classes was to mimic the upper classes in the changed socio economic order. (Some nouveau riche people who made their wealth during this period are called TK's in Kashmir meaning 'tehreeki khojas', the implication being that they made their money in less salubrious ways) But, underneath this change, counter intuitively, the aspiration for education cutting across classes gained traction and momentum. Even though the provision of education was and is shoddy, but people from all walks of life began educating their children. The pirs, even though till a potent force, especially in rural Kashmir, lost their pre eminence; the groos was now educated and aspired to be a government official or a bureaucrat or a professional; some underprivileged classes also by virtue of education became doctors, engineers and so on, forming the middle class firmament in Kashmir.

But, even though there were some inter marriages, the underlying social and prejudicial dynamics remained. Behind his back the educated and professional groos was still called a groos pejoratively; the groos, in turn, when he was in a position of power made it a point to throw his weight and position around and so on. The larger point here is that while education rendered malleable social classes and social mobility, to a degree was made possible but the aspirational dynamic was not entirely the kind that would correspond to modernization of outlook and temperament and therefore equality. It, actually, in a different permutation and combination gyrated to the old dynamic of classes and castes in Kashmir in

back to a normal life.

Peaking: On India's coronavirus tally

n 106 days since the first laboratory-confirmed novel coronavirus case was reported on January 30, India surpassed China's tally of 84,038. As on May 15, India had over 85,500 cases and the death toll stood at 2,752, as against 4,633 in China. There are only 10 other countries that have more cases than India. At the same time, the toll in the U.S. alone went past the total number of cases in China, while the total case load crossed 1.4 million. On March 18, when China reported zero fresh cases, India had just 162 cases and three deaths. Despite the country being under lockdown since almost end-March, the number of fresh cases and deaths reported each day has continued to rise steadily - on average, over 3,600 cases have been reported daily since May 8. This is of serious concern as contrary to the advice of WHO, India has not fully utilised the precious lockdown period to increase manifold the number of tests carried out daily while simultaneously tracing, isolating and treating COVID-19 patients. That even during the lockdown India has witnessed the shortest time, of 13 days, for cases to double compared with 14 other countries that have the most cases reported is testimony to the wide spread of the virus. A reason for this could be that cases in other countries, barring Russia and Brazil, have already peaked or are about to. Unfortunately, even as the number of cases has crossed 94,700, India is yet to begin investigating community transmission despite the strongly suggestive findings of sentinel surveillance among those hospitalised for severe acute respiratory infections. Given the high rate of asymptomatic transmission, high viral resurgence is inevitable when the lockdown is lifted.

With over 11,200 cases, Tamil Nadu has the second highest number of cases next to Maharashtra (over 33,000). But with over 4,000 tests per million, TN is testing nearly two times more than Maharashtra. It is not the States that report more cases that is a cause for concern, but those that have reported fewer. Active case finding and testing of most people with a travel history early during the lockdown could be one reason why Karnataka has reported fewer cases. Similarly, surveillance and case finding of those with a travel history early on have been good in Andhra Pradesh and could be a reason why it has reported fewer than 2,400 cases so far. Maharashtra, Gujarat, Madhya Pradesh and West Bengal have reported high case positivity. This could either be due to good surveillance, which is unlikely, or wider spread of the virus in the community, at least in specific regions. If the latter be the case, India can expect huge numbers to be reported in the coming weeks. No State, including Kerala, can thus be complacent

Talking about the latest trend in gaming, the violent video games like "PUBG" are on the tip of tongue of every child, young as well as adults. With 20 million daily active users globally PUBG is one of the most popular violent video game today. There are many other games which are of the same category show casting sheer violence and killing. With these games, the gamer learns to associate violence with pleasure, rewards for hunting another character while under normal conditions, human emotional wiring is designed to abhor violence and feel rewarded for helping



others. Those who play violent video games build opposite intuitions that they take into rest of life. Whatever a person practices repeatedly becomes an automatic response.

Studies have found short term and long term negative effects of playing violent games that include increased aggressive thoughts, feeling, behaviour and decreased prosocial behaviour. Neuro-scientific studies show reduced cognitive brain functions in individuals exposed to violent games. The lower was the activation of brain areas for learning, thinking, reasoning and emotional control. Violent video games instruct children how to behave like a criminal and intentionally hurt oth-

ers'. Diminishing empathy, pleasure in the pain of others, well-practiced criminal behaviour, decreased capacity for mature decision making, Bad physical health, bad mental health, less sleep and bad academic scores were some of the effects of exposure to violent games. With the advent of these games children neglect hobbies, sports, friends, argue frequently with family members who try to limit gaming and put little or no effort into school work. The WHO in 2018 declared gaming addiction as mental health disorder. Addiction to video games increases the depression and anxiety levels.

What I Learned From Chaiwallas And Autowallas Of Kashmir

CERTAIN ideological political spectrum blames the poor for being poor. According to this ideology defined by intellectual poverty itself, the poor are indolent, lazy, welfare queens (or kings as the case may be) and by implication and inference then, they don't have dignity. This view is far from the truth. I do not predicate my assertion upon a sentimental and mushy view about the poor but on real experiences I had in Kashmir. While the sample size is small, the assessment is neither impressionistic nor anecdotal. Here is what it is based upon.

My commute to work in Kashmir was a staggered one: I would drive to town, park my car at the slot near my friend's café, and then either walk toward office or take an autorickshaw (the famous tuk tuk in the Western schema). I would repeat this routine on my way back. It became so entrenched and such a regular affair that almost all autorickshaw drivers in town knew me. They were not only incredibly nice and polite to me but also usually offered me some discount. The tea and coffee at work was horrible. Because I am fond of either, I would bring my own mug and walk down to the tea vendors near the office to get my hot cup of tea laced with ginger. Yet again, I was given preference by way of giving me more tea than they would any other customer. (Initially, my favourite vendor(Ali Mohammedreal name withheld) would ladle spoons of sugar into tea-a cultural practice in certain quarters of Kashmiri society that denotes respect!).

It may be noted that tea vendors of Kashmir and autorickshaw drivers are daily wagers. They make their money on a daily basis; it is not much and uncertainty of the place eats away



into their earnings.

On day, Ali Muhmmad came rushing into my office premises and sought me out. He said, 'Sahib (an honorific in Kashmir), my wife and kids are trapped in Jammu. They cannot return home because the highway is closed due to heavy snowfall. They have run out of money. Can you help them out?' There was worry and concern in his eyes and tome. I said I'd see what I could do. I organized a sum of 3000 rupees and asked someone in Jammu to go to the bus station where his wife, children and other stranded passengers were. The money was handed over to them. I thought that this was the end of the matter. But, nay, I was wrong. The next day, a beaming Ali Muhammad came to the office, showered prayers and blessings on me.

Taking a wad of notes from his pocket, Ali Muhammad returned me the money. I was embarrassed. The sum of 3000 rupees was not a huge one but he insisted. I refused. This went on for a few minutes till Ali Muhammad kept the money on my table and left.

The tea vendor(s) and the auto rickshawallas had become friends of mine. I admired their grit and determination to make a living against all odds.

During a petrol crisis in Kashmir, Maqsood

(not his real name), after coming to know I had run out of fuel, came to my home one early wintry morning, 'Sir, I realized you have no petrol for your car. Here's 30 litres'. I was overwhelmed and asked how he had obtained it. The response was, 'Arrey sir, I depend on petrol for my rickshaw. So, I was waiting till 2 am in the morning at the petrol station. When it arrived, I filled my tank and got some for you'. I wanted to tip after I paid him for the petrol. A sheepish, rather embarrassed smile on his face and a big No said it all

After leaving Kashmir in September to the West, I did not forget about them. I'd call them and my query, stated very diplomatically, lest they be offended was whether they needed anything. The response invariably was the same, 'Sahib, khoda thaevnai sehat' meaning May God keep you always happy and in good health. Decoded, this was a polite no.

Now that Kashmir is in a Covid 19 induced lockdown, and now that Eid al Fitr (the Muslim festival commemorating the end of Ramazan) is approaching, I called the autorickshawallas -the ones whose numbers I had on my phone and Ali Muhammad, the tea vendor.

Ali Muhammad's typical response was emblematic of all. 'Eid is approaching,' I said. Its been a long time since the lockdown. Do you need anything?' After a pause, Ali Muhammad, effusive and gushing with prayers for me and my family said, ' Khodah theavanai vaare, khoshaal te theavnai sehat' meaning, 'May God always keep you happy, healthy and well'. It was yet again a polite no.

"The COVID pandemic is opening doors for multidisciplinary collaboration so trauma acute care surgeons and intensivists can bring the tools they use in their day-to-day lives and apply them in the critical care setting to new problems," Wright said.

In the study, the researchers analysed 44 patients treated for COVID-19 infection between March 22 and April 20.

They assessed the outcomes for all patients who had a TEG assay as part of their treatment. The scientists also evaluated the outcomes of the COVID-19 patients who were tested with other conventional coagulation assays such as the ones that measure the levels of the molecule D-

These patients, according to the

researchers, could be identified by TEG assays showing no clot breakdown after 30 minutes, and a D-dimer level greater than 2600 nanogramme per millilitre (ng/mL).

Eighty percent of patients with both affirmative test findings were placed on dialysis, compared with 14 per cent who tested for neither finding, the scientists said.

According to the study, patients with positive test findings also had a 50 per cent rate of venous blood clots.

This was compared with zero per cent for those patients with neither finding, the scientists said. "These study results suggest there may be a benefit to early TEG testing in institutions that have the technology to identify COVID-19 patients who may need more aggressive anticoagulation therapy to prevent complications from clot formation," Wright said.

Dubai: Seven cities and governorates in Saudi Arabia have together recorded 2,378 cases, 87 per cent of 2,736 coronavirus infections reported yesterday, the Saudi Alwatan Newspaper reported Sunday.

Makkah with 557 cases topped the list on Sunday. It was followed by Riyadh with 488 cases, 392 in Medina, 357 in Jeddah, 286 in Dammam and 149 each in Hufof and Al Jubail.

There were also 81 new infections in Taif, 51 in Al Khobar, 24 in Qatif, 18 in Tabuk, 15 each in Dhahran and Baish, 14

Al Abdali reiterated that the spread of virus in the kingdom is under control, adding: "It is known during pandemics that the curves will be go up and down gradually, and it is important during these times to have a view of its rapid spread. However, the virus spread in the Kingdom is under control, and the rise in numbers is attributed to redoubling our tests efforts, which results in the early detection of cases.

Saudi Arabia has so far reported 54,752 cases, of which 28.718 are active cases receiving treatment at the Kingdom's hospital. There are also 2020

Madrid: Summer weather is enticing much of the world to emerge from coronavirus lockdowns as centres of the outbreak from New York to Italy and Spain gradually lift restrictions that have kept millions indoors for months.

People are streaming back to beaches, parks and streets just as a heat wave hits southern Europe and spring-like temperatures allow Americans to shed winter coats. As they venture out again. most are keeping their distance and some are wearing masks.

However, protests are also heating up from Germany to England to the United States, arguing the government restrictions demolish personal liberties and are wrecking economies. Greeks flocked to the seaside

on Saturday when more than 500 beaches reopened, coinciding with temperatures of 34 Celsius. Umbrella poles had to be 4 metres apart, with canopies no

closer than 1 metre as the country sought to walk the fine line between protecting people from COVID-19 while reviving the tourism sector that many depend on for their livelihoods.

This is the best thing for us elderly ... to come and relax a bit after being locked in," Yannis Tentomas, who is in his 70s, said as he settled down on the sand.

White circles were painted on the lawn in Brooklyn's Domino Park in New York City to help sunbathers and picnickers keep a safe distance. About half the people in the park appeared to be wearing some form of face covering as they congregated in small groups on a warm Saturday afternoon with police officers in masks keeping watch.

Iran Media Warn US Against Any Move On Fuel Shipment To Venezuela

Tehran: An Iranian news agency close to the elite Revolutionary Guard said on Saturday that there would be repercussions if the United States acted "just like pirates" against an Iranian fuel shipment to Venezuela.

A senior official in President Donald Trump's administration told Reuters News Agency last week the US was considering measures it could take in response to Iran's shipment of fuel to crisis-stricken Venezuela.

The oil sectors of Iran and Venezuela, members of OPEC, are both under US sanctions. The Trump administration official declined to specify the measures being weighed, but said options would be presented to Trump.

"If the United States, just like pirates, intends to create insecurity on international waterways, it would be taking a dangerous risk, and that will certainly not go without repercussion," Iran's Nour news agency said

At least one tanker carry-

ing fuel loaded at an Iranian

port has set sail for Venezuela,

according to vessel-tracking data from Refinitiv Eikon, which could help ease an acute scarcity of petrol in the South American country.

"Venezuela and Iran are both independent states that have had and will continue to have trade relations with each other," Iranian government spokesman Ali Rabiei was quoted as saying by the YJC news website, linked to Iran's state broadcaster.

"We sell goods and buy goods in return. This trade has nothing to do with anyone else. We have to sell our oil, and we have ways to do it," Rabiei said, adding he had no information about the Venezuelabound vessel.

British tanker experience

Separately, an Iranian analyst suggested Tehran may retaliate against US vessels in the Gulf if the US takes action against the Iranian tanker.

"The US Navy and its allies in the Persian Gulf are hostages to any kind of violation against Iran's legal international shipping," Mahdi Mohammadi said on Twitter.

The first Pakistan International Airline (PIA) flight carrying 84 passengers departed from Karachi for Lahore at 1300 local time (0800 GMT), along with flights for Lahore and Islamabad operated by a private airline, local media reported.

"In view of the difficulties faced by passengers in traveling between major cities, the Federal Government has allowed limited domestic flight operations from five major airports. Islamabad, Karachi, Lahore, Peshawar and Quetta with effect from May 16." said a statement issued by the Aviation Division.

Domestic and chartered flight operations will require disinfection of the aircraft prior to boarding, at least one vacant seat between the passengers and compulsory wearing of masks and use of hand sanitizers. No food and beverages will be allowed during domestic flights, the statement added. On Saturday, the Aviation ministry released pictures of passengers seated with a gap of a seat in the flights.

Prime Minister Imran Khan on Friday said that the country could not afford an indefinite lockdown and the nation would have to learn to live with the pandemic.
