

Cleric Who Led Militant's Funeral **Denied Bail**

SRINAGAR: A special NIA court in Anantnag has denied bail to a cleric. who was arrested on March 3 this year, 726 days after leading funeral prayers of a militant from his native village, Damhal Hanjipora in south Kashmir's Anantnag district.

The funeral of the militant Amir Tantray, killed in an encounter with joint team of police and army on 25 October 2018 at Arwani Bijbehara, was held next day.

As per prosecution, when the militant's body was brought to his native village, the people of the area assembled. "The accused Mohammed Iqbal Bhat being cleric and one another cleric namely Tariq Ahmad headed and performed funeral of the deceased militant. In the meanwhile few miscreants raised anti-national slogans and raised slogans in favour of the Pakistan. They also instigated the youth for providing assistance in carrying out the militant activities," the prosecution said.

'Kashmir is in quarantine for long'

Siege mentality, said Prof. Noor Baba, has become a way of life in Kashmir for years now.

"We've got accustomed to this," the political science professor told Kashmir Observer.

"When I started teaching during the early 80s, I was young and it was usual after office hours for us to travel and go to restaurants, and socialize. A lot of social activities were happening in the valley.

But after the 90's insurgency and violence, restrictions increased, Prof Baba, a senior faculty at the Central University of Kashmir, continued.

"There was a time when curfew would be imposed at 3pm, so people had to rush homes. That was deeply seeded into our minds. Social lives were deeply impacted, but somehow we've learned to live with this."

Kashmiris had been quarantined for a very long time, the professor said. "If people were expecting relaxation, in our case it got more reinforced after the Covid-19 situation." **Playing a Therapist**

Life under such a siege tremendously affects every aspect of lives, said Dr Arif Maghribi, a Srinagar-based psychiatrist. "Some people recover, but many do not, even after 20 years. Some cases change into major depressive disorders."

But as relentless restrictions and curbs only deepens siege mentality, Dr. Maghribi focuses on awareness.

"I've started telephonic counselling for the last three-four years," the mental specialist said. "However, with little awareness of mental health, the stigma continues to be associated with it."

Away from lockdown-plagued home last summer, when Afdista of Anantnag went to Mumbai for studies, she marveled the idea of free-world for a long time.

"I wasn't used to seeing so many people roaming and driving cars till late hours of midnight," she said. "Since childhood I had seen many nights even before the day ended."

Growing up, she lived through many days of long curfews, watching forces roughing up locals for merely being on the street.

"This would make me believe that we were some besieged people," she said. "Maybe we were made to accept that reality, which otherwise is totally inhuman."

With these deaths, the COVID-19-related death toll in Jammu and Kashmir has risen to 20, the officials said.

With these cases, the overall tally has mounted to 1449–1238 in Kashmir and 211 in Jammu. Among them 745 are active cases-140 in Jammu and 605 in Valley while 684 patients have recovered—69 from Jammu and 615 from Kashmir while 20 others have died.

Kulgam district reported 21 cases, Anantnag 12, Kupwara 7, Srinagar 5, Budgam 4, Ganderbal 2 while in Jammu, Kishtwar and Doda one each case was reported while Kathua and Ramban reported 3 each

Among the samples which returned positive, 21 were from District Police Lines Kulgam, 11 from Anantnag including 2 pregnant women besides an intern doctor from Psychiatric Disease Hospital, he said. The cops who have tested positive are aged between 25 to 59 years and are residents of different parts of Valley.

Police said all the 21 were already in isolation from March 18 in a compound separated from DPL Kulgam by 3 kilometres. "The officials were all part of a special pool of 60 personnel created as a reserve exclusively for Covid-19 duties at Quarantine and isolation centers, for handling Covid-19 patients and potential carriers and for acting as substitutes for police stations in case of Covid breakout in a particular unit," police said in a statement.

The samples of the officials were being taken from time to

Bhat said he is a respected persons, most particularly in the area where he resides and does not having any previous criminal record.

Govt Issues Guidelines For Domestic Flight Operations

gate will be closed 20 minutes before departure, it said. All scheduled commercial passenger flight operations have been suspended since March 25, when the Modi government announced the nationwide lockdown to combat the coronavirus pandemic.

Civil Áviation Minister Hardeep Singh Puri had announced on Wednesday that domestic flights will resume from May 25 in a calibrated manner.

The guidelines said the passengers should expect a slower process at the airport and avoid last-minute arrival.

"Passengers, before entering the terminal, to ensure wearing of protective gear, as per the prevailing requirement. He will continue to wear the mask throughout the journey," it said.

It said the passengers should not travel if they are staying in a containment zone. The passengers who have been tested positive for COVID-19 will not be allowed to travel.

'The passengers are expected to certify the status of their health through the Aarogya Setu app or a self-declaration form," said the ministry's guidelines.

Vulnerable persons such as very elderly with co-morbidities. pregnant ladies, passengers with ailments are advised to avoid air travel, it said.

Airports have been advised to earmark areas for isolation and COVID-19 testing for suspected passengers. Airports should also have separate areas for change of PPE (personal protective equipment) gear by the staff using it.

The guidelines said the airports would have to ensure easy availability of hand sanitisers at all entry points and also to be available at various touch points.

All food and beverages (F&B) and retail outlets to be opened with COVID-19 precautions. Take-away, digital payments, selfordering booths at F&B and retail outlets to be encouraged to prevent crowding, it said.

Mats or carpets soaked with bleach (sodium hypochlorite solution) would be placed at the entrance for disinfecting shoes, it said.

The official spokesperson further said that on being apprised of the issue of protection of shrines; the LG maintained that the Government has already taken up the issue to ensure the safety and security of the shrines and devotees.

Cop Killed, Another Injured In Pulwama Attack...

Kashmir's Ganderbal district.

Unknown militants appeared in Prichoo area of the district this afternoon and fired randomly towards a checkpoint manned by paramilitary CRPF and police personnel, reports said. Two militants were injured in the initial burst of fire that caught the forces off guard.

Both the policemen were removed to the district hospital Pulwama for treatment. However, the doctors there declared one of the cops identified as Anoop Singh of IRP 10th battalion as brought dead on arrival.

Medical Superintendent, District hospital Pulwama, Dr. Jameel Ahmad told Kashmir Observer that one policeman was brought dead to the hospital while another had received multiple gunshot injuries.

"We referred him to Srinagar hospital for advanced treatment." he added.

The injured cop has been identified as Mohammad Ibrahim. Meanwhile, the militant attack created panic in several villages of the district prompting people to stay indoors.

According to reports, additional forces reached the shootout spot and started a search operation to nab the attackers. Apart from Prichoo, Karimabad and Wagum areas were also placed under siege and search operation was launched.

Pertinently, this was the second attack on state forces in the Valley in the last 24 hours. On Wednesday, militants shot dead two BSF personnel at Pandach area of central Kashmir's Ganderbal district.

rinagar: For the first time in almost over 100 years, Kashmir's revered shrines and masjids remained silent on the most revered night of Shabe-Qadr (night of blessings) in the wake of COVID-19 pandemic that has claimed 20 lives in J&K so far and affected nearly 1400 people so far.

Shab-e-Qadr was observed across Kashmir on the intervening night of Wednesday and Thursday. The closure of shrines and masjids across the Vallev known as peer vear (abode of sufi saints), left the religious sentiments of thousands of people hurt who were confined to their houses to pray on this auspicious occasion.

For Abdul Majeed Bhat, a resident of Pampore area of Pulwama district, would travel to the Kashmir's most revered shrine at Hazratbal that houses the holy relic of prophet Muhammad (SAW), ever year on the occasion of Shab-e-Qadr.




As per an ailing Ghulam Muhammad Bhat, who according to his family members, has crossed 105 years of age. this is for the first time in his life that Shab-e-Qadr prayers were not held in Shrines and Masjids.

Bhat, a resident of Bagaat-e-Kanipora on Srinagar outskirts, has been rushing to the historic Jamia Masiid Srinagar, the grand masjid of Kashmir, for Shab-e-Qadr prayers. He has not been able to move out of his house for the past over 10 years due to his ailing health.

"In my childhood, I would walk from Kanipora to Nowhatta to offer prayers at Jamia Masjid. I would often travel on my cycle to reach Jamia Masjid on the occasion of Shab-e-Qadr and Shab-e-Baraat prayers.

At Jamia, one finds solace, and gets satisfaction when Mirwaiz leads the prayers for repentance," said Bhat, who has witnessed sermons of many former Mirwaizeen including Moulana Muhammad Farooq and also the present Mirwaiz Muhammad Umar Farooq.

Major Among 3 soldiers killed

AMMU - An Army Major was among three soldiers killed and an equal number injured when militants ambushed their patrol party in Rajouri district Friday afternoon.

Brigadier General Staff (bgs) 16 corps, Brig. Dhruv Katoch, told reporters the militants ambushed a patrol at Mouhla area in Rajouri district, 160 km north of Jammu. at 11 a.m. "The attack left Major Satyajet Shinde and three soldiers dead," Katoch said.

The attack took place when an army patrol party of 14 Maratha Light Infantry was on its way for an operation in Dharamshal area of the district following a tip off that militants were present in the area, the sources said.

Militants had set-up ambushes at Bandri area in Kalarara forests in the belt and as the troops led by Major Shinday reached the place militants hurled the grenades and opened indiscriminate fire around 1300 hours, they said

Troops took positions and fired back, they said adding that in the subsequent fire fight four army personnel were killed and four others injured.

The bodies of dead and injured were ferried in a helicopter to military hospital in Rajouri, reports said. The condition of two injured jawans is reported to be serious, they said. Hizbul Mujahedin has claimed responsibility for the attack. Brig Katoch was quoted by reports Friday evening saying that additional troops have been sent to the area and a fierce gunbattle was going on.

Meanwhile in a separate incident in the same district an army jawan was critically in-jured in a landmine blast near the Line of Control (LoC) to-day. Army sources said Sepoy Ajay Kumar inadvertently stepped over a landmine near LoC in Rajouri while he was on routine patrol in the area. In the explosion, Ajay sustained critical injuries. He was airlifted to army command hospital in UIdhampur

Another soldier was injured when militants triggered a powerful Improvised Explosive De-vice (I ED) at Komoh Kulgam in south Kashmir today.

Remember Your Brethren in Distress

id-ul-Fitr follows a period of unmitigated distress in the Valley. Ever since the revocation of the Article 370 in August last, Kashmir has been in a lockdown. It was only by February that the Valley had partially emerged from a six month long siege. But within a month and a half of some relaxation, the Valley was plunged into another lockdown. Though COVID-19 lockdown across the country has been strict, it still can't beat the severity of the post August 5 Kashmir siege. Unlike India or anywhere in the world, Kashmir had no means of communication, not even a landline, used by a small number of people, for a month. Mobile phones were restored after three and a half month and the slow-speed 2G internet after six months

In the process, Kashmir had to bear a colossal loss to its economy: As a local business body has calculated, the Vallev lost an estimated Rs 18000 crore in six months of siege followed by around Rs 13000 crore more in the lockdown over the past two months..Tourism, one of the mainstays of the local economy has come to a halt. This has hit the hotel industry and travel operators hard. The handicrafts sector has been crushed. The fledgling IT industry and the start-ups have been wiped out. Ditto for Horticulture, a Rs 6500 crore industry, Its fallout on the livelihoods of people has been far-reaching. Lakhs of people have lost jobs. What is more, there is little hope to look forward to. Recent rise in violence has further deteriorated the situation turning lives of many more people upside down. For example, the recent razing of 15 houses at Nawakadal during an encounter between militants and security forces. These people have nowhere to go

While we celebrate Eid, a festivity which is incumbent on all Muslims, we need to be mindful of the immediate tragedy that has befallen a large section of our society, over and above the trauma and grief that we have been experiencing for the past three decades. This calls for us to be much more austere in our celebration. We need to show that we care on Eid too. Those of us who can afford to spend should instead donate the amount they would otherwise spend on consumables for their brethren in distress. Same goes for the people who spend lavishly on Eid feast. They would earn more Sawab and God's goodwill should they also contribute some amount to the people who have nothing. Let this Eid further strengthen and sustain the spirit of community effort that has made us resilient in the face of worst adversity.

Law As Weapon

dharna in Agra over the movement of buses to ferry migrant labour led to the arrest of the Uttar Pradesh Congress chief Ajay Kumar Lallu and two of his party colleagues — all three subsequently got bail. Amongst the laws weaponised by the UP police to detain the Opposition leaders is a late-19th century statute, The Epidemic Diseases Act. Drafted by the colonial state in 1897 "to take special measures and prescribe regulations" for "the better prevention of the dangerous epidemic diseases", the law has been summoned in the past to deal with outbreaks of cholera, swine flu and dengue. But its heavy-handed and arbitrary use, or misuse, during the fight against the COVID-19 pandemic is new. Patients, journalists and Opposition leaders have been at the receiving end of this blunt instrument that does not actually define an epidemic, leave alone a pandemic. Of course, combating COVID-19 does require extensive surveillance, including identification of the carriers of the virus and their contacts. But in most parts of the world, including India, a growing body of literature has underlined that such extraordinary measures are best undertaken by taking citizens into confidence, using persuasion and involving the community. At several places, however, the state authorities are giving the go-by to these imperatives and asserting state power in heavy-handed ways, by taking cover under Clause 4 of the Epidemics Act — actions taken under the law are provided immunity from "legal proceedings" for they are deemed to have been "undertaken in good faith". In early April, when knowledge of the virus was still uncertain among large sections of the people, an FIR was slapped against the family of a Bengaluru technician, who had contracted COVID-19, for "hiding information", and they were charge-sheeted under the Epidemics Act. Also last month, the Mumbai Police invoked the law to arrest a journalist, alleging that his social media posts led to unrest among migrant workers in suburban Bandra. A toxic mix of the Disaster Management Act, 2005, Section 144 of the CrPC and the Epidemics Act may well be on its way to becoming the new sedition law, which has been invoked with disturbing frequency in the recent past to criminalise criticism and dissent. Last week, the Gujarat government combined the sedition law with the Disaster Management Act to charge a journalist for reporting that Chief Minister Vijay Rupani may be removed by the BJP High Command for his handling of the pandemic. Also last week, this paper reported that at least four FIRs have been filed against journalists in Himachal Pradesh for highlighting the condition of stranded labourers in the pandemic. The FIRs allege that these reports are "fake" and "sensational" news; the cases are being investigated. But governments must realise that the discourse on citizens' rights and public health has moved on from the times when the colonial government charged Bal Gangadhar Tilak for sedition for criticising its handling of the 1897 bubonic plague. Else, the Supreme Court must intervene to allow people to voice their opinions freely during a crisis, and especially in a crisis, without the threat of their being criminalised.

Seldom have so many lives been lost across continents in a single tragic event.

Deep economic impact

By now, India has surpassed China with regard to the number of confirmed COVID-19 cases, and has moved past the figure of 100,000 cases. What distinguishes the present pandemic from earlier ones is its economic impact, which is perhaps even more threatening than the human costs involved. In the case of India, all forecasts have had to be shredded. Job losses have been massive, specially in urban areas. India's exports in the month of April, for instance, were the worst in the past 30 years. The harrowing plight of India's migrant workers and the images of hungry, aimless, dispossessed migrant worker families trudging along the highways of the nation have seared the conscience of the nation. It could well have been equated to China's May Fourth Movement (1919), except that, unlike in the case of China, the event has yet to catalyse the nation.

Well before this, India had been witnessing a persistent economic downward slide. The pandemic could, thus, not have come at a more inopportune moment. Prime Minister Narendra Modi's announcement of a 20-lakh crore stimulus package was, hence, timely even though economists now believe that in real terms it amounts to around 2% of GDP rather than 10% as the government makes out. Finding resources for even this stimulus package will, however, not be easy. The Centre's finances are not in the best of health. It has already had to resort to a second tranche of \$1 billion loan from the World Bank to support CO-VID-19 relief measures. The finances of States are, to say the least, in a perilous state. Questions are, thus, bound to be raised as to whether adequate funds would be forthcoming for relief purposes.

A valid criticism is that the patchwork of stimulus packages reveals a disjointed mosaic of ideas and thoughts. Also, that these would be more relevant to a Budget discussion than a stimulus package. It is indeed difficult to see how in the absence of a proper and well designed plan, a patchwork of stimulus packages would enable India to return to growth rates of 7% to 8%

In the extant circumstances, comparisons with China have. hence, become inevitable. China may not have anticipated the latest COVID-19 pandemic, but since its early recovery, China has followed a calibrated approach — one that stems from a policy of deliberate strategic progression conceived over the years. It may be worthwhile to understand the facts so as to underscore the gap that currently exists between China and India

Ever since, China has embarked on not only attaining economic and technological progress but also in defining how power would be determined in the new globalised era through devising new international norms in many emerging domains such as cyber, space, artificial intelligence, etc.

Setting the standards

China also set about rewriting international rules, premised not so much on governing where global goods are made, but on setting standards that define production, exchange and consumption. China Standards 2035 plans to set new standards with regard to the Industrial Internet of Things (IIoT) and define next generation information technology and biotechnology infrastructure. China is hoping, thereby, to reap the "early bird" advantage, even as other industrial nations struggle to recover from the devastation caused by the COVID-19 pandemic. Internationalisation of Chinese standards would provide China a clear advantage by providing it an opportunity to set the standards in emerging industries such as high-end equipment manufacturing, unmanned vehicles, new materials, cybersecurity and the like. This would enable it gain a dominant position in the global economy.

The 19th National Congress of the Communist Party of China (2017), thereafter, gave its imprimatur, considering it essential to enable China to achieve pre-emi-

Admittedly, there is a great deal of talk of companies demitting China at this time, partly due to the pandemic and partly due to other reasons. India would more than welcome some of the entities exiting China, but there are no "green shoots" to suggest that such a shift has, or is, about to take place. Many alternatives are available to these companies and it would be excessively optimistic on our part to hold on to the belief that India is the only alternative choice for most of them.

"We're already late this year due to the situation," says 24-year-old Jaheen, who belongs to a Muslim nomadic tribe that has already embarked on their traditional journey

Due to strict lockdown and fear of catching coronavirus, the tribals had to halt their caravan.

Gujjars and Bakarwals bi-annually migrate to the lower, middle, and higher mountain ranges in the northwestern Himalayan mountains, with their cattle, which is their source of livelihood.

These tribal communities constitute around 15 to 20 per cent of the total population of J&K.

Amid lockdown, Jaheen has ration for a few days. After that, he says, he'll be dependent on external sources.

Almost every shop is closed and he doesn't know for how many days he will manage with the food he has. The trail which he has been taking for a long time is closed. Earlier, an advisory was issued for the safety of pastoralists and chopans by the office of the district sheep husbandry officer Bandipora on April 17. The advisory states that Gujjars

and Bakarwals traversing the long distance from different parts of J&K should avoid the intermingling of transit camps. It advises to avoid taking old aged persons, women, and children for the journey. They can join them once the pandemic is over.

The advisory restricts the movement of the nomads through the red zone areas. It promises the establishment of first aid camps from May 15 at various transit routes for the welfare of the livestock.

The government has also reportedly disallowed vehicles and milch animals (cows and buffaloes) to go along with these gypsies.

In response to the issue, the J&K Advisory Board for Development of Gujiars and Bakarwals have written to the district magistrates of Jammu, Samba, Kathua, Udhampur, Kishtwar, Doda, Poonch, Rajouri, Reasi, and Ramban. The letter states the inconveniences caused by the order and requests the magistrates to include "pet animals in the permit as per past

practice after proper verification" to solve the tribal communities' problems while migrating.

To create awareness about COV-ID amongst the nomadic Gujjar and Bakarwal communities, the government made Indian army to distribute pamphlets in bilingual language in remote areas.

Already, Gujjars are facing hate campaign for being the "carriers of coronavirus" pertaining to the Tablighi Jamaat gathering in Delhi's Nizamuddin in March this year.

The congregation is being termed as "a COVID hotspot" as several participants who attended the gathering are tested positive for the virus.

Children Will Miss The Power Of Touch

child psychiatrist friend and I were recently discussing how her adult daughter and three-year-old granddaughter came to visit her in her back yard. They were masked and stayed six feet away. The child, who throughout her infancy and right up until the appearance of Covid-19 had been picked-up and soothed and coddled by her loving grandmother, now found herself sternly disciplined for repeatedly running over to be picked up by her. How will this sudden interdiction of grandmotherly hugs, kisses, and nurturing impact this child? And more generally, what effect will the social distancing that surely will be imposed on child-to-child contact have on children in the months and years to come?

I approach these questions by drawing upon my understanding of the critical importance of affective parental nurturing in establishing an infant's neural pathways of connection, and the follow-on role of inter-child, non-sibling free play in instilling socialisation skills in young children.

Humans are small-pod herd mammals, like certain of the great apes, elephants, and the cetaceans (whales, dolphins, and porpoises). Each of these species suckles and nurtures their young, and their offspring press against them for comforting and connection. Humans, of course, do far more holding and touching of our young and we do so over a much longer time. We invest years in holding, hugging, kissing, bathing, and dressing our offspring - all in response to the identical soothing touch we ourselves enjoyed as infants.

Thanks to contemporary brain imaging techniques, we now know that the physiological effect of parental loving touch is the biochemical imprinting of the neural pathways of connection that children



later use to approach and bond with others. We humans, in other words, actively train our offspring to seek soothing and loving touch in their connections with others. These activities are very much required for the survival of our species - just as other species actively train their young in the skillsets they will need to keep safe from predators, hunt for food, and find their way to water.

If phase one of learning how to connect is an infant's experience of loving parental - (and grandparental!)-soothing touch, phase two involves the critically important social lessons children learn from each other during free play and unstructured activities. This is where they learn and hone their social skills: how to become included in a circle of friends, how to survive the pain of rejection, and how to recognise and deal with bullies. Remember those thousands of hours spent interacting with other children in the school hallways, at recess, on the play field, on your neighbourhood streets, and in those endless summers of childhood? Think about how physical those interactions were - the running together, the holding of hands, the pushing and shoving, and then, later, that first kiss. The playful wrestling and nipping at each other of young puppy and kitten littermates provides is the parallel to the physical horseplay of human children. That's just the kind of mammal we are

Google Ai Could Predict Eye Condition Behind Vision Loss

TEHRAN- Iran will support any nation or group that fights Israel, Supreme Leader Avatollah Sayed Ali Khamenei said on the eve of annual Quds (Jerusalem) Day while a poster showing Palestinian flag



raised over Al-Aqsa Mosque was released on his official website. The image depicts Jerusalem being captured from Zionist state by the Iran led resistance axis.

'We will support and assist any nation or any group anywhere who opposes and fights the Zionist regime, and we do not hesitate to say this," Iran leader said in a post on his official English-language Twitter account.

Iran, Israel's arch-enemy in the Middle East, has been a key supporter of Syria, a frontline Arab country bordering Israel and resistance groups like Hamas and Hezbollah in Gaza and Lebanon.

Israel, which monitors neighboring Syria intensively. has carried out hundreds of air strikes in Syria targeting suspected arms and troop movements by Iran and Hezbollah guerrillas that have bases across areas bordering Israel now.

Earlier his website displayed a poster and text above the image says: "Palestine Will Be Free. The final solution: Resistance until referendum."

The poster evoked a sharp reaction from US and Israeli officials including Benjamin Netanyahu and US secretary of State Mike Pomeo.

Ayatollah Khamenei said that Iran's enmity toward Israel was not the same as hostility toward Jewish people.

"The elimination of the government of Israel does not mean the elimination of Jews. We don't have an issue with Jewish people," he said.

"Elimination of Israel' means the Muslim, Christian and Jewish people of Palestine choose their own government themselves and push out foreigners and thugs like [Israeli Prime Minister Benjamin] Netanyahu," the post added.

Iran leader is scheduled to speak on Friday to commemorate Quds Day.

Iranian leaders have frequently called for the abolition of the state of Israel which was formed in 1948.

In a statement on Thursday Iran;s Revolutionary Guard or the IRGC condemned the continued occupation of Palestine and said, "This old wound continues to afflict Muslim and freedom-seeking nations around the world, and the issue of Palestine still tops (our) major regional, international and Islamic concerns.'



WHO Warns Against Using Hydroxychloroquine Outside Clinical Trials

Geneva: A senior official of the World Health Organization (WHO) has warned against hydroxychloroquine using or chloroquine, the drugs for malaria and other diseases, in the treatment of COVID-19, saying these drugs should be reserved for use "within clini-

cal trials' Responding to question on hydroxychloroquine or chloroquine being used to treat COVID-19 patients in certain countries, Dr Michael Ryan, executive director of the WHO Health Emergencies Programme, told a press conference on Wednesday that, despite that both drugs are

already licensed for many dis-

eases, at this stage, they "have

been as yet found to be effective in the treatment of CO-VID-19 or in the prophylaxis against coming down with the disease", Xinhua reported.

"And in fact the opposite, warnings have been issued by many authorities regarding the potential side effects of the drug and many countries have limited its use to that of clinical trials or during clinical trials or under the supervision of clinicians in a hospital setting that's specifically for COVID-19, because of a number of potential side effects that have occurred and could occur," Ryan stressed.

"Having said that, again it is for each national authority to weigh and assess the evidence for and against the use of this drug," he added.

Ryan said that hydroxychloroquine and chloroquine are included in the ongoing "solidarity trials" that take place across multiple countries. "And as WHO, we would advise that, for COVID-19, that these drugs be reserved for use within such trials."

Dr Maria Van Kerkhove, technical lead of Health Emergencies Programme, noted that "As of today we have more than 3.000 patients enrolled from 320 hospitals in 17 countries, and so that's a show of solidarity and called the solidarity trial, but it's really a show of collaboration and willingness to work towards a common goal of understanding which therapeutics are safe and effective against CO-VID-19".

US arrests 2 men accused of smuggling ex-Nissan boss out of Japan in a box

ashington: A former Green Beret and his son have been arrested in Massachusetts on charges they smuggled Nissan Motor Co. Chairman Carlos Ghosn out of Japan in a box while he awaited trial there on financial misconduct charges.

Michael Taylor, a 59-year-old former Green Beret and private security specialist, and Peter Taylor, 27, are wanted by Japan on charges they helped Ghosn escape the country in December after he was released on bail.

The Taylors were arrested by the US Marshals Service in Harvard. They appeared before a federal judge from jail via video conference, wearing orange jumpsuits and tan face coverings because of the coronavirus pandemic.

Assistant US Attorney Stephen



Hassink said Japan plans "as quickly as possible" to submit a formal request to extradite the Taylors.

An attorney for the Taylors said they plan to challenge Japan's extradition request "on several legal and factual grounds."

"Michael Taylor is a distinguished veteran and patriot, and both he and his son deserve a full and fair hearing regarding these issues, both before the courts and the executive branch," Paul V. Kelly said in an email.

Pakistani man arrested for killing 2 teenage girls over leaked video

slamabad: Police in Pakistan's North Waziristan has arrested a man suspected to have killed two teenage girls in the name of 'honour' after a short mobile video of them with a young man surfaced online, the media reported on Thursday.

The girls were gunned down on May 14 in Shamplan Garyam village after their 'objectionable' video footage went viral on social media, said the Dawn news report.

On Wednesday, North Waziristan district police officer Shafiullah Gandapur said the suspected killer, Mohammad Aslam, who was a cousin of the two girls, was held during a raid in an unidentified location.

He had gone into hiding after the murders.

Earlier in the day, a central character of the incident, Umer

Ayaz, confessed before a local court that he had recorded the video.

A senior police official said Avaz told the court that he used the mobile phone of his friend, Fida Wazir, who had already been held by the police.

Meanwhile, Khyber Pakhtunkhwa Inspector General of Police Sanaullah Abbasi announced cash reward and commendation certificates for police officials over arrests in the honour killing case.

Besides Aslam, the police police have arrested four suspects in the case-Ayaz, Fida Mohammad, father of one of the girls, Zadwal Khan, and the girl's cousin, Roohuddin.

The police claimed that the family of the deceased had kept the killings a secret, so the relevant station house officer registered the FIR as the complainant, reports Dawn news

NEW DELHI- More than 50 million people in India do not have access to effective handwashing, putting them at a greater risk of acquiring and transmitting the novel coronavirus, according to a study.
