# **J&K Reports 3 Covid-19 Deaths In Single Day**

SRINAGAR: Coronavirus on Monday claimed three more lives across Jammu and Kashmir, raising the toll due to the deadly disease in the Union Territory to 31, officials said.

Dr Mir Mushtaq, Deputy Medical Superintendent District Hospital Pulwama said a 70-yearold-man was brought dead to the hospital this morning. "His swap sample was taken which came out to be positive now," he said.

The body was kept in hospital mortuary and would be handed over to the family as per covod-19 protocol.

"The man had comorbidities like COPD," he said.

Earlier, a 72-year-old man with comorbidities from Doda and a 45-year-old man from Shopian died at SKIMS Soura.

### China Flies Fighter Jets 30-35 Kms From Eastern Ladakh: Report

**SRINAGAR:** Amid rising tension and buildup by the two nuclear countries along the Line of Actual Control (LAC) in Eastern Ladakh, the Chinese People's Liberation Army (PLA) on Monday flew fighter jets around 30-35 kms near the contested area fueling fears of border escalation.

According to Asian News International (ANI), the Chinese army have kept a fleet of around 10-12 fighter aircraft at Hotan and Gargunsa at the moment and they are also carrying out flying activity close to the Indian Territory. **People Living On Higher Altitudes** Less Vulnerable To Covid-19: Report

**NEW DELHI:** Researchers have higher altitudes, especially 3,000 level, significantly report lower levels of coronavirus infections than their lowland counterparts.

The Washington Post cited one peer-reviewed study, published in more than 4,000 lives nationally. the journal Respiratory Physiology & Neurobiology, in which researchers from Australia, Bolivia, Canada and Switzerland looking at epidemiological data from Bolivia, Ecuador and Tibet found that Tibet's infection rate was "drastically" lower than that of lowland China, three times lower in the Bolivian Andes than in the rest of the country and four times lower in the Ecuadoran Andes

## **'Dragon Is Already On Our..** Local villagers are equally sulking over the government's 'in-

ability' for not taking "enough measures" to protect their land. "People want that both the countries should talk and resolve this issue once for all," Councillor Korzok Gyurmet Dorjey of Changthang area told Kashmir Observer.

"The Chinese Army has already occupied at least three grazing lands in January and February this year." The captured pasturelands, he said, are the only source of livelihood for the nomadic people of the area.

"The livestock is running short of food, as the nomads aren't being allowed to go for grazing," he said. "Where will the peo-ple go, and what will they do?"

The main concern among the locals remains whether the land captured by China will be taken back or not.

"Because these clashes will happen, and within the passage of time, everybody will be calm but the matter of concern is, will India re-take its land from the China, and if yes, then how," he said. "And if government fails to protect the land, we will fight with China ourselves."

#### **Fight for Fingers**

Chinese troops have entered at least 3 kilometres in Galwan Valley and captured many fingers of strategic Pangong Tso Lake, Namgial Durbuk, former councillor of Congress party, told Kashmir Observer.

Mountain folds around the lake are called "fingers".

"The Chinese troops have captured 6 fingers out of 8," Durbuk said. "India claims territorial rights up to Finger 8, but its defacto holding extends only to Finger 4.'

After India sent its troops, trucks and artillery guns to Eastern Ladakh to shore up its presence in the areas where Chinese soldiers resorted to aggressive posturing, the people are living in fear.

"It's for the first time," Durbuk said, "people are witnessing such a massive troop buildup near the LAC, where Chinese troops are already patrolling our lands, mounting on our horses.

#### Fear of losing Kashmir with Ladakh

Phunchok Stobdan, India's former Ambassador to Kyrgyzstan, told Kashmir Observer that India should solve the issue immediately with diplomatic and military channels.

"In case China disagrees, then India should go for a war," Stobdan suggested. "If your sovereignty and land are under threat, then what's the option?'

Ladakh, he said, is equally important for Kashmir.

"If India loses Ladakh, then Kashmir will be defenceless," he said

It was Chinese intrusion into Indian strategic points which triggered the fresh standoff. Stobdan, a national security expert. continued.

"Aksai Chin is a plateau and is useless," he said, "but the places like Galwan River, Shayok-Daulat Beg Oldie road are full with minerals and are strategically important and India doesn't want to lose it." But the author of The Great Game in the Buddhist Himalayas: India and China's Quest for Strategic Dominance, Stobdan is facing anger over his recent remarks on Tibetan Buddhist leader Dalai Lama. The former diplomat had raised questions about the Dalai Lama's silence on China's transgressions in Eastern Ladakh. "Dalai Lama has to speak and cannot keep focussing on his prayers while China eats away the land [in Ladakh]. It doesn't work like that. Is he doing it in collaboration with China? What is it? There is some confusion in the strategy. We have let him create a government in Dharamsala. He should offer a clarification that this is not Tibet's land; it is India's," he had said. After his comments created controversy. Stobdan told Kashmir Observer that his remarks were on Dalai Lama's politics not on his religion. "It's unfortunate that people took it otherwise.' As a geo-political person, he said, he can't be responsible for the ignorance of the people. "Fact is, Eastern Ladakh would border Tibet, not China," he said. "But as the China captured Tibet, and is now eating Ladakh, I want to ask Dalia Lama, does he accept that it belonged to Tibet or not?"

"155 new COVID-19 cases were detected in J&K. While 99 of them are from Jammu, 56 are from Kashmir," the officials said. Among fresh cases, 53 cases were reported from Ramban, 21 from Doda, 12 from Anantnag, 11 from Kupwara, 10 from Srinagar, eight from Jammu, six each from Baramulla and Kulgam, five each from Shopian and Kathua, four each from Pulwama and Kistwar, three from Rajouri, two each from Ganderbal and Udhampur and one from Samba., the officials said. They added that 96 persons who tested positive are travellers. The number of confirmed cases has now reached 2,601, out of which 1,999 are in Kashmir, while 602 are in Jammu, they said. At the SKIMS virology lab, the reports of 13people returned positive for coronavirus. Among those, 10 are from north Kashmir's Kupwara, two from Srinagar and another from Shopian district.

However, most of the cases were reported from GMC Srinagar. According to officials, 33 out of 910 samples came out positive for Covid-19. Among those include a doctor at the Government Dental College, Srinagar and nine expecting mothers. Officials from JVC Bemina said that out of 430 samples tested at the hospital. 12 were tested positive among them 8 are from Budgam and 04 from Shopian. At army's command hospital in Udhampur, six people were confirmed to be infected by Covid-19. Among them, 5 are from Ramban and 1 from Doda.

There are 1,624 active cases of the coronavirus disease in J&K - 1,157 in Kashmir and 467 in Jammu – and 946 (815 from Kashmir and 131 from Jammu) patients have recovered, the

officials added. The J&K has witnessed 31 COVID-19 (27 from Kashmir, 4 from Jammu) deaths so far, including three deaths reported on Monday

If the test results are positive, they will be brought to a COVID hospital for recovery and ity to cope with hypoxia (low levels of oxygen in the blood) and a natural environment hostile to the virus -- including dry mountain air, high levels of UV radiation and the possibility that lower barometric pressure reduces the virus's ability to linger in the air, the report further said.

Just three populations in the world have been found to have genetic adaptations to altitude: Himalayans, Ethiopian highlanders and Andeans. Yet Clayton Cowl, a pulmonologist at the Mayo Clinic and a former president of the American College of Chest Physicians, suspects the trend may be more closely related to acclimatization, the body's ability to adjust temporarily to altitude, than to DNA.

Cowl notes that prolonged exposure to altitude triggers a chain reaction in the lungs involving a protein known as ACE2 that might prevent pulmonary shunting, a problem common among COVID-19 patients.

Ordinarily, when a part of the lung is damaged, the body redirects the flow of blood toward healthier areas that are better able to absorb oxygen. Shunting stops that process of redirection, resulting in hypoxia. It is, according to Cowl, a common element among the roughly 30 per cent of COVID-19 patients who exhibit mild symptoms yet have unusually low levels of oxygen in their blood -- and who sometimes take a sudden turn for the worse.

But researchers are still looking for more evidence to establish the high-altitude populations' response to the coronavirus, including the possibility that when infected, they sicken less and are therefore less likely to seek medical treatment or test-

"The virus likes people. It doesn't care about altitude," says Peter Chin-Hong, a researcher on infectious diseases from the University of California in San Francisco.

"But we're still learning so much about this disease, and this does provide us with some good clues to try and understand its progression," he added.

## Lockdown 5.0

India has extended lockdown restrictions to June 30 in the "containment zones". Government is, however, allowing restaurants, malls and religious buildings to reopen from June 8 onwards. The lockdown extension order has come as the country has reported a record number of daily new Covid-19 cases. With over 1.85 lakh Covid-19 cases, India has moved past Germany's 1.83 lakh cases and climbed to eighth from the ninth spot in the list of 10 nations worst hit by the coronavirus pandemic. The number of total deaths linked to the highly contagious illness has crossed the 5,000-mark.

The US has so far reported the highest number of over 18 lakh Covid-19 cases. Brazil follows with over five lakh cases, and Russia with over four lakh cases.

But as the cases are registering a sharp spike, the union government has decided to reopen the hospitality and retail businesses, along with places of worship, but they must keep social distancing rules in place. Similarly, curbs have also been removed on movement of people and goods between states. Government has continued with the practice of night curfew, but timings have been changed to 9 pm-5am from the existing 7 pm-7am. The decision about reopening cinemas, schools and international flights will be taken after an assessment in the next few weeks.

The government is gradually moving towards re-opening the economy as it fears the economic fallout from stayat-home measures will be worse than the virus. Indian economy like the economies elsewhere in the world has already gone into recession. In India, its impact has been devastating. Millions of people have lost jobs. Millions of migrant labourers have lost livelihood and shelter in the cities forcing them to go back to their homes in the villages. This has triggered a massive suffering in its wake. And it will only get worse if the economy is not reopened.

Government has thus done well to take steps towards resuming the economic activity. In the west too, the governments are similarly moving towards getting back to normal life. And this is happening even as the Covid-19 cases are spiking and the experts are warning of a second wave of infections. This is a serious apprehension. But the further damage to the economy will be a cure worse than the disease. More so in a country like India where a significant population lives below the poverty line. In the absence of jobs, people will die of hunger. Government is therefore doing well to unlock the economy. It should, however, make the businesses accountable for any laxity in implementing the norms of social distancing..

## Sobering signals

he GDP data released by the National Statistical Office on Friday affirms three disconcerting trends. First, the economy had slowed down considerably, even before the national lockdown was imposed to contain the spread of the coronavirus. The revised data for the first three quarters of the previous financial year indicates that the slowdown was more pronounced than was previously believed. Second, the lockdown has made matters worse. And as the data on the eight core industries for April indicates, the economic distress is likely to be more severe than expected. Third, the headline growth number is being driven by only two sectors agriculture and government.

At the aggregate level, growth in gross value added slumped to 3 per cent in the fourth quarter of the last financial year. While growth was above expectations, as it is based on a limited set of data on earnings — timelines for submitting financial returns have been extended - the numbers are likely to be subject to downward revision as and when more data is available. Agriculture and public administration and defence, which largely reflect government, continue to drive economic activity. Excluding them, gross value added by the remaining economy grew by a mere 1 per cent in the fourth quarter. The manufacturing sector has now contracted for three straight quarters, with the pace of contraction deepening. Similarly, the construction sector has also now contracted for two straight quarters. Trade, hotels and communication have slowed down considerably, as have finance, real estate and professional services. On the other hand, private consumption growth slumped to 2.7 per cent in the fourth quarter, down from 6.6 per cent the previous quarter. And with households cutting back on discretionary spending, private consumption is likely to moderate considerably this year. Investment activity continued to be moribund, contracting now for three consecutive quarters, notwithstanding government spending on infrastructure.

Leading economic indicators paint a grim picture. The index of eight core industries contracted by 38 per cent in April, with all sectors registering a contraction. Exports declined by 60 per cent in April, while non-oil non-gold imports fell by 52 per cent, indicating weak domestic demand. However, there are some signs of economic activity picking up, though marginally, in May. While electricity generation had contracted by 22.8 per cent in April, the pace of contraction eased to 14.9 per cent in May — indicating that the gradual lifting of restrictions has led to the resumption of some economic activities. In large part, how economic activity now shapes up will depend on the easing of the lockdown restrictions, and the success in containing the virus. While one will have to wait for the April-June quarter GDP data to gauge the full impact of the lockdown on economic activity, given the problems with data collection during this period — the NSO was unable to fully capture retail inflation data it is possible that the paucity of data makes it difficult to accurately assess the damage to the economy during this period. Because we expected bit more effort from your side because we all are connected to this film emotionally.

At last, we would again like to thank you for encouraging us by writing back. And, if you have any plans of again shooting in Kashmir, we would be happy hosting you at our respective places. Perhaps, you may agree to our wish of making a film on the Gaw Kadal massacre as a tribute to your Kashmiri Muslim community. We would love to assist you in that film even if you aren't convinced with the idea of making a film on it. Our love and support would always be with your films no matter how they represent us. Because, we have been taught to give love regardless of the outcomes.

# Backstory of Ladakh's Galwan Valley and the legend of Rassul Galwan

HINA AND INDIA — the world's two most populous countries which had fought a fullfledged war in 1962 — are now facing a stern test once again as their militaries are in an eyeball-to-eyeball confrontation at a few places along the Line of Actual Control (LAC) in the Ladakh region. Alongside the main story of border tensions, skirmishes and alleged incursions, there lies a strategic importance of the Galwan Valley in the restive region.

But how this valley was named Galwan? And what is its backstory?

Several historians, scholars and experts of Ladakh affairs are of the view that Galwan Valley was named after Rasool Galwan. According to the book Forsaking Paradise: Stories from Ladakh, Ghulam Rasool Galwan or Ghulam Rassul Galwan had arrived in Leh in 1895.

"In the year 1895, after a hazardous journey of one year and three months in Central Asia and Tibet, Rasool Galwan, and his companions arrived in the village Thiksey. Another day's journey and they would reach Leh and be reunited with their family members," the book reads. "The river Galwan originates from the Aksai Chin

What is lesser known is the fact that the river valley is named after a native explorer of Kashmiri descent Ghulam Rassul Galwan, whose forefathers belonged to the famed Galwan (the Galawan) tribe of Kashmir," writes Waris Ul Anwar, a PhD scholar at the department of history, Aligarh Muslim University, in a Kashmir-based news portal.

Ghulam Rassul Galwan earned fame as well as notoriety for various reasons. He also penned down a book titled Servant of Sahibs: A Book To Be Read Aloud.

As the Galwan Valley is in the news for all the wrong reasons, Jammu and Kashmir's social media space is abuzz with the legend of Rassul Galwan and his book. Reports suggest that some are looking forward to reading Servant of Sahibs during the lockdown period.

Social media enthusiasts are even uploading cover picture of the book which also includes an introduction by British explorer Sir Francis E Younghusband. Some in Kashmir are revisiting history by debating the life and adventures of Rassul Galwan. They say this has resulted in enhancing people's interest in reading more about Ladakh's past to understand the present.

"Today I post the cover of book no: 2 (out of 10) I could lay my hands on. This is in response to what my friend Jaspreet Kaur asked me to do. I request my friends to do the same to excite the curiosity/attention/ interest of people in book reading," wrote Dr Ahad Abdul on Facebook. Dr Ahad is known for his interest in Kashmir's history.

According to Dr Ahad's claim, Servant of Sahibs "is an important book on the life and times of early twentieth century Ladakh and some parts of Central Asia authored by an illiterate Galwan whose ancestry is rooted in the Kashmiri community historically known for their banditry. The illustrious author Rassul Galwan became a trusted assistant to various nineteenth century European explorers."

He says that the book "is the first and perhaps the last of its kind to have found its due space in the most prestigious publications of the famous Cambridge University." "Setting off at a young age, Galwan was soon to be found in the company of adventure travellers like Sir Francis Younghusband, who explored the Tibetan plateau, the Pamir mountains and the deserts of Central Asia. Quietly bringing up the rear of these nowfamous caravans was Rassul Galwan. Having taught himself how to run the expedition, the intelligent mountaineer was soon turning his talents to acquiring languages, picking up a working knowledge of Chinese



and English, among others. It was with this rudimentary English vocabulary that Rassul Galwan authored Servants of Sahibs, the only account of its kind."

Rassul Galwan is said to have written about his life of journeying and adventures in his book. The foreword of the book is written by British explorer and a leading figure in The Great Game between the British and Russia, Francis Younghusband.

In his foreword, Younghusband writes: "Why Himalayan peoples should be ready as they are to undergo hardships, and run risks of the most serious nature, in the service of stray traveller who appears among them is not easy to understand. The payment they receive is small. They have to work for much more than eight hours a day... Yet they readily work through long and arduous days and willingly risk their lives. And, most wonderful of all, they are full of gratitude to their employer when they leave his service. In this book we get an answer to the puzzle."

Rassul Galwan begins his book in flawed and broken English. "This told my mother. Long years before, in Kashmir hills, were herds of ponies belonging to Maharaja, and were very many people to watch to them, on those mountain pastures. One those people, after, become a robber. His name was Karra Galwan. Karra was his name (means: black). Galwan means robber."

The author describes Karra as a strong and clever Galwan (robber), who robbed houses of the rich. "Karra gave much money poor men. Rich men in Kashmir very hard men, never gave money to poor men."

He says that after the arrest of Karra, many of his family (members) moved out of the Valley fearing the Maharaja's forces. He says that one of his great grandfathers had even moved to Baltistan (part of the Gilgit-Baltistan region) and from there to Leh.

Many Galawans moved to Yarkand in Xinjinag Uyghur Autonomous Region. Later, Rassul travelled to Yarkand with, whom he calls, "Captain Younghusband."

There are varied views on popular Ladakhi exlorer and adventurer Ghulam Rassul Galwan, and his their dark complexion suggests that they are not of the same race as the Kashmiri peasants. Others think that the Galawans are the descendants of the Tsak tribe. But as far as I know there is no evidence to support the latter theory," Jammu and Kashmir's first-ever Settlement Commissioner, Sir Walter R Lawrence, writes in The Valley of Kashmir.

According to Lawrence, "Originally, they (Galawans) earned their livelihood by grazing ponies, but as time went on they found it more remunerative to steal them, and they eventually developed into an established criminal tribe." The Galawans, according to Lawrence's account, "earned notoriety in the days of Pathan rule, and when the Sikhs took over Kashmir the Galawans were a terror to the country." (The Valley of Kashmir by Walter Lawrence, p. 311).

He also claims that the Galawans would frequently attack wedding-parties and even carry off the bride. They were also known for their bravery and daring attitude. Lawrence says that Dogra Maharaja Ranbir Singh had "finally sent them as colonists to Bunj. Many of the Galawans have, however, returned to Kashmir, and ponylifting frequently occurs. The ponies are carried off to Poonch, where they are disposed of with ease and safety."

The term 'Galawan', according to him, is also "used to describe a man of violent and predatory habits, and it is said by the villagers that the Galawans in their capacity of horse-keepers, often kill a young foal and eat it, returning the skin to the unfortunate owner."

A Kashmiri proverb "Galawans karun gur hawale" roughly means to hand over the horse to the 'horse-keeper' (read horse stealer).

Meanwhile, the confrontation between the armies of India and China has been reported at Hot Springs in Chang Chenmo River valley, and at Demchok, according to a recent article by Lt Gen (retired) HS Panag in The Print. Media reports have alluded to intrusions and face-offs in the Galwan River on the northern bank of Pangong Tso.

## Why Is Black America So Angry Right Now? Crisis deepens in the US as violence erupts in cities across the country

s if US authorities didn't have enough to worry about in this age of Covid-19 which has led to economic devastation and massive unemployment, justifiable fury over the murder of yet another unarmed African American at the hands of police has erupted into widespread civil unrest not seen since the 1960s.

Night after night the downtown areas of almost every major city, including the capital, have been besieged by looters and arsonists causing governors to call out the National Guard.

Clearly black Americans have had enough. The killing of George Floyd, arrested over his possession of an allegedly forged \$20 note, was hard to watch. Struggling to breathe with a knee pressing down on his throat he called for his mother. He was held on the ground by three uniformed officers for nine minutes.

African Americans along with decent people of all ethnicities are appalled by the culture of police brutality towards certain communities, a culture that has been tolerated as the norm since the Jim Crow apartheid era that established different laws for blacks and whites

In spite of several videos to the contrary, those responsible falsely claimed he was resisting arrest. To date, only one, Derek Chauvin, has been arrested and charged.

The killing echoed that of another black man, Eric Garner, by New York City police officers who sat on his head

ignoring his pleas "I can't breathe".

The list of Black Americans whose lives were cut short by police or white vigilantes, like the father and son who shot and killed Ahmaud Arbery while he was jogging through a white neighbourhood in Georgia, is too long to reproduce here but suffice to say that the perpetrators are often given a mere smack on the wrist.

For sure, African Americans along with decent people of all ethnicities are appalled by the culture of police brutality towards certain communities, a culture that has been tolerated as the norm since the Jim Crow apartheid era that established different laws for blacks and whites.

#### Equal rights legislation - only on paper

The 1950s civil rights movement was successful in bringing about equal rights legislation at least on paper. But the facts tell a different story. Institutional racism is alive and well not only deep within the structure of policing but also the judicial system whereby black Americans receive longer custodial sentences than their white counterparts who commit the same crime.

Data shows that the Los Angeles police search four times as many black and Latino drivers than white. The New York Civil Liberties Union reports that stopand-frisk measures have overwhelmingly targeted African Americans and Latinos.

Last year out of 13,459 stops in New York 59 per cent were black, 29 per cent Latino and just nine per cent were white. It is not surprising that black parents who fear for their sons warn them to avoid the police who more often than not act first and ask questions later.



Peaceful protesters and militants are chanting George Floyd's name while regurgitating the mantra 'Black Lives Matter' but what they want besides justice and recompense for Floyd's family is an overhaul of the system that relegates minorities to second class citizens.

It is no accident of fate that three times as many African Americans have fallen victim to Covid-19 than white people. The US Health Secretary says the black community has "greater risk profiles" in terms of obesity, diabetes, and hypertension, with no mention of those factors — joblessness, poor housing, lack of health insurance and high levels of poverty — that contribute to ill health.

#### **Right of African Americans**

The right of African Americans to be hurt and angry is incontestable but how the federal government and the governors of states stricken by violence channels that rage is paramount to obtaining a peaceful outcome.

Will the grievances suffered by black communities be listened to and addressed or will there be crackdowns akin to throwing petrol on the flames?

The violence which has destroyed the livelihoods of small business owners, incinerated buildings and destroyed private vehicles cannot be allowed to continue and that requires the kind of leadership geared towards bringing people together.

Where are the influential voices capable of speaking up on behalf of black youth? CNN anchor Don Lemon literally pleaded with African American politicians and celebrities to lend their voices to the cause instead of worrying about the effects emotion could have on their "brand". He called upon Oprah, Barack Obama, Beyonce and others to take to their airwaves to show their support.

Can President Trump be the glue that brings peace to his nation? Given his statements thus far, I am not hopeful. His unfortunate tweet "When the looting starts, the shooting starts" flagged by Twitter as glorifying violence was indicative of his mindset.

He has called protesters "thugs" and said if those gathered outside the White House had breached the fence, "they would have been greeted with the most vicious dogs and most ominous weapons I have ever seen". A "them-and-us" scenario must be avoided at all costs to prevent a race war brewing.

In 2010, a Falcon 9 rocket on the launch pad had a cracked nozzle extension on an engine. Normally that would mean rolling the rocket off the pad and a fix that would delay launch more than a month.

But with Nasa's permission, SpaceX engineer Florence Li was hoisted into the rocket nozzle with a crane and harness. Then, using what were essentially garden shears, she "cut the thing, we launched the next day and it worked", Reisman says.

Musk is SpaceX's public and unconventional face – smoking marijuana on a popular podcast, feuding with local officials about opening his Tesla plant during the pandemic, naming his newborn child "X Æ A-12". But insiders say aerospace industry veteran Gwynne Shotwell, the president and chief operating officer, is also key to the company's success. "The SpaceX way is actually a combination of Musk's imagination and creativity and drive and Shotwell's sound management and responsible engineering," McDowell savs.

But it all comes back to Musk's dream. Former Nasa chief O'Keefe says Musk has his eccentricities, huge doses of self-confidence and persistence, and that last part is kev: "You have the capacity to get ward where you're trying to go." For Musk, it's Mars.

Augmented Reality In Retail And E-Commerce Can Improve Online Shopping Experience

ugmented reality (AR) has moved to the retail and e-Commerce industry where it is a great tool for attracting new customers, say researchers, suggesting that AR can improve online shopping.

The survey, published in the 'Journal of Fashion Marketing and Management', found that online computer, phone or tablet screen shoppers return 70 per cent of the clothing they order, more than any other category of purchase.

This has an indirect but real impact on the environment. Online shoppers tend to order multiple sizes and colours, with the intent of sending back the items that don't fit or aren't the right colour, a practice known as "bracket shopping". "An AR tool allowing shoppers

to see an image of themselves in the garment, however, made them more likely to want to buy it," said study researcher Fatma Baytar from technology were mixed. the Cornell University in the US.

While not as effective as physically trying it on, the researchers found that AR boosted the participants' attitudes toward the garment, potentially improving the experience and efficiency of online shopping.

For the findings, the research team focused on the latter technology, asking participants to virtually try on a dress, select a size to "order" and then physically try on the dress in that size.

According to Baytar, the study participants were able to find the right size with AR try-on, but had trouble evaluating the fit, particularly at the bust, waist and hips. ## **Anger Against Police Murders Hits Trump's Doorstep, President Takes Shelter In Bunker**

Washington: Secret Service agents rushed president Donald Trump to a White House bunker on Friday night as hundreds of protest ers gathered outside the executive mansion, some of them throwing rocks and tugging at police barricades.

Trump spent nearly an hour in the bunker, which was designed for use in emergencies like terrorist attacks, according to a Republican close to the White House who was not authorized to publicly discuss private matters and spoke on condition of anonymity. The account was confirmed by an administration official who also on condition of anonymity.

The abrupt decision by the agents underscored the rattled mood inside the White House, where the chants from protesters in Lafayette Park could be heard all weekend and Secret Service agents and law enforcement officers struggled to contain the crowds.

Friday's protests were triggered by the death of George Floyd, a black man who died after he was pinned at the neck by a white Minneapolis police officer. The demonstrations in Washington turned violent and appeared to catch officers by surprise. They sparked one of the highest alerts on the White House complex since the Sept. 11 attacks in 2001.

"The White House does not comment on security protocols and decisions," said White House spokesman Judd Deere. The Secret Service said it does not discuss the means and methods of its protective operations. The president's move to the bunker was first reported by The New York Times.

The president and his family have been shaken by the size and venom of the crowds. according to the Republican. It was not immediately clear if first lady Melania Trump and the couple's 14-year-old son, Barron, joined the president in the bunker. Secret Service protocol would have called for all those under the agen-



cy's protection to be in the underground shelter. Trump has told advisers he worries about

his safety, while both privately and publicly praising the work of the Secret Service. Trump traveled to Florida on Saturday to view the first manned space launch from the U.S. in nearly a decade. He returned to a White House under virtual siege, with protesters

Park into the evening. Trump continued his effort to project strength, using a series of inflammatory tweets and delivering partisan attacks during a time of national crisis.

As cities burned night after night and images of violence dominated television coverage, Trump's advisers discussed the prospect of an Oval Office address in an attempt to ease tensions. The notion was quickly scrapped for lack of policy proposals and the president's own seeming disinterest in delivering a message of unity.

Trump did not appear in public on Sunday. Instead, a White House official who was not authorized to discuss the plans ahead of time said Trump was expected in the coming days to draw distinctions between the legitimate anger of peaceful protesters and the unacceptable actions of violent agitators.

## Most museums in world closed. some may never reopen

**ISLAMABAD: The United** Nations Educational, Scientific and Cultural Organisation (Unesco) says that 90 ner cent of the world's mus ums have closed their doors due to the Covid-19 pandemic and more than 10pc of them may never reopen. It is clear that these temporary closures have had serious economic and social consequences that may affect museums in the long term, says a report released by Unesco on Thursday on "Museums around the world in the face of Covid-19". In its conclusion, the report says the shutdown of cultural tourism endangers the financial stability of a great many institutions: since it constitutes one of the main resources on which museums rely on to ensure their operation and economic survival. Pakistan has 46 museums. out of which 37 have been closed due to coronavirus, representing over 84pc closure.

Western Europe has 61,634 museums, out of which almost 95pc have been closed. This is followed by the Asia and the Pacific region which has 12,195 museums and almost

Moscow: Russia will start giving its first drug approved to treat COVID-19 to patients next week, its state financial backer told Reuters, a move it hopes will ease strains on the health system and speed a return to normal economic life.

Russian hospitals can begin giving the antiviral drug, which is registered under the name Avifavir, to patients from June 11, the head of Russia's RDIF sovereign wealth fund told Reuters in an interview. He said the company behind the drug would manufacture enough to treat around 60,000 people a month.

There is currently no vaccine for COVID-19, the disease caused by the new coronavirus, and human trials of several existing antiviral drugs have yet to show efficacy

A new antiviral drug from Gilead called remdesivir has shown some promise in small efficacy trials against COVID-19 and is being given to patients by some countries under com-

passionate or emergency use rules. Avifavir, known generically as favipiravir, was first developed in the late 1990s by a Japanese company later bought by Fujifilm as it moved into healthcare. RDIF head Kirill Dmitriev said Russian scientists had modified the drug to enhance it, and said Moscow would be ready to share the details of those modifications within two weeks.

Japan has been trialling the same drug, known there as Avigan. It has won plaudits from Prime Minister Shinzo Abe and \$128 million in government funding, but has yet to be approved for use. Avifavir appeared on a Russian government list of approved drugs on Saturday

## **Protests may be last straw** for US global stature

ong Kong: Protests roiling US cities may do irreparable damage to America's global standing. Its sway has been waning under President Donald Trump, but this civil unrest will make it harder to reclaim the moral high ground. Losing it comes at a high cost.

The fear of US democracy decaying into the same tyranny against which the colonies originally revolted has been predicted at least since French political scientist Alexis de Tocqueville visited in 1831. The Economist Intelligence Unit demoted the country to a "flawed democracy" in 2017. The accumulation of policy errors, which precede Trump, have created a litany of problems including income inequality and a flawed healthcare system.

After a botched federal response to the pandemic, which has already killed more than 100,000 people in the United States, the country is now tearing itself apart over police brutality and racial injustice. It reveals the deep-rooted nature of the country's problems even as it pushes away its friends.

Trump just cut America's ties with the World Health Organization, continuing an inward agenda that includes abandoning the Trans-Pacific Partnership that would have eliminated some 18,000 foreign taxes on US exports. His tariffs have failed to erase a trade deficit with China and could ultimately cost American consumers as much as \$1,000 a year according to some estimates.

Ideological hypocrisy compounds the corrosion. Even as US politicians lambast China for censorship and suppressing human rights in Hong Kong, similar behaviour is flaring up at home. The latest demonstrations were set off by a white Minneapolis policeman choking an arrested African American man to death. Police have since detained and shot rubber bullets at journalists covering the ensuing demonstrations.

Almost all the museums in Eastern Europe (11,465) and Latin America and the Caribbean (7,810) have been closed. In Arab states all the 473 museums are completely closed, whereas in Africa, 738 museums out of 841 are open. The main players affected

by this loss are museum professionals, especially the selfemployed, three out of five of whom have lost their jobs and are in urgent need of support. Consequently, reflections on strategies to revive tourism must not forget that museums are at the centre of the cultural experience that visitors have of the country, city or site that they are discovering, the report says.

### "Saudi Game Of Thrones": Pressure **Grows To Release Jailed Prince**

London, United Kingdom: A \$2 million US lobbying effort and petitions from European lawmakers are piling pressure on Saudi Arabia to release a philanthropist prince jailed for two years without charge amid an intensifying royal crackdown.

The detention of Prince Salman bin Abdulaziz and his father since January 2018 is part of a clampdown under de facto ruler Crown Prince Mohammed bin Salman that has ensnared not just potential rivals but also figures posing no visible challenge to his hold on power.

The dangerous power plays have also swept up family members of Saad Aljabri, a former aide to another detained prince



and top intelligence official, who fled to Canada and holds key state secrets.

The most unlikely target is Prince Salman, a multilingual 37-year-old educated at Paris's Sorbonne University, who apparently espoused no political ambitions and earned a reputation of being a "walking blank check" for funding development projects in poor countries.

"This is not just an unlawful arrest," an associate of the prince told AFP. "This is daylight kidnapping. This is a forced disappearance.

One of the New Seven Wonders of the World, India's top tourist attraction has been shut since mid-March as part of measures to try and combat the coronavirus pandemic.

Images showed workers assessing the railing of the main mausoleum, after the storm on Friday night battered Agra city in northern Uttar Pradesh state.

"One sandstone railing which was a part of the original structure has been damaged," Superintending Archaeologist of the Archaeological Survey of India (ASI), Vasant Kumar Swarnkar, said.

"One marble railing which was a later addition, a false ceiling in the tourist holding area and the base stone of the main gate have also been damaged."
