**HUMAN RIGHTS UNDER LOCKDOWN** 

The internet services were suspended in the State of Jammu and Kashmir (Now, the Union Territory of Jammu and Kashmir, hereinafter "the valley"), as a pre-emptive step in August 2019. Since then internet services are not restored to the full extent in the valley. Although on the direction of the Supreme Court of India (SC) 2G services were restored in January 2020, the valley still suffers from arbitrary orders of the valley administration amidst COVID-19 pandemic. Following the national lock-down and other restrictive measures, a petition was moved to the SC to quash the order of the valley administration which suspended internet services. However, the SC on 11th May 2020, in FMP v UT of J&K, constituted a special committee to handle the issue at hand. The SC failed to appreciate human rights and allowed the government of India and the valley administration to cover the issue under the garb of national security....

### **US Voices Concern** Over Attacks On Minorities In India

WASHINGTON: Voicing concern over the alleged attacks and discrimination against religious and ethnic minorities in India, an official American report said on Wednesday that the US officials have emphasised the need to ensure full protection to minorities as guaranteed under the Constitution.

Mandated by the US Congress, the '2019 International Religious Freedom Report' that documents major instances of the violation of religious freedom across the world was released by Secretary of State Mike Pompeo at the State Department on Wednesday.

India previously rejected the US religious freedom report, saying it sees no locus standi for a foreign government to pronounce on the state of its citizens' constitutionally protected rights.

The India section of the report says that the US government officials underscored the importance of respecting religious freedom and promoting tolerance and mutual respect throughout the year with the ruling and opposition parties, civil society and religious freedom activists, and • P-02

## Missing Soldier's Body Found In Dam

Meanwhile, villagers told Kashmir Observer that the state forces used drones during the operation to track down the militants. Some officials linked the CAA with the National Register of Citizens (NRC), a process used to identify illegal immigrants in the state of Assam.

On December 22, Modi disavowed any discussion of implementing the NRC nationwide, including earlier comments from Home Minister Amit Shah that a nationwide NRC should be in place so we will detect and deport every infiltrator from our motherland, the report said.

The Chinese Army has been gradually ramping up its strategic reserves in its rear bases near the the Line of Actual Control (LAC) by rushing in artillery guns, infantry combat vehicles and heavy military equipment, the sources said.

> The trigger for the face-off was China's stiff opposition to India laying a key road in the Finger area around the Pangong Tso Lake besides construction of another road connecting the Darbuk-Shayok-Daulat Beg Oldie road in Galwan Valley. The road in the Finger area in Pangong Tso is considered crucial for India to carry out patrol. India has already decided not to stall any border infrastructure projects in eastern Ladakh in view of Chinese protests. The situation in the area deteriorated after around 250 Chinese and Indian soldiers were engaged in a violent face-off on May 5 and 6. The incident in Pangong Tso was followed by a similar incident in north Sikkim on May 9. The India-China border dispute covers the 3,488-km-long LAC. China claims Arunachal Pradesh as part of southern Tibet while India contests it.

Military sources in New Delhi said the two armies have begun "disengagement" around patrolling points 14 and 15 in Galwan Valley and another in the Hot Spring area, adding the Chinese side has even moved back up to 1.5 km in two areas.

Indian and Chinese troops have been engaged since May 5 following a violent clash in Pangong Tso.

The trigger for the face-off was China's stiff opposition to India laying a key road in the Finger area around the Pangong Tso Lake besides construction of another road connecting the Darbuk-Shayok-Daulat Beg Oldie road in Galwan Valley.

During their military-level talks on June 6, India and China agreed to follow the broad decisions taken by their leaders in the Wuhan summit in 2018 to ensure peace and tranquillity along the Line of Actual Control.

On June 6, Lt General Harinder Singh, the general officer commanding of Leh-based 14 Corps, and Commander of the Tibet Military District Maj Gen Liu Lin held an extensive meeting.

"We want to ask the prime minister what the government is doing to remove the Chinese army from the Pangong Tso Lake in Galwan Valley, where China is sitting with its soldiers and tents,"

He accused the Centre of trying to push the issue in cold storage

Hitting back at Ravi Shankar Prasad for his attack on Congress leader Rahul Gandhi, Tewari said the Union law minister made a "very unfair and completely irresponsible" political attack.

According to Tewari, it is unfortunate that rather than answering questions, the government was using "abrasive language" against the opposition party.

He said the government should direct India's national angst against those who have encroached upon Indian territory, rather than the Opposition.

"We want to tell them that patriotism and nationalism is not the exclusive monopoly of the NDA-BJP and much less the law minister," Tewari said. "Asking hard questions to the government is not unpatriotic, not replying to them is unpatriotic.

Tewari added that the Congress was posing questions as a responsible opposition party.

He underlined that when there were questions of security, unity, integrity, sovereignty, people hoped that the prime minister, defence minister, defence secretary or any other officer would come and tell the country about the situation, adding that there had been no such initiative.

The names of Pangong Tso Lake, Galwan Valley, Naku La were never heard of by Indians, he said, but today "even children know about it because these are all the places where Chinese soldiers have encroached" on Indian land.

The situation in the area deteriorated after around 250 Chinese and Indian soldiers were engaged in a violent face-off on May 5 and 6. The incident in Pangong Tso was followed by a similar incident in north Sikkim on May 9.



# **Hurriyat for erasing** 'artificial lines'

SLAMABAD - After favouring fresh options other than the UN resolution for resolving the Kashmir issue, the moderate faction of the Hurriyat Conference has said efforts should he made to dismantle the "artificial lines" dividing Kashmir. "When we talked about Kashmir it means the entire territory

of Kashmir and the artificial lines drawn between Kashmir must be dismantled." visiting Hurriyat chairman Mirwaiz Omar Farooq told reporters here. Faroog's statement assumes significance as it comes on i he heels of Pakistan President Pervez Musharraf's assertion on similar lines that borders should be made "irrelevant". He had mooted a concept of "soft borders" to resolve the issue.

The Hurriyat leader, who was in Karachi yesterday on a twoday visit, said they would work for removing the "artificial lines" separating the two sides of Kashmir.

About his comments earlier those UN resolutions have failed, he said they were not deviating from their long-held stand, but were in favour of finding other options as the world body has failed to find any solution. Farooq said new ideas and options should be explored and treated on merit for finding a solution to the Kashmir problem as the United Nations had miserably failed over the past 57 years. 'We don't know what will be the final solution but relations

with Pakistan would have a significant bearing on the out-, come." he said. Answering a question about hardline leader Syed Ali Shah Geelani's criticism of their visit, he said the All Parties Hurriyat Conference (APHC) represented a joint struggle and one individual could not dictate terms: He said it was lime for reinforcing unity of the Kashmiri people. Later visiting Mohammad Ali Jinnah's mausoleum at Karachi

along with eight other Kashmiri separatist leaders. Faroog hailed the father of Pakistan. "I on behalf of Kashmiri people salute Quade-Azam his leadership and dignity and freedom struggle initiated by him." he wrote in the visitors book

# **Testing Times**

n Sunday, a senior journalist in Kashmir was tested positive for Coronavirus at Chest Diseases hospital laboratory. But a day after he was tested negative at the lab at Sher-i-Kashmir Institute of Medical Sciences. This has raised a question mark over the testing process followed to detect Covid-19 positive cases. Incidentally, On Sunday itself, the labs in J&K had detected 620 cases, the highest since the Covid-19 lockdown began in the union territory on March 25. It is not that the credibility of all these tests is under question but it is also true that a number of such tests could now be viewed with doubt. The government therefore needs to take note of it. Advisor to Governor Baseer Ahmad Khan has promised to look into it. And it is important that the administration gets to the bottom of it. It is not only about the negative cases being declared positive that should be of concern but also the positive cases being declared negative. In the former cases, the person and his family are subjected to unnecessary trauma but in the latter, the person himself, his family and all his contacts are put under grave risk. And imagine if there are many more such cases, it could wreak havoc on the ground.

There is more to it. Such faulty testing can artificially revise the number of Covid-19 cases upward and downward and thus project a wrong picture of the situation. And this, in turn, has far-reaching consequences for the society as a whole. As things stand, the government has declared eight out of the ten districts in Kashmir as Red Zones. This has meant continuation of the lockdown like restrictions in all these places. That too when the Valley has already been under the lockdown for the past ten months. This has wrought havoc with the businesses and in turn thrown thousands out of their jobs. The administration has gone ahead with extension of restrictions when other places in the country with far worse situation are opening up. And this too after just two months of lockdown.

The government thus needs to take a hard look at the situation. It is time therefore that the administration revisits the restrictions and eases them considerably to let the people return to businesses. What it can focus on instead is to strictly enforce the social distancing norms in public. And it can do so, considering the smaller population of Kashmir makes the infections more manageable than the densely populated states across India. At the same time, there's a need for random retesting of the people declared Covid-19 positive in recent past, so that the true extent of the faulty testing, if any, is known.

# Secure the future of migrants

n a significant, albeit delayed directive, the Supreme Court (SC) on Tuesday asked states and Union Territories to identify stranded migrants and arrange their transport back home within 15 days. It has also asked administrations to withdraw cases filed against migrants for violating the lockdown guidelines, and the Indian Railways to ensure the availability of trains within 24 hours if there is demand. Both the Centre and the states have been told to prepare a detailed list to identify migrants. The court has instructed that all schemes and employment opportunities available to migrant workers must be publicised; and there must be employment relief and skill mapping.

The SC's decision comes over 75 days after the national lockdown, imposed to curb the spread of the coronavirus disease (Covid-19), led to a humanitarian crisis. Migrant workers, suffering from an acute shortage of food and income and yearning to return home to their families and communities, began walking home, before the Centre, in early May, introduced special trains and buses for their transport. But this process has been riddled with complications. There was a controversy over train fares (before the court stepped in to say that migrants cannot be charged); there have been difficulties in Centre-state coordination over trains; social distancing norms have often not been observed; migrants have had to wait for days, if not weeks, to be able to get on to trains, prompting many to walk; many have died due to hunger and fatigue. All of it has led to a socio-economic tragedy which is almost unprecedented in independent India's history; this scale of people

movement has not been seen since the Partition. This newspaper has argued that the SC was remiss in not taking up the issue of migrant workers earlier. It only took up the issue on May 26, two months after the crisis began. To be sure, its intervention now is welcome. But it is not just the judiciary; the primary blame for failing to anticipate the needs of migrants and not providing an adequate safety net lies with the executive. It must now expedite the movement of migrants back, and both the Centre and the state governments need to plan ahead. While the National Rural Employment Guarantee Scheme (NREGS) has emerged as an indispensable policy tool to provide incomes to those who have returned, governments will have to do more in ensuring employment — even as they focus on tackling the spread of the disease. The plight of migrant workers has undermined the credibility of the State and caused enormous distress. It is time to correct the mistakes and find ways to give them a dignified future. The SC should continue to keep an eye on this.

# Human Rights Under Lockdown

internet services were suspended in the State of Jammu and Kashmir (Now, the Union Territory of Jammu and Kashmir, hereinafter "the valley"), as a pre-emptive step in August 2019. Since then internet services are not restored to the full extent in the valley. Although on the direction of the Supreme Court of India (SC) 2G services were restored in January 2020, the valley still suffers from arbitrary orders of the valley administration amidst COVID-19 pandemic.

Following the national lock-down and other restrictive measures, a petition was moved to the SC to quash the order of the valley administration which suspended internet services. However, the SC on 11th May 2020, in FMP v UT of J&K, constituted a special committee to handle the issue at hand. The SC failed to appreciate human rights and allowed the government of India and the valley administration to cover the issue under the garb of national security.

The long-standing shutdown violated freedom of speech and expression as a constitutional right as well as a human right, enshrined under Article 19 of the Universal Declaration of Human Rights (UDHR). However, the gravity of issue has increased exponentially following COVID-19. The restrictions are in violation of the right to life (Article 3 of UDHR), right to health (Article 25 of UDHR, WHO Constitution) and right to education (Article 26 of UDHR) inter alia rights. COVID-19 has led to a situation where 4G internet services in the valley are the essential infrastructure which must be provided by the state to ensure that these rights are effective. The decreased 2G speed of the internet acts as an obstruction in obtaining the latest information/update regarding COVID-19. It is almost impossible to consult a doctor over video-calls, order medicines and other essentials through e-commerce. Moreover, students in the valley cannot prepare for examinawarfare is yet another threat to national security which is argued by the state. The SC by actively ignoring the blatant human rights violations has flouted its own decision in Anuradha Bhasin v Union of India, which applied the three-pronged test for violation of the right to life and personal liberty. The test mandates legality; legitimate state aim; and proportionality. It is the third principle which needs a closer look here. Proportionality ensures a rational nexus between the objects and means adopted to achieve them. It also mandates the use of the least restrictive measure.

The state argues that the actions are necessary to curb militancy and cross-border infiltration. However, it is bald-assertion that medium of the internet facilitates it. The speed of the internet currently being provided is sufficient for these purposes and militancy has peaked in the valley without 4G. There is absolutely no rationale for providing 2G internet coupled with fixed-line internet connection in the valley.

Furthermore, even if the nexus is presumed to exist, the measures used by the state are not least-restrictive in nature. The restrictions can be lifted in areas which are comparatively less likely to plunge into chaos or speed can be restored for verified customers in the valley, there are numerous options available apart from a blanket ban. Appreciating these measures would comply with the basic

principles of proportionality, viz territorial and temporal degree of restriction. These orders are per se disproportionate and manifestly arbitrary are result in denial of basic public utility.

Cross-border information warfare is yet another threat to national security which is argued by the state. However, in the 21st-century information warfare is used by nation-states across the globe, restriction flow of information in general through a gag order is not an effective solution for the state to adopt. Instead of curbing the spread of misinformation/fake news, such bans effectively close paths to cross-check information.

The SC in FMP v UT of J&K (¶ 14) stated that – "it might be desirable and convenient to have better internet in the present circumstances..." (emphasis supplied). This is indicative of the utter disregard of human rights in India. Through such statements, the SC not only leaves the suppressed on their own but also tarnishes its long-standing jurisprudence of human rights. Better internet in the 21st century, especially in times of COVID-19, is not desirable and convenient rather necessary.

# George Floyd Protests And The Dirty Secret Of Indian And Pakistani Communities

Rejecting oppressive treatment of minorities will be start in the fight against racism

Since cultural icons won't use their influence to tackle racist attitudes, it falls to us: the people. If Indians are truly outraged by the murder of George Floyd, they will take action and not just tweet hashtags. In India this means rejecting the destructive and oppressive treatment of its Muslim minority particularly in the north.

n the week that has passed since he was brutally murdered by a police officer in Minneapolis, George Floyd has become an international symbol.

That so many around the world have been outraged by his killing at the hands of the merciless officer Derek Chauvin is a valuable step forward in the fight for racial equality.

Racial injustice is everyone's problem, which means everyone has a role to play in solving this problem. For South Asians, this must start with confronting our sustained racism towards black people

If Indians are truly outraged by the murder of George Floyd, they will take action and not just tweet hashtags. In India this means rejecting the destructive and oppressive treatment of its Muslim minority—particularly in the north

South Asians' anti-black racism is now at the point where it is not even noticed any more; it's so entrenched that it's become part of the fabric of brown society.

#### As common as the head bobble

South Asia's dirty secret is that sharing anti-black views carries no personal or professional penalties: it's as commonly accepted as corruption and the famous head bobble.

Indeed, virtually all parents from the subcontinent view the notion of a black son-in-law or daughter-in-law as a source of shame. But the real shame is clinging to such an indefensible and clearly wrong attitude.

Despite many well documented cases of anti-black racism in India, South Asians appear to be making some progress on this front. For example, many South Asians who have expressed solidarity with the Black Lives Matter movement on social media.

This includes public figures such as Nick Jonas' babysitter (whom you may know as Priyanka Chopra). America's favourite token brown person may have lent support to an oppressed minority in her adopted country via an Instagram post but she continues to ignore the systemic oppression of minorities — Muslims and Dalits — in her homeland.

To be fair to Priyanka, at least she spoke up on Black Lives Matter. Which is more than Bollywood icon Shah Rukh Khan ever did. But

we shouldn't have any expectations from Shah Rukh Khan to see beyond himself.

After all, this is a man of incredible talent, wealth, influence and fame, who uses his platform to shamefully and reductively denigrate Muslims—an oppressed minority population in India—by producing Bard of Blood for Netflix.

I wonder how long it will be before an Apple engineer programs Siri to say Shah Rukh Khan when she is asked "what does sell out mean?".

If this seems unfair, consider that America's black celebrities — such as LeBron James and Jay-Z — routinely speak out when their community is targeted, but India's Muslim celebrities — including Shah Rukh Khan — take selfies with Narendra Modi, a man who is Islamaphobic in policies not just rhetoric.

Tackling racist attitudes
Since cultural icons won't use

their influence to tackle racist attitudes, it falls to us: the people. If Indians are truly outraged by the murder of George Floyd, they will take action and not just tweet hashtags. In India this means rejecting the destructive and oppressive treatment of its Muslim minority — particularly in the north.

To truly honour the memory of George Floyd, Indians should demand justice for the Muslims killed by police officers during Delhi riots in January. To honour the memory of Ahmaud Arbery — the unarmed 25 year old who was killed by vigilantes while jogging — Indians should demand justice for the Muslims killed by cow vigilantes.

To honour the memory of Breonna Taylor — who was shot dead by Louisville police as she slept in her home three months ago, Indians should demand justice for Zaheer Ahmed who was similarly shot dead by police at his home this

past December.

Of course, oppression of a minority population is by no means limited to India. In neighbouring Pakistan, Shiites, Sufis and Ahmadis are sometimes labelled as non-Muslim and are violently targeted by Pakistan's Wahhabi vigilantes.

More troubling is the fact that Pakistani vigilantism has a disturbing cultlike following in the form of terrorist groups such as Sipah-e-Sahaba Pakistan, Tehrik-e-Taliban Pakistan and Lashkar-e-Jhangvi.

Bigotry and violence isn't a black problem, a Muslim problem or a Shiite, Sufi or Ahmadi problem. It's everyone's problem. This only gets solved when everyone contributes towards a solution. And there's no better place to start than confronting the racism in our communities, before it becomes more deadly.

# Thugs: The Indian History Of The Word That Trump Used To Describe George Floyd Protesters

The English colonisers crafted narratives of a demonic cult, 'thuggee', to justify their iron-fisted rule.

othing says law-and-order like thug. Once again, the word is being bandied about in all the media. The thugs are out looting and rioting in the inner cities of America, we are told. Every time protests against police brutality ignite across the United States, out comes the word from some all-too-convenient grab box of insults. Opinion pieces are full of it, and so are the mouths of politicians.

Certainly, there has been violence and destruction of businesses amidst the largely peaceful protests following the horrific murder of George Floyd. We can all agree the wanton destruction of shops owned by innocent community members, often black or brown themselves, is simply wrong. There can be no defense of such actions. But does it help to call the people involved thugs? Is the word at all illuminating in thinking about the events of the last few days? Or does it rather – by design – obscure more than it reveals?

Thug is by now a fully American word, but it wasn't always. As the screenshot below suggests, thug, facilitated by British colonialism, entered the English language in early 19th century India, probably from Hindi or Hindustani.

Screenshot of an online dictionary no doubt – but the "historical" definition offered above is surely wrong. I have written before in this blog – and more fully in the critical essay Thugs and Bandits – about why. And others have too, in postcolonial scholarship that is by now at least 40 years old. Today, scholarly consensus holds that the word thug is profoundly shaped by – willful – British colonialist misconceptions of India.

A religious organisation? Devotees of Kali? Ritually-prescribed strangulation? All of this is likely pure fabrication. Were

there robbers who waylaid and murdered



travellers in the midst of the social chaos of early 19th century India? Surely. But the British loudly and ceaselessly claimed more, much more –that thugs were nothing less than fiendish members of a vast and ancient demonic cult called thuggee. Why?

## Ironing out complex histories

In the early 19th century, British colonialism was rapidly advancing across India. It needed a reason to extend its rule into new territories. Enter thuggee. The wild and diabolical stories of thuggee invented by the British provided justification for them to displace native Indian rulers, seen as either unable to control thuggee or else going further to abet and give it protection. In place of native rulers, the British established their own rule.

The British discourse around thuggee in the 19th century aimed to convert a complex, social story of human beings struggling with social chaos and economic dislocation into a narrative justification for iron-fisted rule. It did so in two parts. First, it converted specific human beings, all robbers no doubt and many murderers, into demonic thugs, that is, targets for the most extreme disciplinary action. Then, it made thugs representative of Indians in general and thus, made India as such a target for disciplinary

action. It was a discourse masterfully designed to create a maximally repressive, law-and-order colonial state.

Fast forward to the US today. Does the word thug not do similar work now? Does it not parallel British colonial discourse in 19th century India in flattening out complex histories of racism, discrimination against black people and relentless police brutality against black men into a law-and-order problem? Does it not prevent us from engaging fully the real origins of the profound rage being expressed by black and other communities?

As an English word, thug originates in a law-and-order mentality and it continues to express such a mentality today.

Rather than fostering understanding and engagement, it propagates the iron fist of draconian rule. Like British discourse on thuggee in the 19th century, the use of the American incarnation of the word today justifies the reduction of a social crisis to a law-and-order problem – a problem to be met by the force of the carceral state about which, alas, black communities know only too much.



PARIS-What is herd immunity and could it work with Covid-19? Herd immunity is when a virus can no longer spread easily because enough people are immune to it. That lowers the chances of the virus jumping from person to person and reaching those who haven't been infected yet.

People can become immune to certain viruses after surviving infection or being vaccinated. Typically, at least 70 per cent of a population must be immune to achieve herd immunity.

# Pakistan rules out adopting WHO recommendation



Islamabad: Pakistan's top health official on Wednesday asserted that the government is following a "holistic" strategy to deal with the COVID-19 threat as he ruled out adopting the WHO's recommendation of implementing a two-week strict lockdown, intermittently, to stem the exponential spike in the coronavirus cases.

Pakistan on Tuesday registered its highest single-day spike of coronavirus cases with 5,387 new infections, taking the total tally to 113,702. The deadly virus has so far claimed 2,255 lives.

Special Assistant to the Prime Minister on Health Dr Zafar Mirza said the government is pursuing a "holistic strategy to combat the coronavirus".

The government, he said, "conscious" of the disease spread and mortality and has



He said Pakistan has consciously but gradually eased generalised lockdowns but at the same time has focused on enforcement of standard operating procedures (SOPs) in shops, industry, mosques and public transport.

In a letter to the Punjab health minister last week, the World Health Organisation said the virus has spread all over the country, and a large number of cases had been recorded in big cities. The cases had increased sharply after the easing of lockdown. It ranks Pakistan among the top-10 most affected countries.

The letter appreciated Pakistan's efforts in fighting CO-VID-19, but warned that recent statistics suggest its current strategy was not paying off.

# **London may remove statues** as Floyd's death sparks change

LONDON: London's mayor announced on Tuesday that more statues of imperialist figures could be removed from Britain's streets after protesters knocked down the monument to a slave trader, as the killing of George Floyd in Minneapolis continued to spark protests and drive change around the world.

On the day Floyd was being buried in his hometown of Houston, Texas, London Mayor Sadiq Khan said he was setting up a commission to ensure the British capital's monuments reflected its diversity.

The Commission for Diversity in the Public Realm will review statues, murals, street art, street names and other memorials and consider which legacies should be celebrated, the mayors office said.

It is an uncomfortable truth that our nation and city owes a large part of its wealth to its role in the slave trade and while lected in our public realm, the contribution of many of our communities to life in our capital has been willfully ignored, Khan said.

International protests of racial injustice and police violence that Floyd's May 25 death spurred show no sign of abating. A white police officer who pressed a knee on Floyd's neck for more than eight minutes has been charged with murder.

Staff members and lawmakers in Britain's Parliament held a minute of silence in Floyd's memory on Tuesday. Demonstrators planned to gather in London's Parliament Square for a socially distanced vigil later.

France has seen nationwide protests calling for greater law enforcement accountability, and more demonstrations are planned for Tuesday evening.

Floyd's death has resonated especially strongly in Frances banlieues, or suburbs, where poverty and minority populations are concentrated. Protesters marching in solidarity with US demonstrations over Floyd's death have also called for justice for Adama Traore, a young man of Malian origin whose death in French police custody in 2016 is still under investigation.

French Prime Minister Edouard Philippe has met police and citizens' groups as part of efforts to calm tensions.

# Two Weeks After His Death, Floyd's **Life Celebrated At Houston Funeral**

Houston: George Floyd, the African American whose death in police custody roused worldwide protests against racism, was extolled at his funeral by religious and political leaders, family and friends on Tuesday in his hometown of Houston.

This is a home-going celebration," Reverend Mia Wright, copastor at the Fountain of Praise Church, told mourners.

Banners featured pop art illustrations of Floyd wearing a baseball cap with a halo above it.

American flags lined the streets outside the church. Flowers and bouquets were placed around a photograph of Floyd.

Former Vice President Joe Biden, the presumptive Democratic presidential candidate, spoke via a video recording.

"Why in this nation do too many black Americans wake up knowing that they could lose their life in the course of just living their life?" Biden said. "We must not turn away. We cannot leave this moment thinking we can once again turn away from racism.

After the service, a funeral

procession was due to travel about 15 miles (24 km) to Houston Memorial Gardens Cemetery in Pearland, Texas. His body was to travel in a horse-drawn carriage for burial alongside his mother.

Floyd, a 46-year-old African American who grew up in the Texas city, died on May 25 after a white police officer in Minneapolis pinned him with a knee to the neck for nearly nine minutes. A bystander's video captured the incident in excruciating detail, including his saying "I can't breathe" and crying out for his mother.

"It was the worst thing I ever could have imagined, watching him going from speaking and breathing to turning blue," said Godfrey Johnson, 45, as he arrived at the church. Johnson, who wore an "I can't breathe" T-shirt, attended Floyd's high school and played football with him.

About 500 people were invited to the funeral, which followed memorial services last week in Minneapolis and Raeford, the North Carolina town where Flovd was born.

Advised to guard against the coronavirus pandemic by wearing masks over their mouths and noses, some mourners and onlookers wore ones that said, "I can't breathe.'

Family members of other black men killed in confrontations with white men attended.

The mother of Eric Garner the New York man who died in a police chokehold, was at the church as was the family of Ahmaud Arbery, a 25-year-old Georgia man who was shot and killed in February while jogging. Three white men were charged.

Outside the church in hot, humid, 90 degrees Fahrenheit (32 degrees Celsius) temperature, two voter registration tables were set up.

Floyd's death ignited a wave of protests across the United States and cities in other countries against racism and the systematic mistreatment of black people, reinvigorating the Black Lives Matter movement.

The case also thrust the administration of President Donald Trump into a political crisis. Trump repeatedly threatened to order the military on to the streets to quell protests, which have mostly been peaceful.

# **WHO Clarifies Remark That Infection From Asymptomatic People "Very Rare"**

Geneva, Switzerland: A top WHO official on Tuesday clarified her remarks that transmission of the new coronavirus from asymptomatic carriers was "very rare", citing a "misunderstanding".

Maria Van Kerkhove ganization's COVID-19 technical lead, had said that on the basis of studies carried out in several countries, transmission of the virus by an asymptomatic person seemed "very rare".

"We have a number of reports from countries who are doing very detailed contact tracing. They're following asymptomatic cases, they're following contacts and they're not finding secondary transmission onward. It's very rare," she

told a virtual press conference on Monday. Her remarks, which were widely relayed on social media networks, sparked a reaction from

part of the scientific community. "Contrary to what the WHO announced, it is not scientifically possible to affirm that asymptomatic carriers of SARS-CoV-2 are not very infectious," professor Gilbert Deray of the Pitie-Salpetriere hospital in Paris said on Twitter.

Liam Smeeth, a clinical epidemiology professor at the London School of Hygiene and Tropical Medicine, said he was "quite surprised".

"There remains scientific uncertainty, but asvmptomatic infection could be around 30 percent to 50 percent of cases. The best scientific studies to date suggest that up to half of cases became infected from asymptomatic or pre-symptomatic people," he said. Van Kerkhove later posted on

"Comprehensive studies on transmi from asymptomatic individuals are difficult to conduct, but the available evidence from contact tracing reported by member states suggests that asymptomatically-infected individuals are much less likely to transmit the virus than those who develop symptoms," it said.

# **Second Etihad plane from UAE** lands in Israel

Washington: FROM White Fragility to The New Jim Crow, literature about the history of racial discrimination in the United States is selling out as white Americans seek to educate themselves as nationwide protests grow over the killing of unarmed black people. As the death of George Floyd, who was pinned under the knee of a white police officer in Minneapolis has prompted more than a week of street protests throughout the states, Americans at home are turning to books, movies and television shows that lay bare decades of discrimination.

Non-fiction books about the black experience head the Amazon.com bestseller list, including children's books, such as the We're Different, We're the Same from the Sesame Street stable. Many titles are sold out and used editions carry asking prices of up to \$50 each. On the Barnes and Noble website, eight of the Top 10 bestsellers were previously published books, including Between the World and Me by Ta-Nehisi Coates, and So You Want to Talk About Race, by Ijeoma Oluo. "This doesnt happen everyday ... The #1 and #2 overall bestsellers @amazon right now are two books challenging racism. This is you," Ibram X. Kendi, author of How To Be an Anti-Racist, tweeted this week. Just as the street protests

have transcended colour lines, Americans have been seeking and passing on recommended reading lists to friends and followers through Twitter and Instagram postings. Kendi, who compiled one such list for The New York Times at the weekend, wrote that the aim was to "confront our self-serving beliefs and make us aware that 'Im not racist' is a slogan of denial." Supporters are also urged to make their purchases through black-owned or independent book stores in a concrete show of support.

Professor Masooda Bashir and doctoral student Tanusree Sharma from the University of Illinois at Urbana-Champaign analysed 50 COVID-19-related apps available in the Google Play store for their access to users' personal data and their privacy protections. The researchers noted that it is disconcerting that these apps are continuously collecting and processing highly sensitive and personally identifiable information, about health, location and direct identifiers like name, age, email address and voter or national identification of a user.

Some of the apps, the researchers said, state they will collect users' age, email address, phone number and postal code; the device's location, unique identifiers, mobile IP address and operating system; and the types of browsers used on the device.

Only 16 of the apps indicated such data will be anonymous, encrypted, secured and reported only in aggregate form, they said.

Of the apps sampled in the study, 20 were issued by governments, health ministries and other such official sources.

The researchers acknowledged that mass surveillance measures may be necessary to contain the spread of the virus.

"Health care providers must absolutely use whatever means are available to save lives and confine the spread of the virus," they wrote in the journal.

However, the researchers added that it is up to the rest, especially those in the field of information privacy and security, to ask the questions published in the journal Nature network connectivity and audio set-needed to protect the right to privacy.

# **Goa Government Allows** People To Skip COVID-19 **Test On Arrival**

the COVID-19 test, provided no symptoms were found in them during the screening at the entry points, Chief Minister Pramod Sawant said on Wednesday.

However, those choose not to undergo the test will have to remain home-quarantined for 14 days, he said.

Sawant said the government has brought a change in the Standard Operating Procedure (SOP) to execute this new plan considering the strain on the testing facilities in Goa in view of the chief minister said so far,

From Thursday, those entering Goa will have the option of skipping which should be issued less than 48 hours before their arrival, Sawant said.

"Everyone entering the state will have to go through thermal scanner check, and if found symptomatic, that person will be taken to a quarantine facility, where test would

be conducted," he said. "The change in SOP has been brought as the testing facilities are getting stressed due to increasing number of people arriving in the state," he said.

On the status of the CO-VID-19 patients in Goa, the

"As per the change in the SOP, people will be allowed to enter the state without having to undergo the CO-VID-19 test. Those not found carrying any COVID-19 symptoms will have this option. It will come into effect from June 11. However, it is mandatory for those who choose to skip this test to observe 14-day home quarantine along with the family members," he said.

"Those who decide to undergo COVID-19 test on their arrival in Goa will have to remain under institutional quarantine till their test results are declared," the CM said.

# **Over 1,000 Doves Starve To Death At Afghan Mosque Shut Due To Lockdown**

MAZAR-I-SHARIF: than 1,000 doves have died of starvation at Afghanistan's famed blue-tiled mosque in Mazar-i-Sharif after it closed to curb the spread of the coronavirus, caretakers said Tuesday.

Before the mosque comnlex shut amid a nation wide lockdown, flocks of the snow-white birds would gather at the popular tourist attraction, where visitors would feed them.

But without any visitors to the 12th century wonder in Balkh province in northern Afghanistan, the doves have had little to eat, caretakers said.

"Every day, about 30 doves die. We bury them outside the shrine," said Qayum Ansari, head of cultural affairs at the mosque, adding that more than 1,000 birds have starved to death in recent weeks.

The doves have been a fixture for decades, with some visitors even considering them sacred.

"The birds were fed by visitors but since the lockdown, nobody has come," said Ahmed Naweed, a caretaker at the mosque.

Local officials said authorities were ready to feed the birds if mosque managers allow it.



"We will buy them bird food," said Munir Farhad, spokesman to the governor of Balkh province.

The mosque, which is adorned with intricate hand-painted tiles, was destroyed by Genghis Khan and his army in the 13th century, but was rebuilt and has emerged as a major pilgrimage centre for Muslims.

Afghanistan's coronavirus crisis is worsening by the day, with authorities reporting 21,459 confirmed cases so far, though the real number is thought to be much higher.

Experts say the country has one of the highest rates of tests coming back positive -- about 40 percent, indicating high levels of undetected infections.

Officials have warned the country faces a "disaster," with hospitals running short of beds as suspected cases surge.
