SRINAGAR: Reporters Without Borders (RSF) calls for the immediate withdrawal of the "New Media Policy" under which it says New Delhi assumes the right to harass journalists and media judicially and economically if they publish content it doesn't like.

to the Chinese at Nathu La."

Nathu La, along with Cho La, in northeastern part of India was the last clash site between the two forces that left hundreds of soldiers from both sides dead. Since then, the two sides have always resolved border disputes through diplomatic dialogues.

But Beijing now claims its sovereignty over the entire Galwan Valley—the site of the recent deadly nocturnal clash—named after a Ladakhi explorer, Ghulam Rasool Galwan. The ongoing faceoff flared up despite Prime Minister Narendra Modi having an iconic swing ride at Sabarmati River Front in Ahmedabad with Chinese President Xi Jinping in recent past. Since then, there've been multiple formal and informal summits between the two leaders. But now, some Beijing-based think tank have linked New Delhi's "unilateral move" of scrapping the special status of the former state of Jammu and Kashmir with the LAC standoff. Standing eyeball to eyeball at multiple locations in eastern Ladakh for the past couple of months, the two most populous nations of the world have already fed war stores to an otherwise "unarmed" LAC. The three major points of the faceoff between India and China are patrolling points 14-15 in the Galwan Valley, Hot Springs, and Finger-4 of Pangong Tso in Ladakh.

This time around, said Ajai Shukla, senior defence analyst and retired army colonel, the Chinese have intruded into new areas like Galwan, for the first time after 1962. "The numbers of intruders are unprecedented," he said. The faceoff started in early April when a scuffle broke out between the Indian and Chinese soldiers in Pangong Tso. According to various reports, few Indian soldiers were taken by surprise when they spotted some Chinese soldiers patrolling the strategic Finger areas in Pangong Tso. The violent clash between the two sides left scores of soldiers heavily injured Ajai Shukla labelled the recent ambush as the brutality of Chinese soldiers and requested the government to come clean on the current situation. In the last week of May, the two sides agreed on resolving the current dispute through dialogue. On June 6, 2020, both sides held talks at high military levels, but the talks could not result in any fruitful results.

While the talks were going on through military and diplomatic channels, the brutal clash on the night of June 15, 2020, further escalated the situation and led to many casualties on both sides. According to the official statement released by the Indian Army, 3 Indian soldiers, including a commanding officer were killed during the violent faceoff and 17 succumbed to death, leading the total number of fatalities to 20. Neither the army nor the government gave any number on Chinese casualties.

New Delhi in a statement said that India has always resolved to maintain peace and tranquility with China along the Line of Actual Control, which stretches from Ladakh in the west, to Arunachal Pradesh in the eastern part of India. The three Indian soldiers who recently lost their lives include Colonel Babu Santosh from Telangana who recently took control of the Army's 16 Bihar unit. A day before the vicious incident, Army Chief General Mukund Naravane told media that troops on both sides were disengaging and the process of de-escalation had begun. While the army has not released any updated figure regarding the casualties, many experts suggest that the number of casualties can be significantly higher. Prime Minister Narendra Modi on June 17, 2020 said that India had never provoked anyone and will protect its sovereignty. The statement came after the opposition demanded the government to come clean on the current situation. Minister of External Affairs, S Jaishankar talked to his Chinese counterpart, Wang Yi, and conveyed, "What happened in Galwan was premeditated and planned action by China which was responsible for the sequence of events." Yi hit back saying Indian forces crossed the LAC and provoked the attack. Calling it a "risky act" of Indian Army, he asked India "to thoroughly investigate and punish those responsible". Later, MEA released a statement which stated that the clash with China would have a "serious impact" on the bilateral relationship. The recent nocturnal attack was the first such incident in 45 years, where the loss of lives has been reported. The last time when casualties were reported was in 1975.

After 1975, there have been incidents of minor scuffles between the Indian and Chinese soldiers, but none of the incidents was fatal. Since the Galwan Valley escalation, both sides have been trying to deescalate the tension and ease off the already volatile situation. The two sides have been now engaged in the highest military level talks. Earlier, the Chinese government said that Indian forces provoked PLA soldiers by crossing the LAC. India rafitted the claim immedia

PLA soldiers by crossing the LAC. India refuted the claim immediately, saying China was unilaterally trying to change the status quo. For over decades, the border dispute has marred the bilateral ties between the two Asian giants. The two neighbours have maintained two different maps for the cold desert frontier. Analysts blame the India-China repeated talk failures for this cartographic conflict.

Meanwhile, while terming the current situation as "a bad moon rising" on Sino-India relations, former Indian Foreign Secretary and Ambassador to China, Nirupama Menon Rao, said, "Chinese always present themselves as injured party and blame opposite nail-studded sticks, iron rods and clubs in carrying out brutal attacks on Indian soldiers after they protested the erection of a surveillance post by China on the Indian side of the LAC in Galwan. Pawar, a former defence minister said diplomatic channels should be used to defuse the tension, adding Chinese troops must be "evacuated" from the high ground in the Galwan valley.

He said that the Chinese army is occupying the high ground in the Galwan valley with a "specific objective of dominating the Dubruk-DBO road on the Indian side". Chinese troops can at any time decide to enforce closure of this road and India will have to pay a heavy military cost if that happened, the NCP chief said in the meeting. Trinamool Congress supremo Banerjee said her party stands firmly behind the Union government in this hour of crisis and urged the Centre not to allow Chinese investments in strategically important infrastructure sectors. The West Bengal chief minister said India "should and will" unitedly tide over the crisis, sources in her party said. "We stand with the government in this hour of crisis. We will win. We will put up a united fight as one nation," Banerjee was quoted as having told the meeting by a source in the TMC. Opposition parties like the RID, AAP and AIMIM reacted angrily over not being invited to the meeting and raised questions over the criteria for the invitation. The two armies were engaged in a standoff in Galwan and several other areas of eastern Ladakh since May 5 when the two sides clashed on the banks of the Pangong Tso.

The situation in the area deteriorated after around 250 Chinese and Indian soldiers were engaged in a violent face-off on May 5 and 6. The incident in Pangong Tso was followed by a similar incident in north Sikkim on May 9. The India-China border dispute covers the 3,488-km-long LAC. China claims Arunachal Pradesh as part of southern Tibet, while India contests it. Prior to the clashes, both sides have been asserting that pending the final resolution of the boundary issue, it is necessary to maintain peace and tranquillity in the border areas.

Fighter Jets, Choppers Seen de-facto border with China on high alert and moved in additional

de-facto border with China on high alert and moved in additional assets like fighter jets and attack helicopters as part of heightened state of preparedness following the clashes.

Air Chief Marshal Bhadauria was at the Leh IAF base on Wednesday (June 17) where he reviewed operational preparedness of the force in effectively guarding the sensitive border areas in eastern Ladakh where Indian and Chinese armies have been on a nearly six-week standoff. From Leh, he traveled to Srinagar on a day-long visit on Wednesday where he held a series of meetings with senior IAF officials. The IAF has already moved a sizable number of its frontline Sukhoi 30 MKI, Jaguar, Mirage 2000 aircraft and Apache attack helicopters to several key air bases including Leh and Srinagar in the last three days, sources said. According a report in NDTV, on several IAF fighter jets and attack helicopters such as the Apache chopper were spotted over Leh. It is learnt that IAF jets have increased their sorties in the eastern Ladakh region in the last few days after Chinese military increased its aerial activities in the area following the Monday evening clash in Galwan. Even as the IAF is yet to confirm the details of the activites by the Chinese Air Force, via an independent investigation conducted by the NDTV, through satellite imagery, a fastgrowing infrastructural build-up has been confirmed at the Ngari Air Force base in Tibet near the Pangong Lake where several large scale Chinese incursions have taken place. The report also mentions that there are several Chinese Air Force bases in Tibet which could pose a threat to India. The IAF is also closely monitoring the situation in Pakistan's air base of Skardu, in Pakistan-Occupied Kashmir, which could also how Chinese fighters. However, the IAF has not yet confirmed the presence of the same. Bhadauria travelled to Leh on Wednesday afternoon after Defence Minister Rajnath Singh reviewed the overall security scenario with him, Chief of Defence Staff Gen Bipin Rawat, and the other two service chiefs. In the meeting it was decided that all the frontline bases of the Indian Army and the IAF along the Line of Actual Control (LAC) with China will be put on high alert in view of the border clash in Galwan Valley. The Indian Navy has also been asked to raise its alert level in the Indian Ocean Region where Chinese Navy has been making regular forays. The Army has already rushed in additional troops and weaponry to all its key frontline bases and formations along the LAC in Arunachal Pradesh, Uttarakhand, Himachal Pradesh and Ladakh, sources said. The IAF has also sent additional platforms to its bases in Sikkim, Assam and Arunachal Pradesh. With most of the Chinese air bases built at high-altitudes, the neighbouring troops may face many operational glitches, including weight and fuel load restrictions, forcing them to cut down on the weaponry they carry. However, India does not face such problems due to it's air bases mostly operating from plains such as Bareilley, Adampur and Jammu and Kashmir bases.

The clash in Galwan Valley is the biggest confrontation between the two militaries after their 1967 clashes in Nathu La when India lost around 80 soldiers while the death toll on the Chinese side was over 300. The Chinese soldiers used stones, nail-studded sticks, iron rods and clubs in carrying out brutal attacks on Indian soldiers after they protested the erection of a surveillance post by China on the Ind side of the LAC in Galwan. The two armies were engaged in a standoff in Galwan and several other areas of eastern Ladakh since May 5 when the two sides clashed on the banks of the Pangong Tso. After the standoff began, the Indian military leadership decided that Indian troops will adopt a firm approach in dealing with the aggressive posturing by the Chinese troops in all disputed areas of Pangong Tso, Galwan Valley. Many Chinese soldiers were also killed in the clash increasing tensions between the two nuclear countries. The Indian Army on Thursday said all Indian soldiers involved in the deadly clashes with the Chinese army at the Galwan Valley in eastern Ladakh on Monday night had been "accounted for". "It is clarified that there are no Indian troops missing in action," the Army had said in a brief statement without elaborating. Following the release of the 10 Indian Army soldiers, situation has comparatively calmed down. The next round of talks between India and China over the weekend will revert to disengagement issues. Quoting military sources, the report further says that 76 Army personnel were brutally assaulted by the Chinese army on Monday out of which 18 were seriously injured while 58 of them sustained minor injuries. They said 18 personnel are undergoing treatment at a hospital in Leh while 58 are admitted to various other hospitals.

In total, three militants were killed in the operation. Inspector General of Police, Kashmir, Vijay Kumar said no firing or IED was used to force the militants out of the Mosque.

"Patience and professionalism worked. No use of firing and IED. Used tear smoke shells only. Maintained sanctity of the mosque. Both militants hiding inside mosque neutralised," the IGP said. In another anti-militancy operation at Munand-Bandpava area of Shopian, which also began on Thursday, four more militants were killed on Friday morning, defence spokesman Col Rajesh Kalia said. The forces had launched the operation there after receiving intelligence inputs about the presence of militants there.

While one militant was killed in the operation there on Thursday, four more were killed on Friday, Col Kalia said, taking the number of militants killed in the gunfight to five.

In total, eight militants were killed in these two overnight operations in the last 24 hours. The IGP Kashmir has congratulated the state forces in Kashmir for killing 100 militants in the valley this year so far. Newborn, 2 Others Die...

In second death at the hospital, an 80-year-old man from Sopore area of north Kashmir's Baramulla district passed away at 9 am in Friday, the officials said. They said the patient suffering from hypertension and cardiac failure was admitted to the hospital on June 17. His sampling was done that day only and the report returned as positive the next day, they added. Earlier, a 79-year-old man from Nowshera area of Srinagar, who had tested positive for COVID-19, died at 11:15 pm on Thursday night, the officials said. They said the patient was admitted to the hospital on June 8 and was suffering from hypertension, hypothyroidism, with bilateral chest infiltrate. He had contact history with a positive patient, they said.

With these fatalities, the death toll due to the pathogen has risen in Jammu and Kashmir to 75–66 in Valley and 9 in Jammu division. So far Srinagar district with eighteen deaths due to the virus has the highest fatalities, followed by thirteen in Baramulla, nine in Shopian, eight in Kulgam, six in Jammu, five each in Anantnag, Kupwara & Budgam, two in Pulwama while one death each has been reported in Bandipora, Doda, Rajouri & Udhampur.

Covid-19 Victim's 2... The kin of the deceased duo alleged that they died due to dehydra-

tion. According to them, their family member died of COVID-19 on Wednesday night and they were told to conduct the last rites in the morning but it got delayed. "Four of us were dressed up in PPE kits and taken to Sidhra for the cremation. As we travelled through the sandy banks of a river, the wheels of the ambulance got stuck and we had to carry the body for some distance. We all were dehydrated," a cousin of the deceased told reporters. "Three of our family members parched because of the high temperature asked for water. But the officials did not give water and instead scolded us. As the three fell unconscious. I carried one to GMC hospital and he was revived." he said. According to sources, the other two persons died on the spot. One of the body was carried to GMC hospital in an ambulance and another was ferried in the evening by the police, they said. Officials said that Jammu and Kashmir Lieutenant Governor Girish Chander Murmu has taken a serious note of the "negligence on the part of the administration and strict action will be taken against those responsible". District Magistrate of Jammu Sushma Chauhan said, "During the cremation of a body on account of COVID-19 related death, two persons accompanying the body for the last rites became unconscious and subsequently passed away in mysterious circumstances. A magisterial probe into it has been ordered." An additional district magistrate shall conduct a probe to ascertain the circumstances leading to the death of the two persons, she said, adding a special board of directors has been constituted to conduct autopsy and the ADM shall submit the report by June 22.

Speaking about the situation on the border, Director General of Jammu and Kashmir Police (DGP) Dilbag Singh said the security forces were conscious of the threats and were adequately responding to those. "We are conscious of the fact that our neighbour and the agencies which are there to perpetuate violence in this region, are making efforts to infiltrate and send in more numbers of militants for various sectors, we have been adequately responding to that threat. "Our highway grids, our border grids are fully alert. We are in a position to take care of any emergent challenge anywhere and we would definitely be on the side of our people. They have been very cooperative and they have extended all kinds of cooperation," he said.

The civilian population in the border areas, it is pointed out, is under huge economic stress and the border skirmishes are to further compound its problems," it said.

Revocation of the 5th August 2019 decisions and unconditional dialogue with all the stakeholders is pivotal to the lasting peace and prosperity in the region, the joint statement said. The party demanded immediate annulment of all the August 5, 2019 decisions and restoration of the August 4 2019 constitutional position of Jammu and Kashmir. It also called for opening of all traditional routes including Kargil-Skardu, Jammu-Sialkot and Poonch-Rawalakot to allow free movement of the people across the LoC and the LAC and to promote people-to-people contact and strengthen inter-regional trade and cultural links.

No Indian Territory Intruded

The categorical statement by the prime minister came in the wake of reports that Chinese military has transgressed into the Indian side of the Line of Actual Control (LAC), the de-facto border, in several areas of eastern Ladakh including Pangong Tso and Galwan Valley. The prime minister's assertion came even as Congress president Sonia Gandhi questioned the government's handling of the situation, asking if there was any intelligence failure and seeking assurance that China will "revert" to its original position. While the Congress and the Left sought to corner the BJP-led National Democratic Alliance government, most other parties, including the ruling alliance's bitter critics like West Bengal Chief Minister Mamata Baneriee and DMK's M K Stalin, extended their support over the issue. Assuring all the leaders that armed forces were fully capable of protecting the country's borders, Modi said, "While on the one hand, the army has been given freedom to take necessary steps, India has also conveyed its position clearly to China through diplomatic means." he said. He added that India today has such capability that no one can even dare to look towards "an inch of our land". Modi said the entire country is hurt and angry at the steps taken by China at the LAC and underscored that India wants peace and friendship, but upholding sovereignty is "foremost". The nearly four-hour meeting through video conference was attended by top leaders including BJP president J P Nadda, NCP chief SharadPawar, BSP's Mayawati, CPI(M)'s SitaramYechury, DMK's MK Stalin, Shiv Sena'sUddhav Thackeray besides Gandhi and Banerjee among others. The government said the leaders of the political parties hailed the bravery displayed by the armed forces in Ladakh and reposed faith in the leadership of the prime minister in this hour of need. They expressed commitment to stand united with the government. In the meeting, Gandhi asked some tough questions to the government like whether there was any intelligence failure on the situation along the LAC, and sought an assurance from Modi that status quo ante would be restored at the border. In her introductory remarks, she said even at this stage they were in the dark about many crucial aspects of the crisis as she posed a set of questions to the government and sought specifics about when Chinese troops intruded into the Indian territory."In the government's considered view, was there a failure of intelligence," she asked.

efence Minister Rajnath Singh said that the nation will never forget the sacrifice of the martyrs while External Affairs Minister S Jaishankar gave an overview of agreements between India and China on border management, besides sharing details of recent developments. Several leaders, including BJP ally and LolJanshakti Party president ChiragPaswan and Banerjee, asked the government to work to curb trade, especially import, with China and said investment from Chinese firms in infrastructure sector in India should be desisted. The clash in Galwan Valley was the worst cross border confrontation between the two sides in 45 years. Gandhi asked specifics about when Chinese troops intruded into the Indian territory in Ladakh and whether the country's external intelligence agencies did not report any unusual activity there. She also asked if the government had not received satellite pictures of the border area and the Military Intelligence did not alert it about the intrusion and the build-up of massive forces along the LAC.

"In the government's considered view, was there a failure of intelligence," she asked. "The question is, what next? What is the way forward? The entire country would like an assurance that the status quo ante would be restored and China will revert to the original position on the Line of Actual Control," she said. Gandhi alleged that valuable time was lost between May 5 and June 6 and the government failed to use all avenues of talks to ease the situation and the result was the loss of 20 lives as well as injury to dozens of personnel. "We in the Congress party believe that valuable time was lost between May 5 and June 6, the date on which the Corps Commanders meeting took place," she said, adding that even after the June 6 meeting, efforts should have been made to talk directly to the leadership of China, both at political and diplomatic levels. "We failed to use all avenues, and the result is the loss of 20 lives as well as dozens injured. I would urge the Prime Minister to kindly share with us all the facts and the sequence of events beginning April this year till date," she said.

Gandhi also asked about the current status of the Mountain Strike Corps, with two mountain infantry divisions, that was sanctioned in 2013. "Should the government not treat it with utmost priority," she asked. She demanded that the government briefs the opposition on the preparedness of the defence forces to meet any threat. The Congress chief also said that her party and the entire opposition unitedly stood by the defence forces and were prepared to make any sacrifice to ensure they were battle ready. The meeting, she said, should have been convened sooner and immediately after the government was informed about the Chinese intrusion on May 5.

"125 new Covid-19 cases were detected in J&K. While 102 of them are from Kashmir, 23 are from Jammu," the officials said. Among fresh cases, 31 cases were reported from Srinagar, 18 from Pulwama, 11 from Kulgam, 10 from Baramulla, eight each from Anantnag & Jammu, seven each from Kupwara, Bandipora, Shopian & Kathua, four from Samba, two from Budgam & Udhampur and one each from Ganderbal, Poonch & Rajouri, they said.

They said that 50 more patients recovered and were discharged from different hospitals. The number of confirmed cases has now reached 5,680 out of which 4,374 are in Kashmir, while 1,306 are in Jammu, the officials said. There are 2,411 active cases of the coronavirus disease in J&K – 1,772 in Kashmir and 639 in Jammu – and 3,194 (2,536 from Kashmir and 658 from Jammu) patients have recovered, according to officials. The J&K has witnessed 75 Covid-19 (66 from Kashmir, 9 from Jammu) deaths so far.

Lt Gen B S Raju, General Officer Commanding (GOC) of the Srinagar-based Chinar Corps, said here.

"The moment there is peace in the valley, it generates violence --both from across as ceasefire violation as well as sending instructions to entities or its proxies within the valley to generate violence," he said. He was speaking at a joint press conference along with senior officers of Jammu and Kashmir Police and the Central Reserve Police Force (CRPF) here. Lt Gen Raju said he does not see any major connection between the situation in Ladakh and the ceasefire violations in Jammu and Kashmir as of now.

"I do not see any such major connection as of now. The existing ceasefire violations have happened through a pattern and there has not been any great increase in the number of ceasefire violations, but, definitely, some of them have been intense in which the Pakistan-initiated ceasefire violations have inflicted some civilian casualties," he said. He said the Army is taking proper measures to provide more security and safety to the civilian population in the areas near to the LoC. "Some action on the construction of civilian bunker has started, some under law."

We therefore call for the withdrawal of this directive, which is unworthy of India's democracy and will have the immediate effect of inducing a profound self-censorship that in practice amounts to prior censorship." 'More than 17% Covid cases in Kashmir are children'

Srinagar, June 19: Doctors Association Kashmir (DAK) on Friday said more than 17 percent of Covid-19 positive cases in Kash mir valley are children.

"We have higher percentage of children with Covid infection than the global average," said DAK President Dr Nisar ul Hassan.

"While children make up fewer than 2 percent of reported Covid-19 cases globally, in Kashmir valley 17.29 percent of Covid cases are in the age group of 0-19," he said.

Dr Nisar said based on our analysis from the data of 989 lab confirmed cases of the novel coronavirus, 171 cases (17.29 percent) were under 19 years of age.

"Majority of the children



who tested positive for the novel virus had history of contact with adults," he said.

'Most of the children with Covid infection had no symptoms or had mild disease," he added.

Dr Nisar said no Covid infected child became seriously ill. "However, today we had the

first infant death in the valley due to Covid infection. A 15-dayold infant who had underlying serious heart ailment died due to

the novel virus," he said. Dr Nisar said research

shows that children are less susceptible to the virus than adults. "School closure and a com-

paratively lower rate of testing for the novel virus among children could contribute to the low number of reported cases among the group," he said.

"It is also possible that due to some quirk of biology, children are less susceptible than adults," he added.

Dr Nisar said studies on whether children are also less likely to spread the infection to others have shown mixed results. "A French study found that a nine year old child who attended three different schools while showing symptoms of Co-



RINAGAR Shortly after the return of Hurriyat and other separatist leaders from their trip from across the LoC. a union of four militant groups today launched a scathing attack targeting a broad spectrum of leaders including the moderate faction of the Hurriyat. "Sycd Salahuddin should make it clear as to who between the Hurriyat (A) and Syed Ali Shah Geelani he recognises as the political leader." he said adding that certain other "shortsighted" militant commanders "had tried to harm the movement in meeting with the leaders of the Hurriyat (A)."

The spokesman hit out at the Jama'at-e-Islami describing "people like" its chief. Nazeer Ahmad Kashani as "nothing but Jaffar's and Sadiq's of Kashmir'

He said that the organisation's attempts to distance itself from Geelani was clear evidence of its discord and disenchantment with jehad.

The alliance lashed out at the moderate faction of the Hurriyat, saying it had returned from across the LoC after learning new tricks of the trade.

'It was foolish of them to have got Syed Ali Shah Geelani cased out of the chairmanship of the APHC." the alliance said, adding that it would have no effect on Geelani's association with the movement.

The alliance said that it was incumbent on Geelani not to repeal the mistake he committed in propping up Prof. Abdul Ghani Bhat, Mirwaiz Umar Farooq, Muhammad Yaseen Malik and Molvi Abbas Ansari.

Geelani should take care not to project such people who will emerge as vet an other Abbas group or a "sellout cartel "

The spokesman said that "final certificate of chairmanship obtained from Musharraf carried no weight with the alliance."We have rejected them. This group is not a representative of the sacrifices of the Kashmiri people but a soul male of Mufti Muhammad Sayeed and Farooq Abdullah." the alliance said.

n October last year a senior Indian security official on a visit to Ladakh met the General Officer Commanding (GOC) of the Indian Army's 14 Corps. The Corps was raised in the aftermath of the Kargil war between India and Pakistan in 1999 and has its headquarters in Leh.

Today, 14 Corps under the India's Northern Army Command is primarily tasked with maintaining the sanctity of the Line of Actual Control that divides Aksai Chin between India and China.

Aksai Chin went under Chinese occupation after 1962 war that dealt India a crushing blow and forced it to vacate large tracts of land and allowing the Chinese to hook up with its all-weather ally Pakistan through the illegally ceded territory of Shaksgam Valley in Pakistan Occupied Kashmir (PoK).

The Indian security official gave a detailed briefing to the Lieutenant General Harinder Singh, a former Director General of Military Intelligence, who took over as the GOC of 14 Corps late last year.

The Indian security official explained that the change of the status of Jammu & Kashmir had irked the Chinese. In the coming months they would up the ante and try and capture more land and shift the LAC deeper into Indian-held territory.

Several Indian security officials have confirmed that there was adequate credible intelligence of China's intentions to up the ante in the Ladakh sector. The heights of the Galwan Valley overlooks a key road that winds its way to Daulet Beg Oldie, a strategic outpost that serves as a key military base for India.

By November/December 2019 the world was waking up to news of a spread of a deadly virus in Wuhan, China and all talk about the Chinese preparation to take over the Galwan Valley in Ladakh was forgotten. As winter set in, Indian troops settled in for business as usual.

But the events that unfolded on the night of June 15 raises several key questions.


Why did India's top political, strategic and military leadership fail to anticipate and counter Chinese intentions to challenge and occupy Indian claims in Ladakh? How should India now counter a clear and present danger on its northern borders?

Did the newly-appointed Chief of Defence Staff, General Bipin Rawat, mislead the government? How did the plethora of official agencies set up to study China fail to predict a clear change in its India policy? **Rising Hostilities**

The brutal killing of Colonel Santosh Babu, the Commanding Officer of the 18th battalion of the Bihar Regiment and his men by the People's Liberation Army (PLA) has now brought home the reality of Chinese intentions in Ladakh.

Reliable military and intelligence sources now say that the death toll of Indian soldiers is considerably

The Chinese plans that the Indian security official had briefed Lieutenant General Harinder Singh late last year continued to be implemented even as the world turned its attention to an emerging pandemic threat from China.

The Chinese build up was confirmed by other Indian intelligence agencies and reports were sent to Delhi. However, they were either missed or ignored allowing the Chinese to build up in the Galwan Valley through the winter.

The Chinese were upset with India's position on rejecting its ambitious Belt Road Initiative (BRI) to connect global markets to China's manufacturing inand any change in status was bound to be viewed as a threat to China's claims.

What is inexplicable is why did India fail to read tea leaves and China's intentions to change status quo?

Crumbling Defences

recommendations of the Kargil Review Committee and set in motion an ambitious plan to reform India's security apparatus.

A key recommendation was to appoint a lead agency for every border to ensure better coordination between different security agencies and accountability. For the Ladkah sector the Indo Tibetan Border Police (ITBP) was chosen as the lead agency.

It reports to the union Ministry of Home Affairs, which also commands the Intelligence Bureau and was the lead on abrogating Article 370 within months of Prime Minister Modi wining a historic landslide electoral victory in May 2019.

A 700 km border and Line of Actual Control that stretches from the Karakorum ranges to Himachal Pradesh is now manned jointly by the ITBP and the Indian Army. The local ITBP sector headquarters holds a meeting every month with representatives from the intelligence agencies, army, air force, customs and the state police to review any intelligence on China relevant to their sector.

So why did this elaborate Indian security apparatus miss China moving troops nearly two army Divisions (about 9000-12000 men) into the area to occupy the Galwan Valley heights?

Why did they miss China building a road up to a key strategic feature known as Finger 4 considered Indian territory? And how did they miss Chinese troops building semi-permanent bunkers in the Galwan Valley heights?

Compounding Failures

Every year the Ministry of Defence and Ministry of Home Affairs sit and jointly plan the patrolling schedule for the Ladakh sector. Decisions are taken on how many patrols will be sent by the army and ITBP separately and jointly. Each patrol carries GPS units to collect waypoints and record the areas that have been covered. Clearly, this mechanism failed to anticipate China's moves to consolidate its position in the Galwan Valley. India's political and strategic leadership also failed to anticipate that the Chinese would violate bilateral agreements from 1993, 1996 and 2013 that specifically bars any change in status of the LAC by either side.

India's military, starved of crucial funds for the last six years, has limited war fighting capabilities. At best, it is in a position to sustain a full-scale war for only 12 days after factoring in its current war wastage reserves. India will also have to keep in mind the possibility of a two-front war if Pakistan steps in, if things escalate quickly with China.

The failure to anticipate China's intentions has already proved costly. However, years of bad planning and abysmal budgets, rapidly spreading Covid19 infections and a broken economy severely restricts India's options. Deccan Chronicle

Covid-19: Virus Will Be Defeated When All Succumb To It

According to experts, herd immunity against coronavirus will be developed only when about 70-90 percent of the population is infected

When an epidemic strikes, people either become infected and die, or become immune when they recover. As the number of people recovering increases, so does the number of people resistant to the disease. s the spread of the novel coronavirus is accelerating in India, the discussion on herd immunity is gaining momentum. Herd immunity means that about 70-90 percent of people develop immunity to the disease, and then the rest will also survive. Now the question is, will herd immunity be able to work in the absence of a coronavirus vaccine?

At the beginning of the pandemic, Britain tried to use the concept of herd immunity. However, more than three hundred scientists there opposed the government's move, saying that the government should think of stricter sanctions, not alternatives such as 'herd immunity', which would unnecessarily endanger the lives of many people. But, the British government continued its experiments for a few days and the virus wreaked havoc there.

According to experts, coronavirus will develop herd immunity among people only when about 60 percent of the population is infected. However, not all experts have a consensus on this figure. Sweden is currently the only country in the world that is working on the experiment. Herd immunity was also mentioned in Britain when coronavirus spread in March, but the government had to back down after severe criticism.

When Britain started using herd immunity in their country, around the same time Sweden also started using it in their country. Initially, Sweden seemed to have some success in that, but now the cases of Coronavirus are soaring there as well. The essential condition of herd immunity is vaccination, which develops immunity in people. The head of the World Health Organization's emergency service, Dr. Mike Ryan says that it is not yet certain whether the antibodies formed in the body of new coronavirus patients after their recovery will be able to protect them from this virus infection again or not.

According to the scientific idea of herd immunity, if a disease spreads to a large part of a group, then the human immune system helps the infected people to fight that disease. People who fight the disease and recover completely become immune to the disease, which means they develop immune properties. Immunity means that a person becomes infected and then their immune system develops antibodies capable of fighting the virus. As more people become immune, the risk of spreading the infection decreases.

Today, not only China but India is also witnessing reverse attacks of the coronavirus, but the truth is that the lack of collective immunity only exacerbates the epidemic. According to epidemiology, the spread of a disease depends on the lethality of the virus or bacteria and the immunity of human beings. The proportion of those who have received the vaccine or medicine and the proportion of infected people and the cleanliness of the environment are the decisive aspects of the spread of the disease. If the lethality of viruses or bacteria is weaker than the immunity of human beings, then the disease does not occur. If the power of both is the same, then nothing happens.

The conflict begins when the power of one side is relatively increased. The lethality of a germ depends on its number, aggression, fertility, and potency. The immunity of the masses depends on the collective immunity formed by combining the immunity of each individual. When an epidemic strikes, people either become infected and die, or become immune when they recover. As the number of people recovering increases, so does the number of people resistant to the disease. As a result, one day the number of people resistant to the disease exceeds the number of patients, and the epidemic subsides.

So far, Coronavirus cases have been steadily rising, but recently there have been reports of four million people recovering from about 79 million cases worldwide. India is giving a recovery rate of 50 percent through its data, while the US is giving 41 percent, China 90 percent, Germany 91 percent, Italy 74 percent and France 46 percent. But these figures are also compared to the total number of infected people, not to the total population, while the herd immunity works on the concept of the total population.

According to Johns Hopkins University, 70 to 90 percent of the population needs to be immune to reach herd immunity; still, scientists hope that if the epidemic reaches the community level, herd immunity may come in handy. But, they have no answer as to how this will work in the absence of a vaccine.

The number of people infected with the coronavirus worldwide has crossed six million, but so far no exact cure or vaccine for this virus has been developed. A report in The New York Times states that the number of people infected with the coronavirus may be much higher than the figures actually shown. Due to the lack of drugs and vaccines, it is believed that the coronavirus will remain with humans, for some time at least. The threat of a second wave remains in many countries, but despite this, the world is still far from herd immunity.

Is this possible in India? Dr. Ramanan Laxminarayan, director of the Washington-based Center for Disease Dynamics, Economics and Policy, and a senior research scholar at Princeton University in the United States, has tried to explain this in the Indian context. He says, "Instead of waiting for a vaccine, we can move towards controlling Covid-19, which is possible through a scientific concept called Herd Immunity. If they have mild or no symptoms at all, Dr. Laxminarayan continues, then the remaining 35% of the population will also get protection from COVID-19."

The growth rate of the virus has decreased and the time it takes for the infection to double has also increased, but a closer look reveals that cases are on the rise in more affected cities like Mumbai, Delhi and Ahmedabad and hospitalization and mortality are also on the rise. A physician treating COVID-19 patients says, "if the infection continues like this, the condition of these cities will be like New York." In many cities, patients are not being admitted to hospitals and they are dying, in one case, a patient died in a toilet. Labs are receiving more samples than the actual capacity, which is delaying the tests.

Ashish Jha, Director, Harvard Global Health Institute, says, "I am concerned about the growing number of cases in India. It is not that the coronavirus will automatically decrease once it reaches the peak, you have to take steps for that." He says that India cannot wait for 60 percent of the population to be infected to develop herd immunity; it will kill millions and is not an acceptable solution. Bhramar Mukherjee, a professor of biostatics at the University of Michigan, says the corona's curve in India has not declined yet. He adds, "We should worry, but this worry should not turn into panic."

'Hello, Please Help Me': Why Distress Calls Ring This Kashmiri Lawyer

T was still wee hours of the morning when Mehreen Zafar's phone started ringing. As she received the call, a lady was on the other side started crying and beseeching her for help.

She told Mehreen that her name was Sania. In order to celebrate Nauroz, she had visited her parent's place for a couple of days in March this year but got stuck there due to the sudden implementation of CO-VID lockdown.

Somehow she managed to travel back to her husband's place but her in-laws vehemently denied her entry, on the grounds of her being infected with the virus.

This was not the first time she faced harassment at her in-laws. She, along with her children, has been facing domestic violence at the hands of her husband for many years now.

Mehreen is a lawyer at district court Budgam and has been nominated by the court to handle cases for women in distress and at the receiving end of domestic violence.

Since the pandemic hit, there has been significant increase in the domestic violence cases worldwide with Kashmir being no exception to it.

The lady lawyer told Kashmir Observer that the situation in many places is quite grim.

"Things are getting out of our hands," she said. "It's beyond all reason why women should suffer even inside the safety of their homes. All the associated lawyers have been receiving a lot of calls and queries. Our phones remain engaged all the day long. There're harrowing tales of what is happening with people out there. From physical to mental abuse, to denying maintenance and custody of children, people are putting women through a lot."

Another call, just a minute later, was from Shairil. Shairil has been married for six years and has two kids. Since her marriage, her in-laws have been harassing her, to the point that they even tried to strangulate her to death.

Even though she survived, she had to listen to abuses and corrosive remarks against her.

Her husband along with her in-laws continuously subjects her to domestic violence which even caused her a miscarriage during her first pregnancy.

He's "involved in an extramarital affair" and in order to hide it, her in-laws have defamed her in society, saying she's characterless.

In order to escape from the everyday ordeal of violence and humiliation, she left to live with her sister but is being denied the custody of her children.

Shairil has lodged a police complaint against the accused, but there has been no action so far. She wants justice for herself and her children but due to the official apathy, her pain persists.

To add to the miseries, her husband wants to divorce her and her in-laws have also filed a case against her. She's so distressed that she wants to commit suicide and end everything in a single go.

As the call ended, advocate Mehreen looked lost in some thoughts.

"What you're noticing is just the tip of the iceberg," she said. "Every day we listen to stories of abuse and ill treatment."

Caught in bad marriage, Ambooj only wants the rights of her son safeguarded.

Even more disturbing case is that of Abida.

Abida was married in February last year. Within a couple of days, her husband and mother-in-law started torturing her for land as dowry. Her husband even spent all the money in her bank account.

The case gets even more interesting as the family had lied that the groom is a jeweller by profession but was actually a salesman at someone's shop and had even quit that job.

Abida had called the lady lawyer because her husband and mother-in-law were threatening her with divorce. She's facing social, mental and emotional harassment at her in-laws and is disturbed by this thought and even has her doubts that her husband is involved in an extramarital affair with her sister-in-law, brother's wife. with her parents, neither allowing her to visit nor letting them come over. She's not even allowed a phone.

Her husband constantly tells her that this marriage was not with his consent and on this pretext, talks to other ladies.

Isha has two children and yet is not provided any kind of financial support by her husband. Her needs are catered to by her parents. She has had family counselling many times but that didn't improve her husband's behaviour.

When she confronted him about the ladies he talks to, he slapped her. She has previously complained against him and now wants to file for a domestic violence case.

Advocate Mehreen talked about Mehak, a blind yoman who lives with her mother and two sisters.

hopes that the distance and the presence of a child would change the scenario but is facing the same issues. Since her husband is a government-employed teacher, she does not want any form of police action but is in dire need of family counselling.

Sabina has a similar story to tell.

She got married in December 2019 and within a week her husband started fighting with her. He blatantly told her that he does not love her and keeps talking to some woman over phone and internet. This has led her to believe he might be involved with someone.

Some home investigation revealed that he claims to love the woman after they started talking over social media platforms. He had even hidden the fact that he is married.

He does not provide Sabina with any financial support either. Even though she is four months pregnant, she's constantly subjected to mental harassment since her marriage and now has been sent to her parents in March. No one has either come to take her back or asked her to come back on her own even though she wants to.

Even though there has been no physical violence against her, Sabina wants her rightful place at her inlaws and a constant maintenance.

Lawyer Mehreen also mentioned that all cases are not related to marriage and in-laws.

"In many cases it's the victim's own kin and kith that violates the sanctity of their relationship," she said. "Like Mehak and Iteba, Rehana is also facing violence and harassment at the hands of her own maternal grandfather."

Rehana's father shifted to her wife's home instead of following the tradition of a lady relocating to her husband's home.

For a good many years they lived together and now they've even constructed their own house. Rehana has 4 more sisters and the eldest one was kept at her grandparents so she may take care of them in their old age.

"Rehana's grandfather used to beat and harass all of them and now that they live separately, he hasn't left bossing around them and keeps interfering, making sure he controls all strings of their life," the lawyer informed. "He would not let them decide for themselves either. They've never complained before as they didn't know whom to turn to for help."

Mehreen is not merely concerned with receiving the distressed calls. Before she can initiate any action, she has to cross-verify all the claims and with the lockdown it becomes difficult.

Another lawyer, Nausheen Bhat, however, shared that a lot of domestic violence cases are false allegations.

"Women are not as naïve as they used to be a century ago," she said. "Not only men, but women also have extra-marital affairs and sometimes have married only under parental pressure. These women later falsely accuse their husbands of domestic violence so they can attain a divorce along with some monetary benefits after which they marry their boyfriends."

In many other cases, Nausheen said, the women are merely playing power games so that their husbands would do whatever they say. "This whole issue has become a nasty business," she continued. "Nobody can be trusted without proper background verification."

She went on to narrate the case of Ambooj.

Ambooj had complained that she's staying at her maternal home for the last one year. She was married on September 25, 2017 and soon after her husband started torturing her for one reason or the other, even threatening her with suicide if she didn't comply.

Also, during her pregnancy, he would harass her

Her husband intends to marry this lady, so is forcing Abida for a divorce and has stopped having any kind of physical relationship with her for past six months.

Abida's husband tried to beat her the previous



and force himself on her, and would even forcefully feed her certain drugs so her pregnancy might be terminated prematurely.

All this caused her tremendous mental stress, making her bleed even during her pregnancy. Her husband did not bother to take care of any expenses, neither during, nor after, her pregnancy.

Ambooj delivered the child in consultation with a private doctor as she had multiple complications.

As she went to her maternal home after the delivery, her husband does not want her to come back home and constantly threatens her to hand over all day as well but she's scared to talk to anyone about her issues and apprehensions.

Even her parents do not listen to her as they're being influenced by her sister-in-law and hence she's facing this trauma all alone. Her husband has even retorted to threatening her about being sent to a mental asylum in order to get rid of her.

Inside the lady lawyer's chamber, the phone kept ringing. Next on line was Isha.

Isha has been married for eight years. Her husband began harassing her within a couple of months after their marriage and does not even let her be in contact Her sisters are also blind.

"She said that her brother and sister-in-law beat her and use abusive language against her, owing to her blindness," the advocate said. "Her father has passed away and her brother wants to own their house. Mehak's mother has already handed over their land to him but now he wants ownership of the house too."

Mehak's sister-in-law was related to them before marriage hence they agreed to the match but after marriage the behaviour of their sister-in-law changed. Her brother lives separately but sometimes he comes over and starts beating everyone.

"Mehak told me that her brother beat her yesterday after which she complained in PS Kupwara but till now no action has been taken," the lady lawyer said. "They're helpless and in dire need of help."

However, Iteba has an altogether different story.

She's a maiden and is facing domestic violence verbal, mental as well as physical abuse—at the hands of her parents and brothers from March 2019.

Her parents want her to marry at the earliest, even without considering whether the match is worth and hence leave the household. This has caused Iteba tremendous mental trauma.

On March 19, 2020, a family was coming to see her but due to the sudden COVID lockdown the programme was postponed which became a new reason for the domestic violence against her.

"She said she's being maltreated by her parents, the reason being her younger brother who instigates her parents and the youngest brother (a drug addict)," advocate Mehreen said.

Iteba, she said, is being insulted on everything she does and has absolutely no idea what to do about it.

"Due to being confined in homes together and not allowed to venture out, people are feeling cornered," the lady lawyer continued.

"After a few days of rest and relaxation it becomes difficult for a huge majority to come to terms with this confinement. It often leads to anger and frustration, which is quite normal. What's unfortunate in this scenario is that women are becoming targets of these anger bouts and suffering at the hands of their companions."

Insha's case is a typical representation of this lockdown anger.

Her husband harasses her for trivial issues and matters, and keeps shouting at her. He mostly remains irritated and angry with her and would not let her make calls even though she works in a hospital and has to remain available on call.

She has been married for 14 years out of which she spent 9 years with her parents. Her husband refuses to contribute anything towards household expenditures and in turn misbehaves with her.

Insha shifted back with her husband in 2018 with

In a case, she faced a couple where the lady claimed that she's being tortured by her mother-inlaw. After some tantrums and a lot of drama they started living separately.

Everyone felt things are improving and everything is settled when the lady fought with her husband, mid-road and spewed venom. She alleged a lot of things, which even her husband was ashamed to retell. Her husband is shocked that after everything that he sacrificed to be with her, she would repay him this way and not even care to keep things private.

In a similar case, another lady is headed for divorce because of her extra-marital affairs.

Her husband was quite generous and forgave her mistake, and was ready to live with her normally when the family got to know that she has other relations. That was the deal breaker.

Mehreen had to face this difficulty quite early in the lockdown phase.

"I was approached by an NGO working for children," she recalled. "They claimed that they needed to bail out a child from custody as he has been falsely accused. As I put out appeals and everything, I came to know that the child has been held under charges of rape, which the NGO hid from me. A lot of people hide such information and cause us a lot of embarrassment. I had to write back to them and refuse any association or assistance in the case."

The sad part is that this is not merely something triggered by the lockdown. This is something that goes on even when things are normal.

A lot of people suffer either because they're too naïve to understand what is happening, have been fed patriarchy so badly that they do not even think about raising their voices or seeking help, or think that they themselves are to blame for these circumstances, Mehreen said.

"The cases mentioned are like a needle in hay," the lawyer said.

"There're numerous cases of violence, slander, cheating and neglect, enough to fill up a whole room. Just by mentioning a few might bring them justice or might show hope to someone in need but this is not how things will improve. We, as a society, have to raise our voices against the wrongdoers, irrespective of their gender. Till we remain in denial, call ourselves a pious society and turn our eyes away, people will continue to suffer one way or the other. We also need to reinstate the Women Commission as lawyers cannot attend to every query and concern of women suffering from everyday life."

Covid-19 Patients With High Stress Hormone Levels At Greater Death Risk: Lancet Study

LONDON- -19 patients with extremely high levels of the stress hormone cortisol in their blood are more likely to deteriorate quickly and die, according to study led by an Indian origin researcher in the UK.

The study, published in The Lanto show that cortisol levels are a marker of the severity of the illness.

WASHINGTON DC: Treating patients suffering from coronavirus infection with transfusion of blood plasma from those who already recovered from the disease have been found to be safe and beneficial, a study suggested.

The new study, conducted over 20,000 hospitalized CO-VID-19 patients, was based on a century-old idea in medicine that has been used against measles, influenza and Ebola. The treatment, also called convalescent plasma, found that people who recover from infection have virus-fighting antibodies floating in their blood, and transfusions of their plasma - the clear liquid after blood cells are removed -- may give recipients' immune systems an assist in fighting off the virus, The Washington Post reported. The study, published in Mayo Clinic Proceedings on Thursday, is the largest analysis yet of an experimental treatment rapidly deployed in the early weeks of the pandemic through a grassroots effort by physicians. TORONTO- : Researchers have results are timely as experts found that suffering from dean increased risk of cardiovascular disease (CVD) and even death. US Supreme Court Blocks Donald Trump's Bid To End **Immigrant Program**

Washington: The US Supreme Court on Thursday dealt President Donald Trump a major setback on his hardline immigration policies, blocking his bid to end a program that protects from deportation hundreds of thousands of immigrants - often called "Dreamers' who entered the United States illegally as children.

The justices on a 5-4 vote upheld lower court rulings that found that Trump's 2017 move to rescind the Deferred Action for Childhood Arrivals (DACA) program, created in 2012 by

protected from deportation and eligible to obtain renewable two-year work permits.

The ruling does not prevent Trump from trying again to end the program. But his administration is unlikely to be able to end DACA before the Nov. 3 election in which Trump is seeking a second four-year term in office.

'We do not decide whether DACA or its rescission are sound policies. We address only whether the agency complied with the procedural requirement that it provide a reasoned explanation for its action," Roberts wrote.

Blast in southern Pakistan kills three

Karachi: At least three people, including security personnel, were killed in a roadside blast in southern Pakistan Friday, police said.

Two members of the Rang--- an elite paramilitary security force -- were killed after an improvised explosive device detonated near their vehicle in the city of Ghotki in Sindh province, senior police officer Hafiz Abdul Qadir told AFP.

A second security official who spoke on the condition of anonymity also confirmed the attack and toll.

Rural Sindh is home to some of Pakistan's most impoverished areas with powerful landowners holding vast sway over large populations of effectively indentured labourers, who have little in the way of access to education, health-

care or upward social mobility. In 2017 the Islamic State claimed a suicide blast at a Sufi shrine in Sindh which killed 90 people, in one of the bloodiest attacks to hit the province in years.

Pakistan has slashed militant violence in the country since launching a series of offensives since 2007 against homegrown insurgents as well as Taliban and Al-Qaeda-linked militants -- often based near the lawless border with Afghanistan.

The offensives have also been coupled with operations by security agencies in urban areas, hitting militant networks hard and dramatically reducing violence across the country.

Militant groups however still retain the ability to launch periodic attacks in many rurals areas of the country.

A Bank of England spokesman said: "As an institution, the Bank was never itself directly involved in the slave trade, but is aware of some inexcusable connections involving former governors and directors and apologises for them."

The Lloyd's of London insurance company also apologised on Thursday for its 'shameful" role in the 18th century slave trade and pledged to fund opportunities for Black and ethnic minority people.

The history of several other financial firms in the UK, including Barclays, is also under fresh scrutiny.

'Sorry is not enough'

A regional alliance of Caribbean countries reacted to the move, saving the institutions that benefitted from slavery should go further than saying sorry and atone for their role in the slave trade by fund-

Scenes of people standing in the rain waiting for stores to open were seen throughout Japan and broadcast on Twitter, while Uniqlo's online store apologised for crashing and later selling out of the washable Airism masks.

The company said more will become available as it was stepping up production. The masks are sold in three-piece packs for 990 yen (\$9.26) plus tax, and are available in three sizes

Prospects of a prolonged crisis have encouraged Japanese consumers to buy and make reusable, washable versions even as disposable masks, initially in short supply, have become more easily available.

Fitch Lowers India's Outlook To Negative After 8 Years

Thursday lowered India's outlook to negative from stable for the first time in eight years saying the coronavirus pandemic had significantly weakened the country's growth outlook for the year and exposed the challenges associated with a high public-debt burden.

The international rating agency, however, retained India's rating at 'BBB-', which is the lowest investment grade and a notch above junk, and said that there are considerable risks to growth.

Fitch expects economic activity to contract by 5 per cent in the fiscal year ending March 2021 (FY21) from the strict lockdown measures imposed since March 25, before rebounding by 9.5 per cent in 2021-22.

"The coronavirus pandemic has significantly weakened India's growth outlook for this year and exposed the challenges associated with a high public-debt burden. The rebound will mainly be driven by a low-base effect," it said, while revisforeign-currency issuer default rating (IDR) to negative from stable.

Fitch had last in 2012 cut India's outlook to negative, from stable. In 2013, the agency had again upped the outlook to stable.

It projected general government debt to jump to 84.5 per cent of the gross domestic product (GDP) in FY21 from an estimated 71 per cent of GDP in FY20.

Fitch's rating action comes after another rating agency Moody's earlier this month downgraded India's sovereign rating by a notch to lowest investment grade of 'Baa2' for the first time in 22 years.

This measure has been introduced in order to improve the airline's cash flow position amid the coronavirus pandemic, they added. "The permanent employee who opts for such a scheme can avail this for a period of one year," the officials said. The pandemic has impacted the aviation industry significantly, and all airlines in India have taken steps like cutting salaries of employees, firing employees to improve their cash The officials said that the employees opting for the flow. "shorter working week scheme" would not have the option to take any other employment during the remaining days of the week. After a gap of two months due to the coronavirus-triggered lockdown, India resumed its domestic passenger flights from May 25 albeit in a curtailed manner. International passenger flights continue to remain suspended in the country.
