3 Minors Among 5 Killed In Doda Accident

Bhadarwah- Five people, including three minor children, were killed when their car skidded off the road and rolled down into a 350-feet deep gorge in Jammu and Kashmir's Doda district on Friday, officials said. The car was on its way from Gool area of Ramban district to Thathri town of Doda district. The accident took place near Raggi Nallah around 10 am, they added. "Police party from nearby Assar police station immediately rushed to the spot and started rescue operation along with volunteers, but all the five passengers, including the driver, were declared dead on the spot," Mushtaq Ahmed, Station House Officer (SHO) Assar, said. Medium Intensity **Ouake Hits Ladakh**

New Delhi: A medium intensity earthquake of magnitude 4.5 hit Ladakh on Friday evening, the National Centre for Seismology said. The quake occurred at 8.15 pm at a depth of 25 kilometres, it added. The Himalaya region is highly prone to earthquakes.

Pak National Held By BSF In Gujarat

Ahmedabad: The Border Security Force (BSF) on Friday apprehended a Pakistan national from Kutch district in Gujarat for trying to enter India illegally, officials said. He was held while trying to enter Indian territory from Pillar Number 1082 in the Rann of Kutch. a BSF release said. Nothing suspicious has been found on him, it said, adding that a joint interrogation would be done by security agencies before he is handed over to the police. LADAKH STAND-OFF **India Warns China Against Changing Status Quo**

BEIIING: India on Friday warned China that trying to alter the status quo on the ground by resorting to force will not just damage the peace that existed on the border areas but can also have "ripples and repercussions" in the broader bilateral relationship, and demanded that Beijing stop its activities in eastern Ladakh.

The only way to resolve the current military standoff along the LAC in eastern Ladakh was for Beijing to realise that trying to "change the status quo by resorting to force or coercion, is not the right way forward, India's ambassador to China Vikram Misri said in a hard-hitting interview to PTI. Asserting that actions taken by the Chinese forces on the ground have damaged "considerable trust" in the bilateral relationship, the Indian ambassador added that it was entirely the responsibility of the Chinese side to take a careful view of the relations and to decide which direction the ties should move.

Noting that maintenance of peace and tranquillity "on the border is sine qua non for progress in the rest of bilateral relationship between India and China", Misri said: "The resolution of this issue is quite straight forward from our perspective. Teen Injured In Cross -LoC Firing In Poonch

JAMMU: A 17-year-old girl was injured on Friday after India and Pakistan troops exchanged heavy gunfire along the Line of Control in Jammu and Kashmir's Poonch district on Friday, officials said.

Nazia Kouser was grazing cattle ahead of the border fencing along the LoC in the Challerri area of Shahpur sector when the Pakistan army violated ceasefire and fired at her around 6 pm, they said.

She was initially treated at a hospital in Poonch and later referred to Jammu for specialised treatment, the officials said.

District Development Commissioner, Poonch, Rahul Yadav confirmed the incident and said an immediate assistance of Rs 10,000 has been given to the girl's family.

Srinagar: Sixteen more Covid-19 positive patients, including a pregnant woman on Friday were discharged from JLNM hospital Rainawari after fully recovering from the deadly disease. Nodal Officer for Coronavirus at JLNM Hospital, Dr Bilguees said that all these patients were asymptomatic. She said all patients were from Srinagar city. Most of these patients were discharged after 20-25 days.

"The total discharged patients from Rainawari Hospital till now are 375 while total positive patients admitted in the hospital at present are 60 in general Isolation Wards and 8 positive pregnant patients in Gynae Isolation Ward," she added.
