India Deploys Missiles, More Troops In Ladakh To Meet Chinese Threat: Report

NEW DELHI: As tension continues to soar between India and China along the Line of Actual Control (LAC) in Ladakh, the Indian armed forces have deployed advanced quick-reaction surface-to-air missile defence systems in the mountainous region to thwart any possible attack by Chinese forces, ANI reported Saturday.

Indian military is also amassing more men and material as a precautionary deployment along the 3,488-km-long disputed border to meet any eventuality.

The deployment, perhaps one of the biggest in the recent years, comes at a time when India and China are locked in a hitherto unprecedented standoff - for eight weeks now - at multiple points along their border.

Quoting government sources news agency ANI reported Saturday, that as part of the ongoing build-up in the sector, the air defence systems of both Indian Army and the Indian Air Force have been deployed in the sector to "prevent

"We all are aware how Pashmina goats in Ladakh are already dying on a larger scale," Ashiq continued. "Now, if this LAC dispute continues, then our workers, weavers, dyers, artists are going to face tremendous loss."

From ending June every year, Kashmiri Pashmina traders start receiving consignment from Ladakhi nomads – who shear their goats to produce the valued raw Pashmina.

But this year, Ashiq said, it looks like the chain has already been affected.

"A huge chunk of Kashmiri women is part of Pashmina industry. They produce Pashmina threads, weave them into the finest fabric, and do embroidery on shawls," Ashiq said.

"One can only imagine their plight if China continues to occupy the winter pasturelands of Pashmina goats." Massive Industry At Stake

Kashmir's Pashmina industry is 600-year-old, which produces world-class shawls known for their grace, class, texture and

The industry of weaving yarns and manufacturing Pashmina shawls and scarfs is huge and caters to a massive market in the

"As a major livelihood activity, there're 6-7 lakhs people involved in the Pashmina industry," said Showket Ahmed Mir, vice president, Genuine Kashmir Cottage handicraft production

"This is their way of income, they're dependent on this. People here are hit by the border disruption and pandemic together. For a long time, the raw material hasn't come down from Ladakh. People are still managing with the old Pashmina stock." Majority of the Pashmina craftsmen, artisans and weavers belong to socio-economically backward classes.

"Most of the Pashmina artists are women, who support their family with their craft," said Parvez Ahmad of Kashmir Artisan Rehabilitation Forum.

"The crisis in the industry is on our head. We haven't got any new supply yet due to LAC faceoff. The entire chain is disturbed right now. Weavers, dyers, embroiders and designers will be badly hit. And these aren't well off people. We're already in a real bad shape and this is going to worsen our condition. **Unending Nightmare**

From manufacturing units to the weavers to the distributors, everyone related and engaged to the Pashmina industry is having a tough time today. While New Delhi's "development" promise remains elusive, the Sino-India LAC showdown has only become another nightmare for the artisan community.

"Pashmina industry is slowly getting hit," said Imtiyaz Hussain Mir, a Pashmina manufacturing unit owner. "Few of our units are already out of the stock. The raw materials have not been coming. Our families, workers, artists are dependent on us. For a large number of women in the rural area, Pashmina is the only source of income."

If the standoff continues and China won't retreat, 80 percent of the industry will collapse, Mir said.

"This LAC tension has a huge impact on us," the Pashmina trader continued. "Already our economy is in shambles, and these tensions in the habitat of Pashmina goats are only going to eat away our ancestral self-sustaining line of work now."

Soon after the Chinese started transgressing into Indian territory into the May first week, the Indian Air Force had sent its Su-30MKIs to Eastern Ladakh after they were found close to entering the Indian air space there. The Chinese choppers have been coming frequently up to their claim lines in the Ladakh sector including a construction site close to the Galwan valley there, the report added.

Alleging that the last six years have seen the biggest diplomatic failure under the Modi government, the former Union minister said "some quick action" should be taken to resolve the LAC issue with China.

"Some quick action is required," he said seeking early resolution of the border dispute with China, while noting that diplomacy and economic blockade with China would not work.

"Yes, the action should be strong (against China). The quality, nature and the timing of that action has to be decided by the government," he said when asked what "quick action" he was asking for. Sibal said it was for the government to decide and not the opposition.

The Congress leader alleged that China has erected tents and structures near PP-14 in Galwan Valley, the place where 20 Indian soldiers sacrificed their lives. He added that satellite imagery also reflects construction of new black top roads by Chinese forces on the Galwan riverbed, erection of large numbers

of military tents and presence of bulldozers and other heavy

"What is our government doing about it? The PM must clear the air and condemn these brazen Chinese incursions," he said. Asking why the prime minister does not openly and publicly condemn the "brazen acts of infiltrations, incursions and occupation" of Indian territory by China, he said, "I want the PM to publicly condemn China. We will support the prime minister." Sibal said the situation is such that the PM's statement that nobody intruded into India is being used by the Chinese globally. "We want the prime minister to address the nation and promise that if anyone has captured Indian territory, we will push them back. If you say so, the public and the entire opposition will stand behind you and your promise," he said.

There has been a standoff between Indian and Chinese troops in the eastern Ladakh area for over a month and a bloody clash took place between them on the night of June 15 in the Galwan Valley, resulting in the death of 20 Indian soldiers.

other districts are equally discouraging. The auction bid for 15 blocks in Pulwama has jumped from the previous Rs 2 Crores to a whopping Rs 17.82 Crores. There is no way that the local contractors can compete and thus disadvantaged," the spokesperson said.

He said while the Government may see the increase in revenue as a positive sign, the consequential increase in material costs for the consumers suggest that it is the locals consumers who have to pay the price.

"Instead of money flowing into the local economy there is all likelihood of a reverse outflow. The introduction of heavy machinery in the extraction process would leave the local sand diggers jobless and the environmental costs are also worrying," the spokesperson said.

"A non-local syndicate appears to have altogether muscled out local stakeholders and is now indulging in aggressive and unfair trade practices. The cost of sand has been more than doubled,"

The spokesperson further said that with the constitutional changes introduced post August 2019, the government was expected to be fully alert with regard to protection of local economic interests from predacious groups.

'The first claim on local resources rightfully belongs to the natives of Kashmir and the Government of Jammu and Kashmir - whatever constitutional structure it may acquire - is duty bound to protect the legitimate entitlement of people of Jammu and Kashmir. Utmost caution needs to be exercised in formulation of economic policies which may otherwise appear to dilute their claims or prove detrimental to the interests of people connected with trade, commerce and industry," the KCCI spokesperson said.

The KCCI urged government for urgent review of the mining and extraction policy to address local interests and incorporate protective clauses for stakeholders and consumers.

"The district wise share of local stakeholders needs to be reserved to the extent of nothing less than 80 percent and market prices of materials need to be capped. It is further urged that the engagement of local labour for sand digging be made mandatory and use of heavy machinery restricted," the spokes-

The trade body urged LG Murmu to order the implementation of the new mining or extraction policy in abeyance till the time a revised policy is announced in consultation with stakehold-

"West Pakistan Refugees (WPRs), Safai Karamcharis and Children of Women married outside Jammu and Kashmir who were earlier deprived are also eligible for Domicile Certificate. West Pakistani Refugees were part of the Parliamentary electoral roll but not of the erstwhile state electoral roll. They will now be covered under the 15 year residence rule or their children under the 7 year/ class 10/12 rule," he added.

Dr Nisar said Covid-19 infection is likely to spread throughout

Quoting a new study published in Canadian Medical Association Journal, he said summer won't halt the spread of Covid as was previously hoped.

Dr Nisar said policy makers and public should remain vigilant in their response to the pandemic, rather than assuming that summer climate will naturally prevent spread of the virus.

"Studies have shown that public health measures like restrictions on mass gatherings, school closure, physical distancing and wearing face mask play an important role in stemming the spread of the disease," he said.

People must continue to follow health guidelines and if they don't, we will end up in a big outbreak which will be difficult to control," said Dr Nisar.

Among today's new cases include 31 CRPF personnel from 44 battalion posted in HMT Srinagar, two BSF men from 102 battalion Kupwara and two soldiers from army's Badamibagh cantonment. Besides it, the fresh cases also comprise six-month-old baby and three other minors.

He said he was again visited by some officials who told him that considering his age and failing health, the government was willing to set him free on the condition that he agreed to retire from politics.

"They also told me that 'you are an elderly person', to which I said that there are many people who are older than me and yet incarcerated and that they should take a view of everybody if they are really concerned about our age and health issues," the former minister, whose PSA detention order mentions his endorsement to Hurriyat leader Syed Ali Geelani's autobiography for students as an education minister, said.

"I told them that more than 100,000 people have already lost their lives in the three-decade-old turmoil, many of them just 14-15 years old. If an old man dies in your prison it won't be a big deal and I won't consider it as a sacrifice.'





When Hoodbhoy Loses Job

Pakistani academician's situation is reflective of the moral and intellectual crisis prevailing in most parts of the Muslim world

he genesis of western civilization lies in the religion of Israel, culture of Greece and laws of Rome. Western civilization has continuously experimented with institutions, ideas, new scientific beliefs, new forms of political order. This continuous tradition of reinvention and experiment led to Enlightenment, to democracy, to social orders which believe in freedom of speech and opinion, freedom of religion and clear distinction between religious clergy and politics.

Pervez Hoodbhoy, a well known physicist in Pakistan was recently caught in controversy. Some of his statements oflate were asking for trouble. I knew something was brimming underneath. Finally the apprehension came true. His university refused to renew his contract for next year. Happens often in our part of the world. Ultimately, however, it's the state's own loss and that of its people. Hoodbhoy will be welcomed by any top university in the west. He will be another addition to sub-continent's growing forced immigration.

Why have Muslims closed the doors to reason and science. Why is that a civilization which rose with such abundance of energy in the seventh century Hejaz area, and which spread across Africa, Far East to produce universities, libraries and a rule of law, in so many places is mute and resentful. Averse to ideas of science and civil liberties.

If the heart of Islam looked towards Mecca, its brain looked towards Cairo, Istanbul and Tehran. In that case, any development in Egypt's political capital has far reaching consequences on entire Muslim world. When in 1981 Anwar Sa-

dat was assassinated by his own guards, it was a triumph of takfiri Islam, which declares impious or unjust Muslims to be deserving of death- a basic precept behind many of today's militant groups. The actual story though goes a little back in time

The downfall of Islamic civilization started almost around 12th century. By then many factions had developed, none more bigger than the shias with the rise of Safavid dynasty in Persia in later centuries. Cataclysmic events like the Crusades, the Mongol invasion led to doubt and turmoil in Muslim world. A consequent internal struggle led to defeat of Islam's philosophical thinkers at the hands of their purist opponents. Rationalism was seen as a culprit. In the words of Imam Ghazali and Ibn Taymiyyah, the goal of the believer was not to know God, but to obey him. It was a master-slave relationship, far different to what earlier Muslim thinkers like Ibn Rushd, Ibn Sina saw it as. The moral and intellectual crisis

in the Muslim world led to its turning back on philosophy and taking refuge in dogma. The Ash'rite sect in Muslim found a potent voice in Imam Ghazali (died in 1111), a brilliant philosopher and theologian. As per him the human reason teaches us to ask questions, discover things, and to make new laws for better governance. For Al Ghazali the reason was enemy of Islam. In his celebrated tractate, The Incoherence of Philosophers, al Ghazali set out to show that reason, enshrined in the writings of western philosophers like Plato and Aristotle leads to nothing but darkness. His arguments were soundly refuted by Ibn

Rushd in his The Incoherence of the Incoherence, but it was that moment of reckoning where Muslims turned to Ash'rite doctrine. Ibn Rushd was sent from Andalusia into exile, and the voice of reason was heard no more in the courts of Sunni Muslim princes.

The assault on philosophy went hand-in-hand with an equally determined assault on law and jurisprudence. The early Islamic jurists had sought to arbitrate Quran and traditions with demands of justice, and had developed a system of law which could be applied in developing circumstances of social life. The interpretation of the law was subject to study and amendment by individual effort called Ijtihad. However, in the 11th century of our era, it became accepted that 'the gate of Ijtihadis closed' - as al-Ghazali himself declared. Since then no new interpretations of the law can be entertained and what seemed right in 12th century Baghdad or Cairo, is right for 21st century as well.

Over time as Islamic civilization was taken over by European Renaissance in 14th century, the decadence was visible in Muslim world. While west was advancing on ideas of reason and science, by early 20th century, the last Muslim Caliphate fell in Turkey sending Muslim world again in introspection. Following the credo of cause and effect, there rose a movement of Islamic revivalism in Cairo, led by Hassan-al Bana. He and later his disciple Syed Qutb, were fundamentally students of Imam Ghazali and Ibn Taymiyyah. They believed Islam as a total system, meaning classical western concepts of separation of church from state did not apply to Muslim world

In his seminal workMilestones, Syed Qutb widely criticizes west, blaming it for complete annihilation of humanity and vital values. He stressed on new world leadership. His growing obsession with 'jahiliyah'- the non-muslims and calls for renunciation of everything that belongs to jahili environment was problematic from the onset.

However, like in 12th century, Syed Qutb found followers in abundance across Muslim world and to the day continues to pull weight among young muslims. His works are widely distributed among Muslim diaspora in the westwhose existential crisis is fed by likes of Syed Qutb.

By drawing the curve of Islamic civilization, it is very clear how its medieval glory proved its ability to generate new ideas, leading to wider cause of human development. Science and experiments were at the core of its civilization. By reading Prophet Muhammad's life, it becomes clear on many occasions that this was his purpose. Unfortunately the later decline owes to the shunning of those basic ideas. This was not what Islam had taught. There is in fact a Quranic verse that shows God's displeasure at an inactive mind. "The worst of creatures for Allah are deaf, dumb, those who will not reason.

ammu and Kashmir has been going through a continuous political churn ever since 5 August 2019, when the BJP government in New Delhi abrogated Article 370. Along with revoking its Constitutionally-guaranteed special position, the Centre has abrogated Art 35A and divided it into two Union Territories. Now the government has released new domicile rules for the erstwhile state. The new rules have generated fresh scepticism, fear and suspicion, particularly in the Kashmir valley and the Muslim-dominated regions of Jammu.

The manner in which these decisions are being taken and implemented—during a lockdown, in the midst of a worldwide battle against the Covid-19 pandemic—reaffirms that Kashmir remains in what the Italian philosopher Giorgio Agamben has called a "state of exception".

KASHMIR AS STATE OF EXCEPTION:

If you ask New Delhi why it has taken any harsh step with regards to Kashmir, you will get the answer that it is because Kashmir is not like any other "normal" place. This is true of all governments, irrespective of their leanings to the right or left. Everything from imposing governments to rigging elections, from tightening state surveillance and harsh security laws to growing military presence, is justified in Kashmir in the name of "national security" and its being an "abnormal" place.

For instance, the people of Kashmir are denied basic rights such as access to the internet, which people in the rest of the country can simply take for granted. The same arguments were put forth in defence of the abrogation of Articles 370 and 35A and for downgrading the state to two Union Territories.

A careful reading of history will reveal that at almost every point, the most important decisions regarding the state, which have serious impact on the future of its people, have been taken "for" them from above and not "with" them. Even the pro-Indian mainstream leaders, be it Sheikh Abdullah and his children or another former chief minister Mufti Sayeed and his

Has 'Normalcy' Made Kashmir More of an Exception?

progeny, were sidelined, even declared anti-national at will by governments at the Centre. This has completely eroded the trust of institutions among people—but is this not exactly how a "state of exception" is governed?

In his book, State of Exception, Agamben argues that in areas that are designated exceptional, inhabitants are stripped of their rights, reduced to "bare life" and submitted to the sovereign power of the state. The literary critic Leland de la Durantaye has expanded Agamben's "state of exception" to mean "that political point at which jurisdiction stops, and a sovereign unaccountability begins; it is where the dam of individual liberties breaks and a society is flooded with the sovereign power of the state."

Not just individuals, even the authority of elected institutions are taken over by nominated ones as the Centre appropriates the powers of local representative bodies. In other words, encounters with the state as well as basic notions and experiences of state, nation and citizen significantly vary between "peaceful" and "disturbed" areas. The peaceful areas represent the "core" whereas the "disturbed" or "exceptional" areas remain on the margins of the state.

The "state of exception" also constitutes what anthropologist Carolyn Nordstrom calls the "shadows". In her book, Shadows of War: Violence, Power, and International Profiteering in the Twenty-first Century, Nordstrom defines as the "shadow" those areas which exist as "part of the formal state, but at the same time remain excluded from it in terms of violent realities of everyday life". To cite such a parallel in Kashmir, while mass protest could be a standard tool of normal politics elsewhere in India, in Kashmir it is unacceptable. This is because from the state's

point of view protest in Kashmir is a nonviolent expression of separatism, which, if left unfettered, would engulf all Muslimdominated areas of the state.

Recently, the Supreme Court refused to pass an order to restore 4G internet services in Kashmir and instead asked the Centre to constitute a committee to look into the matter. This is ironic in this context, given that it is the government which had banned internet access and has constantly been resisting its restoration at full speed, even in Supreme Court.

INSTITUTIONAL TRUST DEFICIT:

Kashmir is also exceptional in the sense that it was never considered worthy of democracy and civil liberties. Elections were mostly a farce and free and fair polls were seen as an "anti-nation" activity that would hand over Kashmir to "anti-national" forces. Over time, "client" governments imposed on the region by New Delhi had been eroding Kashmir's special position.

There were exceptions, such as the 1977 election, which was by and large won fair and square by the National Conference. Yet the pressure on the Sheikh Abdullahheaded state government from the authoritarian and interventionist Prime Minister Indira Gandhi was so intense that his Principal Secretary Ghulam Ahmad recorded in his book, My Years with Sheikh Abdullah, that the "erstwhile lion became mortally efferied of Mrs. Condhi."

tally afraid of Mrs. Gandhi."

Not much changed as the decades passed. The Abdullahs and the Muftis were choked and made to fall in line from time to time. The policy of imposing governments and the denial of democracy turned the state, as the political scientist Sumantra Bose has said in his book, Contested Lands, into a "...police state in

which civil rights and political liberties were virtually non-existent."

Not much changed even when militancy began to wane and elections generated huge mass participation. To an extent, the emergence of militancy and the global governance ethic did force the rulers in New Delhi and Srinagar to revisit their strategy of managing the state. Thus, where electoral democracy was regarded as a serious threat to peace for about half a century, in that very place the deepening of the electoral process started being regarded as an effective instrument to restore "order". In his paper, "Kashmir in 2003: Counterinsurgency and the Paradox of 'Normalcy'", the political scientist Paul Staniland notes that such a paradox arises when "...liberal democracy clashes with the state's preference for a political status quo.'

ence for a political status quo."

That is, the state encourages electoral competition but local politics is "carefully controlled and manipulated; the rule of law is hailed, but state accountability is extremely weak" and non-violent protest is the official aspiration of the state, but practically it is "met with heavy-handed security forces".

security forces".

Staniland argues that in Kashmir the fundamental spirit of democracy gets compromised because it is a "patronage democracy". Political parties are propped up and the Centre establishes control over them, through what he calls "patronage money". While political parties and their leaders are given some leverage, within a Lakshman Rekha, in crucial matters of "security" and the central policies on Kashmir, the local government becomes a non-entity. Political parties may float proposals (such as for autonomy or self-rule) and may raise slogans ('withdraw AFSPA' or 'promote cross-LoC trade') but in prac-

tice they do not matter.

Manipulating parties, eroding their credibility and base, and the dual emphasis on patronising and marginalising local governments has undermined governance and democratic credentials in J&K. This politics of manipulation and impunity erodes the trust of people in institutions. This is also clear from the following CSDS-Lokniti data.

When asked about institutional trust during a post-poll survey in 2002, the sampled respondents expressed their opinion as follows:

Not much has changed over the years. The question was asked during the 2014 election survey as well, and the responses are recorded below.

Similar opinions were expressed with regard to the paramilitary forces as well as local police. It is pertinent to mention that while the data provided here relates only to the Kashmir region, if data for the state as a whole is analysed, one will notice significant regional variations. This variation may not be visible for state institutions, however, with respect to central institutions, the Jammu region, and especially its Hindu dominated areas, show a very positive attitude.

Every move by New Delhi since last August has been carried out with the promise of fostering national integration, stopping militancy and ushering in a new era of development. This idea of developmentalism is not new for Kashmir. It has been used from time to time, with little success. One does not find any noticeable private investment having come to Kashmir since the abrogation of Art 370 and Art 35A. Political activity continues to be curtailed. The prominent Kashmir-based political parties are caught in a Catch-22 situation, while new political formulations are being propped up. On issues such as the domicile law, there is scepticism even in Jammu. There is an eerie silence on the ground and how this is going to unfold only time will tell.

COVID-19: Europe is looking at 'smart lockdowns'

Germany, Italy and Portugal are betting on smaller, local shutdowns to prevent new surge

uropean Union countries are experimenting with new ways of dealing with the coronavirus. Germany, Portugal and Italy have all enforced selective or "smart" lockdowns, shutting down smaller regions in response to new outbreaks as opposed to bringing their entire countries to a halt.

This approach is the only hope of returning to a more normal life as we wait for a vaccine. However, it also puts a much larger onus on the public sector compared to generalised lockdowns. Health officials have to ensure small outbreaks do not get out of control and force the need for harsher measures.

Germany has seen a number of outbreaks in abattoirs, leading local governments to declare new lockdowns, such as in the municipality of Guetersloh, and enforce partial lockdowns, such as in the nearby town of Warendorf

Smart lockdowns require the collaboration of citizens: Wearing masks and maintaining social distancing are two ways to reduce the risk of a new surge in cases. However, much of the burden falls on governments. They have to identify new cases early through rapid testing and contact tracing in order to circumscribe contagion

Over the past few months, Italy has managed to contain some small flare-ups, including one in the tiny region of Molise and one in Rome, without having to impose additional restrictions.

Worying new spike

But the southern region of Calabria has recently imposed quarantine on an area of the seaside town of Palmi, after a handful of cases were reported. And after a worrying new spike in cases, Portugal has ordered stores in parts of the Lisbon region to shut down early, among other restrictions.

Some of these cases show striking similarities. For example, many of these new outbreaks originated in migrant communities facing overcrowded living quarters or unsafe working conditions.

This was true of one meat processing plant owned by the Toennies Group in Germany, where more than a thousand employees, most of them migrants from Eastern Europe, came down with Covid-19. This was also the case of the much smaller outbreak in Italy's central region of Marche.

It was similar in Portugal: At the end of May, an outbreak emerged in Lisbon's Jamaica neighbourhood, which was already struggling with a housing crisis. Health-care facilities are another potential source of contagion, as was the case for the recent flare-up in Rome.

Containing the outbreak

So far, the authorities have managed to contain these outbreaks. In Italy, the number of new infections has been stable in the low hundreds for the past few weeks, despite a substantial reopening of the economy.

In Germany, the reproduction rate "R" of the coronavirus, which measures how many people a virus carrier infects on average, shot up to nearly three last weekend — well above the level of one needed to believe the outbreak is under control.

Fortunately, this factor has begun to decline. According to the country's Robert Koch Institute, it also

does not appear to be too alarming since the overall number of cases remains relatively low.

This tailored approach to lockdowns is in no way a repudiation of the more draconian measures most European countries enforced earlier.

Not feasible for all nations

In fact, the current strategy can only work because Europe has largely brought new infections under control. It doesn't look as feasible for countries such as the US and Brazil, where new infections are still on the rise in many areas.

Smart lockdowns require the collaboration of citizens: Wearing masks and maintaining social distancing are two ways to reduce the risk of a new surge in cases. However, much of the burden falls on governments. They have to identify new cases early through rapid testing and contact tracing in order to circumscribe contagion.

ibe contagion. Getting more people to download contact-tracing apps would help on this front (not enough have done so in France and Italy), but the authorities will also have to ensure local health-care systems have enough staff to trace infections effectively.

Finally, they'll need to manage the process of reopening borders carefully, especially when it comes to countries that have not yet kept the virus in check.

Of course, all of this may not be enough.

e have this huge, ancient Indian almond tree just outside the bedroom window and sometimes peacocks from the neighbouring plantation visit us and sit on the branches and scream in the night, and it is like someone being strangled.

Then we have the melodic Koel, and suddenly in the middle of this beautiful bird song, we hear a cat meowing in tune, and it is the Catbird, that mimics various species. So we have chirping and yowling, all at the same time.

Deathly quiet

But today it was deathly quiet. Maybe the birds could sense something was not right, even if you could not witness the Solar Eclipse in Bengaluru.

The only spots where you could see the "ring of fire" in India was from Dehra Dun, Uttarakhand, Rajasthan and Haryana, as the sun was fully covered by the Moon's shadow, with only the rim showing.

Birds and animals can sense if anything is wrong and if things are awry in nature. It is said dogs can predict an earthquake and start howling



much before it occurs.

I remember one scene in the War of the Worlds when people are fighting to get on board a ferry to escape from the Aliens who are just behind them, and Lucy the young girl character in the movie, looks up as chaos reigns around her, and sees birds, in their thousands, fleeing from inland to the open waters of the ocean

On the social media platforms, Indian millennials were having a great time spoofing the superstitions, and of course, the heated topic of discussion was fasting during the eclipse.

It is not just during an eclipse, but Rahu Kalam, the period of time that is inauspicious, occurs every day in India, and there are certain things one is supposed to avoid doing during these hours.

Here is a conversation most people from India can relate to:

Daughter: Mom, the guests will be arriving from 3pm and as you know the wedding ceremony is 3.45 and please let's not delay anything.

Dad's voice thundering from inside his room: Which silly priest gave you the auspicious time. Here, look at my calendar, it is Rahu Kalam from 3.15 to 4.15pm. If you marry during this time, there will be suicides, shootings, divorce and general mayhem.

Daughter: Dad, please, neither Anand nor I believe in the stars. Will you take your BP medicine and have a nice cup of chai.

In Dubai, the Indian and other expatriates usually do not forget their traditions, and every time the Solar Eclipse occurs, the head of the Astronomy Department would be inundated with calls from anxious women.

"I tell them, especially the pregnant women, there is nothing to be worried about, and it is just superstition," he once told the media.

Russia offered Afghan militants bounties to kill US troops: NY Times

Washington: US intelligence has concluded that the Russian military offered bounties to Taliban-linked militants in Afghanistan to kill American troops and other coalition forces. the *New York Times* reported on Friday.

Citing officials briefed on the matter, the Times said the United States determined months ago that a Russian military intelligence unit linked to assassination attempts in Europe had offered rewards for successful attacks

Islamist militants, or armed criminal elements closely associated with them, are believed to have collected some bounty money, the newspaper said.

The White House, the CIA and the Office of the Director of National Intelligence declined requests from Reuters for comment on the Times report.

President Donald Trump has been briefed on the intelligence finding, the Times said. It said the White House has yet to authorise any steps against Russia in response to the bounties.

Of the 20 Americans killed in combat in 2019, the Times said, it was not clear



which deaths were under suspicion.

After nearly 20 years of fighting the Taliban, the United States is looking for a way to extricate itself from Afghanistan and to achieve peace between the US-backed government and the militant group, which controls swathes of the country.

On Feb 29, the United States and the Taliban struck a deal that called for a phased US troop withdrawal.

US troop strength in Afghanistan is down to nearly 8,600, well ahead of a schedule agreed with the Taliban, in part because of concerns about the spread of the coronavirus. US and NATO officials said in late May.

Russia denounces 'baseless, anonymous accusations'

The "baseless and anonymous accusations," published by the newspaper, had "already led to direct threats to the life of employees of the Russian Embassies in Washington DC and London," the Russian Embassy in Washington wrote on Twitter.

"Stop producing #fakenews that provoke life threats, @nytimes," it added in a later tweet.

Russia has a tortured history in Afghanistan, where the former Soviet Union in its final years was bogged down in a devastating fight against Islamist guerrillas, then backed by Washington.

But Russia has more recently been accused by the United States of quietly providing small arms to the Taliban.

According to the newspaper, the Taliban operation was led by a unit known as the GRU, which has been blamed in numerous international incidents including a 2018 chemical weapons attack in Britain that nearly killed Russian-born double agent Sergei Skripal.

Israeli forces launch massive attack on Gaza

BEIRUT, LEBANON (1:00 A.M.) – The Israeli Defense Forces (IDF) launched a big assault over the Gaza Strip, hitting several areas, including Khan Younis.

According to Palestinian activists, the Israeli Defense Forces primarily used heavy artillery and airstrikes to hammer the southern part of the Gaza Strip, with the main focus being the Khan Younis region.

Furthermore, local media said that an Israeli warplane bombed east of the city of Deir al-Balah, without causing any injuries or damage to the place.

Israeli artillery bombarded another site with two rocket-propelled grenades east of Gaza City, where it was found that the shelling targeted a monitoring post of Hamas.



In a related context, the Israeli Iron Dome system monitored Friday evening the launch of two rockets from the Gaza Strip towards Israel.

Israeli Channel 13 reported that "the two rockets landed, one in an uninhabited area on the Israeli side of the border, while the other landed inside the strip."

This latest incident comes at a time of heightened tensions between the Palestinian leadership and Israeli authorities over the possible annexation of the West Bank.



India Turns Down Pak Offer To Reopen Kartarpur Corridor

KARTARPUR SAHIB CORRIDOR: The government on Saturday, rubbished Pakistan's "readiness" to reopen the Kartarpur Corridor for Indian Sikhs, by calling it an attempt to create "a mirage of goodwill".

Taking to Twitter, Pakistan's Foreign Minister Shah Mahmood Qureshi on Saturday, announced:"As places of worship open up across the world, Pakistan prepares to reopen the Kartarpur Sahib Corridor for all Sikh pilgrims, conveying to the Indian side our readiness to reopen the corridor on 29 June 2020, the occasion of the death anniversary of Maharaja Ranjeet Singh."

The corridor was temporarily closed on March 16 in the wake of the COVID-19 pandemic that originated in China's Wuhan city.

Official sources in New Delhi said that Pakistan is trying to "create a mirage of goodwill" by proposing to reopen Kartarpur Corridor on June 29, at the short notice of two days, while bilateral agreement provides for information to be shared by India with Pakistan side at least seven days before the date of travel.

This would need India to open up



the registration process well in advance, the sources said.

Besides, Pakistan has not built the bridge on their side across the flood plains of the Ravi river despite having committed to it in the bilateral agreement.

With the advent of monsoon, the sources said, it would need to be evaluated whether pilgrim movement is possible through the corridor in a safe and secure manner.

Official sources said cross border travel has been temporarily suspended as part of measures to prevent and

contain the spread of coronavirus. "Further view would be taken in

consultation with health authorities and other stakeholders concerned," an official said.

The 4.2 km corridor links Dera Baba Nanak town in Gurdaspur district with Kartarpur Sahib Gurdwara in Shakargarh tehsil in Narowal district of Pakistan.

India and Pakistan in October 2019 signed an agreement to operationalise the Kartarpur Corridor to allow Indian pilgrims a visa-free visit to the holy gurdwara, believed to have been built on the site where Guru Nanak died in the 16th century, and located some 4 km inside Pakistan.

Dolice are questioning a casting director with Yash Raj Films (YRF) at Bandra police station here in connection with the death of actor Sushant Singh Rajput, an official said on Saturday. Police are probing whether professional rivalry, if any, was responsible for the actor's depression who was found hanging at his apartment in Bandra on June 14.

The casting director, Shanoo Sharma, reached the police station in the afternoon after she was summoned by the police. "Shanoo Sharma, a casting director with the Yash Raj Films, is being questioned at Bandra police station," said Abhishek



Trimukhe, Deputy Commissioner of Police (Zone 9).

Representatives of some more production houses are likely to be called by the po-

lice for questioning in the next few days, another official said. Sharma is one of the popular casting directors in Bollywood who had reportedly spotted talents like Ranveer Singh, Arjun Kapoor, Vani Kapoor to name a few for Yash Raj Films, sources said.

She had worked with the deceased Rajput in YRF's "Shuddh Desi Romance" and "Detective Byomkesh Bakshy!". Days after Rajput was found hanging, YRF handed over copies of the contract signed between him and the production house.

BJP Must Safeguard Land And Job Of J-K Permanent Residents: NC Leader Rana

Tational Conference leader Devender Singh Rana appealed to the BJP and the Jammu and Kashmir administration on Saturday to come up with a road map for safeguarding land, job and seats in professional colleges for the permanent residents of the Union Territory. Rana said some of the recent moves, especially the new domicile rules, have caused concern and apprehensions in the minds of the people but added that his party would remain at the forefront to ensure that their lands and jobs are protected.

"Repeated assurances and rhetorical statements by Jammu BJP leaders that lands and jobs of the permanent residents will be pre-



served exclusively for them (permanent residents) have turned out hollow and bereft of facts on the ground," the Jammu provincial president of the NC said. He said the BJP leaders should clean up these issues and stick to their commitments made to the peo-

ple with regard to the preservation of their rights vis-a-vis land and job in Jammu and Kashmir.

"Government must come up with a pragmatic mechanism to address these important matters in tandem with the sentiments and aspirations of the people of J&K, who are genuinely feeling a sense of denial, deprivation and politico-economic disempowerment," he said. Rana described job eligibility and ownership of land as the most "emotive and sensitive" issue and said ambiguity on the part of the government in the backdrop of promises made by the BJP top leadership from time to time, has added to the concern of the people.

France Arrests Six Over Stolen Banksy Artwork - Source ix people have been arrested in France over the theft of an art-
