## **Kupwara's Killer Well And A Wedding Tragedy**

AHIDA was looking forward to be swarmed by her happy kin who now take turns to console her.

But as the thirty-year-old soonto-be bride remains inconsolable, brought amid sobs and shrieks, a horde of villagers walk in with she saw her lifelong cherished long faces, only to make her home a packed house of mourners.

None of them came out alive.

By the time villagers learned about the tragic event, lot of time had already elapsed. Amid hue and cry, it took hectic efforts from locals, police and other allied departments to retrieve the trapped bodies from the well. They were evacuated to a nearby health facility.

"The deceased were brought dead to the hospital," Dr. Kounsar Amin, Chief Medical Officer Kupwara, told Kashmir Observer. "They apparently died due to suffocation. A post-mortem report is still awaited.

As per the villagers, some "inert

gas" leaked by the weathered walls of the well choked the four men to death. While only an investigation will clear the picture, the loss has already numbed the hamlet.

Among the deceased, Altaf Khan and Showkat Khan, residents of Dard Hari Sangdan, were preparing for the marriage of their sister for months.

"Everything was going well, but we had water scarcity in the village," Nisar Khan, brother of the deceased siblings, told Kashmir Observer. "One has to travel 3 kilometres to fetch water here."

SRINAGAR: The number of COV-ID-19 cases in Jammu and Kashmir have jumped to 8246 as 227 fresh cases including 35 CRPF and 4 BSF personnel besides five pregnant women tested positive for the virus on Saturday

Among new cases that were detected in Jammu and Kashmir on Saturday, 89 were tested positive at SKIMS, 37 at JVC Bemina and rest at other hospitals.

Among 201 new cases, 197 belong to  $\check{\text{K}}\text{ashmir}$  division while as 30 are from Jammu division, officials said, adding that the total number of positive cases in Kashmir division has reached to 6524 including 3869 recoveries and 113 deaths while as total number of positive cases in Jammu division has reached to 1722 including 1274 recoveries and 14 deaths.

#### Govt Hints At 'Restricted' Amarnath Yatra This Year

500 Yatris To Visit Cave Per Day For 15 Days; Daily Puja To Be Telecast Live

JAMMU- Asserting that the upcoming annual Amarnath Yatra would have to be undertaken in a "restricted manner" due to the CO-VID-19 pandemic, the Jammu and Kashmir administration on Saturday said only 500 pilgrims would be allowed per day by road from Jammu to the 3,880-metre-high holy cave shrine.

It also said the standard operating procedures (SOPs) for testing of persons entering the Union Territory would also be applicable to the intending Amarnath pilgrims.

"The yatra this year will have to be undertaken in a restricted manner so that the SoPs for COVID-19 are strictly adhered to during the conduct of the yatra... a maximum of 500 yatris only could be allowed per day by road from Jammu," Chief Secretary B V R Subrahmanyam said.



He was chairing a meeting of the sub-committee constituted by the Supreme Court for the yatra here. In the meeting, he reviewed

the arrangements, including security for the pilgrimage, an official spokesman said. The 42-day yatra was scheduled

## 90 Million Gallons per day supply against required 68 MGD

Dedicated IVRS Call Centre sanctioned for water supply related issues

SRINAGAR, JULY 4: District Administration, Srinagar conducted a comprehensive review of water supply scenario in the city and directed for a host of measures to ensure regular supply and stringent measures against misuse of drinking water for commercial purposes and illegal drilling of supply lines. Concerns related to shortage of water in tail-end areas of some supply lines were reviewed for permanent solutions.

District Development Commissioner Shahid Iqbal Choudhary reviewed the status of supply and approved several measures through inter-departmental coordination for better public grievance redressal, optimum water use, incentivizing authorized connections and strict measures against misuse and malpractices reported therein.

Presently the department has installed capacity to supply 90 Million Gallons of Water every day against maximum requirement of 68 MGDs, with per capita availability of 45-50 Gallons against optimum 30 Gallons. The department expressed concern over rampant misuse of drinking water for commercial and nonrevenue purposes prohibited under law, lack of storage capacity in residential buildings, illegal installation of power motors, car washing, irrigation, damage to supply lines by drilling in many areas. Factors responsible for shortage in some tail-end areas were discussed and measures finalised for permanent resolution.

Underlining the importance of immediate and efficient public grievance redressal he sanctioned Rs 10.00 Lakh for establishment of a Modern Grievance Redressal Cell, integrated with the IVRSbased Call centre already established in DC office ,to attend public complaints raised through helpline numbers which shall operate round the clock, involving record note of calls and real-time tracking of disposal of complaints or issues.

In view of average 200 Ltr of water supply every day against recommended per capita 135 Ltr the measures for promoting judicious use, water conservation, incentivising the registered consumers and action plan against misuse were dis-

The district administration and Jal Shakti Department have also initiated the process of finalisation of plan for installation of Smart Water Meters, for which the funding under Smart City Mission has been made available and steps have been taken for engagement of consultant. The installation of smart water meters is aimed at eliminating the misuse of drinking water supply, centrally controlled response system, timely resolution of supply issues and real-time monitoring.

Meanwhile the district administration has urged all residents who have unregistered tap water connections to approach the offices of the concerned assistant executive engineers and have them

registered. It is notable that just around 1.5 lac out of around 2.5 lac households in the district have registered connections. While all households are supplied tap water this fact complicates and hampers the grievances and complaints redressal efforts of the department.

However as noted above efforts are afoot to strengthen the redressal mechanism of the Jal Shakti department in the district. In each of the 73 administrative wards of the district a district metered area or DMA with designated response team of officials is being created in efforts to redress concerns in a prompt manner as part of these efforts.

Other relevant details were also discussed in the meeting. It was informed that the Jal Shakti department has started online payment of water dues for the convenience of consumers adding that the latter can make the payment from www. ikphedwaterbilling.com website or from J&K Bank's mPay mobile application







#### Pace Of Dialogue **Unsatisfactory: Pak**

'Abandon wullar barrage

SLAMABAD - As Pakistani and Indian officials continue discussions on various issues under the ongoing composite dialogue, Islamabad on Monday said progress towards resolution of issues between the two countries has not been in accordance "with what it had.

"We want a meaningful progress towards the resolution" of disputes with India to build a lasting trust between the two countries." Foreign Office spokesman Jalil Abbas Jilani, said at the weekly press briefing here.

On the upcoming visit off Pakistani and Indian Prime Ministers to the United States, he said it was a coincidence that both the leaders were visiting Washington this, month but added that they would be in the US on different dates. "The United States like the rest of the world is interested' in

the peaceful resolution of the issues confronting the two nations for bringing peace and stability in the region," he noted. Jillani said that after a long time there had been frequent high level contacts between the leadership of India and Pakistan, adding that these engagements gave hope of an early resolution of all outstanding issues, including Kashmir.

'We do want to proceed with people to people contact but issue of Kashmir needs to be resolved, otherwise "the trust level between Indian and Pakistan would not improve," Mr Jilani stressed.

When asked about reports that Pakistani diplomats were being harassed in-India, he said Islamabad had sought more details from its mission if New Delhi.

On the recent Indo-US defence pact, Jilani said Pakistan has conveyed its concerns over the 'induction of sophisticated weapons to India. "It will perpetuate an arms race in which Pakistan does not want to enter," he said, maintaining that it will remain a matter of concern for Pakistan. Elaborating reports on the grant of permission by the Ministry of Commerce to import certain goods from India, he said all such items would be allowed through the

Meanwhile Pakistan on Monday asked India to abandon too Wullar Barrage project over river Jhelum, saying it will restrict the flow of water which is against the provisions of the Indus Water Treaty. "Under the Indus Water Treaty, only 0.1 Million' Acre Feet (MAP) of water storage is allowed while the Indian project envisages a storage of 0.324 MAF, which is 32 times more than what the treaty allows," Jalil Abbas Jilani told the press meet He said 'the Indian design contemplates construction over 'river Jhelum, while the treaty States that no man-made structure is allowed over the river. "The Wullar Barrage construction is therefore in violation of the Indus Water Treaty," Jilani, who visited New Delhi, last week as part of Pakistan's delegation which held talks with Indian water officials on the issue, said.

The 1960 treaty gives exclusive rights to Pakistan over three of the six rivers which flow from India - Indus, Jhelum and Chenab. He added India has sent the data and documents related to the Baglihar dam to Pakistani experts who will study and substantiate



## Doligam and the House of Khwaja Samad Joo

Last summer when I visited the place, there are newer roads inside the village. It can no longer promise the innocence that dwelled here in its folks

was peering out the weather-beaten window at the moonless Pir Panchal forests when I thought of my belonging. When I had woken up, it was still dark and I thought I was in the bowels of a ghost. The Himalayan heat of mid-summer even at 5 in the morning, had settled over my limbs like moist candy floss. I could hear the call to prayer from loudspeaker in the mosque down the road, haunting and lovely Arabic words sounding brassy over an antiquated land.

I've had a love affair with Doligam always. In a place and time not known for self-invention, Doligam had always cast its spell on me. Yet lingering in small places is not in favor now; they no longer seem to fit the world. Yes, Doligam is fading, as it's been since decades. It can no longer promise the innocence that dwelled here in its folks. That life of its own, which settled along a water canal that traversed this quaint village of medieval grandeur. In the corner of the scene, row of women would wash clothes, children played with shards of stones, small stones, that shone under tall walnut trees, men went out for work -- their modest government jobs-taking the same road along that canal, which ended on a curve, the macdamized road from where it took them to main Banihal town, four kilometers

Last summer when I visited the place, there are newer roads inside the village. Concrete replacing the sharp slate stones which were once strewn on its muddy alleys. In houses that I walked past after years, residents were glued to televisions. The sound produced by one of its main natural streams remained from old times. Perhaps, like an artefact. A remnant.

So being woken up early on that morning, what really made me think of

was us. Us as people. Of memories. Of places where sense of belonging comes. It is said unless you have someone of your own buried in a land it doesn't be-

The association between our families goes back a long way. My great grandmother belonged to the landlord family of Wanyee's of Doligam. Wanyee over the years, probably due to their association with urban Srinagar, turned to Wani. There are many far flung areas in valley, where a local dialect of surname prevails. My great grandmother is buried in Doligam, her village of birth, in the precincts of a shrine belonging to PirMehmood Shah, a disciple of Hazrat Sultan- Sheikh Hamza. It was PirMehmood Shah who brought the message of Islam to parts of Banihal. Back in the days there used to be a annual festival here, villagers from faroff places would throng the shrine and tie their prayer knots. Nothing of that remains now.

The etymology of 'Doligam' is very interesting as well. It is believed that a Hindu seer named 'Doli' had taken refuge here. The village came to be known after her. There is evidence of strong Brahmin footprints in the village.

One of my cousin, who lives in Jammu, told me once while digging at a cliff for new construction in Doligam, an idol was found. He took it to Jammu and showed to a archaeologist, who told him that this was a sculpture of Lord Shiva and probably belonged to Gupta period; that is around 1500 years ago. This period coincided with Kushan dynasty in Kashmir-preceding Avantivarman and Lalitaditya.

Built on a mountain, Doligam speaks of things Kashmir and of a way of life its elite aspired of. The old house that belongs to our relatives there, stands still. Dilapidated. The traditional Khatam-band work on its ceiling, pointed arches, emblematic of the style of the era, remnant of its past glory. One of its most famous son of soil is KhwajaSamadJoo. And it is with SamadJoo that the connection of my family began with Wanyee's of Doligam.

SamadJoo was a Vizier first in Ranbir Singh's era and then Pratap Singh's. His family held lot of weight in the Pir Panchal mountains. His father Khwaja Afzal SamadJoo was a Tehsildar and an estate owner. He owned swathes of land, right across from Doru in Islamabad to Banihal. Two of SamadJoo's daughters were married in our family; one being my great grandmother. His death in 1891 had created quite a ruckus in the city.

It is said SamadJoo was on an impromptus visit to Srinagar in the early summer of 1891. As was the ritual, he first paid obeisance at Hazrat Sultan at Makhdhoom sahib. He had brought with him an embellished veneered serape, lined with gold, as mark of respect, to be spread over the grave of his sufi master. However, just when he was to leave and he put his feet on the saddle of the horse, the knuckle broke off. The Vizier feared a bad omen.

After a trip to the Dal in the Doonga with noble men of Shawl family joining them-- a common practice back in the days, he died at our house in Khanyar that night. The omen had come true.

The following morning entire city was cordoned off by Maharaja's sepoys. Pratap Singh believed his Vizier was poisoned by his dogra contemporaries, who were jealous of SamadJoo's closeness to the Maharaja.

The matter was later resolved after Maharaja was visited by nobles of the city, explaining that the cause of the death was natural. SamadJoo's burial was attended by every who's who of the

city. In a long procession that started from our house in Khanyar to Makhdhoom sahib shrine, where he is buried, entire city grieved at the loss of this noble man.

In addition to clear presence of gentry in Doligam and hobnobbing with the nobility of the times, Doligam also has a literary company. Abdul Rahim Amma, a poet who was blind by eyes since birth was a contemporary and comrade of Rasul Mir and has written a masnavi called 'Gulbadan' in Persian.

We've a whole litany of documents that prove all above incidents. It is no hearsay. It is remarkable to know how everything was documented in those times- right from the Persian lines written on the serape KhwajaSamad-Joo laid at Sultan's shrine to hundreds of letters written to each other across the Banihal pass. SamadJoo owned a library-- being well versed in Persian and Urdu. Some of his books to the day are preserved in our house in Khanyar.

The houses that were inhabited by these learned men, in their shattered windows, its sills privy to what happened behind them, in the abandoned dark rooms, not just scarred or peeling walls or dusty floors, the lonely taaks perched in its walls, hollow to the eyes. The names hung over them like weights, each light enough to bear its own. Somewhere close a widely lit path of belonging exists. In these experiences, there are places to look back, the anchor and all that was there. Remembrance of who you are and in it your song of belonging.

ny discourse on Kashmir and its people, from an outsider, no matter where that outsider lies on the spectrum of ideologies or what her understanding of nations and nationalism is, must be mindful of the fighting chance she's been given in terms of her rights, in the present times. Just by virtue of being a non-Kashmiri. Justice for the people of Kashmir has been almost Kafkaesque ever since the inception of their struggle. However, there are two unprecedented challenges being faced by them currently. The first being the internet shutdown in Kashmir, the longest ever imposed in a democracy. The second is the challenge presented by COVID-19. Unfortunately for its people, these two challenges have

become horridly intertwined.

Before discussing the implications of these two challenges being faced in simultaneity, perhaps some background in freedoms is necessitated. Article 19(1)(a) of the Constitution of India guarantees all citizens the right to freedom of speech and expression. However, such freedom under Article 19(2) is subject to reasonable restrictions imposed by the State in the interests of, among others – the sovereignty and integrity of India, the security of the State and public order. Our illustrious Constituent Assembly Members had raised concerns while deliberating on the Article, as it was called then the Draft Article 13. As to Draft Article 13(2) restrictions, Damodar S. Seth was of the opinion that:

"...to suspend civil liberties is tantamount to a declaration of martial law. Even in the United States, civil liberties are never suspended. What is suspended there, in cases of invasion or rebellion, is only the habeas corpus writ. Though individual freedom is secured in this article, it is at the same time restricted by the will of the legislature and the executive which has powers to issue ordinances between the sessions of the legislature almost freely, unrestricted by any constitutional provision. Fundamental rights, therefore, ought to be placed absolutely outside the jurisdiction, not only of the legislature but also of the executive."

## **The Kashmir Blackout**

The author investigates the constitutionality of the internet shutdown imposed in Kashmir. He argues whether the communication restrictions hold up to the test of 'reasonable' envisaged under Article 19(2) of the Constitution of India.

Of course, the Article as it stands today speaks of restrictions being reasonable, vet there rings a modern age truth to the particular concerns of our Constitution Drafters – across India, but especially in Kashmir. In the present times, the pandemic has rendered the legislature dysfunctional and has drastically limited the functioning of the judicial system, to say the least. As a result, the executive has been bestowed with sweeping powers. Whilst this is true across the country, it glaringly pronounced in Kashmir where indigenous political leaders have been placed under preventive detention following the abrogation of Article 370; stringent security measures and now the lockdown. have curbed physical manifestations of protest; and internet restrictions have stripped the people of one of the few basic mediums of speech and ex-

In fact, in January the Supreme Court in the case of AnuradhaBhasin declared internet to be a fundamental right. However, the GOI circumvented compliance by providing 2G internet. Herein, it relied on its narrative that the internet is a means for the thriving of unscrupulous, 'anti-national' and 'terrorist' elements and that any restrictions imposed are thus in the interests of the sovereignty and integrity of India and the security of the State.

There was never any doubt that the state has the power to put certain restrictions on fundamental rights. The question was whether the restrictions in Kashmir were reasonable. The GOI in its argument before Court stated that since August 5, 2019, 108 terrorist attacks have taken place in Kashmir. How is that reconcilable with the fact that till January 2020, there was a complete internet blackout and yet the attacks continued?

GOI has in this regard, failed to establish any proximate or direct nexus between the access to internet and terrorist attacks. By GOIs own admission since 1990, there have been 71038 terror incidents. But, from 1990-2000, the worst period of the conflict, there was no internet in Kashmir, in fact mobile phone services were introduced only in 2003. After the internet was introduced there have been 181 internet shutdowns in Kashmir, and yet, terror incidents remain consistent.

In fact, there is no better example of executive overreach being legitimised in Kashmir, than our Supreme Court letting the executive itself be the assessor of whether 4G internet speed should be restored therein, through a special committee headed by the Secretary of the Union Ministry of Home Affairs! It is most unfortunate that when it comes to balancing a perceived threat to national security and the basic civil liberties of the citizens of our nation, the judicial system has no qualms about authoring preachy judgments that merely defer authority to the executive.

In Superintendent, Central Prison, Fatehgarh v. Ram Manohar Lohia, a five judge bench of the Court mandated that in order for a restriction to be reasonable, there has to be a proximate connection with public order and not a far-fetched, remote or hypothetical one. While the law provides for prior restraint and censorship of speech, provided there is a proximate nexus between free speech and public order, the law does not empower the state to shut down completely, the very means of making free speech.

The state can make an argument that, at times, there may be a proximate nexus between free speech and threat to security, for example a provocative hate speech on the television that leads to communal riots. However, there can never be a nexus, let alone a proximate one, between the medium of television itself and the threat to security. Even during the 1975 national emergency, when the state censored the news, there was no blanket ban on publishing of newspapers.

The Constitution only envisaged temporary restriction on speech that threatens security, but not all speech or the medium of speech. The restrictions imposed in Kashmir since August 5th, 2019 have nothing to do with security or public order and everything to do with dissent. Thus, while GOI might have failed to establish a proximate nexus between access to internet and terrorist activities, what has been established, however, is that these internet restrictions have violated the (i) Right to conduct business by destroying the economy and putting an end to sectors dependent on the internet (ii) Right to education as children haven't been to school in 10 months and there is no possibility of online classes (iii) Right to freedom of speech & expression as people couldn't post online and the press couldn't even file reports. (iv) Right to health by drastically limiting the functioning of the healthcare sector in the middle of a catastrophic pandemic.

## Virtual Tech Is Capturing The Future

atrocities, from web pages and blogs to social media, have proliferated this century. Once unimaginable technology enables individuals and communities to share photos, memories, and ruminations about the past. Recent developments like holograms, artificial intelligence, virtual reality and augmented reality - AI, VR and AR - permit further changes in the very nature of memorialisation, including simultaneously, and sometimes paradoxically, decentralising and globalising it.

Pre-digital practice mostly confined memorialisation to a particular geographical space - often a monument, a museum or an archive. States produced and controlled these spaces, thus using them not only to pay respects to the heroes, victims, and martyrs of its past, but also to craft narratives that supported their own claim to legitimacy.

Virtual memorialisation loosens, if not shatters, such control - carrying the prospect of fundamentally changing how and where collective memory is formed and retransmitted. Digital technology allows those processes both to devolve to individuals beyond the reach of the state and communities that might transcend national boundaries. The resultant local and transnational connections may sometimes reinforce state narratives, but in other instances may serve to contest them. Previously marginalised voices may find a broader audience, while historians and their audiences have the opportunity to use and appreciate new sources and perspectives about the past. Emergent virtual communities generate their own vocabularies as well as their own touchstones for pride, grievance, and understanding.

The use of social media for the memorialisation of mass atrocities illustrates the global dimensions of these new trends. In countries such as Myanmar, Facebook is synonymous with the internet itself. The platform permits sharing of photos, live streaming, pre-recorded videos, stories, and the ability to interact within communities of interest by commenting and 'liking' posts. Residing in 'the cloud', or, more concretely, a server farm in Oregon or Sweden, Facebook commemorative or memorial pages transcend physical space, permitting individuals to form and join communities of interest from anywhere in the world.

In some cases, online memorial sites simply provide a place where people can engage with a memory in a way that is more personal, such as on pages dedicated to the legacies of particular episodes of mass violence. While not necessarily global in ambition, these sites may nonetheless produce the familiar consequence of loosening the nation-state's grip over its historical narrative. Digital forums of memorialisation of wars, genocides and mass atrocities have the power to elevate new voices, allow geographically disparate communities to share experiences and learn about their shared past, and enable others to compose their

own virtual memorials outside the official domain of the state. \\

These positive developments come with limitations and risks. Many states increasingly police social media sites. In some countries, individuals can be arrested for posts and sites deemed oppositional to the state. Revisionist history can also empower denialists or foment resentment at odds with projects of unity and reconciliation. Extremists might also expropriate the virtual memorialisation toolkit for their own hateful purposes, gaining unprecedented global reach.

The first half of 2020 brought a nearly global lock-down to fight the spread of Covid-19, and the ultimate paradox of the local and the global has been laid bare. Confined to our homes and apartments, we were brought perhaps more closely than ever before into direct engagement with people in similar circumstances around the world. In international Zoom conferences, virtual tourism and online memorialisation events, we may be witnessing the emergence of a new norm of

remote mourning and virtual commemoration.

Although the proliferation of digital memoriali-

sation began long before the Covid-19 pandemic, the requirements of social distancing serve to push memorialisation much further into the realm of the virtual The shift from 'real' memorials to virtual ones may be viewed as an extension of globalisation - yet also augers further changes. The current age of populism, nationalism and now the pandemic, each of which threatens to roll back globalisation in one way or another. The turn to virtual memorialisation points to a means for maintaining global connections even as globalisation recedes. At the same time, it illustrates the potential for challenges to state sovereignty and conventional understandings of reality. If, in the future, the past is ultimately represented by decentralised historiography, holograms, or VR or AR tourism, how we define ourselves through our collective memories will

## Where Fiction And Cinema Collide

Awais Khan's debut novel explores issues of love, fidelity, and sacrifice



itwik Ghatak, the great Bengali auteur, has said that cinema is not an art form to him. Instead, it borrows form(s) from other sources such as music, novel, theatre, painting, photography and so on. The only reason he chose the cinema, he elaborated, was that it allowed him to reach a large number of people. Unfortunately, he didn't live long enough to encounter the phenomenon where fiction begins to lean, even recline, on cinema, often referred to as cinematic writing. Though cinematic writing and vivid writing may flow in and out of each other, they are not the same. Cinema's influence on literature is undeniable and how a writer manipulates that influence into the text affects the plot, characters, ideas, the balance between content and context. Fiction, however, is neither cinema nor a TV serial.

Reading Awais Khan's entertaining novel brought an Indian film Rajput (1982) to one's mind. Predicated upon patriarchy, the narrative explores issues of love, fidelity, sacrifice. Hema Malini is betrothed to Rajesh Khanna, a police officer, but she is having a love affair with Dharmender. Rajesh Khanna's wedding procession is ambushed by soldiers from a princely state. Dharmender arrives in time to shoot Rakesh Roshan standing next to the fainted Hema Malini before Rajesh Khanna locates the dead abductor slumped over his wife. Once home, Hema Malini discloses to Khanna that she is pregnant. He thinks the child's father is Rakesh Roshan. That plays out with the backdrop of a princely state, which refuses to be annexed by the Indian state and continues to unleash terror on the local population. Dharmender ends up serving jail time under Rajesh Khanna, who vows to bring the princely state to its knees. Rajesh Khanna begins taking care of Malini's boy only to find out that the child's real father is Dharmender. Approaching climactic battle, Dharmender makes sure that his child and Hema's marriage survive while he sacrifices his own life. Now, let's turn to the novel, which seems to have emerged from the belly of the beast called cinema.

Ali is forced to return to modeling he once abhorred because he needs quick cash so his younger brother, a victim of a terrorist bombing, can have a prosthetic leg. As Ali re-enters the decadent world of high society he encounters an unhappy Mona, married to a construction tycoon with two children studying abroad. Two dramatic strands develop from thereon. Mona and Ali develop mutual attraction. Mona justifies her action partly because her husband, too, has cheated on her several times. Ali is lured gullibly by a friend's friend to a terrorist network as he's given a prosthetic leg free of charge.

In return, Ali is asked to provide information and access to people the terrorist organisation wants to kill. As things build up, Mona finds herself pregnant and is willing to leave her husband. Though abusive, Mona learns, her husband has a good side too, which is why the radicals want him gone. Ali is blackmailed into becoming a suicide bomber to take out Mona's husband or else he'd find his mother and brother killed. Ali can't bring himself to take the final step. Mona's husband learns of her affair. Ali rushes out to the sea to kill himself in the hope of

meeting his mother and brother in a better place. While in mourning Mona visits Ali's grave every day for two hours for many months, but she also wants to recharge the relationship with her husband.

Novels that are fundamentally plot-driven run into the problem of taking structural issues lightly. Sometimes a good writer can wing it by accentuating interiority to highlight exteriority.

I don't mean to suggest that the novel is directly inspired by the film. Rather the writing is heavily influenced by absorbing the influence of such films that employ the narrative technique of Rajput.

Despite being melodramatic, it is a well-crafted novel. The real victim of the bombing is used as a backdrop. Too much energy is spent on relaying how women of upper classes converse and banter, how radical Islamist terrorists wax eloquent and issue threats. Khan tries too hard to achieve believability in his realism. He should've aimed for some impressionism, a bit of expressionism. It could've been a different novel, and a better one, one believes if he had pointed out a connection between the army and its nurturing certain of radical groups, later dividing them into 'good' and 'bad' terrorists. Who knows where the novel could've gone. Instead, the narrative is kept on a tight leash.

There's a basic difference between a narrative film and a novel, which has a much greater ability to go out-of-focus and refocus - literary theorists call it expansion and contraction - to bring in three-dimensionality, a much needed psychological depth and unexpected turn of emotions. The reader learns early on that Mona has two grown-up children, but they remain pretty much absent throughout the novel, making Mona appear like a cardboard figure. Ali has a bit more meat but barely. One wonders if it is Khan has an obsession with physical detail that makes him use the word fat at least seven times while describing mostly women.

This doesn't help even if the reader wants to ignore the sexist trapping of the novel. The development of Mona's character, or the lack thereof, is another issue. One hand, she does not care about material gifts, on the other, she can't conceive of having an agency on her own. The only way she can leave her husband is if Ali leads her. In a magical concurrence of events, when Ali decides to take his life, Mona suffers a miscarriage as well. Status quo ante restores itself just like in the movie Rajput.

Be it through a terrorist organisation or princely state, the sacred institution of marriage has been restored. Good writing requires seeing through these issues. Novels that are fundamentally plot-driven run into the problem of taking structural issues lightly. Sometimes a good writer can wing it by accentuating interiority to highlight exteriority, but in lesser hands, the narrative becomes flat.

From the start, one can tell that the world inhabited by Mona and Ali is going to collide with the world of terrorism, and that Ali is going to pay the price for trespass. Good writing should avoid predictability. Finally, a good editor could've improved the text by making sure that words like flattened and flat do not occur so frequently. While Khan managed to keep my interest, this kind of repetition is just deadwood.

This is a debut novel. Despite some of the weaknesses one cannot ignore, Khan shows promise. His language is modern and he knows how to bring in a Lahori flavor both to the dialogues and narration. He definitely shows a good sense of pacing and that ability alone carries the reader to the last page. That's a good skill to have for a writer of fiction.

## Women With High Bp During Pregnancy Susceptible To Heart Disease

LONDON- Women who experipregnancy are more likely to develop heart disease and heart failure in later life, warn researchers.

Published in the Journal of the American Heart Association, the study found that women who experienced high blood pressure during their first pregnancy were at 45 per cent higher risk of overall cardiovascular disease.

"When we looked at all the available research, the answer was clear women who develop high blood pressure during pregnancy are more likely to develop several different kinds of cardiovascular disease," said senior author Dr Clare Oliver-Williams from the University of Cambridge in the UK.



#### "Asked Me To Light Up" The Oven: Khashoggi **Murder Trial Tells Court**

Istanbul: A Saudi consulate worker in Istanbul told a Turkish court on Friday he had been asked to light a tandoor oven less than an hour after Saudi journalist Jamal Khashoggi entered the building where he was killed.

Zeki Demir, a local technician who worked for the consulate, was giving evidence on the first day of the trial in absentia of 20 Saudi officials over Khashoggi's killing, which sparked global outrage and tarnished the image of Saudi Arabia's de facto ruler.

Demir said he had been called to the consul's residence after Khashoggi entered the nearby consulate to seek his papers.

"There were five to six people there... They asked me to light up the tandoor (oven). There was an air of panic," he said.

Khashoggi disappeared after going to the consulate to get papers for his marriage in October 2018. Some Western governments, as well as the CIA, said they believed Saudi Crown Prince Mohammed bin Salman had ordered the hit - an accusation Saudi officials denied.

Turkish officials have said one theory police pursued was

that Khashoggi's killers may have tried to dispose of his body by burning it after suffocating him and cutting up his corpse.

The indictment accuses two top Saudi officials, former deputy head of Saudi Arabia's general intelligence Ahmed al-Asiri and former royal court adviser Saud al-Qahtani, of instigating "premeditated murder with monstrous intent"

It says 18 other defendants were flown to Turkey to kill Khashoggi, a prominent and wellconnected journalist who had grown increasingly critical of the

The defendants are being tried in absentia and are unlikely ever to be handed over by Saudi Arabia, which has accused Turkey of failing to cooperate with a separate, largely secretive, trial in Riyadh last year.

In December a Saudi court sentenced five people to death and three to jail for the killing, but Khashoggi's family later said they forgave his murderers, effectively granting them a formal reprieve under Saudi law.

A Saudi prosecutor said at the time there was no evidence connecting Qahtani to the killing and dismissed charges against Asiri.

#### **US Sends Aircraft Carriers To South China Sea During Chinese Military Drills**

Washington: Two US aircraft carriers were conducting exercises in the disputed South China Sea on Saturday, the US Navy said, as China also carried out military drills that have been criticised by the Pentagon and neighbouring states.

China and the United States have accused each other of stoking tension in the strategic waterway at a time of strained relations over everything from the new coronavirus to trade to Hong Kong.

The USS Nimitz and USS Ronald Reagan were carrying out operations and exercises in the South China Sea "to support a free and open Indo-Pacific," the navy said in a statement.

It did not say exactly where the exercises were being conducted in the South China Sea, which extends for some 1,500 km (900 miles) and 90% of which is claimed by China despite the protests of its neighbours.

stability," Rear Admiral George M. Wikoff was quoted as saying by the Wall Street Journal, which first reported the exercises.

Wikoff, commander of the strike group led by the Ronald Reagan, said the exercises were not a response to those being conducted by China, which the Pentagon criticised this week as "counter-productive to efforts at easing tensions and maintaining stability"

China dismissed the US criticism of its drills on Friday and suggested the United States was to

blame for increasing tensions. US carriers have long carried out exercises in the West-

ern Pacific, including in the South China Sea, according to the US navy. At one point recently, the United States had three carriers in the region.

China announced last week it had scheduled five days of drills starting July 1 near the Paracel Islands, which are claimed by both Vietnam and China.

Vietnam and the Philippines have also criticised the planned Chinese drills, warning they could create tension in the region and impact Beijing's relationship with its neighbours.

The United States accuses China of trying to intimidate Asian neighbours who might want to exploit its extensive oil and gas reserves. Brunei, Malaysia, the Philippines, Taiwan and Vietnam also lay claim to parts of the South China Sea, through which about \$3 trillion of trade passes each year.

The US statement said the naval exercises gave commanders the flexibility and capabilities "that only the US Navy can command". Reuters

#### **Iran Threatens Retaliation After Possible 'Cyber** Attack' On Nuclear Site

DUBAI: Iran will retaliate against any country that carries out cvber attacks on its nuclear sites. the head of civilian defence said, after a fire at its Natanz plant which some Iranian officials said may have been caused by cyber sabotage

The underground Natanz Fuel Enrichment Plant (FEP) is one of several Iranian facilities monitored by inspectors of the International Atomic Energy Agency, the UN nuclear watchdog.

Iran's top security body said on Friday that the cause of the "incident" at the nuclear site had been determined, but "due to security considerations" it would be announced at a convenient time.

Iran's Atomic Energy Organ isation (AEOI) initially reported an "incident" had occurred early on Thursday at Natanz, located in the desert in the central province

day by state news agency IRNA addressed what it called the possibility of sabotage by enemies such as Israel and the United States. although it stopped short of accusing either directly.

"So far Iran has tried to prevent intensifying crises and the formation of unpredictable conditions and situations," IRNA said. "But the crossing of red lines of the Islamic Republic of Iran by hostile countries, especially the Zionist regime and the US, means that strategy...should be revised."

Iranian officials said they believed the fire was the result of a cyber attack, but did not cite any evidence.

One of the officials said the attack had targeted the centrifuge assembly building, referring to the delicate cylindrical machines that enrich uranium, and said Iran's enemies had carried out similar acts in the past.

#### Nagaland Bans Sale, Consumption Of Dog Meat

The Nagaland government on Friday banned the sale and consumption of dog meat, in a significant decision amid concerns over cruelty to animals.

The decision to ban commercial import and trading of dogs, and sale of dog meat, both cooked and raw, was taken during a state cabinet meeting, said state Parliamentary Affairs Minister Neiba Kronu.

Considering the dangers of importing dogs from other states for consumption and also in line with the Prevention of Cruelty to Animals Act, 1960, the state cabinet took the decision, Kronu, who is the spokesperson of the government, said. The government also decided to ban



commercial import and trading of pigs with immediate effect, he said. The state already banned the import of pigs following the outbreak of swine fever in the region and the cabinet gave approval

to it in the meeting, he said. "The state government has

decided to ban commercial import and trading of dogs and dog markets and also the sale of dog meat, both cooked and uncooked. Appreciate the wise decision taken by the state's cabinet," Chief Secretary Temjen Toy said in a tweet.

#### IIT Roorkee Develops Technology For Smooth Driving In Foggy Weather **DEHRADUN:** The Indian Institute of Technology, Roorkee,

has developed a system to facilitate smooth driving and minimise accidents in foggy weather conditions. A team of researchers at the premier institute has developed an efficient architecture and algorithm to enable better driving experience in low visibility conditions, said an IIT-Roorkee press release. Hundreds of road accidents are caused due to fog every year. The research has been published in the journal IEEE (Institute of Electrical and Electronics Engineers) Transactions on Intelligent Transportation Systems. "The objective of this research was to design a system for real-time defogging that produces a clear image stream from the input foggy frames," said Brajesh Kumar Kaushik, one of the researchers. "The collision of vehicles due to poor visibility caused by fog leads to numerous fatalities annually. This advanced defogging system will aid drivers by providing real-time information and minimise the risks of road and train mishaps due to fog," said Ajit Kumar Chaturvedi, Director, IIT, Roorkee.
