SRINAGAR: Jammu and Kashmir cadre IPS officer Basant Rath has been suspended for alleged instances of "gross misconduct and misbehaviour" with immediate effect, according to a **Union Home Ministry order.** 

The order, issued on Tuesday evening, said the 2000-batch IPS officer was immediately attached to police headquarters in Srinagar.

# 'Withdrawal Of Chinese Troops In Hot Springs Complete; Pull Back Continues In Other Areas'

moved all temporary structures and completed withdrawal of its troops from the face-off site in Hot Springs in eastern Ladakh on Wednesday even as the Indian Army kept a close watch on the pull back and maintained a highlevel of combat readiness in the region, people familiar with the developments said.

They said the two armies are expected to carry out a joint verification in the next few days to assess the implementation of the disengagement process once the dismantling of the temporary infrastructure and withdrawal of troops by China are completed at the friction points along the Line of Actual Control(LAC) in eastern Ladakh.

There has been thinning out of troops from Finger areas in Pangong Tso as well, they said. Pangong Tso has been a major face-off site between the two sides.

The two militaries are set to hold extensive talks on finalising modalities for restoring normalcy and bringing back peace and tranquility in the region after the verification of the disengagement exercise is completed, they said.

The disengagement process began on Monday morning after a nearly two-hour telephonic conversation on an expeditious withdrawal of between National Security Advisor troops from all the standoff points

### J&K Records 5 More Deaths

Dr Tak said. "He died today morning."

About the 75-year-old Batamaloo resident, Dr Tak said that the patient was suffering from chronic kidney disease, hypertension, and hypothyroidism and had bilateral pneumonia. "He died a day after he was admitted to the hospital," he said.

A 65-year-old man from Nadihal, Baramulla died at SMHS hospital. "The patient was admitted to the SMHS on July 6. He had tested positive. The patient was sick with underlying medical conditions that included bilateral pneumonia," Dr Nazir Choudhary Medical Superintendent SMHS said.

He said that 70-year-old woman from South Kashmir's Shopian district was admitted in the hospital with breathing issues on July 6. "She had tested positive for the virus and died late last evening," according to Dr Choudhary.

The fifth Covid death took place at SKIMS, Soura. Dr Farooq Jan, Medical Superintendent SKIMS, Soura said that a woman, aged 36 from Nehru Park area of Srinagar, died due to cardiopulmonary arrest at early morning Wednesday.

"She had a history of hypertension and had gone for renal transplant in 2016. She was admitted in the hospital on June 28 after complaining of breathlessness," Dr Jan said, adding that the deceased had earlier tested positive for the virus.

With the fresh five COVID deaths in the J&K, the number of people who died to the deadly pandemic in UT so far has reached to 148 of which 134 were from Kashmir region and 14 from Jammu.

ready to pay the fees".

It is only the CGC, he said, that is not entertaining the 'legitimate' demands of the students.

Notably, a large number of students coming from outside prefer hostels in Puniab over rented apartments 'due to safety reasons'.

"It's unfair on the part of college authorities to resort to such practices in these challenging times," Manzoor, who evacuated many students from Kashmir during the beginning of the pandemic lockdown, said. "Among the outside students in the campus, 80 percent are from Kashmir.

Manzoor asserted that some 'hostile campus' actions are creating fear-psychosis in the minds of both parents and students regarding future admissions.

Kashmiri students of CGC, which is affiliated to Punjab Technical University (PTU), further claimed that a few days ago, the college authorities even issued a fee notification.

"They are demanding Rs. 23000 as hostel fees for us," a student of CGC told Kashmir Observer on the condition of anonymity. He alleged that the college administration is forcing the students to send a mail as confirmation of leaving the hostel, "in case they're not

A majority of the students are worried because the college administration has set a deadline of July 7 for fee submission.

"I talked to many senior officials of the college administration regarding this and informed them that this is a wrong step, but they said that they had already received orders from the government," the student said.

The move, interestingly, has come at a time when Kashmiri students are already suffering from slow internet back home. Further, Kashmiri students at CGC alleged that they've been asked

to pay for mess. "If we've not eaten any food in the hostel for the last three months, how are we supposed to pay for it?" asked a student from the department of civil engineering

Many students are also alleging that the campus authorities have broken the locks of their hostel rooms without their knowledge and

"This is unfair and breach of privacy," the engineering student said. "The administration told us that they broke the locks for renovation purposes, but then why would they break the locks of our cupboards? There could be so many valuable things like phone or cash in the cupboards. They have put everything in the common room. And when asked, the college authorities are threatening us for highlighting the matter."

Many female students are also bearing the brunt of the current situ-

Hiba Wani (not her real name) from Srinagar said that fearing the spread of the virus, the college authorities asked the students to head home before the lockdown started.

"They said that they were sending us back for only 15 days," Hiba said. "Now they are breaking into our rooms where we have kept our important documents."

A few days ago, a video went viral where the hostel authorities were seen breaking the locks and entering the rooms. "I along with my friends tried to contact our warden," Hiba said, "but she never responded to our calls and messages."

Moreover, MBBS course classes have already started in 4 newly established Medical Colleges at Anantnag, Baramulla, Rajouri and Kathua, while as in GMC Doda, the classes would begin from this year. The Government of India has also released 1st instalment of funds for two more Medical Colleges at Handwara and Ud-

A detailed presentation was also given on Special Initiative to ensure 100% coverage of eligible beneficiaries under Flagship Schemes being implemented in J&K UT. The efforts of the UT administration for the special drive to cover all eligible beneficiaries under 55 schemes of the Central government were lauded. The UT has ensured 100% coverage of beneficiaries under 32 schemes and was committed to achieving the universal coverage under other schemes of the Central Government as well.

It was informed that J&K being a leader in universalization of Health Insurance, over 11 lakh Golden Cards have been generated and 3.5 lakh families have at least one Avushman Bharat Golden Card under Pradhan Mantri Jan Arogya Yojna. ### Valley Rivers Swell As **Glaciers Melt**

Pulwama Areas Under Laar Waters

RINAGAR Rivers and streams in the valley have registered an alarming increase in water levels due to the

ntense spell of heal gripping the region. Several government departments have been put on alert to deal with an imminent threat of floods, even as over two hundred households have been displaced in Pulwama due to

waters from the swollen Laarnullah entering inhabited areas. Glaciers melting under the abnormally high temperatures have raised levels in the Jhelum and other rivers and streams of the valley. In Pulwama a sudden surge in the Laar stream has inundated a large area in Joravillage, displacing 250 of its six hundred households, a KNS re-ort said.

Scores of houses have come under water and hundreds of kanals of land have been submerged, the report said. People have fled their homes seeking higher ground for safety.

The Aribal area, located on the banks of the Laar too has been inundated. Water has entered dozens of residential houses the report said.

A delegation from the affected areas has met the additional deputy commissioner Pulwama to apprise him of the situation.

The ADC has directed the tehsildar concerned to dispatch a team to review the situation and organise relief for the flood-hit population Water has entered paddy fields in several places in the utile) because of rivers over-flowing their banks.

Experts fear that a flood situation is imminent if the heat spell persists with its present intensity, Thegovt has ordered the departments concerned at the district level to be on alert to deal with any eventuality. The metrological department says that although the

maximum temperature is 5 degrees Celsius above normal and the minimum temperature 7 degrees Celsius above normal, the present situation cannot be characterised as an intense or extraordinary heat wave

The rest of the Country is experiencing normal monsoons and rainfall can be expected in the valley within the next two to three days, a spokesman of the metrological department said.

### Bring The Tourists Back

he J&K administration has finally decided to reopen the tourism sector, the backbone of J-K's economy,thathas been shut since August 5 last year when the union government withdrew the former state's special status. The decision was taken at a high-level meeting headed by Lieutenant Governor GirishChanderMurmu. J&K government spokesperson RohitKansalhas said the detailed guidelines and Standard Operating Procedureare being put in place to ensure the tourist arrivals don't lead to further spread of coronavirus. The tourism in Kashmir has reduced to a trickle since August 5 move. And in March when the arrivals were picking up after a long hiatus, the outbreak of Covid-19 forced the government to impose yet another lockdown and ban the entry of tourists as a precautionary measure.

Now, with the union government unlocking the economy and the J&K administration following the suit, the tourism is one of the major sectors of the former state's economy that is being opened up. One of the important measures in this direction is the reopening of the prominent tourist places including parks and gardens. Government had earlier closed them to public in view of the Covid-19 lockdown. This included the Tulip Garden, one of the largest tulip gardens in Asia. However, the government has made it mandatory for every visitor to wear mask, maintain social distancing including at ticket counters. Besides, use of hand sanitizers is a must. There will also be thermal scanners at the entry points.

Tourism is one of the pillars of Kashmir economy. Tourism forms an estimated 6.8 percent of the GDP and employs over two million people in the region. It was dealt a crippling blow in the middle of the peak season last year. Looking back, 2019 as a whole wasn't good for tourism. Nothing went right for Kashmir tourism and in turn for the region's economy. An escalation in India-Pakistan tension following Pulwama bombing in February last year sent tourists packing and forced people planning a visit to defer their programme. Although by June, the situation had improved a great deal and the tourists had started returning, the revocation of the Article 370 put paid to a promising season. In less than two days, Kashmir was empty of all the visitors. This has hit the traders hard. That is, if it hasn't already. For eleven months now no tourists have visited Kashmir. It is good that the administration is finally waking up to the need to revive the sector. Kashmir has lost four straight seasons to the turmoil and the region can ill-afford further halt to the economic activities. More so, the tourism that is so critical to livelihood of a vast section of society.

### Abundant caution

fter three rounds of military-level talks, a round between the two foreign ministers, and on July 5, between the Special Representatives on the Boundary Question, National Security Adviser Ajit Kumar Doval, and China's State Councillor Wang Yi, a movement towards de-escalation is said to be taking place in the military build-up at the Line of Actual Control. Chinese soldiers are said to be stepping back in three of the contentious areas — Galwan, Hot Springs and Gogra. This is a development in the right direction. However, the verification process by the Indian Army is still underway, and it should continue to be so. After all, the incident at Galwan Valley in which 20 Indian soldiers were killed, took place at a time when the two sides were supposed to be disengaging. Moreover, there appears no de-escalation at the other "friction point", Finger 4 at Pangong Lake. In any case, disengagement does not mean a return to status quo ante yet. At Sunday's Special Representatives meeting, the two officials reiterated their commitment to the maintenance of peace and tranquility in the border areas. But the distinct difference in the tone and tenor of the readouts of this meeting put out by the Ministry of External Affairs and the Chinese Ministry of Foreign Affairs draws attention to the hazards of jumping to conclusions. According to the Chinese statement "the right and wrong of what recently happened at the Galwan Valley in the western sector of the China-India boundary is very clear. China will continue firmly safeguarding our territorial sovereignty as well as peace and tranquility in the border areas"

The challenges ahead for India remain enormous. One is the sheer length of the LAC — 4,000 km of it, compared to the Line of Control which is 740 km. Apart from the disputed portions that already exist and that both sides have discussed in several previous rounds of talks between the Special Representatives, there is now an unpredictability as China disputes portions on which there was no ambiguity earlier. India's perception of the Galwan Valley was not disputed by the Chinese before this summer. A give in one part of this long unmarked boundary may be accompanied by take somewhere else. In the latest demonstration of this unpredictability, China has now opened a new front, staking claim to territory in eastern Bhutan, close to the border of Arunachal Pradesh. This "eastern sector" had never been part of 24 rounds of boundary talks between Bhutan and China. The claim, which first came to light when China tried to block UN funding to the Sakteng wildlife reserve in that area, was reiterated by Beijing on Sunday. Even as the Indian Army is preoccupied in Ladakh, this places more pressure on it in the eastern sector, where China

claims all of Arunachal Pradesh. After Prime Minister NarendraModi's visit to Ladakh, and his forceful speech to the soldiers there, with its unambiguous messages for the country, Beijing and the international community, the hard slog is here: Ensuring that China keeps its commitment to peace and tranquility in the border areas. # **Palestine's Annexation On Pause**

or the time being, one of the biggest peacetime military move against the Palestinians by the Israeli government has been temporarily shelved, according to the country's regional cooperation minister. OfirAkunis told Army Radio that the annexation 'will certainly happen in July', but it has to be done in partnership with the US. The annexation 'it will only happen after a declaration by [US President Donald] Trump', he added.

Under its controversial plan to annex portions of the West Bank, the annexation schedule was to be declared by the Israeli Prime Minister Benjamin Netanyahu on Wednesday 1 July, after its approval by either the cabinet or the parliament, as per the agreement signed between him and his defence minister Benny Gantz.

#### **Annexation Plan**

As per the annexation plan outlined by Netanyahu, Israeli forces were to move and occupy areas inhabited by illegal Israelis in Jordan Valley and parts of the West Bank. The illegal Israeli settlements in the West Bank started popping up after 1969, and over the years have increased in both size and population.

Over the years the Israeli government has made it quite clear that Palestinians living in the areas of Jordan Valley and West Bank-will not receive citizenship and will instead have to continue to endure second- or third-class civil rights and status.

However, the annexation plan is neither a sudden invention of Israel nor its support by the US. It has been Israel's intention since it occupied the West Bank in 1967.

Israel's right-wing has long favoured annexing parts or all of the West Bank, saying the territory is vital for the country's security and an inseparable part of the Biblical Land of Israel.

The Israeli plans got a fillip when in 2017 the US recognised Jerusalem as Israel's capital, and in 2019, the Golan Heights as belonging to Israel, both announcements were met with worldwide criticism.

Earlier, in January this year, Trump proposed a Middle East Peace Plan, recognising illegal Jewish settlements in the West Bank as Israeli soil and further allowed Tel Aviv to maintain its control over the Jordan Valley which belongs to Palestine. Immediately thereafter, a joint US-Israeli commission began the mapping process for the annexation plan.

Thus, the covert and overt role played by President Trump in this whole process cannot be denied or overlooked. While the previous US administrations used to turn a blind eye to the Israeli settlements in the occupied areas, under Trump it has become quite legit and brazen and some observers also claim that these policies are led by his business priorities.

However, Joe Biden, the presumptive US Democratic presidential nominee, wants to press Israel not to take any actions 'that make a two-state solution impossible.' to resolve the Palestinian issue.

### Palestinian position

The West Bank, including East Jerusalem, is viewed by the international community as occupied territory under international law. thus making all Jewish settlements there - as well as the planned annexation - illegal.

Palestinian officials have threatened to abolish bilateral agreements with Israel if it goes ahead with annexation, which would further undermine a two-state solution. The Palestinians seek the entire West Bank as the heartland of a future independent state and believe the Trump plan would deliver a fatal blow to their fading hopes of statehood.

Among the plan's components: The Palestinians would only have limited autonomy in a fraction of territory they seek. Isolated Israeli settlements deep inside Palestinian territory would remain intact, and the Israeli military would retain overall security control over the Palestinian entity.

The Palestinian Authority has already cut off its ties with Israel as a protest to the annexation, and in absence of any peace prospects, the Palestinian Authority could see its international funding drying up or it becoming a completely impotent body.

#### **International reactions**

UN Secretary-General Antonio Guterres has said annexation would mark a 'most serious violation of international law'." The EU's foreign policy chief, JosepBorrell, has warned of 'significant consequences'. Britain has said it will 'not support' annexation, and France, Belgium, Luxembourg and Ireland have all mooted punitive economic measures in response. While China is 'deeply concerned', Russia has strongly objected to the plan and even the Vatican has cautioned against annexation.

Amongst the Islamic countries, rkey and much of the internation al community do not recognise Israel's sovereignty over the territories it has occupied since 1967. Jordan has been vociferous in protest and other Gulf countries too have sounded the alarm. UAE's foreign minister Anwar Gargash has stated that the Annexation would be a 'serious setback for the peace process'. Saudi Arabia has made similar protestations.

The reactions made so far by the international community seems to be just empty rhetoric, not much else, as they have been in the past besides allowing the issue to fester while giving uncalled for concessions to Israeli moves against the Palestinians. Everyone is too busy guarding their own spheres of influence and

Arab countries - from Jordan to the Gulf - are too dependent on US military support to step too far out of line, many of them currently enjoy an unprecedented bilateral relationship with Israel from trade to commerce to medicine. We may see resolutions being adopted and passed at the UN, the Arab League, the European Parliament and ICJ, but nothing concrete or worthwhile is expected to emerge out of these antics.

#### **Indian reaction**

Though PM Modi is reported to have spoken to Israeli PM Netanyahu three times in the past four months, mainly to discuss cooperation during the COVID pandemic, there is no confirmation whether the annexation issue had been discussed between them. Earlier, in January, India had disapproved of the US-Israel peace plan, reiterating India's 'consistent support for the Palestinian cause'.

Meanwhile, the Palestinian government has called on India to oppose Israeli plans stressing that the move would end the effectiveness of any future negotiations in the conflict. Majdi El Khaldi, the Senior Diplomatic Advisor to Palestinian President Mahmoud Abbas is reported to have urged India to maintain its support to the right of the Palestinian people to self-determination and statehood.

If the annexation is carried out then the hopes for the two-state solution to the Israeli-Palestinian conflict remain at risk, it may also pose a threat to the future of the Palestinian Authority besides resulting in an increase in the regional tensions and a proliferation of illegal Jewish settlements in the West bank.

If the issue remains frozen, for the time being, due to the play of internal party politics of Israel, then the time may run out on Netanyahu. In addi tion, the US presidential Democratic nominee, Joe Biden, has said he opposes annexation. A Biden victory in November could mean that any Israeli annexation will be short-lived. That seems to be the only reprieve.

Palestinians face a new struggle. retaining their land leading to freedom and the assertion of their national rights eventually, in one Palestine.

## Problem of Climate Change is Solvable

he last decade has been the warmest ever recorded. Deadly wildfires, hurricanes, extreme weather events in north-east India, and climate-influenced migration are now regular occurrences. Ice caps are melting, sea levels are rising, and the very survival of island nations is being threatened. Indeed, our entire ecosystem is at risk. One million animal and plant species may become extinct within a

The authors, from the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES), state: "There is a single species that is responsible for the Covid-19 pandemic – us. As with the climate and biodiversity crises, recent pandemics are a direct consequence of the human activity.

They warn that "rampant deforestation, uncontrolled expansion of agriculture, intensive farming, mining and infrastructure development, as well as the exploitation of wild species, have created a 'perfect storm' for the spillover of diseases from wildlife to people".

They say humans have destroyed more than 85 per cent of wetlands and dedicate more than one-third of all land and most freshwater to crops and livestock production.

"Add to this the unregulated trade of wild animals and the explosive growth of global air travel, and it becomes clear how a virus that once circulated harmlessly among a species of bats in Southeast Asia has now infected almost 10.5 million people all over the world, brought untold human suffering and halted economies and societies around the world," they write, adding: "There is the human hand in pandemic emergence.

The problem of climate change is solvable. We have the technology and science. We now need the leadershipand the courage to change the course. Carbon dioxide and other heat-

trapping gases are the main drivers of global warming. While climate change cannot be stopped, it can be slowed down. To avoid the worst consequences

of climate change, we need to reach 'net-zero' carbon emissions by 2050 or sooner. Net-zero means that, on balance, no more carbon is dumped into the atmosphere than what is taken out.

To achieve net-zero emissions, we need a massive transformation in how we produce and consume electricity. We need a newer and better transportation system. We need to stop defores tation. We need a climate-friendly agricultural system. Much remains to be done-and we need to do it as quickly as possible.

Apart from this, we need to actively remove carbon dioxide from the

atmosphere or offset its effects. The easiest way to do this is afforestation or reforestation. Other enhanced land management practices can help, as well as new technologies that suck CO<sub>2</sub> out of the air (direct air capture) or prevent it from leaving smokestacks (carbon capture and storage). The best policy ideas in the world are not worth it if we do not have activists, experts, and people fighting for the change. From school groups to churches; from corporate boardrooms to mayors and local leaders: we need action.

# Hajj 2020: What You Need To Know About This Year's Pilgrimage

Islamic week-long ritual has been scaled back to a limited number of pilgrims because of the coronavirus pandemic.

Touching or kissing the Kaaba, the holiest site in Islam, will be banned during the Hajj this year, and a physical distancing space of a metre and a half between each pilgrim during the rituals including mass prayers and while in the Kaaba circling area will be imposed, according to a statement by the **Center for Disease** Prevention and Control (CDC).

audi Arabia says it will allow only about 1,000 pilgrims residing in the kingdom to perform the Hajj this year, one day after it announced the annual pilgrimage would be scaled back due to the coronavirus pandemic.

Some 2.5 million pilgrims from around the world flock annually to the cities of Mecca and Medina for the week-long ritual scheduled to begin in late July. This year, no overseas visitors would be allowed.

Saudi Arabia announced on Monday it would hold a "very limited" Hajj this year, as the country is still battling with the coronavirus pandemic.

The Saudi Ministry of Hajj said the decision to curtail the pilgrimage was aimed at preserving global public health because of the risks associated with large gatherings.

This year's event is expected to start on July 28.

#### Who will perform Hajj?

As one of the five key pillars in Islam, Hajj is a requirement for all physically and financially able Muslims to perform at least once in their lifetime.

This year, the kingdom's Hajj ministry said the ritual would be open only to individuals of various nationalities residing in Saudi Arabia.

In a virtual news conference on Tuesday, Hajj Minister Mohammad Benten said the government is still in the process of reviewing the number of overall pilgrims allowed, saying they could be "around 1,000, maybe less, maybe a little more".

"The number won't be in tens or hundreds of thousands" this year, he added.

Health Minister Tawfiq al-Rabiah said no one over the age of 65 or with chronic illnesses would be allowed to perform the Hajj.

#### What are the health protocols?

Pilgrims will be tested for coronavirus before arriving in the holy city of Mecca and will be required to quarantine at home after the ritual.

Wearing of face masks at all times will be mandatory for both pilgrims and organisers.

Touching or kissing the Kaaba, the holiest site in Islam, will be banned during the Hajj this year, and a physical distancing space of a metre and a half between each pilgrim during the rituals including mass prayers and while in the Kaaba circling area will be imposed, according to a statement by the Center for Disease Prevention and Control (CDC).



Congregational prayers are permitted, but worshippers are required to wear face masks and maintain physical distancing.

Also, access to holy sites at Mina, Muzdalifah and Mount Arafat will be limited to those with Hajj permits starting Sunday July 19 till August 2.

#### Has this happened before?

This is the first time in Saudi Arabia's nearly 90year history that foreign visitors have been barred from performing Hajj.

The Hajj has been cancelled because of war and past epidemics throughout history, but not since the founding of the Kingdom of Saudi Arabia in 1932.

#### What has the reaction been?

The response has been a mix of disappointment, relief and acceptance.

Before the Saudi announcement, Indonesia, Malaysia, Senegal and Singapore had already barred their citizens from performing Hajj this year because of coronavirus concerns.

"My hopes of going to (the holy Saudi city of Mecca) were so high," Kamariah Yahya, 68, from Indone-

sia, told AFP news agency.

"I've been preparing for years. But what can I do?

This is Allah's will - it's destiny."

Shahadat Hossain Taslim, head of a group representing Bangladeshi Hajj travel agencies, said "many people will be shattered" by the decision, but it was for the best.

"Unlike other countries, the majority of Bangladeshi pilgrims are elderly people, and they are vulnerable to COVID-19," he said.

Pakistan, which usually sends nearly 180,000 pilgrims, said its diplomats in Saudi Arabia would represent the country during the pilgrimage this year.

In neighbouring India, the minister for minority affairs said more than 200,000 people had applied to go on Hajj in 2020, and that they would receive a full refund of any money deposited for the pilgrimage.

Mohamad Azmi Abdul Hamid, from the charity Malaysian Consultative Council of Islamic Organizations, said Muslim nations should have been allowed to take a "collective decision", rather then it being left to Rivadh.

One of the major drawbacks of the series is that it is set in Kashmir but shot almost entirely in Himachal Pradesh.



thusiastically patriotic narrative on Kashmir. The series is currently streaming on Amazon Prime.

Just like other Indian films set in Kashmir, the series is predictable at most of the junctures. Although the makers of the series claim to break the already set political stigmas attached to the valley, yet, instead of choosing an old straight path, the series takes a bend to re-establish the older stereotypes.

Kashmir is labelled as a 'hotbed' for all antinational activities. The series very cleverly labels Kashmiris as 'brain-washed' kids who succumb to



the prevailing situation in the valley. The series blatantly links Islamic State of Iraq and Syria (ISIS), which has hardly any presence in J&K, to the radicalisation of youth.

Instead of breaking older stereotypes, many new ones surface in the series that again show already suffering Kashmiris in a grim light.

While Manoj Vajpayee is excellent, Gul Panag, making a comeback after a long time, is equally complementing Vajpayee's role diligently, minus her fake Kashmiri accent.

Many critics are calling Family Man a resemblance of Bard of Blood, but the uncanny resemblance is a true depiction of the depths of Indian filmmakers' thought processes.

Though Family Man is quite engaging, the series is highly predictable, even for a child who watches Indian spy films and series regularly.

Talking of realistic account, Haq Se, an Alt Balaji original series, directed by Ken Ghosh is nowhere close to the reality of Kashmir. Though the plot is set in the valley, the series is shot in Manali.

Instead of debunking already prevailing myths about Kashmir, the series has given birth to many new ones.

From accent used to the lifestyle shown, the setup resembles more of North Indian or Pakistani culture and tehzeeb and not Kashmiri.



The series does not set any narrative but comes up with its own precedent that is completely detached from the harsh reality of Kashmir.

In the entire series, Kashmir is used as a 'scenic' place to depict parallel love stories and family

The series has attempted to highlight the tangled socio-political conflict of Kashmir but has failed miserably in doing so. Other than Rajeev Khandelwal, none of the other characters has adapted to the role of native Kashmiris.

The tenor of narrative varies from series to series. While in series like Kaafir, the storyline is humane in nature, whereas, in Family Man, it is again over-enthusiastically patriotic and hurls a 'patriotic' stone at the dignity of a par-

ticular region.

### "Without Historical **Precedent": Climate Change Turns Lakes Green In US**

Paris, France: Global warming is turning clear mountain lakes green in the western United States because of an increase in algae blooms "without historical precedent", researchers reported on Tuesday.

The concentration of algae in two remote mountain lakes more than doubled in the past 70 years, researchers at Colorado State University found.

Their results, published in the British Royal Society journal Proceedings B, highlight the potentially harmful effects of climate change on pristine and remote ecosystems.

"Even in relatively remote lakes located in protected areas... the fingerprint of human perturbation of Earth System is evident," lead researcher Isabella Oleksy of Colorado State University told AFP.

"Rapid warming of high elevation environments has resulted in the rapid acceleration and dominance of green algae, which until recently were found in low abundance in these lakes.'

The team of scientists led by Oleksy examined algae concentrations in lakes in a mountain range about 100 kilometres (65 miles) from Denver, using a tool called a gravity corer to collect sedi-

ment cores without damaging the

Drawing on measurements going back to the 1950s, they found "dramatic changes" in algal abundance in the form of green algal blooms called chlorophytes, which thrive in warmer temperatures.

The high level of algae "came as an ecological surprise", Oleksy said.


She noted that the amounts of algae documented in the study would more typically be found in highly polluted areas, such as those prone to agricultural runoff, and not in unsullied mountain environments.

"While we documented these changes in two lakes in Colorado, it is likely that this is not an isolated phenomenon," she said.

The results are not a smoking gun, the researchers acknowledged, but point to climate change as driving the excess accumulation of nutrients -- such as phosphorus and nitrogen -- that cause algal blooms.

In lakes and oceans, algae blooms sicken wildlife if ingested and destabilise aquatic environments by blocking out sunlight, the United States Environmental Protection Agency says on its website.

Fresh water and marine algae blooms have a huge negative economic impact, affecting fisheries, tourism and human health.



### **Singapore Scientists Seek Power From Darkness Through Shadow Energy**

Singapore: Scientists in Singapore are hoping to perfect a new method of power generation driven largely by shadows, with the hope that it could one day help highly urbanised cities power themselves.

The shadow-effect energy generator (SEG) being developed by the National University of Singapore has the potential to harness power like solar cells, but without needing open spaces with uninterrupted light.

To work effectively, the SEG requires both light and dark and, like solar panels, relies on light to shine on silicon to energise electrons.

However, using panels that feature a thin layer of either gold, silver, platinum or tungsten, the difference in light intensity drives electrons from lit areas towards the shade, creating electricity in the shaded areas.

"Our shadow effect generator comes in handy. It can be placed in those areas to harvest obstructed light," said research team leader Dr Swee Ching Tan.

The research is still in its early stages yet Tan's team is already thinking about the potential of establishing a company to make SEG available

The panels the team have been testing are about 6 sq cm in size and capable of producing just 0.25 volts, meaning about 20 are needed to power a light bulb, or charge a cellphone.

The ideal environment for use would be cities, Tan said, with constantly shifting levels of light and shade throughout the day from clusters of tall buildings and the sun's changing position in the sky.

'It's not practical to place solar cells in such cities. So the device might come in handy in places like very densely populated cities, where skyscrapers are everywhere, where shadows are always persistent,'

### At Least 239 Killed In Ethiopia **Protests Over Singer's Death**

Addis Ababa: The death count from demonstrations and ethnic violence that erupted in Ethiopia last week following the murder of a popular singer from the Oromo ethnic group has risen to 239, according to a tally of police figures.

Pop star Hachalu Hundessa, a hero to many Oromo who saw him as the voice of their marginalisation, was shot dead by unknown attackers on Monday of last week, fuelling ethnic tensions threatening the country's democratic transition.

Protests broke out in the capital Addis Ababa, as well as the surrounding Oromia region which is the homeland of the country's largest ethnic group, who have long felt economically and politically side lined in the diverse nation.



Pompeo restricted visas to Chinese officials determined to be "subantially involved" in the exclusion of foreigners from I

The State Department declined to name the officials or say how many people were affected, citing US confidentiality laws. Chinese foreign ministry spokesman Zhao Lijian expressed China's

"firm opposition" to the move and urged the US to "immediately stop

interfering in China's internal affairs through Tibet-related issues" "In response to the wrong actions of the US. China has decided to impose visa restrictions on US personnel who behave badly on Tibet related issues," he said, warning of further damage to US-China rela-

tions and cooperation. Amid high tension with China, the United States has increasingly been issuing such visa sanctions, earlier taking action over Beijing's clampdown on free expression in Hong Kong and its incarceration of some one million Uighurs and other mostly Muslim Turkic minorities.

Riyadh: Jobless and broke, Sudanese electrician Hatem is stranded in limbo in Riyadh like countless other illegal workers, but he hopes the fastspreading coronavirus will offer a chance for escape.

While coronavirus drives a huge exodus of expatriates, campaigners say potentially hundreds of thousands of illegal workers remain stranded in Saudi Arabia, complicating efforts to fight the disease.

bare what activists call systemic injustices roiling the lives of blue-collar foreign workers in Saudi Arabia -overcrowded housing, exploitative employers and a lack of effective recourse.

Campaigners have called on Saudi Arabia to reform its long-criticised labour policy and offer an amnesty to poor debt-ridden workers trapped in the country, a predicament that risks fuelling the pan-

The problem is rooted in the "kafala" sponsorship system, described by critics as a modern form of slavery that binds workers to their Saudi employers, whose permission is required to enter and exit the kingdom as well as to

"My six kids, my old mother, my sister in Sudan... are living in a difficult situation. but I live in much worse conditions," Hatem told AFP in his squalid Riyadh apartment, which he shares with other

"The sponsorship system is very unjust," said Hatem, who arrived in 2016.

### Calls for amnesty

Saudi Arabia home to around 10 million expats, has expelled hundreds of thousands of illegal workers in recent years.

But many like Hatem who are stuck in a debt trap are not permitted to leave before settling their dues, even as kafala curbs prevent them from legally earning their way to freedom.

### One Nation One Ration Card In J&K 1.19 Lakh Duplicate **Beneficiaries Weeded Out**

Affairs, (FCS&CA) Simrandeep Singh, Wednesday reviewed implementation of One Nation One Ration Card scheme and Aadhar seeding of ration cards in J&K.

Various officers of the FCS&CA Department along with State Project Management Unit (SPMU) under Integrated Management of Public Distribution System (IM-PDS) attended the meeting. Secretary reviewed the targets that each district is required to meet to successfully roll out the scheme as per the timelines set by the government. It was informed that the J&K has to achieve 100% Aadhaar seeding of all Ration Cards up to the beneficiary level, for successfully rolling out the One Nation One Ration Card scheme.

As on date, Kulgam, Anantnag, Shopian, Kishtwar, Pulwama and Ramban have achieved more than 90 percent Aadhar linking of ration cards. However, Srinagar, Baramulla, Reasi and some districts of Jammu province have low percentage of Aadhar seeding. The Secretary informed that the department has been working on mission mode on this scheme since last one month. The current percentage of Aadhaar seeding at Ration Card level is 87%, whereas at beneficiary level the seeding percentage is 71%. In the last 20 days, the Food

SRINAGAR: Secretary Food, has been able to link Aadhaar Civil Supplies & Consumer of nearly two lakh beneficiaries. Further, the department has been able to weed out 1.19 lakh duplicate/silent beneficiaries from the electronic portal of the ration cards management system. It was given out that the duplicity was on account of inter-district/ inter-state double beneficiaries. It is estimated that in next 40 days, the department would end up weeding out an estimated 2.50 lakh duplicate beneficiaries. It was also informed that electronic Point of Sale (e-POS) devices have to be installed at all Fair Price Shops in the J&K.

> It was informed in the meeting that out of 6733 FPSs, the ePoS devices have been installed in 6500 shops. It is pertinent to mention that One Nation One Ration Card scheme trials were successfully held in Anantnag, Shopian, Baramulla, Budgam, Kupwara, Kulgam, Doda, Samba, Ûdhampur, Rajouri, Kathua and Jammu districts yesterday and a number of NFSA beneficiaries from the state of Uttar Pradesh were provided ration at all these districts of J&K.

> One Nation One Ration Card scheme has to be rolled out in I&K in phased manner from July, 2020 to August, 2020.

The beneficiaries of J&K will also be required to draw their ration only after authentication of their biometrics at the Fair Price Shops, from the month of Septem-& Civil Supplies Department ber, 2020 onwards.

# At Last, WHO Acknowledges **Evidence Of Covid-19 Airborne Spread**

GENEVA: The World Health Organization on Tuesday acknowledged "evidence emerging" of the airborne spread of the novel coronavirus, after a group of scientists urged the global body to update its guidance on how the respiratory disease passes between people.

"We have been talking about the possibility of airborne transmission and aerosol transmission as one of the modes of transmission of COVID-19," Maria Van Kerkhove, technical lead on the COVID-19 pandemic at the WHO, told a news briefing.

The WHO has previously said the virus that causes the COVID-19 respiratory disease spreads primarily through small droplets expelled from the nose and mouth of an infected person that quickly sink to the ground. But in an open letter to the Geneva-based agency, published on Monday in the Clinical Infectious Diseases journal, 239 scientists in 32 countries outlined evidence that they say shows floating virus particles can infect people who breathe them in. Because those smaller exhaled particles can linger in the air, the scientists in the group had been urging WHO to update its guidance.

"This is definitely not an attack on the WHO. It's a scientific debate, but we felt we needed to go public because they were refusing to hear the evidence after many conversations with them," he said in a telephone interview. Speaking at Tuesday's briefing in Geneva, Benedetta Allegranzi, the WHO's technical lead for infection prevention and control, said there was evidence emerging of airborne transmission of the coronavirus, but that it was not definitive. "...The possibility of airborne transmission in public settings especially in very specific conditions, crowded, closed, poorly ventilated settings that have been described, cannot

Jimenez said historically, there has been a fierce opposition in the medical profession to the notion of aerosol transmission, and the bar for proof has been set very high. A key concern has been a fear of panic.

"If people hear airborne, healthcare workers will refuse to go to the hospital," he said. Or people will buy up all the highly protective N95 respirator masks, "and there will be none left for

### **RGF Probe: Govt Wouldn't Have Waited For Six Years If It's Politically Motivated, Says BJP**

The central govern-ment's order of a probe into transactions of trusts linked to the Nehru-Gandhi family is a "natural" outcome of information brought out in the public domain recently, the BJP said

BJP general secretary P Mualidhar Rao also rejected the charge that the government's decision is politically motivated, saying it would not have waited for six years had this been true. Prime Minister Narendra Modi-led government came to power in 2014 and won mandate for a second term in 2019. "These transactions are in public domain... Our government is committed to transparency. It is natural to investigate these transactions after so much information was recently brought out in public

domain," Rao told reporters. He said the Congress leadership should cooperate with the investigation. Hours after



the government initiated a probe into the funding of three Nehru-Gandhi family linked trusts, Congress leader Rahul Gandhi hit out at Modi and said those who fight for the

truth cannot be intimidated. "Mr Modi believes the world is like him. He thinks everyone has a price or can be intimidated. He will never understand that those who fight for the truth have no price and cannot be intimidated," Gandhi said in a tweet. An inter-ministerial team has been set up by the government to coordinate probe into the alleged violation of various laws like money laundering and foreign contributions by three Nehru-Gandhi family linked trusts, including the Rajiv Gandhi Foundation (RGF).


## **India's Coronavirus Caseload Climbs To 7.42 Lakh**

With 22,752 fresh cases of COVID-19 in a day. India's coronavirus caseload increased to 7,42,417 on Wednesday, while the death toll climbed to 20,642 with 482 people succumbing to the disease, according to the Union health ministry data.

The number of recoveries stands at 4,56,830, while there are 2,64,944 active cases of coronavirus infection presently in the country, the updated data at 8am showed. "Thus, around 61.53 per cent of patients have recovered so far," an official said.

According to the ICMR, acumulative total of 1,04,73,771 samples have been tested up to July 7 with 2,62,679 samples being tested on Tuesday.

Of the 482 deaths reported in the last 24 hours, 224 are from Maharashtra, 65 from Tamil Nadu, 50 from Delhi,



25 from West Bengal, 18 from Uttar Pradesh, 17 from Gujarat, 15 from Karnataka, 13 from Andhra Pradesh, 11 from Rajasthan, seven each from Bihar and Telangana, six from Punjab, five each from Jammu and Kashmir and Madhya Pradesh, four in Odisha, three from Haryana, two each from Jharkhand and Puducherry and one each in Chandigarh, Goa and Uttarakhand.

Of the total 20.642 deaths reported so

far, Maharashtra accounted for the highest 9,250 fatalities followed by Delhi with 3,165 deaths, Gujarat with 1,977, Tamil Nadu with 1,636, Uttar Pradesh with 827, West Bengal with 804, Madhya Pradesh with 622, Rajasthan with 472 and Karnataka with 416.

The COVID-19 death toll reached 313 in Telangana, 279 in Haryana, 252 in Andhra Pradesh, 175 in Punjab, 143 in Jammu and Kashmir, 104 in Bihar, 43 in Uttarakhand, 42 in Odisha and 27 in Kerala.

Jharkhand has registered 22 deaths, Chhattisgarh, Assam and Puducherry 14 each, Himachal Pradesh 11, Goa eight, Chandigarh seven, Arunachal Pradesh two and Meghalaya, Tripura and Ladakh have reported one fatality each, according to the health ministry.
