Cases Surge As J&K Records 387 New Covid-19 Infections

Fresh Cases Include 50 Security Men, 2 Doctors, Baby; 91 Discharged

SRINAGAR: Jammu and Kashmir on Friday recorded 387 Covid-19 cases, including 97 from Jammu and 290 from Kashmir valley and with this the number of cases in J&K went up to 9888. The fresh cases include 50 CRPF, SSB, BSF and army personnel, two doctors and a 8-months old baby.

Giving the breakup of the cases, officials said that Srinagar reported 94, Baramulla 36, Kulgam 33, Shopian 14, Annatnag 11, Kupwara 34, Pulwama 47, Budgam 6, Bandipora 8, Ganderbal 7, Jammu 23, Kathua 7, Ramban 11, Rajouri 51, Samba 1, Poomch 2, Doda 1 and Reasi 1.

According to Dr. G H Yatoo, Nodal Officer Coronavirus Control Measures at SKIMS Soura, out of 2659 samples which were processed at the viral diagnostic laboratory of the institute today, 132 returned positive for the virus.

Professor Farooq Jan, Medical Superintendent SKIMS Soura said the cases include 37 from Army, CRPF and SSB, 33 from Pulwama, 24 from Srinagar, 12 from Anantnag, 10 from Kulgam, seven from Budgam, six from Bandipora. two from Kupwara and one from Baramulla.

A division bench of Chief Justice Gita Mittal and Justice Sanjay Dhar also sought a status report from the government on the PIL filed by Central Augaf Commit-Tarzoo-Dharnambal, an amalgam of eight Auqaf Committees of the area.

The court passed the directions after hearing Advocate Shafqat Nazir for the petitioners who seek a slew of directions to the Union Ministry of Environment, Forest and Climate Change and the I&K government.

HC Seeks Status Report On Dumping Of Waste In Wullar Lake

at Dharnambal-Ningli Tarzoo in Sopore which falls within the delineated periphery pillars of the Wular Conservation and Management Authority (WUCMA) and also within the limits of Hygam-Ningli-Tarzoo Tourism Development Authority.

The petitioners also seek a direction to Municipal Council to immediately remove the garbage "illegally dumped" on the spot.

The plea urges for developing the area in planned manner given its huge tourism potential while taking care of the environmental sensitivities. It also prays that a place be identified and subsequently developed in terms of Solid Waste Management Rules for dumping of municipal waste away from the residential and environmentally sensitivity areas.

The petitioners alleges that the Municipal Council Sopore since March this year has started dumping solid waste on the boundary of the Wular Lake against the Solid Waste Management Rules.

The whole place has been converted into a stinky swamp, it reads. "The water from the Wular Lake as also the rainwater wash away the garbage and filth into the Wular Lake and the Jhelum and also into the premises of tourist huts".

"The area which was earlier identified as the only recreational park was surprisingly converted into a dumping site without following the rules or taking any permission or NOC from the Pollution Control Board or WUCMA.

"Since the land in question belongs to the Forest Department, and comes under the immediate control and management of WUCMA and HNTDA, therefore it was obligatory for the respondent Municipal Council to take prior permission from the said authorities before dumping the municipal waste on the banks of Wular Lake.

"The area is environmentally sensitive and in terms of Wetland Conservation and Management Rules, 2017, no such activity can be undertaken by the respondents in the area under any circumstances."

"That a Ramsar notified site and prospective tourist destination has been unfortunately converted into an open garbage dumping site notwithstanding the fact that the district administration had earlier identified and earmarked some fifty (50) kanals of land in estate Adipora for dumping of garbage which fact is evidenced by the communication of Deputy Commissioner Baramulla, to Director Urban Local Bodies Kashmir dated 30-07-2019."

The petitioners said the place is having tremendous tourism potential but because of dumping of solid waste it has been reduced in to

with a similar story. "I have filed four online complaints and and have called the local lineman time and again" says Naseer."But none has come nor do I hope anyone will".

Naseer has been without broadband for seven days.

Both subscribers say they are waiting for the jiofibre service to start in their areas to give up their BSNL connection. "It is a horror to be a BSNL subscriber. The company just doesn't want you as its subscriber," says Naseer. "They would rather charge for the service they would not like to give".

"My landline and broadband is not working since the services were resorted in Kashmir," said Syed Shabir Hussain of Hassanabad Rainawari area of Srinagar.

"I contacted the local lineman who said that your telephone pair is defunct. Then I went to Soura exchange where I was told that you have to disconnect the connection as we can't repair it." said Hussain. When contacted Public Relation Officer, BSNL Kashmir, Masood Balla told Kashmir Observer that the department lacks manpower after the Voluntary Retirement Scheme (VRS).

"BSNL had over 2 lakh employees all over India out of which one lakh took the VRS recently. In Srinagar we have over 500 employees working out of which over 300 took the VRS," he said.

Balla added following the retirement of many employees, BSNL outsourced the operations in Srinagar to three contractors, but they are I'll equipped

"Unfortunately, they were unable to deliver because they don't have skilled persons to handle the job, as a result we have witnessed a lot of complaints," Balla added.

According to him BSNL has over 50,000 landline connections in Srinagar city out of which 21000 have broadband connections

Hold Final Year Exams by Sept End: UGC...

guidelines, a copy of which lies with the news agency-Kashmir News Observer (KNO) reads that UGC this month has issued revised guidelines on examinations and academic calendar for the universities in view of COVID-19 Pandemic.

Moreover, the Ministry of Human Resource Development (MHRD) has also issued instructions for conduct of examinations wherein a detailed Standard Operating Procedure (SOP) was formulated for conduct of examinations with measures to be taken in view of the ongoing situation, duly vetted by the Ministry of Health and Family

UGC in the guidelines said, "In view of the emerging situation related to COVID-19 pandemic in India, it is important to safeguard the principles of health, safety, fair and equal opportunity for students. At the same time, it is very crucial to ensure academic credibility, career opportunities and future progress of students globally."

It further reads that the academic evaluation of students is very important milestone in any education system. "The performance in examinations gives confidence and satisfaction to the students and is a reflection of competence, performance and credibility that is necessary for global acceptability," UGC said.

"The universities are required to complete the examinations by the end of September in offline, online or blended mode following the prescribed protocols guidelines related to COVID-19 pandemic."

Stating the provision of examination through special chance, UGC said, "In case a student of terminal semester or final year is unable to appear in the examination conducted by the University for whatsoever the reasons may be given opportunity to appear in special examinations for such courses or papers."

"It may be conducted by the university when feasible, so that the student is not put to any inconvenience or disadvantage. The provision shall be applicable only for the current academic session 2019-20 as a one-time measure," it reads.

UGC said that the backlog of papers in respect of terminal semesters or final year students should compulsorily be evaluated by conducting examinations in offline, online or blended mode as per feasibility and suitability.

"The guidelines regarding intermediate semester or year examinations will remain unchanged as notified in the previous guidelines," SOP's for conducting exams

The UGC said that in case there is a restriction on movements in certain areas, admit or identity cards issued to the students should be treated as a pass for the movement of students.

State Governments should issue instructions to all local authorities to issue movement passes to invigilators and all personnel engaged in the conduct of examination.

Entire examination centre floors and walls, doors, gates, should be sprayed with disinfectant. Fresh mask and gloves to be used by exam functionaries after staff verification is done. Sanitizer bottles should be arranged at the entry gate, examination rooms, staff/observer room, etc. and should be replenished regularly.

All liquid hand wash bottles should be replenished in restrooms and entry gate whenever required. Candidate seating area should be thoroughly sanitized after every session. All the washrooms should be cleaned and disinfected. All door handles, staircase railings, lift buttons, etcetera should be disinfected.

Exam functionaries must submit self-declaration about health status. Thermo gun temperature check must be done at the staff en-

If any Examination functionary fails to meet the self-declaration criteria, or thermal gun check, he or she will be asked to leave the examination centre immediately. Exam functionary needs to wear the mask and gloves at all time

Wherever possible, students should be given fresh face masks by the Invigilators in the examination room itself. Avoid crowding at entry

"Senior staff should monitor the entry and exit. There should be proper markings with at least two meter distance where students stand while waiting for the opening of the college gate. Exit of students should be permitted one by one only. Thermal Screening of students, wearing of face mask, sanitizing of hands etcetera be en-

The students should be asked to sanitize their hands before and after signing the Attendance Sheet," the SOPs read. "Students having symptoms of fever, cough and cold should be either made to sit in a separate room or given a chance to appear on another day.

Pvt Schools Compel Parents to Pay Transport,...

Another parent said that the school management has charged the fifty percent of transport fee besides the tuition charges.

"Since March-2020, the school is charging fifty percent of transport fee besides the tuition fee, however, there are clear directions from the government not to charge any fee apart from the tuition fee," he

In May, the government directed recognized unaided private schools to charge only tuition fee on monthly basis instead quarterly basis for the COVID-19 lockdown period.

The government also ordered the private schools not to hike fee during the academic year 2020-21.

Principal Secretary to government for School Education Department, Asgar Samoon in a circular said, "Only tuition fees shall be charged from students on monthly basis instead quarterly basis for the lockdown period.'

Earlier in June, the government said that the private schools in Kashmir valley were violating the orders of Government Fee Fixation Committee (GFFC) by charging tuition fee as well as miscellaneous fee in the name of tuition fee.

The government had also warned the private schools of strict action in terms of relevant provisions of law in case of any violation found against the school management.

The order issued by the government in this regard stated that the administrative department has issued instructions to private schools in view of COVID-19 pandemic in Jammu and Kashmir with the directions that the last date of deposit school fees is extended up to April-30 without any late fees and no school shall either charge any fee for the online Lecturers or assignments or shall link the result of the child on the basis of home assignment.

Based on its review of the current evidence, the WHO said the novel coronavirus that causes COVID-19 spreads between people through direct or indirect contact with contaminated surfaces or close contact with infected people who spread the virus through saliva, respiratory secretions or droplets released when an infected person coughs, sneezes, speaks or sings.

The report follows an open letter from scientists who specialize in the spread of disease in the air – so-called aerobiologists – that urged the global body to update its guidance on how the respiratory disease spreads to include aerosol transmission.

"This is a move in the right direction, albeit a small one. It is becoming clear that the pandemic is driven by super-spreading events, and that the best explanation for many of those events is aerosol transmission," said Jose Jimenez, a chemist at the University of Colorado who signed the letter, which was published on Monday in the journal Clinical Infectious Diseases.

How frequently the coronavirus spreads by the airborne or aerosol route – as opposed to by larger droplets in coughs and sneezes – is

In a press briefing on Thursday, Dr. Anthony Fauci, director of the US National Institute of Allergy and Infectious Diseases, said there is not a lot of solid evidence yet on airborne transmission of SARS-CoV-2,

but said: "I think it's a reasonable assumption that it does occur." Although incomplete, Fauci said the evidence so far is "the fundamental basis for why we are now so intent on getting people – particularly people without symptoms – to wear masks. To be able to see if we can mitigate against that," he said.

Only a very small number of diseases are believed to be spread via aerosols, or tiny floating particles. These include measles and tuberculosis - two highly contagious diseases that require extreme precautions to prevent exposure.

WHO guidance acknowledges that airborne transmission of the novel coronavirus can occur during specific medical procedures that generate aerosols, such as when performing intubation.

In these circumstances, they advise medical workers performing such procedures to wear heavy-duty N95 respiratory masks and other protective equipment in an adequately ventilated room. Any change in the WHO's assessment of risk of transmission could affect its current advice on keeping 1-meter (3.3 ft)physical distanc-

J&K next to Bihar in corruption. TII, CMS blow whistle

Srinagar - Jammu and Kashmir is in the news for yet another wrong reason, that it is India's second most corrupt state, next only to Bihar, while Kerala has emerged as die least corrupt state. The startling revelation follows a recent survey titled "The India Corruption Study 2005," India (TII) and die Centre for Media Studies (CMS). The study sampled about 14,500 respondents from over 150 cities and 300 villages across 20 Indian states and covered about a dozen services, including police, judiciary, education and public distribution system. It has placed the state very low at 19th position, just a shade ahead of Bihar. Apparently, die services surveyed may not have

included various engineering disciplines, industries and allied sectors, revenue, agriculture and allied fields, education, healthcare, transport and traffic control. In case they were, Jammu and Kashmir should have had die dubious distinction of being die most corrupt state ahead of Bihar. While die alarming report may not have disturbed die sleep of those at die helm, die revelations must certainly not be music "to die state people's ears. By any stretch of imagination, the scenario is

greatly disturbing for a place otherwise groaning under the debilitating impact of numerous other misfortunes, natural as well as manmade. Given the tall promises held out by successive rulers to root it out, the disclosure is all die more amazing.

For the only Muslim majority state mat Jammu and

Kashmir continues to be in spite of die sustained, and in some degree successful, government-inspired attempts to

demographic complexion, die revelations are all the more shocking. One is reminded of the story that an old women refused to believe that a Muslim had lied on something "I can't believe that a Muslim can ever tell a lie", she told her informer. It must have entailed a. relentless effort by that known enemy, satan, and his countless visible and invisible followers to erase die most effective deterrent from die Muslim mind i.e. a firm belief in the Day of Judgement, even if its indicators are visible to die naked eye all over. The custodians of religion would need to ponder over die grim situation.

Pertinently, it is die government which is squarely responsible for die situation taking a turn for die worse in spite of the pledges die successive rulers made while seeking people's mandate. The incumbent regime is particularly answerable because its promises were much louder not only to eradicate the canker but even to bring the earlier swindlers and scamsters to justice. The Peoples Democratic Party, which wrested power

from National Conference on die main plank of eradicating corruption, took about three years to identify a presiding officer for die Accountability Commission even as making it visibly functional may take another three vears for its major coalition partner, Congress, to make the high-profile body discernibly functional.

By now, the chief minister, Mufti Muhammad Saveed, must have forgotten what he told die people on assuming die high office: that nobody should approach him in matters of recruitment as die process would be made absolutely transparent, 'Not only that he and several of his ministerial colleagues are accused of making backdoor appointments, the coalition partners certainly have a mischief Up their sleeves for the ensuing recruitment to over 20,000 vacancies in government departments. This is not the occasion to enumerate all the scandals that surfaced over the recent years in which the government's Conduct has been suspect, even to the extent of overt and covert complicity. Instances are galore to suggest the present rulers are worse than their

witter and its smaller sibling afford chances to put aphorisms, axioms, couplets, verses and puns in public domain leaving you guessing for import. A versifier who has deftly avoided her straight face in her profile on Twitter Lite, a male preserve, challenges patriarchy on it tangentially without triggering malevolent vehemence. She has not any regular column of trolls, stalking which otherwise go into hot pursuit of gendered voices. An innocuous tweet more than a week before set off a reaction, though mild, where local twitterati tried to disabuse her of 'feminism' or any pretence of it. She decided to ignore the reaction and prevented herself from rushing into realm of eternal masculinity where matters could get complicated for her. Was she challenging male cultural hegemony by a simple tweet?

The tweet and its reaction show how we are hardwired into physical, psychological and intellectual confinement of the women. We force them to accept mediocrity and are deeply anxious and insecure about their creativity. '... her wings are cut and then she is blamed for not knowing how to fly' Simone De Beauvoir wrote in The Second Sex. Does her presence in the spaces of social media lays bare the 'con trick of blaming women for not being in accord with men's fantasies'. Social media spans seem to proffer spaces for making women themselves anew. We resort to cultural sleights of hand to gaslight them, even when they are not subversive or make any breach of rules of containment. Some recent interviews of some accomplished women of our valley have shown their parents inclination to regret their daughters are not boys. The social and political

traumas of our embattled zone is making their subjectivity and autonomy even more precarious. The long history of patriarchy has stripped them of their economic rights and there are determined efforts to deny them public spaces. It is not difficult to map out gendered spaces of social media but to effect the exclusion of the female voices even by the methods of abuse and the intimidation is not helping. They are determined to stake their positions, which are socially, politically and economically relevant to them. The virtuality of the space is helpful, even if we are not ready to jettison long held social and cultural constructs of gender. It has blurred traditional lines between, 'women with essentialised traits of emotionality and irrationality and men of self control and superior capacity for the reason'. The refusal to break the persistence of masculine and feminine constructs is not exclusive to Kashmir only.

In the modern times, Karen Arm strong, a world renowned author on religious studies has shown the results of unshackling from hidebound traditions. She left a Catholic convent in 1960s, awakened; she made a spiritual journey few could parallel and is respected across the world for her compassionate teachings and erudition. Lala Ded left her marriage, her house and set out on a journey fraught with suffering and agony. She remained undeterred by stigma and censure, which had a full force of social sanction. Her 'heterodoxy' continued unremittingly and she had will to take the consequences:

They lash me with insults, serenade me with curses. Their barking means nothing to me. Even if they came with soul-flowers to offer. I couldn't care less. Untouched I moved on. (Translation Ranjit Hoskote)

Zoonie, a peasants daughter with a passion for poetry and flair for music from Tsandhara Pampore became a queen. She was not powerful as Sughanda

and Dida, two tenth century queens who ascended the throne as regents. Habba Khatoon is recorded to have encouraged women to dress and decorate themselves as they wished. She revived Circassian tradition of tattooing face and hand with special dyes and powders. Habba Khatoon gives expression to transcending spatial and social confinement:

I thought I was indulging in play and lost myself.

Oh for the day, that is dying. At home, I was secluded unknown.

When I left home my fame spread far and wide.

The pious laid all their merit at my feet. Oh for the day, that is dying.

Likely Scenarios For An Afghan Political Setlement

Key actors, including Pakistan, are likely to balance their support of the Afghan government and the Taliban because in their eyes, the Taliban will be an important part of the future government

he imminent announcement of a date and venue for possible intra-Afghan talks—the first round of negotiations between the Afghan government and the Taliban—has generated optimism about the possibility of a peaceful political settlement in Afghanistan. As both parties have acknowledged on numerous occasions, the current conflict demands an effective political solution, and the present moment may hold unprecedented potential for a settlement. This by no means suggests an easy road ahead, however, nor that peace can be taken for granted. It is likely that the process will unfold in a manner that demands both the Afghan government and the Taliban compromise their respective hardline positions. Two principal sets of challenges remain: the first—institutional ambiguities and a lack of genuine government consensus—may hinder the process ahead of the negotiations, and the second—the sensitive topics likely to appear on the negotiating agenda—might stymie the negotiation process itself.

The Civil Government's Bargaining Position and its Challenges

As both parties have acknowledged on numerous occasions, the current conflict demands an effective political solution, and the present moment may hold unprecedented potential for a settlement. Nonetheless, it is likely that the process will unfold in a manner that demands both the Afghan government and the Taliban compromise their respective hardline positions.

From the Afghan government's point of view, the most advantageous scenario would be a genuine Afghan-led and Afghan-owned process aligned with its negotiating position. The Afghan government's position in the negotiations is buttressed by support from its neighbors and other important international actors such as the United States, the European Union, Russia, China, India and Pakistan. Afghanistan's most important allies—the United States and NATO—will not withdraw their troops fully unless the conditions are met by the Taliban and unless the negotiations achieve concrete results, including a permanent ceasefire and guarantees on peace agreement implementation.

Recent developments, most notably the formation of the High Council for National Reconciliation (HCNR) on May 17, would also bode well for the government. The HCNR was born out of a political deal between the contending candidates in the controversial 2019 election, conferring Abdullah Abdullah leadership of the peace process and Ashraf Ghani the presidency. Now, nearly all political parties and major politicians that were divided between the two camps have lined up behind the government in support of its peace agenda, projecting a semblance of national cohesion on the issue.

Despite this semblance of unity, however, organizational ambiguities and a lack of genuine national consensus threaten to undercut the government's position. The earlier U.S.-Taliban talks—which bypassed the Afghan government in negotiating the withdrawal of foreign troops—might deny the Afghan government its greatest bargaining potential.

Institutional redundancy is one of the clearest examples of this. In Afghanistan, peace and reconciliation bodies are as old as the insurgency itself. The recent HCNR is the fifth such body to have formed. Yet at least two other institutions with a similar capacity continue to operate parallel to the HCNR. These include the High Peace Council (2010-) and the State orous and exhaustive discussions on key parts of the agenda, including the terms of negotiation, the extent to which compromises can be made, and the manner in which we collectively envision a just society that can sustain a durable peace. This would also demand greater understanding on the form of the future government, decentralization of power, and transitional justice, which are central to this peace.

If the aforementioned challenges are not overcome and left unaddressed, a worst-case scenario— the failure of talks and demise of this historic opportunity might come to pass. If the government fails to unite and incorporate factions on its side of the negotiation table, the Taliban would likely develop significantly

One issue that may undercut the Afghan government's position in this scenario is U.S. capriciousness regarding its withdrawal plan and Pakistan's possible tilt towards the Taliban

Ministry for Peace (SMP) (2019-). The HCNR is meant to be a body that oversees all the peace process affairs, and the SMP is its secretariat. The HPC's status and purpose is as yet unclear. In addition, the stipulations in the agreement regarding the mandate and responsibilities of the HCNR are too ambiguous to discourage or minimize fatal disagreements and contention.

These competing and at times overlapping bodies that are shrouded in ambiguous mandates indicate a lack of national consensus. Although the political deal between the two candidates projects the appearance of alignment, a true consensus is much more complex in that it would involve agreement on contentious issues of national significance. It is clear that Afghanistan is far from such a consensus—various parties agree that they want peace but have yet to define what that peace would look like and the types of political and legal arrangements it would entail. The agenda is still unclear as is the process through which an agenda would be developed.

Similarly, political party lines do not account for the needs and perspectives of a diverse Afghan populace. Coming to a genuine consensus requires painstaking debates and discussions spanning disparate ethnic and demographic groups and social and political strata within civil society. Ethnic minorities, victims of violence, women, and some of the more peripheral political parties and media outlets ought to have more of a voice in a process that disproportionately affects them. A national consensus cannot be achieved without vig-

port behind the Taliban in an attempt to fill the void left by the United States. Alongside an escalation in violence, the Taliban would push harder for their political vision, an Islamic Emirate characterized by strict sharia law, nullification of the current constitution, and roll back of the constitutional rights of citizens. In the event that the peace talks fail, it seems unlikely that U.S. troops would remain in the country. This would be disastrous for Afghanistan. A lack of international support—in the wake of a pandemic that has brought economic downturn-might yield a humanitarian disaster and perhaps even a civil war.

However, this scenario seems unlikely, for two reasons. First, Afghanistan's allies, including the United States and the European Union, have supported the post-2001 democratic gains and may work to forestall such a scenario through some form of political and diplomatic intervention and/or mediation. The Afghan government would likely seek out such support. It has, at least rhetorically, taken on the mantle of defending the principles of the republic, including the constitution, and the constitutional rights of citizens. Second, it is likely that the negotiators would manage to arrive at some middle ground through compromise.

The Taliban have also tacitly indicated their support for the talks by continuing to release Afghan prisoners. This indicates that both parties and their allies understand the urgency of a political settlement at this particular moment.

A Middle Ground Scenario

A middle ground seems the most likely scenario for a number of reasons, including public statements from the European Union, the UN and other regional powers in support of the talks, the existing U.S.-Taliban deal, and growing regional recognition of the Taliban. The Taliban have also tacitly indicated their support for the talks by continuing to release Afghan prisoners. This indicates that both parties and their allies understand the urgency of a political settlement at this particular moment. Key actors, including Pakistan, are likely to balance their support of the Afghan government and the Taliban because in their eyes, the Taliban will be an important part of the future government. The Afghan government appears inclined to heed international messaging and engage pragmatically with the Taliban-it has already demonstrated its willingness to do so in releasing Taliban prisoners. This middle ground would involve both parties tempering their stances vis-à-vis each other and the power balance in Afghanistan. Some sensitive topics require extensive discussion. Reaching some agreement on terms for the integration of Taliban fighters into the security forces and civilian life, transitional justice, amending the constitution, reconstructionall tied up in rectifying the deep-rooted traumas civilians have long suffered—could take years. It will also require both parties to draft power-sharing arrangements and reconfigure the state institutions to satisfy

Conclusion: Prospects Dim for Now

Given this unique set of challenges, Afghanistan's peace process is likely to proceed slowly, and along a bumpy road. Even if the negotiations begin—itself an accomplishment-managing polarized ethnic identities, reconfiguring the state and its institutions, transitional justice, reintegration of fighters, and the reality of threats from other terrorist groups will be topics of contention that can stymie the process to a breaking point. It is here that each side would have to determine the price they would be willing to pay for a possible peace agreement, and whether this would indeed engender a sustainable peace. This type of compromise demands honest political acumen, wisdom and moral courage on both sides. The heartbreaking number of casualties from years of violence and political instability in the country provide the exigent circumstances for such moral courage.

Madhosh Balhami: 'A **Chronicler of Collective Pain'**

YEAR before war sirens would alarm Kashmir, Madhosh Balhami, then 34-year-old poet, had picked up an unruffled routine. It was 1998, and he would silently retreat to his prison cell at Srinagar's Central Jail and write poetry at length. He was arrested in January that year for "his activism, and writing poetry". But weaving verses in incarceration threw a major challenge at him — how to smuggle them out of the jail, and importantly, what to do if the jail authorities checked his writing.

And the jail authorities did check, one day.

He had written a poem in Urdu, the official language of the Jammu and Kashmir. The poem was 'overtly political'; its theme: Cargo — the city citadel of special operations group, the SOG of JK Police.

A police officer read it, and confiscated the paper and burnt it down. Madhosh was warned to not write again—at least not the politi-

Among the confiscated writings, there were many poems on mysticism, God, and love; they were written in Kashmiri. Unable to read Kashmiri like majority of Kashmiris, the curious police officers enquired about the prisoner poet's poems. "They're Sufi poems," he told them. They were left untouched.

"For the first time in my life did I rejoice at the fact that most Kashmiris can't read or write Kashmiri," Madhosh recalls the incident at his newly built home at Balhom, Srinagar. "It was a blessing

To filter through jail-time censorship, he devised a plan.

"I began to write political poetry in Kashmiri language. And I would also write a dozen poems in Urdu on the themes of mysticism, and God," says Madhosh.

"It can be said that for every political poem, I had to write a dozen poems on Love and God—the poems I no longer know.'

He would put the mystic poems on the top of the pile of papers, and slip two or three poems of political nature in between. This way, the captive's couplets conveniently circumvented the cell shadowing. That was how he was able to write.

"Jail was the most productive time for me as far as poetry is concerned," the unassuming poet continues to recount his poetic journey. "I had all the time, and I would just write, and compose poems."

When he was released from jail in 2000, he carried all the poems, written in hard labour, in his bag, and wanted to publish them one day. But in March 2018 his house was razed to the ground in a gun bat-

tle between three militants and armed forces. "My entire corpus turned to ashes in front of my eyes—my hard our of three decades," the poet laments

"My poems were like my children. However, I didn't grieve over it; I grieved over the human loss. Death of a human being is more sorrowful than losing your poems."

And death is from where Madhosh traces his journey as a poet. In his childhood, Madhosh was 'captivated' by the idea of loss, and this idea of loss encouraged him to write, and express. And pain, both personal and collective, became theme of his writings.

Madhosh was 16 when his father, Ghulam Mustafa died in 1979. "Death of my father destroyed me," the poet says. "I felt immensely alone, and lost. I wanted to commit suicide. It was the beginning of

"my journey as a writer. It was the period when, according to Madhosh, he was personally lost and carried a "sense of low self-esteem" within him. With no one to support his education—he was studying B.A first year at SP College, Srinagar—he began to work as a daily-wage labourer. He tried to

express the loneliness but was not able to. "I was like a ship caught in a storm, crashing with waves, not knowing where to land. There was so much I wanted to tell but couldn't find the voice," says Madhosh of that time.

It was during this time of his life that he accidently discovered a book in a friend's place. It was a collection of poems of Dr. Mohammad Iqbal, the national poet of Pakistan.

"I read Iqbal, and it had an electrifying effect on me. His ideals of self and political action galvanized me," says Madhosh. As did another figure, Ayatollah Khomeini — the spiritual leader of 1979 Iranian

"I found fatherly figure in Ayatollah and in Iqbal. My political consciousness grew. They led me by hand from darkness to light, from despair to hope," says Madhosh.

The mere thought of Iranian Revolution healed my wounds. I felt that injustice can be defeated. I felt tyrant regimes can be toppled.

Then he began to read.

He read books on Kashmir history, notably the works of GMD Sofi, Prem Nath Bazaz and likes of Shabnam Qayoom. Apart from that, he read the works of Iranian intellectual, Dr. Ali Shariati.

The more he read, the more conscious he became politically.

And then in 1980s, he became an activist with Muslim United Front (MUF) — a political amalgam of various pro-Kashmir parties, that eventually contested elections in 1987 which were infamously rigged by New Delhi.

Four years before that, while a student, Madhosh had formed a local music band, mostly singing folk songs, mystic verses at cultural gatherings. Folk bands form an essential part of Kashmiri music known for singing eulogies of the heroes of Kashmir, both mythical and real. Madhosh played role of a vocalist, and played Rabab.

The experience as a folksinger later was to influence the way he imagined his poetry. Stylistically his poems resemble folk oral poetry that is easy to rhyme, direct, and local. Madhosh was to use this style of poetry to express his political views, and document the times he

"At the meetings with people during my MUF days, I began to recite and sing my poetry—mostly copying the style of Iqbal," the poet recalls. "I would compose a poem a day before or at the spot and recite it. I don't remember any poem of that era but I do remember they celebrated Muslim identity and hope for a better future.

By 1990, Madhosh was making headway as a small poet, known, if not to a lots of people, but to important political figures of the time, including pro-freedom leaders Nayeem Khan, and Syed Ali Geelani.

According to Madhosh, the leaders loved his poetry and suggested he publish it. Madhosh was encouraged to write more. However, he was arrested in 1991—first time, and served two years in prison

"I wanted to publish my poems but no one was willing to publish it," he says. "I showed some poems to a local publisher and they turned it down out of fear. So did newspapers of the time. They told me my poetry is too 'direct and dangerous'.

Discouraged, he didn't try again.

But he kept composing poetry, recite it, and in order to not forget or lose the poetry he wrote it down.

them know how a Kashmiri lived in the times of repression, and what injustices and zulm was committed on a people," he says.

At times, Madhosh doesn't consider himself a poet in the conventional sense of the word. He considers himself a 'chronicler of collective pain' and 'a preserver of people's brutal history, and struggles'.

Poetry, he claims, is a sublime art, dealing in themes of life in "normal and happy times" and believes that meaning of poetry and its nature should alter according to the times one lives in.

He calls himself a 'resistance rhymester' which sees and records every mood of the people.

"I have never seen my people smile," the poet says. "I can't write about flowers, flowing streams and beauty of Kashmir. I don't see beauty, I see blood everywhere. I see the landscape in fetters.

The most dominant theme of his poetry is his experience as

Back in March 1990, when the poet was 24, he was dragged out from his Balhom home and tied to a willow tree on a nearby hill. "I was tortured for two hours," he says. "My back was lashed with willow sticks and bamboo rods." This experience changed him, and the nature of his poetry, drastically.

While descending down the hill after torture, he made a resolve to write about his experience. And few days later, he penned down his first poem that was 'overtly political: the poem was aptly titled 'Gashti' — a Kashmiri word for patrolling party of armed forces.

Sukh mukhe tawan pou hai hai Gashti aaye Gashti aye, Tharr czaye lookan sar to pai Gashti aaye Gashti aye,

(The dread spread, with the arrival of patrolling party, the onlookers trembled, with the arrival of patrolling party...)

For the poet, the street picket is the metaphor for 'political repression'. The repression in Kashmir, he says, began first on the landscape when bunkers were erected all over the place, in every nook and cranny of the valley, giving rise to immense visual suffering and altering the mindscape of the place.

"Bunkers are objects of terror," Madhosh says. "Thousands have disappeared in them, never to return, and their sight is the reminder of our humiliation."

In one of his untitled poems, Madhosh elaborates on the violence that turned the land into "ruined barrenness". The poet compares his verse with the 'songs of spring' and reprimands himself, out of fear, not to sing spring songs amidst 'thorns'.

Yem saasebaedh khanjar che aamit loole chaane yoer, Hanne hanne cze kadnay jaan, ma kar chaak girebaan

(These thousands of daggers have appeared to kill you with a thou-

Madhosh is disappointed with the Kashmiri poets especially the ones who came before him and witnessed the turbulent times in the valley.

They, he says, have not risen up to the occasion—and instead wrote non-political poems without mirroring the ground reality

"Most of the poets didn't write because they didn't want to displease the state," the poet says. "They wrote Sufi poetry and penned paeans to win state sponsored awards and perks. It is the tragedy of Kashmiri literature.

Study Explains How Brain Activity Evolves Fear Into Anxiety

A University of New Mexico research team led by Elaine L. Bearer, MD, PhD, the Harvey Family Professor in Pathology, and graduate student Taylor W Uselman has identified for the first time brain-wide neural correlates of the transition from fear to anxiety.


"Until now, psychiatrists had little information about what goes on in the brain after a fearful experience, and why some people don't easily recover and remain el to learn how frightening expeanxious, for even as long as the rest of their lives," Bearer said.

Foreign Students Weigh Studying In Person Vs Losing Visas

Phoenix: International students worried about a new immigration policy that could potentially cost them their visas say they feel stuck between being unnecessarily exposed during the coronavirus pandemic and being able to finish their studies in America.

The students from countries as diverse as India, China and Brazil say they are scrambling to devise plans after federal immigration authorities notified colleges this week that

international students must leave the US or transfer to another college if their schools operate entirely online this fall. Some say they are think-

ing about returning home or moving to nearby Canada. "I'm generating research, I'm doing work in a great economy," said Batuhan Mekiker, a Ph.D. student from Turkey studying computer science at Montana State University in Bozeman. He's in the third year of a five-year programme.

"If I go to Turkey, I would not have that," he said. "I would like to be somewhere where my talent is appreciated."

Mathias, a Seattle-based student who spoke on condition his last name not be used for fear of losing his immigration status, said he was set to sell his car, break his lease, and get his cat Louis permission to fly back to his home in Paris in the next two weeks.

US Bans Pak Intl' Airlines Flights Over Pilot Concerns

Washington: The US Department of Transportation said it has revoked permission for Pakistan International Airlines (PIA) to conduct charter flights to the United States, citing Federal Aviation Administration (FAA) concerns over Pakistani pilot

The information is contained in a revocation of special authorisation dated July 1 provided by the department to Reuters on Friday.

Pakistan last month grounded almost a third of its pilots after discovering they may have falsified their qualifications. The European Union Aviation Safety Agency suspended

PIA's authorisation to fly to the bloc for six months in a blow to the carrier's operations.

PIA was not available immediately for comment outside

normal business hours.

Pakistan's Geo News reported PIA had confirmed the U.S. ban and said it would address the concerns through ongoing corrective measures within the airline.

Pakistan's grounding of pilots with dubious credentials followed the crash of a PIA jet in May that killed 97 people.



New WHO Guidance Calls For More Evidence On Airborne Transmission

Geneva: The World Health Organization on Thursday released new guidelines on the transmission of the novel coronavirus that acknowledge some reports of airborne transmission of the virus that causes COVID-19, but stopped short of confirming that the virus spreads through the air.

In its latest transmission guidance, the WHO acknowledged that some outbreak reports related to indoor crowded spaces have suggested the possibility of aerosol transmission, such as during choir practice, in restaurants or in fitness classes. (https://bit.ly/2Ck7QBo)

But the WHO said more research is "urgently needed to investigate such instances and assess their significance for transmission of COVID-19."

Based on its review of the current evidence, the WHO said the novel coronavirus that causes COVID-19 spreads between peo-

ple through direct or indirect contact with contaminated surfaces or close contact with infected people who spread the virus through saliva, respiratory secretions or droplets released when an infected person coughs, sneezes, speaks or sings.

The report follows an open letter from scientists who specialize in the spread of disease in the air - so-called aerobiologists - that urged the global body to update its guidance on how the respiratory disease spreads to include aerosol transmission.

"This is a move in the right direction, albeit a small one. It is becoming clear that the pandemic is driven by super-spreading events, and that the best explanation for many of those events is aerosol transmission," said Jose Jimenez, a chemist at the University of Colorado who signed the letter, which was published on Monday in the journal Clinical Infectious Diseases.

How frequently the corona-

virus spreads by the airborne or aerosol route - as opposed to by larger droplets in coughs and sneezes - is not clear.

In a press briefing on Thursday, Dr. Anthony Fauci, director of the US National Institute of Allergy and Infectious Diseases, said there is not a lot of solid evidence yet on airborne transmission of SARS-CoV-2, but said: "I think it's a reasonable assumption that it does occur."

Although incomplete, Fauci said the evidence so far is "the fundamental basis for why we are now so intent on getting people - particularly people without symptoms - to wear masks. To be able to see if we can mitigate against that," he said.

Only a very small number of diseases are believed to be spread via aerosols, or tiny floating particles. These include measles and tuberculosis - two highly contagious diseases that require extreme precautions to prevent exposure.

Nepal bans all Indian news channels except Doordarshan

Kathmandu: Nepal on Thursday stopped the transmission of all Indian private news channels except Doordarshan, accusing them of airing reports hurting the country's national sentiment.

There was no immediate reaction from India on the issue. People familiar with the development said the Nepalese embassy in New Delhi apprised its views to the Indian government over coverage of Nepal's political developments by the Indian channels.

"We have stopped the distribution of all Indian news channels except Doordarshan," Dinesh Subedi, the chairman of Multi-System Operator (MSO), foreign channel distributor, told reporters here.

"We have halted distribution of India's private news channels as they have aired news reports hurting Nepal's national sentiment," he added.

The development comes

condemned some of the reports aired by the Indian news channels.

"Nepal government condemns such acts," Khatiwada said while responding to a question on the issue during a press meet on Thursday. The government will seek political and legal ways against such an objectionable act," he added.

Earlier in the day, former deputy prime minister and spokesperson of the ruling Nepal Communist party Narayan Kaji Shrestha said that the Indian media must stop the baseless propaganda against Prime Minister Oli and his government.

"The baseless propaganda by the Indian media against the Nepal government and our Prime Minister has crossed all limits. This is getting too much. Stop with the nonsense, Shrestha said in a tweet.

The India-Nepal bilateral ties came under strain after Defence Minister Rajnath Singh inaugurated a 80-km-

COVID-19 Causes Far More Symptoms Than First Suspected

Paris: They call themselves "long-haulers", "long-tailers", or simply survivors.

Some have been sick almost as long as the new coronavirus is known to have existed.

Six months after the virus

began to scorch its way across the planet, it is becoming clear that COVID-19 causes far more symptoms than first suspected.

Thousands of people of all ages are staying sick for weeks or even months. British forensic psychiatrist

Scientists have identified chemical marks on the DNA that correspond to these different stages, an area of study called epigenetics.

The field is well established for humans, and some commercial companies let you send in a DNA sample to determine your biological age by reading your "epigenetic clock."

Why Reveal Names Of **COVID-19 Patients? It Involves Privacy: High Court Seeks Government's Reply**

MUMBAI: The Bombay High Court today sought to know why the names of persons who have tested positive for COVID-19 should be disclosed and said the issue involves privacy rights of such patients.

A division bench of Justices AA Sayed and MS Karnik made the observation while hearing a petition filed by two persons seeking disclosure of names of coro-

Its terms of reference also include addressing of all matters regarding Broadband Readiness Index (BRI) and to monitor and evaluate the work of mission pertaining to J&K. "The vision of the national broadband mission is to fast-track growth of digital communications infrastructure, bridge the digital divide, facilitate digital empowerment and inclusion, and provide affordable and universal access of broadband for all," an official statement issued on Tuesday said.

Under the mission, the government of India will work with States and UTs for having consistent policies pertaining to expansion of digital infrastructure including for Right of Way (RoW) approvals required for laving of optical fibre cable.

Mukesh Ambani, At \$68 Billion, Now Richer Than Warren Buffett

ukesh Ambani has had a rollercoaster 2020, cutting a string of deals for his digital business, undergoing wild swings in his wealth and having his brother's finances laid bare for the world to see.

Now he can add another chapter -- eclipsing the fortune of Warren Buffett.

The chairman of Reliance Industries Ltd is now worth \$68.3 billion, surpassing Warren Buffett's \$67.9 billion as of Thursday, according to the Bloomberg Billionaires Index.

Shares of Mr Ambani's Indian conglomerate have more than doubled since a low in March as its digital unit got more than \$15 billion in investments from companies tune dropped this week after



including Facebook Inc and Silver Lake. This week BP Plc paid \$1 billion for a stake in Reliance's fuel-retail business.

While Mr Ambani's wealth has jumped -- he became the only Asian tycoon in the exclusive club of the world's top 10 richest people last month -- Mr Buffett's forhe gave away \$2.9 billion to charity.

The 89-year-old, known as the Oracle of Omaha, has slipped down the rankings after donating more than \$37 billion of Berkshire Hathaway Inc stock since 2006. Berkshire Hathaway's stock performance has also underwhelmed recently.

Mr Ambani, 63, is now the eighth richest person on the planet, and Mr Buffett is ninth, according to the index, which started in 2012.

Thanks to Mr Ambani's deals, India has emerged as a hot-spot for M&A this year, accounting for more than 12% of those announced in Asia Pacific -- the highest ratio since at least 1998

Cigarettes Worth Rs 1.56 Crore Seized At New Delhi Station From COVID Special Train

New Delhi: The customs preventive officials on Friday seized cigarettes worth over Rs 1.5 crore illegally brought by a COVID special train at the New Delhi Railway Station, officials said. They said 10 lakh cigarette sticks of "Special Gold Esse" and "Super slim Esse Light" brands were packed in 100 cartons.



These cartons were recovered from a goods compartment of a COVID-19 special train coming from Varanasi to Delhi, the officials said. Besides, around 9 lakh cigarettes of a lesser known brand and valued at around Rs 36 lakh were seized from the same train, they said. "These were misdeclared and concealed in 38 big gunny bags," an official said. The total seizure is around 19 lakh cigarette sticks valued at around Rs 1.56 crore, he said. "A person linked with the two consignments has been caught and is being questioned. Further investigation is in progress," the official said. The customs preventive officials had on Tuesday seized 4.5 lakh cigarette sticks illegally brought in a COVID special train at the Old Delhi Railway Station. The cigarettes, valued at Rs 40 lakh, were seized from the goods compartment of the train.
