# Dead Mother, Helpless Sons And A Samaritan: 'Viral' Scenes From SKIMS

# Virus Claims 14 More

### **Illegally Acquired Rs** 39.69 Lakh Recovered From IAS Officer

SRINAGAR: The Jammu and Kashmir administration has recovered Rs 39.69 lakh from a senior IAS officer he allegedly took from an organisation and recommended a probe into his alleged "illegal" monetary benefits, sources said on Thursday.

The Lt Governor administration put a notice to the senior IAS officer for allegedly getting illegal monetary benefits from the organisation and asked him to remit the amount worth several lakhs to it, they said.

The officer remitted an amount of Rs 39,69,359 back to the organisation recently, the sources said.

The officer further submitted that Rs 20,86,120 has been deducted as TDS and deposited with the Income Tax department, they added.



# **HC Asks Govt To Reveal Gulmarg Lease Renewal Policy**

SRINAGAR: Jammu and Kashmir High Court has directed government to reveal details on lease renewal policy as regards Gulmarg by August 12.

A division bench of Chief Justice Gita Mittal and Justice Sanjay Dhar passed the orders after advocate S. A. Makroo, counsel for an applicant, pointed out that despite opportunities, the Gulmarg Development Authority and others have not filed the reply and the matter was being unreasonably delayed.

He also pointed out that the authorities have failed to frame the policy with regard to lease renewal.

"Let the reply and the action taken report on lease renewal policy be filed before us by the next date of hearing, failing which Commissioner / Secretary to Government, Revenue Department, J&K, and the Chief Executive Officer, Gulmarg Development Authority, shall remain present in person," the court said as per an order. GNS

# **Man Shot Dead On LOC, Army Launches Ops**

**KUPWARA:** The army on Thursday claimed to have foiled an infiltration bid by killing a militant in an ongoing operation along the line of control (LoC) at Keran sector in north Kashmir's Kupwara district. In a statement, the army said that suspicious movement of unidentified persons was detected across the LoC at Keran sector of Kupwara this morning which was intercepted during which one militant got killed. The statement said that "suspicious move of unidentified persons detected across the LoC at Keran Sector, Kupwara this morning." It said that the militants trying to infiltrate were intercepted by their own troops, contact was established and the infiltration bid was foiled. "During the exchange of gunfire, one militant got killed and one AK was recovered from the site of encounter. The operation in the area is under progress," it read.

# **Dead Mother, Helpless Sons...** SKIMS had already captured the searing struggle for COVID patients and their family members in health centres.

Mourning his beloved mother's departure, Tanveer Makhdoomi-who was seen in the viral video breaking down over the state of affairs at SKIMS-recalled how his mother's four-daylong fever and cough sent her to the hospital, where her Chest X-ray showed bilateral Pneumonia.

She was shortly declared as a COVID positive patient.

"My martyr mother was a brave woman," Tanveer told Kashmir Observer. "She knew the viral infection was a part of life now, but what troubled her was the hostile hospital treatment towards COVID patients at SKIMS."

On Iulv 8, 2020, she was shifted to COVID clinic managed by junior doctors and nurses. Senior doctors, Tanveer said, were nowhere to be seen.

"Our mother was medically fit with no previous comorbidities," said Rameez Makhdoomi, Tanveer's journalist brother.

"Besides our family is well aware that COVID still has no treatment, but from giving Remdesivir, Plasma therapy to Toclizumab, we tried all.'

What shocked the family was the "cluelessness" of the COV-ID-designated staff in the hospital. "The junior doctors were consulting us, as if, we were doc-

tors," Rameez continued. "It looked awkward. They should've sought advice from their seniors." Amid these twists and turns, their mother kept fighting for

"The abysmal behaviour reached pinnacle after her demise," Rameez said. "Even after following every SOP and protocol, and waiting for three hours, we were provided half broken dirty stretcher and no coffin."

Tanveer recalled his visit to SKIMS' Control Room where, he said, he was treated as some "unwelcomed and unwanted" per-

"I was told by a bunch of giggling boys and girls there that new protocol doesn't allow coffin, helpers, and ambulance to COVID patients," he said.

"Although I had already tasked some people to prepare a final resting place for my mother, the hospital wanted me to take my mother in a community casket and thereby exposing the entire neighbourhood to infection! We were also told that no one will aid or guide burial process and that we should do it on our own, with four or five family members. This insensitivity enraged up

After that, Tanveer, "for the first time in his life", was forced to upload a video on social media – wherein he can be seen decrying the apathetic attitude of Kashmir's tertiary care hospital.

'Sensing trouble, SHO Soura arrived on the scene. He was fighting his tears over our plight. Even he was helpless due to the hospital protocol," Tanveer said. "I also received a consolation call from DC Srinagar, Shahid Choudhary.'

It was during this distressed hour, Sajad Khan arrived as a

Along with brothers and some family friends, Sajad went to the Makhdoom Sahab area - where the family graveyard is nestled on a hillock. "Sajad came as an angle for us at that moment," Tanveer re-

called. "He accompanied us and ensured the proper burial with full Islamic rituals.' On his part, Sajad termed the incident as a pressing emergen-

cy which needed a prompt response.

"My team of 20 volunteers always remains ready for handling such crisis," he said. "We act on a phone call. But the SKIMS incident demanded an

immediate response. That's why I didn't wait for my team and went myself. But yes, I didn't do any favour for the family. We're into this crisis together. And therefore, we must fight it together by becoming each other's support."

But after drawing a raging flak and fury, SKIMS came up with an official statement, wherein it gave itself a clean chit.

"When the patient in question expired, it was conveyed to District Administration and Health authorities by control room SKIMS, Nodal officer as well as Medical Superintendent," the statement said.

"Delay in receiving team from concerned officials created anxiety among patient attendants when SHO Police Station Soura was contacted to receive dead body from SKIMS.

SKIMS did away with providing ambulance, coffin and people for burial, as "they're not part of a protocol," the statement said. But after passing through the harrowing experience, the Makdoomi brothers are questioning the existing norms which even make the decent burial a tormenting experience for the depart-

ed person's family. "By providing dirty stretcher, expecting already grief-hit family to do burial and carry coffin-less body on their own, the SOP for dead body seems to have been reduced to zero SOP in Kashmir now." Rameez said.

Among 490 new cases, 428 belong to Kashmir division while as 62 are from Jammu division, officials said, adding that the total number of positive cases in Kashmir division has reached to 9649 including 4846 recoveries and 204 deaths while as total number of positive cases in Jammu division have reached to 2507 including 1602 recoveries and 18 deaths.

The official sources said that total number of active cases in Jammu and Kashmir are 5488 including 4601 from Kashmir division and 887 from Jammu division.

With 109 more recoveries, the tally of total recoveries in Jammu and Kashmir has reached to 6446 which is 53.02 percent of the total cases which was over 63 percent a few days before.

"Cases tested positive in J&K include 259 from Srinagar, 21 from Kulgam, 18 from Baramulla, 42 from Shopian, 06 from Anantnag, 03 from Kupwara, 32 from Pulwama, 34 from Budgam, 02 from Bandipora and 11 from Ganderbal in Kashmir division while as 62 from Jammu division include 14 from Jammu, 03 from Udhampur, 02 from Kuthua, 33 from Rajouri, 08 from Samba and 02 from Doda," officials disclosed.

Officials said 1643 samples tested at SKIMS, 182 were tested ositive Among 182 positive cases 10 are from BR cantonment Srinagar, 89 from CRPF, BSF, Crime branch and IGP office, 25 from PHQ Srinagar, 02 from Srinagar, 06 from Toll plaza Qazigund, 50 samples received from SKIMS, they said.

Official sources from JVC said that 51 including 35 from Srinagar and 16 from Shopian were tested positive.

According to the bulletin, 234,857 persons have completed surveillance period and 43,875 persons are under home surveillance besides that so far results of 481,452 samples are available.

Out of 481,452 the number of samples tested negative stands at 469.296 while as 12,156 have been tested positive, among them 5488 are active and 6446 persons have recovered and 222 persons have died. With inputs from KNO

# Committee Constituted To...

August last year when the Centre had announced revocation of its special status and bifurcation of the state into two UTs - Ladakh and Jammu and Kashmir.

During the hearing on Thursday, the bench, also comprising Justices R S Reddy and B R Gavai, asked the Centre and the J-K administration to file affidavits within a week detailing the setting up of committee and also decisions taken by it in reviewing the orders restricting 4G internet services there.

"Attorney General for India undertakes to file reply affidavit to the contempt petition within a week's time. He is permitted to do so. List the matters after one week, the bench said in its order.

The apex court was hearing a plea seeking initiation of contempt proceedings against the Union Home Secretary and Chief Secretary of J-K for their alleged "wilful disobedience" in complying with the court's May 11 order.

Senior advocate Huzefa Ahmadi, appearing for the petitioner, claimed that the order has not been complied with and the authorities were not responding to the representations filed against the suspension of 4G internet services.

He said since orders passed by the authorities are not being published, nobody can challenge them before the court.

To this, the bench observed the orders passed by the committee should be put in public domain. Venugopal, appearing for the Centre, said that orders suspending 4G internet services have been passed after due appli-

Solicitor General Tushar Mehta, appearing for the J-K administration, also told the bench that the special committee has al-

ready been set up. Ahmadi told the apex court that absence of 4G internet speed has affected the people there, including in online classes for students, medical facilities, e-commerce and online shopping.

Referring to earlier statement of the Union Home Minister, Ahmadi argued he had said that militancy is at the lowest since 1990 in Kashmir.

The contempt plea, filed by Foundation for Media Professionals, has alleged that the concerned authorities have not yet constituted the special committee in line with the top court's order. "It is respectfully submitted that such a lax attitude, especially

during a health pandemic (COVID-19) and humanitarian crisiviolates both the letter and the spirit of this court's judgment... and amounts to wilful disobedience of this court's judgment and order, which had taken judicial notice of the concerns relating to the ongoing pandemic and the hardships that may be faced by the people of Jammu & Kashmir," the plea has claimed.

It has alleged that authorities were duty bound to implement the court's direction but they have failed to notify and facilitate the functioning of the special committee.

"The directions of this court have been summarily ignored and the Respondents have wilfully disobeyed their duty to implement this court's directions, which they were bound to and had undertaken to implement, and therefore must be held in contempt of this court," the plea claimed.

It has also urged the apex court to summon the Union Home Secretary and Chief Secretary of UT of Jammu and Kashmir to explain their position with respect to the alleged non-compliance of the court's directions.

It said that Jammu and Kashmir administration had on May 27 passed an order continuing the restriction on mobile internet speeds to 2G in all districts throughout the UT without any restriction by time or region.

It said the petitioner had sent a representation to the special committee regarding the May 27 order but they have not yet received any acknowledgment of its receipt.

Besides the contempt plea, the petitioner has also filed an application seeking directions to the authorities to notify the constitution of the special committee within three working days.

The application has sought an interim direction to the authority to restore 4G mobile internet services in Jammu and Kashmir, pending disposal of the plea and also the decision by the special committee.

The court had earlier taken note of the submissions of the Centre that continuous infiltration, foreign influence, violent extremism and issues of national integrity are prevalent in J-K.

The apex court's the May 11 order had come on the pleas filed by Foundation for Media Professionals and others seeking restoration of 4G services in the UT.

# **Beigh For Alliance** With Separatists

"Now that Kashmiris have been included in the talks process, and the way cleared for a dialogue with India and Pakistan, militants should give up the gun and join the dialogue

Thirteen militants have been killed in the Gurez sector, and nine more have lost their lives in Uri. Eighty thousand people have been killed so far, and more Kashmiris are bound to die in continuing infiltration attempts,"he said.

"Why should this blood shed go on when the status of Kashmiris as a party to the issue has been recognized and an invitation for talks has come," Beig said, calling upon militants to make use of the opportunity offered by the talk's process. # **HC Declines To Entertain Omar's Plea For Early Hearing In Divorce Case**

New Delhi- The Delhi High Court Thursday declined to entertain former Jammu and Kashmir Chief Minister Omar Abdullah's plea seeking early hearing of his appeal against a 2016 trial court order, which dismissed his divorce petition. saying his estranged wife's consent was also required for advancing the date.

A bench of Justices Hima Kohli and Subramonium Prasad said the high court's Registrar General has already issued a circular stating that during the restricted functioning of courts due to COVID-19, a request for final hearing of pending matters will be entertained only if both the parties agree.

"In view of the fact that this application is not accompanied by any consent from the other side (Payal Abdullah) and nor is the counsel for the respondent present in the hearing, though we are informed that an advance copy of the application was served on him, we are not in a position to accede to the prayer made in the application," the bench said.

"The application is dismissed," it added.

Omar's lawver court that the "lack of coopera-



tion" from the other side was the reason for filing the application.

On August 30, 2016, the trial court had dismissed Omar's plea seeking divorce from Payal saying he had failed to prove irretrievable breakdown of the marriage.

The trial court had said that Omar could not prove his claims of "cruelty" or "desertion" which were the grounds alleged by him for grant of de-

"The petitioner (Omar) has not been able to explain a single circumstance to show that the supervening circumstances have erupted which has made it impossible for him to continue his relationship with the respondent (Paval)

"Rather, evidence shows

that they were in continuous contact till the filing of the divorce petition," the court had said in its order, adding that "there is not an iota of evidence in regard to the circumstances which have prevailed to prompt the petitioner to file the divorce plea"

It had further held that Omar "failed to prove his case for divorce on ground of cruelty".

In his plea seeking divorce, Omar had claimed before the trial court that his marriage had broken down irretrievably and he has not enjoyed a conjugal relationship since 2007 and that the couple, married on September 1, 1994, were living separately since 2009. The couple have two sons who are staying with their mother.

# Mirage of 4G

n Thursday, the Supreme Court sought response from the union government on a petition filed by a body of media professionals accusing Centre of contempt for not carrying out periodic review of its orders suspending internet services in J&K. In a previous order, the apex court had asked the centre to set up a special committee on restoring mobile internet services in J&K. The committee was supposed to undertake the weekly assessment of the situation in J&K to see if it was conducive for the restoration of high speed mobile internet. The petitioner, NGO Foundation for Media Professionals has claimed that no such assessments have been conducted and as such has urged the court to initiate contempt proceedings against the Centre.

However, the government through its Attorney General KK Venugopal has denied there was any contempt on the Centre's part. The Attorney General told the court that the committee had met twice since the court order in May and has asked the J&K administration to find out if relaxation was possible in curbs on internet services.

On July 9, the J&K administration had once again extended the ban on 4G mobile internet until July 19. The administration has so far showed little inclination to review the ban. In its order the administration has reiterated that banning the high speed internet was absolutely necessary "in the interest of the sovereignty and integrity of India, security of the state and for maintaining public order". The order also states that restrictions on internet have been imposed to prevent its "misuse" for various anti-national activities.

But no matter what government says, its security argument to keep 4G internet suspended isn't convincing enough. Truth is the situation in the Valley hasn't been calmer than it is now in a long time. It has been months since the Valley has witnessed a protest or a stone-throwing incident. So, to say that high speed internet will pose threat to security doesn't hold water. Besides, even if a few people are suspected to "misuse" the internet it doesn't justify the collective punishment. More so, at a time when health of people is at risk. While on the one hand, government is taking every preventive to ensure COVID-19 doesn't spread - it has recently put Kashmir under yet another lockdown - it is restricting what should have been its primary tool to create awareness about the disease. More than preventive measures, it is how much people are aware about the Coronavirus that will help the government in the fight against the disease. But the administration, it seems, doesn't want it. Its approach, as always, remains security centric when the need of the hour is to prioritize healthcare.

# Saying no to Huawei

here is no doubt that China will make Britain pay for stripping Huawei from the 5G network. When Beijing said that the reversal "must come at a cost", it didn't mean the £2bn bill cited by the culture secretary, Oliver Dowden; and it sees the UK's stance on Hong Kong as an aggravating factor. The question is how high the price will be, and how precisely the UK will pay.

China's considerations may include the risk of strengthening a Tory rebellion that could push forward Huawei's 2027 exit date from the 5G network, and the fact that other countries are looking again at Huawei's role. The UK is coming into line with other Five Eyes intelligence-sharing nations, the US and Australia, by rejecting Huawei, but could set a new direction in Europe.

Beijing is also fighting on multiple fronts. The imposition of a draconian security law on Hong Kong has caused an international backlash and highlighted other issues, including Beijing's treatment of Uighurs in Xinjiang and its increasingly harsh line on Taiwan. Its biggest battle is with Washington; on Tuesday, Donald Trump signed an order rescinding Hong Kong's special economic status with America. China is also struggling with Australia, over Canberra's calls for an independent inquiry into coronavirus and the offer of permanent residency to some Hongkongers; with Canada, over Huawei; and with India, which has banned dozens of Chinese apps after a deadly border clash. Relations with the EU are becoming more fraught.

tions with the EU are becoming more fraught.

But this proliferation of struggles reflects Beijing's increasing confidence and forcefulness. Britain also looks a good deal weaker than the last time China froze it out, following David Cameron's meeting with the Dalai Lama. Back then, trade actually increased, and diplomatic relations continued at lower levels. But George Osborne's subsequent push for a "golden relationship", with human rights and other concerns low on the agenda as long as the money kept flowing, suggested that the UK will cave whenever it feels the heat. Withdrawal from the EU has left us friendless; and a post-Brexit country weakened by the pandemic will be especially economically vulnerable. The US, despite urging other countries to pick a team, is an utterly inconsistent player.

We can expect more than diplomatic snubs this time. Australia's example is interesting; it faces a ban on some exports, has hinted that China could be behind a cyber-attack, and recently told its citizens that they could risk arbitrary detention if they travelled to China. British businesses might well find they face new obstacles operating in China: HSBC had reportedly warned Downing Street that it could face reprisals if Huawei was blocked from the UK's critical infrastructure. That sounded, if anything, rather like a disincentive to keep using

the Chinese firm. Why offer further leverage for the future? But a broader reconsideration is now needed, with countries looking individually and collectively at how we came to the point where Huawei was regarded as almost indispensable for 5G, while China would not allow a foreign firm to play an equivalent role in its essential infrastructure. It might be convenient for the intelligence services to portray this as a failure of industrial policy – as Robert Hannigan, the former director of GCHQ, did on Wednesday – but there is also truth in his charge. It is time to consider what our technological and manufacturing priorities are and should be, where our companies should be concentrating their efforts, and how they can be encouraged and supported to do so.



n a completely uncalled for move, the Central Board of Secondary Education (CBSE) has revised its syllabus for students of Classes 9 to 12 in the name of handling the stressful situation of teachers and students in view of the continuing Covid-19.

The Union human resource development (HRD) minister Ramesh Pokhriyal in a series of Tweets, earlier this week (9 July) said that, "Looking at the extraordinary situation prevailing in the country and the world, it has been decided to rationalise syllabus up to 30% by retaining the core concepts." This has been done for annual exams for the year 2020-21.

Some of the important chapters that have been deleted include: Federalism, citizenship, nationalism and sec larism from class 11th political science subject besides India's foreign relations with neighbouring countries and citizenship. Colonialism and the countryside colonial cities and understanding partition from class 12th History subject. Complete topic on GST from class 11th Business Studies subject. Complete chapters on population, democratic rights and food security in India from class 9th social science subject. Besides a chapter on girl education by renowned Hindi writer Mahavir Prasad Dwivedi has been deleted from

class 10thHindi subject
Though the CBSE's move is purported to lift the burden off the shoulders of students and teachers in the immediate term, allowing them to pay more attention on the quality of learning. Yet, the selection of topics deleted from the textbooks makes one wonder over the rationale to pick these particular topics or chapters. Most of the deleted topics form the foundation of democratic societies and

students need to learn about these to enhance their knowledge base. The irrational exclusions smacks of a political tone also, to keep a large and young part of the population unaware of these issues. In its defence, the CBSE also issued a press statement, citing the pandemic and NCERT recommendation for the syllabus revision. So far, only the West Bengal Chief Minister Mamata Banerjee from the Opposition ranks has criticised the move.

A careful study of the topics deleted reveals that they include issues, which the current leaders do not want most people to know or discuss about. Instead it wants to insert a completely new narrative 484-page NEP 2019 reveals an issue deserving of wider, more heated opposition. The words "secular" or "secularism" are not found anywhere in the NEP 2019. Though a clear reference to secular education was vital to be seen as the base for these ambitious reform proposals.

The absence of the word "secular" in the NEP 2019 becomes all the more pronounced when seen in contrast to the earlier policies of mentioning secularism as a core Indian value for the Indian education. The omission of the words "secular" and "secularism" in the NEP 2019 is ominous, along with the frequent affirmation of its aim of inculcating constitutional values in the education system, making it doubly odd.

# Six Top Reasons To Be Optimistic About Covid-19

Among all the bad news around coronavirus, there is a silver lining too

vaccine trials seem to be working, and drug manufacturers have already said they might be able to deliver doses by October. Remember, it was not a given that vaccines would work, so the fact that the early-stage clinical trials are showing positive signs is encouraging.

o help get through the coronavirus storm (and all the bad news), we must keep track of positive developments, too.

Here are six positive developments to remind us that there is hope in this crisis:

1. Therapeutic treatments (in addition to what we already have for the most sick patients) will arrive before vaccines. When someone contracts the novel coronavirus, his or her body's immune system launches a defence, including producing antibodies that circulate in the blood to help identify infectious invaders.

These circulating antibodies offer some protection against future infection (for how long, we still don't know). Scientists have now engineered clones of these antibodies — what we call monoclonal antibodies — and they are showing to be effective both therapeutically and to prevent infection.


They work by attacking the spike protein of the coronavirus, which is how this virus gets into our cells. Stop that from happening, and the virus can't replicate inside the body.

Also a reminder that this is lightning-fast; if we get a vaccine within 12 months, that will be the quickest vaccine ever developed — by several years. There is an important caveat: My colleague Juliette Kayyem likes to point out that vaccines don't save people, vaccinations do

2. Rapid, low-cost saliva tests are also coming, and, as my colleague Michael Mina and Laurence Kotlikoff recently pointed out, they are a game-changer. Why? These are like home pregnancy tests but for covid-19, the disease caused by the novel coronavirus.

Imagine a test you could take at home every day, that gives you an answer in a few minutes after spitting into a vial. Such a test would change our ability to slow outbreaks where early detection is everything. It would



also help consumer confidence and slow down this economic crisis.

Want to go to school or work or a Broadway production? Show that your rapid test was negative. These tests are not perfectly accurate, but the counterintuitive part is that they don't have to be. More important than accuracy are speed and frequency of testing.

3. The debate is finally over: Masks work. It took three months, but widespread mask-wearing is catching on. What was once awkward and unusual (in the United States, anyway) has now become more accepted. More states and businesses are requiring them.

And, what was once political—thanks to the US president who said people were wearing masks only to make him look bad—is quickly becoming common sense. We now see leaders in red states urging maskwearing. (Not all masks are created equal, so fortunately, there is now guidance on what constitutes a good mask.)

4. Consensus has finally emerged

that airborne spread is happening. Scientists in my field have been warning about this for months (I have argued that airborne transmission is linked to super-spreader events), yet the Centers for Disease Control and Prevention and the World Health Organisation have consistently failed to recognise this.

This week, the tide turned when 239 scientists signed a letter to the WHO urging it to acknowledge airborne transmission. And that's exactly what the WHO did.

This means that there will be more messaging coming out from the WHO and other organisations recommending that people add a new control to their toolkit for fighting this virus — healthy building strategies, such as higher ventilation, better filtration and the use of portable aircleaning devices.

5. There is some science showing that past exposure to common-cold coronaviruses might be playing a protective role for some people.

This is a big claim — and I should caution that it is not fully resolved —

but several studies are now showing that 20% to 50% of people who had never been exposed to the novel coronavirus have immune cells — known as memory T cells — in their body that react to this new virus. The speculation is that this is due to prior exposure to common-cold coronaviruses.

We still don't know why some people fare better than others, or why a few spread the disease to many while others do not spread it at all, but these findings might hold some answers to those questions.

Once we have a vaccine, the hard task of manufacturing and distributing it comes into play. So, while the signs on vaccines are good, and we might have data in hand in a few months that they work, it will still be a few more months until people have the opportunity to actually receive the vaccine.

For the first time in history, nearly every scientist in the world is focused on the same problem. This is starting to pay real dividends.

# Covid-19: Why Normal Life Is Back In Some Countries, Not Others

While America faces spike in coronavirus infections, many nations are doing much better

If you're lucky enough to live in New Zealand, the coronavirus nightmare has been mostly over since June. After more than two weeks with no new cases, the government lifted almost all restrictions that month. The borders are still shut, but inside the country, normal life returned.

It's coming back elsewhere too. Taiwan, where most days this month no new cases have been reported, just held the Taipei Film Festival, and a recent baseball game drew 10,000 spectators.

Italy was once the epicentre of Europe's outbreak and remains in a state of emergency, but with just a few hundred new cases a day in the whole country, bars are open and tourists have started returning, though of course Americans remain banned.

And America? As of last week, the worst per capita outbreak on the planet was in Arizona, followed by Florida. The world is closed to us; American passports were once coveted, but now only a few dozen nations will let Americans in.

Lawrence O. Gostin, professor of global health law at Georgetown, told me he doesn't expect American life to feel truly normal before summer 2022. Two years of our lives, stolen by Donald Trump.

As our country plunges into a black hole of unchecked illness, death and pariahdom, the administration is waging a PR war on its own top disease expert, Anthony Fauci, trying to convince news outlets that he can't be trusted.

The move to treat Dr. Fauci as if he were a warring political rival comes as he has grown increasingly vocal in his concerns about the national surge in coronavirus cases.

# All-out attack

Trump has also undercut the Centers for Disease Control and Prevention, retweeting the conspiratorial ramblings of former game show host Chuck



Woolery: "The most outrageous lies are the ones about Covid 19. Everyone is lying. The CDC, Media, Democrats, our Doctors, not all but most, that we are told to trust."

There are now so many stories of Trump fans dying after blithely exposing themselves to the virus that they've become a macabre cliché.

Gostin was part of the international panel that put together the Global Health Security Index, a report, released last year, that evaluated the pandemic readiness of every nation on Earth. No country, they found, was as prepared as the United States. But the coronavirus, he said, has shown us that "health system capacity alone is almost useless unless you have

a government that can unleash that capacity prompt-

# It will be over soon?

Others caution against making predictions. "We want to be able to give some assurance of,

'Life will not always be this way, and it will be over soon,' but we don't know when that will be," said Nicolette Louissaint, president of Health care Ready, an organisation established after Hurricane Katrina to strengthen the health care supply chain for disasters.

"We're going to stagger out of it; we're not going to snap back," Gostin said of the pandemic. He added, "It's going to take several years for us to be able to come out of all of the trauma that we've had."

Yet somehow there's no drumbeat of calls for the president's resignation. People seem to feel too helpless. Protesters can make demands of governors and mayors, especially Democratic ones, because at the


local level small accountability still exists.

# Early Life Stress May Lead To **Depression In Adolescence**

esearchers have found that individuals exposed to early life stress (ELS) were more likely to develop a major depressive disorder (MDD) in childhood or adolescence. For the findings, published in the Journal of the American Academy of Child and Adolescent Psychiatry, the research team examined the association between eight different types of ELS and youth-onset depression.

The authors found that while some types of ELS (e.g. poverty) were not associated with MDD, other types of stress, including emotional abuse, were associated more strongly with MDD than a broader assessment of ELS.

# From The Moon To Mars: China's **March Across Space**

Beijing: After sending humans into orbit and landing a probe on the Moon, China is aiming for another milestone in its space ambitions with the launch of a Mars rover next week.

China is among a trio of nations, with the United Arab Emirates and the United States, sending a mission to the Red Planet this month, as Mars is closest to Earth during this period.


Beijing's space program has made huge strides in recent years as it scrambles to compete with the US.

Here are five things to know about the program:

### 'Questions to Heaven'

China's Mars probe will lift off between July 20 and 25 from the southern island of Hainan.

The mission has been dubbed Tianwen-1 (Questions to Heaven) in a nod to a classical Chinese poem that has verses about the cosmos.



"Its purposes are not different from those of other countries: develop the capability, explore the universe, invest on future resource, and finally, create political influence and national prestige," Chen Lan, an independent analyst at GoTaikonauts.com, which specializes in news about China's space program, told AFP.

### Remote-controlled robot

China's space program is controlled by the military, which releases little information about its missions

But Chinese space bloggers with inside information say the robot will have six wheels and four solar panels, with a total weight of 200 kilograms (about 90 pounds).

The rover will roam Mars for three months, according to Sun Zezhou, chief engineer of the probe. The machine is supposed to



The probe aims to go into Martian orbit, land on the planet and release a small, remote-controlled robot to conduct research.

The craft will travel at least 55 million kilometres (34 million miles) to reach its destination. It will arrive seven months after launch, in February, according to an official.

### Without Russia this time

It's not China's first attempt to go to Mars. A previous mission with Russia in 2011 failed because the Russian launcher was unable to get into a transfer orbit to slingshot towards the Red Planet.

# **Covid Spreading In Unexplained Ways, Nations Consider More Lockdowns**

Washington: As countries across Asia Pacific struggle with resurgences of the coronavirus, one data point is steering government responses: the share of cases with no clear indication of how infection occurred.

These patients cannot be linked to other confirmed infections or existing outbreaks by virus responders, indicating hidden chains of transmission. A growing proportion of such cases in a city's resurgence pushes governments. like in Australia and Hong Kong, to take broad and blunt action, returning entire cities to lockdownlike conditions

"You can hardly contain the outbreak because you have no idea where they will come out next," said Yang Gonghuan, former deputy director general of China's Center for Disease Control and Prevention. "When there's more cases where the origins are unknown, it adds to the difficulty

In contrast, a low share of cases of unknown origins means that authorities can stay relatively relaxed -- like in South Korea and Japan -- even if total daily new infections reach the hundreds. These countries can take a targeted and

### Melbourne, Australia: Return to Lockdown

The 5 million residents of Melbourne are in the midst of a government-mandated six-week lockdown thanks to a new wave of coronavirus infections in Victoria state, 51% of which are of unknown origins or still under investigation. The outbreak is spilling over to Sydney, raising fears that Australia's largest city will be a fresh hot spot.

The lockdown, which included the barring of 3,000 residents in public-housing tower blocks from leaving their apartments for several days until they were all tested, is reminiscent of the stringent controls imposed in Wuhan, the Chinese city where the virus first emerged. The measure made Australia one of the only western democracies to mandate that people cannot step outside their homes.

### Tokyo, Japan: Worrying Uptick

# **Belt And Road Re-Emerges In Pakistan With Flurry Of China Deals**

Islamabad: China's Belt and Road program has found new life in Pakistan with \$11 billion worth of projects signed in the last month, driven by a former lieutenant general who has reinvigorated the infrastructure plan that's been languishing since Prime Minister Imran Khan took office two years ago.

The nations signed deals on June 25 and July 6 for two hydropower generation projects costing \$3.9 billion in the Pakistan-occupied Kashmir region, and another to revamp the South Asian nation's colonial-era railways for \$7.2 billion -- the most expensive Chinese project yet in Pakistan.

Khan's government appointed Asim Saleem Bajwa last year to run the China-Pakistan Economic Corridor Authority, which oversees more than \$70 billion in projects from power plants to highways.

He also joined Khan's cabinet in late April, becoming one of more than a dozen former and current

stall since Khan came to power, with no new projects announced in 2018 and very few in 2019.

Since Chinese President Xi Jinping launched the initiative in 2013, the World Bank estimates about \$575 billion worth of energy plants, railways, roads, ports and other projects have been built or are in the works across the globe. Its progress has slowed recently, dogged by accusations that China is luring poor countries into debt traps for its own political and strategic gain.

"The reality is that much of CPEC, like the Belt and Road more broadly, has been paralyzed," said Jonathan Hillman, a senior fellow at the Center for Strategic and International Studies in Washington, referring to the China-Pakistan Economic Corridor. Pakistan "is a flagship for China's Belt and Road, so the need to show progress is even more important.

In a tweet last month, Bajwa said some detractors had given the "false impression" that

The Chinese financing has helped rid Pakistan of an electricity deficit that left exporters unable to meet orders and major cities without electricity for much of the day. # Biden, Gates, Obama among Twitter accounts hacked in **Bitcoin scam**

Washington: Unidentified hackers broke into the Twitter accounts of technology moguls. politicians, celebrities and major companies on Wednesday in an apparent Bitcoin scam.

The ruse included bogus tweets from former President Barack Obama, Democratic presidential front-runner Joe Biden. Mike Bloomberg and a number of tech billionaires including Amazon CEO Jeff Bezos, Microsoft cofounder Bill Gates and Tesla CEO Elon Musk. Celebrities Kanve West and his wife, Kim Kardashian West, were also hacked. The fake tweets tweets offered to send \$2,000 for every \$1,000 sent to an anonymous Bitcoin address

There is no evidence that the owners of these accounts were targeted themselves. Instead, the hacks appeared designed to lure their Twitter followers into sending money to an anonymous Bitcoin account. The Biden campaign, for instance, said that Twitter's integrity team "locked down the account within a few minutes of the breach and removed the related tweet"

Obama's office had no immediate comment. The FBI said it was aware of Twitter's security breach, but declined further comment.

The apparently fake tweets

were all quickly deleted, although the Associated Press was able to capture screenshots of several before they disappeared.

In several tweets, Twitter said it believes the incident was a "coordinated social engineering attack" that targeted some of its employees with access to internal systems and tools. They were then used to take control of many highprofile and verified accounts and tweet from them.

The company said it immediately locked down the affected accounts and removed the tweets posted by the attackers. It also temporarily blocked verified users from tweeting while the company investigated the issue.

Among the political figures targeted, the hack mostly appeared to target Democrats or other figures on the left, drawing comparisons to the 2016 campaign. US intelligence agencies established that Russia engaged in coordinated attempts to interfere in those US elections through social media tampering and various hacks, including targeting the various campaigns and major party organisations.

The hack might also be a simple demonstration of Twitter's weak security controls as the US heads into the 2020 presidential election, a contest in which the service is likely to play an influential role.

doctors in the country, a majority of them general practitioners, have succumbed to COVID-19, the Indian Medical Association (IMA) said on Wednesday, and declared a red alert for medicos and medical administrators asking them to raise their guard.

According to IMA National COVID registry data, of the total 1.302 doctors infected with COVID-19, 99 have succumbed to the disease. Of those dead, 73 were above the age of 50 years, 19 in the age-group of 35-50 and seven below 35 years, the data showed.

"IMA declares RED ALERT to doctors and medical administrators to raise their guard. If COVID-19 mortality has to be lessened, it has to start with doctors and hospitals," the doctors' body

**NEW DELHI:** As many as 99 with COVID-19, mortality is higher among elders. While this is on expected lines, there is scope for lessening deaths across the age spectrum. Meticulous adherence to norms and discipline inside hospitals will have a salutary effect," the statement said.

National President of IMA Dr Rajan Sharma said that while the medical profession remains the beacon of hope for the nation to lead the exit from the pandemic, COVID-19 death among doctors has become a matter of great concern.

"IMA strongly advocates the leadership of doctors in adopting all scientific best practices. Doctors need to take charge of the situation and ensure the safety of themselves, their families, their colleagues and staff."

ed the leadership of doctors in adopting all scientific best practices.

This requires intense review and updating of all administrative set ups in the hospitals, including infection control protocols. Any gap in providing for the safety of doctors, nurses and staff have to be plugged, it said in the statement.

A feedback system from the doctors, employees and public needs to be put in place. Cleaning and sanitising protocols should be meticulously adhered to, the IMA said.

"Analysis of data shows that while senior and young doctors are equally infected

"Friendly and scientific batch posting needs to be implemented. hours should be tempered by concerns of safety. Providing for PPEs, training, physical distancing and sanitisers should be monitored on daily basis.
