### **Medical Team Attacked In Kunzar**

Baramulla: A medical team was on Monday attacked by the local villagers in Kunzar area of Tangmarg in north Kashmir's Baramulla district. The incident took place when the medical team from Kunzar hospital was on COVID sampling drive, officials said, adding that a group of people attacked, abused them and damaged their vehicle in Ogmuna village of Kunzar. Block Medical Officer (BMO) Kunzar, Dr Rukaya told KNO that soon after the medical team entered into the village for COVID-19 sampling, a group of people came and attacked their vehicle. She termed the incident as unfortunate. She said they have registered a complaint in this regard in Police Station Kunzar. Meanwhile, Police Officials from Kunzar confirmed the incident and said "we have registered a case in this regard while father investigation has been taken up."

### **ACR Rajouri To Head** Shahdara Sharief Waqaf

SRINAGAR, JULY 20: The government today ordered Assistant Commissioner Revenue Rajouri, Mohammad Ashraf to hold charge of administration/management of Waqaf, Shahdara Sharief Rajouri and Wagaf of all the tehsils of district Rajouri except erstwhile tehsils of Nowshera and Sunderbani with immediate effect in addition to his own duties. With the implementation of Central Wagaf Act 1995 in Jammu and Kashmir, government in another order terminated appointment of Abdul Qayoom Dar, as Administrator, Wagaf, Shahdara Sharief, Rajouri and for all the tehsils of district Rajouri except erstwhile tehsils of Nowshera and Sunderbani. 51 CRPF, 16 ACB Men Among New Infections: 463 More Recover

SRINAGAR: The re-imposition reported 171, Baramulla 40, of restrictions in many parts of Jammu and Kashmir have failed to curb surge of Covid-19 cases, raising questions about the strategy adopted by the authori-

ties in the district. On Monday Jammu and Kashmir reported the biggest single day spike in Covid-19 infections with 751 additions including 51 CRPF personnel, 16 from ACB headquarters here besides ten pregnant women. Among the fresh cases 240 were

reported from Jammu and 511 from Kashmir division which also include three BSF personnel and as many policemen and seven minors including one year-old baby.

### **US Lawmakers Urge** China To Step Back **From Ladakh**

WASHINGTON: Voicing concern over the recent Chinese military aggression against India, a bipartisan group of nine influential Congressmen have introduced a resolution in the US House of Representatives, urging Beijing that it should work towards deescalating the situation at the border through existing diplomatic mechanisms and not by force.

The troops of India and China are locked in a standoff in several areas along the Line of Actual Control in eastern Ladakh since May 5. The situation deteriorated last month following the Galwan Valley clashes that left 20 Indian Army personnel dead.

# 13 Years On: Family Of 13 Year Old Rape Victim Awaits Justice

HANDWARA: The family of a teenage girl who was gang raped and murdered in North Kashmir's Kupwara by four men still await justice. The family demands capital punishment for the rapists on the pattern of Delhi's famous Nirbhaya case.

On this day in 2007, the 13 year old Tabinda Ghani was raped and murdered by four men after abducting her when she was on her way to home from school. The criminals were later identified as Sadiq Mir alias Saeda Tsoor, Azhar Mir alias Billa, both residents of Langate, Mochi Jahangir of West Bengal and Suresh Kumar of Rajasthan.

# **New Consumer Protection Act Comes Into Force; Govt Notifies Rules**

NEW DELHI- The Consumer Protection Act. 2019. that seeks to set up a regulator to promote, protect and enforce the rights of consumer came into force on Monday with the government notifying rules for its implementation.

The government has notified rules for establishing Central Consumer Protection Authority (CCPA), Central Consumer Protection Council, Consumer sumers. The new act has been in-

# After 'Strike', Both People... soon after the shocking strike, vitriol and vexing reactions

flooded Kashmir's virtual space.

"Our young and energetic resident doctors are risking their lives by serving our community under testing circumstances." Dr. Muzaffar Maqbool, Researcher and Associate Professor, Internal Medicine, GMC Srinagar, said. "Please cooperate."

An angry doctor termed the public fury as a psychopathic action against the "Covid warriors"-whose role has currently become crucial for the community.

"Now you know why doctors leave this beautiful hell and settle abroad?" wrote Dr Zainub Nabi, a 'surgeon in making' at GMC, Srinagar.

Soon as the social media din over the controversy became deafening, many blamed the "critical reporting" done on medical staff by some Kashmiri journalists for the 'attack on the apron'. Netizens even likened some social media active scribes with a prime-time shouting anchor from the mainland.

However, coming to the rescue of the "helpless" medical staff, some users exhorted angry attendants to hold administration accountable instead of assaulting doctors.

"Kashmir, if you are upset with the prevailing conditions in hospitals, hold powerful holier than thou administration and politicians accountable," a twitter user said.

"The frontline workers doctors, nurses, staff are equally helpless." But some users took part in the debate to call out the 'false sense of entitlement' in doctor community 'who're only doing their job'.

"Beating of doctors by some Kashmiri 'miscreants' isn't acceptable but medical negligence is criminal too," a twitter user said. "In garb of aprons, 'some' doctors are dangerous than uni-

formed army personnel. Both are saviours, who kill." Many also attributed the recent attacks to "drunk on arro-

gance" behaviour from the medical staff. "Firstly, any violence upon doctors must be condemned," Ikram Ullah, a scribe from Kashmir, tweeted.

"However, as I have said before, there has to be strict accountability of doctors. All doctors are not noble, as we like to believe. There are these 'holier than thou', self-declared 'cream of the society'."

Amid scorn and solidarity, some doctors rose above the blame game and said that both doctors and patients are Kashmiris, who can't abandon each other at the crisis situation.

"We are all on the same side," wrote Dr. Shazia Shafi, an eye surgeon. "Please all of you, me included, let's focus on our problems and health as united people of Kashmir. Stand with vour doctors.'

Some even blamed the nomenclature for the public wrath on doctors

"When doctors dub as administrators, shit will hit the fan, because you don't have administrative expertise," twitter user Mehvash Rivaz said.

"In Kashmir, administrative decisions at hospitals have since prever been taken by doctors. But when acco they conveniently say, 'It's not on us'." These are exceptional circumstances, Mehvash said. "And it's only getting worse. People and doctors alike need to own upto their faults, only then there may be a slight chance of muddling through this. Otherwise we're doomed. Or maybe, we already are.'

"From the 2017 Doklam standoff to the recent violence along the borders in Sikkim and Ladakh, to China"s new claims to Bhutanese territory, Beijing has all too often sought to redraw the map of Asia without regard for its neighbours," he said.

Top Republican Senator Marco Rubio also recently called on India's Ambassador to the US Taranjit Singh Sandhu to express his solidarity with the people of India as they firmly confront unwarranted and lawless armed aggression by the Communist Party of China.

"India has made it clear, they will not be bullied by Beijing," he said. Senator Tom Cotton too slammed China of its aggression against India. "China has resumed its submarine intrusions in the Japanese contiguous zones and picked deadly fights with India at high altitude," he said.

"Just go around the horn. You started in India, where, high up in the Himalayas, China has essentially invaded India, an ally of ours. And they have killed 20 Indian soldiers," Tom Cotton told Fox News in a recent interview.

"Given the indefensible nature of the illegal detention order, the same was revoked by the government during the course of the proceedings before the Supreme Court," the statement said, adding "we have taken cognizance of the libelous statement of Mr. Baghel and we are presently in the process of consulting our lawyers and shall be initiating appropriate legal action" against him.

Abdullah was taken into preventive detention during the intervening night of August 4 and 5, hours before the Centre announced the abrogation of Jammu and Kashmir's special status under Article 370 of the Constitution and bifurcation of the state into union territories -- Ladakh and Jammu and Kashmir.

Hours before his preventive detention was to end after completing the mandatory six months, Abdullah was booked under the stringent Public Safety Act in February this year. However, on March 24, the PSA order for his detention was revoked after his sister Sara approached the Supreme Court challenging it.

Besides Abdullah, a host of other leaders in Jammu and Kashmir, including PDP leader and former chief minister Mehbooba Mufti were taken into custody in August last year.

# **14,000 Non-Local Labourers...** all the new arrivals including non-local labourers go through

However, a video that went viral on social media takes a lid-off the government claims as a group of non-locals when asked whether they had undergone mandatory tests for Covid-19 they replied in negative. Noted influenza expert and President of Doctors' Association of Kashmir, Dr Nisar-ul-Hassan said no outsider should be allowed to enter Kashmir till the situation gets normal on ground. Since we have poor health infrastructure, we may not be able to cope up with the situation, it would surely be a catastrophe."

### US Lawmakers Urge China...

In the months leading up to June 15, along the Line of Actual Control, the Chinese military reportedly amassed 5,000 soldiers; and is trying to redraw long-standing settled boundaries through the use of force and aggression, the Congressional resolution savs.

Noting that India and China have reached an agreement to de-escalate and disengage along the Line of Actual Control, the resolution says that on June 15, at least 20 Indian soldiers and an unconfirmed number of Chinese soldiers were killed in skirmishes following a weeks-long standoff in Eastern Ladakh, which is the de facto border between the two countries.

"The Government of the People's Republic of China should work toward de-escalating the situation along the Line of Actual Control with India through existing diplomatic mechanisms and not through force," the Congressional resolution said.

It is the sense of the Congress that there is significant concern about the continued military aggression by China along its border with India and in other parts of the world, including with Bhutan, in the South China Sea, and with the Senkaku Islands, as their aggressive posture toward Hong Kong and Taiwan.

The resolution comes days after the House of Representatives Caucus on India and Indian-Americans in a letter to India"s Ambassador to the US, Taranjit Singh Sandhu, said that over the last few months, the Chinese authorities have been acting with impunity and have attempted to transgress on the LAC, which resulted in diplomatic discussions to implement a process for de-escalation along the LAC on July 6.

It was led by Congressmen Holding and Brad Sherman and signed by seven other lawmakers.

"It is my hope that they scale back on their excessive weaponry and infrastructure at the Line of Actual Control and uphold both their longstanding and new founded agreements with India," said the lawmakers who offered their condolences to the families of the fallen soldiers.

"We are disappointed that China has been acting in contradiction to their agreements with India, in their attempt to change the status quo and challenge Indian troops at the border," the letter said.

Last week, Senator Bob Menendez, Ranking Member of the Senate Foreign Relations Committee, said US-India partnership, based on their shared commitment to democracy, is vital to uphold international law, international norms and the institutions that can peacefully and diplomatically resolve disputes and aggression.

"As India and China work to disengage along the Line of Actual Control (LAC), I remain deeply concerned by China's aggressive behaviour in territorial disputes," Menendez said.

He also tagged Congress leaders Rahul Gandhi and Randeep Singh Surjewala and the Congress party in his tweet.

The NC also issued a statement expressing "strong objection" to Baghel''s statement, saying it has "maliciously suggested" that the release of Abdullah from preventive detention was somehow related to Pilot"s revolt or the present political situation unravelling in Rajasthan.

"The Party unequivocally rejects such malicious, false and politically motivated statements that are used for convenient political posturing," the statement said, adding it was "false and scurrilous" and defamatory to the reputation of Abdullah as well.

The party said that it was a public knowledge that Abdullah was released after he had approached the Supreme Court challenging his illegal order of detention.

## Car-Bomb Attack In High Security Zone

Major among 3 soldiers, Civilian killed; 20 injured

RINAGAR - Militants attacked passing army vehicles in the high security Ram

Munshi Bagh area with a powerful car bomb this morning, leaving a civilian and three security men, including an army major, dead.

Twenty others, including five women and four security personnel were injured in the blast.

The attack took place at around 9: 10 am near the Sher-e-Kashmir cricket stadium close to the Burn Hall School when an explosive-laden Maruti car blew up just as army vehicles were pass ing by. The residences of several ministers, politicians and senior bureaucrats are located in the area, and it remains .under round-the-clock vigil of the police and the security forces. Eye-witnesses, quoted by the CNS, said they saw the driver of the Maruti car leap out and disappear through a' lane after slowing the vehicle down. The Maruti rammed in to an army Gypsy and was hurled several feet into the air by the explosion, they said. The police, quoted by the

PTI, said that the explosion occurred in a stationery vehicle. The Hizb-ul-Mujahideen, which has owned responsibility for the blast claiming to have inflicted heavy causalities on the security forces, has said that it was a suicide attack.

The blast killed Major Kupil Vinayak, two other personnel, identified as Ram Krishen and Subhash Chander, and a civilian, Naseer Ahmad Bhat of Buchwara, Dalgate, who worked as an ac countant in the Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST).

Muhammad Suban of Zero Bridge. Ghulam Muhammad Bhat, Sakina Akhter of Tangmarg. Convent School employee Roshni Akhtar, constable Tahmina. Dara Singh of Mattan, Muhammad Yousuf Wani of Haft Chinar, and Narendar Hakka of Shivpora.

Two of the four injured security personnel have been identified as Shankar Rao and driver Ghosh.

The blast, which was heard over a large area, left the area strewn with bleeding bodies and twisted metal of damaged vehicles. The Maruti car used in the blast was blown to bits and only its engine could be recovered by the police The army Gypsy was wrecked, and three other vehicles were damaged

Window panes of the nearby LIC office, the Highland Motors showroom, the official residence of the chief justice of the state high court, and several other buildings were smashed by the impact of the explosion.

# Involve the community

he figures tell a story about the Covid-19 cases in Kashmir: The count has now gone well past 13000 cases. Out of these cases, 5,797 are active positive, 7,165 have recovered and around 250 have died, most of them in Kashmir. Srinagar district with 62 deaths has the highest fatalities followed by Baramulla at 50, On Saturday, for the first time, the number of patients recovered were higher than those who tested positive on a single day. Patients, numbering 607, were cured and discharged from different hospitals in the union territory even as 441 new cases were reported. Similarly, of the total of over 13000 cases, 3,202 have been reported as travellers.

Since most of the active numbers are concentrated in the Valley, it is challenging to tackle them for the existing healthcare infrastructure. Any upgradation of the medical infrastructure over the past four months isn't sufficient to treat the surging number of cases.

Going forward the situation doesn't give any confidence. At the current rate, the number of cases are going to be far too many in near future to be handled by our doctors. More so, when the healthcare professionals are also now indicating that the community transmission might have already set in. The situation, we are given to believe, has aggravated after the government took steps to open up the economy. And which is also important. It is not possible for people to remain in a perpetual state of lockdown. This has already wrought havoc with the economy. More so, in Valley which has been under lockdown for the past twelve months. This has led to a loss of employment for thousands of people. The vital sectors of our economy like tourism, horticulture, handicrafts have been hit hard. So, perpetuating the lockdown is not an option. What the administration can do and which is eminently possible is to create more awareness about social distancing norms and take action against the people and the businessmen who violate it. It is time people are made responsible for their own health. We have to ensure that both life and livelihood are saved.

And to this end, the government will have to run an aggressive awareness campaign about the disease. It has to also work towards involvement of the community by charging village, locality elders, mosque managements etc to ensure people follow the safety precautions. Government should also enlist the youth for the purpose. This will go a long way to make a redeeming difference to the attitude of the people towards the contagion and in turn arresting its spread.

# **Give People Credit**

In an afflicted economy, J&K Bank must rise to the occasion. Here's how

All in all, before the liquidity crisis in Kashmir morphs into a fullfledged insolvency crisis, J&K bank must rise to the occasion and create conditions for the economic

ammu and Kashmir Bank is perhaps the backbone of our economy. In fact, it underwrites the economy of J&K. Amidst a lockdown that has been extended (right or wrong I am not debating that), the bank has a special role to play to rescue both the livelihoods of people and keep businesses-MSMEs and SMEs afloat. The question is how? Whilst I plead guilty to the charge of neither being an economist nor a banker, I would proffer a set of suggestions that might salvage our economy which has incurred losses in thousands of crores since the past year and even longer.

The bank can and must, against the backdrop of almost non-existent fiscal space in J&K, must keep credit flows open. Admittedly, this poses a risk in terms of profitability for the bank and a possible overshooting of Non-Performing Assets (NPA's) and the distinct possibility that the loans and their interest repayment will create leverage on companies' balance sheets and not investment. This would assume salience against the backdrop of a dwindling net interest margin (NIM) of and for banks (Net interest margin is the difference between the interest income of banks and the interest paid to lenders). The decrease, accruing from a poor macro and micro economic environment, presupposes a decrease in both net and operating profits of the bank. Against this condition, increasing or enhancing credit flows would sound irrational but there is no other way out. Enhanced credit flows can be offset against loan loss provisioning and perhaps increasing the capital adequacy ratio (CAR) of the bank and prudential regulations thereof. Obiter dictum, the present conditions and increasing the CAR - both tier one and tier II capital - might warrant increasing the deposit share of J&K bank by taking the bank, so to speak, to what are traditionally called the non-bankable segments of the population. The bank can even go on a deposit taking binge. In terms of enhanced credit flows, at this

critical juncture, these can lead to a positive spiral of investment and consumption that J&K is in dire need of. This, in the least, is the assumption and the theory with empirical evidence to back up with.

While credit must be extended to all kinds and forms of businesses, but if the businesses in contention have scale that qualifies them to be either a start-up or an MSME, then what the bank must ensure as a stipulation is develop a criterion that should be coeval with or as important as collateral: the requirement of robust and sound business model and plan. (In Kashmir, often times, what is in vogue is the 'project report' which has a rough equivalency with the business plan but there's hardly a demand for business models. This lacuna must be redressed. If one properly, it will make new businesses more efficient and effective and after uncertainty in Kashmir is accounted for perhaps even more prudential.

The problem and the major uncertainty are and remain the future economic outlook and the nature of the recession induced by the Covid 19 pandemic. No one now can know its form and nature. Would then increasing credit flows at this point constitute shooting itself in the foot by J&K bank? Not necessarily, JK's econ omy, is not necessarily aligned to economic developments elsewhere even though it is affected by these in a convoluted way. The region's economy is decoupled from that of the world: the nature and form of the recession while it would have an impact will not necessarily be the same as elsewhere. This means that even if there is a rebound and uptick in economic activity in other parts of the world, the same might not happen in J&K. This makes J&K Bank's role more salient and its activism, for want of a better word, important. If the overall profitability of the bank will suffer and take a hit. what can the bank alternatively do to boost income and profitability. There can be two ways for this.

One is to eke out cost savings from operations. It amounts to stating the obvious that there exist large inefficiencies in the operational side of the bank. If and when these are weeded out, cost savings can accrue without cost cuttings (read without layoffs) in the bank. The most pedestrian of techniques to weed out operational efficiencies would be business process re-engineering (BPR) and allied techniques. And to boost the overall income and profit of the bank along with operational efficiency of the bank would be to engage in trading activities, bonds, derivatives, stocks and so on. If there is an extant trading department of the bank, it needs to be more robust and effective. If done well, it can enhance the bank's profitability and cushion it against economic issues that might emerge. In the developed world, well known banks, have made a killing by trading activities which has offset their loan losses

J&K's economy is in crisis but crisis can also be touchstone for opportunities. If the suggestions made here are taken up by the bank, it should also set the institution thinking on its future direction and nature. What I have in mind is for the bank to become a financial conglomerate with a diverse and diversified set of activities that not only validates its historical role as the underwriter of J&K's economy but also take the region's economy to a new level. All in all, before the liquidity crisis in Kashmir morphs into a full-fledged insolvency crisis, J&K bank must rise to the occasion and create conditions for the economic uplift of our society. This is not charity. Besides inhering in the bank's charter and remit, this particular institution has a duty to perform. But this need not, as demonstrated here, undercut its income and profitability. Let the bank then do a serious rethink and approach both the Covid 19 and post Covid 19 world in a way that is both dexterous, efficient, effective and moral.

# Undying tale

he Narendra Modi government had given India a unique gift; it is sheer bad luck that the novel coronavirus should compel its withdrawal. The gift was not willingly given, but had the government not pushed through the Citizenship (Amendment) Act and the National Register of Citizens for the whole country then the months-long sit-in at ShaheenBagh, Delhi would not have happened. At the time, the government was on a roll, pushing through legislations on the strength of its majority in Parliament against protests from the Opposition and sections of the people as though democracy was just a crude matter of numbers, ignoring questions about the discriminatory purpose of the CAA and the possible exclusionary intention of the NRC, while allowing the violent repression of protests. Then ShaheenBagh happened.

Muslim women from a locality of that name came out of their houses and sat on the ground close by: without fuss, they said this was their land and they would not leave it for CAA or NRC or anything else. Their gathering radiated peace, goodwill and welcome - the prime minister never did accept their repeated invitation to tea so that they could 'talk' — and they spoke of no religious cause. They held up the Constitution and the Indian flag. Their presence, day after day, even through the Delhi winter, showed India what peaceful protest is like: immovable, democratic — there were no leaders, only organizers - and completely disciplined, united in a common purpose. It was as though elements from the visions of Gandhi and Ambedkar, whose picture was displayed, had taken shape. Only political leaders with their speeches were forbidden. The women's presence under their own agency was a glorious example of the equality the Constitution aims at. They came from precisely that segment of the population that various shades of political and privileged opinion, with condescending concern, considerttobe backward, voiceless and put upon in their own society. ShaheenBagh gave divided and misogynistic India that immemorial moment when not just members of a community often discriminated against, but its women, led a quiet and intransigent protest movement that no one could match. Its hold on constitutional ideals was unmatched too. Muslim women led a truly secular movement which all communities, classes, ages and genders could join. help or participate in, and which spawned similar movements across the country. ShaheenBagh shone as a microcosm of what India was meant to be - and can still become.

No pandemic can take ShaheenBagh away. That two books have been published on it is one manifestation of the deep impression it has made on many. The character of the protest would ensure that many more would have felt its transforming touch than the books can reach. It is now a reference point, a dream of the possible, a revelation of potential to which, irrespective of text books, history can keep aspiring. *Telegraphindia*

# When a patient dies, why is a doctor beaten?

he recent incidents of lifethreatening assault on doctors by some goons, though not new by any means, are certainly disheartening and disturbing. Why does a patient die? The reasons can be many. Lack of proper infrastructure, unavailability of an ambulance to transfer the patient, lack of life saving drugs, lack of trained medical staff and so on. When people die in hospitals, you beat doctors. But when they die at home, do you beat yourself, your wife, your kids, your neighbors. Exactly who do you take out your frustration on.

I just saw a video of a man sharing his anguish regarding the delay in getting the dead body of one of his relatives, pending COVID testing. I was feeling his pain till he uttered this sentence 'kisi doctor kasarphodahai. Lekin is hisab se theek hi kiyahai'. I cannot express the amount of disgust I felt looking at his face and suddenly the feeling of sympathy vanished. This statement was disgusting for me but not demoralizing. What is demoralizing for me is that in a place like Kashmir where scores of relatives flock your house for an issue as minor as vomiting or diarrhea, a top administrator from SMHS comes to a doctor in casualty who has just survived an attack on his life and suffered seizures and has the cheek to tell him 'ye sab tohhotarehtahai'. It kills the compassion inside me as well as the little respect, if any left, for our administrators.

As a doctor, I don't expect any patient to thank me or think high of me. Let them call us killers or donation doctors or murderers or whatever they wish, on facebook and behind our backs. The problem I have is with anyone physically harming a doctor and with the failure of the administration to ensure the safety of doctors.

Don't think of yourselves as heroes or brave people when you attack doctors in groups of 10-20 in the dark of the night. You don't do it out of angst or concern for the health of your patient. You are just a frustrated person who seeks gratification by taking out your frustration on a vulnerable section of the society. When was the last time you attacked some policeman who was taking undue advantage of his power or a clerk who wouldn't forward your file without some emoluments or some politician who consumed the funds that were meant for the healthcare facilities that don't exist now.

Recognize yourself for who you are: a coward.

And the administration should also recognize themselves for what they are: a failure.

# 12 Ways To Help Overcome Social Anxiety

Act confidently. There are a large number of adults suffering from social phobia and crippling shyness. You can learn to be confident in the same way you learned to ride a bike. Act more confidently and people will react positively. This doesn't mean you need to be the class clown or the centre of attention. It's just about being more assertive. Something that feels terrifying at first will gradually feel better each time

Social anxiety disorder is often misunderstood and many people could be suffering in silence. It's much more than feeling shy and not wanting to speak up in big groups. It can really take control and impede your everyday life. Anxiety Care UK states that social anxiety is a common and distressing condition with as many as 40 per cent of the population suffering from it.

The good news is that there are ways to develop new habits to help ease and overcome your social anxiety.

1. Challenge your negative and anxious thoughts. At times it may feel like there's nothing you can do about the way you feel and how you think. In reality though, there are a number of things that can help. Challenging your mentality and negative thoughts can be an effective way to reduce symptoms of social anxiety. Start by identifying the anxious thoughts that automatically pop into your head when you think of social situations. Next, analyse these thoughts and challenge them. Question why you think like this and if your first reaction is actually how you feel or you're just always assuming the worst. Changing the way you think is a long journey and is not an immediate fix but the mind is a powerful thing and it is possible

2. Be mindful. Being mindful and practicing mindful meditation helps you to be present and aware of your thoughts and feelings in a nonjudgmental and positive way. In a study published in the journal Social Cognitive and Affective Neuroscience, researchers found that meditation has effects on activity in particular areas of the brain. Participants who had normal levels of anxiety took part in four 20-minute mindfulness meditation classes. They found up to 39% decrease in anxiety levels after mindfulness training.

3. Go to a coffee shop. If you enjoy watching movies online or catching up on your favourite tv show then try taking your tablet or laptop to your nearest coffee shop. Do an activity you like and feel comfortable with, in an environment that would usually make you anxious. You have the familiarity and comfort of being able to concentrate only on what you're doing but will be pushing your boundaries. Hopefully, you can push yourself but remain in your mental comfort zone at the same time.

4. Create an exposure hierarchy. Identify and rate how each social situation makes you feel in terms of anxiousness. For example, 0 would mean no anxiety and 10 would be a full-blown panic attack. Make a list and write down how you think you would feel for every situation, no matter how small or big. From walking into a room at a gathering to asking a stranger on the tube for the time. It's important to write down on a piece of paper your predictions so that when the times comes to experience it, you know how you thought you would feel. 5. Don't focus on yourself. It's hard to



stop the endless mind chatter when you're in situations that make you particularly anxious. We often turn inward and focus on ourselves and how others will perceive us, almost always assuming it will be negative. The thought that everyone will be looking at you when you walk into a room and judging you in one way or another. This isn't the case. Stop focusing on yourself and what other people are thinking of you. Focus on other people, try to be present and make genuine connections. No one's perfect so try to be in the moment and actually listen to what is being said.

6. Adopt a healthier lifestyle to reduce anxiety. The mind and body are linked and how you treat your body can have a significant impact on the rest of your life including your anxiety levels. By making small lifestyle changes, these can help to improve your self-confidence and your ability to cope with anxiety symptoms. Avoid or limit your caffeine intake by not drinking coffee or caffeinated drinks after a certain time. Energy drinks act as a stimulant and can increase anxiety symptoms. Make physical exercise a priority in your day and always try to be active at some point, even taking a brisk walk during your lunch hour is a great way to fit it in.

plenty of water, stay hydrated and get enough high-quality sleep. When you're deprived of sleep, you're much more vulnerable to anxiety and your mood can be affected greatly. New research suggests that sleep deprivation can actually cause an anxiety disorder. slow down your breath can help you take back control of your body. Simply take a seat, get comfortable and take the biggest breath you've taken all day and hold it in for four seconds. Then exhale slowly, pushing out as much air as possible. Take another deep breath filling the stomach with air and continue until you feel your breath slowing down to its normal rate.

8. Act confidently. There are a large number of adults suffering from social phobia and crippling shyness. You can learn to be confident in the same way you learned to ride a bike. Act more confidently and people will react positively. This doesn't mean you need to be the class clown or the centre of attention. It's just about being more assertive. Something that feels terrifying at first will gradually feel better each time.

9. Find social situations and engage. Make a conscious effort to be more social. Actively look for supportive social environments that can help you overcome your fears. Perhaps start with a social skills training class. Here you can properly practice your social interactions before heading out into the real world. This will give you some tips on what to say and do when you find yourself in a social situation you're unfamiliar with or anxious about.

10. Be kind to yourself. Nobody's perfect and everyone feels embarrassed at one point or another in their life. Overcoming social anxiety is by no means easy. You'll have times where you think negatively and slip back into old habits. If you're feeling run down or tired, you may find yourself feeling more anxious than normal but it doesn't mean you've failed. Just take a minute, focus on the present and practice the techniques you've been working on.

11. Talk. By overcoming social anxiety and shyness you will hopefully start feeling more confident during conversations. Talking to someone can be very challenging and knowing what to say isn't easy. Sometime's an awkward silence can feel like it lasts a lifetime. Talking to people gradually will help you be less anxious each time.

12. Face your fears. The final step is to face your fears. It's impossible to overcome social anxiety if you don't expose yourself to situations that make you anxious. By using avoidance as a tool to cope, you won't be helping yourself or encouraging personal growth. Numerous studies have shown that exposure therapy, facing your fears, is effective in treating anxiety disorders. Research does suggest, however, that exposure should be applied gently. Therefore take part in a social interaction or activity that only slightly provokes your anxiety and work your way up.

Overcoming social anxiety is a long journey and it takes time for new neural pathways for social interactions to form. Is your social anxiety is constantly interfering with your daily life? Then don't hesitate to seek professional help in whatever form you feel comfortable looking for. These are great ways to help overcome your social anxiety. Although it seems like an impossible obstacle, it's so worth overcoming so you can live your life to the fullest.

You are committed to an eternity of the Circle Line as it pitches and jolts through the darkness each station a purgatory where lost souls might finally ascend into the light after their tortuous journey.

There is a deceptive stillness on the white ceramic tiled walls opposite the platform — the subway pattern often replicated by inferior interior designers, a subtle psychological torment to remind condominium owners and urbane urban yuppies of the underground unfurling beneath their city buildings.

# Personality From One's Smartphone Data

veryone who uses a ◀ smartphone unavoid-✓ ably generates masses of digital data that are accessible to others, and these data provide clues to the user's personality. Psychologists at Ludwig-Maximilians-Universitaet in Munich (LMU) study how revealing these clues are. In a study that appears in the journal PNAS, a team of researchers led by LMU psychologist Markus Buhner set out to determine whether conventional data passively collected by smartphones (such as times or frequencies of use) provide insights into users' personalities. The answer was clear cut. "Yes, automated analysis of these

data does allow us to draw conclusions about the personalities of users, at least for most of the major dimensions of personality," says Clemens Stachl, who used to work with Markus Buhner (Chair of Psychological Methodologies and Diagnostics at LMU) and is now a researcher at Stanford University in California.

The LMU team recruited 624 volunteers for their PhoneStudy project. The participants agreed to fill out an extensive questionnaire describing their personality traits and to install an app that had been developed especially for the study on their phones for 30 days. The app was designed to collect coded information relating to the behaviour of the user. The researchers were primarily interested in data pertaining to communication patterns, social behaviour and mobility, together with users' choice and consumption of music, the selection of distribution of their phone given individual's personality: tiousness. ### **Development In** Children

Physical activity is linked to better cognitive ability, which is in turn related to academic performance in school. As per the new study, physical activities can enhance cognitive functions especially in those who have the most room for improvement. The recent study was lead

by Associate Professor Keita Kamijo at the University of Tsukuba and Assistant Professor Toru Ishihara at Kobe University shows.

Understanding the effects of physical activity on cognition has been difficult for several reasons. "Previous studies looked at the issue too broadly. When we broke down the data, we were able to see that physical activity helps children the most if they start out with poor executive function," explained Professor Kamijo.

Executive functions refer to three types of cognitive skills. The first is the ability to suppress impulses and inhibit reflex-like behaviors or habits. To assess this ability, children were asked to indicate the color in which words like "red" and "blue" were displayed on a computer screen. This is easy when the words and colors match ("red" displayed in red font), but often requires inhibition of a reflex response when they don't ("red" displayed in blue font).

The second skill is the ability to hold information in working memory and process it. This was evaluated by testing how well children could remember strings of letters that vary in length.

## **China Expands Amphibious** Forces In Challenge To US **Beyond Asia**

Hong Kong: China launched its military build-up in the mid-1990s with a top priority: keep the United States at bay in any conflict by making the waters off the Chinese coast a death trap. Now, China's People's Liberation Army (PLA) is preparing to challenge American power further afield.

China's shipyards have launched the PLA Navy's first two Type 075 amphibious assault ships, which will form the spearhead of an expeditionary force to play a role similar to that of the US Marine Corps. And like the Marines, the new force will be selfcontained - able to deploy solo with all its supporting weapons to fight in distant conflicts or demonstrate Chinese military power.

The 40,000-tonne Type 075 ships are a kind of small aircraft carrier with accommodation for up to 900 troops and space for heavy equipment and landing craft, according to Western military experts who have studied satellite images and photographs of the new vessels. They will carry up to 30 helicopters at first; later they could carry fighter jets, if China can build short take off and vertical landing aircraft like the US F-35B

The first Type 075 was launched last September and the second in April, according to reports in China's official military media. A third is under construction, according to the May edition of a Congressional Research Service report.

Washington: US President Donald Trump faces an uphill task in his re-election bid in November with his approval rating hitting a record low and Democratic nominee Joe Biden taking a doubledigit lead in key indicators, according to a survey con-ducted by the Washington Post and ABC News.

The opinion poll, conducted July 12 to 15, shows how the coronavirus outbreak has adversely affected Trump's prospects.

The survey said 54 per cent of Americans believe Biden would handle CO-VID-19 outbreak better than Trump. Only 34 per cent felt Trump was doing well tackling the pandemic.

In handling of the economy, Biden has made giant strides and is nearly on par with Trump in the opinion poll, the ABC News reported.

Biden edges out Trump by 9 points in crime and safety, which has been a major topic in the US after hundreds of anti-racism protests in the last two months.

On race relations, Biden has a lead of 25 points over his Republican rival (58-33 per cent). Trump's job approval rating has plummeted in the last two months, standing at 39 per cent positive and 57 per



cent negative.

Notably, 48 per cent of the surveyed 'strongly disapprove' Trump's way of doing his job, according to the Washington Post's article.

However, the president has managed to hold a positive view on his handling of the economy with 50 per cent of the surveyed saying they are happy with the US economy's performance and 47 per cent disapproving.

Biden is perceived to have a better personality and temperament to serve as president, holding 26 points advantage over Trump, the Washington Post reported.

The Japanese rocket carrying the probe developed by the United Arab Emirates (UAE) lifted off from the Tanegashima Space Centre in southern Japan right on schedule at 6:58 am local time (2158 GMT Sunday).

The launch of the probe, known as "Al-Amal" in Arabic, had twice been delayed because of bad weather, but the Monday liftoff appeared smooth and successful.

Almost exactly one hour later, a live feed showed people applauding in the Japanese control room as the probe success fully detached.

The launch vehicle trajectory was executed as planned and separation of the Hope spacecraft was confirmed," rocket manufacturer Mitsubishi Heavy Industries said.

In Dubai, the launch was met with rapturous excitement, with the Burj Khalifa -- the world's tallest skyscraper -- lit up hours before liftoff with a symbolic 10-second countdown in anticipation.

"This mission is an important milestone for the UAE and the region," said Yousuf Hamad AlShaibani, director of the UAE's Mohammed bin Rashid Space Centre, at a post-launch press conference in Japan.

Villages were razed, thousands were taken to detention camps, more than 3,000 non-Serbs were executed and tens of thousands were driven from their homes.

Eleven Bosnian Serb ex-policemen were convicted of the crime, including Darko Mrdja who was jailed for 17 years by the Hague-based international war crimes tribunal. The remainder were convicted by the Bosnian war crimes court.

The suspected mastermind of the killing, Simo Drljaca, the Prijedor police chief, was killed in an exchange of fire with NATO-led peacekeeping forces in 1997 in their first attempt to arrest suspects still at large.

## **Ahead Of Court Verdict, Ex-SS Guard Apologises To Holocaust Victims**

amburg: A 93-year old former Nazi concentration camp guard apologised to Holocaust victims at a Hamburg court on Monday, ahead of the verdict in the high-profile trial over his complicity in the World War II atrocities.

'Today I would like to apologise to those who went through the hell of this madness, as well as to their relatives. Something like this must never happen again," said Bruno Dey from the dock.

In what could be one of the last such cases of surviving Nazi guards, Dey stands accused of complicity in the murder of 5,230 people when he worked as an SS tower guard at the Stutthof camp near what was then Danzig, now Gdansk in Poland.



The court is expected to issue its verdict on Thursday. Prosecutors have sought three years in jail for the 93-year-old.

But in his summary on Monday, Dey's defence lawyer Stefan Waterkamp asked the court for an acquittal or a suspended sentence, saying his client "would not survive" jail.

Dey himself has denied any guilt for what happened at the camp, and said that the triescape"
