India, Pak Trade Fire Along LoC

Jammu: India and Pakistan troops on Saturday exchanged heavy gunfire along the Line of Control in Jammu and Kashmir's Poonch district, officials said. The Pakistani troops fired from small arms and shelled mortars towards the forward posts along the LoC in Mankote sector this evening, officials said. The officials said the Indian Army retaliated befittingly. This was the fifth day that the Pakistani forces have violated the ceasefire along the LoC. The Pakistani troops had shelled areas along the LoC in Raiouri and Poonch districts on Tuesday, Wednesday, Thursday and Friday.

Searches Carried Out In Tral

Srinagar: Government forces on Saturday carried out a cordon and search operation in Tral area of south Kashmir's Pulwama district. According to the reports, police and army cordoned off Brantal area of Tral town after receiving inputs about the movement of militants. The joint team sealed all the entry and exit points before starting search operation. Early this month, the area witnesses a fierce 20-hour long gunfight between militants and the government forces during which the former managed to flee.

Iran-Kashmir Collaboration Bringing Music To War-Weary World

■ HE stage was set. Artists were prepared. Arrangements were done. Advertisers were ready. But then, COVID hit the world.


The subsequent viral lockdown was a big blow for Qaisar Nizami, a celebrated Kashmiri musician and singer on his first visit to the United States (US) to perform and present at an event supposed to be held on March 20 at the University of North Texas (UNT) College of Music, a premier institute for music education.

With a travel ban imposed by the Government of India for an indefinite period soon after his arrival,

Nizami was stranded in the country for the next two and a half months. Amidst continuing frustration and helplessness, his host Dr. Sadaf

Munshi, a professor of Linguistics at the UNT introduced Nizami to her friend, Ehsan Matoori, a US-based musician and composer of Iranian origin. Dr. Munshi's colleague Dr. Vivek Virani, and Ali Montazeri, a graduate student at the university, for a live virtual performance which was broadcasted from Munshi's residence after the University was shut down for all in-person events.

SRINAGAR- A top commander of the Lashkar-e-Taiba (LeT) was among two militants killed in an encounter with the state forces in Ranbirgarh Panzinara area on the outskirts of Srinagar on Saturday, police said.

The state forces launched a cordon and search operation in Ranbirgarh Panzinara area in the morning following inputs about the presence of militants there, a police official said.

He said as the forces were conducting the search, militants fired upon them. The forces retaliated, triggering an encounter The police said one of the two

slain militants was identified as Ishfaq Rashid, a resident of Sozeith in Srinagar.

Rashid was one of the top LeT commanders active in Kashmir Valley since 2018. He was wanted in many militancy-related cases,

JK Bank Hiring In Ladakh Soon: CMD

SRINAGAR: A day after Ladakh observed a complete shutdown against declaring its "educated/unemployed" youth "non-eligible" for the recently-advertised bank jobs, J&K Bank's Chairman and Managing Director (CMD) R K Chhibber on Saturday said the bank shall soon initiate a recruitment drive for filling the posts of Probationary Officer (PO) and Banking Associate (BA) in Leh and Kargil.

Talking to Kashmir Observer. Chhibber said the announcement in this regard will be made soon. "After the regulatory clear-

ance, the recurrent drive will be announced for the aspirants of Ladakh." Chhibber said. Notably, the candidates from

Ladakh were left out in recent recruitment drive in J&K Bank.

'Those candidates from Ladakh who have already applied for the posts advertised in 2018 need not to apply again," the CMD added.

On Friday, life got crippled in Ladakh, which was cut from the erstwhile state of Jammu and Kashmir last summer, after the region observed a complete shutdown against the "non-eligibility" of its educated youth in the bank jobs.

8 More Die Of Covid-19 In Kashmir, Toll In J&K 308

SRINAGAR: At least eight more people on Saturday died of Covid-19 in Kashmir Valley, raising the number of fatalities due to the deadly disease in Union Territory of Jammu and Kashmir to 308.

Among the victims, four were Srinagar residents, two from north Kashmir's Bandipora, while one each from Baramulla and Pulwama district, officials said.

NEW DELHI: A study done exploring the elastic properties of rocks and seismicity in the eastern most part of the country has found that the area is quakes at two different depths.

"It's an unusual collaboration, the first of its kind, which brought together a large team of accomplished artists, musicians, and choreographers from different countries, including India, Iran, Lebanon, and the United States," said Munshi.

Na zninay, composed and produced by Ehsan Matoori, is partly inspired by a Kashmiri melody Pur Mah, 'full moon'.

Matoori arranged and composed the multilingual musical piece with the vocalists Qaiser Nizami and Alireza Ghorbani from Iran.

Ghorbani is a foreground singer of the Persian song and a master of numerous scales of Middle Eastern music. Nizami, a highly versatile artist with a strong command on various Indian languages including Kashmiri, his native tongue, specializes in the Indian classical and light Sufiyana music of Kashmir.

"It was an amazing experience to perform with the great Santoor player Ehsan Matoori who skillfully brought together a Kashmiri and an Iranian singer," said Nizami weeks after having gone through the ordeal of repatriation. Matoori crafted the story using excerpts from the Kash-

miri ghazal written by Ibrahim Miskeen and a Persian poem, Beneshi n Mara , 'Stay with me', by Fereydoun Moshiri. Video direction was done by Afshin Hashemi, an award-winning Iranian filmmaker.

"The music was very powerful and the poetry was full of beautiful imagery," Afshin said about the composition. Choreographers from three different ethnocultural backgrounds, viz., Indian, Iranian and African-American, were chosen for the dance. The shooting was done in Tehran and Chicago.

"Most of the shooting was done outdoors following social distancing norms," said Dr. Munshi. "The locations used for the shoot were empty as people were stuck inside due to the

The musical pact became part of a larger project "The Voices and Bridges" composed and produced by Matoori in collaboration with renowned musicians from many parts of the world including Bombay Jayashri, Celia Woodsmith, Grammy award winner Mike Block (cello player), Alireza Ghorbani and Qaiser

The Voices and Bridges project was announced by the BBC world, BBC Persian and the Silk Road Project in July 2019 and took off with the first song El Sueño with Ghorbani as the lead

Exploring diverse musical and poetic traditions around the world, Matoori invited Dr. Munshi to provide linguistic advice on the Voices and Bridges project which brings together languages as diverse as English, French, Spanish, Italian, Turkish, Arabic, Kashmiri, Urdu, Burushaski, and Bengali.

"A strong believer in the transformative power of language and performing arts, working with Matoori is personally exciting for me," said Dr. Munshi.

The lyrics were based on texts of different periods from various parts of the world by prominent poets such as Borges, Nima Youshij, Pablo Neruda, Rabindranath Tagore, Nazim Hikmet, Pierre Reverdy, Allama Iqbal, Margot Bickel, and Lal Ded, Dr. Munshi informed.

Each linguistic component and device was thoroughly analyzed; the texts were transcribed, reviewed and translated over many meetings with the help of native speakers.

J&K Govt Begins Registering... to domicile of the Union Territory.

On May 16, the L-G's administration took a historic decision

by reopening "fresh registration" for Kashmiri migrants and displaced persons, that paved the way for inclusion of bonafide people who migrated from the UT.

"Bonafide migrants and bonafide displaced persons who are not yet registered with the relief and rehabilitation commissioner (migrant), Jammu and Kashmir, can apply before the competent authority for registration for purpose of issuance of a domicile certificate only," an order issued by Additional Secretary, Department of Disaster Management, Relief, Rehabilitation and Reconstruction, S P Rukwal, said on May 16.

The opportunity of registration for the purpose of obtaining a domicile certificate shall be open only for a period of one year from the date of issuance of this order, Rukwal said.

The relief and rehabilitation commissioner (migrant) of Jammu and Kashmir shall be the competent authority for the purpose of registration of displaced persons, besides Kashmiri migrants to issue domicile certificate, he said.

For this purpose, migrants and displaced persons can apply online with one of the proofs, including a copy of permanent resident certificate, name in electoral roll of 1951 and 1988, proof of working in an autonomous body or entity before 1.11.1989, proof of owning immovable property in J&K on of after 1944, among others. "In order to facilitate such bonafide migrants, the relief de-

partment has made a special and limited provision, which will enable such bonafide persons to apply to the relief commissioner for registration of domicile certificate through production of various documents," Principal Secretary, Power, Rohit Kansal said.

We are conscious of the fact that there are a large number of bonafide migrants and bonafide displaced persons who are not registered with the relief department, he said.

They can show proof through a permanent resident certificate (PRC) or registration as migrant, besides names in the list of 1988 and 1951 electoral rolls, Rukwal said. Kashmiri Pandits welcomed the decision of the launch of on-

line registration for the KPs and displaced persons living outside Jammu and Kashmir and said that justice has been done by the Lieutenant governor Girish Chander Murmu.

"We welcome the decision. It is a historic decision. Those

KPs, who shifted to various places in India and outside will get justice. We thank L-G Murmu sahib for this historic decision", All Party Migrant Coordination Committee (APMCC) Chairman Vinod Pandit told reporters here.

Panun Kashmir Convener Dr Agnishakher and Chairman Dr Ajay Chrungoo also praised the L-G for the historic step and said that such initiatives are steps to correct historic wrongs and provide justice to the community.

All State Kashmir Pandit Conference (ASKPC) General Secretary Dr T K Bhat also welcomed the decision and said that credit of providing justice goes to the L-G. "It is a confidence building measure for the community", Bhat said.

Rights Group Paints Grim...Prevention Act (UAPA), to stifle dissent," reads the 72-page

report. The report further says that the 11 months of lockdown-comprising closures, barricades, checkpoints and restrictions on mobile telephony and internet connectivity-have enormously impacted public health, and caused trauma and stress amongst the people of Jammu and Kashmir, violating the rights to health and medical care under the Indian, and Jammu and Kashmir, constitutions.

"Prolonged lockdowns, arrests and detentions; restrictions on media and 4G mobile internet services, appear to have caused worrisome disquiet and seething youth anger," the re-

"The rights of children to a trauma-free environment have been arbitrarily ignored. The impact on education has been particularly severe. Schools and colleges functioned for barely 100 days between 2019 and 2020," the report said.

Referring to the continued high-speed internet ban despite Covid-19 pandemic, the report says that limiting networks to 2G has made it impossible for online classes to function adequately and the graduate students and teachers have been unable to participate in conferences or have their papers published, causing wilful harm to their careers and violating the rights to education under the Indian, and Jammu and Kashmir,

"Local and regional industries have suffered large losses in almost every sector. Companies that are heavily or solely reliant on 4G networks that are available in the rest of the country, such as tourism and cottage industries, have been forced out of business," the report says.

It says that the new domicile rules introduced by the Ministry of Home Affairs and the Jammu and Kashmir administration, moreover, erode prior employment protections for per-

Terming the local media as one of the worst sufferers, the report says that the journalists have been harassed and even had draconian charges slapped on them, for example under the Unlawful Activities Prevention Act (UAPA).

"Their content, readership and revenues have suffered such a sharp decline that dozens of journalists have lost their jobs. The new media policy is a death blow to an independent media and the freedom of expression," the report said.

In the conclusion, the rights groups presented a set of 13 recommendations while terming Kashmir 'litmus test of Indian democracy'. Among the recommendations included, release of political detainees, speedy trials, amendment of controversial PSA and other detention legislations, release of juveniles and dropping charges against them followed by action against the state forces found guilty of child rights violation, withdrawing UAPA charges against journalists and activists and rollback of new media policy, restricted use of Section 144, compensation to the people whose houses have been launched in cordon and search operations, restoration of high-speed internet, smooth passage of medical staff and patients at checkpoints besides compensation for the local that were forced to shut down due to the government lockdown between August 2019 and March 2020.

Gardens, Parks in S-Kashmir Generate Only 2 Percent Of Usual Revenue: Report

Srinagar: Ongoing long lockdown has badly hit the revenue generation of the floriculture department from various popular gardens located in south Kashmir, officials said.

The lockdown which has hit almost every sector in Jammu and Kashmir has cast a shadow on the revenue generated from parks maintained by the floriculture department.

Officials said that due to lockdown, the revenue generated from parks under the floriculture sector is just around two percent as compared to last year.

Pahalgam, Floriculture department which has seven parks that include Poshwan Park, Akad Park, Ashmuqam Park, Lidder view Park, Club Park and Island park under its control have generated a revenue of less than one lack which generated over Rs 35 lakhs last year.

"Despite clampdown after August 05 last year, these seven



major parks in south Kashmir region generated revenue of around Rs 35 lakh (last year). However, this year the revenue generated is abysmally low,"

Assistant Director Floriculture, Mohammed Hussain said.

"This year due to the less flow of tourists and locals, these parks have hardly generated any revenue," he added. "Same is the case of famous Kokernag, Verinag and Achabal as the revenue generated from these parks is also very low this year due to

Zaheer Ahmed, Floriculture officer under whom Achabal, Kokernag and Verinag parks are said that from March to August 05 last year, these three parks generated an amount of over Rs 50 lakhs however from March till date this year the revenue generated is below Rs 1 lakh.

"After the government decided to open parks and gardens, a large number of people started to visit the parks which created some enthusiasm here. But after Covid-19 cases witnessed a surge, the flow of visitors dried up completely," he added.

Notably, the government spends lakhs on maintenance of these parks to attract more and more tourists as well as locals.

Pertinently, famed Mughal Gardens of Srinagar and Asia's largest Tulip Garden located at the foothills of Zabarwan hills here also witnessed zero flow of tourists this year due to lock down.

Giving further details, Navin K. Choudhary, Principal Secretary to Government, Agricultural production Department said that GI certification establishes specific geographical origin and certifies certain unique qualities of the product. "GI certification enables those who have the right to use sign in order to prevent third parties from using the sign. This GI certification would also stop the prevalent adulteration

of Kashmir Saffron and thereby authenticated Saffron will fetch much better prices.'

Choudhary further informed that Kashmir Saffron is the only one in the world grown at an altitude of 1600 meters, which adds to its uniqueness and differentiate it from other saffron varieties due to its unique characteristics like longer and thicker stigma, natural deep-red colour, high aroma, bitter flavor, chemical free processing and high quality colour strength, flavor and bitterness.

He further informed that on the directions of LG, Sprinkler Irrigation System in the entire saffron fields are being installed on a war footing and likely to be completed in next two weeks.

Protests, Clashes In Kupwara **Over Trihgam Killings**

Scores Of Students Injured In Police Action: Schools In 3 Zones Closed For 3 Days

SRINAGAR - Over a score of protesting students were injured in Kupwara today after police used force and fired into the air to disperse a huge demonstration against yesterday's killing of three school-children in Trihgam by the security forces. In view of the continuing tension, authorities have ordered schools in some parts of the Kup-wara district to be closed for three days. The killings have evoked strong condemnation from political parties cutting across ideological divides.
Students in Vilgam, Trihgam, and Kralpora took out a pro-

cession today to decry the killings, and shouting slogans against the army and the government, marched several kilometres to get to Kupwara town.

News of the procession brought students and public into the streets, swelling the numbers of the protestors to thousands.
"Shops closed down and govt employees out their offices as

the procession shouting "stop the killing of innocents," "punish the guilty" and don't play with our lives," entered the town.

The demonstrators also shouted slogans against the deputy ommissioner, Kupwara, for his purported statements about the

killings yesterday. The protesting students alleged that the DC was trying to attribute the killings to cross-firing. Refusing to disperse when the police blocked their way

to the DC office, the demonstrators kept on repeating their demand of punishment to the guilty.

The police resorted to lathi-charge to scatter the protesters who retaliated with pelting stones at the police and government buildings. The police swung into action once again on the orders of the SSP and the DC, using lathi-charge and dozens of teargas shells.

Army regrets killings Portraying as accidental the killing of three Kashmiri youths and injury to another in Kupwara in North Kashmir, the Army today expressed regret over the incident and said an inquiry has been ordered into it. "The Army regrets this unfortunate loss of life and has ordered an inquiry into the incident.

I Was A Dogged Indian Cricket Team Fan, August 5 Changed Me

During the lockdown, I realized that something in me had shifted. Mahendra Singh Dhoni, was no longer my favourite cricketer

n 18th June, 2017, when Mohammad Amir took three crucial wickets against India in the finals of Champions Trophy, our entire hostel erupted in cheerful noise, I had not seen my friends that elated in a long time. That night I mulled over my transition from shedding tears, when India had lost to Pakistan in the group match of 2014 Asia Cup, to being extremely joyful for their day's defeat.

In 2015, I finally got admission in Islamic University of Science and Technology (IUST), for a bachelor's programme in electrical engineering, after several involuntary hiccups along the journey until that point which included unrests of 2008, 2010, and the floods of 2015. The university was located on a hill top in Awantipora district of South Kashmir, a distance of about 80 kms from my hometown Sopore.

Kashmir was gradually returning to stability only to be in mess again after witnessing the chaos and bloodshed for more than two decades which had completely put a halt to day-to-day life. But little did everybody know that the worst was yet to come.

South Kashmir, where the university was situated, was already the hub of militancy. Militants who previously preferred to hide their identities to protect themselves from security forces, had now become courageous enough to stop being in disguises and openly flaunt their pictures and videos along with their AK-47 rifles on social media. The rebel leader Burhan Wani, who was the face of new militancy on social media, had gained popularity all over Kashmir.

Meanwhile I had commenced the journey on the path of engineering, being an ardent supporter of Indian cricket team, I religiously watched every single match and cheered on every run scored and sometimes got frustrated whenever a wicket fell, like a die-hard fan. In fact, I was among the very few youngsters in Kashmir, who were of the opinion that sports and politics ought not to be mixed and supporting the Indian cricket team was not equal to going against the popular sentiment of hatred towards the Indian state. As a youngster, I did not understand the nuances of the relationship between Kashmir and India, but I had always known that the relationship was quite special and everyone in Valley was awaiting the day, when Kashmir will also be like any other normal state.

But the situation over the past few decades had already made people lose faith in India and it's democracy. The policies of the government to deal with the Kashmir issue had always been anti-people, they rightly had no reason to believe in any of their soft-talk and

hate, even in the Indian cricket team. One thing I always knew was that, Kashmir was a cage where people had no liberty and absolutely no rights courtesy of the draconian Armed Forces Special Powers Act (AFSPA), which had been placed in Kashmir since long before I was even born and even a small mistake could lead to the end of my life or at least my career. Section 4(a) of the said Act gives security forces the license to kill any person on the basis of mere suspicion. Government's argument in favour of this Act is that, it avoids any threat to the internal security arising from the militants in Kashmir, but evidently it has not served that purpose. The fact that the militancy has still not subsided and attacks on armed forces are still rampant, leads to a single conclusion that the only thing this Act has been successful in achieving is that it has antagonized the people of Kashmir to the point where they see Pakistan as their only hope. The cruel and dehumanizing capabilities that this Act empowers the security forces with, are not only against the international conventions like Universal Declaration of Human Rights (UDHR), but are also against the Indian constitution.

The Act has bestowed the security forces with the power and the courage to stop your car in the middle of your journey for no reason at all and make you wait for as long as they want. The agony of you not having the right to ask them any question while they humiliate you by doing so is inexpressible.

On July 8, 2016, while enjoying the breeze on the balcony of my hostel room, in the evening, the news of the killing of Burhan Wani broke out. Perhaps the most loved person in Kashmir at that time, was killed by security forces in an encounter in Bumdoora area of Kokernag. The news sent chills down my spine, because I understood that this was the beginning of something which could plunge Kashmir deeper into turmoil. In its immediate aftermath, scores of young Kashmiris were killed and thousands injured. Whole Kashmir was burning with fathers giving shoulders to the coffins of their dead sons, mothers and sisters wailing asking questions to their creator, why had he taken the light of their eyes away too soon. "Ye ha ohss me echanhundgaash", (He was the light of my eyes), cried the wailing mother living in the vicinity of the hostel,

whose son got killed by security forces.

What followed the incident was complete inactivity for several months in Kashmir, with schools and offices shut, mobile connectivity was barred for several months, people were restricted to their homes helplessly with nobody to hear their calls for assistance. For the whole period of lockdown that lasted for about six months, watching the evening news bulletins about the number of people injured and killed during the course

of the day and listening to the statements of different nobodies and somebodies had become the daily rou-

During this period of hibernation, I realized that something in me had shifted. I had also become a rebel, Mahendra Singh Dhoni (then the captain of Indian cricket team), was no longer my favourite cricketer, I had stopped making a distinction between India and the Indian cricket team, they were all the same. The inhumane restrictions put in place by the Indian government on Kashmiris, was something that even the caged unruly animals were unworthy of. Perhaps for them, that is what we were "unruly beasts", who deserved to be caged and punished, and that is how the people of Kashmir were portrayed by the Indian nationalist media, to their mostly jingoistic audience "wolves waiting for the opportune moment to attack the Indian federation". But little did everyone know, that the caged animal was not a wolf, but only a little bird, but mere fluttering of its wings, as the bird was gasping for air.

The unrest lasted for more than six months. Life returned to normal seemingly after an eternity of violence. The coming year, we had to complete three semesters, which ideally would have taken one and a half years to complete, in order to compensate for the time already wasted. The hectic schedule almost made me give up on my engineering dreams.

The night, when India lost to Pakistan in the finals of Champions Trophy, I felt asleep, listening to the poem by Revolutionary poet, Habib Jalib:

"Tum ne lootahaisadiyonhamarasukoon, Ab na hum par chalegatumhaarafasun Chaar agar dardmandonkebante ho kyun tum nahichaaragar koi maanemagar main nahi manta meinnahijaanta"

(For centuries you all have stolen our peace of mind But your power over us is coming to an end, Why do you pretend you can cure pain? Even if some claim that you've healed I refuse to acknowledge, I refuse to accept)

The wrong policies of the government had made me reconcile with our doomed fate and give up on my dreams of ever seeing light in the valley. Perhaps I had stopped believing in the resurrection of Kashmir.

When that ominous August of 2019 came, I had almost completed my degree. At a time when the Indian government should have seriously given a thought to invalidating the AFSPA in Kashmir, they chose to revoke the special status or limited autonomy, granted to J&K under Article 370 of the Indian constitution, bifurcated the state and downgraded it into a centrally ad-

ministered Union Territory (UT). The vents of the cage were sealed yet again, this time the oppressive measures on the activity in Kashmir were even more stringent. All the regional leaders whether mainstream or separatist were placed under house arrest, mobile connectivity was suspended, more than ten thousand boys, many of whom were juveniles, were picked up from their homes and put behind the bars, heavy curbs were imposed on the freedom of local press, curfew was imposed in all parts of J&K, even up to this day the high speed mobile internet is not working in Kashmir. All this to suppress any form of response.

Recently the J&K administration has approved the new "Media Policy-2020", which effectively empowers the administration to decide whether a particular news is "anti-social and anti-national" or not. The move drew sharp criticism from the Kashmir journalists, as according to them the policy was detrimental to the freedom of speech and expression and had no place in the constitutional framework of India, the same constitution that the ordinary Kashmiris had stopped believing in a long time ago. I see people least bothered by such regressive policies of the administration, may be because they see New Delhi as a usurper and usurpers have a history of curbing the freedom of their subjects.

While Kashmir was under a savage lockdown, the world leaders were scheduled to speak at the United National General Assembly (UNGA), in September 2019, the people of Kashmir with all their innocence had tied their threads of hope to it. But nothing happened.

In November 2019, when nothing was working out in Kashmir, I decided to shift to Delhi for further education. To my surprise, I found that everyone in Delhi, from an Uber driver to my landlady seemed convinced that Modi had done wonders in Kashmir, by abrogating Article 370, bringing happiness to the people of Kashmir, that it was merely because of Pakistan that Kashmiris rebelled against India, that there was no fundamental issue of snatching the rights of Kashmiris and this move would eventually bring as they would say "Vikas", (development) in Kashmir. I was bewildered by the magnitude of misinformation that had been spread among the ordinary citizens regarding Kashmir, through social media and by some biased media organizations. I realised that, perhaps we were already living in a dystopian society, where there were humongous handicaps on the free thinking ability of the proletariat, where the government's propaganda was the ultimate truth and the truth was considered to be the hate speech, and where everyone was under the surveillance of the government.

irca 2014. Halfway through election campaigning, it occurred to me that the issues of azaadi, autonomy and Article 370 were never raised in any of the meetings, anywhere. Not once was it asked of me where I stood on these. Even in private conversations with people—farmers, shopkeepers, traders, and agricultural labourers—the National Conference's demand for 'autonomy' or the PDP's concept of 'self-rule' were never mentioned, even in passing.

The reason for this, it turned out, was simple: people didn't see these mainstream parties as having any role in the resolution of the Kashmir issue. These parties were only about governance and, in the words of John Lewis, the civil rights pioneer, about "good trouble". Nothing more. Nothing less either! Coexisting with this was the palpable separatist sentiment that one could sense and see. The families of militants—dead or alive—were res¬pected. They were invariably seen as the "village elders" who exercise influence that comes with upward social mobility. Over the years, socially, militancy had become a rite of passage.

The same people who would attend election rallies would also attend the funerals of militants. In their mind there seemed no conflict between the two. The former was an individual obl¬igation born out of material needs, while the latter was a collective desire engendered by a certain understanding of political history. These two worlds were not reconciled with each other, but inevitably coexisted. In ¬bet¬ween, of course, there were occasions of confrontation.

At the level of local political workers, the BJP didn't exist—neither in their -territory nor on their minds. No ¬political field worker or supporter saw the BJP as an opponent, let alone a ¬serious adversary. For PDP workers, it was the National Conference or the Congress that was the adversary and vice versa. Politics at the grassroots, being much localised, is quite different from the view on the tree top. No ¬wonder, at the party level, the BJP was seen and discussed

as the single ¬biggest opponent!

la Robert Musil—not in their conversations. In fact, Kashmir's relationship with India was not an issue any longer.

And then August 5, 2019, happened. Kashmir, in popular perception all over the country, was reintegrated yet again; it was reconceived, if not rec¬laimed. For the government of India, the barrier to democracy and development was abolished. Never mind that way back on December 4, 1964, then Union home minister GulzariLal Nanda had candidly informed Parliament that "Article 370, whether you keep it or not, has been completely emptied of its contents, nothing has been left in it". Nanda was not given to hyperbole. He was absolutely right.

Circa 2020. Everyone without exception—farmers, shopkeepers, traders, agricultural labourers—are feeling hum¬iliated, hoodwinked and helpless. The ghost of 370 is harbouring the spirit of resentment. This, in turn, has enlarged the constituency of supporters for resistance. For the old-timers, it was more than a mere article of the Constitution, it was an article of faith. They are in an existential and moral crisis—as if they had been living in sin.

Article 370 is reborn, resurgent. This time not as an ideology or an issue, but as an illustration—an example of yet another betrayal, both by the local mainstream parties and by "Hindustan". Kashmir's relationship with India is now back again in conversation—hushed at the moment, but very much audible.

It ought to have been realised by now, but hasn't been, that abrogation of Article 370 has not hit at the

separatist political ideology; quite the contrary. For them, it has been an "instrument of control" rather than a "guarantee for autonomy". It has provided them with a renewed justification. But more than that, it has strengthened the sentiment of separatism among people. How this will find expression in local politics is a big imponderable. A year down the line, it appears that a while slaying a shadow, the silhouette has been sharpened.

The only political space that has shrunk, at least for now, is that for mainstream politics—the political parties whose basis has been politics of ethnicity, not Kashmiri nationalism. In its most extreme form it has been a politics of asymmetric federalism.

The August 5 action has, in the words of Perry Anderson, destroyed their "seriality"—the social construct that underlies their political existence. The limits of mainstream political leadership in J&K have been brutally exp¬osed. No wonder, in the last one year, no political formation has taken shape, despite quite a few failed attempts.

A new paradigm of electoral politics, it is hoped, will be around restoration of statehood. Hence the reports that people are more "hurt and humiliated" about being downgraded to a Union territory than the abrogation of Article 370. May be. May be not.

Until the pandemic took over, for six months, the audacious abrogation of Article 370 was seen all over the country as a 70-year-old commitment fulfilled, correcting a perceived historical blunder and honouring

the political rhetoric of reframing a Hindu Rashtra. The pandemic stymied all that in a great rush.

A year down the road, the juggernaut has rolled relentlessly. Having demolished the edifice, the scaffoldings are now being systematically removed. On March 31, 2020, as part of the exercise to align the state laws of the erstwhile state of J&K with its new stature as a Union territory, the government of India amended 109 and repealed 29 state laws.

Importantly, the constitutionally guaranteed domicile rights have been replaced by liberal domicile rules and criteria. This has bred enormous insecurity in the minds of the Kashmiri people, not completely unfounded, of a demographic change being planned.

According to the 2011 Census, there were 28 lakh "migrants" working in the state—almost a quarter of the total population. To put this number in -perspective, it is 10 times the population of Ladakh. Many of them have been in J&K since the later 1990s. In principle, they will qualify for the status of a -domicile of J&K.

Further, a delimitation commission has been notified, leading to -apprehension that this would change the character of representation in a Muslim-majority region. The electoral ¬demography will surely und¬ergo a change even if only 25 per cent of the ¬migrants vote in the legislative assembly elections to which they are now entitled under the domicile rules.

The manner in which Kashmir has been hammered in the last one year has taken a heavy toll on the people. Abrogation of the autonomous position, bifurcation of the state, downgrading to a UT, domicile law changes, delimitation of constituencies, notifying "strategic areas" for use by the army, a six-month political logjam followed by a pandemic lockdown, connectivity embargo and the continuing restrictions have affected them physically, psychologically, financially and politically. The way things are in Kashmir, it is heading to stage where, in words of Albert Camus, "your very existence is an act of rebellion".

Path to Past: 10 Books on Kashmir **History for Summer Reading**

HE probing pen delving into past might've been previously popularized by the likes of Prem Nath Bazaz with his "impartial record-keeping", but over the years the valley saw the rise of new writers who captured and chronicled its chequered past like never before.

While many busted myths, others set the records straight with their gritty fact-findings. While a few followed statist suit, some made it to controversial shelves with their "tell all".

What makes most of these exhaustive researchbased readings significant are the popular notions and mainstream narratives based on selective history and biases, making it more difficult to objectively know the ever changing and evolving landscapes of Kashmir.

At this juncture, it becomes more quintessential to navigate through the pages of history and grasp the often untold, and unpopularly known stories and events surrounding the Kashmir issue which has been the microcosm of so many levels of discord.

The History of Struggle for Freedom in Kashmir: Cultural and Political, from the Earliest Times to the Present Day (1954)- Prem Nath Bazaz (National Book Foundation)

Published in 1954, Prem Nath Bazaz wrote the preface as "Kashmir belongs to Kashmiris" which went on to become a very popular sentiment.

As the name suggests, Bazaz, a prominent Kashmiri Pandit politician and intellect, chronicled the struggle of Kashmiris into two parts 'to present a connected history of the freedom movement of the people from the dawn of civilisation to our times.'

Tracing the sentiments of independence among the populace from the past history of dominant Dogra-ruled state to present days, Bazaz made a thorough analysis of comprehending the 'accession' dispute and political developments following the partition by delving into the ancient and medieval times of the region as well.

When the history of Kashmir is to be understood, Bazaz's work is widely discussed. The book had foreseen the 90's insurgency and assertion "as a matter of right after nearly 450 years of oppression" and further examines how the present scenario is impacted by the shared history of the past.

In this award-winning book, the British historian, Alastair Lamb explores the history and genesis of the Kashmir dispute.


Recognized as an expert of judicial and diplomatic history of Kashmir, Lamb who previously authored several books on the same subject, meticulously works to provide historical context of the internal political evolutions as well as interpretations and alternative solutions to the struggle of Kashmir in this one.

Published in 1991 by Oxford University Press, soon after the start of the 90's militancy, Lamb's work tries to clarify those basic key issues of 1947 and the way in which they have been "modified, obscured or distorted" with the passage of time and the pressure of partisan arguments.

The book, however, has been banned in India as Lamb positioned himself, supported by public documents and records, that New Delhi "had no valid legal ground or moral justification for accession" in the 'Vale of Kashmir

Published in 2004, Mridu Rai's work became an indispensable one to understand the region's contested past. The historian did the path-breaking work of telling about today's troubles by going all the way back to 1846.

Rai argues the creation of the Dogra-ruled state



was the turning point where the Kashmiri society got unequally divided into rulers and ruled and paved the way for the widening gaps and exploitations.

Critically acclaimed and highly recommended by scholars worldwide, Rai's scholarly work examines the 100 year period prior to the decision of 1947 which led to mixture and growth of religion and politics inextricably intertwined with the consciousness of the Muslim populace.

Rai focuses on the geopolitics of Kashmir and mainly the legitimacy and autocratic nature of the Hindu Dogra state which led to years of impoverishment and tribulations in the lives of the Muslim subjects which ultimately gave rise to identity politics

The book becomes a definite read to understand the historical study of rights, religion, regional and community identities. It explains how the origins of the present day dilemmas and state of affairs are interlinked to the past shaped by these consequences.

Victoria Schofield, the British historian and commentator on international affairs, authored this to address the escalating nuclear arms race between India and Pakistan arising out of the dispute and how the Kashmir conflict even after decades is the major flashpoint and key decisive factor in shaping domestic and foreign relations.

"Schofield," Lucian W Pye of the Foreign Affairs wrote, "has reviewed the entire record of the conflict, interviewed many participants, and struggled to find possible solutions.

Schofield extensively gives context to the issue of increasing militancy and continuing violence and the wider implications of the Kashmir issue in the

Published in 2014, Constitutional expert and lawyer, AG Noorani, compiles his detailed accounts of the long-standing dispute and complex history of the region backed by painstaking research spanning over years based on both archival and contemporary documents.

Blaming both the Pakistani and Indian administrators as well as the British for the plights, tragedies and continuing miseries of the Kashmiris, Noorani does not shy away from addressing the biggest 'villain' responsible for the wrong doings.

In the book, Noorani extensively quotes India's first Prime Minister, Jawahar Lal Nehru's "lies" in Parliament as well in telegrams addressed to Pakistan and British prime ministers during those intervening years of 1947.

Nehru in one of his last telegrams wrote, "Our assurance that we shall withdraw our troops from Kashmir as soon as peace and order are restored and leave the decision about the future of the State to the people of the State is not merely a pledge to your Government but also to the people of Kashmir and to the world.

"In their totality," Muhammad Ali Siddiqi of Dawn writes about Noorani's book, "the articles turn the book into a piece of research that gives us a comprehensive story of the Kashmir tragedy from political, diplomatic, legal and, more importantly, human angles."

Published in 1954, Josef Korbel, the Czech -American diplomat authored a first-hand narrative of the many complex factors stemming from the Kashmir dispute.

Korbel was named one of the delegates mediating the Kashmir dispute by the United Nations Commission of India and Pakistan in 1947.

The book is a result of his personal experiences and addresses, the dispute and changes in Kashmir starting from its past history as a princely state to United Nations interventions and negotiations between the two countries as well as roles and failures in the Kashmir scene.

Published in 2017, author Khalid Bashir Ahmad seeks to challenge the perpetuated narratives of Kashmir's history over the centuries.

With his book, the author aims to bring forward the hidden 'true' Kashmir's history of the land and

its people and delegitimize the popular held beliefs which he sees as 'myths' propagated by a wellplanned state machinery.

In the epilogue, the author writes: "Nobody would dispute the fact that in a situation as sensitive as Kashmir, selective mention of tragedies will all but bridge the trust gap. Understanding and recognising each other's pain and suffering are crucial for achieving this. Alongside a reference to Nadimarg, Wandhama and Sangrampora (places where Kashmiri Pandits were massacred by suspected militants), a mention of Gawkadal, Sopore, Handwara and Islamia College (places where Kashmiri Muslims were massacred by government forces) is imperative to complete the picture of Kashmir trag-

Considered as one of the most crucial reads in recent times, Khalid Bashir's book extensively works to expose the selective narratives based on few fragmentary sources and challenges the premises of historical books such as Kalhana's Rajtarangini (The River of Kings) and brings forward fallacies in play.

Indian economist and journalist, Prem Shankar Jha based his book on declassified as well lengthy reports and documents on the accession of Kashmir

Published in 1996, Jha with his book, aims to rebut Alastair Lamb's positions over Kashmir accession and provide alternative readings.

Jha argues to prove how Kashmir's accession came to India legitimately with a particular focus on Maharaja Hari Singh. Jha views Hari Singh adopted the right course of actions to minimise the damage when confronted by the immeasurable, powerful

forces beyond his control. Many critics and scholars, however, disagree with Jha's "partisan views" of those turbulent times in the course of history.

Professor and literary historian, Ananya Jahanara Kabir explores long standing historical elements along with conceptual, social and cultural aspects of the dispute.

Published in 2009, the author provides fresh approaches to the dispute through nuanced and symbolic examinations of the Kashmiri artists and poets' collective desires for 'their homeland'.

Proposing non-militaristic ways, it gives an insightful read and representations to understand the cultural and political lives in the beautiful valley of Kashmir torn apart by the intense, repeated desires by both sides of the border.

Australian political scientist, Christopher Snedden in a rarity offers a fresh interpretive history of the largely forgotten four million people of "Azad

With his book, Snedden says that "a reason why little has been written about the major events in Jammu Province in 1947 is Indian and Pakistani neglect. Both governments have been engrossed in their war of words over J&K rather than factually determining what - or who - instigated the Kashmir dispute.'

In a radical approach, Snedden aims to reject the popular narrative and notions that Pukhtoon tribesmen from Pakistan instigated the dispute over Kashmir's international status. Rather the author documents how the Jammuites engaging in three significant actions post the partition of 1947 instigated the unresolved dispute.

Published in 2011, this book provides new information about the least known, neglected area of J&K- "Azad Kashmir", a narrow strip of Kashmir populated by Muslims amidst India's ongoing ownership claims and Pakistani sides' oversight.

N the last decade, as the valley witnessed a creative boom, many locals became brain and brawn behind many visual projects. Many of those attempts took the form of documentaries touching among other things the pulse of politics and the perpetual struggle for life in Kashmir.

Presenting and projecting the picture of the vallev in a detailed manner, most of these documentaries became popular in an era when social media as an instant interactive tool created raging debates and discussions around them.

Physical Stress On The Job Linked With Brain, Memory Decline In Older Age: Study

new study has found that physical stress in one's job may be associated with faster brain ageing and poorer memory.

Aga Burzynska, an assistant professor in the Department of Human Development and Family Studies, and her research team connected occupational survey responses with brainimaging data from 99 cognitively normal older adults, age 60 to 79. They found that those who reported high levels of physical stress in their most recent job had smaller volumes in the hippocampus and performed poorer on memory tasks. The hippocampus is the part of the brain that is critical for memory and is affected in both normal ageing and in dementia.

Their findings were published this summer in Frontiers in Human Neuroscience under the research topic 'Work and Brain Health Across the Lifespan.'

"We know that stress can accelerate physical ageing and is the risk factor for many chronic illnesses," Burzynska said. "But this is the first evidence that occupational stress can accelerate brain and cognitive ageing."

She added that it is important to understand how occupational exposures affect the ageing of our brains.

"An average American worker spends more than eight hours at work per weekday, and most people remain in the workforce for over 40 years," Burzynska said. "By pure volume, occupational exposures outweigh the time we spend on leisure social, cognitive and physical activities, which allel yet opposing associations with

Burzynska explained that the association between "physical stress" and brain/memory were driven by physical demands at work. These included excessive reaching, or lifting boxes onto shelves, not necessarily aerobic activity. This is important because earlier work by Burzynska and her colleagues showed that leisure aerobic exercise is beneficial for brain health and cognition, from children to very old adults. Therefore, the researchers controlled for the effects of leisure physical activity and exercise.

As expected, leisure physical activity was associated with greater hippocampal volume, but the negative association with physical demands at work persisted.

"This finding suggests that physical demands at work may have par- and general psychological stress.

brain health," Burzynska explained. 'Most interventions for postponing cognitive decline focus on leisure, not on your job. It's kind of unknown territory, but maybe future research can help us make some tweaks to our work environment for long-term cognitive health."

She added that the results could have important implications for society.

"Caring for people with cognitive impairment is so costly, on economic, emotional and societal levels," Burzynska said. "If we can support brain health earlier, in middle-aged workers, it could have an enormous impact."

One piece of the puzzle

"The research on this topic is so fragmented," Burzynska said. "One previous study linked mid-life managerial experience with greater hippocampus volume in older age. Another showed that taxi drivers had larger hippocampi than a city's bus drivers, presumably due to the need to navigate. In our study, job complexity and psychological stress at work were not related to hippocampal volume and cognition. Clearly, our study is just one piece of the puzzle, and further research is needed.'

The magnetic resonance imaging (MRI) data used for the study was collected at the University of Illinois Urbana-Champaign between 2011 and 2014.

CSU researchers now can collect MRI data with the new 3T scanner at the University's Translational Medicine Institute.

With this new capability, Burzynska, along with Michael Thomas and Lorann Stallones of CSU's Department of Psychology, is launching a new project, "Impact of Occupational Exposures and Hazards on Brain and Cognitive Health Among Aging Agricultural Workers," which will involve collecting MRI brain scans and identifying risk and protective factors that could help the agricultural community age successfully. The project recently obtained fund-Term Project from the High Plains Intermountain Center for Agricul-

tural Health and Safety. The Department of Human Development and Family Studies is part of CSU's College of Health and Human Sciences.

US Sterilisation Program Tried To "Breed Out" Black People: Study

Washington: A sterilization program that ran in the US state of North Carolina from 1929 to 1974 was explicitly designed to "breed out" black citizens and met the UN definition of genocide, a study said this week.

Almost 7,600 men, women and children as young as 10 were surgically sterilized under the program that was created to serve the "public good" by preventing people deemed "feebleminded" and others from becoming parents.

Most were coerced but some women who had no other means of birth control sought out sterilization by having themselves declared unfit mothers.

The new paper was published in the American Review of Political Economy.

It examined the years 1958 to 1968, a period in which more than 2,100 authorized sterilizations occurred across the state's 100 counties.

The authors found that, for the period they studied, sterilization rates increased with the size of the unemployed black population -- but unemployed whites and other races were not similarly targeted.

William Darity Jr, a professor at Duke University and coauthor, said the United Nations's



definition of genocide cites intent to destroy, in whole or in part, a national, ethnic, racial or religious group.

This includes, according to the text of the Geneva Convention, "imposing measures intended to prevent births within the group."

"North Carolina's disproportionate use of eugenic sterilization on its black citizens was an

act of genocide," said Darity.

Previous work had shown that the eugenics program had disproportionately targeted black people, but the new paper shed light on the mechanics by which the program worked and its mo-

"Controlling black bodies and their reproductive choices is nothing new," added co-author Rhonda Sharpe of the Women's Institute for Science, Equity, and Race.

'Our study shows that North Carolina restricted reproductive freedom, using eugenics to disenfranchise black residents.'

Subject: SOP for Dealer Assisted Registration for Non-Commercial Vehicles in the UT of Jammu and Kashmir

CIRCULAR Dated. 21.07.2020

In view of COVID-19 pandemic and to reduce the footfall at the RTOs / ARTOs offices across the UT of Jammu and Kashmir, the following instructions are hereby issued in continuation to Order No. 09-P-TC of 2017 dated 12.10.2017 read with Circular Instructions issued under No. TC/JK/ MV/2017/965-72 dated 15.02.2018, for strict compliance:

1. Non Transport Vehicles shall be issued permanent registration mark through VAHAN portal of Ministry of Road, Transport and Highways (MoRTH), Government of India, at the time of first sale by the dealers in the UT of Jammu and Kashmir.

2. No vehicle sold by the Dealer (Trade Certificate Holder) to any person shall be driven / taken out of showroom, unless a permanent registration mark is allotted to the vehicle by the Dealer through the VAHAN portal.

Each dealer shall be provided with a unique 'login id and password' in VAHAN portal by applying for the same on the prescribed form, which shall serve as his identification to access the portal of MoRTH.

4. The Dealer will take required documents for registration as per Rule 4 of Central Motor Vehicles Rules, 1989 from the vehicle owner duly selfattested by the owner of vehicle.

The Dealer shall enter the data related to the vehicle on the VAHAN portal. He shall enter the Chassis Number and all the details regarding Chassis shall be auto populated from the Homologation data base. (Homologation database is a repository of all vehicle models/variants manufactured by the vehicle Manufacturers in India, whose credentials are provided by Ministry of Road, Transport and Highways and National Informatics Centre).

6. Form No.20 shall be printed from the portal and the Dealer after inspecting the vehicle, shall issue the Certificate of Inspection on the proforma, as prescribed in Form 20 and upload it on the VAHAN portal to satisfy the Registering Authority about the physical inspection of the vehicle.

7. The following documents (duly signed by the purchaser) and any other document as may be prescribed in the CMVR, 1989 or by the Government from time to time, shall be uploaded by the Dealer on VAHAN portal

ii.	Form No. 21 (Sale letter)	
iii.	Form No. 22 (Road worthiness certificate)	
iv.	Sale invoice	
٧.	Valid address proof of the Purchaser as per Rule-4 of CMVR, 1989

The relevant information and documents to be uploaded shall be duly verified by the Dealer and thereafter all the fees/taxes shall be deposited online in VAHAN portal. The fees/taxes shall include the following or any other fees/taxes as levied by the Government from time to time:-

ii. Hypothecation fee, if applicable

iii. Road Tax and cess etc

Registering Authorities (RTOs / ARTOs) shall verify the documents of the vehicles on the basis of the documents uploaded by the Dealer on the Vahan Portal. However, the onus of authenticity / genuineness of the documents uploaded on Vahan portal shall be the sole responsibility of the

The registration mark shall automatically be generated after completion of all the codal formalities, as prescribed above.

The Registration mark shall be placed by the Dealer on HSRP supplied by Manufacturer or selected vendor. The HSRP shall be affixed by the Dealer on the vehicle.

No additional charges/amount shall be realised by the Dealer from the purchaser of the vehicle for the allotment of permanent registration number, deposition of online tax and fee, cost of HSRP and processing of application. The Dealer shall also undertake to abide by all the terms and conditions issued in this behalf by the Department of Transport, Government of J&K, from time to time and MoRTH, Government of India. In case of non compliance, violation or breach of any of the terms and conditions, the Trade certificate of the Dealer shall be liable to be suspended/cancelled.

13. (a) The Dealer shall upload the parameters/laser codes of HSRP affixed on the vehicle, on VAHAN portal.

(b) RC will be issued by the Registering Authority only after the above (a) is performed by the

(c) The permanent registration marks as generated by the VAHAN Portal, shall be assigned from tne series allotted to the concerned registering authorities/dealer. It the purchaser is willing to get a choice number/vanity number as mentioned in Rule 54 {6(a)} of Jammu & Kashmir Motor Vehicles Rules, 1991, he shall deposit the requisite fees through the VAHAN portal. After confirming the transaction, receipt shall be generated from the VAHAN portal for the purchaser.

14. During this process, the dealer shall also ensure that:-

The new vehicle has obtained type approval from the agency authorised under Rule 126 of the Central Motor Vehicles Rules, 1989 and from the Department of Transport, Jammu and Kashmir for registration of a vehicle of that model in the UT of J&K, as per J&K Motor Vehicle Rules, 1991 and SROs / SOs as amended / issued from time to time.

a) The new vehicle to be delivered to the purchaser is not a stolen/resold vehicle. Further, the new vehicle is not mechanically defective and complies with the requirement of Motor Vehicles Act/Rules and instructions issued thereunder from time to time.

b) The purchaser/applicant has furnished accurate particulars in the application for the registration of the vehicle and has furnished all supporting documents issued by the competent authority as may be required and that there is no reason for the refusal of the registration of the vehicle.

c) Where the new motor vehicle is held under hire purchase agreement, lease, hypothecation with any Bank or finance company, the full name and address of the Bank or Finance company has to be

incorporated legibly/prominently in Form No. 20 and 21. 15. The authenticity/genuineness of the documents uploaded shall be the sole responsibility of the Dealer. In case, if any document uploaded by Dealer including the inspection report of vehicle, is found at later stage fake, frivolous/forged/tempered, the Dealer's login ID on VAHAN portal shall be

disabled immediately and the Trade Certificate of the Dealer shall get ipso facto cancelled. Besides, he shall also be liable for prosecution under relevant provisions of law. The concerned Registering Authority shall not in any way be responsible for authenticity/genuineness of all requisite documents uploaded on VAHAN portal by the dealer, required for the issuance of Registration Certificate. 16. Permanent registration mark as allotted shall finally be approved by the concerned Register-

ing Authority on the basis of documents uploaded by the dealer on the VAHAN Portal and the approval shall be conveyed to the Dealer online within a period of 72 hours from such uploading. Upon receipt of approval from the Registering Authority, the dealer shall generate the print out of Registration Certificate carrying the scanned signature of the Registration Authority.

17. In order to maintain the security of data, the user will receive an OTP on their mobile phone at

18. The Registering Authorities are authorised to inspect the records which are in possession of Dealer in case of any doubt with regard to genuineness of all or any records and the dealer is bound to allow such inspection by Registering Authority as and when required.

19. The Dealer should have a valid Trade certificate. In case of expiry of Trade Certificate, dealer will not be allowed to initiate the process of registration in the system.

20. The original files, till further orders, shall remain in safe custody of the concerned dealer which can be called as and when required by the transport authorities. In case of change/closure of business by the dealer, all the original files relating to registration of vehicle shall be handed over to the concerned Registration Authority under proper receipt.

21. The Dealer shall indemnify, defend and protect the interests of the Government including its officers and employees against any, all proceedings, actions and third party claims for any loss, damages, expenses of whatever kind arising out of the Registration process. The Dealer shall fully indemnify and defend the Government including its officers and employees from and against any and all losses and damages arising out of or with respect to failure of the Dealer to comply with applicable Laws, Rules and Regulations.

22. This system shall not apply for registration of vehicles purchased through CSD, imported vehicles and for vehicles purchased outside the UT of Jammu and Kashmir but being registered in the J&K, in which case they shall continue to be registered at the level of the Registering Authority.

Lebanon, Iran to sue **US** over harassment of airliner in Syria

Beruit: Lebanese Health Minister Hamad Hasan says Beirut is going to lodge a complaint at international institutions and organizations after two US fighter jets harassed a Lebanon-bound Iranian civilian aircraft over Syria's airspace, and caused injuries among the passengers.

On Saturday, Hasan denounced the incident as a "criminal intimidation" and a shameful act for Americans, stating that Lebanon will soon announce its official position over the matter.

He noted that his ministry, on behalf of the passengers of Mahan Air's Flight 1152, will sue Washington over mental and physical threats posed to

passengers. The Iranian aircraft had taken off from the capital Tehran and was en route to the Lebanese capital Beirut when US warplanes conducted aggressive maneuvers and came dangerously close to the plane over

'While the earth is facing coronavirus (COVID-19) pandemic, the sky is suffering from an evil disease to which we must respond firmly," Hasan commented.

Separately, Yemen's popular Houthi Ansarullah movement censured the US military's harassment of the Iranian plane as "a blatant violation of international air navigation treaties and a terrorist act by the United States and its collaborator Israel."

'The US arrogance and its stubborn persistence of violating Syria's sovereignty are an aggressive approach and a barbaric behavior from a criminal establishment, which tramples on all international regulations," the media bureau of Ansarullah said in a statement released on Saturday.

It stressed that resistance remains the strongest and most effective option in the face of arrogant powers, and will force them to respect the rights of world nations and not to infringe upon their rights and the sovereignty of their homelands.

Israel strikes Syrian army positions in retaliatory attack, says army

Jerusalem: The Israeli military on Friday said its helicopters struck Syrian army targets in response to mortars fired toward the Israeli-occupied Golan Heights.

"A number of targets were struck, including SAF observation posts and intelligence collection systems located in SAF bases," the military said in a statement, referring to the Syrian Armed Forces.


Syria's state news agency SANA quoted a military source as saying Israeli helicopters targeted three outposts in Syria's southern Quneitra area with anti-tank guided missiles, causing two injuries and some forest fires.

The strike came a few hours after the Israeli military said blasts were heard from the Syrianheld area of the Golan Heights. No casualties were reported but a building and an Israeli vehicle were damaged, it said.

LONDON: Global equities took a beating Friday as China-US tensions intensified, while stalled stimulus talks in Washington fuelled fears for the economy, traders said.

Lingering worries about the impact on businesses of fresh coronavirus outbreaks helped trigger major profittaking, overshadowing a batch of bright data in Europe.

"It's a sour end to the trading week," said AJ Bell investment director Russ Mould. The Dow was down nearly 140 points approaching midday in New York, 'adding to yesterday's declines in morning action as friction between the US and China heated up overnight", said Charles Schwab analysts

European indices were up to two percent lower at the close.

Earlier in Asia, Shanghai and Hong Kong had already dived as relations between the world's two superpowers took

The standoff is the latest in a string of issues - including Hong Kong, coronavirus and Huawei — that have plunged relations between the superpowers into crisis. 

Anti-CAA Riots: Sharjeel Imam Charged With Sedition

New Delhi: The Delhi Police on Saturday charged former JNU student Sharjeel Imam with sedition before a court here for allegedly inciting people to indulge in activities detrimental to the sovereignty and integrity of the country.

The police made the allegations in its charge sheet filed before the court in a case related to anti-CAA riots earlier this year.

The agency filed the final report under various sections including 124-A (Sedition), 153(A) (Promoting with the Northeast. He also enmity), 153-A (promoting ferent communities) 153-B means of protest" it said (Assertion prejudicial to national integration) and 505 (spreading rumors) of IPC and under the sections of stringent Unlawful Activities (Prevention) Act.

"He is accused of delivering seditious speeches and inciting a particular section of community to indulge in unlawful activities, detrimental to sovereignty and integrity of the nation," the charge sheet said.

"In the garb of protesting against the Citizenship Amendment Act, he exhorted people of a particular community to block the highways leading to the major cities and resort to 'Chakka Jam', thereby disrupting normal life," it said.

It further alleged that Iman openly defied the Constitution and called it a "fas-



cist" document.

The court is likely to take up the matter for hearing on July 27.

Govt Notifies New Rules For E-Commerce Entities

The government has notified new rules for e-commerce companies, including mandatory display of 'country of origin' on their products, and said any non-compliance will attract penal action.

The 'Consumer Protection (E-Commerce) Rules, 2020' were notified on Thursday. The new rules will be applicable to all electronic retailers (etailers) registered in India or abroad but offering goods and services to Indian consumers. The violation of the rules will

attract penal action under the Consumer Protection Act, 2019. According to the new rules, the e-commerce players will have to display the total price of goods and services offered for sale along with a break-up

of other charges.



They are also required to mention the 'expiry date' of goods offered for sale and the 'country of origin' of goods and services that are necessary for enabling the consumer to make an informed decision at

the pre-purchase stage. Under the rules, e-commerce players have to display details about return, refund, antee, delivery and shipment, and any other information that may be required by consumers to make informed decisions.

Sellers offering goods and services through a marketplace e-commerce entity will have to provide the above details to the ecommerce entity to be displayed on its platform or website.

Under the new rules, ecommerce entities should not

impose "cancellation charges" on consumers cancelling orders after confirmation unless sellers are ready to pay similar charges in case cancellation of orders are from their side.

They are also not allowed to "manipulate the price" of the goods and services offered on their platforms to gain unreasonable profit and discriminate between consumers of the same class or make any arbitrary classification of consumers affecting their rights under the Act.

Further, e-commerce entities will have to provide information on available payment methods, the security of those payment methods, any fees or charges payable by users, and the contact information, among other details, of the relevant payment service provider.
