PakBreached Truce Along LoC: Army

Srinagar: Pakistani troops violated ceasefire along the Line of Control (LoC) in Kupwara district of Jammu and Kashmir by resorting to unprovoked firing towards Indian positions on Tuesday, an Army official said. There have been no reports of any casualties so far. "Pakistan initiated an unprovoked ceasefire violation (CFV) along the LoC in Macchil and Gugaldara sectors in Kupwara in the afternoon hours by firing mortars and other weapons," the official said. A befitting response was given to the Pakistani aggression, he said.

Tipper Crushes Biker In Baramulla

Srinagar: A motorcyclist was knocked to death by a speedy tipper in Palhallan area of north Kashmir's Baramulla district. 30-year-old Muhammad Yousf Najar of Bagh-e-Islam locality of main town Baramulla was killed after his bike (JK05E-2435) was hit by a tipper bearing registration number JK01R-6355 at Palhalan area of Pattan area. Meanwhile, police have registered a case under relevant sections of law and started further investigations in this regard. Police have also seized the tipper after the accident.(KNO)

Covid-19 'One Big Wave', Not Seasonal: WHO

GENEVA: A World Health Organisation official on Tuesday described the COVID-19 pandemic as "one big wave" and warned against complacency in the northern hemisphere summer since the infection does not share influenza's tendency to follow seasons.

WHO officials have been at pains to avoid describing a resurgence of COVID-19 cases like those in Hong Kong as "waves" as this suggests the virus is behaving in ways beyond human control, when in fact concerted action can slow its spread.

Margaret Harris repeated that message in a virtual briefing in Geneva. "We are in the first wave. It's going to be one big wave. It's going to go up and down a bit. The best thing is to flatten it and turn it into just something lapping at your feet," she said.

Pointing to high case numbers at the height of the U.S. summer, she urged vigilance in applying measures and warned against mass gatherings.

"People are still thinking about seasons. What we all need to get our heads around is this is a new virus and...this one is behaving

differently," she said. "Summer is a problem. This virus likes all weather.'

ECI Pulls Up LG Murmu Over J&K Poll Remarks

NEW DELHI- The Election Commission on Tuesday took "exception" to the reported remarks of Jammu and Kashmir Lt Governor G C Murmu on timing of polls in the union territory, and said in the constitutional scheme of things, only the EC is authorised to decide on the poll schedule.

Taking note of a media report which quoted Murmu on the delimitation exercise in I&K and holding of polls, the EC in a statement said it "takes exception to such statements and would like to state that in the Constitutional scheme of things, the timings etc. of elections is the sole remit of Election Commission of India."

The Commission also referred to similar statements of the LG reported by various media outlets in November last year and June this year.

"It would be proper for authorities other than the Election Commission to refrain from making such statements which virtually tantamount to interfering with the Constitutional mandate of the Commission," the statement said.

The poll panel said before deciding the timing, it takes into consideration all the relevant factors, including topography, weather,

sensitivities arising out of regional and local festivities in the areas where the election is to take place.

"For example, in the current times, COVID-19 has introduced a new dynamic, which has to be, and shall be taken into consideration at the due time. In the instant case, the outcome of delimitation is also germane to the decision," the statement said.

Availability of central forces and railway coaches for their trans-

portation are important factors, it pointed out.

"All this is done after meticulous homework by the senior officials of the Commission and a detailed assessment in due consultation with concerned authorities." it said.

The Commission itself schedules a visit to the concerned state wherever required and holds extensive consultations with all the stakeholders, the statement noted. >> PAGE 02

Will Verify J&K LG, Madhav's Statements On 4G. Govt Tells SC

NEW DELHI- The Centre on Tuesday told the Supreme Court that it will verify reported statements made by the Lt Governor of Jammu and Kashmir and BJP leader Ram Madhav that 4G Internet service can be restored in the Union Territory, and sought time to file a reply to the rejoinder affidavit filed by an NGO.

A bench of justices N V Ramana, R Subhash Reddy and B R Gavai adjourned the hearing for August 7, on a contempt plea filed by an NGO Foundation for

Media Professionals.

High speed Internet service in J-K has been suspended since August last year when the Centre had announced revocation of its special status and bifurcation of the state into two UTs — Ladakh and Jammu and Kashmir.

The apex court was hearing a plea of the NGO seeking initiation of contempt proceedings against the Union Home Secretary and Chief Secretary of J-K for their alleged "wilful disobedience" in complying with the court's May 11 order.

Militant Trying To Sneak Into J&K Killed

IAMMU: An unidentified militant on Tuesday was killed while trying to sneak into Jammu and Kashmir through Line of Control (LoC) in Rajouri district, officials said Tuesday.

According to official sources, the security forces noticed the movement of a group of five militants on the other side of the fence in Samhani Bagsar area in Naushera sector of the district. The movement of militants, they said was well intercepted before they could have managed to reach LoC and were engaged.

Amid engagement of militants, official sources said an explosion took place in the area after one of the infiltrators stepped over a land mine or an Improvised Explosive Device (IED) and died on the spot

The Serological Surveillance for SARS-CoV2 infection was jointly commissioned by NITI Aayog, the BMC and the Tata Institute of Fundamental Research (TIFR). A serological survey involves testing of blood serum of individuals to check for the prevalence of antibodasymptomatic COVID-19 infecies against an infection.

The study found high proportion of asymptomatic COVID-19 infection in the city.

The civic authorities claimed the sero surveillance result indicates that "asymptomatic infections are likely to be a high proportion of all infections".

"He was admitted in isolation ward of GMC Hospital Jammu on July 21," a senior doctor at GMC Jammu said, adding, "He was a known case of Potts Spine (Spinal tuberculosis) and was on ATT for the last 10 months. Besides he was also suffering from jaundice and had Rt sided thigh and Gluteal Abcess."

The doctor said that the youth was put on oxygen on July 27 and died 5.30 a.m, today. The youth's death was the first fatality due to the virus in Ramban district.

The Kupwara deaths include a 72-year-old Tengchak Lolab, a 70-year-old from Batpora and a middle aged man from Maratgam, who was working in Revenue department.

Regarding 72-year-old, they said, he was brought to Kupwara for medical checkup where doctors advised him for CO-VID-19 test. "On July 23 he died naturally at his home as he was a hypertensive and Leprosy patient. His report came positive today," a senior health office functionary said.

Regarding the septuagenarian, the official said, he died at Wayan heath centre and his test came positive for the virus while the revenue official was admitted in Handwara hospital on July 22 and was referred to Srinagar where he died later.

Meanwhile, a 60-year-old man from Nagbalkhag Budgam, who was admitted to SKIMS Soura on July 23, as a case of "hypertension, chronic obstructive pulmonary disease (COPD), bilateral Community Acquired Pneumonia died at 8:15 a.m., a senior doctor at the tertiary care hospital said.

Besides it, a 59-year-old man from DH Pora Kulgam and a 75-year-old man from Noorbagh Sopore and a 70-year-old man from Pattan with "bilateral pneumonia" also died of Covid-19 on Tuesday

assembly and parliamentary constituencies in the country. According to the section 60 of the J&K Reorganisation Act, ...the number of seats in the Legislative Assembly of Union territory of I&K shall be increased from 107 to 114...

Out of these, 24 seats are in Pakistan-controlled-Kashmir. So effectively, the seats will go up from 83 to 90, Chief Election Commissioner Sunil Arora had explained recently while responding to queries on the delimitation process in I&K.

Will Verify J&K LG, Madhav's general Tushar Mehta, appearing for the J-K administration,

said that it has received a lengthy rejoinder from the petitioner on the counter affidavit filed by the Centre, which said that 4G Internet curbs have been reviewed by the special committee. He said that some time be given to reply to the rejoinder affidavit filed by the petitioner.

Senior advocate Huzefa Ahmadi, appearing for the petitioner NGO did not oppose the submission of Mehta, and said that the request is reasonable as the rejoinder was served on Monday

According to him, the Lieutenant Governor of Jammu and Kashmir had recently made a statement that 4G Internet service in the valley can be restored and similar statement was also made by BJP leader Madhav.

Ahmadi said that he requests that these statements be also

Attorney General K K Venugopal, appearing for the Centre, told the bench that the said statements need to be verified.

The bench said then it will list the matter on August 5. Mehta intervened, and said, that it would be better to have the hearing on another date as August 5 is the date of imposition of Internet curbs.

The bench accepted the request of the Solicitor General and changed the date of hearing to August 7.

On July 16, the Centre and J-K administration had told the top court that a special committee has been set up as per the court's directive to consider the issue of restoration of 4G Internet services in the Union Territory.

Venugopal, while claiming that incidents of terrorism are on the rise there, had told the court that no contempt was made out against the authorities as they have complied with the directives of the apex court.

On May 11 the ton court had ordered setting up of a "special committee" headed by the Union Home Secretary to consider pleas for restoration of 4G internet services in J-K, saying national security and human rights need to be balanced in view

of the fact that the UT has been "plagued with militancy". The contempt plea filed by the NGO has alleged that authorities concerned have not yet constituted the special committee in line with the top court's order.

It has also urged the apex court to summon the Union Home Secretary and Chief Secretary of UT of Jammu and Kashmir to explain their position with respect to the alleged non-compliance of the court's directions.

The plea said that the Jammu and Kashmir administration had on May 27 passed an order continuing the restriction on mobile Internet speeds to 2G in all districts throughout the UT without any restriction by time or region.

Besides the contempt plea, the petitioner has also filed an application seeking directions to the authorities to notify the constitution of the special committee within three working

The application has sought an interim direction to the authority to restore 4G mobile internet services in Jammu and Kashmir, pending disposal of the plea and also the decision by the special committee. The court had earlier taken note of the submissions of the

Centre that continuous infiltration, foreign influence, violent extremism and issues of national integrity are prevalent in J-K. The apex court's May 11 order had come on the pleas filed by the Foundation for Media Professionals and others seeking restoration of 4G services in the UT.

While on Mount Arafat, where the Prophet Muhammad

(PBUH) delivered his final sermon nearly 1,400 years ago and where pilgrims will spend Thursday in deep prayer and repentance, pilgrims will be wearing high-tech ID cards that connect to an application on their phones.

The card and app allows the government to easily monitor the pilgrims, and gives them a way to reach out to their group leader and make special meal requests.

The card stores the pilgrims' personal information, health status, residence and other Haj-related details. In the future, Al-Maddah said the cards will be fitted with a location tracker to follow individual pilgrims' movements. The tracker will be managed by a control room, and can be used as a pay card in

Pilgrims have also been given special attire to wear during the Haj laced with silver nano technology that helps kill bacteria and makes clothes water-resistant.

Al-Maddah said the measure is a precaution, even if it can affect almost nothing or has a minimal chance of improving health conditions. It's all part of the special treatment pilgrims are receiving

this year. Other perks such as meals, hotel accommodation, transportation and healthcare is paid for by the Saudi government. Typically, the Haj can cost thousands of dollars for pilgrims who save for a lifetime for the journey. This year marks the first time in nearly a century of Saudi

rule over Makkah that people from outside the kingdom will not take part in the five-day Haj, which is a once in a lifetime requirement of Muslims. Âl-Maddah, who sits on the Haj planning committee, said

allowing people to enter Saudi Arabia from abroad would have posed a global health risk. Two thirds of pilgrims this year are foreigners already resid-

ing in Saudi Arabia from among the 160 different nationalities that would have normally been represented at the Haj. The other one third are Saudi security personnel and medical staff. All pilgrims had to be between the ages of 20 and 50 with no terminal illnesses and showing no symptoms of the coro-

Each year, the Haj poses a massive logistical challenge for Saudi authorities. As recently as 2015, a stampede killed more than 2,400 people.

Crowd control measures require the use of thousands of cameras and security officers to coordinate the movements of the more than 2.5 million people densely packed into narrow streets, walkways and paths.

Facial recognition technology and other high-tech security systems have to be advanced enough to decipher between pilgrims, dressed in nearly identical terry white cloth garments.

"For us, safety comes first," Al-Maddah said. "We are employing technology to make sure that these services and these precautions are met and delivered in the highest standard.

"This is highly irresponsible and needs to be probed. The body should have been kept in GMC mortuary till COVID-19 test results would have come," he said.

Srinagar: Doctors Association Kashmir (DAK) on Tuesday urged concerned authorities in Kashmir Valley to make life-saving drug Tocilizumab available for critically-ill COVID-19 patients.

"The drug reduces the risk of death in seriously ill Covid-19 patients," said DAK President and influenza expert Dr Nisar ul Hassan in a statement.

Quoting a study from the University of Michigan, he said COVID-19 patients on ventilators who received a single dose of Tocilizumab injection were 45 percent less likely to die compared to those who did not receive the drug.

"Originally developed to treat rheumatoid arthritis, the drug combats the disease by quelling cytokine storm which is the hyperimmune response of the infected person to the virus," Dr Nisar said.

"Mortality in Covid-19 patients has been linked to the presence of the cytokine storm induced by the virus," he said adding that "excessive production of cytokines leads to respiratory failure and widespread



tissue damage resulting in multiorgan failure and death."

Dr Nisar said Tocilizumab suppresses the hyperimmune response by blocking receptor for a key cytokine known as interleukin-6 (IL-6) and improves survival rates and reduces mortality among CO-VID patients.

"Recently Indian Counof Medical Research (ICMR) in its revised protocol has allowed usage of the drug for patients with progressively increasing oxygen requirements and in mechanically ventilated patients not improving despite the use of steroids," he said.

Dr Nisar said it is vitally important to know that there is no single magic bullet to treat the novel Coronavirus and several drugs in combination are needed to tackle the virus. "With the approval of several therapies, combination of them given at the right time gives a good result," he said.

"Apart from oxygen, moderate to severe patients are given steroids, remdesivir, convalescent plasma and Tocilizumab in various combinations," he added.

"Initially it was believed that deaths were happening because of poor oxygenation. Now we know that intravascular clotting can also lead to lung dysfunction and death. So heparin is given in Covid patients to prevent clotting,' said Dr Nisar-

Srinagar - Death and devastation on a large scale was averted today when the police recovered 100 kilograms of RDX from a stolen Maruti car near Magam in the Baramulla district. The driver of the car was apprehended while two other occupants managed to escape.

"The RDX was concealed in a trunk and was fitted with two live grenades fixed to detonators/' Inspector General of Po-lice, Kashmir, Javed Mukhdoomi, said at a hurriedly-called press conference this evening. A wireless Set was also found along with the explosives.

Police immediately called the bomb disposal squad who neutralised the explosive material.

"There is a possibility that the car was being driven to Srinagar for a bombing," he said, adding that a major tragedy had been averted.

The recovery was made during routine checking near Magam when a blue Maruti 800 Was stopped by line police at around 6 PM Tuesday evening. The three occupants of the car made a break for it, but one of them, the driver, identified as Zahoor Ahmad of Hanjiwera, Pattan, was caught at Mazhama on the Srinagar-Magam road after the police gave chase, the IGP said.

The car (original registration number JKE 6394) was fitted with a false number plate (DL3C 8177). It had been stolen a few days ago from Aripathan, and an FIR stands lodged in the Beeru police station, the IGP said. The interrogation of the driver was going on.

'Seizure a major breakthrough'

The Centre today described the seizure of an explosive-laden car and the arrest of its driver on Srinagar1 Gulmarg Highway a major breakthrough in the investigations into a spate of bomb blasts in the recent past. These huge dumps of waste now referred to as Legacy Waste is to be scientifically treated as per National Green Tribunal guidelines. 4G hope

t long last, the J&K administration has told the Centre that it has no objection to restoring 4G internet services, as high-speed internet will not be a security concern. In a recent interview to a national daily, the Lieutenant Governor GC Murmu said that his government was no longer afraid of high-speed internet. "Pakistan will do its propaganda, whether it is 2G or 4G. It will always be there...but I don't see an issue," the LG is quoted to have said. This is a welcome change of heart. One can look now forward to restoration of the 4G in the near future, hopefully around Eid-ul-Azha.

The past year has played out like a horror story on many counts. Soon after the Article 370 was annulled on August 5 last year, the government placed Kashmir under a security blockade and communication blackout. It was only after a month that the least used landline phones were restored followed by re-opening of the post-paid mobile phones without texts after two and a half month. It took the government more than six months to restore internet, that too a severely curbed 2G connection with access to only a few hundred government chosen white-listed websites. This was made possible only after the Supreme Court declared the indefinite internet gag in Kashmir as impermissible and illegal. The court, however, didn't order the government to end the gag but only asked it to review it on a weekly basis. So, the government only eased the internet ban, didn't end it.

Government later gave selective access to fixed line internet to major government departments and businesses after they signed an undertaking that the service will not be 'misused'. It was only sometime later that the government allowed an unrestricted access to the broadband.

Drawn internet gag and social media ban all but halted the informal collective conversation that gives vent to and shapes up public opinion. In a severely regulated information environment, government was able to control what people know and what they don't. It also evacuated the everyday life of the play of the conventional mainstream and separatist discourses and temporarily pushed them out of collective memory.

At the same time, the lockdown and prolonged internet gag wrecked the local Kashmir economy, including IT companies and start-ups. The children couldn't study online as the 2G speed wasn't sufficient enough to access video lessons. The people in J&K would thus welcome the restoration of high-speed mobile internet. This would go a long way to normalize the life in the union territory following a year-long disruption.

Co-operate on vaccine

S. officials said this month that Russian hackers are attempting to steal coronavirus vaccine research. This past week, the Justice Department indicted two Chinese hackers for doing the same thing. Both attacks are condemnable acts of global aggression in a time when cooperation is essential. But this country bears the onus of cooperating, too.

Policy experts have suggested that the type of espionage in these cases isn't against any established cybersecurity rules of the road — which points to a need to establish new rules. The problem with that approach is that few of the primary players appear interested. The Chinese hackers charged on Tuesday have reportedly undertaken a years-long effort to snatch trade secrets, sometimes on their own behalf and sometimes on behalf of the state, flying in the face of the pact that government signed with the United States five years ago. President Trump, for his part, has unilaterally expanded intelligence agencies' mandate to include practices such as embarrassing hack-and-dumps that this nation has in the past condemned.

This insistence on escalation rather than cooperation is also what makes the vaccine snooping as insidious as it is unsurprising. The immediate harm of an adversary speeding the development of a lifesaving medicine amid a pandemic is admittedly unclear. But it is possible to imagine China exploiting that medicine as a domestic moneymaker, or as leverage over developing countries to whom it will play the munificent benefactor. This points to the larger problem: There are appropriate avenues for every nation to purchase vaccine candidates. There are also appropriate avenues for ensuring that when a vaccine comes, it comes to the whole world regardless of who develops it or who has the ability to pay. Yet the default approach for China and for Russia wasn't to pursue any of those avenues but, rather, to resort to criminality.


The United States would have an easier time sitting astride the moral high horse if it were contributing to vaccine-sharing efforts itself. Yet just as the White House has been uneager to work on building cyber-operational norms with friends or with foes, it has sent the signal that it will pursue an "America First" approach to wiping out the disease. Rather than joining in initiatives to bolster global vaccine availability, it has announced its withdrawal from the World Health Organization and purchased nearly all available stocks of the key antiviral drug remdesivir.

The United States and China in particular have been playing a coronavirus blame game over the past few months. The reality is that every country will benefit from every other country having access to a vaccine. They should be figuring out how to share the wealth, not how to steal it.

UAE's Mars Mission: Al Amal for Muslims

he Emirates Mars Mission, the first interplanetary exploration undertaken by any Arab nation, lifted off successfully on an H-IIA rocket from Tanegashima, Japan, on 17 July 2020 and is on its way to Mars planet, where it will arrive at in February 2021, it will spend two years orbiting the red planet gathering crucial science data. The mission will also be marked as the Arab world's initial foray in space sciences and exploration.

The mission IS being carried out by the Mohammed bin Rashid Space Centre (MBRSC) in the UAE in collaboration with a number of global research institutions.

Mission Al Amal

The orbiter, named 'Hope' meaning Al Amal in Arabic, carries three science instruments and will provide a unique view of the lower and middle atmosphere of the planet. The data collected will help scientists to understand the connections within and between the upper and lower atmospheres and how those connections helped to drive atmospheric escape, and Mars' evolution from a warm, cyclically wet world in the ancient past to the cold, dry planet we see today. Unique to Hope is its orbit, which enables near-complete daily and geographic coverage, providing a weather-satellite style view of all layers of the Martian atmosphere from the surface on up to space.

This mission will give scientists greater insight into how our own planet may have evolved, as well as enable greatly improved weather forecasting to help support the future human missions to Mars. Importantly, Hope addresses several key goals of the Mars Exploration Program Analysis Group (representing the consensus of the international Mars community) in regard to both science and human exploration.

Al Amal Team

The spacecraft, which is about the size of a small car, was constructed at Laboratory for Atmospheric and Space Physics (LASP) at the University of Colorado Boulder, US by a joint MBRSC/LASP team led by Project Director Omran Sharaf from MBRSC and deputy program manager and science lead investigator Her Excellency Sarah Al Amiri. Approximately 450 engineers and technicians worked on

the Hope probe for six years. The 734.5 million Emirati dirham (\$200 million) spacecraft, weighing in at 1,350 kilograms, is set to reach Mars on a date to coincide with the Gulf country's 50th anniversary.

The mission also shattered many other myths and societal norms. Apart from Sarah al-Amiri, about 34% of the mission's scientists and 80% of its science team are women, significantly higher than the 28% represented in the Emirati workforce.

While talking to international media outlets, Sarah revealed being 'mesmerised by space' due to its largeness and complexities and drove her to exploration. "The mission is called 'hope' because we are contributing to the global understanding of a planet," she said. "We are going above and beyond the turmoil that is now defining our region and becoming positive contributors to science. For the benefit of human understanding." Another key woman scientist at the mission is Fatma Hussain Lootah, supervisor of the team's instrument science portion.

The mission's name, Hope, was chosen to send a message of optimism to millions of young Arabs, according to Sheikh Mohammed bin Rashid Al Maktoum, the Ruler of the Emirate of Dubai for whom MBRSC is named.

Al Amal for Muslims

The Al Amal mission has also sent a very strong message to Muslims across the world. That is to embrace education in a more focused manner and garner the lost prestige of Muslims in various sciences by embracing learning and the spirit of innovation. In The Muslim 500, a list of influential Muslims around the world, scientists and technocrats who have worked in varied sectors like Digital Signature and Cryptography to DNA Repair occupy a large percentage. Also, when we speak of the past, then we can't ignore Muslim scientists like Al Razi, Al Zahrawi, Ibn Sina and Geber. aka Abu Musa Jabir ibn Hayyan, who all contributed to various fields like chemistry, pharmacy, philosophy, astronomy, geography, cartography, medicine & surgery and physics.

In fact many of the people named in The Muslims 500 have passed out from the sciences, medical and engineering departments of the AMU and JMI. But when we consider the real percentage of these scientists and technocrats with world numbers, they are insignificant compared to the Muslim population in India and across the globe, both.

So what are we missing? We need to introspect deeply. First, the number of our young people going in for higher studies is increasing but not up to the desirable level, for this we need to initiate a community-level education programme at every tehsil and village level, to motivate parents to send their wards to schools. Secondly, a large percentage of our youngsters are getting employed in IT sector, so we need to push a little bit further and motivate and guide them towards research and development.

But to achieve this we first need to handhold, motivate and guide our youngsters. For this an all-India interactive programme could be initiated in partnership of various academic institutions and religious figures, wherein we should try to present these achievers as role models to our youngsters. At these interactions many young minds could be presented with a roadmap for their future and guided on how to achieve the results by the achievers. For this we'll also have to impress upon the achievers to become the guiding beacon for our youngsters and thus to repay back something to the community. Our academic institutions besides religious and social leaders could take the lead in this regard.

In fact the time has come for the entire Muslim world to introspect and get awakened and revisit five centuries, from 750 to 1258 AD – which is often described as the Golden Age of Islamic sciences – to be influenced and motivated by our past achievements to reinvent Islam's image of peace, human values and service to humanity through Quranic injunctions and Prophet Muhammad's (PBUH) sayings (Hadiths).

'Rajiv Gandhi Paid a Price For Believing In Farooq Abdullah, Modi Won't'

MID the growing chorus for Statehood in Jammu and Kashmir, National Conference top leaders—Farooq Abdullah and his son Omar Abdullah—have finally ended their political silence and jumped on the bandwagon. But the timing of their talk has once again made people read some old pattern and fuelled speculations about "secret goings-on".

Back in Eighties when New Delhi had faced a similar leadership crisis in J&K, Rajiv Gandhi government had approached his "buddy" for filling the political void in the valley.

"Rajiv was sure he could trust Farooq to end the impasse in Kashmir, and integrate the state into the Indian polity," writes Ashwini Bhatnagar, a seasoned scribe, in his recent book, 'The Lotus Years: Political Life In The Times Of Rajiv Gandhi'.

Published by Hachette, the book offers a "360-degree view" of politics in India during the time of Rajiv Gandhi.

"Farooq's persuasive ways convinced Rajiv that he was the go-getter that Kashmir so desperately needed," the author writes.

In November 1986, after months of hectic parleys mediated by Rajesh Pilot, Rajiv and Farooq signed an accord that reinstated the latter as chief minister and proposed a roadmap for "stabilizing" the state.

"Even as a caretaker coalition government was being cobbled together, silent dissent was brewing in both the Congress and the National Conference," Bhatnagar writes. "Sections in both parties were apprehensive about the secret goings-on."

In an exclusive interview with Kashmir Observer, writer Ashwini Bhatnagar talks about New Delhi's Kashmir management, his Kashmir reporting days and why Farooq can't be Modi's man in Kashmir.

Do you think Delhi has no hope other than Abdullahs in Kashmir?


The hope lies with the people of Kashmir. The time for 'self determination' (in a different context) of their future as full, equal, prosperous citizens of a democratic, secular republic is now; and it has to come through new leadership.

But do you see Modi engaging with Abdullahs in the coming future?

It depends on a lot of factors. But as of today, I don't think Modi will engage with the Abdullahs in any substantive way. History conclusively proves it is counter-productive to engage with them. Rajiv paid a price for believing in Farooq. I'm sure Modi has learnt the lesson well. Moreover, he's much more politically-savvy than Rajiv ever was.

You've written about the Rajiv-Farooq Accord in your recent book. How did it come about and what went

Without doubt, Rajiv was a man of peace. From the moment he took over, he purposefully worked



towards quieting dissonance in various parts of India – the Punjab Accord, Assam Accord, Mizo Accord, etc were his handiwork. He was committed to the bigger national picture of unity and harmony even at the expense of his party's political interest.

The Kashmir Accord was an earnest effort on his part to give Farooq Abdullah a fair chance to address the grievances of the people of J&K. Farooq, however, failed to deliver on his promises and used the opportunity to play footsie with interests inimical to India.

Farooq could have led from the front to secure the rights of his people. That he did not became the trigger point for militant to start calling the shots. From there on it went from being bad to worse and festered for another three decades. And mind you, it is not yet over despite the new formulations at work today.

How was the relationship between Srinagar and Delhi back then?

The relationship was always tenuous. It will continue to be so in the foreseeable future too. There is no escape from it. Even if every political person in the Kashmir Valley wants to turn over a new leaf, Pakistan will not allow it. Actually, since 1980, Kashmir has been on a road which goes nowhere.

If you dispassionately look at it, Delhi has gone out of its way to accommodate Kashmiri aspirations. Funds too have been poured into the former state for development purposes.

But the politicians there have always had the single agenda of stoking religious sentiments, either themselves or through militancy, to keep their coffore flowing.

Back in those tumultuous days, how did you see Mufti Mohammad Sayeed's role in Kashmir politics?

It was reckless. Running with the hare and hunting with the hounds sort of a thing. I have always felt Mufti Mohammad Sayeed thought himself to be clever – it turned out he was too clever by half.

How was your reporting experience in Kashmir then?

Well, I started to actively report on Kashmir shortly after the exodus of Kashmiri Pandits began in the late 80s. There was no political activity as such then, only violence. Perhaps, absence of po-

litical activity was in itself politics of sorts.

In fact, Kashmir politicians, since the early 1980s, were either silent spectators or indirect collaborators to the certain forces in the Valley. It suited their purpose because they could leverage the situation to their advantage, both in Srinagar and in Delhi. It was a myopic but an expedient view which afflicted the National Conference and the Congress leaders in the state in equal measure.

Both Farooq Abdullah and Mufti Mohammad Sayeed rode the tiger, sure it was a horse, and they could command it. But, by the time they realized their misjudgment, it was too late. The tiger was riding them. Farooq panicked during the 1987 elections when it seemed that Muslim United Front had become a runaway hit with the masses. He rigged the elections and was confronted with a bigger mess.

Similarly, in 1989, when Mufti was Home Minister in VP Singh's government at the Centre, his daughter was kidnapped by the very people he had helped to raise. Farooq and Mufti had now become hapless purveyors of the shift from their leverage politics to diktats of AK-47s.

How was Kashmir story different for your journalism career?

I have covered militancy in Punjab, Assam, Nagaland and Mizoram too besides Kashmir. Frankly, the tragedy and futility of it remains the same everywhere. It is always about gain for a select few and a massive loss to people at large. The young, the innocent get killed and tortured. Never the kin of the leaders. It's the peoples' lives that is destroyed. They live through shootings, curfews and police searches while the leaders travel for holidays abroad when the going gets rough at home. Every human story is in fact an inhuman story of political perversion. We, as people, have to escape it by forging our own models which serve societal rather than political interests.

How do you see New Delhi's new policy and action plan in Kashmir, especially post-abrogation of Article 370?

Article 370 had become some sort of a totem pole around which a grotesque, ritualistic political dance was being performed now and then. It drew the people to it since it seemed sanctified in some way – may be because it had been happening for so long that it had acquired its own legitimacy. The Centre has uprooted this totem pole. I suppose it was done as part of the strategy to demystify assumed realities in Kashmir politics.

I think the Centre is moving cautiously but surely towards dismantling the scaffold that supported the key players during their bull run. Bifurcation of J&K is another definite step in this direction. Let's wait and see what eventually happens in the long run. But one thing is sure for now — it will not be business as usual in Kashmir Valley. The fiefdoms will wither away and hopefully die providing space to alternate leadership.

hen Mehmed II prayed in the Hagia Sophia after the conquest of Constantinople on 29 May 1453, it signalled a turning point in the power balance in Anatolia in favour of a young new force, the Muslim Turks, who had emerged from Central Asia.

Five centuries later, on 1 February 1935, when Kemal Ataturk declared the Hagia Sophia a museum, it was another turning point, announcing the age of Kemalism - of top-down, forced westernisation and secularisation.

The Hagia Sophia's enormous, precious prayer carpet was torn to pieces. Its school annex, the first Ottoman university, was demolished. The gigantic candles that lit its prayer halls were chopped off and melted. Its small Beyazit II minaret was destroyed and the rest of its minarets were due to follow suit, had it not turned out that they supported the domes, which would then have collapsed, bringing the whole edifice down.

The project of Kemalism

The conversion was a resounding declaration of the project of Kemalism, which placed the elimination of Turkey's religious heritage at the forefront. The replacement of the Ottoman Arabic script with the Latin alphabet, the ban on the call to prayer in the original Arabic, prohibition of traditional Islamic dress, and closure of hundreds of mosques, schools, shrines and religious endowments, were other manifestations of this radical project.

The Turks saw Ataturk as a great liberator, a national hero who had confronted British and French forces as they occupied Anatolia - so much so that he was known as "Gazi Kemal", or Conqueror; a new Mehmed II, no less.

The message was clear and unequivocal: there will be no tolerance of religious expression in whatever shape or form - not even simple, mundane rituals and practices

Ataturk proceeded to use the legitimacy acquired from his role in the national liberation struggle to launch a virulent campaign against the country's Ottoman legacy, in favour of a state-imposed modernisation and military secularisation, which revolved around his cult of personality.

When three decades later, elected Prime Minister, Adnan Menderes, though neither religious nor an Islamist, sought to reign in this ferocious assault on society's culture and identity, for instance, by reinstating the call to prayer (Adhan) in Arabic, which had been raised exclusively in Turkish for 18 years, he was toppled by a brutal military coup, imprisoned and taken to the gallows on 17 September 1961.

The message was clear and unequivocal: there will be no tolerance of religious expression in whatever shape or form - not even simple, mundane rituals and practices.

Charting a different path

Much water has flown under Istanbul's bridges since then. Secularism's sacred military guards found themselves face to face with a movement of Islamisation, which sprung from the depths of Turkish society, from mosques and shrines, schools and universities.

In the 1970s and '80s, this vast, fast-growing grassroots movement came to assume a soft political character, which grew increasingly vocal. The young Recep Tayyip Erdogan had himself been part of this rising movement before he was elected mayor of a decaying Istanbul and began to chart a different path from that of his teacher, Necmettin Erbakan.

Erdogan's recent decision to return the Hagia Sophia to its former status as a place of worship has, in fact, little to do with a conflict between Islam and Christianity, or church and mosque. It forms part of the journey that has been unfolding in Turkey over the last four decades: a rejection of military secularisation and forced, top-down westernisation.

Erdogan has been seeking to renew his country's links with its past Ottoman Islamic history, and to reclaim its symbols and legitimacy, at the heart of which lies the Hagia Sophia.

Sifting through Erdogan's public statements and discourses since before he was Istanbul's mayor, one cannot fail to note the frequent references to the Hagia Sophia. Though he often expressed reluctance to change the status of the iconic monument, fearing that the moment was not right, references to Hagia Sophia can be found in his discourse since before he was Istanbul mayor.

His imprisonment in 1999 followed a public speech in which he had passionately quoted the famous verses of nationalist Turkish poet Ziya Gokalp: "The minarets are our spears, the domes our helmets, mosques our barracks, the faithful our soldiers."

Reclaiming the Ottoman past
Just as declaring the Hagia Sophia a museum
symbolised a rupture with Turkey's Ottoman past
and an affirmation of the rise of western secularisation, its reinstatement as a mosque signifies a reclaiming of the country's past. Erdogan describes it
as a return to our forefathers; a return to the past
as a launching pad to the future, to a new Turkey
reconciled with its Ottoman past.

It comes as a conflict of legitimacy rages around the region among different heavyweights. In Saudi Arabia, the de facto ruler, Crown Prince Mohammed bin Salman, has been moving from a state-imposed Wahhabism to an aggressive model of state-imposed westernisation, in sharp contrast with the country's status as the custodian of Mecca and Medina.

In Egypt next door, al-Azhar, once a powerful centre of Sunni Islam, has lost all influence and credibility. Its sheiks are now seen as little more than officials appointed by military intelligence to legitimise President Abdel Fattah el-Sisi's policies.

The virulent hostility towards political Islam shared by the two countries (along with the UAE) has driven them to antagonism towards Islam itself.

Turkey, meanwhile, has been going in the opposite direction: affirming its credentials as a leader of Sunni Islam and investing in its symbolic capital as the heir to the Ottoman Empire.

An inspiring model

Though the reinstatement of the Hagia Sophia as a mosque is a domestic Turkish affair, it has resonated throughout the Muslim world. Erdogan has been hailed by his supporters as a powerful Muslim leader - the antidote to weak Arab kings and presidents who are seen as complicit in much Muslim suffering, turning their backs on Palestine, Islam and all that is sacred to their people, in order to preserve their corrupt, despotic reigns.

After the Hagia Sophia decision, many Muslims commented that those outraged by the move had been undisturbed by the annexation of mosques big and small, by the conversion of mosques into cathedrals, or by the destruction and seizure of hundreds of other Islamic monuments in Spain, the Balkans, Palestine, Italy, India, Russia, or other parts of the world. In their eyes, this was just another embodiment of western hypocrisy and double standards.

For all the attacks against him in western and Arab media, Erdogan seems to have won the legitimacy contest.

Heart Inflammation Observed In Recently Recovered Covid-19 Patients: Study

n analysis of 100 patients who recently recovered from novel coronavirus infection has revealed that nearly 80 per cent of them have cardiac manifestations of the disease, a finding which indicates the need for further research to understand the long-term consequent es of COVID-19.

The study, published in the Journal of the American Medical Association, assessed 100 patients who recently recovered from COVID-19 illness from Germany's University Hospital Frankfurt between April and June 2020.

According to the researchers, including those from the hospital, cardiac involvement was observed in 78 patients, and ongoing heart inflammation in 60 individuals.

They said the reported symptoms were independent of preexisting conditions, severity and overall course of the acute illness, and time from the original diagnosis.

In the study, the scientists assessed recent recovery from the novel coronavirus SARS-CoV-2 infection as determined by RT-PCR assays which check for the 33 required hospitalisation. presence of the virus from swab tests of patients' upper respira- the scientists said the mol-

Ji Rong, a spokesperson for the Indian Embassy in New Delhi, said on Monday that India was an emerging economy and adhered to strategic independence and should thus resist hegemony together with China and other nations.

Iran Targets Dummy US Aircraft Carrier In Gulf Exercises

Tehran: Iran's Revolutionary Guards blasted a mock-up of a US aircraft carrier with missiles on Tuesday during military exercises in sensitive Gulf waters, state television said.

The exercises -- dubbed 'Prophet Mohammed 14th" were held near the Strait of Hormuz, a vital shipping lane for a fifth of global oil output.

They were staged at a time of heightened tensions between Iran and its decades-old arch enemy the United States.

Footage of the war games broadcast on state television showed the Guards' air and naval forces readying for an attack off the country's south-

Speedboats skimmed across the water in formation before ground forces fired cannons and a missile was launched from a helicopter. The mock-up of a Nimitz-

class aircraft carrier came into view with rows of dummy fighter jets on either side of its landing strip. The television then cut to

rockets being fired out to sea from the backs of trucks, before showing damage to the hull of the mock-up aircraft carrier.

Another missile fired from a helicopter left a trail of smoke before appearing to smash into the side of the fake warship. Armed forces were then seen rappelling onto the deck of the vessel, before around a dozen speedboats circle around it.

"What was shown today

in these exercises, at the level of aerospace and naval forces. was all offensive," Guards commander Major General Hossein

Salami told state television. The war games come only days after Tehran accused US fighter jets of harassing an Iranian commercial airliner in the skies over Syria.

At least four passengers on board the Mahan Air plane were injured in Thursday's incident, after the pilot took emergency action to avoid the warplanes. Tensions have escalated between Iran and the United States since US President Donald Trump unilaterally withdrew from a landmark nuclear deal in 2018.

The arch foes have come to the brink of war twice since June 2019, when the Guards shot




down a US drone in the Gulf.

Their animosity deepened after Iran's most prominent general, Qasem Soleimani, was killed in a US drone strike near Baghdad airport in January.

One of the most recent confrontations was in mid-April, when the United States accused the Guards of using speedboats to harass its warships in the Gulf.

Flipkart said its hyperlocal service, dubbed Flipkart Quick, will also sell mobile phones and stationery items, taking it a step further than existing quick-delivery services which mainly offer just groceries.

Flipkart Quick will debut in select locations in Bengaluru, the company said, without specifying a launch date.

The new service puts Flipkart more directly in competition with Amazon and Alibaba-backed BigBasket, both of which offer quick deliveries of groceries. Bengaluru-based Flipkart will also go up against delivery grocery

JioMart, backed by Asia's richest man, Mukesh Ambani. Google-backed Dunzo and

Naspers-backed Swiggy also offer grocery deliveries in India, and the service could be lucrative for companies during the COVID-19 pandemic, which is making more Indians order essential items such as groceries online.

"Halfway through the year of the pandemic, supply chains have transformed drastically,' Flipkart said in a statement. 'The hyperlocal category, known for being a convenience for many, has now emerged to be a long-term essential service for the country."

Israel PM Netanyahu's son apologises after his tweet offends Hindus



sraeli Prime Minister Benjamin Netanyahu's eldest son Yair has apologised to Hindus after he faced flak from some Indians who found one of his tweets to be "quite offensive".

On Sunday, the 29-yearold Yair, who is very active on social media and often defends his father's policies, posted a picture of the Hindu

goddess Durga, with the face of Liat Ben Ari, the prosecutor in his father's corruption cases, superimposed over the goddess' face.

Her many arms were also raised giving the middle finger. "I've tweeted a meme from a satirical page, criticising political figures in Israel. I didn't realise the meme also portrayed an image connected to the majestic Hindu faith. As soon as I realised it from comments of our Indian friends, I have removed the tweet. I apologise," Yair said Attorney General Avichai

Mandelbit's face was superimposed over that of a tiger accompanying the goddess under a caption that said, "know your place you despicable people"

The Twitter users were split in their reaction over the post with some Indians harshly criticising him for the offensive tweet while others giving him the benefit of doubt and attributing it to general ignorance about the Hindu faith in the West.
