### Lt Governor GC **Murmu Resigns**



SRINAGAR: Jammu and Kashmir Lieutenant Governor Girish Chandra Murmu on Wednesday tendered his resignation after nine months as the head of administration of the Union Territory. However there was no official word on the development till late on Wednesday.

According to sources, he could be the next Comptroller and Auditor General of India after Rajesh Mehrishi retires this week.

While reports said Murmu has sent his resignation to Presdent Ram Nath Kovind, there was no confirmation whether it has been accepted or rejected.

# **Another August 5 & People In Kashmir Remain Locked Indoors**

SRINAGAR- Curfew-like restrictions remained enforced across Kashmir on Wednesday, the first anniversary of revocation of semi-autonomous status of Iammu and Kashmir.

"Police and CRPF personnel were deployed in strength all across the Valley, especially Srinagar city and major towns, to keep a lid on any form of protests, even as no one had called for them

The officials said police vehicles, fitted with public address system, went around localities soon after day break announcing imposition of strict restrictions for combating COVID-19 spread.

"There is a ban on assembly of more than three persons and people are requested not to violate the law and stay indoors," the police said.

Barricades have been set up at hundreds of places in the valley including Srinagar city to regulate movement of essential services and emergencies, while concertina wires have been laid to block some parts of the roads, the officials said.

Authorities in Srinagar had on Monday announced that curfew will be imposed in Srinagar city "in view of inputs about violent protests endangering public life and property as the separatist and Pakistan-sponsored groups were planning to observe 5 August as a Black Day.'

# **Wait Of Centuries Has Ended: Modi**



**AYODHYA-** The wait of centuries has ended, Prime Minister Narendra Modi said after performing the groundbreaking ceremony here for a temple at the spot where many devout Hindus believe Lord Ram was born.

Across the country, people remained glued to their television sets as Modi performed rituals at the Ram Janmabhoomi, the site of a bitter Hindu-Muslim conflict that lasted decades before being settled by the Supreme Court last year.

Beginning his speech with Jai Siya Ram , the prime minister told the gathering that a grand temple will now be built for Ram Lalla, the infant Ram, who had been living in a temporary tent for years.

Many people made sacrifices for the Ram temple. I pay my respects to all of them, the prime minister said in the speech that followed the laying of

# CRPF Man, 10 More Die Of Covid-19 In J&K

**SRINAGAR:** A Paramilitary CRPF man and ten others on Wednesday died of Covid-19 in Jammu and Kashmir, raising the number of fatalities in the Union Territory to 428 since the pandemic breakout, officials said.

Among them, three deaths were reported from Srinagar, two each from Anantnag and Budgam including a CRPF trooper besides one each from Bandipora, Kupwara, Baramulla and Jammu di-

vision's Udhampur district. With these deaths, the toll due to the virus in Kashmir stands

Official sources said 43-year-old woman from Ramnagar Udhampur died

at ASCOMS (Batra) hospital. "She was a cancer patient and tested positive for the novel coronavirus subsequently." Regarding the CRPF trooper,

they said, he belonged to 176 battalion. He had tested covid-19 negative on July 25 but his X-ray showed bilateral lower pneumonia. He was shifted first to morning at CD hospital, one of BSF hospital and later to SKIMS Soura where his Covid-19 test was found positive.

# 25,000 Non-Local **Workers Return To I&K**

SRINAGAR: A total of 25,000 non-Kashmiri migrant workers, out of the 40,000, who had left Jammu and Kashmir after the coronavirus outbreak, have returned to the Union Territory for work, a top official said on Wednesday.

A total of 3.2 lakh people, including the migrant workers, arrived in Jammu and Kashmir from outside since the nationwide lockdown came into effect on March 25, and all of them were subjected to COVID-19 tests. "A total of 25,000 non-Kashmiri

migrant workers, who had gone to their respective states after the coronavirus outbreak, have returned

to Jammu and Kashmir," Divisional Commissioner (Kashmir) Pandurang Kondbarao Pole told PTI here.

As estimated, 40,000 non-Kashmiri migrant workers were engaged in different works in the Union Territory prior to the CO-VID-19 pandemic.

After Prime Minister Narendra Modi announced the nationwide lockdown for the first time, migrant workers staying in different parts of the country became desperate to leave for their native places. Due to the non-availability of

transportation at that time, many of them had started returning home on foot, creating a humanitarian crisis. Later, the central government

Murmu was appointed as the first L-G of Jammu and Kashmir last October after the formation of the new Union Territory under the Jammu and Kashmir Reorganisation Act, 2019. His resignation came on the day the ruling BJP commemorated the first anniversary of the abrogation of Article 370 of the Constitution, which scrapped Jammu and Kashmir's special status and divided it into two Union Territories. Earlier on Wednesday, Army commander of Northern Command had called on Murmu and discussed the overall security management of the Union Territory.

Murmu is a 1985 batch Indian Administrative Service officer of the Gujarat cadre. He also served as the principal secretary to PM Narendra Modi during his tenure as the chief minister of Gujarat.

The human rights body also asked government to decongest prisons and launch a prompt and independent investigation into the attacks on journalists in Jammu & Kashmir, a statement issued by AI said today. "Over the last one year the Government of India has been systematically dismantling all avenues for justice for the people of Jammu and Kashmir. With zero representation, protracted internet restrictions, arbitrary use of some of India's most stringent laws, verbal orders of detention and crippling of the local media - most of this disproportionately higher in Kashmir - it's been a complete year since we have heard the people of Jammu and Kashmir speak," said Avinash Kumar, Executive Director, Amnesty International India. On 5 August 2019, the Government of India unilaterally revoked Article 370 of the Indian Constitution which guaranteed special autonomy to Jammu & Kashmir and bifurcated the state into two separate union territories, bringing the region under the direct control of the central government.

"All these amendments and changes were made amidst a complete communication clampdown, restrictions on movement and mass detentions in the region," Amnesty statement said. The rights body further said that it acknowledges that the Government of India may have legitimate security concerns which may merit reasonable restrictions on the right to freedom of expression in certain circumstances. "But these restrictions must always be limited in duration and demonstrably proportionate as set out under Article 19 of the International Covenant on Civil and Political Rights (ICCPR), to which India is a state party," the Amnesty handout read.

"However, in an absolute violation of India's international obligations, the entire population of Kashmir has been deprived of their right to freedom of expression and opinion through protracted communication restrictions since the last one year. This has been compounded by a censored media, continuing detention of political leaders, arbitrary restrictions due to the pandemic with little to no redressal," it added. The International rights body also accused government of restricting flow of information from the region through use of repressive laws such as the Jammu & Kashmir Public Safety Act (PSA) and Unlawful Activities (Prevention) Act (UAPA)

"Amnesty International India documented physical attacks on, harassment and intimidation of at least 18 journalists since 5 August 2019. The draconian media policy introduced by the government in the region which openly aims to create "a sustained narrative on the functioning of the government in media" by checking on "anti-national activities, fake news and plagiarism" has further extinguished independent media in the region," the Amnesty statement said. It further added that after gathering information from various digital and print media, Amnesty International India has found that at least 70 political leaders - cutting across a wide political spectrum - were placed under administrative detention.

"While most of those arrested have been subsequently released, many continue to be in detention on the basis of verbal orders or repressive laws such as the PSA. This is in complete violation of their fair trial rights guaranteed by the ICCPR and Indian Constitution," the handout read. "Their release, made possible through signing of bonds that restrict them from indulging in any political activity including making political speeches, is also as problematic as their detentions. Under international law, political speech cannot be prohibited unless it constitutes a direct threat to public order, which has not been adequately demonstrated by the Indian government in the orders accessed by Amnesty International India," it added.

The rights watchdog also alleged that the government policies during the COVID-19 pandemic have further marginalised the people of Jammu & Kashmir and severely affected their access to justice. Between 2016 and 2019, Amnesty International said, it has a found that more than 300 habeas corpus petitions were filed against unlawful detentions before the Srinagar wing of the J&K High Court.

"However, as on 4 August 2020, only 11 habeas corpus petitions have been filed. This sharp fall may be attributed to the punitive emergency measures invoked by the government to curb the CO-VID-19 pandemic but also the lack of hi-speed internet required for uninterrupted online hearings," the Amnesty statement said.

It also expressed concern over the closure of the State Human Rights Commission along with six other commissions, including the State Commission for Protection of Women and Child Rights, saying the move has further left the people of Jammu & Kashmir with absolutely no redressal for their human rights violations. "The Government's ruthless attempts to create a public opinion of 'normalcy' while curbing the freedom of independent press, imprisoning the entire political leadership, arbitrarily arresting those likely to dissent and imposing communication restrictions have usurped the voice of the region," Executive Director, Amnesty International India. He demanded restoration of 4G mobile internet, end of criminal investigations against journalists under PSA and UAPA and withdrawal of the new media policy, immediate and unconditionally release all persons, including political leaders, allegedly deprived of their freedom solely for the peaceful enjoyment of their rights to freedom of expression, association, peaceful assembly, belief or equality and non-discrimination as they should not have been detained in the first place. "A rights-respecting government must know that an end to the abuses in Jammu & Kashmir cannot come without the involvement of its people," Kumar added.

"Drastic controls on information, obstructing the dissemination of articles and videos, intimidation by the security forces in the field, every kind of judicial harassment and violation of the confidentiality of sources - the list of press freedom violations by the Indian authorities in Kashmir is unworthy of a democracy. If Narendra Modi's government maintains these policies, it will go down in history as the one that deprived 8 million citizens of reliable news and information in mid-pandemic,"

Bastard said that on the first anniversary of revocation of J&K's special status, RSF has examined the current state of press freedom in this northern territory with the help of its journalists.

"In the light of their alarming accounts, RSF calls on the Indian government to immediately change its policy or go down in history as a regime that deprived the region's 8 million inhabitants of reliable news and information at the height of a pandemic," he said.

The head of RSF's Asia-Pacific desk also said that the streets of Srinagar, the Kashmiri capital, were completely deserted this morning and

that the only human presence were the paramilitaries who are occupying the city and patrolling all of Jammu and Kashmir. "For Kashmir's citizens, this is a sad reminder of what happened a year ago, on 5 August 2019, when it became one of the world's biggest news and information black holes, with all forms of communication - Internet, mobile data, TV and fixed-line telephone - suddenly suspended. The Kashmir Valley, from which foreign reporters had already been barred for several months, was cut off from the world. As RSF pointed out in February, New Delhi has succeeded in imposing the longest e-curfew in history," the RSF said. The International journalists' body also cited example of south Kashmir journalist Qazi Shibli of the prevailing situation in the Valley in which journalists were being harassed.

"The police confirmed yesterday that he is being held in Srinagar prison but gave no reason for his arrest. He was released in April after being detained provisionally for nine months for nothing more than a tweet," the RSF statement said. "Aside from this kind of police harassment, Kashmir's journalists are subjected to far more pernicious curbs on their freedom, starting with the suspension of high-speed mobile Internet," it added. The RSF quoted several journalists working in Kashmir complaining about harassment by government forces, and difficulties in performing professional duties in absence of high speed internet. "There have been incidents in which reporters and photojournalists were roughed up by cops although they were just doing their jobs as journalists," Srinagar-based freelancer Syed Ali Safvi told RSF. "Harassing reporters by summoning them to police stations poses a serious threat to the free flow of information."

Safwat Zargar, who reports for the Scroll.in news portal, told RSF that the very idea that journalists have to go to a government facility to use the Internet at a time when people around the world are working from home and practicing physical distancing is "just terrible." "This Internet ban not only jeopardizes the lives of these journalists but also puts their families at risk," he said. "And the absurdity is that the government wants us journalists to be thankful that they created this centre."

"It is observed that practices implemented over the last year -- since the abolishment of the article [370] of the Indian constitution that granted special status to Jammu and Kashmir -- have further complicated the situation in Jammu and Kashmir and not served to peace and stability in the region," said Hami Aksoy in a statement. Aksoy further reiterated Turkey's call for dialogue to resolve the issue under the UN charters and resolutions. On Aug. 5 last year, the Indian government scrapped the special status of Jammu and Kashmir and split the state into two Union Territories. The move was followed by a communication blockade and a harsh crackdown during which thousands of people, including three former Chief Ministers were detained.

Devotees started arriving there around 6 am, just after the morning puja ended, temple's administrator Kishor Chawla said. "A puja has been going on non-stop for three days. The 'Ram darbar' has been decorated. A replica of the 'shila' (foundation stone) has been prepared and it will be sent to Avodhya along with other material." he said. President Ram Nath Kovind said the foundationlaying ceremony defines India's spirit of harmony.

Being built in tune with law, it defines India's spirit of social harmony and people's zeal. It will be a testimony to ideals of RamRajya and a symbol of modern India," he tweeted. trains for the transportation of the migrant workers. Jammu and Kashmir has carried out COVID-19 tests of these 3.2 lakh people, including the migrant workers, who have returned to the UT. Of these, 29.963 had arrived at the Jammu airport till August 4 and 48.680 in Srinagar airport. A total of 41,680 arrived at the railway station in Jammu while the rest came by road. "Jammu and Kashmir is the only state which is carrying out COVID-19 test under the real-time polymerase chain reaction (RT-PCR) method," spokesperson of the lammu and Kashmir government Rohit Kansal said.

"We are doing the highest testing and our mortality is lowest," he said. Jammu and Kashmir has so far done a total of 6.63 lakh testing. Testing for per million people is 50,853. The mortality rate in the Union Territory is 1.9 per cent. In Jammu and Kashmir, so far 22,396 people have tested positive for COVID-19 of which 14,856 have recovered. A total of 417 patients have succumbed to the deadly virus in the UT.

### We Want People To Become...

He said three-tier panchayati raj institutions -- district chairpersons, block chairpersons and village-level panch and sarpanch -- have the potential to create a "new political power-cum-governance structure". It will be an alternative model of governance and development and bring peace in Jammu and Kashmir. "It gives people a sense of belonging. The people in local areas becomes their own 'bhagyavidhaata'," he said. They will keep a tab on governance, administration and development, and bridge the gap between the government and the people, he said. Elections to panchayati raj institutions are not held regularly and thousands of vacancies remain to be filled. Since assuming office, Lieutenant Governor Murmu has taken a host of measures to strengthen the panchayati raj system. On August 4, Murmu approved the creation of Block Development Fund of Rs 25 lakh which will be at the disposal of block development council chairpersons.

The administration last week announced a life insurance cover of Rs 25 lakh each to all elected members of panchayati raj institutions and urban local bodies of the union territory in case of death due to a militancy-related incident. The decision is aimed at strengthening the grassroots democracy by providing a sense of security to the elected members of local bodies who are under constant threat from militants. In this regard, the government on December 19 last year accorded sanction for paying Rs 15,000 per month emoluments to chairpersons of Block Development Councils. The BDC chairpersons will get Rs 13,000 honorarium, Rs 1,500 travel allowance and Rs 500 per month as telephone, mobile usage charges. The government also increased the monthly honorarium of sarpanch from Rs 2,500 to Rs 3,000 per month.

Last month, the administration amended rules to give block development council chairpersons a status equivalent to that of an Army brigadier. According to the warrant of precedence issued by the Hospitality and Protocol Department of Jammu and Kashmir, BDC chairpersons have been placed at serial number 28. They are placed alongside district magistrates, district and sessions judge, major heads of departments, presidents of municipal committees and municipal councils and officers of the rank of brigadier.

**Article 370: A Year On, Mess...** they failed to contain the resistance in Kashmir. But we can't say they've been forsaken forever. Probably, there was dispute on degree of collaboration. New Delhi wants absolute collaboration in Kashmir." Hussain argues that GoI has used the regional parties whenever it needs them, and the local unionists were always willing to be used. "Centre's stance towards Kashmiri politicians has changed now," the professor said. "They either want them to work on their terms and conditions, or simply render them useless.

### 'We all feel betrayed'

Peoples Democratic Party (PDP)'s Waheed Para agrees with the arguments of Hussain, saying that New Delhi has erased its 70 years of investment in Kashmir. "We're also trying to understand now what has been our role since decades," Parra told Kashmir Observer. "We all feel betrayed and think who we are, and where is our space." Since last one year, the PDP youth president says, BJP has achieved nothing in J&K, and has only pushed people to the wall.

### 'Delhi Can't Erase History'

However, NC spokesman, Imran Nabi Dar, believes that the mainstream politics is trying its bit despite facing hounding and detentions. "Detention is the part of politics," Dar told Kashmir Observer. "And that doesn't mean parties have no future in J&K. We're fighting for restoration of special status. New Delhi can't erase history.'

### 'All Politics Is Local'

Prominent political analyst, Prof. Siddiq Wahid, believes that New Delhi can't rule directly on J&K without local politicians. "BJP feels it can afford to be arrogant because of the lack of any real challenge to the majoritarian politics that they have introduced in India," Prof. Wahid told Kashmir Observer. "But, as the saving goes, 'all politics is local'; so domination is not as easy as Delhi thinks if they go against this logic." However, the former vice chancellor of IUST doesn't see bright future for local politicians, unless they're able to be the "definers" of politics in Kashmir.

### 'Mainstream wiped out'

Senior Srinagar-based scribe, Rashid Maqbool, asserts the so-called mainstream politics has been completely wiped out in a single move post 5 August "by the power which has created it over 70 years". "But now," Maqbool told Kashmir Observer, "New Delhi is desperate to restart political process in I&K, just like it was in 1995, when it brought back Dr. Faroog Abdullah. But now see the fate of the man!"

Maqbool feels that GoI might be fed up with its old allies and wants to create a new breed of "yes men" in Kashmir.

### 'End of Soft Separatism'

Senior journalist Riyaz Malik echoes the views of his colleague, Rashid Maqbool. "Be it NC's Autonomy or PDP's Self Rule, everything was smashed down by 5 August decision," Malik, who edits the prominent Urdu daily published from Srinagar, told Kashmir Observer. Malik says the "soft separatism" politics has run its course in the valley now.

"Revocation of special status was an actual loss for local political parties and its revival is the only reason they can be relevant again," he says. "Local parties can't do politics in Kashmir without special status." **Shaky Ground** 

### Even as some unionist leaders have broken their silence recently, their party foot-soldiers don't seem much keen after pass-

ing through a harrowing time since last summer. 'Lip service apart, Kashmir's mainstream politics is in deep mess due to Delhi's aggression," Hassan, the NC man from Downtown Srinagar, says.

"Unless government of India restores pre-August 5 position in J&K, nobody is going to take us seriously on ground."

The Kushok Bakula Rimpochee Airport, operated by the Airports Authority of India (AAI), is the 64th civil airport to be brought under the cover of the CISF. Norbu handed over a ceremonial key of the airport to CISF Deputy Commandant and chief airport security officer Sanket Gaikwar, the officer said. DG Ranjan, the CISF officer said, "emphasised that coordinated efforts are to be made by all government agencies and stakeholders to ensure security of the Leh airport.'

Ranjan also asked his personnel to ensure "zero error" security at the facility. On Tuesday, he had inaugurated barracks for the CISF personnel who will be posted to guard the facility and he reviewed other operational systems of the airport. Air India, Vistara, GoAir and SpiceJet operate commercial passenger flights between Leh and Delhi. Commercial operations began at this "tourist intensive" airport in 1978.

A new passenger terminal is being built here at a cost of Rs 480 crore and is expected to be completed by September next year.

The CISF contingent will provide 24x7 armed cover to the facility and will check passengers while approaching the facility, at the terminal gates followed by comprehensive checks and body frisking ahead of boarding a flight.

# **Engineering Wings Reorganized For Quality, Cost Control in Projects**

- A dozen in-house engineering wings in various departments abolished; SIDCO, SICOP to stop work for others
- PWD. PHE. RDD and PDD to be the main construction deptts

SRINAGAR, AUGUST 05: In a decision with significant structural change in Engineering Wings of various departments and their working, the Administrative Council which met here today under the chairmanship of Lieutenant Governor, G C Murmu, sanctioned the merger/subsuming of in-house engineering wings in various departments/organizations like Tourism, School, Higher and Technical Education, Agriculture Production, Horticulture, Animal Husbandry & Fisheries, Floriculture, Hospitality & Protocol, Estates, DMRRR, Forest. Transport and SKIMS in PW(R&B) Department with effect from 1.12.2020.

The Administrative Council in its decision directed that the user departments whose engineering wings are being subsumed shall, however, retain the power of prioritization and identification of works and their administrative approvals.

Primarily, this decision will bring better quality, faster execution and lower costs in construction projects. The decision

is aimed at addressing issues being faced by various existing inhouse engineering wings which broadly include shifting of focus of departments from their core objective to construction activities, mushrooming of engineering wings, inconsistency in the estimation processes due to unrevised SoPs, absence of uniform standards & procedures and poor implementation.

The Administrative Council further directed constitution of a Committee of concerned Administrative Secretaries along with domain experts to work out modalities for merger/ repatriation/deputation of staff from the subsumed wings to PWD, Jal Shakti or PDD as the case may be. The Committee is required to submit its recommendation by 15.09.2020.

The Administrative Council also decided to constitute a Committee under the chairmanship of Administrative Secretary, Public Works to suggest restructuring of PWD (R&B) with additional units/wings/ verticals to cater to the needs of regional units and specialized wings. The Committee shall also examine the possibility of delineating the boundaries of the engineering divisions which will be co-terminus with the boundaries of districts.

Taking note of inconsistency in the existing norms/ procedures/SOPs governing the aspect of accord of administrative approvals, estimation,

tendering, work allotment and procurement of material, the Administrative Council has asked for constitution of a Committee under the chairmanship of Administrative Secretary, Planning, to suggest reforms in the existing norms/procedures/ SOPs and submit a draft SOP by

Further, the Administrative Council also decided that the mandate of specialized wings of SIDCO and SICOP shall be clearly delineated and these wings shall restrict their activities to their mandate.

Taking cognizance of HRM issues of engineering wings having been adversely impacted by issues of ad-hoc promotions, non-finalization of seniorities and outdated recruitment rules affecting career progression, the Administrative Council decided to constitute a Committee to revisit all HRM related issues concerning engineering departments. The Committee shall submit its report along with its recommendations by 15.10.2020.



# Yatris flee Pahalgam after massacre

AHALGAM: Hundreds of panic-stricken Hindu pilgrims were today fleeing this picturesque tourist resort, which has been converted into the base camp for the annual pilgrimage to the Amarnath cave up in the mountains.a day after suspected militants killed 33 devotees on their way to

Pahalgam witnessed the worst of a series of overnight massacres by suspected militants across the state which claimed a total of 100 lives, mostly Hindu civilians

Officials said two suspected militants swooped down from forests overlooking Pahalgam, some 100 km south of Srinagar. and shot dead 31 people. They

Were killed in the retaliatory fire by the security forces. The incident took place at a community kitchen (langar) on a road in the close vicinity of a security camp with an army camp just at a stone's throw. "I could hear gunmen firing at the tents for at least 10

minutes without interruption," said Sanjeev Parishar of New Delhi, who added that local Muslims had helped the wounded in Pahalgam to go to hospital.

Nissa Shah, a local Muslim shawl-vendor, said "I was doing brisk business when all of a sudden firing started from two points. At least a dozen people were hit by bullets and three died on the spot."

Ashok Kumar, a surviving pilgrim, was in a state, of shock. "The shooting started at around  $6.4/5~\mathrm{p.m.}$  I rushed towards my burs but a bullet hit me in the leg; "It is due to God that 1 am still alive," he said. Speaking of the attackers, Kumar said: "They were firing at will and they looked visibly relaxed."

Though the officials claimed the attackers to be foreign militants, police sources, on condition of anonymity, said the two persons were local youth from Anantnag, one of them a student of Aligarh Muslim University. The other youth was identified as Shabbir Ahmid Shah. One of rifles with a Lashker-e-Taiba sticker put on it, had been placed by the side of a 'slain youth.

Hundreds of pilgrim-packed cars, buses, trucks and jeeps were seen leaving this town, even as the sky was overcast. This is a valley of destruction," said Akash Chaad, a Chandi-Atma Ram, a Bihari pilgrim said he did not visit the Ama-

# **Ladakh administration** unveils transfer policy

Srinagar: Nearly nine months after re-organisation of the erstwhile state of Jammu & Kashmir, the administration of Ladakh has unveiled a policy for effecting transfers of employees in the Union Territory.

Under the new policy, the administration of Ladakh UT has delegated powers to Chief Executive Councillors of two Hill Councils for effecting transfers of 12502 district, divisional and district cadre pots.

Notwithstanding the delegation of powers, the UT administration can transfer officers/ officials of any cadre, level, department, in the interest of administration,

It also reserves the right to modify, cancel or put in abeyance any transfer order made by any authority, "in the interest of administration".

Under the policy, the respective CECs with the prior approval of their executive council have sole powers to effect transfers of officials holding 9182 identified district cadre posts.

The respective CECs can also effect transfers of officials holding 2193 divisional cadre level posts identified under the policy with the prior approval of their executive council.

However, inter -district transfers in respect of all divisional cadre posts can be made by the director/ divisional head of department, the policy

They will also be empowered to effect transfers at divisional level for other than 2193 posts identified in the policy.

According to the document the UT administration will have powers to make transfers of officials holding UT cadre

Under the policy, the CECs with prior approval of their ince, 21 have been recorded in executive council will have powers to effect transfers of officers holding identified 1127 posts of UT cadre

The directors and HODs have also been empowered to effect inter-district transfers in respect of level-8 to level-10A posts of UT cadre.

# 4-year integrated B.Ed degree to be minimum requirement for teaching

Srinagar: The Ministry of Human Resource Development (MHRD) has said that the minimum qualification for teaching will be a four-year integrated B.Ed. degree.

of COVID cases.

The MHRD has also stated that the National Curriculum Framework for Teacher Education (NCFTE) will be formulated by the NCTE in consultation with NCERT by 2030.

This was stated by MHRD in the recently approved National Education Policy (NEP).

As per the NEP-2020, the MHRD has stated that in the long term, the minimal degree requirement for all permanent tenured teachers will be the four-year integrated B.Ed. degree.

"However, to promote local knowledge and expertise, schools or school complexes will be permitted and indeed supported with suitable resources to hire local eminent persons or experts as specialized instructors in various subjects, such as traditional local arts, vocational crafts, entrepreneurship, agriculture, or any other subject where local expertise exists, and would bene t students and help preserve and promote local knowledge," it reads.

In the NEP, it was mentioned that by 2030, the minimum degree qualification for teaching will be a four-year liberal integrated B.Ed. degree that teaches a range of knowledge content and pedagogy, and

includes strong practicum training in the form of student teaching at local schools.

"The two-year B.Ed. will be intended only for those who have already obtained Bachelor's Degrees in other specialized subjects," it reads.

The MHRD in the NEP also said that these B.Ed. programmes may also be replaced by suitably adapted to one-year B.Ed. programmes for

those who have completed the equivalent of four-year multidisciplinary bachelor's degree or who have obtained a master's degree in a specialty and wish to become a subject teacher in that specialty.

"All such B.Ed. degrees would be offered only by accredited multidisciplinary higher educational institutions offering four-year integrated B.Ed. programmes," NEP reads.

# Way forward

he first anniversary of the revocation of Article 370 passed off without any incident. The Valley, however, woke up to severe restrictions despite the fact that the government had withdrawn its earlier order imposing the curfew in the region on the day. In a review on Tuesday, the administration had lifted the curfew but let Section 144 and Covid-19 restrictions remain in place. On ground though it made little difference to the situation. The curfew-like restrictions remained in force on the ground. This brings up the question why did the government withdraw the curfew order when it didn't mean it? Former J&K Chief Minister Mehbooba Mufti in a tweet termed the order to lift the curfew a "hogwash" a result of the government's preference not to "leave a paper trail" for

Be that as it may, the anniversary passed along the expected lines. Kashmir continued to be under a heavy lockdown. One thing that once again stood out is the absence of any political activity. The politicians were corralled in their homes. At the same time, no mainstream political party had announced any programme for the day. National Conference leader and the former J&K Chief Minister Omar Abdullah had in a recent interview said that they will observe the anniversary as a day of mourning in their homes. On the separatist side, former chairman of one of the two Hurriyat factions Syed Ali Shah Geelani had called for a complete strike on August 5. Similarly, the anniversary was observed as "Youm-i-Istehsal (Day of Exploitation)" in Pakistan. Incidentally, on the occasion Pakistan issued a new map that showed J&K as its part.

If anything, all these developments create an unsettling sense of uncertainty about Kashmir and the region as whole. One can't but feel deeply concerned about the direction of the situation. A year after the withdrawal of the Article 370, the people in Kashmir haven't come to terms with the drastically altered situation in the region. It has made regional situation also very fraught. More so, with China through its incursions in Ladakh also asserting itself as a party to the longstanding conflict over Kashmir. India, Pakistan relations have already plumbed new depths and it seems unlikely that the neighbours could back to any kind of engagement anytime soon. This has only increased the odds of a bigger conflict between the neighbours. Hence the urgent need to lower the temperatures by taking some confidence building measures. And to start with New Delhi can start a political outreach to Kashmir and later on reach out to Pakistan for a resumption of long stalled dialogue.

# Next, in the Valley

year after the BJP-led NDA government made Article 370 redundant, withdrew the special status of Jammu & Kashmir, and bifurcated the state into two Union territories, the fait accompli has seeped in. The Union territory of J&K may become a state again, but there will be no turning back the clock on Article 370. For the BJP, it was the fulfilment of a long-standing ideological promise to "integrate" the Muslim-majority state with the rest of the country. By all accounts, the move has been met with acquiescence, if not support, across the country - no national political party has prominently protested the Centre's move, nor any regional parties outside J&K. In the past year, there has been no visible outpouring of protest in J&K, no major militant strikes.

That does not mean, of course, that the seven-decade-old problem has been resolved or that the people have accepted the changes imposed on them. The reality is, they have not yet been allowed to express themselves through institutions of representation or governance. Indeed, what began as a departure from democratic norm — the NDA government decided on the state's future by cutting out the people, their political leaders and even the BJP's own allies — has played out over the year in the imprisonment of political leaders and hundreds of others, effectively erasing the degrees of difference between the mainstream and separatists and those in between. Curbs on the press, routinely calling journalists to the police station, deepen the distrust.

While many leaders have been released since, the detention of former chief minister Mehbooba Mufti under the Public Safety Act has just been extended by three months and many others continue to be in official and unofficial detention. The lockdown imposed on August 5 last year has segued into a second lockdown, induced by the COVID-19 pandemic. Even though 2G has been restored, the unavailability of high speed internet has made life and work difficult, for businessmen who need to communicate with partners outside the state, for those applying for jobs and college seats, to those trying to download information on the pandemic. Students, too, have suffered. There is an air of uncertainty. Militancy continues - local young men are easy recruits even as crossborder infiltration has come down.

Except for the decision to make new domicile rules in keeping with the abrogation of 35A that defined "permanent residents", and the delimitation exercise, the government has appeared unclear on a roadmap ahead


It should be clear to it that the continuing political vacuum in the Valley can only cause damage. There is a limit to how much, or how long, panchayats from a flawed election can be propped up in place of an elected Assembly. Though the Election Commission took exception to his comments, Lieutenant Governor G C Murmu was right in saying that elections could follow the completion of delimitation. The government must expedite the restoration of political processes in J&K. It must release Mehbooba Mufti and others who are still in detention. It must restore all freedoms guaranteed under the Constitution, including the right to free speech, which in this day and age, includes access to the Internet. Most importantly, it must set the stage for the people to elect their representatives.

# **Article 370 Abrogation And Pak Response**

**By taking** Kashmir to UNSC and ending up failing to get any support for its "principled stand" challenging abrogation of Article 370, hasn't Islamabad ended up reinforcing New Delhi's stand that Kashmir is a bilateral Indo-Pak issue and that UNSC or any other nation or organisation has no role to play in its resolution?



Another reason why secessionists didn't lose heart after abrogation of Article 370 was their belief in Pakistan's claim that it's stand on Kashmir was "principled" and thus, they were confident that when Islamabad brought India's "illegal actions" to the notice of United Nations Security Council (UNSC) and International Court of Justice (ICJ), both would direct New Delhi to withdraw its August 5 order. Pakistan Prime Minister Imran Khan also announced that he would travel the world as "Kashmir ka safir (Kashmir's ambassador) and promised to "forcefully present Kashmir issue like never before" at the UNGA annual meet in September. Unfortunately, while Islamabad's attempt to seek intervention of UNSC in this matter failed, its much-publicised plan to take up this issue to ICJ didn't even take off. As far as Khan's UNGA address is concerned, Islamabad and the Hurriyat may have lauded it as a 'big victory', but this claim is questionable as abrogation of Article 370 hasn't been

reversed. There was no public outcry in Kashmir when Article 370 was abrogated and Hurriyat leaders claim that they were unable to mobilise public opinion against the August 5, 2019 order since they were under detention. However, this explanation isn't very convincing because in the past, Hurriyat leaders have been able to organise massive protests even when they were caged. Thus, this strange behaviour does raise suspicions that their silence could be part of a secret deal with the center related to the ongoing National Investigation Agency



(NIA) investigation into their alleged hawala money transactions.

Militants were the only ones in Kashmir who were active after New Delhi abrogated Article 370. However, they started a new trend of targeting apple traders and migrant workers, which wasn't appreciated by the public and continued killing of locals on suspicion of being informers only added to public resentment. It also sent a negative message to the international community by linking the 'self-determination' movement with terrorism. United Jihad Council chief and Hizbul Mujahideen (HM) supremo Syed Salahuddin has always boasted of how militants are giving security forces a tough fight and keeps assuring us that the 'armed struggle' would achieve its aim of driving them out of Kashmir. However, just recently, while paying tributes to HM commander Riyaz Naikoo killed by security forces in an encounter, Salahuddin publicly confessed that "The enemy (Indian army) is in a strong position" in

Ever since Article 370 has been abrogated, all Islamabad has been able to do is to feed Kashmiris with hollow promises. While Prime Minister Khan announced observance 'Kashmir solidarity Day' on a weekly basis, Pakistan army chief General Qamar Bajwa promised that the army is prepared to go "to any extent" for the sake of Kashmiris. Unfortunately, while observing Kashmir solidarity day every week has achieved nothing. Gen Bajwa's assurance remains unfulfilled. And now, just a few days before the first anniversary of the abrogation of Articles 370 and 35A, Pakistan has 'presented' us with yet another catch-phrase of 'Yaum-i-Istehsal' (Day of Exploitation). However, by doing so hasn't Islamabad indirectly accepted that despite its "principled stand" on Kashmir, it hasn't been able to do anything to reverse abrogation of

Articles 370 by India?

In hindsight, it appears that Islamabad's response to New Delhi's abrogation of Articles 370 was ill-planned and thus proved ineffective. It's immediate reaction of downgrading diplomatic relations and suspending bilateral trade with India were unwise moves as they made no difference to New Delhi. Next, it's evident that by end September last year, Khan had realised that Islamabad's inability to generate support against Article 370 abrogation and he openly admitted this by saying, "even if the rest of the world is not standing by Kashmiris, Pakistan is." However, rather than do something about this, Islamabad decided to take this issue to UNSC, which was another big blunder because with Pakistan Foreign Minister Shah Mehmood Qureshi telling Pakistanis "not to live in a fool's paradise" since UNSC members wouldn't be "waiting for you with garlands in their hands," it's evident that Islamabad also knew that nothing would come out of this issue at UNSC. By taking Kashmir to UNSC

and failing to get any support for its "principled stand" challenging abrogation of Article 370, hasn't Islamabad ended up reinforcing New Delhi's position that Kashmir is a bilateral Indo-Pak issue and that UNSC or any other nation or organisation has no role to play in its resolution? Lastly, Islamabad's decision not to approach ICJ in this matter has been interpreted by the international community as an indication that Islamabad had no legal basis to justify its opposition to the abrogation of Article 370. Thus, while Islamabad may have observed August 5 as 'Yaumi-Istehsal' for Kashmir with a special song for this occasion prepared by the military's media wing. # Women in Science, Engineering and Technology Businesses

he economic and developmentl significance of participation of women in entrepreneurial activities has attracted great policy interest. Young women are highly under-represented in Science, Engineering and Technology (SET) businesses both at the national and international levels. Women owned ventures tend to be concentrated in traditional sectors like retail and lifestyle and service sectors like professional services, hospitality etc. The technology field still remains colossally maledominated.

This prompts the question, why? This is primarily due to the effect of "specific identities" associated with both technology and entrepreneurship. An entrepreneur, particularly, a technologist, is often written and spoken about of as it were gender-neutral in general discourses, but are actually located and symbolically associated with the male universe. Technology Entrepreneurship represents a merging of two supposedly male-spheres. This means that in order to venture and function in this non-traditional field, women technopreneurs have to

Research also indicates that in Science, Engineering and Technology academia, cultural values, norms and beliefs by and large have persistently been and still continue to be hostile to females. Women encounter innumerable industry as well as organizational level resistance ranging from age and gender stereotyping to financial discrimination. Also, in addition to being highly competitive, the SET Sector is perceived to be intensely political.

Qualitative studies pertaining to women Technopreneurship indicate that as opposed to "glass ceilings' encountered in the corporate settings, women technopreneurs experience "labyrinth walls" (meaning broad multi-faceted resistance to women leadership) and "thorny floors" characterized by criticism, non-compliance and sabotage from opposite gender subordinates. Women in Science, Engineering and Technology business, demographically a minority, frequently experience and encounter the problematic perceptual tendencies associated with Tokenism, i.e., Visibility, Contrast and Assimilation.

In addition to this, working in the technopreneurial field can be very de-

manding as tech-jobs are many a times considered to be 'extreme' in terms of nature of the work, the physical effort required, long working hours and travel time which women cannot easily sustain since they are still chiefly responsible for managing the household, family and children (mounting work-life balance issues). The paucity of female role models, female mentors in SET is yet another deterrent. Career in SET is often rejected due to dearth of information, awareness and lack of role models who offer guidance and a realistic preview of what it means to venture into a male-dominated field.

Lastly, the broader conservative and biased society which continues to discourage women from pursuing Science, Engineering and Technology pursuits in a subtle manner by incessantly pressing women to conform to their feminine identities can also be faulted and blamed for disproportionate representation of women in the SET businesses.

These reasons can also be attributed to be substantially responsible for the 'leaky pipeline", that is, large number of women entering the sector by taking up jobs in SET and subsequently dropping out.

Nevertheless, many "intentionalist and headstrong" women have despite the odds ventured into the technopreneurial field and made inroads into heavily male-dominated fields such as in the manufacturing, agritech, construction industry. These women perceive the technopreneurial field to be highly merit-driven where establishing oneself as a plausible competitor is a must to gain acceptance and recognition.

A prerequisite to facilitate Women Technopreneurship and overcome these challenges and barriers is a renewed Entrepreneurship policy focus which provides support specific to Women Technology business, nongendered policy discourses and promotion of distinguished and successful female role models via various new technologies and platforms for they can act as a source of inspiration for the young, aspiring, potential women technopreneurs.

# August 5, 2019: 'When No News Came from Home'

on this day, last year, snapped communication channels tormented many Kashmiris studying, working outside the valley. A student from Srinagar studying journalism in Punjab narrates how the day became a timeline of trauma, nightmares and anxiety for Kashmiri students far from home.

NSIDE the confines of an acoustic foam-walled studio, I was sitting on a steel chair, heedlessly listening to a teacher's lecture on "Indian Media's bias towards BJP".

It was the blistering morning of August 5, 2019, and sitting next to me was a friend from Assam. He was enquiring about the sudden communication blackout and a new curfew imposed in the valley from the midnight of August 4.

These questions heightened my anxiety. The fretful state had first gripped me a week ago when advisories asking tourists to leave the valley suddenly fared online. Some in the tightlipped administration equated the leaked circulars with the "well-planned militant attack". The possible execution of some prominent Kashmiri captives in Delhi's Tihar Jail was also doing rounds. Additional reinforcement in one of the world's most militarised zones further fuelled speculations

Rumours, it seemed, were never so wild in Kashmir. The author like many Kashmiri students studying outside the valley kept checking his phone for some news from home

Even though students were strictly prohibited from using cellphones in class, I'd my eyes and fingers constantly swiping through the social media profiles just to read news update from my homeland. My dejected face had itself coerced the Punjabi teacher to allow me to use the cellphone.

But that day, Kashmir's vibrant virtual space was dead silent. News channels were only babbling over the 4th August's midnight video of police enforcing another uncertain curfew in Kashmir.

Elders back home say that since the notorious Jagmohan era, these uninvited curfews were continuously used by the establishment to punish Kashmiris whenever there was a rise of reason and rage in Vale.

But that day, since there were no specific protests scheduled, it created more panic in Kashmir. And when even landline phones were snapped, the entire region became an incommunicado village.

In that air-conditioned college room, I was constantly thinking of my family, friends, colleagues and my aunt battling stage-4 brain tumour. They were all snuffed out from the rest of the world, coercing them to live this new ordeal on their own.

Kashmir was turned into this acoustic foamwalled room from where the voices were barred to disseminate.

While scrolling down the broken display of my phone, my eyes were caught to the sudden pop-up, "Amit Shah was about to speak on Kashmir emergency in Parliament."

The tranquil class was flaring with these pop-ups, all hands trying to take out their phones from pockets. The eager teacher himself wanted to know the reason behind the ongoing Kashmir fuss that had caught an international eye. The lecture came to an end early that day.

The fate of Kashmir was written on the paper lying 825 kilometres away in the hands of Home Minister of India in New Delhi.

Within a few minutes from the start of Parliament's Live coverage, Shah started to read the provident speech from the white paper with colorful sticky notes.

As my palpitations gradually fluttered with sweat pouring down the right side of my face, Shah numbed every Kashmiri listening to him, "Article 370 was now a history"

istory". The reason behind sudden advisories, additional



troops, curfew, and communication clampdown became clear. The so-called terrorist attack was nothing but a diversion to introduce a new tactic of penalising Kashmiris.

While Kashmiri bodies were being tainted, many faces around me were exhilarated. But some foreign students were still perplexed on Shah's seemingly endless speech.

Anxiety, suffocation, longing and agony had already pushed me to the brink. I wanted to cry and share this ordeal with someone who was suffering from the same fate. But there was no Kashmiri except me in the class of 40.

I immediately absconded from the class where the majority celebrated this unilateral revocation of Article 370 and failed to understand this nightmare.

After walking for more than 15 minutes, I reached the roadside bistro where other Kashmiri friends had assembled with a despair face. Many sat on steel benches, some on tables, and others lost in their own agony. All yearned for their loved ones back in the valley. Like others, I had patently believed that Kashmir was once again turned into a land of mourning.

For days, I kept thinking about my family, the unfinished conversations, and goodbyes. They were all haunting me. "What if my Aunt was no more in this world? Had destiny prefixed a lonely burial for her," I wondered, while being surrounded by non-Kashmiris who were provokingly planning to buy land near Dal Lake.

Some international news organizations were suggesting that several Kashmiri civilians including juveniles as young as ten were arrested during the night raids and incarcerated for crimes they never committed. New Delhi's allies in Kashmir were also locked up, at secretive makeshift jails, making the valley a faceless territory

Amid all this, there was no information of my family living in the world's largest open-air prison. The nights were seemingly endless, the anxiety attack and horrific thoughts had already taken over my sleep. The valley was completely silent, with military siege in power. Kashmiris were forced on the abandoned path where Fundamental Rights had no value.

Far from their loved ones, Kashmiri students outside the valley were passing through an imaginable pain. Many were losing hope of their family members being alive, others breaking down in tears while seeing their family pictures, and the rest of us were psychologically traumatised from the daily incitement from non-Kashmiri students and bistro owners for their vicious sexist comments for Kashmiri girls.

In between, satellite numbers were shared on some official social media accounts back home. After finding the prescribed number for my area, I tried calling them a few hundred times, all in vain. The service seemed ironic. It was like faking sympathy after inflicting massive pain on a person.

But that didn't stop the patriotic media to add insult to our injury. They kept running headlines like "Kashmiris are celebrating this historic move" — when no news was coming from mountains we call home.

It was simply too much for the likes of me to take. Due to the communication clampdown back home, many of us were now running out of means. After left with just Rs 500 in my pocket, I abandoned the daily lectures for over a fortnight. The same was happening with other Kashmiri compatriots.

After a month of remaining oblivious about my family's whereabouts, I finally received a call from our family landline.

It was my sister, saying, "We're all alive", before the line went dead again.

eople don't look at the sky anymore, a problem that predates even the chin-down screen age. This is odd, when you consider that the sky is the largest single natural element in our lives.

Even within the concrete canyons of the city, there's plenty of sky to go around. Grab it, I say. It's mesmerising, it's beautiful, it's free.

If you take a few minutes to study the heavens, you will see some amazing things: eagles, vultures, a formation of geese. Contrails are like wet lines of paint, intersecting, shifting and diffusing. Clouds, in all their variation, will tell you the direction of the next weather front and hint at its ferocity.

I am amazed whenever I feel a slight breeze on the ground and look up to see a raging current aloft, the clouds pushed violently by strong rivers of air.

### Magical skies of the year

I'm thinking about the sky now because the next few weeks offer what I believe are the most dramatic, vivid and magical skies of the year. The truly thrilling times are around dawn and dusk, when you can get colours that are astonishing in themselves and mindboggling in their combinations.

A few years ago, I witnessed a sunrise over the Potomac River that was a calico of indigo, purple, violet and orange and of such mystical intensity that I half expected

to see Charlton Heston emerge in a winged chariot. For the gardener, the subdued nature of the land-



scape reinforces the aerial display, and, at special mo-

ments, the sky becomes a flower bed in the firmament.

Just as architects will orient a house to take in a view of the lake, the mountains or the ocean, the land-scape designer can play to the sky. It helps to have a viewing point, indoors or out, and to be mindful that the sun rises in the southeast and sets in the southwest.

### Sky on a plate

An open meadow will hand you the sky on a plate, but some sort of frame will give the vista coherence. In a small urban backyard, that might be the 15-foot gap between a holly and a magnolia.

p between a holly and a magnolia.

The artist James Turrell has spent a career ex-

ploring light and space and is known for his Skyspace works that force a focused view of the sky. Artists, like gardeners, learn how to see nature. On canvas, no one brings the dreamy qualities of the sky alive quite like Ren Magritte.

Perhaps it is those shared garden-art perceptions that make me think of the Glenstone Museum in the Washington suburb of Potomac, Maryland, as a place where the sky plays such an important role.

You cannot view Jeff Koons' quirky "Split-Rocker," either from afar in silhouette or close up against its (in-season) fabric of flowers, without seeing its

place against the sky.

The cluster of galleries in the main building is

centred around a large-scale water garden that is wholly enclosed by the circle of connected galleries to form a Turrell-like frame for the sky.

Without the aquatic plant coverage of summer, the water court mirrors the sky and amplifies its winter role. The colour of the air is different, and as clouds move across the sky, they move from one edge of the frame to the other.

### Unfettered horizon

You don't need an entirely open space or an unfettered horizon to appreciate the value of the winter sky. Watching the waning afternoon light through a woodland demonstrates that this is at best a dance between the opalescent sky and the black-branched tree.

Sometimes the sky is grey and sunless, a feeble pewter glow so ably depicted in Dutch landscape paintings. Such paintings speak to the long, dark, hard winters of the north.


You will find a stark example of this at the National Gallery of Art, where visitors to the West Building are greeted by a large-scale landscape by Jacob Maris, which depicts a bleak wintry scene across a canal.

The title has as much breadth as the picture: "View of the Mill and Bridge on the Noordwest Buitensingel in The Hague" (1873). A hint of sun is caught in the chilly water and a pair of windmills allude to the icy winds from the North Sea. Two figures, a woman and child, are bundled against the elements. Such a day should hasten us all to shelter.

But on the type of dry, warm days that now seem so common, we can at least look up and look around and realise that, at least for the next few weeks, the sky's the limit.

### **Hundreds Of Peru Women, Girls Gone Missing During** Virus Lockdown

Lima: Hundreds of women and girls have gone missing and are feared dead in Peru since a lockdown was imposed to curb the spread of the new coronavirus.

From March 16 through June 30, a total of 915 people -606 girls and 309 women - were reported missing, according to authorities

Last week, Peru's women's ministry said 1,200 women and girls had been reported missing during the pandemic - a higher figure that included the month of July.

"The figures are really quite alarming," Isabel Ortiz, a top women's rights official, told the Reuters news agency on Tuesday.

"We know the numbers of women and girls who have disappeared, but we don't have detailed information about how many have been found," she said. "We don't have proper and up-to-date records.

The Andean nation home to 33 million people has long had a domestic violence problem, but the home confinement measures because of the pandemic has made the situation worse, said Eliana Revollar, who leads the women's rights office of the National Ombudsman's office, an independent

body that monitors Peru's human rights.

Peru is one of the hardest virus-hit Latin American nations, with more than 430,000 COVID-19 cases and 20,000 related deaths.

Hospitals are struggling to cope with the rising number of patients and healthcare workers have protested against a lack of personal protective equipment (PPE).

Before COVID-19, five women were reported missing in Peru every single day, but since the lockdown, that number has surged to eight a day.

The women's ministry said the government was working to eradicate violence against women and had increased funding this year for genderbased violence prevention pro-

Countries worldwide have reported increases in domestic violence under coronavirus lockdowns, prompting the United Nations to call for urgent government action.

Before the pandemic, hundreds of thousands of women throughout Latin America including Peru, were staging mass street demonstrations demanding that their governments should act against gender-based violence.

### After UAE, Saudi to use dogs to sniff out COVID at airports

Riyadh: The role of sniffer dogs in airport security is a long and gloried one. Whether it is to detect bombs, bed bugs, drugs or even SIM cards, sniffer dogs have played a vital role in the line of defence at an airport.

Now, Saudi Arabia may follow suit after airports in the United Arab Emirates started deploying dogs that can sniff out the scent of coronavirus from infected passengers.

With international flights resuming in Saudi Arabia, the customs department has trained dogs—Jack Terriers as well as other breeds—to detect passengers

tional, becoming the first country to do so in the process. Samples taken from passengers are taken to another room where they are sniffed by dogs-with results being delivered in less than one minute according to the Dubai Police.

Numerous studies have shown that dogs are able to discern signs of coronavirus infection if trained to do so, being able to isolate the scent of infection from a patient's sweat—even if they are otherwise asymptomatic

With over 300 million scent receptors, compared to the six million found in humans, dogs are much more able to discern indi-

The training has been done in collaboration with the country's Centers for Disease Control and Prevention (CDC) and has been 80 per cent successful so far. Mohammed Al-Salloum, director of the National Center for Living Means at Saudi Customs, told Arab News, adding that final preparations were ongoing to start deploying dog teams across airports in the kingdom.

Likewise, the United Arab Emirates has already deployed sniffer dog squads at the Dubai Interna-

Both the UAE and KSA were home to millions of expatriate workers before the COVID-19 pandemic hit. A Saudi Labour Market Developments report by Jadwa Investment estimated that up to 1.2 million expat workers would leave the kingdom in 2020. Likewise, around 150,000 Indians had registered to leave the UAE on repatriation flights back to India as of June. The UAE alone is expected to shed 900,000 jobs and lose 10 per cent of its expats due to the COVID-19-induced exodus.



### **Lebanon Puts Port Officials Under House Arrest, Declares State Of Emergency After Explosion**

Beirut: The Lebanese government says it is putting an unspecified number of Beirut port officials under house arrest pending an investigation into how 2,750 tonnes of ammonium nitrate came to be stored at the port for years.

The move comes amid speculation that negligence was to blame for Tuesday's explosion that killed more than 100 people.

It was announced following cabinet meeting Wednesday during which the government declared a two-week state of emergency, effectively giving the military full powers during this time.

President Michel Aoun vowed before the meeting that the investigation would be transparent and that those responsible will be punished.

"There are no words to describe the catastrophe that hit Beirut last night," he said.

State prosecutor Ghassan Oueidat ordered security agencies to start an immediate investigation and collect all reports and letters related to the materials stored at the port as well as lists of people in charge of maintenance, storage and protection of the hangar.

Interior Minister Mohammed Fahmi had earlier told a local TV station that it appeared the blast was caused by the detonation of the ammonium nitrate that had

### Malaysian police raid Al Jazeera office over documentary on migrants

Kuala Lumpur: Malaysian police raided the office of news broadcaster Al Jazeera and two local TV stations on Tuesday, seizing computers as part of an investigation into a documentary on undocumented migrants that enraged the government.

Al Jazeera, a Qatari-state owned broadcaster, said in a statement that police seized two computers during the raid, which it called a "troubling escalation" in a government crackdown on media freedom. It urged Malaysian authorities to cease the criminal investigation.

Police opened an investigation last month into the Al Jazeera documentary on the treatment of undocumented migrants after officials complained it was inaccurate and

a statement. The two local TV stations had reportedly aired the video.

Huzir said the raids were conducted jointly with the Malaysian Communications and Multimedia Commission, which is also investigating the stations.

He said police seized computers which will be sent for further analysis and took statements from witnesses during the raids. "No individual or entity will be spared from action if they have violated the law," he said.

Al Jazeera said the raid was "an attack on press freedom as a whole" and urged Malaysian authorities to cease the criminal investigation.

"Conducting a raid on our office and seizing computers is a troubling escalation in the authorities' crackdown on media

ashington: The suspected teenage mastermind of a huge Twitter hack pled not guilty Tuesday to allegations he hijacked celebrity accounts to swindle people out of more than \$100,000 in a cryptocurrency scheme.

The 17-year-old Tampa, Florida resident pled not guilty before a state court, during a short hearing conducted via videoconference, according to the Tampa Bay Times newspaper. He was arrested Friday

along with two others, aged 19 and 22, one of whom lives in Britain, and was charged with cyber fraud.

Investigators viewed the 17-year-old as the mastermind behind the mid-July cyberattack that rocked Twitter.

Hackers who accessed doz-



ens of high-profile Twitter accounts gained access to the system with an attack that tricked a handful of employees into giving up their credentials, according to a company update.

The hackers "targeted a small number of employees through a phone spear phishing attack," according to a Twitter Support statement.

The incident has raised concerns about the security of the platform increasingly used for conversations on politics and public affairs, particularly as the US presidential election in November approaches.
