Soldier Falls Into Gorge, Dies

Air India Plane With 191 Passengers **Splits Into Two After Landing**

KOZHIKODE: At least two people were feared dead and 35 injured when an Air India Express passenger plane overshot the runway and broke into two after landing in the southern city of Calicut in Kerala in heavy rain on Friday, police said.

The Boeing-737 plane flying from Dubai had 191 passengers and crew on board, the civil aviation ministry said in a statement. The flight had a total of 191 passengers, including two pilots. There were 174 general passengers, 10 infants and five cabin crew members. "We believe there are two people dead, and 35 injured, we are still in the middle of the rescue effort," area police superintendent Abdul Karim said.

Heavy rains in Kerala are being cited as the primary reason for the accident to take place. The flight split into two pieces while landing, with debris flying all over the place. The flight is also said to have fallen into a 30 feet deep gorge while landing, which is another reason for the accident. Thankfully, the flight did not catch fire, making things a lot better. The incident took place during heavy rainfall, at around 7:40 PM.

Both the pilots are said to have been killed in the accident, along with 5 other fatalities. At least 50 passengers have been injured and have been admitted in the nearest hospital. It is feared that 50 more passengers are still stuck in the flight debris, especially following the landslide that took place in the hilly Idukki district, during • P-02

SC TO J&K: Come Up With Final Stand **On 4G Internet By 11 August**

NEW DELHI: The Supreme Court on Friday asked the Jammu and Kashmir administration to explore the possibility of restoring 4G services in certain areas.

The Jammu and Kashmir administration sought time to take instructions on the restoration of high speed internet service, saying a new Lt Governor has been appointed in the Union Territory. Outlining his priorities, Sinha pitched for peace and stability and said the powers of the Constitution will be used for the betterment of the people and the development of Jammu and Kashmir. We need to establish a dialogue with the common people of Jammu

Sinha said the process of direct dialogue with the people will start in a few days.

"There should be peace and stability in Jammu and Kashmir. The situation of uncertainty should end, terrorism should end. Achieving all this along with accelerated development will be our aim, our mission," the lieutenant governor said.

Less than 150 people were invited for the swearing-in ceremony. Social distancing norms were observed with all invitees seated away from each other and everyone wearing masks in view of the CO-VID-19 pandemic. Sinha and the chief justice briefly took off their masks for the oath-taking.

Sinha succeeds former IAS officer Girish Chandra Murmu, who resigned on Wednesday night and was appointed Comptroller and Auditor General (CAG) on Thursday.

The National Conference stayed away from the ceremony for which both Farooq Abdullah and Omar Abdullah were invited.

The National Conference has said the process of democracy should begin by releasing their detained leaders as well as former chief minister and PDP chief Mehbooba Mufti.

"On August 5, we were not allowed to meet. Two days later, we are asked to participate in the oath taking ceremony," an NC leader said. Advisors to the previous lieutenant governor, including Farooq Khan and Baseer Khan, as well as senior bureaucrats and policemen were present at the function in the Raj Bhavan, at the foothills of the Zaberwan range.

Sharma, who is known for his connect with people, particularly in rural areas, will have to tackle several pressing issues. He will have to work towards ending factionalism within the bureaucracy in the union territory, with some senior IAS officers recently found to be publicly indulging in verbal spats.

He will also have to focus his attention on the state intelligence department, which has of late failed to anticipate events. In the last three days, a panchayat member and a sarpanch have been attacked in south Kashmir's Kulgam district in two separate incidents.

Known in some circles as 'vikas purush' (development man), Sinha is a three-time Lok Sabha MP who was minister of state for communication in 2016 when the telecom industry was engaged in the sale of spectrum. He was elected to the lower house for the first time in 1996 and then in 1999 and 2014. However, he lost the election from Ghazipur in 2019.

A B.Tech in civil engineering from the Institute of Technology (now known as IIT-BHU), Sinha has been credited with overcoming the menace of call dropping by holding widespread consultations with telecom operators.

Sinha, an agriculturist, is the first politician to be nominated LG of the union territory.

The Centre had earlier appointed Satya Pal Malik, a politician, as governor of the erstwhile state.

"The study has been carried over the entire region of Jammu and Kashmir, including Jammu, Kashmir, Ladakh, Gilgit-Baltistan. Aksai Chin and other regions across the Line of Control (LoC)," noted Professor Shakil Ahmad Romshoo, Dean of Research at the University of Kashmir.

Meanwhile, a 65-year-old man was killed in cross-LoC shelling in

"The average annual temperature is projected to increase by 4.5 degrees Celsius, 3.98 degrees Celsius, and 6.93 degrees Celsius by the end of the twenty first century under three different scenarios, respectively," Romshoo, lead author of the research, told PTI.

The temperature increase of 6.9 degrees Celsius for the Jammu and Kashmir Himalayas is way more than the projected average rise in the global and national temperatures by the end of the century.

Romshoo added that if the current emission rates of greenhouse gases are sustained, the global average temperature is likely to rise by nearly 5 degrees Celsius by the end of the twenty-first century under the worst case scenario.

Similarly, the average temperature over India is projected to rise by approximately 4.4 degrees Celsius under such a scenario, he said.

Romshoo noted that there will be significant impacts on almost every sector of the economy in Jammu, Kashmir and Ladakh due to this climate change driven temperature increase.

"The glaciers, the most important resource of the region, are going to shrink by around 85 per cent by the end of the century if the projections come true," the professor at the Department of Earth Sciences, University of Kashmir, noted.

He explained that this would lead to significant depletion of the streamflows in the Indus basin, the waters of which are shared between several countries in South Asia.

Similarly, the impacts on agriculture, horticulture and even tourism shall significantly threaten the livelihood of the dependent population in the region, the environmentalist warned.

The researchers, including Jasia Bashir and Irfan Rashid from the Department of Earth Sciences, University of Kashmir, noted that the drivers of climate change are primarily the increasing emission rates of greenhouse gases in the atmosphere.

Greenhouse gas emission is directly related to fossil fuel use, industrialisation, deforestation, air pollution, and other environmental unfriendly activities across the globe, they explained.

"Though, the mountainous regions like Jammu, Kashmir and Ladakh are the least industrialised, unfortunately, they are bearing the brunt of the climate change as the phenomena has global dimensions and footprint," Romshoo noted.

The projected climate change under the three emission scenarios also indicates significant changes in the distribution of prevalent climate zones.

The projected climate change under different scenarios revealed that the subtropical and temperate climatic zones would expand while the cold desert climate zone is projected to shrink significantly under all the three scenarios, the researchers noted.

"The cold desert climate zone in the Ladakh region would shrink by 22 per cent and correspondingly the subtropical and temperate

zones would expand due to the projected climate change," the researchers noted in their study. The projected changes in the climate and climate zones by the end of the twenty-first century would have significant impacts on various sectors in the region which might lead to the redistribution and changes in the composition of vegetation, enhancement of snow depletion and glacier recession," said Romshoo. He noted that the situation would also lead to an increase in the frequency of climate extremes, changes in streamflows, in the faunal and floral biodiversity, plant invasions, changes in agriculture and horticulture productivity. This is in addition to the loss of hydropower generation, ecosystem services, and impacts on other key economic sectors in the region, according to the researchers. "The vital information generated in this research would inform policymaking for framing robust strategies for adaptation and mitigation of the impacts of climate change on various socioeconomic and ecological sectors in the region," Romshoo added.

In Kashmir, Srinagar tops the list with 5822 cases followed by Baramulla with 2073, Pulwama 1769, Kulgam 1593, Shopian 1508, Anantnag 1498, Kupwara 1209, Budgam 1462, Bandipora 962, and Ganderbal 630.

In Jammu division, Jammu district has 1473 cases, Raiouri 754, Ramban 576, Kathua 574, Udhampur 618, Samba 478, Doda 302, Poonch 253, Reasi 214 and Kishtwar 159.

"Moreover, 510 more COVID-19 patients have recovered and discharged from various hospitals, 142 from Jammu Division and 368 from Kashmir Division," the officials said.

Subrahmanyam, a 1987-batch IAS officer who was hand-picked by Prime Minister Narendra Modi to "clean up" the Jammu and Kashmir administration, said mis-governance and corruption had continued for so long that the system collapsed from inside.

"People have to be patient to get a whole lot of benefits after the abrogation of Article 370 as what had happened on August 5 last year, have not been rolled out fully (yet)," he told a group of visiting journalists here.

On August 5 last year, the central government had announced abrogation of Article 370 provisions and bifurcation of the erstwhile state of Jammu and Kashmir into Union Territories (UT) -- Jammu and Kashmir, and Ladakh.

Subrahmanyam said before he came to Jammu and Kashmir in June 2018, he met the prime minister and sought his guidance for his new assignment.

"The prime minister told me: Go, clean up the administration, rebuild it and hand over the "amanat" (precious possession) to the local people," he said.

The chief secretary said he has been working sincerely to create a robust institutional infrastructure which is free of corruption.

"There was a terrible situation here. Things were designed for corruption. Mis-governance and corruption were for so long that the system has collapsed from inside. The whole state was a big ponzi scheme," he said.

Subrahmanyam said there were scores of incomplete projects, land acquisition was a big scam and there were instances when doctors working in the Middle East were drawing salaries in Jammu and Kashmir as it had no system of monitoring.

He said frauds in Jammu and Kashmir were at "unbelievable levels". "There were frauds in jobs, frauds in projects, frauds were everywhere".

"The IK Bank CMD was the scamster number one. Twenty families or a maximum 30 families milked the JK Bank. There was no accountability. All other PSUs (public sector undertakings) in other states submit their report to the assembly, the PSUs in other states come under RTI, CVC (Central Vigilance Commission). But the JK Bank is accountable to none," he said.

The chief secretary said Jammu and Kashmir was a "broken state the

(NC) leader, in Srinagar and that of his son in Jammu.

"A substantial part of the loan was siphoned off by Hilal Rather by transferring the funds from the loan account of Paradise Avenue (his company) to various entities and re-routing the funds back to the firm's current account from where it was further withdrawn and transferred for purchase of movable and immovable assets in India, Dubai and the USA and also spent on foreign tours and other personal activities," the ED alleged.

It added that three flats in the name of Hilal Rather and family members were "acquired in Dubai and one bungalow was acquired in the name of Hilal Rather and his wife in North Carolina, USA" by allegedly misusing the loan amount.

The central probe agency has filed a money laundering case against Hilal Rather and others, under the Prevention of Money Laundering Act (PMLA), taking cognisance of a case filed by the Jammu and Kashmir anti-corruption bureau against him.

The CBI and the Income Tax Department too are probing him in this

The ED said its probe found that a loan of Rs 177.68 crore was sanctioned by J-K bank, without verifying documents and in violation of guidelines of RBI. to Paradise Avenue for construction of a residential housing project in Jammu.

The CBI has alleged that Hilal Rather entered into a criminal conspiracy with the then officials of the Jammu and Kashmir Bank to get loans of about Rs 177.68 crore in alleged violation of rules and guidelines.

"The loans that were sanctioned for construction of flats were allegedly diverted and misappropriated by the accused using the bank accounts of his employees," the CBI had alleged.

It was further alleged by the CBI that the accused submitted forged certificates and bills to the bank.

In a charge sheet filed before a special court in Jammu this March, the CBI had named two former branch heads of J&K Bank's New University Campus branch, Iqbal Singh and Arun Kapoor, apart from Hilal Rather.

Detailing alleged omissions on the part of bank officials, the CBI had said they "did not" verify certificates and helped Hilal Rather in siphoning off the loan amount and laundering of money.

The I-T Department too had raided him in June last year on charges of alleged tax evasion.

"During the search, it was detected that the tax evader (referring to Hilal and his group) has been given illegal benefit of Rs 60 crore by J-K Bank. His outstanding loan of Rs 190 crore was settled at Rs 130 crore, although he did not deserve any concessional treatment," the Central Board of Direct Taxes had then said in a statement.

The CBDT is the policy-making body for the I-T Department. Referring to Hilal, the CBDT statement has alleged that "he is also holding and operating a foreign bank account".

"Neither his interest in the Dubai company nor the foreign bank account has ever been disclosed by him in his tax returns," it had said. It added that Hilal Rather and his group "sold/booked part of his real estate project of Paradise Avenue near Jammu against unaccounted cash."

SC TO J&K: Come Up With...

The apex court was hearing a plea of the NGO seeking initiation of contempt proceedings against the Union Home Secretary and Chief Secretary of J-K for their alleged "wilful disobedience" in complying with the court's May 11 order.

At the outset, Solicitor General Tushar Mehta, appearing for the J-K administration told the bench that he needs to take instructions as the LG has changed and new LG has taken over yesterday.

The bench said that with the change of LG nothing change high powered committee is there to look into the issue. It said that the court cannot say what the situation is on the ground level but the issue is that the matter should not be delayed. The bench asked Mehta to take instructions on whether 4G services can be restored in certain areas. The bench told Mehta that he has to explain under what circumstances the LG had reportedly said that the 4G internet service can be restored and what was the basis of that statement by the LG.

Centre Mulls New Law...

In April, the Union Home Ministry had reversed its order on new domicile rules for Jammu and Kashmir within a week after the amendment triggered protests in the Valley.

Under the revised order, only domiciled residents of the Union Territory will be eligible to apply for recruitment there.

The fresh order, issued on April 3, made government jobs in the Jammu and Kashmir administration out of bounds for non-residents. Earlier, in the order issued on March 31, the home ministry had reserved jobs for domiciled residents only in Group D and non-entry gazetted government posts.

This meant that people from any part of the country could apply for jobs in the higher categories.

Under the new definition of domicile for Jammu and Kashmir, a person residing there for at least 15 years will be eligible to be a permanent resident of the Union Territory.

The government notification also extended domicile rights to central government employees who have served in the state for ten years and also to their children.

Before August 5, 2019, when the government abrogated the erstwhile state's special status given under Article 370 and divided it into two Union Territories, the Jammu and Kashmir assembly was constitutionally empowered to define a resident of the erstwhile state. These defined residents were alone eligible to apply for jobs or own immovable property.

However, the home ministry amended a 2010 legislation the Jammu and Kashmir Civil Services (Decentralisation and Recruitment Act) on March 31 by substituting the term "permanent residents" with "domiciles of Jammu and Kashmir".

Then again budget from April for the whole financial year. Division of assets and liabilities have not been finalised yet," he said.

Subrahmanyam said Rs 6,500 crore worth of projects had been lying incomplete that include a 26-year-old project to construct a bypass in Baramulla. "We have already sanctioned Rs 2,500 crore to complete all these incomplete projects," he said.

Asked about the security situation in Jammu and Kashmir, Subrahmanyam said, "The day I can drive down to Pulwama just with my driver without police escort and pilot, we can safely say that the peace has returned to Jammu and Kashmir."

Pulwama is considered to be a hotbed of militancy. A bus carrying CRPF jawans was blown up by a militant in Pulwama in February 2019, killing 40 personnel.

'Panchayat Bypolls After...

Spate of Resignations After Killing of BJP Sarpanch

New LG knows how to deal with situation, says BJP's Sofi Yusuf

Srinagar: The killing of a Sarpanch affiliated with BJP has once again sparked fear among the party workers with many submitting their resignations or publically disassociating from the mainstream parties in South Kashmir.

On Thursday, suspected militants shot dead a BJP Sarpanch Sajad Ahmad Khanday in Qazigund area of Kulgam district. While on Wednesday, a BJP Sarpanch Arif Ahmad was shot at, leaving him critically injured.

These attacks have sparked fear among political workers, panches, sarpanches, and councilors across South Kashmir. Many have fled their homes and taken refuge in comparatively safer areas, according to reports.

"We put our lives at risk after contesting polls but nobody is bothered about our security. We live under constant fear. The recent attacks on Sarpanchs have triggered a fresh fear among workers on the ground," a Sarpanch from South Kashmir was quoted as saying

Several political workers mostly associated with the BJP have resigned.

Muhammad Rafig Bhat, BJP General Secretary for Dooru constituency in South Kashmir's Anantnag district, announced his resignation from the party on Thursday.

Independent Sarpanch Muhammad Iqbal from Chandan Pajan area of Devsar, Kulgam uploaded a video on social media announcing his resignation.

Several BJP workers from Kulgam and Anantnag resigned from the party on Thursday seeking 'forgiveness' from people. On Wednesday, three BJP workers from Qazigund had announced their resignations.

Defying militant threats, the Panchayat members contested the Panchayat polls during November-December 2018 with an assurance by the government that Panchayat members will be provided security, said a Panch.

The Panchayat election in 2018, was largely boycotted in Kashmir. In the Valley out of 20093 Panch and Sarpanch seats, only 6162 Panches and 1366 Sarpanches were elected, most of them uncontested. Year on 12565 constituencies remain vacant. The authorities have failed to conduct elections on these vacant seats, so far.

Several BJP leaders have also resigned from the party in North Kashmir. This comes after a BJP youth leader

Waseem Bari along with his father and brother was killed in North Kashmir's Bandipora district last month.

Senior BJP leader Sofi Yusuf said many party workers have resigned because of the fear.

"Militants are attacking BJP workers and leaders. Panchs and Sarpanchs don't have proper security. They are resigning for their safety. There are many elements in Kashmir who don't want the strengthening of BJP," Yusuf said.

"BJP workers will fight. We celebrated the first anniversary of the abrogation of Article 370 on August 5. We told previous Lieutenant Governor G C Murmu to provide security to Panchs, Sarpanchs, and Councilors. But we now have a political leader who is LG of J&K who knows well how to deal with the situation," he said.

He said Manoj Sinha has been appointed LG of J&K as the Centre knows where to utilize services of such people.

"I have been saying a political process shall be started which is for betterment of J&K. There are some people who do politics on fake promises. But people are educated and they know the politics of these politicians," he said. (KINS)

Concern Grows Over Fragile Talks As Deadline Nears Hizb threatens to 'Stun' India

slamabad: Hizbul Mujahideen today threatened to "stun" ndia if it fails to agree to unconditional three-way talks with Pakistan ahead of Wednesday's ceasefire deadline. Hizb supreme commander, Syed Salahuddin, in a letter to diplomats here Monday, accused India of dodging the group's central demand for peace talks involving Pakistan and pleaded for foreign help to "give peace a chance" He also said other mujahideen groups which are still fighting Indian rule in Kashmir could be "convinced" to make peace if India agreed to allow Pakistan a seat at the proposed talks. "Let the world community decide by itself who is laying the impediments," Salahuddin wrote in the letter, a copy of which was sent to AFP. "We are still in a position to continue our targeted com¬bat missions and stun India but we kept our guns silent temporarily (to wait for) a proper response.

Dr Samoon said that J&K has 36 functional KVs and setting up of 23 KVs are being pursued with Government of India for augmentation of education infrastructure here.

He directed the Deputy Commissioners to expedite the process of identification of land for the purpose besides finalizing the temporary suitable accommodation for these KVs which is prerequisite for the sanction by Kendriya Vidyalaya Sangathan GOI.

Dr Samoon stressed on the close coordination between the Director School Education Kashmir and Jammu with concerned Deputy Commissioners for speedy completion of all modalities for their establishment.

CONCERN OVER FRAGILE TALKS

Meanwhile, concern grew Monday over the future of fragile peace talks in Kashmir, as the Indian government and the Hizb struggled to find a common framework for dialogue.

The two sides held an initial round of discussions here on Thursday, agreeing to set up negotiating teams for further talks on cementing a formal ceasefire.

Since then, however, the Hizbul Mujahideen militant outfit has accused Indian secu¬rity forces of violating the cur¬rent temporary ceasefire, and reiterated a Tuesday deadline for India to agree to tripartite talks outside the framework of the Indian constitution.

TALKS UNCONDITIONAL, BUT ...

New Delhi, meanwhile has been sending mixed signals over the crucial issue of whether the talks will be held within the framework of the Indian constitution, which rules out Kashmir's secession from India.

Prime Minister Atal Behari Vajpayee failed to clarify the issue on Monday when he told parliament that there were "no conditions" for the talks, but then added that any agreement would be bound by the constitution. "While the talks with the Hizbul Mujahideen are uncon-ditional, no decision will be taken outside the constitu-tion,' Vajpayee said. The Hizb leadership has in-sisted that "unconditional" should mean without any con-stitutional constraints. Vajpayee's latest formula-tion was an apparent attempt to balance the militant demand that the talk; can cover any issue including secession against political pressure not to compromise on the constitution. 

In Search Of Vaccine

There are around 100 vaccines being developed against Covid-19 by research teams in companies and universities across the world

With the total number of cases in India of COVID-19, mounting TO around two million with about 40,000 deaths the situation has assumed alarming proportions. The situation in Kashmir valley is also very scary. We really need an early breakthrough in the form of an effective and safe vaccine Accination is a simple, safe, and effective way of protecting people against harmful diseases, before they come into contact with them. We now have vaccines to prevent more than 20 life-threatening diseases, helping people of all ages live longer, healthier lives. Immunization currently prevents 2-3 million deaths worldwide every year from diseases like diphtheria, tetanus, whooping cough pertussis, influenza and measles etc. It

makes the body's systems immune to get infections against which vaccination has been done. The term vaccine is related to Edward Jenner to denote cowpox ,Variolae vaccinae (smallpox of the cow), which he discovered in 1798 and used for small pox prevention. In 1881, to honour Jenner, Louis Pasteur proposed that the term

should be extended to cover the new protective inoculations then being developed and the term thus stayed. All these vaccine development programs are complex and have several stages; Exploratory stage, Pre-clinical stage, Clinical development, Regulatory review and approval, Manufacturing and Quality control. Clinical development is a three-phase process. During Phase I, small groups of people receive the trial vaccine. In Phase II, the clinical study is expanded and vaccine is given to people who have characteristics (such as age and physical health) similar to those for whom the new vaccine is inand protection from the said disease. An Investigational New Drug application, Pre-licensure vaccine clinical trials, A Biologics License Application (BLA), Inspection of the manufacturing facility, Presentation of findings to the controller from the controlling authorities and finally the usability testing of product labelling. What about COVID 19? There are

around 100 vaccines being developed against SARS-CoV-2 by research teams in companies and universities across the world. Researchers are trying different technologies, some of which haven't been used in a licensed vaccine before. At least six groups have already begun injecting formulations into volunteers in safety trials; others have started testing in animals.

All vaccines aim to expose the body to an antigen that won't cause disease, but will provoke an immune response that can block or kill the virus if a person becomes infected. There are at least eight types being tried against the coronavirus, and they rely on different viruses or viral parts. The four groups - with each having 2 sub-groups are:1. Virus-Inactivated or weakened, 2. Viral Vector- replicating and Non-Replicating. 3. Nucleic Acid based- DNA or RNA. 4.Protein based- Protein subunit and Virus like particles.

Just to give an update of some recent reports in prestigious international Journals. New England journal of medicine carried an original article based upon a mRNA vaccine on July 14th this year, in a phase 1, dose-escalation, openlabel trial including 45 healthy adults, who received two vaccinations, 28 days apart, with mRNA-1273 in 3 different escalating doses in 15 participants each. The vaccine mRNA- induced anti–SARS- CoV-2 immune responses in all participants, and no trial-limiting safety concerns were identified. These findings support further development of this vaccine. The financial support of this ambitious program is from National Institute of Allergy and Infectious Diseases and others sources of US federal government.

The other very talked about vaccine is the Oxford vaccine the preliminary report of its Phase 1 and 2 came in on July 20 last month, in the LANCET. It showed an acceptable safety profile, and homologous boosting increased antibody responses. The vaccine was the chimpanzee adenovirus-vectored vaccine (ChAdOx1 nCoV-19). These results, together with the induction of both humoral and cellular immune responses. support a large-scale evaluation of this candidate vaccine in an ongoing phase 3 program, which is a time-consuming program involving several thousand subjects assessing safety and efficacy.

On the other hand we also hear about a Russian vaccine from Moscow's Gamaleya Institute which according to their health minister has completed clinical trials, and 'paperwork' for its 'registration' with the country's regulatory body was underway. He also announced that a mass vaccination programme, presumably using this vaccine, would be launched in Russia in October and that doctors and teachers would be among the first groups to be vaccinated. A news report by Russia's Tass news agency in the second week of July had said that this candidate vaccine had entered phase 2 of clinical trials on July 13. A phase in which the vaccine is tested for its ability to trigger immune response in human beings, usually takes a

ing phase 3 is a dangerous gamble which most scientific authorities do not agree to. Only a very small number of vaccines that are developed actually get the approval to be used. In the case of the Russian Coronavirus vaccine, however, a regulatory approval is being taken almost for granted. Because of these reasons, there is some amount of scepticism with regard to the Russian vaccine. This scepticism was expressed by top infectious disease experts internationally. Same concerns are being raised against the Chinese Vaccine which is also according to Chinese news reports around the corner.

Zydus Cadila of India is working with 2 COVID vaccines, one using DNA and the other using Replicating Viral Vector. Both are in very early stages. The Serum Institute of India vaccine based upon live attenuated virus is also in early stages. They are partnering with Codagenix vaccine which is in pre-clinical trials and their, Novavax candidate is only a few months behind the Astra-Zenica Oxford vaccine. They plan to announce its availability possibly by the end of 2021.

We Will Not Falter From Our Ideal The relationship of the only Muslim majority region with India was contingent on the depth of Indian democracy

or those who labour under the delusion that the curtailment of civil liberties in Kashmir and persecution of minorities in Delhi are "internal" matters of the country: India chose democracy, secularism, and socialism as its goals in 1947.

The first milestone on this road is democracy.

Democracy entails a lot more than merely conducting elections every five years. In substance, democracy is a way of life and a way of thinking.

In a democracy, the majority will prevail, but it is equally incumbent on the majority to respect and defend the legitimate interests and sentiments of minorities and to dispel their apprehensions.

The greatest test of the success of a democracy lies in the extent to which its minorities feel secure. In this perspective, democracy and secularism in India will remain failed experiments so long as minorities are marginalized and brutalized.

I am not saying this as a Kashmiri Muslim, but as a South Asian and, more so, because I have never reconciled with the communalization of politics.

Muslims are part and parcel of South Asia's history — past and future –and I am of the firm conviction that every inhabitant of India must be given a sense of participation in the country's affairs.

In light of the complex political history of India, it becomes all the more important to ensure that the minorities of the country are satisfied with their relationship with mainland India.

It is regrettable that this complex political history of the subcontinent is being deliberately ignored by the Bharatiya Janata Party (BJP).

This grave lapse is responsible for breeding extremist national chauvinism, thereby weakening the secular character of the Constitution and the country. Amidst incidents of shootings, beatings, arsons and lootings in Delhi, several unsung heroes are fighting to protect our common humanity. From the Hindu man who sacrificed his life saving his six Muslim neighbours from the conflagration that engulfed them, to the Muslims who formed a human chain around a temple to prevent its desecration, such heart warming instances demonstrate that humanity hasn't perished.

Despite the apathy of law enforcement in Delhi and incendiary speeches of head honchos of the BJP, mobs, and giving refuge to endangered Muslims; and Sikhs opening relief camps for the sick, wounded, and vulnerable are manifestations of the indivisibility of the human bond.

several people have kept themselves away from the despicable influence of communalism.

Communalism and its propagation should be regarded as a sin against humanity. Even today, there are people who do not tolerate an outlook that makes a distinction between communities and people.

Many of us were taught not to discriminate between Hindus and Muslims. We were taught that the life of a Hindu was as sacred to us as that of a Muslim. We were taught that any harm to a Hindu should be prevented at the cost of our lives, for our religion teaches us that it is our duty to defend and help our neighbour. I am proud to see people like the Muslims of Chand Bagh, who chose to protect a Hindu religious site, amidst the inferno.

Stories of Muslims saving Hindus and protecting their religious sites; Hindus warding off frenzied sure that the State and its appendages cannot claim monopoly of every human relationship.

Those who have been in the political arena for a long time must recognize that there is no politics without negotiation. And the ultimate negotiating authority is always the citizens.

The ruling BJP has been brazenly muzzling political voices that are antithetical to its agenda of making India a Hindu Rashtra. But real democracies thrive on differences of opinions, not on gagging those who might not be on the same page. But what we are witnessing in India especially the BJP ruled states, is a systematic attempt at deterring the growth of democracy by depoliticising citizens.

The Citizenship Amendment Bill (CAB) brings to the fore forces of fundamentalism with unabated vigor.

The CAB seeks to give citizenship to only non-Muslim religious minorities from Pakistan, Bangladesh, and Afghanistan, who are supposedly fleeing persecution. It does not accord the same privilege to Muslim minorities, who might be fleeing religious persecution as well.

In effect, the Citizenship Amendment Bill flouts the principle of secularism and rights relating to life, liberty, and freedom of expression guaranteed by the Constitution for non-Muslims and Muslims alike. The reaction of the bloodthirsty mob to those legitimately protesting the CAB has been culpable. The unabated violence inflicted on peaceful protestors, including women, by fringe elements that are being mainstreamed by the BJP makes one cringe at the unabashed erosion of democracy.

Nevertheless, the stories of sanity, human compassion and mutual trust that have shone in the wake of targeted violence against Muslims in Delhi, remind me that the BJP is not India, and every Indian is not a Modi-devotee.

How To Prepare Kids As Schools Open

• Pay attention to your child's mental health needs: Although young people possess amazing powers of resilience, it is important to look out for signs of anxiety, loneliness, and behavioral problems. any people are extremely hesitant about send-ing their children back to school, citing fears around the transmissibility and manifestations of the virus in children, particularly after new research suggests children can carry the virus at high levels. Others worry that extended school closures and virtual learning could lead to potentially stunting their children's social, emotional, and academic growth, as pediatric associations have warned. Wherever they stand, all parents I know are exhausted from the triple duty of working, parenting, and teaching their children for almost half a year.

As difficult as this coming year may be, it also presents an opportunity to build up connections after a summer of limited contact and isolation. So, no matter how schools return in the fall, there are things that families can do to prepare their children for the scenarios that lie ahead and to decrease harm to their natural exuberance, curiosity, and capacity to thrive- the psychology of opening school.

1. Relationships come first: For students to have an engaging learning experience online, in person, or some combination of both, parents and teachers must come together to form positive relationships in the months ahead. Parents must advocate for their child's needs and provide input wherever possible through organizations, forums, or other means. This is not a time to stay passive. If you have the time, make contact with your school, volunteer to advise the principal, create a parent council, or ask to be put on one.

Your relationship to your child's teacher will be key this coming school year. Arrange regular check-ins and ask how you can support their teaching success with your child. Make sure to mention how your child adapted during lockdown and what your child will need to thrive. Ask them to share their observations and try not to be defensive.

2. Pay attention to your child's



mental health needs: Although young people possess amazing powers of resilience, it is important to look out for signs of anxiety, loneliness, and behavioral problems. Keep this in mind as they renavigate the norms and structures of school life, virtually or otherwise.

I am often asked when a parent should become concerned about their child's mental health. Indeed, it can be difficult to differentiate between sadness and depression, frustration and aggression, or problems of focus and ADD. However, children and adolescents often share their feelings more readily than adults. One way to make the distinction is by using your own instincts.

Some questions you should ask yourself are: Do you feel something has changed? Does your child's demeanor feel different to you? Has your child's mood or behavior shifted for a prolonged time?

To receive support, you can reach out for advice from doctors or counselors-it will make you feel less alone. For more serious concerns, reach out to your child's pediatrician, or your health and mental health clinic as soon as possible and don't let things linger. Do not allow shame or stigma hold you back-we all are struggling and seeking help is a strength, not a weakness. Engage with the school's student support team, the person in charge of counseling, or the teachers if your child needs help.

It is important not to forget that significant mental health problems evolve over time, and the best way to prevent is to make sure the schools are going to support your child not only academically but a whole child, socially and emotionally. As a parent, ask the school how the wellbeing of children is prioritized during this hard period. Communicate with other parents so you can figure out how you can support the school so it becomes a place of laughter, joy, and learning where your child or adolescent belongs and feels welcomed.

Relational and mental health needs are now truly essential for children and families-not just the choice of school leaders and faculties-especially at a time when we must create resilient communities, schools, and afterschool programs where we can all heal and help those who have truly been traumatised

This set off a storm on social media and rightly so. Nobody expected Bachchan to sue an enthusiast for a mere recitation of his father's work, much less demand reimbursement, rather than expressing humility for what's essentially an honor.

What his baritone voice, impeccable language, recitals of his father's poetry, dilly-dallying with powers that be and pretentious laughter could never hide, was Bachchan's pettiness and complete lack of grace," a user of social media, Celine Mary, wrote in her Facebook post.

Bachchan's recent belligerence, aggressiveness and reacting in a manner unbecoming for the dignity of a global celebrity that he is-on an nameless faceless troll's wishing him death—quickly eroded sympathy and support for him.

"Now with his "thok do saale ko", he yet again displayed what he really is - a troll himself, as contemptible as the one who wished him death," Mary reacted to Bachchan's rant.

The megastar took to his blog, addressing one "Mr Anonymous", and wrote that the troll was trying to gain a sense of self-importance by attacking a star like him.

"If I die, you won't get to write your diatribe anymore, by weathering your remark on a celebrity name. Pity, for, the reason of your writing to be noticed was, because you took a swipe at Amitabh Bachchan, that shall no longer exist.

The 77-year-old actor, along with son Abhishek, was admitted to Nanavati Hospital on July 11 after he tested positive for the novel Coronavirus. Less than a week later, his daughter-in-law, Aishwarya Rai Bachchan, was also admitted at the hospital, after testing positive for coronavirus on July 12. Her daughter Aaradhya had also tested positive for the virus.

While the megastar wrote his blogpost in English, he chose Hindi to write the "thok do saale ko" cuss phrase as if addressing a specific audience. Bachchan said though he has not asked his fans to take any action against the troll, if he survives Covid-19, he will. However, he pledged to "exterminate" such trolls once out of hospital by asking his millions of fans to turn on them.

'That extended family shall in the flash of an eye become 'extermination family'," he wrote while describing his fans as his kin.

Bachchan, after a few decades of demigod status in Bollywood, is the very baritone of authority in the Indian film industry. The iconic actor is a household name in India who has been extensively involved in campaigns like Swachh Bharat, Covid-19, malnutrition, etc. and helped mobilize millions of Indians in the right direction. These campaigns, by virtue of his massive following, have been wholeheartedly welcomed by the entire nation.

It is most definitely unusual for a man with such enormous power to address an anonymous troll and use phrases as pedestrian and incendiary as "thok do saale ko" so openly. For a celebrity who has worked for more than half a century in the film industry, to lose his cool in such indignant manner. is quite appalling as well as disturbing. In a country like India where extremist ideologies, of late, have been promoted with due patronage from the ruling class, the kind of outburst as expressed by Mr Bachchan shall have far-reaching consequences.

Describing Bachchan replying to the troll as "unfortunate" and "not in good taste", Ahmadabad based human rights activist, Fr. Cedric Prakash, senses an undercurrent of dark foreboding as to how it might translate into action.

"Given the polarised situation of the country today, with some of the bigots spewing venom through hate speeches, I really think that Amitabh replying to some anonymous troll with such strong words, is not in good taste, it is very unfortunate," Fr Prakash said. "He would have added some 'value' points to his own battered image— if he just ignored it."

In her tweet, senior editor Times of India, Bharti Jain, who reports on home ministry and security affairs, wrote: "Thok do saale ko' sounds a bit too filmy even for a film star. Surely you can overlook the few crazy critics among your 90 million followers.'

I read the piece and his outburst. It should be called out for its pettiness, regressive insult and violent threat. Can't be condoned. Can't be given a pass just cos his work brings joy to millions.

"From 'khoon kaa badlaa khoon' then to 'thok do saale ko' now, no surprises from the nation's #1 WhatsApp Uncle," Managing editor, Scroll.in, Sundeep Dougal, wrote in his Twitter post, adding: "Quite in keeping with the "golii maaro saaloN ko" crowd."

Pertinently, a prime witness in 1984 anti-Sikh riots, Jagdish Kaur, had told Times of India that "everyone who had been watching Doordarshan saw how superstar Amitabh Bachchan provoked the rioters".

"I wonder why no one in India lodged case against Amitabh Bachchan for provoking killing of Sikhs, "Kaur said.

Amitabh Bachchan was summoned by the federal court of Los Angeles for allegedly instigating violence against the Sikh Community in 1984. The petition against Bachchan was filed by Sikhs for Justice legal advisor Gurpatwant Singh Pannun. According to the petition, Bachchan instigated the attacks. He allegedly raised slogans saying, "Khoon ka Badla Khoon se lenge" ("Blood for Blood") after former Prime Minister Indira Gandhi was assassinated.

Another twitter user, Harshit Agarwal @Citizen Agarwal. said: "I strongly think think #SupremeCourt #bombayhc should consider this statement under suo moto cognizance because it seriously undermines the rule of law and promotes anarchy."

'Doesn't this amount to inciting violence," questioned another user.

India's national capital saw its worst violence in seven decades in February, with two and a half days of rioting leaving at least 53 dead, many more injured and thousands affected.

Section 153A of the Indian Penal Code (IPC) criminalises and punishes making statements, speeches or acts which have the effect of disturbing public tranquillity or law and order by promoting enmity or creating fear or alarm between classes of people on basis of difference in religion, caste, language or place of birth.

Given the recent uptick in prejudicial and violent sentiments against minorities and critics of the government in the prevailing political climate, it is important that people of reasonable authority maintained their cool in order not to vitiate a peaceful environment. They should contribute more towards building national harmony and win hearts rather than allowing themselves to be a target of hate-mongers and trolls.

Study Says Childhood Connection With Nature Has Many Benefits But Is Not Universally Positive

Taving a connection with nature supports multiple areas of young people's wellbeing. However, according to a recent study nature connection is not universally positive.

The review, published in the British Ecological Society Journal People and Nature, is the first to focus on nature connection in children and adolescents.

In the article Dr Chawla comprehensively reviews the full scope of literature on the topic, covering peerreviewed articles, books and studies by environmental organizations.

'There is strong evidence that children are happier, healthier, function better, know more about the environment, and are more likely to take action to protect the natural world when they spend time in nature," said Dr Chawla.

Several studies found that children's connection with nature increased with time spent in natural environments

Here's How Common Cold Infection May **Train Body To Recognise Covid-19**

Based on the finding, the scientists said fighting off a common cold coronavirus could teach the T cell compartment to recognise some parts of SARS-CoV-2 as well. They believe this process provides evidence for the hypothesis that common cold viruses can, in fact, induce cross-reactive T cell memory against SARS-CoV-2.

Pakistan Lifts Virus Restrictions As Cases Drop

ISLAMABAD: Pakistan on Thursday announced it would be lifting most of the country's remaining coronavirus restrictions after seeing new cases drop for several weeks.

All restaurants and parks will be allowed to re-open from August 10, as will parks, theatres, cinemas and public transport, said Asad Umar, who heads Pakistan's task force to fight the coronavirus.

Lebanon Prez Michel Aoun Says Negligence **Or Missile May Have Caused Blast**

BEIRUT: Lebanon's president said Friday that a cataclysmic port blast was caused either by negligence or a missile attack, but rejected widespread calls for an international probe. The explosion that killed

more than 150 people and wounded at least 5,000 on Tuesday could have been "negligence or foreign interference through a missile or bomb,' Michel Aoun told reporters.

Saudi Crown Prince Sent "Hit Squad" To Assassinate **Ex-Spy In Canada: Lawsuit**

Washington: A former senior Saudi intelligence official said in a US lawsuit Thursday that the country's Crown Prince Mohammed bin Salman tried to have him assassinated in 2018, just weeks after dissident journalist Jamal Khashoggi was murdered in Turkey.

Saad Aljabri said Prince Mohammed sent a "hit squad" to Canada, where he lives in exile, to kill and dismember him in the same way that Khashoggi was murdered allegedly by the prince's agents in Istanbul in October 2018.

"To fulfil his murderous desire, Defendant bin Salman has personally orchestrated an attempted extrajudicial killing of Dr. Saad, an attempt that remains ongoing to this day," Al jabri charged in the lawsuit filed in federal court in Washington.

Aljabri said that Prince Mohammed wants him dead because he is close to rival prince and former Saudi security chief Prince Mohammed bin Nayef, and because he has intimate knowledge of Prince Mohammed's activities that would sour the close relationship between Washington and Riyadh.

"Dr. Saad is uniquely positioned to existentially threaten Defendant bin Salman's standing with the US government. That is why Defendant bin Salman wants him dead," the

suit said. Aljabri was already abroad in June 2017 when Prince Mohammed seized power in the palace, removing Mohammed bin Nayef as crown prince and placing him under house arrest.

After his children in Riyadh were hit with travel restrictions, Aljabri refused entreaties to return, fearing he would meet the same fate as Prince Nayef, and moved to Canada where a son lives.

Since then Riyadh tried unsuccessfully to use Interpol to gain custody of him. And he

says they sent a team of agents to the United States to track him down



davs Thirteen after Khashoggi's murder on 2 October 2018, a team from what Aljabri called in the lawsuit Prince Mohammed's "personal mercenary group, the Tiger Squad," arrived in Canada.

The team, he claimed, included forensic specialists and equipment similar to the group that dismembered Khashoggi's body, which was never found.

He said Canadian security became suspicious and disrupted the plot, but that efforts to kill him continue, and that Prince Mohammed obtained a religious fatwa, or command, for his death from clerics.

In March his two children in Saudi Arabia were taken away and haven't been heard from.

The suit against Prince Mohammed plus 12 named and another 11 unidentified people was filed as a claim of attempted extrajudicial killing under the Torture Victim Protection Act.

Aljabri asked the court for unspecified damages for "severe emotional distress." anxiety and hypertension, and other ailments, and punitive damages against the defendants as well.

He also asked the court to declare that the defendants violated the "law of nations" under the Alien Tort Statute.

"This court can begin the process of holding defendant bin Salman and his agents accountable for their actions," the suit said.

Lebanese Rally To Assist Those Affected By Beirut Explosion

eirut, Lebanon - After Lama Masri felt the shockwaves of the massive explosion that ripped through Beirut on Tuesday, she knew that people in the city would need help.

"I went immediately to the pharmacy, grabbed a first aid kit and ran to help. When something like this happens, it's your first instinct - you're in crisis mode," the 32-year-old told Al Jazeera.

Masri, a software developer based in Beirut, was among thousands of Lebanese nationals who have been actively taking matters into their own hands to provide aid to those affected by the explosion, which killed 137 people and wounded some 5,000 others according to the government.

"I could see literally at least 60 percent of our population on the streets, helping people, whether they're organisers or just coming in on their own as volunteers," she told Al Jazeera.

"I had 11 workers helping out and I'd left for a bit to get them sandwiches. [Since] nothing was open - everything was shattered; some people came out on motorcycles to distribute food," said Masri. "I ended up with 11 boxes of free food.

The country has been shaken by multiple crises in recent months. Last October, protesters took to the streets to call for a political overhaul as finan-



cial and economic crises worsened in the country

According to ICRC spokeswoman Rona Halabi, there has been increasing concern that the situation will worsen in the aftermath of the explosion, which devastated the port of Beirut - a vital location for food and aid imports.

"We usually get all our aid through the port, so this may affect our work," Halabi told Al Jazeera. "But we, of course, are here to provide as much as we can to the families of the victims and the injured."

Meanwhile, people are coming together as part of volunteer organisations, and even individually, to assist stricken communities. Halabi savs providing medical assistance has undoubtedly been critical.

"This city and everyone is shaken to the core," she said. "Several hospitals are still damaged; the ones that are still working have been overwhelmed [with people] who've had injuries. And there's still a big need of assistance.

But as hospitals struggled with the influx of wounded people - many had to look for medical treatment elsewhere.

"My colleague was injured with her mother and she went to the hospital in Beirut ... They were then able to receive medical support in another hospital because there were more serious injuries that needed those hospital beds," said Halabi. "A lot of patients were also being treated in

parking lots."

Volunteers who have provided assistance on the ground, like Masri, said they used tweezers to help remove glass pieces from people's wounds.

"You can't just sit at home and say, I'm safe here, when others have lost everything. I can't see devastation and not react," said Masri.

Campaigns focused on spreading awareness of the situation on the ground have since gained international attention. A large number of charity organisations, like non-profit group Impact Lebanon, have put together fundraisers to respond to the crisis. Several initiatives have also been launched to direct potential donors and volunteers to reliable organisations.

Ghida Beydoun, 22, Dania Kharazi, 20, and Nour Abi Fadel, 19, recently came up with the idea of a platform to help spread awareness about the availability of services catering to those in need.

"We're creating an Instagram account called VolunteerBeirut outlining the different areas of help," said Abi Fadel.

"[Its purpose] is to increase equity in the digital space so everyone is aware of current volunteering initiatives, and they can determine how to help as well.'



In Just 21 Days, India Adds Another Million COVID-19 Cases To Its Tally

egistering over 60,000 cases in 24 hours for the first time, India's COVID-19 tally galloped past 20 lakh on Friday, while the number of recoveries surged to 13.78 lakh, according to Union Health Ministry data.

The coronavirus infection tally had crossed 19 lakh just two days ago. It took 110 days for COVID-19 cases in the country to reach one lakh and 59 days more to cross the 10-lakh mark. Thereafter it took just 21 days more to go past 20 lakh. This was the ninth day in a row

that the tally increased by more than 50.000.

According to the health ministry data updated at 8 am, 62,538 cases were added in a day taking the total coronavirus caseload to 20,27,074. The death-toll climbed to 41,585

with 886 people succumbing to the infection in 24 hours, the data showed. At the same time, the number of patients who recuperated from the disease surged to 13,78,105 on Friday taking the recovery rate to 67.98 per cent. There are 6,07,384 active coronavirus cases in the country presently

which comprise 29.96 per cent of the total caseload. The Union health ministry said India continues on the path of CO-VID-19 management boosted by two significant achievements -- continuously rising recovery rate and reduc-



ing Case Fatality Rate (CFR) which is much below the global average. The Recovery Rate on Friday was recorded 68%, while the CFR dropped down to a new low of 2.05 per cent.

Ramped up hospital infrastructure and emphasis on efficient treatment of hospitalised patients through the Standard of Care incorporated in the Clinical Treatment Protocol issued by the Centre, have effectively ensured improvement in the recovery rate.

According to the Indian Council of Medical Research (ICMR), a cumulative 2,27,88,393 samples have been tested for coronavirus infection up to August 6 with 6,39,042 being tested on Thursday. Of the 886 new deaths reported,

316 are from Maharashtra, 110 from Tamil Nadu, 93 from Karnataka, 72 from Andhra Pradesh, 61 from Uttar Pradesh, 56 from West Bengal, 27 from Gujarat, 26 from Punjab, 17 in Madhya Pradesh, 15 from Delhi and 12 from Rajasthan and Telangana.

Ten fatalities have been reported each from Odisha and Jammu and Kashmir, nine in Jharkhand, eight in Bihar, five each in Tripura, Puducherry and Assam, three each from Kerala Haryana, two each from Goa and Andman and Nicobar Islands and one in Manipur.

Of the total 41,585 deaths so far, Maharashtra has reported the maximum at 16,792, followed by 4,571 in Tamil Nadu and 4,059 in Delhi, 2,897 in Karnataka, 2,583 in Gujarat, 1,918 in Uttar Pradesh, 1,902 in West Bengal, 1,753 in Andhra Pradesh and 946 in Madhya Pradesh.

So far, 757 people have died of COVID-19 in Rajasthan, 601 in Telangana, 517 in Punjab, 458 in Haryana, 436 in Jammu and Kashmir, 363 in Bihar, 235 in Odisha, 145 in Iharkhand, 126 in Assam, 98 in Uttarakhand and 97 in Kerala.

Chhattisgarh has registered 77 deaths, Puducherry 70, Goa 66, Tripura 36, Chandigarh 20, the Andaman and Nicobar Islands 16, Himachal Pradesh 14, eight in Manipur, seven in Ladakh, six in Nagaland, five in Meghalaya, the ministry data showed.

The US state department issued the Level 4: Do Not Travel advisory-the home orders, business closures and othhighest level of travel advisory—on March 19, urging American citizens due to the COVID-19 pandemic, it said. not to travel overseas due to the coronavirus pandemic. India remains on the Level 4 of the travel advisory along with more than 50 countries, including China. This means that the US urges its citizens not to travel to India due to the increasing coronavirus cases.

The state department, in its latest travel advisory on India issued on Thursday, said, "Do not travel to India due to COVID-19 Exercise increased caution in India due to crime and terrorism". tional passengers to fill a mandatory self-declaration form. Eligible passengers can apply for exemption from compulsory institutional quarantine for coronavirus, said the Delhi International Airport Limited (DIAL) on Friday.

This will make traveling contactless as they won't have to fill physical copies of self declaration and guarantine exemption forms when they arrive in India. From Saturday onward, a total of five categories of passengers can get exemption from the mandatory seven-day institutional quarantine. These five categories include pregnant women, those who have had bereavement in their families, people suffering from serious illnesses, parents accompany-

Passengers who are allowed exemption would have to undergo 14-day home quarantine. All other international passengers arriving in India have to follow the usual process of undergoing mandatory seven-

day institutional quarantine, at their own cost, followed by seven days of home quarantine. "Passengers seeking exemption under the five specific categories will need to fill the e-form available on www.

newdelhiairport.in. They will have to submit it along with supporting documents, including a copy of their passports, at least 72 hours before boarding

their flights," DIAL said. According to rules, every passenger has to submit a termed 'Air Suvidha' and it can



self-declaration form saying they have not tested positive for COVID-19 three weeks prior to the flight. A copy of approval or rejection of exemption requests on specific grounds will be emailed to the passengers.

"Those eligible for exemption from mandatory institutional quarantine can show the approval certificate at the transfer area after landing and walk out hassle-free," said the DIAL. This will not only help flyers but also reduce congestion at the arrival hall of the airports, according to DIAL. The portal has been

be accessed through Delhi airport's official website.

This facility will be available for international passengers from Saturday. The online forms have been developed in collaboration with various state governments, Ministry of Civil Aviation, Ministry of Health and Family Welfare and Ministry of External Affairs. Scheduled international passenger flights continue to be suspended in India since March 23 amid the coronavirus pandemic. However, special international repatriation flights and charter flights have been permitted by the aviation regulator.

Since May 6, special international flights have been operated by Air India under the Vande Bharat Mission to help stranded people reach their destination. Private carriers have also operated under this mission.
