Banihal/Jammu: The Jammu-Srinagar Highway was closed for traffic on Thursday due to a landslide in Ramban district that left over 300 vehicles stranded, an official said. The 270-km highway, the only allweather road linking Kashmir with the rest of the country, was blocked by a major landslide at Mehaar area, they said.

Police Begins Probe Into Shopian Encounter

Probe To Focus On DNA Sampling, Trio's Militant Links: IGP Kumar

SRINAGAR: A police team from Kashmir has been sent to Rajouri district in Jammu region to collect DNA samples of the people claiming to be relatives of the three youths killed in an alleged fake encounter in Shopian district of the Union Territory last month, a senior police official said on Thursday.

"We have sent a team headed by Deputy SP Wajahat today (Thursday) to Rajouri to collect the DNA samples of those claiming to be relatives of the deceased." Inspector General of Police Kashmir zone Vijay Kumar told reporters on the sidelines of a function here.

Kumar said the DNA samples will be sent to central laboratories for matching.

"There are two aspects of the investigations. One is matching the DNA and then we will be also investigating whether these youths, who had come to work in Kashmir, had any links with militants. We will be going through their call details and other technical aspects as well," he added.

Israel-UAE Announce Full Diplomatic Ties

WASHINGTON- Israel and the United Arab Emirates announced an agreement on Thursday that will lead to a full normalization of diplomatic relations between the two states, a move that reshapes the order of Middle East politics from the Palestinian issue to Iran.

Under the accord, which U.S. President Donald Trump helped broker, Israel has agreed to suspend annexing areas of the occupied West Bank as it had been planning to do, White House officials said.

It also firms up opposition to regional power Iran, which the UAE, Israel and the United States view as the main threat in the conflict-riven region.

Israel had signed peace agreements with Egypt in 1979 and Jordan in 1994. But the UAE, along with most other Arab nations, did not recognise Israel and had no formal diplomatic or economic relations with it until now.

The agreement was the product of lengthy discussions be-tween Israel, the UAE and the United States that accelerated recently, White House officials said.

A joint statement issued by the three nations said Trump, Israeli Prime Minister Benjamin Netanyahu and Abu Dhabi's Crown Prince Sheikh Mohammed Bin Zayed had "agreed to the full normalization of relations between Israel • P-02

The families, who filed the police complaint jointly, gave pictures of their kin -- Mohammed Ibrar (21), Ibrar Ahmad (18) and Imtiaz Ahmad (26) -- which were subsequently shared with the Kashmir Police for investigation.

The relatives of the youths lodged the missing report with the local police after they failed to contact the trio and news of an encounter came on July 18 from Shopian, a police official said.

DNA Samples Of Families...He said that the officials have told the families that the reports of

the DNA tests are most likely to come next week.

"We will bring the bodies to Rajouri when the DNA tests match," family sources said. Deputy Commissioner Rajouri, Nazir Ahmed Sheikh was quoted by a local news agency KNO as saying that the district administration facilitated collections of DNA samples of family members of all three missing persons.

Meanwhile, several delegations of locals, elders, and civil society groups met the police team from Kashmir and Rajouri police officers and demanded an impartial, independent probe into the 18 July killings that took place in Ashmipora, Shopian.

"This historic diplomatic breakthrough will advance peace in the Middle East region and is a testament to the bold diplomacy and vision of the three leaders and the courage of the United Arab Emirates and Israel to chart a new path that will unlock the great potential in the region," the statement said.

In a separate statement, the crown prince stressed that the agreement would stop further Israeli annexation of Palestinian territories, which Israel has said had been awaiting a green light from Washington.

The agreement, to be known as the Abraham Accords, also gives Trump a foreign policy accomplishment as he seeks re-election on Nov. 3. "HUGE breakthrough today! Historic Peace Agreement between our two GREAT friends, Israel and the United Arab Emirates," Trump wrote on Twitter. The UAE said it would remain a strong supporter of the Palestinian people and that the normalization agreement maintained the viability of a twostate solution to the Israel-Palestinian conflict. Netanyahu said the agreement represented a "historic day" for his country. But a senior Israeli official said applying Israeli sovereignty to areas of the West Bank - territory Palestinians seek for a state along with Gaza and East Jerusalem - was still on the agenda. The official said, "The Trump administration asked us to temporarily suspend the (sovereignty) announcement so that the historic peace agreement with the UAE can be implemented." Trump's special envoy Brian Hook said the deal is a "nightmare" for Iran. Iran and Israel are arch foes. Israel is particularly concerned about suspected Iranian efforts to develop nuclear weapons, which Tehran denies. Iran is also involved in proxy wars from Syria to Yemen, where the UAE has been a leading member of the Saudi-led coalition opposing Iran-aligned forces there. Delegations from Israel and the United Arab Emirates will meet in the coming weeks to sign agreements regarding investment, tourism, direct flights, security, telecommunications and other issues, the statement said. The two countries are expected soon to exchange ambassadors and embassies. The statement said that "as a result of this diplomatic breakthrough and at the request of President Trump with the support of the United Arab Emirates, Israel will suspend declaring sovereignty" over areas of the West Bank that were envisioned in a U.S. plan announced by Trump in January.

In the White House Oval Office, Trump said similar deals are being discussed with other countries in the region. A signing ceremony including delegations from Israel and the United Arab Emirates will be held at the White House in the coming weeks, Trump added.

"Everybody said this would be impossible," Trump said. "After 49 years, Israel and the United Arab Emirates will fully normalize their diplomatic relations. They exchange embassies and ambas-

sadors and begin cooperation across the border." The agreement envisions giving Muslims greater access to the Al-Aqsa Mosque in the Old City of Jerusalem by allowing them

to fly from Abu Dhabi to Tel Aviv, White House officials said. Trump said, "This deal is a significant step towards building a more peaceful, secure and prosperous Middle East. Now that the ice has been broken, I expect more Arab and Muslim countries will follow the United Arab Emirates' lead and normalize relations with Israel."

"We are already discussing this with other nations, very now erful, very good nations that want to see peace in the Middle East so you will probably see others of these," Trump added. "Things are happening that I can't talk about, but they're extremely positive."

Palestinians Slam the Deal A senior Palestinian official has slammed the US-brokered deal establishing full diplomatic ties between Israel and the United Arab Emirates in exchange for Israel dropping its plan to annex West Bank land. Hanan Ashrawi said on Twitter the deal perpetuates Israel's occupation of the West Bank.

"Israel got rewarded for not declaring openly what it's been doing to Palestine illegally & persistently since the beginning of the occupation," she wrote. She also said the UAE has come forward with its "secret dealings/normalisation with Israel."

"Please don't do us a favour. We are nobody's fig leaf!" she wrote.

Also, they said, a 40-year-old man from Poonch who was referred from Batra hospital to Chest Diseases hospital died on the way. A 25-vear-old female from Bijbhera Anatnag died at CD hospital here, one of the exclusive facilities of the management of the covid-19 patients. "She was referred to LD Hospital as case of pneumonia with Sepsis with AKI after testing positive on Rapid Antigen Test on August 11 at LD Hospital where she had LSCS and had delivered twin daughters," official sources said. They said she was on ventilator and suddenly developed bradycardia followed by cardiac arrest today at around 4:30 p.m. Regarding two deaths from Kupwara, they said, the victims include a 67-year-old from Kupwara who was admitted to hospital on August 10 and died today.

Also, a 90-year-old woman from Panzgam Kupwara having underling ailments such as "HTN, CKD and encephalopathy besides bilateral Community acquired pneumonia" died at SKIMS, six days after she was admitted to the tertiary care hospital. The Srinagar fatalities, they said include a 65-year-old woman from Khanyar who was suffering from hypertension, hypothyroidism, besides severe bilateral pneumonia, a 62-year-old woman from Eidgah and an elderly from Lal Bazar "who was a known case of hypertension" and died at around 7:30 a.m. today, nine days after being admitted to SKIMS. A 70-year-old woman from Rafiabad Baramulla who was having "HTN, and bilateral pneumonia" died at SMHS hospital where elderly woman from Mazhama Budgam besides two residents from Pulwama-an eldely man from Baygund Tral and 50-year-old woman from Drabgam-also succumbed, official sources said. "All these patients had bilateral pneumonia and other ailments," they added. A 45-year-old man from Shalabug Ganderbal who was admitted hospitalized on August also succumbed to the virus, they added. With these deaths, officials said, 512 people have succumbed to the virus in Jammu and Kashmir so far-473 from the Valley and 39 from Jammu division. The Mig-21 Bison is a single engine and single seater multirole fighter aircraft of Russian origin which was the backbone of the IAF for several decades. The Mig 21s played a major role in the 1971

Last week, Vice Chief of Air Staff Air Marshal Harjit Singh Arora visited a number of air bases along the Line of Actual Control in eastern Ladakh to take stock of the IAF's operational preparedness in the region.

Air Marshal Singh also visited the strategically crucial air base in Daulat Beg Oldie, known as one of the world's highest airstrip. The airbase is situated at an altitude of 16,600 feet.

In June, Air Chief Marshal Bhadauria made a quiet visit to Ladakh and Srinagar air bases to review the IAF's overall preparedness. In the last two months, the IAF deployed almost all its frontline fighter jets like Sukhoi 30 MKI, Jaguar and Mirage 2000 aircraft in the key frontier air bases in eastern Ladakh and elsewhere along the LAC. The IAF has been carrying out night time combat air patrols over the eastern Ladakh region in an apparent message to China that it was ready to deal with any eventualities in the mountainous region. The IAF has also deployed Apache attack choppers as well as Chinook heavy-lift helicopters to transport troops to various forward locations in eastern Ladakh.

5.35 lac COVID-19 cases and a daily average of 1700 new cases but despite it the state has entered unlock 3.0 phase. Quoting figures, the KCCI spokesperson said the Mumbai has a population of over 2 crore living in an area of 603 sq km as compared to Srinagar's population of around 17 lakhs in an area of 294 sq km; six times higher population density of 33,168 persons per sq km as compared to 5,782 persons per sq km in Srinagar. Divulging further details, he said on August 3, the BMC has allowed all shops - essential and non-essential - to open all day except in containment zones. He said only theatres, food courts, in-house dining in restaurants, bars and gaming zones, street vendors and hawkers, continue to be prohibited. "There are currently around 700 containment zones in Mumbai but unlike in Srinagar, they mostly consist of individual buildings and slums," the KCCI spokesperson said.

"Here, the administration cannot be bothered to stop tweeting and identify individual houses. They simply barbwire-off entire neighbourhoods, if not the entire districts," he added.

The KCCI spokesperson said that with six times the population density, gradual opening of business establishments and the population being allowed much more movement, the infection rate of around 2.65 percent not been seen as a very successful operation but speaks volumes about the intent of the Maharashtra Government to provide avenues of livelihood and it's concern for the welfare of the public.

India Cannot Keep Depending On Imported Defence Supplies: Rajnath Singh

NEW DELHI: Defence Minister Rajnath Singh on Thursday said India cannot depend on foreign governments and overseas suppliers to meet its requirement of military platforms, and self-reliance in the defence sector is far more crucial than any other field.

Singh made the comments after launching a range of new products brought out by several defence public sector undertakings and the Ordnance Factory Board (OFB) at an online event.

The products unveiled by Singh included a prototype of Nag missile carrier, a prototype of 8.6x70 mm sniper rifle and an underwater remote operated vehicle. Separately, he also launched a naval innovation and indigenisationorganisation of the Indian Navy. "Security is its first priority for the development of any nation. It is known to all of us that the nations, which are able to protect themselves, they have been able to build their strong image at the global level," Singh said. "We cannot depend on foreign governments, foreign suppliers and foreign defence products to meet our defence needs. It is not compatible with the objectives and feelings of a strong and 'Atmanirbhar Bharat'," he added. In a mega push to boost domestic defence production, Singh on Sunday announced that India will stop import of 101 weapons and military platforms like transport aircraft, light combat helicopters, conventional submarines, cruise missiles and sonar systems under a staggered timeline running into 2024. India is one the largest importers of arms globally. According to estimates, the Indian armed forces are projected to spend around USD 130 billion in capital procurement in the next five years. "We should not only be able to ensure the fulfilment of our national interests but also be able to help other people in times of need. Self-reliance in the defence sector is far more crucial than any other field," Singh said.

J&K Bank extends 2 pc interest subvention to MUDRA-Shishu borrowers

Srinagar, Aug 13: J&K Bank has extended the central government's relief in the form of interest subvention scheme to all its eligible MUDRA Shishu beneficiaries.

The relief forms part of the Government's economic stimulus package under Atma Nirbhar Bharat wherein 2% interest subvention will be provided for a period of 12 months on repayment of Shishu Loan accounts that are not categorized as NPA's as on March 31, 2020. However, the benefit of such subvention shall be passed on to the borrowers only when the interest on the loan amount is serviced regularly on monthly basis.

The scheme, the bank in a statement said, aims to alleviate financial stress for borrowers at the 'bottom of the pyramid' by reducing their cost of credit.

"The scheme will be in operation for 12 months. For borrowers who have availed moratorium under RBI's Covid package, the scheme would take effect after the moratorium period for 12 months i.e. from September 01, 2020 till August 31, 2021. For other borrowers, the benefit of 2% subvention would begin with effect from June 01, 2020 till May 31, 2021", the statement added.

JAMMU- Police said Thursday they had foiled a major militant bombing mission and captured eight persons, six of them Hindus, from Jammu found working with a hardline militant group Harkat-ul-Jehad-e-Islami (HUJI). Inspector general, R.V Raju, said they had captured Bharat

year on from the repeal of Article 370, India, Pakistan relations have gone steadily downhill. And with every new move that New Delhi takes to further integrate Kashmir into the country, the ties between the neighbours are worsening further. On the first anniversary of the withdrawal of Article 370 on August 5, Pakistan issued a new Kashmir map that shows the Indian side of J&K and Ladakh as part of Pakistan. The map is not new except that what was earlier presented as disputed territory is now described as 'illegally occupied by India. Similarly, Pakistan has urged the US to help improve the India, Pakistan ties. This, in effect, is a call for the US mediation in Kashmir, something the Washington has been loathe to do unless both countries ask for it. India's position has invariably been against the third party involvement as it regards Kashmir as a bilateral issue with Pakistan. So, Pakistan's call for the US or any other country's mediation means little

This leaves India, Pakistan to sort their messy relationship themselves. They will need to pick up the thread where they have left it. But it won't be as easy. The withdrawal of Article 370 in August last has further wiped out the space for an engagement between the neighbours. Things have since become complicated geopolitically too. China's incursions in Ladakh have made the communist power as yet another party to the issue. And the alleged China-Pakistan collusion in the region has erected what some observers in Kashmir think 'a great wall of China' around India on its northern and western side. Also the cooperation among China, Pakistan, Iran, Russia is giving all indications of emergence of a geopolitical block. And if all goes well Afghanistan under Taliban could also be part of this block. Also, India has already withdrawn from China's Border and Road Initiative. New Delhi, on the con trary, has aligned itself with the US and the west.

These shifting alignments are putting in place a new geopolitical order. This order, however, in no way will help resolve the issues of the subcontinent particularly those between India and Pakistan. That is, if the two countries themselves don't show a willingness to address these. And this needs to be done before the two countries get sucked into the emerging new cold war. This calls for steps for re-engagement between them, that is informed by a deep realisation that the only way to peace in the region is through India-Pakistan reconciliation.

Goodbye, Rahat Indori

est known for his politically charged poetry about the rising tide of communalism and growing turpitude in public life, Rahat Indori's last verses concerned life and death. It was fitting, and also quite natural, because Indori always lived in the moment. His latest work reflected the grim reality of a pandemic sweeping the world, forcing the human race, which suffers from the delusion that it is the master of nature, to ponder its own mortality.

Not long ago, Indori had been the man of the moment as protests against the Citizenship Amendment Act ignited across the country and his poem Agar khilaf hai was recited in rallies, especially the line: "Kisi ke baap ka Hindustan thodi hai" (India is not anyone's father's property). His verse connected viscerally with millions because he had abandoned formalisms rendered obscure by the passage of time, and preferred a simple diction which blended Hindi and Urdu, the spoken language of the common people of north India.

An accessible modernism and a determination to hold up a mirror to a nation in the throes of moral decay and ambiguity made Indori the rock star of mushairas. Along with peers like Basheer Badr, he was part of a new generation of poets who spoke directly to the heart, addressing potentates and paupers in the same register. His style recalls the Pakistani poet Nasir Kazmi's terrifying simplicity as he describes (it is widely believed) the night of Partition: "Main hun, raat ka ek baja hai/ Khali rasta bol raha hai/ Aaj to yun khamosh hai duniya/ Jaise kuchh hone wala hai..." (It's me, it's one o'clock at night/ Only the empty road speaks/ And the world is so calm tonight/ That something must happen...). Indori was part of an old tradition of modernity, which will always be with us.

In The Name Of Security And Public Order

The Lockdown Imposed Onaugust 5 Last Year On Communication And Internet Has Denied The Basic Essential Rights To People In Jammu And Kashmir

n August 5, at the stroke of midnight, State of Jammu and Kashmir was placed under a complete lockdown. All voices of dissent neutralized. You ask why? The answer smoothly given with a smile is, "In the name of National Security and Public Order".

Way back onAugust5, 1914, Great Britain had declared war on Germany. This was due to Germany's invasion of Belgium and its refusal to leave Belgium neutral. At that time, telegraph was the mode of communication and Great Britain had the most advanced undersea telegraph cable system. Great Britain, being in a dominant position, thus wanted to make full use of its advanced infrastructure, the only impediment being cables of Germany.

As a military strategy, on August5, 1914, a British Cable Ship severed five German overseas underwater cables, which passed from Emden through the English Channel to Vigo, Tenerife, the Azores and the United States. German Communications were completely cut, forcing them to communicate on British Lines and providing Great Britain an intelligence windfall. The messages sent on British Lines were Intercepted and decoded. This strategy resulted in Great Britain intercepting the "Zimmermann Telegram" which was used to help draw the United States as an ally. Great Britain thus created the first global communications surveillance system.

While, Great Britain used "interdiction", as a military strategy in war, the same is clearly being used in Jammu and Kashmir, by the Central Government to either gain intelligence inputs or maybe to completely curb dissent. Although, events which have transpired since August 5, 2019 tilt the balance in favor of curbing dissent.

The lockdown imposed on August 5, 2019, on communication and internet, has denied the basic essential rights to people in Jammu and Kashmir: education, healthcare, trade communication, most of all, right to choose their own leaders. Surprisingly, these very rights were guaranteed by the Constitution of India, but put in abeyance, for no good reason, all in the name of National Security and Public Order.

It need not be explained how lack of communication and impositions of restrictions on movement can paralyze an entire eco system. Restrictions imposed on August 5 and continued since, impacted not only trade and commerce, but also took a heavy toll on education, justice delivery system and tourism sector. If figures are to be believed, revenue loss has been stated to be more than 20,000 Crores. Who will compensate people for this loss?

Considering the impact, the restrictions imposed had on the people of Jammu and Kashmir, the issue was taken up to the Hon'ble Supreme Court of India, in the case of Anuradha Bhasin v. Union of India.It was expected from the Hon'ble Supreme Court to step in protect. nourish the rights of people of Jammu and Kashmir. But just like, Cancer, National Security and Public Order, slowly and steadily took over the freedoms guaranteed to the people in Jammu and Kashmir, where even Court-therapy (Chemotherapy) did not help. During arguments, before the Hon'ble Supreme Court, Government was unable to justify the basis for its actions anddenial of basic rights of communication, trade, and a dignified life. Making it clear that the denial was merely on the whims and fancies of the Executive/Central Government.

While few politicians and individuals challenged the action of the Central Government in abrogating article 370 of the Constitution of India, there was a complete lack of interest by the Civil Society Members, intellectuals and even political parties from Jammu and Kashmir (barring one Politician who filed a case) to take actions for protection of these rights.

On January 10, 2020, the Hon'ble Supreme Court of India, passed a detailed judgment declaring that the freedom of speech and expression and the freedom to practice any profession or carry on any trade, business or occupation over the medium of internet enjoyed constitutional protection and the restriction upon such fundamental rights was required be in consonance with the mandate under Article 19 (2) and (6) of the Constitution, inclusive of the test of proportionality.

While doing so, Hon'ble Supreme Court, cautiously, stayed away from declaring actions of Government illegal, perhaps in the name of "National Security". This Judgment, in all vehemence asserted that the action of complete blocking/prohibition could not be accepted by the Court and observed that the Government should have attempted to determine the feasibility of putting restrictions on social media. The Government was thereafter directed to revisit its orders, pass fresh orders and place the same in public domain.

Consequently, certain relaxations were given, and internet came back to Jammu and Kashmir, albeit at the restricted speed of 2G. As such, it appeared that the Government would in the coming months remove the restrictions. However, that was not the case to be. The Government continued to restrict the Internet Connectivity to 2G on mobiles, despite knowing that majority of population of Jammu and Kashmir was not accessing Internet through board-band. Internet, through mobile communication, remained an effective and cheap mode of accessing internet. Any reasonable Government, having a mandate to help people, would find a way, to make life of people less miserable, or at-least provide a way out. But with the "string led administration", dealing with misery of people clearly was not on menu.

In the interregnum, the entire world was hit by the Covid-19 pandemic. This forced entire nation into a lockdown and at the same time gave a glimpse of what a common person from Jammu and Kashmir was suffering. The loss on account of employment, trade, and the effect it had on the economic situation of the country was clearly visible.

It was presumed that the Government would relax the restrictions and allow use of 4G through mobiles as it would not only help children in accessing their online classes, but also allow students/professionals and even the Judicial system to function through this pandemic on the virtual mode.

Who would have thought that more misery would be inflicted by the Government? The orders based on which restrictions were imposed, went on to state that the restriction on Internet speed has no effect on education of children through video conferencing. Additionally, these orders, which as per the Judgment of the Supreme Court were required to be passed based on certain judicial principals, were nothing but "Parrot" orders. Nothing in the orders would show any application of mind or a justifiable reason.

While the entire nation, through virtual mode was progressing, people in Jammu and Kashmir were made to struggle even for essentials. Imagine the extent of damage to the economy of Jammu and Kashmir, in absence of Internet. The only tool, snatched away, which allowed people, to remain sane, to enforce their rights, of trade, education and most importantly, right of communicating with each other and without which right to live in this chaoswasdifficult.

The impact of Covid-19 pandemic, forced the Foundation of Media Professionals and Private Schools Association of Jammu and Kashmir to knock the doors of Supreme Court, with a basic plea to increase the Internet Speed so that the students, professionals and even traders can go on with their lives, live with dignity.

However, yet again, the Central Government came up with the old excuse of "National Security" and the Hon'ble Supreme Court declined to pass any directions and surprisingly formed a Committee, consisting of Senior officers of the Government to look into the issue and consider the representations of the Petitioners before the Court.

No none can be the Judge in their own cause, this is the fundamental principle of law. However, rights of people, were placed by the Hon'ble Supreme Court at the mercy of the Government, which in the first place had taken the rights away. It was expected of the Hon'ble Supreme Court to take-action, as the orders passed by the Government were not in accordance with law.

The Government, yet again, flouted the law and did not take any action. A contempt petition was thus filed, which is as on date pending. The Hon'ble Supreme Court, yet again, in the contempt petition, filed by Foundation of Media Professionals, did not pass any directions, but requested the Government to see and analyze whether 4G services can be provided on experimental basis. The Apex court has the duty to protect and preserve the rights of the people and such a duty cannot be blinded by the argument of national security. In the said Contempt Petition, Central Government has now given a statement that it would be allowing 4G services on experimental basis in two districts of Jammu and Kashmir Division.

Should we be happy? The answer is in negative. There is no cogent reason for Government to continue with the restrictions. This is especially when the Lieutenant Governor, as available in media, himself made a statement that 4G services can be resumed and they had no impact on the security scenario.

Till date 88 orders have been passed by the Government in respect of Telecom Restrictions.It will take average intelligence to understand that the real issue of the Government is use of Social Media in instigating people against the Country and use of Voice Over Internet Protocol (VoIP) services by people across the border to destabilize the state.

These assertions clearly appear to be a smoke screen. Incase, the Government had any issue with the use of Social Media, the same could have been curtailed by banning or withholding such Social Media Applications, however, that step has not been taken. This is even though an observation was made in this regard by the Hon'ble Supreme Court. In so far as the VoIP is concerned, the same can even as on date be accessed through 2G. Thus, there is no rationale in even giving such a justification. It is in common knowledge that mostly satellite telephones are used for infiltration.

It is also surprising that there is already a system in place to check misuse of Social Media (Inter-mediatory Guidelines framed by the Government), further, Social Media continues to be used on 2G Network, why is it then necessary to put an embargo on the Internet Speed? Why so many restrictions, when the same are not in public interest? I presume it is to force the people to look towards Center for any relief/change.

Most of the population is dependent on 4G services for their basic essential requirements. When the remaining country has access to such services, denying the same to inhabitant of Jammu and Kashmir is anathema to the rule of law.

Clearly, people at the helm of affairs are acting without taking the interests of public into consideration. The actions of the Government are clearly robotic and, on the ipse, dixie of the officials at the Centre. The rights of people of Jammu and Kashmir will continue to be trampled till the time there is a puppet at the helm of affairs. It is the need of the hour for an elected representative to take control of the situation and relay the concerns of the people of Jammu and Kashmir.

Once the government in Jammu and Kashmir is controlled by the Centre, the interests of People of Jammu and Kashmir will always be secondary. The administrators controlling Jammu and Kashmir neither have the mandate of people nor have any affinity towards them, clearly reflective from their approach to the grievances of people. Political activity therefore is a must.

It is therefore essential for the Civil society members, intellectuals and Political Parties to amplify the grievances of people, through a political process and if possible, approach the Hon'ble Supreme Court and fight for the resumption of 4G services to the entire region of Jammu and Kashmir.

NEP: Don't discontinue MPhil

he Nation Educational Policy (NEP) which was approved by the union cabinet recently has invited mixed reactions. It may be able to change the course of Indian educational system by introducing to it a modern outlook but the discontinuation of the MPhil degree is a big blow to those who aspire for higher education especially in Kashmir.

With the new National Education Policy's clause to discontinue the MPhil degree course; securing a research opportunity will become even more daunting for Kashmiri students. Masters students in Kashmir University have little to no research experience. The course isn't designed to include any research based papers, assignments or projects. One doesn't even have to submit a dissertation in order to secure a Masters Degree here. There's no encouragement to develop

research acumen especially in the Humanities and the Social Sciences.

Since, the curriculum does not prepare the students for research; they are expected to have an intermediate degree that will help them bridge the gap of semester oriented studies to a research oriented one. This was supposed to be the utility of an MPhil degree. With its discontinuation, students will now have to look for the foreign counterparts of an MPhil degree and try to gain at least one year of research experience. This will limit opportunities for students from underprivileged backgrounds who will not have the resources to apply abroad.

Some would argue that many other prestigious universities do not have a research based Masters Degree course but Kashmir University is still a special case. It stands out in the sense the education sector has faced major chal-

lenges in the past three decades owing to the political situation in the valley. In addition to a persistent decrease in the number of working days and multiple mass promotions, it is also the mediocre pedagogical structure of higher education that has dented higher education irreparably.

The university has overburdened itself and has closed the doors on quality teaching and learning experience. Only a few years ago, there were a limited number of seats for a Masters degree programme which were allotted to students based on their performance in the University Entrance Test. Recently, this number was increased without taking into account the infrastructure needed to deal with it. A system of dividing students into Morning and Evening shifts was adopted which brought with it many issues as well. It created some sort of a class divide within stu-

dents wherein those studying in evening shifts were looked down upon for securing less marks in the entrance examinations. This also created an unhealthy learning environment in the university and some departments are still trying to deal with it.

Interestingly, while seats have been increased for Masters Courses, those available for a PhD programme have been very limited. The recent advertisements showed no more than 6-8 seats in PhD or MPhil which makes for a very poor ratio with the number of Masters Graduates. If the seats remain limited even after NEP is implemented, where will the huge number of Postgraduate students go?

Remembering Rahat Indori: The Poet **Who Touched Many Hearts in Kashmir**

The man had had a stunning 50-year poetic career, and was one of the biggest mushaira stars in the subcontinent. Indori's words had always tickled the conscience and pushed for selfintrospection. He had been undoubtedly one of the most loved and popular contemporary Urdu poets in India.

As tributes have been pouring in from all over the world for the celebrity couplet-maker of India, many Kashmiris are hailing him for touching their hearts amidst their dogged distraught state. But the wordsmith of 'Mission Kashmir' fame was more than just a distant poet luring the valley with his verses.

BOUT seven to eight years ago, in an exclusive mushaira (poetry symposium) arranged by the Cultural Forum in Srinagar's Sher-e-Kashmir International Conference Centre (SKICC), Rahat Indori's sharp tongue had aroused resentment in the audience that had just been wooed by his wit and charm a few minutes ago.

"Kashimiriyoon ko apni soch mein tabdeeli laani hogi" (Kashmiri will need to modify and change their way of thinking), the timeless Indian poet had said while touching upon the contentious topic of the conflict in the Valley.

Zareef Ahmad Zareef, who had been a participant at the symposium, remembered the audience's murmurs of discomfort. "People were disappointed at the frivolous statement the man had made," the valley's prominent poet-historian told Kashmir Observer. "No Kashmiri acquiesced to what Indori had said and some asserted in protest that the establishment needs to be civil for the people to accept it."

Quickly realising his misspoken mistake, the poet had apologised with a clarification. "I was trying to put forward my point of view, but you're Kashmiris and the real prey of the system. You know better," Zareef recollects Indori's response to the live listeners he had upset.

However, continuing in a voice powered by grittiness, astuteness, and enveloped in warmth, poet Indori had later kept inspiring awe from his audience

"That day," Zareef says, "the poet proved that he knew a lot about Kashmir and its history.'

As per his memory of the mushaira, Rahat Indori had said: "Development and progress has only taken place by the virtue of love and passion. Force and oppression has never achieved anything but aggravated the pain of people. If Kashmiris are given their basic rights and due justice, why would they have a problem with India? Didn't they join hands after the Partition, with India? But when Sheikh Mohammed Abdullah was jailed in 1953, they began to hate the political establishment in the mainland."

'There're no two ways about that he was an intellectual for India," Zareef says.

The same witty man who once drew and handled the 'militant mood' in Kashmir breathed his last on August 11, hours after he tweeted about his CO-VID-19 positive status.

The 70-year-old 'people's poet' had been admitted to Sri Aurobindo Institute of Medical Sciences, Indore, where he passed away after suffering from a

"Zulfon ki shayari (poetry of romanticism and beauty) was not really his style," Zareef continues. His pen always flowed with words reflecting the societal realities of his time. He was 'waqt shenaaz', a Maqbool, says, "The man was someone who we can



'mushaira shayaar', a 'maqbool'."

The late lyricist would perform as if he controlled his audience and he really did, Zareef says. "He belonged to the rare tribe of poets who could churn heart-searching poetry by gauging the vibe of the audience. The old and young, the happy and grumpy, everyone resonated with his shayari. Even if he has passed away, he is immortal. Artists like him will always be immortal.

In recent times, college activists and anti-CAA protestors had used two lines from his poem titled 'Agar khilaf hai, hone do' as a headliner to their ideology of resistance.

"Sabhi ka khoon shaamil hai yahan ki mitti mein, kisi ke baap ka Hindustan thodi hai" (Everyone's blood is mingled in this earth. Hindustan is no one's ancestral property) - were the lines from the poem that decorated posters and banners in the protests that shook India in the months of November and December last year.

Indori had claimed to have written this poem around 35 years ago. "I don't remember the exact year or the context in which it was written," he said in an interview. "I've recited this ghazal at many mushairas and had even forgotten about it, but I don't know what has happened in the last three to four years that like a crop, these words have risen again." He had also reportedly said that he hadn't written this poem 'as a Muslim'.

Indori had also made a powerful display of his understanding of the Kashmir conflict in the posterworld of Bollywood. Through his poetic lyrics for Vidhu Vinod Chopra's Mission Kashmir (2000), he had touched a chord with many Kashmiris who identified with his rhymes.

He had also penned down the words for the movie's chart-busting 'Bumbro Bumbro' song, which was inspired from prominent Kashmiri poet Dina Nath Nadim's iconic original poem of the same name.

His lyrical poem 'Dhuan Dhuan', which was also used in Chopra's movie, received praise for being

A painter-turned-professor-turned-poet, Indori was known for his sharp-witted one-liners on live stage performances. Before his talent was spotted by the Mumbai film industry, he was a pedagogist of Urdu literature at the Indore University.

(We aren't the leaves that break away from its branches. Tell the storm to mind itself)

In 2015, during the "award wapsi" movement that took shape in the backdrop of the lynching of Mohammad Akhlaq in Dadri, Uttar Pradesh, poet Indori had extended his support by saying, "If I had some government award, I would have returned it in protest."

His unique punchlines, delivered with his trademark expressions, were also very popular with Tik-Tok users and those who did not even understand Urdu poetry.

Earlier this year, when the Chinese video-making application was functional in India, his poem "Bulati hai magar jane ka nahi" went viral on social media, making him an almost-cult figure among young Urdu/Hindi-speaking people in the subcontinent.

People began using a few lines from the poem for making memes and it continued to trend on Twitter, Facebook, Instagram, and Tiktok

"Late Rahat Indoriji will be remembered for his free, fair and fearless poetic expressions," Ghulam Nabi Azad, seasoned congressman from J&K, said.

Due to his viral inquilabi poetry and online mushiaras, countless souls were actually attached to the late poet, Rashid Maqbool says.

The city of culture

The city buzzed with the ideas of boots-on-theground, Antonio Gramsci "organic intellectuals" anxious to put in their two-cents worth. Bookstores proliferated in every neighbourhood. (One street off

Martyrs Square was lined exclusively with them.) Dozens of newspapers and periodicals, in Arabic, English and French, sold off the ubiquitous news-stands.

Movie theatres were everywhere, featuring both fluff from the US, like Pillow Talk, starring Doris Day and Rock Hudson, and art-house, New Wave productions from France, like Alain Resnais's Hiroshima Mon Amour

Heck, you could even splurge on an issue of Cahier du Cinema for 2 Liras — a king's ransom knocked off a teenager's weekly allowance — and later, sitting at Faisal's across from your friends, talk about the work of directors like Goddard, Truffaut and Rivette, showing yourself off as a budding cineaste.

Whichever way you looked, there was constant preoccupation with the life of the mind. It was as if ideas were not a luxury, a frivolous pursuit, but a rigorous need in one's quotidian life.

And it was all, \bar{I} say, laid-back — zestful, engaging, fun. Beirut was a city so laid-back in those days that when, on July 15, 1958, 1,700 US Marines stormed its beaches, ready for combat, weapons cocked, backed by warships in the Mediterranean there to save incumbent President Camille Chamoun from being deposed — they encountered, well, Gee, a whole bunch of Beirutis languidly sunbathing on the beach and teenagers in swimsuits playfully offering to help them set up their equipment.

Propulsive Mediterranean rhythm

That was Beirut then, an urbane city that beat with the propulsive rhythm of the Mediterranean Sea, on whose shore it sat, and the timeless resolution of Mount Lebanon, at whose foot it lay. Beirut then was living a belle époque.

But — yes, there's a but — Beirut, like the rest of the country it was a capital of, was overripe with anarchic compulsions, political, class and sectarian compulsions, simmering beneath the garden surface of a belle époque — as those that acted as the backdrop to Europe's own belle époque showed in 1914 — always have a cruel, preordained equifinality to them.

In short, there had been hotness in the blood and the Lebanese people called for it on the streets. By 1975, these folks had turned on each other in an orgy of self-hate that lasted 15 years and left Lebanon's national soul bruised and mortally wounded.

When the dreaded nitrate explosion devastated the city last week, visiting irremediable suffering on its denizens, the Lebanese people's wounds had not yet healed and their broken spirit had not mended from the conflict. It made for a tragedy all the more crushing, not just for the Lebanese people but for all peoples in the Arab world.

With no European backing, US goes it alone to renew Iran ban

United Nations: As the UN Security Council (UNSC) gears up for a vote on a resolution proposed by the administration of US President Donald Trump to extend an arms embargo on Iran, Washington is increasingly finding itself isolated without even a little help from its European allies.

An opinion piece published by Bloomberg said the Europeans are "disinclined to help the US" at the 15-member Security Council.

"Having needlessly antagonized European leaders from the start of his presidency, Donald Trump cannot now rely on them to back the US in any effort to prevent the Islamic Republic from acquiring powerful new weapons," the report said.

The US has circulated a revised resolution to keep in place a UN arms embargo on Iran, which is set to expire on October 18 under UNSC Resolution 2231 that enshrined the 2015 multilateral nuclear deal.

The Trump administration was forced to water down its first proposal, which required other countries to join the US in sanctioning individuals and entities as well as interdicting cargo to and from Iran.

The new draft is just four paragraphs compared to the original seven-page, 35-para-

graph resolution.

It also calls for the weapons ban on Iran to be extended "until the Security Council decides otherwise.'

The Bloomberg piece predicted that Germany, France and Britain "will more than likely back, whether by acclamation or acquiescence, the efforts of China and Russia to sell tanks, missiles and fighter jets" to the Islamic Republic after the embargo expires.

"This would be the diplomatic equivalent to cutting one's nose off to spite one's face. The European leaders will in effect be acting as unpaid agents for Chinese and Russian weapons makers, since their own arms producers will still feel constrained by American sanctions. In exchange for betraying their principles, they'll merely enjoy a measure of schadenfreude: the sight of the Trump administration's humiliation in the Security Council." it added.

In case of a failure to renew the Iranian arms embargo, the US will likely try to trigger the so-called snapback of the UN sanctions, which had been in place against Iran prior to the nuclear accord's inking.

This is while Washington forfeited its right to invoke the provision in 2018, when it pulled out of the nuclear accord — officially known as the Joint Comprehensive Plan of

Judicial proceedings are to take place in the country's military courts, which Human Rights Watch and other rights groups have shown do not conform to standards on due process.

Rights groups have raised serious concerns about the state of emergency, saying it 2,750 tonnes of dangerous chemicals left in storage at Beirut's port for nearly seven years, with the knowledge of top secu rity and political officials.

'Room for protest'

Citing the "militarization of the state", parliamentarian Osama Saad was the only one out of the 119-member chamber, a reduced number after the resignation of nine MPs since the explosion, to oppose the state of emergency.

Speaker Parliament Nabih Berri responded the army had "not taken steps that people fear, nor suppress television [channels] and despite the chaos in the media it did not intervene and left room for protest", according to local media. Sessions are not televised and, therefore, statements by lawmakers are carried by local media.



Trump has left US 'in tatters', Biden and Harris say

Washington: Presumptive US Democratic presidential nominee Joe Biden and running mate Kamala Harris have launched a stinging attack on President Donald Trump. saying he has left the nation "in tatters" as Americans are "crying out for leadership" to overcome the triple crisis of the COVID-19 pandemic, racial injustice and a ravaged

Making their first appearance as running mates at a Delaware high school, Biden and the newly-minted vice presidential nominee vowed to end Trump's presidency and "rebuild this country."

Harris said, "This is a moment of real consequence for America. Everything we care about, our economy, our health, our children, the kind of country we live in, it's all on

The 55-year-old California senator and a daughter of im-

migrants attacked the US president as an incompetent leader, saying Trump "just isn't up for the job," as the country is at the crossroads.

She said "Trump inherited the longest economic expansion in history from Barack Obama and Joe Biden. And then, he ran the US economy straight into the ground."

"yet we have a president who cares more about himself than the people who elected him," she said.

The case against Donald Trump and Mike Pence is open and shut," said the former California attorney general as she blasted Trump's "failures of leadership" on containing the coronavirus pandemic.

Harris also tapped into the nationwide protests over racial disparities and police violence, saying "we're experiencing a moral reckoning with racism and systemic injustice that has brought a new coalition of conscience to the streets of our country demanding change."

The former vice-president, who will face Trump in November's election, promised that a Biden-Harris administration will do what it takes to "turn the corner on this pandemic.'

Biden, 77, announced Harris as his running mate on Tuesday afternoon, thrilling black lawmakers and activists and drawing enthusiasm for the Democratic ticket

He said, in their first joint appearance on Wednesday, Harris' story as the child of immigrants and a woman of color who fought her way to the top ranks of US legal and political circles would inspire the country.

"Don't Complain, Do Something": What **Kamala Harris Learnt From Her Mother**

ashington: Taking the center stage of American politics for the first time after becoming the presumptive vice-presidential nominee of the Democratic party, Indian-origin Senator Kamala Harris remembered her mother Shyamala Gopalan. saying it was she who taught her not to sit and complain about things during the time of problem but do something to improve it.

Presumptive Democratic party presidential nominee Joe Biden on Tuesday named 55-vear-old Harris as his vice presidential running mate, making history by selecting the first black woman to compete on a major party's presidential ticket.

Making her first appearance along with Biden in Wilmington in Delaware, Harris said her mother had a great role in her life.

'My mother, Shyamala, raised my sister Maya and me to believe that it was up to us, and every generation of Americans, to keep on marching. She'd tell us, Don't



sit around and complain about things, do something," Harris during her appearance in Wilmington, Delaware.

Harris, whose father is from Jamaica and mother an Indian, is currently the US Senator from California.

"You know, my mother and father, they came from opposite sides of the world to ar-

rive in America, one from India and the other from Jamaica, in search of a world-class education," she said.

senior leader of the outlawed Muslim Brotherhood movement has died of a heart attack in the notorious Tora Prison in Cairo, Egyptian security sources have said. Essam el-Erian, who was sen-

tenced to several life sentences following the military coup against Egypt's first democratically elected president Mohamed Morsi, died at the age

El-Erian had been moved to a prison hospital after suffering a heart attack and died during treatment, two prison sources told Reuters news agency

'We were informed of his death by prison authorities ... they told us the death was natural," a lawyer representing the Muslim Brotherhood, Abdel Moneim Abdel-Magsoud, said in a statement to local media.

He said he received a call on Wednesday from the prison authority informing him of



"I don't know whether he died in prison or in hospital," he told Anadolu news agency. "I informed his family of his death to start the funeral procedures.'

According to Abdul-Maqsoud, he and el-Erian's family have not been able to see him for about six months after the

authorities suspended visits to prisons, claiming a precautionary measure to combat the coronavirus.

El-Erian had complained in previous court sessions of being prevented from treatment and being subjected to medical negligence. Egypt's public prosecutor had no immediate comment.

Relatives of other high-profile Islamist prisoners at Tora had previously raised concerns about their health, saying they were being held in poor conditions without adequate healthcare. Egyptian authorities have denied mistreating prisoners or neglecting

Amid Covid, Some Conflict Actors "Sponsor Opportunistic Terror": India At UN

that some conflict actors are exploiting the current uncertain climate to press their agendas through misinformation and even sponsor opportunistic terrorist attacks.

The COVID-19 pandemic has adversely impacted the initiatives that contribute to peacebuilding and exacerbated conflict situations, India said in a statement at a high-level open debate of the UN Security Council on 'Pandemics and the Challenges of Sustaining Peace". "We are in the midst of



the COVID-19 pandemic that has caused global disruption on a scale that has not been experienced before by this generation," it said. "The pandemic is still raging and its implications, though hard to foretell in exact terms, is certain to be profound and multidimensional," it said.

India recalled that UN Secretary-General Antonio Guterres had outlined several trends related to the pandemic with implications for conflict prevention, including erosion of trust in public institutions and rise in societal tensions associated with national government's response measures.

"Some conflict actors are also exploiting the current climate of uncertainty to a matter of greater conflict. press their agendas, including through the spread of misinformation to foment discord and violence and even sponsor opportunistic terrorist attacks," India said in the statement. India further stressed that peacebuilders must mobilise to identify and counter misinformation.

"Community engagement and effective communication are critical to combat the 'infodemic" of false information that often drives fear and division," the country said. India, which is among the largest troop-contributing countries to the UN peacekeep-

UNITED NATIONS: India at ing operations, highlighted that the UN said on Wednesday the pandemic has impacted adversely almost all initiatives which usually go on to contribute to peacebuilding.

"In some ways, it has served to exacerbate conflict situations to the extent that we now have to tackle more strife and conflict as well as a growing humanitarian crisis rather than address some of the other important issues relating to peacebuilding.

"This is where our current challenge lies. How do we prioritise between various needs?" it said. India underlined the need for national governments to support and engage local peacebuilders to help design and lead CO-VID-19 sensitisation and response efforts "to help mitigate further conflict, prevent violence, adapt and sustain peace processes, and rebuild social cohesion."

Also of "vital importance" is that efforts are focused towards preventing a "lapse and relapse" into conflict.

"Poverty and lack of opportunity pose some of the most formidable barriers to sustainable peace. Development is, therefore, critical and should have the attention of the international community," it said.

In the context of the pandemic, India suggested that the immediate focus of the international community should be on ensuring that the humanitarian needs of the community, which are in a conflict, are met so that lack of availability of minimum needs itself does not become

Further, India underlined that if peacebuilding has to endure then it should rest on institutions and not on individuals.

"Consequently, strengthening of national institutions combined with strengthening of democratic structures should not be compromised in the face of the crisis brought about by the pandemic," the country said, adding that "it is only when institutions are strong, and other factors, like addressing equitably the needs of the conflicted communities and strengthening of human rights, can be effective.'

Supreme Court Allows Prashant Bhushan, Others To Withdraw Plea On Contempt Law

NEW DELHI: The Supreme Court Thursday allowed former Union minister Arun Shourie, veteran journalist N Ram and activist-lawyer Prashant Bhushan to withdraw their plea challenging the constitutional validity of a legal provision dealing with criminal contempt.

A bench headed by Justice Arun Mishra was informed by senior advocate Rajeev Dhavan, who was representing the petitioners, that they want to withdraw the plea as several petitions on the same issue are pending before the anex court and they don't want "this to be entangled" with them.

The bench, also comprising Jus- and K M Joseph. tices BR Gavai and Krishna Murari, allowed the petition to be withdrawn with liberty to the petitioners to approach the appropriate judicial forum, except the apex court.

During the brief hearing conducted through video-conferencing, Dhavan said that at this stage the petitioners want to withdraw the plea with liberty to approach the top court again, maybe after two months.

The petitioners had challenged the constitutional validity of a legal provision dealing with criminal contempt for "scandalizing the court", saying it was violative of freedom of speech and right to equality.

The petition had challenged the validity of Section 2(1)(c) of the Contempt of Courts Act, 1971 as being vague, unconstitutional and incompatible with the basic features of the Constitution.

The provision defines what constitutes criminal contempt and says that if by way of publication of words, the dignity of the courts is lowered and if they scandalize the courts then the offence of contempt of court is deemed to have been committed.

The petition alleged the provision iolated the freedom of speech and expression.

The filing of the plea challenging the validity of the provision assumed significance in view of the fact that a bench headed by Justice Mishra on July 22 had issued a show cause notice to Bhushan after taking note of a petition urging it to initiate criminal contempt proceedings against him for his alleged tweets against the judiciary.

The apex court had on August 5 reserved its verdict on the suo motu contempt case against Bhushan.

The top court is also seized of another criminal contempt case against Bhushan which was initiated in 2009 over his alleged comments against former CIIs in an interview given to a magazine.

The top court on August 10 had said further hearing was required in the 2009 criminal contempt case against Bhushan and journalist Taments on "corruption" against judges per se amounted to contempt or not.
