Guns Roar Along LoC In Rajouri

Jammu: The India and Pakistan troops on Wednesday traded heavy gunfire along the Line of Control (LoC) in Raiouri district of Jammu and Kashmir. Pakistan Army violated ceasefire by resorting to heavy firing and mortar shelling in forward areas along the LoC in Rajouri district, prompting a befitting retaliation from the forces, officials said. "At about 1630 hours today, Pak army initiated unprovoked ceasefire violation by firing with small arms and intense shelling with mortars along the LoC in Keri Battal area of Sunderbani sector." defence spokesperson said. Youth Found Dead In Handwara

Srinagar: A youth on Wednesday was found dead in Handwara town of the frontier Kupwara district. 24-year-old Aamir Suhail of Kargam village was found dead near the bus stand Handwara on Wednesday by the locals, a police officer said. He said a police team instantly reached the spot after receiving information from the locals. "A case under relevant sections of law has been registered and further investigation taken up," the officer told GNS.

Labourer Drowns In Jhelum

Srinagar: A young labourer on Wednesday died of drowning while extracting sand in river Jehlum in Pulwama district of south Kashmir. 20-year-old Irshad Ahmad Sheikh was extracting sand from Jhelum near Sombura bridge in Kakpora, Pulwama when he slipped into the river, official sources said. Several vouth jumped into the river to save the Sheikh from drowning. However, after hectic efforts, they retrieved the lifeless body of the labourer. Sheikh's body was handed over to his family for final rites after completion of legal-medico formalities.

9-Day Old Militant Killed In Shopian Encounter

Handwara Gunfight Leaves Lashkar Commander, Aide Dead

SRINAGAR: Two Lashkar-e-Taiba militants and a nine-day-old Hizbul Mujahideen recruit were killed on Wednesday in two separate encounters with government forces in Shopian and Kupwara districts of the Valley. A teenager, who joined militant ranks just nine days back, was killed in a brief encounter in Molu Chitragam area of Shopian this afternoon, a police official said.

The state forces, he said launched a cordon and search operation in Molu Chitragam area of Shopian after receiving specific information about the presence of militants in the area.

He said the search operation turned into an encounter after the militants opened fire at a search party of the forces, who retaliated. In the ensuing exchange of fire, one militant was killed, the official said. However, two other militants reportedly managed to escape from the encounter spot, reported GNS quoting sources.

The report identified the militant as Talib Hussain Mir son of Nissar Ahmad Mir, a resident of

Govt Orders Pull Out Of 10,000 Troops From J&K

NEW DELHI: The Centre on Wednesday ordered "immediate" withdrawal of about 10,000 paramilitary personnel from the Union Territory of Jammu and Kashmir, officials said.

This is the biggest de-induction of these forces after additional troops were rushed to the UT post the abrogation of the Article 370 of the Constitution that gave the erstwhile state a unique status.

They said the decision was taken after the Ministry of Home Affairs reviewed the deployment of the Central Armed Police Forces (CAPFs) in the union territory (UT). The Home Ministry had last with-

drawn 10 CAPF companies from the UT in May, while 72 such units were taken out in December last year.

A senior official said that a total of 100 CAPF companies have been ordered to be withdrawn "immediately" on Wednesday and they have been asked to revert to their base locations in the country. • P-02

7000 Bunkers Come-up Along LoC, IB In Jammu

Govt Orders Pull Out...

As per the directions, a total of 40 companies of the Central Reserve Police Force (CRPF) and 20 each of the Central Industrial Security Force, the Border Security Force and the Sashastra Seema Bal, will be taken out from Jammu and Kashmir by this week. The CRPF has been asked to make arrangements for air lifting of these units to Delhi and other locations, they said.

A CAPF company has an operational strength of about 100 personnel. "The units that are being withdrawn are deployed both in Jammu and Srinagar. It was felt that the counter-insurgency and counter-militancy grid is intact in the UT and these additional units that were sent in last year can be deinducted giving them the much required rest, recuperation and training," a senior CAPF officer said. Also, he said, with the winters soon setting in, it would have been an onerous task to keep these units in make-shift and temporary dwelling units especially in the Kashmir valley region. With the latest de-induction, the lead counter-militancy force CRPF will have a strength of about 60 battalions (about 1,000 personnel in each bat-

talion) in the Kashmir valley apart from very few units of the other CAPFs.

pneumonia, diabetes and acute kidney injury, a doctor at the hospital told said that the septuagenarian's condition deteriorated and today he developed bradycardia followed by cardiac arrest. "He died at around 8 a.m.," the doctor added. A 60-year-old woman from Lal Chowk here who was suffering from hypertension, diabetes and Hypothyroid besides pneumonia died due to cardiac arrest at CD hospital at 4: 50 p.m. today. Also a 65-year-old woman from Hawal died due to the virus, officials said. Two other Budgam residents— a nonagenarian woman from Budibagh Choon and a 65-year-old resident from Malpora Chadoora-died last night, they added. Among three deaths reported from Kupwara includes an 80-year-old of Tanghdar Kupwara who was admitted to SMHS hospital on August 16 and diagnosed with bilateral CAP with "hypoxemia" died this afternoon. Regarding fatality from Shopian, they said, a 70-year-old woman from Wachi died at Government Medical College Anantnag few days ago and was included in the official list along with that of a resident from Baramulla and two other residents from Kupwara. With these deaths, officials said, 581 people have succumbed to the virus in Jammu and Kashmir so far—539 from the Valley and 41 from Jammu division. (GNS)

Giving district-wise breakup of the cases, official sources said that Srinagar reported 229 new cases, Baramulla 35, Pulwama 24, Budgam 88, Anantnag 48, Kulgam 19, Shopian 10, Kupwara 43, Bandipora 48, Ganderbal 62, Jammu 41, Rajouri 4, Kathua 4, Udhampur 2, Ramban 2, Samba 10, Doda 3, Poonch 1, Reasi 34 and Kishtwar 1. In Kashmir, Srinagar tops the list with 7253 cases followed by Baramulla with 2510, Pulwama 2146, Budgam 1922, Kulgam 1747, Shopian 1589, Anantnag 1905, Kupwara 1680, Bandipora 1583 and Ganderbal 1051. In Jammu division, Jammu district has 2074 cases, Rajouri 794, Ramban 631, Kathua 681, Udhampur 664, Samba 599, Doda 350, Poonch 333, Reasi 336 and Kishtwar 186.

Moreover, sources said 611 more COVID-19 patients have recovered and were discharged from various hospitals, 175 from Jammu Division and 436 from Kashmir Valley.

Police had also filed a case under section 153A IPC (promoting enmity between different groups) and 295A IPC (deliberate and malicious acts, intended to outrage religious feelings of any class by insulting its religion or religious beliefs) at Pacca Danga police station.

Meanwhile, anger against the blasphemous video also triggered protests in border area of Uri and Karnah.

According to reports, scores of villagers from Dhani, Choolan, and Gingal in the border town Uri today hit the streets and staged a protest against the members of the extremist group. Chanting pro-Islam slogans, the protesters demanded exemplary punishment for those elements who hurt the sentiments of Muslims.

Similar reports were also received from Karnah area of border district Kupwara, where scores of people, including traders took out a protest march against the blasphemous remarks. The protesters later dispersed peacefully.

NC Calls Meet To Test Govt's ...

on part of the government, the party president Farooq Abdullah has invited senior party members including Ali Mohammad Sagar, Abdul Rahim Rather, Mohammad Shafi Uri and Nasir Aslam Wani for a meeting at his residence on 20.8.2020 at 5 pm," it said. The party also made it clear that it is mindful of the present pandemic and accordingly the meeting with various leaders that have been under detention will be done in batches of four members per meeting. "Needless to add that all standard operating procedures shall be strictly followed by all concerned," the party statement said. The party is hopeful that the liberty of the members under detention is now absolute and the meeting will be held successfully on the appointed day, it said. The Abdullah father-son duo had filed a bunch of habeas corpus petitions on July 13 seeking their release.

A habeas corpus is a writ requiring a person under arrest to be brought before a judge or into court, especially to secure the person's release unless lawful grounds are shown for their detention.

Filing the replies before the High Court earlier this month, senior additional advocate general Bashir Ahmad Dar said the contention of the pleas was "not only surprising but shocking as well" as there were neither any legal proceedings underway nor was it being contemplated.

The similarly worded replies, vetted by Inspector General of Police (Kashmir range), however, said in the wake of Constitutional amendments carried out in the Article 370, "it was apprehended that inimical elements may disturb the peace" and the leaders "may provoke them to cause aggravation in the disturbance".

However, no order of detention either under preventive detention law or substantive law was issued against the party leaders, it said, adding, the leaders were free to move with certain precautions "as deemed fit" for their security

The reply said the petitioner being a categorised person has been advised not to visit any vulnerable areas without informing the concerned authorities" and reasoned that it was to ensure proper security.

The Abdullahs had filed 16 petitions on July 13 for as many NC leaders contending that they were being held in "brazen violation" of Constitutional guarantees of the right to liberty.

they turn to bodies like ours."

The victims who come in are generally very confused and nervous about the consequences of their complaints with the third-party. Torn between giving their abusers a 'second chance' and their innate wish to 'move on', the victims reportedly have a hard time choosing from the variety of redressal options placed in front of them by professionals at these nongovernmental organisations.

'This is where the 'counseling' part comes in," Qureshi continued. "Our legal professionals explain all the options to the complainant. She may file a court case, or an FIR with the police, or get us to intervene with the abusers or her own family which may be acting as a barrier. We negotiate and single out the best solution and help the victim's case."

Sometimes, these women are also presented with all the options and then given the time to think and choose the one they deem best. "Our job is to assure them that 'we are here for them' as long as they want help," Qureshi said. Backing Qureshi's views and women welfare work, Sabreena Bhat said that in spite of SCPWCR's presence in the past, women preferred to reach out to NGOs, like Mehram, for their issues. "Be that as it may, the final destination for the files that such NGOs would compile would be the SCPWCR's office until it was functional," the writer mentioned.

At the end of the day, the NGOs would send all the troubles and complaints back to the apex office for its perusal. But now, with the body no more, all of the pending and existing cases that were stocked in the former state's folders are in the NCW office.

Calling the NCW a "disaster", Qureshi narrated her personal ordeal with the central body. "Somebody I knew had been incessantly harassed and there was a threat to her life. The police in Srinagar refused to file an FIR, so I had to contact the NCW for help. I kept calling on all numbers that were displayed on their website but no one picked up. I remember spending a good 2-3 hours on this. Finally, I took to Twitter and tagged the NCW and wrote my complaint online."

It was only then that the NCW responded to Qureshi assuring her a reply after a short while. "This happened in the last week of May. The point of reaching the NCW was to get my contact's case registered in absence of any local help," she said.

Ironically, the NCW redirected her complaint, via email, back to Kashmir, to the SP's (Superintendent of Police) office. Qureshi even went to check on the status of the case at the office but was told to go to another 'office' where the complaint was supposed to have been sent.

"Why do I have to go around from one office to another when the NCW had clearly said in their email that the complaint was sent to the SP? The SP's office had asked me to go to a few places with the printout of the original email. What I am trying to underline here is that the process with the NCW is not at all streamlined and I do not even have an update on my complaint till now," she sighed.

In the email, the NCW had stated that Qureshi's complaint was a timebound issue and the police must respond within 30 days of its filing. But even after the passage of a lot of time, she does not have an inkling about its status. "I followed up too, but it was of no use."

Hameeda Nayeem, a prominent civil society member and retired English professor based in Srinagar, maintained that she had always dismissed the commission as "she never thought that it had ever resolved anything.'

She said that the SCPWCR only had "nominal and cosmetic value" in the Valley. "Woh bas daastaan sunte the, mujhe nahi lagta kaam kuch hota tha" (they would only listen to our stories, and I do not think that they ever did much).

"How will they?" she questioned, "It has all been a business appointed and conducted by New Delhi in Kashmir. Through these commissions they barely ever resolved the issues of women and only sought to achieve control over the population," the fiery professor said.

Discussing the next possible course of action in Kashmir, Naveema Mehjoor believed that it was foolish to make another commission after wiping out the old one.

Interestingly, Rekha Sharma, the chairperson of the National Commission for Women, while speaking to the Indian media a while back had said, "Jammu and Kashmir will have its own Women's Commission once the elections will be held in J&K and an Assembly will be constituted."

"As an old officer in the administrative setup, I do not wish to see another commission but the reinstatement of Article 370," Mehjoor, the ex-commissioner, said. "The dialogue between women can only begin once the special status is back and not without it."

But until the political processes kickstart, the biggest issue remains the inability of victims to free themselves of the abuse, even when they wanted to, Sabreena Bhat said.

"Kashmiri women are unaware of their rights," she said. "The general response by a Kashmiri woman, bred in this society, to her husband shouting at her would be: 'if not at me, then at whom will he shout?' I know women who are highly qualified and very outspoken in their professional field but are married to physically abusive partners and keep their mouth shut about it."

In her view, young girls need to be educated and taught the basic difference between protecting the family's honour and protecting themselves. "In Kashmir people follow a lot of traditions and customs. These things are given more importance than religion at times. Outsiders paint the Kashmiri society as religiously extreme, but they do not know that when it comes to cultural traditions, Kashmiris overlook even religion," Bhat shared. She also asserted that the common perception: 'mard toh mard hai, woh kuch bhi kar sakta hai' (a man is a man, and hence he can do anything) is "the real rot in the system that needs to be ripped off" before any more discussions on women's rights can be conducted.

There is no infringement or brazen violation of the law as claimed in the petition. "The respondents have shown utmost respect for the law of the land," it said and pleaded for dismissal of the petition with costs.

The party leadership moved the High Court after the petitions of these detained leaders to the Home Secretary of Union Territory on June 30 seeking removal of restriction on their movement and set them at "absolute liberty" remained unanswered.

The party, before moving the High Court, had expressed hope that the legal system will come to the rescue of their colleagues, who have been suffering for no fault ever since the abrogation of provisions of Art 370, Art 35A on August 5, 2019.

In the meeting, he said it was further apprised that in Rajouri, of the total 3141 bunkers (2806 individual, 335 community) 2483 bunkers (2264 individual, 219 community) have been completed till date, while in Poonch of the total 1188 bunkers (500 individual, 688 community) 903 bunkers (408 individual, 495 community) have been completed so far. He said that the Div Com directed the concerned officers for close monitoring the construction of bunkers.

In the absence of a watchdog-like body for her issues, a woman named Sharifa who wants freedom and justice for her two kids from the clutches of her torturous in-laws has been running pillar to post for some redressal. Recently, she reached out to a female lawyer with the hope to obtain some help.

Since her marriage in 2014, she said, her in-laws have been harassing her to the point that they even tried to strangle her to death. She survived but she has had to listen to abuses consistently.

Sharifa said her husband also subjected her to domestic violence which even caused her a miscarriage during her first pregnancy. "He was involved in an extramarital affair." she said, and in order to hide it, her inlaws have tried to defame her in society by calling her characterless. She had lodged a police complaint against the accused but there was no action taken. She hopes for justice but due to the official apathy, her pain persists. Also, to add to her plight, her husband wants to end terms with her and her in-laws have also filed a case against her. She is in such deep distress that sometimes she wishes to commit suicide and have everything end in a single go.

Elaborating on such incapacitation of Kashmiri women, Sabreena Bhat, too, noted that, "Even if Kashmiri women (generally speaking) did not visit the commission enthusiastically for solving their problems, just knowing that they had an option was enough support."

Since women in Kashmir are bred in a highly patriarchal society, going out of the bounds of their homes to report instances of domestic abuse or violence was a very big thing for them, she said.

"But at least they had the option," she stressed. "Now, without the existence of such a body, we've nowhere to go. It goes without saying that this move has affected women and their safety a lot."

Notably, in the two-month period of the 'world's strictest' COVID-19 lockdown, announced by Prime Minister Narendra Modi on the eve of March 24, Jammu and Kashmir reported 16 cases of rape and 4 cases of molestation. Needless to say, since these victims do not have a statutory professional body to seek support from, they are "left in a vacuum of sorts" as per Dr Touseef Rizvi, a psychology professor at Kashmir University.

"For the perpetrators, there's nothing to act as a deterrent," Dr Rizvi told Kashmir Observer. "Previously, they knew that their female housemates had the option of availing the services of the commission and that did serve as a deterrent." In absence of the commission, Arshie Qureshi's Mehram, the organisation working to provide legal aid to women suffering from gender-based violence, has stretched the duties of the employees beyond the stated purpose now.

"We also need to provide psychological support to the victims and brainstorm about different ways in which we can engage with society to start a dialogue about these issues," she said.

Last year, when all the communication lines were severed in the valley, social impact workers had trouble in helping and identifying victims of gender-based violence. In a few rare cases, the women would manage to come to them with their problems. If they knew the residential address of the worker, they would directly come to their homes. Some who managed to get their hands on a landline would try to reach out to their "Kashmiri sisters" placed outside of the Valley to narrate their ordeals. "It's important to know that women only use such 'third-party options'. for redressal, when all the other options that are immediately accessible to them turn out to be useless," Qureshi further explained.

"Whenever there is an incident of violence, the family members try to resolve it at the familial level. If that does not work, then it is taken up at the community level. When they cross and exhaust all these avenues

ACB Books Seven For Illegal...

Municipal Committee (MC) Katra, Ravi Kumar; then Inspector MC Katra. presently posted as KhilafWarzi officer MC Samba, Ashwani Kumar; and then president MC KatraMulkh Raj Sharma.

Jugal Kishore of Udhampur, and Sat Paul and KailashNathPangotra of Jammu were the other persons named in the FIR, the spokesman said. The case was registered following a preliminary inquiry by the ACB regarding the role of MC Katra officials and revenue department Katra after a commercial superstructure was erected on a state land measuring five Marlas in Katra town by Satpal in violation of the provisions of J&K Control of Building Operation Act (COBA), 1988.

"The inquiry revealed that the piece of land in question was allotted to one Fazlu in 1964 under a scheme to rehabilitate the landless downtrodden community of sweepers. But the ownership rights regarding the said land were never conferred upon him and therefore, the same could not be sold to any person," the spokesman said.

In 1999, he said, thenNaibTehsildar Nek Ram, without any legal justification, changed entries with respect to the land and entered the name of one Jugal Kishore, who subsequently raised the double storey superstructure over the said land without obtaining building permission from the MC Katra.

It has also been found that on March 22, 2006, Kishore sold the land along with the erected structure to Sat Paul and Pangotra for consideration of Rs 11 lakh through an agreement to sell, duly notarized, however no change was effected in the revenue records in favour of Sat Paul and KailashNath, the spokesman said.

He said notices under various sections of the J&K Control of Building Operation Act were issued by the Municipal Committee Katra clandestinely in the name of Ashok Kumar in connection with the construction.

Taking advantage of the "clandestine and superficial process" adopted by MC Katra, Kishore approached the MC for a proper building permission, whereby, his application for building permission with incomplete documents were also issued and shown dispatched.

"The inquiry also revealed that due to deliberate inaction on part of Municipal Authorities Katra, the construction work was allowed to continue under the garb of the pendency of application for permission," the ACB spokesman said.

However, a fresh report was submitted by KhilafWarzi Inspector wherein illegal construction of Guest House with changed nomenclature was reported, whereupon again a notice was issued to Sat Paul and Kailash-Nath to discontinue the construction and show cause as to why the illegal construction be not demolished.

SRINAGAR, AUGUST 19: Setting the tone and tenor of Government's relentless pursuit towards ensuring extensive development across J&K, the Lieutenant Governor, Manoj Sinha today while reviewing the developmental scenario in Baramulla District, approved 21 crore funding under JKIDFC for completing Jetty Bridge awaiting completion for 22 Years and directed for completion of the project within 2 years.

While interacting with scores of deputations at the District Headquarters, the Lt Governor took immediate cognizance of the demands related to various works of immediate public utility and announced Rs 50 lakhs as first installment of Untied Grant to all Deputy Commissioners across J&K for taking up the same on priority and to accentuate the overall developmental ecosystem in the UT.

The Lt Governor during the visit took a comprehensive assessment of the development scenario and other important local issues. At the outset, the Lt Governor inspected Government Medical College Baramulla and took the first hand appraisal of the pace of the construction work. He was informed that the College is being developed at an estimated cost of Rs 139 crore and shall be completed by July 2021. He directed the concerned agencies to expedite the pace of work so that it is completed within the stipulated

time frame.

The Lt Governor also visited Dak Bungalow where he distributed Special Aids and Appliances among 10 children with special needs under Samagra Shiksha. He evinced keen interest about the well-being of these children and directed the officers to provide the best possible facilities to them.

During the Development Review meeting, Deputy Commissioner, Baramulla, Dr. G.N. Itoo gave a detailed Power-Point presentation of the various ongoing developmental works being executed by different departments in the district. He also informed the Lt Governor about the achievements that have been recorded in different sectors.

On achievements made under PMG-SY, he informed the chair that all the unconnected habitations in Baramulla will be covered under PMGSY by March, 2021. During the review, the Lt Governor

directed the officers to formulate District Capex Plans after a holistic assessment of the developmental needs of the District so that the allocation is utilized in the most efficient way thereby addressing the needs of the common people. Public to pay for Hizb decision: RR

RINAGAR: Fear has gripped several Sopore localities after a Rashtriya Rifles (RR) officer warned locals that common people would have to pay dearly for the cease-fire withdrawal by the Hizb-ul-Mujahideen, news agency, KPS reported from Sopore today.

The threat came this morning when residents of Seelu found themselves under a security forces cordon following a night during which they kept up a fearful barrage of gunfire, reports from Sopore said.

Inhabitants were ordered to assemble in the open and village elders told to use the public address systems in mosques to announce that people would now be penalised for the Hizb decision to revoke the cease-fire, the report said. An officer of the 22nd Rashtriya Rifles told the assembled villagers to co-operate with the security forces and keep them informed about militants'; movements, threatening that the entire locality would be razed to the ground if the security forces came under a militant attack.

Congress needs a new leader

Romer Congress president Rahul Gandhi has once again made it clear that he won't be taking over as the party's new president and would want a non-Gandhi chief as new Congress leader. His stand has been endorsed by his sister, AICC general secretary Priyanka Gandhi. According to Priyanka if the new Congress chief shifts her from Uttar Pradesh where she has currently been posted by her party to Andaman Nicobar, she will happily go. It has been a year since Gandhi resigned as the Congress president after his party suffered a humiliating loss to the BJP in last year's national election. Congress could just muster 54 seats against the BJPs landslide victory of over 300 seats.

Ever since Congress fortunes have only further plummeted. The BJP continues to reign supreme. A recent India Today survey found out that Narendra Modi is India's best Prime Minister and Yogi Adityanath was the best Chief Minister. In fact, 66 percent of those polled said that Modi will be a good Prime Minister for the next term as well while Rahul Gandhi got just 8 percent votes.

The BJP has received a tremendous popular boost after it accomplished a series of once unthinkable ideological projects like revocation of Article 370 in Kashmir and the inauguration of Ram Mandir at Ayodhya. And by the time the next election draws around, the BJP is further expected to further consolidate its hold on the electorate. That is, if Congress remains as rudderless and adrift as it does now.

For the past year, Congress has Sonia Gandhi as an interim president. The prospect of a non-Gandhi president taking over has turned out to be elusive. For all the talk of Rahul Gandhi and his sister, there has been no visible effort for the election of a new Congress president. This, despite the fact that several senior Congress leaders have dis-

Ataturk was Islamophobic Statesman

He turned Turkey into an isolated nation-state bereft of its deep Islamic roots and rich Ottoman culture

> he August 8 issue of Kashmir Observer carried an opinion piece called "Ataturk and the Question of Hagia Sofia" written by Faheem Jeelani Gundroo.

Before examining the reason behind Ataturk's conversion of Hagia Sofia into a museum, the author sets out to clear the "crusty old bird misconstruction" that Mustafa Kemal was westernised. To foreground his military acumen and leadership, he is compared to the great 12th century Muslim military leader Saladin.

Further, as in awe of Ataturk, my friend dives ahead to draw another comparison. This time, in my opinion, an overblown one. He considers him to be the modern interpretation of Khalid Bin Waleed (Peace be upon him), one of the greatest military generals in history, who the Prophet called Saifullah or the Sword of Allah after the battle of Mutah.

These comparisons conjure up Jonathan Phillips's biography of Saladin, in which he quotes I. Gershoni and J.P. Jankowski's "Egypt, Islam and the Arabs",

"In September 1922, rumors began to circulate in Egypt that Kemal might start a jihad to liberate Egypt from the British. "Poets and illustrators compared him to the Prophet's companion and great general, Khalid bin al-Waleed, and to Saladin".

One wonders what those poets and illustrators would have had to say after Ataturk's modernisation of Turkey!

In 1902, when the results were out at the Royal Military Academy, Mustafa Kemal was number eight among Four hundred and fifty nine cadets. He had graduated with proverbial flying colors. By that time, the curriculum at the academy had come quite close to that of European institutions; majorly at the expense of religious subjects like Persian and Arabic. The academy had been molded by the military and bureaucratic reforms of the early nineteenth century with the goal to churn out educated men with professional militarism instead of ordinary educated citizens.

The spheres of study were heavily influenced by French and later German disciplines as well. Around 1883-1884, the famous German theorist Colmar Von der Goltz visited the academy at the sultan's invitation and helped transform the academv on the lines of the German institution, Kriegsakademie of Berlin. Along with the introduction of algebra and other technical disciplines, Goltz laid special emphasis on the role of military in the society. In his book, "Das Volk in Waffen" or The Nation in Arms, he had argued that war was inevitable between nations and it was an indispensable duty of the military to encompass all the spheres of the society in their role to defend and drive the nation. In other words, the military was to be the elite class of the society. Glotz's ideas of a distinguished military class were not fulfilled until the Young Turk Revolution of 1908. "It was therefore ironic", writes Klaus Kreiser in his biography of Ataturk that, "Goltz's ideas gained more currency in the Ottoman Empire than they did in his native Germany' By 1908, the idea touted by Goltz was embedded in almost every Ottoman officer's mind. The idea that they had the duty of transforming the nation and that they were, in fact, the elite among the commoners. After graduating from the academy, Mustafa Kemal had earned good respect in this "privileged class".

By 1907, this class was quite sympathetic to Goltz's ideas but was also aware that the Ottoman state was a polyethnic empire with a diverse set of social mores and traditions. In 1907, Ataturk proposed that Ottoman Empire should dissolve itself in order to make way for population exchanges which would in turn give way to the Turkish state. From then on, the prime priority was to vouch for Turkish nationalism.

The victory of Japan over Russia cemented Kemal's view of a national consciousness. The Balkan wars of 1912-13 had exposed the loopholes in the Ottoman military, following which the government invited Lieutenant General Otto Liman von Sanders for a thorough restructuring of the army across the ranks. World War I was verging on and the Ottoman army proved their mettle with a valorous determination. After the war, the old school officers who were sympathizers of the sultan got sidelined and young officers of Kemal Ataturk's generation got promoted to important positions. In 1915, Lieutenant Colonel Mustafa

Kemal took charge of a division. However, these military men considered themselves to be a class apart from the masses. Many historians have stated that these young men were attracted to Gustave Le Bon's idea of crowd psychology in which military is the crown of the ruling elite.

Mustafa Kemal was no different. He had also found Le Bon's notions very enticing. Recep Cengiz states that he had read Le Bon's magnum opus, "Lois Psychologiques de L'Evolution Des Peoples" and later Turkish renditions of Le Bon's "Enseignements Psychologiques de la Guerre Europeenne", "Le Desequilibre du Monde", and "Hier et Demain" with unflagging interest.

Another doctrine which was very close to the hearts of the educated class of Turks to which Ataturk belonged was the German philosophy of vulgar materialism; a potpourri of materialism, rationalism and Darwinism. Later, the ottoman version of this materialism centered upon the downplaying of religion. Their idol was the German physiologist Ludwig Buchner, the author of "Kraft und Stoff" or Force and Matter.

Ataturk was no intellectual but he certainly was a good reader. He had read Leone Caetani's "Annali dell'Islam" in Turkish translation. Infact, Quoting Recep Cengiz, Sukru Hanioglu writes, "He seems to have fully agreed with the Italian Orientalist that revelation was a myth fabricated by Muslim tradition; that the Quran represented Muhammad's own composition; that the prophet adopted many practices from Judaism: and that the driving force behind Islamic expansion was not religious zeal but the rapacity of the Arab tribesmen" He further comments that, "As president of the Republic, he went so far as to make cautious use of Caetani's words when drafting a chapter on the origins of Islam for the official high school history textbook. In November 1922, the Sultanate had been abolished but the Caliphate was still there. There were emotions of Muslims attached with the institution. Mustafa Kemal himself praised the Caliphate as an emirate tying together Muslims, which would prove very prosperous to the Turkish state and the entire Muslim world. However, he was also aware that the Caliphate was that one institution which could prove to be an obstacle on his way to be the nationalist autocratic ruler of Turkey. As Sir Mohammad Iqbal had said: "main khatakta houn dil-e-yaz-

dan main kantay ki tarah"

Like a thorn, I rankle God's heart On March 1, 1924, the National Assembly opened for a session and in the opening speech, Mustafa Kemal made three main points: safeguarding of the Republic, the creation of a national education system, and the need to cleanse and elevate the Islamic faith by rescuing it from being used as a political instrument. He emphasized that politics was harmful to religion when he stated, "it has now become a plainly evident truth that it is necessary to liberate and to elevate the Islamic religion from its position of being a tool of politics, in the way that has been traditional for centuries". He then prepared a draft bill to abolish the Caliphate.

On March 2, 1924, the proposals of Mustafa Kemal were discussed and accepted in a meeting. After 623 years of being founded by Osman along the borders of Byzantine Empire, the Ottoman sultanate was abolished.

Gazi Dogan, a PhD student in the department of History at Kansas State University writes that after the establishment of the Kemalist single-party regime, social and legal reforms were launched and implemented by the Kemalist Government in a Jacobin way.

In 1925, the Hat Law was introduced. Mustafa Kemal was of the mind that European civilization would not accept the Turkish people in a fez, which he said, "sat on our heads as a sign of ignorance, fanaticism, of hatred to progress and civilization". The New York Times stated that "Mustapha Kemal and his associates evidently want the Turks to cease being a peculiar people, in either garments or habits."

Another "reform" was closing down of the Dervish lodges. In 1925, the Tarikats, religious orders and dervish lodges were banned by the Government. "This was one of the significant Jacobin-style interventions in the people's religious life during the Kemalist modernization. As a modernist, Mustafa Kemal showed zero tolerance to the religious social institutions which were seen as responsible for the back wardness of the Turkish society", writes Gazi Dogan. The new turkey was to be rid of its Islamic past. Consequently, hijab was banned, shariah was outlawed and even Azaan didn't sound the same. The language reforms were another sad legacy of the Kemalist regime. The Arabic alphabet was replaced by Latin alphabet of Europe. This cut off Turks from their Islamic history. They could no longer read the calligraphic inscriptions in old imperial mosques and neither could they read the vast Islamic literature. In a way, Turkey was forced into an isolated nation-state bereft of its deep Islamic roots and rich Ottoman culture. To conclude, it won't be inapposite to say that Mustafa Kemal Ataturk, being the first president, was also Turkey's first Islamophobic statesman and military general.

The disruption of the economic system in Kashmir has not been addressed adequately. The government hasn't given any substantial relief packages to people in Kashmir. It is shifting the responsibility of prevention on people as it has failed to equip our healthcare system. Why must a poor shopkeeper take the brunt of the lapses that our administration has made?

Shops with their shutters down and men in khaki thronging the streets is a sight that brings back memories of hartals and curfews. Why is a curfew and a Covid-19 lockdown being implemented interchangeably in Kashmir? The long lockdown last year that followed the abrogation of Article 370 had also crippled our economy. Coupled with the Covid-19 lockdown, it has totally shattered it. Therefore, it is absolutely important for businesses to open up in Kashmir now. The adverse effects of a yearlong lockdown in Kashmir might outlast generations. Such a realisation only goes on to foreground the urgency with which our economy needs to be revived.

Therefore, the government needs to lift the lockdown and find other ways to ensure SOPs are followed. Not opening up the economy as promptly as possible or reimposing more lockdowns is tantamount to deliberately pushing people to hunger and deprivation.

Don't try to change things you can't control

To nurture the acceptance mindset, build a regular well-being practice which includes self-compassion mantras, meditation and expressions of gratitude

•n so many situations, especially those beyond my control, I've always found it difficult to accept things as they are. The last several months stuck indoors has tested my patience and sanity to the extreme. With a new baby in tow as well as an inescapable terror about the future, my inability to accept this new reality has resulted in nothing but perpetual anguish and rage. This is not healthy. I am not healthy.

I imagine there are many of us who feel this way, constantly vacillating between fear and fury - which is why, for all of our sakes, I turned to the professionals to show us how to better accept the things we simply can't (or don't want to) accept.

Free your mind(fulness)

From the numerous psychologists and mental health experts who responded to my call for help, one common theme emerged: Mindfulness

Paul Harrison, a mindfulness expert and founder of TheDailyMediation.com, describes mindfulness as "the practice of being aware of the present moment and without judgement" and essentially the key to mastering acceptance or the ability "to be non-reactive to people, events and our own thoughts and feelings."

Mindfulness sounds like a simple concept in theory but practising it successfully is far from simple. When's the last time I didn't judge, criticise or critique a situation that wasn't to my liking? I can't even remember. So where do we start?

Right vs. wrong is wrong

A powerful step in our path towards mindful living, says Harrison, is to stop thinking in terms of "right" and "wrong." This is challenging, especially if you've already set your mind on things happening or being a certain way.

So Harrison's advice is to practice "calm observation", which is to try to perceive things without reacting to them. Doing so "trains the mind to experience negative thoughts and feelings in a non-reactive way.'

That said, you shouldn't hide or stifle your emotions. You can and should feel however you feel, but the key is to take a step back and observe "what is happening in the present moment, and not getting lost in thoughts or feelings," he says.

After all, being judgmental is a natural human behaviour, according to Terry B. McDougall, an author and career coach. It is when we feel threatened or unsafe that we feel most judgmental - it's our "fight or flight" instincts kicking in. That's why it's important to "stop and ask



yourself what belief is at the heart of your judgement," she says. Look for valid evidence "to either confirm or invalidate your judgement" to prevent basing your feelings on unfounded assumptions

Embracing an objective mindset can be transformative in all areas of your life, including relationships. In his therapy practice, Ned Presnall helps couples reframe right and wrong and see them instead as "competing preferences," helping both partners recognise that their behaviours and feelings are equally valid.

"Despite what each person may think, their preferences are their preferences, and do not automatically equate with 'right.' People will argue and argue about their different preferences, but both are typically within the realm of normal. Relationships work best when we compromise and take one another's perspective.'

And, it's worth emphasising that "acceptance is not resignation," says psychotherapist Michael Ceely, so you don't have to like this reality - you only have to acknowledge that it is the current reality.

Work in progress

As with most skills, mastering acceptance is not a one-time event nor should it be rushed. "Acceptance often requires ongoing work and conscious effort," says Nicole Arzt, a marriage and family therapist. "We need to remind ourselves that it's okay not to accept something right away - sometimes we just need to feel our anger or sadness or fear." In fact, putting too much pressure on ourselves to come to terms with something immediately can backfire, since it may "intellectualise and invalidate our feelings, which in turn, makes it harder to accept the situation.

To nurture the acceptance mindset, Alan Chu, an assistant psychology professor at University of Wisconsin-Green Bay, recommends building a regular well-being practice which includes self-compassion mantras (focused on mindfulness, common humanity and self-kindness), meditation and expressions of gratitude.

And the reward for being more accepting? A happier life. Now isn't this a challenge worth accepting?

Is Gaming The Future Of The Virtual World?

During the pandemic, digital 3-D environments are where much of life is taking place

ven before the pandemic and the lockdowns, digital games were fast emerging as one of the world's favourite pastimes. But when live entertainment came to a halt, the virtual kind just took off.

Since April, every week has ended with US box office receipts down at least 97 per cent and gaming revenue up by more than 50 per cent, compared with the same week the year before. Driven by widening bandwidths that make digital games fun to play on mobile phones, global gaming revenues have risen steeply from under \$20 billion in 2010 and are on track to hit \$160 billion this year — more than books, music or movies.

But gaming is doing more than displacing other forms of entertainment. It is also providing digital three-dimensional environments in which people can interact freely, develop content and pass on knowledge in new ways. Though built by a creative class of coders for the purpose of play, these rapidly growing platforms are shaping the future of the virtual economy — indeed, the future of the virtual world.

During the lockdowns, gaming platforms have been thriving as venues for all manner of events. Savvy teachers are holding online classes where their students are already spending their time: on game-focused sites like Twitch and Discord. People have held beach weddings inside Animal Crossing and concerts inside Fortnite. Students at the University of Pennsylvania, the University of Chicago and other universities built 3-D replicas of their school settings inside Minecraft and some held graduation celebrations there.

There is even evidence to suggest that playing these games can have beneficial effects, including improvement in spatial skills, motivation and learning concepts.

These 3-D worlds are good business. Consider Fortnite. Made by Epic Games, it uses the "freemium" model: Players

are allowed into the game's 3-D world free of charge, but once there, they can buy virtual accessories - equipment, outfits ("skins"), dance moves, even branded merchandise from outside vendors like the National Football League. Fortnite made an estimated \$1.8 billion last year, most of it from sales of virtual goods to its more than 350 million registered players. The game is seen as the harbinger of a day when consumers move seamlessly

between physical and virtual commercial spaces.

Aware of the threat posed by gaming companies, internet giants like Apple, Amazon and Google are racing for controlling stakes in what is sometimes called the "metaverse" — a term borrowed from Neal Stephenson's 1992 sci-fi novel "Snow Crash," which anticipated the arrival of a parallel online world. Companies like Microsoft have already bought out online gaming pioneers like Mojang Studios, the creator of Minecraft, and have the resources to swallow many more.

Virtual world is young and rapidly evolving

Critics accuse the internet giants of taking an unfair cut of the nearly \$120 billion global market for mobile apps, three-quarters of which is spent on gaming apps. It is a sign of the times

that one company bold enough to take on the tech giants is a gaming company: Epic. On Thursday, after Apple and Google banished Fortnite from their app stores for dodging the 30 per cent cut that they take from app purchases, Epic shot back with lawsuits, calling the cut an "oppressive" tax.

The tech giants are not as invincible as they may appear. Remember that IBM, Intel and Microsoft were once seen as too big to challenge for supremacy in the digital age — but they weren't. The virtual world is young and rapidly evolving, and no company can claim a permanent place in it.

Many gaming companies have reached the stage where Google and Facebook were a decade ago — attracting millions of users but not yet making as much money on each user as they might. In other words, they have room to grow. These companies also have powerful backers: The Chinese tech giant Tencent, for instance, holds a stake in the companies behind seven of the 10 top-grossing games since 2008, including Epic.

The prospect of a virtual world built on gaming platforms may unsettle those who see digital games as a mind-deadening waste of time at best and full-immersion training in antisocial behaviour at worst. But this is an outdated view. There is even evidence to suggest that playing these games can have beneficial effects, including improvement in spatial skills, motivation and learning concepts.

What gaming is likely to do is take the common 2-D online experience and add a richer third dimension. The result would be fully realised "worlds" where people can work, play, study and shop in a more immersive way, fostering greater social interaction, creativity and innovation.

The findings, published in the journal EClinicalMedicine, analysed hospital data and mortality statistics from more than 152,483 smokers in the UK Biobank to look how heavier smoking affects disease risks.

Smartwatch Can Track Drug Levels Inside Body In Real-Time

esearchers have demonstrated that drug levels inside the body can be tracked in realtime using a custom smartwatch that analyses the chemicals found in sweat. This wearable technology could be incorporated into a more personalised approach to medicine where an ideal drug and dosages can be tailored to an individual, according to the study published in the journal Proceedings of the National Academy of Sciences. "We wanted to create a wearable technology that can track the profile of medication inside the body continuously and non-invasively," said study leader Sam Emaminejad from the University of California-Los Angeles.

Because of their small molecular sizes, many different kinds of drugs end up in a sweat, where their con-



centrations closely reflect the drugs' the-counter pain medication, on indicirculating levels. Former colonizer France and the United Nations, which has maintained a peacekeeping mission in Mali since 2013, also expressed alarm ahead of Keita's speech.

U.N. Secretary-General Antonio Guterres sought "the immediate restoration of constitutional order and rule of law," U.N. spokesman Stephane Dujarric said.

But news of Keita's detention was met with celebration throughout the capital by antigovernment protesters who first took to the streets back in June to demand that the president step down.

Asteroid Flies By Earth Closer Than Any Seen Before, NASA Says

WASHINGTON- An asteroid has flown past Earth closer than any

The tiny object, known as asteroid 2020 QG, came just 1,830 miles over the southern Indian Ocean on Sun-

According to Independent, as it did so, it was spotted by the Zwicky Transient Facility, a robotic camera that scans the sky in search of a variety of objects, from the smallest as-

The object was discovered by looking through the images from the ZTF, as part of a Nasa-funded programme to track and study such asteroids. As they fly across the sky, they leave streaks across the ZTF images, and every night an algorithm looks through about 100,000 pictures in search of those streaks, forwarding any promising ones onto staff for further investigation.

"A lot of the streaks are satellites, but we can quickly go through the best images by eye to find the actual asteroids," said Bryce Bolin, a postdoctoral scholar in astronomy at Caltech and a member of the ZTF team. "This latest find really demonstrates that ZTF can be used to locate objects very close to Earth that are on potentially

India is also working on providing alternative connectivity to the strategically important Sub-Sector North including the Daulat Beg Oldi and other areas there for the last three years and work has already started from the world's highest motorable road Khardung La pass. "Agencies are working to provide

alternative connectivity from Manali to Leh through Nimu-Padam-Darcha axis which will help in saving a lot of time in comparison with the existing routes passing through Zojila pass from Srinagar and the other route from Manali to Leh through Sarchu," government sources told ANI.

The road will save almost three to four hours' journey time while travelling from Manali to Leh and will also not leave any scope for the Pakistanis or other adversaries to monitor the movement of the Indian Army while deploying troops and heavy weaponry like tanks and artillerv guns to the Ladakh area from other locations, they said.

The route mainly used for transportation of goods and men is the one from Zojila, which passes through Drass-Kargil axis to Leh.
