India, Pak Troops Trade Fire Along IB

Jammu: India and Pakistan troops exchanged heavy gunfire along the International Border (IB) in Kathua district of Jammu and Kashmir officials said on Saturday. Pakistani Rangers violated ceasefire by resorting to unprovoked firing and mortar shelling along the IB in Kathua district, they said. The ceasefire violation in the Border Out Post Karol Mathna area of Hiranagar sector started at 11.30 pm on Friday, prompting strong and effective retaliation by the Border Security Force (BSF), they said. The cross-border firing between the two sides continued throughout the night and ended at 4.40 am on Saturday, officials said. P-02

IAF Officer Shoots **Self Dead**

Jammu- A warrant officer in the Indian Air Force (IAF) allegedly committed suicide by shooting himself with his service pistol inside a camp here, officials said on Saturday. Warrant Officer Inder Pal Singh, 53, a resident of Uttar Pradesh, allegedly shot himself at Air Force Station Kalu Chak on the outskirts of Jammu on Friday, they said. The officials said Singh's colleagues rushed him to a nearby hospital, where doctors declared him dead. After conducting a postmortem and a COVID-19 test, the body of the deceased was handed over to his family on Saturday, they said. The motive behind his taking such an extreme step was not • P-02

Youth Slips To Death In Poonch

'August 5 Changed J&K's Relationship With Delhi'

SRINAGAR: A year after Modi-led Bharatiya Janta Party government scrapped Article-370 and 35-A and split Jammu and Kashmir into two Union Territories, the signatories of last year's 'Gupkar Declaration' on Saturday vowed to fight for restoration of special status to the erstwhile state.

A joint statement issued and signed by National Conference president Farooq Abdullah, PDP chief Mehbooba Mufti, J-K Congress chief Ghulam Ahmad Mir, Peoples' Conference leader Sajjad Lone, state CPM leader M Y Tarigami and Jammu and Kashmir Awami National Conference senior vice-president Muzaffar Shah termed the August 5 events as unfortunate and said it has "unrecognizably changed the relationship between J-K and New Delhi".

"In a spitefully shortsighted and unconstitutional move, Articles 370 and 35A were abrogated and the State was bifurcated and relegated to the status of two Union Territories and its Constitution tried to be made unenforceable," the joint statement said.

J&K Reports 17 More Covid-19 Deaths, **Toll Reaches 619**

SRINAGAR: At least seventeen people, including a teenager and a pharmacist died of coronavirus in Jammu and Kashmir on Saturday, taking the number of fatalities due to the virus in the Union Territory to 619.

While the deadly infection claimed thirteen lives in Kashmir valley, four others succumbed in Jammu division, official sources said.

They said that a 60-year-old woman from Kishtwar, a 70-yearold man from Marh in Jammu, a 70-year-old man from Samba and a 24-year-old man from Surankote in Poonch died at GMC Jammu where they were admitted.

Army's 'Saviour' In 2014 **Floods Takes Up Arms**

SRINAGAR: A Pampore youth, who won praise for saving dozens of soldiers during devastating floods in 2014, has reportedly joined militant ranks, six years after his heroic acts.

A resident of Sambora in saffron town of Pampore, Asif Muzaffar Shah has reportedly joined militant ranks, ten days after he went missing, news agency KNT reported Saturday. His family had filed a missing report on August 14 at the police station, after he failed to return home.

Shah, an arts graduate was run-

ning a perfume-cum-stationary shop at Kakpora area of the district.

The report further says that Shah was arrested on charges of supporting militants following the deadliest attack on state forces in Lethpora in 2019 in which over 40 CRPF personnel were killed.

Pertinently, Shah is said to have played a saviour's role in rescuing over two dozen soldiers, who were trapped in flash floods triggered by incessant rains in September 2014.

'August 5 Changed J&K's... to chalk out future political strategy. Slamming the government over the August 5 move, the joint statement said that the series of measures undertaken on 5th August 2019 were grossly unconstitutional and in reality measures of disempowerment and a challenge to the basic identity of the people of J-K.

"The measures attempt to redefine who we are. These changes were accompanied by repressive measures meant to silence people and coerce them into submission, and continue unabated," the signatories said. Reiterating their commitment to collectively fight to restore the Special Status of J-K as guaranteed under the Constitution and the commitments made from time to time, the mainstream leaders said that these were testing times and times of pain for the peace-loving people of J-K.

"There is unanimity amongst the political leaders that collective institution is the effective way to fight for these rights and tirelessly struggle to get back the special status and restore the Constitutional guarantees forcibly taken away, against our will," the joint statement said.

"We want to assure the people that all our political activities will be subservient to the sacred goal of reverting to the status of J-K as it existed on 4th August 2019," it added.

Expressing gratitude to the people of India, the political parties, the intelligentsia and other civil society groups for opposing the unconstitutional measures of 5th August 2019 and ever since standing with the people of J-K in this crises, the joint statement urged for their unstinted support to "our just cause till the unconstitutional measures of 5th August 2019 are undone and the special status of J-K restored,"

"We all reiterate that we are bound, wholly, by the contents of the GUP-KAR DECLARATION and will unwaveringly adhere to it. We are committed to strive for the restoration of Articles 370 and 35A, the Constitution of J-K and the restoration of the State and any division of the State is unacceptable to us. We unanimously reiterate that there can be nothing about us without us," the joint statement added.

"India has repeatedly conveyed its concerns to both China and Pakistan on the projects in so-called China Pakistan Economic Corridor, which are in the territory of India that has been illegally occupied by Pakistan," he said. The analysis comes in the wake of the assessment by the Army that the Chinese military is not serious about the resolution of the border conflict

There has been a stalemate in the military talks as the Indian Army was strongly insisting that the Chinese side must restore the status quo ante of April this year to resolve the over three-month-old row.

The Indian Army has clearly stated to the Chinese People's Liberation Army (PLA) that "shifting" of the Line of Actual Control is not acceptable to it, the sources said adding Chinese military is now desperately attempting to give "ex post facto strategic meaning" to its actions in east-

"Due to the strong response of the Indian Army, the PLA is faced with unanticipated and unintended consequences of his misadventure," said a source, adding it is looking for a "face-saving exit strategy".

India and China have held several rounds of military and diplomatic talks in the last two-and-half months but no significant headway has been made in resolution of the border row in eastern Ladakh.

On Thursday, the two sides held another round of diplomatic talks following which the Ministry of External Affairs (MEA) said they had agreed to resolve outstanding issues in an "expeditious manner" and in accordance with the existing agreements and protocols.

However, the sources said the meeting could not produce any significant

The formal process of disengagement of troops began on July 6, a day after a nearly two-hour telephonic conversation between National Security Advisor Ajit Doval and Chinese Foreign Minister Wang Yi on ways to bring down tensions in the area. However, the process has not moved forward since mid-July.

The Chinese military has pulled back from Galwan Valley and certain other friction points but the withdrawal of troops has not moved forward in Pangong Tso, Depsang and a couple of other areas, sources said. In the five rounds of corps commander-level talks, the Indian side has been insisting on complete disengagement of Chinese troops at the earliest, and immediate restoration of status quo ante in all areas of eastern Ladakh prior to April.

Even as both sides have been engaged in diplomatic and military talks, the Indian Army is making elaborate preparation to maintain its current strength of troops in all key areas in eastern Ladakh in the harsh winter

Army Chief Naravane has already conveyed to all the senior commanders of the Army, overseeing operation of the frontline formations along the LAC, to keep up a significantly high state of alertness and maintain the aggressive posturing to deal with any Chinese "misadventure", the

The Army is also in the process of procuring a number of weapons, ammunition and winter gears for the frontline troops, they added. The temperature in some of the high-altitude areas along the LAC drops to minus 25 degrees Celsius in the winter months.

The tension between the two sides escalated manifold after the violent clashes in Galwan Valley on June 15 in which 20 Indian Army personnel were killed. The Chinese side also suffered casualties but it is yet to give out the details. According to an American intelligence report, the number of casualties on the Chinese side was 35.

Following the Galwan Valley incident, the government gave the armed forces "full freedom" to give a "befitting" response to any Chinese misadventure along the LAC.

The Army sent thousands of additional troops to forward locations along the border following the deadly clashes. The IAF has also moved air defence systems as well as a sizeable number of its frontline combat jets and attack helicopters to several key air bases.

The notifications announced sanctions on key figures of militant outfits such as the Jamaat-ud-Dawa (JuD), JeM, Taliban, Daesh, Haggani Group, al-Oaeda. and others.

The government ordered the seizure of all movable and immovable properties of these outfits and individuals, and freezing of their bank accounts, the report said.

These militants have been barred from transferring money through financial institutions, purchasing of arms and travelling abroad, it said. The notifications ratified a complete ban on all leaders and members of defunct Tehreek-e-Taliban Pakistan (TTP) hiding in the Pakistan-Afghanistan border areas.

The paper reported that Saeed, Azhar, Mullah Fazlullah (alias Mullah Radio), Zakiur Rehman Lakhvi, Muhammad Yahya Mujahid, Abdul Hakeem Murad, wanted by Interpol, Noor Wali Mehsud, Fazal Raheem Shah of Uzbekistan Liberation Movement, Taliban leaders Jalaluddin Haqqani, Khalil Ahmad Haqqani, Yahya Haqqani, and Ibrahim and his associates

The notifications said that leadership of the defunct TTP, and other organisations including Lashkar-e-Taiba, JeM, Lashkar-e-Jhangvi, Tariq Geedar group of TTP, Harkatul Mujahideen, Al Rasheed Trust, Al Akhtar Trust, Tanzim Jaish-al Mohajireen Ansar, Jamaat-ul Ahrar, Tanzim Khutba Imam Bukhari, Rabita Trust Lahore, Revival of Islamic Heritage Society of Pakistan, Al-Haramain Foundation Islamabad, Harkat Jihad Al Islami, Islami Jihad Group, Uzbekistan Islami Tehreek, Daesh of Iraq, Emirates of Tanzim Qafqaz working against Russia, and Abdul Haq of Uyghurs of Islamic Freedom Movement of China have been banned.

Though various sanctions were in place against almost all of those listed by the UNSC, the government, through the new notifications, consolidated and documented the previously announced measures, the report

The UNSC Sanctions Committee deals with sanctions on entities and individuals declared as terrorists. All states, including Pakistan, are bound to implement the sanctions, which include assets freeze, an arms embargo, and travel ban.

It is believed that the latest move by the Pakistan government is part of its efforts to wriggle out of the grey list of the global money laundering and terrorist financing watchdog FATF.

On August 12, Pakistan Parliament's lower house passed four bills related to the tough conditions set by the FATF after the government and the opposition reached a consensus

The legislation was part of the efforts by Pakistan to move from the FATF's grey list to the white list.

In its third and final plenary held virtually due to the COVID-19 pandemic in June, the FATF decided to keep Pakistan in the "grey list" as Islamabad failed to check the flow of money to militant groups like Lashkar-e-Taiba (LeT) and Jaish-e-Mohammed (JeM). The plenary was held under the Chinese Presidency of Xiangmin Liu.

With Pakistan's continuation in the 'grey list', it will be difficult for the country to get financial aid from the IMF, World Bank, ADB, and the European Union, thus further enhancing problems for the nation which is in a precarious financial situation.

If Pakistan fails to comply with the FATF directive by October, there is every possibility that the global body may put the country in the 'Black List' along with North Korea and Iran.

The FATF is an inter-governmental body established in 1989 to combat money laundering, terrorist financing, and other related threats to the integrity of the international financial system.

The FATF currently has 39 members including two regional organisations—the European Commission and Gulf Cooperation Council.

BSF Kills 5 Pak Intruders...

The border post is guarded by the 103rd battalion of the Border Security Force.The spokesperson said BSF personnel noticed suspicious activity near the border around midnight and asked the intruders, who were wearing T-shirts or shirts and full pants, to surrender but they "did not pay any heed to the challenge" and opened fire on the troops.

"To stop any further misadventure and in self-defence, the BSF troops retaliated with fire in which five Pakistani armed intruders succumbed to bullet injuries," he said.

BSF Inspector General (Punjab Frontier) Manipal Yadav told reporters during a press conference in Amarkot that the five men had "crossed the IB and entered into Indian territory".

Yadav said the operation against the infiltrators began around 11:30PM on Friday, and initially two bodies were found during a search this morning. Three more were found later.

He said the bodies were handed over to the local police, which will now probe the case and scan the data of the two mobile phones the BSF found with the bodies

Another senior BSF official said the exchange of fire began around 4.30 am. BSF troops, officials said, used thermal imaging, night surveillance devices and also set up multiple ambushes to track down the infiltrators. The intruders were seen carrying rifles and moving through 'sarkanda' or elephant grass to hide themselves, they added.

A photo collage released by BSF showed two bodies piled on each other while three others were lay separately in the slushy grass. The weapons and a backpack were visible in the photographs.

Officials said the BSF has seized over 356 kg heroin and 25 illegal weap-

The spokesperson said the LG was informed that 161 km length of the Rs 27,949 crore project has been commissioned.

Sinha directed the Railway authorities to complete the remaining part of the project from Katra to Banihal by August 15, 2022, and assured full support to the executing agencies for timely completion of the project. The Railway authorities assured the completion of the project by the set deadline, the spokesperson said.

The world's highest railway bridge with a height of 359 metres is coming up on the Chenab river under the project, while India's first cable-stayed railway bridge on Anji Nallah in Reasi is also coming up along the link. Sinha directed the Railway authorities to expand the rail link towards unconnected areas of Rajouri-Poonch and Kupwara region.

On this, the Railway officials informed that a preliminary survey for the 223 km-long Jammu-Poonch rail link at an estimated cost of Rs 22,768 crore was completed and submitted in 2017, and for the 39 km-long Baramulla-Kupwara rail link with an estimated cost of Rs 3,843 crores, the survey has been completed and submitted to the Railway Board in

The LG asked the railways to prepare detailed project reports of both the projects so that the matter could be taken up with the Ministry of Finance for sanctioning of these projects, the spokesperson said.

He said the Railway authorities requested Sinha to resolve the issue of non-availability of minor minerals in Ramban district. Sinha issued on-spot directions to the director of Geology and Mining

and the deputy commissioner of Ramban to issue short-term permits so that the railways could procure essential construction material without any hassle, the spokesperson said.

He said the LG also asked the railways to run vistadome coaches in Kashmir to attract tourists and offer them a better view of the scenic Kashmir Valley once the COVID-19 situation normalises.

On the intervention of Sinha, the railways agreed to run a local train service between Kathua and Udhampur to benefit local commuters. The local train service will be started once the COVID-19 pandemic subsides. It was informed that on the request of the Union Territory government, the railways has agreed to construct a rail over-bridge at its own cost near Madhopur to decongest traffic between Pathankot and Lakhanpur, the spokesperson said.

He said Sinha also asked the railways and the Jammu and Kashmir State Road Transport Corporation (JKSRTC) to launch a single-ticket travel facility to provide travellers with an opportunity of going from Kashmir to Kanyakumari, Tamil Nadu via train and bus.

The spokesperson said the LG directed the divisional commissioner of Jammu to identify projects to be taken up by the Indian Railways under the Corporate Social Responsibility (CSR) in the region.

member was called to look after him. She told us there was hardly any staff that would come to even ask or see if everything was okay. Those who came were in a hurry to leave. They had needed cotton gauze for dressing but weren't able to find it anywhere in the hospital," Ameena

After the delivery, the baby was tested and his reports came out negative four days later. Saima tested negative a day later, and was finally allowed to hold the baby and breastfeed him.

"It has been a traumatising experience for each of us, but even then it isn't possible to imagine what Saima must have gone through on an emotional and mental level, with her husband being in the hospital, two of her kids away at home, and a newborn she couldn't even hold close," Ameena said. "She said that her stay in the hospital felt like being put in a grave, where you're all alone by yourself."

This particular experience left them scared and anxious for the third delivery of Ameena's cousin, Kulsoom, Kulsoom had married late and had been able to conceive with a few complications involved. After the incident with Saima, Ameena narrated how Kulsoom would often call in a voice laced with fear while asking about Saima's wellbeing.

"She was getting her consultations done from a private clinic since the beginning, and that's where they got the delivery done eventually, at the end of July, when the crisis in Kashmir had deepened," Ameena said.

Kulsoom's pre-delivery COVID test was carried out by a private laboratory and she tested negative. The test cost around Rs 5,500, despite the government putting a cap on its price. "But the situation had been such that added with the trauma of past experiences, they would have paid more without a second thought.

"On the day of the delivery \tilde{I} saw her weeping even while entering the Operation Theatre. She was anxious since days and even her ECG before the surgery had hinted at the same. However, things went fine, Alhamdulilah," Ameena said.

Kulsoom gave birth to a baby boy sans any complications.

"I slowly slipped into depression"

"I couldn't get an appointment with the doctor while I was pregnant," Areeb said, a resident of downtown Srinagar, who delivered a baby girl on 6th June. "No one was available for a check-up and they told me to come when I was in my 9th month, that too, if I was in pain. Even then, they said they weren't sure if they would be able to give me a check-up." Due to unavailability of doctors, Areeb visited Soura to try her luck. Upon reaching the Sher-i-Kashmir Institute of Medical Sciences (SKIMS), she was turned away.

"I got the required tests after many obstacles but wasn't even spared a glance. They told me I wasn't a patient here so I had no business coming here till my 9th month," she said. "They told me they had their own patients to deal with, and they couldn't do anything for me.'

Despite their rejections, she lumbered on with her visits, fighting the overwhelming fear of contracting the virus while trying to get checked. She tried to take care by standing far from the crowd, wearing a mask and gloves to protect herself and her then unborn child.

"Even if I'd go in the morning at 9 am and stay till 8 pm, no doctor would see me," she said. "I slowly slipped into depression. I had fifteen days left before my delivery. It was so bad that my in-laws decided to take me to a private hospital. We had no other option." În Modern Ĥospital, Dr. Masuma Rizvi took on Areeb's case and consoled

her throughout the last leg of the traumatic race. "She told me not to be afraid, that she would take care of me. She helped me a lot. Those last fifteen days went smoothly." After her delivery. Areeb's feelings of helplessness subsided, but she staved alert and cautious. She took extra care of her newborn, aware of

the dilapidated health infrastructure she has been a victim of. "I don't hand her over to anyone," she said assertively. "I sanitize my baby's hands every other hour and don't let any passing guest hold her in their lap. If they insist, I tell them to wash their hands before touching my child. If I don't trust that person, I don't give her to them. This is not

the time to speculate. This is the time to stay safe.' 'They don't know what to do to keep their child safe'

"Well, first of all, before talking to them about the delivery, you have to explain to them about the virus's existence," a senior gynaecology resident in Srinagar said when I asked her about her patients' psyche. "So many of them are totally ignorant of the virus. Some think the virus is a lie, a few educated among them blame the system and the closure of private clinics due to the lockdown. There are some women who are very

worried and don't know what to do to keep their child safe." The resident, who wished to remain anonymous, said that the women would feel very anxious and would try to leave early after their check-up so that they would not expose their child to the virus.

"They find it very problematic to wear a mask during these times," she said. "Since the female is already in distress owing to her pregnancy, this is an added burden."

Stating that the attendant is not allowed to stay by the patient's side during the check-up, or during labour or during required surgery, the resident said that her patients felt a lack of moral support and insecure. The resident's patients came often from small towns from faraway districts, such as Uri, and had very little idea about the pandemic.

"When I asked my patients about bringing up a baby in the midst of all this, many gave hopeful answers, saying that it wasn't as if the virus was here to stay," she said. "But they do feel worried about it, from time to

One of her patients, who had been tested positive, told the resident that she was more worried about infecting the newborn with the disease rather than being infected herself.

"In my personal opinion, I found many do not have an idea about the vi-

rus or how serious the situation was," she said. "Those who were worried about it were extremely worried." According to the resident, the patients were more affected by the treatment of the doctors during this time than by the virus itself. They complained of not being able to recognise the doctor behind a PPE kit, being

scolded for trivial things such as wearing a mask and were offended by

not being touched by a doctor. "They take the last part personally and don't understand that precaution is more important right now," she said.

VVIP Wazwaan & a bridge too far

Sopore: Even as the long wait for completion of the Hathishah bridge here is over, its formal opening awaits a ministerial indulgence. For a good two mo'nths, no minister or VIP has been available to cut the ribbon to enable the people benefit from its erec-tion. The inordinate delay &am generated resentment among the local people who have been inconvenienced due to its absence over the fears.

According to reports, the authorities had slated the formal inauguration of the bridge at least thrice so far. On every such occasion, the engi¬neers had to arrange the cus¬tomary feast. known as wazwan, for the august guests to partake. Obviously forces alleged, the charges on this ac-count might have to be borne out of the funds provided for the main project.

Reports said the border Security force (BSF) personnel manning the security posts on filler side of the bridge were not allowing any vehicle to pass over the bridge on the plea that no minister had so far inaugurated it formally. However, they allowed some pedestrians selectively prohibiting the general public to walk over the bridge.

It may be recalled the speaker of the legislative as ¬sembly, Abdul Ahad Vakil, was the one to crack an occasional whip to get the work on the bridge, which had been going on at a snails pace over the years, speeded up. He held several meetings with engineers and even promised its completion long ago. Now that the work is complete, no minister is available to Commission Bridge.



Kashmir's Economic Downfall

In the absence of an enduring vision about the fate of Kashmir's political destiny, little can be done to accelerate forces of economic development in the region

In a recent report, the Kashmir Chamber of Commerce and Industry (KCCI) put economic losses in Kashmir Valley in the last year at Rs 40,000 Crore. These figures estimate a loss of about 11 percent of J&K's economic output ore than a year since the abrogation of Article 370, J&K's economy is going deeper into a crisis. In August last year, a complete communication blackout and lockdown was enforced after BJP-led central government scrapped Article 370 and suspended J&K's constitution. This lockdown continued into the next year and extended further due to the Covid-19 pandemic. The effects of this double lockdown have been devastating on Kashmir especially its economy. Twelve months into it, there's little to no hope of improvement.

Current State of J&K's Economy

In a report, "Jammu and Kashmir: The Impact of Lockdowns on Human Rights" compiled by The Forum of Human Rights in Jammu and Kashmir, civil rights members said that, "the August 2019 lockdown plunged the state into a sharp downward spiral. By the end of December 2019, economy of the valley was in dire straits". This was because, in the first four months of the lockdown, industries in J&K suffered a loss of about Rs.17,878.18 Crores (roughly USD 2.4 billion). Job losses in the valley were under half a million (497,000). According to the preliminary loss assessment report by Kashmir Chamber of Commerce and Industries, service sector including Tourism took the biggest cumulative hit. It lost Rs 9191 Crore in the first 120 days that followed the abrogation of article 370. The sector also witnessed 1, 40,500 job losses.

According to a news report by Scroll.in, as per statistics provided to Parliament in December last year, tourist figures declined from over quarter of a million in 2018 to just over 43,000 between August and December'19. As a result, an estimated 144,500 jobs were lost

in the tourism and handicraft's sector alone.

Even after a year, this number has only increased. In a recent report, the Kashmir Chamber of Commerce and Industry (KCCI) put economic losses in Kashmir Valley in the last year at Rs 40,000 Crore. These figures estimate a loss of about 11% of J&K's economic output.

The prolonged lockdowns from August 2019 till date led to low demand, fewer purchases, and reduction in satisfaction. This in turn affected turnover, margins, market share and overall business performance. For instance, the fruit industry, which is one of the state's largest producers lost around 1.35 lakh metric tons of its crop, due to restricted transport facilities. According to the MHA, by January 2020, the National Agricultural Cooperative Marketing Federation of India (NAFED) had only purchased Rs.70.45 Crores worth of apples, while the average revenue from apple sales used to be around Rs. 14,000 crores per annum.

Is There a Way out?

In his book, "How an Economy Grows and Why it Crashes", Peter Schiff presents three important aspects that characterise a robust economy. The first aspect is the prevalence of production over consumption. The second is improving the deteriorating economic situation through savings and the third condition is that the economy needs deflation and not inflation for prosperity. Unfortunately, Kashmir is becoming more and more of a consumer state.

However, economic growth also depends on a degree of economic freedom. In the words of leading economic analyst for South Asia, Zahid Hussain, "economic growth and political stability are deeply interconnected. The uncertainty associated with an unstable politi-

cal environment reduces investment and the pace of economic development"

Over the years, intense political conflict in Kashmir has hampered any heavy industry to thrive and prosper. The absence of sustainable peace and the presence of frequent shutdowns not only results in the loss of human lives, but also makes the society economically weak.

Since last August, there has been limited to no physical movement in Kashmir. Internet bans in Kashmir have proved harmful for the economy. It has devastated supply chain and caused a colossal demand shock. The absence of high speed internet facilities has also affected businesses to a large extent. In the absence of it, it has become difficult to switch to e-commerce even as the pandemic has made the world rely on the digital to avoid big losses.

When the brutality of conflict surrounds every sphere of life, people's lives are bound to become chaotic and anarchical. The landscape of Kashmir is swiftly changing around a particularly compelling narrative. The India Government's policies are detrimental to Kashmir's economy and are damaging its sociology. People are in an economic quandary and in a practical dilemma over how to sustain this crisis. In the absence of an enduring vision about the fate of Kashmir's political destiny, little can be done to accelerate forces of economic development here.

Meet the Philosopher Who Is Trying to Explain the Pandemic

Giorgio Agamben criticizes the "techno-medical despotism" of quarantines and closings.

tumping for regional candidates in Tuscany this month, Italy's former interior minister Matteo Salvini waved around a surgical mask — and pointedly did not wear it. Covid-19 has taken more than 35,000 lives since it struck Italy in January. But now the daily death toll is typically in single digits, and Mr. Salvini, the leader of the anti-immigration League party, wants to put the country back to work. "Italians are being held hostage, kept at a distance, masked," he hollered, "and meanwhile they let thousands of lowlifes land their boats and do what they want, go where they want, spit, infect. Enough is enough!"

People cheered. But half of them kept their

masks on.

This is a common pattern in the Western countries (and American states) where Covid-19 fatalities are dwindling. The arguments for freedom may be strong — but they are put awfully crudely. The arguments for discipline and prevention may often be resented — but they have a lot of scientific authority behind them, and they carry the day. Better safe than sorry. Late last month, Italy's parliament voted to extend the government's state of emergency until Oct. 15

In a society that respects science, expertise confers power. That has good results, but it brings a terrible problem: Illegitimate political power can be disguised as expertise. This was a favorite idea of the French philosopher Michel Foucault, who used it to explain how experts had expanded definitions of criminality and sexual deviancy. One of Italy's most celebrated thinkers, Giorgio Agamben, has recently applied similar insights to the coronavirus, at the risk of turning himself into a national pariah.

In late February, Mr. Agamben began using the website of his publisher, Quodlibet, to criticize the "techno-medical despotism" that the Italian government was putting in place through quarantines and closings. Mr. Agamben, 78, is a philosopher of language, art and meaning. Since 1995, he has focused on what he calls the "archaeology" of Western political institutions, devoting a monumental nine-volume work, "Homo Sacer," to excavating their hidden logic. Some of his earlier work was translated by Michael Hardt, the Duke professor and co-author of the

radical campus classic "Empire."

The part of the Italian intellectual establishment that calls itself "radical" has been Mr. Agamben's milieu for half a century. His position on the coronavirus has cost him its support. Paolo Flores d'Arcais, the influential editor of the bimonthly MicroMega, accused Mr. Agamben of "ranting." The newspapers La Repubblica, Corriere della Sera and Il Foglio all called him a negazionista regarding the coronavirus, using a word generally reserved for those who deny the Holocaust happened. Just as unexpected as these repudiations was the sudden receptivity to Mr.

Agamben's recondite philosophy in the pages of La Verità and Il Giornale, newspapers more often sympathetic to Mr. Salvini's League.

Last month, Quodlibet published Mr. Agamben's collected posts in an expanded volume called "Where Are We Now? The Epidemic as Politics." (That's a rough translation; the book does not yet exist in English.) In hindsight, Mr. Agamben missed a few things in the first days of the coronavirus. For instance, he relayed the National Research Council's description of Covid-19 as a kind of influenza — true enough in most cases, but far from the whole story. Today, however, with the Italian crisis receding, and with a measure of calm restored to the public discussion, we can see his book for what it is: not a work of scientific crankery or crackpot policymaking but an on-the-spot study of the link between power and knowledge.

Mr. Agamben's name may ring a bell for some Americans. He was the professor who in 2004, at the height of the "war on terror," was so alarmed by the new U.S. fingerprinting requirements for foreign visitors that he gave up a post at New York Universi-

which locking down an entire nation of 60 million becomes unreasonable. Many European governments, including Italy's, have developed national contact tracing apps that allow them to track their citizens using cellphones.

Wars have bequeathed to peacetime a "series of fateful technologies," Mr. Agamben reminds us, from barbed wire to nuclear power plants. Such innovations tend to be ones that elites were already agitating for, or that align with their interests. Epidemics, he suggests, are no different. He believes that the fateful inheritance of the coronavirus will be social distancing. He is puzzled by the term, "which appeared simultaneously around the world as if it had been prepared in advance." The expression, he notes, "is not 'physical' or 'personal' distancing, as would be normal if we were describing a medical measure, but 'social' distancing."

His point is that social distancing is at least as much a political measure as a public health one, realized so easily because it has been pushed for by powerful forces. Some are straightforward vested interests. Mr. Agamben notes (without naming him) that

the former Vodafone chief executive Vittorio Colao, an evangelist for the digitized economy, was put in charge of Italy's initial transition out of lockdown. Social distancing, Mr. Agamben believes, has also provided Italy's politicians with a way of hindering spontaneous political organization and stifling the robust intellectual dissent that universities foster.

The politics of the pandemic expose a deeper ethical, social and even metaphysical erosion. Mr. Agamben cites Italians' most beloved 19th-century novel, Alessandro Manzoni's "The Betrothed," which describes how human relations degenerated in Milan during the plague of 1630. People came to see their neighbors not as fellow human beings but as spreaders of pestilence. As panic set in, authorities executed those suspected of daubing houses with plague germs.

When a society loses its collective cool this way, the cost can be high. Rich, atomized, diverse, our society has a weak spot, and the coronavirus has found it. "For fear of getting sick," Mr. Agamben writes, "Italians are ready to sacrifice practically everything — their normal living conditions, their social relations, their jobs, right down to their friendships, their loves, their religious and political convictions."

In fact, "the threshold that separates humanity from barbarism has been crossed," Mr. Agamben continues, and the proof is in Italians' treatment of their dead. "How could we have accepted, in the name of a risk that we couldn't even quantify, not only that the people who are dear to us, and human beings more generally, should have to die alone but also—and this is something that had never happened before in all of history from Antigone to today—that their corpses should be burned without a funeral?"

Mr. Agamben has always been fascinated by such instances of common customs or historic institutions getting emptied out of their long-held meanings. In books less punchy and direct than the present one, he has described this process with the word inoperosità. It means "idleness," but idleness of a kind that can generate new systems of belief and new dangers. Whatever it is, it has made itself felt not just in Italy but in all Western societies in recent months, perhaps in the United States most of all.

Five ways to manage back-to-school stress

or months we have been discussing back-to-school plans for our K-12 and higher education institutions. By and large, these anxiety-dominated conversations have been happening on politicised, theoretical stages, with little input from the students and parents, or staff, teachers, and faculty directly impacted by these decisions. In many cases, this glaring irony has negatively impacted individuals, families, and communities around our nation, leaving a lot of us feeling dismissed, discouraged, and disempowered.

At the same time, while parents may post memes and videos on social media begging people to come and take their children, by and large, the surveys of parents show they fear risking their child's and family's health by sending them to school. They also report deep concerns over either sending their child to school intermittently or educating them from home full-time. Either a blended or fully-remote option presents issues with childcare, work arrangements, and a lack of experience and ability to teach their own children.

The following five suggestions won't remove all your stress about the looming school year, but following them may help you face it with less anxiety and a stronger sense of empowerment.

When we are in a state of distress, your body and brain could be operating from a "fight, flight, freeze, or fawn" response. In this frame of mind, we are not accessing our 'logic brain' as much as we are relying on our 'survival brain'. Our survival brain helps us make quick decisions to preserve and protect ourselves from perceived immediate danger.

If you start feeling anxious when receiving notice of yet another change of plans, rather than making a survival-brain decision, engage your logic brain by looking to your longer-term priorities instead. To begin, make a list of things you consider important right now. For example, you may have three priorities: Providing a good education for your 10-year-old, working to support your family as a single parent, and avoiding exposing your live-in 62-year-old mother to Covid-19.

Next, rate each one independently on a scale of 1, which is not at all important, to 10, indicating the most important priority right now. Doing this may help you better decide how to respond to a recent announcement of a choice to either a) send your child to school on alternate days a week or b) an all-online option.

Most of us think we make decisions based on the facts we have before us. In truth, we act on our inter-



pretation of what is happening, not some objective version of reality.

Instead, slowing down your decision making can help you challenge those distorted beliefs instead of cutting yourself short of a learning experience.

When we are not in survival mode, so many of us think we must make decisions based only on logic. We try to shove our feelings out of the way so we can be "clear-headed" about the matter at hand. But ignoring our emotions is precisely what causes us to lead with them.

Instead of swallowing your feels, take a moment to acknowledge what you're feeling about this news.

When you feel overwhelmed, you tend to think you can rely on only yourself. In survival mode, you consider only the resources within your immediate access. By identifying and changing your automatic thoughts and checking-in with your feelings, you switch on your full self. This gives you an opportunity to consider other resources and supports in your life. Creativity can return when you feel safe and grounded.

Finally, once you are out of a state of survival,

determined your priorities, identified your automatic thoughts, acknowledged your feelings, and gathered your resources and supports, you are ready to respond to the new information rather than react. Unless you are truly in a dangerous situation and need to let your survival brain take over, a thoughtful, emotionally sound response that utilises your full resources and supports to meet your highest priorities first will always be better in the long run.

These are truly trying times for so many of us. With social distancing and self-quarantining become necessary, it's easy to be knocked into a tailspin. While these suggestions won't take all the stress and hardship away, they can help you shift from a panicked sense of hopelessness to a place of sound decision making and inspire hope.

OW well is it said by Henry Valentine Miller, the great American writer and painter that, "The one thing we can never get enough of is love. And the one thing we never give enough of is love." One could hardly find any better lines to express the love of bollywood with the subject of Islamophobia.

When the media literacy of the masses in a country like India is almost invisible, the Hindi cinema becomes vulnerable of turning into a mere propaganda machine. As the bollywood actress, Swara Bhaskar, in one of her discussions with the Quint rightly puts forth that, "Bollywood historicals in the last few years are totally playing into the Hindutva ideology, and the Hindutva writing and rewriting of history."

Bollywood has a long history of producing Islamophobic content and portraying Muslims as barbaric and threats to the society. The filmmakers continuously flirt with the depiction of a good and bad Muslim in order to create an illusion of balance in the minds of the Muslim audiences. And this trick has so far paid good dividends to the Indian film industry. They make gold by an ill representation of the Muslim community which is evident by the success of many such films. Be it Padmavat or recently released Tanhaji, both of these historic fictional movies were big blockbusters. We see Muslims once again being taken to task by the makers of the film by exploiting their artistic license. Though, you may see good Indian Muslims fighting the bad in the movies but that's always kept in the background.

Based on a chapter titled "We Don't Really Know Fear," from the book, "India's Most Fearless: True Stories of Modern Military," by Shiv Aroor and Rahul Singh, starring Amit Sadh in a tough lead role evident from of his appearance at the end of the fourth episode, where he could be seen getting beaten by his inmates while he remains hung upside down from a beam. Unfortunately, Muslims in Avrodh: The Siege Within, a SonyLiV web release, suffer a similar fate. Especially, given the way people are reacting to it in the hyper-nationalistic environment blanketing India, one is bound to say that Muslims have once again been summoned in this series.

Produced & created by Applause Entertainment & Irada Entertainment, this 4 hour 48 minute watch is packed in 9 episodes each of 30 minute duration. The establishing shot captures the beauty of Kashmir by focusing on the lush green trees with birds chirping around. A Chinar leaf falling from the tree unto the ground after which the date and reference of the place, 8th July 2016, Bumdoora, Anantnag, J&K, is given. We then see gushing water, donkeys and native



women taking fodder for their cattle. A local wedding is taking place in Bumdoora where a militant named Bilawal Wani who draws acute comparison with Kashmir's young and popular Hizbul Mujahideen commander, Burhan Wani, is trapped and killed by the armed forces.

Directed by Raj Acharya, who has also worked with Danny Boyle for Slumdog Millioniare (2008), Avrodh takes us back to what was already shown in 2019 blockbuster and India's national award winning movie, Uri: The Surgical Strike. That put forth a dramatized version of what was declared a "surgical strike" by India in September 2016 done in Pakistan's administered Kashmir to avenge the killings of its 19 soldiers in a planned attack allegedly carried out by Jaish-e-Muhammad, a Pakistan based militant outfit. Avrodh unlike Uri movie is placed more on the technical side and shows the planning and in hand tireless hard work of the forces and the government that had been invested in making what was claimed to be a successful surgical strike on the militant launch pads across the border.

The writing team of Avrodh, Harmanjeet Singha, Sudeep Nigam, Abhishek Chatterjee and Aadhar Khurana, has weaved the 9 episodes brilliantly and succeed in keeping their audience on the edge of their seats. Though it is not much action packed mainly as it is more about the homework that had been done before carrying the attack. That's why there are secret meetings between the Prime minister played by Vikram Gokhale, who deserves appreciation for his role as he has fully impersonated the actual Prime minister of India, Narendra Modi, and the officials.

The role of the National security advisor played by the Neeraj Kabi, who is best known for films like Talvar, Ship of Theseus, and popular web series Sacred Games laudably stands out because of his serious acting. Anant Mahadevan who plays the role of defence secretary looks classic and well in control of his character. We see an emotional foot soldier in the form of Major Raunaq Gautam played by Darshan Kumaar who initially is portrayed as the protagonist until the main Hero in the form of Major Videep Singh (Amit Sadh) appears to the scene. There is an over enthusiastic Journalist, Namrata Joshi, played by Madhurima Tuli, who is shown fully independent and ready to work without fearing the consequences. And her work to some extent as a journalist is quite impressive in the movie. But given the fact that the position of India in the World Press Freedom Index report (142) covered in 2020, she seems to be far away from reality. Anil George's role as Abu Hafiz is again praise worthy and notable. He has been able to build the strange and devilish calmness around his character. His sharp kohled eyes, white beard and curly black long hair hanging from the sides and back of his typical Muslim cap have helped to create a sharp contrast between the militant leaders of Jaish-e –Muhammad and other alike outfits. However, his address to the school children looks unconvincing. He has been given a cruel look in the movie and children in that very scene are too young to get attracted by him, they should have rather felt terrified.


Mir Sarwar, the Kashmiri actor plays his part well as Fakhrudin a Kashmiri journalist. His look is pretty much similar to Abu Hafiz's and that in itself carries a message and is bound to raise the debate of a good and a bad Muslim. We also have Arif Zakaria, as Ali Raza Khan, an NIA officer, who does remarkably well. Nirmal Pandey's music compliments the film well. The cinematography by Shanu Singh Rajput is decent in capturing Kashmir.

The less action in the movie is justifiable as it is more about the work behind the curtains. Hence, that is understandable. But the movie lacks powerful dialogues that can make your blood rush. This series is also guilty of doing injustice with Kashmiris as they have been portrayed voiceless again. The makers haven't bothered to take Kashmiri version into consideration. Also, this movie seems to be drawn by an element of propaganda given the way Prime minister of India in this series has been shown giving confidence and wisdom quotes to his officials that looks strange and farcical. His strong character which, undoubtedly, has been glorified to an extreme level. The time which he spends with the team is also not understood.

The series becomes easily predictable and it doesn't look like a release of 2020 rather of 1990s. It also calls for the responsible action of all the Kashmiri actors who work in these kinds of movies to at least filter the content once and not act blindly. Artists are also from this society why should art be then let free?

Bollywood has always preferred to romance with Islamophobia and the dangerous depiction of Islam and its followers by the filmmakers is only threatening the existence of the Muslims in India. The Indian film Industry should act responsibly at a time when Islamophobia is on rise across India. History would mark this series as one of those movies which have only added fuel to the rising levels of Islamophobia and swept Kashmiri sentiments fully.

This series is a perfect watch for the current environment of India but we would suggest people to watch it with open senses. Here, we from Kashmir would give this series 2.5 out of 5 stars.

Greece pushing migrants back to sea, says UNHCR


ATHENS: The UN refugee agency on Friday said it was deeply concerned by "credible reports" that Greek authorities had towed migrant ships back out to sea or just left them adrift.

The United Nations High Commissioner for Refugees (UNHCR) said in a statement there were testimonies about "people being left adrift at sea for a long time, often on unseaworthy and overcrowded dinghies, waiting to be rescued".

The UN body said it was concerned" "particularly about an increasing number of reports since March that some migrants who disembarked on Greek shores "have thereafter been towed back to sea".

A third area of concern for the UNCHR were reports of migrants being informally returned to Turkey immediately after reaching Greek soil or territorial waters in recent months.

On Wednesday Greek Prime Minister Kyriakos Mitsotakis denied claims of illegal pushbacks of asylum-seekers



Based on its research, the Times said more than 1,000 asylum-seekers had been "dropped at sea" since March.

More than a million migrants and refugees arrived in Greece in 2015 and 2016, according to the UN refugee agency. There are now around 120,000 in the country.

More than 25,000 asylumseekers live in camps on the five Aegean islands that were originally built to handle just 6,095 people.

UNHCR Representative in Greece Philippe Leclerc acknowledged on Friday that "Greece and its people have shown immense solidarity and compassion with thousands of refugees and asylum-seekers who have sought safety in the country since 2015".

However, he added that 'safeguarding Greece's borders and protecting refugees are not mutually exclusive.

13 Of 15-Member UN Security Council **Oppose US Push For Iran Sanctions**

United Nations: New York: The United States was further isolated on Friday over its bid to reimpose international sanctions on Iran with 13 countries on the 15-member U.N. Security Council expressing their opposition, arguing that Washington's move is void given it is using a process agreed under a nuclear deal that it quit two years ago.

In the 24 hours since U.S. Secretary of State Mike Pompeo said he triggered a 30-day countdown to a return of U.N. sanctions on Iran, including an arms embargo, longtime allies Britain, France, Germanv and Belgium as well as China. Russia, Vietnam, Niger, Saint Vincent and the Grenadines, South Africa, Indonesia, Estonia and Tunisia have already written letters in opposition, seen by Reuters.

The United States has accused Iran of breaching a 2015 deal with world powers that aimed to stop Tehran developing nuclear weapons in return for sanctions relief. But President Donald Trump described it as the "worst deal ever" and quit in 2018.

Diplomats said Russia, China and many other countries are unlikely to reimpose the sanctions on Iran. Pompeo again warned Russia and China against that on Friday, threatening U.S. action if they refuse to reimpose the U.N. measures on Iran.

The United States acted on Thursday after the Security Coun-

cil resoundingly rejected its bid last week to extend an arms embargo on Iran beyond its expiration in October. Only the Dominican Republic joined Washington in voting yes.

Dominican Republic has not vet written to the council to state its position on the sanctions snapback push.

Under the process Washington says it has triggered, it appears all U.N. sanctions should be reimposed at midnight GMT (8 p.m New York time) on Sept. 19 just days before Trump is due to address world leaders at the U.N. General Assembly, the annual meeting that will be largely virtual because of the coronavirus pandemic.

A 2015 Security Council resolution enshrining the nuclear deal states that if no council member has put forward a draft resolution to extend sanctions relief on Iran within 10 days of a non-compliance complaint, then the body's president shall do so within the remaining 20 days

The United States would be able to veto this, giving it a cleaner argument that sanctions on Iran have to be reimposed.

However, the 2015 resolution also says the council would "take into account the views of the states involved." Given the strong opposition, some diplomats say the council president - Indonesia for August

and Niger for September - would not have to put up a draft text.

"Faced with this very strong view of a majority of Security Council members that the snapback process has not been triggered, as the presidency they are not bound to introduce the draft resolution," said a U.N. Security Council diplomat, speaking on condition of anonymity.

Pompeo and outgoing U.S. Iran envoy Brian Hook signaled that Washington expects Indone sia or Niger to put a text to a vote. Another U.S. option is to put forward the draft itself or ask the Dominican Republic to do so.

The United States argues that it can trigger the sanctions snapback process because the 2015 Security Council resolution still names it as a nuclear deal participant.

However, in a joint letter to the Security Council on Thursday hours after the U.S. submitted it complaint, Britain, Germany and France said: "Any decisions and actions which would be taken based on this procedure or on its possible outcome would also be devoid of any legal effect."

U.N. Secretary-General Antonio Guterres distanced himself from the showdown in the Security Council.

"Security Council members will need to interpret their own resolution." U.N. spokesman Stephane Dujarric told reporters. "It's not the Secretary-General."

Israel bombs Gaza, tightens blockade

GAZA CITY: Israeli warplanes bombed the Hamasruled Gaza Strip on Friday, as Palestinians fired rockets and launched fire bombs into southern Israel, the army said.

Israeli planes launched raids against Gaza shortly after midnight on Thursday and then again later on Friday morning.

Israel said the bombs were in response to seven rockets launched from Gaza, six of which were intercepted by its

tercepted damaged the roof of a house in Sderot, but did not cause any casualties, a photographer said. Israel has bombed Gaza almost every night since August 6 in retaliation for the launch of balloons fitted with fire bombs, or less frequently, rocket fire, across the border.

The number of rockets fired from Gaza was the largest number in a day since the latest round of exchanges began two weeks ago.

Israel has also tightened its blockade of Gaza's two million inhabitants. It has banned

Father of Kamala Harris reveals how he lost contact with his daughters

Washington: Donald Harris, father of Indian-origin senator and Democratic vice presidential nominee Kamala Harris, has said close contact with his daughters <u>"came to an abrupt h</u>alt" after a contentious custody battle, according to a media report.

The New York Times report said the Jamaican-born economics professor expressed regret that the custody battle brought an end to the contact with his daughters.

Harris' mother Shyamala Gopalan, a cancer biologist, came from India to the US at the age of 19 to pursue her dream of curing cancer.

In her speech at the Democratic National Convention, Harris spoke fondly and profusely about her mother but had limited words for her father.

She said her mother met her father, who had come from Jamaica to study economics, at the University of California Berkeley, and "the two fell in love in that most American way while marching together for justice in the civil rights movement of the 1960s"

"My mother instilled in my sister, Maya, and me the values that would chart the course of our lives. She raised us to be proud, strong Black women. And she raised us to know and be proud of our Indian heritage," Harris, 55, said in her acceptance speech on Wednesday.

"When I was 5, my parents split and my mother raised us mostly on her own. Like so many mothers, she worked around the clock to make it work, packing lunches before we woke up and paying bills after we went to bed. Help-

ing us with homework at the kitchen table and shuttling us to church for choir practice," said the Indian-American senator from California.

"She made it look easy,



though I know it never was She taught us to put family first, the family you're born into and the family you choose," Harris said.

The New York Times article said her father Donald 81, is long retired from teaching and has remained mostly silent even as his daughter "has stepped into the national spotlight.' The report cited a

say by Donald, in which he says his early, close contact with his daughters "came to an abrupt halt" after a contentious custody battle.

"This early phase of interaction with my children came to an abrupt halt in 1972 when, after a hard-fought custody battle in the family court of Oakland, California, the context of the relationship was placed within arbitrary limits imposed by a court-ordered divorce settlement based on the false assumption by the State of California that fathers cannot handle parenting. China will own the US if Joe Biden is elected, says Trump

Washington: US President Donald Trump on Friday said China will own the US if his Democratic rival Joe Biden is voted to power in the November 3 presidential elections.

On the final day of the four-day virtual Democratic National Convention on Thursday, Biden (77) accepted the Democratic Party's nomination as the presidential candidate to challenge incumbent 74-year-old President Trump, a Republican, in the presidential election.

Trump said the biggest thing about his challenger's speech was the issues that he did not talk about, including China.

"It's time to reject the anger and the hate of the Democrat Party. We have the biggest election



coming up of our lifetime. No party can lead America that spends so much time tearing down America. But, the biggest part of last night's speech was what Joe Biden didn't talk about. He didn't talk about law enforcement. He didn't talk about bringing safety to Democrat-run cities that are totally out of control and they have no clue," Trump said in his address to the

Despite Virus, Pilgrims Pour Into Iraq's Karbala Ahead Of Ashura

hia pilgrims poured into the Iraqi shrine city of Karbala on Friday for the rites of the holy month of Muharram, despite calls to stay home as Covid-19 spreads.

The pilgrimage is expected to be one of the largest religious gatherings in the Muslim world since the onset of the coronavirus pandemic, which already forced Saudi Arabia to hold the smallest Haj in modern history

Usually, millions of Shia pilgrims from around the world flock to Iraq to commemorate the birth of their faith, praying, eating and reflecting together.

But this year, authorities in Iraq, Iran and beyond have repeatedly urged their citizens to forgo real-life pilgrimages due to the high risk of contracting the coronavirus.

Shia-majority Iran is the hardest-hit Middle Eastern country with more than 20,000 coronavirus deaths. Iraq is second with more

Still, by Thursday night, thousands of pilgrims were already en route to the gates of the golden mausoleums in the holy city of Karbala, some masked and gloved but others proceeding shoulder-to-shoulder as they always had.


Enormous tents have been erected as usual to host pilgrims in Baghdad and Basra as well as Karbala, but with a new twist — an attempt at social distancing.

Mumbai HC's Biting Remarks On FIRs Against Tablighi Members

'Foreign Attendees Of Tablighi **Event Made Scapegoat'**

MUMBAI: The Aurangabad bench of the Bombay High Court has said that the foreign nationals, who had attended the Tablighi Jamaat event held in Delhi in March this year, were made "scapegoats" and allegations were levelled that they were responsible for spreading COVID-19 in the country.

A division bench of Justices T V Nalawade and M G Sewlikar made the observations on August 21 while quashing the FIRs filed against 29 for-


eigners, who had attended the event. The bench also noted that while the Maharashtra police acted mechanically in the case, the state government acted under "political compulsion".

The 29 foreign nationals were booked under various provisions of the IPC, the Epidemic Diseases Act, Disaster Management Act and Foreigner"s Act for allegedly violating their tourist visa conditions by attending the Tablighi Jamaat congregation held at Nizamuddin in the national capital.

The bench in its order noted that there was a big propaganda against the foreigners who had come to the Markaz in Delhi.

"A political government tries to find the scapegoat when there is pandemic or calamity and the circumstances show that there is probability that these foreigners were chosen to make them a scapegoat,"

called religious activity (Tablighi Jamaat) was unwarranted. The activity was going on for more than 50 years and it is there throughout the year," it added. It said that the circumstances and the latest figures of infection of COVID-19 in India show that such action against the petitioners should not have been taken.

"The government cannot give different treatment to citizens of different religions of different countries," the court said. Apart from the foreign nationals, police also booked six Indian nationals and trustees of the Masjids for giving shelter to the petitioners.

The bench was hearing three separate petitions filed by the accused foreign nationals, who belong to the countries like Ghana, Tanzania, Benin and Indonesia.

At the end of the judgement, Justice Sewlikar said that while he agrees with the quashing part of the order, he has differing views on a few observations made by Justice Nalawade. However, he did not

With a record spike of 69,874 infections in a day, India's COVID-19 tally increased to 29,75,701, while the recoveries rose to 22,22,577 pushing the recovery rate to 74.69 per cent on Saturday, according to the Union health ministry data.

The death toll climbed to 55,794 with 945 fatalities being reported in a span of 24 hours, the data updated at 8 am showed.

The COVID-19 case fatality rate has declined to 1.87 per cent, it said. There are 6,97,330 active cases of coronavirus infection in the country which comprises



23.43 per cent of the total caseload, the data stated.

India's COVID-19 tally had crossed the 20-lakh mark on August 7. A cumulative total of 3,44,91,073 samples have been tested up to August 21 with 10,23,836 samples being tested on Friday, the highest done in a day so far, Lokesh Sharma, scientist and media coordinator at

NCLT Begins Bankruptcy Proceedings Against Anil Ambani



MUMBAI: The NCLT has directed to initiate insolvency proceedings against Reliance Communications Chairman Anil Ambani to recover Rs 1,200 crore under the personal guarantee clause of the bankruptcy law.

Anil Ambani had given a personal guarantee to the loans given by State Bank of India (SBI) to Reliance Communications and Reliance Infratel in August 2016.

The National Company Law Tribunal (NCLT) Mumbai in its order on August 20 said both RCom and RITL committed default in repayment in and around January 2017.

The accounts were retrospectively declared as nonperforming account (NPA) with effect from August 26, 2016, even before loan agreements had been entered into.

"Such retrospective declaration seems rather incongruous, akin to the adage 'putting the cart before the horse'. While debt and default have remained undisputed, the incongruity of the declaration of NPA. has not been raised and contested by the Respondent.

"Besides, reappraisal of the declaration of the NPA by this Authority would not fall with- Ambani provided personal in the ambit of the provisions of the Code, under which the instant Applications have been made," the order said.

The NCLT ordered the appointment of a resolution professional and asked SBI to take the necessary action.

Moreover, it maintained that it is wrong to assume that no action can be taken until a resolution plan is accepted.

"Sec 60(2) clearly provides for proceedings to be launched against personal guarantors, running parallel to CIRP (corporate insolvency resolution process). Fallacious to assume that no action can be taken against guarantors until the Resolution Plan is accepted," according to the order.

A spokesperson for Ambani said: "Mr Ambani is reviewing the order dated August 20, 2020, of the National Company Law Tribu-

nal, Mumbai Bench (NCLT). and is taking advice on filing an appropriate appeal before the National Company Law Appellate Tribunal against the appointment of the resolution professional."

The NCLT has declined SBI's request for a restriction on Ambani from dealing or appropriating his assets, to the prejudice of the interest of SBI, the spokesperson said.

"The NCLT order directing appointment of the resolution professional does not constitute an admission of SBI's insolvency application by the NCLT. The resolution professional will examine SBI's insolvency application against Mr Ambani and submit a report to the NCLT."

The claim against Ambani, after verification and determination of maintainability, would be considered at a later date by the NCLT, the spokesperson said.

The order of the NCLT will have no bearing on the operations of Reliance Infrastructure Ltd, Reliance Power Ltd and Reliance Capital Ltd," the spokesperson added.

According to the order, around 2015-16, RCom had sought credit facilities of Rs 565 crore for repayment of certain existing financial debts and for credit facilities of Rs 635 crore for its sister concern RITL, also for the repayment of

existing financial debts. SBI on August 29, 2016, provided the amount as loan to RCom and RITL, the order said, adding that Anil guarantee under a Personal Guarantee Deed in favour of the Financial Creditor in re-

spect of the credit facilities. RCom filed for bankruptcy last year, consequently, its secured debt was estimated at around Rs 33,000 crore, while lenders submitted

claims of around Rs 49,000 crore in August 2019. Recently, in March the SBI board had approved a resolution plan for Reliance Communications that envisaged lenders recovering around Rs

23,000 crore, entailing a haircut of nearly 50 per cent. RCom owes nearly Rs

5.000 crore to SBI.

The lenders of Reliance Communications (RCom) and Reliance Infratel (RITL) have already approved the resolution plans with 100 per cent voting in March 2020 and have been placed for the approval for the NCLT Mumbai.
