Police Officer Dies Of Heart Attack

Srinagar: A police officer died on Monday after suffering a heart attack in central Kashmir's Ganderbal district. ASI Abdul Gani Naikoo complained of chest pain following which he was rushed to nearby hospital for treatment, report said Monday. The doctors there, the report said referred him to Srinagar hospital for treatment. However, the doctors there declared him brought dead on arrival. The deceased cop was a resident of Kanilwan Bijbehara. According to the reports, the reason behind the cop's death was a heart attack. A police officer told news agency KINS that a case in this regard has been registered and further investigation has been initiated.

Car Falls Into Gorge In Reasi. 2 Killed

Jammu: A woman was among two persons killed, while her husband and two minor daughters were injured when a car skidded off the road and plunged into a deep gorge in Reasi district of Jammu and Kashmir, police said on Monday. The accident took place at Daggan top when the driver of the car lost control due to dense fog late Sunday evening while moving from Gool to Judda Arnas, a police official said. He said the car fell into a 60-feet gorge, resulting in the death of its driver Reyaz Ahmad (24) and Sameena Akhter (28). Akhter's husband Mohammad Shakeel and daughters -- six-year-old Myra and eight month-old Mehar -- were rescued in an injured condition and rushed to hospital, the official said.

LADAKH STAND-OFF **India Ready For Military Action, If Talks Fail: CDS Rawat**

NEW DELHI: India's armed forces are prepared to look at any military option if the extensive talks to restore status quo ante along the Line of Actual Control (LAC) did not yield any positive result, Chief of Defence Staff (CDS) Gen Bipin Rawat has said on the prolonged border standoff with China in eastern Ladakh.

Gen Rawat, who has been part of the top military brass strategising on the Sino-India border issue, said a "whole of government" approach is being followed to peacefully resolve the row.

The armed forces are always prepared for military actions if all efforts to restore status quo ante along the LAC don't "fructify," the CDS said when asked about the over three-month-long border row. Gen Rawat, who was the Chief of Army Staff from December 2016 to December 2019, said the transgressions take place along the LAC because of varying perceptions about it by the two countries.

India and China have held several rounds of military and diplomatic talks in the last two-andhalf months but no significant headway has been made for a resolution to the border standoff.

Scientists Say Hong Kong Man Got Coronavirus A Second Time

HONG KONG: University of Hong Kong scientists claim do not have lifelong immuto have the first evidence of nity to the virus if they've someone being reinfected with the virus that causes COVID-19.

Genetic tests revealed that a 33-year-old man returning to Hong Kong from a trip to Spain in mid-August had a different strain of the coronavirus than the one he'd previously been infected with in March, said Dr Kelvin Kai-Wang To, the microbiologist who led the work.

At the military talks, the Indian Army has been strongly insisting that restoration of the status quo ante of April this year by China is the only way to resolve the row, according to government sources.

There is a growing view in the Army that the Chinese military is not serious about the resolution of the border conflict as it is resorting to "back and forth" negotiations while the Indian side has very clearly conveyed about its position on the matter.

Sources said notwithstanding the border row, India has been carrying on with the work on laying new roads in the Ladakh region besides developing other key infrastructure.

"Our road construction is not in response to PLA infrastructure development but based on our requirements and those of our people," said a source.

The formal process of disengagement of troops began on July 6, a day after a nearly two-hour telephonic conversation between National Security Advisor Ajit Doval and Chinese Foreign Minister Wang Yi on ways to bring down tensions in the area. However, the process has not moved forward since mid-July.

The PLA has pulled back from Galwan Valley and certain other friction points but the withdrawal of troops has not moved forward in Pangong Tso, Depsang and a couple of other areas, sources said.

In the five rounds of Corps commander-level talks, the Indian side has been insisting on complete disengagement of Chinese troops at the earliest, and immediate restoration of status quo ante in all areas of eastern Ladakh prior to April.

Even as both sides are engaged in diplomatic and military talks, the Indian army is making elaborate preparations to maintain its current strength of troops in all key areas in eastern Ladakh in the harsh winter

during the meeting that there is a provision in the Jammu and Kashmir Reorganisation Bill, 2019 for continuing with the same board -- J&K State Board Of School Education (JKBOSE) -- but since the erstwhile state has been bifurcated into two Union territories, it would be difficult to manage the administrative affairs of the board.

Hence, the committee stated that an alternative plan should be placed for the future. they said.

"The committee members emphasised that schools in the Union Territory of Ladakh should be affiliated to a board which can fulfill the realistic needs of the students in every respect according to the natural conditions of the region which affect the academic session," officials said. The committee members also asserted that given the tough criteria laid down by the Central Board of Secondary Education (CBSE) for affiliation. most of the schools cannot fulfill those criteria in real terms.

However, they said certain aspects from CBSE which may suit the purpose for establishment of a new board in Ladakh can be adopted.

That Facebook did consider the posts to be offensive is apparent from the fact that these posts were deleted on Aug 17, after the WSJ wrote to Facebook seeking its comments. We are dismayed to learn, again from the WSI article. that the Public Policy Head of Facebook India consciously opposed applying Facebook's hate speech rules to members of the ruling Bharatiya Janata Party (BJP) because doing so would adversely affect the company's business prospects in India," it added.

The letter further says that the signatories have written only to the government and government institutions whenever the democratic rights of Indian citizens were being violated, but have not written to any non-Indian body

"We are writing to you now, in a departure from our usual practice, because certain actions (or the absence of certain actions) by Facebook in their operations in India have thrown into danger some of the fundamental rights of the people of India," the letter reads.

The letter also mentions about the recently passed Citizenship Amendment Act (CAA), coupled with the proposed National Registry of Citizens (NRC), that "threatens to take away the citizenship of hundreds of thousands of Muslims and other minorities in India and put them in detention centers."

"You cannot also be ignorant of the communal riots that took place in Delhi in February 2020, in which 53 persons were killed, two thirds of them Muslims. Several cases of lynching and torture, primarily of Muslims and Dalits (oppressed castes and groups), have also occurred in India in recent years," the signatories write.

The letter also brings up the issue of 'cow vigilantism' into the notice Zukerberg.

"Many of these crimes have been instigated through hate speech spread through various communication channels, such as Facebook, WhatsApp, and Twitter. Despite being aware of this, Facebook has failed to implement its own policy of discouraging hate speech in India, or has implemented it in a clearly partisan manner. That this seems to have been done to protect Facebook's commercial interests is even more reprehensible. We note that such behaviour on Facebook's part has become a subject of debate in other countries as well." the former civil servants add in the letter. Urging serious effort to audit the implementation of Facebook's hate speech policy in India, the signatories say that while such an audit is underway: it must be ensured that the present Public Policy Head of Facebook, India, is not in a position to influence the investigations. "We also fervently hope that in future, you will not let your company's business prospects stand in the way of implementing your own policy against hate speech and posts which can lead to hate crimes. This is a sure way of demonizing minorities and inflicting violence upon them while undermining the democratic and secular basis of the Indian Constitution," the letter adds.

Sabia Hussain, another witness said that the cops also entered the shrine and baton charged whosoever they came by. She said that the cops didn't even spare women and children.

"The police action was unwarranted and uncalled for. The procession was about to conclude at the shrine when the cops came out charging from their vehicles," she said.

Sabia also alleged that the police was rounding up heads of the families for holding planned night long majaalis at their respective places.

The alleged police action also triggered outrage on social media after a 1.52 minute video clip showing police beating mourners went viral. In the short duration video, the mourners were seen screaming and engaging in a heated argument with the policemen.

"You cannot do this. This is our religious practice. And it was a peaceful procession," a woman mourner can be heard shouting. "How dare they beat me up? How can you touch women? Were we

shouting Azadi slogans?" shouts another woman at cops.

Earlier reports said that flags of Lebanese resistance group Hezbollah hoisted at various places in the old city were seized by the police.

When contacted, SHO Zadibal Mr Javed refused to comment on the allegations of highhandedness levelled against his men.

"At lower level, we are not allowed to talk to media. Only senior officers can speak about it," he said.

cy (CRA) on the terms and conditions, fixed by the Industrial Finance Corporation of India (IFCI) Limited of the Union Ministry of Finance: Formal mandate was given to the Stock Holding Corporation of India Limited (SHCIL) for the purpose, and Commissioner Stamps (Commissioner, Commercial Taxes Department) acting as the Nodal Officer of the e-stamping project and to Co-ordinate between various stakeholders i.e. Department of Law and Parliamentary Affairs, Revenue Department, Finance Department and Stock Holding Corporation of India Limited (SHCIL) for the switching over to e-stamping.

On the 16th September 2013, the Government implemented e-stamping system in the erstwhile State initially in the Districts of Srinagar and Jammu on pilot basis.

All Jamabandies To Be Prepared By Sep End

E-stamping would help govt save Rs 30 cr: Kotwal

SRINAGAR, AUGUST 24: Principal Secretary and Financial Commissioner Revenue, Dr Pawan Kotwal, today asked the revenue officials to gear up for the new system of land measurement that is more prompt and highly accurate.

Pertinently, Continuous Operating Reference Station (CORS) is the modern system of measuring land that is equipped with a dish antenna linked with a satellite to get accurate coordinates. Measurement of land, as said, is accomplished in minutes along with producing an accurate map of the land.

The meeting was attended by Deputy Commissioner Srinagar, Shahid Iqbal Choudhary; and Mohammad Qasim, Regional Director Survey & Land Records (RDSLR) Srinagar while Deputy Commissioners of other districts of Kashmir division along with respective RDSLRs participated through video conferencing.

Dr Kotwal directed the officers to complete the digitization of all the quadrennial Jamabandies before the initiation of new measurement process. He asked them to work extraordinarily so that the same is accomplished before the initiation of land measurement through CORS. Principal Secretary asked the con-

cerned to correlate the quantam of each measured field with the official records so that no dichotomy creeps into the newly created records. He maintained that the

results of this process are highly scientific and accurate. Therefore the records created thus are more reliable and would have greater utility. Dr Kotwal urged upon

all the Deputy Commis-

sioners to complete the

process of making of qua-

drennial Jamabandies by September this year so that their ditization is taken in hand forthwith. He asked the Regional Directors to authenticate all the Jamabandies well before the deadline.

Dr Kotwal underscored the need of clearing all the pendencies regarding the issuance of domicile certificates before 10th of September as per the orders of the Lieutenant Governor of UT of J&K. He further asked them to expunge all the illegal entries from the revenue records besides accelerating the process of eviction from kahcharai/state land.

Dr. Kotwal asked the officers to provide the geo-coordinates of identified land plots for creation of revenue infrastructure like Niabats and Patwarkhanas thereon. He directed them to install signboards on all such plots so that these are notified for people once the assets are created over them. He exhorted upon them to work for getting the images and details of all the water bodies in their respective areas as per GoI guidelines by using the already provided gadgets to them. He revealed that same is necessary to preserve

and protect them for posterity.

Principal Secretary was informed that near about 6.7 crore of revenue documents have been digitized till date including almost all documents from the record rooms. He was further informed that all the Jamabandies will be ready by the end of September this year.

The meeting was also apprised that some 51748 old revenue maps and 1747 new village maps have already been digitized. Besides, 3895 ground control points and 5855 GPS points stand already verified for hastening the process of measurement under previous system.


It was informed in the meeting that about Rs 30 crore would be saved by the government on printing of stamp papers by adopting e-stamping mechanism.

The meeting was informed that 32286 registrations has been done up to 20.08.2020 and Rs 30.42 crore have been realised from the same. It was further said that entire registration process is planned to be computerized and made online adopting the National Generic Document Registration System (NGDRS) shortly.

SRINAGAR, AUGUST 24: On Monday, The department of Legal Metrology (LDM) Srinagar unit said that it booked and penalized 26 drug stores and departmental stores/ retailers in the current financial year 2020-21 for over-charging/ labeling norms and collected penal sum of over Rs. 50,000.

Due to Covid19- pandemic, Government of India, under Essential Commodities Act, 1955 declared Hand Sanitizers, 2 ply and 3 ply surgical masks and N-95 masks as essential commodities in the month of March 2020 for a period of 100 days in order to prevent their hoarding, black- marketing and profiteering.

It also added, the prices of Hand Sanitizers/2 ply and 3 ply surgical masks were notified by the Ministry of Consumer affairs GOI, however. N-95 masks were not brought under pricecontrol as its quality parameters are differential.

Congress crisis

letter by over twenty senior Congress leaders to the interim Congress president Sonia Gandhi has plunged the party into a deep crisis. It is learnt now that Sonia Gandhi is set to resign to pave the way for the election of a non-Gandhi president. But the letter has split Congress down the middle with Gandhi family supporters and opponents at logger-heads with each other. Among the Gandhi family supporters, however, are incumbent chief ministers like Amarinder Singh, Bupesh Baghel and Ashok Gehlot. However, the letter marks a break from the passivity of the last six years with the party apparently seeming to have resigned to its current lot. But it won't also be easy to elect a non-Gandhi president. And the party has its own reasons for this: a Gandhi not being at the helm will run the risk of breaking the party up. Also, in the present circumstances, Congress doesn't boost of many a mass leader -albeit, there are many senior politicians who can be worthy successors to Gandhi. Gandhi's term at the helm has shown that he is not just up to the task.

The situation is not any better among other parties. The country's secular opposition is in tatters and fighting over scraps. There is no major pan-India leader to take on the overarching persona of Modi. While Rahul Gandhi and many others look like minions, the likes of Mamta Banerjee and Mayawati who once showed signs of shaping up into credible rivals have too paled into significance. The caste based parties in Uttar Pradesh who were only hope to stop Modi's juggernaut have bitten the dust. And they are unlikely to recover from the beating they have taken in polls after polls.

It is now clear that the Modi wave remains alive and kicking. After a few reverses here and there over the past six years, Modi's appeal has only grown stronger. He is now certain to win many more Assembly polls, more so, the upcoming election in West Bengal unless Congress and wider opposition gets its act right. If no credible opposition emerges from the shadows in the near future, a prospect which looks bleak.


The deft blend of ideology and the grassroots organization under Modi's charismatic leadership is expected to help the BJP triumph in future polls. While the opposition is reeling from the defeat over the past some years the BJP is busy setting up its base in the states where it lacks the presence. With some pushback brewing within its ranks, there is hope that Congress can set its house right by electing a full-time leader who is able to take on the might of Modi. This alone can get it back in reckoning.

even years after its birth, the Jammu & Kashmir Muslim Conference was converted into a new political party — the Jammu & Kashmir National Conference — on 11 June 1939 to, what its President, Sheikh Mohammad Abdullah claimed, pursue nationalistic politics. The development caused dissension among the Muslims of Kashmir, resulting in perennial enmity, which, though, had started years earlier. between the supporters of Abdullah and Mirwaiz Mohammad Yusuf Shah, who opposed the conversion. For years, the two ideologically divergent groups fought out their differences on the streets of Srinagar city and gave each other bloody noses and broken bones.

On the basis of his mass support, Sheikh Mohammad Abdullah, the founder President of the Muslim Conference, was able to bulldoze the dissenting voices and formalize its conversion to a 'nationalist party' inviting into its fold the minority communities. Eight decades down the line, analysts suggest that demolition of the Muslim Conference, not the Partition of 1947, laid the foundation of the Kashmir problem that has bitterly engaged two neighbouring countries of South Asia for the last over seven decades. That being a subject for researchers to further work on, let us now come to a different point linked with the dissolution of the Muslim Conference and birth of the National Conference.

A year after the Muslim Conference was launched, the foundation stone of a building named the Mujahid Manzil (Abode of Warriors) was laid, on 6 November 1933, on the left bank of the Jhelum opposite the famous Muslim shrine of Khanqah-e-Moulla, to serve as the party's headquarters. Post-11 June 1939 decision, the Mujahid Manzil was taken over by the National Conference as its party headquarters. However, there were others who believed it was the property of the Muslim Conference and, therefore, of the Muslims. On 16 June, barely five days after the formation of the National Conference, some youth went to Hazratbal shrine and hoisted a green Islamic flag on the shrine building. Buoyant with their act, they now marched to the Mujahid Manzil in order to wrest the building from the National Conference and unfurl their flag on it. When the group of youth arrived at the Mujahid Manzil, there were some workers and leaders of the National Conference present there. Prominent among them was the party President, Sheikh Mohammad Abdullah. As the youth attempted to take control of the building, the National Conference leaders led by Abdullah resisted them. There erupted a clash between the two sides. Abdullah and his associates pelted stones on the invading youth, injuring them and making them to retreat. It was quite an interesting scene where. both literally and figuratively, the tallest leader of Kashmir and the President of its largest political party was engaged in 'kani jung' or hurling stones on his opponents. The event is the first recorded in-

cident in the turbulent history of Kashmir when a political leader of Abdullah's stature had resorted to stone pelting. On the following day, the police arrested some workers of the National Conference in connection with the incident.

The event was recorded by Molvi Mohammad Shah Sa'dat in his daily diary, Tareekh-i-Kashmir Ki Rozana Dairy. Sa'dat, we are told, was admitted by Maharaja Hari Singh, the last Hindu Maharaja of Kashmir, to his Darbar as a historian. Noted historians, G. M. D. Sufi and Munshi Muhammad Din Fauq, authors of Kashir and Tawarikh-i-Kashmir, respectively, have drawn from his works. A year after the stone pelting incident at the Mujahid Manzil, a group of educated youth had a meeting at Badam Waer (The Almond Alcove) on 26 March 1940 where they raised pro-Muslim Conference slogans and made speeches. After their meeting, they marched to the Mujahid Manzil and hoisted a flag atop the building. Molvi Mohammad Sayeed Masoodi, General Secretary, National Conference, who was present there, had the youth thrashed and the flag removed. Between 1953, when Sheikh Mohammad Abdullah was dismissed as the Prime Minister of Jammu & Kashmir and arrested, and 1975 when he returned to power after mending fences with Prime Minister Indira Gandhi, the Mujahid Manzil served as the party office of the Jammu & Kashmir Plebiscite Front, a political party launched by Abdullah's lieutenant, Mirza Mohammad Afzal Beg and others to launch a peaceful agitation for demand for plebiscite while the former remained incarcerated. Abdullah's return to power also saw the return of the Mujahid Manzil as the party headquarters of his National Conference. On 27 December 1994, the historic building was reduced to rubble in an incident of fire. In the earlier phase of rivalry between the followers of Abdullah and the Mirwaiz, Bakshi Ghulam Mohammad, a right hand man of Abdullah, who later staged a successful coup against him in 1953 to become the Prime Minister, was beaten to a pulp by the Mirwaiz supporters at Genz Khod in old city on 8 September 1933, as a result of which he lost consciousness. Later, in 1942, the two sides hurled stones at each other after the supporters of Abdullah tried to stop the Mirwaiz from delivering Eid sermon at the historic Eidgah. In the violent clash, hundreds of people were injured. In 1944 and 1945, respectively, public meeting of Mohammad Ali Jinnah and river procession of Jawaharlal Nehru were thrown stones at by the rival sides. In the later incident, among others, Khan Abdul Gaffar Khan was injured. In 1939 and 1967, agitating Kashmiri Pandits resorted to stone pelting while protesting against the takeover of the Durganag Temple by the Dharmarth Trust and conversion of a community girl, Parmeshwari, to Islam and marriage to her Muslim colleague, respectively. On 5 November 1973, the vehicle of Sheikh Mohammad Abdullah, who was then out of power, came under a shower of stones when he had arrived at the Government College for Women, Maulana Azad Road to attend as chief guest a function to rename the college after Jawaharlal Nehru.

Stone pelting has been a weapon of protest in Kashmir for long and those caught in the act are severely dealt with by the police. In recent times, especially since August 2019 after the revocation of the Article 370 of the Indian Constitution that guaranteed internal autonomy to Jammu & Kashmir, stone pelting youth were booked under the draconian Public Safety Act and, after amending the law, several of them were lodged in jails outside Jammu & Kashmir.

TAILPIECE: There is an interesting ritual associated with stone pelting with religious sanction observed in village Dhami, near Shimla, in the north-Indian state of Himachal Pradesh. As per tradition, on the second day of Diwali, a major Hindu festival, people of the village divide thems ves into two groups and pelt stones at each other. In the process, the blood of the first injured person is used to perform tilak (coloured mark worn by Hindus on the forehead) on the deity, Bhima Kali. The legend has it that once the ruler of the area was killed in a fight and, following the then prevalent custom, his wife committed sati. Before jumping on the funeral pyre of her husband, she took a pledge from the villagers that they would stop offering human sacrifice at the Bhima Kali Temple and instead form themselves into two groups and throw stones at each other. The blood thus spilled should be offered to the deity.

A deepening alliance

here were no dramatic announcements from the meeting between the Pakistan Foreign Minister, Shah Mahmood Qureshi and his Chinese counterpart, Wang Yi, late last week in the Chinese island province of Hainan. It was about the further consolidation of the all-weather partnership between Islamabad and Beijing across a broadening range of issues -from economic and commercial to the political and security. What makes this round of Sino-Pak strategic dialogue significant is the rapid deterioration of India-China ties amidst the unresolved militarv standoff in eastern Ladakh. India has had to cope with the consequences of the China-Pak partnership that can be traced back to the mid 1950s. Yet, Delhi has continuously underestimated the deepest sources animating it. To make matters worse, Delhi has always over-determined the prospects for its own partnership with China and its ability to transcend the Sino-Pak alliance.

For Delhi, the immediate concern is about intensive Sino-Pak political coordination on Kashmir. China has lent strong support to Islamabad's efforts to mobilise international condemnation of Delhi's constitutional changes in Kashmir since late last year. The joint statement issued after the talks between Wang and Qureshi saw China reaffirm its criticism of India's "unilateral actions" in Kashmir. As part of the commitment on both sides to support the "core interests" of the other, Pakistan expressed support for China's repression of the majority Muslim community in Beijing's far western province of Xinjiang. The point here is not about Pakistan's double standards in raising human rights concerns about Kashmir and supporting China in Xinjiang. Hypocrisy is very much part of international relations. The real story is about the deep foundations of the Sino-Pak alliance that transcend religion and are tied to shared interests of the two nations in containing India.

India, however, has been reluctant to confront this central reality — which continues to express itself in multiple ways. These range from the construction of the Karakoram Highway through Kashmir in the 1970s to the expansive China-Pakistan Economic Corridor of the present and from Beijing's nuclear and missile assistance to Pakistan in the 1980s to the integration of Pakistani naval forces and bases into China's ambitious Indian Ocean strategy. Even as it fends off their coordinated attempt to put India in the international dock on Kashmir, Delhi must prepare for a full range of other contingencies - from Sino-Pak joint support to insurgent groups in India's Northeast to probing India's other internal, regional and international vulnerabilities. Recognising the challenge of the Sino-Pak alliance is necessarily the first step in any Indian strategy to cope with it in the days ahead.

Kashmir's Covid Catch-22

ashmir is currently exhibiting a double burden of poverty exacerbated by the allied physical, social and psychological impacts of COVID-19 itself. Many estimates predict a worsening of the situation. A yearlong lockdown has placed Kashmir in a catch-22 situation where we're having to choose between what might be considered "right" and what might be the "needful". In any case, one can't take a puritan position and advocate complete lockdowns to protect life. One has to find a strategic way out of the calamity Kashmir has been facing for over a year now.

Kashmir's workforce thrives on the informal sector to a larger extent, yet the mitigation plan from the government has totally neglected this sector. In fact, the plight of day labourers in Kashmir is only the tip of a larger humanitarian crisis. Even migrant workers in Gulf have lost their livelihood. Small businesses based in Kashmir have suffered huge losses and have exhausted savings for further investments in business. It is the same with manufacturing labourers who work in factories, workshops or even at home. One of the many sectors which has incurred huge losses is the public transport sector, which has also faced the brunt of a yearlong crisis in Kashmir

If the lock down continues even intermittently, these groups might have to skip meals, take loans or liguefy household items as their meagre income would not go long. Remittances, which contribute a lot to the GDP, have already experienced a sharp decline. Many expatriate workers who

had temporarily travelled to the Gulf nations and Southeast Asia for skilled work, have returned in the past months and the government is under pressure to take them back. As remittances are one of the main source of Kashmir's revenue, the decline has put a serious drain on the economy.

Additionally, India's agriculture sector depends hugely on export orders, which have drastically decreased due to the rise of the novel coronavirus cases around the world, including in-country transportation. This has also affected agriculture based entrepreneurs and other stakeholders in the agrarian sector in Kashmir.

But hunger and poverty have not been the only implications of the lockdown. Many other social and psychological issues have crept up. The lock down is taking a heavy toll on women

and children. There are multiple reports revealing increase in domestic violence cases against women and children especially in the urban areas. This increase in violence within domestic spaces has also put others like elderly, sick or differently abled people at risk.

It is quite baffling that little has been done or planned to address these issues strategically. Only NGOs and philanthropists are trying to do their best to reach out to as many people as possible. However, in the absence of policies and systematic plans from the government; scattered and individual good Samaritans can only do little to bring Kashmir out of the mess.

porting a signature mid-length hair and a traditional wear, a jovial Kashmiri woman has captured the hearts of thousands of netizens with her profound humorous acting and dialogue delivery blended with applaudable punches.

Perhaps spreading smiles comes naturally to MeankaHandu, the contemporary Kashmir's celebrated comedian who has never been to any acting school. It was her pure love for Kashmir, its culture, people and the unfortunate known fact of dying Kashmiri language which motivated her to go online.

She addresses her audience via her YouTube channel 'AsvunKoshur' in a typical Kashmiri language whisked with a comic ingredient and brings a wide smile on every face that listens and watches her.

In April 2017, she posted her first video on YouTube in her mother tongue and the overwhelming response that followed encouraged her to take this riveting and constructive step further.

Meanka'scentral comic character Dida makes her deeply rooted to her homeland, its culture and language. The rib-tickling character is a name given to a Kashmiri Pandit woman.She brings every Kashmiri together and makes them laugh regardless of their religious faith or political opinion.

Dida plays the role of a much older woman who is the mother of two kids—18-year-old Sheen and 16-yearoldNabad; while as JiggaMasi and her daughter Cherry Didi are the villainous fictional characters.

Meanka performs all these roles single-handedly. She receives several messages from her female audience since they relate themselves with the name Dida.

"I've received messages from some Kashmiri Muslim girls who are called Dida at home," says Meanka. "I believe my audience relates to this name and character."

Since her school days, Meanka used to receive bunch of plaudits for her unique sense of humour. And ergo, she decided to mix her gift with euphonious Kashmiri language. And hence, the name 'AsvunKoshur' came into being which means a smiling Kashmiri.

With 40k subscribers to her YouTube channel, Meanka seeks to teach Kashmiri in an informal way often loaded with proverbs and old sayings of Sufi saints and Rishis such as LalDedand Nund Rishi.

She addresses the taboos and social issues prevalent in the society in a humorous manner, thereby, making a humble effort to raise awareness among the people and at the same time accentuating Kashmiri language.

She firmly believes that mother tongue is the backbone of any culture that needs to be preserved and revitalized.

"Kids are not encouraged to speak Kashmiri at homes or even in schools," says Meanka."Hence, I started my YouTube channel which caters to this cause."

Speaking in one's native language creates an immense impact on maintaining its zenith, and Meanka steadfastly believes that it is one's identity which indigenous people must love, encourage, preserve and take pleasure in speaking.

"I take great pride in the fact that I can fluently speak in my mother tongue, so should every Kashmiri,"the witty woman continues.

Also, she reckons, there's no better way to give out the message of oneness, communal harmony and broth-



erhood than in an amusing and familial manner. "Even if a handful of people are able to shun bitter-

ness, I will consider my job done," she smiles. In addition to YouTube, she has approximately 85k and

15.5k followers on Facebook and Instagram respectively. Apart from Kashmir, her whacking followers include non-Kashmiris from Delhi, Punjab, Maharashtra, Andhur Droden and Varnetelar The with dwine her for

Andhra Pradesh and Karnataka.They admire her efforts and comic style. Currently residing at Noida, Meanka was born in a

well-educated Kashmiri Pandit family in Rainawari, Srinagar. However, her parents had to leave following the mass migration of her community in 1990.Her father, VirenderPrakash, runs a trekking company, while as her mother, RaajHandu, has been a teacher all her life.

"My dad always taught me the difference between education and literacy, encouraged me to read newspapers and books, and didn't let me restrict myself to academic syllabus only," Meanka says. "My parents have always been supportive and I shared my first video with them and few close friends, who actually stood by me in my thick and thin."

She completed her schooling from KendriyaVidyala, Noida, and later did her engineering in Information & Technology from University of Mumbai. However, she craved for something that offered her creative freedom.

As such, she took Learning and Development as her profession. Having worked in MNCs for almost eight years, she now works as a freelancer and helps emerging companies set up training functions.

So far, her three years of online journey has made her more humble and empathetic because of the people who jam-pack her inbox with gratifying notes. Also, she has learned to respond rather than react to any kind of obnoxious text thrown at her.

myself this is what I don't have to do to anyone. I think hundred times before writing or saying anything to any person," says Meanka.

But on professional front, she handles and manages all the technical aspects—writing, directing, executing, recording, editing—without relying on anyone.

"Hours of hard work and mental preparation goes on in the background before the act is delivered to the people which just comes out as a 10-15 minutes of work," she says.

As a person, Meanka is an action-oriented woman and believes in taking practical steps to deal with any problem or situation.

"My life and career have always been driven by a strong passion to support and bring about a change," she says.

She balances her professional and personal life gracefully despite it becoming hectic for her at times. However, her love and commitment towards her work and the numerous fans looking forward to hear from her provide her strength and motivation amidst her incessant schedule.

She has also started her online shop on her official Facebook page that deals in coffee mugs, t-shirts, and hand-painted wooden accessory boxes for females.

But amid virtual laughter and faraway real life, she often gets drifted to mountains and yearns for the grape creepers, walnut tree, kitchen garden, clear blue sky, andtwilight chirping of birdsin her ancestral home.

Despite not being able to spend much time at her native place, she feels a strong connection with Kashmir and someday in future she desires to come back.

She believes that Kashmiris who had to leave Kashmir and those who continued living there have suffered regardless of their religion and community. Hence, both must overcome the enmity and rise above it.

"I truly believe we all need to acknowledge each other's pain and rise above hate," Meanka concludes.

How an "Early Marriage" Empowered Me

t's been almost a year since I've been married to the most wonderful human being. I married him at an age many would deem "too young" for a woman with ambition. In my pensive moments, I would wonder if that were true. I was often overcome with the fear that my life would halt as an individual and start as someone's wife. But I took the leap, knowing well, that I shall set my own terms.

In our society, discussions about marriage are always scaled on a timeline. There's a consensus on what should be deemed too early, early, the right age, late or too late. This timeline is redundant as it does not take into account the lives of women per se. All women are different by virtue of their personal as well as professional lives. How then can we have one timeline for all? Why must we have a timeline at all?

I grew up and worked my way in environments where my opinion was respected and asked for. I was always passionate about my professional life. There had been days when, like many, I had also perceived marriage as a hindrance to my career. However, it was my parent's marriage which had kept my faith in the institution. For many, this has not been the case and the institution has rightly been seen as a problematic one. However, I had been privileged this way and in many others ways. This is why, when the right person came around, I wasn't hesitant to get married.

For many, the age of getting married isn't their discretion and many are pushed into one without having a say in it. This is an unfortunate reality of our society and one which I am aware of. However, as an educated woman from a privileged background, I had the apprehension of a different kind of stigma — that of marrying "too early".

Nonetheless, the realisation that I still own my destiny and identity as a human came to me after realising that men in my family had gone on to faring well in life even after becoming husbands and fathers. While they were able to do that because they were men; I had the opportunity to change that for myself. With the right mindset, I could make right choices for myself and my husband was one of the many I have made in the direction. When I first met him, the first thing I noticed that he loved about me was my ambition. I decided to get married to him not because I felt he completed me but because I could see myself growing as an individual with him along the way with me.

The society judges us and our decisions as women because we are not yet ready to realise that women aren't owned by their husbands or fathers. In the past year, a couple of my colleagues and friends have come up to me and mocked my decision to settle down. But why can't I have it all like the men before me had? Why can't I have crazy ambition and an amazing family life? Why can't I as a woman have kids as well as patents?

The question here is not about marriage but about a person's agency. Most women in our society face hurdles in exercising their agency. However, that needs to change. We must let women decide their own journeys. We as women must also remember that the picture can't



always be painted for us. We've got to choose our own scenery and develop it.

However, our society has to change to make itself conducive for women to exercise our agency. We need to change narratives around marriage to accommodate those who want to marry, do not want to marry and even those who do not believe in the institution of marriage.

But for it to become easy for women to make decisions easily, we must also have allies.

I have had the privilege of growing up in a supportive environment where I had many allies. My father-in-law pushed me to go for a project that would keep me away from home. My husband and my mother-in-law have also ensured that I have an environment where I can actively choose my own professional path and enjoy my family life as well. My mother and father have been my primary role models who made way for me to chart my own destiny.

We, as a society, need to find a way out of our conventional expectations from marriage. We must strive to create an environment where no choice is stigmatised. No one gets to decide what empowerment looks like. For some women, it may be fulfilling to work as a home maker and others might find fulfillment outside their domestic spheres. We need to let women decide for themselves without keeping on them the ever looming threat of stigma and judgment. Society might not change too quickly and will continue to quantify women through our performances as wives, working women or through our looks. However, the only person a woman needs to satisfy emotionally, spiritually, physically and professionally, is no one but herself.


Jerusalem: As US Secretary of State Mike Pompeo started a Middle East tour in Israel on Monday, Islamist group Hamas called on regional leaders to "break their silence" on Israel's blockade of Gaza.

Israel has bombed the coastal Palestinian strip, which is ruled by the group, almost daily since August 6, while balloons carrying fire bombs and, less frequently, rocket fire have hit Israel from Gaza

In retaliation for the balloon attacks and the widespread blazes on farms and scrubland they have caused, Israel has tightened its 13-year blockade of Gaza's two million inhabitants

It has banned Gaza fishermen from going to sea and closed its goods crossing with the territory, prompting the closure of Gaza's sole power plant for want of fuel.

Hamas in a statement called the closure of the Kerem Sha-



Pompeo touched down in Tel Aviv Monday morning to kick off a five-day trip to the Middle East.

His visit will focus on Israel's normalising diplomatic ties with the UAE, seen as a betrayal by many Palestinians, and urging other Arab states to follow suit.

Earlier Monday the Israeli army said it had again hit Hamas targets in the Gaza Strip overnight, in retaliation for incendiary balloon and rocket attacks launched from the Palestinian enclave.

An Egyptian delegation has been trying to broker a return to an informal truce.

"During the day, explosive and arson balloons were launched from the Gaza Strip into Israel," an army statement said.

"In response ... fighter jets, tanks and aircraft struck military posts and underground

WHO Says 172 Countries **Engaging With Global COVID-19 Vaccine Plan** Agencies

Geneva/London: Some 172 countries are engaging with the COVAX facility designed to ensure equitable access to COVID-19 vaccines, the World Health Organization said on Monday, but more funding is needed and countries need now to make binding commitments. Countries wishing to be part of the global COVAX plan

have until Aug. 31 to submit expressions of interest, WHO officials said, with confirmation of intention to join due by Sept. 18, and initial payments due by Oct. 9.

WHO director general Tedros Adhanom Ghebrevesus said the facility was critical to ending the COVID-19 pandemic, and would not only pool risk for countries developing and buying vaccines, but also ensure prices are kept "as low as possible"

"Vaccine nationalism only helps the virus," he told a media briefing. "The success of the COVAX facility hinges not only on countries signing up to it, but also filling key funding gaps."

COVAX is co-led by the GAVI vaccines alliance, the WHO and the CEPI Coalition for Epidemic Preparedness




Innovations and is designed to guarantee equitable access globally to COVID-19 vaccines once they are developed and authorised for use.

It currently covers 9 candidate COVID-19 vaccines and its aim is to secure supplies of and deliver 2 billion doses across countries that sign up by the end of 2021.

"Initially, when there will be limited supply (of COVID-19 vaccines), it's important to provide the vaccine to those at highest risk around the globe,' Tedros said

He said this included health workers on the front lines of the pandemic, who were "critical to saving lives and stabilising the overall health system"

At the opening of the sentencing hearing in a Christchurch courtroom, prosecutors revealed chilling details of a meticulously planned attack in which Brenton Tarrant wanted "to have shot more people than he did".

With the Australian gunman face-to-face with the bereaved families and wounded for the first time, survivors told of hiding under bodies, of forgiving Tarrant, and of living with the sound of an automatic rifle ringing in their ears.

Held amid tight security with



snipers positioned on downtown rooftops, the hearing was told how on March 15 last year the heavily-armed Tarrant opened fire on men, women and children, ignoring pleas for help and driving over one body as he moved from one mosque to the next.

When he saw three-year-old Mucad Ibrahim clinging to his father's leg. Tarrant killed him "with two precisely aimed shots," prosecutor Barnaby Hawes told the court.

Tarrant has pleaded guilty to

51 charges of murder, 40 of attempted murder and one of terrorism after storming into two mosques in Christchurch, with the rampage ending when police stopped him as he travelled to a third.

Lawyers expect the 29-year-old to be the first person jailed for life without parole in New Zealand.

Wearing grey prison clothing and surrounded in the dock by three police officers, the 29-year-old remained silent, occasionally looking around the room, as Hawes delivered a chilling summary of facts.

"He admitted going into both mosques intending to kill as many people as he could," Hawes said.

"He stated that he wanted to have shot more people than he did and was on the way to another mosque in Ashburton to carry out another attack when he was stopped," he said.

ASHINGTON: Donald Trump's older sister described the US president as cruel and a liar whose lack of principles meant he could not be trusted, according to secretly made recordings published on Saturday.

It was the latest unflattering insider account to target the president, only instead of a jilted aide or business associate, it was from one of his closest relatives.

Maryanne Trump Barry, a former federal judge, slammed her brother over his immigration policy that saw children separated from their parents at the border and sent to detention centres.

"All he wants to do is appeal to his base," she said in recordings obtained by the Washington Post. "He has no principles. None.

"His goddamned tweet and lying, oh my God."

The recordings were secretly made by the president's niece Mary Trump,



who published last month a bombshell memoir of the "toxic family", who produced him.

The president's younger brother Robert, who died last week, went to court to try to block its publication arguing that Mary was violating a nondisclosure agreement signed in 2001 after the settlement of her grandfather's estate, but to no avail.

Some 950,000 copies were sold the day of the memoir's release, with the White House calling it a "book of falsehoods"

TikTok to sue Trump over crackdown

EW YORK: Video TikTok said app on Saturday it will challenge in court a Trump administration crackdown on the popular Chineseowned platform, which Washington accuses of being a national security threat.

As tensions soar between the world's two biggest economies. President Donald Trump signed an executive order on August 6 giving Americans 45 days to stop doing business with TikTok's Chinese parent company ByteDance effectively setting a deadline for a potential pressured sale of the app to a US company.

"To ensure that the rule of law is not discarded and that our company and users are treated fairly, we have no choice but to challenge the executive order through the judicial system," TikTok said in a statement.

COVID-19: AICTE Allows MBA, PGDM Admissions Based On Marks In Qualifying UG Exams

nstitutions offering MBA and PGDM courses have been allowed to ad-I mit students based on marks obtained in qualifying undergraduate exams as several entrance tests could not be conducted due to the COVID-19 pandemic, the All India Council of Technical Education (AICTE) said. The council has directed institutions to select candidates based on merit in the qualifying UG exams if there are vacant seats available.

The technical education regulator has also clarified that the relaxation is being made available only for the 2020-21 academic session and should not be seen as a precedent for future academic years.

"All-India tests like CAT, XAT, CMAT, ATMA, MAT, GMAT and the Common Entrance Test of respective states are the qualifying tests for admission to MBA or the Post Graduate Diploma in Management (PGDM) course. In many states, some of these entrance tests could not be conducted due to the fear of coronavirus spread, and there is no indication as to whether these tests are postponed or likely to be held or cancelled," AICTE Member Secretary Rajive Kumar said.

"AICTE, being more a facilitator than a regulator, considered alternative proposition through which selection of the students could be made for admission to PGDM course which will benefit both the institutions as well as the students. Therefore, in the current scenario, the PGDM and MBA institutions are al-

Batting Legend Zaheer Abbas Inducted To Icc Hall Of Fame Along With Lisa Sthalekar

SOUTH HAMPTON: Pakistan batting great Zaheer Abbas, outstanding South Africa all-rounder Jacques Kallis and Australia women's star Lisa Sthalekar were all inducted into the International Cricket Council's Hall of Fame on Sunday.

Zaheer, 73, a prolific run-scorer during the 1970s and 1980s with both Pakistan and English county side Gloucestershire, was nicknamed the 'Asian Bradman' in honour of Australia's Don Bradman, widely regarded as Test cricket's greatest batsman of all time.

"I feel privileged and truly humbled to be inducted into the ICC Cricket Hall of Fame of the class of 2020." said Zaheer, a former president of the global governing body and the only player from Asia to have scored a hundred first-class hundreds.

'Final recognition'

Zaheer scored a double-century and a century in the same first-class match on a record four occasions and was the first



batsman to score three successive centuries in one-day international cricket.

"I would like to say a special thanks to my family, my country Pakistan, my county Gloucestershire and many fans worldwide who helped me achieve and fulfil my dreams by playing this great game at the highest level," he said.

"Thank you, ICC, and the members of

the jury, for this special honour. It is a final recognition for any cricketer. This great I believe that I would ever get to join game has made me the person I am."

Kallis, 44, is the only player to score at least 10,000 runs and take at least 250 wickets in both Test and ODI cricket.

The ICC player of the Year and ICC Test player of the year in 2005, Kallis is also South Africa's leading Test run-scorer, and currently third on the all-time list.

"It is something that I never expected when I started playing," said Kallis, the most capped South African player in both Test and ODI cricket. "I only wanted to win he games for whoever I was playing for." 'Pantheon of greats'

India-born off-spinner Sthalekar, 41, was the first woman to achieve the double of 1,000 runs and 100 wickets in ODI cricket. She was also a member of the Australia teams that won the ICC Women's World Cup in 2005 and 2013 and the ICC Women's T20 World Cup in

2010 and 2012.

"Never in my wildest dreams did such an illustrious group of players," said Sthalekar as she thanked her team-mates. Kallis is the fourth South African player inducted and Zaheer the sixth from Pakistan. Sthalekar is the ninth women's cricketer in the list.

In all, 93 players have been inducted so far under the system in which players become eligible five years after playing their last international match. Hall of Fame members formed the majority of the adjudicating panel with representation from the media, ICC and Federation of International Cricketers' Association (FICA).

ICC chief executive Manu Sawhney: "These are all players with a legacy that will continue to inspire future generations for years to come.

"I congratulate Zaheer, Jacques and Lisa on their inclusion in the pantheon of cricket greats."
