

J&K's Positivity Rate 3.8%, Lower Than **National Average: CS**

SRINAGAR: The Jammu and Kashmir government said on Thursday that the Union Territory has maintained positivity rate of 3.8%, much lower than the national average of 8.60%, with coronavirus case fertility rate of 1.89%, which is roughly close to national average of 1.84%.

The details about UT's efforts to contain Covid-19 it were shared by J&K Chief Secretary, B V R Subrahmanyam in a high level meeting chaired by the Cabinet Secretary, Rajiv Gauba on Thursday, an official spokesperson said. Chief Secretaries of various States including Punjab, Andhra Pradesh, Karnataka, Maharashtra, Madhya Pradesh, Uttar Pradesh, Gujarat, Tamil Nadu and West Bengal also participated in the meeting.

Ex-MLC, 10 More Die Of **Covid-19 In J&K, Toll 675**

1500 Structures In Prohibited **Zones In Pahalgam: Govt**

SRINAGAR: The J&K High Court on Thursday said "financial incapacity" cited by the government for undertaking the relocation or rehabilitation of the built-up areas, hamlets existing within wildlife and forest zones in Pahalgam "cannot be compromised under any circumstances."

Hearing a Public Interest Litigation, a division bench of Chief Justice Gita Mittal and Justice Puneet Gupta it was the sole responsibility of the Government whose imperative duty lies in such conservation.

Ihelum very often," Rehman explained. Generally, contractors are awarded infrastructural projects after the con-

cerned department issues a tender for the same. As most government processes have been digitised to mirror the pace of international institutions, even tenders are required to be issued electronically in Jammu and Kashmir – especially since the inception of J&K's e-tendering portal in 2011. "We guessed at that time that they did not have the time to float e-tenders because they told us to begin our work without issuing anything. We were told, at that time, in complete seriousness, that it was an emergency. We dutifully followed the government officers then, but they have been missing in the conversation ever since we appeared with our bills and liabilities from the projects we finished," he said. The committee of contractors that Rehman represents has alleged that the Department of Finance has been outrightly rejecting the bills presented by his peers from the 'rehabilitation work' they executed post 2014. The Department has reportedly claimed that the contractors cannot be compensated because most of their contracts were carried out without 'e-tendering'.

"The due process has not been followed, we are told. But the irony is that we were asked to do the work by officials and technocrats," he lamented. "The bills must contain the details of e-tendering, administrative approval, and technical sanction, otherwise they are being dismissed." Basheer Ahmad Khan, former president of Hot Mix Plant Owners Association, compared the extraordinary circumstances of 2018 to the unprecedented pandemic of 2020. He questioned if the administration had issued etenders, as per the formal process, to manufacture masks, sanitisers, etc. suggesting that the opposite had happened. "The same thing affected us in 2015. Government authorities told us to focus on completing the civil projects while assuring that our payments will happen as and when we finish our assignments. We trusted them but now an amount of Rs 309 crore is due from the Public Works Department (PWD) alone," he said. Khan and Rehman have stated that the three ministers from the PDP-BJP coalition government of 2015-2018 - Haseeb Drabu, Naeem Akhtar, and Altaf Bukhari – have been responsible for ordering the infrastructure work, approaching the contractors, and forming the agreement. Commenting on his implication in the pending payments problem, Apni Party chief and ex-PWD minister of J&K, Altaf Bukhari told Kashmir Observer, "Yes, a lot of road restoration work along with other projects was completed after the floods and I would like to compliment all the contractors who helped the government at that time and finished their jobs efficiently. I am aware that, unfortunately, around 300 plus crores are due to them."

However, Bukhari added that there was little he could do after the government reshuffle in 2016 owing to Mufti Mohammed Syed's death. "We were asked to finish the projects on a war-footing-basis. This has been the case from 2014. Since the introduction of JK Pay Sys in early 2019, the officials in the Treasury Department tell us that without e-tendering, our bills will not be accepted. However, there is close to nothing we can do to change the past. We were contacted and employed by chief and superintendent engineers of different public departments. If something has gone

wrong they are equally responsible if not more," Rehman declared. The contractors asserted that they have always welcomed modernising initiatives like the 'JK Pay Sys' – which is being implemented in full swing since this financial year. But the moot point between the employing (government) and employed (contractors) parties has been whether 'work which was undertaken or completed before the institutional introduction of JK Pay Sys, should be scrutinised by the new rules'.

They, at that time, were given administrative approvals and technical sanctions fulfilling two out of the three prerequisites of the new payments system. "So now when they ask us, 'why was there no e-tendering' before rejecting our bills, I wish to question their motive behind directing the query to us, contractors. Why ask us? Ask the ones who gave us the job, who also have to float the tenders as a part of their responsibility," he rued.

Altaf Bukhari has called this treatment "harassment" and expressed concerns over the "financial mismanagement in Jammu and Kashmir." Amin Khan, a mechanical contractor, also admitted to not having received his payment from the last three years. He said that a lot of contractors have been taking up tenders after applying for bank loans at a time when, he believes, the administration is issuing tenders without

having any monetary funds to fulfill their part of the deal. In September 2019, he had worked with the PHE and IFC departments (now collectively called as 'Jal Shakti') for Narendra Modi's 'Ghar Ghar Paani' scheme which promised citizens access to tapped water facilities. "Despite having completed my job and spent around Rs 15 lakhs, I haven't got a single penny that is to be rightfully paid to me," he solemnly said.

"The 1000 crore figure is simply not true," Iftikhar Ahmad Kakroo, the Chief Engineer of Irrigation and Flood Control Department (IFC) told Kashmir Observer. "A lot of the dues have been paid back to the contractors that were employed in the specified period." As per this official, all dues have been cleared by the IFC department for 2014. "Yes, there is some liability for 2018. This was work that was undertaken to help the State Disaster Response Fund (SDRF) and I think that the outstanding amount is only a couple of crores," he said. Interestingly, Zeeshan Rehman alone has bills amounting to Rs 35 lakhs from 2018 and 7 lakhs from 2014, which need to be paid for by the IFC department.

However, Mazhar Hussain, the Director of Finance for the Public Works (R&B) Department, maintained that the "government has been very serious about clearing the liabilities" while citing the "new order" which presents a roadmap for clearing macadmisation dues. "This issue is very tedious and does need careful examination," Hussain told Kashmir Observer. "It would not be right to comment right now since I am not completely aware of the problems of the contractors. But I would like to say that every process needs to be transparent." Noting that e-tendering was not a new feature in the business of contractors. Kakroo admitted that "in 2014 and 2018, when an emergency was declared, e-tendering was not done." He has been chairing the functions of the IFC department since the past two months only but has claimed to have taken the contractors' issue with the seniors of his department. "We are committed to solving this and undoing the confusion," he stated.

What Do Officials Want?

Even after several attempts made by groups representing Jammu and Kashmir's contractors to bring the miscommunication and discrepancies in the system to the attention of the authorities, Rehman believes that all the efforts have so far been in vain. "We did not go to then-government with begging bowls asking for work. They came to us for our services. Also, if we have done anything wrong then all the chief and superintendent engineers should also be penalized with us. We are told 'you did more work than you were allotted' but it was the officials who asked us to do it and because of their carelessness we have been having liabilities since the past 4-5 years," he further mentioned. Basheer Khan argued that the process of budget allocation has been tampered with, leading to all these problems.

"Previously," he said, "lawmakers had a mechanism that allowed the budget to be slightly more than the estimate for the community and state. For example, if the budget needed to be Rs 100 crores, it would be made Rs 120-130 crores. Our dues were being cleared as per our agreements until 2014." As per his interaction with the authorities, the accrued amounts of 2014 and onwards will be cleared only after the physical examination of the embankments. The examination is reportedly being conducted by the Anti-Corruption Bureau, the ACB which has now started digging the earth around the river to check the work that was completed four years ago. But in a region like Kashmir, where all construction projects would be time-bound for weather-related reasons, the players of this seasonal business say that are being "pushed to the edges of despondency.'

"The government has been ignoring us after 2014. We are a community on $\,$ the operations of which a government functions. Without us, there would be no one to build and establish all the schools, hospitals, infrastructure that the politicians promise the public. But we have been grossly ignored by the political setup since 2015," Basheer said exasperatedly.

Altaf Bukhari confirmed that the contractors have been troubled by these developments in their case.

"The present Finance Secretary has been delaying this case, but I know

that he is an honest bureaucrat," the Apni part chief said. "Nevertheless, honesty is not only about being non-corrupt but it is about doing your duties properly. One cannot hide behind the smokescreen of 'anti-corruption' and delay processes. Issues must be solved on priority. I vouch for the contractors as I know their problems are real." The politician also stated that the contractors' dues must be paid to them with interest so that they can pay their lenders and justify their wait of many years.

32.8 mm. A weather advisory by the MeT Office predicted flash floods and landslides in vulnerable parts of Jammu and Kashmir. "IMDs experimental model shows that the soil at various places of J-K, especially the Jammu region is fully saturated and has low water absorbing capacity. Continuous rain may lead to flash flood and landslide at vulnerable places," the advisory read. It said the weather system may lead to disruption of traffic on Srinagar-Jammu National highway, Srinagar-Leh highway and the Mughal Road. The MeT office has said the heavy rainfall will continue across the valley till the evening of Thursday, after which there will be a gradual decrease.

The weather will improve and will be sunny from Friday afternoon, the MeT office said, adding that the weather is likely to stay dry over the next few days. **Relief to farmers**

The continuous rainfall across Kashmir since the intervening night of Tuesday and Wednesday also brought relief to the farmers as the valley had reeled under dry weather conditions over the past three months. Srinagar city recorded a maximum temperature of 35.7 degrees Celsius on August 17 which was the hottest August day in the last 39 years. The mercurv in the city and elsewhere in the valley had staved above the normal

by several degrees this month. However, the rains have brought down the temperature with the city recording the maximum of 22.6 degrees Celsius on Wednesday which is 13 degrees lower than what it recorded on August 17, the officials said. The maximum temperature in Srinagar is 6.6 degrees below the normal for this part of the season, they added.

The other places in the valley also experienced huge relief from the hotter days due to the rains as the mercury went down by several degrees.

Rains Batter Jammu, No Threat ...

all-weather road linking Kashmir with the rest of the country, also remained closed for the third day, while landslides triggered by overnight rains led to the closure of several other hilly roads in different parts of the Jammu division this morning, they said. "The situation so far is under control though the water level in major rivers and streams across Jammu region is increasing due to heavy rains in the catchment areas. However, there is no immediate threat of floods," Superintending Engineer (hydraulic Circle), Irrigation and Flood Control department Jammu, Sumit Puri told PTI. He said the water level in river Tawi in the city at noon was 10.30 ft which is seven feet below danger mark while the gauge in river Chenab near Akhnoor in the outskirts of Jammu read 29 feet which is also almost six feet below the danger mark. "Our teams are monitoring the water level regularly and have already sounded an alert, asking people not to come closer to the swollen water bodies as a precautionary measure," he said, adding that people need to exercise caution as the weatherman has predicted more rains during the day. He said the water level in Tawi and other water bodies was expected to increase by two to three feet in the next couple of hours.

Five persons, including a couple, were killed and a number of cattle perished in separate incidents of landslides and house collapse in different parts of the Jammu region, while a bridge and dozens of thatched hutments belonging to Gujjar and Bakarwals were washed away over the past two days. The residents in many areas also faced a lot of hardships after water from overflowing streams entered their homes and pedestrians had to walk through water-logged roads to reach their destination. A number of roads in various localities were also damaged by the rains, the officials said, adding that a clear picture about the extent of damage would emerge after a detailed assessment. The officials said thousands of vehicles, mostly trucks, remained stranded on Jammu-Srinagar national highway which remained closed for the third day on Thursday.

The highway was closed for vehicular traffic on Tuesday after a massive landslide struck the arterial road at Dalwas in Ramban district but the road clearance work was hit by inclement weather which triggered fresh landslides and shooting of stones from the hillocks overlooking the highway at nearly a dozen places between Banihal-Nashri sector.

"The highway is still closed as overnight rains triggered fresh landslides and shooting of stones at various places including Panthiyal, Digdole, Samroli, Dalwas, Kunfer, Monkey Morh and Moum Passi," a traffic department official said, adding that despite inclement weather, the restoration work is going on to ensure early reopening of the road.

He said landslides also forced closure of different hilly roads, including Basohli-Kathua, Kotranka-Rajouri, Paddar-Kishtwar, Basant-Dudu and Doda-Bhaderwah, this morning and the men and machines are on the iob to restore these roads.

Meanwhile Reporters Without Borders (RSF) also reiterated on Thursday its call for the release of Kashmiri journalist who completes his second year in detention "without any serious evidence ever being produced to support the charges of "harbouring terrorists". RSF in a recent report, alleged that it has been almost impossible for

journalists to operate in the Kashmir Valley for the past year because of draconian information controls, obstacles to the dissemination of articles and videos, intimidation by the security forces in the field, and every kind of judicial harassment.

"The way the Indian authorities repeatedly obstruct the freedom to inform in Kashmir is unworthy of a democracy," said Daniel Bastard, the head of RSF's Asia-Pacific desk.

He further said: "EAM had further noted that 'when it comes to finding a solution, this must be predicated on honouring all agreements and understandings. And not attempting to alter the status quo unilaterally". China, meanwhile, said India should look at the big picture of bilateral ties and work with it and take concrete steps to bring the relationship back on the right track of normal development." Beijing also said New Delhi should put the border issue in an appropriate position in this "big picture" and avoid misjudgement. Asked for his comments on the current situation at the India-China border at the monthly online media briefing, Chinese defence ministry Spokesman Senior Colonel Wu Qian said progress has been made in the disengagement of the frontline troops of India and China in eastern Ladakh due to efforts from both sides. "China and India are important neighbours to each other. Maintaining peace and stability in the border areas is not only conducive to their respective development, but also to regional and world peace and stability, he said, adding that "remaining issues" at the border needed to be handled properly.

"India could work with China towards the same goal, bearing in mind the big picture of bilateral ties and putting the border issue in an appropriate position in this big picture, avoid misjudgement, keep divergences from escalating into disputes, and take concrete steps to bring the bilateral relations back to the right track of normal development," Wu was quoted as saying in a statement put out by the Ministry of Defence. At his online briefing, Srivastava also referred to last week's talks between the two sides under the framework of the Working Mechanism for Consultation and Coordination (WMCC) on border affairs. "As I had conveyed earlier, complete disengagement requires re-deployment of troops by each side towards their regular posts on their respective sides of the LAC. It is natural that this can be done only through mutually agreed reciprocal actions. Thus it is important to bear in mind that achieving this requires agreed actions by both sides," he said.

Srivastava said the two sides at the last meeting of the WMCC agreed to resolve the outstanding issues in an expeditious manner and in accordance with the existing agreements and protocols. "Both sides also agree that full restoration of peace and tranquility in the border areas would be essential for the overall development of bilateral relations. The two sides had also agreed to continue their engagements both through diplomatic and military channels," he said. At the WMCC talks, Srivastava said the two sides had a candid and in-depth exchange of views on the existing situation in the India-China border areas. "Both sides have reaffirmed that the two sides will continue to sincerely work towards complete disengagement of the troops along the Line of Actual Control in the Western Sector in accordance with the agreements reached between the two Foreign Ministers and the two Special Representatives." he said. On July 5. National Security Advisor Ajit Doval and Chinese Foreign Minister Wang Yi held a nearly two-hourlong telephonic conversation on ways to resolve the row. The formal process of disengagement of troops began a day after Doval-Wang talks. Both Doval and Wang are special representatives for boundary talks.

In Beijing, Wu was further quoted as saying that China and India have agreed to follow the "important consensus reached by the leaders of both countries and other relevant agreements, continue to maintain dialogue and communication through military and diplomatic channels, further ease and cool down the China-India border situation, properly handle the remaining issues, and jointly safeguard peace and tranquility in the border area." The Chinese military has pulled back from Galwan Valley and certain other friction points but the withdrawal of troops has not moved forward in Pangong Tso, Depsang and a couple of other areas since mid-July. sources said. In the five rounds of Corps commander-level talks, the Indian side has been insisting on complete disengagement of Chinese troops at the earliest, and immediate restoration of status quo ante in all areas of eastern Ladakh prior to April. The tension between the two sides escalated manifold after the violent clashes in Galwan Valley on June 15 in which 20 Indian Army personnel were killed. The Chinese side also suffered casualties but it is yet to give out the details. According to an American intelligence report, the number of casualties on the Chinese side was 35.

Following the Galwan Valley incident, the government gave the armed forces "full freedom" to give a "befitting" response to any Chinese misadventure along the LAC. The Army sent thousands of additional troops to forward locations along the border following the deadly clashes. The IAF has also moved air defence systems as well as a sizeable number of its frontline combat jets and attack helicopters to several key air bases.

In order to ensure that there is no illegal construction activity in Pahalgam, the court observed that a digital blueprint of the existing structures and their surroundings requires to be prepared, which would include cadestial mapping, photography and videography. "In the report financial incapacity is reported for undertaking the relocation or rehabilitation of the built-up areas / hamlets existing within wildlife / forest zones. But keeping in view the preservation and conservation of the fragile ecology and environment including forests and wildlife, this aspect cannot be compromised under any circumstances," the court said, adding, "It is the sole responsibility of the Government whose imperative duty lies in such conservation, to have the existing structures video-graphed / photographed on the same lines as has been undertaken in Dal Lake area in Srinagar."

The court has also directed that each building owner located in the forest, wild life areas shall submit the complete site plan of the existing construction with photographs to the Chief Executive Officer, Pahalgam Development Authority and the Deputy Commissioner, Anantnag. The Deputy Commissioner, Anantnag, and the Chief Executive Officer, Pahalgam Development Authority shall cause verification of the submissions by the owners; prepare a list of owners as well the locations, sizes of the plots and extent of construction on which the construction exists," the court said. The CEO Pahalgam Development Authority and the Deputy Commis-

sioner, Anantnag, the court said shall initiate and submit a report to the Court for undertaking digital documentation including videography, the cadestial mapping photographs of all the existing structures via drones in Pahalgam on the same lines as had been done in and around the Dal Lake.

"The respondents shall complete all proper digital documentation, of the forest and wildlife areas clearly demarcating places where the construction exists," the court said, adding, "We also direct that the videography of the forest and wildlife area shall also be undertaken by the aforesaid officers."

The court also ordered that the record shall be put in the public domain and safely preserved both by the Deputy Commissioner, Anantnag, as well as the Chief Executive Officer, Pahalgam Development Authority. "A status report in this regard shall be filed before this Court within six weeks from today," the court said. Regarding Solid Waste Management Bye-Laws, Deputy Commissioner, Anantnag, filed a status report stating that all the Municipal Committees in District Anantnag including Municipal Council Anantnag have notified the Bye Laws. "With regard to the Solid Waste Management Byelaws, the Deputy Commissioner, Anantnag, shall file a status report with regard to the action taken for implementation of the Solid Waste Management Bye-laws and the details of fines which have been recovered in the process thereto," the court said and ordered that such report shall be filed within eight weeks. Draft Agr Produce, Livestock Marketing Bill, 2020 Approved

SRINAGAR, AUGUST 27: The Administrative Council (AC) which met here today under the chairmanship of Lieutenant Governor, Manoj Sinha, accorded sanction to the submission of draft J&K Agricultural Produce and Livestock Marketing (Promotion and facilitation) Bill, 2020 to the Ministry of Home Affairs, Government of India for its promulgation.

The passage of Bill will pave the way for deeper integration of electronic markets throughout the country through e-NAM (National Agriculture Market). Consequently, it will prevent leakages at intermediary level by eliminating brokers and distributors, thus enabling farmers to directly sell their produce in open market.

For managing the assets and regulating activities of various fruit Mandis in J&K, the proposed Bill provides for establishment of Agriculture Produce Marketing Committees (APMCs). It further includes several provisions for welfare of farmers ranging from contract farming, direct marketing, special commodity market, setting up of markets in private and co-operative sector, to e-trading, single point of levy of market fee, single registration of market functionaries, unified single trading license and alike.

Ceasefire Offered Without Salah-Ud-Din's Nod: Geelani

'Jamaat chief doesn't consult me on important issues

SRINAGAR: Former chairman of the All Par ties Hurriyat Conference (APHC) and senior Jama'at-e-Islami leader, Syed All Shah Geelani, said today the unilateral ceasefire announced by the Hizbul Mujahideen chief commander operations, Abdul Majid Dar, did not have the consent of the Hizb supreme commander, Syed Salah-ud-din. In an interview with CNS, he said Salah-ud-din had endorsed the announcement in the interest of unity in the out-fit's rank and file.

Describing the ceasefire offer merely as a view, Geelani said the, centre's hurried acceptance of it was aimed at her desire to utilise the matter in her favour, Admitting that Dar had spoken with him on telephone before making the announcement, he said he had made it dear that the ceasefire would be tantamount to defeat.

ADVICE TO WAIT: Geelani said he had advised Dar to wait till the organisational elections of Jama'at-e-Islami and also to consult other militant groups. He also sought Dar's meeting with him and another Jama'at leader, Muhammad Ashraf Sehrai, before making the ceasefire announcement.

Referring to Abdul Majid Dar's reported statement that efforts were on to resume the dialogue, Geelani said the talks should be held between all the parties to the dispute and to solve the basic issue of Kashmir. "It is imperative for purposeful talks and their success to remove the existing bottlenecks", he said citing India's refusal to accept Kashmir as a dispute or claiming it as her integral part as the main hurdles in it.

FUTILE TALKS: Asserting that the recent talks between the Hizb and the centre were a futile exercise, Geelani asked what necessity there was to work out the modalities. "At some places, the Hizb cadres were asked to surrender arms and at others they were officially sounded to stay in certain specified areas. In some areas, identity of Hizb men was asked for", he said, adding that all this was done to make inroads into the outfit with a view to harming it at an available opportunity. Pakistan, Geelani said, was a basic and inalienable party to the Kashmir dispute.

The Hurriyat stand on resolution of the issue has remained flexible and the alliance always welcomed any suggestion for the purpose. He said the Hurriyat should stick to its stand of tripartite talks to solve the issue.

Go beyond lockdown

ith fifteen more people succumbing to coronavirus infection in J&K on Wednesday, eleven of them from Kashmir, the number of fatalities caused by Covid-19 across the Union Territory has risen to 664. J&K has also recorded a fresh 704 cases, taking the total number of people infected by the virus to 34,480. Srinagar has once again recorded the highest number of 198 cases.

If anything, it shows a steady rise in the number of cases over the past five months, with no signs of the government getting a grip on the runaway contagion. That too despite the government imposing first a 70 day long lockdown and following it up intermittently with small duration lockdowns. And these measures seem to have achieved little other than hitting the economy hard.

In hindsight, it should be clear to the government that the lockdowns have not helped. Either the lockdown was not inherently helpful a measure in addressing the outbreak of the contagion or the tool was badly handled. But as for their handling, the lockdowns were strictly enforced, creating a curfew like situation on the streets. This also helped prevent the gatherings including the religious assemblies. But considering the exponential rise in the number of Covid-19 cases since then, it can be safely concluded that the lockdown has only made a minor redeeming difference to the spread of contagion. And by now the government should have learnt its lesson and explored other measures against the deadly contagion. And the most overriding of such measures should have been the strict enforcement of the safety precautions in public.

But this is something that seems to have only been followed in breach. For example, it is now obvious to one and all that despite the standing government instructions a predominant majority of people do not wear masks in public. More alarmingly, the masks are conspicuously absent from the faces of most of the passengers using public transport. And none of these violators is taken to task.

This is strange. The government is ready to lock everything down at the drop of a hat, and doesn't care two hoots about wrecking the economy that, in turn, deprives thousands of people of their livelihood. But it shirks from implementing the law when it comes to forcing people to observe precautions during the unlock period. It is time it does so now. The government needs to urgently work on two fronts: one, run an aggressive advertising campaign alerting people to the deadliness of coronavirus and the urgency of observing safety precautions. Second, a strict action needs to be taken against the people who go out without masks or participate in large gatherings. These are the only pragmatic and hopefully helpful tools to tackle the contagion. That too, with least damage to the economy.

More pain for economy

hree weeks after its monetary policy committee decided to hold fire on interest rates amid accelerating retail inflation, the Reserve Bank of India (RBI) has forecast more pain for the economy. Its assessment of the economic landscape and its prognosis for near-term prospects posit a stark picture: of demand hollowed out by the severe shock to private consumption, public finances strained by the imperative of funding mitigation measures, anaemic appetite for investment among corporates and credit-flowimpeding risk aversion among bankers, to name but a few. The COVID-19-induced economic contraction that manifested itself in the fiscal first quarter, is now almost certain to extend through the July-September period, the RBI said in its Annual Report. Observing that the "reimposition or stricter imposition of lockdowns" in different parts of the country in July and August had mainly contributed to damping the tentative revival in momentum seen in the preceding two months, it said several recent high-frequency indicators pointed to an unprecedented retrenchment in activity. Noting that the services sector has been a prime mover of the Indian economy. the central bank flagged the fact that whatever consumption had survived the shock was now manifesting as essential spending with services including transport and hospitality almost completely eviscerated.

The Central government, which has gamely attempted 'pandemic proofing' demand by increasing its net revenue expenditure by a third in the first quarter, is, however, likely to find itself strapped for resources in the coming months. As a result, it would have little leeway to continue to undergird momentum. States too are expected to find their finances so tightly squeezed as to have to cut capital spending. In its prescription to overcome the funds crunch, however, the central bank appears to run into a contradiction. The RBI suggests that the government should help "crowd in" private investment through targeted public investment that could be funded by monetising assets in steel, coal, power, land and railways. But given that private companies have been either too highly in debt and therefore keen to use gains from the government's corporate tax rate cut to repay loans, or loath to raise capital spending when saddled with excess capacity, it is hard to see the government raising much out of its privatisation efforts. Ultimately, as Expenditure Secretary T.V. Somanathan has acknowledged, the Centre may opt to marshal its meagre resources more prudently and wait for the curve of infections to start flattening before committing to any further stimulus spending. A revival will ensue only once consumers regain confidence to go out and spend. And that, as of now, seems a

Interestingly, our per day loss

calculation of approximately Rs. 149 crore is in line with two authentic studies. First one was a part of J&K Economic Survey 2016 which had estimated a loss of Rs. 16000 crore for 116 days of lost business during 5 months long political turmoil in the valley. The daily loss therefore from GoJK accounts arrives at Rs 138 Crore. Pertinently the nature of shutdown and communication blockade in 2016 was far less severe in terms of geographical distribution within the valley and therefore comparatively less than what is relevant for the previous 12 months. Another research by SEBI registered and RBI accredited rating agency Acuite Ratings and Research Limited (ARRL), has pegged per day loss on account of lockdown across India at Rs 35,000 crore. Since J&K contributes 0.77 percent to the national GDP, the daily loss to J&K comes to Rs 269.50 crore of which Kashmir's share is estimated at Rs 148.22 crore approx. (55percent of JK GSDP).

Phase-2 comprising 109 days of partial opening of economy from early 4th Dec '19 till 21st Mar 2020, belongs to the most economically inactive portion of the calendar year. With hostile weather, all educational institutions shut, sarkari darbar in Jammu, regular CASOs in every nook and corner of the valley and a perceived threat of demographic change, the economic output is assumed to have dropped by a drastic 45 percent. The resulting loss amounts to Rs 7308.45 Crore.

March 22nd witnessed the mother of all lockdowns encompassing entire India, which, on paper, lasted for 70 days till 31st May 2020. With a per day loss of around Rs. 149 crore, phase 3 has cost the 10 districts of Kashmir economy with a back breaking amount of Rs. 10,430 Crore.

Similarly, 65 days of unlock 1.0 and 2.0 from June 1st till 4th Aug 2020 too were marred with frequent covid-19 infection outbursts, ineffective unlock, total closure of transport sector, tourism sector and e-commerce. Export sector which contributes over Rs 1,700 crore to the export economy annually, was already gasping for breath from sustained high speed internet blockade and was now getting overwhelmed under the debris of a severe global recession. Our, otherwise steady, annual stream of Rs. 1300 Crore foreign remittances from Kashmiris working across the globe too started facing the heat of global lockdown. Domestic businesses suffered huge income losses resulting in widespread bank defaults, rampant job cuts and foreclosures. Consumption too was severely devastated due to accelerating job cuts which in turn shook the demand mercilessly. The economic output is assumed to have nosedived by approximately 55percent, resulting in an unavoidable loss of Rs. 5326.75 Crore.

The assumed percentage drop in economic output in various phases of last 12 months have been carefully mapped with various consumption data points like sale of cars, tractors, two-wheelers, commercial vehicles, mobile phones and occupancy in hotels and resorts etc.

For example, compared to an annual sales figure of Rs.650 Crore and Rs. 750 Crore for FY 2017-18 and FY 2018-19, the mobile phones market in Kashmir valley, with an aggregate sales figure dropping to Rs 250 crore, registered a contraction of over 66percent in FY 2019-20.

Likewise, compared to automobile sales of 64,445 units for J&K for last four months of 2018 calendar year, the sales data for the same period from September '19 to December '19 nosedived to only 34,271 units registering a contraction of over -53 percent. The months of April 2020, May 2020, June 2020 and July 2020 were even worse with a respective YoY (Year on Year) contraction of -100 percent, -98.57 percent, -87.60 percent and -53.50 percent. Pertinently, these figures are for entire J&K and given the geographical distribution of the economic slump, the figures of Kashmir valley alone are expected to be even worse.

Based on the above discussed assumptions and methodology, the cumulative loss therefore for the 4 phases arrives at a whopping Rs. 40,943.38 Crore. With a nominal GSDP of Rs 1.587 Lakh Crore for entire J&K and Rs. 87,285 Crore for Kashmir valley, a loss of Rs. 40.943.38 crore means a respective contraction of 25.80 percent and 46.90 percent for the previous 12 months. These are not just simple numbers. A contraction of this scale which has wiped almost half of the Kashmir valley's GDP in just 12 months period will have serious and long lasting ramifications on the ground. With draining household savings and eroding business capital, Government's loan bonanza is falling woefully short. This economic catastrophe is already wreaking havoc with lakhs of bread earners losing their jobs, businesses closing down amid rampant bank defaults and average households finding it excruciatingly hard to make the ends meet Policy responses on the other hand are not only short in size but late in delivery. It is time that both, the UT government as well as the union government put their heads together and respond with a sustainable fiscal stimulus so that Kashmir survives this brutal economic quagmire with dignity.


In Kashmir, the debate over language usually circumambulates the concerns of social heritage and the need to preserve it. Largely seen as a mode of transmission of values, culture and collective history; language is hardly scanned for its power of creating our world-views, organising our social lives and shaping our sense of wrong and right. Consequently, we become the peddlers of prejudicial and exclusionary behaviours, almost as a part of our genetic

and social duty.

Being a part of a society, one tends to internalise and exhibitnormalised yet abnormal proclivities. Consequently, we busy ourselves with internalising every piece of learning that falls on our ears from diverse media and are content withmodelling ourselves on the template that

social mechanisms turn all of us into.

However, women hardly have the privilege of remaining oblivious to the struggles they face. Each attitude that oppresses women finds itself translated into a verbal-biasharboured against them. The pervasiveness of these sexist attitudes in our colloquial conversations only goes onto show that subordination or exclusion of women isn't some violent spectacle that erupts on some unfortunateSunday. It is a normalised attitude which is deeply enmeshed in our everyday routines, off-the-cuff conversations, stereotyped images and the social expectations directed at women.



Preserving our heritage doesn't merely entail wholesale and lazy emulation of symbols of the past. It must involve screening them to criticism before handing them down to progeny.

Every time a boy's birth in the neighbourhood is exalted toshoob, one can't help but mourn the existential rejection women are subjected to in Kashmir. From extreme marginalisation of bint-e-Hawwain the briefest pleasantries like,Khodah pholneavnai dyekas te potras, to objectifying statements like Khodah soozyinas rut Khareedaar and-

koor cha luk hund maal;devaluation of women seems likean invasive yetunchallenged norm.

These samples of conventional wisdom imagine her as some tradable and perishable commodity to be sold off, lest it diminishes in value. Such idiomatic expressions put a women's existence subservient to that of a man. Her worth

and value isconsidered contingent upon the health of relations she shares with men as a daughter, mother or a wife not as an individual.

The normalisation of such discriminatory language is so internalised that women participate and in some cases encourage such views. In fact, even with the awareness of these misgivings in

our language, expressions like kouri mohnyui seem harmless in the face of the monstrous and fulminating phrases like, Veariv gai qabar, tset aasi ya zeeth, yi cha bardaash Karin.

Very often, these leitmotifs of subjugation use the garb of religion and moralityto bludgeon women into submissiveness. They champion misogyny in the name of religion and turn the word of God to the task of Satan. Ironically, the ideals of docile and submissive womenglorified in public discourses clash with the strong and principled figures of Islamic history who fought for Haq/ Rights. The values of fierceness and bravery of Prophet's (peace be upon him) female companions like Hz Nusaiba binti Kaab (r.a), the political merit exhibited by the likes of Queen of Sheeba and countless other figures have rarely ever shaped the ideals upheld and celebrated in our society.

Reading carefully into the workings of language, the fault of sexism is hardly a fault of Kashmiri language per se. Misogyny is itself a language with a deepseated,multi-pronged attitude that manifests itself in a myriad of ways; language only betokening one of them.

Awareness and sensitisation on the issue, although gradual are contributing toward the much-needed erasure of devaluing language. We as a society are required to revisit how language continues to be used as a tool of inhibition rather than liberation. Preserving our heritage doesn't merely entail wholesale and lazy emulation of symbols of the past. It must involve screening them to criticism before handing them down to progeny.

Rhetorically the significance of language in imagining our worlds couldn't be put more eloquently than Hafez in this verse:

"The words we speak become the

house we live in"

Parental Instruction Instrumental For Children To Learn How To **Safely Cross Busy Roads**

earning to cross a busy street is anything but easy for a child, especially in places where the traffic doesn't stop. Children must first identify a safe gap in traffic, use refined motor skills to precisely step off a curb the moment a car passes, and safely reach the other side of the street before the next vehicle arrives.

Research says parents can help their children in the same.

A new study from the University of Iowa reports that parents who use road crossings as teachable moments help their youngsters learn road-crossing skills faster and become better at crossing streets. The researchers learned this by watching sets of parent-child duos--with the children varying in age from 6 to 12 years old--cross a virtual road with continuous traffic.

A finding says that children who received constructive advice from their parents--especially the pointing out more readily and crossed more safely.

"When you're crossing roads with your child, don't just say, 'Let's go!' when you want to go. Help the child look at the oncoming traffic and pick out ahead of time which gap you're going to choose. It helps the child learn how to pick the gap ahead of time and to correctly time when to cross," said Jodie Plumert, a professor in the UI Department of Psychological and Brain Sciences and a co-author of the study.

The findings add to previous results by researchers in the UI's Hank Virtual Environments Lab (led by Plumert and Joseph Kearney, a professor in the Department of Computer Science at Iowa) showing that most children don't fully grasp how to identify gaps in traffic and correctly time their road crossings until age 14.

"If this was something that parents were doing most of the time, then that would be great," Plumert said.

"But our study shows that parents aren't using effective strategies to help their child learn about safe road crossings all that often. But the times the parents do have useful instructions, it's really helpful to the child. They just show

WASHINGTON- Does a face mask protect me, or just the people around me? It likely provides protection for both. Studies on the

can block most of those particles from spreading. While some droplets may still spread out, wearing a mask could reduce the amount, providing a benefit to others. Research shows people don't get as sick when exposed to smaller amounts of virus, said Dr Monica Gandhi, a virus

expert at University of California, San Francisco. And masks may protect the people wearing them by reducing the amount of droplets from others that might make contact with them. In two US food processing plants where masks were required and infection clusters occurred, Gandhi noted that most workers who developed COVID-19 had mild illness or no symptoms.

Research on a different coronavirus has also found low infection rates among people who frequently wore masks in public. Experts say masks are particularly important with the new coronavirus because infected people can be contagious even if they don't have symptoms.

Beijing: China has fired two missiles, including one dubbed an "aircraft-carrier killer", into the South China Sea, according to a news report, in a pointed warning to the United States as tensions in the disputed sea lane rise to new levels.

The South China Morning Post reported on Thursday that Beijing fired one intermediaterange ballistic missile, DF-26B, from Qinghai province and another medium-range ballistic missile, DF-21D, from Zhejiang province on Wednesday in response to US aerial activities in a "no-fly zone"

In response, Mark Esper, the US defence chief, said China has repeatedly fallen short of promises to abide by international laws, noting China seems to be flexing its muscles the most in Southeast Asia.

The two missiles were reportedly fired in the direction of the area between Hainan province and the disputed



Paracel Islands, the Hong Kong-based publication added, quoting an unnamed source.

According to the newspaper, a US U-2 spy plane had reportedly entered a Chinesedesignated "no-fly zone" on Tuesday without permission during a live-fire naval drill conducted by China in the Bokiller", according to the stateowned Global Times.

Chinese defence ministry spokesperson, Senior Colonel Wu Qian, was previously quoted as saying the missile can carry conventional or nuclear warheads and is capable of launching precision strikes on land and sea targets.

Saudi Arabia's Most Famous Prisoners **Go Silent During Pandemic**

Riyadh: Saudi authorities have severed contact between some of the kingdom's most prominent detainees and their families, escalating a crackdown on dissent that threatens to strain relations with Western allies.

Loujain Al-Hathloul, a men's rights activist whose 2018 arrest made global headlines, hasn't called her family since June 9, her sister said. Princess Basmah bint Saud - a royal family member imprisoned with her adult daughter - hasn't contacted relatives since April, when her detention was made public on Twitter, according to people familiar with the matter. And Salman Al-Odah, a prominent religious cleric detained in 2017, made his last call on May 12, according to his son.

Most were previously allowed to make regular, even weekly, phone calls home. Now, they've fallen silent.

"I'm worried to the degree that I really am numb at this point," said the cleric's son, Abdullah Alaoudh, explaining that he's heard from many others

in the same situation. "They're worried sick about their families, and whether there have been any coronavirus cases, and why the government is just keeping them in the dark.'

Meanwhile, Saudi officials are moving forward with another set of cases that have caused upset in the United States. A group of intellectuals and writers detained last year that includes two Saudi-American dual nationals - Salah Al-Haidar and Bader Al-Ibrahim - recently received their list of charges, according to three people familiar with the matter.

They're expected to face trial in a court reserved for terrorism and other securityrelated cases, the people said.

The Saudi government's Center for International Communication, which fields inquiries from foreign media, did not respond to requests for comment. Calls to the General Directorate of Prisons' public relations department were not answered, while a request for comment sent to its official media email bounced back with an automated message that the inbox was full.



New Zealand Mosque Shooter Sentenced To Life Without Parole

Christchurch: A court in New Zealand has sentenced a selfconfessed white supremacist who killed 51 Muslims as they prayed at two mosques in Christchurch to life imprisonment without parole, the first time such a sentence has been handed down in the country.

Brenton Tarrant, 29-year-old Australian, pleaded guilty earlier this year to 51 charges of murder, 40 counts of attempted murder and one charge of committing a terrorist act during the March 2019 rampage in the southern city, which he livestreamed on Facebook

In delivering the sentence, High Court Judge Cameron Mander said on Thursday that a finite term was insufficient for such a crime and that Tarrant had shown no remorse.

"Your crimes are so wicked that even if you are detained until you die it will not exhaust the requirements of punishment and denunciation," Mander said.

"As far as I can discern, you are empty of any empathy for your victims.

Prosecutors told the court at the opening of the sentencing hearing on Monday that Tarrant had been planning the attacks for a long time and wanted to create fear among immigrants.

The killer had been representing himself and said through a lawyer in court on Thursday that he did not oppose the sentence. Dressed in

grey prison clothes and surrounded by guards, Tarrant did not react to the sentence.

"The hatred that lies at the heart of your hostility to particular members of the community that you came to

this country to murder has no place here - it has no place anywhere," Mander said.

'Complete and utter silence'

Temel Atacocugu, who survived being shot nine times during the attack at the Al Noor mosque, said he felt relieved at the sentence.

"Finally we can breathe freely, and we feel secure, and my kids feel secure," Atacocugu told The Associated Press news agency. "The justice system has locked up this ideology forever.

Gamal Fouda, the imam of Al Noor Mosque, said that "no punishment would bring our loved ones back", but was proud of New Zealand's response to extremism.

"We respect our justice system and in New Zealand Muslim community, and the non-Muslim as well - we stood together against hate. And with it, our own model for the world. Extremists are all the same. Whether they use religions, nationalism or any other ideology," he said.

"All extremists, they represent hate. but we are here today. We represent love, compassion, Muslim and non-Muslim people of faith and of no faith. That is us, New Zealanders, and we are very proud that we are Muslims in New Zealand and we'll continue to serve this country, and no punishment again is going to bring our loved ones back.

Prime Minister Jacinda Ardern said she was relieved "that person will never see the light of day".

"The trauma of March 15 is not easily healed, but today I hope is the last where we have any cause to hear or utter the name of the terrorist behind it. His deserves to be a lifetime of complete and utter silence," she said.

Now Asymptomatic People Don't Need Covid Test After Exposure, Says US

Washington, United States: After previously encouraging people without Covid-19 symptoms to get tested if they have been exposed to someone diagnosed with the virus, US health authorities have abruptly reversed their position without a clear explanation.

The changes in guidance were quietly made to the Centers for Disease Control and Prevention (CDC) website on Monday amid US media reports of political interference

for all close contacts of persons with SARS-CoV-2 infection.

"Because of the potential for asymptomatic and presymptomatic transmission, it is important that contacts of individuals with SARS-CoV-2 infection be quickly identified and tested.'

The site now says: "If you have been in close contact (within 6 feet) of a person with a COVID-19 infection for at least 15 minutes but do not have symptoms, you do not necessarily need a test unless you are a vulnerable individual or your

President Donald Trump has repeatedly said that the US should do less testing, and blamed testing for making it appear as though the country is do ing poorly against the pandemic.

This is not true: though the US is testing at a high level, that is because its outbreak is worse than any other country in the world, with more than 5.8 million confirmed cases and almost 180,000 deaths.

The CDC's site previously said: "Testing is recommended

Skirmish in Syria: Vehicle collision with Russians injures 4 US troops



Moscow: In the most violent skirmish in months between US and Russian forces in Syria, a vehicle collision in the eastern part of the war-torn country left American troops with concussions, two US officials said Wednesday.

One official said Russian vehicles sideswiped a lightarmored U.S. military vehicle, injuring four Americans. The official said two Russian helicopters flew above the Americans, and one of the aircraft was within about 70 feet the vehicle.

While there have been several other recent incidents between the American and Russian troops who all patrol in eastern Syria, officials de-

serious. US troops are usually accompanied by members of the US-backed Syrian Democratic Forces.

Both officials spoke on condition of anonymity to provide details of the incident that were not yet made public. One official said the incident happened deep inside the eastern Syria deconfliction zone, where Russian troops generally should not be present.

The officials said the incident is being discussed by senior officials from both countries who routinely work to prevent conflicts between troops in that area. US and Russian commanders have frequent conversations to try and avoid contact between their troops there.

he Hague: Prosecutors urged UN judges on Wednesday to uphold former Bosnian Serb military chief Ratko Mladic's genocide conviction, saying he personally oversaw the 1995 Srebrenica massacre of some 8,000 Muslim men and boys.

Mladic, 78, is appealing against his 2017 conviction and life sentence by a tribunal in The Hague for genocide over the massacre and for crimes against humanity and war crimes throughout the 1992-95 Bosnian war.

The former general dubbed the "Butcher of Bosnia" resorted to "genocide, extermination and murder" as part of a campaign of ethnic cleansing to drive out Croats and Muslims from the UN-protected area, prosecutor Laurel Baig said.

"Mladic was in charge of the Srebrenica operation, Srebrenica was

the court "He used the forces under his command to execute thousands of men and boys," she added, describing the slaughter as being on "a scale not seen on European soil since the Second World War.

Mladic will be allowed to speak for 10 minutes later on Wednesday at the

International Residual Mechanism for Criminal Tribunals - which handles cases left over from the now-closed UN tribunal that convicted him.

India Slams Pak For Evading "Responsibility" For Pulwama Terror Attack

NEW DELHI: India on Thursday slammed Pakistan for evading responsibility for the Pulwama terror attack and pointed out that Jaishe-Mohammad chief Masood Azhar, a key accused in the case, continues to find shel-

ter in that country. External Affairs Ministry Spokesperson Anurag Srivastava said the charge sheet into the Pulwama attack case has been filed after an investigation spanning oneand-a-half years.

"Jaish-e-Mohammad had claimed the responsibility of Pulwama attack. The organisation and its leadership are in Pakistan. It is regrettable that Masood Azhar, the first accused in the charge sheet continues to find shelter in Pakistan," Mr Srivastava said at an online media briefing.

Farmers Driven To Debt As Banks Turn Risk-Averse During Pandemic

MUMBAI: Last month, Dnyaneshwar Siddhanth, a farmer from Maharashtra, was in desperate need of money to buy seed and fertilizer as the monsoon sowing season approached.

But after being rejected by his bank for a loan despite several attempts, Siddhanth finally borrowed 150,000 Indian rupees (\$2,021) from a moneylender at a rate of 60% annually.

Amid the country's worst economic slowdown in decades due to the novel coronavirus pandemic millions of farmers like Siddhanth are loans. being shunned by banks as lenders

turn cautious due to rising bad loans. That is forcing them to turn to illegal moneylenders who are charging increasingly exorbitant rates, according to over a dozen farmers and

bankers that Reuters spoke to. Agriculture accounts for near 15% of India's \$2.8 trillion economy and is a source of livelihood for more than half of its 1.3 billion people.

Higher interest rates will reduce farm earnings, impacting overall rural incomes which are key to reviving the economy.

'Most of the profit goes to paying interest to a private moneylender," Siddhanth said.

"Everything now depends on monsoon rains. If the crops fail, then I will have to sell land to repay the loan." LENDERS HAMSTRUNG

Till last year private moneylenders were charging 24-36% interest, but are now asking for 48-60% as more farmers seek loans, said Prashant Kathe, rupees to distressed farmers.

Prime Minister Narendra Modi's government has been instructing banks to increase lending, but bankers

say they are choosing to be cautious. Economists forecast India's economy to shrink by 5.1% in the current fiscal year, the weakest performance since 1979.

Lenders also complain that they are caught up by farm loan waiver schemes announced by several governments to win over farmers ahead of elections.

"Even though some of the states announced the scheme years ago, the money has still not reached the bank so technically the farmer's account is a non-performing asset for us and we can't give more loans till the outstanding is cleared," said the head of agriculture lending at a large state-owned bank.

Last year, Maharashtra government, had announced that banks will write off loans of up to 200,000

Siddhanth, who already owed a bank 178,000 rupees from a previous loan, was covered under the scheme. However, the state government is yet to provide funds to repay it, and nearly one-third of the loan remains outstanding.

As of October 2019, 10 states that had announced farm loan waivers since 2014-15 had yet to complete 300,000 rupees at a 60% interest rate. the promised loan write-offs, ac-

"Only about 30-35% of the p ised amount by the various state governments has been sanctioned to the bank," said a senior banker who didn't wish to be identified.

The high level of bad loans in the agriculture sector is another deterrent to more lending.

The share of soured loans in the segment has risen from 8.4% as of September 2018 to 10.1% as of March 2020, at a time when the overall share of bad loans in the banking sector has been going down.

"There is reluctance to lend in the agri segment due to poor asset quality, as a result banks are more keen to lend if there is gold as collateral, but otherwise fresh lending in the segment has been tepid," said Anil Gupta, analyst at credit rating agency ICRA.

Between March and June this year, lending to the agriculture sector contracted 1.8%, according to the Reserve Bank of India. During June 2019-2020, lending to the sector grew by 6.7% compared to 11% in the same period the previous year.

India Witnesses Record-Breaking 75K COVID-19 Cases In A Single Day

NEW DELHI: With 75, 760 fresh cases and 1, 023 deaths, India recorded the highest single day jump in COVID-19 cases on Thursday as overall cases crossed 33.10 lakhs, while total deaths in the country so far reached 60, 472.

However, the number of recoveries too zoomed to 25.23 lakhs, out of which 56,013 persons were discharged from medical supervision in the last 24 hours. India's Recovery Rate now is 76.24 per cent. The Recovery Rate is best in Delhi (90%), followed by Tamil Nadu (85%), Bihar (83.80%). The country as of Thursday now has 7.26 lakh cases under active medical care.

"The sustained high recoveries have ensured that the actual caseload of the country, ie, active cases, comprise 21.93% of the total positive cases," said health ministry officials.

"A focus on standard of care protocol as described



in the clinical ment protocol of Ministry of Health Ministry, better skilled doctors in the ICUs and hospitals, improved ambulance services, use of non-invasive oxygen and use of investigational therapies have led to the national Case Fatality Rate (CFR) maintaining its downward slide. It has further slumped to stand at 1.83% today," officials added.

As per data, ten States/UTs are faring better in terms of Recovery Rate than the national average. The CFR is lowest in Assam (0.27%), followed by Kerala (0.39%), Bihar (0.42%), Odisha (0.51%), Telangana (0.70%), Tripura (0.87%), Andhra Pradesh (0.93%), Chhattisgarh (0.95%), Goa (1.08%) and Jharkhand (1.09%).

No Loan Interest Waiver For Middle Class, Rahul Gandhi Slams "Suit Boot Ki Sarkar"

Coronavirus Hits 10 Of Dying Andaman Tribe Of Just Over 50 People



PORT BLAIR: Ten members of India's dwindling Great Andamanese tribe have tested positive for the coronavirus, officials said Thursday, fuelling concerns about the safety of the group and other indigenous people in the remote archipelago.

Out of the 10, six have recovered and have been put in home quarantine, while the rest are undergoing treatment in a local hospital, officials told AFP.

Just over 50 Great Andamanese people survive today and live on the tiny Strait Island where the government looks after their food and shelter.

The Andaman and Nicobar Islands, with a population of some 4,00,000, has reported 2,268 coronavirus cases so far with 37 deaths. Authorities sent a team

of health officials to Strait Island on Sunday after six members of the tribe tested positive in the archipelago's capital Port Blair recently. Some of the tribe's mem-

bers travel to Port Blair where they have government jobs.

"The team tested 37 samples and four members of the Great Andamanese tribe were found to be positive. They are admitted in hospital," Avijit Ray, a senior health officer in charge of the disease management in the Andamans, told AFP.

Sanjiv Mittal, a senior government officer for tribal welfare, told AFP authorities were doing their best to keep all the members safe and healthy.


