3 Killed After Van Falls Into Gorge

NEW DELHI: China has mobilised thousands of soldiers, tanks and howitzers within rifle range of Indian Army deployment at Spanggur Gap in the southern part of Pangong Tso in eastern Ladakh, sources said, even as Indian troops are on high alert.

The Chinese People's Liberation Army made provocative military deployments at Spanggur Gap, which is between Gurung Hill and Magar Hill, from August 30 after Indian soldiers seized tactical heights on the ridge line on the southern bank of Pangong Tso near Chushul at the Line of Actual Control >> PAGE 02

JAMMU: India and Pakistan troops traded gunfire for the fourth consecutive day Saturday along the Line of Control (LoC) in Poonch district of Jammu and Kashmir.

Pakistani troops on Saturday evening violated ceasefire by resorting to unprovoked firing and intense shelling along the LoC in Poonch district, a defence spokesman said.

The Indian Army retaliated befittingly and the cross-border firing between the two sides in Mankote and Gulpur sectors was going on when last reports were received, the spokesman said. • P-02

NEET 2020 Exams Today, NTA **Issues Dress-Code** Guidelines

NEW DELHI: The National Eligibility-cum-Entrance Test (NEET) is going to be held on Sunday (September 13, 2020). Over 15 Lakh candidates will be appearing for the exams amidst strict COVID-19 protocols.

The National Testing Agency (NTA) has increased the number of examination centres from 2.546 to 3.843 in order to maintain social distancing. The number of candidates has been reduced from 24 to 12.

'We're Treated As Labourers': Endless Woes Of Kashmir's Private Teachers In FOC

n an early September day in Srinagar, sunbeams from her small kitchen window shone Ruksaan Ali's furrowed face. Her worried and woeful appearance made her look more than her actual age of 40. Apart from a per- sustaining the private education sonal tragedy, she's equally griefstricken over her "thankless" job.

This Srinagar-based private school teacher has been religiously preparing video lectures of Urdu subject for 1st and 2nd class students since Covid lockdown crippled the already discord-dented fighting her own silent battles of life. educational calendar of the valley.

But despite doing what she calls and equally an unpaid, educator, a desperate-for-living job, she stays unpaid for last three months.

"Most of us don't grumble about it anymore now," said the teacher donning the mantle of a matriarch for her strife-torn home. "Despite sector with our sweat and blood, most of us are being dismissed as expandable at the end of the day, and are literary forced to beg for our hard-earned salaries.'

The lady who's a "moody madam" for her gossip-loving locality keeps Apart from being an underpaid,

Ruksaan is the breadwinner for her family. Her husband is bedridden since 2018 when he suffered a paralytic bullet-injury, followed by a major heart attack in 2019. His lifesaving drugs cost the private teacher around Rs 15000 every month.

"It's too much to bear with my holdup Rs 5000 monthly salary,' the teacher, who's graduate and specialized in physical education, voiced her woe. Despite students paying their

full fees every month, many private schools today face charges of forcing teachers to work without salaries.



Schools and other educational New Delhi revoked Article 370 and institutions in Kashmir have been the region subsequently faced the shut since the August last year when communication clampdown.

In March 2020, when the first case of coronavirus was reported in the valley, educational institutions were once again closed after resuming class work for just few weeks.

As education in the valley shifted to 2G-driven online mode, private school teachers were instructed to conduct the online classes from home.

But despite working hard, these unsung educators-like Saima Bhat-are today facing salary hassles and sudden job terminations.

In August 2020, the 27-year-old private school teacher was sacked along with 29 others from a wellreputed private school of the valley.

A B.Ed degree-holder, Saima had joined the school in January and was teaching lower primary department through online mode.

"We were simply told that they don't need us anymore," the distressed teacher said. "Before sacking us, the school authorities told us they'll clear our pending salaries within a month."

The ouster came as a rude shock to Saima and her ilk-who worked hard to complete school assignments despite grappling with pestering and pathetically slow internet to conduct regular online classes. "In addition to video >> PAGE 02

(LAC). "Seeing the Chinese PLA troop and guns mobilisation, the Indian Army too made mirror deployments at Spanggur Gap. Both the countries' troops and guns are within shooting range," said a government official

Further, sources said, China has deployed its militia squads to "consolidate the border" and "stabilise Tibet region". They have been tasked to try and dislodge the Indian Army soldiers from the tactical heights. The militia is an irregular mix of mountaineers, boxers, members of local fight clubs and others. Most of the members are raised from the local population.

"Militia is basically a a reserve force of the Chinese's People Liberation Army. They are deployed during war time situations and to help the PLA in its military operations," said a senior government officer.

The officer also said that Chinese militia also conducts independent operations and provides combat support and manpower replenishment to the PLA.

Indian Army has clearly reiterated that the forces will retaliate if Chinese troops make provocative military moves.

At the northern bank of Pangong Lake, sources said that even as PLA troops continue to occupy positions on Finger 4 mountain spur jutting into the lake, Indian soldiers have occupied some heights overlooking their positions.

"Our troops have occupied some heights overlooking the positions occupied by PLA," said a source.

The north bank of the lake is divided into 8 'Fingers' that are contested by both sides. India claims Line of Actual Control at finger 8 and had been holding on to area till Finger 4 but in a clear alteration of status quo the Chinese have been camping at Finger 4 and have set up fortifications between Finger 5 and 8.

Movement of Chinese troops, vehicles and new defence mechanisms of Chinese are visible in the north, south banks of Pangong Lake. In some places heavily armed troops are in close proximity.

To de-escalate the situation, armies of India and China are holding interaction daily.

India and China are engaged in a four-month-long standoff at the LAC in eastern Ladakh. Despite several levels of dialogue, there has not been any breakthrough and the deadlock continues.

India has also found that the Chinese side has started troop, artillery and armour build-up in three sectors of the LAC -- western (Ladakh), middle (Uttarakhand, Himachal Pradesh) and eastern (Sikkim, Arunachal Pradesh). India and China are engaged in a four-month-long standoff at the LAC in eastern Ladakh. Despite several levels of dialogue, there has been no breakthrough and the deadlock continues.

> progress. "But at the end," she lamented, "no one is talking about it. Even government is equally silent over the issue."

However, Dr. Asgar Samoon warned a strict action against private schools for paying half salaries to their teachers besides terminating them.

"I've instructed parents to pay tuition fee only because the private school teachers will get their salaries," Samoon, Principal Secretary School Education, told Kashmir Observer. "But if schools are harassing their staff they will face dire consequences."

But such warnings are hardly working, as the axe of termination is ceaselessly falling on the "unsung educators".

Since the Covid-plagued spring, Rifat Ara, 29, had been working tirelessly in Srinagar's prominent private school. Her toil was driven by her escalating destitute situation back home.

"My father is about to retire from his job and I wanted to give him some relief and respite by becoming his helping hand," anxious Rifat detailed her family compulsion for doing what she calls a "thankless" job.

After completing around 80 percent of her school syllabus, she received a terse text: 'Stop it for now'.

"Almost every student in our school has paid tuition fee till now," the teacher said. "I fail to understand why school terminated me and my colleagues?"

Such self-styled decisions taken on wishes and whims of the private school consortium have already drawn massive flak from the campusdeprived community. While the repeated and unaddressed issue has already become an irritable noise for some, many still seek the administration's attention towards the plight of Kashmir's private school educators.

As a remedial measure, Dr. Samoon told Kashmir Observer that in the coming days, Right to Education will address most of these issues.

"Once this measure is implemented," he said, "schools will have to submit audit report of their yearly expenditures to the government." But as of now, he asserted, any harassed private teacher can send him

'grievance message' on his Whatsapp number. "We'll act accordingly," he assured. "Besides, we'll engage Labour Commission to ensure that these private teachers are paid their well-de-

served dues." However, Afshan Younis, a sacked private teacher from Srinagar,

strongly contradicts the top official's assertions. She lately lodged a complaint in Director Education's Office regarding

her sudden sacking, but so far, she said, nothing has been done. "There're no rules and regulation set for the private schools with respect of their staff," Afshan told Kashmir Observer.

Five of seven youths, who went hunting on September 2, were allegedly whisked away by the Chinese troops from Sera-7, an Army patrol zone located around 12 km further north of Nacho in Upper Subansiri district.

The youths, engaged as porters by the Indian Army, were reported missing by their families on social media.

Covid-19 Could Get Worse...

University of Sydney, he said cold and drier conditions of winter could cause a higher risk of Covid-19 infection.

The increased risk is mainly because of low humidity during wintertime

The study found for every 1 percent drop in humidity, the number of Covid-19 cases could increase by 6 percent.

Nisar said low humidity is the main driver of virus transmission.

When an infected person coughs or sneezes or even talks, he/she produces infectious droplets that can hang around for longer in drier air with low humidity. And that increases the exposure for other people. He said respiratory viruses including Covid-19 tend to thrive in cooler weather conditions. They survive outside better when it is cold. "Low temperatures could slow down the normal mucus clearing of in-

fective viruses in our nasal passages," he said.

"Winter is also the time when people tend to spend more time indoors when ventilation is less and social distancing not so easily achieved," he added.

The DAK President said there is a possibility of a strong wave of Covid-19 infection in Kashmir valley this winter and it could coincide with annual flu season, and this double whammy could cause the health system to grind to a halt.

"We must prepare now for this new challenge," he said, adding "It is vitally important to scale up the testing and strengthen the track and trace system."

He said hospitals should be prepared for Covid surge and they should increase the number of beds, ICU's and ventilators.

"There is an urgent need to set up more Covid care centers to cope up with the possible spike in cases," Nisar said.

"Getting this year's flu shot is critical as it will keep more people out of hospitals and will prevent the possibility of getting sick with both flu and Covid at the same time." he added.

Here is the dress code for candidates appearing for NEET 2020 exams: 1. Closed footwear and shoes with thick soles are not allowed 2. Candidates must wear gloves and mask.

3. Candidates can wear light clothes with half sleeves to the examination centre.

4. Garments with large buttons and long sleeves are not allowed. 5. Candidates with specific attire for religious reasons are required to

report to the exam hall for mandatory frisking.

Teams Set Up To Speed Up...

District Development Commissioner, Ramban, Nazim Zai Khan constituted various teams of officers to remove all bottlenecks hindering the progress of construction work during a meeting which was among others attended by officers of revenue department and National Highway Authority of India (NHAI), the officials said.

Reviewing section wise progress on the four-laning of the highway, especially in the most problematic zones, especially Nashri-Banihal section, Khan discussed issues related to land acquisition, removal of structures and felling of trees in Right of Way (RoW) and shifting of power transmission towers in detail.

He expressed concern over delay in the process of shifting of towers and felling of trees causing unnecessary hindrances in smooth progress of work.

With regard to progress on additional land acquisition cases process. the DDC asked collector land to expedite the process so that the land falling in the alignment of the project is handed over to NHAI at the earliest to undertake construction works.

Khan also instructed the NHAI and the construction agencies associated with the highway four-laning project to ensure maintenance of the existing road to avoid traffic disruption.

He asked those concerned to take all measures to keep the road trafficworthy, the officials said.

The district development commissioner also directed the agencies to adhere to the guidelines of the National Green Tribunal and conditions of the contract agreement to avoid criminal proceedings.

lectures," the jobless teacher informed, "we submitted PPT presentations and other assignments to the school every day. We worked double than our normal classroom routine and yet we were dumped as if we never mattered."

Like others, Saima said, she also received salary of March and April only, and was charged Rs 1200 as bus fee, without availing the service. Decrying job insecurity, the sacked private school teacher said her tribe

"Government has not even made any job policy for us. Teacher is said to be a building block of the education system, but in Kashmir, private teachers don't have any respect or value. We're treated as labourers. Our society is also silent on this discrimination against their own children's tutors!'

Afshan was recently sacked after she demanded her pending salary. Barely 12 hours later, she received her termination letter.

"But I am not the only one," she informed. "The private school management follows its own whimsical hire and fire policy in Kashmir."

As Eid was approaching on July 11, she had demanded her pending salary during an official online meet.

"We could not manage family expenses with half salary," Afshan said. "But when I raised my genuine issue, I was abused, taunted, with strong obnoxious words by the school authority, who insisted me to resign, there and then only, without regarding my long and loyal association with them."

Two days later, she received her sacking notice from the school management, stating that she has been relieved from her duties and all her dues will be cleared when her other colleagues will receive it.

"I gave my youth to that school," Afshan lamented. "After ten years of my life, they handed a termination letter and asked me to go. For the sake of that school, I worked beyond office hours, and did not even give enough time to my two-year-old son who was my priority."

Meanwhile, at her rundown Srinagar residence, Ruksaan Ali was getting anxious about her husband's falling health and rising home expanses.

"Despite uploading regular video lectures for students during pandem-

ic, the school management never bothered about my salary," she said. "I could've resigned long back, if only I had an option. I've an ailing husband and two kids to sustain. Only my Allah knows how I'm managing with such a small amount!"

Despite some NGOs taking care of her ailing husband's medical bills, the private school teacher's world stays woeful.

"My children have not worn new clothes from many years now," she rued. "I hardly cook a good food for them. I'm not able to provide a good life to my family. What have I achieved by serving that school all these years? Nothing, a big zero! This is a life of a private school teacher who does not care for her own children but gives her time and youth to others' children only to live such a deprived and distressed life."

OIC gears up for key role on Kashmir

RINAGAR: Organisation of the Islamic Conference (OIC) is to con¬vene a special session for deliberations on the situation prevailing in Kashmir, and depute a team for an on-the-spot assessment of the same. At the OIC contact group meet, presently underway In New York. OIC Secretary General, Izzah Din Lairaki, said the Conference wants to play a key role with regard to the future of Kashmir-Pledging all possible assistance to facilitate tripartite negotiations on Kashmir, the OIC said it would pursue the issue in the United Nations and depute an envoy for the purpose.

The OIC contact group on Kashmir, which includes the foreign ministers of Saudi Arabia, Niger, Pakistan and Turkey held a se-ries of sessions in which the Secretary General of the Conference also participated.

An APHC statement issued here today said the OIC foreign min-isters meet in New York had declared the multiparty alliance the authentic representative body of the people of Jammu and Kashmir, which could play a fundamental role in determining the fixture of the state.

Reiterating his country's commitment and support to the Kashmir issue, the Pakistan foreign minister said the Hur¬riyat was the acknowledged representative body of Kashmiris and thail Pakistan would abide by all decisions the affiance takes (with regard to 'he Kashmir issue). Echoing the sentiments, his Turkish counterpart said all efforts would be undertaken to resolve the issue.

Earlier, Mirwaiz Farooq, who flew from Teheran to New York on Wednesday, gave an overview of the situation in Kashmir. The prime minister of Pak-Controlled Kashmir, Barrister Sultan Mehm-ood and Sardar Abdul Qayoom Khan also attended the sessions.

The PcK chapter of the APHC was represented by Moham¬mad Yousuf Naseem and Dr. Ghulam Nabi Fai .OIC delegates expressed grave concern at what they called persecution of Hurrivat leaders and political activists in Kashmir and observed these were in flagrant violation of the Geneva Convention on human rights. The OIC adopted a resolution detailing measures it would undertake in this regard.

The Popular Populist

Some have hoped that the pandemic will cause voters around the world to once again demand "competence" from their leaders. That's just wishful thinking. ndia's COVID-19 cases continue to climb, even as the economy tanks. China is pressing forward on the two countries' disputed Himalayan border, where dozens of Indian soldiers have been killed. Tax revenues have plummeted, state governments are unhappy and 21 million of India's rare salaried jobs vanished in the last few months. And yet Prime Minister Narendra Modi — who recently posted pictures of himself feeding peacocks in his serene garden — remains as popular as ever.

While they have responded to the coronavirus in different ways, many of his fellow populists are struggling. Mexico's Andres Manuel Lopez Obrador, faced with crashing poll numbers, flatly refuses to believe they are true. Multiple missteps in recent months have brought Boris Johnson's Tories practically level with Labour in some recent UK polls. Vladimir Putin's United Russia party is facing a tough set of local elections.

And, of course, there's US President Donald Trump, whose re-election campaign seems to be based largely on pretending the pandemic doesn't exist.

Modi seems to understand something that the others do not about the relationship between a populist leader and voters. In a crisis, you can, like Brazil's Jair Bolsonaro, temporarily push your numbers up through cash transfers. Or you can, like Turkey's Recep Tayyip Erdogan, use identity politics to distract people from your bungles; that's being tried in India as well.

But there's another factor Modi exploits to the hilt.

The most adept populist leaders don't only detach the electorate's perception from inconvenient facts, providing an alternative narrative in which they, and they alone, are the stars. To repeat that trick in the face of disasters such as a recession or a pandemic, they also need to act. They have to make the sort of big decisions around which their supporters can construct a convincing narrative: a decision that comes across as brave, or stern, or wise, or fatherly or, ideally, all of those things.

In India...If the pandemic spreads, that's because bureaucrats, or state governments, or the people themselves failed to live up to the leader's vision.

When Modi, with just a few hours' notice, withdrew 86% of India's currency in November 2016, it was unquestionably a disaster. People lost jobs and livelihoods, economic growth was mortally injured and, given that all the money eventually returned to circulation, none of the exercise's goals were actually met.

What Modi learned from the experience, however, is



would dare to do, and that you did it for the best reasons.

That's what many Indian voters thought about "demonetisation": If the gambit didn't work, it was everybody else's fault. At least Modi tried to stamp out corruption, supporters said, doing something no other prime minister in India's history, no other world leader had done. (For good reason.)

Still suffering from after-effects of demonetisation

Just months after demonetisation, while Indians were still suffering from its after-effects, Modi's party won crucial elections in India's largest state. The political scientists Rikhil Bhavnani and Mark Copelovitch discovered that, in fact, Modi's party did relatively better in those areas where people were hurt the most by demonetisation. Apparently, the worse the medicine tastes, the more the doctor must care about the disease and want to cure it.

When Modi shut down the Indian economy in March in response to COVID-19's arrival on our shores, he did so relatively early India's was also perhaps the most down in response to the threat. By taking action early and on the grandest possible scale, he essentially inoculated his popularity against the pandemic's political effects. No rival can now accuse him of not doing enough and be believed by voters.

The chances are that the decision to go big will work out far better for leaders such as Modi and the Philippines' Rodrigo Duterte, who also shut down early and hard, than denying the pandemic will for others, from AMLO to Trump. Denial and delay was, in any case, the wrong course. Now the consequences of not acting are entirely on them.

In India, they're on everyone else. If the pandemic spreads, that's because bureaucrats, or state governments, or the people themselves failed to live up to the leader's vision.

Some have hoped that the pandemic will cause voters around the world to once again demand "competence" from their leaders. That's just wishful thinking. The evidence from India is that nothing has changed. The populist playbook is still effective, as long as it's in hands as skilled as Modi's

Social Media Users or Pawns? The recent Facebook fiasco coupled up with a world where democracies are inextricably bound to social media, who are we as users serving?

here is no doubt to the fact that technology has changed our lives beyond any imagination. It created tools which made our life easy in multiple ways. It's funny to think how so many Bollywood movies back in 60s and 70s revolved around this story of separated brothers at a Kumbh mela, and who years later reunite. In present era it's unthinkable. We have Google, social media et al. We'll just look them up.

But there is a flipside to all this. Social media platforms like Facebook, Instagram, Twitter, Snapchat have become so big now that they have taken a life of their own, and not necessarily in a correct way.

We are living in a more polarized world. The decades after World War 2 were liberating at societal and cultural level. The world had suffered inordinately in the Second World War. People wanted a change. Imperialism was on its way out from subcontinent and Africa. Newly independent nation states opted for democracy and liberalism. India's socialist Prime Minister JawaharLal Nehru set India out on its path of progress and liberty. Pakistan ruled by army was focusing on its own path — a very liberal society where you had the freedom to choose.

Immigrants from Asian countries were welcome in more developed west. There are multiple stories of immigrants bringing laurels to their adopted home. When France won the 1998 FIFA World Cup, 6 of its players were immigrants. Champs-Elysees celebrated the success together. This was probably the great immigrant dream coming true. A world that was shrinking into a Global Village.

So how did we land up here? A world where democracies are under threat, right-wing politics is on rise and what should have been an age of information, is clearly turning into a world of disinformation.



Social media platforms like Facebook, Instagram, Twitter are currently used by billions of people. Never in the history of mankind have people come together across ethnicities on one platform. That is the power of social media. With all the good it can do, and it has, these systems are run by giant computers. The platforms on their own are not evil, but it's what technology does with it, that should be our cause of concern.

The cause of worry is the business model that these platforms use — which in broader terms means that we the users are being used as product and are we being sold to the advertisers, who in turn pay to facebook, twitter, YouTube and others. The idea of this business model is to get as much as possible of our attention. The more time we spend on Facebook, YouTube, Google, more money we are generating for them.

At the face value, social media seems useful and harmless. However, it's this naivety of us which has brought us to the point we are at.

So, if one is slightly bent towards right politics, or they're anti-Muslim and open a link or a video on-Facebook or Twitter that endorses this idea. AI will run an algorithm in the background, notifying it that this person probably is interested in right politics and is anti-Muslim. Next time when one logs in, their feed will be filled with videos or links about right politics and anti-Muslim speeches. It is a viscous system. So even if one thinks one is onlyclicking a link or video with one's own will; it is not entirely the truth. We are programmed to watch the stuff that the AI wants us to. That is how this system works and becomes monetized.

Therefore, someone who was probably 10% of a radical, the first time he logged onto social —will be totally radicalized in only a matter of few months. Because he is constantly fed this information. I was engrossed in pleasant dreams of the pari when I became conscious of a slight tingling in my right arm. hat is common between a Jersey Gau (Cow) and an anaemic Post Traumatic Stress Disorder (PTSD) patient? Well, if you ask me, not much—I swear upon the holiest oaths ever invented that the difference is minimal. After all, some philosopher did state that man was a something animal-something escapes me. The cow is fed generously so that she produces more milk, and an anaemia patient is fed in the same way so that their haemoglobin levels rise. Whether any consideration is given to the cow's likes and dislikes, I have no knowledge of, but I will vouch for the fact that it is the last thing under consideration when an anaemic is being fed.

Meet yours truly, an anaemic PTSD patient holed up in his sickening yellow room since May 5, 2012-how I curse that day. PTSD reminds me of Rajesh Khanna in the babu-moshai movie; it sounds impressive in its full form. I can see what he meant by the look on his visitors' faces when he announces the name of his disease: awestruck.

Some caresses knock the wind out of you, some spoil your carefully parted hairbut then, it is their love—haan jaan gaye, haan maan gaye (yes, I know and accept!)—and when was I averse to love? Sigh!

There is one more thing that relatives come laden with: diagnosis. I am sincerely of the opinion that Kashmiris have originated from a progenitor who must have been a doctor or a compounder. A select few pronounce my condition as GARMI (heat, of/from what, God only knows). However, most declare me a victim of the evil spirit and the evil eye: he is such a good writer, he looks so handsome, nazar toh lagni hi hai. I am seriously contemplating a raiment of rags and unkempt hair when I go out in public. Yes, little boys will throw stones at me but I would take them gladly in exchange for such diagnosis. And as every Kashmiri professes to be a knowit-all, the addresses of doctors and saints and shamans, too, are freely swapped. Doctors I can bear (though, in-



explicably, most turn up late on days I have an appointment), but it is encounters with the shaman, or holy men, that trouble me.

One just does not know what is in store when one visits a shaman, called peer in local parlance. I had the pleasure of making the acquaintance of one who immediately pronounced that a pari (female genie, duffer!) was besotted with me. My relief and joy knew no bounds. For all you know, it could easily have been a djinn. How would I have faced my friends?

I am heterosexual and it would have been a rather unpleasant conjecture. As for joy, is there a better antidote for a breakup than a readymade relationship waiting for you with open arms? Who needs a girlfriend when one has a pari for a lover? (dillagi hai PARI say toh KHAREE kya cheez hai). I was engrossed in pleasant dreams of the pari (O hansini, kahan ud chali) when I became conscious of a slight tingling in my right arm. Then I felt a searing pain.

As I roused myself, I became aware that the baba was raining blows on me with a plastic rod to ward off the pari. My protests were drowned by my cries of agony. Anxiety To Speak In Online Classes

Many parents and students are engaged in a daily routine of speaking to people via a camera on a computer, tablet or phone during COVID-19 restrictions. This often means finding a quiet place in order to ask a question, provide an answer or share an opinion with a virtual audience.

Initial concerns about using video apps focused on privacy and equity issues.

Soon, new terms emerged such as Zoom fatigue. But an issue that has been less discussed is the role that nerves might play in these mediated sessions.

What is speaking anxiety?

For centuries, people have questioned their ability to speak in front of others. It's said the Roman orator Cicero (106-43BCE) turned pale and quaked before any speech he gave.

But it was in the 20th century that communication anxiety was studied in depth. It has been described by a number of different terms, including stage fright, unwillingness to communicate and communication apprehension.

Research suggests about one in five speakers experience high communication apprehension. This can make all speaking opportunities difficult.

Examples include speaking to a boss or teacher, contributing to a group discussion, or delivering a presentation. Public speaking anxiety is part of communication apprehension.

The prevalence of public speaking anxiety is well documented. It is complex (varying causes, indicators and treatment options), individual (affecting speakers differently) and unstable (changing levels of anxiety within and between presentations).

A focus on individual differences acknowledges that internal thoughts and feelings might not match external behaviour. For example, a speaker who appears disengaged may actually feel a lack of control.

It is a tricky phenomenon. Some people can feel nervous the moment a speaking task is announced and, on the day of presentation, may rate themselves as more nervous than what an audience observes.

Nervous about the audience

It is the audience, and the potential for negative

evaluation from that audience, that can make us feel anxious. And those listening can be physically or virtually present.

This brings us to the rather awkward situation of speaking to rows of little boxes on a screen in a video hook-up. Not only does this set-up limit broader non-verbal cues, but it also restricts general banter between participants.

On the plus side, this can make sessions more time-efficient, but it does tend to make conversations more stilted.

A perceived need to be visible is a contested area in online delivery. In educational settings, those who support "cameras on for everyone" suggest it helps to replicate usual classroom conditions, encourages discussion and ensures students are actually in attendance (not just logged on).

But it is important to consider the rationale behind making any feature mandatory. Participating via a video app is not the same as a live setting.

For a start, speakers rarely see themselves when talking to others. As a lecturer, seeing myself onscreen while speaking with a class can be distracting, especially when trying to look directly at the camera lens to maximise eye contact.

7 tips to make things easier

Whether running a business meeting or teaching a class, the following tips may help you to feel more comfortable speaking online:

- provide an agenda ahead of time, which could include sending out some prepared questions for discussion
- reduce uncertainty about participation by letting people know from the outset if there is any need or expectation to talk in a hook-up
- use linking statements and signposts to keep everyone on track as other cues and clues may be absent (walking across a room to a computer), so it's important to let all participants know what you are doing and why (for example: "I'm going to check the chat box at the end of this point so feel free to add any questions as I go along.")
- model good speaking practices, draw on simple structures to make your point and use language that is suitable for oral delivery
- rethink the value of calling on someone randomly to contribute to a discussion, because if people are worried they may be asked to respond without notice. they may be less likely to engage overall
- make decisions about the need for interaction (including break-out rooms) based on the type of session and number of participants, because needless interaction is not better than no interaction plan for each online event rather than stick to a set of

general rules. For example, is it always necessary for speakers to see each other onscreen? As most educators will tell you, just because a student is physically present that doesn't mean they are actively engaged.

Online tutorials, workshops and meetings are here to stay for the moment. To create safe, supportive and productive sessions, we need to build competent and confident speaking practices.

Acknowledging that speaking anxiety is common, and affects people in live and virtual settings, is a good place to start.

"It allowed us to obtain a comprehensive overview and establish that colour-emotion associations are surprisingly similar around the world." Nearly 50% Of India's **Working Women Feeling Increased Stress Due To Pandemic: Survey**

Tearly 50 per cent of India's working women are feeling increased stress due to the COV-ID-19 pandemic, claimed a survey conducted by online professional network LinkedIn.

It revealed that the pandemic is taking a toll on the emotional well-being of India's working women as 47 per cent report they are experiencing more stress or anxiety due to the pandemic, LinkedIn said.

For men, this number stood at 38 per cent, pointing towards a disproportionate impact on women in these testing times, it said.

LinkedIn on Thursday announced the findings of the tenth edition of the LinkedIn Workforce Confidence Index, a fortnightly pulse on the confidence of India's workforce. Based on the survey responses of 2,254 professionals in India, findings from the weeks of July 27 - August 23 reveal the pandemic's impact on India's working mothers and working women, and the cautious optimism of freelancers towards personal finances and career prospects, it said.

The survey also underscored the challenges of childcare during the pandemic, according to a LinkedIn statement. The survey showed that India's overall confidence is growing steadily.

Remote working has laid out a tougher road for India's working mothers as the survey showed that around one in three (31 per cent) working mothers are currently providing childcare full-time, when compared to nearly one in five (17 per cent) working fathers, the statement said. "Worryingly, more than two in five (44 per cent) working moms are working outside their business hours to provide childcare, nearly twice as many men (25 per cent)", it said.

The survey showed that only one in five (20 per cent) working mothers rely on a family member or friend to take care of their children, when compared to 32 per cent men. More than 46 per cent working mothers reported working till late to make up for work, and 42 per cent are unable to focus on work with their children at home, it said.

How the world reacted to Bahrain, Israel normalising ties

Manama: Bahrain has become the latest Arab nation to agree to normalise ties with Israel as part of a broader diplomatic push by US President Donald Trump and his administration

In a joint statement, the United States, Bahrain and Israel said the agreement was reached after Trump spoke with Israeli Prime Minister Benjamin Netanvahu and Bahrain's King Hamad bin Isa Al Khalifa on Friday

Trump hailed the deal as "a historic breakthrough".

The agreement comes only a month after the United Arab Emirates became the first Gulf Arab country to reach a deal on normalising relations with Israel, capping years of discreet contacts between the two countries in commerce and technology.

Bahrain is the fourth Arab nation to reach such a deal with Israel after Egypt, Jordan and the UAE.

Here is how other nations and stakeholders in the Israeli-Palestinian conflict reacted to the Bahrain-Israel deal

Palestinian leadership

The Palestinian Authority (PA) condemned the Bahrain-Israel normalisation deal as another betrayal by an Arab state.

The agreement was "a stab in the back of the Palestinian cause and the Palestinian people", like the UAE-Israel deal announced last month, Ahmad Majdalani, social affairs minister in the occupied West Bank-based PA, told AFP.

Hamas, which controls the Gaza Strip, said the deal was an "aggression" that dealt "serious prejudice" to the Palestinian cause

U.S. hospitals Washington: have turned down about a third of their allocated supplies of the COVID-19 drug remdesivir since July as need for the costly antiviral wanes, the Department of Health and Human Services (HHS) confirmed on Friday.

Some hospitals said they

establish relations, saying that it hoped it would have a positive effect on peace and cooperation in the region and around the world.

"The move represents a significant step towards an era of security and prosperity ... (and) would expand the scope of economic, cultural, scientific, and diplomatic avenues of cooperation," the UAE foreign ministry said in a statement.

On September 15, the UAE will formally normalise ties with Israel, a move that was announced last month. Bahrain and Israel will sign a declaration on the same day.

Iran

Following the agreement, Iran said Bahrain was now partner to the "crimes" of Israel.

"The rulers of Bahrain will from now on be partners to the crimes of the Zionist regime as a constant threat to the security of the region and the world of Islam," the foreign ministry said in a statement on Saturday.

Egypt

Egyptian President Abdel Fattah el-Sisi said he appreciated the "important step" Israel and Bahrain had taken in agreeing to establish diplomatic relations.

The agreement would help establish "stability and peace in the Middle East, in a way that achieves a just and permanent settlement of the Palestinian issue," el-Sisi said on Twitter.

Turkey

The Turkish Foreign Ministry strongly condemned Bahrain's decision to establish diplomatic ties with Israel, adding it will deal a fresh blow to efforts to defend the Palestinian cause.

"It will further encourage Israel to continue illegitimate practices towards Palestine and its efforts to make the occupation of Palestinian lands permanent," the ministry statement said.

klury in some countries. An HHS spokesperson confirmed on Friday that between July 6 and September 8, state and territory public health systems accepted about 72.%of the remdesivir they were offered. Hospitals in turn purchased only about twothirds of what states and territories accepted, as previously detailed to Reuters by Michael Ganio, senior director of pharmacy practice and quality at the American Society of Health-System Pharmacists.



Warring Afghans meet in Doha to find peace after decades of war

Kabul: Afghanistan's warring started negotiations in sides Doha on Saturday for the first time aimed at ending decades of war, bringing together delegates appointed by the Afghan government and the Taliban.

US Secretary of State Mike Pompeo attended the opening ceremony, which was held in Qatar where the meetings will take place. It's the latest in a flurry of diplomatic activity by the Trump administration ahead of the US presidential election in November. The discussions are important in the search for lasting

peace that will also provide an exit for US and Nato troops after nearly 19 years. The sides will try to tackle

tough issues. This includes the terms of a permanent cease-fire. the rights of women and minorities and the disarming of tens of thousands of Taliban fighters and militias loyal to warlords, some of them aligned with the government.

The talks in Doha follow the US-brokered recognition of Israel by two Gulf nations — Bahrain on Friday and the United Arab Emirates earlier this month.

The Afghan sides are also expected to discuss constitutional changes, and power sharing. Even seemingly mundane is-

sues like the flag and the name

of the country — the Islamic Republic of Afghanistan or as the Taliban's administration had been known, when it ruled, the Islamic Emirate of Afghanistan — could find their way on to the negotiation table and roil tempers.

Among the government-appointed negotiators are four women, who vow to preserve women's rights in any power-sharing deal with the hardline Taliban. This includes the right to work, education and participation in political life — all denied to women when the Taliban ruled Afghanistan for five years. The Taliban were ousted in 2001 by a US-led coalition for harbouring Osama bin Laden, the architect of the Sept 11 terrorist attacks on America.

There are no women on the Taliban's negotiation team, led by their chief justice Abdul Hakim.

Pompeo has said he expected the discussions to be contentious.

Washington's peace envoy for Afghanistan Zalmay Khalilzad said on Friday that launching the talks is an important achieve ment, but that "there are difficulties, significant challenges on the way to reaching agreement".

This is a test for both sides, for the Taliban and the government," he said. "Can they reach an agreement despite differences, in terms of their visions for the future of Afghanistan?"

Pakistan, China invited to Russia war games

The intra-Afghan negotiations were laid out in a peace deal Washington signed with the Taliban on Feb 29. At that time the deal was touted as Afghanistan's best chance at peace in 40 years of war. The talks were originally ex-

pected to begin within weeks of the Feb 29 signing.

But delays disrupted the timeline from the outset. The Afghan government balked at releasing 5,000 Taliban prisoners, which was stipulated in the deal as a sign of good faith ahead of the negotiations. The Taliban were required to release 1.000 government and military personnel in their custody.

Political turmoil in Kabul further delayed talks as Afghan President Ashraf Ghani and his rival in controversial presidential polls the year before, Abdullah Abdullah. squabbled over who won, with both declaring victory.

The Taliban's refusal to reduce the violence further hindered the start of talks.

While Washington ramped up pressure to get the intra-Afghan negotiations started, the deal they signed with the Taliban to withdraw completely from Afghanistan does not hinge on the success of the talks.

PARIS: Global animal, bird and fish populations have plummeted more than twothirds in less than 50 years due to rampant over-consumption, experts said on Thursday in a stark warning to save nature in order to save human beings.

Human activity has severely degraded three-quarters of all land and 40 per cent of Earth's oceans, and our quickening destruction of nature is likely to have untold consequences on our health and livelihoods.

The Living Planet Index, which tracks more than 4,000 species of vertebrates, warned that increasing deforestation agricultural expansion and were the key drivers behind a 68 per cent average decline in pop ulations between 1970 and 2016.

It warned that continued natural habitat loss increased

Tehran: Iranian wrestler Navid Afkari has been executed after being convicted of stabbing to death a security guard, according to state media

"The retaliation sentence against Navid Afkari, the killer of Hassan Turkman, was carried out this morning in Adelabad prison in Shiraz," state TV quoted the chief justice of Fars province, Kazem Mousavi, as saying on Saturday.

Authorities

said Navid Afkari was arrested after the murder of a 52-yearold water worker accompanying the Shiraz water company and that murder took place on 23 July 2018. "Navid Afkari was arrested by police a few days after, after they identified him using CCTV footage. As far as the judiciary is concerned, his arrest and conviction have nothing to do with the protests that took place," said Baig.

A surplus of remdesivir which costs \$3,120 for a 6-vial intravenous course - marks a turnaround from earlier in the pandemic, when supplies of the drug had fallen short of demand in some regions.

Government-led distribution of remdesivir will expire at the end of September. Hospitals said they have little information on availability after that.

MOSCOW: Russia said on Friday it would stage massive military drills in the Caucasus later this month with troops from several countries, including Pakistan, China and Iran, invited to participate.

More than 12,000 troops will take part in the "Caucasus-2020" war games, which will take place in southern Russia from Sept 21 to 26 and include land and naval exercises, Deputy Defence Minister Alexander Fomin told a briefing. "The Caucasus-2020 drills

Trump's appeal

Afkari's sentencing had triggered a social media campaign that portrayed him and his brothers as victims targeted for participating in the 2018 protests. On Tuesday, a global union representing 85,000 athletes had called for Iran's expulsion from world sport if it executed Afkari.

Iran Former Top Judiciary Official Jailed For 31 Years Over Corruption

ehran: Iran said Saturday it condemned a former top judiciary official to 31 years in prison for corruption, one of the heaviest sentences against a former official in the Islamic republic.

Akbar Tabari received the jail term after being convicted of "setting up and heading a bribery network", judiciary spokesman Gholamhossein Esmaili told state television.

The high-profile trial of Tabari, who served in a number of senior roles in Iran's judiciary, opened in June alongside 21 other defendants.

In its ruling, Tehran's criminal court ordered Tabari to pay more than 430 billion rials (\$1.65 million) in fines. It also ordered the seizure of illegally



acquired properties.

Tabari was also found guilty of money-laundering, for which he was sentenced to 12 years and ordered to pay about 600 billion rials (\$2.3 million), said Esmaili.

The judiciary spokesman said the verdict could still be appealed and that, based on Iran's criminal code. Tabari would have to serve only the longest of the jail terms.

Among the properties to be confiscated were four apartments

in north Tehran, two business venues in the heart of the capital, and five plots of land in a popular northern tourist resort.

Tabari served as the former deputy head of administrative affairs at the judiciary.

He was later promoted to be the head of executive affairs and then executive deputy under then judiciary chief Ayatollah Sadegh Amoli Larijani from 2009 to 2019.

In March last year, Iran's supreme leader Ayatollah Ali Khamenei replaced Larijani with Ebrahim Raisi, a religious conservative, and called on him to work "against corruption".

According to media reports, Raisi sacked Tabari "eight days after taking office" without providing a reason.

Tabari's arrest was confirmed by the judiciary on July 2019.

Liberia declares rape a national emergency

iberian President George Weah has declared rape a national emergency and has ordered new measures to tackle the problem after a recent spike of cases in the poor West African state.

The moves comes after thousands of Liberians protested rising incidents of rape in the capital Monrovia last month, in a bid to draw attention to the country's alarming rate of sexual assault.

Late on Friday, Weah said he would install a special prosecutor for rape in Liberia, as well as set up a national sex offender registry, a statement from his office said.

The government will also establish a so-called "national security task force" on sexual- and gender-based violence.

The high rates of rape in impoverished Liberia, forced to contend both with war and the Ebola virus in recent years, has been a longstanding concern.

A UN report in 2016 recorded 803 rape cases the previous year in the country of 4.5 million, and found that only



two percent of sexual violence cases led to a conviction, for example.

It was the resulting sense of impunity and the legacy of the 14-year civil war between 1989 and 2003, when rape was commonplace, that had created the current problem, it said.

Incidents of rape appear to have risen sharply this year, however.

Margaret Taylor, the director of Liberia's Women Empowerment Network, told AFP last month that her NGO had recorded 600 cases of rape between June and August, for example.

Missing Hunters From Arunachal Who Crossed LAC Handed Over To India By China

The army took over all five individuals at Kibitu on September 12 after completing all the formalities. The individuals will now be quarantined for 14 days as per COVID-19 protocol and will thereafter be handed over to their family members, the statement added.

There Will Be 'Flood' Of Pending **Cases Post-Covid, Mediation Needs To Be Emphasised: CJI**

hief Justice of India S A Bobde on Saturday said that the COVID-19 pandemic would present a "huge pendency of cases" in courts and a lot of emphasis has to be placed on utilis-ing mediation for resolving many of these matters.

The CJI also stressed on the need to focus on mental health and referred to the "uncomfortable prediction" that there might be a suicide pandemic following the COVID crisis.

This COVID pandemic is going to present us with huge pendency of cases. I do not see any way out of it. We have to decide cases," the CJI said during a virtual event where he launched the book - 'Judiciary, Judges and the Administration of Justice' - authored by former top court judge Justice R Banumathi.

The CJI said he believes that this is the time when a lot of emphasis has to be placed on utilising mediation, pre-litigation and post-litigation mediation to resolve many matters. "I am not suggesting every matter can be, but when the pandemic goes away and the lockdowns are all lifted,



way of following the detailed procedure and this is something which we all have to put in our minds together to deal with," he said. Addressing the gathering, Justice N V Ramana said judges are now being construed as soft targets for criticism and are becoming "victims of juicy gossip and slanderous social media posting".

Justice Ramana, the senior-most udge of the apex court after the CJI, said that judges have to balance their social life in order to be independent.

"It is completely upon the judge to maintain a distance. Judges themselves restrain from speaking in their own defence and they are now being construed as soft targets for criticism. This issue is further complicated by we are going to face a flood of cases the proliferation of social media and

technology. Judges are becoming victims of juicy gossip and slanderous social media posting," he said.

Raising the issue of mental health, the CJI said it requires serious attention as there is a very "uncomfortable prediction" about a suicide pandemic. "I don't believe and sincerely hope that it does not happen," he said, adding that pandemic has brought two things amongst people which is very troublesome -- depressive tendency and unnecessary aggression.

"It is high time that we devote energy to mental health," he said, adding that the Supreme Court has taken an initiative to deal with the mental health issue and provide professional mental health advice, which the secretary general of the top court would soon announce.

He said the judiciary belongs to the nation and its achievements are the result of "unflinching dedication" and commitment of numerous individuals on and off the bench.

The CJI said that for judges and consequently for the judiciary, the biggest challenge is to ensure that the nation inches towards the goal set in the Constitution.

According to a video of the incident that took place inside Wednesday's flight, reporters and cameramen were jostling and bunching up to get a comment from Ranaut, who was sitting in that at times, the airlines

Saturday said, "It has been decided that from now on. incase any violation (photography) occurs on any scheduled passenger aircraft-the schedule of flight for that particular route shall be suspended for a period of two weeks from the next day (of the incident)." The order was sent to all domestic airlines in India. The order stated that as per Rule 13 of the Aircraft Rules 1937, no person is allowed to take any photographs inside a flight except when permission is granted by the DGCA
