Youth Found Dead In Sopore

They said a police team took the body in custody to conduct post-mortem and to ascertain the cause of death. SRINAGAR: Hundreds of people on Thursday protested in Batamaloo area of this capital city after a pre-dawn encounter in the area left three militants and a woman dead, while two CRPF personnel, including an officer, were injured.

Around 2:30 am, state forces launched a cordon and search operation in Firdous Abad locality of Batamaloo following specific information about presence of militants, officials here said.

According to police, besieged militants turned down surrender offer and opened fire on joint column of forces resulting in injuries to a CRPF Deputy Commandant Rahul Mathur and a woman identified as Kousar Ian.

Pakistan To Grant G-B Full Provincial Status

ISLAMABAD- Pakistan has decided to elevate Gilgit-Baltistan's status to that of a fullfledged province, a Pakistani media report on Thursday quoted a senior minister as saying.

According to a report in the Express Tribune, Minister for Kashmir and Gilgit-Baltistan Affairs, Ali Amin Gandapur, on Wednesday said that Prime Minister Imran Khan would soon visit the region and make the formal announcement to elevate Gilgit-Baltistan to the status of a full-fledged province with all constitutional rights.

Gandapur said Gilgit-Baltistan would be given adequate representation on all constitutional bodies, including the National Assembly and the Senate.

After consultation with all stakeholders, the federal government has decided in principle to give constitutional rights to Gilgit-Baltistan, the minister told reporters.

India has conveyed to Pakistan that "the entire union territories of Jammu and Kashmir and Ladakh, including the areas of Gilgit and Baltistan, are an integral part of the country by virtue of its fully legal and irrevocable accession."

22 Soldiers Died At High Altitudes In 3 Years: Gol

SRINAGAR: At least 22 soldiers have died while serving at high altitudes including Siachen Glacier, the world's highest battle ground, the government informed on Thursday.

In 20016, there were six casualties while the number stood at eight each in 2018 and 2019 respectively.

India Wants Normal Relations With Pak: India

According to the witnesses, the killings triggered protests in the area. Scores of youth hit the streets and clashed with government forces deployed in the area in huge numbers.

"The government forces fired pellets and burst tear smoke shells to disperse the stone pelting youth. However, the angry protesters regrouped and continued renewed attacks on the police and paramilitary forces. The ding-dong battles continued for several hours," Farooq Ahmad Bhat, a local told Kashmir Observer.

He said that thousands of people turned up at the funeral of the woman amidst intense sloganeering on Thursday night.

"They were given a chance to surrender, but they refused and fired. One CRPF officer and another CRPF man sustained injuries in the initial exchange of firing. The officer is critical and we are praying for his recovery," Singh said. He added that the forces conducted the operation in a professional manner and killed all the three militants. The three militants were identified as Zakir Ahmad Paul of Shopian, Ubair Mushtaq Bhat of Kulgam and Adil Hussain Bhat of Awantipora, affiliated with Hizbul Mujahideen. "However, a woman was caught in the crossfire. Her death is very unfortunate, and we express sympathy with the bereaved family," the DGP said. The DGP was accompanied by IGP, Kashmir, Vijay Kumar and IG, CRPF, Srinagar sector, Charu Sinha.

"Arms and ammunition were recovered," he said. Singh said militants from other districts of south and north Kashmir keep coming to Srinagar to carry out attacks on state forces. "On August 14, they targeted our party and killed two policemen at Nowgam. Before that, they had killed two BSF men at Pandach on the city's outskirts. And then, they made another attempt at Pantha Chowk, where we lost a brave SOG man," the DGP said. He said the police and CRPF teams are on alert, and whenever they get a lead about the presence of militants in the city, efforts are made to ensure zero collateral damage. "Today's operation was the seventh one in Srinagar in the recent past," Singh added. Police chief said 177 militants have been killed in 72 operations so far this year.

"In terms of peace, 2020 has been better on every parameter than 2019. So far this year, we have done 72 operations, in which 177 militants were killed, including 12 in Jammu," the DGP said. He said 22 militants from Pakistan were among these 177. "Most of the (militants) working in outfits like Lashkar and Jaish are from Pakistan. I hope the way the forces are conducting operations, we will achieve more successes on the peacebuilding and operations front," Singh said. He said the endeavour of the state forces was to avoid collateral damage in every operation.

"We also give opportunity to the militants to surrender, even when there is exchange of firing. Also, we try to bring back those youth who have taken up the wrong path and we have achieved success on that front also, especially in south Kashmir. I think around 20 youth have been brought back and they have joined their families," the DGP said. He appealed to the young people not to take the wrong path, saying it puts the society in danger.

"Where the gun or bullet or grenade reaches, there is loss of life, and we can avoid it only if we shun the path of militancy and make way for peace. I think Pakistan does not lose an opportunity to instigate our youth and is trying to renew (militant) outfits like Al-Badr and create new ones like PAFF (People's anti-Fascist Front) and TRF (The Resistance Front). Pakistani agencies in Karachi are planning and executing these things and we condemn it. The youth here have a right to build their own lives and careers, but Pakistan's interference is there," Singh said. Asked about the alleged assaults on media persons near the encounter sites, the DGP said it was unfortunate. Such things should not

"We do not support such acts and feel bad. But at times, during operations, our men have high temper which results in such incidents. There is overreaction sometimes, which I regret. However, there is no deliberate attempt. I reiterate that media and policemen are each other's good friends," he said. (with PTI inputs)

He was responding to a clarification sought by former defence minister A K Antony on the issue of Indian forces not being allowed to patrol in certain parts of the Galwan valley. I want to make it clear (that) skirmishes and face-off are because of this (issue of patrolling)," he said, adding the patrolling pattern is traditional and well defined.

Singh made the statement in Rajya Sabha after the government and opposition agreed not to have a discussion on the sensitive issue. Chairman M Venkaiah Naidu, however, allowed members to seek a few clarifications on the statement, which was almost identical to the one Singh had made in Lok Sabha on September 15. The minister said India and China are yet to resolve their boundary question. "China does not accept the customary and traditional alignment of the boundary between India and China," he said.

"We believe that this alignment is based on well-established geographical principles confirmed by treaties and agreements, as well as historical usage and practice, well-known for centuries to both sides," he said. The Chinese position, however, is that the boundary between the two countries has not been formally delimited, that there exists a traditional customary line formed by the extent of jurisdiction that they claim was exercised historically by each side, and that the two sides have different interpretations of the position of the traditional customary line," he said.

China, he said, continues to be in illegal occupation of about 38,000 square kilometers of Ladakh. Besides it also holds 5,180 sq km of Indian territory in Pakistan controlled Kashmir that Pakistan had illegally ceded in 1963.

"I would like to mention here that as yet there is no commonly delineated Line of Actual Control (LAC) in the border areas between India and China and there is no common perception of the entire LAC," he said, adding more than two decade old agreements call for two sides to maintain minimal forces along the LAC. On the latest situation, the minister said India has noticed a buildup of troops and armaments by China in the border areas adjacent to Eastern Ladakh since April. "In early May, the Chinese side had taken action to hinder the normal, traditional patrolling pattern of our troops in the Galwan Valley area, which resulted in a face-off," he said.

Even as this situation was being addressed by the Ground Commanders, in mid-May the Chinese side made several attempts to transgress the LAC in other parts of the Western Sector. This included Kongka La, Gogra and North Bank of Pangong Lake. "These attempts were detected early and consequently responded to appropriately by our armed forces." he said.

"We made it clear to the Chinese side both through diplomatic and military channels that China was, by such actions, attempting to unilaterally alter the status quo. It was categorically conveyed that this

was unacceptable," Singh said. Given the growing friction along the LAC, the senior commanders of the two sides in a meeting on June 6, 2020 agreed on a process of disengagement that involved reciprocal actions. "Both sides also agreed to respect and abide by the LAC and not undertake any activity to alter the status quo," he said. "However in violation of this the Chinese side created a violent face off on June 15 at Galwan. Our brave soldiers laid down their lives and also inflicted costs including casualties on the Chinese side," he said.

Indian armed forces have during these provocative actions maintained "sayvam" (restrain) and displayed "shaurya" (valour) to protect the territorial integrity of India, he said.

Giving details of the talks held with China to de-esclate the tension, the minister said India pressed for three key principles -- strictly respecting the LAC, not attempting to alter the status quo unilaterally, and abiding by all agreements and understandings between the two sides.

The Chinese side, on its part, took the position that the situation should be handled in a responsible manner and ensure peace and tranquillity as per bilateral agreements and protocol.

China made provocative military manoeuvres late last month even when these discussions were on, he said.

"As is clear from these events, the Chinese actions reflect a disregard of our various bilateral agreements. The amassing of the troops by China goes against the 1993 and 1996 agreements," the minister said.

Respecting and strictly observing the LAC is the basis for peace and tranquillity in the border areas and explicitly recognized in both 1993 "While our armed forces abide scrupulously by it, this has not been

reciprocated by the Chinese side. Their actions have led to face-offs and frictions from time to time along the LAC," he said.

The incidents and "the violent conduct of Chinese forces" has been in complete violation of all mutually agreed norms, he said.

Singh said China has mobilised a large number of troops and armaments along the LAC as well as in the depth areas. "There are several friction areas in Eastern Ladakh including Gogra.

Kongka La and North and South Banks of the Pangong Lake," he said. In response to China's actions, Indian armed forces have also made appropriate counter deployments in these areas to ensure that national security interests are fully protected. "I would like to emphasise, that India remains committed to resolving

the current issues in our border areas through peaceful dialogue and consultations," he said, referring to his meeting with his Chinese counterpart in Moscow on September 4.

"I conveyed in clear terms our concerns related to the actions of the Chinese side, including amassing of large number of troops, their aggressive behaviour and attempts to unilaterally alter the status quo that were in violation of bilateral agreements," he added.

Leader of Opposition Ghulam Nabi Azad, Anad Sharma and former defence minister A K Antony of the Congress asked the government to take efforts to restore the status quo ante of April and resolve the over-three-month-old border standoff. Some members such as Prasanna Acharya of the Biju Janata Dal (BJD) and Sanjay Raut of the Shiv Sena cautioned the government while entering into any agreement with China over the present situation. Defence Minister Rajnath Singh made a statement in the Rajya Sabha after the government and opposition agreed that there will be no discussion on the sensitive issue. Chairman M Venkaiah Naidu, however, allowed the members to seek a few clarifications on the statement, which was almost identical to the one Singh made in the Lok Sabha on September 15. Sharma said the country is proud of its Army and the sacrifices made by the soldiers to protect the border.

"There should be no doubt on this and the entire nation would stand together," he said. Referring to the recent talks between the Indian defence minister and foreign minister with their Chinese counterparts and a statement on September 11, Sharma asked: "Do we understand that the restoration of the status quo ante will remain a non-negotiable and final objective for India?"

Antony sought a clarification over Singh's statement in the Upper House. "You have to clarify that sovereignty means status quo ante as on the middle of April. That is the meaning of sovereignty," he said. Galwan Valley in eastern Ladakh was never a disputed site, the former defence minister said.

"Even at Galwan Valley, our soldiers are now not allowed to patrol at the point at which they used to patrol earlier. In the Pangong area, in a more than eight-kilometre area they are not allowing us to patrol, the area which we used to patrol. Previously, we used to patrol till Finger 8 and now we are not being allowed to patrol till Finger 8," he added. The Army and the Indo-Tibetan Border Police (ITBP) should be allowed to patrol at the point where they used to patrol earlier, the Congress leader said. Azad said he stands with the armed forces and salute their valour. Being a citizen of the erstwhile state of Jammu and Kashmir, Azad said the people from there are ready to sacrifice themselves to defend the territory and integrity of the nation. "On behalf of my party, I would say at least on this China issue, we stand with the government. There should be no compromise. They should go back to the position where they were in April," the Congress leader said.

RCP Singh of the Janata Dal (United) said China is an "ungrateful' country that always follows a "policy of aggression". He suggested that the government should negotiate with the neighbouring country from a position of strength. Tiruchi Siva and P Wilson of the Dravida Munnetra Kazhagam (DMK) expressed their solidarity with the armed forces. Raut said patience and valour are the traditions of India, but not of China.

The neighbouring country has a "tradition of betrayal and we should always be careful with them," the Shiv Sena leader said.

BP Baishva of the Asom Gana Parishad (AGP) said the people of the northeast are with the armed forces and salute their sacrifice.

Ravi Prakash Verma of the Samajwadi Party (SP), K Keshava Rao of the Telangana Rashtra Samithi (TRS), Binoy Viswam of the Communist Party of India (CPI), Elamaram Kareem of the Communist Party of India (Marxist), Sanjay Singh of the Aam Aadmi Party (AAP) and Veer Singh of the Bahujan Samaj Party (BSP) also participated in the debate and expressed their solidarity with the armed forces.

On Wednesday, protests broke out at Sidiq-Colony area of Sopore after news spread that a youth Irfan Ahmad Dar, arrested by police a day earlier, has been found dead under mysterious circumstances. While the family charged police of killing the youth in custody, the latter claimed that Dar was an OGW and his body was recovered near Stone Quarry of Tujjar-Sharief, hours after he escaped from the police taking cover of darkness and terrain during a search operation.

Meanwhile, Inspector General of Police (IGP), Kashmir Vijay Kumar said today that he believes Dar fell on a stone and may have had a cardiac arrest, and died while trying to flee when the police were taking him to a spot for recovering ammunition. "The SP has said Dar was an OGW, hand grenades were recovered from his possession and that he was being taken to the spot for more recovery during the night when he fled. He had no arms, so he did not fire and our jawans also did not fire. After some time, they found him. He had fallen on a stone. He also had an injury on his foot. He was taken to a hospital. Post-mortem and COVID tests were done. His family was called and he was buried in Sonamarg." Kumar said while replying to a query at a presser here on Thursday.

Asked why Dar's body was not handed over to his family, he said earlier, there was a written agreement after a militant had died in Sopore that only 50 to 60 men would attend the funeral, but 2,000 people had turned up. "So we had apprehensions that 10,000 or 20,000 people may gather at the funeral and there was a risk of the spread of the (COVID) pandemic. That is why the body was not handed over to family," the IGP said.

Results Of DNA Samples...

ED Files Charge Sheet... sources of income and this money could not have been obtained

through licit means. It clearly implies that Dr Bilquies Shah was an active accomplice of Shabir Shah in his illicit criminal activities. She had spent money in excess of her known sources of income towards her monthly expenses, daughters' education, maintenance of vehicle and investments in financial instruments, it said, adding that this proves illicit money acquired by them was spent on meeting these expenses and investments.

Shabir Shah and his wife Dr. Bilquis Shah by way of criminal activity related to scheduled offences had acquired huge sum of money through Hawala route from Pakistan and laundered the same by using part of it in acquisition of movable & immovable properties and to meet their lifestyle expenses, it said, terming the properties as proceeds of crime.

The charge sheet added: Dr Bilquis Shah is guilty of offence of money laundering as defined in Section 3 of the PMLA, as she was directly or indirectly indulging in and actually involved in all or any process or activity connected with the proceeds of crime including its concealment, possession, acquisition or use and projecting or claiming it as untainted property accordingly Dr Bilgies Shah has also been arrayed as an additional accused in this Supplementary Complaint (ED's equivalent of a charge sheet).

The ED said Shabir Shah was the main accused named in the charge sheet as he was the conspirator who had devised the whole scheme of money laundering by obtaining illicit funds from outside India to further the nefarious designs of causing unrest in J&K. "Shabir Ahmad Shah was in regular touch with Hafeez Sayeed, head of Jamatud-Dawa. He was further in regular touch with Mohd. Shafi Shayar, based in Pakistan, whose Pakistani phone number was provided by him to Aslam Wani for collecting the crime money in Delhi on his behalf." Shabir Shah had taken the services of Aslam Wani in the on a commission basis plus reimbursement of expenses, to collect crime money from Pakistan at Delhi and to carry the same for onward delivery to him or his wife Dr Bilquis Shah, it said. Aslam Wani used to receive hawala money from Pakistan at Delhi and carried the same to Srinagar on the directions of Shabir Shah and in lieu of these services, he was paid money by Shabir Shah, it said. The charge sheet has been filed under sections 3 and 4 (money laundering) of Prevention of Money Laundering Act.

The agency had earlier filed charge sheet against Shabir Shah and Aslam Wani. The ED alleged that Wani was asked by Shah to work for him (on a commission basis) in collecting hawala money from Delhi and deliver to him at Srinagar. The case dates back to August 2005 in which the Delhi Police's Special Cell had earlier arrested Wani and recovered Rs 62.96 lakh cash, five Kgs of explosives and one pistol with 15 live cartridges from his possession. Wani had claimed that he had to deliver Rs 52,96,000 to Shabir Shah in Srinagar and the remaining Rs 10 lakh were to be paid to the activists of Jaish-e-Mohammad. Wani stated that Shabir Shah was directing hawala operators including some from Pakistan to deliver money to him in Delhi. He also submitted that he was working on the directions of Shabir Shah and even in the past he had taken money to be delivered to Shabir Shah in Srinagar. Wani had then claimed that he had given Rs 2.25 crore to Shah, following which the ED had registered a criminal case under PMLA against the duo in 2007.

the I-T Department."During the course of the search operation, receipt of unsecured loans to the tune of Rs 25 crore in the past two years from persons of no means has been found," it said. "All these loans are prima facie not genuine, as the same have been advanced by persons with doubtful creditworthiness," it added. The action also revealed, it said, that the assessee's children are studying in the US on whom expenditure of about Rs 25 lakh per annum is being incurred.

The expenditure on account of education in the US prima facie appears to be unexplained/undisclosed, it said. "The assessee is also running a B Ed college as a trust along with his mother. The trust in not registered and no return is being filed though it has substantial taxable income. "The assessee has also admitted to having incurred an expenditure of Rs 40 lakh on the renovation of his residence," it said. A bank locker, found during the searches, has been put under restraint, it said. Meanwhile, the second case pertains to a prominent jeweller in Srinagar.

"During the search, it was found that he had not maintained books of accounts of the jewellery business even though the turnover is of the range of Rs 2 crore-Rs 10 crore in the earlier years."

"The search has revealed that an undeclared bank account was maintained by the assessee with deposits running into crores of rupees, which has not been offered to tax," the CBDT said. The assessee also sold immovable property of Rs 1.90 crore in Srinagar in financial year 2015-16, capital gains tax on which has not been paid, it said. Documents were found, during the raids, that revealed receipt of Rs 16 lakh in cash as 'pagri' by the assessee in FY 2019-20 at the time of leasing of one of the shops. "This transaction is in violation of provisions of Section 269SS of the I-T Act. This fact of receiving cash of Rs 16 lakh has been admitted by the assessee as well as the lessee. The payment of Pagri of Rs 16 lakh is also out of undisclosed income of the lessee," the CBDT claimed. The search also revealed that sale of a flat in Delhi was made by the wife of the assessee in 2019-20 FY for Rs 33 lakh. "During the search, it was seen that no capital gain has been paid on the above sale. Further, out of the sale consideration of Rs 33 lakh, Rs 13 lakh has been received in cash in violation of provisions of Section 269SS of the I-T Act," it said.

The source of investment of buyer also seems prima-facie undisclosed, which is being investigated, the statement said.

The search also revealed that the daughter of the assessee was studying abroad and the expenditure on account of the same prima facie appears unexplained/undisclosed, it said.



4 teenagers die in LoC blast Jawan, 5 Militants among 10 Killed

RINAGAR: Four teenagers were blown to pieces after a live artillery shell they were fiddling with in a village in Uri sector of the line of the control (LoC) exploded today. Elsewhere, 10 people including a jawan and five militants were killed even as security fames arrested a militant across the state since yesterdays. Some shops in Tral bazaar were damaged in an IED blast near the bus stand last night.

According to reports received from Uri. 4 teenagers including a brother and a sister in the age group of 12 and 14 were killed at Garkot village on the Wednesday afternoon in a

Three teenagers were out grazing the cattle when one of them found some unexploded shells in the field. When one of the boy started fiddling with a shell it exploded killing all three of them on spot, police sources in the Baramulla said. The village has been witness to intermittent exchange of artillery shells and mortar firing between India and Pakistani troops during recent weeks.

Don't Reopen Schools

he J&K administration has decided to reopen schools from September 21 and the attendance of the students will be on a voluntary basis. The onus will be on parents and students whether they want to attend the schools or not. Ironically, the government has decided to reopen schools at a time when the coronavirus pandemic is spreading through J&K like a wild fire and the number of deaths is rising. So, how does government expect there will be no infections at the schools?

True, the government will be coming out with Standard Operating Procedures for the schools, one of which is that only 50 percent staff and the students will be allowed to attend. But how does this matter when say 500 out of a total number of 1000 pupils attend. This is a huge number and the students, given their young age, can't be expected to seriously follow the SOPs.

Also what about the students whose parents will not send them to schools for the obvious reason? Won't they be unfairly deprived of education? The authorities have explained that the reopening of schools won't affect online classes. But the question is who will give these classes when teachers will get busy at schools? One can infer from the government's logic that the 50 percent of the teachers who will be at home will deliver online lectures. But will this 50 percent comprise teachers from all subjects? Unlikely.

If we evaluate the situation objectively, the government guidelines for reopening of schools are simplistic. On ground the exercise is not only not going to serve its desired purpose but also disrupt the ongoing online classes and leave a majority of students without education.

Schools have been closed since mid-March when Coronavirus was declared a pandemic around the world. This was barely fifteen days after the schools had reopened following seven month closure in the wake of the revocation of Article 370 in August last year. This has taken a massive toll on the education in Kashmir.

The best solution to lack of schooling for the government was to restore 4G internet in the union territory. This would have ensured the easy access to online education to students. Use of communication technology would have thus obviated the need for a hurried reopening of schools. But while the government is refusing to restore the highspeed internet, it is taking steps to reopen schools, a fraught decision under the circumstances. More so, when Covid-19 cases are spiking in the union territory.

Reopening schools would expose the children to the infection. Schools lack the adequate infrastructure to protect the children. It would also be impossible to make the students follow the safety precautions. This is therefore not the conducive time to reopen schools. Government should wait for the contagion to be reigned in before children can go back to school.

Rajnath Singh on China

hat is left unsaid, at times, says a lot more than what is actually uttered. In a statement to the LokSabha, the Union defence minister, Rajnath Singh, stated that China has amassed a formidable number of troops along the Line of Actual Control and — this admission is significant — in "inner areas". Mr Singh's sombre tone was in sharp contrast to the bragging tune adopted by some influential figures, including the prime minister. Mr Singh may have been comparatively transparent than NarendraModi who has, so far, not issued a substantial statement on a matter concerning national security. But Mr Singh, just like Mr Modi, was also being evasive. He did not, for instance, elaborate on what these "inner areas" are; there is no word yet on the restoration of status quo ante along the LAC; neither did he explain the details of the fateful night that cost the lives of Indian soldiers or, for that, matter, why New Delhi proceeded to sign a loan agreement with a financial institution that has Beijing as its biggest stakeholder only four days after the death of its valiant soldiers. The Centre's admission of accepting financial assistance from a Chinesecontrolled bank would certainly take the sting out of its rhetoric of an economic retaliation against Beijing manifest in the banning of Chinese apps.

The bunglings of Mr Modi's government on China are now fairly evident. The government is speaking in many tongues, with the statements of the defence minister or of the army countering those made by the prime minister, only to be refuted, in turn, by the home ministry. The inability to speak in a transparent, unified voice on the part of a government that supposedly prioritizes unity is shocking and shameful. Sowing the seeds of confusion, even though it casts the government in poor light, may not be an entirely innocent exercise. The multiple signals would, the Centre may be hoping, deflect public attention and enquiry. Mr Modi's government has been busy stonewalling questions raised by the Opposition during the current session in Parliament. The Opposition, even in its fragmented state, must now take the responsibility of mobilizing public opinion, forcing the Centre to come clean on the matter. Truth - history is a witness — has a way of prevailing over falsity. The accompanying political costs of disclosure, Mr Modi should remember, are not insubstantial

What About Education?

Under the new dispensation, the education has been worst hit. And the government doesn't seem to care

The uncertain and interrupted schooling deprives Kashmiri youth proper education and skills. The lack of employment opportunities denies them a future. And the lingering conflict over the region frames their worldview and determines their lives and choices.

t has now been over a year since schools in Kashmir have been closed. And as things stand, it is unlikely that the schools will function normally until early next year the government's order to reopen them on September 21 notwithstanding. That too will be possible only if we have got a grip on the runaway contagion and there is a vaccine for it. However, the Covid-19 related closure of schools is just six months old. Our educational institutions were earlier shut for seven months following revocation of Article 370 in August last year. The sweeping security lockdown and the snapping of the communications brought life in the Valley to a halt.

an exception. What has set the education further back is the lack of high speed mobile internet for the virtual classes. The government has consistently refused to restore 4G in J&K, saying it is necessary "in the interest of the sovereignty and integrity of India, security of the state and for maintaining public order". The government also deems it important to prevent the "misuse" of high speed internet for various "anti-national activities". It was only last month, however, that the government made an exception for the two districts - Ganderbal in Kashmir and Udhampur in Jammu.

Schools could have hardly been

Over a yearlong closure of schools and the difficulty in accessing online education has put a question mark on the future of lakhs of Kashmiri students. But this is an area that has drawn very little media and political attention. In a sense, this doesn't hold true for the last year only. Over the past three decades, the education has been easy and the least focussed casualty of the ongoing turmoil. Schools have intermittently remained closed for months and no one in the Valley seems to lose his sleep over this depressing state of affairs. There were several reasons

for this: the frequent hartals, the constant disruption in public life due to the unrest following mostly a human rights excess or a government move deemed provocative by the people. This alongside everything else politicized the education too. In the midst of an unrest, the Government saw the re-opening of the schools as a major step towards normalcy and the separatists for the same reason were determined to prevent it. Government also couldn't provide security to over 15000 educational institutions and the schools also didn't want to be seen playing along with the Government in defiance of the separatists and at variance with the popular sentiment.

Often, the Government and the separatists mouthed platitudes about their concern for education, but in practice sought to use the school children against each other – at times spinning the issue into a argument. From three successive summer unrests to 2010, followed by the one in 2016 and the situation over the last year, a student who will be studying in 10th class now must have lost almost five years of schooling. One can only imagine how much this must have affected his or her knowledge of the basics of all subjects.

After the erasure of J&K's semi-autonomous status last year, the government-separatist dynamic that largely dictated the state of affairs in the Valley has temporarily ceased to operate. But under the new dispensation, the education has been worst hit. And the government doesn't seem to care. It didn't care when the lockdown and communications blackout kept schools shut for seven months. And it doesn't care now when the lingering ban on high-speed mobile internet in all but two districts is making it challenging for the students to access online education. And this ban has nothing to do with the ongoing pandemic, but continues for a very specious reason, almost for the sake of it. It seems unlikely that the government will review the ban in the near future, something that hardly helps the cause of education.

What about the post-pandemic situation? There is no reason to believe that the schooling will return to normal. The ongoing calm in the Valley has nothing authentic about it. It has been held in place with application of great force and is likely to come unstuck as the suppressed underlying factors of the situation resurface. And that can happen sooner than later.

The situation as it stands is thus as follows: The uncertain and interrupted schooling deprives Kashmiri youth proper education and skills. The lack of employment opportunities denies them a future. And the lingering conflict over the region frames worldview and determines their lives and choices.

If anything, this renders Kashmir of today structurally unfavourable to its children. And this scenario can only be expected to replicate itself endless ly unless there is a fundamental change, shift or alteration in the factors in play.

But together we can will it otherwise, by making an exception for the education across the ideological divide. We need an educated new generation not only to make informed choices about ourselves but also make a better sense of our situation and to articulate it for ourselves and the world.

An easy way to time it is by singing the entire happy birthday song twice while making sure to cover palms, backs of hands, fingers, in between fingers, wrists, and fingernails. The soap dissolves the fat membrane and the virus falls apart like a house of cards; dies or becomes inactive.

During the current global pandemic, proper handwashing will not only reduce the spread of Covid-19, but can also prevent the spread of viral illnesses such as cold. flu and other infections.

As we diligently wash hands to slow the spread of the Covid-19, unfortunately, the very soaps and even wringing of hands underwater will also break down the barrier we are trying to protect. Frequent hand washing can strip the natural protective oils in your skin and exacerbate dry skin issues. It can cause dry, cracked and raw skin that can irritate, flake, itch, crack, and even bleed without proper precautions and may also lead to conditions such as eczema. This can cause open wounds in your skin that can allow in bacteria and other germs; increasing your risk for infection through the fissures.

Luxury treatments for hands

Take four teaspoon almond oil and mix one tablespoon rose water. Add half-teaspoon tincture benzoin, drop by drop. Mix together. Apply this on the hands. Wear loose cotton socks on the hands and leave on the preparation all night. Rinse off with plain water next

Lemon juice and sugar, rubbed together with the hands also helps soften the skin. Take 2 tablespoons sunflower oil, 2 tablespoons lemon juice and 3 tablespoon coarse sugar. Mix together till it becomes a paste. Apply and rub into hands. Wash off after 15 minutes. Do this three times a week.

Take fresh orange peels and pierce them with a fork. Rub the peels on the hands to brighten them.

Choker (wheat bran) and besan (gram flour) can be mixed with turmeric and milk into a paste and applied on the hands. Wash off after 20 minutes. This softens, cleanses and tightens the skin.

Nail Health

Mix almond oil and honey in equal parts and massage into the nails and cuticles. For dry nails, warm any vegetable oil and soak fingers in it for ten minutes. Wipe off with a moist towel. One-teaspoon Brewer's yeast added to one glass of fresh fruit juice also keeps the nails and skin in good condition.

A few almonds eaten daily make the nails strong. Include whole grains, yogurt, leafy green vegetables, sprouts and fruits in your diet as well.

Night Time Routine

Before going to bed, apply thick moisturizer and then cover your hands with cotton gloves to increase absorption. Consider a humidifier at night as raising the humidity level in a room can help dry skin.

Other Precautions

Germs spread more easily from wet skin than from dry skin, so drying your hands completely is an important step. Paper towels or clean cloth are the most effective ways to remove germs without spreading them to other surfaces.

Cashless Transactions Or Financial Surveillance?

banknote has been sitting in my wallet for six months now. As time ticks on, it burns an ever greater hole in my pocket.

At first I felt uneasy spending it, fol-

lowing COVID-19 warnings to pay more attention to hand hygiene and the surfaces we all touch on a daily basis.

Now I have less and less opportunity to do so. While the World Health Organisation has never advised against using cash, more and more businesses are displaying signs that read "We Only Accept Contactless Payment" next to their registers.

A recent global poll conducted by MasterCard – a company with reason to favour card-based payments – found 82% of its users see contactless payments as cleaner than cash.

Online shopping is booming too. Amazon's value alone has risen by 570 billion US dollars this year.

But while electronic payment may reduce our exposure to germs, it also shows banks, vendors and payment platforms what we do with our money. Social media is awash with posts condemning the forced use of contactless payment for fear of overseers eyeballing spending. Some people are even boycotting stores that won't accept cash.

The growth of digital transactions exposes yet another aspect of our personal life to, what the social psychologist ShoshanaZuboff has called, "surveillance capitalism". Financial data is now a valuable raw material that can be bought, sold and refined in the name of profit.

The decline of cash

When the pandemic began, cash had already been on the decline for years.

For many people, increasing digitisation is synonymous with progress. It can be seen as a way of leaving the cumbersome, historical artefacts of coins and banknotes behind.

COVID-19 has accelerated this move away from cash. Wariness of

microbe-ridden banknotes has seen contactless payment become a spontaneous public health standard.

Because cash is a social material, it moves between us, connecting us both financially and physically. The US Federal Reserve even decided to quarantine dollars returning from Asia earlier this year in an attempt to stop the coronavirus crossing its borders.

Dropping digital breadcrumbs

One perk of paper money is that it does not leave paper trails. Digital

money, however, leaves traces in the databases of banks, vendors and platform owners, while governments look keenly over their shoulders.

Financial journalist Brett Scott calls this a "prison of watchable payments".

Tax officials love digital transactions because they make it easier to monitor the nation's economy. Banks and payment platforms are pleased as well: not only do they collect fees and gain the ability to allow or obstruct transactions, they can also profit from the troves of personal data piling up on their servers.

Internally, banks use this data to offer you other bespoke services such as loans and insurance. But information is also aggregated to better understand wider economic trends, and then sold on to third parties.

At the moment, these data metrics are anonymised but that doesn't guard against retailers using de-anonymising techniques to attach transactions back to your identity.

Data brokers exist for this very reason: building digital profiles and creating a marketplace for them. This allows re-

tailers to target you with tailored advertisements based on your spending. The devices at everyone's fingertips become a feedback loop of information in which companies analyse what people have bought and then urge them to buy more.

Can surveillance work on your behalf?

Having records of every transaction can also be useful for individuals. Companies such as Revolut and Monzo offer "spending analytics" services to help customers manage their money by tracking where it goes each month.

But information about a user's own behaviour never truly belongs to them. And, as the digital economist Nick Srnicek explains, "suppression of privacy is at the heart of the business model".

Digital payment with (some) privacy

While filling virtual baskets or paying by tapping a card does open up transactions for inspection, there are still ways you can protect your health and your data at the same time.

"Virtual cards" like those provided by privacy.com are one useful tool. These services let users create multiple card numbers for different online purchases that conceal consumption patterns from banks and credit card details from merchants.

Cryptocurrencies might also find a new limelight in the pandemic. Hailed as cash for the internet, the inbuilt privacy mechanisms of Bitcoin, Zcash and Monero could work to mask transactions.

However, finding companies that accept them is challenging, and their privacy capabilities are often overstated for everyday users. This is particularly true when using exchanges and third-party wallet software such as Coinbase.

In brick-and-mortar stores, staying under the radar can be more difficult. Prepaid cards are one option – but you'll need to buy the card itself with cash if you want to keep your anonymity fully intact. And that takes us back to square one.

Coronavirus cases to cross 30 million globally

Washington: The global tally for positive COVID-19 cases will soon cross 30 million, a Reuters report reads. The pandemic shows no signs of slowing down and India is emerging as its epicentre. Of the 30 million cases, 6.65 million are from the US, 4.42 million cases from Brazil, while more than 5.12 million cases are from India.

As per data, the global death toll will soon cross 1 million. According to the World Health Organisation, the coronavirus cases is more than five times the number of severe influenza cases recorded annually. COVID-19 death toll in the US is nearing 200,000. These numbers come 18 days after global COVID-19 infections surpassed 25 million globally.

In a report, Global Preparedness Monitoring Board (GPMB), an independent body created by the World Health Organisation and the World Bank, reveals how little the world had focused on preparing for a disaster of such a scale, despite several warnings that large disease outbreaks were

inevitable. "The COVID-19 pandemic is providing a harsh test of the world's preparedness," the report read. It added that the impact of the pandemic is worse than anticipated.

Though the US has 4 per cent of the world's population, it has about 20 per cent of global cases and Brazil has 15 per cent of global cases.

Health experts have said that actually positive cases and deaths might be higher than official data, as some countries have limited testing capacity. Even as the race to develop and roll out a vaccine for the coronavirus grows increasingly frantic, US President Donald Trump said his country could have a vaccine ready for distribution before the US election on November 3. A Chinese official in the meantime has also said that China could have a vaccine ready by November.

The Global Preparedness Monitoring Board has urged the UN, the WHO and international financial institutions like the World Bank to meet and discuss an international framework for emergency preparedness and response.

A Court Reprieve For Trump's H-1B Visa Ban, Challenged By 169 Indians

Washington: The Donald Trump administration's move in US to curtail H-1B visas widely used by foreign technology workers survived an initial court challenge.

US President Donald Trump's June 22 proclamation declaring foreign workers a risk to the US Lawyers for the plaintiffs didn't immediately respond to a request for comment. But they said in a court filing that they will appeal.

The president's visa order freezes through the end of the year new H-1B and H-4 visas, widely used by technology workers and their families, as well as L visas for intracompany transfers and



labor market amid the coronavirus pandemic triggered pushback from workers and business groups. An array of the nation's biggest tech companies have warned that the policy will do "irreparable harm on businesses and the nation's economy."

But in a ruling Wednesday, US District Judge Amit Mehta in Washington declined to bar the administration from imposing the visa restrictions while the legal challenge to them plays out.

The case was brought by a group of 169 Indian nationals who recently went back to India after living in the US on work visas and are now attempting to return. They argued that the proclamation was "arbitrary and capricious" and called for the government to process their visa applications.

most J visas for work - and study-abroad programs.

The ruling on Wednesday was the second time this month that Mr Mehta has denied a request to suspend the proclamation. Just as he did in a September 4 ruling in a related case involving a group of visa applicants, Mr Mehta found that the Indian workers fell short of the high legal threshold for an order blocking the decree while the litigation proceeds.

In both cases, the judge concluded the plaintiffs were not likely to succeed in showing that Trump exceeded his authority with the proclamation.

A different federal judge in Oakland, California, is weighing another request to block the decree from business groups including the US Chamber of Commerce.



Vaccine Nationalism: Rich Countries Have Already Bought Up Over 51% Of Vaccine Stocks

Washington: Rich nations representing a fraction of the global population have already bought up over half the promised Covid-19 vaccine stocks, a study showed, as US President Donald Trump pledged to begin inoculating Americans within weeks.

Big pharma is racing to produce an effective jab to counter a virus that has now killed more than 935,000 people around the world and infected almost 30 million.

European Union chief Ursula von der Leyen on Wednesday warned against "vaccine nationalism" that she said could put lives at risk by depriving the most vulnerable in poorer nations of immunity.

But a study released by Oxfam showed a group of wealthy countries representing just 13 percent of the world population has already secured the lion's share of doses.

"Access to a life-saving vaccine shouldn't depend on where you live or how much money you have," said Robert Silverman of Oxfam America.

"Covid-19 anywhere is Covid-19 everywhere." The five leading vaccine candidates currently in late-stage trials will be able to supply 5.9 billion doses, enough to inoculate about three billion people, the Oxfam report said.

Some 51 percent of those jabs have been snapped up by the wealthy world, including the United States, Britain, the European Union, Australia, Hong Kong and Macau, Japan, Switzerland and Israel.

The remaining 2.6 billion have been bought by or promised to developing countries including India, Bangladesh, China, Brazil, Indonesia and Mexico.

'Vaccine nationalism'

Trump on Wednesday said he would begin rolling out a vaccine in America as soon as next month, contradicting doubts expressed by a top health expert in his administration who said a jab was unlikely to be widely available until mid-2021.

"We're very close to that vaccine as you know... We think we can start sometime in October" or

shortly thereafter, Trump said.

Democrats have expressed concern that Trump is pressuring government health regulators and

scientists to approve a rushed vaccine in time to help his uphill bid for re-election in early November. "We're within weeks of get-

we're within weeks of getting it, you know - could be three weeks, four weeks," the president told a town hall session with voters in Pennsylvania Tuesday.

But in an implicit swipe at Trump's America First approach to the pandemic, von der Leyen said Europe would support multilateral bodies such as the World Health Organization with its attempts at a more equitable rollout.

"None of us will be safe until all of us are safe - wherever we live, whatever we have," she said. "Vaccine nationalism puts lives at risk. Vaccine cooperation saves them."

'Going hard and early'

The global economy has been devastated by the pandemic, with many nations still maintaining restrictions on their populations to contain fresh outbreaks.

New Zealand was added to the list of economic casualties on Thursday when it reported it had plunged into recession for the first time in a decade.

Guterres warns UN facing its '1945 moment'

United Nations; UN Secretary-General Antonio Guterres has warned that the world body was facing its own "1945 moment", noting that efforts must be made to "meet that moment".

"In this 75th anniversary year, we face our own 1945 moment. We must meet that moment," Xinhua news agency quoted Guterres as saying at a press conference at the UN headquarters in New York on Wednesday.

"We must show unity like never before to overcome today's emergency, get the world moving and working and prospering again, and uphold the vision of the Charter," he added.

The UN was established after World War II with the aim of preventing future wars, succeeding the ineffective League of Nations.

On April 25, 1945, 50 government representatives met in San Francisco for a conference and started drafting the UN Charter, which was adopted on June 25, 1945, and took effect the same year on October 24.

Pursuant to the Charter, the



organisation's objectives include maintaining international peace and security, protecting human rights, delivering humanitarian aid, promoting sustainable development and upholding international law.

At its founding, the UN had 51 member states. The membership now is 193, representing almost all of the world's sovereign states. IANS

London: A group of students in Britain have invented a way of capturing tyre dust -- a major contributor to air and water pollution -- as a car drives along, winning them this year's James Dyson Award in the UK.

Tiny particles of rubber from tyres are responsible for nearly half of road transport particulate emissions, according to the UK government, and they are the second largest source of microplastic pollutant in oceans after single-use plastic.

"Everyone focuses on air pollution being directly from the engines themselves and coming out of the exhaust pipe," Hugo Richardson, one of four members of The Tyre Collective, told Reuters in London.

"But what people don't necessarily recognise is that tyre wear is a huge contributor to that, and that's partly down to its microscopic size and the fact that you don't obviously see it all the time." The award-winning solution was to capture tyre particles at source by fitting a device that wraps closely around the edge of the tyre and using electrostatics and the aerodynamics of a spinning wheel to collect particles as they are emitted.

Richardson said the coronavirus lockdown, which reduced traffic significantly, had given people a glimpse of how clean a city's air could be.

"I think we all realise that clean air in our cities is not a pipedream any more, but something that is immediately achievable with some clever innovation and some impetus from those in charge." The students say their prototype can collect 60% of all airborne particles from tyres under a controlled environment on their test rig.

The benefits to public health could be profound.

"These (tyre) particles are actually small enough to be inhaled," said Siobhan Anderson, a member of the Innovation Design Engineering programme offered jointly by Imperial College London and the Royal College of Art.

"So they can cause different lung diseases and developmental issues and they also enter our water and eventually make their way through our food chain and come back to us." Each time a vehicle brakes, accelerates or turns a corner, the tyres wear and tiny particles become airborne, producing half a million tonnes of tyre particles annually in Europe alone, according to the International Journal of Environmental Research and Public Health.

Israel Preparing to Enter Yemen: Ansarallah

EIRUT: The leader of Yemen's Ansarallah Movement, Abdel-Malek Al-Houthi, said that Israel had begun preparing to establish a presence in his country with protection from the Arab coalition led by Saudi Arabia and the United States.

In a televised speech on Monday, Al-Houthi said, "Many facts are now largely clear, and the Saudi and Emirati role and the Al-Khalifa (the ruling family in Bahrain) in the aggression against Yemen has become clear in this general context, which is the implementation of the American and Israeli agenda."

He said: "Whenever they were able to control the southern governorates, the Americans began to be behind them, and they had a



base at Al-Rayyan Airport in Hadramout, and they became present in Sharurah and to some extent in Aden. Then the Israelis began to come from behind them, with their protection, their expenses and their efforts."

He said that the Arab coalition countries are conspiring against Yemen and fulfilling the U.S.' agenda.

Al-Houthi's accusations come on the eve of the signing of two agreements by the UAE and Bahrain, which are allies of Saudi Arabia in the "coalition to support legitimacy in Yemen," to normalize relations with Israel during a ceremony at the White House.

Asian Airlines Join Trend Of Scenic "Flights To Nowhere" Amid Pandemic

ydney: Qantas Airways Ltd said it would operate a seven-hour scenic flight over Australia next month, adding to a growing trend in Asia of "flights to nowhere" that take off and land at the same airport.

Tough border restrictions to keep the coronavirus under control have led to a 97.5% plunge in international travel in the region, according to the Association of Asia Pacific Airlines.

Many frequent flyers miss getting on planes and airlines including Taiwan's EVA Airways Corp and Japan's ANA Holdings Inc, desperate for revenue and to keep their pilots' licences current, have offered special sightseeing flights.

EVA used one of its iconic Hello Kitty livery planes for a special father's day flight last month, while ANA used an Airbus SE A380 that usually flies to Honolulu for a 90-minute flight with a Hawaiian experience on board. Tickets costing around \$228 for a Tigerair Taiwan flight from Taipei that will circle over South Korea's Jeju Island reportedly sold out in four minutes

The price includes a one-year voucher

for round-trip tickets from Taiwan to Korea, which can be used after COVID-19 travel bans are lifted.

Singapore Airlines Ltd is also considering scenic flights, but no decision has



been made, a spokesman said.

Qantas said it would use a Boeing Co 787 typically used for long-haul international flights for the flight from Sydney that will fly at low levels over Uluru, the Great Barrier Reef and Sydney Harbour before landing back in Sydney. Tickets will cost between A\$787 and A\$3,787 (\$575 and \$2,765) depending on the seating class.

Top US science magazine backs Joe Biden for President

ven though Scientific American had never endorsed a US presidential candidate in the magazine's 175-year history, its top editor has said there was little internal debate over a decision to back Democrat Joe Biden.

Editor-in-Chief Laura Helmuth said President Donald Trump's administration was much worse for the scientific community than the magazine had feared. The magazine's endorsement was posted online on Tuesday, a day after Trump questioned the science of climate change in relation to the California wildfires. Helmuth said the timing was coincidental and the editorial was written during the past two months.

Scientific American said that "the evidence and the science show that Donald Trump has basically damaged the United States and its people because he rejects evidence and science". The editorial by senior editor Josh Fischman sharply condemned Trump for his handling of the coronavirus pandemic.

Regulate Digital Media First, Sufficient Framework Exists On Print, Electronic Media: Centre To SC



NEW DELHI: The Centre has said that if the Supreme Court decides on the issue of media regulation, then such an exercise should be undertaken with the digital media first as it has faster reach and information has the potential to go viral due to applications namely WhatsApp, Twitter and Facebook.

The government told the Apex Court that sufficient framework and judicial pronouncements existed for the electronic and the print media.

"Considering the serious impact and the potential, it is desirable that if this court decides to undertake the exercise, it should first be undertaken with regard to digital media as there already exists sufficient framework and judicial pronouncements with regard to electronic media and print media," said the counter affidavit, filed by the Ministry of Information and Broadcasting.

"It is submitted that while in a mainstream media (whether electronic or print), the publication or telecast is a one-time act, the digital media has faster reach from a wider range of viewership or readership and has the potential to become viral because of several electronic applications like WhatsApp, Twitter and

Facebook," it said.

the top court is hearing a petition which has raised grievance over Sudarshan TV's 'Bindas Bol' programme whose promo had claimed that channel would show the 'big expose on conspiracy to infiltrate Muslims in government service'.

A bench headed by Justice DY Chandrachud had on September 15 restrained the channel from telecasting its episodes of a programme for two days, saying "the intent" of aired episodes "prima facie" appears to "vilify" the community.

In the 2020 Smart City Index, Hyderabad was placed at the 85th position (down from 67 in 2019), New Delhi at 86th rank (down from 68 in 2019), Mumbai was at 93rd place (in 2019 it was at 78) and Bengaluru at 95th (79 in 2019).

"Cities in India (New Delhi, Mumbai, Hyderabad, Bengaluru) suffer significant drops this year. This can be attributed to the detrimental effect that the pandemic has had where the technological advancement was not up to date," the report said.

It further added that "Indian cities have suffered more from the pandemic because they were not prepared".



The total coronavirus cases mounted to 51,18,253 while the death toll climbed to 83,198 with the virus claiming 1,132 lives in a span of 24 hours, the data updated at 8 am showed.

India Ranks 116 In World Bank's **Human Capital Index**

WASHINGTON: India has been ranked at the 116th position in the latest edition of the World Bank's annual Human Capital Index that benchmarks key components of human capital across countries.

However, India's score increased to 0.49 from 0.44 in 2018, as per the Human Capital Index report released by the World Bank on Wednesday.

The 2020 Human Capital Index update includes health and education data for 174 countries - covering 98 per cent of the world's population — up to March 2020, providing a pre-pandemic baseline on the health and education of children, with the biggest strides made in low-income

The analysis shows that pre-pandemic, most countries had made steady progress in building the human capital of children, with the biggest strides made in low-income countries

CBI Books 6 Firms For Installing Malware On People's Computers

NEW DELHI: A pop-up on your computer screen warning about technical problems could be a trap!

The CBI has busted a racket, booking six private firms that were allegedly installing a malware on people's computers in the name of providing anti-virus to protect them from bogus security issues flagged through pop-up messages.

The central agency has conducted searches at the premises of these accused companies—New based Softwill Infotech Private Limited and Saburi TLC Worldwide Services Private Limited, Jaipur-based Innovana Thinklabs Limited and Systweak Software Private Limited, Noida-based Benovellient Technologies Private Limited and Noida and Gurugram-based Saburi Global Services Private Limited.

The agency has carried out searches at the premises of the companies at 10 locations in Jaipur, Delhi, Noida, Gurugram, Faridabad and Mainpuri.

The companies allegedly sent pop-up messages on personal computers of users, giving bogus warnings about purported security issues



the Microsoft Windows Sys tem, officials said.

The pop-up messages carried the phone number of a call centre, where the employees of the companies allegedly advised the victims to install certain anti-malwares or anti-virus, which are essentially PUPs (Potentially Unwanted Programmes), they said.

'The victims are allegedly given the option to activate the PUPs by paying a fee on-line or by calling a support number advertised in the interface of the programme. The victims are fraudulently influenced in this manner and allegedly fall in their trap to maintain their systems properly," CBI Spokesperson RK Gaur said.

The customer care allegedly posed as the support system call centre and asked people to make payments through an online link to resolve the non-existent proband presence of malware in lems, the officials said. – PTI

5 Chinese Nationals Charged In Mega Hacking Scheme, Indian Govt **Networks Hit: US**

WASHINGTON: The US Justice Department has charged five Chinese citizens with hacking over a 100 companies and institutions in America and abroad, including the Indian government's networks, and stealing valuable software data and business intelligence.

Attorney Deputy General Jeffrey Rosen on Wednesday announced three indictments have been unsealed in the matter that collectively charges five Chinese nationals with computer hacking and charge two Malaysian nationals for helping some of those hackers target victims and sell the fruits of their crime.

The Malaysian nationals also targeted. were arrested on Sunday and the Chinese nationals have been declared fugitive, according to a Justice Department statement.

Rosen severely criticised the Chinese government.

"The Department of Justice has used every tool available to disrupt the illegal computer intrusions and cyberattacks by these Chinese citizens. Regrettably, the Chinese Communist Party has chosen a different path - of making China safe for cyber-criminals so long as they attack computers outside China and steal intellectual property helpful to China," the deputy attorney general said.

"In about 2019, the conspirators compromised Government of India websites, as well as virtual private networks and database servers supporting the Government of India. The conspirators used VPS PROVIDER serv-

ers to connect to an Open VPN network owned by the Government of India," the indictment said. In the attacks, the conspira-

tors installed 'Cobalt Strike' malware on Indian governmentprotected computers, it added. According to the charges,

the computer intrusions affected over 100 companies in the United States and abroad.

The victims ranged from software development, computer hardware, telecommunication, social media and video game companies. Non-profit organisations. universities, think-tanks, foreign governments, prodemocracy politicians and activists in Hong Kong were

Security rese tracked the intrusions using labels "APT41," "Barium," "Winnti," "Wicked Panda," and "Wicked Spider." These intrusions facilitated the theft of source code, software code signing certificates, customer account data, and valuable business information, the researchers said.

These intrusions also facilitated the defendants' other criminal schemes, including ransomware and "crypto-jacking" schemes, the latter refers to the group's unauthorised use of victim computers to mine cryptocurrency.

The Chinese hackers also targeted government computers and networks of Vietnam and the United Kingdom. The hackers, however, were not successful in compromising the government computer networks in the United Kingdom.

The petitioner, Saurabh Sharma, has claimed in his




while driving to work he was stopped by Delhi Police officials and was challaned for not wearing mask even though he was alone in the car.

Assam Government Asked To Pay 1 Lakh To Man Beaten Up For Selling Beef

GUWAHATI: The National Human Rights Commission (NHRC) has ordered the Assam government to pay 1 lakh to a person, who was beaten up by a mob for selling cooked beef at his tea stall in the Biswanath district.

The commission also took a serious note of the fact that neither the Chief Secretary replied to a show-cause notice nor the Director-General of Police submitted the action taken report against the guilty police officials in the case.

Shaukat Ali (48) was thrashed by a mob and forced to eat cooked pork in front of a few policemen for selling beef at his tea stall at the Madhupur weekly market in Biswanath Chariali on April 7 last year. A



contractor of the market was also allegedly beaten up for allowing Ali to run the shop.

Consumption of beef is legal in Assam and the Assam Cattle Preservation Act, 1950 permits the slaughter of cattle above 14 years of age with proper certificate only by a veterinary officer of the area.

Considering the matter on September 9 over a complaint by Leader of the Opposition Debabrata Saikia, the rights to the Commission within six body warned the DGP of initiating action against him if the report is not sent within four

weeks, as per an NHRC letter to the police chief.

"The Commission has not received reply or any response to show cause notice from the concerned authority which led Commission to observe that the concerned authority has nothing to urge upon the Commission with regard to the show cause notice.

"Therefore, the Commission confirms its recommendation and directs to the Chief Secretary, Government of Assam to release amounting to 1,00,000 to the victim Shaukat Ali and submit a report along with proof of payment weeks," a letter to the chief secretary from NHRC assistant registrar (law) said.

5-Foot Python Found In Backseat Of Auto Rickshaw In Delhi

NEW DELHI: A five-foot-long Indian Rock python slithered into the backseat of an autorickshaw in Tughlakabad area on Wednesday, triggering panic among people.

The incident happened in the morning when the auto was parked on the roadside and there was no one inside it, said an official of Wildlife SOS, which caters to animal-related distress calls.

The driver noticed the snake curled up under the CNG kit of his auto rickshaw and frantically dialed the helpline number of the wildlife NGO.

A two-member rescuer team rushed to the location with necessary rescue equipment in hand. The rescuers dismantled the metal frame around the cylinder to get easy



access to the distressed snake. An hour later, the python was safely transferred into a transportation carrier and released into its natural habitat, the official said.

Kartick Satyanarayan, Cofounder and CEO of Wildlife SOS, said, "Handling snakes can be quite challenging but our team is trained to carry out such sensitive operations. This python is a great example of the difficult situations that reptiles in urban settings often find themselves in."
