NEW DELHI: India on Monday pressed for an early and complete disengagement of Chinese troops from friction points in eastern Ladakh as their senior army commanders held a sixth round of talks that primarily focused on implementing a five-point bilateral agreement to ease the prolonged border standoff, government sources said.

The latest round of Corps commander-level talks that began at around 9 am in Moldo on the Chinese side of the Line of Actual Control (LAC) across India''s Chushul sector in eastern Ladakh went on for over 12 hours and was still underway at 9 pm, the sources said.

It is learnt that the Indian delegation insisted on a timebound implementation of the agreement finalised during the extensive talks between External Affairs Minister S Jaishankar and his Chinese counterpart Wang Yi in Moscow on September 10 on the sidelines of a Shanghai Cooperation Organisation(SCO) meet. SRINAGAR: An army man was injured Monday in an ongoing gunfight between state forces and militants in Chrar-e- Sharif area of Central Kashmir's Budgam district, prompting authorities to snap internet services in the district.

According to the officials, army's 53 RR, special operations group (SOG) of police and CRPF181 Batallion launched a cordon and search operation in Nowhar of Chrar-e-Sharif after receiving inputs about the presence of militants in the village.

As the joint team started advances, the militants hiding in the village opened fire upon them in a bid to break the cordon. In the initial exchange of fire, the official said a soldier was injured. Centre Tells Apex Court

'Print Media Rarely Crosses Line, Digital Media Uncontrolled'

NEW DELHI: The print and electronic media rarely cross the line by the very nature of their composition but the digital media is completely uncontrolled and remains unregulated by and large, the Centre has told the Supreme Court.

The government said if the apex court considers it necessary to lay down guidelines for mainstream electronic and print media, it is the need of the hour that the exercise should start first with web based digital media.

Militancy Incidents Down By Half After Art 370 **Revocation: Govt**

NEW DELHI: There has been a drastic decline in terrorist incidents in Jammu & Kashmir after the abrogation of Article 370 from the erstwhile state on August 5 last year, the Ministry of Home Affairs informed Parliament on Monday comparing the last two years' data.

The terrorist incidents from July 7, 2018 to August 4, 2019 (in 393 days) were 443 while the number from August 5, 2019 to August 31, 2020 (393 days) reduced to 206. Similarly, the number of stone pelting cases reduced from 703 to 310.

A total of 54 civilians were killed from July 7, 2018 to August 4, 2019

while the number went down to 45 from August 5, 2019 to August 31. 2020. Minister of State for Home G Kishan Reddy informed the Rajya Sabha in a written reply.

As per the data shared by the minister, a total of 125 security personnel were killed in the 393 days before August 5 while the number reduced to 49 - almost one-third - during the same number of days after August 5.

The government on August 5. last year scrapped Article 370 from Jammu & Kashmir which gave it special status and later bifurcated it into two Union Territories – Jammu & Kashmir with an Assembly and Ladakh without one. **PAGE 02**

China on the border row under the framework of the Working Mechanism for Consultation and Coordination (WMCC) on border affairs, was part of the delegation.

The team also comprised Lt Gen PGK Menon, who is expected to succeed Singh as the commander of the 14 Corps next month, the sources said.

The sources said the Indian team insisted on an early and complete disengagement of troops by Chinese People''s Liberation Army(PLA) to end the four-and-a-half-month standoff, adding the agenda for the talks was to chart a specific timeline for implementation of the fivepoint agreement.

The agreement aimed at ending the tense standoff included measures like quick disengagement of troops, avoiding action that could escalate tensions, adherence to all agreements and protocols on border management and steps to restore peace along the LAC.

At the previous five rounds of Corps commander-level talks, the Indian side has insisted on complete disengagement of Chinese troops at the earliest, and immediate restoration of status quo ante in all areas of eastern Ladakh prior to April. The face-off had begun on May 5. The fifth round of Corps commander talks on August 2 lasted for nearly 11 hours while the fourth round went on for nearly 15 hours on July 14.

Military sources, meanwhile, said the newly-inducted Rafale jets started carrying out sorties in various forward areas in eastern Ladakh as part of measures to give a boost to the overall combat readiness in view of the "provocative actions" by Chinese troops in the last three weeks.

The deployment of French-made Rafale jets in Ladakh came less than 10 days after they were formally inducted into the Indian Air Force(IAF).

At a ceremony in Ambala on September 10 where five Rafale jets were inducted into the IAF, Defence Minister Rajnath Singh said this was crucial considering the atmosphere being created along the frontier and was also a "big and stern" message to those eyeing India"s sovereignty.

The sources said the Indian Army has made elaborate arrangements to maintain the current level of troop and weapons deployment in all forward areas in eastern Ladakh and other sensitive high-altitude sectors in the harsh winter months when the temperature drops up to minus 25 degree Celsius.

They said the situation remained tense at both the southern and northern bank of the Pangong lake area as well as in other friction points.

There have been at least three attempts by the soldiers of the PLA to "intimidate" Indian troops along the northern and southern bank of Pangong lake area in the last three weeks where even shots were fired in the air for the first time at the LAC in 45 years.

The situation in eastern Ladakh deteriorated after China unsuccessfully attempted to occupy Indian territory in the southern bank of Pangong Lake on the intervening night of August 29 and 30.

On September 7, the Chinese troops again made an unsuccessful bid to close in on the Indian position and even fired shots in the air in the Mukhpari area of Rezang-La ridgeline on the southern bank of Pangong lake.

As Jaishankar and Wang were set to hold talks in Moscow, Chinese soldiers fired a barrage of "warning shots" in the air on the North Bank of Pangong lake to "intimidate" the Indian troops, Indian Army sources had said.

India occupied a number of strategic heights on the southern bank of Pangong lake and strengthened its presence in Finger 2 and Finger 3 areas in the region to thwart any Chinese actions. China has been occupying the areas between Finger 4 and Finger 8.

I could feel something was wrong. As I started walking inside the corridor, my heart beat faster," he wrote in a first person account.

Auqib said when he was waiting outside the SP"s office as the cop accompanying him had gone inside, someone approached him from behind and slapped him.

"I heard the sounds of boots approaching, and as I turned to see who it was, a masked policeman slapped me hard on my left cheek. He did sound like a local. "Kis liye aaya hai tu (why have you come?)," he demanded. Once I recovered from the shock of the slap, I said, "SP saab has called me". He slapped me hard again and left," Augib alleged.

"It was the first time I had ever been hit. As I stood there in a fog of shock, I somehow and vaguely rationalized this assault as the cost of doing journalism in Kashmir. I was not the first to be intimidated," Augib wrote.

Augib said he wanted to know under what law he was summoned by the SP of Cyber Police and verbally abused and slapped by the cops. He was then sent to the SP, Incharge of the police's cyber cell, Tahir Ashraf Bhatti's room. Augib writes that the SP questioned him about "how could he write that cyber police are bullying people".

According to the journalist, Bhatti demanded to know why he had used a picture of the Cargo center, when it was not the cyber police station, and why he had written a "concocted" story.

"He started abusing my mother and sister and kept up the shouting," Augib has written. Augib said he told the SP that the story was based on facts but the picture and headline were written by the editors at Article-14.

"No, this is a fake and baseless story," the SP said, according to Auqib. However, Cyber Police refuted all these charges.

In a press statement regarding the incident, the cyber police said, "the allegation of excesses by Police officials/officer published subsequently by Article-14 and other social media handles are misleading and factually incorrect, hence refuted."

"Javeed has committed a mistake of using the wrong picture and when Cyber Police conveyed this to him, he called his editor and removed the picture from the story," the press release added.

But response poured on Twitter in support of the journalist from various politicians and journalists.

Assault on Journalist Draws Instant Response

Peoples Conference chief, Sajjad Lone, called the act as "pure savagery" which is aimed at humiliation.

Iltija Mufti, daughter of former Chief Minister Mehbooba Mufti, also tweeted from her mother's account in support of Auqib.

Human Rights activist Khurram Parvez tweeted about it saying that it is a "very serious allegation".

Journalist Athar Parvaiz also came forward in support of Javeed and tweeted that questions asked by him should be answered

Journalist Ahmer Khan described Javeed's experience as a "harrowing experience".

Akash Banerjee who runs a Political & Social Satire platform, Desh-Bhakt, tweeted, "The Kashmir Cyber police says this article is 'misleading'.... One certainly hopes so, otherwise, this is a wake-up call on how dissent on social media will be closely monitored for all in the near future.'

It reiterated that regulation of electronic and print media is substantially occupied by either legislative field or judicial pronouncements. By and large the dividing line - what is freedom of expression and what is not - is also capable of being culled out through various judicial pronouncements. The term hate speech' by its very nature is incapable of being precisely defined except by considering each case depending upon the facts arising therefrom, it said.

It said the court may not widen the scope of the plea by laving down any wider guidelines of general application and may leave the same to the competent legislature to provide the same.

It is also relevant to note that in case of electronic and print media, the security of the nation is also taken care of at the time of the registration and/or grant of license to the company or the organization intending to publish or broadcast either newspaper or a news-channel, it said.

It said that India has about 385 regular news channels which are registered or licensed by the central government under the Uplinking and Downlinking Policy Guidelines.

It said that News Broadcasters Association (NBA) is not the sole association having all broadcasters as its members and as is a non-statutory voluntary body, its membership is also voluntary.

It said another similar association News Broadcasters Federation (NBF) is also a voluntary organisation having several broadcasters including regional channels as its members.

Both these two associations have their own self-regulatory mechanism which is not only robust but can inspire confidence as both such self-regulatory mechanism are headed by a former judge of this court, it said.

It said self-regulatory mechanism for redressal of complaints in case of all the aforesaid organisations are, by and large, effective and ensures impartiality.

It said membership of such organisations does require examination as no broadcaster can be compelled to become a member of any of the voluntary organisations compulsorily.

This question is under examination of the central government as regards the manner and procedure to ensure one statutory umbrella mechanism redressal of grievances while completely ensuring journalistic freedom.., it said.

"An opportunity of being heard is the 'sine-qua-non' of every order/ decision involving disengagement of the services of Government servants, besides, reasons justifying so, while issuing the order, have to be spelt out in detail," the court said. However, in the case on hand, the court said that the principles of natural justice appear to have been violated with impunity. "The defence of the petitioners has been scuttled/ shut by deception and the procedure governing the subject has been given a complete go by."

The courtunderlined that justice was not only law and its administration, but is, in most cases, above law and is done to safeguard an individual from whatever he or she seeks protection. "Our country aims at the goal of achieving a welfare State where everyone is/ has to be, as far as possible, looked after. The principles of natural justice are imbibed from the Constitution itself," the court said.

The reason for disengaging the petitioners, the court said was that the Corporation was of the view that their services are no longer required. "The rules relating to reasonableness, good faith, justice, equity and good conscience, which are a part of law and relate to administration of justice and fairness, have been followed in breach and, resultantly, it has caused miscarriage of justice," the court said.

The services of the petitioners were regularized with the approval of the Chairman of the Corporation after passing of the 'performance' test' on their part, the court said. "The corporation, all of a sudden, could not have unilaterally issued the disengagement orders of the petitioners solely on the ground that the services of the petitioners are no longer required," the court said and underlined that corporation was obliged under law to give adequate time to the petitioners for seeking their response before disengaging them.

"Given the above circumstances, both these petitions are allowed and, by a 'Writ of Certiorari', the impugned orders, viz., SFC Order No. 62 of 2012 dated 24th of February, 2012 and SFC Order No. 63 of 2012 dated 24th of February, 2012 are guashed," the court said and directed the Corporation to allow the petitioners to continue discharging their services. (GNS)

Army To Use Double-Humped ...

(DRDO) in Leh has conducted research on the double hump or Bactrian camels which can carry load of 170 kilograms at an elevation of 17,000 feet height in the Eastern Ladakh region.

Speaking to ANI, DRDO scientist Prabhu Prasad Sarangi said, "We have been doing research on double hump camels. They are local animals. We have researched on endurance and load-carrying capacity of these camels. We have conducted research in Eastern Ladakh area at 17,000 ft height near the China border and found they can carry a load of 170 kg and with this load they can patrol for 12 kms."

These local double hump camels were also compared to single hump camels which were brought in from Rajasthan to test them for endurance. These camels can survive on food and water scarcity for three davs.

Now the Defence Institute of High Altitude Research (DIHAR) is focusing on increasing the population of these double hump camels. "Trial has been conducted and these camels will soon be inducted into the Army. These animals have less population but after proper breeding once we reach the numbers then they will be inducted," Sarangi added.

Indian Army traditionally uses in the region mules and ponies which have the capacity to carry around 40 kgs of load.

nothing is required for accessing digital media except a smart phone. This shows its potential spread and its potential to harm the very fabric of any nation. The electronic media would normally have a geographical barrier and would rarely have a global presence. The digital media, on the other hand, has global presence both in terms of content coming from out of India and the content going out from within the country, it said.

As against this, there is absolutely no check on the web based digital media. Apart from spreading venomous hatred, deliberate and intended instigation to not only cause violence but even terrorism it is also capable of indulging in tarnishing the image of individuals and institutions. The said practice is, in fact, rampant, the affidavit said. It said any further regulation of electronic and print media by the court, either by way of guidelines or providing for any redressal mechanism, would incentivise broadcasters to use electronic media

Here in Srinagar, very few students were seen at a number of High and Higher Secondary Schools (HSS).

At Nawakadal in the down town there was hardly any student though teaching staff were present.

However, the situation in Kothi Bagh Girls HSS was a little different as students, some of them in uniforms, could be seen in the schools wearing masks. "We have kept masks so that any student who is not wearing masks could be provided", principal of the school said.

Similar reports were received from other parts of the Kashmir valley, where parents questioned the necessity for filing undertaking that school was not responsible if their children got infected. Why the school management and government cannot take responsibility, the parents asked.

Dr Samoon said "schools reopening Monday not for regular classes but consultation" by volunteer secondary students on consent of parents with 50 per cent teachers on roster as per MHA lockdown 4 guidelines and Minister of Health and Family Welfare protocols conveyed by chief secretary and circulated to Deputy Commissioners (DCs) Directors and Chief Education Officers (CEOs).

In reply to a question by a parent that there is no santization and no bothroom facilities in government schools, Dr Samoon said all Deputy Commissioners have been directed to monitor the functioning of schools.

Another parent to a question as a father, my child's security is my primary concern and sending her to school could increase the risk of her catching COVID-19. The present pandemic situation and spike in Covid19 cases in Srinagar is a matter of enormous concern. You should reconsider your decision.

Dr Samoon said please keep her home. "Young kids not to attend schools, he said adding unlock 4 decision is collective and at apex level. He further said anyways only secondary school children can attend only with parents' consent.

"More than Students, Teachers are much more worried as they are compelled to Join Schools . Everybody is aware about unLock 4 Guideline . But I believe it's prerogative of Government to take decision and Union Territory (UT) government should be more sensitive towards their students & Teachers", asked another parent.

However, Dr Samoon said no student is compelled; no regular classes, no compulsory attendance; senior students can volunteer to meet their teachers for guidance with parents' consent with face masks, keeping safe distances & to observe all covid protocols.

Dr Samoon said there is no proposal yet to reopen Middle schools. Schools remained closed from March though private schools were providing online classes to students, including minors, in the valley. The private schools charged full tuition fees from students. Online facility was not available for students of government schools who are from lower and lower middle class families (UNI).

Militancy Incidents Down... After August 5, last year, the minister's reply mentioned, the number

of terrorist incidents, stone pelting cases registered, civilians killed and security force personnel martyred in terrorist incidents in J&K reduced significantly because of the government's zero-tolerance policy towards terrorism.

The government took various measures such as strengthening of security apparatus, strict enforcement of law against anti-national elements, intensified cordon and search operations to effectively deal with the challenges posed by terrorist organisations.

While keeping a close watch on persons who attempt to provide sup-

cases in the country have surpassed Brazil and now stands second to

USA in spite of the stringent lockdown in the world. "The lock down which was put in place at three hours notice forced millions into hunger and poverty, but failed to control the sprawl of the new infections. The crises induced by COVID-19 unleashed a dramatic economic collapse and humanitarian catastrophe in India, the most destructive being the trajectory of the disease due to the ill-conceived decisions and mismanagement of the situation by the incumbent government," he said.

"COVID-19 knocked the door of the country in early february this year. Unfortunately the government retort to the disease was nonchalant and slothful. No attention was paid to the augmentation of medical equipment and hospital infrastructure. On the contrary the government invested into the program like Namaste Trump and similar other insignificant programmes, turning volt face to the emerging storm," he added.

Drawing attention of the government towards the dearth of facilities and infrastructure in I&k. Masoodi said. "As far as I&K is concerned the region has already been under a stringent clampdown and curfew post unconstitutional abrogation of Articles 370, 35-A. The subsequent COVID-19 induced lock down compounded the miseries of the people. Our laborers were stuck across north Indian states. Many of them got infected due to the slack attitude of the government. On their arrival they were kept in primary schools and PanchayatGhar which lacked basic facilities."

"The frontline staff, and numerous health workers including doctors, nurses have been working day in, day out notwithstanding the deficiency of necessary life saving gear. The local administration had also failed to give a bump to the required infrastructure at the very onset. On my behalf I released Rs 1.50 Cr from my MPLAD Funds in Anantnag constituency to enable the local administration to increase their efforts to combat the crises effectively. However the dearth of ventilators, ambulances is still felt in every district of J&K. So far nealy 14 lakh tests have been done, but the process needs to be amplified. The local frontline workers are still devoid of necessary masks and other live saving kits including PPE, masks etc," he said.

He urged the government to ensure necessary economic support to the J & K administration to address the exigencies that have arisen in wake of humanity's biggest ever public health crises. He also expressed dismay over the continuous gags on 4G internet connectivity in the state saying the measure has affected lakhs of our students and medical staff to work effectively during the ongoing COVID-19 induced crises. He impressed upon the GOI to restore full speed internet connectivity in the region.

On the recently announced economic revival package for J&K, Masoodi said the compensation announced was just 10% of the total losses suffered by J&K. "Every single sector of J&K is bleeding ranging from Horticulture to Manufacturing. The businesses are not able to pay their over dues to different banks. Many units are on the verge of bankruptcy, if the situation continues, it won't take time for the local business to turn into NPAs. The recompense which is being given out is too less to pay off the losses incurred by J&K economy," he added.

'India faces pressure to solve Kashmir'

ISLAMABAD: The International pressure is increasing on India to resolve its explosive Kashmir dispute with Pakistan, military ruler General Pervez Musharraf said Tuesday.

"As a result of concerted efforts of Pakistan, the international pressure is growing on India to settle this issue," reports quoted him as saying.

Musharraf, who was speaking to reporters at Gilgit in northern Pakistan, accused India of heightening tension along the line of Control (LoC), the unofficial border in Kashmir, which is divided between the two countries.

On Monday, the two sides reported a clash on the LoC, where skirmishes and duels occur routinely.

The military here said Indian troops attacked a Pakistani forward post in the Lipa region of Kashmir, adding that- the attack was repelled and three Indian troops were killed and more than 10 wounded.

India's army said it fired on the Pakistani border outpost because of "menacing H movements," and killed six Pakistani soldiers. It denied Indian troops had crossed the LoC. Musharraf blamed Indians for frequent firing on villages close to the dividing line on the Pakistani side of the disputed Himalayan territory. He promised government assistance to the people affected by Indian firing.

entre has once again defended the internet restrictions in Kashmir arguing such curbs are in the interest of sovereignty and integrity of India. At the same time, the union government has said that the throttled speeds are enough for digital education and public health services. Speaking in parliament, the minister of state for home GK Reddy said that the high-speed internet was already available in Kashmir on fixed line. He also informed the parliament about lifting of social media restrictions from March onwards.

If anything this shows that the government is in no mood to restore the high speed mobile internet anytime soon. And it doesn't think that the 2G speed hampers the access to online classes. According to Reddy, "E-learning apps and education and e-learning websites of the government are accessible over 2G internet for downloading e-books and other study material". Similarly for the minister "the 2G mobile internet speed is not an impediment in Covid control measures including dissemination of information to general public as well as health workers".

But ask the teachers and pupils in J&K, they would hardly agree with the union government on this. Truth is, it is certainly not feasible to study online with 2G speed. For one, it is challenging to attend the video classes which are a critical component of online education. Such classes enable a direct interaction of the students with their teachers and allows them to ask questions and seek clarifications. On 2G speed, the schools can send only a textual study material to students through mail. And that is as good as studying text books at home.

It is thus important that the government restores the high speed mobile internet. It is the best solution to lack of physical schooling. Use of communication technology would thus obviate the need for a hurried reopening of schools. But while the government is refusing to restore the high-speed internet, it is taking steps to reopen schools, a fraught decision under the circumstances.

As for the public health, the need for a high-speed mobile internet cannot be overemphasised. In this day and age, when people get most of their information on internet, government could have used 4G to deepen awareness about COVID-19, the disease caused by coronavirus. Information about the disease and its real-time dissemination among people is critical to fighting it. It empowers the people to take precautions and preventive measures on their own. But the government, it seems, doesn't want it. Its approach, as always, remains security centric when the need of the hour is prioritize healthcare and facilitate the online education of our children.

Economy Central Business Subsistence Package Relevance, Adequacy and Impact

oon after the first phase the unprecedented lockdown,vis-à-vis article 370 abrogation was eased in the month of Dec 2019;the Kashmir Chamberof Commerce and Industry (KCCI) started running from pillar to post highlighting the piling up losses on account of irreversible damage sustainedby the businesses across the Kashmir economy. From meeting Lieutenant Governor of the newly crafted Union Territorvin Raj Bhawanto seeking an audience with the Union Finance and Home minister in the North Block, their desperation for survival forced them to leave no stone unturned. Despite consistent and strenuous efforts, there was no tangible response from either the UT or the Union Government for over a year.

However, soon after the appointment of the new LG Mr. Manoj Sinha, things started moving at an accelerated pace. Within only 12 days of his appointment, a high level committee was framed which eventually doled out an economic revival package of Rs. 1353 crore within a short period of only 30 days.

The two aspects, therefore, which deserve to be acknowledged before embarking on the relevance, adequacy and impact of the packageis the consistency and grit demonstrated by the KCCI and the swift and forthcoming attitude showcased by the new LG.

There is no denying the fact that the size of the loss incurred by J&K in last 13 months i.e. approximately Rs. 41,000 Crore and the meager volume of the financial response i.e. Rs. 1353 Crore, is beyond comparison. To put things into perspective, J&K's GSDP as per conservative estimates contracted by over 25% in the last 13 months.Compare this colossal contraction to the microscopic relief package, which is just 0.74% of the UT's GSDP.

J&K is not the only UT/State which has announced a state level economic revival package in order to fight Covid-19 lockdown induced economic slump. For example, compareJ&K's relief package with a mammoth business revival package of Rs. 20,000 Crore announced by the state of Kerala, which is around 2.28% of its GSDP. The state of Gujarat tooannounced a substantial Rs. 14,000 Crore Covid19 economic revival packge, which is around 0.90 % of its GSDP. Contrary to other states of India, the fact that J&K has not been incurring losses on account of Covid-19 lockdown alone but also because of the lethal August 2019 shock, makes our paltry fiscal response even more insignificant. Moreover, the package has been conveniently built around bank loans, ignoring the vast drivers of economy which operate outside the system of bank credit. A major portion of the J&K economy is informal in nature, for which procedural barriers and hassles erected by the banking system act as disincentives for lower strata of businesses in choosing formal credit and banking channels. Almost 80% of the package i.e. Rs. 1089 Crore is aimed at easing the burden of bank interest for the indebted businesses. A part of it i.e. Rs.139.24 Crore is a part of the pendency on account of restructured loan accounts of 2014 floods and 2016 unrest. As per Centre for Monitoring Indian Economy (CMIE). J&K's workforce hovers

around 43 Lakh. And as per Reserve Bank of India, there are a total of around 18 lakh borrowers in J&K, of which approximately 42% have exposure towards personal loan products. The remaining 58%, therefore, comprise approx. 10.5 Lakh business loan borrowers. In other words, 80% of the package announced, shall benefit only 24% of the 43 lakh income generators in the economy, leaving a whopping 76% outside the purview of the interest subvention scheme. Factor to it the fact that the ineligibility of Kisan Credit Card borrowers, Artisan Credit card borrowers and the eligibility riders of being standard on July 2019 and March

jecting allocation of Rs.15 crore for bio-digesters as a business revival incentive is absolutely misplaced. It is more of Government's obligation towards ecology rather than a fiscal support to the houseboat owner. Likewise, the insurance premium support announced as a part of the package for transports is a decision in the right direction. It would have been even better if the upper caps would have been raised more magnanimously.

Transporters were expecting relaxation in various taxes like the passenger tax, road tax, GST on insurance and waiver of transport loan EMIs for the last 12 months.None of their expecta-



2020. the net eligible borrowers who shall be able to benefit under the interest subvention scheme is going to shrink even further.

Although the Govt for the first time has acknowledged the chronically turbulent nature of the economic environment within which the businesses in valley operate, however, when it comes to the calculations- there has been a clear mismatch in deeds and words. The calculation of 5% interest subvention, which constitutes over 70% of the package, has been carefully decoupled from the Aug 5, 2019 political shock and the base assumption on which almost the entire response has been crafted, recognizes Covid19 lockdown from April 2020 as the starting point.

This has been a serious letdown. In addition to the above mentioned points, the sectoral hierarchy of the economic drivers of J&K have been totally ignored and the response has been left to the existing credit exposure distribution patterns of the banking system. The amount of incentive received by respective sectors, therefore, shall be governed by the credit portfolios of banks. By nature of the capital intensive business models in manufacturing and construction, the flow of the package will be skewed accordingly. This might end up leaving comparatively less credit dependant sub sectors of service sectors like hospitality, tourism, trade and social sectors like education and healthcare in lurch. This broad brush approach can be fatal given the fact that Agriculture, Horticulture, Hospitality and Tourism occupy the central axis around which rest of the economy operates in J&K.A sector specific relief measure would have been more effective in optimizing the limited resources available with the fiscally challenged Government coffers. The incentives of waiving of the water charges is a welcome decision, however, electricity charges waiver have been too miserly designed. This has resulted in more heartburn than relief. Pro-

tions were misplaced given the amount of business this sector has lost in the last 13 months and the amount of damage it has done to all the families associated with it. A remuneration of Rs. 1000 for 6 months, therefore, for these drivers and cleaners associated with buses, mini buses, cabs and autos need to be revisited, both in terms of amount as well as duration.

Other allocations in terms of Rs.1000 monthly income support towards 3100 artists and 19914 workers in the tourism sector deserve an applause, however, here also the duration as well as amount deserve to be revisited. These economically vulnerable sections of the society are the basic elements of demand in the system. Handing over cash directly to them makes not only social but also a lot of economic sense

The business revival package was a much needed injection of confidence for the rotting economy of J&K. Despite being insufficient in size and not being holistic in direction, the fact that the administration on records has stated that there is more to follow, should give stakeholders even stronger reasons to pursue the demands. Administration at the same time needs to widen its horizon and include more effective response tools like tax rebates, small loan waivers, operational expenses support and above all connectivity, logistical and marketing support to the limping businesses. On IPL 2020

he glitzy high of the cricketing season, with its daily share of short bursts of thrills stretched across the summer. Since its launch in 2008, the IPL became a seasonal fix as inevitable as soaring temperatures and the reflexive craving for ice creams. The Twenty20 tournament seemingly brooked no resistance while the purists leant on the classical air that permeated Test cricket. Even in 2009 and 2014, when the Lok Sabha elections clashed with the IPL's schedule, the Board of Control for Cricket in India solved the logistical nightmare.

But 2020 has been a difficult year for humankind with the relentless spread of the coronavirus pandemic. Saturday night's inaugural contest of the IPL's 13th edition at Abu Dhabi's Sheikh Zayed Stadium, that pitted defending champion Mumbai Indians and last year's runner-up Chennai Super Kings, dished out a last-over climax with the latter stunning the former.

The lay-off from the game and the attendant rust was evident in the way the rivals fielded while the artificial crowd sound infused into the live telecast, reflects these fraught times of empty stadiums and bio-bubbles. Because of the constraints imposed by the virus and the cancellation of domestic cricket in India for now, the IPL at the Emirates, has turned out to be the season opener for the national players while also offering an opportunity for overseas stars to have a biff in the park. Eight teams playing 60 matches in 53 days across Abu Dhabi, Dubai and Sharjah, with a summit clash on November 10, will present its own set of challenges. The organisers have set stringent protocols even as a few tested positive in the lead-up to the championship. The players have to watch their health-parameters while helping cricket find its feet, an endeavour that England did first with remarkable efficiency by hosting the West Indies, Pakistan and Australia. It is a template worth emulating as fans starved of action wait to catch live moving images of M.S. Dhoni, Virat Kohli, Rohit Sharma, Steve Smith, Kane Williamson, AB de Villiers and other icons. Cricket in the Indian context has made a start and a lot is at stake as this IPL also offers a stage for Kohli and company to prepare for the coming tour of Australia

A Year Of Silent Houseboats

It has been a year of longing, a year of waiting, a year of reverie and a year of silent houseboats

t has been a year since I have heard anyone speak in German or in Siamese or even in Marathi. It has been a year of longing, a year of waiting, a year of reverie and a year of silent houseboats —quiet and empty.

At my home, mornings would always be full of activity. Most mornings I would wake up to the smell of omelettes and gentle clatter of knives and forks against china. I would hear my mother talking in broken English, desperately searching for English counterparts of Kashmiri words.

One could see the excitement of heading to Gulmarg or Sonamarg in the early morning rush. Boilers at the back of houseboats would billow smoke; warming the cold water. The roaring engines of Royal Enfields were another hallmark. "Madam main flower wala, flower lega?" or "Memsahab, would you like to see some jewellery?" would say the Shikarawalas. Tourists wearing Pherans would pose for the photographer, excited to take in as much Kashmir as they could. That's how my mornings used to be - a showcase of foreign languages and Kashmir's hospitality. Evenings were filled with chats in languages I couldn't comprehend. An occasional laughter would burst out from dining rooms. Houseboats used to be like that — lively wooden things reverberating with light, laughter and conversations with a cuppa kehwa to sip.

boat (we have three boats at my home) and play hide and seek; hiding under anything — dining table, beds, chairs and couches.

I never felt any different from them and they showered me with lots of love. They looked at me in awe, surprised, at my fair complexion, long nose and certainly my red cheeks. At times, I along with *Dadu*, would go to Gulmarg with them or to the Mughal Gardens.

I never knew life would take a drastic turn and take away the only way of life we have ever known.

Over the years, the number of tourists that come to stay in houseboats has been nothing but dwindling. Beeline of agents and cheap hotels are among the factors responsible for the decline. Nothing can to promote and preserve them.

It's been more than a year now without any business. To top it off, the government recently announced the New Houseboat Policy which requires houseboat owners to re-register their boats after fulfilling certain conditions such as having a digester, a sophisticated menu and a modern kitchen. Under this policy, making of new houseboats is strictly prohibited. It encourages houseboat owners to surrender their boats for a meagre compensation. This policy comes at a time when houseboat community is most vulnerable. The policy seeks to relocate houseboats; to where? — Only God knows.

This policy aims at wiping out houseboats in the name of conservation of Dal. At a time when big businesses around the world have been shattered,

The last time there were any tourists was in July, last year. Since then, houseboats are lying vacant. While much of business is turning around now, however, small houseboats and the people associated with them haven't seen any change. The people associated with houseboats have been watching their boats turn into poor irrelevant things.

As a kid, I would play with children from different places — Mumbai, Pune, Australia, Kerala, and Korea to name a few. We would sneak into a house-

fers and maintaining its delicacy is not an easy task. Huge investments go into maintaining a boat. The workers skilled in repairing a houseboat are limited, demanding high wages. Additionally, since a houseboat is solely made of deodar, it becomes a very expensive and cumbersome affair to buy timbre when it is needed.

With all the expenses, the price per room of a houseboat has still stayed more or less the same during recent years making it less and less profitable to run a boat. There have been many instances in which a houseboat caught fire charring its wooden dexterity, walnut wood furniture, expensive carpets and wood carving. The losses are massive.

The funny part is there is no policy which compensates houseboat owners when their boats are reduced to ashes or when a houseboat submerges requiring investment in crores (the prices of timbre have skyrocketed). What is even worse is the fact that there's no way of insuring houseboats.

Houseboat owners have never been offered any worthy economic stimulus whenever situation turned bad in Kashmir and the administration promotes, "Kashmir's potential for tourism" with houseboats and shikaras printed on banners.

Sometimes due to lack of resources an owner sells his boat and prefers another venture. This is the reason why the number of houseboats in Srinagar's water bodies has gone down from 1500 to a mere 900, as recently reported by The Tribune.

Houseboats are Kashmir's and Kashmiris' heritage and have been an important part of Kashmir's tourism industry. Houseboats are an inseparable part of Kashmir's identity and culture. There was a time when Britishers would come to stay in houseboats because of the luxurious experience that they offer.

Houseboats in the past have attracted film stars and many high-profile guests. International celebrities like the Beatles lead guitarist George Harrison too have stayed in houseboats but unfortunately no step has been taken by subsequent administrations this policy requires houseboat owners to make massive investments or risk losing their registration.

The haphazard manner in which the policy has been rolled out without logical consideration of rehabilitation and preservation, makes the agenda clear: to take advantage of the helplessness of the houseboat community and snatch their livelihoods by relocating their boats away from the Dal.

The houseboat community has always cooperated in the conservation of Dal. It being their source of livelihood, they will willingly make the necessary amendments to their boats. However, the way in which the policy has been framed, its timing and its aim to separate the two is regrettable.

Are only houseboats and Dal dwellers polluting the Dal?

On many occasions I have seen people tossing wrappers and plastic bottles into the lake and going about their lives as if the responsibility to conserve Dal lies solely with the Dal dwellers. But when it comes to taking aesthetic pictures with Dal and Shikaras in the background, the passion with which people do it is hypocritically unparalleled.

The time is not far away when there will be no houseboats lining the waters of Dal and no aesthetic backgrounds. I know many people who are considering selling their boats. It is too painful to see this community losing their boats — for a houseboat owner his boat is his right arm.

Oppn parties in Pak launch alliance to oust PM Imran

Islamabad: Demanding Pakistan Prime Minister Imran Khan's immediate resignation, the country's major Opposition parties have launched an alliance to hold a countrywide protest movement to oust his government.

A 26-point joint resolution was adopted on Sunday by the



All Parties Conference (APC), which was hosted by the Pakistan Peoples Party (PPP) and attended by Pakistan Muslim League-Nawaz (PML-N), Jamiat Ulema-e-Islam Fazl (JUI-F) and several other parties.

At a joint press conference after the end of the multi-party meeting, JUI-F chief Mualana Fazl ur Rehman read out the resolution and said that the Opposition parties have agreed to launch an alliance named Pakistan Democratic Movement (PDM) to organise countrywide protests against the Pakistan Tehreek-e-Insaf (PTI) government from October.

The resolution alleged that the Khan government has been granted "fake stability by the same establishment" that interfered with the elections to bring the incumbent rulers to power. In an obvious reference to

the powerful Pakistan Army, the resolution expressed "extreme concern" over the increasing interference of the establishment in the internal affairs of the country and regarded it as a "danger to the nation's stability and institutions"

According to the resolution, the protests would start in phases. In the first phase, the Opposition parties will hold joint rallies in all four provinces in October. The second phase will begin in December during which the Opposition will hold huge rallies across the country.

Finally, a "decisive" long towards Islamabad march would start in January next year to oust the government.

The forum also demanded that elections be held again in a transparent manner and that electoral reforms should be passed in order to ensure free and fair polls

Terming the Parliament a "rubber stamp", the PDM declared that the opposition will not cooperate with the government in the legislative process.

The Opposition will also enlist lawyers, traders, farmers, students, media as well as members of the civil society in its movement. In order to oust the government, opposition parties will use "every legal and constitutional option in and out of parliament, which include moving no-confidence motions and collective resignations from assemblies at an appropriate time," the resolution stated.



Russia launches Kavkaz-2020 military drills, featuring forces from Iran, China

Moscow: The joint military exercises, which started on September 21 and will run through September 26 involve about 80.000 personnel, including officers of the Russian Emergencies Ministry and the Russian Guard, as well as up troops from Iran, Armenia, Belarus, China, Myanmar and Pakistan. In addition, more representa-

tives from the armed forces of Iran, Azerbaijan, Indonesia, Kazakhstan, Tajikistan and Sri Lanka will participate as observers of the military drills. About 12,900 military personnel from the participating countries are going to take part in

activities covered by the 2011 Vienna Document of the Negotiations on Confidence-and Security-Building Measures. Most of the action on the ground will be taking place in the Southern Military District.

Up to 250 tanks, 450 infantry fighting vehicles and armored personnel carriers and 200 artillery and missile systems will participate

Ships of the Black Sea Fleet and the Caspian flotilla will join the action, too, enjoying the company of the Iranian Navy vessels. About 60 Ilyushin Il-76 military transport planes have been moved to operational airfields as part of the military drills.

Russia's Armed Forces will pay particular attention to combating cruise missiles and unmanned aerial vehicles during the exercise, the Ministry stated.

"The Kavkaz-2020 drills will particularly focus on combating cruise missiles and unmanned aerial vehicles, as well as on fire and electronic warfare activities against entire enemy for mations, on training airborne troops' vertical envelopment capability and ways to rapidly shift between military activities," the statement read. The event is led by Chief of the General Staff Army General Valery Gerasimov.

Travel bug hits people, digital skills to boost recovery: Google

San Francisco: After living months in isolation during the pandemic, the travel bug has hit millions of people and according to Google, 45 per cent of the top 100 questions related to travel in Search focused on the impact of Covid-19 and the desire to travel as safely and as soon as possible.

Google research, conducted with the Boston Consulting Group (BCG), showed that 31 per cent of people hope to plan leisure travel once they feel safe enough to do so, the company said in a blog post on Monday

'World Tourism day is coming up on September 27, and Search trends show that people have the travel bug. In August, the top queries were related to where and when people can travel 'right now,'"

said Pierric Duthoit, Senior Lead, Google Global Tourism Acceleration Centre.

Where do travellers want to go right now?

Heading to the beach and visiting rural areas or small towns are top of the list, particularly for Italians and the Dutch.

"Our data and analyses, available on our 'Think with Google' site, can help tourism businesses identify new trends in consumer preferences," Duthoit said.

For example, as people increasingly search for local and outdoor tourism, businesses can react to these changing needs by doing marketing campaigns that highlight nature destinations, and they can prepare for an uptick in lastminute bookings.

New Delhi: The FinCEN files show that the world's biggest banks have allowed criminals to move "dirty money" around the globe. In total, these reports flagged more than \$2 trillion in transactions, according to **BuzzFeed News**

The BBC reported that Russian oligarchs used banks to avoid sanctions and moved their money into the West.

It is the latest in a string of leaks over the past five years that have exposed secret deals, money laundering and finan-

cial crime, a BBC report said. The FinCEN files are more

Suspicious activity reports, or SARs, are an example of how those concerns are recorded. A bank must fill in one of these reports if it is worried one of its clients might be up to no good. The report is sent to the authorities, BBC said.

It has been revealed through these documents that HSBC allowed fraudsters to move millions of dollars even after it learned from US investigators that the scheme was a scam.

JP Morgan allowed a company to move more than \$1 billion through a London without knowing account who owned it. The bank later discovered the company might be owned by a mobster on the FBI's 10 Most Wanted list.

Erdogan files complaint over Greek newspaper's insulting headline

urkish President Recep Tayyip Erdogan has lodged a criminal complaint against four senior staff employed by a Greek newspaper about an insulting headline, according to Turkish media.

The state-run Anadolu Agency reported that the president's lawyer, Huseyin Aydin, filed the complaint on Monday about the headline run in Dimokratia, a rightwing paper, on September 18.

The headline "Siktir Git Mr. Erdogan", which means "F*** off Mr. Erdogan" in Turkish, appeared next to a photo of the president, and included the English translation.

In the complaint submitted to the Ankara prosecutor's office, Aydin described as "suspects" the four people



involved - Manolis Kotakis, the author of the article, editors Andreas Kapsampelis Yorgos Giatroudakis. and and editor-in-chief Dimitris Rizoulis

Following the complaint, the prosecutors in the capital launched an investigation against the newspaper.

"Considering the silence of the Greek public, it is understood that this moral collapse is not limited

to marginal segments," the complaint said, according to Anadolu.

Swearing is the language of those who do not have a word to say, or those who have a word to say but are incapable of speaking in a proper language, it added.

Turkey's foreign ministry had already summoned Greece's ambassador about the headline in, which was also published on the newspaper's website.

'Freedom of expression protected' The Greek foreign min-

istry had said on Friday that freedom of expression was fully protected in the EU member country, but added: "The use of offensive language is contrary to our country's political culture and can only be condemned."

Woman Suspected Of Sending Package **Containing Poison To Trump Arrested**

ashington: Authorities have arrested a person suspected of sending the deadly poison ricin in an envelope addressed to the White House but intercepted before it could be delivered there, a law enforcement source said on Sunday.

In response to a Reuters query seeking confirmation of media reports that a woman accused of mailing the ricin-tainted letter had been taken into custody at the U.S.-Canadian border, the FBI field office in Washington issued a statement saving: "An arrest was made of an individual allegedly responsible for sending a suspicious letter.

The statement added: "The investigation is ongoing."

The law enforcement source, familiar with the case but speaking on condition of anonymity, told Reuters the "suspicious letter" referred to in the FBI statement was the same as the envelope found to have contained ricin.

The source also said the person arrested was a woman of Canadian citizenship.

The Royal Canadian Mounted Police said on Saturday that it had received a request for assistance from the FBI in the investigation and that the suspicious letter in question appeared to have been sent from Canada.

The RCMP further stated that an FBI analysis of a substance inside the envelope detected "the presence of ricin," a highly toxic agent derived from castor beans.

While naturally occurring, the toxin requires a deliberate act to convert it into a biological weapon, with exposure to an amount as small as a pinhead capable of causing death within 36 to 72 hours. No known antidote exists.

Initially asked about the incident on Saturday, the FBI said it had joined the U.S. Secret Service and the U.S. Postal Inspection Service in the investigation of "a suspicious letter received at a U.S. government mail facility."

Hydrogen-powered Plane by 2035

Paris: Airbus is aiming to put the world's first hydrogen-powered commercial plane into service by 2035, the European aircraft maker's boss said in remarks published Monday.

Hydrogen is a clean fuel, emitting only steam, but whether it is green depends on the carbon footprint of the fuels used to produce it. France and other European countries are investing billions of euros in the development of green hydrogen, with the highly polluting transport industry a prime area for its intended use.

"It is our ambition to become the first aircraft maker to enter such a plane into service in 2035," Airbus CEO Guillaume Faury told Le Parisien newspaper

The development of decarbonised hydrogen fuel is a "priority axis of development" for Airbus, he said.

The manufacturer has already been using hydrogen technology to power its satellites and the Ariane rocket.

Over 1,300 Central Bureau Of Investigation Posts Vacant: Centre Tells Lok Sabha

NEW DELHI: Over 1,300 posts are lying vacant in the Central Bureau of Investigation (CBI) against its total sanctioned strength of 7,273, the government told Parliament on Monday.

sanctioned Of the strength, 5,944 posts are filled and 1,329 vacant in the CBI, according to data shared by Minister of State for Personnel Jitendra Singh in a written reply to a question in the Lok Sabha.

Giving category-wise details, he said out of the sanctioned strength of 5,000 of executive ranks, 4,198 is the actual strength, as on August 31, 2020.

Of the 370 posts of legal ranks, 285 were filled and 66 out of 166 posts meant for technical ranks were occupied, according to the reply.

As many as 1,368 and 27 posts of ministerial ranks Union Public Service Comand canteen staff were occupied against the sanctioned strength of 1,671 and 70 respectively, the data showed.

WHO Endorses Protocol For **Coronavirus Herbal Medicine Trials**

BRAZZAVILLE, CONGO: The World Health Organization endorsed Saturday a protocol for testing African herbal medicines as potential treatments for the coronavirus and other epidemics.

Covid-19 has raised the issue of using traditional medicines to battle contemporary diseases, and the endorsement clearly encouraged testing with criteria similar to those used for molecules developed by labs in Asia, Europe or the Americas. It came months after a bid by the

president of Madagascar to promote a drink based on artemisia, a plant with proven efficacy in malaria treatment, was met with widespread scorn.

On Saturday, WHO experts and colleagues from two other organisations "endorsed a protocol for phase III clinical trials of herbal medicine for Covid-19 as well as a charter and terms of reference for the establishment of a data and safety monitoring board for herbal medicine clinical trials," a statement said.

"Phase III clinical trials are pivotal in fully assessing the safety and efficacy ated research and development proof a new medical product," it noted.

"If a traditional medicine product is found to be safe, efficacious and quality-assured, WHO will recommend (it) for a fast-tracked, largescale local manufacturing." Prosper

Tumusiime, a regional WHO director, was quoted as saying.

WHO's partners are the Africa Centre for Disease Control and Prevention and the African Union Commission for Social Affairs.

"The onset of Covid-19, like the Ebola outbreak in West Africa, has highlighted the need for strengthened health systems and accelergrammes, including on traditional medicines," Tumusiime said.

He did not refer specifically to the Madagascar drink Covid-Organics, also called CVO, that President Andry Rajoelina has pitched as a cure

for the virus, however.

It has has been widely distributed in Madagascar and sold to several other countries, mainly in Africa.

In May, WHO Africa Director Matshidiso Moeti told media that African governments had committed in 2000 to taking "traditional therapies" through the same clinical trials as other medication.

"I can understand the need, the drive to find something that can help," Moeti said. "But we would very much like to encourage this scientific process in which the governments themselves made a commitment.

Tortured, Denied Food, Water In Mathura Jail: Kafeel **Khan To UN Human Rights Experts**

GORAKHPUR: In a letter to a group of UN human rights experts, paediatrician Kafeel Khan has alleged that he was "tortured" in the Mathura jail, where he was lodged after being charged under the National Security Act (NSA) for allegedly delivering provocative speeches in Aligarh Muslim University (AMU) during the anti-CAA stir in December 2019.

"I was tortured mentally as well as physically, denied food and water for many days, and treated inhumanely during months of incarceration in a congested, overcrowded Mathura prison," he wrote to the United Nation human rights experts.



Kafeel Khan, who is now the Indian government to reout on bail, wrote to the UN lease him.

The human rights group human rights group of excomprises independent experts on September 17 with reference to their June 26 letperts, not the UN staff. ter, in which they had urged "The use of stringent national security laws / UAPA against political dissenters, in the absence of any appeal, is something to be condemned in all cases," Dr Khan told news agency PTI.

Earlier, when he was in jail. his wife Shabistan Khan had written to the UN human rights expert group alleging unlawful detention of her husband.

Dr Khan, a Gorakhpurbased paediatrician, was also arrested earlier and lodged in Gorakhpur jail as one of the nine accused in BRD Medical college case relating to the death of over 60 children in August 2017 allegedly due to the shortage of oxygen cylinders in the hospital.
