Pak Shells LoC In Rajouri: Army

Jammu: The Pakistani army resorted to heavy firing and mortar shelling in forward areas along the LoC in Jammu and Kashmir's Rajouri district on Thursday, officials said. "At about 1745 hours today, Pakistan army initiated unprovoked ceasefire violation by firing with small arms and intense shelling with mortars along LoC in Nowshera sector", a defence spokesman said. Biker Dies In Budgam Mishap

Srinagar: A biker was killed in a road mishap in central Kashmir's Budgam district on Thursday. 30-year-old Mohammad Yousuf Mir of Waterwani was critically injured when his bike was hit by a tipper (JK13-5911) near Mirgund on Thursday, reports said. He was immediately shifted to nearby hospital for treatment. However, the doctors there referred him to SMHS hospital, where he died after battling with life for several hours, reports said. Bear Mauls Woman In Tangmarg

Srinagar: An elderly woman was attacked and killed by a bear in Tangmarg area of Baramulla district, reports said Thursday. 55-year-old Zoona Begum, wife of Haji Muhammad Akbar Malik was walking in a field in Tumberhama village of Tangmarg when a bear appeared there and attacked her. The woman sustained serious injuries in the attack by beast. She rushed to hospital where doctors declared her brought dead, news agency KNT reported.

BJP Member From Budgam Resigns

Srinagar: A Bharatiya Janta Party (BJP) member from central Kashmir's Budgam district on Thursday resigned from the party, a day after a Block Development Chairman was shot dead by suspected militants in the district. Abdul Rashid Banday from Habber Drang area of Budgam, who unsuccessfully contested assembly elections on BJP ticket in 2014, announced his disassociation from BJP today, news agency KNT reported. Banday's resignation comes a day after a BDC Chairman from Khag-Bhupinder Singh was shot dead by militants on Wednesday evening.

Labourer Killed, 7 Hurt In Kupwara Accident

Srinagar: A labourer was killed, while seven others, including three soldiers were injured on when an army vehicle they were travelling in met with an accident in Kupwara district of north Kashmir. Official sources said that the accident took place near Bari Baihka, some 25 kilometers from main town of Kupwara, at around 1:30 pm. A labourer identified as Daulat Hussain son of Amirdeen of Marsari was killed and seven other persons including three soldiers and four labourers were injured. unidentified gunmen, believed to be two in number entered Hawal residence of Advocate

Babar Qadri and fired shots at him from point blank range, a police official said. Qadri sustained critical injuries in the attack while the gunmen managed to flee from the spot.

24 More Deaths Take Covid-19 Toll In J&K To 1088

SRINAGAR: As many as twenty four people succumbed to coronavirus in Jammu and Kashmir on Thursday, taking the number of fatalities due to virus in the Union Territory to 1088.

While fourteen more Covid-19 deaths were reported from Jammu division, the remaining ten were confirmed by the officials in Kashmir valley.

According to officials, a 70-year-old woman from Bemina, a 65-year-old woman from Chanapora and a 72-year-old man from Nishat died at the Chest Diseases hospital here, one of the exclusive facilities for the management of the covid-19 patients.

Seven of the deaths were reported at SKIMS Soura and included a 46-year-old man from Batmaloo, a 60-year-old woman from Malabagh Srinagar, a 68-year-old man from

Observer Monitoring Desk Fateh Kadal, an 80-year-old from Noorpora, Tral, a 70-yearold man Tral, a 70-year-old from Tangmarg and a 60-yearold from Bandipora.



In FOCUS New Language Bill Sparks Mixed Reactions In J&K

ntroduction of Kashmiri, Dogri, and Hindi as official languages of Jammu and Kashmir has strong political connotations, said Mir Tariq Rasool, former Secretary J&K Adbe Markaz Kamraz (AMK) and Patron Kashmir Literary and philosophical foundation.

According to him, the new language bill has disseminated respect to the sense of identity among Hindi/Dogri-speaking people, but for Kashmiri-speaking people "it is nothing but a political trick", as to introduce Devanagari script for

brought dead to hospital," SKIMS Medical Superintendent Dr Farooq Jan told Kashmir Observer. Srinagar Superintendent of Police Haseeb Mughal said police teams had been sent to the location where the attack took place and a manhunt launched to find the assailants.

According to the reports, police and CRPF laid a siege around Zahidpora, Madin Sahab and adjoining localities of Hawal after the attack. Qadri, originally from Tangmarg in Baramulla district, had been practicing law at Kashmir High Court for more than a decade. Besides an advocate, Qadri was a vocal panelist and TV debater. He is survived by his parents, three siblings, wife and two daughters.

Qadri, who was a student activist, became well-known for taking up cases of juveniles booked under various laws, including the controversial Public Safety Act (PSA).

He was often seen on national channels debating Kashmir. He was vocal on Kashmir affairs and often at loggerheads with other panelists. Three days earlier, he had in his last Tweet urged the police in Jammu to register an FIR against a Facebook user for launching a "wrong campaign" against him.

Just hours before his death, the lawyer, during a Facebook live, had said that he had been receiving intimidating messages.

Hundreds of people participated in the funeral prayers of Qadri on Thursday evening amidst pro-Islam sloganeering. Amid sobs and cries, his body was taken to his ancestral graveyard in Tangmarg. Meanwhile, former chief minister of Jammu and Kashmir and National Conference (NC) vice president, Omar Abdullah in a tweet condemned his killing and termed it as tragic. He said that the sense of tragedy is all the more because he warned of the threat.

"Sadly his warning was his last tweet," Omar tweeted. Former minister and Peoples Conference president, Sajad Gani Lone

in a tweet said that one more Kashmiri falls to bullets. "Sad news. Advocate Babar Qadri assassinated. One more Kashmiri falls to bullets. Yet another victim of conflict. My thoughts with the family," Lone Tweeted.

The People Democratic Party (PDP) also took to Twitter to condemn the killing.

"Mournings are a constant feature in every Kashmiris life. Vehemently condemn the assassination of Babar Qadri,"

Noted Human rights activists Khurram Parvez also expressed his grief and sorrow over the assassination of young lawyer.

"In this hour of grief, we at @apdp_jkccs & @jkccs_ stand by the family of Adv. Babar Qadri. Tragic times refuse to end for Kashmiri families," Parvez Tweeted.

Jammu and Kashmir Pradesh Congress Committee (JKPCC) strongly condemned the killing of Qadri and urged the government to ascertain the identity of killers for exemplary punishment.

Describing the killing of Qadri as an unfortunate, shocking and cowardly act, JKPCC spokesperson has expressed anguish over this unfortunate and highly condemnable incident and urged the government to take effective measures to put an end to the bloodshed in Kashmir.

Pak To Hold Gilgit-Baltistan.

terms of Section 57(1) of the Elections Act 2017, the statement said. The polls in Gilgit-Baltistan were to be held on August 18, but the Election Commission on July 11 postponed them due to the coronavirus pandemic.

Polling would be held on 24 general seats of the legislative assembly. The five-year term of the previous assembly had ended on June 24, bringing an end to the five-year rule of the Pakistan Muslim League-

There are a total of 33 seats, but six are reserved for technocrats and three for women. The special seats are filled from nominations by the parties winning the polls according to their representation.

The election date has been announced amidst reported consultations to elevate Gilgit-Baltistan's status to that of a full-fledged province. The issue was discussed in a meeting between the Opposition leaders and Pakistan Army chief Gen Qamar Javed Bajwa on September 16. Meanwhile, India came down heavily on Pakistan for its decision to hold general elections in Gilgit-Baltistan and said any action to alter

the status of the "militarily-occupied" region has no legal basis. "Any action by Pakistan to alter the status of the militarily-occupied so-called 'Gilgit-Baltistan' has no legal basis whatsoever and is totally void ab-initio," Spokesperson in the Ministry of External Affairs (MEA) Anurag Srivastava said at virtual media briefing.

Referring to statements by the Pakistani leadership on the issue, he said Pakistan has no locus standi to comment on India's internal mat-

"Our position has always been clear and consistent. The entire territories of the UTs of Jammu and Kashmir and Ladakh have been and are an integral part of India and would remain so," Srivastava said. India also clearly conveyed to Pakistan that the entire Union territories of Jammu and Kashmir and Ladakh, including the areas of Gilgit and Baltistan, are an integral part of the country.

slapped in the face, to which Kashmiri journalist Augib Javeed was subjected during a five-hour interrogation by cyber-police in Srinagar after writing about their intimidation of Twitter users.

"Such behaviour is unacceptable in a democracy," RSF said. Auqib, an accredited journalist with Kashmir Observer, was verbally summoned by the Cyber Police station on September 18 over his story titled, 'The Real Cyberbully: Police in Kashmir Question Twitter Users' which appeared in 'Article 14" a Bangalore based web portal.

According to Auqib, he was slapped twice by a masked cop outside the room of Superintendent of Police of the Cyber Wing, Tahir Ashraf Bhatii when he was on way to meet the officer on Saturday. The SP, he said had also hurled choicest abuses at him.

"It is absolutely unacceptable that members of the police manhandled, threatened and intimidated a journalist who just did his job," said Daniel Bastard, the head of RSF's Asia-Pacific desk.

"The behaviour of the Srinagar cyber-police is typical of authoritarian regimes and unworthy of Indian democracy. We call on the federal authorities to punish those responsible for the violence against Auqib Javeed," he added.

Quoting Auqib, the RSF statement said that he was still in a state of shock when he spoke to RSF on 21 September and, earlier that day, he had written about his brutal treatment by the police two days before. "I fear for my life now," Javeed told RSF. "I believe that the authorities could go to any lengths to silence me and could arrest me on an fabricated charge.'

RSF said that it was not the first time Augib has been subjected to in-

timidation in connection with his work. The global media watchdog said that the National Investigation Agency, India's counter-terrorism police, interrogated him for three hours in July 2018 for interviewing a Kashmiri separatist leader.

"His phone was also taken and never returned," the RSF said. RSF said that last week it condemned police "violence" against three other journalists in Kashmir.

"While covering an exchange of shots between separatists and government forces on 15 September, Newsclick photographer Kamran Yousuf and reporters Faisal Bashir and Reshi Irshad were beaten by several policemen, one of them with a baton," the RSF added. India is ranked 140th out of 180 countries in RSF's 2020 World Press Freedom Index.

Militants Kill CRPF Officer...

Soon after the attack, government forces carried out a cordon and search operation in the area to nab the assailants. News agency KNT reported that two people, including a tailor were detained by the state forces for questioning.

Pertinently, the attack on CRPF officer comes barely a day after suspected militants shot dead a block development council (BDC) member in the central Kashmir district on Wednesday evening.

Bhupinder Singh, a member of the block development council of Khag block in Budgam district, was shot at by the militants in his ancestral village Dalwash. He died on the spot.

Militant Killed In Tral Encounter

cordon and search operation in Machama area of Awantipora this morning, a police spokesperson said. The militant, he said turned down surrender offer and instead opened fire upon the search party. "The joint team returned the fire triggering off an encounter. In the exchange of fire, the militant was killed. His body was also retrieved from the encounter site," the police spokesperson said.

Police identified the killed militant as Irfan-ul-Haq Dar of Gadikhal village in Awantipora associated with Al-Badr.

Dar, according to police was involved in a grenade attack on police station Awantipora in April last year. He was arrested by police and sent to Kot Balwal Jail.

"After his release in April 2020, Irfan-ul-Haq was secretly involved in militant activities which include Al-Badr related recruitment in Awantipora & Tral areas. He was an important motivator and influenced young minds for joining militant ranks," the police spokesperson said. Earlier in 2016, the police spokesperson said Dar was involved in a stone pelting/arson case of Police Station Awantipora.

"Keeping in view the prevailing pandemic due to COVID-19 and to ensure the safety of people from inherent risk of contracting the infection, the body of the killed militant shall be sent to Handwara for burial after completion of all medico-legal formalities. The nearest family members of the killed militant shall be allowed to participate in the last rites at Handwara," he said.

The police spokesperson said that incriminating materials including arms, ammunition were recovered from the site of encounter. He said all the recovered materials have been taken into case records for further investigation and to probe his complicity in other crimes.

"In this connection a case under relevant sections of law has been registered and investigation has been initiated," the police spokesperson said. "People are requested to cooperate with police till the area is completely sanitized and cleared of all the explosive materials, if

Pakistani populations. Brereton, Daly and Bristow also sit on the All Party Parliamentary Group on Kashmir (APPGK), which is chaired by Labour MP Debbie Abrahams, who was deported to Dubai on February 17 after being informed at the Delhi airport that her e-visa was not valid. The following day she flew to Pakistan and met Pakistan Prime Minister Imran Khan.

Kuldeep Shekhawat, president of the Overseas Friends of BJP (UK), plans to draft a letter and send it to the co-chairs of the Conservative party, which he claimed more than 200 PIO activists will sign.

"We are not happy with this kind of anti-India move by the Conservative team. Britain has no right to interfere in India's internal matters," he said. Lord Rami Ranger, a patron of the Conservative Friends of India, has written a letter to Bristow and Daly, appealing them not to undo the work he has done.

"Kashmir is dividing the Conservatives," Ranger said.

"Not only will they stop voting, they will also stop giving donations to the party once they hear about this. The UK is trying to negotiate an FTA with the largest democracy in the world. This is hardly going to go down well," Ranger added.

India Slams Pak For Raising...

External Affairs Minister S Jaishankar represented India at the meeting. The MEA said Pakistan has no locus standi to comment on internal affairs of India, asserting that the Union territories of Jammu and Kashmir and Ladakh have been and will remain an integral part of

"Pakistan's remarks today constitute gross interference in India's internal affairs, sovereignty and territorial integrity which is inconsistent with the CICA Declaration on the Principles Guiding Relations between the CICA Member States of September 1999," the MEA said, in response to remarks by Pakistan Foreign Minister Shah Mahmood Qureshi. It said Pakistan is the "global epicentre" of terrorism and continues to

be the source of terrorist activities in India. "We advise Pakistan to cease its sponsorship and overt and covert support to terrorism against India. This will enable the two countries to engage and address issues bilaterally rather than distract this important forum from its agenda," the MEA said.

In his address at the CICA meeting, Jaishankar called for greater collective efforts to counter terrorism and its sponsors.

"So far we have tracked many drone consignments of weapons and narcotics and arrested all those involved in those modules. This is another evil design (of Pakistan) and we are alert to it," Singh said. He said underground tunnels and hideouts made by militants were a cause of concern as they posed a threat to the civilian population and peace in Jammu and Kashmir.

"Tunnels are mostly old, but now the intelligence network is strong and we are destroying these hideouts whether in forests or built up areas," he added.

The DGP said that while there were two attacks by militants within the past 24 hours, the government forces had conducted successful operations during the same period.

"While we have had these two incidents in the last 24 hours, you must

appreciate that we had a successful operation this morning at Tral in which one hardcore militant has been neutralised. Just couple of days back, many successful operations have been carried out," he said. Singh said in the current scenario in which Pakistan and its agencies are "sponsoring militancy in the state and are promoting it by all means", the effort of the security grid is to see that every such effort is foiled.

"We have been successful and we will be successful. Anyone who is involved in militancy will be brought to justice," he added. Assistant Sub-Inspector N C Badoley was killed in a militant attack in the Kaisermulla area of Budgam district on Thursday morning.

Director General CRPF A P Maheshwari led the security forces in paying homage to the fallen officer.

Maheshwari said such incidents would not deter the force. "We are in complete synergy with J-K police and we will continue our mission to neutralise the militants who have been operating in the area. This does not deter us and reinforces our resolve. I assure that we will be soon eliminating the militants who are operating in

Disengagement Requires...

Anurag Srivastava said disengagement is a complex process which would require mutually agreed "reciprocal actions", and the way ahead will be to refrain from making any attempts to unilaterally change the status quo.

Separately, External Affairs Minister S Jaishankar said India and China are going through an "unprecedented" situation, but noted that the border row is one part of the larger issue of how the two countries adjust to each other when both are rising.

Speaking at a virtual conference of the World Economic Forum, he said it is important that China and India understand the need to accommodate each other's rise.

"We are going through, in a sense, an unprecedented situation. But if one looks at it from a somewhat longer-term. I would say this is one facet of a larger phenomenon for which both India and China have to sit down and find a solution," Jaishankar said when asked how ties between the two Asian giants will move forward.

At his media briefing, Srivastava said the next meeting under the framework of the Working Mechanism for Consultation and Coordination (WMCC) on India-China border affairs is likely to take place "soon". It is learnt that the WMCC talks will take place ahead of the next

round of the Corps commander-level discussions. "Even as two sides work towards complete disengagement in all friction areas, it is at the same time also necessary to ensure stability on

the ground. The latest senior commanders meeting should be seen in this overall context," he said. India and China held the sixth round of Corps commander-level talks on Monday following which both sides announced a series of deci-

sions including to stop sending more troops to the frontline, refrain from unilaterally changing the situation on the ground and avoid taking any actions that may further complicate matters. The MEA spokesperson referred to the first ever joint press release issued by the two sides on Tuesday after any Corps commander-level meet-

ing during the four-and-a-half-month standoff, adding it reflected their stated commitment to disengage along the Line of Actual Control(LAC). "As we have pointed out earlier, disengagement is a complex process that requires redeployment of troops by each side towards their regular posts on their respective sides of the LAC. This would require mutually agreed reciprocal actions," he said.

Srivastava also said the meeting gave the senior commanders an opportunity to have candid and in-depth exchange of views on stabilising the situation along the LAC.

"The way ahead will be to refrain from making any attempts to unilaterally change the status quo, while the two sides continue their discussions to achieve complete disengagement in all friction areas and to ensure full restoration of peace and tranquillity in the border areas," he said. He also mentioned about the decision of the two sides at the military talks

to have the next meeting of the senior commanders at the earliest. "In parallel, the next meeting of the WMCC is also likely to take place soon." Referring to the military talks, Srivastava said the two sides had decided to strengthen the ground communication to avoid any further misunderstandings and misjudgments, stop sending more troops to the frontline, refrain from unilaterally changing the situation on the ground, and avoid taking any actions that may complicate the situation.

It was for the first time the Indian army and the Chinese People's Liberation Army(PLA) announced specific measures to ease tensions in eastern Ladakh where the face-off began in early May.

The situation escalated manifold after 20 Indian soldiers were killed in a clash in Galwan Valley on June 15. The Chinese side too suffered casualties, but it is yet to divulge the details.

The situation further deteriorated following at least three attempts by the soldiers of the PLA to "intimidate" Indian troops along the northern and southern bank of Pangong lake area in the last three weeks where even shots were fired in the air for the first time at the LAC in 45 years. As the tensions escalated further, the foreign ministers of the two countries held talks on the sidelines of a Shanghai Cooperation Organisation meet in Moscow on September 10 where they reached a

five-point agreement to defuse the situation in eastern Ladakh. The agreement was the basis for the sixth round of Corps commander-level talks on Monday which was also attended for the first time by a joint secretary from the MEA.

The agreement aimed at ending the tense standoff included measures like quick disengagement of troops, avoiding action that could escalate tensions, adherence to all agreements and protocols on border management and steps to restore peace along the LAC.

'A Step to Create Friction'

Rao Farman Ali, author of 'Resistance History of Kashmir', told Kashmir Observer that the move by the Centre would act as a divisive step in the region.

In the future, it might create friction than unification in J&K, he added. "Urdu was a link language between all ethnic groups of Jammu, Ladakh and Kashmir," he said. "In the process of finding the link language, people would shift towards English and it would be a new type of anguish towards New Delhi."

'A move towards transparency' But while a majority of people criticized the Bill, many hailed the in-



1100 militants active in Jammu division: Army

AMMU: About 1100 militants, 50 percent of them foreigners are operating in Jammu division, a senior army official has said. The militants strength has increased from 600 to 1100 in Doda, Poonch, Rajouri, Udhampur and Kathua districts of Jammu division since 1997-98, the GoC of Jammu Corps, Lt.General A.S. Khanna told reporters at the 16 Corps headquarters in Nagrota yesterday.

Of these, 50 percent are operating in Doda district alone, while the remaining in Rajouri, Poonch, Udhampur districts, he said, adding that over 50 percent of militants belong to Hizb-ul-Mujahideen.

He said as many as 549 militants 'were killed in different operations in Jammu division this year. Of these, 164 militants were killed in Poonch, followed by 15.7 in Rajouri, 94 in Udhampur, 75 in Doda, 41 in Jammu and 18 in Kathua districts since January this year.

Last year as many as 458 militants were killed in. the division. Similarly, troops killed 115 militants along Jammu border during 77 unsuccessful infiltration bids, while 62 militants were killed in 54 bids last year. Besides, 52 civilians were killed by militants this year. Of these, 43 civilians were killed by militants and nine civilians were killed in blast caused by same period, he said.

Hope on Indo-China front

not to send troops to the frontline in Ladakh. This was agreed at a meeting of the Indian and Chinese senior military commanders that met on Monday to discuss stabilizing tensions along the Line of Actual Control (LAC). Both sides have agreed to reinforce communication on the ground to remove the possibility of a misunderstanding or action that may further complicate the situation. They also agreed that there shall be no unilateral action that would alter the situation on the ground. The two sides are meeting again to build upon the current understanding.

In another positive development, Chinese premier Xi Jinping has said that China doesn't want either hot or cold war against any country. Addressing the United Nations General Assembly, Jinping said that China will never seek hegemony or pursue expansionist policies.

However, on ground in Ladakh, the situation remains tense. Indian and Chinese armies remain in an eye-ball to eye-ball position along the LAC. Despite several meetings between the armed forces of the two countries and later on between defence and foreign ministers of the two countries that have led to agreements to disengage and de-escalate the situation, little has altered on the ground. At times, actions by the Chinese side have pushed the situation to the brink. On June 15, twenty Indian soldiers and an unknown number of Chinese soldiers were killed in a skirmish in Galwan Valley. And recently, there was also a shooting incident between the two armies, the first of its kind in decades.

India wants China to go back to status quo ante as it existed in April but Beijing is in no mood to do so. On the contrary, the People's Liberation Army has enhanced its military profile on the border by deploying thousands of its soldiers and equipment. In recent years China has reportedly more than doubled its total number of air bases, air defence positions and heliports near the Indian border.

This has now become a high stakes war of nerves between the two countries. More so, for India that can hardly afford to be distracted at a time when the number of the Covid-19 positive cases has crossed 56 lakh. What is more, the number of the daily cases has shown an exponential rise at times reaching close to one lakh. Besides, the depleting economy hit hard by the badly implemented nationwide lockdown hardly affords the government any space for hostilities. China, on the other hand, has successfully tackled the pandemic, despite being the country of origin of the deadly contagion.

A pragmatic way out to resolve the lingering stand-off is through negotiations, even if it takes time. With winter approaching it will be in the interest of both the countries to reach an understanding that also holds on the ground. But this can only happen if Beijing approaches the dialogue seriously.



Fallen warriors

or how long can an illusion affecting the lives of millions be kept up before it collapses? The Indian Medical Association seems to have found an answer to the question when it called out the Centre's "hypocrisy" for extolling Covid-19 frontline healthcare workers as "warriors" while, at the same time, not bothering to keep track of those among them who have lost their lives to the virus. That it fell to the IMA to point out that 382 doctors have died from Covid-19 is telling, as is the fact that the Union health ministry insisted, at the time of a national-level health crisis, that health is a state subject. That the Centre has suddenly remembered to invoke the principle of federalism suggests that it will pounce on every opportunity to pass the buck to conceal its own dereliction of duty. This is not surprising. The BharatiyaJanata Party-led Central government's willingness to maintain data depends on the nature of the information. So the Centre has expressed its inability to collate data on, say, the deaths of migrant workers during the lockdown or on farmer suicides. Yet, in Uttar Pradesh, where the BJP is in power, data collection — surveillance? — has been facilitated by tracking the call records of Covid-19 patients, ostensibly for effective contact tracing.

The Centre's plaintive cries about the absence of data on the deaths of frontline health workers have several implications. The most troubling is its use of lofty rhetoric in place of meaningful interventions. The prime minister goaded the nation to honour Covid warriors by raising a frightful din with pots and pans; more recently, and on a serious note, a bill has been passed by Parliament to protect frontline workers and doctors from physical assault. But several other crippling dimensions of the crisis remain unaddressed. For instance, how serious is the shortage of protective equipment? Doctors in Bihar — the BJP is eveing the state in the forthcoming polls — are on record saying that one of the chief reasons for deaths in the fraternity is the supply of substandard protective equipment. There have been other irregularities as well. Several hundred fake ventilators were allegedly installed in hospitals across Gujarat — the prime minister's home state — without any regulatory assessment of the faulty equipment, seriously undermining concerns of public health. Meanwhile, personnel in the lower rungs of India's Covid Warrior Force continue to labour with minimal resources. Theatrics can do little to mask the stench of death in

possibility the state is perpetually wary of. It implies that the power to nominate and determine meaning and accessibility has transferred

from the state to the people. That the act of sloganeering is conducted in public, is an attestation of the fact that symbolic associations with public places especially conspicuous places like Ghantaghar or Clock Tower or the UN office get built over time, and acquire a narrative infallibility that is impossible to erase. As Edelman notes, "The conspicuousness of public structures, together with their emptiness of explicit meaning, enablesthem to serve as symbolic reaffirmations of many levels of perceptions and beliefs." A slogan is therefore at once an act of historicizing, an act of dissent, and an act of reclamation. It serves as an agent of translation where the collective dissent is translated into a

say seencha/Woh Kashmir humarahai (The Kashmir you have watered with blood/ That Kashmir is ours). The slogan was conceived during the Plebiscite movement started by Afzal Beg - the trusted lieutenant of Sheikh Abdullah - the then Prime Minister of Kashmir who was summarily dismissed first for losing the confidence of his cabinet, and arrested on charges of conspiring against the country. The slogan sought to reiterate the heavy price Kashmir had to pay for opposing Dogra rule invoking the various massacres like the Zaldagar Massacre the horror of gilgitbegaar (forcible labour to carry supplies to Gilgitcantonement that routinely left the coolies dead, disabled, or traumatized) and the partition horrors in Jammu against Muslims to press the demand that people of Kashmir must be allowed to decide their political destiny.

renewal or familiarization with an integration into a particular ideological position (of being part of, or against a collective). While the state relies on increasing the distance between the subjects, if necessary by use of coercion (a curfew or tear gas shelling is meant to scatter the protestors), sloganeering achieves the opposite effect by reducing the distance between the participants. It unites the protestors as voices are synchronized, order followed and replies coordinated impromptu; establishing them as a collective unit rather than a collection of disparate

individuals.

Having established the dynamics of performativity of the slogan, it now follows that one must examine the operation of the slogan itself – why the slogan is what it is, and how does it work? I propose to illustrate this by taking up a case study of a slogan, and analyzing its working. The slogan I have selected for this analysis is Jis Kashmir koKhoon

The operative word in the slogan first is the demonstrative 'jis' (That) implying therein that there are multiple Kashmirs. The plural evokes the multiple imaginations of Kashmir - as a paradisiacal bower, a war zone, an atootang and a shahrag (Integral part for India, and the jugular vein for Pakistan), as well as the MaejKasheer (Mother Kashmir) for its locals. The demonstrative 'jis' then evokes a Kashmir, which is the real Kashmir and not its fantastical representations. The slogan, however, works first due to the emotive force of the verb 'seencha', which can mean both plough and irrigate. 'Plough' evokes the pervasive violence that inscribes and unsettles the soft surface of the earth evoking the imaginaries of incision, engraving and etching into the flesh, a painful process and thereby an appropriate reminder of the pain of Kashmir. Visceral experiences are the primary and first experiences in an individual's

life, and therefore the evocation of a memory etched in flesh is a reminder of the permanence and severity of the trauma of Kashmir. Hence, one of the common ways to indicate severe grief, especially in Kashmir, is to suggest that it is inscribed on the heart (the heart being a repository of emotions). The land and people become fused, as the earth becomes a metaphor for the heart and flesh—the emotive collective and collective memory of Kashmir.

Moreover, since the land is ploughed by blood, the land and people are further fused as blood spilled leaves a trail of destruction and grief on the Kashmiri heart. However, it can be read in an another way too - blood as fertilizer and land as the fruit. The National Conference Flag and the flag of erstwhile state of Jammu and Kashmir was a red cloth with a white plough on it. This relic of Abdullah's flirtation with Nehruvian socialism evoked the plough as a symbol of the disenfranchised tiller, invariably a Kashmiri Muslim, crushed under agrarian debt, and a hostile Hindu state. The colour red both the colour of blood, and revolution indicated a 'Naya Kashmir' (New Kashmir) - one premised on equality and liberty. The verb 'seencha' thus evokes this whole paradigm of historical memory, and the hope of finally reclaiming the land. The assertion of 'Woh Kashmir humarahai' serves as a reminder that the process is yet incomplete. This tracing of the land through blood is a reminder of the imaginaries in which a nation is conceived - sacrifice and bloodshed. As the grandmother in Amitav Ghosh's Shadow Lines points out that the character Ila has no right to live in England. She says:

"She doesn't belong there. It took these people a long time to build that country... years of war and bloodshed. Everyone who lives there has earned his right to be there with their blood: with their brother's blood and their father's blood and their son's blood."

The nation, therefore, is conceived through the rite of blood, and the slogan is a reminder of this rite. I leave it to the reader to reflect on how the slogan still stays as relevant in the post-370 context, as it was when it was conceived five decades ago – five decades of stagnation, and grief.

Having lost his mother in 2014 and father in 2018, Hilal lived in Malviya Nagar, New Delhi working as a Process Associate for Admiral Group plc, headquartered in Cardiff, Wales. He was a BBA graduate from Islamia College and had even completed his MBA degree from Kashmir University (KU). He had applied for a PhD in Management Studies while he was on the job. His last conversations with his friends were about prospective job offers and career opportunities.

'Our parents raised us with passion, surviving many difficult times. Our mother dreamed of Hilal as a professor and so did he," Yasir said.

Before he disappeared, he left New Delhi for Kashmir on March 23, just before 'the world's strictest lockdown' was declared. He was working, quarantined in his quarters, when his uncle called him back home in the wake of the COVID-19 pandemic. Obedient, as he had always been, Hilal came home after trying to protest a little.

"He argued that if anything were to happen to him, Delhi was a much better place to be, healthcare services-wise. But we were adamant. We had called all the children of the house back during the worldwide scare of coronavirus," Sadiq disclosed.

And so, complying as per culture, the bird flew back to his nest to be 'safe'. He came back to his old room, unoccupied since two years, and refurbished it in his own style with paint. He installed a Jio Fiber connection - familiar in a sans-Internet Kashmir - to work.

The evening before he disappeared, Hilal had worked for 10 hours. He had shared that evening's supper with his brother and had told him that he had to "bring juice" for others in the trekking group.

At dawn, the following day, June 14, he had also updated his Facebook status and WhatsApp story individually, with information about the planned activity.

"It hurts when they speak like that. With such carelessness. He was no militant. He was barely even a political person," Hilal's brother stated.

At 10:15 am, when the Four were indeed drinking tea, Mehraj also saw Hilal retract with his phone. It was to send a text message to Yasir.

"After that, he lost connectivity and we have

been searching for him since," Sadiq cried. "Please help us," he said, "The police had told us a month and a half before Eid-ul-Adha that they were getting a 'lead' in Shopian. But they just kept repeating that for more than a month, not divulging anything more about what it exactly was. It turned out to be a phone number that they had to trace but there was no progress there. So I took the name and address of the 'lead' from the police and went to find out for myself. It was just a boy from Hilal's college who he had called to discuss academics."

Danish, the 'lead' from Shopian, studied in Islaa College with Hilal "Yes, that is true, Hilal was barely my friend, just an old college-mate. Ten days before he disappeared, the forms for the Maulana Azad National Fellowship for Minority Students had been released. He called regarding some doubts he had about that scholarship. My roommate, a resident of Kangan, is studying Commerce so Hilal asked me to connect them. My roommate also knew him from college," the 'lead' stated.

Danish believes that his conversation was singled out because of Shopian's infamy and his from-Kangan roommate. "I was called in for questioning and I submitted my phone to the Deputy Superintendent of Police. Eventually they found out that we had only spoken about academics.

Even though he said that he 'hardly knows Hilal', Danish does not think that the scholar would ever lift

His roommate of two years, Umar, called Hilal a 'quiet type' who slept a lot. He informed that Hilal had invited their common friend, Qadri, to the trek after learning about it. "Since Qadri's leg/hand was

hurt, he declined the offer. But feels terribly guilty now," Umar mentioned.

When the police asked him if Hilal had any romantic inclinations, Umar said that having a girlfriend was never his priority. Hilal was immersed in his ambitions and would never miss a night's work. He worked in the graveyard shift at Admiral Group plc. "Hilal would always manage to almost-miss the cab because of his love for sleep," he chuckled.

Umar painted from his memory the picture of a notebook the scholar kept at Malviya Nagar. On one of its pages, Hilal had craftily written about His Dreams that one of their flatmates had caught a glimpse of.

An Unfamiliar Disappearance

Neither has there been any public announcement of his suspected recruitment to militant ranks nor have the police found a single alibi from their network of information. Yet

And the Four regret their trek. The siblings said in bitter sarcasm that they committed a mistake going for the hike that day. Now, every turn they take, they are followed by punishing looks and mistrusting faces. Their families only mourn their sons' ill-timed adventure and pity their luck.

Hilal's brother and family said that they have

Our parents raised us with passion, surviving many difficult times. Our mother dreamed of Hilal as a professor and so did he," Yasir said.

This titibit was boisterously shared among the flatmates as it reminded them of children's expression corners created on the backs of school notebooks.

He also vaguely remembered e-meeting Tabish when Hilal added him to their PUBG-team, "Hilal had friends, a decent social life. He was not lonely or facing any mental health issues. Our last conversation was about our plan to apply for jobs at the J&K Bank. He even sent me some online books to study for the same," he added.

Hilal was not cut out to be a militant, the roommate stressed.

"A funny type," he said, "Hilal would not follow anyone on Instagram. We once argued about that too and I had teasingly unfollowed him."

But @hilal_abdulbasit follows one person and there is no way to know 'who' for anyone who is not an existing follower. His uncle said that he had reason to believe there was a clue hidden there. "I do not know if the follower was added after his disappearance and I have appealed to the police to employ their ethical hackers to check. What if he is trying to tell us that he is alive? We need to know."

Unfortunately, the police have not checked or responded to his appeal. Yet.

"There is no case of militancy here. The child has always been studious and an excellent performer. He has won so many recognitions and was even setting his sail to Dubai after his best friend got a job there but we stopped him so that he was easily reachable," Sadiq said stressfully but excitedly.

What Has Been Done To Find Him?

The investigating officer at Kangan Police Station said that there was no reason that necessitated tracing Hilal's phone. "He was out of coverage when he 'stopped' and was 'lost'. Assuming that he has 'crossed the border', his SIM card won't work and hence is untraceable," Sub-Inspector Rashid de-

But there is no evidence that the scholar has crossed the border. Yet. Still.

"We have scaled the mountain 10-15 times to find him," the cop informed. "Recently, on August 24, a large group of police officers, SHO and DSP included, stayed near the lake for four days. We checked every obvious and non-obvious spot but have found noth-

He maintained that they have been on their toes at their best, desperately looking for a solid clue.

Has he left with a purpose or is a captive some-

been failed by hollow promises and sympathetic words. The system's uncooperativeness, they said, has broken their family.

"Every act is insincere and every appeal is unheard. We wander alone, sometimes with people who wish to help, to look for a sign or some direction that will lead us to him," Yasir sobbed. He said this as he was reaching the Kangan town

India is 'proud' to endorse US initiative on universal human rights

New Delhi; India on Wednesday said it is "proud" to endorse the US initiative on a joint statement on the Universal Declaration of Human Rights that recognises the many differences in national traditions and yet reaffirms fundamental freedoms and rights for all.

A joint statement, issued by the US, on the Universal Declaration of Human Rights (UDHR) said, "On the occasion of the 75th anniversary of the founding of the United Nations, We, the above listed signatories of the Universal Declaration of Human Rights, established and adopted in 1948, recommit ourselves today to the Declaration and its foundational ideal that certain principles are so fundamental as to apply to all human beings, everywhere, at all times.

"India is proud to endorse the US initiative on the Joint Statement on the Universal Declaration of Human Rights," India's Permanent Mission to the UN tweeted.

Other nations joining the US on the statement include Bahrain, Brazil, Democratic Republic of the Congo, Egypt, Iraq, Israel, Japan, Jordan, Maldives, Morocco, Saudi Arabia and the United Arab

'We recognise the many differences in our cultural, political, legal, religious, and other traditions, yet reaffirm fundamental freedoms and rights for all, and reassert our commitment to honouring the dignity of all persons that is the basis for our commitments under the UDHR, the joint statement said.

The Universal Declaration of Human Rights is a "milestone document" in the history of human rights.

Drafted by representatives with different legal and cultural backgrounds from all regions of the world, the Declaration was proclaimed by the UN General Assembly in Paris in December 1948 as a common standard of achievements for all peoples and all nations. It set out, for the first time, fundamental human rights to be universally protected.

The contribution of Indian reformer and educator Hansa Jivraj Mehta in ensuring a more gender sensitive language in the landmark Universal Declaration of Human Rights is widely lauded. But for Mehta's insistence, it could very well have been that the Universal Declaration of Human Rights may have been only the Universal Declaration of the Rights of Man

Chelsea owner donated over \$100m to Israeli settler group

Moscow: Russian billionaire and Chelsea football club owner Roman Abramovich donated more than \$100m to a far-right Israeli organisation that has been accused of displacing Palestinian families from Jerusalem, bank documents

The documents were part of a 22,000-page cache of reports sent to US authorities by banks between 2000 and 2017 that were leaked to Buzzfeed news. They show that over the last 15 years, four companies run by Abramovich donated \$100m to Elad, a right-wing Israeli settler organisation dedicated to "strengthening Israel's current and historic

connection to Jerusalem" The organisation has been responsible for scores of Palestinian evictions and has in some cases fought legal battles to do so, particularly in Silwan, a town annexed by Israel in 1967 that houses some 55,000 Palestinians.

The four companies Abramovich used to fund Elad - all located in the British Virgin Islands and registered on the same day in 2003 - funded more than half of the organisation's work between 2005 and 2018.

While Abramovich was suspected to have links to Elad, having been frequently present at their events, the extent of the football club owner's involvement was



not revealed until a set of bank reports - known as the "FinCEN Files" - about financial transactions and ownership of the companies were leaked, BBC News Arabic reported.

The documents, submitted to the US Treasury Department by the American branch of Deutsche Bank, showed that the oligarch is the ultimate beneficial owner of three of the companies and controls the fourth.

'Are people to be left to die?' Vaccine pleas fill UN summit

United Nations: If the United Nations was created from the ashes of World War II, what will be born from the global crisis of Covid-19?

Many world leaders at this week's virtual UN summit hope it will be a vaccine made available and affordable to all countries, rich and poor, But with the US, China and Russia opting out of a collaborative effort to develop and distribute a vaccine, and some rich nations striking deals with pharmaceutical companies to secure millions of potential doses, the UN pleas are plentiful but likely in vain.

"Are people to be left to die?" Honduran President Juan Orlando Hernández, a Covid-19 survivor, said of the uncertain way forward.

More than 150 countries have joined Covax, in which richer countries agree to buy into potential vaccines and help finance access for poorer ones.

But the absence of Washington, Beijing and Moscow means the response to a health crisis unlike any other in the UN's 75 years is short of truly being global. Instead, the three powers have made vague pledges of sharing any vaccine they develop, likely after helping their own citizens first.

This week's UN gathering could serve as a wake-up call, said Gayle Smith, president of the ONE Campaign, a nonprofit fighting preventable disease that's developing scorecards to measure how the world's most powerful nations are contributing to vaccine equity.

"It's not enough for only some G20 countries to realize that an equitable vaccine is the key to ending this virus and reopening the global economy," she said. With weeks remaining before a deadline for countries to join

"The pace and scope the #USIndia partnership continues to expand! Whether it's at @UN or with Quad partners, our growing security and diplomatic cooperation with India is vital to a free, open, and inclusive #IndoPacific," tweeted State Department for the Bureau of South and Central Asian Affairs (SCA)

Nobel Prize Cash Raised To \$1.1 Million

Stockholm, Sweden: The cash envelope that accompanies each Nobel prize will be increased this vear from nine to 10 million kronor (\$1.1 million), the Nobel Foundation said Thursday.

"The work done in recent years to strengthen the Nobel Foundation's financial standing has made it possible to increase the prize sum the foundation said in a statement. This year's prizes in the fields of medicine, physics, chemistry, literature, peace and economics will be announced during the week of

The prize sum was reduced from 10 to eight million Swedish kronor in 2011, when the foundation launched a programme to improve its finances.

Prize creator Alfred Nobel, an inventor and scholar who made a vast fortune from his invention of dynamite in 1866, decreed in his 1895 will that the bulk of his estate -- about 31.5 million Swedish kronor, equivalent today to about 2.2 hillion kronor (\$222 203 million euros) -- be invested to fund the prizes.

The Nobel Foundation has previously announced that the traditional award ceremony and banquet in Stockholm have been cancelled this year because of the coronavirus pandemic, replaced by a televised event with laureates receiving their prizes in their home countries.

to see what happens," Trump responded when asked at a White House press conference whether he is committed to the most basic tenet of democratic rule in the United States. Trump, who is currently

behind in the polls against Democratic challenger Joe Biden, then resumed his near daily complaint about the way the election is being organized.

Apparently referring to the increased use of mail-in ballots -- due to the coronavirus pandemic -- he said: "You know that I've been complaining very strongly about the ballots and the ballots are a disaster."



Trump frequently claims that mail-in ballots are vulnerable to mass fraud and are being encouraged by Democrats to rig the election. However, there is no evidence that ballots sent through the postal service have ever led to significant fraud in US elections.

Netanyahu Brings His Dirty Laundry To White House, Literally: Officials

to great lengths to conceal their dirty And then there's Prime

Minister Benjamin Netanyahu. Over the years, the Israeli leader has developed a reputation among the staff at the U.S. president's guesthouse for bringing special cargo on his trips to Washington: bags and suitcases full of dirty laundry, according to U.S. officials familiar with the matter.

The clothes are cleaned for the prime minister free of charge by the U.S. staff, a perk that is available to all foreign leaders but sparingly taken advantage of given the short stays of busy heads of state.

"The Netanyahus are the only ones who bring actual suitcases of dirty laundry for us to clean," said one U.S. official, who like others spoke on the condition of anonymity to



discuss the details of a foreign leader's visits. "After multiple trips, it became clear this was intentional.'

Israeli officials denied that Netanyahu overuses his American hosts' laundry services, calling the allegations "absurd," but they acknowledged that he has been the target of laundry-related accusations in

In 2016, Netanyahu sued his own office and Israel's attorney general in an effort to prevent the release of his laundry bills under the country's freedom of information act. The judge sided with Netanyahu, and the details of his laundry bills remain secret. The relatively minor ac-

cusation joins a longer list of corruption allegations that have threatened the 70-yearold leader's hold on power and triggered protests in Israel this month. Netanyahu was indicted in November in a corruption trial involving gifts from wealthy friends and allegations that he sought regulatory benefits for media magnates in return for positive coverage. SC Notice To UPSC, **Centre On Plea Seeking Postponement Of Exams**

The Supreme Cour Thursday sought response from the Centre and the Union Public Service Commission on a plea seeking postponement of civil services 2020 examinations in view of alarming spurt of CO-VID-19 pandemic and floods.

A bench of Justices A M Khanwilkar and Sanjiv Khanna issued notices to UPSC, Centre and posted the matter for hearing on September 28, 2020.

petitioners sought postponement of the Civil Services Exam for two to three months, so that the flood/incessant rains go away and COVID-19 curve flattens.

The plea filed by Vasireddy Govardhana Sai Prakash and others submitted that the decision of the UPSC to conduct the exam in accordance with the Revised Calendar, violates the rights of the petitioners and those similarly situated, under Article 19 (1) (g) of the Constitution to practice their chosen profession/occupation of serving the public.

The plea has been filed by 20 UPSC aspirants through advocate Alakh Alok Srivastava against conducting of the Civil Services (Preliminary) Examination on October 4.

According to the plea this seven hours long Offline exam, will be taken by approximately six lakh aspirants at test centres in 72 cities across the country.

"Conducting the aforesaid examination across India at such perilous time, is nothing else but putting lives of lakhs of young students (including Petitioners herein) at utmost risk and danger of disease and death. Also, the natural calamities like flood, incessant rain, landslides etc. are likely to directly affect the life and health of the



Petitioners and many similarly situated students.

"Hence, the impugned Revised Calendar is utterly arbitrary, unreasonable, whimsical and patently violative of the "Right to Health" and "Right to Life" of the Petitioners herein and lakhs of similarly situated students, under Article 21,' the petition stated.

The plea said the Civil Services Exam, being a recruitment examination, is altogether different from an academic examination and in the event of its postponement, there would not be any question of delay or loss of any academic session.

It said that due to nonavailability of exam centres in their hometowns, many aspirants are facing "unimaginable" hardship due to non-availability of or unsafe health conditions in, the PG accommodation/ hostels/ hotels etc., where they are forced to stay with their family members, once they are travelling to an outstation Examination Centre.

"It is pertinent to mention here that despite alarming spurt in COVID-19 pandemic, UPSC did not increase the number of Examination Centres, resulting into a situation where many candidates from rural areas will be forced to travel for around 300-400 Kilometres, in order to reach to their Examination Centres and there will be high probability of such aspirants, getting affected while using public transportation for such travel," the plea said.
