# **Remittances To India To Drop By** 9% In 2020: World Bank Report

WASHINGTON: The World as it affects migrants and their Bank on Thursday said remittances to India would fall this

year by nine per cent to USD 76 billion due to the ongoing coronavirus pandemic and global economic recession.

India followed by China, Mexico, the Philippines, and Egypt continue to be the top five countries in 2020 to receive foreign remittances, the World

Bank said in its latest report. As the COVID-19 pandemic and economic crisis continues, the amount of money migrant the decline in remittances inworkers send home is

termed the move akin to putting Jammu and Kashmir up for sale. PDP president Mehbooba Mufti tried to reach the PDP office, but was asked by the police to return to her residence.

Addressing reporters at her Gupkar residence, Mehbooba said the party leaders were protesting the new land laws, but no one was allowed to speak in Kashmir.

"Our protest was against the laws passed for looting the resources of Jammu and Kashmir But no one is allowed to speak here," she said accusing the BJP of pursuing communal agenda.

"PDP's @parawahid, Khurshid Alam, Rouf Bhat, @MohsinQayoom\_ & @ buttkout were arrested by J&K police for protesting against the settler colonial land laws thrusted upon people of J&K. We will continue to raise our voice collectively & won't tolerate attempts to change demographics, the PDP leader tweeted earlier.

Meanwhile, all the detained leaders were released from police station Kothi Bagh after signing surety bonds at a local court here, a local news agency KDC reported.

An order issued in this regard by Executive Magistrate Ist Class (Tehsildar South Srinagar) reads, " Surety persons have appeared before this court and gave written surety bonds to the tune of Rs 10,000 As such you are hereby directed to release the accused persons who are under judicial custody."

Asserting that it was not a crime to seek constitutional rights through peaceful and democratic means, he said, "Today, there was a peaceful protest against the new (amended) land laws (by PDP) but it was not allowed. Are we wrong in seeking our right within the Constitution and peacefully?"

Abdullah said last year after the Lok Sabha elections, political parties had expected that assembly elections will be held in Jammu and Kashmir.

"But today we are fighting for our identity. Shame on those of us who are still hankering after power. It is no more about power," he said. About the formation of the People's Alliance, he said the Centre has

been using "all kinds of tricks" to "weaken and divide us". "I wish we had forged an alliance earlier. Maybe we could have avoided

the situation (revocation of special status of Jammu and Kashmir)," he said, adding "Whatever we are facing today is because of that weakened voice. We were divided and they implemented their plan, our voice got weakened and they attempted to erase our identity".

He further said those making "tall claims about merging Jammu and Kashmir with India are still indulging in step-motherly treatment with us", saying the land amendments done earlier this week were an application of the land amendments done earlier the say of example for that.

The former Chief Minister also said that many states especially in the northeast have special laws relating to land ownership whereby people from other parts of the country cannot buy land there, and questioned why the Jammu and Kashmir could not have similar laws.

"There are many states like Himachal Pardesh, Sikkim, Meghalaya, Nagaland and union territories where no Indian can go and buy land even today," the former chief minister said.

'Why is it only us who become anti-national when we talk of these laws? Why are there no media debates when similar voices (for special provisions) are raised from other states?" he asked.

The authorities are evidently targeting these civil society and media groups because of their continued work reporting and advocating for the rights of the people of Jammu and Kashmir despite a harsh communications blackout that was imposed by the Indian government in the region since 5 August 2019," said Julie Verhaar, Acting Secretary General of Amnesty International in a statement.

"In a worrying pattern, the UAPA and the foreign funding law are being repeatedly and deliberately weaponized to intimidate, harass and restrict the ability of civil society groups from operating, in clear violation of their rights to freedom of expression and association," she added.

The statement further said that the raids come after Amnesty International India was forced to halt its work and let go of its employees in the country from 1 October 2020 after its bank accounts were frozen by the government, shortly after it released a Situation Update on human rights in Jammu & Kashmir.

Since 2014, the Amnesty statement said several organizations have been "targeted" under the foreign funding law, including Greenpeace India, Lawyers Collective, Centre for Promotion of Social Concerns, Sabrang Trust, Navsarjan Trust, Act Now for Harmony and Democracy, NGO Hazards Centre, and Indian Social Action Forum.

"In September 2020, amidst the COVID-19 pandemic, the FCRA was further amended, without any public consultation, to choke civil society in India," the Amnesty statement said.

"By directly attacking and failing to protect civil society organizations organisations, India stands in a clear violation of its human rights obligations, particularly Articles 19 and 22 of the International Covenant of the Civil and Political Rights (ICCPR), to which it's a state party," it added.

Srinagar has been the worst affected district by COVID-19 in Jammu and Kashmir with nearly 19,000 persons infected so far and 348 deaths due to the pandemic.

The district has 1,651 active cases as compared to 5,300 in the remaining 19 districts of the union territory.

Khan said a wider sero-survey is underway across the remaining nine districts of Kashmir valley where 400 samples have been collected from each district.

"The results are expected to come within two weeks from now," he added.

Jammu and Kashmir has witnessed nearly 85,000 COVID infections and 1,455 deaths so far due to the pandemic

According to officials, seven more people succumbed to Covid-19 in Kashmir vallev, while four more died of the virus in Jammu division. The victims from the valley included two women from Chattergam and Lal Bazar here, besides five men hailing from Budgam, Baramulla and Srinagar districts. Three among the victims from Srinagar were resi-

dents of Shalimar, Chanpora and Bemina The victims from Jammu region include a 44-year-old man from Bakshinagar Jammu and two persons from Udhampur besides one from Rajouri.

With these deaths, the fatality count has reached 975 in Valley and 492 in Jammu region.

"Kashmir has been turned into a jail. Nobody is allowed to express himself. Neither journalists or allowed to talk, nor civil society and politicians. People in Bihar demand jobs and food from BIP and this party tells them to go to Kashmir and purchase land there. BIP can't think beyond elections. It is befooling people and using Kashmir in every election," Mehbooba told media at her Gupkar residence. She said that the Government of India has communal intention with

regard to Kashmir. The former Chief Minister also criticised BIP's silence over the land occupied and China and using muscle power on the people of Kashmir. "Go and get the land occupied by China that has killed so many soldiers. No, BJP can't and won't do this because it can't overpower China. It is suppressing the helpless people of Kashmir," she said.

Mehbooba also claimed that her party workers, who were planning to stage protests against the new land laws, were arrested from their homes during night hours.

"Our office was sealed. There is complete lawlessness and people have been caged," she said.

She said people of Jammu and Ladakh have started coming around to the views of people of Kashmir.

"BIP wants to loot the land and resources of Jammu and Kashmir. People of Ladakh were airlifted to Delhi when they started protesting against the BJP's diktats. They want to loot everything from Kashmir and we won't allow them to do so," the PDP President said.

She said everybody is not a Twitter politician and she will hit roads against the diktats that are coming from New Delhi.

"Every day BJP issues new 'Farmaans'. Sometimes they violate domicile rules and sometimes put our land on sale. We won't remain silent, come what may," she said.

The ex-CM further said that BJP was not doing this for common masses but to appease the capitalists of India.

"A poor who lacks food and clothes can't buy land here but this new land law diktat is for those rich capitalists who are hand in glove with the BIP." she said.

"Today you stopped us using muscle power, tomorrow you will fail. People will respond to you in a big way," she said.

Mehbooba Mufti said that Kashmiris were never in good books of New Delhi and BJP but now this (BJP govt) have started targeting people of Jammu and Ladakh too.

"Whatever India did here was unconstitutional, illegal and irrigational," she said, adding that Modi has ruined the whole country and BJP's communal intent is clear now.

Mehbooba concluded her briefing with the couplet: "Sarfaroshi ki tamanna ab hamare dil mein hai, dekhna ki zor kitna baazu-e-qatil mein hai." (The desire for revolution is in our hearts, we shall see how much strength lies in the arms of the enemy.)

The NIA spokesperson said several incriminating documents and electronic devices have been seized during the searches.

Reacting to the raids, Khan said his home and offices were raided by the NIA this morning from 7-11 am during which the officials took many papers, all laptops, hard disks of all desktops, cash found etc.

They showed me an order on their mobile, issued by one Yadav of NIA to conduct the raid linking me and my NGO with Kashmir terror," he said. Khan said he had "no relationship or even contacts with Kashmiri militants and have not even visited Kashmir for many years. "It seems an attempt to implicate me in some terror or riot case," he tweeted.

He said he has been "thrown to stone age. No laptop, no mobile, no desktop. The NIA people said order for raid came from the very top and they were woken up at 4 am for this great task of raiding a journalist. They had no patience. They jumped the wall to enter my house like they did with (PC) Chidambram."

The People's Alliance for Gupkar Declaration (PAGD) also strongly condemned the NIA raids at the offices of prominent English daily Greater Kashmir and a number of NGOs in Kashmir.

Terming the raids by the NIA as part of political vendetta against the people, the PAGD cautioned the Centre that the raids were "unwarranted" and "unjustified".

"The consequent harassment is bound to deepen uncertainty and alienation of the people and urged it to desist from such vindictive measures," the amalgam of seven mainstream parties, including the NC and PDP, said.

The NIA had on Wednesday searched 10 locations in the Valley and one in Bangalore in connection with the same case of diversion of funds.

Those whose premises were searched include Khurram Parvez (coordinator of the J&K Coalition of Civil Society), his associates Parvez Ahmad Bukhari, Parvez Ahmad Matta and Bangalore-based associate Swati Sheshadri as well as Parveena Ahanger, chairperson of the Association of Parents of Disappeared Persons (APDP).

The offices of the NGO Athrout and GK Trust, owned by prominent English daily Greater Kashmir's Fayaz Kaloo, were also searched, the statement added.

The APDP issued a statement saying all information and material sought by the raiding team was provided to them. "The team examined all documents relating to APDP's work. They subsequently seized several documents and some electronic devices. Ahanagar's (heading APDP) mobile phones were also seized," the statement said.

They alleged that the documents and devices seized by the NIA team contain details of the names, identities and incidents of human rights abuses by security personnel.

There is a grave apprehension that the same may be accessed by other agencies, and/or lead to adverse consequences and reprisal against victims and families who have testified and are pursuing justice," it said. The statement further said the APDP neither receives foreign funding nor engages in any illegal activities and the raid has no basis and only "exposes the state's desperation to deter APDP from pursuing justice for hundreds of victims of human rights violations committed by state actors in Kashmir."

#### Amnesty Calls For An End...


He also took stock of the developmental works there and directed the project authorities to expedite the pace of work to complete the project in a set time frame.

OPORE: Security forces have unleashed terror at Watlab on Sopore-Bandipore road for the past four days in the wake of a recent landmine explosion in which a securityman, Suresh Ku¬mar, was killed. People in general and the commuters and em-ployees in particular are scared travelling on the route for fear of being belaboured by the personnel of 15 RR deployed at Watlab.

Evewitnesses told Observer News Service the passengers are brought down from the buses and forced to walk over a distance of three kilometres on either side of Watlab. The Ban¬dipore-bound passengers are forced to disembark at Warpora and made to foot the distance upto Sangri top. Likewise, the Sopore-bound passengers have to come down at Watlab and walk three kilometres upto to Warpora.

Lending a sadistic touch to the torment, eyewitnesses al-leged, the security forces force the passengers, both men and women, to carry their luggage over their head all through the 3-km ordeal

They said many transporters were reluctant to ply their ve¬hicles of the route compouding the people's problems further

Reports said the hospital authorities here referred a villag-er of Botengoo to Srinagar after his condition deterio rated fol¬lowing several dog bites. He had been beaten by the security forces at the Watlab camp after which dogs were set at him. He was brought to the sub district hospital where doctors re-ferred him to Srinagar with multiple dog bites

# Srinagar Sero-Survey

he latest seroprevalence study carried out by the Government Medical College Srinagar (GMC) in Srinagar district has revealed that over 40 per cent people living in Srinagar district have developed COVID-19 antibodies. This means that a large segment of the population in the city have been infected by the Covid-19. A serosurvey tests the blood serum of people to identify the existence of antibodies against a Coronavirus infection.

The new study reveals a 3.8 per cent jump in seroprevalence over a similar study conducted in the district in June. The samples were taken randomly from 20 clusters in Srinagar district. In the survey over 40 per cent of the 2,400 persons tested negative but had developed antibodies. Significantly, a higher prevalence of antibodies was found in the female population than males.

But the doctors are skeptical about the herd immunity setting in anytime soon. Herd immunity is expected to occur after a large number of people, usually 70 to 90 per cent, become immune to a contagious disease after being infected by it. So, it will need many more people to be infected by the contagion for people in the Valley to develop immunity. But at the same time it is still premature to say if herd immunity will work against the novel Coronavirus.

Srinagar has so far recorded 19000 infections and 348 deaths making it the worst affected district by COVID-19 in J&K. As of now, the district has 1,651 active cases as compared to 5,300 in the remaining 19 districts of the union territory. J&K, as a whole, has witnessed nearly 85,000 COVID infections so far and 1,455 deaths.

Going forward the situation doesn't give any confidence. With winter setting in, the number of cases are going to be far too many in near future to be handled by our doctors. More so, when the community transmission has already set in. The situation, we are given to believe, has aggravated after the government took steps to open up the economy. And which is also important. It is not possible for people to remain in a perpetual state of lockdown. This has already wrought havoc with the economy. More so, in Valley which has been under lockdown for the past twelve months. This has led to a loss of employment for thousands of people. The vital sectors of our economy like tourism, horticulture, handicrafts have been hit hard. So, resorting to lockdown is not an option. What the administration can do and which is eminently possible is to create more awareness about social distancing norms and take action against the people and the businessmen who violate it. It is time people are made responsible for their own health. We have to ensure that both life and livelihood are saved.

And to this end, the government will have to run an ag-

# Religion and Secularism: A Misleading Dichotomy

he recent incident of beheading of a teacher in France, as a reaction to the images of the Prophet Muhammad, shown by a history teacher, that had first been published by the satirical magazine Charlie Hebdo (Pailliez, 2020), and then a racist attack on two Muslim women at Eiffel Tower in the same country in quick succession have further exposed the fault lines vis a vis the debate on Secularism. In addition to that, the remarks of the French President serves a reminder that the debate around Secularism continues to be a point of contention across the globe for decades now and it seems far from settled.

#### **Three Erroneous Linkages**

Against this backdrop, the questions around the configuration of relationship between religion and the state assume a momentum of another kind. However, three commonly erroneous affixations and links that bedeck the discussion around the relationship of religion and politics in democracies can be sensed in the present moment too and should be addressed at the earliest. One is to do with the misplaced linkage drawn between liberalism and secularism, while branding everything that is wrong with secularism under the "Liberal" tag- this without stopping to care for explaining what the term actually implies. So much so, that secularism is being essentialised as an attribute of Liberalism, which is logically incorrect. Secondly, secularism is being understood as another definitive feature of democracy, which again shows the extent to which the idea of secularism is central to one's understanding of democracy, but it nonetheless is a misleading linkage and we can have democracies that exist independent of secularism and yet can fit the definition of a functional democracy. At the same time, we can have non-liberal states that are secular too. Third, is the very concept of secularism and its relationship with religion. More often than not, secularism is being understood as the chucking out the religion out of the public sphere, thus calling for greater privatization of religion. Again, this is only one way of understanding secularism, and strictly speaking this has never been the dominant strand within political theory and practice, when one studies how various states operationalize the concept of Secularism.

Now, before proceeding further, it is pertinent to mention, that so far, the three erroneous links that have been listed, is not to deny the limitations in the concept of Secularism or a crisis brooding within for democracies on account of secular exhaustion. This, therefore should just be seen as an attempt to simplify certain misconceptions around the idea of secularism, to attain the clarity of air around the linkages that we tend to draw, often carelessly. We often employ the three words: 'democracy', 'liberalism' and 'Secularism' in the same breath, which might at times unnecessarily and unfairly burden one term with the con ceptual weight of the other. It also must be remembered that Secularism in function clearly predates the rise of Liberal democracies. The corporatisation of religion, even within liberalism is a much later development and has often been contested even internally. Even Liberal thinkers differ on the terms of relationship between religion and the state- therefore one must abstain from referring to liberal as a monolith tag. It is also possible for the state to exist relatively autonomous of the religion and that can well work without eliminating religion from the public sphere. Afterall, what is secularism but the idea that the state or the political authority shall exist in such a way that it does not have to depend on nor derive its legitimacy from the religious authority, plainly speaking. For this to be made possible, one does not require the absence of religion at all from the public sphere, nor the invisibilisation or demeaning of the same.

and second, religion in terms of not just beliefs and practices, but in terms of identity and the claims emanating from the same. Hence, the crisis of secularism is not a reaction against the excess of certain religious identities but the refusal to accommodate or acknowledge a set of other religious identities within the political discourse on part of the state and the social hostility towards it. In simple words, the problem is not why a state is for example funding a church or a temple, but rather why is the same measure being denied to say a mosque, for that matter.

Further, while Secularism can be practiced in diverse modes, to simply do away with it by attributing it to the West entirely is again an illfounded argument; for it is true that Secularism arose in the West due to the demands thrown up by the political conditions of the time; however, by referring to it as a Western idea- it not only obliterates the contestations and diverse debates around secularism within the West itself but it also reduces the internal diversity intrinsic to the practice of secularism as seen from the differential experiences of many countries, to a homogenous practice redacted of its diverse historical and cultural contexts. As a simple example, Secularism in the US would be different than say the one being practiced in France or UK or Germany and these models come with its own distinct set of problems.

#### Cultural Racism and Deepening Faultlines

One final word on the existing framework employed to understand secularism: while the debates around secularism find themselves strongly opted within the tradition of toleration, one must at the same time remember that it is this tradition which also sets the limits on the working of secularism. For instance, when it comes to religious toleration, the premise inevitably fixes itself around the distinction particular identity comes to be racialised will be an error of judgement. Thus, Islamophobia is not just a form of intolerance; it has gone beyond that years ago, rather it is a form of racism. The tradition of toleration will do little to help us understand this and deal with certain chain reactions as these, for here the question is less about one's religious beliefs and practices and more about the people marked by religious identity. It is needless to say that no amount of violence can be justified as a reaction to any expression that one finds hurtful or hurts the religious sentiments of a community, and at the same time a multilogue is essential to understand why are certain points hurtful for a community within the domain of freedom of enquiry. No one is arguing that one's religion is beyond questioning and yet it is pertinent to reiterate that the freedom of enquiry can be exercised in ways that do not have to be necessarily hostile or hurtful to a particular community.

The Charlie Hebdo attacks in 2015 and the later analysis that followed was a stark reminder that behind the simple facts of the case was a larger narrative about the alienation of the Algerian Muslim community in France and its perception that French secularism was being interpreted in a way that was meant to specifically humiliate and disenfranchise them. Further, the cartoons in the Charlie Hebdo magazine are analogous to the ethnic cartoons of Jews in Nazi Germany or the be speckled, buck-toothed drawings of Japanese in American World War II posters. These kinds of images demean a whole race or culture. (Juergensmeyer, 2017). The question then arises- should we be comfortable with a culture that sees no issues with racializing a particular identity or not mind the same because that is the acceptable sense of humour in that culture? For instance, questioning ho-

of religious beliefs and practices and therefore any incident of "intolerance" is countered by questioning the religious beliefs and practices approved of within that religion, in the name of which perpetrator of intolerance acts or commits the hate crimes. This is not helpful however, and is limiting in many ways.

The tradition of toleration not only makes one oblivious to the domain of religion as identity and the force of religious identity, it also renders the entire debate more around individuals and less about the groups and communities, in addition to arguing for maintaining strict lines of divide between the public and the private. If one then follows the arguments within the tradition of toleration, one will fail to situate the hate crimes so committed as a form of racism, or cultural racism to be precise. However, what makes these attacks racist, is that they emanate from a hatred directed against the people of a particular religious identity, and while religious beliefs and practices can and do overlap with religious identity and are often a source of the same, these attacks more often than not are not really a litmus test of how true one is as a Muslim or a Christian vis a vis the practices. One's name or symbol that marks one's religious identity is enough to make one the recipient of such hate. Hence forcing one community to take an apologetic stance, invoking the authenticity of approval around their religious beliefs or practices in the midst of such spree of incidents is not really a solution, when the problem is not really about the beliefs and practices but beyond it. For example, when one talks about the recent beheading incident, here, it is also important to situate the incident in the context of cultural racism and Islamophobia, where in Muslims have been at the receiving end for a long time now. Say for example, commenting on such incidents committed out of hate for a particular community, without taking into account the historical context against which a

locaust or the holocaust denial is hurtful and extremely insensitive and is thus punishable in sixteen European nations as well; on similar lines there can be certain issues to which certain other communities can be sensitive about and a dialogue to understand this, while institutionalising this process of understanding would do no harm to anyone.

Such incidents or acts committed out of hate cannot really be seen at the level of individual alone, while you want the entire community to apologise for the same despite being comfortable with the culture of alienation that you impose upon them- for it obfuscates at times genuine grievances and the chain re action that perpetuated those grievances for a period of time. If a set of thinkers started batting for a separation of church and state in sixteenth and seventeenth century, it was not in relation to a particular radical individual unleashing violence in the name of religion- it was in relation to a confluence of events rooted in sectarian conflict and a chain of incidents linked to the same. The refusal to acknowledge the same would be of no avail in understanding the gravity of the situation and the pragmatic solution that the tradition of toleration brought for the people in that particular time period. And while we must be mindful of the same, in the present moment certainly the situation has changed and a lot of other factors have come into play which must be taken into account and not denied, for a viable solution to be thought of suited to the need and demands of the time- one that is inclusive and does not look down upon any particular identity, or does not require the breeding ground of demeaning the other, for it to thrive on

gressive awareness campaign about the disease. It has to also work towards involvement of the community by charging village, locality elders, mosque managements etc to ensure people follow the safety precautions. Government should also enlist the youth for the purpose. This will go a long way to make a redeeming difference to the attitude of the people towards the contagion and in turn arresting its spread.

# J&K realty

he centre appears determined to go out of its way to court anger in Jammu and Kashmir, as if to convey to the people there that they are completely incidental to its plans for the one-year-old Union Territory. The new land laws notified on October 27, like the new domicile rules notified in April, do nothing to assure the people of the former state that their concerns on demographic change are being taken into consideration. Lt. Governor Manoj Sinha telling people, as late as the morning of the notification, to "rest assured" that no land would be sold to outsiders flies in the face of the notification that opens out J&K land for sale to anyone from any other part of the country, with no protections whatsoever. There are 23 petitions in the Supreme Court challenging the Centre's August 5, 2019 decision, revoking the special status of J&K and bifurcating the state into the Union Territories of J&K and Ladakh. It would have been proper for the government to wait for the court to pronounce a verdict on these petitions, last heard in March, instead of creating a fait accompli on the ground.

If the Centre had hoped J&K's political parties might reconcile themselves to the August 5, 2019 decisions, the changes to the land rules have made it even more difficult for them to do that. In a place where people have come to view the government's every action as an assault on their ethnic, political and religious identity, land rights take on huge significance. The sentiment was reflected in the reactions of all political parties in J&K. The People's Alliance for Gupkar Declaration called it a "massive assault" on the rights of the people. Fears of demographic change have haunted the people of Ladakh, too, and the J&K notification would have sent shock waves through the newly elected councillors of the Leh-Ladakh Autonomous Hill Development Council. But it is in BJP-dominated Jammu that the feeling of having been let down by its own is most predominant.

From August 5, 2019, the government's actions in J&K have smacked of hubris, as if to say, "we do what we do because we can". That may win some elections for the BJP, but it is not a solution to the longstanding problems in Kashmir. Prime Minister Narendra Modi and Union Home Minister Amit Shah had assured that there is no plan to change the demography of J&K and that the Centre would take all steps to protect employment and land rights of the people. These assurances have to be written into the law to prevent further alienation of the people of J&K.

# Let's reclaim the spirit of Eid-e-Milad

**The ultimate meaning** of the Milad prayers and remembrance of God and the Prophet (SAW) should enable us to reorient ourselves towards enduring nobler and spiritual dimensions. But, given that most of us will revert to quotidian lives and forget the spiritual dimension of the Milad, our devotion and prayers will cease to be meaningful, unless it affects a change in our orientations.

'n the deserts of Arabia, about 15 centuries ago, in 570 AD, a supremely creative and paradigm shattering historical (even trans-historical) event with eschatological implications happened. The consequences of this event were far reaching: a world historical civilization was borne-one that transformed not only the environs of Arabia but the whole world. This event was the birth of the Holy Prophet of Islam, Prophet Muhammad (SAW). The day that the Great Prophet of Islam was born was later called the Eid Milaad un Nabi. Eid Milad un Nabi(SAW)will be celebrated with fervor and gaiety on the 24th of December, 2015. Prophet Muhammad (SAW) was rahma(t)(mercy) for the entire mankind. The message that he brought from God through Arch Angel Jibraeel was that of monotheism, peace, amity and a value system defined and characterized by truth equality, equity, and justice. He (SAW) taught mankind these values by example and deed. Belief in One God (monotheism) and His Messenger (SAW), Peace, Justice, Equality, Compassion for all Creation, a metaphysical dimension, were and are the essential and defining characteristics of Islam.

But . these fine attributes , are a legacy of the past- a past that was defined by the cosmogony of Sufi Islam and the centrality of the Prophet(SAW) in our lives. We cannot really afford to rest on the residual legacy of these. We need to and must re-inculcate these fine values and value system in our collective and individual selves

Now coming back to the theme of Eid Milad un Nabi: this day will be celebrated with great festivity, fervor and nobility of spirit in Kashmir. Thousands will flock to the Durgah at Hazratbal, and other shrines to remember the Prophet (SAW) and make special devotional prayers. Many will endure the bitter cold wintry nights and pray. They will be spiritually uplifted but alas the enlightenment accruing from this spiritual odyssey will be ephemeral. It will not last long. We will after the Milad celebrations are over revert to our usual selves. This, in the final analysis, constitutes a travesty. The ultimate meaning of the Milad prayers and remembrance of God and the Prophet (SAW) should enable us to reorient ourselves towards enduring nobler and spiritual dimensions. But, given that most of us will revert to quotidian lives and forget the spiritual dimension of the Milad, our devotion and prayers will cease to be meaningful, unless it affects a change in our orientations.

So, on this Milad un Nabi, let us all make that extra effort and resolve to make self purification, self transcendence and self transformation our end goals. This can only happen if we seriously introspect and take to heart the teachings of our Great Prophet(SAW). To repeat, the essential components of his(SAW) message were Compassion, Honesty, Truth, Equality and Justice- ideas and themes that have over time become largely notional for us. This notional fidelity to these great moral and spiritual ideas and ideals has meant that we, as both society and individuals, have to a degree, lost our compass and bearing. The saving grace is that all is not lost. We can reclaim the spirit and essence of the Prophet's teachings. Key here is sincerity of purpose and fidelity. This would constitute real love for the Prophet (SAW): not mere mechanical and ritualistic incantations and behavior. So, on the Milad un Nabi, let us disavow the cosmetic and focus on the real and the substantive.

## a deliberate provocation to further demean Islam

hen you type "respect" in the online Cambridge dictionary search section, you will get this: "admiration felt or shown for someone or something that you believe has good ideas or qualities". It is a natural tendency to admire good things or behaviour, and it is also natural to feel uncomfortable with people who have the tendency to intentionally disrespect a culture, religion or language. Therefore, the reaction of the Muslim world to the caricatures of the prophet Mohammad (pbub) is nothing but a natural reaction to an act of utter disrespect by some people in various countries especially France and Denmark. The blasphemous images were published by countries like Denmark, France, Germany, Italy, the Netherlands, Spain, Switzerland, and Norway. These countries also house some of the most respected educated communities in the world with a backbone of some of the top ranked educational establishments, and yet they have shown no respect for Muslims by constantly engaging in demeaning the image of Islam.

Isn't this contradictory to the basic tenants of education? How can someone deliberately indulge in spreading hate against religious personalities, even though they may disagree with their teachings? Isn't a routine to agree and disagree on a scientific research problem, and that behaviour is not seen an insult to scholarly community standard but often praised for raising some of the critical questions that otherwise would have remained untouched. But the sanity of those communications remains intact in the ability to argue without engaging in name calling.

Who abuses: someone who has lost the power to communicate sensibly, or someone who is deliberately doing it to fulfil a set agenda. Therefore, it is safe to argue that the wave of atrocities on Muslims and the attack on Islam is a pre-planned and is an organized campaign that will not end anytime soon. How can it end when the motive is to generate a mass hysteria about Islam in the entire world, and this has started decades ago with 9/11 attack in America as a recent incident that fuelled its rise.

Interestingly, the religion of Islam is not about hate but peace and was founded to bring justice in the world and it proclaims that no living or nonliving entities should be worshipped expect Allah, the one God that controls what is hidden and what is revealed. How ironic that those who have power at their disposal feel threatened by powerless Muslims

just because Islam teaches self-respect and obedience to Allah and his emissaries. For them, this means that a typical Muslim cannot be tamed. Historically, Muslims have emerged winners after each struggle and the life of Prophet Mohammad (peace be upon him) is the best example of perseverance and truthfulness to achieve the goal of enlightening the world about the message that Islam has for the known and unknown worlds.

It is clear that people who have published the cari-

catures of the beloved Prophet Mohammad (pbuh) are well aware about the reaction from the Muslims. It seems that the plan is to deliberately provoke with a motivation to further demean Islam. This becomes clear when we see double standards with respect to Muslims especially their life style. For example, the call for ban on the Muslim women head and face cover has been one of the most intensely debated questions in French society. Why? Because the society argues that the Muslim women's veil is a form of oppression, and therefore they have the right to protect the fellow citizens from the religious oppression enacted upon them by Muslim men. Strangely enough, this they are doing without asking the Muslim women about their opinion on why they are practicing veil, and thereby directly contradicting and violating their own French constitution which guarantees equal rights to women, and secular life to all without distinction of origin, race or religion. Here is the text from the French constitution: "France shall be an indivisible, secular, democratic and social Republic. It shall ensure the equality of all citizens before the law, without distinction of origin, race or religion. It shall respect all beliefs. It shall be organised on a decentralized basis. Statutes shall promote equal access by women and men to elective offices and posts as well as to position of professional and social responsibility.'

French President recently said "Islam is a religion that is in crisis all over the world today, we are not just seeing this in our country", and this cannot come out of blue and must be part of the anti-Muslim rhetoric that has become part of his life now. The various unfortunate attacks by people affiliated with Islam have helped such hate mongering, and therefore, it is important to investigate such barbaric attacks and connect the dots to understand the full picture of who is doing it and why. Until then it will continue and Islam will be used frequently and particularly during the election times.

A Nigerian-American writer and photographer, aptly summed it up Facebook. They wrote, "The people of Charlie –who in my view were simultaneously the victims of a terrifying, unspeakable crime, and the producers of an antic and gross publication (nothing wrong with that) that was at the same time deeply prejudiced – finally step away from the mask of 'it's satire and you don't get it' to state clearly that Muslims, all of them, no matter how integrated, are the enemy," he said.

"Reading this extraordinary editorial by Charlie, it's hard not to recall the vicious development of 'the Jewish question' in Europe and the horrifying persecution it resulted in. Charlie's logic is frighteningly similar: that there are no innocent Muslims, that 'something must be done' about these people, regardless of their likability, their peacefulness, or their personal repudiation of violence. Such categorisation of an entire community as an insidious poison is a move we have seen before."

# **Workplace Interruptions Lead To Physical Stress**

nterruptions in the workplace may lead to physical stress, suggested a study.

If this stress becomes chronic, it can lead to states of exhaustion that have a negative impact on public health and carry a significant economic cost.

The study was published in the journal Psychoneuroendocrinology. According to the Job Stress Index 2020 compiled by Stiftung Gesundheitsforderung Schweiz, a Swiss health foundation, almost one-third of the Swiss workforce experience work-related stress.

In a digital early warning system at the Mobiliar Lab for Analytics at ETH Zurich, an interdisciplinary team is working to pre-empt such states of exhaustion by developing a digital early warning system that uses machine learning to detect stress in the workplace in real-time.

"Our first step was to find out how to measure the effects of social pressure and interruptions two of the most common causes of stress in the workplace," said psychologist Jasmine Kerr. The difference between the two stress groups was that participants in the first group stopped work only to have samples of their saliva taken. But the participants in the second stress group had to contend with additional interruptions in the form of chat messages from their superiors urgently requesting information.

Upon evaluation, the data indicated that asking participants to compete for a fictional promotion was enough to raise their heart rate and trigger the release of cortisol. "Participants in the second stress group released almost twice the level of cortisol as those in the first stress group," Nagelin said. What surprised the researchers were participants' subjective responses in terms of how they perceived psychological stress. They observed that participants in the second stress group, who were interrupted by chat messages, reported being less stressed and in a better mood than the participants in the first stress group, who did not have these interruptions.

Interestingly, although the two groups rated the situation as equally challenging, the second group found it less threatening. The researchers inferred that the release of cortisol triggered by the additional interruptions mobilised more physical resources, which in turn led to a better emotional and cognitive response to stress. # **Economic Recovery Faster Than Expected, Confident Of Meeting** \$5-Trn Target By 2024: Pm Modi

NEW DELHI: The Indian economy is getting back on track faster than expected as a timely lockdown and various relief measures announced by the government helped address issues faced by all sections of society and all economic sectors due to the COVID-19 pandemic, Prime Minister Narendra Modi has said.

He also expressed confidence that the target of making India a USD 5-trillion economy will be achieved by 2024, saying that the crisis gave the government an opportunity to carry out reforms that were waiting to happen for decades but no one earlier took the initiative.

"Reforms across sectors such as coal, agriculture, labour, defence, civil aviation and so on have been undertaken which will help us get back on the high growth path that we were on before the crisis," Modi said in an interview published in the Economic Times newspaper on Thursday.

On COVID-19 vaccine, he said every Indian will be vaccinated as and when a vaccine becomes available, though the focus initially would be on protecting the most vulnerable and the frontline workers.

Modi reiterated that there should be no room for complacency in fighting this virus and the only way forward is to take precautions such as wearing masks, hand washing and social distancing.

He said the government in the very beginning decided to be proactive and introduced a timely nationwide lockdown.



# **India Condemns** "Personal Attacks" On Macron, Criticised For **Islam Remarks**

NEW DELHI: India on Wednesday strongly condemned the personal attacks against French President Emmanuel Macron after his tough stance on radical Islam, calling it "a violation of the most basic standards of international discourse".

In a strongly-worded statement, the Foreign Ministry also condemned the brutal terrorist attack that killed a French teacher, and said "there is no justification for terrorism for any reason or under any circumstance"

"We strongly deplore the personal attacks in unacceptable language on President Emmanuel Macron in violation of the most basic standards of international discourse," the MEA said.

"We also condemn the brutal terrorist attack that took the life of a French teacher in a gruesome manner that has shocked the world. We offer our condolences to his family and the people of France," it said.

After the statement, French Ambassador to India Emmanuel Lenain thanked India saying both countries can count on



each other in the fight against terrorism. "Thank you @MEAIndia. France and India can always count on each other in the fight against terrorism," he tweeted. Macron has been facing criticism from various Muslimmajority countries after he took a tough stand on radical Islam and defended cartoons of the Prophet Muhammad. The French President said that Islam was a religion in "crisis".

His comments came in the backdrop of the beheading of French teacher Samuel Paty on October 16 outside Paris in broad daylight. He had shown caricatures of the Prophet Muhammad to his students.



MUMBAI: Next time if you are caught without a face mask in public in Mumbai, get ready to sweep roads as part of community service if you fail to pay fine to the city civic body.

The Brihanmumbai Municipal Corporation (BMC) is making violators do community service in the form of sweeping roads if they are reluctant to pay Rs 200 as fine for not wearing masks in public places, according to civic officials.

In view of the coronavirus pandemic, authorities have made wearing of face masks mandatory in public to curb the spread of the infection.

The K-West civic ward, which includes areas like Andheri West, Juhu and Varsova, has already made several violators sweep roads for an hour to deter people from roaming around without a mask.

Vishwas Mote, assistant municipal commissioner (K-West ward), told PTI on Thursday that since the past

"On realising that they made a mistake by not wearing face mask, some people readily agree to do community service," the official said.

Aiming to control the pandemic, the civic body is continuously spreading awareness among citizens about wearing face masks, maintaining social distance and practicing hand hygiene.

Last the BMC had directed authorities concerned to disallow entry of people without masks in public buses, taxis, auto-rickshaws and even inside housing societies. PTI
