Pleas Challenging Abrogation Of Article 370

Applicant Seeks Early Hearing By SC

SRINAGAR: An application has been moved before the Supreme Court of India seeking early hearing of the petitions challenging the abrogation of Jammu and Kashmir's special status and the subsequent orders issued post August 5, 2019, online portal Live Law reported on Monday.

The petitioner Advocate Shakir Shabir has submitted before the top court that in pursuance of the impugned Constitution (Application to Jammu and Kashmir) Order, 2019 which had been promulgated on 5th August, 2019, the Respondents (Union of India) "are continually proceeding ahead with further changes in laws concerning the erstwhile State of Jammu and Kashmir, which has now been split into two distinct Union Territories of Jammu and Kashmir & Ladakh".

According to the report, the application further submits that all consequent acts of the government, including the recent changes to land laws in the Union Territories, derive authority from the impugned order or subsequent orders, and are therefore also illegal and void ab initio.

A Journalist Killed Every Four Days This Past Decade: UNESCO

DOHA: Fifty-seven journalists and media workers were killed across the world last year, the United Nations says in a new report to mark the International Day to End of Impunity for Crimes against Journalists.

In the first nine months of this year, 39 journalists have been killed, including 3 female journalists, the report released by UNESCO on Monday said, noting that this is the lowest death toll in the last decade.

Unprecedented global attention better mechanisms to improve the fatalities, amounting to 10 killings. safety of journalists were notential reasons for the lower death toll recorded this year, the report said.

It added that journalists practising self-censorship in reaction to widespread threats could also be a factor. In 2018, 99 journalists were killed globally, according to the report.

According to UNESCO's data, the largest number of fatal attacks in 2019 – 23 killings – occurred in Latin America and the Caribbean region, representing 40 percent of the total killings registered worldwide.

With 15 killings, Asia and the Pacific region recorded 26 percent of the fatalities – the second-highest tally globally.

The Arab region was the third-deadfollowing high-profile cases and liest with 18 percent of the recorded

Winter Woes: KPDCL To Issue Power Cut Schedule In A Week

SRINAGAR: The Kashmir Power Development Corporation Limited (KPDCL) will announce within a week the new curtailment schedule for the coming winter to meet the electricity demands in the Valley, a senior official said Mondav.

"We did not curtail power this year till now. However the load has increased. We are framing a power curtailment schedule which will be issued within one week," Chief Engineer KPDCL, Aiaz Ahmad said Monday.

When asked if there were any chances of improved electricity supply this year, Ahmad said the department will ensure sufficient power supply to the people.

However, he quickly put the ball in people's court saying that if electricity is used judiciously, then there will be improvement in power supply as well.

'We have to optimize things from all available resources," he said. Expressing optimism that the

this year's curtailment schedule will have a lot of respite for the Valley consumers, Chief Engineer KP-DCL said that various reformatory measures have been taken by the power department in this regard.

Police 'Crack' Militant Attack Case On BJP Leader, 3 Held

SRINAGAR- Police on Monday claimed to have cracked October 6 attack on BIP leader from Nunar Ganderbal in which a militant and a policeman were killed.

"On October 6, (militants) carried out an attack on the District Vice President BJP Ghulam Qadir at Nunner Ganderbal in which one (militant) involved in the attack namely Shabir Ahmad Shah of Tral was neutralised on the spot in retaliatory fire," said a police official in a statement.

One constable Mohammad Altaf also killed due to a gunshot wound during the incident.

Accordingly , the police official said, that a case (FIR No 209 of 2020) under section 302 IPC ,13,16,18 UA(P) police station Ganderbal and invesrigation set into motion.

'During investigation involvement of one Qaiser Ahmad Sheikh (Hospital Security Guard) of Serch Ganderbal was unraveled. However, he upon questioning tried to dodge the investigation agency. Mizoram's Kolasib district Superintendent of Police Vanlalfaka Ralte told PTI that Intazul Laskar (45), a well- known drug peddler, was apprehended on Sunday evening when he crossed the inter-state border to deliver a consignment and later died at a health facility.

However, an Assam Police official said that he had gone missing from a forest area where he went to collect wood and a case was registered at the Dholai police station.

"This morning, we got confirmation from police of Kolasib district in Mizoram that he is in their custody.

However, by the afternoon, we were told that he expired," the official said.

Ralte claimed that Intazul went to Vairengte to deliver a drug consignment when he was apprehended by volunteers of the Young Mizo Association (YMA) and handed over to officials of the state Excise and Narcotics department

who arrested him.

"The Mizoram Police has intimated us that they are proceeding as per the NHRC guidelines related to custodial death." he said.

The Mizoram Police officer claimed that no person laid hands upon him at the time of his arrest and the incident has no connection with the present border standoff.

"The Prohibition of Conversion of Land and Alienation of Orchards Act, 1975 not only prohibited alienation of orchard lands; it surprisingly restricted creation of new orchards too. Similarly, the old Agrarian Reforms Act prohibited the selling of land distributed to tillers even after 44 years. The Right of Prior Purchase Act severely constrained an owner's right to dispose off his own property," he added.

According to the government spokesperson, the new Land Laws are modern and progressive even while affording adequate protection against alienation of land to outsiders.

"A number of protections have been built into the new land laws on similar lines as has been enacted in other states such as Himachal Pradesh and Uttarakhand. To begin with, no agricultural land can be transferred to any person from outside the UT of J&K but can only be sold to an agriculturist from within J&K," Kansal said.

"No land used for agricultural purpose can be used for any non-agricultural purpose. The terms agricultural land and agriculturist have been unambiguously defined to include not just agriculture but horticulture and allied agro-activities as well," he added.

Elaborating further, the government spokesperson said that agriculturist has been defined as ".. a person who cultivates land personally in

"The safeguard on agricultural land alone would ensure that more than 90 percent of land in the UT which is an agricultural land remains protected and with the people of J&K," Kansal said.

He further said that the new provisions not only address the infirmities in the old set of laws but also provide for modern and enabling provisions to aid in the agricultural and industrial growth of the UT of J&K. "While progressive provisions of the repealed laws have been retained by including them in the modified Land Revenue Act, new provisions have been added to modernize existing laws," he said.

"There are now provisions for setting up of a Board of Revenue, Regional planning for regulating use of land, alienation and conversion, land lease, consolidation and Contract Farming. The Board of Revenue comprising senior officers will not only be the Developing Authority for preparing regional plans but can notify a scheme of consolidation of land holdings and also a scheme for restricting and regulating the fragmentation of agricultural land holdings to make agriculture viable," he added.

these issues. So the three of us thought we will share with you salient features about these Acts and inform you about the changes and what necessitated all this and what are the safeguards that have been built." He said that there was need to understand that entire the gamut of land laws which was existing in J&K was "probably a product of its time and may be appropriate to the time when it was introduced."

"But it was essentially meant to serve an old agrarian rural economy. Quite obviously many of these laws had become outdated, obsolete and as new laws kept added, the system of land laws when looked as a whole suffered from not only obsoleteness and redundancies but also ambiguities and contradictions and in many cases the laws that were in existence were clearly regressive and anti-people.

"How was it so? Let me give you some examples. The Big Landed Estates Abolition Act fixed a ceiling of 182 kanals but it was superseded by the Agrarian Reforms Act of 1976 which kept 100 standard kanals, yet both provisions continued to coexist," he said, adding, "The Agrarian Reforms 1976 Act is 44 years old now. We are in 2020 now yet this Act prohibited selling of any land that was available to the tiller and so as a result even after a generation has past and this land could not be sold or transacted. What was the consequence? You had large number of so-called Benami transactions and restriction to other generations for transactions which was otherwise made legitimately available to the tiller."

At the end of all this, he said there was gamut of land laws which was "sometimes inconsistent, sometimes ambiguous, sometimes contradictory or at other times clearly opposed to interest at public at large". "There was a need to straighten up, clean up the system and provide a set of simpler land laws which would prevent unnecessary litigation and prevent discretionary interpretation of laws leaves opportunities for the vested interests."

On October 27, the Ministry of Home Affairs, Government of India, repealed the 11 laws and modified four other major laws of the erstwhile Jammu and Kashmir

The announcement has been made by Ministry of Home Affairs as per its order to be called the Union Territory of Jammu and Kashmir Reorganisation (Adaptation of Central Laws) Third Order, 2020.

"A general perception about the people of Jammu is that they welcomed the abrogation of Article 370," said a Jammu-based politician. "However, like Kashmir, people of Jammu too suffered and have been ditched by the people they voted for."

Notably, the Narendra Modi government's decision to remove the special status of Jammu and Kashmir opened the doors for outsiders to buy land and property, get government jobs and attend institutes of higher

Before the abrogation, the Article 370 had empowered the government of the former state to define "permanent residents" of Jammu and Kashmir and reserve certain rights for them.

In its latest order, the home ministry said the new laws will be called the Union Territory of Jammu and Kashmir Reorganisation (Adaptation of Central Laws) Third Order, 2020. It added that it will come into effect

However, the new land laws have not gone well with the people of both Jammu Kashmir, and Ladakh, including the political parties except BJP.

Talking to Kashmir Observer, Harsh Dev Singh said the sole purpose of the October 22 meeting was to discuss ways to protect land, job and other rights of the people of Jammu region.

Government, Singh said, is ignoring Jammu and focusing on Kashmir and Ladakh for "political gains". "They've taken Jammu for granted," the Panthers Party leader said. "This

government is not listening to the people. Post-abrogation of Article 370, things have been worse for Jammu. We're being deprived in every sphere. The BJP has cheated the people of Jammu." Singh said the recent meeting in Jammu wasn't against Gupkar Declara-

tion, as reported by some section of media. "But yes, we aren't going to support them [Peoples Alliance] since their demand [restoration of Article 370] is in Supreme Court," Singh said. **New Action Plan Soon**

Dogra Sadar Sabha (DSS) Chairman, Gulchain Singh Charak, who participated in the meeting, told Kashmir Observer over phone that they welcomed the abrogation of Article 370 last year. "Magar badlay mai kia mila humko (What've we got in return)?'

"If you're deleting the so-called "anti-people" model, then you should tell us about better alternatives? We need to discuss it in Jammu, Kash-

mir and Ladakh as well.' Sabha said people of Jammu were "unhappy with the demotion of the state into UT".

"The government should come clean and talk to the people and know what they want," he said.

New land laws, Sabha said, are clear threat to the identity of the people of both Jammu Kashmir, and Ladakh.

'We'll meet in coming days to decide future course of action," he said. **Nothing Will Happen**

However, Ankur Sharma, chairman IkkJutt Jammu, who participated in the October 22 meeting, told Kashmir Observer that he doesn't endorse the statement of Harsh Dev Singh regarding the new land laws.

"Nothing will happen," Sharma said. "These laws will in-turn be helpful for the development and economy of the Jammu region. Kashmiri politicians are peddling this fake propaganda about new land laws. Our identity will remain the same."

He said that the extended power cuts surface soon after the Durbar

(seat of governance) shifts to Jammu as a bi-annual practice. A KPDCL official said that on average 1300 MWs of electricity is provided to the consumers across Kashmir. However, with winters setting in, he said the demand reaches 1800 MWs

Another senior official said that if the consumers make judicious use of electricity, there will be no need for long power cuts in the coming months. "We have seen that power thefts and use of heaters and boilers by the consumers causes the overloading. People should use electricity judi-

ciously so there will be less curtailment," the official said. The Centre has been allotting additional 700 MWs of power to Jammu and Kashmir in view of higher demand in winters. But there has been no improvement in Union Territory as authorities have failed to augment the existing infrastructure to receive additional electricity from

the central grids. "Additional allocation of power will overcome power crisis only when required infrastructure is in place. How will we handle additional power when there is no infrastructure available? There will be improvement in power supply only when new girds are commissioned," the official said.

Div Com stresses on strict implementation of official rates

Govt. Fixes Mutton Rate at Rs. 480 Per Kg

SRINAGAR, NOVEMBER-02: The Divisional Commissioner, Kashmir Pandurang K Pole today chaired a meeting of Rate Fixation Committee and fixed rates of mutton at Rs 480 (retail) and Rs 450 as (wholesale) rates in Kashmir.

The meeting, among others was attended by Director FCS&CA, Director Animal Husbandry, ADC Srinagar, JD Extension, Technical Officer Sheep Husbandry besides members from mutton retailer and wholesaler associations and media

At the outset, the Div Com said that rates have been fixed after taking all factors including, production cost, transportation, processing, cutting and all other charges into consideration.

He said that now onwards mutton rates shall be revised annually as per government's wholesale pricing index.

Stressing on the strict implementation of official rates, the Div Com said that stringent action including FIRs shall be registered against mutton dealers butchers if found selling mutton on higher rates or resorting to any kind of violations against the official rates.

The meeting was informed that out of 81 FIRs, 42 have been registered against mutton dealers only while an amount of Rs. 4.63 lac fine has been imposed on offenders in different districts of Kashmir during the month of October.

The Div Com said that despite increase in the local production, we have to import around 70 per cent mutton from other states and urged all stakeholders to cooperate for implementation of official rates.

He appealed to wholesale dealers to buy mutton as per the rate list from outside mandis or dealers from different states to avoid overcharging or black marketing of the mutton.

During the meeting, members from mutton dealer association raised various issues with the Div Com and demanded prompt and proper measures are taken for hassle-free mutton

Miscreants Behind Circulation of Fake Appointment Orders: Govt

SRINAGAR, NOVEMBER 02: The office of the Chief Conservator of Forests, Kashmir division today issued a statement informing the general public that it has not issued any appointment/ engagement orders to any person against any post.

The department has informed that it has come to its notice that some miscreants are issuing fake appointment/engagement orders under the seal and signatures of the authorities which do not exist in the department.

Citing one such example, the statement reads that For instance, the Station House Officer, Police Station Shaheed Gunj in investigation of Case FIR No. 70/2020 U/S 170, 420,467, 468 - IPC had seized some fake engagement orders whereby the concerned person(s) was shown engaged

as Plantation Watcher and the said order was bearing seal and signature as 'Chief Conservator of Forests UFD Srinagar'.

Accordingly the SHO Shaheed Gunj was informed that the Appointment orders were fake besides, there was no post of Plantation Watcher existing in the department and that there is no authority of the rank of Chief Conservator of Forests UFD Srinagar existing in the hierarchy of the department.

Further, the matter was also referred to the Senior Superintendent of Police Crime Branch Kashmir for further investigation.



It has been informed that the instructions have already been issued to the subordinate offices that even the appointment orders issued on the basis of selection by the SSB or appointments in terms of SRO-43 need not to be entertained until authenticity of the order(s) is got ascertained from this Office or from the office of PCCF J&K.

Now the general public and all the concerned are being informed through this news item that, no process of any appointment/ engagement (whether permanent, Daily Wage, Consolidated, Casual, need based etc) is in vogue in this

office and any such order coming to fore anywhere, need not to be acted upon.

It is further informed that in case any such appointment/ engagement orders comes to your notice, necessary action as provided under law be initiated against the concerned person producing such order and the action interalia should follow lodging of FIR in the Police Station and above all referring the

matter to the Crime Branch for further investigation.

The department has made it clear that the mode of appointment in vogue in the department is based on the selection made by the Services Selection Board and appointment of NOKs of the deceased officials in terms of SRO- 43 of 1994 by the competent authority.

DTH TV Okayed

TEW DELHI: The Union cabinet today gave its nod for al¬lowing direct-to-home (DTH) television services, which would revolutionize broadcasting in the country. The decision came three days after an eight-member Group of Ministers (GoM) headed by Home Minister L K Advani prepared a unanimous, report favouring DTH, official sources said.

The KU-band DTH service offers greater and direct connectivaity to the viewer providing over 100 channels through a small dish antenna doing away with intermediaries like cable op-erators. It has enormous penetration power to cover far flung and remote areas.

Promising enhanced picture quality, it also has the scope for interactive TV services like movie on demand and possibil-ity of introducing value-added services like internet access, e-mail, home shopping, banking and tele-education. The GoM was formed nearly two years ago to go into the con

troversial DTH issue and place its recommendations to the Union Cabinet when Pramod Mahajan was the Information and Broadcast-Besides Advani, others in the gmup are HnatKfc Minister Vashwant Sinha, Defence Minister George Fernandas, Information and

SLAMABAD. The little-known Islami Jirga on Monday pub-licly burnt 11 television sets by describing them as a source of obscenity in the Pakistani city of Mardan. of obscenity, a threat to faith, a danger for pious women. One of the

slogans written on a television set vowed to foil the Jewish conspir acy against Islam. Before burning the sets, an Islami Jirga activist, Mohammad Salim, described television as a source of obscenity and felt it was misleading the youth, particularly girls, He lashed out at the cable

Provincial status to GB

akistan's Prime Minister Imran Khan has said that his government will grant provisional status to Gilgit Baltistan, removing any ambiguity that prevailed over the issue in recent months. The decision has drawn condemnation from India. On Sunday, Khan addressed a rally in the city of Gilgit, capital of the Gilgit-Baltistan that forms a part of Pakistan-administered Kashmir, ahead of the elections there later this month. India, however, has rejected the move reiterating "that the Union Territories of Jammu and Kashmir and Ladakh, including the area of so-called 'Gilgit-Baltistan', are an integral part of India by virtue of the legal, complete and irrevocable accession of Jammu and Kashmir to the Union of India in 1947".

In response, Pakistan has also rejected Indian objection. According to Pakistan foreign office, the move is the result of the demand from the people of Gilgit Baltistan. "The administrative, political and economic reforms are a long-standing demand of the people of Gilgit-Baltistan,' said a statement released by Pakistan late on Sunday.

Interestingly, New Delhi and separatists in Kashmir are on the same page in opposing a provincial status to Gilgit Baltistan, albeit for entirely different reasons. The separatists had even urged Islamabad not to do so as the move according to them, would alter the status of "a disputed territory". In a recent statement, Sayyid Abdullah Gillani, the special representative of the top Hurriyat leader Syed Ali Shah Geelani, had said that such a step is "laden with disastrous consequences" with Pakistan risking not only "weakening its position and losing moral high ground but also demoralizing Kashmiri people and debilitating their ongoing struggle for the right to self-determination".

Islamabad's urgency to recast the region's constitutional relationship with the country is traced to \$60 billion China-Pakistan Economic Corridor project and China's alleged insistence for a legal cover to its investment through a disputed region.

More so, when Gilgit-Baltistan has to serve as the gateway for the multi-billion dollar project. China is building industrial parks, hydropower projects, railway lines and roads in the region. Besides, the project also involves the expansion of the Karakoram Highway connecting China's restive Xinjiang region with Gilgit-Baltistan.

But the scene is complicated since Gilgit Baltistan is part of the undivided J&K and hence an inextricable part of the region's contested legacy. There is also a debate how this would impact the status of Kashmir issue. With both countries integrating the parts of Kashmir under their possession – more so, Pakistan that has so far tried to maintain a position that the parts of Kashmir it controls aren't its parts - this is believed to undermine the legal nature of the region as "a disputed area". However, it remains to be seen how Pakistan and India handle the issue and what will be the implications of the provincial status to Gilgit Baltistan on the larger Kashmir issue.

Real estate: On changes to J&K land laws

ne of the arguments against the now nullified special status of J&K was that the restrictions on land transfers hampered investments. The government has said the changes will encourage investment and advance peace and progress in J&K. The argument that these changes would help the people of the region might have been stronger if these were done in consultation with them. The irony is that in all three regions — Jammu, Kashmir and Ladakh — there is strong opposition to opening the land market to non-residents. Political parties in J&K too have opposed the changes.

Free movement of people, and an integrated national market can advance development but India's governance structure accommodates fears and concerns of local populations in this context in a measured manner. There are several States which have provisions to regulate ownership and transfer of land under Article 371 of the Constitution. The Centre is expected to announce new land laws for the UT of Ladakh before October 30, and it has promised to "safeguard interests of the people" regarding "all issues related to language, demography, ethnicity, land and jobs". The Centre's approach towards J&K has been marked by a lack of trust, which has accentuated the alienation of large sections of the population. Fears of deliberate demographic engineering have dominated politics in the Valley for long. After the reorganisation of the State and the loss of its special status in 2019, the people of Jammu and Ladakh also turned nervous on this question. Desirable as it may be, there is no point forcing a particular path of development upon people.

The situation is precarious also because of the heavy hand of the state on political and civil society activities in J&K. The unilateralism that has come to define New Delhi's dealings with J&K is achieving little. There is no wisdom in pushing through measures aimed to promote investment when the end result is political volatility. The Centre's policy towards J&K must be buttressed by a robust political process that enables people's participation and ensures stability with growth and development.

France and Islam

he French attacks on Islam and its Prophet are nothing new, we only have to peep a little bit into the past, to find the roots of this hatred

The recent storm over the inflammatory statements against the Holy prophet and Islam itself, by the French President Macron has set the Muslim world on fire. Leaders of all hues and denominations have condemned the so-called attacks on Islam. The outcry, as expected, follows a similar pattern after any anti-Islam incident takes place in the Western world. We need to take a long breath, pause and wonder on the similarity of attacks and the Islamic response to it globally

Muslims move on with times. Alongside, the western world also continues with its activities related to interfaith relations and peaceful coexistence. However, in real terms one wonders whether these activities are indeed carried out with good intentions or are just an eyewash; while beneath the surface anti-Islam hatred continues unabated as they are in real terms afraid of Islam and its teachings.

What has happened in France is nothing new. The French radical extremism, legitimises itself under the French term laicité meaning secular, and under this garb it continues its attacks on French and non-French Muslims.

A French NGO, The Collective Against Islamophobia in France (CCIF) listed 1,043 Islamophobic incidents that occurred in 2019 (a 77 percent increase since 2017). Not so far back, in October 2019, French President Emmanuel Macron and his then Interior Ministerrorism in France to any signs of French Muslims' faith and culture, including having a beard, praying five times a day, eating halal food,

'Liberating' Islam

Last week, Macron declared "Islam is a religion that is in crisis all over the world today, we are not just seeing this in our country". He added that he is seeking to "liberate" Islam in France from foreign influences by improving oversight of mosque financing.

One wonders, in what capacity will Macron 'liberate Islam' and who gives him the right to do so? Historically, Macron is not the first French ruler who wanted to "liberate" Islam. This is an old French "secular" tradition from the times of Napoleon Bonaparte. When Napoleon invaded Egypt and Palestine in 1798, he lied to the Egyptians by announcing that he and his army were "faithful Muslims" and that they have come to liberate Muslims and Islam from the tyranny of the Turk Mamluks. However, the deception did not work and both the Egyptians and Palestinians rose against him. Napoleon was defeated, though his army committed untold atrocities in Egypt and Palestine. At that time, Napoleon and France wanted to avenge the defeat faced by French forces in the Palestinian

city of Acre, two centuries ago.

French Invasion of Algeria

The French invasion of Algeria was launched in mid-June 1830 and Algiers fell on 5 July. The French army robbed Algiers' treasury clean, stealing upwards of 43 million Francs in gold and silver. The French King Charles X told the French National Assembly that the immediate goals of the invasion were to avenge the French for the Algerian insult, besides "ending piracy and reclaim Algeria for Christianity"

In line with its Christian commitments, the conquering French army took over mosques and converted them into churches and cathedrals at gunpoint, including the largest Ottoman Ketchaoua mosque in Algiers, built in 1612, which was converted into the Cathedral of St Philippe in December 1832. That same year the French wiped out the entire tribe of the Ouffias, sparing no woman or child, and seizing all their possessions.

French barbarism

We should not forget the French barbarism, which has been recorded for posterity by history. Authors like Martin Evans, John Phillips, Haley C. Brown have documented in-depth the French atrocities in Algeria in their books. It would also be pertinent to note here that the French played a crucial role in persuading the Algerian ulemas and clerics to close the doors of Ijtihad, which ultimately made a crucial and long lasting affect on the growth of Islamic sciences and social sciences.

In 1871, Algerian Muslims revolted again against French rule, with 150,000 people joining the forces of a local tribal leader, Al-Mugrani. The French genocidal machine responded by killing hundreds of thousands of Algerians, which, combined with the Frenchcaused famine deaths in the late 1860s, resulted in the death of one million Algerians. The French razed dozens of towns and villages to the ground while eliminating the entire elite of Algerian society. But even that did not resolve France's "crisis" with Islam.

During the 19th century, France colonised many Muslim nations, and thus their concern about their "crisis" with Islam increased further. To answer this

quest, a journalist of ill repute and with known anti-Turk views was appointed to seek answers. Edmond Fazy (1870-1910) presented his analysis in the form of Questions diplomatiques et colonials, which contained submissions by known anti-Muslim and anti-Turk academics, journalists or so-called experts on Islam and African nations. Edward Said has discussed the real role of these so-called Orientalists in-depth in his book Orientalism (1977).

Future of Islam

Chauvinism and hate has always dominated the French culture, whether it is with the British or Islamists. Many of the contributors to Fazy's journal saw fit to manipulate Islamic theology and transform Muslim ulemas to produce not only a modern Islam that European modernity would tolerate, but also one that, they hoped, would weaken the Ottoman Em-

The project of transforming Islam into something compatible with European Christianity and which French laicite can tolerate continues afoot in 2020, but with unsatisfactory results as far as Macron is concerned.

Both the French Muslims and immigrant Muslims continue to face an institutionalised discrimination in France. The country continues to be submerged in a dominant discourse of chauvinism and hate today that is not dissimilar to the one that always dominated French culture even before the French Revolution

The current French crisis is based on its white supremacist Christian agenda and a country holding on to its past glories or misdeeds, while in reality they should strive to undo or repent their misdeeds committed by them in the former colonies held by them.

What the French need to do is to pay back the debts they owe to all those whom they robbed and killed around the world since then. Only that will end France's crisis with "Islam" and with itself.

At the same time, Muslims across the globe need to connect or reconcile their national, ethnic and sectarian identities within the context of Islam's inner unity and integrity based on moral and human grounds, on the one hand, and maintain its global and cosmopolitan outlook on the other. This will be the best antidote against such vitriolic agenda.

Child Marriages in Covid-19: An Urgent Issue

hild marriage was criminalized with effect from July 1st, 1930 under Child marriage Restraint Act,(1929). According to the 2016 National Family Health Survey 27% of women aged 20-24 years were married before they turned 18.

The data over the years hasn't shown much promise. In fact, from April to June alone, Childline India received 5584 calls reporting child marriage. Tamil Nadu, Karnataka, West Bengal, Andra Pradesh and Telangana are the top 5 states to have reported child marriages during these first three months .Karnataka alone accounts for nearly 29 percent of interventions for child marriage.

As is obvious with data, it doesn't always represent the true number. With societal restraints and cultural hurdles, many such cases are likely going unreported. In fact, according to a UN report published in April, the covid-19 pandemic could lead to an extra 13 million child marriages. Other findings suggest that four million girls are at risk of child marriage in the next

two years. The surge in the number of marriages may have a close relationship with the fallouts of the pandemic. The economic implications of the lockdowns may have led to conditions

which would have forced many to marry off their daughters at a young age to avoid further desperation. Many may have also opted for early marriages as the pandemic has sanctioned simple and cost efficient marriages without the family having to be answerable or being chided for simplicity.

Developing countries are also vulnerable to crimes against women and child marriages may be a reflection of these trends. Hence, it is the need of the hour to immediately address this issue. Working at the grassroots is important as is ensuring the safety of children married off at a young age. This evil is so grave that it requires

immediate and urgent intervention to prevent violence against children especially the girl child.

Desperate times call for desperate measures has a flip side here. The pandemic has only made matters worse especially for women. Special attention must be paid to these issues which are often hidden or rationalized in the name of tradition and culture and might go unreported and unaddressed.

Being a Woman Geologist in Kashmir

Most of the people believe that geology is the subject of men. "I think you cannot climb up a glacier with the men, work on something else," said a teacher to me when I wished to study climate change vis a vis glaciers. The words whirled round and round my head for a couple of days. Because of my gender, I was barred to research on my favourite portion of Earth Sciences.

hange your decision of doing masters in geology, go for any other subject or prepare for civil service examination," one of my geology teachers told me when I was selected in Applied Geology for the Masters programme at Kashmir University. Was it my gender or the increasing trend of Civil service exams or the lack of jobs in Applied Geology in Kashmir which made him say so? The question lingers.

I didn't change my decision because my love for geology was unfathomable. The first thing which I came to know in the university from a teacher was that Geology is the subject of economically underprivileged students. Only the students from poverty stricken families opt for geology and the students from well off families engage in Computer Sciences or in other technical courses. May be the attire of the students had pushed him to conclude so.

Field work and outdoor activities are the requisite in geology. Data collection from the field is an important component of the geology. While on field work, geologists are exposed to a threat of wild animals and other dangers of remote locations. Despite setbacks the geologists toil in the field until the job is done.

In the strife torn parts of the world, the data acquisition from the field is tough row to hoe for female geologists. For instance, in Kashmir, female geologists with gung-ho attitude find it difficult to reach the field as anything can happen from encounters to protests at any time. In such volatile atmosphere, reaching home late is another difficulty which the female geologists face. They are also subject to conservative outlooks of the society. "Yh che kour, emis kya baalan khasun" (She is a girl, she should not climb up the mountains) is the remark which I heard from a group of women when I was doing field work. Such things are rife in Kashmir, if you are a female and you venture out to do something which usually girls do not do like the field work, lots of eyeballs stare at you and many casual remarks are made.

Most of the people believe that geology is the subject of men. "I think you cannot climb up a glacier with the men, work on something else," said a teacher to me when I wished to study climate change vis a vis glaciers. The words whirled round and round my head for a couple of days. Because of my gender, I was barred to research on my favourite portion of Earth Sciences. According to UNESCO data, women represent less than 30% in research. Women in Science, technology, engineering and maths (STEM) are published less,



paid less for their research and do not advance as far as men in their careers.

Since time immemorial, women geologists have faced hardships travelling to their locations or working in the field. In the beginning of the 19th century. women from the upper class were prevented by their families to join the Earth Science field as it required outdoor activities. Women from lower classes used to engage in this field like, Marry Anning from Lyme Regis, United Kingdom. She discovered a number of fossils but was often not credited for her work. Because of her gender, she was barred from Geological Society of London. Etheldred Benett, a spinster from England was the first female geologist who has extensively worked on Paleontology. She was an avid fossil collector who devoted her life to Earth Sciences. Despite belonging to a wealthy family she engaged in the Geo Science research. Like many other women geologists

she also faced discrimination both overt and covert.

Recently the two women scientists, Emmanuelle Charpentier and Jeniffer Doudna were awarded the Nobel Prize 2020 in Chemistry for developing the tools to edit DNA. This reflects that women are doing well in the research. Their research may inspire many young girls to follow the scientific path. The only female faculty member at Applied Geology department in Kashmir University, Dr. Sarah Qazi, has won the young scientist award in hydrogeology research in the year 2018. She has an experience of ten years in hydrogeology (sub surface water study) as a researcher and has authored a number of papers. She followed her dream of research, evened all the odds and stepped into the male dominated field, Earth Sciences.

The Name is Bond

Sean Connery passed away on the 31st of October at the age of 90. He was the first Bond, and for many people, the best

overage of the passing of Sir Sean Connery has inevitably been dominated by his legacy as the screen's first – and best – James Bond. Connery's "Bond, James Bond" moment near the beginning of Dr. No (1962) is one of the iconic moments of cinema history and has spawned countless imitations and parodies.

Perhaps the most persistent myth about Connery, who was 90, is that he was an "unknown" actor who was plucked from obscurity by Bond producers Albert "Cubby" Broccoli and Harry Saltzman, who reportedly cast him against the wishes of author Ian Fleming and distributor United Artists. But this is to ignore the fact that Connery had already established himself as a television actor, drawing critical plaudits for lead roles in a 1957 BBC production of Requiem for a Heavyweight and in the 1961 TV production of Anna Karenina, but also appearing in a number of meaty co-starring roles in Hollywood films, including opposite Lana Turner in Another Time, Another Place (1958).


It was reportedly his appearance in Disney's fantasy Darby O'Gill and the Little People (1959) that drew Connery to the notice of Broccoli's wife, Dana, while the British crime drama The Frightened City (1961), in which Connery as an underworld enforcer steals the picture from its nominal star John Gregson, was also evidence of a star in the making.

Nevertheless Connery was inspired casting as James Bond. Connery made the role his own to such an extent that it is now impossible to imagine any of the other actors said to have been considered – including Cary Grant, David Niven, Patrick McGoohan and even Roger Moore – stepping into the shoes of "the gentleman agent with the licence to kill" in 1962.

In this context an important point to remember about Bond is that Fleming's character was not an Old Etonian establishment figure: he is even described in Moonraker as being "alien and unEnglish". Connery's working-class Scottish roots – he was born and grew up in Edinburgh, where his early jobs had included milkman, bricklayer and coffin-polisher – imbued his Bond with that sense of "otherness".

To this extent Connery's Bond has as much in common with the outsider protagonists of the British new wave – Laurence Harvey, Albert Finney, Richard Harris – as the tradition of British screen heroism incarnated by stars of the 1950s such as Richard Todd and Kenneth More.

Connery's performance in Dr No is edgy and brusque: he really settled into the part in From Russia With Love (1963) and Goldfinger (1964) where he commands the screen with that indefinable qual-

ity of star "presence" that means all he has to do to dominate a scene is to be in it.

Beyond Bond

Bond brought Connery fame and fortune. He was paid a mere £6,000 for Dr No, four times that amount for From Russia With Love and a then-record US\$1.25 million for his first Bond "comeback" in 1971's Diamonds Are Forever (George Lazenby had taken the role for On Her Majesty's Secret Service in 1969).

The lucrative remuneration meant that Connery was able to pick and choose his roles outside the Bond pictures. Indeed his non-Bond roles demonstrate just how versatile an actor Connery was. Alfred Hitchcock cast him against type as Tippi Hedren's conflicted husband in Marnie (1964), and he excelled in two films for Sidney Lumet, as the rebelwith-a-cause in the hard-hitting military prison drama The Hill (1965) and as a vengeful policeman in the much underrated The Offence (1973).

Connery was particularly good at playing characters older than himself, including the potentate

standing up to Teddy Roosevelt in The Wind and the Lion (1975) and an ageing Robin Hood reflecting on his own myth in the beautifully elegiac Robin and Marian (1976). He paired with Michael Caine as soldiers of fortune in 19th-century Afghanistan in The Man Who Would Be King (1975) and was one of the all-star cast of suspects in Sidney Lumet's lavish adaptation of Murder on the Orient Express

There was, inevitably, the occasional left-field choice, but even the science-fiction oddity Zardoz (1973) now has something of a cult status. Connery famously said that he would "never" play Bond again after Diamonds Are Forever: hence the ironic title of his second Bond "comeback" Never Say Never Again (1983), a rival production outside the Eon Production series mounted by independent producer Kevin McClory.

Connery won his only Academy Award, a popular choice as Best Supporting Actor for his "Irish" street-cop in The Untouchables (1987), after which his career enjoyed a second wind as the world's most bankable sexagenarian film star in a sequence

of superior adventure and caper movies including The Hunt for Red October (1990), The Rock (1996) and Entrapment (1999).

By this time Connery's refusal to disguise his accent had become something of a trademark, whatever the part. When Steven Spielberg cast him as Harrison Ford's father in Indiana Jones and the Last Crusade (1989), it captured the idea that Connery's Bond was the symbolic "father" of a later generation screen hero.

Feet of clay

Most stars turn out to have feet of clay: Connery was no exception. He attracted controversy for a remark made in an interview with Playboy in 1965 that legitimised hitting a woman ("An open-handed slap is justified if all other alternatives fail"). His Bond did this on screen in From Russia With Love and Diamonds Are Forever.

He also had a public falling-out with Broccoli, suing the producer and MGM for alleged non-payment of profit shares in the Bond films. Against this should be set Connery's charitable work: he used his fee for Diamonds Are Forever to found the Scottish International Education Trust to provide financial assistance for Scots from disadvantaged backgrounds to attend university and college.

Proud 'Scottish peasant'

Connery, who since the 1970s lived in Spain and the Bahamas as a tax exile, was proud of his Scottish roots. Ian Fleming warmed to Connery to the extent that he introduced a Scottish heritage for Bond into the later stories. Bond's "I am a Scottish peasant and I will always feel at home being a Scottish peasant" – from The Man With the Golden Gun – might have been written with Connery in mind, although Bond was actually played by his successor, Roger Moore, in that film.

Unlike Bond, Connery did accept a knighthood, for services to film drama, in 2000. It is widely believed that his public support for the Scottish National Party had delayed his knighthood.

Connery's last screen appearance was as Allan Quatermain in The League of Extraordinary Gentlemen (2003), in which he leads a Victorian superhero team to save the British Empire. He confirmed his retirement when he was presented with the American Film Institute's Lifetime Achievement Award in 2006.

He died in his sleep at his home in Nassau, and is survived by his second wife Micheline and son (by first wife Diane Cilento) Jason Connery.

UN Body To Suggest Global Covid-19 Test Guidelines For Screening Airline Passengers

global aviation manual Anow under review by a UN body suggests global guidelines calling for the use of highly reliable tests when screening passengers to detect the novel coronavirus ahead of flights, three sources familiar with the matter said.

Carriers and airports are pushing for uniform global testing guidelines to waive strict quarantine requirements that are decimating travel, with airline trade group IATA forecasting a 66% decline in 2020 air traffic because of the pandemic.

Travel restrictions and the use of testing now vary globally. Certain airlines require passengers to obtain a negative test, even as some countries allow visitors in without quarantine, while others bar all non-essential foreigners.

The International Civil Organization (ICAO) Manual on Testing and Cross Border Risk Management Measures, expected in November, would offer voluntary technical guidance but not oblige countries to remove quarantines.

Veteran British journalist Robert Fisk dies at 74

Washington: Veteran British journalist Robert Fisk has died at the age of 74, The Guardian reported late on Sunday.

Fisk was admitted to St Vincent's hospital in Dublin on Friday after suffering a suspected stroke and died shortly afterwards, according to a re-



port on the BBC.

Planning and Development Minister Asad Umar expressed sadness on the journalist's death. "A fearless journalist who understood the Middle East better than almost any other Western journalist and wrote the truth with clarity and without fear," he said.

Renowned historian William Dalrymple said the late journalist was "fearless" and his book Pity the Nation was "extraordinary"

Fisk started his career at the Sunday Express before moving to The Times, working as their correspondent in Belfast during the Northern Ireland conflict.

In 1976, Fisk became the Middle East correspondent for the paper, covering the Lebanese civil war, the Iranian revolution, the Iran-Iraq war and the Soviet invasion of Afghanistan.

He switched to The Independent in 1989 where he continued to work until his death. The paper said "Fisk was renowned for his courage in questioning official narratives from governments and publishing what he uncovered in frequently brilliant prose."

The paper's managing director said: "Fearless, uncompromising, determined and utterly committed to uncovering the truth and reality at all costs, Robert Fisk was the greatest journalist of his generation. The fire he lit at The Independent will burn on."

Fisk spoke Arabic fluently and interviewed Al Qaeda leader Osama bin Laden twice. according to the publication.

He was also the author of several books on Northern Ireland and the Middle East, including Pity the Nation: Lebanon at War and The Great War for Civilisation.

Fisk won various awards, including the Orwell Prize for Journalism, Amnesty Award and multiple wins at the British Press Awards in the categories of international reporter of the year and foreign report er of the year.



Kaba To Open For Umrah by Foreign Pilgrims

MAKKAH: After a sevenmonth hiatus, some 10,000 pilgrims were scheduled to arrive in Saudi Arabia from abroad to perform Umra and visit Masjid-i-Nabawi in Madina on Sunday, the first day of the third stage of the resumption of Umra.

The 10,000 international pilgrims will first have to obtain a permit and upon their arrival in Saudi Arabia they will be kept in isolation for three days before being transported to Migat sites, principal boundaries at which pilgrims

intending to perform Umra must change into Ihram.

The kingdom's deputy minister of Haj and Umra, Dr Amr Al-Maddah, said that the 10,000 pilgrims can stay in the country for up to 10 days, three of which are for isolation. As per protocol, 500 groups of international pilgrims are dispersed throughout the day, each with 20 pilgrims. The maximum age limit for international pilgrims is 50.

According to Arab News, the deputy minister said that countries are subject to continuous evaluation as part of

the government's approved standards and protocols. Visas for pilgrims arriving from countries that are seeing a noticeable increase in numbers will be placed on hold.

With the start of the third stage, the holy mosques will be working at 100 per cent capacity, a pivotal stage for companies in the sector.

According to the deputy minister, if at any stage there is a cause for concern or danger to pilgrims, the ministry will evaluate the situation and return to previous stages and decrease capacity.

Gunmen kill at least 19 people in attack on Kabul university

Kabul: Gunmen attacked Kabul University's campus on Monday, killing at least 19 people including students and trading fire with security forces, an Afghan government official and witnesses said.

At least 22 others were injured, according to the spokesperson for the Afghan interior ministry. The attackers were targeting students and fired on them as they fled in the Afghan capital, one witness said.

"They were shooting at every student they saw," Fathullah Moradi told Reuters, saying he had managed to escape through one of the university's gates with a group of friends. The attack took place as the lowed an explosion in the area. The attack ended after several hours with security forces killing three of the attackers, the interior ministry spokesperson said.

While Afghan officials declined to discuss the bookfair, Iran's semiofficial ISNA news agency reported on Sunday that Iranian Ambassador Bahador Aminian and cultural attaché Mojtaba Noroozi were scheduled to inaugurate the fair, which would host some 40 Iranian publishers. Iranian state television reported the attack occurred, but did not offer information on its officials.

Iranian diplomats have been targeted previously by attacks in the country and nearly sparked a war between the two countries. In 1998, Iran held

Our Position Is Clear, Will Focus On "Actions" Of New US **Administration: Iran**

Tehran: Iran's foreign ministry said Monday it will focus on the "actions" of the new US administration rather than who wins the White House, a day before Ameri-

"Our position is clear: we do not look at (what happens) tomorrow, we will be watching the ap-



proach of the new US administration, whichever party it's from," ministry spokesman Saeed Khatibzadeh told reporters.

"More than the result of the election, we will pay attention to the actions" of whoever is president, he added.

Since unilaterally withdrawing from a landmark nuclear deal with Tehran and world powers in 2018, the Republican administration of President Donald Trump has re-imposed -- and extended -crippling sanctions on Iran.

Trump's Democratic chal-

lenger, Joe Biden, has said he wants to use the 2015 nuclear accord -- a pact hammered out when he was vice president under Barack Obama -- as a "startingpoint for follow-on negotiations" with Tehran.

Iranian officials have repeatedly said they favour no specific candidate in the race, while also calling for a return to the nuclear accord the lifting of sanctions and compensation for damages caused.

"What is clear is that both parties have realised the extent of the failure of their policies" regarding Iran, Khatibzadeh added, referring to the Republican and Democratic parties, and emphasising that the "framework for talks" is the

US intelligence last month accused both Iran and Russia of trying to interfere in the 2020 election, charges which Tehran has strongly denied.

Tehran "has repeatedly stated that it neither has any interest in interfering in the US election nor does it think interference would be to anyone's benefit," Khatibzadeh said, calling US allegations "baseless.

"The US election has turned into a show, and as in a show, they try to create more attractions," he added.

Joe Biden in lead, Trump catching up in swing states: Poll survey

New York: With two days to go, Democrat Joe Biden holds a commanding national lead over President Donald Trump amid deep voter concerns about the Covid pandemic, but Trump is keeping his hopes alive by staying competitive in the swing states that could decide the White House race.

Biden's national lead over the Republican president has stayed relatively steady in recent months as the public health crisis has persisted. He is ahead 51% to 43% in the latest Reuters/Ipsos poll taken October 27-29. But Trump is close to Biden in enough state battlegrounds to give him the 270 state Electoral College votes

needed to win a second term. The survey shows that the race remains a toss up in Florida, North Carolina and Arizona. Trump also trails by five points in Pennsylvania and nine points in Michigan and Wisconsin, three other battleground states that helped give him an Electoral College win in 2016 over Hillary Clinton.

Meanwhile, Indian-American supporters of both parties have intensified their

campaign. Two recent surveys show Indian-Americans support Biden. — Agencies

China Wants To Build A Tibet With More Wealth And Less Buddhism

Beijing: Sitting in a home built by Chinese authorities near Tibet's capital of Lhasa, one of the highest cities in the world, Sunnamdanba tells foreign journalists on a government-sponsored tour how much the Communist Party has improved life -- and how irrelevant religion has become for him.

"I could have never dreamed my life would be so good," the 41-year-old father of two, who by tradition uses only one name, said in comments translated by a local official. Foreign journalists can only report from the region on trips organized by the government.

Asked about the Dalai Lama, Tibet's 85-year-old spiritual leader now living in exile and condemned by China as a separatist Sunnamdanba said: "I never met him and I don't understand him.

And Buddhism, the religion that has for more than a millennium been the foundation of Tibetan culture? "I spend most of my time and energy now on work and making a living," he said. "There's less

time to spend on religion." Why hang a portrait of President Xi Jinping in your living room? "None of this could have happened without the party."

Legitimacy to Rule

For China, showcasing Tibetans singing the Communist

Party's praises helps affirm its legitimacy to rule the region, something that's weighed on Beijing's ties with the West since a failed uprising in 1959 forced the Dalai Lama to flee and set up a government-in-exile in northern Indian. It's become more important recently as politicians in the U.S., Europe and India accuse China of using forced labor, detentions and re-education campaigns to assimilate ethnic minorities in its borderlands.

The Trump administration's newly appointed special envoy for Tibetan issues met with the head of the exiled Tibetan administration this month, generating outrage from China. India, which only recognized Beijing's sovereignty over the area in 2003, also recently venerated a Tibetan soldier who died fighting against China this year in the worst clashes along the border since a 1962 war.

Tensions have risen in other areas as well. Earlier this year, a Chinese government effort to make Mandarin Chinese the language of instruction at schools in a region inhabited by ethnic Mongolians sparked street protests. And in Xinjiang, a province directly north of Tibet, outrage over China's move to detain more than a million minority Uighur Muslims in re-education camps has led some U.S. lawmakers to push for the actions to be declared "genocide."

Jacinda Ardern names 'incredibly diverse' New Zealand cabinet

rime Minister Jacinda Ardern unveiled what she called an "incredibly diverse" cabinet on Monday, as she promised to prioritise economic recovery in the wake of the COVID-19 pandemic.

Former Finance Minister Grant Robertson was named deputy prime minister, the first openly gay person to hold the position. He also retains the finance portfolio.

Women and the Maori community were also strongly represented in the 20-member cabinet, including new Foreign Minister Nanaia Mahuta, who has a "moko kauae" - a traditional Maori tattoo on her chin.

New Zealand's Prime Minister Jacinda Ardern (right) and Nanaia Mahuta who has just been made foreign minister [File: Bianca de Marchi/Pool via AFP]

Ardern has revamped her ministerial lineup in the wake of a landslide election victory. allowing her to form the first single-party government since New Zealand moved to a German-style system of proportional representation in 1996.



"The next three years will be very challenging for New Zealand," she told reporters in Wellington. "With the global outlook worsening we won't be immune to the ongoing effect COVID is having around the world."

While expressing pride at her cabinet's diversity, Ardern also said appointments were made on merit.

"It is both a cabinet with huge merit and talent, which also happens to be incredibly di-

verse." the 40-year-old said. "I think it's an important point to make - these are individuals who have been promoted for what they bring to the cabinet. they also reflect the New Zealand that elected them.

"I think as a country we should be proud of this.'

Ardern won the October 17 election campaigning on New Zealand's success containing the coronavirus and her cabinet includes a new role of minister for COVID-19 response, filled by former Health Minister Chris Hipkins.

She said the change would allow Hipkins to focus on issues such as border control and managed isolation, without distraction from the wider health portfolio.

She also appointed two legislators from the Green Party to ministries outside the cabinet.

One Greens co-leader, James Shaw, will become climate change minister and the other, Marama Davidson, will have a portfolio focusing on preventing family and sexual violence.

3-Year-Old Rescued 65 Hours After Deadly Turkey Earthquake

ayrakli: Rescuers pulled two children from the rubble in a town in western Turkey on Monday, nearly three days after a powerful earthquake hit the Aegean, killing 85 people.

Three-year-old Elif Perincek was rescued 65 hours after the 7.0-magnitude quake struck Turkey and Greece on Friday, the Turkish emergency authority AFAD said.

Local media showed a video of a little girl wrapped up in a foil blanket quickly taken to safety in the coastal town of Bayrakli -- the hardest hit by the disaster -as rescue workers broke into applause.

"I'm so happy, God bless you. I'm reunited with Elif," her grandmother said, quoted by state broadcaster TRT. "My prayers were answered." Elif was the 106th person pulled out

which included her mother and three siblings the day before. But her rescued brother later died,

alive from collapsed buildings in Bayrakli,

TRT reported. AFAD also reported the rescue of 14-year-old Idil Sirin in Bayrakli, 58 hours after the quake hit, levelling buildings in both Turkey and Greece.

But the family's joy was brief as the lifeless body of Idil's sister, Ipek, was found, the Hurriyet newspaper reported. "I can't hear any sounds from my



sister, she's dead," Idil told rescuers as she

was being pulled out, Hurriyet said. Turkey's count from the quake is continuing to rise, with Environment Minister

Murat Kurum reporting 83 dead. Nearly 1,000 people were injured, with over 200 still in hospital.

Two teenagers were also killed on their way home from school on the Greek island

of Samos, near the epicentre of the quake. Racing against time, search and rescue workers are still on a desperate search to try to find people alive in the rubble in Bayrakli, an AFP correspondent at the scene said.

Prince William Had COVID-19 In April, **Kept It Secret:** Reports

London: Prince William, secondin-line to the British throne, contracted coronavirus in April but kept his diagnosis secret, media reported on Monday.

The Sun newspaper said the Duke of Cambridge, 38, was diagnosed shortly after his father, heir-to-the-throne Prince Charles, announced he had caught the virus in late March.

But he did not make the diagnosis public "because he didn't want to alarm the nation", the tabloid said. The BBC also reported the story, quoting a palace source.

William's Kensington Palace office would not confirm the reports when contacted by AFP but also did not deny they were true.

"There were important things going on and I didn't want to worry anyone", the prince was reported to have told a guest at an engagement, adding he was "determined it should be business as usual"

India, World's Largest **Consumer Of Sugar, Wants People To Eat More**



'n a world where sugar has attracted increasing scrutiny for its impact on health and obesity, there are moves afoot in the biggest consuming country to persuade people to eat more of the sweetener.

Mills in India are eyeing increased consumption as a way to cut the nation's chronic oversupply, which stems partly from the favorable incentives provided to growers in politically powerful rural areas. High production costs mean the country finds it hard to sell sugar on the global market without subsidies.

To push forward their initiative, the mills have begun an online campaign to boost demand, involvdomestic ing workshops and webinars, where everyone from nutritionists and endocrinologists, to public health experts and medical practitioners will share their expertise and knowledge.

"Sugar is the most preferred source of the body's fuel for brain power, muscle energy and every natural process that goes body cells," the Indian Sugar rains boosted planting.

Mills Association said, adding that the calories in sugar are the same as calories from any other food, and it's only when calories are not burnt adequately or too many are consumed, that body weight increases.

Social Media

Consumption in India has stagnated at 19 kilograms per capita per year compared with a global average of 23 kilograms as social media campaigns saying the cane-based sweetener is unhealthy discourage people from eating it, according to the association. Per capita consumption growth between 2000 and 2016 was among the lowest in the world, it said.

If per capita consumption rises to the global average, domestic demand will climb by 5.2 million tons a year, according to Sudhanshu Pandey, the top bureaucrat at the food ministry. That would slash the surplus, cut overseas sales and save the government money by reducing export subsidies.

Mutation In Novel Coronavirus May Have Made It More Contagious: Study

lating genetic mutations, one of which may have made it more contagious, according to a study involving more than 5,000 COVID-19 pa-

The research, published in the journal mBIO, however, did not find that these mutations have made the virus deadlier or changed clinical outcomes.

The researchers noted that the mutation, called D614G, is located in the spike protein that pries open our cells for viral entry.

The virus is mutating due to a combination of neutral drift -- which just means random genetic changes that don't help or hurt the virus -- and pressure from our immune systems," said Ilya Finkelstein, associate professor at The University of Texas at Austin, US.

The researchers noted that during the initial wave of the pandemic, 71 per cent of the novel coronaviruses identified in patients in Houston had this mutation.



When the second wave of the outbreak hit Houston during the summer, this variant had leaped to 99.9 per cent prevalence, they said.

This mirrors a trend observed around the world, according to the researchers. The reason why strains containing this

mutation outcompete those that didn't have it may be that natural selection would favour strains of the virus that transmit more easily, the researchers said.

However, some scientists have suggested another explanation, called founder's effects.

In that scenario, the D614G muta-

tion might have been more common in the first viruses to arrive in Europe and North America, essentially giving them a head start on other strains, according to the researchers.

The spike protein is also continuing to accumulate additional mutations of unknown significance, they said.

The team also showed in lab experiments that at least one such mutation allows spike to evade a neutralising antibody that humans naturally produce to fight SARS-CoV-2 infections.

The researchers said this may allow that variant of the virus to more easily slip past our immune systems.

Although it is not clear yet whether that translates into it also being more easily transmitted between individuals, they said.

The scientists noted a total of 285 mutations across thousands of infections, although most don't appear to have a significant effect on how severe the disease is.

31% Candidates In **Bihar Phase 3 Polls Face Criminal Charges: Report**

NEW DELHI: Out of 1,195 candidates contesting in phase-3 of the Bihar assembly elections later this week, 31 per cent have declared criminal cases against themselves, according to a report by poll rights group Association for Democratic Reforms (ADR).

About 282 or 24 per cent have declared serious criminal cases against themselves. Serious criminal cases are non-bailable offences attracting over five years of imprisonment, the report said. As many as 361 or 30 per cent

of these candidates have stated their financial assets to be worth crores of rupees, the report said. Out of 1,195 candidates ana-

lyzed, 371 or 31 per cent have declared criminal cases against themselves, it said. According to the report, 32 (73 per cent) out of 44 candi-

dates analysed from the RJD have declared criminal cases against themselves and 22 (50 per cent) of them have declared serious criminal cases against themselves in their affidavits. About 26 (76 per cent) out of

34 candidates analysed from the BJP have declared criminal cases against themselves and 22 (65 per cent) have declared serious criminal cases against themselves in their affidavits, the report said.

It said about 19 (76 per cent) out of 25 candidates analysed from the Congress have declared criminal cases against themselves and 14 (56 per cent) have declared serious criminal cases against themselves in their affidavits.

About 18 (43 per cent) out of 42 candidates analysed from the LJP, 21 (57 per cent) out of 37 candidates analysed from the JD(U) and 5 (26 per cent) out of 19 candidates analysed from the BSP have declared criminal cases against themselves in their affidavits.

Eleven (26 per cent) out of 42 candidates analysed from LJP, 11 (30 per cent) out of 37 candidates analysed from JD(U) and 4 (21 per cent) out of 19 candidates analysed from the BSP have declared serious criminal cases against themselves in their affidavits.

As many as 37 candidates have declared cases related to crimes against women and five of them have declared cases related to rape, the report said.

The report said 20 candidates have declared cases related to murder (IPC Section-302) against themselves and 73 candidates have declared cases related to attempt to murder (IPC Section-307) against themselves. As many as 72 (92 per cent) out of 78 constituencies are red alert constituencies, i.e. those where

three or more contesting can-



didates have declared criminal cases against themselves, it said.

The findings of the report were unveiled at a press briefing by the ADR. Jagdeep Chhokar, founder

member and trustee of ADR and National Election Watch, said the directions of the Supreme Court have had "no effect" on the political parties in selection of candidates as they have again followed their old practice of giving tickets to candidates with criminal cases.

"All major parties contesting in Bihar Phase III elections have given tickets to 26 per cent to 76 per cent candidates who have declared criminal cases against themselves," he said.

The Supreme Court in its directions in February had asked political parties to give reasons for selecting candidates with criminal backgrounds and why other individuals without criminal antecedents could not be selected as candidates

"This data clearly shows that political parties have no interest in reforming the electoral system and our democracy will continue to suffer at the hands of lawbreakers who become lawmakers," Chhokar said.

The details of the financial background of the candidates was also given in the report.

"Out of the 1,195 candidates, 361 (30 per cent) are crorepatis. Among the major parties 31 (91 per cent) out of 34 candidates analysed from BJP, 17 (68 per cent) out of 25 candidates analysed from Congress, 35 (80 per cent) out of 44 candidates analysed from RJD, 30 (81 per cent) out of 37 candidates analysed from JD (U), 31 (74 per cent) out of 42 candidates analysed from LJP and 10 (53 per cent) out of 19 candidates from BSP have declared assets worth more than 1 crore," the report said.

The average of assets per candidate contesting in the Bihar Assembly Elections 2020 Phase III is

1.47 crore, the report said. "Among major parties, the average assets per candidate for 25 INC candidates analysed is 2.57 crores, 37 JD(U) candidates analysed is 3.31 crores, 44 RID candidates have average assets of 4.79 crores, 42 LIP candidates have average assets of

3.14 crores, 34 BJP candidates have average assets of 3.86 crores and 19 BSP candidates have average assets worth 336 crore" it said

These Are The Airlines On The Brink Of Ruin In Coronavirus Crisis

Taving a home government with deep -- and open -- pockets is emerging as key in terms of whether an airline will make it through the coronavirus pandemic. Carriers in jurisdictions where there

is scant support from up high are most likely to go bust, according to an analysis by Bloomberg News. Using the Zscore method developed by Edward Altman in the 1960s to predict bankruptcies, Bloomberg sifted through available data on listed commercial airlines to identify the ones most

prone to financial strife. Versus the same analysis done in March, when the virus was just starting to spread beyond China into parts of Asia and Europe, rapidly cutting off international travel, the results show a clear swing to the West. At least four of the 10 airlines named back then have restructured in some fashion, and all but one were in Asia.

The list now is populated more by carriers in Africa and Latin America,



where some have already folded or entered administration. Representatives from Medview Airlines Plc, Precision Air Services Ltd., Grupo Aeromexico SAB and Gol Linhas Aereas Inteligentes SA didn't immediately respond to requests seeking comment.

AirAsia Group Bhd. and Azul SA declined to comment. Thai Airways International Pcl said a reorganization plan will be proposed to the Central Bank-

ruptcy Court by the end of the year, and noted the company plans to fulfill its commitments to all creditors.

A spokesman for Pakistan International Airlines Corp. said while data may show the airline's liabilities exceed assets by around four times, "in reality it's different because those liabilities are extended on sovereign guarantees and servicing is done through the government budget. In that sense, the situation isn't as it shows. We're comparatively doing okay."

That's not to say Asia is out of the woods. AirAsia X Bhd., AirAsia's longhaul budget arm, is restructuring more than \$15 billion of debt and the future of state-run Malaysia Airlines Bhd. remains uncertain. The director of aviation development at the Malaysian Aviation Commission, Germal Singh, said recently the government is unlikely to intervene to help out.

Cash Burn

In Latin America, Grupo Aeromexico SAB last month received a \$1 billion bankruptcy loan, while Colombia's largest airline, Avianca Holdings SA, is awaiting court approval for a \$2 billion financing plan as it reorganizes under Chapter 11. Proxy Writer In Assam JEE-Mains Scam Arrested At Guwahati Airport **GUWAHATI:** The proxy writer in police custody. cial investigating team set up to

the Joint Entrance Examination (Mains) scam was arrested on Sunday evening from Lokpriya Gopinath Bordoloi International airport in Guwahati, police said.

The Assam Police Headquarters said in a release that Bhargav Deka, the owner of a citybased coaching institute Global Edu Light, has been arrested. Police had launched a hunt to

arrest the two accused - Deka and a Tata Consultancy Services (TCS) employee - in connection with the examination scam in which a candidate used a proxy and topped in the state.

So far, seven persons have been arrested with five, including the candidate, his father, two TCS employees, and an invigilator arrested on Wednesday and remanded to five days

The arrested have been identified as candidate Neel Nakshatra Das, his father Dr Jyotirmoy Das and three alleged accomplices Hemendra Nath Sarma, Pranjal Kalita and Hiru-

kamal Pathak.

One woman was held on Saturday, Police Commissioner Munna Prasad Gupta said.

Meanwhile, police has approached the National Testing Agency (NTA), which conducts the exam across the country, and sought data to aid the investigation.

The NTA had outsourced the infrastructural and human resources support to TCS for conducting the examinations.
