4 Cops Injured In Baramulla Accident

SRINAGAR: At least four policemen were injured, one of them critically after an escort vehicle of a former PDP legislator met with an accident in north Kashmir's Baramulla district, reports said Monday.

An escort vehicle of former Legislator Rafiabad Yawar Mir met with an accident near Stadium Colony Baramulla on Sunday evening leaving at least four policemen injured, news agency KNT reported. All the injured cops were removed to the nearby district hospital for treatment. However, one of the critically wounded cop identified as Muhammad Yousuf was referred to SKIMS Soura for further treatment.

Three other cops have been identified as Selection Grade Constable Ramesh Kumar of Kishtwar. Head Constable Gh ulam Mustafa Khan of Ganderbal and Constable Tarig Hussain Jinder of Boniyar Baramulla.

Army Defuses Live Shell In Uri

URI: Army on Monday detonated unexploded shell fired from across the border last week in Kamalkote area of Uri in north Kashmir's Baramulla district.

There was heavy exchange of gunfire and shells between the armies of India and Pakistan last Friday in Kamalkote and Hajipeer sectors of Uri, leaving four civilians and two soldiers dead. A shell was found unexploded in residential house at Kamalkote and was defused by Army's Bomb disposal squared (BDS) today, reported news agency GNS.

SDPO Uri confirmed that the live shell was detonated in the area. He said a police team was also on spot.

According to reports several live shells are lying in Hajipeer and Kamalkote sectors after last Friday's incident.

CBI Takes Over Roshni Probe, Files 3 Cases

Senior IAS Officer Among Those Under Scanner

NEW DELHI: Taking up the cases in the Roshni Act Scam, the Central Bureau of investigation (CBI) on Monday filed three separate cases for alleged land grab in Jammu and Kashmir in collusion with government officials, in which a secretary-ranked officer at the Centre is also under scan-

ner, officials said on Monday. The cases were earlier probed by the State Vigilance Organisation and the CBI has taken over the probe on the orders of the Jammu and Kashmir High Court, they said.

The cases relate to alleged land grab in Jammu and Samba districts, they said.

The third case pertains to Samba district where revenue officials allegedly conferred undue pecuniary benefits upon the illegal occupants of the state land by intentionally contraven-

ing provisions of the Roshni Act. "It was further alleged that in many cases, ownership rights over the state land were conferred in favour of individuals, who were not having the recorded possession in their respective names in the revenue records. It was also alleged that the rates were not fixed by the Price Fixation committee, as per the provisions of the Act and in many cases were not remitted to the Government Treasury, thereby causing huge loss to the state exchequer," Gaur said.

Shooting Stones, **Landslides Block** Highway

Hundreds Of Load Carriers, **Passenger Vehicles Stranded**

SRINAGAR: The 270-km Jammu-Srinagar highway, the only motorable road link, with rest of India was again closed on Monday due to snowfall and landslides, a traffic police official said.

The official said after initially allowing movement of some vehicles in the morning, traffic on the Srinagar-Jammu national highway was suspended after landslides and shooting stones at Batery Cheshma and Panthyal, triggered by rain.

There were about three to four inches of snowfall at Jawahar tunnel, Banihal and Shaitan Nallah and it was still snowing heavily when the reports last received at 0945 hrs, he said adding the road has become slippery due to which traffic movement was stopped.

The Light Motor Vehicles (LMVs) were to ply today from Jammu to Srinagar and Heavy Motor Vehicles (HMVs) from the opposite direction, he said.

The upper heights in Banihal on Jawahar tunnel area received more than one feet of snowfall, he said.

The National Highway Authority of India (NHAI) and Border Roads Organisation (BRO) has already put sophisticated machines and men at different places to clear the landslides and snow. However, continued snow and shooting stones are hampering the road clearance operation.

He said traffic will be resumed only after receiving green signal from the NHAI and BRO besides traffic police personnel deployed at different places on the highway.

However, he said, there is a forecast for more snow and rain during the next few days **••** More On P2

Guns Roar Along LoC After Two-**Day Lull**

SRINAGAR: Three days after a deadly clash along the Line of Control (LoC) left five soldiers and five civilians dead, the India and Pakistan troops on Monday exchanged mortars and other weapons along the LoC in the frontier Kupwara district.

"Pakistan initiated an unprovoked ceasefire violation along LoC in Tangdhar Sector, Kupwara district today evening by firing mortars & other weapons," Srinagar based Army Spokesperson, Col Rajesh Kalia said,

On Friday, the LoC across north Kashmir witnessed unprecedented shelling leaving at least four soldiers, a border guard and five civilians dead and at least twenty people, including civilians and soldiers injured.

Property Worth Lakhs Destroyed In **Bandipora Fire**

SRINAGAR:- Property worth lakhs of rupees has been damaged in an overnight devastating fire incident in Bandipora district of north Kashmir, official sources said on Monday.

The fire broke out in a shopping-cum-residential complex belonging to local Augaf at Aloosa in Bandipora at 2 am. However, before the fire tenders could reach the spot and join the locals to control the leaping flames, fire spread to entire complex, housing six shops and four residential rooms.

Locals said that shopkeepers have lost their everything in the fire. However, there was no report of any loss of life or injury in the fire.

The cause of fire was not known, they said adding police has registered a case and initiated proceedings.



As Party Leader Files Nomination Papers

SRINAGAR: Cracks have started widening in the People Democratic Party, as a party leader has filed nomination papers for the upcoming District Development Council (DDC) elections from central Kashmir's Budgam district, where Peoples Alliance For Gupkar Declaration (PAGD), an amalgam of seven mainstream parties, including PDP has also fielded a candidate from National Conference.

Much to the embarrassment to the Mehbooba Mufti led PDP: the party's District President for Beerwah, Nazir Khan filed his nomination papers at DIET Beerwah as an independent candidate on Monday. Khan accused NC Vice-President Omar Abdullah of sabotaging his candidature as a PAGD candidate.

"Omar Abdullah played politics and without informing Farooq Abdullah and Mehbooba Mufti nominated NC candidate, who has no ground in Beerwah, just to weaken my position." Khan said. Khan became second independent candidate after Akhtar Ali from Hayatpora Beerwah who is also in the fray. Besides Khan and Ali, there is PAGD's candidate Muhammad Ashraf Lone from Poonchgund, BJP's Showkat Wani from Loolipora, and PDF candidate Javaid Beigh from Sonpah Beerwah

SRINAGAR: Seven more people succumbed to coronavirus infection in Jammu and Kashmir on Monday, taking the number of fatalities since the outbreak of pandemic in the Union Territory to 1598.

Officials said Monday that four people from Kashmir Valley lost the battle with the deadly infection, while three others succumbed to Covid-19 in Jammu division. Three among the victims from Valley were residents of Srinagar and one from south Kashmir's Pulwama district. With these deaths, the total count in the Valley has reached region has reached 1060 and 538 in the Jammu region.

Srinagar district with 399 deaths tops the list followed by Jammu (283), Baramulla (157), Budgam (97), Pulwama (85), Kupwara (78), Anantnag (75), Doda (50), Rajouri (48), Kulgam (48), Bandipora(48), Shopian (36), Ganderbal (37), Ud-hampur (35), Kathua (33), Samba (25), Poonch (22), Ramban (18), Kishtwar(16), and Reasi (8). Jammu and Kashmir reported on Monday 390 new cases of coronavirus, including a 15-day-old baby and thirty eight travelers, taking the total number of people infected by the virus in Union Territory to 103009. While Kashmir valley reported 240 new cases, the remaining 150 were confirmed by the officials from the Jammu division.

Giving district wise details, officials said that Srinagar reported 112 cases, Baramulla 58, Budgam 20, Pulwama 8, Kupwara 11, Anantnag 4, Bandipora 11, Ganderbal 13, Kulgam 3, Shopian 0, Jammu 97, Rajouri 2, Udhampur 17, Doda 3, Kathua 5, Poonch 1, Samba 10, Kishtwar 5, Ramban 8 and Reasi 2. 👩

Zoom Meetings Linked To Negative Self-Image, Increase In Plastic Surgery Demand, Experts Say

C pending more time on virtual platforms could be affecting self-image of people and leading them to rush for facial treatments they may not have considered months before confronting a video screen, a new phenomenon called 'Zoom Dysmorphia', experts say.

Writing in the journal Facial Plastic Surgery & Aesthetic Medicine, the authors noted that the COVID-19 pandemic had seen a massive shift towards remote work and living, with people spending record amounts of time on virtual platforms with evidence indicating that these citing their appearance on Zoom as a rearemote trends will persist even when conditions improve.

Zoom had allowed life to go on in an ever-changing world but may be affecting the way individuals view themselves, they said. The authors noted a surge in patients ers said.



son to seek care, particularly concerned with acne and wrinkles. "A recent analysis of Google search

trends during the pandemic showed the terms 'acne' and 'hair loss' are increasing in this newly virtual reality," the research-

Dubbed "Snapchat dysmorphia," the influx of people hoping to look more like their edited selves has caused widespread concern for its potential to trigger body dysmorphic disorder.

They attributed this trend to the association of acne and hair loss with anxiety and depression, common psychological conditions during quarantine.

"We suspect the trend may also arise from people constantly seeing themselves on video and becoming more aware of their appearance," said Arianne Shadi Kourosh, from Massachusetts General Hospital, US, and one of the authors of the article.

Before Zoom took over as the metric used to value one's appearance, people used selfies and an arsenal of photo editing apps to create filtered versions of themselves. Hore On P2

Mehbooba Warns ...

Mehbooba visited the upper reaches of Pahalgam in south Kashmir's Anantnag district on Monday and met people whose 'Dhoks' (temporary shelters) were demolished by authorities as part of an anti-encroachment drive.

"This is part of the illegal pro-cess started by central govern-ment in Jammu and Kashmir after the abrogation of Article 370, under which the people, who live here like nomads, Gujjars, Bakerwals, whose forefathers have been living here for centuries, are being evicted. Mehbooba said.

She said after the Centre made changes in the domicile law, it wants to bring people from the whole country to J-K and evict its own residents.

"This is not happening here (in Kashmir) only. If you see in Jammu, in places like Bhatindi, Sujwan, Chatta, wherever there is Muslim population, the Gujjars, the Bakerwals -- who are the real protectors of these forests -- they (government) pinpoint them and are evicting them. Where will the people go in the winter? she said.

According to the officials, this is the season's first major snowfall in the famous ski resort of Gulmarg in Baramulla and the tourist resort of Sonamarg in Ganderbal.

Gulmarg received 19 cm of snow in the last 24 hours, while Pahalgam in south Kashmir's Anantnag district received light snowfall, the officials said.

Due to the snowfall, the authorities closed the Srinagar-Leh road, which connects Jammu and Kashmir with Ladakh, for traffic on Saturday, they added. The meteorological department said while the weather improved significantly in both the UTs on Monday, light rain or snow at scattered places is likely during the next 24 hours.

The authors noted that in 2019, 72 per cent of the American Academy of Facial Plastic and Reconstructive Surgery members reported seeing patients seeking cosmetic procedures to improve their selfies.

In addition, higher levels of engagement on social media have shown to correlate with increased body dissatisfaction, they said.

"Unlike the still and filtered selfies of social media, Zoom displays an unedited version of one-self in motion, a self-depiction very few people are used to seeing on a daily basis," explained Emmy Graber from the Dermatology Institute of Boston, US.

"This may have drastic effects on body dissatisfaction and desire to seek cosmetic procedures," Graber said.

The reasons behind this critical self-image, noted the researchers, is that during real-life conversations, people do not see their faces speaking and displaying emotions, and do not compare their faces side-by-side to others like they do

on video calls. In addition, cameras can distort video quality and create an inaccurate representation of true appearance, they said.

"One study found that a portrait taken from 12 inches away increases perceived nose size by 30 per cent when compared with that taken at 5 feet," said Shauna M Rice from Massachusetts General Hospital.

"Webcams, inevitably recording at shorter focal lengths, tend to produce an overall more rounded face, wider set eyes, and broader nose," Rice added.

The researchers noted that it is important for patients to recognise the limitations of webcams and understand that they are, at best, a flawed representation of reality. To further deconstruct the motivations behind this influx of patients in the era of Zoom, the authors turned to the facial feedback hypothesis.

The theory explains that treatment of sad-appearing wrinkles may reduce depression by making the patient appear less sad to others. which, in turn, makes them feel better about themselves.

"Perhaps there is a recent surge in patients seeking cosmetic procedures simply because they now see their imperfections on camera daily, or because the wrinkles they see on screen make them look more depressed to others and feel more depressed themselves," the authors added.

Ladakh Records 40 **New Corona Cases**

Leh: Forty people tested positive for COV-ID-19 in Ladakh, taking the infection count in the Union Territory to 7,396, while 96 patients recovered during the past 24 hours, bringing down the active cases to 922, an official bulletin said on Monday.

Ladakh has recorded a total of 89 fatalities -- 49 in Leh district and 40 in Kargil dis-

trict -- since the outbreak of the pandemic. According to the bulletin released by Health Department on Monday afternoon, 38 new cases were detected in Leh and two others in Kargil.

It said 96 patients were discharged after their successful treatment in Leh, taking + the total number of cured patients in the Union Territory to 6,385.

NEW DELHI/AMRAVATI, NOV 16 (PTI) The CBI has booked 16 individuals for posting alleged defamatory material against Supreme Court and Andhra Pradesh High Court judges on social media, taking over investigations from the state CID, officials said on Monday.

The Central Bureau of Investigation (CBI), on the orders of the Andhra Pradesh High Court, has taken over the investigation in 12 cases registered by the state CID on the complaint of B Rajasekhar, the registrar general of the court, the officials said.

It was alleged in the complaint that "key personnel, who are occupying posts of prominence in the state of Andhra Pradesh, by intentionally targeting the judges, made interviews/posts/ speeches attributing motives, caste and corrupt allegations to some of the Supreme Court judges and High Court judges in delivering orders/judgments and they posted abusive, life threatening and intimidating postings against judges in social media i.e Facebook, Twitter over recent orders and judgments delivered by judges of High Court of Andhra Pradesh".

On October 12, the high court directed the CBI to probe the case and submit a report to it in a sealed cover within eight weeks. The next hearing of the case is on December 14.

Taking cognizance of the alleged defamatory posts, the court had directed the CBI to probe the role of prominent persons in the southern

Govt Mulls Unique Identification Number For Landholdings

SRINAGAR: The Jammu & Kashmir government has sought suggestions from its officers for implementation of unique land parcel identification number (ULPIN) in the Union Territory.

Documents reveal that Divisional Commissioner Kashmir's office has written to Director Land Records Kashmir, seeking his inputs/ suggestion for implementation of ULPIN in I&K UT.

"I am directed to request you to kindly look into the matter and furnish your valuable suggestions/inputs for implementation of the ULPIN in the UT of J&K directly to the Financial Commissioner, Revenue, J&K Govt under an intimation to this office," reads the letter written by Assistant Commissioner(Central) Kashmir.

The development comes after Financial

"When persons in positions made comments against the judges and the courts, why have cases not been filed? Looking at things, we are left to infer that a war has been declared on the judiciary,' the bench commented orally during a hearing.

The CBI office in Visakhapatnam registered the case under various sections, including 506 (punishment for criminal intimidation), of the Indian Penal Code (IPC) and section 67 of the Information Technology Act.


According to a report, the security forces had taken three local mazdoors working with a contractor in a forest of Bhadarwah area for guiding them. However, they did not return till late in the eve¬ning. Next day, the government claimed killing of 'three militants' in an 'encounter' with the security-forces in the same forest.

Bodies of the slain 'militants', the agency report said, were handed over to the local police station where these remained unidentified for two days.

Dangerous spiral

n Friday last India and Pakistan engaged in one of their fiercest skirmishes along the Line of Control leading to loss of sixteen lives on both sides, ten of them on Indian side that included four security personnel. On Pakistani side, the government acknowledged the losses of five civilians and one soldier. This is a huge loss. Both sides accused each other of using heavy weapons against each other which not only led to the loss of lives but also destroyed the property. The videos of the damage to the property on both sides went viral on social media. This was like witnessing the scenes from a war.

Mercifully, the situation has since returned to normal. But it's only a matter of time before the situation is likely to go back to square one. Ever since 2003 LoC ceasefire agreement began to fray around a decade ago, the border skirmishes have grown in frequency leading to loss of lives on both sides. This year so far 4,052 ceasefire violations by Pakistan have been reported of which 394 took place in October. 3,233 incidents were reported last year.

Going forward, the situation is hardly going to change. This intermittent killing of soldiers, civilians and also displacement of the civilian population has become an addictive bloody ritual. This gives a cathartic vent to a long entrenched pathological animosity, which is now pursued for its own sake. And there's no way it can be addressed unless the two counties arrive at a fundamental understanding that addresses the core issues at the root of their lingering estrangement. But that prospect appears now farther off than ever before.

More so, after the revocation of Article 370 last year that has further drifted the neighbours apart. Pakistan sees India's withdrawal of Kashmir's special status enshrined in Article 370 as a dilution of what it sees as the disputed status of the region. But New Delhi sees the changes to the constitutional position of J&K as its internal matter. Two positions look all but irreconcilable. But for a durable peace in the region, the two countries have to find a way to get together. This requires statesmanship on both sides. And this will only be possible if there's willingness on the part of the neighbors to resolve their issues. But the Fridays escalation gives no such confidence. The situation looks set to go further downhill from hereon. That is, if the leadership of the two countries doesn't step back and seek to put their relationship back on rails.

ECONOMY CENTRAL Employment Paradox



s per India's leading business Information Company, Centre for Monitoring Indian Economy (CMIE), J&K's unemployment ratio as on October 2020 hovered at around 16 percent. This is way above the all India average of 6.98 percent for the same period. In terms of absolute value, J&K is therefore currently crowded with a staggering number of approximately 7.5 Lakh unemployed people. The actual situation on ground, however, is much worse than what the sample survey based CMIE has estimated-as envisaged in this column (J&K's employment drought 5th Sep 2020). As a matter of established fact, this poor performance on account of employment in J&K is not a new phenomenon and is surely not driven by the prevailing pandemic alone. A quick view of the monthly unemployment rates in J&K on CMIE platform depict a continuously dismal performance throughout the past 48 months, with unemployment rates even touching 30 percent at times.

Logically, the situation of unemployment arises when the number of available manpower exceeds the volume of jobs available in the market. However, the same economy where lakhs of indigenous workers are unable to find jobs, paradoxically, provides secure stable and consistently growing livelihood to lakhs of migrant labor force with fair amount of efficiency. This conundrum of employment irony is what is referred to as an "Employment Paradox" and is definitely not unique with our economy.

How much do non-local workers earn?

Various Govt and private estimates regarding the number of migratory labor force working in J&K has put the number between a range of 5 Lakh to 10 Lakh. Barring the climatically hostile months of December and January, most of these workers spend around 300 days in J&K from February till November. Their daily wage ranges from Rs. 600 to Rs. 1200 depending upon the skill level and the nature of job. Pertinently, these rates are 40-50 percent higher than what they normally earn in their home states of Bihar, UP, Rajasthan, West Bengal etc. From toiling unskilled construction workers and agrarian laborers, these migrant workers over a period of decades have gradually cemented their way into more skillful and high earning roles in manufacturing plants, tailoring shops, salons, gymnasiums, restaurants, masonry, carpentry, tiling and even gold smithing. Add to this their prolific growth in trading sector as well. Door to door selling of textiles, blankets and scores of migrant hawkers selling street food & road side merchandise can be witnessed across the region. Assuming 75% of working days (225 days) at an average daily wage of Rs. 700 across the skill spectrum, a conservative number of five Lakh migrant laborers skim a fortune of Rs. 7875 Crore annually from J&K. To put things into perspective, this is almost equal to our flagships Apple, Walnut and Saffron industries put together, which support over 7 Lakh families in the region. This entire earning pie gets normally divided in two parts. A typical ratio of 60% saving (transferred to their families back home) and 40% on local consumption (on rentals, conveyance and food), is followed. In other words, it means an annual flight of approximately Rs. 4725 crore and a domestically created demand of around Rs. 3150 Crore.

Despite chronic regional unemployment, the local market forces have been more than willing to let the trend continue. Why has this issue never became a part of the political debate in J&K? The answer is surprisingly simple - nobody actually wants these jobs. This economically ironic behavior is surely not without an explanation and there are a host of social as well as economic reasons for this employment conundrum.

Firstly, the disruption caused in the categorization of economic classes in 1950, when land was distributed evenly among peasants and landlords blurred class lines. This iconic decision resulted in an economically homogeneous society with majority of the people lying somewhere in the middle of the income bell curve. Land ownership has been a great leveler and this is why even today after almost seven decades, the below poverty ratio in J&K at 10.35% is less than half of all India average of 21.92%. This is precisely the reason why it is very difficult for us to find indigenous workers for lower strata jobs in the economy.

Secondly, due to comparatively blurred levels among social classes, the education levels among generations too have been almost at par with minor inequality. With vast majority of workforce carrying respectable academic credentials, the expectations for an office going white collar job too have been acting as a spoil sport. We have examples where people have preferred a Rs. 1500 per month RET job rather than earning almost 10 times more in the open market. Thirdly, there has been a growing chasm of skill mismatch. While our educational institutions have been awarding diplomas and degrees to growing number of youth, the stress has mostly been on theoretical aspects - unfortunately even in technical courses. Ideally, the skilled and technical human resource requirement of an economy is supplied by ITIs and Polytechniques. We do have both these supply chains established long back with numerous employees and branches spanning across the region but somehow it seems that they have lost the plot. What they train is obsolete and what is demanded is absent. Despite our manufacturing & construction sector creating decent salaried jobs, the skill starved youth are finding it difficult to compete with experienced migrant workers in this segment.

conflict has been the main building block around which these structural flaws have emerged. The backwardness of our industry and private sector which has forced it to remain small and primitive has resulted in very elementary levels of job creation. The impact on our technical and vocational skill centers too has been severe. Operating within an environment of frequent restrictions on physical movement and sustained communication shut down have resulted in chronic down gradation of the regional private sectors' ability to soak middle income level employment. As a natural response, job seekers and likewise the educational sector adjusted negatively.

Poverty is a great influencer but so is social approval and perception of dignity. With time the stereotype constructed by the economically backward migrant workers in construction, orchards and brick kilns, the stigma of rubbing shoulders with such class of laborers at work erected huge social barriers even among people who are desperately in need of earnings. There is a tacit structural hierarchy of work and migrant laborers are being perceived at the lowest step of the work ladder. This is why we see local farmers paying Rs. 600 per day to migrant workers in their paddy fields and orchards so that they can spare themselves to work in a contractual Govt job at Rs. 225 per day. This is beyond financial loss and gain for them. This is more about gaining social equity. Nevertheless, things are changing fast. The sustained economic shocks are pushing more indigenous people below the poverty line and the skill sets needed for new jobs is changing fast. Moreover, the migrant labor force has slowly but growingly been competing in more skill based sectors. How these fast changing dynamics will govern the job markets in future will determine the fate of this paradox. We can only hope that timely policy interventions and effective responses from job seekers change the situation for better. All eyes on the economy inance minister Nirmala Sitharaman an-nounced the third Atmanirbhar Bharat package on Thursday. The announcements came on a day when the two important economic numbers were announced. The Index of Industrial Production came out of contraction zone — it grew at 0.2% on an annual basis — in September for the first time since the imposition of a nationwide lockdown. The Purchasing Managers' Index manufacturing had entered expansion zone in August and has been gathering momentum since then. India's retail inflation, as measured by the Consumer Price Index, grew at 7.61% on an annual basis in October. This is the highest monthly growth in inflation since June 2014, the first full month after Narendra Modi assumed office. To be sure, the inflation spike is a result of seasonal shocks to food prices and the government's taxation policy on petroleum products, rather than an overheating of the economy.

Given the fact that the government will be presenting the next Union Budget in just over 75 days, it is reasonable to assume that no significant measures will be announced before it. While there is an acknowledgement of the fact that sequential economic recovery has been gaining momentum, it remains to be seen how much of this is preserved after the festive season. Keeping food inflation under control has been one of the key political economy priorities of this government. If things do not improve quickly, there could be more curbs on both domestic and foreign trade in food items, which goes against the spirit of agricultural reforms announced earlier this year. More broadly, the government's measures are positive — but whether they will be enough remains a big question.

Surging Menace of Child Labor

ur screens have been filled with distressing images of people from economically underprivileged sections suffering because of the pandemic, loss of job, the unprecedented lockdown and our general apathy towards them. The fallout of the migrant crisis, floods, cyclones and other challenges exposed people to different risks which had severe impacts because they were coupled with the threat of Covid-19.

Consequently, this year has been tough on everyone especially families from underprivileged backgrounds. This has in turn exposed people to more and more vulnerabilities. One such alarm has to be rung on the front of increasing risks to children especially through child labor.

One in ten children is laboring in the global economy today. Children don't even get a chance to start school because of poverty pushing them into being trafficked, prostitution and manual labor. They are often separated from their parents. Children are often put in illegal sectors which do not have any income regulations. This encourages child labor as children are considered a cheap labor. These children are often also victims of physical, mental, and sexual violence.

In addition to denying Children the right to education, working at such a young age also exposes children to threats to life. They have a risk of being victims of crime and may in fact be led into it because of vulnerability. There also severe health risks associated with child labor. In the world's poorest countries, around 1 in 4 children are engaged in child labor. them, 152 million are victims of child labor; almost half of them, 73 million, work in hazardous child labor. Among 152 million children in child labor, 88 million are boys and 64 million are girls.

The pandemic has adversely impacted children as many have had to drop out of schools and work to make ends meet. chal society, their education is never considered as a necessity. With financial constraints, girl's education maybe a far cry now, augmented by structural consequences of poverty.

The recent changes in labour laws in India are likely going to weaken laws that discourage child labor. With a view to boost the economy, states such as Gujarat, Punjab, Himachal Pradesh, Uttar Pradesh, Maharashtra, Rajasthan, Madhya Pradesh, Odisha, and Assam have amended the Factories Act, 1948 through an ordinance, to allow companies to extend a factory worker's daily shift from eight to 12 hours per day. Most of these states also have a high burden of child and adolescent labourers. Though the recent changes do not affect child labour legislation per se, they may fuel an increase in demand for adolescent workers who housing. You can educate them that in the long term it is better that the child is educated, so they can have a better job. Also tell them that the child has the right not to be forced to work! Organize a debate evening in your community in which you can share information and let parents and children talk to each other about this problem.

Is a child in your class suddenly not coming to school anymore? Or does a friend tell you that he or she needs to work to earn money? Often there are people you can report this to: a local organization, social workers, and teachers. Research who can help you and report the case

Up and Running: Beat the Winter Blues

s winter descends and as the temperature drops and daylight hours shorten, many people may want to spend more time indoors. And those of us under lockdown may feel even less inclined to get outside and exercise. But staying indoors may have unintended health consequences, due to both a lack of physical activity and exposure to daylight.

Being physically active all year long has many benefits to both physical and mental health. Exercise may even counter some of the negative effects winter weather can have on our energy levels and mood.

Research shows people exercise for an average of eight minutes less during the cooler months. People also drop other activities they do during warmer months, such as active travelling. Light intensity activity (such as slow walking and housework) is shown to decrease during the winter, while time spent sitting and sleeping increased.

But, despite decreases in light intensity activity and sleeping more, researchers did not find any differences in terms of sleep quality, nor did it find a drop in moderate and vigorous activities – such as planned exercise classes or walking the dog – which people still did, despite the weather. A preprint (not yet peer-reviewed) study also suggests that activity levels were lower during the first spring lockdown. This could mean people may be even less active this winter.

There are many reasons we may lose our motivation to exercise during the winter months. In the winter, low levels of ambient light coupled with shorter days reduces exposure to vitamin D. This causes us to feel tired or fatigued. People often experience disrupted sleep during winter months as well, further contributing to low energy levels.

Seasonal mood disturbances may also make it difficult to find the motivation to get up and move. Many people (particularly women) experience low mood as the weather gets colder. Some even develop mental health disorders such as seasonal affective disorder (SAD), in which a person experiences symptoms of depression during the winter months.

Exercise benefits

The benefits of engaging in regular physical activity are widely reported for physical health – including reductions in weight, coronary heart disease, type 2 diabetes, strokes and certain types of cancer. It's also associated with greater immune function.

Physical activity is also important for wellbeing. It's been shown to reduce fatigue and enhance job satisfaction), optimism, selfesteem and better stress management. Exercise can also be used effectively to treat mental health conditions such as depression and

The reasons why we exercise can also affect our motivation levels. For example, motivation is shown to waver if the primary focus of our exercise is on improving health and body image, rather than exercising for enjoyment and accomplishment. Research also shows that people who exercise outdoors all year round are better at finding the time to stick to their routine, and are more motivated by their enjoyment, or the challenge of their exercise compared too those who are only active during warmer months. So it's easy to see how a person's mood can lead to a more sedentary lifestyle. anxiety SAD, and promotes positive mood.

Though winter weather might not always allow it, exercising outdoors is also great at reducing mental fatigue and stress, improving wellbeing, life satisfaction and happiness. Adolescents in particular benefit mentally from being in natural spaces. Blue spaces – such as coastal regions and inland waterways – also have similar restorative benefits for mental health.

Outdoor exercise also provides more opportunities for social interaction, which, if allowed, is important for our health and wellbeing during this winter lockdown. Exercis-

ing outdoors in natural light is also linked to improvements in sleep quality, physical health and wellbeing.

To achieve these mental and physical benefits, it's important to make sure you're getting enough exercise. The UK's NHS recommends a weekly health target of 150 minutes of moderate intensity activity (or 75 minutes of vigorous intensity), which can easily be broken down into smaller chunks of ten minutes throughout the week. Moderate activity is enough to raise your heart rate, make you feel warmer and breathe faster. An easy way to tell is that you can still talk but find it difficult to sing. Two days of the week should also focus on strengthening activities.

Though it can sometimes be hard to find the motivation to exercise, carrying an activity monitor (wearable accelerometer) or phone app that records activity (such as step count) can motivate and enable people to set and achieve goals. Committing to activity can also be easier if you have someone to exercise with. Increasing the challenge – such as the number of activity sessions, the intensity (such as walking speed or weight lifted) or the time spent in each session – can also increase fitness and strength.

Thankfully, there are plenty of ways to be active during the winter. In addition to sport and forms of exercise, taking active transport (walking and cycling to work), or doing chores will all contribute. Of most importance is to break up time sitting with movement and activity outside, in daylight, to ensure you profit from the additional health benefits.

ork stress and burnout are mutually reinforcing, suggests a recent study conducted on work-related stress.

"This means that the more severe a person's burnout becomes, the more stressed they will feel at work, such as being under time pressure, for example," said Professor Christian Dormann of Mainz (JGU).

"When exhausted, the ability to cope with stress usually decreases. As a result, even smaller tasks can be perceived as significantly more strenuous," said Guthier, the first author of the article.

"We expected an effect of burnout on work stress; the strength of the effect was very surprising," she noted.

The effect of burnout on perceived work stress can be somewhat mitigated if employees have more control over their own work and receive support from colleagues or superiors.

According to Dormann, a new research area is emerging on the basis of this unique data because the strong boomerang effect of burnout on work stress has not yet been investigated.

Key questions that need to be addressed are: how can the effects of burnout on perceived work stress be reduced and how can the development of this vicious circle be prevented? Dormann and Guthier suggest that the place to start is with management behaviour.



COVID-19 Vaccine Delivery To Begin By End Of This Year, Or Next Year Beginning: Scientist

London: If coronavirus vaccinations are rolled out widely, life could return to "normal" by next winter, one of the scientists behind the frontrunning coronavirus vaccine told British television on



Ugur Sahin, the Turkish co-founder of German firm BioN. told the BBC's The Andrew Marr Show that "this winter will be hard" without any major impact from vaccinations.

Together with US giant Pfizer, BioN is developing the leading candidate in the worldwide chase for a vaccine.

"If all goes well, we will start to deliver the vaccine at the end of this year, or be-



"Our goal is to deliver more than 300 million doses by April next year, which could already have an impact," he said.

The infection rate will then go down in summer, he predicted, adding that it is essential that there is a high takeup of the vaccination by autumn.

"I'm confident that this will happen, he said. A number of vaccination

companies are working to increase the supply, he said: "so we could have a normal winter next (year)."

Sahin and his wife Ozlem Tureci founded BioNTech in the western German city of Mainz in 2008.

Having identified promising vaccine blueprints, the company formed a partnership in March with American pharmaceutical giant Pfizer.

The announcement on Monday that their vaccine was more than 90 percent effective in trials led news bulletins around the world and sent stock markets and hopes soaring.

BioNTech is now worth \$25.8 billion (21.8 billion euros), more than Germany's largest lender Deutsche Bank.

UAE Extends "Golden" Visa Eligibility, Allows 10-Year **Residency To Some Professions**

Dubai: The United Arab Emirates will extend its "golden' visa system - which grants 10-year residency in the Gulf state - to certain professionals, specialised degree-holders and others, the UAE's vice president said on Sunday.

Foreigners in the UAE usually have renewable visas valid for only a few years tied to employment. The government in the past couple of years has made its visa policy more flexible, offering longer residencies for certain types of investors, students and professionals

All holders of doctorate degrees, medical doctors and also computer, electronics, programming, electrical and biotechnology engineers are eligible. UAE Vice President and the ruler of Dubai Sheikh Mohammed bin Rashid al-Maktoum said in a statement.

Also eligible are those with specialised degrees in artificial intelligence, big data and epidemiology, as well as high school students living in the UAE who rank top in the country and students from certain universities with a GPA of 3.8 or higher.

After first announcing a long-term visa plan in 2018, the UAE in 2019 started granting 5- and 10-year renewable visas to certain foreign inves tors, entrepreneurs, chief executives, scientists and outstanding students.

The emirate of Dubai, a Middle East trade and tourism hub, in September said it would grant visas renewable every five years to wealthy foreign retirees An oil and gas producer,

"I Concede Nothing": Trump's U-Turn After Accepting Biden "Won"

Washington: President Donald Trump on Sunday briefly acknowledged losing the U.S. election in a morning Twitter post but then backtracked, saying he concedes "nothing" and vowing to keep up a court fight that election-law experts say is unlikely to succeed.

President-elect Joe Biden focused on the coronavirus pandemic, setting meetings with vaccine developers as the crisis intensifies. The number of U.S. coronavirus cases passed 11 million on Sunday, a million more new cases than a week ago and the fastest increase since

the pandemic began. Biden defeated Trump in the Nov. 3 election by the same 306-232 margin in the state-bystate Electoral College that Trump proclaimed a "landslide" when he won it in 2016. The Democratic former vice president also won the national popular vote by at least 5.5 million votes, or 3.6 percentage points, with some ballots still being

counted. Trump, pursuing long-shot litigation to contest election results in several states, made conflicting comments on Twitter. He initially appeared to admit for the first time publicly that Biden won, then reversed course. Trump also repeated unfounded claims of wide-

spread voter fraud. "He won because the Election was Rigged," Trump wrote, not referring to Biden by name, adding a list of complaints about vote counting. About 90 minutes later, Trump wrote: "He only won in the eves of the FAKE NEWS MEDIA. I concede NOTHING!

After golfing at a club he owns in Virginia, Trump said on Twitter he would soon file "big cases showing the unconstitutionality of the 2020 Election." Trump's campaign has filed lawsuits seeking to overturn the results in multiple states, without success.

Legal experts have said the Trump litigation stands little chance of altering the election's outcome, and election officials of both parties have said there is no evidence of major irregularities

"Donald Trump's Twitter feed doesn't make Joe Biden president or not president. The American people did that," Ron Klain, Biden's choice as White House chief of staff, said on NBC's "Meet the Press.

More than a week after Biden was declared the victor by major news organizations based on state-by-state vote counts, the General Services Administration still has not recognized him as president-elect, preventing his team from gaining access to government office space and funding normally afforded to an incoming administration to ensure a smooth transition.

Without explicitly mentioning the transition, Trump praised the GSA administrator he appointed, Emily Murphy, writing on Twitter: "Great job Emily!"

Klain said Murphy's agency must formally recognize Biden, saying it is critical to ensure the president-elect receives intelligence briefings before taking office and to facilitate coordination with the White House coronavirus task force. Klain urged

licans and former members of Trump's administration have also called on the White House to allow Biden's transition team access to more information to

The health crisis will be a paramount concern for Biden, who takes office on Jan. 20. Klain said Biden's scientific advisers would meet with Pfizer Inc and other drugmakers starting this week to prepare for the "giant logistical project" of widespread vaccination against a virus that has killed more than 245,000 Americans and thrown millions more out of work.

Pfizer said last week its vaccine candidate proved more than 90% effective in initial trials, giving hope that widespread vaccination in the coming months could help get the pandemic under control.

Other companies also are in advanced stages of developing promising vaccines

"It's great to have a vaccine, but vaccines don't save lives. Vaccinations save lives." Klain said. "And that means you've got to get that vaccine into people's arms all over this country."

'Israel, Working With US, Killed Qaeda Deputy In Drive-By Attack'

Jerusalem: Israeli agents acting at the behest of American officials assassinated al-Qaida's second-in-command in August, in a brazen drive-by shooting in Iran's capital, according to a senior U.S. official.

Abdullah Ahmed Abdullah, whose nom de guerre was Abu Muhammad al-Masri, was killed along with his daughter, Maryam, as they were driving in an upscale Tehran neighborhood, according to the official, who spoke on the condition of anonymity because of the matter's sensitivity.

The operation, first reported Friday by the New York Times, further slims the leadership ranks of al-Qaida and removes the accused mastermind of the 1998 bombings of two U.S. embassies in East Africa that killed more than 200 people.

Al-Qaida has not officially acknowledged Masri's death, and no country has claimed responsibility. The Israelis coordinated the operation with the CIA, according to the official. The CIA, FBI and Pentagon declined to comment, and the White House did not respond to a request for comment. The Israeli prime minister's office and intelligence ministry also declined to comment.

"One Heck Of A Ride": SpaceX Launches 4 Astronauts Into Space

Washington, United States: SpaceX confirmed that it was on the right orbit to reach the ISS a little more than 27 hours later, at around 11:00 pm Monday night (0400 GMT Tuesday), joining two Russians and one American aboard the station, and stay for six months. There was a problem with the cabin temperature control system, but it was quickly solved.

"She's operating just fine," said SpaceX president Glynne Shotwell during the press conference. But "we'll be able to breathe a sigh of relief, 26

or so hours from now, once we hand the crew over to NASA."

SpaceX briefly transmitted live images from inside the capsule showing the astronauts in their seats, something neither the Russians nor the Americans had done before.

US President-elect Joe Biden hailed the launch on Twitter as a "testament to the power of science and what we can accomplish by harnessing our innovation, ingenuity, and determination," while President Donald Trump called it "great."

Bahraini ministers to pay first official visit to Israel for tripartite meeting

Jerusalem: Two Bahraini ministers are set to make the first official visit by ministers from the tiny island to Israel in order to attend a tripartite meeting with Israeli and US officials.

Israel's Walla news site reported on Sunday that Bahrain's Foreign Minister Abdullatif bin Rashid Alzayani and Minister of Industry, Commerce and Tourism Zayed Bin Rashid Al Zayani will pay a visit to Israel later this week.

They are expected to attend a meeting with Israeli prime minister Benjamin Netanyahu, and his US Secretary of State Mike Pompeo in Jerusalem alQuds on Wednesday.

Israel's foreign minster Gabi Ashkenazi will also participate in the meeting.

According to Israeli sources, the parties are due to sign an aviation agreement for direct flights between Tel Aviv and Manama during the meeting.

They will also discuss opening embassies and exchanging ambassadors.

On September 11, US President Donald Trump announced that Bahrain was following the United Arab Emirates (UAE) in normalizing ties with Israel.

Four days later. Netanyahu signed agreements with Emirati Foreign Minister Sheikh Abdullah bin Zayed Al Nahyan

and Bahrain's Foreign Minister Abdullatif Al Zayani during an official ceremony hosted by Trump at the White House.

Pakistan: Ruling PTI Wins Most Seats In Gilgit-Baltistan Assembly Election

rime Minister Imran Khan's Paki-stan Tehreek-i-Insaf (PTI) on Monday won most of the seats in the legislative assembly election in Gilgit-Baltistan in northern Pakistan, keeping alive the tradition of success in the region by the party ruling the country. India has slammed Pakistan for its decision to hold elections in Gilgit-Baltis-

tan and said any action to alter the status of the militarily-occupied region has no legal basis. Elections were held on 23 seats of the

third legislative assembly on Sunday amidst tight security due to the threat of militancy. Unofficial results compiled by the

various media outlets showed that PTI won at least 8 to 9 seats, but it was still well short of majority to form the government. However, it was in a position to form the government as 6-7 independent candidates also won.

Geo TV reported that PTI won 8 seats, independent candidates 6, Pakistan People Party (PPP) 5, Pakistan Muslim League-Nawaz (PML-N) 2, Jamiat Ulemae-Islam Fazl (JIU-F) and Majlis Wahdatul Muslimeen (MWM) 1 seat each.

legislative assembly after political reform introduced in 2010. Traditionally, the party ruling in Is-

lamabad have won the Gilgit-Baltistan polls. The first election was won by PPP when it got 15 seats, followed by PML-However, Dunya TV reported that PTI N, the then ruling party, in 2015 when it won 16 seats.

The voters kept the tradition but with a difference as PTI failed to get an outright majority. PML-N emerged as the biggest loser as it ruled from 2015-2020 stan Muslim League-Nawaz (PML-N).

PPP Secretary General Nayyar Bukhari on Sunday demanded disqualification of ruling PTI candidates from the election.

Regardless of who wins the polls, it is expected that some changes in the status of the region would be announced after the new government was formed in the region.

In a ruling earlier this year, the Pakistan Supreme Court allowed Islamabad to amend a 2018 administrative order to conduct general elections in the region. The Gilgit-Baltistan Order of 2018 provided for administrative changes, including authorising the prime minister of Pakistan to legislate on an array of subjects.

Following the verdict, India issued a demarche to a senior Pakistani diplomat in New Delhi and lodged a strong protest over the apex court ruling.

India also clearly conveyed to Pakistan that the entire Union territories of Jammu and Kashmir and Ladakh, including the areas of Gilgit and Baltistan, are an integral part of the country.

The polls in Gilgit-Baltistan were to be held on August 18, but Pakistan's election commission on July 11 postponed them due to the coronavirus pandemic.

The five-year term of the previous assembly had ended on June 24, bringing an end to the five-year rule of the Paki-

SC Seeks UP Govt's Response Over Arrest Of **Journalist Going To Hathras**

he Supreme Court on Monday sought response of the Uttar Pradesh government on a plea challenging the arrest of Kerala-based journalist Siddique Kappan on his way to Hathras where a young dalit woman had died after allegedly being gang-raped.

A bench of Chief Justice S.A. Bobde and Justices A.S. Bopanna and V. Ramasubramanian asked the counsel for the Kerala Union of Working Journalists (KUWJ) as to why it has not approached the Allahabad High Court and came to it straightaway.
