### **GOC 16 Corps, LG Discuss Situation**

JAMMU: A senior army commander on Thursday briefed Lt Governor Manoj Sinha on the overall security situation in the Union Territory, including the Line of Control (LoC) and on the antimilitancy front.

General Officer Commanding, GOC, 16 Corps Lieutenant General MV Suchindra Kumar called on LG at the Raj Bhavan here and discussed important security issues and the overall security management in the Union Territory with him, an official spokesperson said. The army commander, he said briefed the LG about the prevailing scenario along the forward areas including the LoC.

"Anti-militancy operations and matters pertaining to coordination with other state forces were also briefed by the GOC," he said.

The LG, he said appreciating the government forces for their operational synergy and their success in recent counter-militancy operations said that sustained coordination between security forces and the civil administration is crucial to meet security challenges in Jammu and Kashmir.

### **Tral Shuts Down Against** Power 'Hike'

**SRINAGAR:** The residents in Tral town of south Kashmir's Pulwama district on Thursday observed a token half-day strike against what they termed unprecedented 'hike' in the electricity tariff by the Kashmir Power Development Corporation Limited (KPDCL).

According to local news gather ing agency KNT, all shops in Tral town remained shut for half-day while the public transport was also off the roads in response to the call given by Citizen's Council Tral against the alleged power hike by the KPDCL. The report also said that a protest was also led by Chairman Citizens Council Farooq Trali.

"The protesters decried the hike in electricity charges and asked department not to overcharge consumers," the report said, adding "They said the issue about power-hike was raised on numerous occasions but no action has come so far and hence they are forced to stage this protest

The report quoted MD Kashmir Power Discom, Aijaz Asad as saying that no hike in Power Tariff

has been done by the Regulator. "In fact, tariff levels in Jammu and Kashmir remain unchanged for the past 4 years," he said.

### **ANC Sarpanch Candidate Wins Unopposed**

SRINAGAR: Awami National Conference (ANC) has bagged the Sarpanch seat from Kijpara block of central Kashmir's Kangan

Shabir Ahmed Mir who was fielded by ANC for the constituency was declared victorious after BJP candidate withdrew his nomination form.

ANC has termed this as the victory of people and hoped that people will participate in coming DDC elections in large numbers and will defeat the Bhartiya Janata Party (BJP).

### **Cab Driver Killed In Gurez Accident**

SRINAGAR: A cab driver on Thursday was killed while six passengers were injured in a road accident in Gurez valley of north Kashmir's Bandipora district on Thursday evening.

Sub division police officer (SDPO) Gurez, Peerzada Ajaz said that a passenger cab (JK15-2335), skidded off the road at Check-Nallah village in Gurez, resulting in on spot death of the driver.

He identified the deceased as Muhammad Najmudin of Gujran,

He also said that six persons, who were also travelling in the vehicle were injured and have been shifted to Sub district hospital Dawar for special treatment.

The police officer identified them as Rehamtulla Lone, Abdul Gafar lone, Zahoor Khan, Farooq Ahmad Lone, Zameer Ahmad Khan, Abdul Majeed Khan, all residents of Gujraan and Mohammad Sultan Lone of Muzgund Tulail. (KNO)

## 4 Militants Killed In Pre-**Dawn Highway Shootout**

JAMMU: Four militants were killed and two policemen injured in a gun-battle on the Jammu-Srinagar highway after a truck carrying them was intercepted on the outskirts of Jammu city on Thursday, top police officials said.

The militants had come to execute a "big plan" which has now been foiled, Inspector General of Police (IGP), Jammu, Mukesh Singh, said.

In Srinagar, IGP, Kashmir, Vijay Kumar said the four militants were on their way to the Kashmir Valley to disturb the District Development Council (DDC) polls scheduled later this month, as Pakistan has been trying to cause trouble in the political process.

Giving details of the encounter. IGP Mukesh Singh told a press conference in Jammu that ever since the announcement of DDC polls, police have been receiving inputs about a possible infiltration bid by militants in Jammu.

"We had kept our all teams deployed at check points. There were intelligence inputs that militants may sneak in with large quantities of arms and ammunition," the IGP Jammu said.

A truck was stopped at Ban toll plaza in Nagrota area at 5 am for checking, but the driver left the vehicle and fled, → More On P2

## **2 Militants Escape From Army Dragnet In Pulwama**

SRINAGAR: The militants, one of them purportedly a top Jaish-e-Mohammad (JeM) commander, have managed to escape after a brief encounter with a state forces in Parigam area of south Kashmir's Pulwama district on Thursday, officials said.

A police senior officer said that as per specific inputs two militants including JeM commander with code name "Lambu Bhai" were trapped.

The officer said that the militants

"seem to have fled soon after the encounter broke out." However, the officer said that the searches in the area are continuing, reported news agency GNS.

The encounter which lasted for a brief span of time had ensued after a joint team of Police, Army and CRPF launched a cordon and search operation in Parigam village this afternoon.

As the joint team approached towards the suspected spot, the hiding militants had fired upon the forces, triggering off the brief encounter.

## **HC Grants Govt 4 Weeks To File Reply**

**SRINAGAR:** Jammu and Kashmir education in the Recognized unaided High Court has granted government four weeks more time to file response to a Public Interest Litigation, seeking issuance of the appropriate guidelines for admission of Children with Special Needs (CWSN) under Right To Education Act.

A division bench of Chief Justice Gita Mittal and Justice Puneet Gupta granted the time after NH Shah, Sr. AAG, representing the authorities, sought further time to file the reply.

"Let him file the same within four weeks," the court said, adding, "Rest of the respondents who have not filed the reply shall also file the same within the aforesaid period."

## **Hafiz Saeed** Gets 10 **Years Jail**

**LAHORE:** Jamat-ud-Dawa (JuD) chief Hafiz Saeed was on Thursday sentenced to 10 years in jail by an antiterrorism court in Pakistan in two more terror financing cases.

Saeed, a UN designated terrorist whom the US has placed a USD 10 million bounty on, was arrested on July 17 last year in the terror financing cases. He was sentenced to 11 years in jail by an anti-terrorism court in February this year in two terror financing cases.

The 70-year-old JuD chief is lodged at Lahore's high-security Kot Lakhpat jail.

"The Anti-Terrorism Court (ATC) of Lahore on Thursday sentenced four JuD leaders, including its chief Hafiz Saeed, in two more cases," a court official told PTI.

Saeed and his two close aides Zafar Iqbal and Yahya Mujahid - have been sentenced to 10 and a half years each, while JuD chief's brother-in-law Abdul Rehman Makki was sentenced to six months imprisonment. More On P2

## **Woman Injured** In LoC Firing

JAMMU: Pakistani Rangers opened fire and shelled border out posts (BoPs) and hamlets along the International Border in Jammu and Kashmir's Kathua district, leaving a woman injured, officials said on Thursday.

The Pakistani troops targeted several BoPs and few hamlets in Manyari, Sapwal and Karol Krishna on late Wednesday night, prompting an effective retaliation by the BSF, the officials said. In the exchange of fire, which

continued till this morning, one woman suffered injuries at Manyari village, they said. The shelling has triggered panic among border residents. "We have been facing heavy fir-

ing and shelling each night. It has become a regular feature", Manyari resident Kuldeep said.

"Two shells exploded in our compound and one woman family member suffered splinter injuries", Kuldeep said. Several houses and structures have suffered damage in the shelling, he added. (PTI)

the police official said. Immediately, CRPF and police personnel moved to search the vehicle and came under fire from the militants hiding in the truck.

According to the IGP Jammu, the militants were asked to surrender but they ignored the announcement leading to a gunbattle.

Other security forces also joined in resulting in a fierce gunbattle in which militants lobbed grenades and fired arms, he said.

In the three-hour-long gunbattle, four militants were killed and two policemen injured, the police officer said.

The truck, loaded with rice sacks, caught fire during the encounter. The bodies of the militants, hiding in a cavity within the truck, were recovered.

The two injured policemen, Kuldeep Raj and Mohammad Ishaq Malik, were admitted to Government Medical College (GMC) hospital in Jammu. They were out of danger, officials said.

A huge cache of arms, ammunition and explosive material, including 11 AK rifles, three pistols, 24 magazines, 29 grenades and six UBGL grenades, was recovered, the IGP, Jammu, said.

medicines, explosive material, bundle of wires, electronic circuits and bags in huge quantities were recovered from them.

"This is for the first in the last few years that such a large quantity of weapons were recovered from slain militants," Mukesh Singh said.

Asked about the motive of the militants, Singh said given the quantity of weapons recovered from the slain militants, it seems that the group had infiltrated recently and were "planning something very big".

"But their plan stands foiled," he said, adding the operation was carried out jointly by the police, CRPF and the Army.

The recovered weapons indicate that the militants belong to JeM. They had a big error plan, Singh said, adding efforts were on to track down the truck driver.

A senior police officer said, it seems the militants infiltrated from across the International Border (IB) in Jammu region before boarding a Kashmirbound truck.

Speaking on the sidelines of a function in Srinagar, IGP Vijay Kumar said, "For the last few days, Pakistan has increased attempts to infiltrate militants into this side and to disturb the elections for which the process is on."

"In this context, Jammu Police and security forces have done a good job by neutralising four Pakistanis (militants). Their (militants') aim was to come to Kashmir to disturb the election process".

On January 31, a group of militants had opened fire at a police team near Ban Toll Plaza, triggering a gunfight in which three militants were killed and a policeman got injured.

support para-athletes. Asthana said Pakistan was making increased attempts to infiltrate more militants before the heavy snowfall, but the BSF and all other agencies and forces are prepared and are tackling the situation as best as they can.

"There are attempts to push militants into our country and particularly this period is very suitable for such activities, so all the counter-measures we are taking are very effective and as DG BSF I can tell you we are committed to foil such attempts and we will tackle the situation effectively.

"It is a situation which requires a lot of attention, lot of alertness. This situation is there, no doubt about it and we are facing it, he said.

Referring to the killing of four militants in an encounter in Jammu earlier in the morning, the BSF DG said it was because the forces were alert to the attempts of infiltration from across the border.

The inputs about militants present at launch pads keep on coming. We are alert and prepared to counter that. Today's encounter also signifies that all our security agencies and police force are alert and ready to counter that (infiltration), he said. He said the BSF is committed to the civilians living near border areas and will provide them all sorts of assistance in their difficult times.

The officer said the force was organising a medical camp under its civic action plan to help the people affected by the recent shelling during the ceasefire violations by Pakistan.

Thursday's sentencing weeks after Paris-based global money laundering and terrorist financing watchdog - the Financial Action Task Force retained Pakistan on its grey list till February 2021 as Islamabad failed to fulfil the agency's six key obligations, including failure to take action against two of India's most wanted militants --Saeed and Maulana Masood Azhar.

Saeed-led JuD is the front organisation for the Lashkar-e-Toiba (LeT) which has been accused by India of carrying out the 2008 Mumbai attack that killed 166 people, including six Americans.

The US Department of the Treasury has designated Saeed as a Specially Designated Global Terrorist. He was listed under the UN Security Council Resolution 1267 in December 2008.

The FATF had placed Pakistan on the grey list in June 2018 and asked Islamabad to implement a plan of action to curb money laundering and terror financing by the end of 2019 but the deadline was extended later on due to COVID-19 pandemic.

With Pakistan's continuation in the 'grey list', the country may find it difficult to get financial aid from the International Monetary Fund (IMF), World Bank, Asian Development Bank (ADB) and the Furopean Union, thus further enhancing problems for the cash-strapped nation.

In dashing Pakistan's hopes of becoming militarily equal to or more powerful than India, Indira Gandhi delivered a body blow to that country. By facilitating the break up of Pakistan into two parts, she did yoeman service to India for all time to come," it says.

The book says India moved the Pakistan Army into cantonments where some 93,000 soldiers laid down their weapons - the biggest surrender since World War II.

"Indira Gandhi was now the greatest, much-celebrated heroine of India. The prime minister received a standing ovation in Parliament following the unconditional surrender by Pakistan

It says Pakistan attacked India first on December 3, 1971 and its President General Yahya Khan had hoped his preemptive strike would destroy India's air capability - not knowing that Indians were waiting for him.

"Mrs Gandhi had devoted further resources to India's external intelligence and that paid handsome dividends.

The author says India lost a major opportunity to resolve the Kashmir issue at the Shimla summit in July 1972.

"The talks did not proceed well. India was looking for a solution to the Kashmir issue through talks so as to end hostilities with Pakistan for all time. It is my view that India lost all the advantages it had 1971 because our negotiators failed nuclear capacity". in the game of brinkmanshin India Kashmir issue because it fell for promises made by Bhutto.

"Pakistan recognised Bangladesh, which it would have done sooner or later. meeting in Delhi in November 1983 with But more importantly, it got back its POWs without addressing the Kashmir issue. Bhutto and his delegation were not willing to concede anything, but I believe to this day that he would not have gone back without ensuring the release of Pakistani POWs. The families back home in Pakistan wanted them back.

"Once its POWs were back in Pakistan, the Pakistan Army again began its nefarious activities against Bangladesh and India...And at home, Indira Gandhi faced widespread criticism for signing the Simla Agreement without sorting out Kashmir issue," says the author.

Referring to the beginning of Indira Gandhi's first tenure as Prime Minister, in Bihar which was facing near-famine the book says she assumed prime ministership at a "very difficult time".

"She had to handle the fallout resulting from Lal Bahadur Shastri's agreement in Tashkent. The nation was angry at the withdrawal of its forces from areas such as Haji Pir pass and the mountaintops of Kargil that the army had captured with great sacrifice. The mystery surrounding Shastriji's death added to the general

The book describes how the old guard went against her after the 1967 election, which the Congress won with a small majority, and how she asserted her control over the party by encouraging VV Giri to contest as an independent candidate for the office of country's President against the official nominee of Congress.

"This is the only instance in the country's history since Independence that an independent candidate contested and won the presidential election. This election could have been the undoing of Mrs Gandhi. She had taken a huge gamble," says the book

The author recalls that in an interview Indira Gandhi had termed parliamentary democracy as moribund and not suitable for India. "Years later she toyed with the idea of

introducing a presidential system. The idea was dropped but the fact that it was floated at all suggested she was always looking to consolidate power," he says. Referring to the events leading up

place on 25th of November 2020 from to Emergency in which Indira Gandhi's election to Lok Sabha was set aside in 1975, the author says that the verdict was like "pronouncing a death sentence on someone for jaywalking".

"It is a pity that a tiny technical fault in 1971 election should have led to her election victory being set aside and the horror of Emergency and dictatorship imposed on India, with Sanjay Gandhi, an extra-constitutional centre of power, taking virtual control of the government. There had been no corruption in Indira Gandhi getting elected in 1971," the book savs.

Referring to the atrocities during Emergency in Delhi, the book notes that these took place just a few kilometres from her residence.

"And yet she went about her daily work without any evidence of being affected by the events. In truth, the government was being run by her son Sanjay and the close group around him...Sanjay Gandhi became the virtual prime minister of India. It was clear to most of us journalists that fond, as she was of Sanjay, Mrs Gandhi allowed him to stay in active politics. Soon officials and ministers began taking orders from constitutional centre of power.

"Ultimately, the decision to stop him had to come from the prime minister and the government. But she did not stop him. Why was the modern-day 'Durga' so helpless? No prime minister is ever helpless; they chose to abdicate decision-making. And that is what Indira Gandhi did. She would not be the last Indian PM to do so," the book says.

It says that this span of Indira Gandhi's prime ministership was "to be forever tainted by the stain of Emergency and all the good work she did was overshadowed by dictatorial steps she had taken on her son's behest." The book says Indira Gandhi launched her 1979 election campaign with enormous energy. "Never before had I seen her or anybody else go into a campaign determined to fight it out single-handedly.'

It notes that after winning from two seats, she surrendered Rae Bareli in favour of Sanjay Gandhi.

"It was a clear message to her detractors that she would not punish her son for Emergency. It also, in a way, set precedent for her family, which is given not to admitting to past political mistakes made by their kin".

Recalling how Sanjay Gandhi died in a plane crash in June 1980, the book notes that it was a huge tragedy for Indira Gandhi and she was "shaken, in fact devastated".

"Indira Gandhi was, I don't know why a very lonely person. She had always been a loner but Sanjay's death left her even more isolated. It was at this stage that she managed to convince her other son, Rajiv Gandhi, to stand for Congress."

The book talks about trouble in Punjab, inaptitude of some Congress leaders and describes factors and conditions that led to Operation Blue Star.

Referring to India's first nuclear test in 1974, the book says Indira Gandhi led gained through its victory in December "the Chinese know that we too had the

lost a major opportunity to resolve the "was a recognised world leader" and received immense respect from Commonwealth heads of government when she hosted the Commonwealth Queen Elizabeth opening the meeting as head of the Commonwealth.

"Similarly, she earned a huge and positive reputation from her interest in the Non-Aligned Movement and from the NAM summit in Delhi, with practically all world figures attending, including Fidel Castro. She was a global leader in her own right." The book has many interesting

anecdotes of the author about the historic or tumultuous moments in the long years when Indira Gandhi was the prime minister.

The author recalls his efforts to get government nod to cover its relief efforts conditions, his courageous foray for coverage into East Pakistan that could have turned very tragic, his forced visit to London during Emergency and sending the first news feed via satellite out of India and scoring a world exclusive as polling started in 1977 elections.

Prem Prakash is a pioneer in Indian journalism and in his long career has covered some of the most important stories of post-Independence India including the 1962 war with China, 1965 and 1971 wars against Pakistan, the assassination of Indira Gandhi and Lal Bahadur Shastri's fateful Tashkent journey. The book provides a detailed account of his professional life and stories he covered from Nehru's demise to rise of Prime Minister Narendra Modi.

In Trap Case

SRINAGAR: The Anti- Corruption Bureau on Thursday filed chargesheet against a former Executive Engineer of roads and buildings (R&B) department who was aught while accepting bribe from a contractor last year.

According to an ACB spokesperson, a case was filed (FIR 08/2019) under section 5(1)(d) r/w 5(2),4-A of the Prevention of Corruption Act Samvat 2006 against Abdul Aziz Bhat, the then Executive Engineer R& B Division Bandipora. The case, he said was registered on the basis of a written complaint lodged in Police Station ACB wherein it was alleged that the complainant had executed and completed the works of R&B Division. Bandipora, but the then the officer was not releasing the payments.

"The complainant requested him several times but he did not release the payment of Rs.5,18,089 without bribe. Finally the Executive Engineer demanded a bribe of Rs 20,000 for release of the

payment of bill," the ACB spokesperson said. After registration of the case, he said, a trap team was constituted and the services of independent witness were utilized. In April 2019, he said the accused was arrested red handed while demanding and accepting an amount of Rs.20,000 money from the complainant.

"The Investigation of the case was concluded as proved against the accused public servant for launching prosecution and the chargesheet was produced in the court of law," the ACB spokesperson added.

## **Congress pusillanimity**

ours after the home minister Amit Shah attacked the Congress over its tie-up with People's Alliance for Gupkar Declaration (PAGD) and asked it to clarify its position on restoration of Article 370, the national party announced its dissociation with Gupkar grouping. Its chief spokesperson Randeep Surjewala said in a statement that the Congress was not a part of the Gupkar alliance and was contesting the district development council elections in Jammu and Kashmir to "expose" the BJP through democratic means.

Earlier, National Conference President, Dr Farooq Abdullah had said that Congress was with Peoples Alliance for Gupkar Declaration (PAGD) and will also be a part of the group in the upcoming district development council (DDC) polls. He told media that Congress state President Ghulam Ahmad Mir had personally expressed his support for the PAGD and decided to fight elections jointly.

If anything, Congress approach to its alliance with the PAGD mirrors its pussilanimous politics to politics as a whole. Over the past many years now, the party has displayed a stunning lack of conviction in its so called secular ideology. Its strategy has been shaped largely by what the country's rightwing opinion feels. For example, it was so called secular Congress which moved Afzal Guru up the queue to hang him in 2012. To add insult to the injury, Guru's family, his wife and the lone son were not informed before his execution, let alone allowed to meet Guru. The hanging and the indecorous secrecy of the deed only played into the deep cynicism and the sense of alienation in Kashmir.

India needs a robust secular narrative to confront the hardline sectarian narrative with a serious political challenge. The country needs a politics that brings into sharp relief the secular-communal binary and turns it into a fight between good and evil. But Congress so far has not been up to the task. His vision for the country is vague and insipid. It has so far failed to straddle the widened Hindu-Muslim divide. Instead, it has chosen to play second fiddle to the BJP on ideology and ply a soft Hindutva that includes making a beeline to temples during elections and avoiding Muslims. As it is, its election campaign during recent Bihar Assembly polls was bereft of any discourse about Muslims or addressing their concerns. This is why a substantial number of them shifted to the party of Asad-u-din Owaisi and led to Mahagathbandan falling just shy of victory.

Congress' politics in J&K is a reflection of its ambiguous cowardly politics at the national level. It isn't certain about any of its ideological tenet, while as the BJP is.

## **Revisiting Kashmir Reportage**

As friction accelerates between the Centre and Kashmiri leaders in the Kashmir Valley, how I wish two veteran journalists, Nikhil Chakravartty and Ajit Bhattacharjee were still around in our midst

Earlier this month, on Nikhil

Chakravartty's birth anniversary – he was born 3 November 1913- I sat reading his features on the Kashmir Valley. He could be termed as one of those journalists who wrote and spoke most fearlessly against the political misrule. His analytical essays/features focusing on the human rights violations in and around the Kashmir Valley were laced with stark facts.

s the friction accelerates between the Centre and the Kashmiri leaders in the Kashmir Valley, how I wish two veteran journalists were still around, in our midst. After all, Nikhil Chakravartty and Ajit Bhattacharjee were probably the first two Indian journalists who had not just spoken out but written extensively about the grave human rights violations and the connected aftermath which had begun to spread out in the Kashmir Valley.

Earlier this month, on Nikhil Chakravartty's birth anniversary he was born 3 November 1913- I sat reading his features on the Kashmir Valley. He could be termed as one of those journalists who wrote and spoke most fearlessly against the political misrule. His analytical essays/features focusing on the human rights violations in and around the Kashmir Valley were laced with stark facts. He was one of those veteran journalists who had regularly travelled to the Kashmir Valley and believed in delving right into the causes. In fact, his writings on the then situation in the Kashmir Valley should be preserved as they hold out some hard-hitting realities, which paved way for unrest and disasters.

With nostalgia tightening its grip, I'm reminded of my first meeting with Nikhil Chakravartty. It was around the Spring of 1987 when I first met him. I was working as a features editor with a magazine and was assigned to do a feature on 'old men '! He was residing in New Delhi's Kaka Nagar - a typical government colony but his 'D 11 type' apartment which looked 'different'. The outer gate was painted in Post Office red. I still remember that the PO red-painted gate stood out, breaking the monotony, relaying positive vibes. I was left impressed to such an extent that the very next day I went to the nearest market (Khan Market) to buy PO red paint and had all possible doors of my home painted red!

It was a long detailed interview but here it is important to quote him on the significance of travelling especially if one has to report on the human situation. "How I travel! Well, I catch the bus. No reservations about that. Also, I prefer to travel alone. For my profession traveling is a must as I want to see for myself the situations and ground realities. whether here in our country, or in Iran, Poland, or in Afghanistan... Till date I slog, do a lot of work, as I believe that if an old car is kept in the garage for too long it stops working!" Also stands out his comment on the decay that had already begun to set in and spread out in our country, "In Modern Indian society there could be less taboos and individual freedom is encouraged, but do let me add, with emphasis, that with all our modern living a great amount of insensitivity has crept in. Norms have been shattered. There is no concept of Indian-ness left, and only the RSS views are thriving in this so-called Modern India ....We have not developed culturally and that's the root cause of our decay.

And author – journalist, Ajit Bhattacharjea, held the distinction of being the first Indian journalist who started reporting from the Kashmir Valley, right since 1947, he had witnessed the help the Kashmiris had provided in resisting the invasion by the Pathan tribals, sent in by Pakistan ...Today the essential tragedy of the situation is the very contrast between the Valley of the late 1940s (when the Kashmiris were resisting the Pathan tribals sent in by Pakistan) with what's seen today. Today it's the same Kashmiris who are crying out 'Azaadi' from India."

To the 'whys' inherent in this changed situation, he had detailed. Then, there was a link between the Valley people with Sheikh Abdullah and Pandit Jawaharlal Nehru ... Mind you, that link was secularism together with socialism, since both these leaders believed in secularism and also in socialism. So the Kashmiris were with India and rejected Pakistan because for them it didn't stand for either socialism or secularism ...Also, now, over the years the Hindutva political parties here have exerted their influence over Government of India. With that several other factors came up and all this made the Kashmiris disappointed.'

He had further said, "There's a sense of alienation amongst the Kash-

wrote for years on the Kashmir situation, travelling in and around the Valley, authored books , including

the biography of Sheikh Abdullah.

I would meet Ajit Bhattacharjea regularly here in New Delhi and I'd also met him in Srinagar when we were both in the Valley. And during the course of an interview with me, he had stated – "The first time I had arrived in Srinagar was in 1947, soon after our troops landed there...and I

## A 'Meaty' Business

ammu and Kashmir (J&K) is known for its mouth-watering delicacies, and when it comes to non-vegetarian food, there is no match to the traditional dishes of the erstwhile state. The traditional Wazwan is the epitome of Kashmiri cuisines.

A lesser-known fact about the source of these authentic dishes is the place where meat comes from to J&K. A large amount of meat and livestock are supplied from Haryana to J&K. Not just J&K, Haryana sup-

plies meat and livestock to the Ladakh region as well.

The average yearly consumption of meat in J&K including Ladakh is more than 50 million kilograms. The majority of Kashmiris prefer mutton over chicken, and when it comes to mutton, the demand for lamb meat is always high in J&K. Haryana produces nearly 400 thousand metric tons of poultry meat every year. The availability of live stocks in abundance has proven to be a major booster for Haryana's supply chain of meat.

Ambala district of Haryana is one of the biggest suppliers of livestock and meat to J&K and Ladakh. The district supplies more than 60% of the total supplies to the region. Apart from Ambala, Shahbad division of Kurukshetra district of northern Haryana also supplies a huge quantity of meat to J&K and Ladakh.

Haryana caters to a good number of varieties of livestock, thus creating a diverse market of livestock in the Jammu region, Kashmir and Ladakh as well. Ankit Titoria, a meat dealer

based in Karnal district of Haryana says a large number of consignments in trucks are sent to J&K and Ladakh every week. "Every Tuesday a meat mandi is set up in Ambala, and most of the consignments are sent from there only to cold places such as Himachal Pradesh, Uttarakhand, J&K, and Ladakh," adds Titoria. "Mostly," Titoria says, "sheep meat is sent to J&K."

# **Shades and Shadows of Strife: Growing Up Trauma in Kashmir**

According to a report by Jammu Kashmir Coalition of Civil Society (JKCCS), the fifteen-year period from 2003 to 2017, witnessed not less than 318 killings of children (in the age group of 1 to 17) in various incidents of violence in the valley.

eary-eyed with blood-stained clothing, the threeyear-old child wailing on the chest of his dead grandfather on a roadside in north Kashmir lately transported 20-year-old Gowher Mubeen back to his tormenting childhood.

"I was out on a street just like that kid when I saw bodies falling in early 2000," Mubeen recalled. "The scene continues to haunt me. I could never bury those blood-drenched and bullet-ripped bodies in my head all these years."

Soon after the HMT boy was photographed in a heartbreaking scene in Sopore, commentaries on his unsound future started, with many Kashmiri netizens drawing parallels between their growing up experience in Kashmir during nightmarish nineties and with the child's life ahead.

"The naive heart of the kid will take a few years to make sense of what is a gunfight or bullet that took his grandpa's life, but what can't be undone is the death and trauma he had to endure," Mubeen continued. "Our children don't deserve these recurrent spine-chilling experiences in their own home."

Even as propaganda, whitewashing and blames tried to distort the disturbed image coming out of Sopore recently, what's inevitable, many say, is the protracted conflict regularly plunging the valley into an abyss of agony.

Just nearly two months back, locals in downtown Srinagar lost their homes in the Nawa Kadal gunfight, the same incident which caused a young seven-grader, Basim Aijaz, to lose his life.

According to a report by Jammu Kashmir Coalition of Civil Society (JKCCS), the fifteen-year period from 2003 to 2017, witnessed not less than 318 killings of children (in the age group of 1 to 17) in various incidents of violence in the valley.

In Saffron town Pampore, Labeeb Baig, 22, has spent most of his boyhood battered with instability and street hostility.

"I was just 9, when our neighbour and his father-inlaw randomly disappeared one evening and were found to be killed a week later after sustaining critical injuries," Labeeb said

And when his hometown witnessed raging protests in 2016, his parents decided to send him away to Lucknow, to pursue studies at his maternal uncle's place. "But I refused, as I was really scared to leave my family and younger sister alone amidst the dreaded atmosphere."

Unlike others, Kashmiris have grown habitual of waking up to news of their brethren's killing and tensions in their homeland. "Our families mourn deaths, our mothers become widows overnight," Labeeb, a political science graduate, continued. "There seems no end to our miseries."

As per the report, Structure of Violence, published by JKCCS in 2015, Kashmiris are living in "the most militarized zone of the world", even more than Iraq, Afghanistan and Gaza, where "there's one Indian soldier for every 10 Kashmiris"

Most Kashmiris have firsthand violent lived experiences in the valley, said Jibraan Javid, a PhD researcher at Aligarh Muslim University.

"I remember how in 1994, my father's right arm was shot by the armed forces and a decade later his leg was fired at," Jibraan, who hails from Kashmir's Bandipora, said. "It's not only a personal incident but a microcosm of the violence which is happening at a large scale, almost like a pandemic. Most of us often wonder, as why our bodies are made to bleed, or be at the discourse of violence!"

After joining Aligarh in 2018 for his doctorate degree, the Bandipora boy felt his childhood trauma returning to haunt him. "Especially after the Pulwama attack, when Kashmiris were cornered and targeted with slogans like 'dogs are allowed, Kashmiris are not', I felt like reliving the dreadful past."

Elaborating on the impact of living in a conflict zone, the scholar said, one suffers from structural and systematic violence, "for example, the internet gag", apart from physical violence.

"Since last month, I've been doing my research on 2G and not been able to attend any online lectures or webinars, or be able to download any larger books," Jibraan said.

According to Access Now, an international advocacy group, India's Internet shutdown in Kashmir is "the longest ever in a democracy". While low-speed internet has been allowed after a complete blackout in January this year, it's mostly limited or restricted. In want of high-



speed internet, the mandatory online classes have become a tall order for the lockdown-weary Kashmiri students.

"We've been facing e-curfews and digital restrictions in our homes for a while now," the scholar said. "Today even as academic structure has been shifted from the offline world to an online medium, the frequent internet bans are marring our prospects."

With the result, he said, children in Kashmir get disillusioned with their study in an insecure atmosphere, where their rights, lives and future remain uncertain. "For people like me," Jibraan said, "this sense of disillusionment comes at a later stage in life."

Dr Yasir Hamid Bhat, Assistant Professor at the Department of Psychology in the University of Kashmir, talks about his experiences and the sharp differences he has observed over the years while teaching in restricted and non-restricted areas.

"While teaching at Tata Institute of Social Sciences, Mumbai, the thing which I clearly observed was the sense of security," Prof. Bhat told Kashmir Observer.

"Students there openly share their experiences without any fear of repercussions. There's an academic calendar and routine life. But here in Kashmir, it's patchy. There's always an uncertainty amongst the students about what's going to happen tomorrow, and how they look into their future."

The socio-psychological impact is that, along with the conflict, comes insecurity, Dr Bhat continued. "Not only the physical insecurity, but of survival," he asserted.

Over the years, the professor said, the lived trauma has gone through the roof in the valley. "Unfortunately conflict is impacting different people in different ways. And it culminates into the vulnerability, susceptibility and stressful life, which is rampant and serious issue now."

Prof Bhat heavily stressed on the quality of life—which depends on the sense of security, access to opportunities, and absence of violence. "But in case of well-being, in a conflict zone, one may find a large population devoid of any stress, anxiety or other mental disorders but still we can see their well-being is deteriorated. When there's no space to express oneself, they become isolated and all the goals shunt to just survival."

A prototype of the professor's personality portrayal, Aqsa Sidiq, a Class 9 student, often finds herself locked in her room. Lack of indoor audience and restricted outdoors have silenced this otherwise chirpy girl ever since lockdown became a dominant feature of life in Kashmir.

"Our curbed life is leaving a little choice for us now," Aqsa said. "You can't go out for normal schooling and routine outing. And back home, your parents keep sulking over

the situation in Kashmir. This takes toll on your mind." For last one year now, ever since New Delhi struck down JK's special status, Aqsa and her class have been consuming distressing information in the form of communication gags, gunfights, LAC tensions, COVID spike, and other horrid events.

"We aren't coming out of this vicious circle," Jibraan, the Bandipora scholar, continued. "This turmoil seems endless, so do our miseries."

Recalling his childhood dreadful incident, Jibraan said, "My late grandma was once beaten and pushed into a drain when she chased armed forces for taking away my father. I still have all those images and happenings stuck in my mind. My father had been taken for months, and I saw him coming back home from the army camp whimpering and tortured."

Even today, he said, the street hostility is creating deep impressions on the young minds in Kashmir.

"On January 22 this year, we were on our way to SKIMS, Srinagar amid heavy snowfall to get my father treated," he said. "We were stopped a dozen of times before getting caught by a military convoy near Ajas, Bandipora. We were told to come out of the car. Everything was so traumatic. We had left home at around 7.30 am but it was past noon when they had asked us to leave. With the result, we couldn't reach to the hospital on time."

What was more insulting, he said, was when he was asked to unlock his phone pattern and hand over his handset to the forces.

"What to do in a place where you do not even have the basic rights like privacy," Jibraan said. "Each one of us in Kashmir has shuddering tales to tell."

Prof Bhat said that even after war or conflict ends, the impact of it is felt even decades after.

"Society needs to move forward and become progressive, but in conflict zones, the reverse happens. Here, we're moving backward, and seep into regressive times," he said.

"Although there's resilience and coping mechanism among the natives, but we need to understand that much of that has to do with our helplessness. We should not be self-appreciating, as this is not something one would ideally want. If given an option, we would not need to be in a constant state of strife. It takes a huge toll on the population who would want to be free and rather use their potential in better ways and focus on fulfillment of their goals and aspirations."

## Children Without Childhoods

he biggest problem in the world right now is that, while we are completely aware that our surroundings and our practices are forcing millions of children to grow up without a childhood, without education and without human rights, we are completely okay with it. Even if we cannot solve the problem, we should at least try to ensure that children who are dying because of our voluntary or involuntary silence are given the rights they are entitled to.

According to the UN, continents like Africa and Asia are notorious for their colossal contribution to the number of children in child labour, while America, Europe, and Arab States account for 5%, 4%, and 3%, respectively.

Developing and under-developed countries are seen to report higher numbers than developed countries, mainly because child labour has a deep connection with poverty, fuelled by lack of education, social backwardness, and, most importantly, the demand for cheap labour.

In many communities, children hired at cheap rates as domestic help are subjected to abuse and even rape while many, out of the 73 million children involved in hazardous activities around the world, die because of the kind of risky work they do. And that is not all; children are also forced into drug trafficking, prostitution/pornography, and other activities which

scar them for life.

However, Covid-19 has made 16 million children in the world's vulnerable countries stop their education with little hope of return. Furthermore, previously poverty-stricken families have also lost their sole breadwinner to Covid-19 or to unemployment. Thus, the jobless now rely on their underaged children to make ends meet.

But how do we end child labour? Merely stopping

equally imperative.

But most people living in rural areas tend to look into the short-term benefits that can be gained from children. Thus, boys are sent to work and girls are forced into marriages at an early age with middleaged men claiming to be richer.

Undoubtedly, that seems profitable to most of these parents, leading to girls like Nurunnahar dying at the age of 14. It is so hard to believe that, in the 21st  $\,$

## Study suggests regular dose of nature may improve mental health during COVID-19 pandemic

ature around one's home may help mitigate some of the negative mental health effects of the CO-VID-19 pandemic, suggest the findings of a new study published in the journal Ecological Applications.

An online questionnaire survey completed by 3,000 adults in Tokyo, Japan, quantified the link between five mental-health outcomes (depression, life satisfaction, subjective happiness, self-esteem and loneliness) and two measures of nature experiences (frequency of green space use and green view through windows from home).

More frequent greenspace use and the existence of green window views from the home were associated with increased levels of self-esteem, life satisfaction and subjective happiness, as well as decreased levels of depression and loneliness.

"Our results suggest that nearby nature can serve as a buffer in decreasing the adverse impacts of a very stressful event on humans," said lead author Masashi Soga, PhD, of The University of Tokyo. "Protecting natural environments in urban areas is important not only for the conservation of biodiversity but also for the protection of human health." (Agencies)

## **US Senators Seek To Stop** Trump's \$23 Billion In Arms Sales To UAE

Agencies

Washington: Three US senators said on Wednesday they would introduce legislation seeking to halt the Trump administration's effort to sell more than \$23 billion of drones and other weapons systems to the United Arab Emirates, setting up a showdown with the president just weeks before he is due to leave office.

Democratic Senators Bob Menendez and Chris Murphy and Republican Senator Rand Paul will introduce four separate resolutions of disapproval of President Donald Trump's plan to sell more than \$23 billion worth of Reaper drones, F-35 fighter aircraft and air-toair missiles and other munitions to the UAE.

The huge sale could alter the balance of power in the Middle East, and members of Congress have chafed at the administration's attempt to rush it through, having sent a formal notice to Congress only last week.

Many lawmakers also worry about whether the UAE would use the weapons in attacks that would harm civil-

ians in Yemen, whose civil war is considered one of the world's worst humanitarian disasters.

When the deal was announced, Amnesty International warned that the weapons would be used for "attacks that violate international humanitarian law and kill, as well as injure, thousands of Yemeni civilians.'

The sale includes products from privately held General Atomics, Lockheed Martin Corp F-35s and missiles made by Raytheon.

### SALES' FATE UNCERTAIN

While the resolutions bring attention to lawmakers' questions about the massive sales, and could delay them, they are unlikely to stop them.

US law covering major arms deals lets senators force votes on resolutions of disapproval. However, to go into effect the resolutions must pass the Republican-led Senate, which rarely breaks from Trump. They also must pass the Democratic-led House of Representatives and survive

In August, Kuwait's aviabanned commercial flights to Pakistan and 30 other countries were regarded as "high risk" due to the spread of the coronavirus.

The number of infections has been rising in Pakistan since late last month and authorities have declared that the country was witnessing the second wave of COVID-19. The positivity rate of the disease has increased, especially in major cities including Karachi, Lahore, Islamabad, Faisalabad and Hyderabad.

## **Pfizer Vaccine Delivery Could Start** "Before Christmas, If All Goes Well"

Washington: Pfizer Inc and BioNTech could secure emergency US and European authorization for their COVID-19 vaccine next month after

final trial results showed it had a 95% success rate and no serious side effects, the drugmakers said on Wednesday The vaccine's ef-

ficacy was found to be consistent across different ages and ethnicities - a promising sign given the disease has disproportionately hurt the elderly and certain groups including Black people.

The US Food and Drug Administration could grant emergency-use by the middle of December, BioNTech Chief Executive Ugur Sahin told Reuters TV. Conditional approval in the European Union could be secured in the second half of December, he added.

"If all goes well I could imagine that we gain approval in the second half of December and start deliveries before Christmas, but really only if all goes positively," he said.



The success rate of the vaccine developed by the US drugmaker and German partner BioNTech was far higher than what regulators had said would have been acceptable. Experts said it was a significant achievement in the race to end the pandemic.

Of the 170 volunteers

who contracted COVID-19 in Pfizer's trial involving over 43,000 people, 162 had received a placebo and not the vaccine, meaning the vaccine was 95% effective. Of the 10 people who

had severe COVID-19, one had received the vaccine. "A first in the history of

mankind: less than a year from the sequence of the vitrial of a vaccine, moreover based on a whole new technique," said Enrico Bucci, a biologist at Temple University in Philadelphia. "Today is a special day.

Tehran: The Iranian government will launch a fresh loan support program to cover 10 million families affected by its restrictions meant to curb the spread of the coroanvirus pandemic.

The Governor of the Central Bank of Iran (CBI) Abdolnasser Hemmati said on Tuesday that households will receive 10 million rials, equal to \$238 on official exchange rate, to help them cope economically with two weeks of pandemic-related closures that will begin on November 21.

Hemmati said the government will pay the 12-percent interest that will incur on the loans, saying the aid will target families that are on a payroll more than 21 million families in late April amid a first wave of the spread of the pandemic that caused businesses and government agencies to close down for nearly a month.

The announcement on new

loan support scheme came a day after the government said it would introduce sweeping anti-virus measures in more than 150 Iranian cities and towns to contain an already surging infection rate. Members of the Iranian

**NEW DELHI: Over 600 child care** collected by the NGOs has raised **institutions, run by NGOs and** concerns about possible siphoning housing 28,000 children, received up to 6 lakh per child in foreign funds in 2018-19, far more than the estimated average expenditure, the top child rights body NCPCR said as it expressed apprehensions of possible financial irregularities.

In a random analysis of information about 638 NGO-run CCIs in five states, the National Commission for Protection of Child Rights (NCPCR) found that in 2018-19 the average amount they collected was between 2.12 lakh to 6.60 lakh per child and it is now planning a country-wide exercise to examine the foreign funding and expenditure of such NGOs, according to NCPCR Chairperson Priyank Kanoongo.

In this exercise, data available on the Foreign Contribution Regulation Act (FCRA) website of the Ministry of Home Affairs (fcraonline.nic.in) for the year 2018-19 was used.

North Korea, Turkmenistan, South Sudan, Venezuela and Eritrea present the highest commercial bribery risk, while Denmark, Norway, Finland, Sweden and New Zealand

In 2019, India's rank stood 78 in the matrix. position with a score of 48 while in 2020 the country was ranked 77 with a score of 45, the data showed.

The score is based on four factors -- business interactions with government, anti-bribery deterrence said it measures the likelihood of and enforcement, government and civil service transparency, and capacity for civil society oversight, including the role of the media.

India fared better than its neighbours - Pakistan, China, Nepal and Bangladesh, Bhutan, meanwhile, secured 48th rank with a score of 37, the data showed.
