Car Plunges Into Chenab River, 2 Killed

JAMMU: A day after a vehicle rolled down into river Chenab in Ramban district, the police on Tuesday said that two persons onboard it have been killed and efforts are ongoing to retrieve their bodies from the vehicle (Mahindra Bolero).

The vehicle plunged into the fast-flowing water body last night near Mehar area along the Jammu-Srinagar highway and only one of its wheels was visible. Soon a rescue operation was launched, reported news agency GNS.

SSP Ramban Haseeb-Ul-Rahman, who is overseeing the rescue operation, said that efforts are underway to pull out the vehicle and retrieve the bodies. Both of them are said to be locals from the Ramban district.

He said intermittent snowfall and rains continued at many places on Tuesday. The famous ski-resort of Gulmarg in north Kashmir recorded seven inches of fresh snowfall during the night, while Pahalgam tourist resort in south Kashmir recorded six inches of snow, the official said. There are reports of snowfall in

other areas in the higher reaches, including the Sonamarg-Zojila axis on the Srinagar-Leh road which connects the valley with Ladakh, he said. The road was closed for traffic on Monday. The MET Office has said intermittent light to moderate rain/

Act or encroached state land for residential or commercial purposes.

The lists were made public by the divisional administration, both in Kashmir and Jammu regions, in accordance with the October 9 directive of the high court which declared the Roshni Act "illegal, unconstitutional and unsustainable" and ordered a CBI probe into the allotment of the land under this law.

Issuing the first list of 35 beneficiaries who included former finance minister Haseeb Drabu and some top hoteliers and a former bureaucrat. the divisional administration Kashmir showed that National Conference headquarters, several hotels and over a dozen commercial buildings at prime locations in and around Lal Chowk have been regularized under the act.

Majority of the beneficiaries including Drabu and his wife have one Kanal of land under residential use, while Congress leader K K Amla is the owner of Broadway hotel and prominent businessman Mushtaq Ahmad Chaya owns a guest house and a hotel.

On November 1, the Union Territory government cancelled all land transfers that took place under the JK State Land (Vesting of Ownership to the Occupants) Act, 2001 - also known as the Roshni Act - under which 2.5 lakh acres of land was to be transferred to the existing occupants.

The principal secretary and revenue department has been asked to work out a plan to retrieve large tracts of state land vested under the Act. According to the high court order, a total of 6,04,602 kanals (75,575 acres) of state land had been regularised and transferred to the occupants. This included 5,71,210 kanals (71,401 acres) in Jammu and 33,392 kanals (4174 acres) in the Kashmir province.

"Principal Secretary to government, Revenue Department shall also work out the modalities and plan to evict encroachers from such State Land and retrieve the State land within a period of six months. Principal Secretary to Government, Revenue Department shall work out modalities for handling the money received for these lands after annulment," the JK government had said in a statement.

According to the order, complete identities of influential persons, including ministers, legislators, bureaucrats, government officials, police officers and businessmen, their relatives or persons holding benami for them, who have derived benefit under the Roshni Act will be made public within a period of one month.

Mohammad Shafi Pandit and his wife own two residential houses in the prime location of the city, the document said, adding a total of over eight acres of land was vested to the beneficiaries, who also included several other relatives of Drabu.

In Jammu region, two separate lists were displayed by divisional administration Jammu on its website -- one related to Roshi Act and the other showing encroached land outside Roshni Act.

Among the beneficiaries of the encroached state land of about three and a half acres in Bahu Tehsil (Physically Encroached but not shown in Revenue Record) the list included former ministers Saiiad Kitchloo (National Conference) and Abdul Majid Wani (Congress), NC leaders Syed Akhoon, and Aslam Goni and former chairman of JK bank MY Khan.

Another list of 383 people, belonging to majority community, were shown under possession of over 483 acres of encroached land in Maria Mandrian tehsil of Jammu district, while 854 beneficiaries having possession of over 370 acres in Jammu south and 15 others in Jammu west.

Under the Roshni Act, two retired superintendents of police Shiv Kumar Singh and Mani Lal were among 10 beneficiaries in Bahu

He said while declaring the law unconstitutional, the Jammu and Kashmir High Court had said that the names of people who had acquired land under the Act be listed and made public.

"Names of various politicians of the state have appeared in that list," he said, naming former chief minister Farooq Abdullah, his sister and various Congress and NC leaders including Haseeb Drabu, Majid Wani and Sajjad Kichloo.

It is very unfortunate that key leaders of Jammu and Kashmir including Farooq Abdullah used their influence and power for "land grabbing and appropriated government land," he said.

However, Abdullah's son and former chief minister Omar Abdullah, while reacting to the list, denied that his father benefited from the Roshni Act.

on Monday afternoon on Srinagar-Jammu national highway due to slippery conditions and landslides, triggered by fresh snowfall and rain.

The historic Mughal road, connecting Shopian in south Kashmir with Rajouri and Poonch in Jammu region, remained closed for traffic for the second day due to fresh snowfall. Traffic on the road was recently restored after remaining suspended for four days due to snowfall.

"The road, seen as alternative to Srinagar-Jammu highway, remained closed due to slippery conditions because of fresh snowfall on Monday, he said. The road was being used to transport fresh fruit from Kashmir valley to different mandis, including Jammu after frequent closure of the highway this summer.

Traffic will be resumed only after weather improves and a green signal is received from traffic police civil administration officials posted at different places on the road, which remains closed for about six winter months due to heavy snowfall.

Among the victims from the Valley, officials said, included a 70-year-old woman from Uri, a 64-year-old from Shopian and a 60-yearold man from Kulgam besides three from Srinagar-a 69-year-old man from Zaina Kadal, a 60-year-old from Shuhama and a 79-year-old from Tengpora here.

The victims from Jammu division include one resident each from the winter capital of the J&K, Udhampur, Doda and Samba, they said. With these deaths, the total fatality count in the Valley has reached 1085 and 566 in the Jammu region.

They also said that the election for Mayor was uncalled for when the by-elections for the Corporation are to be held in the month of December.

The authorities on the other hand said that there was no clause in the Model Code of Conduct, issued by the Chief Electoral Officer of the Jammu and Kashmir, which bars the Municipal Corporation to hold the election for the post of Mayor during the ongoing process of by-elections of Municipal Bodies.

The counsels appearing on behalf of the officials have referred to certain events and dates preceding the present Notification, under challenge, in order to bring home their contention that the election of Mayor cannot be delayed.

"The Court need not go into those events as the same are not germane for disposal of the present application," they said, adding, "The Court should not ordinarily come in the way of holding the election of the institutions like Local Bodies." –Agencies

5 Drug 'Smugglers' Held In Jammu

Jammu: Five narcotic smugglers were arrested after 60 kgs of drugs were recovered from their possession in Jammu district, officials said on Tuesday.

A police party intercepted a truck and on the search of the vehicle, 51 kgs of poppy and Rs 30,000 was recovered on Monday, they said.

Police arrested suspected drug smuggler Gurmeet Singh and seized his vehicle. In another case, a police party intercepted a Punjab-bound truck at Jhajjar Kotli on the highway and during search of the vehicle, recovered 9 kgs of poppy at Suketar naka, they said. They apprehended two people identified as Tara Singh and Mewa Singh. A police party also intercepted a two-wheeler at Old Akhnoor bridge and apprehended two people identified as Ankush Verma and Dilawar Singh and recovered 80 gms of cannabis on Monday night, they said. A case has been registered.

Cardiac Arrest Kills Soldier In Kupwara

SRINAGAR: An army man died of cardiac arrest on Tuesday in north Kashmir's Kupwara district. Sukhmangat Singh of army's 7RR suffered a massive cardiac arrest on Tuesday morning at his camp in the frontier district, officials said. He was immediately rushed to a nearby hospital where doctors declared him dead on arrival. (KDC)

Employee Suspended For MCC Violation

DODA: A government employee on Tuesday was suspended in Doda district of Jammu and Kashmir for violating Model Code of Conduct (MCC) in place for the forthcoming District Development Council (DDC) polls.

A Rehbar-e- Janglat employee of forest Division Doda was suspended by Nodal Officer Model Code of Conduct, Surat Singh (ADDC) after finding him involved in MCC violation, an official spokesperson said.

He said that the Programme Officer ICDS Doda has been directed to conduct a detailed inquiry into the matter and submit report within a week's time. "During the period of suspension he shall remain attached in the office of Tehsildar Doda," the official spokesperson said.

Meanwhile, the District Panchayat Election Officer Doda has warned the Government employees not to indulge in MCC violation and act as responsible government machinery for smooth conduct of DDC Elections and bye Elections of Sarpanchs/ panches and ULBs, he added.

3 Houses Gutted In Bandipora Fire

SRINAGAR: Three residential houses were damaged in a fire incident in north Kashmir district of Bandipora, official sources said here on Tuesday.

A fire broke out in a residential house in main town in Bandipora late on Monday evening. "Fire tenders were rushed to douse off the leaping flames, clearly visible from a distance," they said. Before the fire was brought under control, it spread to nearby houses. Three residential houses were damaged in the mishap," the sources said, adding no one was injured in the incident. Cause of the fire was not immediately known. A case has been registered and an investigation has been taken up to ascertain the cause of the mishap.

Polythene Ban HC Seeks Personal Appearance Of Top Officials On Dec 1

SRINAGAR: Jammu and Kashmir High Court has sought personal appearance via video conferencing of top officials of various departments for failure to submit action taken report regarding prohibition on polythene in ecologically fragile J&K.

As many as 419 people, mostly farmers belonging to majority community, have been vested powers of 405 acres of agriculture land under Roshni act in Khour tehsil and 97 others in Nazool tehsil over over four acres of land, the list highlighted.

The Jammu and Kashmir state lands (vesting of ownership to the occupants) act was enacted in the year 2001 with the twin objective of generating resources for financing power projects and conferment of proprietary rights to the occupants of the state land.

The act popularly called as Roshni scheme initially envisaged conferment of proprietary rights of around 20.55 lakh Kanals (102750 hectares) to the occupants of which only 15.85 per cent land was approved for vesting of ownership rights.

The scheme was finally repealed by the then governor Satya Pal Malik on November 28, 2018.

Amid reports about its widespread misuse. the entire legislation was challenged before the JK high court, in a public interest litigation, wherein the court besides staying the proceedings under the said act also directed that neither the occupants having been conferred upon the ownership rights shall sell these lands nor can raise constructions on such lands.

In 2014, however, the Comptroller and Auditor General had estimated that only Rs 76 crore had been raised from the transfer of encroached land between 2007 and 2013. - PTI

He said that names of several top politicians, including NC leader Farooq Abdullah and former state ministers from the Congress and the NC have come to the fore for allegedly benefiting from the Roshni Act, which has since been struck down by the Jammu and Kashmir High Court.

The Jammu and Kashmir State Land (Vesting of Ownership to the Occupants) Act, 2001 is also known as the Roshni Act.

"There was a conscious loot by powerful people of forest land and getting benefits under the Roshni Act, which has been declared unconstitutional by the high court," Prasad told reporters.

The Union minister said it is the lowest ebb in a democratic polity. "We condemn it outright," he added.

Demanding a thorough probe, Prasad said the land should be taken back from the beneficiaries as directed by the high court.





Ansari Motors attached for 'ST default'

RINAGAR: The sales tax department today attacked M/s Ansari Motors, Sonawar, for alleged default' in the payment of sales tax. The concern is owned by the former minister, Maulvi Iftikhar Husaain Ansari, his brother, Abid Hussain Ansari, and another family member.


Quoting the deputy commissioner, sales tax (recovery), Kash-mir division, an official handout said the attachment was carried out for default in the payment of sales tax of Rs 1.11 crore ending March 1994. In respect of the assess¬ment for 1994-95, 1995-96 and 1996-97. It said, action was being taken separately in light of the directions of the Supreme Court. According to the handout, the sales tax department asked other defaulters to clear their outstandings Immediately and save themselves from embarrass¬ment. The department appreciated the support extended by general public in its drive against the defaulters adding it would be taken to its logical end.

Meanwhile, according to a CNS report, the owners of the company later broke open the locks put by the sales tax department officials and resumed their normal work. The department had sealed the office, showroom and workshop of 'Highland Motors' this morning and locked all the doors. Sources in the department alleged the former company, M/s Ansari Motors, owed a sales tax of Rs 1.11.56,000 to the government. Reacting to the action, a partner of the company, Abid An-sari, told Observer News Service, the government had com-mitted contempt of court by attach-ing the properties of 'Highland Automobiles' allegedly in violation of the supreme court directives. He said the apex court had quashed all the ex-parte assessments and or-dered reassessment pending which the company had been asked to pay Rs 50 lakh. Ansari said he had paid over Rs 33 lakh in about six quarter-ly installments of Rs 5,60,594 each on self-assessment under the amnesty scheme announced by the government. His persistent request to the authorities to imple-ment the Supreme Court orders for fresh assess¬ment also did not bear fruit, he said, adding they attached our properties with the help of two companies of CRPF and without any prior notice. Ansari said he would launch contempt proceedings against the authorities.

When contacted, the deputy commissioner, sales tax (recovery) Mushtaq Ahmad, told Observer News Service late this evening Ansari Motors had run into arrears of sales tax for the period from 1988 89 to 1993-94 to the extent of Rs 1.41 crore on the basis of assessment in which the company had cooperated. After tallying the adjustment of Rs 29 Lakh, the arrears were reduced to Ra 1,11,56,000. The deputy commissioner said the first notice (dastak) was served to the company on October 16 this year, followed by reminders Oc¬tober 31 and November 6. As they did not show any positive response, the department attached the properties during an operation carried out between noon and 2 pm today. He said Abid Ansari, who was present in the premises, identified the portions belonging to Ansari Motors on the basis of the documents with which he was confronted. He de nied this period of sales tax assessment was the subject of any court proceedings. Mushtag said the department had assessed an other Rs 13 crore as sales tax arrears for the period 1994-95 to 1996-97. However, the amount was based on an ex-parte assessment against which the company had approached the Supreme Court. In March this year, he said, the apex court had directed de-novo (afresh) assessment and restoration of its CST/GST registration. It also asked the firm to deposit Rs 50 lakh in two installments

Expressing his ignorance about the reported breaking open of loop by the firm to resume its normal work, Mush-tag said, he would ascertain the facts tomorrow. However, he asserted no contempt was made out in the matter.

Lingering stand-off

I ilitary-level talks between India and China to resolve their current standoff along the Line of Actual Control in Ladakh have been deadlocked, for now. There are no fresh dates for the talks even though the two sides are busy preparing for a fresh round of talks. The last round of talks, the eighth since June 6, was held on November 7. Following this round there were reports of three-step disengagement plan proposed by China; this would oblige the two sides to withdraw tanks and artillery to depth areas followed by withdrawal of troops of both sides. Subsequently they are supposed to hold talks for Indian troops to withdraw from the Kailash Range and heights around Chushul that were occupied in August.

But there has been no progress on the plan since. There has also been criticism of the plan in India as its implementation is thought to require India to move back from what it claims as its own territory. The plan has thus found no favourable response from New Delhi.

Meanwhile, there are reports that China is reinforcing its positions in Ladakh. It is building border infrastructure, and laying fibre cables. It is also bringing additional troops to man the friction points. Reports also say that Beijing is establishing additional military infrastructure all along the LAC opposite Uttrakhand, Himachal Pradesh, Sikkim and Arunachal Pradesh.

Other reports have said China is upgrading and installing radars along the entire stretch of the LAC from Ladakh to Sikkim region. If anything, it shows that China has no intention of withdrawing unless on its terms. It also doesn't want to give up the over 1000 square kilometres of land it has occupied.

India wants China to go back to status quo ante as it existed in April but Beijing is in no mood to do so. On the contrary, the People's Liberation Army has enhanced its military profile on the border by deploying thousands of its soldiers and equipment. In recent years China has reportedly more than doubled its total number of air bases, air defence positions and heliports near the Indian border. This has now become a high stakes war of nerves between the two countries.

A pragmatic way out to resolve the lingering stand-off is through negotiations, even if it takes time. With winter already having set in it will be in the interest of both the countries to reach an understanding that also holds on the ground. Gupkar Alliance's Rise and Capitulation

A Characteristic of Kashmir's Political History

n October 13, 2020, Mehbooba Mufti, the last chief minister of Jammu and Kashmir, was released from detention after 14 months. A few days later, mainstream Kashmiri politicians came together to form the People's Alliance for Gupkar Declaration (PAGD). This declaration was signed a day before the abrogation of Article 370 last August. It stated that "any modification, abrogation of Articles 370, unconstitutional delimitation or trifurcation of the State would be an aggression against the people of Jammu, Kashmir and Ladakh." In its first press conference, PAGD accused BJP of breaking the federal structure of India by abrogating the limited autonomy of Jammu and Kashmir and subsequently downgrading it to a union territory.

On October 17, barely a week after Gupkar Alliance was established by the mainstream politicians of Kashmir, the Indian government amended the Jammu and Kashmir Panchayati Raj Act, 1989. It has paved the way for establishing District Development Councils (DDC). With no signs of assembly polls being conducted any time soon, New Delhi introduced this new governance unit in the region. The members of DDC are supposed to be elected by the voters of the new union territory. Many had speculated that the alliance leaders would boycott these elections like the Panchayat polls which were held earlier this year. DDCs were established a year after the abrogation of Article 370, under the new bureaucratic power structure. Participating in these elections would mean accepting the constitutional changes made on August 5 last year. Therefore, many people were shocked when the alliance declared that they would be contesting the DDC elections. They claimed that they were fighting these elections to bar the "free run" of the Bhartiya Janata Partv. Recently, Home Minister Amit Shah sent a series of tweets against the alliance. He accused the "Gupkar Gang" of colluding with the foreign forces and insulting the tricolor. It was said that Gupkar Alliance had check matted the BJP by deciding to participate in the elections. However, in the larger perspective, this interpretation seems faulty keeping in mind the political history of Kashmir post 1947. Kashmir's politics is often described as complex and unpredictable. This description is used by every other politician to justify their actions and it often contradicts their own stand. In all fairness, a conflict zone like Kashmir offers little room for people to oppose the narrative of those in power. However, as the stakeholders of this dispute, we can objectively understand these political happenings through the prism of history. It may never repeat itself in totality but the post-partition history does offer some insights into what has been happening in Kashmir since the last couple of years.

A few days into the "security" lockdown imposed on August 5 last year, a video from inside a passenger flight went viral. In the video, a Kashmiri woman was seen narrating the ordeal of Kashmiris to Rahul Gandhi. Later in the video, Gandhi held her hand while she described the misery of Kashmiris under a strict lockdown and communication blockade. Many were impressed by what they saw as the compassionate side of Rahul Gandhi.

However, in October 2019, former Prime Minister of India Dr Manmohan Singh had said that Congress was not against the abrogation but only criticized its implementation. In fact, the dilution of Kashmir's autonomy started long ago under the Congress rule. The dismissal of Sheikh Abdullah, followed by his arrest in October 1953, was not just because of mistrust between him and Prime Minister Jawaharlal Nehru. Sheikh Abdullah's government was dismissed without allowing him to prove his majority. The then Sadr-i-Riyasat (Constitutional Head of State) Dr Karan Singh cited that Abdullah had lost the confidence of his cabinet.



Sheikh Accord of 1975 officially ended the movement for self-determination and plebiscite. Sheikh Abdullah's political career was based on promises of self-determination, which he effectively dropped after signing this accord. Sumantra Bose, in her book Kashmir: Roots of Conflict, Paths of Peace, notes that the first clause of the accord, which declared that J&K as the constituent unit of the Union of India will be governed under Article 370, was hypocritical. Twenty-three constitutional orders had already been made by the mid-1970s, and 262 union laws had already been implemented in the state. Sheikh Abdullah became the chief minister after signing this accord and continued as such until his death in 1982.

A recurrent theme in the political history of Jammu & Kashmir is the disempowerment of the state by coercing the local politicians. However, the so-called mainstream politicians of Kashmir have always obliged, settling for the leftovers. PAGD's sudden enthusiasm to keep BJP away from Kashmir through DDC polls is ludicrous. By willfully or ignorantly participating in these elections, they are only helping the "normalcy" narrative in Kashmir.

Projecting "normalcy" in Kashmir through elections is the oldest trick in the book. For all the logical reasons, PAGD's move will not disrupt the plans of BJP. Home minister Amit Shah's tirade against the alliance is more of a pre-election attack and a control mechanism deployed against the local politicians. The brinksmanship will only push the Kashmiri politicians to prove their legitimacy through these elections. People's Alliance fighting the elections suits the optics of the Indian government. Even if they win all the seats in Kashmir, they'll have nominal power. BJP will still be calling the shots through the Lieutenant Governor and the subordinate bureaucracy. They will also declare that the democratic process has "restarted" in Jammu & Kashmir. Speaking at a press conference in Srinagar recently, BJP spokesperson Shahnawaz Hussain claimed that "Gupkar Gang" had accepted the decisions taken on August 5 because they are taking part in DDC elections. This jubilance among the BJP cadre is quite obvious given that Kashmiri politicians are aiding their attempts at normalizing the August 5 changes There is a little element of newness when it comes to the current government's Kashmir policy. What has changed, however, is that the policy of disempowerment has reached its climax, and speaking for Kashmiris or their rights will cut your vote share in India. Congress distancing itself from Gupkar Alliance immediately after Amit Shah's tweets indicates just that. One must not see BJP's political maneuvering in Kashmir in isolation but a culmination of Indian government's policy towards the former princely state.

Get ready for Oxford Vaccine

In a world ravaged by the virus, hope, unsurprisingly, comes in the shape of a vial. The news that India is likely to receive the first contingent of Covid-19 vaccine developed by Oxford-AstraZeneca in the first few months of the new year is certainly encouraging. This development has come among other welcome bulletins: the drugs developed by two other pharmaceutical firms, Pfizer and Moderna, have demonstrated an acceptable degree of efficacy against the coronavirus; the phase three trials of Covaxin, an indigenous drug, is also expected to begin soon.

But optimism cannot lead to complacency. The challenges that confront a country like India - burdened with a high, impoverished population and a rickety healthcare network - remain steep with respect to the Covid-19 vaccination programme. There are several areas of concern that the Centre must focus on with immediate effect. The first would be the choice of the vaccine, given the possibility that not every medication is expected to provide the same kind of immunity. The selection of the vaccine must adhere to standards of effectiveness that have been substantiated by scientific trials. It makes sense for India to opt for multiple sources while taking care to weed out spurious medication. The second interconnected - challenge concerns the pricing of the vaccines. India's wobbly economy — it has been dealt debilitating blows by the pandemic as well as by its ruling dispensation — dents New Delhi's purchasing powers considerably, and it is likely that India would have to depend on collaborations with its international partners to make vaccines accessible and affordable for its large population. The G20's recent pledge to make Covid-19 medication and testing universal and uniform must be followed up with firm, affirmative action. The other, equally formidable, obstacle relates to the scale of immunization in India. The Centre may stagger the distribution of the available vaccines with priority sectors - frontline workers and vulnerable citizens - receiving the early doses. But the cleavages in India's social fabric and the limited reach of healthcare are likely to lead to substantial exclusions. The government must be mindful of ensuring that the vaccines eventually reach the most marginalized segments of society. These must include socially disadvantaged groups as well as minorities. India's experiences of indigenous vaccination programmes for polio and tuberculosis could be beneficial in addressing possible gaps in this context. Finally, India must undertake the modernization of its drug storage and supply chain. Covid-19 is unlikely to be the last of the pandemics India and the world would see.

Remarkable Vaccines and Raising Debts

COver the past few months, world governments have drastically increased their borrowing to cover the costs of the pandemic. It might appear logical that the cost of credit will go up during uncertain economic times. The reality, however, is that capital often goes to safer sovereign debt during economic downturns, particularly as the equity markets become unstable and volatile.

ovid continues to ravage societies around the world, and a key issue is how governments can afford to fight it. As economies are disrupted, governments are stepping in to increase their spending to bail out companies, pay the cost of health measures, and subsidize workers' wages.

Before Covid, when people argued that the state should be able to offer free health care and free education, among other services, and welfare measures, a standard political response was that state resources were limited. Asked by a nurse in 2017 why her wages hadn't increased from 2009 levels, then British prime minister. Theresa May, said: "There is no magic money tree that we can shake that suddenly provides for everything that people want."

Except, a few years later, the government has not only been able to pay the wages of millions, it has also created rescue packages for thousands of firms and offered people vouchers to eat out in restaurants. A number of European countries have also taken the unprecedented step of underwriting the wages of millions of workers in response to the pandemic.

How is the British state and others capable of this radical increase in spending at a time when revenues from taxes are collapsing?

'Magic money tree'

The answer to this lies in the debt market. Over the past few months, world governments have drastically increased their borrowing to cover the costs of the pandemic. It might appear logical that the cost of credit will go up during uncertain economic times. The reality, however, is that capital often goes to safer sovereign debt during economic downturns, particularly as the equity markets become unstable and volatile.

Over recent months, rather than struggling to find lenders or having to pay more for debt, the governments of the major economies have been awash with credit at historically low rates. In October, the EU, until now a small player in the debt market (as borrowing mostly is by national governments of member states), began a major borrowing campaign as part of the efforts to fight Covid through the SURE programme (Support to mitigate Unemployment Risks in an Emergency) which was created in May.

The first sale of bonds worth 17 billion was met with what some described as "outrageous demand", with investors bidding a total of 233 billion to buy them. This intense competition was for bonds that offered a return of -0.26% over ten years, meaning that an investor who holds the bond to maturity will receive less than they paid today.



buying huge quantities of these bonds once they are circulated in the market.

Poorer countries

Not everybody, however, enjoys a similar position in the debt market. While the rich economies are being chased by investors to take their money, the situation is radically different for poorer countries. Many poor countries have limited access to the credit market and rely instead on public lenders, such as the World Bank.

In recent years, this pattern began to change with a growing number of developing countries increasing their foreign borrowing from private lenders. Developing countries, however, are in a structurally weaker position than richer peers. The smaller scale of their capital markets means that they are more reliant on external financing. This reliance means that developing countries rely on raising money in foreign currency, which increases the risk to their economies.

As many developing countries have less diversified exports with a higher percentage of commodities, the price decline in commodities in recent months has increased those risks. As a result, developing countries face a significantly higher cost of borrowing compared to the richer economies.

A few large developing countries, such as Indonesia, Colombia, India, and the Philippines have begun to follow the policy adopted by the advanced economies of buying government bonds to fund an expanding deficit. The risks of doing this, however, are higher than the richer economies, including a decline in capital inflows. A report by the rating agency S&P Global Ratings illustrated the differences between those two economies: "Advanced countries typically have deep domestic capital markets, strong public institutions (including independent central banks). low and stable inflation, and transparency and predictability in economic policies. These attributes allow their central banks to maintain large government bond holdings without losing investor confidence, creating fear of higher inflation, or triggering capital outflow.

ible public institutions and less monetary, exchange rate and fiscal flexibility have less capacity to monetize fiscal deficits without running the risk of higher inflation. This may trigger large capital outflows, devaluing the currency and prompting domestic interest rates to rise, as seen in Argentina over parts of the past decade."

While the reaction of the market to this approach by developing countries has been muted so far, the report argued, this situation might change. Developing countries who do this could "weaken monetary flexibility and economic stability, which could increase the likelihood of sovereign rating downgrades."

Ratings downgrades

Over recent months, downgrading by rating agencies have been a major risk facing developing countries with many economies facing higher costs of borrowing as a result of such downgrades. These downgrades were often linked to decline in prices and exports of commodities, as was the case for diamonds for Botswana and oil for Nigeria.

In July, following the participation of Ethiopia, Pakistan, Cameroon, Senegal, and the Ivory Coast in a World Bank-endorsed G20 debt suspension initiative, the rating agency Moody's took action against those countries, arguing that participation in this scheme increased the risk for investors in bonds issued by these countries, leading to some developing economies avoiding the initiative in order not to send a "negative signal to the market." Zambia is on the verge of being the first "Covid default" and other developing countries could face a similar situation in coming months. Access to credit has become a defining factor in the ability of governments to respond to the pandemic. As a result of access to cheap credit, developed economies are so far able to take such health measures while limiting the social and economic impact of the pandemic. Many developing countries do not have this luxury. Not everyone gets to shake the branches of the magical money tree.

The EU is not the only borrower that is ef fectively being paid to borrow money. Many of the advanced economies have been in recent years and months selling debt at negative rates. For some countries, the shift has been dramatic. Even countries such as Spain, Italy and Greece that were previously seen as relatively risky borrowers, with Greece going through a major debt crisis, are now enjoying borrowing money at very low rates.

The reason for this phenomenon is that while these bonds are initially bought by "traditional" market actors, central banks are

Oxford Astrazeneca, The Game Changer

n the long dark tunnel that has been 2020, November stands out as the month that light appeared. Some might see it as a bright light, others as a faint light - but it is unmistakably a light.

On November 9, Pfizer announced the interim results of its candidate vaccine, showing it to be "more than 90% effective" in preventing symptomatic COVID-19 in late-stage human trials. The news was greeted with joy.

A couple of days later, the Russian Direct Investment Fund announced that the candidate vaccine they are funding dubbed Sputnik V - showed 92% efficacy in late-stage trials. Not to be outdone, Moderna then announced that its candidate vaccine showed 94.5% efficacy.

The latest COVID-19 vaccine announcement comes from Oxford University. And, as with all of the above announcements, it came via press release. Its vaccine candidate, developed in partnership with AstraZeneca, showed an overall effectiveness of 70.4%

In case that sounds disappointing, bear in mind that these are interim results and the figures might change. Also, the Oxford vaccine was given to one group of volunteers as two standard doses, which showed 62% effectiveness, and another group of

volunteers as a smaller dose followed by a standard second dose. This raised effectiveness to 90%

It's not immediately clear why this is the case. Professor Andrew Pollard, one of the lead researchers on the project, described the results as "intriguing". He also highlighted that the use of lower doses means that there would be more vaccine doses available

There were no cases of severe CO-VID-19 in those who received the vaccine. And it seems to generate a protective immune response in older people. Although we'll have to wait for the final breakdown of results to get clarification on that.

Not the only measure

Despite the Oxford vaccine having

lower overall effectiveness than the Pfizer or Moderna vaccines - at least at this interim stage – there are other success factors to consider. Safety is one, and the Oxford vaccine is so far reported to have a good safety record with no serious side-effects.

Another crucial factor is storage. The Oxford vaccine can be stored in a domestic fridge. The need for sustained freezing across the whole vaccine journey from factory to clinic at ultra-low temperatures as seen with the Pfizer vaccine - may be a problem for many countries, but especially poorer countries

The Oxford vaccine, based on a viral vector, is also cheaper (around US\$4) than Pfizer and Moderna's mRNA vaccines around US\$20 and \$33, respectively. Astra-Zeneca has made a "no profit pledge".

Equitable distribution

As I have previously discussed, equitable distribution of new vaccines is vital, especially for low- and middle-income countries which don't have the profile or purchasing power of wealthier countries. GAVI-a global health partnership that aims to increase access to immunisation in poor countries - has worked for years to address this very point. It set up the COVAX initiative in 2020, which has access to 700 million doses of COVID vaccine if clinical trials are successful.

Oxford and AstraZeneca have previously made their own commitments to provide a billion doses of their vaccine for

low- and middle-income countries, with a commitment to provide 400 million doses before the end of 2020. Certainly, AstraZeneca has committed to provide more doses to countries outside of Europe and the US than any of its nearest competitors.

An excellent start

These commitments will clearly not be enough for immediate global coverage, but it is an excellent start. Around 9% of the world's population live in extreme poverty, and the health systems around them are fragile. With promises for equitable vaccine distribution, there is hope that the poorer populations around the world will not be forgotten. The global health community must keep its focus on this area.

What does this announcement mean for the world? Potentially a huge amount. But remember that the trials are not yet complete and, at the time of writing, the regulators have yet to approve any of the new vaccine candidates. Even when those hurdles are cleared, we still need to vaccinate the world, which requires successfully navigating the complex obstacles of distance, terrain, politics, cold-chain logistics and human behaviour.

The global pandemic is not over and won't be for a long time yet - but the light is getting brighter.

The second group was told if they punished the wrongdoer he or she would be told it was for ripping up the drawing, what researchers called the "communicative" condition.

About one-quarter of children (26 percent) in the first group decided to punish the transgressor even after being told they would lose use of their own iPad. "Retribution is a driving force in young

children's moral judgment," said Marshall. However, children in the second group, who knew that the wrongdoer would be told why he or she was being disciplined, were 24 percent more likely to punish

than the first group. "The opportunity to teach a wrongdoer a lesson motivates children to punish over and above the desire to see them suffer for their actions," Crockett said.

"Children seem equipped at an early age with both a desire for punishers to receive their just deserts, and a desire to have them improve their behavior for next time," said Marshall, who is now a postdoctoral researcher at Boston College

Crockett added: "Despite having a taste for retribution, young children also value the social benefits that punishment can bring. How social learning impacts the balance of retributive and forward-looking motives for punishment is an important avenue for future study." - Agencies

Heterogeneous thinkers may possess quick decision-making: Study

recent mathematical indagation has come up with a new perspective claiming that a group of people with different information may possess better decision-making process than a group of people with homogeneous thoughts. Communication, also known as a process of exchanging infor-mation is very crucial for living. Florida State University has come up with recent research on the same.

Bhargav Karamched, assistant professor of mathematics, and a team of researchers published a new study explaining the decision-making process of groups and the dynamics that make for fast and accurate decision making. He found that networks consisting of both impulsive and deliberate individuals made, on average, quicker and better decisions than a group with homogenous thinkers.

In groups with impulsive and deliberate individuals, the first decision is made guickly by an impulsive individual who needs little evidence to make a choice," Karamched said. "But, even when wrong, this fast decision can reveal the correct options to everyone else. This is not the case in homogenous groups.

According to a research paper of



crucial in a variety of biological and social functions. But Karamched contradicted the same and explained, "Although, information sharing in networks has been studied quite a bit, very little work has been done on how individuals in a network should integrate information from their peers with their own private evidence accumulation.

Most of the studies, both theoretical and experimental, have focused on how isolated individuals optimally gather evidence to make a choice.'

"This work was motivated by that," Physical Review Letters, researchers not- Karamched said. "How should individued that the exchange of information is als optimally accumulate evidence they

see for themselves with evidence they obtain from their peers to make the best possible decisions?

Kresimir Josi, Moores Professor of Mathematics, Biology and Biochemistry at the University of Houston and senior author of the study, noted that the process works best when individuals in a group make the most of their varied backgrounds to collect the necessary materials and knowledge to make a final decision."

Collective social decision making is valuable if all individuals have access to different types of information." Josi said. According to Karamched, a mathematical model was not enough to reach his conclusion and plenty of room is required for follow-up research.

Karamched said that his model assumes that evidence accrued by one individual is independent of evidence collected by another member of the group. If a group of individuals is trying to make a decision based on information that is available to everyone, additional modelling would need to account for how correlations in the information affect collective decision-making.'

For example, to choose between voting Republican or Democrat in an election, the information available to everyone is common and not specifically made for one individual." – Agencies

'Maintaining healthy sleep pattern helps lower risk of heart failure'

hile maintaining a good sleeping pattern helps in concentration in tasks, a recent study has pointed out on the additional benefit of a good sleep pattern. It suggests that the adults with the healthiest sleep patterns had a 42 per cent lower risk of heart failure regardless of other risk factors compared to adults with unhealthy sleep patterns.

The research was published today in the American Heart Association's flagship journal Circulation. Healthy sleep patterns are rising in the morning, sleeping 7-8 hours a day and having no frequent insomnia, snoring or excessive daytime sleepiness.

Heart failure affects more than 26 million people, and emerging evidence indicates sleep problems may play a role in the development of heart failure.

This observational study examined the relationship between healthy sleep patterns and heart failure and included data on 408,802 UK Biobank participants, ages 37 to 73 at the time of recruitment (2006-2010). The incidence of heart failure was collected

until April 1, 2019. Researchers recorded 8 hours a day; and prolonged, or 9 hours or 5,221 cases of heart failure during a median more a day. follow-up of 10 years. Researchers analyzed sleep quality as

well as overall sleep patterns. The measures of sleep quality included sleep duration, insomnia and snoring and other sleep-related features, such as whether the participant was an early bird or night owl and if they had any daytime sleepiness (likely to unintentionally doze off or fall asleep during the davtime).

'The healthy sleep score we created was based on the scoring of these five sleep behaviours," said Lu Qi, M.D., PhD, corresponding author and professor of epidemiology and director of the Obesity Research Center at Tulane University in New Orleans. "Our findings highlight the importance of improving overall sleep patterns to help prevent heart failure."

Sleep behaviours were collected through touchscreen questionnaires. Sleep duration was defined into three groups: short, or less than 7 hours a day; recommended, or 7 to

After adjusting for diabetes, hypertension, medication use, genetic variations and other covariates, participants with the healthiest sleep pattern had a 42% reduction in the risk of heart failure compared to people with an unhealthy sleep pattern.

They also found the risk of heart failure was independently associated and:

-8% lower in early risers;-12% lower in those who slept 7 to 8 hours daily;-17% lower in those who did not have frequent insomnia; and-34% lower in those reporting no daytime sleepiness.

Participant sleep behaviours were selfreported, and the information on changes in sleep behaviours during follow-up was not available. The researchers noted other unmeasured or unknown adjustments may have also influenced the findings.

Qi also noted that the study's strengths + include its novelty, prospective study design and large sample size. –Agencies

Study Says More Than Half Of 20-Year-Olds In India's Metros Likely To Develop Diabetes In Lifetime

More than half of men, and nearly two thirds of women currently aged 20 years in India could develop diabetes in their life time, with most of those cases likely to be type 2 diabetes, according to a new study.

The research, published in the journal Diabetologia, estimated the probability of a metropolitan Indian of any age or body mass index (BMI) developing diabetes in their lifetime.

According to the scientists, including those from the Centre for Chronic Disease Control (CCDC) in New Delhi, the country already has a significant health burden caused by diabetes with more than 77 million adults currently afflicted by the condition, and the number expected to almost double to 134 million by 2045.

As urban centres continue to grow rapidly across India, they said decreasing diet quality, and decreased levels of physical activity are all contributing to this hidden epidemic.

In the study, the researchers assessed age-, sex- and BMI-specific incidence rates of diabetes in urban India based on data from the Centre for Cardiometabolic Risk Reduction in South Asia (2010-2018).

They also analysed the age-, sexand urban-specific rates of mortality from period lifetables reported by the Government of India (2014), and the prevalence of diabetes reported by the Indian Council for Medical Research INdia DIABetes study (2008-2015).

Based on the analysis, the scientists said the lifetime risk of developing diabetes in 20-year-old men and women free of diabetes today is 56 and 65 per cent, respectively. Women generally had a higher lifetime risk across the lifespan, the study noted.

According to the researchers, for those currently aged 60 years and currently free high probability of developing diabetes of diabetes, around 38 per cent of women and 28 per cent of men would go on to develop diabetes.

They cautioned that obesity had a



obese metropolitan Indians -- 86 per cent among 20-year-old women, and 87 per cent among men.

People with lower BMI had considerably higher diabetes-free life expectancy and obese 20-vear-olds were estimated to have around half of their remaining life years free from diabetes.

However, those with normal or underweight BMI were projected to live out most of their remaining years diabetesfree, the scientists said.

"The remarkably high lifetime risk of developing diabetes and the low diabetes-free life expectancy in India's metropolitan cities, especially for individuals with high BMI, implies that interventions targeting the incidence of diabetes may be of paramount importance moving forward," the researchers noted in the study. They noted that metropolitan Indians

Israel drops Saudi Arabia from virus quarantine list, day after Netanyahu's reported visit

Jerusalem: A day after Prime Minister Benjamin Netanyahu's reported trip to Saudi Arabia, Israel's health ministry added the kingdom to its list of coronavirus "green" countries, exempting returning travellers from quarantine.

The health ministry on Tuesday confirmed that Saudi Arabia had been added to the safe list a day earlier, but dismissed any link to Netanyahu's reported visit to the futuristic Red Sea city of Neom on Sunday.

"The process is very simple and it happens once every two weeks," health ministry director general Hezi Levi told public broadcaster Kan on Tuesday morning.

"On the previous list, Saudi Arabia was red," he said. "The morbidity rates decreased. It's now green. "It has nothing to do with anyone's visit to any country to agency staff and briefing

Israeli media reported that Netanyahu travelled to Neom for landmark talks with Crown Prince Mohammed bin Salman. the de facto ruler of Saudi Arabia, which has no official diplomatic ties with the Jewish state.

There has been unconfirmed speculation that Saudi Arabia might be seeking to become the latest Arab state to normalise ties with Israel.

An Israeli government source contacted by AFP confirmed the talks, which Riyadh firmly denied on Monday, and the kingdom has publicly said it will not establish diplomatic relations with Israel until the Palestinian conflict is resolved.

Had Saudi Arabia not been on Israel's coronavirus green list, Netanyahu and his staff would technically been compelled to quarantine for 14 days upon return.

Another country turned 'green" in the ministry's latest listing was Bahrain, which along with its Gulf ally the United Arab Emirates have established ties with Israel, only the third and fourth Arab nations to do so.

On Tuesday, Netanyahu announced he had spoken with Bahraini Crown Prince Salman bin Hamad Al Khalifa and accepted an invitation to conduct "an official visit to Bahrain soon".

Tents are helping many restaurants get through lean times.

But they may cost extra. In Detroit, Lumen restaurant charges \$30 per person to reserve a heated structure with windows for two hours. Lumen's igloos and greenhouses can each seat six people, and the party must spend at least \$300.

Once a party leaves, the structure is cleaned, sprayed with sanitizing fog and aired out for 30 minutes, savs Gabby Milton, the restaurant's managing partner. — AP

wo of Charles Darwin's notebooks containing his pioneering ideas on evolution and his famous "Tree of Life" sketch are missing, believed stolen, the Cambridge University Library said on Tuesday.

The British scientist filled the leather notebooks in 1837 after returning from his voyage on the HMS Beagle. The library said they were worth millions of pounds.

In one book, he drew a diagram showing several possibilities for the evolution of a species and later published a more developed illustration in his 1859 book "On the Origin of Species".

The University of Cambridge's vast library first listed the notebooks as missing in 2001 after they were moved out of the Special Collections Strong Rooms for photogra-

The University Librarian, Jessica Gardner, released a video statement appealing to the public to help.

"It is deeply regretful to me that these notebooks remain missing despite numerous wide-scale searches over the last 20 years," she said, adding that the library has since massively improved its security systems.

The librarian suggested that former or current library staff, those working in the book trade or researchers could have information.

Musk now 2nd richest in world, surpasses Gates
