Srinagar Teen Found Dead In Pahalgam

SRINAGAR: A teenager from Srinagar on Monday was found dead under mysterious circumstances in the tourist resort of Pahalgam in south Kashmir's Anantnag district.

19-year-old Mubashir Sajad Dar of Nowpora here was found unconscious by his friend at a hotel in Pahalgam on Monday morning, news agency KNO reported. He was removed to the government medical college (GMC) Anantnag where doctors declared him brought dead. More On P8

J&K Reports 6 More Covid-19 Deaths

SRINAGAR: Jammu and Kashmir reported on Monday six more coronavirus deaths and 156 fresh cases of Covid-19, including 10 travellers, taking the total number of people infected by the virus in the Union Territory to 120293.

Out of the six more deaths, five were reported from Kashmir Valley and one from the winter capital of Jammu and Kashmir -a 78-year-old from R S Pura Jammu, officials said. The victims from the Valley, officials said, included a 46-year-old man from Budgam, a 70-year-old man from Kupwara, a 65-year-old man from Srinagar, a 70-year-old man from Baramulla and an 80-year-old man from Shopian.

With these deaths, the total fatality count in J&K reached 1875-1183 in the Valley and 692 in the Jammu region.

Srinagar district with 447 deaths tops the list followed by Jammu (354), Baramulla (171), Budgam (108), Kupwara (91), Pulwama (88), Anantnag Doda (62), Bandipora (60), Udhampur (57), Kulgam (53), Rajouri (54), Kathua (48), Ganderbal (43), Shopian (38), Samba (38), Poonch (23), Ramban (21), Kishtwar(21), and Reasi (14).

Meanwhile, ten travellers were among 156 more people, who tested positive for coronavirus in J&K during the last 24 hours, officials said.

While 81 new cases were detected from Kashmir Valley, the remaining 65 were confirmed by the officials from Jammu More On P8

Snowfall In Upper Reaches, Temp Up

KASHMIR In Capital: Old Delhi's Delicacy Maker



SHAHJAHANABAD, DELHI: On a chilly December morning, one can see several Kashmiris - single and with family — moving a little ahead of the Jama Masjid, towards a small, yet lively restaurant.

They're going to the most famous Kashmiri eatery in the area-

Kashmiri Restaurant. The restaurant termed as home by many is run by Ghulam Hassan Sarkar, an erstwhile resident of Budgam, Kashmir.

In 1985, Hassan, now 60, came to Delhi as a struggler—running from



his homeland's political troubles— for a better life and employment

My mother was against my decision, as she always believed that a little earning at home is better than making fortunes elsewhere," Hassan said, as we sat to talk about his life and times in India's capital.

In the first five years after arriving in Delhi, he was indulged in the Shawl business that eventually resulted in the loss.



Then, he tried his hands on carpet business, before finding his call in Wazwan eatery.

But even as the man from mountains was resilient enough to create his niche in the sweltering plains, Delhi never made it a cakewalk for him.

'The beginning was full of difficulties," he recounted with solemn expressions."There was no food and I used to sleep empty stomach, with tears coming out of my eyes. Even then I had to pay Rs 60 per month as rent."

That tumultuous period lasted for a decade-between1985 and 1995.He still feels pain of that trou-

Study Reveals How Masks Disrupt Facial Perception

it may be difficult to recognize familiar faces when people wear surgical masks to help them protect against Covid-19.

According to the findings published in the journal Scientific Reports, during the pandemic, the identification of people wearing masks has often presented a unique challenge. This new study led by researchers from Ben-Gurion University of the Negev (BGU) in Israel and York University in Canada reveals the impact of this predicament and its potentially significant repercussions.

"For those of you who don't always recognize a friend or acquaintance wearing a mask, you are not alone," according to the researchers Prof. Tzvi Ganel, head of the Laboratory for Visual Perception and Action at the BGU Department of Psychology, and Prof. Erez Freud, who earned his Ph.D. at BGU and is now a faculty member at York University in Toronto, Ontario.

"Faces are among the most informative and significant visual stimuli in human perception and play a unique role in communicative, social daily interactions," the researchers note. "The unprecedented effort to minimize Covid-19 transmission has created a new dimension in facial recognition due to mask-wearing."

To examine the effects of wearing masks, Prof. Ganel and Prof. Freud used a modified version of the Cambridge Face Memory Test, the standard for assessing facial perception, which included masked and unmasked faces. The study was conducted online with a large group of nearly 500

The researchers found that the



success rate of identifying someone wearing a mask was reduced by 15%. "This could lead to many errors in correctly recognizing people we know, or alternatively, accidentally recognizing faces of unfamiliar people as people we know," says Prof. Galia Avidan who is a member of the BGU Department of Psychology and the Department of Cognitive and Brain Sciences, and an expert on facial recognition and perception. "Face masks could be even more

challenging to people whose face recognition skills are not ideal to begin with and cause greater impairment."

The research team also found that masks specifically interfered with extracting a holistic impression of faces and led to feature-by-feature processing which is a less accurate and more time-consuming strat-

"Instead of looking at the entire face, we're now forced to look at eyes, nose, cheeks, and other visible elements separately to construct an entire facial face percept which we used to do instantly, the researchers say.

These changes in performance, with the alteration along with the processing style of faces, could have significant effects on activities of daily living, including social interactions, as well as other situations involving personal interactions, such as education

"Given that mask-wearing has rapidly become an important norm in countries around the globe, future research should explore the social and psychological implications of wearing masks on human behaviour," Ganel says. "The magnitude of the effect of masks that we report in the current study is probably an underestimation of the actual degree in performance dropdown for masked faces.'

New Wearable Device Detects Hand Gesture You Intend To Make


magine typing on a computer without a keyboard, playing a video game without a controller or driving a car without a wheel. A team of scientists has developed a new device that can recognise hand gestures based on electrical signals detected in the forearm.

The system, which couples wearable biosensors with artificial intelligence (AI), could one day be used to control prosthetics or to interact with almost any type of electronic device, said engineers from the University of California, Berkeley.

"Prosthetics are one important application of this technology, but besides that, it also offers a very intuitive way of communicating with computers," said Ali Moin, who helped design the device as a doctoral student in UC Berkeley's Department of Electrical Engineering and Computer Sciences

Reading hand gestures is one way of improving human-computer

"And, while there are other ways



of doing that, by, for instance, using cameras and computer vision, this is a good solution that also maintains an individual's privacy," Moin said in a new paper appeared in the journal Nature Electronics.

To create the hand gesture recognition system, the team collaborated with Ana Arias, a professor of electrical engineering at UC Berkeley, to design a flexible armband that can read the electrical signals at 64 different points on the forearm.

The electrical signals are then fed into an electrical chip, which is programmed with an AI algorithm capable of associating these signal patterns in the forearm with specific

The team succeeded in teaching the algorithm to recognise 21 individual hand gestures, including a thumbs-up, a fist, a flat hand, holding up individual fingers and count-

Like other AI software, the algo-

rithm has to first "learn" how electrical signals in the arm correspond with individual hand gestures.

To do this, each user has to wear the cuff while making the hand gestures one by one.

"In gesture recognition, your signals are going to change over time, and that can affect the performance of your model," said Moin.

We were able to greatly improve the classification accuracy by updating the model on the device.

Another advantage of the new device is that all of the computing occurs locally on the chip: No personal data are transmitted to a nearby computer or device.

Not only does this speed up the computing time, but it also ensures that personal biological data remain

While the device is not ready to be a commercial product yet, it could likely get there with a few tweaks, said Jan Rabaey, senior author of the





Saudi Arabia extends entry ban amid coronavirus variant fears

Saudi Arabia's interior ministry on Monday extended a ban on entry to the kingdom by air, land and sea for another week amid concerns over a fast-spreading variant of the new coronavirus, the state news agency SPA reported.

Saudi Arabia shut its borders on Monday Dec 21 and suspended international commercial flights on a rolling weekly basis although foreign flights already in the country were allowed to leave.

The ministry said it is evaluating the situation while allowing non-citizens to leave the kingdom and allowing entry for exceptional cases, SPA reported. The measures do not affect the movement of goods. Pakistan International Airlines (PIA) had also halted all its flights scheduled to Saudi Arabia since Dec 21. PIA spokesman Abdullah Khan had said all affected passengers would be accommodated at the earliest upon flight restoration.

PIA is resuming commercial flights to Saudi Arabia on Monday (today) to bring back stranded Pakistanis after Saudi Arabia's General Authority of Civil Aviation allowed non-Saudis to leave the kingdom and permitted foreign airlines to operate flights for the purpose.

Days after calling it 'disgrace', Donald Trump signs US COVID-19 relief bill

The signing comes after unemployment benefits expired for millions of Americans on Saturday as the bill went unsigned.

US President Donald Trump on Sunday (local time) signed the USD 2.3 trillion coronavirus relief package, days after he expressed displeasure with the spending outlined in the bill.

According to The Hill, Trump signed off the package from his golf club in the West Palm Beach.

"I will sign the Omnibus and Covid package with a strong message that makes clear to Congress that wasteful items need to be removed," Trump said in a statement upon signing the legislation.

"I will send back to Congress a redlined version, item by item, accompanied by the formal rescission request to Congress insisting that those funds be removed from the bill," he added.

The President had in past expressed dismay with the USD 2.3 trillion package that Congress passed Monday, which includes USD 900 billion in coronavirus relief and USD 1.4 trillion to fund the government until October, conflating the two bills and saying the spending goals were misguided.

The signing comes after unemployment benefits expired for relief-government funding packmillions of Americans on Saturday as the bill went unsigned.

Trump has visited his golf club in Florida each day since arriving

in the state on Wednesday and has made no public appearances. In the statement, Trump laud-

Citizen journalist jailed for 4 years over Wuhan virus reporting

A Chinese citizen journalist held since May for her livestream reporting from Wuhan as the COVID-19 outbreak unfolded was sentenced to four years in prison on Monday, almost a year after details of an "unknown viral pneumonia" surfaced in the central China city.

Zhang Zhan, a former lawyer, was accused of "picking quarrels and provoking trouble" for her reporting in the chaotic initial stages of the outbreak.

Her live reports and essays were widely shared on social media platforms in February, grabbing the attention of authorities, who have punished eight virus whistle-blowers so far as they try to stamp out criticism of the government's response to the

Human rights groups have also drawn attention to Zhang's case.

Authorities "want to use her case as an example to scare off other dissidents from raising questions about the pandemic situation in Wuhan earlier this year," said Leo Lan, research and advocacy consultant at the Chinese Human Rights Defenders NGO.

Zhang, who has maintained her innocence, is the first of a group of four citizen journalists detained by authorities earlier this year after reporting from Wuhan to face trial.

Previous attempts by the AFP news agency to contact the other three -Chen Qiushi, Fang Bin and Li Zehua - were unsuccessful.

Towards Justice

he police has accused an army officer and two associates of planting weapons on the bodies of three labourers who were killed by Army in September at Amshipora, Shopian and passed off as militants. Captain Bhoopendra Singh who is now in military detention, has been charged with murder, conspiracy and other offences. Similarly the two civilian "sources", who were with him at the time, are in police custody.

A police statement issued late on Sunday said the officer and two others "planted illegally acquired weapons and material on their dead bodies after stripping them of their identities and tagged them as hardcore terrorists in possession of war-like stores."

This is a rare case in which police has directly blamed the Army for the killing of civilians in an encounter. To be fair to Army, even it has blamed its own personnel in this incident. Earlier the Army had claimed to have killed three unidentified militants in the said encounter. But once their pictures were published in newspapers and circulated on social media, three families in Rajouri claimed they were their children and insisted they had had no terror links. According to the families, the trio had gone to Shopian to work as labourers. The Army was quick to order a high-level Court of Inquiry (CoI) into the encounter.

But nobody in Kashmir, even in their wildest imagination, believed that the Army would indict its own soldiers. This is why when it happened, it came as a pleasant surprise to people. Army has chosen to voluntarily dispense justice in a case where its personnel have in the words of Army itself "exceeded" the powers vested under the AFSPA. The Army has already confirmed that the three youth killed in an encounter at Amshipora were civilians from Rajouri in Jammu. The finding followed an internal probe into the incident.

As the Amshipora case has once again showed, what matters is the accountability of the personnel responsible for gross excesses, not the revocation of the AFSPA per se. Best the way out is the willingness among the security agencies to act fairly and speedily in case of rights violations. This is the only pragmatic solution under the circumstances. One can also ask what is stopping the centre from making necessary modifications in the law that makes the security personnel who commit human rights violations accountable for their actions. Such actions cannot be left entirely to the discretion of the Army. There has to be an inbuilt legal mechanism to punish the erring personnel irrespective of the institutional discretion of the security forces.

Spot the winner

he Union minister of law and justice has described the results of the District Development Council elections in the Union territory of Jammu and Kashmir as a 'historic' triumph for the Bharatiya Janata Party. The BJP, at first glance, seems to have performed well. It has emerged as the single largest party winning over 70 seats, sweeping southern Jammu and even pocketing three seats in the Valley. But the minister, as is the wont of this dispensation, has spotted the wrong winner. For it is the People's Alliance for Gupkar Declaration — its constituents include the National Conference, the Peoples Democratic Party, the Communist Party of India (Marxist) and others — that has emerged as the real winner. The PAGD, which is seeking to restore Jammu and Kashmir's statehood that the BJP took away, is in a position to dominate not only the district boards in Kashmir but — this is significant — quite a few in Jammu if the Congress decides to lend a helping hand. The alliance has made a mark in north Jammu, and a closer look would reveal that some of its smaller members — the CPI(M) and the Jammu and Kashmir People's Conference are examples — have had the best strike rates among the contestants. Contrastingly, the BJP, which has ceded some strongholds in Jammu and polled a little over three per cent of votes in Kashmir, clocked a strike rate of 32.6 per cent although it fought the highest number of seats. The election results have not been disputed, but this should not deflect attention from the formidable hurdles that the PAGD had to confront. There was the all-too-familiar vilification: the Union home minister described the alliance as a 'gang', insinuating its sympathy for separatists; PAGD candidates were also prevented from campaigning freely on specious grounds. The people have now replied unambiguously against this orchestrated intimidation.

Local elections are usually benign affairs. But what made the DDC elections singular was that this was the first election that took place since the controversial abrogation of Article 370. There is thus reason to view the outcome as an expression of the people's opinions on the Centre's interventions. The message should be chastening for the BJP. However, another concern seems to have escaped public scrutiny. With the creation of an additional layer of governance — the DDCs are not statutory bodies since their genesis lies in an executive fiat — what would be the prospect of the state assembly, if there is one, in the future? Parallel institutions need not be a sign of the triumph of democracy in Jammu and Kashmir.

s the details of DDC polls emerge, there is one aspect that has gone completely unnoticed. The implications of these polls on India. It is clear that like many other new measures, Jammu and Kashmir is a laboratory to test a new project which will alter the very foundations of trio all politics across states. The concept to elect DDC through direct vote isn't done anywhere else. It was tried in J&K first.

These DDC polls have actually turned Panchayats (which are elected through a direct vote) irrelevant and are going to be a replacement of the assemblies too. It is not being done anywhere else yet, all states have DDCs elected by Block committees and panchs and not through direct vote. Once the two layers above Panchayats are elected by panchs, it keeps them relevant to the whole process. In fact, that process had made Panchayat system three tier. Now an elected DDC is going to make Panchayat polls redundant and completely powerless. There are 14 elected members in a district who will choose a chairperson and there isn't any clarity what role Panchayats are going to play. The Panchayat system is no longer connected. With DDC elected through a direct vote, the lower two layers are no longer important. DDC makes panchs irrelevant, so is it going to turn elected assemblies unnecessary.

It also is aimed to depoliticise state level politics. BJP is moving towards a presidential form of government which will not be a federal structure / every state sooner or later will have DDC without any body or forum above them. This way you will have district assemblies at state level and a strong centre and there will be only bureaucracy that will connect these district bodies with the Centre. This means there will be no assemblies/ no CMs but only Lt Governors. This will depoliticise grass root and these elected members in each district will be busy with their so called developmental works where they will not have even any role in development planning or decisions on allocation etc — that will be decided

to pass such an amendment.

This means there will be DDC in all of 716 districts elected through direct vote with 14 members in each district. And as there is no forum for these DDC's to come together at state or UT level, they will have no forum to come together. Their role will be exclusively development related and not politics. But that much is sufficient to turn MLAs and state assemblies redundant, making way for their subsequent removal. The new system will have 716 DDCs and each state headed by a Lieutenant Governor appointed by the Centre that will run the affairs

The DDC model is literally a move towards turning every state into a UT. BJP has always been a votary of a strong Centre/centralisation of all power and politics. So, once this DDC model is replicated in other states, the regional politics that is literally the only competition to BJP in the absence of a potent national party will be wiped out.

However defending the film, its executive producer Husaain Ashmere says, "There are 250 films on Jesus Christ, 120 films on Moses, 80 about the other prophets, 40 films on Buddha and nine films about Mary, there are none about the life of Lady Fatima (AS), the daughter of the Prophet Muhammad (Pbuh).'

He said, during the making of this film no individual represented a holy personality in accordance with the Islamic tradition

However according to blogger Hamid Waqar, the main reason behind this controversy is the involvement of Yasser Al-Habib. "Furthermore, the film seemed to portray a dangerous theme promoted by Yasser Al-Habib and the Shirazi clan".

The film starts with a scene from present day wartorn Iraq. An Iraqi child who has lost his mother to a terrorist attack learns the importance and power of patience in his new home, where a loving grandmother narrates the historical story of The Lady Fatima (AS) and how her suffering as the "first victim of terrorism" spun out of control into the 21st century

The controversial cleric Yasser Al-Habib, who surfaces as the screenplay writer, is actually said to be the brain behind this film project. Al Habib known for stoking controversies, has previously been jailed in Kuwait for insulting Islam. He later took refuge in the UK where he spent £2million to buy a former evangelical church in Fulmer County and turned it into his base. It houses a mosque and headquarters of his controversial satellite TV channel, Fadak.

Al Habib is widely believed to be a UK point man of Qum based cleric Sayyid Mohammad al-Shirazi, a critic of the Islamic Republic and its founding philosophy. Shirazi heads what has come to be known as 'Shirazi group' or 'Shirazi clan'. The group owns more than 20



satellite television channels in different languages spoken in Muslim lands

In 1979 Shirazi left Kuwait and settled in the holy city of Qum immediately after the success of Islamic Revolution in Iran. Shirazi initially supported the revolution but soon fell apart with the leadership because of his extremist views. Later his group was declared outlawed by the Iran government. "Shirazi advised his followers not to reveal all their cards so they do not become mere tools in the hands of the Islamic Republic", researcher Hassan al Mustafa wrote on Al Arabiya website recently.

"The Shirazis are aware that Iran is a state with huge financial capabilities and political influence that goes beyond its borders. They know they cannot compete with it on this front so they headed towards another field which is possessing the sentiment of the Shia public, addressing it and influencing it especially amid the sectarian conflict in the Middle East and the worsening Sunni-Shia conflict", Mustafa writes.

"Amid this sectarian polarisation, the group launched a plethora of satellite television channels. They adopted a religious rhetoric and broadcast juristic and doctrinal lectures and prayers and aired footage

of visitors to sacred shrines of holy imams. This combination of religious material touched the worried and wounded Shia sentiment at a time when Al-Qaeda explosions rocked Iraqi cities and killed thousands of innocent people and amid the rise of Daesh and the violence and oppression it represented.

The "Husayni" rhetoric of these channels created an objective and moral space for the public in the Gulf and in Iraq in particular as people found themselves a breather which they can use to declare their own identity amid attempts to bury it and eradicate it, as they

"Arresting the Shia sentimental space" was the task which the Shirazi group found itself capable of in terms of competing with the Iranian government and excelling over it, especially that Islamic Republic presents itself as a state against extremism and sectarianism and promoter of Muslim unity.

The Shirazi group refuses to surrender to the Iranian will but it cannot compete with the Islamic Republic. It can compete with it in controlling the Shia sentiment via the project of rituals and satellite channels. This explains why the Shirazi office began establishing ideological channels. By broadcasting controversial and provocative material they have largely succeeded in undoing what Iran has been painstakingly doing, that is to bury the old Shia-Sunni hatchet and forge Muslim unity.

Top Shia clergy in Iran, Iraq and beyond have branded the Shirazi group as an extension of British intelligence service, the MI6. According to a report published in March by the news agency Tasnim that's close to Iran's Revolutionary Guards, Shirazi groups media channels work on a daily basis to promote extremist ideology, attack the Iran's Islamic Republic and ignite the fire of war between Sunni and Shia, i.e. provide indirect services to takfirist movements that wreak havoc in the Muslim Ummah.

Fadak TV, which broadcasts from the UK premises of al Habib and which is directly supervised by him, is one of the most important channels that adopts a sectarian and slanderous rhetoric that excludes whoever is different whether Sunni or Shia. Habib's insults have included respectable Sunni and Shia Islamic religious symbols.

Researcher Ahmed Al-Katib has his own opinion on the matter as he said: "Fadak TV and other similar channels express the opinion of the current Shirazi reference, despite the different terms used and the type of the adopted rhetoric. Everyone drinks from the same shallow intellect.

"Yasser Al-Habib's movement greatly harmed the image of Shia and depicted them as a group that do nothing but disturb others. This contradicts with the culture we inherited from the Imams of the Ahl al Bayt who forbade insulting, says Islamic scholar Sheikh Habib al-Jumayaa.

In September 2013, Iran's Supreme Leader Ayatollah Sayed Ali Khamenei warned in a speech about Iran's "enemies." Along with the usual suspects, such as the United States and Israel Avatollah Khamene also mentioned satellite channels like Fadak streaming out of the West. Referring to them as a "bunch of mercenaries who add more fuel to the fire" of Sunni-Shia conflicts, Syed Khamenei said emphatically, "They are given a mass media reach. And where are they based? The United States, Britain. The Shiaism that is being broadcast to the world from London is not Shia Islam but British Islam.'

"Sometimes there was only rice to eat," he said with tearful eyes. "And sometimes, there was nothing..." Amid hardships, a moment of happiness came when he married a local girl in 1992.

"After marriage, I was allotted a small house by my in-laws here in old Delhi," he said.

"From that house, I worked quite hard and opened this restaurant in around 1995.

By then, his homeland was mired in the throes of raging conflict with Delhi desperately trying to revive "democracy" in the strife region.

Despite longing for his home, Hassan chose to struggle in the heat of the capital—then remote-controlling the erstwhile state through president's rule. Even Radio Kashmir was airing the Kashmiri bulletin from Delhi with a signature style: "Ye Radio Kashmir Hai, Ab Aap Sunye Nayi Delhi Se Khabrein".

"Back then, many Kashmiris were migrating to other parts of India for better employment opportunities," Hassan recalled. "It was hard for any business to prosper in the valley due to the uncertain situation."

However, as he stood steadfast in the capital commotion, Hassan rose to become a prominent eatery face away from home. He developed good relations with big hotel owners such as Karims and Al-Jawahar.

But while he was growing in business, many of his competitors tried hard to create obstacles for him.

"They never wanted a Kashmiri to own a restaurant here because they thought it will cause them losses," Hassan said with a smile.

"However, Almighty had some different plans for me, and today I'm here quite well settled."

But things changed in the Covid era-handing him a daily loss of around Rs 10,000. Yet, he didn't shy away from adhering to the quintessen-

tial Kashmiri hospitality. "My own beloved people were stranded here in Delhi during Covid lockdown, and I just couldn't have let them die with hunger," Hassan recalled the initial Covid-lockdown experience.

"I provided them with food for around two months and along with the help of the Delhi government, arranged a special train for them from Delhi to Jammu. Sustaining lockdown was hard, but with the help of Allah, I'm happy I could play my part to spread some smiles."

His 'service to humanity' came when he had already lost around Rs20 lakhs in pandemic. He said he could've reversed that loss by sacking his employees. However, he still remembers his own struggling days in Delhi.

This same compassion reflects in Towheed Alam, one of Hassan's employees. "Hassan Sahab has treated us like his own sons," Alam told me as we sat to talk about the Budgam man in Old Delhi.

"I have never faced any problem in my entire life working here. He is a great man and he cares for us. I can't expect this sort of love and care from a local restaurant owner, and he being a Kashmiri has proved true to his identity and every other thing Kashmiris are known for.'

Most of Hassan's customers are from Kashmir actually. No matter wherever they stay, be it Trans-Yamuna, Nizamuddin, Okhla, or Malviya Nagar, they all come to eat here.

"I have seen people coming from Sopore and Anantnag especially for my restaurant," Hassan continued.

They say 'even if Karim give us food for free, yet we shall come to Hassan Sahab's place.' It not just makes me feel alive, but also compels me to give them a good discount."

But carrying 'Kashmiri Identity' in Delhi comes at its own costs, especially on the eve of Independence Day or Republic Day, when Kashmiris are asked to leave the hotels they are staying in. "Not just this," Hassan added," hotel owners are also strictly advised to not give space to Kashmiris. Why are my fellow people subjected to such harsh treatment?'

Recently, he said, one of his ex-workers was arrested for trespassing into the parliament.

"As soon as I heard about his arrest, I rushed to the police station and got that kid out because I knew he was new to Delhi and wasn't familiar with the area. He wasn't a trespasser, yet he was harassed. So being a Kashmiri does bring problems sometimes." But compared to his brethren, Hassan feels some sort of safety in Delhi now.

"Here, the authorities may question you regarding your ethnicity, but it isn't much difficult now," he said.

"However, there was a time between 1990s and early 2000s, when things were tough for Kashmiris in Delhi. I remember one Delhi Police ACP, Rajbir Singh. He was notorious for arresting and torturing Kashmiris."

Amid these capital concerns, Hassan often craves for his roots. His family in Delhi gets ecstatic when they've to leave for Kashmir every year in the summers.

"They all love and crave for Kashmir," Hassan said."My daughter and grandchildren enjoy more in Kashmir than here. They eagerly wait for summers all year and when it comes, they get super excited. I love seeing them happy.'

Today, even after spending 35 years of his life in Delhi, Hassan still feels he doesn't belong anywhere in the world but his homeland.

"I miss the period I could've lived there in the valley. I've informed my family that, the moment I die, take my body to Kashmir, and bury me there only. I earned a lot here. I got a name, fame, and everything, but today I believe it wasn't worth leaving my homeland behind for this life. I always miss my home, my Kashmir,"Hassan said with tears in his eyes.

It is pertinent to mention that activists of Jammu & Kashmir RTI Movement led by Dr Raja Muzaffar Bhat along with affected tribal population and traditional forest dwellers of villages in Branwar Zilsidara, Batwodder , Kanidajan in central Kashmir's Budgam held protest demonstrations during last several weeks over issuance of eviction notices, axing of fruit trees and non-implementation of Forest Rights Act in J&K.

Several national and international media organizations gave coverage to this public outcry which prompted the Govt to start rolling out Forest Rights Act (FRA) in Jammu & Kashmir which otherwise was not being implemented on ground in spite of being extended to UT of I&K on October 31st 2019 after abrogation of article 370.

Welcoming the decision of the Govt to implement the Forest Rights Act, Chairman RTI Movement Dr Raja Muzaffar Bhat demanded that Institute of Management Public Administration and Rural Development (IMPARD), Tribal Affairs Department J&K Govt and national level NGO's who have been conducting training courses on FRA in other states be also involved in training govt officials.

"Panchayat members, village forest rights committees and local NGOs also need to be trained on FRA implementation and Govt must seriously think over it and organize training of

trainers (ToT) workshops at district level to creaté more resource persons locally on FRA. There is a great role of civil society groups in it and they need to be taken on board" he said.

Pertinently, a video conference was held recently on FRA implementation by top Govt functionaries. The virtual meeting was addressed by the Principal Secretary, Home/ Revenue Department Shaleen Kabra, Commissioner Secretary Forest, Ecology & Environment Department, Sarita Chauhan, Secretary Tribal Affairs Department, Rehana Batul and Principal Chief Conservator of Forests Dr. Mohit Gera. The action plan/roadmap for implementation of FRA was shared and discussed with the Deputy Commissioners. (KNS)

Snowfall In ...

Meanwhile, fresh snowfall was recorded in many areas in the higher reaches of the valley and the Jammu region during the night, the officials said.

They said the popular ski-resort of Gulmarg, in north Kashmir, recorded two inches of snow, while Pahalgam resort, in the south, and Sonamarg resort, in central Kashmir, each received around an inch of snow.

Gurez in north Kashmir recorded three inches of fresh snowfall, the officials said, adding there are reports of snowfall in other areas in the upper reaches of the valley as well.

Many areas in the Jammu region also received fresh snowfall, they said. The officials said the area around the Jawahar Tunnel -- on the Srinagar-

Jammu national highway -- received two to four inches of snow, leading to temporary disruption of traffic movement on the highway. The traffic on the highway -- the only

all-weather road-link connecting the valley with the rest of the country was suspended for some time in the morning, but was allowed later after the clearance of snow, the officials said.

Kashmir is currently under the grip of 'Chillai-Kalan' -- the 40-day harshest winter period when a cold wave grips the region and the temperature drops considerably leading to the freezing of water bodies including the famous Dal Lake here as well as the water supply lines in several parts of the valley.

The chances of snowfall are most frequent and maximum during this period and most areas, especially in the higher reaches, receive heavy snowfall, the officials said.

While 'Chillai-Kalan' -- which began on December 21 -- will end on January 31, the cold wave continues even after that in Kashmir with a 20-day-long 'Chillai-Khurd' and a 10-day-long 'Chillai-Bachha' following it. The MeT office has said the weather would likely remain dry till January 3. (with PTI inputs)

hope for the business community. "While appreciating the efforts put in by Lt. Governor for the said package. But at the same time most of the announcements in the package are still awaited," he said.

The spokesperson said that the Committee has recommended an interest subvention of 5% for six months amounting to Rs. 1089.24 Crore, partial waiver of fixed electricity charges for one year amounting to Rs. 80 crore, waiver of water charges for six months costing Rs. 25 crore, time bound one time settlement (OTS), capital infusion in accordance with the Atma Nirbhar Bharat Abhiyan, replacement of old vehicles and insurances support costing Rs. 50 Crore to the transporters support to artist and others costing Rs. 108.75 crore which are partially implemented and needs immediate attention from the I&K Government.

"Various committees were supposed to be constituted like Committee for settlement of bank, finances and industry issues with association representatives as members to be chaired by Finance Department, Committee in each province/district involving members of the business association to address their issues which shall meet every month at District level and every two months at provincial level to settle issues of the business community. The Committee shall have a representative from I&C/ Finance/Bank as its members but the committees were not constituted yet which results in huge problems faced by the industrial sector," the KCCI spokesperson said.

He further said that the removal of Lakhanpur Toll post has hit the business very badly and a committee was formed to ascertain its effects on the industries but the report has not still come out.

"It is a well-known fact that our export performance over five years have deteriorated to the worst level. To encourage exports from J&K, we need to support at all levels in manufacturing, artisans and weavers. In our recent meeting held with Hon'ble Lt. Governor was kind enough to ensure KCC&I delegation that Government constitute a Export Promotion Board for all Export level issues but till date no Board was constituted," he said.

He said the tourism sector in general and tour operators in particular were running into the most difficult time due to business losses since

August, 2019. "In the above said financial package subsidy for installation of the bio-digesters in the houseboat, pending payments to the hotels utilized for quarantine facility, issues related to permission for renovation of Hotels Houseboats with the Committee of experts on LAWDA, simplification of process for renewal of licenses of the Houseboats, extension of Tourism incentives scheme for next 15 years for Travel Agents and Tour Operators, Power Tariff at par with Industries are still pending with the concerned authorities," he added.

The KCCI spokesperson further said that the body appreciates the extension order for renewal of fitness and registration papers for transporters till 31st March, 2021.

"But they have to submit the documents online and as you are well aware that internet 4G is not working in Kashmir and on 2G internet speed it's somehow difficult for them to upload the documents online," he said.

The KCCI, he said, requests authorities to waiver off all the penalties and the transport sector must be waived off from paying passenger tax, token tax, fitness charges and permit fees for the last seventeen months besides complete compensation of insurance for the last one year.

"It would be pertinent to mention that GST Council and many more issues which KCC&I submitted to J&K Government are referred to by the Centre Government needs to be followed up by concerned departments which we believe are urgent in nature and require immediate consideration," the KCCI spokesperson said.

"Various other issues were raised by the KCC&I with the State and Central Government being faced by the Industrial and other sectors which needs to be addressed so that the problems faced by the industries and other sectors are taken care off," he said, while seeking intervention of LG.

Asked about the below-expectation performance of the JKAP, the new entrant in the political space of Jammu and Kashmir, he said, "Please understand that 12 (candidates) won on our ticket while 21 independents were supported by us."

Secondly, we were just born a few months back but our vote share is more than that of the PDP which has been in the political arena for more than two decades. We have been moving around and telling people about our party. The cadre base is building and we will only improve from here,' he said.

The JKAP secured 5.3 per cent of votes in the eight-phase elections held between November 28 and December 19. The counting of votes took place on December 22.

The Peoples Democratic Party led by former chief minister Mehbooba Mufti had secured only 3.96 per cent votes.

The BJP topped the chart with 24.82 er cent vote share, followed National Conference with 16.46 per cent. Independent candidates had a vote share of 13.82 per cent.

The JKAP was contesting against the People's Alliance for Gupkar Declaration (PAGD) which comprise the National Conference, the PDP, People's Conference, CPI(M), CPI, JK People's Movement and the Awami National Conference.

Bukhari said the JKAP has been working towards having its chairperson in as many as six to seven districts in the union territory.

"People have been approaching us and are willing to cross over. The independent winners are willing to join us as the IKAP is not a dynastic political party and there is scope for climbing up the ladder if one performs well," he said.

While PAGD swept the polls by winning 110 seats, the BJP emerged as the single largest party by getting 75 seats in the first democratic exercise after the revocation of Jammu and Kashmir's special status under Article 370 of the constitution and bifurcation of the erstwhile state into union territories.

There are 280 DDC constituencies 14 each in 20 districts. The results of two seats -- one each in Bandipora and Kupwara districts of north Kashmir -are awaited as the counting of votes has been deferred there till further orders.

State Election Commissioner K K Sharma had last week said the counting in Drugmulla constituency of Kupwara and Hajin-A in Bandipora have been kept in abeyance to clear the citizenship issue of two of the candidates. "The central government should bring the basic and fundamental reforms not only in the administrative and political field but also in the social, economic and cultural fields as well. Jammu and Kashmir should always be on the top of the agenda of the party and the government. There are opportunities available to substitute militancy with tourism in the UTs of Ladakh and J&K," he said. (PTI)

Gold Prices May Touch Rs 63,000 Per 10 Grams In New Year

old, always considered a safe haven for investment in uncertain times, is likely to glitter more and even soar to Rs 63,000 per 10 grams next year amid expectations of fresh stimulus measures and weaker American dollar.

In 2020, the economic and social uncertainties triggered by the coronavirus pandemic turned the spotlight on gold as a safe haven. The price of the yellow metal reached an all-time high of Rs 56,191 per 10 grams at MCX and USD 2,075 an ounce in the international market in August.

A sharp turn in global monetary policies that led to a low interest rate scenario and unprecedented liquidity, which began in mid-2019, gave a boost to gold price in all major currencies, making the yellow metal attractive for investors.

'The year began (with gold) at Rs 39,100 (per 10 grams) and USD 1,517 (an ounce). The knee jerk reaction to the pandemic was short-lived as the domestic price hit a low of Rs 38,400 from where it steadily rose all the way to Rs 56,191. The stimulus provided subsequently triggered a sharp rise in investment buying in the domestic market," Commtrendz Risk Management Services CEO Gnanasekar Thiagarajan told PTI.

He said the outlook for gold remains strong despite coronavirus vaccine prospects and economic revival post CO-VID-19, mainly due to fresh stimulus expectations.

The political risk in the US due to a weak majority in the Senate could make things difficult for the incoming Joe Biden-led administration to push reforms and that could aid in the bullion's upward movement, Thiagarajan said.

"The physical demand (for gold) from India and China will take centre stage in 2021, which has been weak for the past few years and could see a strong revival. We expect prices to test Rs 60,000 or USD 2,200 at least in 2021, provided the rupee remains stable too," he opined.

HDFC securities Senior Analyst (Commodities) Tapan Patel said the yellow metal is likely to remain bullish next year with targets of USD 2,150 and USD 2,390 in COMEX gold and Rs 57,000 and Rs 63,000 at MCX on concerns over global economic recovery.

"The slower pace of revival of economic activities and labour market growth along with higher amounts of stimulus measures will continue to remain driving factors for gold prices," he added.

people may put off their international travel plans due to concerns over the spread of new variant of coronavirus in some countries and possibility of flight bans by nations like Dubai, France and Singapore, a survey has revealed.

The survey, which is based on over 15,000 responses from over 10,000 people from across 204 cities and conducted by online platform LocalCircles, also revealed that as many as 42 per cent of the respondents did not have any travel plan for domestic travel at all.

Post lockdown, the government hasn't yet allowed regular operation of international flights, instead it operates transport bubbles with 23 countries, including the UK via the Vande Bharat Mission.

However, India imposed a temporary on flights from and to the UK from December 23 till December 31 following the detection of the new variant of the virus in the UK.

LocalCircles has conducted a survey to understand the impact of this new strain of coronavirus on international travel plans of Indians in the next three months.

The platform has observed an increase in citizens' posts suggesting that many may hold back on their travel plans to any international countries as fear and anxi-

ety of getting infected by this new strain as well as the possibility of flight bans from other airline hubs like Dubai, Singapore, Paris, etc. has increased, LocalCirles said in a release.

The survey also tried to understand people's plan to undertake domestic travel in the next three months as with reducing case-loads and COVID fatigue setting in, many more have started to travel since October, it said.

Consumers were asked about their situation in regard to undertaking international travel in the next three months, according to the

online platform. "Local circle received 7,820 response, of which as many as 71 per cent consumers said that they have no plans to undertake international travel in the next 3 months. while 2 per cent said they have bookings and will likely travel, and another 2 per cent saying that have bookings but may cancel based on COVID situation," it said.

Also, as many as 16 per cent said they had plans but may not travel due to COVID, while 7 per cent said they might travel based on coronavirus situation.

"The aggregate feedback of consumers suggests that the new virus strain that was recently detected in the UK and related flight bans, the majority planning international travel in the next 3 months are likely to hold back," the survey revealed.

When only the consumers considering international travel were surveyed - while keeping the 71 per cent consumers who had no plans to undertake international travels in the next three months out of scope. it appears that of the 100 per cent consumers who were considering international travel, 59 per cent of them who had "plans but no bookings" will likely not travel, and 7 per cent who had bookings will cancel those bookings and not travel, as per the survey.

Eight per cent who have international travel bookings already will likely travel and another 26 per cent who do not have bookings will likely plan their international travel in the next three months based on how the

COVID situation develops, it said. Overall, the survey indicates that the mutant coronavirus and related flight bans have led to 66 per cent of consumers planning international travel in the next 3 months to hold back. However, if India is able to contain the spread of Covid and the new virus mutations, domestic travel is likely to be strong. And if that happens, it seems likely that many might cancel their trip to Switzerland in favour of Dalhousie or Kashmir. -

Scientists develop new gene therapy for deafness

new study from Tel Aviv University (TAU) presents an innovative treatment for deafness, based on the deliv-Lery of genetic material into the cells of the inner ear. The genetic material "replaces" the genetic defect and enables the cells to continue functioning normally.

The scientists were able to prevent the gradual deterioration of hearing in mice that had a genetic mutation for deafness. They maintain that this novel therapy could lead to a breakthrough in treating children born with various mutations that eventually cause deafness.

The study was led by Professor Karen Avraham of the Department of Human Molecular Genetics and Biochemistry at TAU's Sackler Faculty of Medicine and Sagol School of Neuroscience. The paper was published in EMBO Molecular Medicine. Deafness is the most common sensory disability worldwide.

According to the World Health Organization, there are about half a billion people with hearing loss around the world today, and this figure is expected to double in the coming decades. One in every 200 children is born with a hearing impairment, and one in every 1,000 is born deaf. In about half of these cases, deafness is caused by a genetic mutation.

There are currently about 100 different genes associated with hereditary deafness. "In this study we focused on genetic deafness caused by a mutation in the gene SYNE4 -- a rare deafness discovered by our lab several years ago in two Israeli families, and since then identified in Turkey and the UK as well," Pro-

fessor Avraham reports. "Children inheriting the defective gene from both parents are born with normal hearing, but they gradually lose their hearing during childhood. The mutation causes mislocalization of cell nuclei in the hair cells inside the cochlea of the inner ear, which serve as soundwave receptors and are essential for hearing. This defect leads to the degeneration and eventual death of hair cells." "We implemented an innovative gene therapy technology: we created a harmless synthetic virus and used it to deliver genetic material -- a normal version of the gene that is defective in both the mouse model and the affected human families," says Shahar Taiber, one of Professor Avraham's students on

the combined MD-PhD track. "We injected the virus into the inner ear of the mice, so that it entered the hair cells and released its genetic payload. By so doing, we repaired the defect in the hair cells and enabled them to mature and function normally." The treatment was administered soon after birth and the mice's hearing was then monitored using both physiological and behavioural tests. "The findings are most promising," says Professor Jeffrey Holt from Boston Children's Hospital and Harvard Medical School, a collaborator on the study. "Treated mice developed normal hearing, with a sensitivity almost identical to that of healthy mice who do not have the mutation.'

Scientists are now developing similar ther-

apies for other mutations that cause deafness. "This is an important study that shows that inner ear gene therapy can be effectively applied to a mouse model of SYNE4 deafness to rescue hearing," says Prof. Wade Chien, MD, from the NIDCD/NIH Inner Ear Gene Therapy Program and Johns Hopkins School of Medicine, who was not involved in the study.

"The magnitude of hearing recovery is impressive. This study is a part of a growing body of literature showing that gene therapy can be successfully applied to mouse models of hereditary hearing loss, and it illustrates the enormous potential of gene therapy as a treatment for deafness."

Study discovers new measures to predict risk of bowel diseases

ount Sinai researchers claim to have discovered new measures to predict risk for inflammatory bowel diseases (IBD) including Crohn's disease and ulcerative colitis.

The study published in the research journal Gastroenterology shows that the polygenic risk scores, built using association data from multiple populations in Mount Sinai's multi-ethnic BioMe Bio-

bank, maximized IBD predictions for every population in the biobank. BioMe is a system-wide effort at Mount Sinai that is revolutionizing diagnosis and classification of diseases according to the patient's mo-

lecular profile. The study showed that risk scores calculated from integrating data significantly improved predictions among individuals with European, Ashkenazi Jewish, and Hispanic ancestry in BioMe, as well as European individuals in the UK Biobank, which contains biological and medical

data on half a million people between ages 40 and 69 living in the UK. Predictive power was lower for patients with African ancestry, likely due to substantially smaller reference datasets and substantially greater genetic diversity within populations of African descent.

"The ability to accurately predict genetic disease risk in individuals across ancestries is a critical avenue that may positively affect patient outcomes, as early interventions and even preventive measures are being considered and developed," said the study's senior author Judy H. Cho, MD, Dean of Translational Genetics and Director of The Charles Bronfman Institute for Personalized Medicine at the Icahn School of Medicine at Mount Sinai.

These findings support a need for greater genetic diversity, including more data on African American populations, to enhance disease risk predictions and reduce health disparities for all populations," added Cho. These polygenic risk scores--representing an estimate of overall risk based on the sum of an individual's many, most common, genetic variants--were calculated using IBD association data from cohorts with European, African American, and Ashkenazi Jewish backgrounds.

Additionally, researchers assessed rare variants in genes associated with very-early-onset IBD within each population and found that African American carriers of uncommon LRBA variants showed reduced expression of both proteins LRBA and CTLA-4.

LRBA deficiency increases susceptibility to IBD and results in lower CTLA-4 expression, which can be reversed with the commonly prescribed antimalarial drug chloroquine. Future studies by the Cho Laboratory will focus on predicting which subsets of patients might benefit from targeting this pathway.

"Since lowered LRBA and CTLA-4 expression can lead to IBD, it's encouraging that chloroquine is able to partially recover expression," said the study's first author Kyle Gettler, PhD, a postdoctoral fellow in the Department of Genetics and Genomic Sciences at the Icahn School of Medicine at Mount Sinai.

SRINAGAR: Doctors Association Kashmir (DAK) on Monday said people who have recovered from Covid-19 infection could be reinfected with the new mutated strain.

"Those who have got Covid-19 could get sick again with the new variant," said DAK President and influenza expert Dr Nisar ul Hassan.

"A new mutated Covid strain has surfaced in the United Kingdom and is spreading to other countries," he said.

"The new variant has multiple mutations in the spike protein of the virus and the most troubling is deletion mutation which makes it spread more easily."

Saudi rights activist Loujain al-Hathloul sentenced to almost six years in jail



Court suspends some of sentence and backdates start of term. meaning she only has three months left to serve

Loujain al-Hathloul, the Saudi women's rights activist detained three years ago by the Saudi government, has been sentenced to five years and eight months in jail after being found guilty of spying with foreign parties and conspiring against the kingdom.

But the court suspended two years and 10 months of her sentence, and backdated the start of her jail term to May 2018, meaning she only has three months left to serve.

Although human rights campaigners will say she should never have been detained for so long without charge, the prospect of serving only a further three months in jail will help defuse a potentially damaging early con-frontation with the Biden administration that would have occurred if she had been locked up for a further 20 years, as seemed possible at one point.

The Saudi courts had already cleared the kingdom's prosecutors of torturing her in detention, saying there was no evidence that she was transferred from Jeddah governorate to a secret location where she was tortured and sexually harassed.

The news of her verdict was first tweeted by the newspaper Asharq Al-Awsat, which said a Saudi court had "sentenced a female detainee with incitement to change the kingdom's ruling regime and cooperating with individuals and entities to carry out a foreign agenda".

She had been arrested in May 2018 along with four other human rights activists. She claims she was not allowed to speak to anyone for seven weeks after her arrest.

After more than two years of detention, and some internal debate within the kingdom on how to handle her case, the Saudis waited until after their hosting of the G20 summit in November to transfer her case to the specialised criminal court.

Terrible floods in India cost \$10 bn loss: UK charity

NEW DELHI: Fifteen extreme weather events, influenced by climate change, were identified globally this year, including the terrible floods that struck India cost \$10 billion, killing 2,000, a UK charity report said on Monday.

The London-based Christian Aid's report, 'Counting the cost 2020 A year of climate breakdown', said 10 of those

events cost \$1.5 billion or more. The US was hit by the highest costs due to the record-breaking hurricane season and fires.

Most of these estimates are based only on insured losses, meaning the true financial costs are likely to be higher.

While the report focuses on financial costs, which are usually higher in richer countries because they have more valuable property, some extreme weather events in 2020 were devastating in poorer countries, even though the price tag was lower.

South Sudan, for example, experienced one of its worst floods on record, which killed 138 people and destroyed the year's crops. Some of the disasters hit fast.

like cyclone Amphan, which struck the Bay of Bengal in May and caused losses valued at \$13 billion in just a few days.

Other events unfolded over months, like floods in China and India, which had an estimated cost of \$32 billion and \$10 billion respectively. Six of the 10 most costly events took place in Asia, five of them associated with an

billion. The outbreak has been linked to wet conditions brought about by unusual rains fuelled by climate change.

But the impact of extreme weather was felt all over the world. In Europe, two extratropical cyclones, Ciara and Alex, had a combined cost of almost \$6 billion.

The US suffered from both a record-breaking hurricane season and a record-breaking fire season adding up to more than \$60 billion in damages.

Some less populated places also suffered the consequences of a warming world.

In Siberia, a heat wave during the first half of the year set a record in the city of Verkhoyansk. with temperatures reaching 38 degrees Celsius. A few months later, on the other side of the world, heat and drought drove the fires in Bolivia, Argentina, Paraguay and Brazil.

While there were no human casualties reported from these events, the destruction of these areas has a great impact on biodiversity and the planet's capacity to respond to a warmer

While climate change may have influenced all these events, many of the countries that bear little responsibility for global warming were affected.

It is critical that countries commit to bold new targets ahead of the next climate conference, which will take place in Glasgow in November 2021.

The report's author Kat Kramer, Christian Aid's climate policy lead, told IANS "The Covid-19 pandemic has understandably been a major worry this year. For millions of people in vulnerable parts of the world, climate breakdown has compounded this.

"The good news is that, like the vaccine for Covid-19, we do know how to fix the climate crisis. We need to keep fossil fuels in the ground, boost clean energy investment and help those who are suffering on the frontline.

"Whether it be floods in Asia, locusts in Africa or storms in Europe and the Americas, climate change has continued to rage in 2020. It is vital that 2021 ushers in a new era of activity to turn this US President-elect

Biden in the White House, social movements across the world calling for urgent action, post-Covid green recovery investment and a crucial UN climate summit hosted by the UK, there is a major opportunity for countries to put us on a path to a safe future." Over 5% more malicious files detected every day in 2020: Kaspersky

NEW DELHI: Global cybersecurity firm Kaspersky's detection systems discovered an as worms - malicious proaverage of 3,60,000 new malicious files every day over the past 12 months, a growth of 5.2 per cent when compared to the same period previous Dinihou malware family.

The growth was driven mostly by the number of Trojans malicious files capable of a range of actions, including deleting data and spying -- and backdoors, a specific type of Trojan that gives attackers remote control over the infected device, Kaspersky said in its 'Security Bulletin Statistics of the Year Report'.

"It's hard to know whether or not attackers were more active or our solutions detected more malicious files simply because of greater activity. It could be a combination of both," Denis Staforkin, security expert at Kaspersky, said in a statement.

"Either way, we have registered a noticeable increase in the number of new malicious files this year, and this will most likely continue going into 2021 as employees continue to work from home and countries implement different restrictions.'

The report said that 60 per cent of those malicious files detected in 2020 were non-specific Trojans. In general, the per cent 40.5 per cent when compared to ceived from unknown sources.

The vast majority of malicious files detected (89.80 per cent) occurred via Windows PE files - a file format specific to Windows operating systems, said the

At the same time, the number of new malware related to Android operating systems de-clined by 13.7 per cent. Given that many people were working and studying from home, most likely on computers and laptops, attackers appear to have shifted their focus to these devices.

There was also a 27% increase in the number of different scripts - sent via malicious email campaigns or encountered on infected websites, which could, once again, reflect the fact that people spent more time on the Internet and attackers attempted to capitalise on that fact.
