Militant Associate Held In Kulgam: Army

SRINAGAR: Army on Saturday claimed to have arrested a militant associate and recovered arms and ammunition from his possession in Kulgam district of Jammu and Kashmir.



'Vitamin D inexpensive, low-risk, can strengthen immune response to COVID-19'

levels of Vitamin D lead to severe Covid-19 symptoms but there is a definite connect between the "sunshine vitamin" and immune responses to the disease, say experts as the pandemic spreads across the world and concerns mount over a new mutant strain. Stressing that Vitamin D is inexpensive and has negligible risk when compared to the considerable risk of Covid-19, global researchers on the disease have asked governments to make it part of their strategy against the novel coronavirus. Many factors such as age, being male and comorbidities are known to predispose individuals to higher risk from exposure to SARS-CoV-2, but inadequate Vitamin D is by far the most easily and quickly modifiable risk factor with abundant evidence to support a large beneficial effect, said Prof Afrozul Haq, former dean of the School of Interdisciplinary Sciences and Technology (SIST) at New Delhi's Jamia Hamdard University.

He is one of the 170 experts who earlier this month wrote an open letter on the matter. Calling for immediate widespread increased Vitamin D intake, the letter posted on the website vitamindforall.org states that "research shows low vitamin D levels almost certainly promote Covid-19 infections, hospitalisations, and deaths". "This campaign group of Vitamin D and Covid-19 researchers, including myself, started the process to write this letter for the purpose to make all aware about the benefits of Vitamin D supplementation in Covid-19 infected patients and sending this letter to all health ministries, healthcare workers, governmental bodies and NGOs," Haq told PTI. According to the letter, which had 171 signatories by Wednesday, evidence suggests the possibility that the Covid-19 pandemic sustains itself in large part through infection of those with low Vitamin D and deaths are concentrated largely in those with deficiency.

"The mere possibility that this is so should compel urgent gathering of more vitamin D data. Even without more data, the preponderance of evidence indicates that increased vitamin D would help reduce infections, hospitalizations, ICU admissions, & deaths," it said.

As debate on the matter escalated, immunologist Vineeta Bal added a note of scepticism, noting that most of the experts are based in developed

countries where Vitamin D daily supplementation may be feasible, practical and affordable. "But that is not the case with India. Vitamin D deficiency is extremely common in India, Regular supplementation is not part of standard recommendations, not even for pregnant women,"

Bal, visiting professor at Pune's Indian Institute

of Science Education and Research, told PTI.

"If individuals are heavily deficient, supplementation as recommended in the letter is likely to take weeks or months to achieve desirable levels of Vitamin D in the serum," she said. The scientist added that this cannot be considered an emergency measure, when the country lacks manpower and facilities even for the vaccine programme. In her view, Vitamin D supplementation should be a long-term, nonemergency measure and something that could be useful in the Covid-19 scenario as well.

'Not just Vitamin D, other vitamins and micronutrients such as zinc have also shown beneficial effects," she explained.

According to Prof Srijit Mishra, another signatory to the letter, the recommendation is Vitamin D intake for adults of up to 4,000 international Units (IU) or 100 microgrammes (mcg) daily. Those at an increased risk of deficiency due to excess weight, dark skin, or living in care homes may need higher intakes.

"The current evidence suggests that 25-hydroxyvitamin D serum levels over 30 nanograms per millilitre (ng/ml), a test to measure Vitamin D level is a widely endorsed minimum to reduce Covid-19 risk," Mishra, from Mumbai's Indira Gandhi Institute of Development Research (IGIDR), told PTI.

Bal said Vitamin D is generally known to have many beneficial contributions in immune responses, and added, "There are no reports, to the best of my knowledge, where there are radical improvements brought about by supplementation of Vitamin D in normal individuals." In her judgment, Vitamin D can have an additional role to play along with other medications but not a primary role. The linkage between Vitamin D and better immune competence does exist based on experimental data, and data on patients is almost invariably associative and does not prove a cause-and-effect relationship, she said.

While no clinical trials have tested Vitamin D's efficacy as a treatment or a preventive measure, several studies have found an association

between low levels of Vitamin D and Covid-19. However, a review of five of these studies by the National Institute for Health and Care Excellence (NICE) in the UK concludes that the studies provide no evidence that Vitamin D levels influence the risk of getting Covid-19 or dying as a result.

There is no evidence to support taking Vitamin D supplements to specifically prevent or treat Covid-19," authors of the study wrote.

Mishra also noted that the evidence so far on risk-factors of Covid-19 with low Vitamin D level is associational, with some studies pointing out that low levels of the vitamin had a higher risk in infection and positivity rates.

He said a communication from UK-based NNEd-Pro Global Centre for Nutrition and Health has brought out a 10-point summary on diet, nutrition and the role of micronutrients for combating Covid-19.

The note identifies the relevance of various micronutrients, including Vitamin D. However, as the NNEdPro write-up clearly points out, this advice on nutritional adequacy should not be con-stituted as a substitute for key public health and medical advice on prevention," Mishra said. -PTI

Model predicts global threat of sinking land will affect 635 million people worldwide

activities uman such as groundwater removal and other natural causes are leading to sinking of the Earth's surface and the phenomenon will affect 635 million people, mostly in Asia, with a total exposed Gross Domestic Product (GDP) of \$9.78 trillion in the next four years, warn researchers.

By 2024, 19 per cent of the world's population—accounting for 21 per cent of the global GDP—will be impacted by subsidence, the sinking of the ground's surface, said the study published in the journal Science. The results represent "a key first step toward formulating effective land-subsidence policies that are lacking in most countries worldwide," the authors noted.

Lead researcher Gerardo Herrera Garcia and his team performed a large-scale literature review that revealed that during the past century, land subsidence due to groundwater depletion occurred at 200 locations in 34 countries.

The team developed a model by combining spatial and statistical analyses that identified an area's subsid-

While the model does not consider existing mitigation measures, potentially resulting in overestimates of subsidence exposure, their results still represent a step forward to effective policies. During the next decades, factors including global popula-tion and economic growth, exacerbated by droughts, will probably increase land subsidence occurrence and related damages or impacts. "Policies that implement subsidence modeling in exposed areas, constant monitoring of high-risk areas, damage evaluation, and cost-effective countermeasures could help reduce the impacts of subsidence where it will hit hardest - namely, areas with in-

creased population density, high groundwater demand, and irrigated areas suffering water stress," the authors

Div Com said this while chairing a meeting of concerned officers. The meeting, among others was attended by CE I&FC. PHE, Commissioner SMC, Director Rakhs and Forms, ADC WLW Wetlands, Tehsildar Eidgah, representatives from different departments and Chairman NLCO.

The Div Com said that wetlands are not lands for dumping of waste but are to be sustained as lungs of Valley to safeguard us during rainy days.

Stressing on immediate cleaning, dredging and restoration of both lakes, the Div Com emphasized on active involvement of locals in the restoration mission. He said that major cleanliness drive shall be launched across these lakes to ensure these are restored to its past glory and attraction.

SMC Realizes Over Rs 37,000 Fine In Two Days

He added that on day two, a total of 113 persons were fined within the Municipality limits, adding that Rs 1200 each were realized from the norm violators across Srinagar all the 35 wards of the corporation. He said in the initial days, Rs 200 only will be realized as fine from norm violators and in case they (people) don't adhere to the guidelines, the fine will go up to Rs 500.

The amount on the first two days of the camping realized is Rs 37,600. Qadri said that the response on the ground is quite appreciable and people are being found wearing face masks.

He added that from Monday, they will visit places like coaching centers and other places where huge gatherings are being witnessed almost on a regular basis to check whether all the set norms are being followed in letter

Pertinently, SMC created awareness among the masses for almost seven days from December 26 and urge people to wear face masks to prevent the deadly virus from spreading. Cops produce youth in court

RINAGAR - A Kupwara youth 'missing' in police custody for the past two years and presumed dead by his family, was produced in the court last month by personnel of Soura police station after persistent efforts by the valleybased civil rights body, Human Rights Front (HRF) and the intervention of the National Human Rights Commission. All this while police had been denying they had the youth in their custody and the family had performed the Fateha Khawani as well as observed his death anniversary. Muhammad Jamal Sheikh, of Panjar, Trihgam had been

picked up during a Joint raid by Soura and the 100th battalion BSF from Batmaloo stand where he earned a living as a cart-puller HRF chairman Mohammad Ahsan Untoo had brought the

custodial disappearance to the notice of the State Human Rights Commission, but both had drawn a blank with the police who continued to deny holding him. It was only after Untoo took the matter to the NHRC and the

commission issued a notice to the state police chief and the union defence ministry, that con from Soura police station produced Jamal in a Srinagar court on December 24, with a charge, reported fictitious, under the Indian Arms Act slapped against him. Five day later, he was sent to Jail for a further Id months

under the Public Safety Act. After his arrest two years ago, he had reportedly been subjected to severe physical and mental torture by a team of 'interrogators' led by the then SHO of the Soura police station,

Abdul Rasheed Khan. It is pertinent to mention here that the SHO Rashid Khan wanted in a tripple murder case is absconding for over an year now. Reportedly, at-tempts had also been made to liquidate Jamal in custody. (NAFA)

Top Doc Warns Against Lowering Guard On Covid-19

Srinagar, Jan 2: A top Kashmir doctor on Saturday cautioned the public over any lowering of guard against the Coronavirus pandemic despite the rollout of vaccines.

Addressing as lead speaker the inaugural session of a two-week refresher course, organised by the Kashmir University's UGC-HRDC, Prof Parvaiz Koul, Head of the Internal and Pulmonary Medicine Department at Sher-e-Kashmir Institute of Medical Sciences Srinagar, said: "At this point, I would not advise that you get rid of social distancing norms or other Covid-appropriate behavior that we have gotten used to. These measures have to run parallel to the vaccination rollouts".

Prof Koul was answering a question whether people can do away with masks and social distancing measures while the vaccination programmes have been launched in many countries.

"At this point, the vaccination is being prioritised. The final rollout is going to take a year and a half. It's after that we can think of doing away with masks and social distancing measures. But at this stage, it's not advisable."

The two-week refresher course for university and college teachers was inaugurated by Vice-Chancellor Prof Talat Ahmad, while Registrar Dr Nisar Ahmad Mir was a guest of honour on the occasion.

Prof Koul said the pandemic outlook of the Coronavirus is likely to get over with vaccination and the fact that herd immunity is going to step in.

"So people would be mostly nonsusceptible to the virus. But nonethe-

less, the virus is likely to stay because it has disseminated so widely across the globe that its complete eradication may not be possible. It may, however, stay in low-level endemic form, but the pandemic form is going to be taken care of by the vaccination and consequent stepping in of the herd immunity." Prof Koul said the existing vaccines against Coronavirus are believed to be effective against its new variant found in the UK."As of now, there's no data to suggest vaccines would not be effective. Currently, the knowledge is that the vaccine is effective against variant viruses as well. It is a different thing that any subsequent mutations might influence the virus efficacy. But that's not the case with the new UK variant,"





The Conservation Conundrum

As a writer who has frequently travelled to the hinterland to meet sorrowful villagers whose loved ones have been killed by wild animals, I find myself in the same dilemma as Jim Corbett, and so many other humanists. What should come first, man or animal?

his week, a Leopard was spotted in a residential area of Srinagar. The news about the magnificent beast roaming freely in Baghe Mehtaab area had scared people into the safety of their homes and had even raised an alarm in the adjoining areas. The leopard was finally caught by the wildlife department in an abandoned house, after it had jumped walls and been chased by people. This tussle between man and the wild is not new and certainly not restricted to Kashmir alone.

Recently, I toured villages in rural Maharashtra where a man-eating leopard killed a dozen human beings. The beast travelled hundreds of kilometres through five districts of the state over a period of months, devouring men, women and children along the way. I met the families of two such victims who were killed earlier this month. One was a nine-year-old girl, daughter of a farm labourer. The animal pounced on her in broad daylight as she played in a banana field, where her parents and other labourers were at work. She died instantly. The other victim was a 35-year-old woman, mother of three small children. The leopard killed her as she took their cattle for grazing atop a forested hillock where their house is situated. As sunset came, her distraught husband and in-laws who went in search of her found her severed head just a few meters away from their house. They were visited by local politicians and given a cheque of Rs 4 lakhs as compensation; a cheque that they still haven't encashed.

The leopard was finally shot dead by sharp-shooters in a leafy banana farm on the very day I was in the villages, leading conservationists to ask if shooting it, instead of tranquillizing it and capturing it alive, was indeed the right strategy.

Two years ago, a similar controversy had arisen in another part of Maharashtra, which made national headlines. The man-eater in this case was a tiger, India's national animal, to save which the Government of India has spent millions of rupees. Its killing by a 'trigger-happy' sharp-shooter from Hyderabad led to an ugly face-off between Maneka Gandhi, the then Minister of Environment and Forests in the Modi 1.0 government, and the state Minister of Environment and Forests who ordered the shooting; especially as the animal was a female named



Avni with two cubs. The case, to the best of my knowledge, is still in the courts.

Villagers, however, whom I personally met and interviewed for two newspapers, were relieved that the tiger was killed. They felt that city-based environmentalists and wild-life activists lived in ivory towers, and had no idea of the dangers they suffered when predator animals entered their villages and stalked them, making it impossible for them to get out of their houses after dark, even to answer nature's call. They vehemently refuted the view that it was they who had encroached on the animals' territory. Their villages had been there for decades, if not centuries, they pointed out.

Though the above incidents occurred in Maharashtra, man-animal conflict, as the media calls it, isn't restricted to any particular state. It exists throughout India, from Jammu & Kashmir in the north, to Karnataka, Kerala and Tamil Nadu in the south, wherever

villages lie in close proximity to forests.

Human beings are regularly killed by man-eating tigers in the Sunderbans in West Bengal and Bangladesh. The deceased are usually honey-gatherers who risk their lives sailing to islands in the delta to collect honey. But they have no option as this is their only source of livelihood. It is said that if a man in the

Sunderbans is unlucky enough to be killed by a tiger, his wife becomes a 'tiger widow' and is ostracized by the community. Hence, before setting out for the islands, the men pray to a goddess known as Bon Bibi to bring them back to their wives safe and sound. Unlike elsewhere in India, where orders are issued by forest officials to shoot maneating tigers and leopards, the man-eaters in the Sunderbans are so numerous that they cannot be eliminated. So the poor villagers learn to live with them.

The tradition to shoot man-eaters began in the Kumaon, now in the state of Uttarakhand, at the beginning of the 20th century with Jim Corbett, after whom India's largest national park, the Jim Corbett National Park, is named. Corbett was an Englishman who was born in Naini Tal and lived there till the time of Independence. Conservation was indeed a conundrum for him, save the lives of hapless villagers traumatized by man-eaters, and simultaneously protect the region's wildlife. He evocatively describes accounts of his brush with predator animals in his books, Man-Eaters of Kumaon, The Man-Eating Leopard of Rudraprayag, and many others.

In one case, a man-eater known as the Champawat tiger killed over 600 human beings in Nepal and North India before Jim Corbett shot it dead. Dane Huckelbridge recently wrote about the Champawat man-eater in his book No Beast So Fierce. In it, he explains the reasons for the tiger becoming a maneater in the first place: the loss of one of its canines as a hunter unsuccessfully tried to kill it.

As a writer who has frequently travelled to the hinterland to meet sorrowful villagers whose loved ones have been killed by wild animals (a thing unthinkable to those of us who comfortably live in cities), I find myself in the same dilemma as Jim Corbett, and so many other humanists. What should come first, man or animal?

I daresay that this is a question that merits no easy answer.

o misquote Shakespeare, our Brexit negotiating revels now are ended. The tempestuous talks did not lead to a dramatic walkout, even if at times the UK government gave the impression this was a feud worthy of the Montagues against the Capulets. The negotiators ignored the background noise and succeeded in drafting a dense legal document on which the future of UK-EU relations now hangs.

How the deal came together

The UK was adamant throughout the negotiations that it be treated as a sovereign equal of the EU and have its independence respected. This was particularly important when it came to fishing rights – one of the last issues to be resolved.

There were always two problems with this argument. Firstly, as explained by the Spanish foreign minister – a veteran trade negotiator – a trade agreement is designed to establish interdependence rather than being an exercise in asserting independence.

Secondly, the EU is simply a bigger beast economically speaking than the UK. This meant Brussels was confident it could weather the disruption of a no-deal separation better than the UK. By refusing to extend the transition period despite the pandemic, prime minister Boris Johnson ensured both parties faced the same time pressure. But they did not face the same level of risk if no agreement was reached. Hence the real ringmaster of the Brexit deal was Father Time, not Johnson or Angela Merkel, as UK newspapers often reported.

Nevertheless, it looks like the UK government will claim victory by arguing that it is now able to escape the jurisdiction of the European Court of Justice while getting tariff and quota-free access for goods exported to the EU. In a statement immediately following the announcement of the deal, the UK government did just that:

The deal ... guarantees that we are no longer in the lunar pull of the EU, we are not bound by EU rules, there is no role for the European Court of Justice and all of our key red lines about returning sovereignty have been achieved. It means that we will

have full political and economic independence on 1st January 2021.

The reality though – as with everything Brexitrelated since 2016 – is far more complex.

In the deal

Johnson's negotiator David Frost liked to argue that the UK just wanted a standard free-trade deal like that between Canada and the EU. In reality, the UK was asking for extras, such as mutual recognition of conformity assessment for goods and mutual recognition of professional qualifications. The EU does not appear to have budged on those.

Brussels was also adamant that the deal required legal guarantees to prevent the UK undercutting the single market by using its new regulatory autonomy to lower environmental standards or employment rights. Johnson agreed in principle to this level playing field idea in the political declaration that accompanied the 2019 withdrawal agreement he got through parliament. Then, later in negotiations, he tried to renege on this pledge. In the end he uturned again. The deal states that divergence from EU standards would lead to potentially restricted access to the single market.

In a press conference on the deal, Johnson reassured "fish fanatics" there would be plenty for their dinner plates, but the deal means that for the next five and a half years EU-based vessels will continue to enjoy significant access to British waters, during the transition to a final arrangement.

It's clear that free movement of people has ended, while goods will face customs and regulatory checks. Transport chaos around the port at Dover is therefore still a distinct possibility after January 1 if exporters fail to have the proper paperwork to cross the Channel. Given they have not done this

in a generation, there are bound to be difficulties. EU-based hauliers might also opt for caution and in the short–term avoid the risk of getting their lorries stuck in the UK. The UK will also leave the Erasmus higher education exchange programme, which will come as a blow to many students – although the UK now plans to launch its own "Turing" scheme to offer placements at universities around the world.

Much less clear is the future of the UK's key export industry: financial services. Outside the single

market, the City of London relies on the EU to grant permission to service EU-based clients and sell them banking, accounting, and associated legal products. This "equivalence" arrangement is reviewed on an ongoing basis, depending on the UK approach to financial regulation and data protection. That puts the sector on a much less firm footing than, say, manufacturing.

Selling the deal

The dance is over but now comes the hard sell. Credit claiming and blame avoidance will be the twin priorities for the UK government. Johnson is bound to play up the sovereignty angle by highlighting the ability to avoid the intrusion of EU law.

The blame game is where things are likely to get more interesting. This is because the deal requires a constant dialogue with the EU over things that can affect the terms of the agreement, such as government subsidies. This is the position Switzerland constantly finds itself in. The Brexit deal requires both sides to submit to a general review after four years to make sure both sides are meeting the requirements. Hard eurosceptic Conservative backbenchers, who pushed for a no deal, may see this as a concession too far.

What can Boris Johnson do to overcome internal opposition? His parliamentary majority is sufficient to overcome anything short of a major revolt. But his strongest card might be to simply shift the blame to his predecessor, Theresa May, for triggering Brexit without a plan. Meanwhile, Scotland's first minister Nicola Sturgeon tweeted immediately after the deal was announced that "no deal that will ever make up for what Brexit takes away from us. It's time to chart our own future as an independent, European nation." So, while one episode in this long drama may be drawing to a close, it seems that others, relating to the very future of the UK, are far from over.

In Freeze Frames Life Inside Lake

Away from the shoreline decorated with Mughal Gardens and a front lined with houseboats, the Dal Lake houses hundreds of families, most of whom make their living from fishing and farming. The arrival of the winter like always means an increase in the hardships for them.

N the arctic ambiance of Kashmir's iconic Dal Lake, fisherman Ghulam Hassan is fighting a 'cold war' these days.

He equates the ongoing winter with the classic cold — when the frozen waters of the lake would turn stony surface for some memorable expeditions, like the fabled jeep ride of the erstwhile Prime Minister of Jammu and Kashmir, Bakshi Ghulam Mohammad. While kings and their courtiers would gallop across its length and

breadth, children would play on the icy surface of the lake.

But that faded romance with the frozen waters apart, fiftyyear-old lake-man Hassan is currently fighting a battle with his

shivering nerves.
Winter, the tough time of the year, is even tougher in the lake.

"Not that we're complaining about it," Hassan standing near his abode says, "but life inside the lake is far from mesmerizing during winters"

Born in houseboat and brought up by fishing, Hassan has seen the lake evolution—from poet's musings to commoner's dirges—quite closely.

When landmasses started emerging as some votebank incentive

from the lake in his youthful days, his family also crawled out of their watery abode and built a house.

Many moons later, one fine day, the house would rise up in flames.

Many moons later, one fine day, the house would rise up in flames and bring "immense hardships" for his family.

Later the fisherman would rebuild a four-room single-storey house for his family with a bank loan.

But beyond this struggling story, Hassan's daily trysts with the frozen lake are tough and tolling.



Fishing in sub-zero temperature cannot be a vocation of the faint-hearted around this period. One has to wake-up before the break of the day, chart a course deep into the frozen lake and return late in the evening or spent the night out, in case there is not a sufficient catch in the nets — sufficient still being meager, since winter sees a reduction of fishes in the lake.

"This life is a gift by God, so we manage and live with what was handed down to us by fate," Hassan continues.

"Fishing in winter is an art, because you need to work under harsh climatic conditions. It doesn't fulfill our needs but we manage and take this work as worship."



Fishing in winter can cause severe health implications, like chilblains, raptures, and frostbites. Hassan himself suffers from rheumatoid arthritis, a disease that always worsens in winter.



"The body petrifies like a statue," Hassan describes the frozen time in the lake. $\,$

"Any sort of work is very hard in the winter. I feel fatigued, my hands start to shiver and body gets jitters, yet nevertheless, I'm always successful in dealing with it. The thought of hunger pushes me to work. I would do any other work in winter if there was the availability of it. but alas!"



Hassan's views are reflected by his water-borne community.

His next-door neighbour, Ali Mohammad Dar, a 65-year-old fisherman, comments upon the winter with a shiver. "What do you know about winter, kid!" he smiles, as wrinkles trace across his forehead.

"These hands are the witness of some of the harshest winters in the valley. When I used to do fishing, I had to cross the iced lake. Before casting net, I would break the white sheet of ice covering the surface of the lake. Now fishing and bearing the cold has become a habit for us. We bear the cold water, the snow, rain and the changes of atmosphere because we see it every coming winter. Hurdles make you strong, so does the winter. We have learned to live in such hard conditions."



To display the cruelty of the lake, Dar puts out his rough and chapped hands that hold a firepot and says, "This Kanger and Phiran have been my sole friends in this journey. The blazing embers in Kanger are the witness of this weather, too. Fishing in winter is not an easy job."



For the lake women, the trails of the daily life are no less. From doing the dishes and washing the clothes with cold water of the lake, to peddle the catch of fishes in the city marketplaces and countryside towns, their life is riddled with hardships.



Active participation ensures a great deal of woman emancipation inside the lake, as well as spares the men from two-fold hardship.

"It has forever been so," Hassan continues. "Men catch the fish,



The community reserves the rainy and snowy days to knit the throwing nets.

A crafty hand would take around nine months to weave a throwing net, called 'Gurun-Zaal' or 'Nuk-Patte Zaal' in Kashmiri.

The weight of the net can be approximately of 9 kilograms due to the metal 'naag' stitched on the bottom which helps catch the little fish.



With changing times, the lake has also witnessed a shift. The millennial is reluctant to follow in the footsteps of their forefathers.

Most of them think that their ancestral vocation is not their line of

living owing to hardships and lack of returns in it.
"My children are not willing to continue the family work," Hassan

says. "They'd rather hawk clothes or do some other stuff than bear the trouble of doing the fishing in the lake."



Apart from fishing, farming also takes a backseat in winters. Even as the floating vegetable market runs without any hiccups, the vegetable gardening is totally excused through the frosty season.

Tourism, as another alternate source to supplement the income, is unreliable, because it's always the first and foremost calamity of the wavering political weather of Kashmir.



In preparation of the winter, these lake dwellers dehydrate vegetables, because that way the eatables last longer during the cold season.

The lake-men also collect logs and branches and burn them to have charcoal to fuel their Kangers during winter.

Because the erratic power-cuts are a norm, the candles, kerosene lanterns and other forms of traditional sources of light are put in use.



The updates about the weather are heard keenly by the old from the young, who regularly check the tweets from Meteorological Department of Jammu and Kashmir, and then, when the snow comes, the men climb the roofs of their houseboats with spades in their hands and clear the rooftops.

"We sometimes need to wake up at 3 in the morning to clear rooftops of our houseboats, so that the weight of the snow won't capsize it," Mohammad Shaban Zargar, a houseboat owner in his eighties, comments

"Every year we maintain our boats. If a boat wrecks, it's a huge loss to the family and the owner."



While elders remain on their toes, the children of the lake relish the winter for more reasons.

The snowball tournaments take place in-between the different groups formed at the whim of a coin-toss. The season of tales also begins, where the heroes from the fables and folklore revisit the lake yet again.

Cricket is another recreational activity which unlike summer



But despite the current cold proving to be the classic winter in Kashmir, Abdul Gafar Tuman, a sexagenarian shikarawala, says the lake has seen the worst.

"In my childhood," Tuman says, "icicles would hang on the rooftop of our houseboat and we would always be eager to eat them. We used to sing Kashmiri hymns like 'Sheena paito paito, mama yeto yeto' [Come, oh snow, come! Be a dear, and come]. And when snow would fall, we would have snowball fights on the lake that'd be frozen like the brass. That eagerness and enthusiasm has forever gone now."

One-Way Traffic ...
We resumed one-way traffic on the national highway, the only all weather road connecting Kashmir valley with the rest of the country, a traffic police official said.

He said traffic could not be restored on the Mughal road, connecting Shopian in south Kashmir with Rajouri and Poonch in Jammu region due to accumulation of snow and slippery conditions for the past over three weeks. (Agencies)

In the video that has gone viral on social media, Ahmad is seen breaking down in tears and make fervent appeals to the government. He also says in the video that he will visit the PCR to seek his son's body and will kill himself if denied

"I want justice and if I was denied my dead son's body, I will end my life," he says in the video shot at the family's ancestral graveyard in Bellow village of Pulwama.

Ahmad also alleged that he was denied last glimpse of his son by the authorities by shifting the body to Sonmarg.

The killing of Athar and two other youth Ajaz Maqbool Ganaie of Pulwama and Zubair Ahmed Lone of Shopian has created a political storm after the mainstream political parties demanded a time bound probe into the circumstances leading to the encounter. The demand for probe gained momentum after the families vouched for the innocence of the youth and accused the state forces of killing them in a fake encounter, a charge strongly contested by police.

Police have been maintaining that all the three were militants, two of them hardcore OGWs, and planning a major strike on the forces along the Srinagar-Baramulla highway. (With KNT inputs)

Ubiquitous tension on borders besides affecting the economic activities also causes mental trepidation to the elderly and children," they added.

They impressed upon the administration to provide immediate relief to the people whose dwellings have incurred heavy damages due to the incessant cross border shelling. "The damage to the property and livestock of the local should be assessed without delay and compensated instantaneously," they added.

Exports fall 0.8% in December, trade deficit widens to \$15.71 bn

Exports contract for the third straight month to \$26.89 billion

Contracting for the third straight month, India's exports slipped marginally by 0.8 per cent to \$26.89 billion in December 2020, due to decline in sectors like petroleum, leather and marine products, as per the government data.

The trade deficit in December widened to \$15.71 billion, as imports grew by 7.6 per cent to \$42.6 billion, according to the preliminary data released by the commerce ministry on Saturday. Exports in December 2019 were \$27.11 billion, while imports stood at \$39.5 billion. In November 2020, exports were down by 8.74 per cent.

In April-December 2020-21, the country's merchandise exports contracted by 15.8 per cent to \$200.55 billion, as compared to \$238.27 billion in the same period last fiscal.

Imports during the nine months of the current fiscal declined by 29.08 per cent to rice (8.60 per cent), meat, dairy and poultry \$258.29 billion, as against \$364.18 billion in April-December 2019-20.

"India is thus a net importer in December engineering goods (0.12 per cent). Sectors 2020, with a trade deficit of \$15.71 billion, as compared to a trade deficit of \$12.49 billion, widened by 25.78 per cent," the ministry said

In December 2020, oil imports declined by 10.37 per cent to \$9.61 billion. During April-December this fiscal, the imports dipped by 44.46 per cent to \$53.71 billion, it added.

Major commodities of export which have recorded positive growth during the month under review include Oil meals (192.60 per cent), Iron ore (69.26 per cent), Carpet (21.12 per cent), pharmaceuticals (17.44 per cent), spices (17.06 per cent), electronic goods (16.44 per cent), fruits and vegetables (12.82 per cent), and chemicals (10.73 per cent).

The other commodities in the positive terrain include cotton yarn/fabrics/madeups, handloom products (10.09 per cent), products (6.79 per cent), gems and jewellery (6.75 per cent), tea (4.47 per cent), and coke and briquettes.

that registered negative growth include petroleum products (-40.47 per cent), oil Seeds (-31.80 per cent), leather and leather manufactures (-17.74 per cent), coffee (-16.39 per cent), ready-made garments of all textiles (-15.07 per cent), man-made yarn/fabrics/made-ups (-14.61 per cent), marine products -14.27 per cent), cashew (-12.04 per cent), plastic and linoleum (-7.43 per cent), and tobacco (-4.95 per cent).

Aviation deaths rise worldwide in 2020 even as fatal incidents, flights fall

WASHINGTON: The number of people killed in large commercial airplane crashes rose in 2020 to 299 worldwide, even as the number of crashes fell by more than 50 per cent, a Dutch consulting firm said on

Aviation consulting firm To70 said in 2020 there were 40 accidents involving large commercial passenger planes, five of which were fatal, resulting in 299 fatalities. In 2019 there were 86 accidents, eight of which were fatal, resulting in 257 fatalities.

Large commercial airplanes had 0.27 fatal accidents per million flights in 2020, To70 said, or one fatal crash every 3.7 million flights -- up from 0.18 fatal accidents per million

flights in 2019. The decline in crashes came amid a sharp decline in flights due to the coronavirus pandemic. Flightradar24 reported commercial flights it tracked worldwide in 2020 fell 42 per cent to 24.4 million.

More than half of all deaths in the To70 review were the 176 people killed in January 2020 when a Ukrainian plane

was shot down in Iranian airspace.

The second deadliest incident was the May crash of a Pakistan airliner crashed in May killing 98.

Large passenger airplanes covered by the statistics are used by nearly all travellers on airlines but exclude small commuter airplanes in service.

"Over the last two decades, aviation deaths have been falling dramatically. As recently as 2005, there were 1,015 deaths aboard commercial passenger flights worldwide," the Aviation Safety Network (ASN) said.

Over the last five years, there had been an average of 14 fatal accidents for commercial passenger and cargo planes resulting in 345 deaths annually, ASN added.

In 2017, aviation had its safest year on record worldwide with only two fatal accidents involving regional turboprops that resulted in 13 deaths and no fatal crashes of passenger

The United States has not had a fatal U.S. passenger airline crash since February 2009 and one fatality due to a US passenger airline accident in

Ten more arrested over attack on Hindu temple in northwest **Pakistan**

PESHAWAR: Pakistani police have arrested 10 more people in overnight raids for their alleged involvement in the vandalisation of a Hindu temple by a mob led by members of a radical Islamist party in Khyber Pakhtunkhwa province.

With the latest arrests, the number of accused arrested in the case has risen to 55. Over 350 people have been named in the FIR after the temple in Terri village in Khyber Pakhtunkhwa's Karak district was vandalised and set on fire on Wednesday by a mob protesting against its expansion work.

Search is underway to nab the others accused named in the FIR.

The temple which also had a samadhi of a Hindu religious leader was attacked by the mob after members of the Hindu community received permission from local authorities to renovate its decadesold building.

The mob, led by some local clerics and supporters of Jamiat Ulema-e-Islam party (Fazal ur Rehman group), demolished the newly constructed work alongside the old structure.

The attack on the temple drew strong condemnation from human rights activists and the minority Hindu community leaders.

India has also lodged a protest with Pakistan over the vandalisation of the temple and sought strict action against those responsible for the incident.

No Bar On Granting Anticipatory Bail For Offence Under 2019 Triple Talaq Law: SC

NEW DELHI: The Supreme Court "triple talaq" upon his wife can be has said there is no bar on granting anticipatory bail for an offence committed under the Muslim Women (Protection of Rights on Marriage) Act 2019, which makes the practice of instant divorce through "triple talaq" among Muslims a punishable offence, provided the court hears the complainant woman before granting pre-arrest bail.

The top court noted that under the provisions of the Act, a Muslim husband who pronounces

sentenced to a jail term that may extend to three years.

The top court said the prohibition in the 2019 law is evidently one "which operates in relation to a Muslim husband alone". A bench headed by Justice DY Chandrachud referred to the relevant sections of the Act and also the provision of the Code of Criminal Procedure (CrPC), which relates to directions for the grant of bail to a person ap-

"For the above reasons, we have come to the conclusion that on a true and harmonious construction of section 438 of the CrPC and section 7(c) of the Act, there is no bar on granting anticipatory bail for an offence committed under the Act, provided that the competent court must hear the married Muslim woman, who has made the complaint, before granting the anticipatory bail," the bench, also comprising justices Indu Malhotra + and Indira Banerjee, said. —PTI

Iran Guards Vow "Decisive" Response To "Any Action" Amid US Tensions

"We are here today to evaluate and be assured of our powerful capabilities at sea and against enemies who sometimes boast... and threaten," Hossein Salami said.

TEHRAN: Iran's Revolutionary Guards chief Hossein Salami vowed Saturday to respond to any "action the enemy takes," in a visit to a strategic Gulf island, amid rising tensions with the US.

Salami was speaking on the eve of the first anniversary of the US killing of top Iranian military commander Qasem Soleimani in a Baghdad drone strike on January 3, 2020.

KARACHI: Pakistan cricket team's current pacers are 9 to 10 years older than what their birth certificates suggest, former seamer Mohammad Asif alleged, while also hitting out at their "inability" to bowl long spells.

Asif's remarks came in the wake of Pakistan's 101-run defeat against New Zealand in the first Test in Mount Maunganui this week.

"They are so aged. It is written as 17-18 years on paper, but they are actually 27-28 years old," Asif said on his compatriot Kamran Akmal's YouTube channel but did not take any names. "They don't have the flexibility to bowl 20-25 overs. They don't know how to bend the body and they become stiff after a while. They are not able to stand on the field after bowling a 5-6 over spell," he added.

One of the finest seamers of his time, Asif's career in competitive cricket came to an end after he was banned by the ICC for five years for indulging in the 2010 spot-fixing scandal in England.

His days as Pakistan cricketer long gone, Asif is disappointed by the present crop of fast bowlers in the national team, which was once dominated by at Christchurch from Sunday.

legends such as Wasim Akram, Waqar Younis and Imran Khan.

'I feel it might have been 5-6 years since a fast bowler took 10 wickets in a match. We used to salivate after seeing the pitches like the ones in New Zealand. There was no question of leaving the ball as a fast bowler. I never used to leave the ball before taking a five-wicket haul.'

The 38-year-old, who had formed a potent pairing with speed merchant Shoaib Akhtar during his time in top-flight, added that today's pacers lack the knowledge to test the batsmen. "These kids do not have the knowledge. They don't know how to keep the batsmen on the front foot, not give them a single and how to bowl on the wickets. When they try to bowl on the wickets, it goes down the legside. They do not have the control," Asif said.

Among the current lot of Pakistan pacers doing duty in New Zealand, Shaheen Afridi and Naseem Shah are 20 and 17-year-old respectively. Mohammad Abbas is 30 and Faheem Ashraf is 26.

Sourav Ganguly Stable After Cardiac Arrest

KOLKATA: BCCI President and former India cricket captain, Sourav Ganguly was hospitalized on Saturday after he complained of chest pain. His condition is said to be stable after undergoing angioplasty at the Woodlands Hospital in Kolkata. Ganguly, 48, had complained of

chest pain following a workout session on Friday evening and family members took him to the hospital Saturday afternoon when the problem recurred. "Sourav Ganguly has undergone

angioplasty. He is stable and completely conscious now. He will be monitored for the next 24 hours, hospital sources told reporters.

A team of five doctors has been constituted to supervise his treatment, hospital sources said.

West Bengal Chief Minister Mamata Banerjee expressed concern over Ganguly's hospitalisation.

"Sad to hear that Sourav Ganguly suffered a mild cardiac arrest and has been admitted to hospital. Wishing him a speedy and full recovery. My thoughts and prayers are with him and his family," Banerjee tweeted.

The former Indian captain Ganguly, was officially entrusted with the task of heading Indian cricket Board in October 2019 at + the BCCI's General Body meeting in Mumbai. His appointment ended the controversial 33-month reign of the Supreme Court-appointed Committee of Administrators (CoA).

Sourav Ganguly became BCCI's 39th President succeeding C K Khanna, who was the interim head of the Board since 2017.

though I was myself a working lady there in Kashmir," she recalls, with a little laugh and sparkle in her eyes. "But, it was my daughter, for whom I came here, to give her a feel of home out-

side home. She studied here, so she was meant to work here only, so I just couldn't have left her alone."

The transition wasn't hard.

Kamili's work experience in Kashmir helped her in settling down in Delhi with ease, though she found a big difference in two faraway capitals' way of working.

"Here in Delhi, you can put up your outlet till late at night, which is something not possible in Kashmir," she says.

"Also, there's no load-shedding here in Delhi-NCR while we've to wait for electricity in the valley for around 6 hours each day. You can also count the transportations and mobility problem. Here we can have taxis and metro, but in Kashmir, the public transport services are in a miserable condition.

Kamili says she believes in perfection, and tries to perfect every little thing in her

nam," Kamili, who considers her Kashmiri Kitchen as her third child, continues.

"So you can get an idea now that how and why Kashmiri cuisine was selected to be served at an event taking place in the extreme south of the country, that too from Kashmiri Kitchen, which was just 6 years old in 2016. This achievement is all because of my emphasis on quality and perfection."

But before coming of catering age, Kamili had to do a lot of adjustments in Delhi. She remembers how she had to get a chicken substitute for every mutton dish out there in her restaurant.

"Here, most of the people don't eat mutton, because of different reasons such as diet, taste and personal beliefs," she

says.
"As a result of this, I've to prepare Chicken Yakhini and Chicken Rogan Josh. Also, people here are more health-conscious, so their taste varies as compared to Kashmiris.'

Kamili must have been ideal for many, the reason being her story is also connected to the political turmoil in her home-

Higher education, better living conditions, and a variety of appropriate employment opportunities were some of my reasons for sending my daughter here," "Had the environment remained peace-

ful in the valley, I would never have sent my daughter to study outside." Meanwhile, the tea arrives along with

the snacks, and the rest of the talk continues from here. Kamili's daughter, Pearl, also joined us by this time. Pearl introduced me to a number of

awards and certificates, the restaurant has earned over a period of 10 years. "Kashmiri Kitchen has been the recipi-

ent of multiple awards including the 'Hin-

dustan Times Crystal Awards 2012' and 'Times City Awards 2014'. We were also recommended by Condé Nast Traveller as 'Delhi's 50 best meals' in 2015," Pearl says, while showing me the paper-cuttings of various newspapers and magazines speaking of the restaurant's high prestige and grandiose.

"We have been associated with leading hotels like The Oberoi, Radisson, Hotel Surya, Le Meridian, and Fortune Group of Hotels for Kashmiri food festivals and catering. We have also partnered some leading caterers like Colonel Kebabz, Divas Catering, and F&B Caterers to name a few."

Coming back to her business, Kamili appears to be optimistic regarding the reopening of her outlet, post-Covid, or once the vaccination is done all across the capital.

"Lockdown made us suffer, mainly in terms of financial stability," she says."We had to close the restaurant, and in June, I went to Kashmir for around four months. There was an unlock process also, but we never made any plan to reopen the restaurant, as we don't want to take any risk."

Most of her customers, Kamili says, are locals from the NCR, though some Kashmiris come especially from the valley, to eat at Kashmiri Kitchen.

"We've received a lot of love from both local and Kashmiris, be it the Pandits or the Muslims," she says.

There was a reason, Pearl says, for opening a restaurant in NCR and not in Muslim localities of Delhi, where most of the Kashmiris are concentrated.

"We wanted to popularize the Kashmiri cuisine here among the locals, just like Chinese and other cuisines," she says."We had a much larger target group in our minds. We want the world to relish the rich Kashmiri flavors, not just the resident Kashmiris who are already familiar with the cuisine.'

In any case, the mother-daughter duo never wanted to establish themselves as a seasonal restaurant for winters, when most of the Kashmiris migrate from the

"Our quality is superior over any other Kashmiri restaurant, and that is the reason

behind our success," Kamili says.
