

## **Kashmiri Bird Watcher's Rare Avian Sightings Giving Wings to Passion**

s the first Kashmiri snapper to discover White Breasted Water-Hen, Steppe Gull, Rufous Napped Niltawa with photographic evidences, Ansar Ahmad, 28, from Nishat Srinagar, has a poetic introduction about himself: "Mountains are my home, birds are my family and photography is a bond between me and my family.

Three years ago, when a sudden

ruffling of leaves occurred outside his window, a bird watcher took an abrupt birth in Ansar.

That day, he recalls, he tirelessly waited for an avian guest behind the ruffling of leaves. It took him some time to spot a bird eating an apple.



He grabbed his camera, zoomed the bird and pulled his photo of a rose-ringed

parakeet. Next time, as an eager bird-watcher, he was sitting on Srinagar's Foreshore area—in an apparent dubious manner behind the bushes.

He was quietly picturing a whitebreasted water hen paddling its way in the serpentine water body.

"I was very excited and called my friend Riyaz," Ansar recalls. "He immediately responded in

# Teachers having to work harder than any other professionals, says study

eachers are working harder than ever before and more than any other occupation, according to a study published in the peer-reviewed journal Oxford Review of Education authored by researchers from UCL. The proportion who say their job demands a very high level of input is nine in ten which represents an increase of two-thirds (90% vs 54%) over 25 years, according to the findings taken in 2017 and based on more than 800 teachers in British schools. This compares with just 44% of people in all other occupations who agree they have to work very hard. Only health and social services managers and legal professionals come close to the levels of work intensity faced by teachers.

The data reveals for the first time how this drop in job quality goes beyond just pay and hours. Training, the influence teachers have over their tasks and work-related wellbeing have also declined.

An increasing percentage of teachers say they often or always come home from work exhausted (72% in 1997 vs 85% in 2017) which again is higher than any other professional over the same period (44% vs 45%)

The study author Professor Francis Green from the UCL Institute of Education says the findings suggest a link between declining work well-being and decreased job quality, independent of the long hours teachers work. He says reforms are needed to address the issue which is a possible factor in declining teacher retention rates.

"The most striking aspect of job quality is teachers' high work intensity and intensification,"

"Compared with other professionals and all other occupations, teachers work more intensively and this has risen to unprecedented levels. "Any improvement in teachers' iob quality achieved in a post-COVID-19 environment should be beneficial. Not only for teachers, but also for schools and the pupils who depend so much on the quality of teaching.'



Job quality is defined as how people's needs are met by work. Studies to date have focused on pay and hours, but Professor Green analysed work intensity, as well as other additional factors such as the control staff, have over their work and train-

His research was based on Skills and Employment Survey (SES) series data from 1992 to 2017. The SES collects information on what people including school teachers do at work, the skills they use and how

they work in Britain.

A total of 857 teachers aged 20 to 60 and working in nursery, primary, secondary and special schools were asked about job quality and overall work satisfaction. The majority were female (72%) and living in

England (86%) with a minority in the private sector (13%).

Funded by the Economic and Social Research Council. the study not only found teachers are having to work extremely hard physically and mentally, but also increasingly at very high speed (16% in 1992 vs 58% in 2017). Overall, those in Scotland reported the lowest work intensity anywhere in Britain. Private school teachers also said their job demands are lower but were more likely to say training quality was poorer.

In addition to work intensity, key findings that illustrate job quality has decreased for teachers include: -The proportion of teachers with a great deal of influence over how they perform tasks fell from just under half (48%) in 2012 to less than a third (31%) in 2017. Those wanting more control over how they did their job rose from 15% to nearly a

quarter (24%). -High work strain increased from virtually no reports in 1992 to more than a quarter saying this was an issue (27%) in 2017. Teachers had

double (16% vs 9%) the likelihood of other professionals of experiencing this type of stress.

 A high level of involvement in decision-making fell markedly (45% in 2012 vs 10% in 2017).

- Participation in training reduced (92% in 2006 vs 86% in 2017), as did the quality with less than a third (31% in 2017) agreeing their skills improved significantly compared with two in five (41% in 2006).

 In contrast, teachers reported greater satisfaction levels than other professionals about their promotion chances which have increased notably, and for job security which has remained high.

Other positives include the fact job quality has not declined in terms of hours worked, nor has real pay declined over the long-term, apart from between 2006 and 2017. However, the study offers no direct evidence to explain why job quality has declined for teachers. Another limitation is the SES data does not include physical working conditions or social support.

Whereas, this office has already issued a public notice vide vehicle No. TC/JK/MV/2019/3968-70 dated 09-07-2019 whereby the owners of Motor Transport Service License holders were advised to get their license renewed, failing which their license will be cancelled:

Now, therefore, the owners of Motor Transport Service License holders who have failed to get their license renewed are once again advised through medium of this notice, to get their licenses renewed, failing which their licenses will be cancelled. Please note that apart from Cancellation of license, the owner shall be blacklisted and debarred from all activities which are related to the Goods or Passenger Transport in J&K State. Further, any other license standing on the name of the owner shall also be processed for cancellation.

## US DIPLOMATS HOLD SECRET TALKS WITH APHC Nusrat Javeed

**NEW DELHI-** US diplomats were holding secret talks with the All Parties Hurriyat Conference (APHC) in this charged and security-ridden Indian capital as the Vajpayee government deliberated whether to extend the "unilateral ceasefire" beyond January 26.

Quoting what it said was a very reliable source, The News report said at least one, or maybe more, diplomats working for the US mission here, was wrong overtime, even on Sun-day. The lady diplomat reportedly held a lengthy meeting with two APHC activists, who maintain regular contacts with New Delhi-based diplomats. As this back-door diplomacy continued, the all-important Cabinet Committee on Security (CCS) met to decide whether the army and other security agencies in Kashmir should continue with the policy of "non-initiation of fire."

Projected as the "unilateral cease-fire," this policy was hailed all over the world, showing to the "international community" as if New' Delhi was seriously looking for a lasting solution of the Kashmir problem. It also spread the impression that at tile peak of his political career, which was mostly spent in pursuing the Hindu extremist causes, Vajpayee wanted to get out of the historic prejudices and rigid constructs, developed during 50 years of acrimony between Pakistan and India. The Indian prime minister strengthened the impression through his "musings" on the New Year eve.

But Vajpayee has opponents in his own party and the government, although many in' New Delhi seriously believe that Vajpayee and Advani have played "good cop-bad cop" by design. Jaswant Singh has also conveyed it to the prime minister's office that permitting the APHC delegation to Pakistan would eventually lead to "tripartite talks" on Kashmir, a possibility the foreign office mandarins of South Block, vehemently resent.

Many Indian journalists, regularly writing on external affairs, have also begun high-lighting and supporting the

South Block's reservations to APHC delegation going to Pakistan. In the latest issue of prestigious "India Today," Tavleen Singh author of a well-received book on the Kashmir entangle, had written a very strong column about it.

He called on Americans to "mask up" for the next 100 days, saying that doing so could save more than 50,000 lives. Biden's tone was notably sober, con-



## President Biden Removed Trump's 'Diet Coke' Button In Oval Office: Report

WASHINGTON: It appears that US President Joe Biden has removed the "Diet Coke" button installed on the presidential desk by his predecessor Donald Trump, who was devoted to the soda drink.



The device installed at the Resolute Desk wasn't visible in photos of Biden captured Thursday at the White House.

Biden's Oval Office features framed photos of the family behind the Resolute Desk, beside a bust of Cesar Chavez, a Latin American workers rights activist, according to NZ Herald

"President Biden has removed the Diet Coke button. When @ShippersUnbound (Tim Shipman) and I interviewed Donald Trump in 2019, we became fascinated by what the little red button did. Eventually, Trump pressed it, and a butler swiftly brought in a Diet Coke on a silver platter. It's gone now," tweeted journalist Tom Newton Dunn. The Hill reported that Trump, a soda devotee, reportedly had the button put in place on the Resolute Desk in order to "keep the carbonated beverages flowing". When pressed, a staffer would be summoned to provide the drink to the thirsty commander in chief. Trump would regularly consume 12 cans of Diet Coke a day, as per media reports. Ex-White House aide Chris Sims wrote in his 2019 book "Team of Vipers" that Trump would also use the red button as a way of pranking visitors by suggesting it could trigger nuclear capabilities, cited by The Hill.

"Out of nowhere, he'd suddenly press the button," Sims wrote of the former president.

He added, "Not sure what to do, guests would look at one another with raised eyebrows. Moments later, a steward would enter the room carrying a glass filled with Diet Coke on a silver platter, and Trump would burst out laughing."

Even though Biden may have gotten rid of the soft drink buzzer, he, according to reports, also has "a similar taste in beverages".

## Fauci says feels liberated to speak on science under Biden In his first White House briefing as President Joe Biden's top advisor on Covid-19, Anthony Fauci

said it was "liberating" that he could focus on science without fear of repercussion now that Donald Trump had left office.

The top infectious disease scientist was briefing reporters Thursday on the state of the US outbreak that has claimed more than 408,000 lives. Asked to compare his experience under the previous administration to the new one, the 80-year-old responded a little coyly at first, saying he wasn't sure he could "extrapolate" based on first impressions.

"But one of the things that was very clear as recently as about 15 minutes ago, when I was with the president, is that one of the things that we're going to do is to be completely transparent, open and honest. "If things go wrong, not point fingers but to correct them and to make everything we do be based on science and evidence.

## Canada Governor General Resigns Over Workplace Harassment Report ottawa, Canada: Governor General Julie Payette, Queen Elizabeth II's representative in Canada,

resigned Thursday ahead of the release of a reportedly scathing report on workplace harassment claims levelled against her office.

The independent review had been ordered by the government last July when allegations of a "toxic" climate at Rideau Hall -- the official residence of the governor general -- first surfaced. Canadian media, citing unnamed sources briefed on its contents, said the review's conclusions were damning. "In respect for the integrity of my viceregal office and for the good of our country and of our democratic institutions, I have come to the conclusion that a new governor general should be appointed," Payette said in a statement.

## 6Food Crises In Srinagar **ANC Leader Seeks LG's Intervention**

SRINAGAR: Awami National Conference Senior Vice President Muzzafar Shah has sought intervention of Lieutenant Governor Manoj Sinha to resolve food crises in Srinagar.

"The Director Food and Supplies should come clean and state the correct position in front of the people of Srinagar City whether they are supposed to get five kg rice per person or 3.5 kg's per person. Why are the residents of Srinagar city being informed publicly of the Government's decision to provide rice at 5kg's per person whereas the DC food has instructed the Store keepers and the ST Shop owners to provide only 3.5 kg's rice per person against their ration card?" He said that a delegation of residents of downtown and ST Owners met him at ANC party headquarters today.

He appealed to the LG Manoj Sinha that he should intervene in this very sensitive and serious issue confronting the people of Srinagar city during the harsh winter conditions with 1.5 lakh people without Aadhar Card in Srinagar city alone, a prerequisite for distribution of Rice. ## Bandipora Duo Held For Murder of ATM Guard in Jammu

JAMMU: A day after the 'murder' of an ATM guard in Nanak Nagar area of Jammu, locals today staged a protest and blocked the road seeking justice for the family.

Pertinently, the ATM guard identified as Raju Sharma, son of Gullu Ram, a resident of New Plot area of Jammu, was found dead inside the guard chamber of the bank ATM at Sector 13 in Nanak Nagar

on Thursday late evening. Locals had found his body in a pool of blood while police formally registered a murder case against unknown persons. On Friday morning, family members, relatives and locals from the native area of the victim, blocked the road in New Plot area of Jammu. They demanded thorough investigation into the murder, financial assistance to the poor family and a job in the bank for one of the family members.

"The victim was the sole bread earner and lone brother among seven sisters. This is a tragedy for the family and they deserve justice," said a protester Ram Kumar adding that besides feeding his seven sisters, the victim had two little children and a spouse. Civil and police official rushed to the spot informing them that those responsible for the murder have been arrested. Later SSP Jammu Sridhar Patil addressed a press conference divulging information about the said murder. He said that police have rounded up two youth from Bandipora north Kashmir for the murder. "The duo had gone to the ATM with the intention to loot cash, but faced stiff resistance from the ATM Guard. They assaulted him, chocked him with a blanket inside rest room of the ATM," he said and identified the accused as Muhammad Kaif Lone and Waqas Bashir Lone.

He said both the accused had been living in Nanak Nagar area in a rented house.

The SSP said that further investigation was underway. (KNT)

With the NC and the PDP still together, the alliance can be a force to reckon with and certain to be a major player in the government formation in future" hen the People's Alliance for Gupkar Declaration was formed in April last year, few people in Kashmir expected it to last. But no one expected it to fall apart so soon. With the exit of the People's Conference, the alliance has been left reeling and if nothing is done to give it a fresh sense of purpose, the remaining constituents may too go their separate ways.

The reason for the PC chief Sajad Gani Lone to leave the PAGD is the fielding of proxy candidates against one another by the constituent parties in the recent District Development Council polls. Lone has termed it "a breach of trust" and rightly so. After the PAGD nominated candidates to contest the DDC election, the constituent parties also fielded their own candidates. So, the PAGD candidates not only had to contend with the candidates from the BJP and the parties like Apni Party but also with the candidates from the PAGD constituents. This resulted in the defeat of many of them. The independent candidates, many of them from the PAGD constituents, ended up winning a whopping 49 seats. If there were no independents running on behalf of the PAGD parties, the grouping's tally would be far higher than the 110 seats it garnered. And this, in turn, would have established more forcefully the demand for the restoration of J&K autonomy, the raison d'etre of the PAGD.

But why was this not done? The answer to this question is not far to seek. In the new grassroots governance scheme at the district level, a DDC chairperson or a DDC member will wield a huge political clout. They will be more or less exclusively charged with the development of the district. The DDCs have almost become mini-assemblies. As a result, a DDC chairperson and the members will be in a position to build a vaunted support base for their respective parties. This is where the conflict arises among the parties. More so, when the parties would not only want to preserve their traditional support base but also expand it. So, while politically, the parties may have a common cause and seek to fight an election jointly, the arrangement works against their respective electoral interests. The National Conference thus wouldn't want to dilute its standing as the dominant political party, so wouldn't the PDP, now the second major political outfit. And the People's Conference, being still a marginal political player would want to outgrow its Kupwara confines which as a part of the PAGD it couldn't hope to do.

Could the parties have resolved these contradictions



Progressive Alliance. There have been alliances in the states too. Mahagathbandan defeated the BJP in 2015 Bihar Assembly polls and came close to repeating the feat again in the last election, this time without the JDU of Nitish Kumar. This, despite the fact that these coalitions have been primarily about the pursuit of power. But when the PAGD was formed it had a larger cause, one that also had a moral resonance. And the alliance too had stressed this point saying there can be, "nothing about us, without us".

"We want to assure the people that all our political activities will be subservient to the sacred goal of reverting to the status of J-K as it existed on 4th August 2019," the Gupkar Declaration issued in August had stated adding that the constituents would be "bound, wholly, by the contents of the Gupkar Declaration and will unwaveringly adhere to it".

But less than six months on, the PAGD seems about to come loose. It may still be a group of five parties, two of them the NC and the PDP, but the PC's exit seems to have taken the sting out of the alliance. It suddenly appears vulnerable and shorn of its promise. And all this over an apparent conflict that could have easily been resolved had the leaders deemed it worth their while to sit together and talk. But this apparently was not done, nor sought by the parties. Why? There is no easy answer. It looks intriguing why exiting the alliance should have been the first option for the PC unless the party had been despaired of the redressal.

As for the future, it will be interesting to see how the remaining parties in the PAGD will conduct themselves. With the NC and the PDP still together, the alliance can be a force to reckon with and certain to be a major player in the government formation in future. As for pressing the demand for restoration of Article 370, all that the parties seem capable of doing as of now is to stick together. There has been no attempt to even symbolically register displeasure about what was done to J&K. And for obvious reasons. Centre has disproportionately raised costs for any show of even a symbolic defiance and this includes forming an alliance too. It remains to be seen how the remaining parties in the PAGD will respond to the costs of staying together.

## Will Biden "Make American Great" Again?

Biden needs a grand strategy to clean up Trump's mess and restore America's leadership in the world.

he way forward for the new Biden administration cannot be the way back. Harking back to the Obama era and stacking his administration with "Obamians" will not suffice to restore America's credibility and leadership. As president of the United States, Joe Biden has to look further, aim higher, and act bigger.

It is important for Biden to reverse much of Donald Trump's policies, but that will not erase his legacy or undo the damage to America's soul. Certainly not when the bitter and vengeful former president and his allies continue to lurk around in the shadows.

Trump's authoritarian attempts to restore white supremacy have thankfully failed miserably, mainly because America has moved on. But he did succeed in causing so much damage to the fabric of American society and democracy that it will take years to clean up.

That is why Biden will have to tread carefully, addressing the social and economic grievances of the Republican base without alienating his own Democratic base.

Democrats have long run and won elections on the promise of cleaning up a Republican mess.

From Franklin D Roosevelt's (FDR) 1933 victory amid the Great Depression and John F Kennedy's 1961 ascendance following the late 1950s economic recession, to Barack Obama's historic triumph following the Iraq war and the 2008 financial meltdown, Democratic presidents have repeatedly faced the challenge of restoring US prosperity and leadership. And somewhat succeeded. Such selective reading of the past century may be all too self-righteous, but never have Democrats and liberals, including liberal Republicans, shown as much enthusiasm for turning the page on a Republican presidency as they do today.

Biden's cabinet picks show a great deal of cultural and gender diversity, albeit from within the establishment. If policy is indeed shaped by official appointments, the new administration shows some promise.

Of course, many Democrats would have liked to see the likes of Elizabeth Warren and Bernie Sanders in the new administration, but my guess is, Biden hopes to work with traditional and liberal Republicans in order to end the Trumpist mindset that divided the country.

This would prove controversial and even alienate many progressive Democrats, but it could potentially widen the rift within the Republican Party and improve the Democrats' position come midterm elections.

Biden already committed to reverse a plethora of Trump's executive orders on his first day in office, including lifting the "Muslim Ban" and rejoining the Paris climate accord.

He will also try to move rapidly to fix Trump's shameful and deadly pandemic record by issuing new directives to combat the coronavirus.

These are important steps that signal his seriousness to turn the page on the Trump era, but not enough to reckon with his legacy and tackle America's social and racial injustices that elevated him to the presidency.

That is why Biden needs to go beyond what Obama did after the calamitous years of the Bush presidency. He must design a new American covenant along

the lines of FDR's New Deal and Lyndon Johnson's Great Society. He could start by embracing and implementing a wide-ranging national revival programme that follows FDR's three Rs: relief for the many unemployed through direct government support; recovery through greater infrastructural investments and market subsidies; and reform of the economy through regulations and welfare programmes.

Addressing poverty and inequality is indispensable for tackling the deeper more contentious issues of racial and societal tensions that are dividing and paralysing America.

Needless to say, a struggling, divided and unstable America is an America that is unfit to lead the world. Its attraction, as the cliché goes, comes not only from the example of its power, but the power of its example, as a stable, democratic and prosperous superpower.

So once Biden restores what he calls the "soul of American" – its democratic civility, economic vitality and political liberality – he will be able to proceed with restoring its credibility.

Reinstating American leadership will require rebuilding alliances, strengthening global institutions and upholding international agreements, which Trump abandoned.

Unfortunately, many among America's allies, like its European and South Asian partners, have already moved on. They have begun to shape their own autonomous security structures and some have even signed new trade deals with China.

Although they are pleased with the changes in Washington and with America reengaging with the world in a responsible diplomatic fashion, America's closest allies will not rush to embrace US leadership as in the past and will not be swayed by mere sweet talk or hollow assurances. Biden will have to work harder than his predecessors to regain their trust. He will also need to accept more equitable transatlantic and transpacific relationships based on mutual respect and mutual interest.

These alliances are indispensable for America to deal with, not to say stand up to, a rising China and emboldened Russia, its two greatest challenges in the decades to come.

When it comes to great power politics, Biden will have to restore that which distinguished America from its rivals, albeit at times selectively and cynically, i.e. its emphasis on and promotion of human rights and democratic values.

And nowhere is this as urgent as it is in the Middle East, where the Trump administration has abandoned all that is politically legal, decent and humane.

Biden must put human rights at the centre of America's regional policy. This begins by pressuring America's clients, Saudi Arabia and Israel, to end the war in Yemen and the occupation of Palestine, respectively.

Returning to the Iran nuclear deal is commendable and necessary, but it must go hand-in-hand with ensuring Iranian respect for human rights and legal norms. As the region's self-appointed guardian superpower, America shares responsibility for the civil wars in Syria and Libya, which Obama enabled and Trump left to fester.

Biden says America is shaped by a constant battle between its better angels and darkest impulses. This is also true for foreign policy.

It is high time for its better angels to prevail in America and beyond.

he last few days, any follower of cricket must have been fed on a generous dose of praise heaped on the new India and their heroics to win back-to-back Test series in Australia - one of the toughest frontiers to conquer in the game. It's been a series which, to put it in a nutshell, renewed our romance with the game at a time whose supply has outweighed demand in recent years.

What exactly has been this 'new India'? I would urge you to go back to a visual of members of Indian team doing their victory lap after breaching the Australian fortress at the Gabba last Tuesday, Holding the giant tricolor is Shardul Thakur, who had been not even a regular member of India's white ball plans; Mohammed Siraz, three Tests old; Washington Sunder, essentially a member of the national T20 squad; Navdeep Saini and T. Natarajan — who would not have been a part of the Test squad if India had not sent a jumbo squad in the first place as a backup for the COVID-19 pandemic. Men like Rohit Sharma or Ravi Ashwin. the established stars, kept themselves away from the frame while captain Ajinkya Rahane is famous for taking the back seat in such moments. This very much summed up the ethos of the side which scripted one of the most intriguing comebacks in the history of Test cricket - not to speak of the Gabba win which would rate among India's top three bestever Test wins either at home or away. The Indian cricket fan with a sense of history would urge not to forget India's historic chase of 403 against the West Indies at Port of Spain in 1975-'76, masterminded by twin centuries by Sunil Gavaskar, Gundappa Vishwanath or the Marathon Act of VVS Laxman-Rahul Dravid in the 2001 Test at The Eden against Steve Waugh's Australians. However, those were the legends of Indian cricket who pulled off the Houdini Acts — not the Everyman cricketer who punched above their weight for three Tests in a row — first staging a miraculous turnaround at the Boxing Day Test barely 10 days after being 36 all out in Melbourne, then fought with their backs to the wall at the Sydney Test to keep the series and finally turn the tables at the Gabba. What made this miracle happen? There could be the argument that since winning their first Test series Down Under barely two years back to end a hoodoo of 70 years, men like new 'Wall' Cheteshwar Pujara, Rahane, Rohit Sharma, Mayank Agarwal, Jasprit Bumrah or Ravi Ashwin were no strangers to looking the Aussies in the eye and going for the kill if the situation was ripe for one. And yes, Head Coach Ravi Shastri also made a pertinent point when he said Virat Kohli — the captain in absentia also deserves a bit of credit for instilling the self belief in the team.

# **Study Says Childhood Neglect Leaves Generational Imprint**

arly life experiences can have an outsized effect on brain development neurobiological and health. New research is showing that those effects can be passed down to subsequent generations, reporting that the infant children of mothers who had experienced childhood emotional neglect displayed altered brain circuitry involved in fear responses and anxiety

The study appears in Biological Psychiatry: Cognitive Neuroscience and Neuroimaging, published by Elsevier.

These results show that our brain development is not only shaped by what happens in our own life, but is also impacted by things that happened to our parents before we were even conceived," said lead author of the study, Cassandra Hendrix, PhD, Department of Psychology, Emory University, Atlanta, GA, USA.

Dr. Hendrix and her colleagues studied 48 Black motherinfant pairs starting in the first trimester of pregnancy. Mothers

were given a questionnaire to assess childhood trauma (experiences of early abuse or neglect). The mothers were also evaluated for current, prenatal stress levels, and for anxiety and depression. One month after birth, infants underwent a brain scan using resting-state functional magnetic resonance imaging, a non-invasive technology that could be used while the babies slept naturally.

"These remarkable results leverage our ability to image the brain and its functioning very early in life," said Cameron Carter, MD, Editor of Biological Psychiatry: Cognitive Neuroscience and Neuroimaging.

The researchers focused on brain connections between the amygdala, which is central to processing fearful emotions, and two other brain regions: the prefrontal cortex and the anterior cingulate cortex. Both areas play a key role in regulating emotions. Babies whose mothers experienced childhood emotional neglect had stronger functional connections between the amygdala and the cortical regions.

After controlling for mothers'



current stress levels, the research ers found that the more emotional neglect a mother had experienced during her own childhood, the more strongly her baby's amygdala was connected to the frontal cortical regions. Physical abuse or neglect of the mother was not correlated with the stronger connectivity. The findings suggest that childhood emotional neglect has intergenerational effects on brain structure and function.

The significance of the stronger connection remains unclear, said Dr. Hendrix

"The neural signature we observed in the 1-month-old infants of emotionally neglected mothers may be a mechanism that leads to increased risk for anxiety, or it could be a compensatory mechanism that promotes resilience in case the infant has less supportive caregivers.<sup>2</sup>

Dr Hendrix added, "In either case, emotional neglect from a mother's own childhood seems to leave behind a neural signature in her baby that may predispose the infant to more readily detect threat in the environment almost from birth. Our findings highlight the importance of emotional support early in life, even for subsequent generations.

"The findings add to evidence of the intergenerational consequences of early life adversity, such as maternal neglect," added Dr. Carter

"Future studies that follow children longitudinally will help us understand the functional significance of these changes in brain function in terms of the emotional and social development of children of mothers who experienced early neglect."

Meanwhile, the minimum temperatures across the Valley increased marginally on Friday, even as they remained several notches below the freezing point, a MeT department official said here.

Srinagar city recorded a low of minus 6.1 degrees Celsius, nearly four notches below the normal for this time of the year. The city had recorded a minimum temperature of minus 7 degrees Celsius the previous night, the official said.

The minimum temperature in Gulmarg in north Kashmir's Baramulla district was minus 6 degrees Celsius last night, up from minus 7.8 degrees Celsius the night before.

Pahalgam tourist resort in south Kashmir, recorded a low of minus 7 degrees Celsius, up from minus 9.3 degrees Celsius the night before.

Qazigund recorded a minimum temperature of 6.2 degrees Celsius, the official said.

Kupwara in north Kashmir recorded a low of minus 4.8 degrees Celsius, while Kokernag in south recorded a low of minus 6.5 degrees Celsius.

Several water bodies in the Valley have frozen due to the intense cold.

A thick layer of ice on several roads in the city and elsewhere in the Valley makes it difficult for motorists to drive in the early hours. However, the situation improves later in the day as the Valley has been witnessing unusual winter sunshine.

Kashmir is currently in the grip of 'Chillai-Kalan', a 40-day period of harshest winter when a cold wave grips the region and the temperature drops considerably leading to the freezing of water bodies including the famous Dal Lake here and the water supply lines.

The chances of snowfall are the maximum during this period and most areas, especially in the higher reaches, receive heavy snowfall.

While 'Chillai-Kalan' began on December 21 and will end on January 31, the cold wave continues even after that in Kashmir with a 20-day 'Chillai-Khurd' (small cold) and a 10-day 'Chillai-Bachha' (baby cold). (With PTI inputs)

## **Cross-LoC Firing**

"The exchange of gunfire is underway at Nachian area," sources said.

The defence sources further said that the exchange of gunfire is still going on in the area. There are no immediate reports about injury or damage from the spot so far, they said.

On Thursday, an Army man was killed when Pakistani troops allegedly violated the ceasefire and resorted to firing on forward positions along the LoC in Poonch district.

Havaldar Nirmal Singh of the 10 JAK Rifles unit of the Army was critically injured in the firing and subsequently succumbed to his injuries, the officials had said.

Singh's killing came barely a day after four soldiers were injured in Pakistani firing along the LoC in Akhnoor sector on Wednesday. All the four soldiers had suffered splinter injuries and were shifted to the military hospital in Udhampur for treatment.

Jammu and Kashmir recorded 5,100 instances of ceasefire violations by Pakistan along the Line of Control (LoC) in 2020, the highest in the past 18 years with an average of 14 cases daily, according to official sources. land within 30 days; Apex Level Land Allotment Committee, High Level Land Allotment Committee and Divisional Level Land Allotment Committee to decide and allot industrial land to the applicant within 45 days in cases of projects worth Rs. 200 crore, Rs. 50-200 crore and up to Rs. 50 crore, respectively.

"The policy aims at achieving inclusive growth through sustainable industrialization and employment generation, and includes provisions for evolving a fair and transparent mechanism for land allotment for industrial use," the official spokesperson added.

"However, no such concessions are available for students from Jammu & Kashmir who are appearing for national level competitive exams where the syllabus remains unchanged and where they must compete with students from other parts of India who have the ability to continue their education through high-speed internet access," it said.

"Due to the internet restrictions, many students have been forced to leave their families and live outside Jammu & Kashmir to prepare for competitive exams. Those without such privilege are left to compete with students from the rest of a country, on an unequal field," the Association added.

The handout further said that the denial of access to education has taken a toll on the mental health of children in Jammu & Kashmir and they are suffering from high levels of stress, anxiety and depression.

"For these reasons, we have once again approached the Supreme Court seeking enforcement of the fundamental right to education guaranteed by the Constitution and we hope the Court will restore 4G mobile internet access to protect the future of our students," the Association said.

of J&K is battling the menace of (militancy), aided and abetted from across the border, and in view of well-founded apprehensions about the dissemination of inflammatory and seditious propaganda material that has a direct bearing on public order, limited restrictions on high-speed internet mobile services have been placed whilst allowing adequate access to the internet through broadband services over a landline," reads the order issued by Earlier in his childhood playmate, Sheikh Riyaz, Ansar had found a bird-watching companion. They discuss about birds and get excited over new avian findings.

But Ansar's wanderlust into woods and wilderness for capturing the winged creatures has already made him Kashmir's adept bird-watcher.

"There're 266 bird species in Kashmir, and I've covered 161," he says, adding, "actually, there're 366, but 100 are common between Jammu and Kashmir".

After exploring and clicking every new bird, he takes the help of a field guide, or an e-bird organization—known for its bird-identifying App.

"I upload photo of unknown bird on that App, and then they respond with the name of the bird," Ansar says.

"If they doubt the existence of bird in particular place, they call me or mail me asking where the bird was seen, what the habitat was surrounding them. They check all of it, and then they confirm our sightings."

Ansar lives a quintessential bird-watcher's life. He likes talking about birds and gets excited by rare avian species.

Among all the birds, he informs, Kashmir Flycatcher in particular belongs to Kashmir, "but it migrates out in winters, moreover, it has different breeding places."

In absence of birds, many of his days end without any sighting.

"I once went to capture Himalayan Monal," he says. "I had to wait for 3 hours just to have its flying shot but in the end I had to leave empty-handed. It's not at all an easy job to take photos of birds."

But then, some days do turn out to be a rainbow in the bird-watcher's life.

One such moment came during his recent outing in Dachigam. In a single day, he came across 25 species, including Golden Eagle and Orange Bulfinch, which are rare birds in Kashmir.

Back in 2018, the young bird watcher started his photography after seeing the chirpy guests frequenting his neighborhood orchard. His youthful admiration of birds grew into passion at every avian sight after that.

"I would sit on my window for hours together waiting for birds to come, and they would," Ansar continues. "Sometimes we both would eat the same fruit, far from each other. And I would click their moments."

After capturing more than 35 bird species from his window, the construction of residential houses inside the orchard has now restricted birds from visiting.

"Birds don't like disturbed places," he says while blinking his eyes firmly.

As part of his routine, however, the avian aficionado—who can proclaim the name of the bird from its chirping—silently steps between the trees of Rajparian Wildlife Sanctuary.

Holding his long lens camera, he eyes around without missing a dust in air and deftly follows the bird. The closer he gets, the distant the bird flies.

"Birding is an art of perseverance and patience," the avid bird watcher continues.

"I observe them and move into them patiently, their natural instinct makes them scrutinize us. They sit on branches to know us. There's doubt about us and they hide and peek. They don't stop reading us. Seconds pass and they rule out any imminent threat. They ease themselves and I establish my passion in their ease."

Though Ansar's passion plays hide and seek behind the trees, he's certain to seek the hiding.The bird-watcher doesn't like to miss a vibrant bird sitting on a withered tree. "Initially it was difficult for me to get pictures,"

"Initially it was difficult for me to get pict he recounts his winged journey.

"I used to jump closer, bustling them into unawares. They would be gone in a jiffy, which would hurt me a lot and leave me with questionable expressions. This happened half a dozen times and I learned I can't go close to them. I needed a camera with better zoom, so that I could watch from distance without disturbing them. And I got one Ansar equally resents the deplorable condition **Ansar** of water-bodies in Kashmir.

Since a year now, he says, government has not attended to Shalbough wetland.

"It has become polluted resulting in changes in water birds habitation," he says."The birds that used to come there didn't visit this year."

While as, in another wetland, Hokersar, birds visit in good numbers, because it's protected under wildlife.

"They put all the efforts there, restrict poaching and provide security to the winter visitors," the bird-watcher says.

To create awareness about the birds and give wings to passion, Ansar along with others has floated a group named 'Birds of Kashmir', which runs under the tagline: 'Birds and birders have no boundaries.'

"After we started uploading photos on social networking sites, we got a warm response from people," Ansar says.

"It was exciting for many of our viewers. People from different places and countries contacted us for accompanying them on their bird-watching visits. I'm happy that our tribe is growing in the valley today."

Government had earlier banned the imports as soon bird flu scare started and has lifted it when six states including neighboring Punjab confirmed avian influenza in poultry.

There has so far not been any confirmed report of bird flu in J&K.

The states which have confirmed bird flu in poultry include Kerala, Haryana, Madhya Pradesh, Maharashtra, Chhattisgarh and Punjab. Across all birds, avian influenza has been reported in 12 states. The government of India has directed all state and UT governments to lift the ban on the imports to prevent loss to the poultry farmers.

Reports further suggest that data services that rely on the availability of highspeed internet are extensively utilized for coordinating and facilitating infiltration," reads the order.

"Now, therefore, upon assessment of impact of the directions for regulation of the telecom services on the overall security situation and maintenance of public order, while keeping in view the available alternatives, I, Principal Secretary to the Government, Home Department, being satisfied that it is necessary so to do, in the interest of the sovereignty and integrity of India, the Security of the State and for maintaining public order, in exercise of the powers conferred by sub-section (2) of section 5 of the Indian Telegraph Act, 1885 and sub-rule (1) of Rule 2 of the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules. 2017. hereby direct that access to internet shall be made available with the following restrictions," it reads.

"The internet speed shall be continued to be restricted to 2G, except in the districts of Ganderbal and Udhampur, where mobile internet connectivity shall be continued to be made available without any speed-related restrictions," the order reads.

"The postpaid SIM cardholders shall be continued to be provided the access to the internet, whereas, these services shall not be provided to the pre-paid SIM cards holders unless verified as per the norms applicable for post-paid connections," it reads. "Fixed-line Internet connectivity: Internet connectivity shall be continued to be made available, with Mac-binding," it added.

"The aforesaid directions shall be effective from January 23, 2021, and remain in force till February 6, 2021, unless modified earlier. The IGsP, Kashmir/ Jammu shall communicate these directions to the service providers forthwith and ensure their implementation in letter and spirit," reads the order.

disbelief and thought I was joking, but then I sent him the photos and soon we were raving in happiness."

Nikon D750 with 150-600mm G2 lens." Ansar fancies birds in and out, and nature does not disappoint him.

Once in the morning he moved out for work and surprisingly found a bird. Rushing back, he flung the door, and snatched the camera from his wardrobe.

"All the people in my home thought what devil did I see and my mother immediately fixed their thought saying, 'It's the same old birds he is chasing'. And in the end I did capture the bird."

The same devotion made the grueling lockdown in Kashmir easier for him.

When everyone was looking for ways to pass the hours, Ansar would expend his time in bird-watching.

"One could evidently feel fresh air and better visibility during lockdown," he says. "The photographs were clear and I could easily detect birds and discern the specie."

A government employee in Animal Husbandry Department, he buys his accessories from his salary and moves out to places on holidays to find birds.

As someone whose passion lies in the sky and on the trees, Ansar can't resist birds.

Recently, when his friend informed him about an owl, he immediately scooted to that place, and called the doctor after seeing the bird inactively trying to clip into hiding.

"The owl was ill," he says. "The medico prescribed some medicines and I fed the bird with it over the night."

Next morning the owl seemed livened up.

"He fluttered in happiness," Ansar recalls."I stripped the owl off the restrain and took to the place of his habitat of trees and finally he was there in the sky, rounding the place."

Ansar's frequent bird-watching outings make him feel sorry about the fading green in the valley.

"The trees we cut are habitat to birds," he says, "and when trees are gone, the birds are naturally gone. We aren't only affecting the climate, but also stealing the homes of birds."

But as a bird photographer, Ansar believes that he's playing his part to protect environment.

"I feel like bird photographer is also a conserver, he conserves nature," he says."I trek into the places and pick up the polythene whenever I find one.It's heartbreaking to see wrappers on such pristine places."

Beautiful birds visit beautiful places, he asserts, and when a place becomes littered, it spoils the mood of birds compelling them to find another place for residing.

"It's imperative for people to know the bird diversity we are blessed with. I'm a medium to tell people how many birds we have, how much biodiversity in birdlife we have here, they must know it. I tell them through my photography that we don't only have common mynas and sparrows, we have 266 more bird species."

Saha, who is considered India's number one wicketkeeper, said he does not see Pant's heroic show as the end of road for him in the Indian team and he will continue to strive for excellence, leaving the selection headache to the team management.

"You can ask him (Pant), we have a friendly relationship and help each other whoever gets into the XI. Personally, there's no conflict with him," Saha told PTI in an interview after returning home from the historic Test series win in Australia. "I don't see who is No 1 or 2..

Team will give a chance to those who does better. I will continue to do my job. Selection is not in my hands, it's up to the management." Saha was all praise for the 23-year-old Pant whose 89 not out on the fifth day sealed the match for India at the Gabba to win the series 2-1.

'No one learns algebra in class I. You always go step by step. He is giving his best and will definitely improve. He has always matured and proved himself. In the long run, it augurs well for the Indian team, he said of Pant who was often found wanting behind the stumps.

"The way he has shown his intent after being sidelined from his favourite T20/ODI formats was really exceptional."

Since the Brisbane show, Pant's comparison with the legendary Mahendra Singh Dhoni has only grown but Saha said "Dhoni will remain Dhoni and everyone has his own identity".

Saha scored 9 and 4 in the Day/ Night Adelaide Test where India were shot out for a record low of 36 and he did not play in the

phase. A professional player always accepts the highs and lows, be it with form or criticism," the 36-year-old said.

"I was unable to score runs that's why Pant got the chance. It's as simple as that. I always focused on improving my skills and never gave a thought to my career, even when I started playing cricket. It's the same approach now," he said.

He said the series win was "no less than a World Cup triumph" because of the way the team bounced back from 36 all out in Adelaide and considering the inexperience of many players.

"Even though I did not play (in three matches), I enjoyed every moment of it.

"We faced challenges in putting up XI players, so it was an outstanding feat, an outstanding team effort. Definitely, it will be one of our greatest series wins."

Saha said India may not have known the outstanding depth in their reserve bench had they not faced the crisis situation of several players injuring themselves, apart from captain Virat Kohli leaving after the first Test on paternity leave.

"It was about instilling selfbelief and going session by session. The series win last time also played in our minds," Saha said.

Both Pant and Saha have been picked for the first two Tests in the home series against England next month and it remains to be seen whether the team think tank will play the veteran as a specialist wicketkeeper.

Saha feels stand-by captain Ajinkya Rahane's success mantra was staying calm even in the toughest situations.

"He goes about his job with a cool head. Like Virat, he too has full of belief in his players. Unlike Virat, he never shows any excitement.

"Approach is a bit different. Rahane stays calm always, never loses temper. He knows well how to motivate the players. That is his success mantra.

## Liverpool's Unbeaten Run Of 68 Matches Ended By Burnley

LONDON: Liverpool's 68-match unbeaten streak at Anfield in the Premier League ended with a 1-0 loss to Burnley in the latest setback of a fading title defense.

Ashley Barnes scored from the penalty spot in the 83rd minute on Thursday after the forward was brought down by goalkeeper Alisson Becker as Burnley became the first team to win in the league at Anfield since April 2017.

It was Burnley's first win at Liverpool since 1974 and it leaves Jurgen Klopp's side six points behind PL leaders Manchester United halfway through its title defense, having not scored in four successive games.

"It obviously didn't work out tonight and that's what we have to admit," Klopp said.

"It's obviously my fault." Frustrations boiled over at the half-time whistle as Barnes reacted angrily to Fabinho appearing to flick out at him, provoking a small melee, but referee Mike Dean only showed the Brazilian a yellow card. Meanwhile Klopp and Burnley manager Sean Dyche had their own heated exchange as they headed down the tunnel.

"I didn't start it, but it's nothing," Klopp said. "All good."

While Liverpool is chasing a record equalling 20th English title, Burnley is trying to stay in the league and it moved seven points above the drop zone.

## **Amid Reports Of Cancellation, Tokyo Olympics Organizers Say 'Focused On Hosting'**

TOKYO: President Thomas Bach and local organisers are pushing back against reports that the postponed Tokyo Olympics will be cancelled.

Now set to open July 23, the Tokyo Games were postponed 10 months ago at the outbreak of the coronavirus pandemic, and now the event appears threatened again.

The Times of London, citing unidentified government sources, reported that the games will have to be cancelled. It quoted an unidentified senior member of the ruling government coalition.

"No one wants to be the first to say so but the consensus is that it's too difficult, the source said.

"Personally, I don't think it's going to happen."

In a statement Friday, the local organising committee did not address directly The Times story, but said the Olympics were going forward and had the support of Prime Minister Yoshihide Suga.

"All our delivery partners including the national government, the Tokyo Metropolitan Government, Tokyo 2020 Organizing Committee, the IOC and the IPC (International Paralympic Committee) are fully focused on hosting the games this summer." the statement said.

"We hope that daily life can return to normal as soon as possible, and we will continue to make every effort to prepare for a safe and



secure games."

The Times of London said Japan hoped to land the 2032 Olympics. The IOC has already awarded the 2024 Olympics to Paris and the 2028 version to Los Angeles.

Unlike other sports businesses that offer hundreds of games, the IOC has only two main events to sell the Summer and Winter Olympics.

Bach hinted that radical changes may be needed to pull off the Tokyo Olympics, which involve 11,000 athletes and tens of thousands of coaches, officials, judges, VIPS, media and broadcasters.

However, after internal consultations on Thursday, the farmer unions decided to reject the offer and stick to their two major demands -- the repeal of the three laws and a legal guarantee of the minimum support price (MSP).

"We told the government that we will not agree to anything other than the repeal of the laws. But the minister asked us to discuss separately again and rethink the matter and convey the decision," farmer

leader Darshan Pal told PTI.

## **Delhi Airport Evaluating Computer Vision To Ensure Social Distancing**

NEW DELHI: The Delhi Airport is evaluating a 'computer vision' technology to track passengers, reduce waiting time and ensure social distancing at its terminals, a top official of the facility's operator said on Tuesday. Computer vision technology uses images to analyse and understand passenger density at the airport. It has already been installed at the GMR Group's Hyderabad Airport.

Delhi Airport, which is also led by a GMR Group-headed consortium, installed the 'Xovis' passenger tracking system at Terminal 3 last month. It uses sensors to check passenger density.

"We are also evaluating some other technologies. As you might be aware that the Terminal 1 is getting revamped, so while this (Xovis) system is a tried and tested one, there is also something called computer vision technology our Hyderabad Airport has tried. We are also

currently less than pre-COV-ID-19 levels, only Terminal 2 and Terminal 3 of the Delhi Airport are handling aircraft movement. In the Xovis passenger tracking system (PTS), passengers are counted and tracked anonymously using display screens at various points of Terminal 3's checkin hall, arrival pier junction and so forth.

Jaipuriar said all other stakeholders like CISF, which provides security at the Delhi Airport, as well as the Bureau of Immigration have also been linked with the Xovis system.

"We have to work with the CISF and the Bureau of Immigration to make sure that the passengers' waiting time keeps coming down. All the stakeholders have responded very positively to this particular technology," he added.

Jaipuriar clarified that while the airport operator is using systems like Xovis, markers and volunteers on ground, it does not have the legal power to penalise anyone.

"So, what we bank on is that people would respond to our requests, signage, announcements, and we keep on urging them to maintain social distancing, which is good for them and good for the fight against coronavirus," he noted.
