

SRINAGAR: There was an improvement in the cold conditions in Kashmir as the minimum temperature increased across the valley on Monday, while it settled below the freezing point at all weather stations, officials said.

Srinagar, the summer capital of Jammu and Kashmir, recorded a low of minus 2 degrees Celsius last night, up from the previous night's minus 3.6 degrees Celsius, the officials said.

Qazigund recorded a minimum of minus 5.5 degrees Celsius, up from the previous night's low of minus 6.3 degrees Celsius, they said.

Pahalgam tourist resort in south Kashmir, recorded a low of minus 5.3 degrees Celsius, up from minus 7.5 degrees Celsius the previous night.

The minimum temperature at the Gulmarg skiing resort, in north Kashmir's Baramulla district, settled at minus 2.5 degrees Celsius last night, an increase of four degrees from the previous night, the officials said.

They said the night temperature at the resort was 4.2 degrees above normal for this time of the season.

KASHMIR In Capital: 'Masterpieces' Of Valley In Delhi

ambling in Lajpat Nagar of New Delhi introduced me to several shops owned by a successful Kashmiri business class. To my luck, the variety of different Kashmiri handicrafts instilled in each shop made me come across Sajad Enterprises, a renowned Kashmiri Papier Mache seller in Delhi.

Syed Sajad, now 61, came to the capital 30 years back to build a home outside home. "When the banks became non-

functional in 1990, I made my

decision to move out," said Sajad, sitting calmly on his desk.

"Also, I had 250 artisans to take care of. Hadn't I moved out of the troubled home at that time, all the 250 artisans, along with their families, would have rendered jobless," he added.

However, his family wasn't fond of his decision, and his parents always insisted upon staying back in the valley and eating at the same dining table.

"It was a taste of life," said Sajad, while referring to working in Kashmir, which he did for around eight-ten years. For him, just like other Kashmiris in Delhi, working

in the valley is more of working at home, in a mesmerizing lovely atmosphere.

But, in the capital, things were different. Hot weather, unfamiliar faces, and different cultural practices proved difficult to master.

Yet, there was always a reason for Sajad to spend most of his life in a foreign land. "In the very first year [in 1991] I came here, I was coming back to Nizamuddin from Rashtrapati Bhavan in my own car. Since I didn't know the route, I called another person in a car. But he didn't respond," he said.

Nonetheless, things changed in the blink of an eye.

"The moment I returned emptyhanded from the first person, a Navy General came to me, breaking his protocol, and informed me about the path ahead in the politest manner one could imagine," he said.

This act of kindness made him steadfast upon the decision of establishing his commerce in Delhi.

However, it was Sajad's association with the union textile department that accorded him immense notability. It also earned him few trips to Europe to >> More On P2

RS Approves Bill

for Home Affairs G Kishan Reddy said in Rajya

He said that the Constitution of India is now fully applicable in Jammu and Kashmir, and that the bill will enable availability of officers in Jammu and Kashmir who have experience of running union territory administration.

He said around 170 central laws are being implemented in Jammu and Kashmir.

"For smooth implementation of these laws, application of schemes and effective execution of projects and for better strength of cadre, officers with experience of UT administration are very important.

"Through merger of J&K cadre with AGMUT Cadre, services of All India Services officers of AGMUT cadre can be taken in Jammu and Kashmir union territory," Reddy said.

Participating in the debate, BJP leader Shamsher Singh Manhas said no development could take place earlier despite maximum central funds going to Kashmir as compared to Jammu, Leh and Ladakh.

However after the union territory was made, the situation in the region was improving as there was peace there and developmental works were underway, he said.

But to carry forward the development work in a speedy manner, more officers are required and the bill aims to achieve this purpose, he added.

Sharing similar views, BJD leader Amar Patnaik said that the bill aims to solve the issue of All India Service officers in the two new UTs. It is not the first time such a bifurcation is happening. It was done earlier too, when the states were divided into smaller states, he said.

J&K PDP leader Mir Mohammad Fayaz expected the return of the earlier status in the region instead

the first speaker, Azad said it was perhaps his last speech in the House and he didn't want to use harsh language but contrary to the government's tall promises behind converting J&K into UT, development had been stalled, industry couldn't enter and unemployment was on the rise.

Minister of State for Home G Kishan Reddy had earlier moved a motion for considering the bill and a statutory resolution on the draft law in Rajya Sabha.

The senior Congress leader said Article 370 had only two conditions outsiders couldn't buy land or work there which had been in place since the time of Raja Hari Singh.

Saying that only small chunks of land were there due to the region being mountainous and full of forests, he said on scrapping of Article 370 many MPs were elated to buy land but he had told them that land was too costly there and "even I couldn't afford to buy" it.

The earlier law ensured locals had jobs but now no new industries were coming up and even existing firms were shutting operations, he said, adding seven districts out of 10 in Jammu province had no industry and no proper rail connectivity.

"No new industry is coming up at present... Of the 12,997 industries in Jammu, only 5,890 are functional, while 7,160 i.e. 60 per cent are closed... development remains stalled... It is only on TV and not on roads," he said.

The condition of national highways is dilapidated and ceasefire violations have risen causing severe damage to land and property, he said and added that water supply was in shambles, while power tariff had risen abnormally to Rs 350 per unit from Rs 90 per unit.

Tourism had taken a toll on account of monthslong curfew earlier and then due to COVID-19 pandemic, schools, colleges and universities were closed and no salaries were being given to teachers.

Had there been elected representatives they could have taken responsibility and addressed the issues, he said.

Drawing Home Minister Amit Shah's attention towards PhD and MPhil qualified 3,000 teachers, he said they were living from hand to mouth, barely being given Rs 3,000 a month and were on probation for 7 years. He said no where does this happen.

"Give attention to such issues ...probation happens for six months...Had there been Assembly they should have gone there with their plight but they are forced to come to me...they can't afford milk for infants on such a meagre salary," Azad said.

He said likewise 15,000 medical assistants and pharmacists were jobless.

"Give statehood and conduct elections," Azad demanded and said it is a border region and both the enemies -- Pakistan and China -- are sitting on our heads, and under the circumstance the government should strive to win the hearts of locals and strengthen its hands.

He said people of Kashmir had always been with India and recalled how Kashmiris, including women and children, resisted Pakistan's bid to capture the region in 1948, till the Indian Army reached there.

Azad also said that though it was Muslim-majority state, the executive remained largely Hindus and urged the government not make "Kashmir a guinea pig for experiments."

While participating in the debate, BJP's Dushyant Gautam said that political parties in the state were exploiting the people under the guise of Article 370.

AIADMK's A Navaneethakrishnan said the state requires more all India services cadre officers to implement the development schemes in the Union

"It is for a good purpose ... these amendments have been brought on. I welcome it and support this bill," he said, adding that considering it is a border state, with threats from Pakistan and China, J&K should remain under the direct control of the Union Government.

Manoj Kumar Jha of RJD wanted to know whether the changes proposed under the bill were temporary or permanent in nature. He also wanted to know from the government whether there had been any increase in fresh recruitment in militancy in the valley after the change of J&K's status.

Ashok Siddharth of BSP also supported the bill, however, said earlier 50 per cent of the state cadre KAS officials were elevated to IAS cadre but after this, their elevation would be reduced to only 33 per cent and this should be looked into.

Sushil Kumar Gupta of AAP said the government should take steps to normalise the situation in J&K and restore its full statehood as promised earlier.

PM Praises Azad, Congress and the group of 23 leaders (G-23) who had written to party chief Sonia Gandhi demanding an organisational overhaul, including elections to party posts and a full-time and active president.

Azad, the Leader of Opposition in Rajya Sabha, was among the letter writers who had triggered a storm in the Congress with their step and had drawn a sharp reaction from Gandhi loyalists. His Rajya Sabha tenure will end on February 15.

Ghulam Nabi ji has praised the elections for panchayats, BDCs (block development councils) and DDC (district development councils) held recently in Jammu and Kashmir and I am grateful to him for doing so.

"But I also fear on this praise showered on me. I am confident that people in your party will take this in the right spirit and not mistake it as the advice of 'G-23' to do something opposite," the prime minister said while replying to the debate on the motion of thanks on the President's address in the Upper House.

He said he has heard Azad, who is very polite and soft-spoken and has never used a foul word that could hurt anyone. He said that has been his specialty and "I feel all Parliamentarians need to learn that from him. I respect him a lot".

"He praised the recent elections that have taken place in Jammu and Kashmir. He said that Jammu and Kashmir is very dear to him, just as it is for every Indian who keeps Jammu and Kashmir very close to heart. Our effort is to make Jammu and Kashmir 'aatmanirbhar' (self-sufficient)," Modi said. Before Azad, the prime minister singled out an-

other Congress leader Partap Singh Bajwa. "Bajwa sahab from Congress was also speaking. He was speaking in such detail that I thought he will talk about the Emergency (period) soon as he was just one step away from it. But he did not go there.

'Speedy Development

Kashmir will be connected by train by December 2022 and an elevated light rail system is also being planned in the region.

He said 100 per cent piped water connection to 80.16 lakh rural households will be provided by September 2022 in the region.

'Since the last two years, speedy development is happening in Jammu and Kashmir, when compared to the last 70 years. Both the Centre and the J&K government are trying to develop the region and will do more. Due to coronavirus, we could not reach the set target," Reddy said in reply to a debate on I&K Reorganisation (Amendment) Bill in Rajya Sabha.

After his reply, the Upper House passed the bill which seeks to replace an ordinance issued in January with an aim to merge the Jammu and Kashmir cadre of IAS, IPS and IFS with the Arunachal Pradesh, Goa, Mizoram, and Union Territory cadre, also known as AGMUT cadre.

The MoS asserted that all major projects are on track in Jammu and Kashmir, and bottlenecks have

Highlighting the major steps taken in the region, Reddy said the foremost is the municipal polls in rural and urban bodies.

The District Development Council polls were completed successfully. There was 74 per cent voters' participation in rural bodies elections, while 98 per cent in block development council polls that were held post independence for the first time, he said.

Not only elections were held, local bodies were strengthened giving them the responsibility of midday meal scheme, Anganwadi programme and MGNREGA, he said, adding that grievances boxes were also installed in panchayats.

The minister further said gazetted officers have been asked to visit villages for two days as part of 'Back to Villages' programme to review development activities and address grievances of villages. Similarly in urban areas, 'My town and My pride' programme is being implemented.

Stating that about 54 per cent of work has been completed under the PM's Development package for J&K, he said about 20 projects, including central and UT projects, have been executed. Eight more projects are likely to be completed by the end of the financial year, he said.

Among other steps taken, Reddy said the 359-metre-high Chenab bridge work is underway and will be completed by next year.

In the power sector too, he said the government has started many works and an action plan has been made for creating additional capacity of nearly 3.498 mega watt (MW) by 2055.

In the last two years alone, projects above 300 MW were revived and put on track. About 330 MW new projects will be kickstarted and an MoU was signed by NHPC in January this year. Four projects worth Rs 34,882 crore will also be launched, he said.

That apart, I&K has achieved 100 per cent electrification, including in border villages. About 3.57 lakh beneficiaries have been covered under the 'Saubhagya' scheme, the minister added.

In replying to a question in Rajya Sabha, the defence minister said "appropriate retaliation" to the ceasefire violations, as required, has been carried out by the security forces.

"In addition, all violations of ceasefire are taken up with Pakistan authorities at the appropriate level through the established mechanism of hotlines, flag meeting as well as weekly talks between the director generals of military operations of the two countries," Singh said.

"Diplomatically, India has repeatedly emphasised at the highest level, the need for Pakistan to uphold the sanctity of the Line of Control and the International Border as its obligations emanating from the understanding in vogue," he said.

The defence minister said 299 incidents of ceasefire violations were reported till January 28 this

According to official data, the number of ceasefire violations by Pakistan in 2019 was 3,233.

Notwithstanding the coronavirus pandemic in the region, Pakistan has been resorting to unprovoked ceasefire violations along the LoC and making concerted efforts to push militants into Kashmir.

To a separate question on whether a proposal to develop indigenous conventional submarine was approved. Minister of State for Defence Shripad Naik in a written answer said the information is sensitive in nature and its disclosure is not in the interest of national security.

Replying to another question, he said the recently held Malabar naval exercise enhanced synergy, interoperability and coordination between the participating nations.

"The exercise highlights the convergence of views among the participating countries on maritime issues, and their shared commitment to an open, inclusive Indo-Pacific and a rules-based international order," Naik said.

In the midst of growing concerns over China's military muscle-flexing in the Indo-Pacific region, India hosted the Malabar naval exercise in November last. Following India's invitation, Australia also participated in the exercise effectively making it a drill by all the Quad member nations.

The Quad, comprising India, the US, Australia and Japan, is aimed at ensuring a free and open Indo-Pacific. The Malabar exercise was seen as a prelude to future military cooperation among the Quad member nations. (PTI)

Mystery Continues

A resident of Soura area of Srinagar, Zargar was working in a privately-owned Rishi Ganga power project (130 Mw), which is on the upper stream of the Alaknanda river site and was the first to face the brunt of the avalanche.

Zargar went missing after a glacier near Raini village above Rishiganga river in Uttarakhand burst.

"At sharp 10:28 am on Sunday, we spoke to him," Zargar's brother Muneer Ahmad told Kashmir Observer. "He was doing fine but as soon as we heard the news of the glacier burst, we tried to enquire about his well-being but his phone was switched-off."

Muneer said his brother was staying in New Delhi along with his wife and was on an official trip to the power project site in Uttarakhand.

Zargar, according to Muneer, was project engineer at the company.

At least 15 people have died due to the flooding caused by the glacier burst and close to 150 people are still missing.

An operation to rescue people trapped in a tunnel near the Tapovan dam is currently underway and heavy machinery is being used to clear the debris.

Meanwhile, Deepak Katiyar, Managing Director (MD) in Kundan Group, told Kashmir Observer that the rescue operation is going on a war-footing and they are hopeful that their men are safe and sound.

"We are aware that one Kashmiri engineer along with our four employees are trapped inside the rubble," Katiyar said.

"The rescue operation is going on," he added, "we are trying our best to save them.

Aamir Ali, Director Disaster Management J&K, told Kashmir Observer that they are yet to get the figures of people from Uttarakhand, who are still

"But we are in touch with our counterparts there," Ali said. "We have raised the gueries of the missing Kashmiri engineer, however so far there is no response from them."

Nasir Khuehami, a student activist present on the ground, said the missing Kashmiri engineer was working in Reshi Ganga Power project Chamoli when he spoke last time with family on phone.

"DIG Nilesh Anand who is heading the Control room of rescue and search operation told me that his phone is switched off," Khuehami said. "Rescue operation is underway and we are trying to trace

VEHICLES ATTACKED AT I AKHANPUR

Curfew Bandh Continues In Jammu Areas

SRINAGAR – A number of Punjab-bound vehicles from Kashmir were damaged on Tuesday evening by a violent mob at Hatli Maud, a short distance from Lakhanpore in Jammu, even as a rampaging crowd stormed through a sports goods

factory run by a Kashmiri in the vicinity.
Reports from Jammu said irate Shiv Sena and Bajrang Dal activists attacked a convoy of goods carriers from Anantnag Kashmir, near Haiti Maud. The mob pelted stones at nearly 34 trucks and tried to hijack one (JK01D-9938). The driver, Muhammad Altaf was injured in the hijack attempt.

The Shiv Sena and Bajrang Dal had called for a bandh in Jammu on Tuesday to protest against the killing of 6 members of the Sikh community in Srinagar. Scores of Gypsy borne activists of the two organisations, armed with sharp-edged weapons besides hockey sticks and canes, had earlier descended in the locality and raided a factory. Goodway Sports owned a resident of Anantnag. The mob ransacked the equipment and caused damage to the factory.

One factory worker, Bashir Ahmad Dar from Dogri Sangam, Anantnag was injured during the attack There was considerable tension in Kathua district after the violent incidents.

4G is back

fter eighteen months of suspension, the government has finally restored high speed mobile internet services in Jammu and Kashmir. This was announced by the principal secretary to J&K Government Rohit Kansal on February 5. Though people are happy that the 4G is back, nothing can detract from a deep sense of grievance that it took the administration 550 days to restore it. This is why that much more than the celebration, it was the latter sentiment that found vent on social media. And that too not only in Kashmir but also outside the region with many celebrities noting this fact in their tweets.

All these months, the government kept denying the high speed internet on the specious ground that doing so was a security risk. This despite the fact that the ground situation in the Valley has remained calm over the past one and a half year. So, no matter what the government said, its security argument to keep 4G internet suspended didn't hold water. Truth was the Valley did not witness a protest or a stone-throwing incident in a long time.

The restoration followed weeks after Private Schools Association of Jammu and Kashmir filed a petition in the Supreme Court seeking restoration of high speed mobile Internet. The Association had pleaded that the children of J&K have already lost two academic years as it was "impossible to conduct online classes using video-conferencing tools such as Zoom or WebEx at 2G mobile Internet speed". The Association had also highlighted the prolonged closures of schools after August 5, 2019 and then on account of COVID-19 pandemic.

This is true, the students of J&K were the worst victims of the lack of 4G. For almost two academic sessions they were unable to study and largely because of the ban on high speed mobile internet. The poor students suffered the most as unlike the children from well-off households, they couldn't afford fixed line internet. This, in a sense, created a 'haves and have nots' divide in education, perpetrated by the government itself. Thousands of poor students have thus been left behind. They couldn't adequately participate in the online teaching by their schools. Their ability to compete with the students who could attend online tutorials by virtue of having fixed line internet has thus become moot. It should take the poor students some time to catch up.

However, as Omar Abdullah has said, the restoration of 4G internet is better late than never. A high speed mobile internet will be a bone for not only the education but also for the businesses as whole.


18 months on

he restoration of full internet services in Jammu & Kashmir after 18 months is enormously belated but very welcome. The 550-day suspension will go down as a period in which the world's largest democracy turned its back on what the Supreme Court has held to be an essential means to exercise the fundamental right of freedom of expression. Indeed, the sheer number of days that millions in the erstwhile state were deprived of a basic facility without which daily life — including education, business, leisure and entertainment — is no longer considered complete, threatens to place this country in a dubious list, alongside nations with questionable democratic credentials.

The ban began on August 5, 2019, when the government abrogated Article 370 in Jammu and Kashmir, revoking its special status and carving it into two Union Territories. But the long suspension, among other measures, raised question marks on its claim of integrating the region with the rest of the country and promoting greater economic development. It continued even as the security establishment claimed successes in bringing terrorism under control and the National Investigation Agency said its raids in Kashmir had curbed cross-border funding of protests — the two reasons usually advanced for cutting off access to the internet. While the restoration will bring back some welcome normalcy to people's lives, it is only a step in a larger process. Many steps remain to be taken.

In this context, the challenges in Kashmir can only get sharpened if attempts are made — or are seen to be made — to tamper with the outcome of the District Development Council election results. The Altaf Bukhari-led Jammu and Kashmir Apni Party, launched six months after Jammu and Kashmir was split in August 2019, and called the "King's party", has now managed to win over enough Independents to take control of the DDCs in Srinagar and Shopian. The monarchical reference and its associated sense of entitlement is already worrying — the BJP should also be concerned about the political fallout of being seen to wrest DDCs without winning them in the election. The Apni Party won five seats in the Valley and its control of two DDCs is hardly reflective of the spirit of the mandate in both places. Having conducted a free and fair vote against all cynical predictions that the results would be a repeat of 1987, the BJP-led government must not be seen to do or to countenance anything that proves the naysayers right.

Indian Muslims: Dilemmas and Panacea -Part 2

For their community's benefit Muslim leaders will have to adopt a pragmatic approach and identify path-breaking alternatives for community's progress.

he Indian Muslims, as a community, do not possess a common community psyche. They are divided in many factions and no faction is ready to tolerate the other. Community unity, in spite of factionalism is found in abundance in other minorities of the country like Sikhs and Parsis. We have to learn a lot from other minorities on how to develop a community psyche, so that each and every one considers them to be part of a larger whole, and the guiding spirit should be collectivism instead of individualism, every Muslim should be seen as contributing both physically and financially, for enhancing the community's and lives of our brethren.

All the above is easier said than done, and the big question remains, who is going to deliver it and how? The answer lies in our religious leaders. It is a fact that a vast percentage of the Muslims, still listens to and acts upon the messages conveyed to them by our clergy. But most of the time the messages conveyed are not relevant in any manner to the development and progress of the community in the light of the Islamic teachings, but on mundane issues. Instead our clerics will have to work to contextualise the message of the Holy Quran and Ahaadith to the present era, only then they'll be effective and remembered. For this purpose the speech before the Juma Khutba can be a very important tool.

Clergy's role

The Muslim clergy should first try to modernise. It would be good if it could start on a path of critical and scientific thinking or Ijtihad, on issues of importance to the community. Instead of harping back to old and irrelevant texts, it would be better if it could consider each and every issue in a pragmatic fresh perspective based on the correct interpretation of the Holy Quran and Ahaadith. As the Holy Quran is a dynamic not a static book, it offers new solutions as per the new assimilation and analytic prowess gained by its followers with every passing day.

We also bemoan the issue of lack of funding for establishing new educational institutes. Here we forget that if the Indian Muslims decide to contribute every paisa of the interest accrued in their bank accounts and the yearly Zakat to a single entity, then the fate of the community could be changed completely in the next 5 years. This sum could be utilised to establish and rejuvenate the educational institutes, orphanages, taking care of the needy and providing for medical facilities for the community and everyone else.

countrymen. We sound hollow when we decry the increasing tide of Islamophobia in the country and elsewhere in the world. But how do we tackle the issue? In this age of information technology, many battles are being fought and won using social media tools. The latest example in this regard is the surge in Islamophobic messages on the social media and response of the Muslim nations. Due to the overwhelming response of the Muslim countries, many social media platforms had to issue guidelines on how to manage the Islamophobic content, besides immediate remorse shown and forgiveness sought by people who engaged in posting Islamophobic content on various social media websites.

Muslims and the media

It would be better if the community should equip itself to counter the fake and biased news, first. A strong rebuttal and countering mechanism would serve the community well, as the cost for this would not be too high.

The first step towards this could be to build a monitoring team, which could keep track of all anti-Muslim news, to be fed to a team of fact checkers, who with strong research and messaging capabilities should be able to counter any anti-Muslim narrative promptly and professionally.

A central team of Media Monitors based in Delhi should keep track of state monitors and should be equipped to work out quick and coherent responses to every issue, charge or misrepresentation on various social media platforms such as Twitter, Facebook, Instagram and WhatsApp.

Next, a group of community spokesmen should be trained in the language of the states to which they belong. They should be coached in language nuances, debating skills and how to engage in a coherent and conclusive dialogue with their competitors, viz. every aspect of conducting a successful verbal communication process.

Every state should have a small team of at least five people who could represent the community at every media opportunity. An effort should be made to constitute a panel of erudite and knowledgeable people to represent the community at various media outlets. The views espoused by this panel should be endorsed by leading clerics and social leaders beforehand.

All this seems achievable and commendable, but the biggest requisite for this to succeed would be the coming together of different leaders representing various sects, outfits and schools within the Muslim community at one platform. We should have a panel of academics, researchers, ideologues, businessmen and entrepreneurs, activists and ground level workers, who should be seen as the real face of the community.

Way forward

Moreover, it would be better if the Muslim community instead of turning the current concerns into an existential one, introspects and finds the areas and issues, which beleaguers it and where it has floundered, besides trying to be seen as part of the county's mainstream. Follow it with judicious and committed planning and strategising, so that these determinants could be overcome and after the next 25 years, when we'll be celebrating the century of our independence, we can proudly say that the community has fulfilled the aspirations of its followers and countrymen, both.

What we need is a clear-cut plan and a will to innovate and implement those programmes, which will take the community out of its slumber and apathy and take it on the path of progress. Until and unless the Muslim community as a whole decides to change its psyche and reform itself, no body can help the community survive the present onslaught.

Elderly Care

Health For The Aging Population

Elderly people should be encouraged to carry out their own personal hygiene routines as much as possible. This promotes independence and a sense of purpose in life. Even managing the smallest task is better than nothing at all.

raditionally, older adults are taken care of by their families. However, because of the changing gender roles, employment of women, erosion of traditional family values, and an increasing trend for nuclear families, a caregiving crisis is predicted. The number of older adults living alone is increasing. With decreased family support and informal caregivers, more of the older adults in India care for themselves. Caring for older adults requires a multidisciplinary approach and we need to become familiarise with the changes that occur in the aging process. This can enable us particularly healthcare professionals to provide better care to the elderly.

We Need to Understand Age Related Changes in the Body

Ageing is a progressive and universal phenomenon encompassing gradual loss of cells resulting in decline in organ functional abilities. Consequently, even the baseline functions of the body also get wasted. Age-related changes affect the function of every system of the body, even in the healthiest older people. Heart output declines. Calcium migrates from bones and teeth into blood vessels. Cataracts may dim vision. Hearing fades. Lung, liver, and kidney functions slow. Wear and tear on joints makes pain an unwelcome companion. So, the normal age-related changes may be accompanied by chronic health problems such as diabetes or heart disease.

Management of many such chronic conditions may include one or more medications prescribed for regular use. Although medications may relieve symptoms, improve the quality of life, and in some cases increase the lifespan, they are not without risk. For example, research has shown that taking four or more prescription drugs is an independent risk factor for a fall injury which can put an independent older adult into the ranks of the frail elderly.

Ageing is not a disease in itself, but the aged do become vulnerable to diseases. These alterations make the human being vulnerable to various diseases with declining immune responses, poor regenerating capacities thereby increasing exponentially the morbidity and ultimate mortality amongst them. The major chronic diseases which contribute globally to the death of those > 70 years of age include cardiovascular diseases, cancer, chronic respiratory diseases and diabetes mellitus.

Elderly Care Tips:

It is very important for the elderly to adapt certain healthy habits in order to decrease the prevalence of various age related problems. Though it is very difficult to change the habits in the old age, however, there is no harm in making an attempt:

Maintain Daily Routine: Maintaining daily routine of activities is a basic step in remaining healthy. They should be asked to fix a time for each activity during the day e.g. eating, napping during day, going for sleep at night and getting up in the morning, exercises, walk, entertainment, religious activities etc. In old age it becomes very difficult for the body to adjust if the routine is disturbed. Sleep requirement decreases with age. Older adults tend to sleep more lightly and for shorter time spans, but they generally need about the same amount of sleep as they needed as a young adult (7 to 8 hours a night).

Physical Activity: The elderly should be promoted for the physical activities as per their capabilities. Thirty minutes walk in the morning as well as in the evening is the best physical exercise. They should be



accompanied by someone while going out.

Personal Hygiene: Elderly people should be encouraged to carry out their own personal hygiene routines as much as possible. This promotes independence and a sense of purpose in life. Even managing the smallest task is better than nothing at all. The safety issues in the bathroom should not be overlooked. Make sure there are no throw rugs that could create a risk of fall. A bath chair may be used to sit in the bathroom. The floor should not be slippery. The water temperature should be comfortable. Adaptive equipment such as holding showers can make bathing safer, because sometimes it may be difficult for the elderly to hold a mug full of water.

Dental Hygiene: The dental hygiene should also not to be overlooked. Other than brushing the teeth in the morning and night after having meal, they should be encouraged to rinse their mouth properly after eating anything. Dentures should be cleaned using warm water and anon-abrasive cleanser.

Social Activity: Loneliness leading to depression is quite common in old age. Encourage the elderly to remain socially active by involving themselves in certain activities/joining certain NGOs, spending time with friends, family, relatives etc. This will help utilising their lifelong experiences and maintain their physical and mental health.

Regular Health Checkups: The elderly should be encouraged for regular health checkups. They should undergo all the investigations at least once in a year. Any health problem can be managed properly if it is detected at its early stage.

Bowel Care: Constipation is one of the most frequent problems of the older people. It becomes a source of frustration if they do not pass stool in the morning. Encourage them to take high fibre diet, promote regular exercise, add stool softeners if required and little bit increase in fluid intake.

Urinary Care: The patient may have one or multiple urinary problems leading to disturbed urinary pattern, i.e., either incontinence (involuntary urine loss) or retention of urine. Establish a toilet schedule

every 2 hours, before and after activity, before and after meals, before and after sleep or rest periods, easy access to toilet, adequate fluid intake, avoid bladder irritants such as caffeinated beverages, alcohol and artificial sweeteners.

Ensure Cautious Use of Medications: Administration of medication through various routes vizoral, intramuscular and intravenous carries a greatest risk especially for the elderly patients. Drugs can accumulate and reach toxic levels more quickly than in a younger person, further emphasizing the importance of increasing dose intervals. The kidneys, which are responsible for most drug excretion, experience decreased function as people age. Polymedication should be avoided as far as possible.

Nutritional Needs of the Elderly: Offer small and frequent meals. Three small meals are better than one large meal. The meals should be eaten at a fixed and scheduled time. The number of calories should be considered. These should not be too much or too less. The diet should be balanced in terms of all food nutrients i.e. protein, fat, carbohydrates, vitamins, minerals and fibres. Fried, very spicy food, red meat, animal fat etc. should be avoided

Communicating with Elderly: It has been recognised as one of the most important aspects of nursing elderly people. Ineffective communication with elderly can lead to patients noncompliance, disturbance in socialisation and some patient's needs may be left unmet thereby creating and increasing stress on caregivers. Communicate respectfully and preserve patient dignity when performing physical care as well as when communicating.

Work from Home Injuries

ince the outbreak of the pandemic, many people are working from home more regularly. Dr Manoj Kumar Nair, Physical Medicine and Rehabilitation Specialist at the Dubai Physiotherapy and Rehabilitation Centre, DHA, says that often home environments are not as ergonomic as traditional offices and that this can lead to poor posture.

"The common complaints we receive in our clinic are neck pain and back pain because of poor

posture," he says.

"It is very important for people who work from home to look at their environment. Many people do not have an optimal posture for preventing posture-related injuries. Work stations at home don't tend to be as ergonomically refined as those they tend to get

in the office."

Dr Nair says that poor posture can lead to a number of health issues and it tends to affect people more as they age but that he also sees children with posture-related issues. "It's when people reach their thirties that they can start to experience back problems but we also see children with back pain and I think this is attributed to their lifestyles where they are watching too much TV or spending too much time on their mobile phones for example. This can cause the muscles on the back of the neck to strain and become tired."

He also says that regular breaks should be taken when possible during the working day. "I would suggest people who from home take breaks from their desks and stretch when possible. Rather than taking long breaks, I would recommend a short break every 15 to 20 minutes. When you keep moving and warming up the muscle tissues, your movement becomes more fluid.

"I think standing work stations are an excellent solution because there has been a lot of research and studies that have suggested using this method for improving posture works and achieves good results."



The importance of exercise

Dr Nair believes that regular exercise is key to avoiding many posture-related injuries and that people should start at an achievable and safe level before increasing the intensity of their workouts. "There are plenty of exercise activities available during this month's Dubai Fitness Challenge. For somebody who is new to exercise, I usually suggest they start with brisk walking and jogging rather than running.

It is very important for people who work from home to look at their environment. Many people do not have an optimal posture for preventing posture-related injuries

"When people start to workout we don't know their limits. As a ball park figure we calculate people's maximum safe heart rate during exercise by subtracting their age from 220. We then initially set a target heart rate of 50 to 70 per cent of this for moderate exercise. Then we gradually increase the intensity of the exercise and we often see this causes people's resting heart rate to come down significantly but this depends on how much exercise people are able to do and the fitness levels they can achieve.

"People should be exercising for a minimum of 20 minutes, with five to ten minutes of warm-up followed by five to ten minutes of cool down exercise.

"When you warm up your body it increases your circulation and prepares your muscles and tissues for exercise. If you are running for example, you can start by brisk walking and then gradually increase your speed"

Dr Nair also reiterates the importance of stretching both before and after exercise to reduce your risk of injury. He also says that people with health concerns should consult a specialist prior to exercising to rule out any potentially dangerous underlying health problems. "When you are exercising, stretching is very important. If you stretch after your warm-up you will get more benefits than when you first start your exercise.

"If you have doubts about your health condition it is best to seek a medical opinion before carrying out vigorous exercise so they can rule out any serious problems with your heart and other organs. Everyone has to start exercising somewhere so I always recommend starting with minimal activity and seeing how much you can tolerate."

Dr Nair encourages people to be conscious of their fitness levels and says that while it's never too late to improve your health and well-being, it's beneficial to start regular exercise at a young age. "I suggest people should start exercise as early in their lives as possible as once you reach a certain age it becomes very difficult to change your habits."



Garland's team would like to repeat this experiment and take samples at additional points in time, to better understand when the changes in mouse microbiomes first appear, and whether they extend into even later phases of life.

Regardless of when the effects first appear, however, the researchers say it's significant that they were observed so long after changing the diet, and then changing it back.The takeaway, Garland said, is essentially, "You are not only what you eat, but what you ate

The drugs can be detected by using nanomaterials technology that amplify the optical signal of narcotics to a flexible, body-worn material.

The technology enables fast and highly sensitive drug detection—the sweat patch is attached to the skin for a certain period of time and then irradiated with light for testing.

By exposing the Raman laser on the patch, the drug can be detected in real time without removing the sensor.

Man City Capitalize On Liverpool GK's Mistakes, Chelsea Win On **Road To Recovery, Kane Scores To Give Spurs Much-Needed Win**

LIVERPOOL: The fireworks being set off behind the Kop provided a flashback to last season's Premier League trophy celebrations. But little on the Anfield pitch suggested these were the champions in action.

Jurgen Klopp's side appears a faded force preparing to relinquish the title, highly possibly to Manchester City after being beaten 4-1 by the leaders on Sunday.

After going 68 games unbeaten on home soil, Liverpool has now lost three in a row for the first time in 58 years.

And it's City with a five-point lead. Not over Liverpool but Manchester United and with a game in hand. Liverpool has slipped 10 points off the pace in a league it dominated to win by 18 points last season and led last month, now just clinging onto the fourth Champions League place.

Leicester moved three points ahead of Liverpool in third after drawing 0-0 with Wolverhampton. Chelsea is within a point of Liverpool after maintaining the revival under Thomas Tuchel with a 2-1 victory at Sheffield United.

And Tottenham is only four points from fourth place after ending a three-game losing run by beating West Bromwich 2-0.

On a freezing day across England, Klopp could only figure that the icy conditions were to blame for a blundering performance by goalkeeper Alisson Becker that proved so costly. "Maybe he had cold feet?" Klopp

"It sounds funny but it could be." Liverpool had been spared falling behind in the first half when Ilkay Gundogan struck a penalty into the empty Kop. Gundogan did find the net at the other end four minutes into the second half when Phil Foden's close-range shot was parried by Alisson into his path.

verpool needed Perhaps that's why the fans shut out of the stadium during the coronavirus pandemic lit up the skies with fireworks, seven months after they celebrated the end of a 30-year title drought with pyrotechnics here.

And Mohamed Salah gave a route back into the game by doing what Gundogan couldn't do by scoring a penalty in front of the Kop after being brought down by Ruben Dias.

The team's top scorer played his part. But the usually reliable barrier

in the goal did not. Alisson cleared directly to Phil Foden, who set up Gundogan to score into an empty net for 2-1.

Another lapse followed. City midfielder Bernardo Silva intercepted a feeble clearance by Alisson and lifted the ball over the goalkeeper for Raheem Sterling to head over the line.

"These two goals were a killer," Klopp said.

Tonight it was decisive. That's OK as he (has) saved our lives I don't know how often. He is absolutely a world class goalie. Something went wrong but we have to take that."

It was the power of Foden's shot that beat Alisson rather than any mistake that allowed City to complete its first victory at Anfield since 2003.

"Hopefully next time we can do a similar performance with spectators because Anfield with people in and without is different," Guardiola said.

"I could imagine at 1-1 how much they could influence the players.

"But especially when we missed the penalty and conceded a goal, how good we reacted. Everyone took a step forward. Ilkay and Sterling made an incredible game."

It extended City's unbeaten run in all competitions to 14 matches to turn the season around. It was only 35 days earlier that a 3-1 win at Chelsea took City to fifth, four points behind then-leader Liverpool with a game in hand.

CHELSEA RECOVERY

City's victory at Stamford Bridge contributed to Frank Lampard being fired two weeks ago. Since Tuchel took charge, the west London club has now won three, drawn once and is yet to concede from an opposition player.

It was only Antonio Rudiger's owngoal that allowed Sheffield United to cancel out Mason Mount's first-half opener at Bramall Lane. Jorginho's 58th-minute penalty clinched the win over the last-place team after Timo Werner was brought down by goalkeeper Aaron Ramsdale.

"For myself again no goals, but it's good to see that I can help the team with other things at the moment," said Werner, who hasn't scored in 14 league games.

KANE COMEBACK

Harry Kane has none of Werner's difficulties in scoring. The challenge is staying fit but the striker made a rapid recovery from ankle injuries after 10 days and scored the opener against relegation-threatened West Brom with a low finish. It was his 13th goal of the league campaign and he also fed Lucas Moura to tee up Son Heung-min to double the lead.

"The team depends a lot on him, we can't hide that," Tottenham manager Jose Mourinho said of Kane.

"It's the goals he can score, the assists he can make, the link play he has, that personality that players like that can have and he is always an important influence for us.

IND VS ENG 1st Test

India End Day 4 At 39/1, Chasing A World Record Target Of 420

CHENNAI: India were left with the herculean task of chasing a world record 420 after England refused to declare in an unfocussed second essay, cut short by Ravichandran Ashwin's brilliance on a sharply turning fourth day strip in the opening Test in Chennai on Monday.

At stumps, India were 39 for one, requiring another 381 runs to set a new record and take a 1-0 lead in the four-match series. The previous best is 418, chased by West Indies against Australia in 2003.

Relishing bowling on a responsive pitch, the seasoned Ashwin returned excellent figures of 6/61 to snap England's second innings at 178 after the home team conceded a massive

first-innings lead of 241 runs. With opener Rohit Sharma (12) back in the hut, Shubman Gill (15) and Cheteshwar Pujara (12) will begin the proceed for India on the fifth and final day at the MA Chidambaram pitch, which has started to play tricks.

India would have been in a bigger hole had it not been for a seventh-wicket partnership of 80 runs between newcomer Washington Sundar (85) and Ashwin, who also contributed a 31 with the bat before picking his career's 28th five-wicket haul.

But despite the duo's best efforts, the hosts still fell way short of the follow-on target after being bowled out for 337. India resumed the day at 257 for six.

Hoping to give their bowlers some respite from the sweltering heat, England decided against enforcing the follow-on and batted again.



But the start wasn't the one they wanted as Ashwin bowled with the new ball, the bounce aiding him in his endeavour.

Ashwin removed Rory Burns with the very first ball of the second innings when he induced an edge for Ajinkya Rahane to take an easy catch in the first slip.

Having ambled to 16 off 37 balls, Dominic Sibley was shown the door by Ashwin, with the bounce again helping the off-spinner.

Veteran pacer Ishant Sharma was rewarded for bowling with a lot of hearth throughout the match when he had Daniel Lawrence trapped in front of the wicket with the one that snaked in.

That was wicket number 300 for Ishant, making him the sixth Indian and third pacer from the country to reach the landmark.


Ben Stokes could not replicate the form of his first innings as he Rishabh Pant a catch off Ashwin.

As wickets kept falling at one end, skipper Joe Root (40 off 32 balls) looked like he was batting on a pitch different from the one where the ball was turning from one end to the other, scoring runs without much ado.

With all the confidence in the world, first-innings double centurion Root swept and reverse swept the India spinners, including Ashwin, as runs came at a fast clip when he was in his element in the second session.

He not just negated but also attacked the spinners with aplomb but what Root could not tackle was a delivery that kept low on landing before thudding against the English run-machine's pads.

'A Roller-Coaster Ride' Ishant **Sharma Becomes Third Indian Pacer To Take 300 Test Wickets**

CHENNAI: Veteran fast bowler Ishant Sharma on Monday became the sixth Indian and third pacer from the country to take 300 wickets in Test cricket, joining legendary former India captains Kapil Dev and Anil Kumble after a "roller-coaster" ride.

Ishant reached the landmark when he trapped Dan Lawrence with a delivery that swung back sharply before hitting his pads in England's second innings on the fourth day of the opening Test here.

Besides Kumble (619) and Kapil (434). Ravichandran Ashwin (377 before this game), Harbhajan Singh (417), and Zaheer Khan (311) are the other bowlers from the country who have reached the landmark.

The 32-year-old Ishant reached the milestone in 98 matches, more than the other Indian bowlers in the club.

'Quite a roller-coaster life so far. A lot of experiences, I've learned a lot about how to bowl in the subcontinent, and what lengths to bowl when we go abroad," Ishant said at the end of the day's play.

"Feeling a bit sore, just played four-over T20 games in domestic, and came back and straightaway bowled 35 overs."

India were set a world record target of 420 to win the opening Test here and Ishant said his team is positive about it, especially after their incredible showings in Australia recently.

"If we get a good start tomorrow, I'm sure we can chase this down. We have a fearless batting line-up, and we"re very positive

"First two days it felt like we were playing on the road, but on the fourth day it started turning a bit and we caught a bit of a break.

"Even on the first two days I thought we bowled well even though we weren't getting much help," Ishant added.

The BCCI and ICC joined some cricketers in congratulating the seasoned pacer who began his Test career way back in 2007.

"Congratulations @ImIshant. He becomes the third Indian fast bowler to take 300 Test wickets. He traps Lawrence in the front as England lose their third wicket," the BCCI tweeted soon after he accomplished the feat.

The ICC also lauded the seasoned fast bowler's achievement, coming after more than 13 years of toil.

"Ishant Sharma becomes the third India pacer after Kapil Dev and Zaheer Khan to reach the 300-wicket mark in Tests. What an achievement!" the game's global governing body tweeted.

He has 11 five-wicket hauls and picked up 10 wickets in a match once. The lanky pacer's spell to former Australian captain Ricky Ponting during his teenage years is still discussed in Indian cricketing circles.

Ashwin was the fastest to get there, taking only 54 matches, followed by Kumble (66), Harbhajan (72), Kapil (83) and Zaheer (89).

Ishant, who made his Test debut against Bangladesh, missed the four-match Test series against Australia due to a side strain and came back for the challenge
