6.4 Earthquake Shakes Kashmir

Panicky Residents Rush Out Of Their Homes Into Streets For Safety

SRINAGAR: An earthquake of magnitude: 6.4 shook Kashmir Valley and adjoining areas late on Friday sparking panic among the residents, many of whom rushed out of their homes for safety despite intense cold weather. Many people, the reports said, left barefoot and stood on frozen snow outside their houses after witnessing their houses shaking.

It is pertinent to mention here that such a high-intensity earthquake jolted Kashmir after 15 years, and during the

previous incident around eighty thousand people perished on Pakistani side of Kashmir when an earthquake measuring 7.6 on the Richter scale struck the region on October 8, 2005.

According to Seismological Centre the earthquake originated at 38.08N, 73.31E; 256km southwest of Kashgar, China and 35km westsouthwest of Murghob, Tajikistan. It was reported to have a depth of 80km.

The tremors which were also felt in multiple parts of the sub-continent besides Leh and Kargil lasted for several >> More On P10

EU Envoys Visiting J&K Next Week

SRINAGAR: A twenty member European delegation is arriving next week in Jammu and Kashmir on a two-day visit to assess the situation in the Union Territory in the backdrop of maiden District Development Council (DDC) elections.

The delegation will arrive in Srinagar on February 17 and will interact with newly elected DDC members, representatives of political parties, trade leaders, social activists and journalists, reports said Friday. Next day, the European envoy team will leave for Jammu to interact with DDC members, members of mainstream parties and social activities about the prevailing situation in J&K.

According to the sources, the tour is being organised by the external affairs ministry to project the recently concluded DDC elections in J&K as grassroot level empowerment of local population, news agency KNS reported.

Pertinently, this is the third foreign delegation of diplomats to arrive in Jammu and Kashmir since the abrogation of erstwhile state's special status by government of India on August 5, 2019.

No Territory Conceded To China Under Agreement: Govt

NEW DELHI: India on Friday said it has not conceded any territory as a result of the agreement finalised with China for disengagement of troops in Pangong lake areas in eastern Ladakh.

Hours after Congress leader Rahul Gandhi alleged that the government has "ceded" Indian territory to the Chinese and raised questions over the agreement, the Ministry of Defence issued a strongly-worded statement, saying the effective safeguarding of country's national interest and territory in the Eastern Ladakh sector has taken place because the government reposed full faith in the capabili-

ties of the armed forces. "Those who doubt the

achievements made possible by the sacrifices of our military personnel are actually disrespecting them", the statement said.

The ministry also made certain clarifications in the statement, and said, "the assertion that Indian territory is up to Finger 4 is categorically false. The territory of India is as depicted by the map of India and includes more than 43,000 sq km currently under illegal occupation of China since 1962."

"Even the Line of Actual Control (LAC), as per the Indian perception, is at Finger 8, not at Finger 4. That is why India has persistently maintained the right to patrol upto Finger 8, including in the current understanding with China," the MoD said.

Govt Revokes Order On Gulmarg Hotels

SRINAGAR: Authorities in Baramulla district of Jammu and Kashmir on Friday withdrew an order asking hotels to cancel pre-bookings at the famous ski-resort of Gulmarg to accommodate partici-pants of Khelo India National Winter Games after the move drew sharp criticism.

The order was withdrawn a day after it was issued by the additional deputy commissioner of Baramulla.

The order has been withdrawn, Deputy Commissioner, Baramulla, Mohammad Aijaz Asad told PTI.

The move had drawn sharp reaction from the National Conference which termed it as mindless application of government writ".

Asad said there was no need for such an order to be issued in the first place. It was not required, he added. Another official in the ad-

HC Quashes Sedition Charges Against Ladakh Councillor

SRINAGAR: Jammu and Kashmir High Court has quashed criminal proceedings against a councillor of Ladakh Autonomous Hill Development Council (LAHDC)-Kargil Zakir Hussian who was arrested last year and charged with sedition and other offences for his audio clip mocking Prime Minister Narendra Modi and the Army in the wake of the face-off between India and China in Ladakh.

Kralpora Family Protests Against 'Murder' Of Their Son

Demands Thorough Investigation, Strict Action Against Culprits

SRINAGAR: A family from Kralpora area in Srinagar outskirts on Wednesday staged a protest against the alleged murder of their beloved son in August last year.

The family members as well as relatives of the youth assembled at Srinagar's Press Enclave and staged a protest to press for their demands.

Sona-ullah Ganaie, one of the relatives of the deceased Sajad Ahmad Bhat, said that his wife called them (family) in the wee hours of August 28 morning and claimed that Bhat has hanged himself to death.

"Soon after we reached to see him, our beloved was dead and had marks on his body, which clearly indicate that he was murdered." he



said, adding that they approached the police and registered a complaint following which the body was taken for postmortem.

Brother of the deceased said that since August 28, they have not received postmortem reports while the killers of their beloved are roaming freely.

"Every day SHO Chadoora is saving us that we have received a postmortem report and will give you that but he is making us fool and not giving any such report," he added.

"SHO Chadoora and Investigating Officer converted the murder case (302) into 306 (abetment of suicide) after taking bribe from culprits, he is trying to save them," he added.

Sajad was 'murdered' by his wife with the help of her one boy, who he identified as Shahnawaz.

"We demand authorities to investigate the matter thoroughly and identify the persons who are involved in killing of our beloved," they said.

DFP Supremo Says No Intl Supervision Necessary

NEW DELHI - In a significant climb down from his earlier stand senior Kashmiri separatist leader Shabir Shah on Saturday advanced a new proposal for holding of elections in Jammu and Kashmir under the supervision of some non-governmental organisations (NGO) of the country and intellectuals.

"If the government is really interested in finding the true representatives of people of Kashmir, then elections should be held under the supervision of some Indian NGOs and in¬tellectuals," Shah announced this at a press conference.

Shah made it clear that he was not seeking supervision by any international organisation or the United Nations as he had complete faith in Indian NGOs and intellectuals.

Shah, one of the founder members of militant movement in the state, said simultaneously polls under such supervi-sion should also be held in Pa¬kistan-controlled-Kashmir to choose the representatives who could talk on behalf of the peo¬ple in that part of Kashmir Referring to Jammu and Kashmir chief minister Farooq Abdul-

lah, be said "if he claims to be the genuine representa-tive, he should prove his major-ity again by stepping down and facing the elections under such supervision.' He blamed Abdullah for recent killings of Sikhs in Snnagar and sought a judicial probe into it so that culprit: were brought to book

Five Killed In Attack On UN Convoy In Kabul

KABUL: Five Afghan security personnel were killed Thursday when a United Nations convoy they were escorting came under attack in Kabul province, the UN mission said, in the latest violence to rock the country.

The United Nations Assistance Mission for Afghanistan (UNAMA) said no UN personnel were hurt in the attack that happened in the restive Surobi district of the province outside of the capital Kabul.

"The UN family in Afghanistan mourns the loss of five Afghan Directorate of Protection Service personnel in an incident today in Surobi district of Kabul," UNAMA tweeted, referring to a unit of the interior sonnel to UN and foreign embassies. and chaos in the restive city.

"No UN personnel were hurt or vehicle effected in an attack which hit a DPS vehicle that was escorting a UN convoy.

"Violence in Afghanistan must end," tweeted Ramiz Alakbarov, UN Secretary General's Deputy Special Representative for Afghanistan.

Sisters Of Freed Saudi Activist Al-Hathloul Demand 'Real Justice'



he sisters of prominent Saudi women's rights activist Loujain al-Hathloul have said they want real justice for her, and the lifting of a travel ban, a day after she was released from prison on a

Loujain, 31, who has campaigned for women's right to drive and to end Saudi Arabia's male guardianship system, was released on Wednesday but remains forbidden to leave the country for five years. She spent nearly three years behind bars in a case that drew international condemnation. Rights groups and her family say Loujain was subjected in prison to electric shocks, waterboarding, flogging and sexual assault – accusations Saudi Arabia denies. "What we want now is real justice," Lina al-Hathloul told an online news conference on Thursday, speaking from Brussels. "That Loujain is completely, unconditionally free." She said her sister would fight the travel ban, and that their parents were also unable to leave the country. Another sister, Alia, said Loujain was now at the home of their parents, who were overjoyed to have her back. The first thing Loujain did after speaking to her siblings, they said, was to go to the

supermarket for ice cream. Lina tweeted a picture of Loujain on Wednesday, smiling but thinner than before, with a new grey streak in her hair. The sisters said she had lost weight from the hunger strikes she had staged to protest against her prison conditions. "She's very strong," said Alia, who also lives in Brussels. "I'm so proud of her ability to keep high hopes, to be very positive and to say 'OK, I went through horrible things – but life continues." Loujain was arrested in March 2018 in the United Arab Emirates, where she was studying, and flown back to Saudi Arabia against her will. She was one of at least a dozen women's rights activists who were arrested as Saudi Arabia ended a ban on women driving cars, at least two of whom are still in prison, human rights sources said. Allegations of torture

She was given a sentence of five years and eight months last December under broad cybercrime and "terrorism" laws, for activities including calling for an end to male guardianship and communicating with global rights groups, activists, foreign diplomats and international media. UN rights experts said the charges were spurious. Loujain served most of the custodial half of her sentence, which is suspended for a further two years and 10 months. "She is very determined to use all means that exist within the legal framework in Saudi Arabia ... in order to obtain her rights," Alia said. "She was tortured and she cannot forget this very dramatic period in her life." Loujain told her siblings she had not initially mentioned the torture during phone calls from prison because guards had held an "electroshock device" to her ear and threatened to use it if she mentioned her treatment.

100-Car Pileup On US Highway Leaves 3 Dead

t least three people are dead and several dozen injured, some critically, following a devastating 100-plus car pileup on Interstate 35 West in Fort Worth on Thursday morning. Freezing rain and drizzle are probably to blame, with slick roadways posing a serious danger to travel. The Fort Worth Fire Department described the accident as a mass casualty incident, meaning local first responders were overwhelmed by the response needed to treat the number of those injured. All northbound lanes of the highway were closed to traffic as crews responded to the accident, with

reports of multiple people trapped and concerns of hypothermia if victims are not removed from the vehicles quickly. The accident occurred around 6 a.m. Local media outlets confirmed that at least 100 vehicles, including more than a dozen semi tractor-

trailers, were involved in the crash. Police opened a reunification meeting point at the Riverside Community Center in Fort Worth. Horrific video posted to social media showed mangled vehicles piled atop one another, with some left as unrecognizable heaps of twisted metal. Some vehicles were facing each other head-on, indicating probable spinouts in the slick conditions leading up to the crash.

Tornado Throws Cars Into Air, Rips Apart Buildings

ISTANBUL: A tornado ripped through a port area in Turkey's western coastal province of Izmir overnight, flinging vehicles into the air, damaging buildings, toppling a crane and leaving 16 people injured, Turkish officials said on Friday. A rarity in Turkey, the tornado capsized boats, uprooted trees and sent debris from buildings across parts of the Aegean tourist resort of Cesme, Ihlas news agency drone footage showed. "In the space of just 20 seconds there was a great misfortune. We see a very sad picture. Many roofs have been blown off, vehicles lifted up and smashed to the ground. It's unbelievable," Izmir Mayor Tunc Soyer told reporters as he surveyed the damage.

Kashmir's 83% Healthcare **Workers Opt Out Of Covid-19 Vaccine: DAK**

SRINAGAR: Doctors Association Kashmir (DAK) on Friday said most of the doctors, nurses and paramedical staff in Kashmir are opting out of Covid-19 vaccine.

"More than 80 percent of the healthcare workers have turned down the vaccine," said DAK President and influenza expert Dr Nisar ul Hassan.

Out of 7,000 healthcare workers at Government Medical College Srinagar and its associated hospitals, only 1,167 (16.67 percent) have received the vaccine as on February 09. 5, 833 workers (83.33 percent) have opted out of the vaccine.'

"Such a large percentage of medical personnel declining to take the vaccine is a major concern," he said.

"It is a troubling development, especially since healthcare workers are at higher risk of contracting the virus and their sickness would mean disruption of healthcare delivery system."

'Medical staff would imperil patients by snubbing Covid-19 shots," DAK President said.



"Unvaccinated staff have the potential to transmit the disease to patients who are vulnerable to Covid related complications and death."

He said the most frequent explanation for hesitancy is mistrust and misinformation.

Other reason for reluctance is that most healthcare workers are young and they feel invincible. Some simply want to wait as they are fearful of being first in line.

Those who have recovered from Covid-19 believe that they don't need the vaccine. 'Vaccine hesitancy in health-

care workers will have implications on vaccine coverage among the population," Dr Nisar said.

"The idea of vaccinating healthcare providers first is to help pave way for broader vaccine acceptance.

"But if they are reluctant for the vaccine, we will be having a huge challenge in convincing the general population to take the vaccine," he said.

"Vaccine confidence among healthcare workers is vital in promoting public vaccine confidence."



The Chinese 'Debt Trap' Is a Myth

hina, we are told, inveigles poorer countries into taking out loan after loan to build expensive infrastructure that they can't afford and that will yield few benefits, all with the end goal of Beijing eventually taking control of these assets from its struggling borrowers. As states around the world pile on debt to combat the coronavirus pandemic and bolster flagging economies, fears of such possible seizures have only amplified.

Seen this way, China's internationalization—as laid out in programs such as the Belt and Road Initiative—is not simply a pursuit of geopolitical influence but also, in some tellings, a weapon. Once a country is weighed down by Chinese loans, like a hapless gambler who borrows from the Mafia, it is Beijing's puppet and in danger of losing a limb.

The prime example of this is the Sri Lankan port of Hambantota. As the story goes, Beijing pushed Sri Lanka into borrowing money from Chinese banks to pay for the project, which had no prospect of commercial success. Onerous terms and feeble revenues eventually pushed Sri Lanka into default, at which point Beijing demanded the port as collateral, forcing the Sri Lankan government to surrender control to a Chinese firm.

The Trump administration pointed to Hambantota to warn of China's strategic use of debt: In 2018, former Vice President Mike Pence called it "debt-trap diplomacy"—a phrase he used through the last days of the administration—and evidence of China's military ambitions. Last year, erstwhile Attorney General William Barr raised the case to argue that Beijing is "loading poor countries up with debt, refusing to renegotiate terms, and then taking control of the infrastructure itself."

As Michael Ondaatje, one of Sri Lanka's greatest chroniclers, once said, "In Sri Lanka a well-told lie is worth a thousand facts." And the debt-trap narrative is just that: a lie, and a powerful one.

Our research shows that Chinese banks are willing to restructure the terms of existing loans and have never actually seized an asset from any country, much less the port of Hambantota. A Chinese company's acquisition of a majority stake in the port was a cautionary tale, but it's not the one we've often heard. With a new administration in Washington, the truth about the widely, perhaps willfully, misunderstood case of Hambantota Port is long overdue.

The city of Hambantota lies at the southern tip of Sri Lanka, a few nautical miles from the busy Indian Ocean shipping lane that accounts for nearly all of the ocean-borne trade between Asia and Europe, and more than 80 percent of ocean-borne global trade. When a Chinese firm snagged the contract to build the city's port, it was stepping into an ongoing Western competition, though one the United States had largely abandoned.

It was the Canadian International Development Agency—not China—that financed Canada's leading engineering and construction firm, SNC-Lavalin, to carry out a feasibility study for the port. We obtained more than 1,000 pages of documents detailing this effort through a Freedom of Information Act request.

The Canadian project failed to move forward, mostly because of the vicissitudes of Sri Lankan politics. But the plan to build a port in Hambantota gained traction during the rule of the Rajapaksas—Mahinda Rajapaksa, who served as president from 2005 through 2015, and his brother Gotabaya, the current president and former minister of defense—who grew up in Hambantota. They promised to bring big ships to the region, a call that gained urgency after the devastating 2004 tsunami pulverized Sri Lanka's coast and the local economy.

To look at a map of the Indian Ocean region at the time was to see opportunity and expanding middle classes everywhere. Families in India and across Africa were demanding more consumer goods from China. Countries such as Vietnam were growing rapidly and would need more natural resources. To justify its existence, the port in Hambantota would have to secure only a fraction of the cargo that went through Singapore, the world's busiest transshipment port.

Armed with the Ramboll report, Sri Lanka's government approached the United States and India; both countries said no. But a Chinese construction firm, China Harbor Group, had learned about Colombo's hopes, and lobbied hard for the project. China Eximbank agreed to fund it, and China Harbor won the contract.

This was in 2007, six years before Xi Jinping introduced the Belt and Road Initiative. Sri Lanka was still in the last, and bloodiest, phase of its long civil war, and the world was on the verge of a financial crisis. The details are important: China Eximbank offered a \$307 million, 15-year commercial loan with a four-year grace period, offering Sri Lanka a choice between a 6.3 percent fixed interest rate or one that would rise or fall depending on LIBOR, a floating rate. Colombo chose the former, conscious that global interest

rates were trending higher during the negotiations and hoping to lock in what it thought would be favorable terms. Phase I of the port project was completed on schedule within three years.

For a conflict-torn country that struggled to generate tax revenue, the terms of the loan seemed reasonable.

Finally, in 2009, after decades of violence, Sri Lanka's civil war came to an end. Buoyed by the victory, the government embarked on a debt-financed push to build and improve the country's infrastructure. Annual economic growth rates climbed to 6 percent, but Sri Lanka's debt burden soared as well.

In Hambantota, instead of waiting for phase 1 of the port to generate revenue as the Ramboll team had recommended, Mahinda Rajapaksa pushed ahead with phase 2, transforming Hambantota into a container port. In 2012, Sri Lanka borrowed another \$757 million from China Eximbank, this time at a reduced, post-financial-crisis interest rate of 2 percent. Rajapaksa took the liberty of naming the port after himself.

By 2014, Hambantota was losing money. Realizing that they needed more experienced operators, the SLPA signed an agreement with China Harbor and China Merchants Group to have them jointly develop and operate the new port for 35 years.

Rajapaksa called a surprise election for January 2015 and in the final months of the campaign, his own health minister, Maithripala Sirisena, decided to challenge him. Like opposition candidates in Malaysia, the Maldives, and Zambia, the incumbent's financial relations with China and allegations of corruption made for potent campaign fodder. To the country's shock, and perhaps his own, Sirisena won.

Steep payments on international sovereign bonds, which comprised nearly 40 percent of the country's external debt, put Sirisena's government in dire fiscal straits almost immediately. When Sirisena took office, Sri Lanka owed more to Japan, the World Bank, and the Asian Development Bank than to China. Of the \$4.5 billion in debt service Sri Lanka would pay in 2017, only 5 percent was because of Hambantota. The Central Bank governors under both Rajapaksa and Sirisena do not agree on much, but they both told us that Hambantota, and Chinese finance in general, was not the source of the country's financial distress.

There was also never a default. Colombo arranged a bailout from the International Monetary Fund, and decided to raise much-needed dollars by leasing out the underperforming Hambantota Port to an experienced company—just as the Canadians had recommended.

Before the port episode, "Sri Lanka could sink into the Indian Ocean and most of the Western world wouldn't notice," Subhashini Abeysinghe, research director at Verité Research, an independent Colombo-based think tank, told us. Suddenly, the island nation featured prominently in foreign-policy speeches in Washington. Pence voiced worry that Hambantota could become a "forward military base" for China.

Yet Hambantota's location is strategic only from a business perspective.

After the construction of the port in Hambantota, for example, Chinese firms and banks learned that strongmen fall and that they'd better have strategies for dealing with political risk. They're now developing these strategies, getting better at discerning business opportunities and withdrawing where they know they can't win. Still, American leaders and thinkers from both sides of the aisle give speeches about China's "modern-day colonialism."

Chinese firms are not the only companies to benefit from Chinese-financed projects. Perhaps no country was more alarmed by Hambantota than India, the regional giant that several times rebuffed Sri Lanka's appeals for investment, aid, and equity partnerships. Yet an Indian-led business, Meghraj, joined the U.K.-based engineering firm Atkins Limited in an international consortium to write the long-term plan for Hambantota Port and for the development of a new business zone. The French firms Bolloré and CMA-CGM have partnered with China Merchants and China Harbor in port developments in Nigeria, Cameroon, and elsewhere.

The other side of the debt-trap myth involves debtor countries. Places such as Sri Lanka—or, for that matter, Kenya, Zambia, or Malaysia—are no stranger to geopolitical games. And they're irked by American views that they're been so easily swindled. As one Malaysian politician remarked to us, speaking on condition of anonymity to discuss how Chinese finance featured in that country's political drama, "Can't the U.S. State Department tell the difference between campaign rhetoric that our opponents are slaves to China and actually being slaves to China?"

The events that led to a Chinese company's acquisition of a majority stake in a Sri Lankan port reveal a great deal about how our world is changing. China and other countries are becoming more sophisticated in bargaining with one another. And it would be a shame if the U.S. fails to learn alongside them.

- Substance abuse or alcohol use
- Smoking


High blood pressure—uncontrolled - It is quite common to check blood pressure of children in Europe from 10 years onwards in schools, then colleges and places of work. No student of any class will be able to join the new class before producing a medical certificate in which blood pressure levels are mentioned along with diabetes and lipid profile. Same holds true for employees. Let's do whatever we can that is under our control. This can be replicated easily in Kashmir with the help of government hospitals and NGOs.

- High cholesterol levels
- Lack of physical activity
- Childhood Obesity (must never be overlooked) Stress which is not treated.

If you have any of the above disorders, do not fret or think you will die. But do listen to your cardiologist or endocrinologist. However, steer clear of Google searches or local chemist's suggestions on whether to take medicine or not, they're often off the mark and say, "Ma khey Dawa, aadat gassi" /"do not take medicine as you get addicted to it". I have seen even highly educated people refusing to take life saving medicines.

One in three children in Kashmir is either overweight or obese, a study [2017] by SK Institute of Medical Sciences titled 'Prevalence of obesity and over weight in school children in Kashmir'. has revealed. The study that measured weight of over 9000 school children (between 5-15 years of age) across Kashmir's schools has stated that 34.5% boys and 38.4% girls were overweight and obese. If our children are not healthy, how can they become healthy adults?

It would be a ridiculous and a wrong statement to make if I were to say that all heart attacks are caused by overdose of drugs in Kashmir. However, we need to know about menace of drug abuse in Kashmir. A study conducted by Srinagar based Institute of Mental Health and Neuroscience (IM-HANS) in a Drug De-addiction centre in Srinagar, found that over two-third of patients in the study had started substance abuse in the age group of 11-20 years. The most common substances of abuse identified included nicotine (94.4%), medicinal opioids (65.7%), cannabis (63.6%), benzodiazepines (45.5%), other prescription medications (43.4%), alcohol (32.5%), inhalants (11.1%), and cocaine



(7.5%). The study revealed that poly-substance abuse was found in 91.9% of the studied patients. Inhalant use was seen predominantly among adolescents (54.5%) whereas nicotine (50.2%), cannabis (49.2%), alcohol (51.1%), opioids (58.4%), and benzodiazepines (53.48%) were more predominant in the age group of 21 to 30 years.

Heroin blocks your body from getting pain messages and slows your heartbeat and breathing. If you overdose, you may stop breathing and die. Data tabled in Rajya Sabha shows that the problem of drug abuse is such that India sees 10 suicides related to drug abuse- and only one of them is from Punjab.

Dr JPS Sawhney, chairman, Department of Cardiology, Sir Ganga Ram Hospital has said, Heart attacks take the maximum toll of human life all over the world. Heart disease is reportedly killing approximately 17 million people in the world, and a similar scene is seen in our country, where 3 million people die because of CVDs (cardio-vascular diseases), which include heart attack and stroke. About 14 lakh people are affected in the urban area and 16 lakh in the rural area.

On an average, Indians get a heart attack 8-10 vears earlier than other ethnic groups. The most unfortunate fact is that 40 percent of people in our country who get heart attacks are under the age of 55. It has been observed that 50 per cent of the heart patients have their first episode or first presentation as heart attack and 50 per cent will get a warning signal of chest pain (angina) followed by a heart attack.

Now, doctors in India are seeing parents bringing their children, even as young as 16 with symptoms of cardiovascular diseases. A 'First attack survey' done in the State-run Sri Jayadeva Institute of Cardiovascular Sciences found that 35% of the 2,200 patients registered with the first cardiac event in their lifetime were aged less than 35. A recent study by Harvard says "In a study of 3,564 men, the Framingham Heart Study evaluated the cardiac impact of six major risk factors: high total cholesterol, low HDL ("good") cholesterol, high blood pressure, diabetes, obesity, and smoking. A man who is free of all six has a remarkably low 5% risk of developing cardiovascular disease by age 95. In contrast, the risk for a man with two or more risk factors is 69%. In addition, a risk-free man can expect to enjoy 11 more years of life than a man with two or more risk factors.

Heart attacks more frequent in colder weather

quently in winter, a major Swedish study has confirmed. Published today in JAMA Cardiology the research found the incidence of heart attacks in a sample of more than one-quarter of a million people increased with lower air temperature, lower atmospheric air pressure, higher wind velocity and shorter sunshine duration.

They saw the most pronounced association with air temperature. An increase in 7.4 was associated with a 2.8% reduction of heart attack risk.

Doctors have long acknowledged heart attacks are more likely to occur in cold weather. Every medical student over the past five decades has seen medical artist Frank H Netter's classical illustration of a middle-aged man clutching his chest as he steps out of a warm building into a cold winter's night.

Not all heart attacks are typical but in the mind of Netter and his medical advisers of the time, there is nothing more typical than that.

It is well documented that heart attack rates rise soon after a major natural disasters such as an earthquake, volcanic eruption or tsunami. These probably bring forward the timing a heart attack that was going to happen anyway as there are slightly fewer heart attacks a few

But natural disasters are of course unpredictable, so we can't prepare for them in the same way as some natural rhythms: night and day, summer or winter, wet or dry seasons. This is why research that confirms something we can plan for is a risk factor is important.

Predicting heart attacks

Reasons for why someone is prone to a heart attack are clear. These are obvious risk factors such as high blood pressure, abnormal cholesterol, smoking or diabetes as well as unseen underlying genetic and environmental factors. But the the reasons for the timing of heart attack are more difficult to understand.

Atherosclerosis, the underlying disease process leading to blockage of a coronary artery and heart attack, develops over many decades. There appears to be randomness to when thrombosis, the blood clot that forms in a vein or artery



and causes the final and sudden event, occurs. It can occur during sleep, emotional stress and extreme physical activity but more commonly, it occurs when not

much is happening at all. Then there are other people with advanced coronary artery disease who have never had a heart attack. If we knew more about the short-term triggers, we could help people with coronary disease avoid some of them. And if we knew some of the longer-term influences on rates, we could tailor scarce resources in the emergency and health systems to be ready for peak periods.

Why is winter riskier?

There is a clear association between cold and artery function (the vessels that deliver oxygenated blood from the heart to other parts of the body). This can be illustrated by a common physiology lab manoeuvre known as the cold pressor

test. People are asked to put their forearm into iced water. Blood pressure rises immediately because arteries constrict, presumably to maintain core body temperature at normal levels.

Simple hydrodynamics tells us constriction is more profound and impacts more on the flow through a tube – in this case a coronary artery - at points of obstruction. In a few people with coronary disease the cold pressor test is enough to cause the artery to spasm and for flow to

cease until the artery relaxes again. But there are other factors that make heart attack more likely in winter than in summer. In many places, air pollution is more common, and evidence is accumulating that certain particles in the air are related to heart disease. Winter is also flu season, which makes people already at risk of heart disease more vulnerable.

And our life is very different in winter than in summer. Studies performed by myself and my colleague Dr Gillian Deakin while she spent a year on a pothis. In winter it is always dark, and the weather prevents expeditioners doing much outside activity; they tend to put on weight and drink more alcohol.

Inevitably emotions are high when a disparate group is confined to a small area for a long time and away from their families and other everyday supports. Not surprisingly, their heart health was not the same as when they arrived. Blood pressure was higher and the metabolic pattern of their blood less healthy. This was remedied with a regular supervised exercise program.

In summer there was a general feeling of "joie de vivre" as expeditioners conducted most of their work activities for the year. These often involved long hikes, moving large items of equipment and other physically demanding tasks. More light and milder weather allowed more time for outside leisure activities too as they explored the extraordinary Antarctic landscape and fauna.

Their blood pressure and metabolic profile improved markedly. The same exercise program they had undertaken in winter did little to improve these further as they were already at peak or near peak

What about heat?

This is an extreme example of what happens to many of us in temperate climates across the seasons and most smaller studies have reported a similar pattern to Sweden. Sudden variations in temperature also seem to be associated with heart attacks.

In Sweden and Antarctica there are very cold winters and much warmer summers. What about in the tropics where extreme heat is a defining climatic feature. A study in Pakistan also found a winter peak in admissions to coronary care units in winter. However, there was another peak in mid-summer when temperatures were highest.

So, by all means keep warm and comfortable in winter but get out and do something too. Look after your risk factors and see your doctor regularly for a heart check.

Bolder climate action could save millions of lives each year by 2040

Countries could save millions of lives annually by 2040 if they commit to bolder plans to cut planet-heating emissions and curb global warming in line with the goals of the Paris Agreement on climate change, researchers said on Tuesday.

A study published in The Lancet Planetary Health journal found policies to that end could, each year, save 5.86 million lives due to better diets, 1.18 million lives from cleaner air and 1.15 million lives through more walking and cycling by 2040.

In 2015, governments set a global goal of limiting average temperature rise to "well below" 2 degrees Celsius above preindustrial times and set emissions reduction targets as a first step to getting there.

On Monday, however, UN Secretary-General Antonio Guterres urged countries to take bolder action ahead of November's COP26 UN climate conference and come up with stronger 2030 targets consistent with cutting emissions to net zero by 2050.

The new research highlighted how the potential health benefits of climate

action could give added impetus to countries to submit more ambitious national climate plans ahead of COP26.

The nine countries modeled in the study - the United States, China, Brazil, Germany, India, Indonesia, Nigeria, South Africa and Britain - represent half of the world's population and 70% of global emissions.

Six of them have yet to submit revised climate action plans, which were due in 2020 but put back by many countries as the COVID-19 pandemic delayed the climate summit for a year.

"Ahead of COP26, we'd like to see governments focus on health as one of the priorities in climate change policies," said lead author Ian Hamilton, executive director of The Lancet Countdown on Health and Climate Change.

"There's good evidence to show that meeting the Paris Agreement commitments will be good for our health, and that these benefits accumulate to those individuals in the countries taking leadership,' he told the Thomson Reuters Foundation. SHORT-TERM WINS

Using national and international data, the study analysed emissions generated by the energy, agriculture and transport sectors, along with factors like national diets and lifestyles.

The researchers modeled the scenarios required for each country to meet the Paris accord, including changes like adopting cleaner energy and reducing car use, as well as to achieve global development goals such as zero hunger.

They found that changes towards "flexitarian" diets - with moderate amounts of animal-based foods and a high share of plant-based foods - offered the greatest health benefits as well as reducing carbon emissions.

For example, many deaths would be avoided by lower rates of non-communicable diseases such as obesity and heart disease, connected to excessive consumption of carbon-intensive red meat and processed foods, and lack of access to fruit and vegetables.

"Why wouldn't we prioritize investments that will save more lives nearterm if they give us the same amount of carbon value?" said Aaron Bernstein, interim director of The Center for Climate, Health, and the Global Environment at the Harvard T.H. Chan School of Public Health.

Changing diets is a complex challenge for governments, he noted, but potential ways to do it include subsidizing healthier foods and putting a price on the emissions produced by more carbonintensive foods that require a lot of natural resources

Beef production, for instance, fuels greenhouse gas emissions as carbonstoring forests are cut down for pasture and cattle burp out methane.

A focus on health is one way to make climate action more personal and appealing, Bernstein added, instead of being framed as a cost now that will bring benefits for future generations.

"We have to make this issue relevant to today, and (talk about) improving the welfare, economic opportunities and health of people in a time frame that they can get their heads around," he said.

A separate study out on Tuesday found pollution from burning fossil fuels causes one in five premature deaths globally, totaling 8.7 million in 2018 and suggesting the health impacts of those emissions may be far higher than previously thought.

No Airline Has Shown Interest In Regular International Air **Service From Srinagar**

The Centre also submitted that the infrastructure for undertaking international flights from Srinagar Airport is in place.

"However, no regular international flights are operating from there and therefore, necessary immigration and custom staff is not posted on permanent basis. The officials of Immigration and Customs, work from Srinagar Airport only during Hajj flights," it further reads. --With inputs from KNO

Fuel Prices Hiked For Fourth Day, Petrol Reaches Record-High In Delhi

and diesel prices soared to record highs on Friday after rates were hiked for the fourth day in a row. Petrol price was increased by 31 paise per litre and diesel by 35 paise a litre, according to a price notification of stateowned fuel retailers.

This took petrol price to an alltime high of Rs 88.14 a litre in Delhi and to Rs 94.64 in Mumbai. Diesel rates rose to Rs 78.38 per litre in the national capital and to an all-time high of Rs 85.32 in Mumbai.



In four days, prices have gone up by Rs 1.21 per litre for petrol, while diesel has risen by Rs 1.25 a litre.

Oil Minister Dharmendra Pradhan on Wednesday had told Parliament that the government is not considering a reduction in excise duty to cool rates from their record highs.

Rates have risen as international oil prices touched \$61 per barrel for the first time in more than a year on improving demand outlook amid the global rollout of COVID-19 vaccines, he had said.

Central and state taxes make up for over 61 per cent of the retail selling price of petrol and about 56 per cent of diesel.

Retail petrol rates have risen by Rs 18.57 per litre since mid-March 2020, after the government raised taxes by a record margin to mop up gains arising from fall in international oil prices. Diesel rates have gone up by Rs 16.09.

Parliamentary Panel On Defence Decides To Visit Galwan Valley, Pangong In Eastern Ladakh

NEW DELHI: The parliamentary standing committee on defence has decided to visit the Galwan Valley and Pangong lake in eastern Ladakh region which has been witness to a violent standoff between the troops of India and China, sources said on Friday.

30-member committee, chaired by senior BJP leader and former Union Minister Jual Oram and of which Rahul Gandhi is also a member, wishes to visit the eastern Ladakh region in the last week of May or in June.

The decision to visit these areas was taken in the panel's last meeting which was not attended by the Rahul Gandhi, sources said, adding since the panel intends to visit the LAC, it depends on the approval from the government.

After a nine-month standoff, the two militaries reached the agreement on disengagement in the north and south banks of Pangong lake that mandates both sides to cease forward deployment of troops in a "phased, coordinated and verifiable" manner.

On Thursday, Defence Minister Rajnath Singh made a detailed statement in Parliament on the disengagement pact.

According to the agreement, China has to pull back its troops to east of Finger 8 areas in the northern bank while the Indian personnel



will be based at their permanent base at Dhan Singh Thapa Post near Finger 3 in the region.

Similar action will take place on the south bank of the lake as well, Singh said in Parliament.

India has not "conceded" any territory to China by firming up an agreement on the disengagement process in Pangong Tso in eastern Ladakh, and other outstanding "problems" including in Depsang, Hot Springs ad Gogra will be taken up at the upcoming talks between military commanders of the two countries, the

defence ministry said on Friday. The statement by the ministry came hours after Congress leader Rahul Gandhi alleged that the government has "ceded" Indian territory to China and raised questions over the agreement on the disengagement process.

The ministry also dubbed as "categorically false" the assertion that Indian territory is up to Finger 4 in the Pangong Tso area, adding the permanent posts of both sides in the area are "longstanding and well-established".

"India has not conceded any territory as a result of this agreement. On the contrary, it has enforced observance and respect for LAC and prevented any unilateral change in the status quo," the ministry said in the strongly-worded statement.

The MEA also said the two countries have agreed to convene the 10th round of senior commanders meeting within 48 hours after complete disengagement in the Pangong Lake area to address the remaining issues, and added that no date has been set for Working Mechanism for Consultation and Coordination (WMCC) on India-China border affairs.

The agreement on disengagement in the north and south banks of Pangong lake mandates both Chinese and Indian sides to "cease" forward deployment of troops in a "phased, coordinated and verifiable" manner.

Appeals Court Won't Delay Ex-Cop's Trial In Floyd's Death

MINNEAPOLIS: The Minnesota Court of Appeals on Friday dismissed prosecutors' request to delay the trial of a former Minneapolis police officer charged in the death of George Floyd, saying that although prosecutors argued that COVID-19 was a risk, they didn't show that holding the trial in March would have a critical impact on its outcome.

The appeals court also dismissed the state's request to hold a joint trial for Derek Chauvin and the three other former officers who face charges.

Floyd, a Black man, died May 25 after Chauvin, who is white, pressed his knee against Floyd's neck while he was handcuffed and saying he couldn't breathe.

Chauvin is charged with second-degree murder and manslaughter. The other defendants, J. Kueng, Thomas Lane and Tou Thao, were charged with aiding and abetting counts.

Judge Peter Cahill ruled last month that Chauvin would stand trial on his own starting March 8 and that the other defendants would be tried together starting August 23, citing a lack of courtroom space due to COVID-19 safety protocols.

Prosecutors appealed, saying multiple trials would traumatize witnesses and the community, and that the evidence against all four defendants is

They also said all four officers



should be tried in the summer, when COVID-19 may present less of a risk. Pretrial appeals are rare and are only allowed in limited circumstances.

The appeals court found that prosecutors did not show that holding Chauvin's trial in March would have a critical impact on their ability to successfully prosecute the case, which is the threshold they need to meet for a pretrial appeal.

Because the state has not shown critical impact on the outcome of the trial, and there is no basis for this court to exercise inherent authority to review the pretrial rulings challenged by the state, these appeals must be dismissed, according to the decision.

The appeals court found that even though the state suggested in passing that its ability to prosecute the case might be impacted by COVID-19 if trial participants get sick and a mistrial results, in general, the state arguments related "not to the state's ability to prosecute but rather to public-health

The ruling says those concerns are important, but the judicial branch has safeguards in place.

The appellate court also said that while it doesn't dismiss concerns that COVID-19 could spread at protests or other activities outside the courtroom, "we are not persuaded that the concerns establish a rationale for appellate jurisdiction.

Prosecutors didn't immediately respond to a message seeking comment and it wasn't clear if they planned to appeal to the state Supreme Court. Chauvin's attorney, Eric Nelson, declined to comment.

The appellate court also declined to consider the state's request to issue a writ of prohibition," in which it could order the lower court not to proceed.

The appeals court said a write of prohibition is an extreme remedy, and a district court has discretion in making decisions on whether to postpone trials or try multiple defendants separately. (AP)

There were no immediate reports of destruction or casualties.

Some reports suggest that the quake also jolted parts of Afghanistan and Central Asia. In the region the earthquake was felt in Delhi, Punjab and parts of Pakistan including

Lahore, Islamabad and Rawalpindi. Earlier an earthquake of magnitude 3.5 on the Richter scale occurred in Gulmarg on Monday morning, according to the National Centre for Seismology

Having impact-based forecasts of flood risk will be useful for efficient and effective contingency planning and swift evaluation of severity for necessary response, Sinha said.

The spokesman said the framework, using earth observation (EO) based information, will be capable of being linked to any existing or future flood flow forecasting system.

While quashing the criminal proceedings, the court underlined that for making out an offence under Section 124A, 153A, 153B and 505(2) IPC, it is necessary to demonstrate that the words written or spoken or signs or visible

"The provisions of Section 196 Cr.P.C. do not, in any manner, control Section 154 of the Code of Criminal Procedure, in that, the police is competent to register an FIR, if information received by it discloses commission of cognizable offence, even if it is referable to Section 196 Cr. P. C," the court concluded, adding, "The police, who are competent to register FIR under Section 154 Cr. P. C., are equally competent to investigate the same and present the final report before the Court."

Section 196 Cr. P. C., Justice Sanjeev Kumar said, would come in operation at the stage of taking of cognizance by the Court and it will refuse to take cognizance of the offence(s) referable to Section 196 Cr. P. C., if there is no previous sanction by the Central Government or State Government or District Magistrate, as the case may be. "That in case, challan with regard to the offence(s) having reference to Section 196 Cr. P. C. is presented before the Judicial Magistrate without obtaining prior sanction from the competent authority, the Court shall not take its cognizance but return the same to be presented only after seeking previous or prior sanction of the competent authority."

The Court shall be deemed to have taken cognizance only if it applies its mind to the Final Police Report submitted before it in terms of Section 173 Cr. P. C. with a view to proceed further in the manner provided in law, Justice Sanjeev Kumar said. "That the Magistrate, who finds the police report not in consonance with Section 196 Cr. P. C. shall not retain the challan and proceed in the matter rather it would return the same to the prosecution." (GNS)

Australian Open To Continue With No Crowds Amidst A Fresh COVID-19 Lockdown

MELBOURNE: The Australian Open will be allowed to continue but without crowds for at least five days after the Victoria state government imposed a lockdown starting Saturday in response to a COVID-19 outbreak at a quarantine hotel.

Victoria Premier Daniel Andrews on Friday announced a five-day, statewide lockdown starting a minute before midnight local time, imposing new restrictions that restrict residents to their homes except for work, to shop for essential supplies, care or care-giving, and limited exercise.

He said the Feb. 8-21 Australian Open could continue "because these people are at their workplace."

The minimum number of staff for it to be run safely, will be there," Andrews said. "It will be happening, but there'll be no one there watching it." Schools and universities will be closed Monday through Wednesday,

and there will be no gatherings permitted for weddings or religious services. Fans arriving at Melbourne Parl on Friday before the new restrictions were announced were instructed at

the entrance gates to maintain socialdistancing, apply sanitizer to their hands and pull their masks up over their noses. With three big night matches

scheduled for Friday, fans will be permitted to enter Melbourne Park. But Andrews' urged people to exercise good judgement" and not go out.

Andrews said the measures were a short, sharp circuit breaker" in a bid to avoid a bigger, longer lockdown as the state combats a hyper-infectious," strain of the coronavirus. Andrews said the guiding prin-

ciple of the restrictions was that if people could work from home, they should work from home. Of the Australian Open, he said,

All players, staff and officials who arrived on charter flights for the tournament, a total of about 1,200 people, had to do a mandatory 14day hotel quarantine. Of those, 72 were forced into a hard lockdown after being deemed close contacts of passengers on their charter flights who tested positive for the virus after landing in Australia.

The Australian Open was the first Grand Slam tournament in a year to allow sizeable crowds

After the COVID-19 outbreak became a pandemic, Wimbledon was canceled, fans were not allowed at the U.S. Open and the number of spectators at the French Open was heavily restricted.

Under the initial plan for the Australian Open, the government allowed up to 30,000 people daily at Melbourne Park, or about 50% of capacity. The biggest daily attendance in the first four days was 21,010 on Thursday

The cluster of COVID-19 cases linked to hotel quarantine at the Holiday Inn at Melbourne Airport grew to 13 on Thursday night, with five new cases emerging, including two household contacts of existing cases. These were the first cases linked with the cluster who had not been inside the hotel.

Andrews met with senior cabinet ministers and health officials overnight and had discussions with other federal and state government leaders.

Australia has 909 deaths attributed to COVID-19, including 820 in Victoria state. Most of those were during a second deadly wave last year when a hard lockdown and overnight curfews were put in place in Melbourne.

The lockdown then lasted 111 days. All non-essential businesses and schools were closed, and residents were initially permitted to leave their homes for just an hour each day. A nightly curfew was imposed for weeks.

The extreme measures did succeed in stamping out the virus. Victoria had gone 28 straight days without a locally acquired case.

Australia's states and territories have also been quick to close their borders when small outbreaks have occurred. South Australia closed its borders to travellers from greater Melbourne at midnight on Thursday. Other states were imposing travel restrictions starting on the weekend.

One up in the four-match series, England are in contention for the only available spot for the inaugural ICC World Test Championship final at the Lord's from June 18-22.

England know that two more wins in their remaining three Tests in India will see them qualify for the WTC final against New Zealand. Root and Co will take on Kiwis in a two-Test series at home be-

fore the coveted five Tests Ashes against Australia series Down Under. They also host India for five Tests starting August. "With the amount of Tes

et in particular this year, didn't feel like it was the right time, didn't feel like I could throw all my energy into it, which I think it deserves.

"I don't think it would serve English cricket best with what's to come... So, a very difficult decision. Hopefully next year, there's more of an opportunity to potentially be a part of the IPL, or at least be in the auction."

Kohli's India Seek Redemption In Chennai Against A Confident England Side

CHENNAI: A desperate India have decided to go for the jugular by opting for a spicy turner against a well-prepared England side in the second Test starting Saturday, well aware that it can boomerang and cost them a spot in the World Test Championship final.

The honeymoon of the Australian series is over after a sobering 227 run defeat in the first Test which must have shaken a complacent team out of its stupor ahead of three high stake Test matches.

But it is a perfect stage for India's mercurial skipper Virat Kohli, who loves to bring his A-game to the fore when the chips are down.

With the crowd back inside the heated cauldron ready to egg him on, something he thrives on, the Indian captain would be eyeing a good slugfest against a very resolute opposition. India need to win two matches and not lose any of the games to make the WTC final.

England will have a new wicketkeeper in Ben Foakes and Stuart Broad will replace James Anderson as part of workload management. Also in the mix is Moeen Ali, a known nemesis of India,

in place of last match's first innings top wicket-taker Dom Bess.

Jofra Archer's elbow injury might make way for bowling all-rounder Chris Woakes, who is a handy batsman apart from being a fine pacer in his own right.

"Jofra is a slight setback but hopefully he is fit and ready for the third Test," skipper and the team's No 1 batsman Joe Root said on the eve of the game. A look at the newly-laid dark coloured

Chepauk track is an indication that unlike the strip used during the first Test, this one will offer turn earlier than expected. Ravichandran Ashwin will need a lot of support from the other end in terms

of both restrictive and attacking options. A fit-again Axar Patel is the closest to being a like-for-like replacement for an injured Ravindra Jadeja. Patel's Test debut looks imminent as Ashwin will need someone to hold on at the other end.

However, one can't be so sure about Kuldeep Yadav, who in his short six-Test career, has played some tough games. He would fancy his chance for being

a better attacking option than Washington Sundar, but on a rank turner where batting becomes important, all-rounder Hardik Pandya can come into the fray.



The 20-year-old Washington might go on to to become a fine all-rounder in the Ravi Shastri mould in the coming years but as of now, he is not good enough to play as a specialist third spinner.

Kuldeep is an excellent attacking option but the team management's continued reluctance to play him is an indication of lack of faith in the Uttar Pradesh wrist spinner's abilities of late.

Hardik, on the other hand, might just be able to score those quick runs against spinners and bowl 8-10 overs which is the maximum that is required from a fifth bowler on a friendly pitch.

The Indian team management, after a drab first two days at the Chepauk during the opening game, had two options going into the second Test.

The first option was to leave a liberal sprinkling of grass and then get tested by the Anderson-Broad duo, who would have got the SG Test to land on seam and move around off the pitch.

The second option, which they have

taken is shaving off the grass and very

North India Fears Another Flash Flood From New Lake

NEW DELHI: A newly formed Himalayan lake raised fears on Friday of another flash flood above a disaster-hit valley in northern India, prompting authorities to conduct helicopter surveys and send a team on a 16-hour climb to investigate

Thirty-six people died and 168 are still missing after a barrage of water and debris hurtled down

the valley in the northern state of Uttarakhand with terrifying speed and force on Sunday, obliterating roads and bridges and smashing through dams.

The flash flood on the Rishiganga river is thought have been triggered by a chunk of glacier breaking off, or a glacial lake -- formed when a glacier retreats -- bursting its banks. Glaciers are receding fast in the

region due to global warming. On Thursday, geologists said

that a new lake had formed near the same river.

Naresh Rana, a geologist at Hemwati Nandan Bahuguna Garhwal University, released a video shot in the area, in which he pointed out the location of the lake and said, "this means that the Rishiganga will breach again."

Satellite images and a helicopter survey had confirmed the presence of the lake, senior local police official Ashok Kumar told AFP.

He said that teams had been sent to investigate on foot, a trek that would take around 16 hours, with the spot at around 4,200 metres above sea level.

"But there is one important thing to note. For the last few days, there was less water flow in the Rishiganga. But since yesterday, the flow is a lot," Kumar said.

"That means that the lake has given some opening. It would have been dangerous if the water had just been

A desperate and arduous search continued on Friday to reach around 30 people trapped in a tunnel since Sunday's flood, with hopes fading for their survival.

"We are trying to go to the smaller tunnel which is 12 metres below the existing one," Kumar said.

"In the small tunnel, we are hoping for the best... If they escaped the slush and the water, they might be safe in one corner."

Scientists Hail Weight Loss Drug As 'Game Changer' **In Fighting Obesity**



LONDON: Scientists have described a drug which hijacks the body's appetite system as a potential "game changer" in treating obesity after research showed it could cut body weight by up to 20 percent.

The results from the large-scale international trial, which were published in the New England Journal of Medicine, showed more than one-third of those who took the drug semaglutide lost over

The study, which involved almost 2,000 people in 16 countries, also showed three-quarters of those who took the drug lost more than 10 percent of their bodyweight.

The drug is currently used to treat diabetes and works by altering appetite regulation to reduce calorie intake.

One of the main authors of the study, Rachel Batterham from University College London, called the study a "major breakthrough".

Scientists have looked for existing, low-cost medications to help severely ill Covid-19 patients as more elaborate treatments disappoint. One of the biggest successes so far has been dexamethasone, a steroid that has



been shown to reduce the risk of death by one-third for patients on ventilators.

The findings on blood thinners are based on data from more than 4,000 patients, mostly men, from the U.S. Department of Veterans Affairs. They were hospitalized between March 1 and July 31 with Covid-19. The patients getting anticoagulants didn't have an increased risk of bleeding, according to the study.

The study is based on observation, which means the results need to be confirmed by clinical trials and some are underway, the scientists said. The drugs may show a result because blood clots developing in major veins and arteries could be to blame for Covid deaths, according to the research.

UK Scientists Develop Urine Test To Detect Womb Cancer



NEW YORK: The findings, published in the journal Nature Communications, showed analysis of the samples correctly diagnosed 91.7% of women with womb cancer

British scientists announced on Friday they had developed a test to detect womb cancer using urine samples, explaining the method could replace a painful and invasive procedure currently in use.

At present, clinicians diagnose the cancer by taking a biopsy, a process which requires a narrow telescope called a hysteroscope, to examine inside of the uterus and

Nearly a third of women who undergo the procedure have the process repeated because of technical difficulties or intolerable pain, the research showed.

Thousands of women in Britain who do not have womb cancer also undergo the procedure, with huge financial implications for the country's state-run National Health Service (NHS)

The study from Manchester University has developed a new detection tool which examines urine or vaginal samples that can be collected by women on their own at home.

The findings, published in the journal Nature Communications, showed analysis of the samples correctly diagnosed 91.7% of women with womb cancer.

The proportion of women without womb cancer who tested negative with the new tool was 88.9%, the study showed.

"Our results show that womb cancer cells can be detected in urine and vaginal samples using a microscope," said Professor Emma Crosbie, who led the study. "Women who test positive with

this test could be referred for diagnostic investigations while women who test negative are safely reassured without the need for unpleasant, invasive, anxiety-provoking and expensive procedures." The new tool was first trialled

on 103 women with known cancer and 113 with unexplained postmenopausal bleeding and could be brought into clinical practice once expanded trials have concluded. Womb cancer is the sixth most

common cancer in women, with an estimated 382,000 new diagnoses and 89,900 deaths from the disease in 2018 worldwide, the university said.

While most women receive early treatment after the onset of symptoms, which include bleeding after menopause, 20% of women who are diagnosed at an advanced stage have only a 15% chance of surviving beyond five years.

Imagine Life Without Google, Australia Faces The Unthinkable



SYDNEY: Imagine a world without Google, the search engine so pervasive it's the starting point for more than five billion queries a day. That's the reality facing Australia, where the tech giant is threatening to unplug its homepage in a standoff with the gov-

Google opposes a planned law that would force the company and Facebook Inc. to pay Australian publishers for news content. The Internet juggernaut's ultimatum to local lawmakers -- change the legislation, or else -- has left a digital vacuum hanging over a nation that essentially knows just one way to navigate the web. Google runs

95% of Internet searches in Australia. Potential fallout from the spat goes far beyond Australia for Alpĥabet Inc.-owned Google, whose dominance of global advertising has made it a target for watchdogs worldwide. If the company backs down in Australia, the pay-for-news law risks becoming a template for jurisdictions including Canada and the European Union that are following the quarrel and keen to shorten Google's lead.

But disabling what is arguably the world's most famous website would hand all of Australia to rivals, including Microsoft Corp.'s Bing and Duck-DuckGo, which have failed to dislodge Google as the gateway to the web. These search-engine competitors would suddenly have a playground for development and a foothold to advance on the global stage.

Software-engineering student Patrick Smith exemplifies Australia's Google dependency. The 24-year-old from Canberra said he sometimes racks up 400 Google searches a day to help with his studies, catch up on news and look up recipes. Smith said his browser from the previous day shows 150 searches -- in the space of just five hours.

"The prospect of Google search disappearing is frightening at best," Smith said. "It's quite reflexive of me to Google something, anything, that

I'm even mildly not sure of." Searching for 'best beach Sydney' shows the variance in performance among Google's competitors. Duck-DuckGo's first result was an ad for a hotel more than 1,000 kilometers away in Queensland, with Sydney beach reviews listed below a second ad link. Search Encrypt, which touts its data-protection capability, said: 'It looks like there aren't any great matches.' Bing's initial suggestion was Bondi Beach Post Office. Only Google returned a real beach, Bondi,

first up.

World-First Legislation

The world-first legislation will be considered by Australia's parliament from the week starting Feb. 15 after a Friday that the bill be passed.

"The government expects all parties to continue to work constructively towards reaching commercial agreements," Treasurer Josh Frydenberg said in a statement welcoming the senate report.

The government says the local media industry -- including Rupert Murdoch's News Corp. and Sydney Morning Herald-publisher Nine Entertainment Co. -- has been bled of advertising revenue by the tech giants and should be paid fairly for content.

Google argues it drives traffic to their websites, and that being forced to pay to display snippets of news breaks the principle of an open Internet. It also opposes the law's final-offer arbitration model that determines how much it should pay

Facebook has said it may stop Australians from sharing news on its platform if the law is enacted, an unprecedented step.

Australia's entire economic output is less than Alphabet's \$1.4 trillion market value, so it may be surprising the distant and tiny market is suddenly so important. But the Internet titans are so keen to avoid Australia setting a global precedent that Alphabet Chief Executive Officer Sundar Pichai and Facebook's Mark Zuckerberg broke into their diaries in recent weeks for phone hookups with Prime Minister Scott Morrison or his minis-

Sniffing an opportunity, Microsoft President Brad Smith and CEO Satya Nadella also reached out.

Grabbing the free hit, Smith told Morrison that Microsoft would invest to "ensure Bing is comparable to our competitors." This week, Smith wrote in a blog post Thursday that the U.S. should adopt its own version of the Australian law.

DuckDuckGo, a search engine that says it doesn't track its users, is also trying to cash in.

"There's a growing global demand for privacy online and Australians don't have to wait for government action" to stop using Google, Duck-DuckGo said by email. Search Encrypt says its results expire after 30 minutes of inactivity.

UP Cops File Case Against Google's Sundar Pichai, Then Drop His Name

VARANASI: Police in Uttar Pradesh's Varanasi had charged Google CEO Sundar Pichai and 17 others last week over a video that allegedly defamed Prime Minister Narendra Modi but later removed the tech giant officials' names from the FIR, police officials said today.

The names of Sundar Pichai and three other top officials of Google were removed after they were found not involved in the case, a police official privy to the probe told news agency Press Trust of India over the phone.

The First Information Report or FIR was filed following a complaint by a local resident who claimed that he got over 8,500 threat calls on his mobile video that he first came across musicians who allegedly made



in a WhatsApp group and later on YouTube, where it has over five lakh views, the officials said.

Besides Sundar Pichai, others named in the FIR are three Google India officials including Sanjay Kumar Gupta, according to the case filed at UP's Bhelupur police station on February 6. Google's response over the case

Among the rest named in the FIR are Chazinur district-based

the video song, a recording studio and a local music label company. The FIR has been lodged under Indian Penal Code sections

504 (intentional insult with intent to provoke breach of the peace), 506 (criminal intimidation), 500 (defamation), 120B (party to a criminal conspiracy). Charges under the Informa-

tion Technology Act's section 67 (publishing or transmitting obscene material) have also been invoked against the accused, according to the FIR, which has been accessed by news agency Press Trust of India.

The names of Google officials were removed from the FIR the same day as it turned out that they were not involved in the case. Investigation on other points is underway, an official from the local Bhelupur police station told news agency PTI.
