Study Sheds Light On Solutions For Overeating

cience is a step closer to a new response to obesity, thanks in part to a study conducted by a team at The University of Texas at El Paso.

The 10-member team led by Brandon Warren, Ph.D., assistant professor of pharmacodynamics at the University of Florida, made discoveries about a specific area of the brain tied to recollection and the desire to seek and consume food. It could lead to a way to inhibit the desire to overeat.

Iniguez, who directs UTEP's Iniguez Behavioral Neuroscience Lab and helped design novel experimental techniques for the research, said that people tend to overeat when exposed to cues or environments that remind them of treats, which is one reason why people opt for dessert even after a filling meal.

The study showed that neurons in a specific part of the brain control the link between the cue (seeing



the dessert) and the action (ordering the dessert). Iniguez and team found that animal subjects consumed fewer treats when they regulated that region of the animal's brain.

The techniques and the data eventually could help overcome some issues linked to obesity such as stroke, Type 2 diabetes, high blood pressure, high levels of bad choles-

terol, and coronary heart disease. "This is a big discovery because we now have experimental tools that allow us to turn off neurons while the subjects engage in a specific behavior," Iniguez said.

"This research shows that a specific part of the prefrontal cortex of the brain is important for the initial stages of learning to seek food."

SRINAGAR: The impasse between the administration and mutton dealers over the prices in Kashmir Valley is likely to end as the trade body Kashmir Economic Alliance's 'fact-finding' committee covering meat prices in outside markets has submitted its report to the authorities.

Led by Farooq Ahmed Dar, Convener of the Committee and Co-Chairman of Kashmir Economic Alliance, the members of the Committee on Monday submitted the report to the Director, Department of Civil Supply, Consumer Affairs and Public Distribution and Divisional Administration.

Bi-lingual 18 page report, compiled in Urdu and English features the prices of meat in Delhi, Rajasthan, Ambala and Amritsar markets.

'JEHAD' TO END IF INDIA WITHDRAWS FROM KASHMIR: LASHKAR

NEW DELHI - Hafiz Mohammad Saeed, the chief of Lashkare-Taiba, has said the "jehad" against India over the Kashmir issue would end only if Indian security forces were with-

drawn, from the stale. Until then, Saeed said, his organization would continue to target Indian leaders including Prime Minister Atal Bihari Va-jpayee and Home Minister Lai Krishna Advani, and carry out more strikes like the De¬cember 24 attack on an Indian Army camp in the Red Fort here.

If Vajpayee seriously wants to solve the Kashmir dispute, then he should order the with-drawal of India's 800,000 secu¬rity forces from Kashmir. Then we can stop our jehad, Saeed told "Aai Tak" an television news channel, in an interview Tuesday evening.

The interview, conducted somewhere in Pakistan, is prob-ably the first by Saeed to an In-dian news organization. Saeed heads the Markaz Ad-Da'awa Wal Irshad, the ideological par-ent of the Lashker which has its headquarters at Muridke near Lahore in Pakistan.

Saeed said he would person-ally ensure that the Lashkar 'and other groups engaged in the violent movement in Jammu and Kashmir would end their jehad if India with-drew its forces from Kashmir. The Lashkar leader rejected India's unilateral cease-fire cur-rently in force in Jammu and Kashmir, saying the principal reason for his stand was the "total distrust" of India's promises. The cease-fire, which began November 28, has been extended twice and is scheduled to end February 26.

"We have suffered one cease-fire earlier. In 1948, when we started our jehad for Kashmir's independence, a cease-fire was called and we participated in it by stopping the jehad. But India has only increased the strength of its security forces in the 40 years since then," Saeed said. Saeed said it was not possi-ble to talk of ending the jehad

when such a large contingent of Indian security forces was sta-tioned in Jammu and Kashmir. He alleged the Indian forces were responsible for terrorizing the Kashmiri people while be-coming an instrument of their oppression.

Significantly, Saeed claimed the Lashkar was re-ceiving arms from Indian sol-diers who were smuggling weapons to the militant group on the sly. He claimed that the Lashkar had no links with Afghanistan's Taliban regime.

The Lashkar ideologue did not find fault with the "political approach" adopted by the All Party Hurriyat Conference (APHC) to deal with the Kashmir problem.

'They want to solve the dispute politically while we want to do it by jehad. But our goal is one and that is the independence of Kashmir. It makes no difference that our methods are different," Saeed said.

Let more Gulmargs bloom

fter more than three years, tourists have from all across the country have begun to wend their way back to Kashmir. This winter has witnessed a good number of tourists visiting the Valley, something that has come as a boon for the Valley's battered economy. The statistics about tourist arrivals paint a happy picture of the tourist sector. According to tourism department data, this year, in January alone, a total of 46383 tourists visited Gulmarg. As against this, 98,757 tourists visited Gulmarg for the entire last year. This is a welcome change. For almost 17 months, the tourism sector in J&K lay decimated. The siege following revocation of Article 370 on August 5, 2019 and later the Covid-19 lockdown made Kashmir out of bounds for the holiday makers. Thousands of people associated with the sector lost their jobs as the health resorts and the hotels were deserted.

Following Covid-19 lockdown, the J&K administration released a stimulus package of Rs.5.67 crores for tourism sector. The benefit of Rs.1000 per month was later extended for a period of six months and an amount of Rs 618.70 Lakh has recently been approved for the tourism stakeholders. But the growing tourist arrivals since have buoyed up the sector. According to tourist department figures, the hotels in Gulmarg are occupied until March. Similarly, the tourist spots like Pahalgam are seeing the rush. But it is Gulmarg which is the go to place. This is because Gulmarg has received most of the publicity. Adding to Gulmarg's appeal is that it is also the skiing destination. But the excessive focus on Gulmarg is drawing tourists away from other equally scenic places, some of them like Aharbal, Yusmarg, Tosamaidan, Gurez, historic old city in Srinagar have only recently found a prominent place on the tourist map of Kashmir. These places need development of tourist infrastructure and also a wider publicity for people to visit.

Going forward, the tourism department has to work hard to ensure that more people from across the country are persuaded to visit Kashmir. The visits by the tour operators and also the Bollywood producers has played their due role in bringing tourists back. But it is also true that the spike in tourist visits to Kashmir is in some part the result of the ongoing ban on international travel due to Covid-19 pandemic. And once the world recovers from the pandemic and in the international travel is restored, Kashmir will be in direct competition with the international tourist destinations. So, the tourism department has to prepare for this turn of events. Even when international travel is restored, there will be enough tourists in the country who will be happy to come to Kashmir provided Kashmir is sold as one of India's most sought after tourist destination through coordinated promotional activities.

Death trap: On Labour reforms

housands of workers in Tamil Nadu's famed fireworks industry remain trapped in unsafe conditions despite an unending series of accidents that keeps drawing attention to their plight. In the latest accident at a fireworks unit in Virudhunagar, at last count, 20 lives have perished, while 28 workers are in hospital. Such tragedies, caused predominantly by gross violation of norms governing the hazardous industry and human error in handling explosive substances, have occurred with some regularity now. In 11 months, 25 lives were lost in major blazes in three other fireworks factories in Virudhunagar (9), Cuddalore (9), and Madurai (7). Most victims were women. While the dead end up in statistical records, on the ground there is only short-term action: registration of cases, arrests, identification of causes, token inspections, issuance of warnings and safety advisories. The causes are well documented. Unlicensed units that have mushroomed in and outside Sivakasi mostly escape scrutiny till explosions occur. A greater concern is the illegal sub-leasing of contracts for manufacturing crackers by licensed units. Preliminary investigation into the current tragedy has also revealed sub-leasing of works to several persons. The very nature of work in a hazardous industry makes sub-leasing a byword for safety compromise. It leads to conversion of every shed in a manufacturing unit into a 'factory' in itself with inflammable chemicals stored all over. Consequently, the limit on workers to be deployed is violated resulting in crowding in each shed. Supervision of the quantum of chemicals to be mixed or stored — a key task to avoid friction becomes a casualty. Untrained workers and the piece-rate system, which induces people to race to produce more units per day, have also caused accidents. Evewitness accounts suggest that in the latest accident, a worker, possibly fatigued, had hurriedly emptied semifinished crackers triggering an explosion. While the Petroleum and Explosives Safety Organisation offers training for workers, shortage of labour has prompted the industry to hire new recruits with limited skills. The industry continues to be labourintensive, although a decade ago Parliament was informed that automation of the hazardous manufacturing process would be undertaken. Periodic inspections at factories, sustained crackdown and stringent penal action against violators are nonnegotiable. For this, Central and State governments must provide the needed manpower for enforcement agencies as the industry has grown manifold. A sustained political push for labour reforms and technological innovations within the industry is also essential. After all, there can be no joy during any celebrations using fireworks if those making it lead a life of dangerous uncertainty.

The Russian Affair

The recent demonstrations in Russia might have raised the West's hope to see an end to the Russian oligarchy, but it may turn out to be a wishful dream

ver the last two weeks, many Russian cities including Moscow and St. Petersburg witnessed a second wave of public demonstrations in support of opposition figure Alexei Navalny.

However, the demonstrations were mostly against Kremlin's policies and less in Navalny's support. In most cities, demonstrators expressed frustration with Russia's coronavirusrelated lockdown measures, anti-Putin sentiments and government's actions against other anti-establishment political activists.

Putin-Navalny Fight

Russian opposition leader, politician, lawyer, and anti-corruption activist, Alexei Anatolievich Navalny came to international prominence by organising anti-government demonstrations and running for office to advocate reforms against corruption in Russia, President Vladimir Putin and his government.

Navalny's video of Putin's alleged palace on Russia's Black Sea coast has now been viewed more than 111m times. His detention and court appearance prompted the biggest street protests in Russia since 2011-12, with demonstrations in 180 towns and cities across Russia.

Navalny has also antagonised the Kremlin by calling on the west to impose personal sanctions on 35 individuals linked to Vladimir Putin. They include oligarchs, the judge who remanded Navalny in custody last month, and senior government figures. Navalny poses a serious threat to

the country's political elite. They don't seem to know how to handle him. If Navalny is kept in prison or released, his movement will be strengthened, and it has the potential to fuse to broader public dissent over Russia's long-term economic performance and government ineffectiveness.

Besides pro-Navalny support, other factors fuelling public anger are falling living standards, pandemic-related troubles, diminished political freedom, and Putin's decision to effectively remain in power beyond 2024. Many Russia observers are of the view that these demonstrations represent a new stage in Russian public dissent.

Emil Avdaliani, a professor at the Tbilisi State University in his recent paper for BESA Centre on the continuing demonstrations opines that the first indicator that these rallies are different is their sheer size. Totalling nearly 100,000 people, they were the largest nationwide displays of dissent in recent years. The detention of 3,700 people greatly exceeds the detentions that occurred during the wave of anti-Kremlin protests that rocked Russia in 2011 and 2012. Moreover, these protests have spread countrywide. According to latest reports Russians in nearly 100 cities across the country took to the streets. Avdaliani opines that historically, Putin enjoyed the advantage of Russia's geography, which precluded the spread of public dissent. Much has changed, however, as modern technologies have enabled the coordination of simultaneous protests across Russia's vast territory. The manner in which Putin and his cliques have handled the issue has catapulted Navalny into a celebrity.



At present, Russia is experiencing what it experienced in the 1990s and the early 2000s - a struggle for a more effective government, more accountability, transparency over public spending, and most of all, the ability to change the government through elections, and Putin's gambit to remain in power indefinitely has added fuel to the public dissent, in which the Navalny episode has acted as a catalyst.

Currently, Navalny is Russia's second most prominent face and voice abroad after Putin, and has become a politician with global reach.

Initially, for nearly a decade, the Russian authorities treated Alexei Navalny like a minor political headache. The county's political elite addresses him in an imperious manner by not referring to him by his name, but then the decision to assassinate him catapulted him to the status of a national figure. Not long ago, many Russians had any idea who Alexei Navalny was, but he is now famous enough to pose a direct threat to the leadership.

At present, Russia is experiencing what it experienced in the 1990s and the early 2000s - a struggle for a more effective government, more accountability, transparency over public spending, and most of all, the ability to change the government through elections, and Putin's gambit to remain in power indefinitely has added fuel to the public dissent, in which the Navalny episode has acted as a catalyst. perhaps take a toll on the organisation's ability to handle international issues, as a unified response to the Russian affair has been missing, as the EU member states can't agree on how to handle Putin.

More European sanctions on Russia may be announced soon, but not even the humiliation of the EU's foreign policy chief Joseph Borrell's recent visit to Moscow looks likely to sharpen the bloc's woefully divided policy towards the Kremlin, analysts say.

EU unity on Russia can't be expected any time soon. Despite mounting concern at Moscow's behaviour in many capitals, there is widespread disagreement over how to respond, with national strategic and economic interests far from aligned.

Germany, which played a major

now, national interests in Europe have prevented that from happening and it's hard to see that changing.

Nicu Popescu of the European council on foreign relations argues that European attempts to reset relations with Russia were doomed to failure because they are "predicated on the idea of mutual concessions". Instead, a more muscular approach might yield better results, he added.

Meanwhile, Russia issued an international arrest warrant for Leonid Volkov, one of Navalny's senior allies, who is currently based in Lithuania.

However, European nations' hope that dissent may generate a liberal movement to replace Putin may not be fulfilled. Though some degree of a liberal mood might be present amongst the demonstrators, they are clearly not either pro-West or pro-democracy. Instead of the young crowd, the demonstrators have included middle-aged, middle-class Russians. These people are frustrated with the government's economic performance and corruption and the end result may not be what Europe wants – an end to the Putin era.

EU's Response

Meanwhile, the internal affairs of Russia had an after effect on the manner in which the European Union functions. So far, the UK and EU have already introduced targeted sanctions over the poisoning of Navalny, and the EU is considering additional measures over his jailing and the subsequent crackdown.

The Guardian reported that the Russian foreign minister, Sergey Lavrov, has said that his country was prepared to break off relations with the bloc if there were any new sanctions. But the inner EU wrangling may role in EU sanctions against Russia after the annexation of Crimea in 2014, is resisting calls to back out of the Nord Stream 2 gas pipeline project, preferring targeted sanctions against wealthy Kremlin supporters.

Meanwhile, Emmanuel Macron of France still favours dialogue and a strategic 'reset' in EU-Russia relations, while Poland and the Baltic states want far tougher action.

Judy Dempsey of the think-tank Carnegie Europe opines that Moscow prefers dealing separately with each member state, instead of EU as a bloc, and on the other hand most EU states don't know what they clearly want from Russia

Use Of Emergency Light

would like to express my view on the use of emergency lights on the vehicles of hospital ambulances and police officers through the medium of your esteemed daily news.Hope the space will be provided to me on humanitarian ground.

The red and blue flashing LED or rotating emergency light on the ambulances or government official vehicles have much significance and importance. Generally the red color indicates an emergency as it can be seen on the ambulances while the reason for using blue lights is to alert about the presence of police and law enforcement agencies. Sometimes the combination of both lights can be seen on the police vehicles which simultaneously explicit the emergency and presence of police Nowadays, it has been observed, in India in general and Jammu Kashmir, in particular that the emergency lights are being used on private vehicles. These lights are being fixed either in front of the radiator grill somewhere on the bumper or on the dashboard inside the cabin of the vehicles. As I studied even law and Motor Vehicles Amendments Rules where I read almost all the relevant sections where I found no such provision which allows this activity on private vehicles either by officials or by non official persons. It is also I wanted to express here that the emergency lights cannot be used by the official persons on their private vehicles belonged to law enforcement agencies or public ad-

ministrative offices .In this respect and connection I have even contacted some police officers who acknowledged that there is no such law that allowed using emergency lights on their private vehicles but they defend themselves giving the reason that some police stations have fewer official vehicles than required therefore they use the emergency lights on their self owned vehicles. Firstly, it is a well established principle and also enunciated by the Constitution of India that no one is above law and everyone is equal before the law according to Art.14 of the Constitution of India. Hence, by giving any reason without indulging oneself in the debate that whether the given reason is true or not is in a position to boldly say that

this activity is illegal. Secondly, it is near to impossible for a common person to identify which private vehicle having an eye catching flashing emergency lights is of a law enforcement agency or any private person. Last but not least, the emergency lights should be used to serve the purpose of their creation but not for pomp and show and fun.Therefore I would like to urge the Govt of India,Department Of Home ,Director General of Police and Police Commissioners to pay heed to this illegal activity and take necessary steps to stop this prohibited activity.

cvnosure in cramped and crowded streets of Sopore, meandering around narrow alleys of Sopore regularly. But one must remember, the law of nature, the only permanent thing in this world is change and one can't resist change.

he recent significant decision taken by the Sopore administration regarding the banning of tongas from plying on the streets of Sopore town can be termed as a better-late-than-never decision. If we think sensibly, it is not only the tonga wallas who have been at the receiving end of this administrative order but many cart retailers and vegetable vendors, who have been illegally occupying roads for decades. They have now been forced to vacate illegal encroachment of roads to facilitate the smooth movement of traffic on congested roads.

No doubt, Tonga is more than a horse cart for soporains as it has become a part of their cultural folklore and many well-off families still prefer to travel short distance destinations by tongas in the times when we are seeing the boom of modern fuel cars. Tonga has become cynosure in cramped and crowded streets of Sopore, meandering around narrow alleys of Sopore regularly. But one must remember, the law of nature, the only permanent thing in this world is change and one can't resist change.

Next, one can't deny the fact that everything loses its shine and sheen with time, the same thing has happened with these horse driven carriages. They can't keep pace with modern vehicles driven on fuel, who are outpacing this traditional ride in being

more time effective and comfortable for travel purposes. In the west, they are planning to replace conventional vehicles being run on petrol and diesel with eco-friendly electrical vehicles, but we are doing cart before the horse here by trying to justify the relevance of tangas in the 21st century. So, tongas are not battling with administration for survival, in reality they are fighting with changed time for survival.

Now coming to the cultural aspect. How is it cultural assault if cons of tangas outweigh it's pros? Ask any pedestrians walking on streets or person driving his/her vehicle in Sopore, how much inconvenience tongas cause in smooth flow of traffic, reply will be on these lines: they don't follow any traffic rules, stopping in the middle of the road is normal for them and with no permanent parking space(adaa) available for them these tangas can be seen parked at random places on road. Just a few months back, while driving in Sopore. I dared to ask a tonga wallah about his wrong parking on road, his response was beyond my expectations. Instead of listening and acting on my gentle request, he pounced upon me with a barrage of cuss words and irony

is that he didn't spare my vehicle too by calling it a "Loana Gaeed"/ (Car bought on finance).

Yet another issue is the foul-smelling excreta of horses found on roads and pavements, it's simply unacceptable in these times when we are already fighting with deadly COVID19, we can't afford to be victims of communicable disease as poor hygiene is considered precursor for these diseases. Regarding rehabilitation of these cart drivers, authorities already have plans in mind. They will be provided alternate sources of employment in the form of auto rickshaws, that will simply add value to their income and status. So, for the larger good of Sopore town we have to swallow this bitter pill of ban. I am sure this step of administration will prove to be a game changer for development of Sopore.

Too Much Information: The COVID Work Revolution Has Increased Digital Overload

re too many online meetings and notifications getting you down? Online communication

tools - from email to virtual chat and video-conferencing - have transformed the way we work. In many respects they've made life easier. Without them we could not have made the shift to remote working during the COVID pandemic.

But are we now overly connected? I and my colleagues have interviewed 120 experts from around the world to get a handle on the effects of 2020's workingfrom-home revolution.

What they told us suggests the desire to compensate for the lack of physical interaction is compounding digital overload – the phenomenon that technology researchers Larry Rosen and Alexandra Samuel described in the Harvard Business Review way back in 2015 as perhaps "the defining problem of today's workplace"

As Rosen, a pioneer in the "psychology of technology", explains in The Distracted Mind: Ancient Brains in a High-Tech World, his 2016 book co-written with neuroscientist Adam Gazzaley, our brains have not evolved for media multitasking.

So many technological innovations have enhanced our lives in countless ways, but they also threaten to overwhelm our brain's goal-directed functioning with interference. This interference has a detrimental impact on our cognition and behaviours in daily activities. It impacts every level of our thinking, from our perceptions, decision making, communication, emotional regulation, and our memories.

This interference is increasing as we embrace ever more tools that facilitate virtual communication and collaboration, always "on" and in touch through a barrage of messages and notifications.

Using nine tools a day

Our research is part of a global project on the future of work and education involving 14 university, corporate and non-profit partner organisations.

We interviewed managers in the private sector (from start-ups to corpora-

tions), the public sector and academia. We talked to each for an a hour about how their work environments had been affected by the pandemic, and how they imagine the future.

Almost all agreed digital overload had increased due to too many digital tools, too much information and too many hours spent in online conferencing.

On average, they reported using nine collaboration and communication tools every day. If that seems excessive, count how many you use. More than likely you have software for writing, email, instant message, calendars, file sharing, conferencing, work organisation and password management. That's nine just there.

More online fatigue

Our respondents also reported increased fatigue from being online all the time, and from being expected to send and respond to messages. As one of interviewee put it, the old problem of lack of information has been overtaken by how to keep up with all the information we are expected to take in and provide.

Online meetings were cited as particularly exhausting. This concurs with research showing the demands of constantly observing ourselves as performers leads to "Zoom fatigue".

3 tips to manage digital overload

You may not have much influence over the number of tools you use. But you can control how you use them. The key is to reduce "goal interference" - anything that interrupts or distracts you from the task in front of you.

Here are three simple principles to manage the load.

1. Switch between tasks less often

Research shows the idea of multitasking is a myth. Maybe we can cope

with two things at time, such listening to music while working. But for any task requiring focus we have to make a cognitive switch. Studies show the more we switch, the worse we get at focusing on what's relevant to the task before us. Make fewer switches to maximise your ability to filter out interference from thoughts about other tasks

2. Schedule set times for regular tasks Behavioural experiments show those who check emails just a few times a day report lower stress than those who constantly check throughout the day. Make the effort to do related tasks in set times blocks (say 30 minutes). Give yourself the opportunity to really concentrate. Switch off unnecessary notifications and other distractions.

3. Limit unnecessary communication Sharing information is important

- knowledge is power, after all. But too much information becomes just another distraction. As another adage goes, data isn't information, information isn't knowledge, knowledge isn't understanding, and understanding isn't wisdom. Information in the digital age is a bit like food. Tens of thousands of years of scarcity has conditioned us to crave it. But abundance means we have to consciously check ourselves from consuming too much.

Changing work culture

These three tips are far from a complete solution, of course. As our interviewees underlined, addressing the problem of digital overload at work requires radical reflection on the temptations of technology – including thinking yet more technology will solve the problem.

There have been many lessons to learn from 2020.

From our unplanned leap into a work future long predicted would come from digital technology, we have the opportunity to understand the pain points. We've had a technological revolution in workplace communication and collaboration. Now must come a cultural revolution.

The orientation programme was conducted ahead of the census of Migratory Birds and other endemic birds nesting in the Valley Wetlands on 17th, February, 2021.

The aim of the programme is to identify the current status of Valley Wetlands viz. Hokersar, Mirgund, Narkara, Hygam, BadiNambal, Shallabugh, Anchar, Dal Lake, Wular Lake, Chatlum, Kranchoo, Manibugh, Freshkrori Wetlands which harbour sizeable number of migratory birds and to check the population fluctuation of migratory species in the Valley Wetlands during Winter migration.

The participants from Kashmir University, Central University, S.K.U.A.ST-K, Wildlife Conservation Fund, Kashmir Bird Watchers Club, Wildlife SOS, Wildlife Research & Conservation Foundation, Volunteers and freelancers are taking part in the said census.

The Wildlife Warden, Wetlands Division Kashmir, Ifshan Deewan stated that coordinated effort by the Department of Wildlife Protection to conduct the Annual

Water bird Census (AWC) this year shall go a long way in establishing the numbers of various water bird species particularly the migratory Waterfowl that visit the wetlands of the Valley during Winter months.

This annual practice conducted by the Wildlife Protection Department shall help in creating a sound data base of the wintering Waterfowl population in the Valley Wetlands, she added.

Foreign Envoys

BJP led Central government for ensuring democracy at grass-roots level, the newly-elected members of the DDC would be meeting besides holding a meeting with a few prominent citizens and administrative secretaries.

Strengthening of democratic institutions at the grass-roots level would be significantly highlighted, the officials said, adding that during a presentation the envoys would be shown how panchayats have been empowered by giving them financial powers.

On the second day, the ambassadors would visit Jammu where they would be meeting Lt Gov Manoj Sinha besides some of the DDC members and epresentatives of some social organisations, they said.

This is an another diplomatic exercise being undertaken by the government to counter the propaganda that is being orchestrated by Pakistan at international foras, the officials said.

The envoys would be briefed about the security situation by senior officers involved with the law-and-order situation in the Kashmir valley, especially attempts of Pakistan to push militants into India through the Line of Control and also about the frequent ceasefire violations, they said.

Last year, envoys from 17 nations including the US had visited Jammu and Kashmir. The team also comprised ambassadors from Vietnam, South Korea, Brazil, Uzbekistan, Niger, Nigeria, Morocco, Guyana, Argentina, Philippines, Norway, Maldives, Fiji, Togo, Bangladesh and Peru.

Three months after the Centre withdrew the special status of Jammu and Kashmir by revoking Article 370 of the Constitution and bifurcated it into two union territories, a delegation of 23 EU MPs was taken on a two-day visit to assess the situation in the Union Territory by the International Institute for Non-Aligned Studies, a Delhi-based think tank.

At Chewa, the minor's father told Kashmir Observer that on February 10, 2021, his daughter was on the way home from her tuition centre when some unidentified persons pulled their car in front of her.

"She was offered Rs 520 by one of the men," he said. "And when she refused the money, one of them came out of the car and grabbed her arm in a bid to abduct her."

Luckily, he said, one of his friends was around-who got alerted by his daughter's cries. and rushed to the spot along with other locals.

"They caught the three people and checked their identity cards," the distraught father continued.

"They turned out to be the Army men. We didn't take law in our hands and informed the police immediately.'

After the incident, the 'daily-wage' father of the minor said, the Army from a local camp came to his home and "harassed" his family.

"This is strange that I am facing this sort of treatment when I am the same person who rescued the soldiers when an Army chopper crashed in this area a few years ago," he said.

"The police should investigate the case thoroughly and take action against the accused."

Senior Superintendent of Police, Bandipora. Rahul Malik, told Kashmir Observer that an FIR has been registered and three persons have been detained in the case.

The officer, however, didn't reveal the FIR number and identity of the trio "due to the sensitivity of the case".

But according to a local news gathering agency, FIR No. 15/2021 under sections 341, 363, 511 IPC has been filed in the case last week at Police Station Sumbal, following the family's complaint.

"The accused army soldiers have been identified as sub-inspector Harbachan Singh, Naik Amit Tahkor, and Hawaldar Manzoor Ahmad. All the three are under police detention," the

report said.

However, the incident is already giving sleepless nights to the minor's family. And due to trauma, they even fear to talk about it.

"Everybody is talking about us," the grandfather of the minor told Kashmir Observer.

"We don't know what will happen, but we are glad that our child is safe."

He said that under this Act 61 vehicles, including 2 trucks, 1 tipper, 4 Alto cars, 2 Hyundai Creta, 1 Maruti Echo, 1 Baleno, 4 Santro, 1 Asta, 2 Wagon R, 1 Mahindra Quanta, 1 Auto, 2 Maruti Swift, 18 motorbikes, 5 Scooty, 2 load carrier, 3 Alto K10, 1 Maruti 800, 1 Load carrier, 2 Tavera, 1 Ambulance, 1 Tata Tiago, 1 Ford Figo, 2 Echo ambulance, 1-I20, and 1 Dutson have been seized.

"These include the Creta Car belonging to Sofi Fahmeeda, associate of Asiya Andrabi. Cash of rupees 370000, cheque worth Rs 50,000 has been also seized.

CHENNAI: India skipper Virat Kohli on Tuesday rejected criticism of the spin-friendly Chepauk pitch, asserting that his side showed the requisite grit and determination to conquer England on it in the second Test with the toss not being a matter of concern at all.

India on Tuesday beat England by 317 runs on a dust bowl, which was heavily criticised by former English players such as Michael Vaughan.

"We didn't panic out there looking at the turn and bounce, we showed grit, got into the game and scored 600 runs in the game. We know our bowlers would do the job for us if we put up these runs," Kohli said in the post-match presentation.

Former England players such as Kevin Pietersen had mocked the pitch for the turn it offered from day one, calling it a "brave" track for a Test match and that fortunes could have swung the other way had India lost the toss and batted second.

Kohli said it wouldn't have mattered.

"If you looked at our second innings, we got 300 as well. It wasn't unfair if the toss went either way. Both teams should be in the game from the first session onwards, whether it is on spinning to seaming tracks, and that exactly was the case in this game," he said.

The India captain said playing before fans was a big factor in their massive victory as the home players were egged on by the cheering crowd. The first game was played behind closed door due to the COVID-19 pandemic restrictions, which

"It was a bit strange in the first game to be playing at home with empty stands. We were pretty flat on the first two days over there to be pretty honest, myself included, didn't pick up energy on the field.

"But from the second innings onwards in the first game. we picked up and were on the money in terms of our body language," Kohli said.

"The crowds make a big difference, this game was an example of the grit and determination this side shows and the crowd is a big part of that. If I am running in to bowl in this heat, I need people to motivate me. It is a perfect game for us."

Kohli also praised wicketkeeper batsman Rishabh Pant for his improved skills behind the stumps and the hard yards he has been putting in since the Australia tour.

"Rishabh Pant has really worked hard in Australia, when he moves with the gloves you can see the difference in his reactions. He has shed a lot of weight and has worked hard on himself. "It is showing, the way he

Naomi Osaka Advances **To Australian Open Semis After Beating Hsieh**

MELBOURNE: Naomi Osaka on Tuesday advanced to a potential semifinal showdown against Serena Williams at the Australian Open. Osaka earned her 19th victory in a row by overpowering Hsieh Su-wei 6-2, 6-2, and will next meet the winner of the quarterfinal match Tuesday night between Williams and No. 2-seeded Simona Halep.

"Normally I never look at my draw," Osaka said. "But everyone has told me about my draw here, so I kind of had no choice but to know who my next opponent is. It's definitely going to be really fun."

Seeded third, Osaka reached 122 mph (196 kph) on her serve against Hsieh. She hit seven aces, lost only two points on her first serve and was never broken. Osaka also plaved excellent defense, such as in the final game, when she raced forward to chase down a drop shot, flicking a backhand cross-court for a winner. At 35, Hsieh was the oldest woman to make her Grand Slam quarterfinal debut in the professional era. But Osaka wasn't fazed by Hsieh's flat, deceptive two-handed strokes from both sides, pounding forehand winners into both corners. Osaka's winning streak includes a U.S. Open title in September for her third Grand Slam championship. The streak also includes her fourth-round win last week, when she saved two match points and swept the final four games to overtake Garbine Muguruza.

"It makes me a bit more calm, knowing that my back was severely against the wall," Osaka said.

Osaka is 4-0 in Grand Slam quarterfinals, including a victory en route to the Australian Open title in 2019. Two quarterfinal matches were on the men's schedule: eight-time champion Novak Djokovic against Alexander Zverev, and Grigor Dimitrov versus 114th-ranked qualifier Aslan Karatsev.



Kevin Pietersen Congratulates India For Beating 'England B Team', Slams ECB

CHENNAI: With a brief but cheeky congratulatory message, former England captain Kevin Pietersen on Tuesday teased the Indian team for comprehensively beating what he called "England B" in the second Test.

India roared back into the four-match series with a crushing 317-run victory in little over three days to restore parity after the reverse in the opener.

"Badhai ho India, England B Ko harane ke liye (Congratulations India, for beating England B)," Pietersen wrote on his Twitter handle shortly after the home team's win.

The former star batsman then again lashed out at the England & Wales Cricket Board (ECB) for the strange move to continue its rotation policy even for such a massive series against one of the world's toughest teams

'You don't pick your best team in the hardest place to WIN a Test match, you actually cannot even show emotion to it," Pietersen wrote.

He also expressed his surprise at the England team management's decision to send back experienced spin bowling all-rounder Moeen Ali after the second

match, in which he picked up eight wickets (four in each innings). "We played in 2005 on terrestrial TV and BEAT Aus (Australia). It changed the game of cricket in this country. Cricket goes back to terrestrial TV for this HUGE series and

England don't pick their best team for it. "Moeen Ali now going home after ONE Test. Wow," Pietersen wondered.

Having lost the first Test by 227 runs, India inflicted on the visitors, an embarrassing defeat in the second match to not just come back into the series in style but also put themselves in contention for a place in the inaugural World Test Champion final against New Zealand at Lord's in June.

As part of the rotation policy introduced by the ECB to keep all their players in peak physical condition in the year of the T20 World Cup, England rested veteran pacer James Anderson for the second Test, despite losing Jofra Archer to elbow injury just before the game.

India were done in by Anderson's reverse swing on the fifth day of the first Test.

Among other big players, England also sent back Jos Buttler after the win in the series opener while resting off-spinner Dom Bess for the second game.

Uttarakhand CM Orders Probe Into Wasim Jaffer Coaching Resignation Controversy

NEW DELHI: Uttarakhand Chief Minister Trivendra Singh Rawat has ordered a probe into the controversy surrounding the resignation of Wasim Jaffer as the head coach of the state's senior men's cricket team. A controversy had erupted after Jaffer resigned as the head coach of the state's senior men's cricket team on February 8 over charges of religious bias in the selection of players.

Jaffer, in his statement, made it clear that some of the undeserving players were given a nod without his consultation. while CAU brushed aside the allegations, citing the coach had 'issues'.
