# Study examines effect of consumers picking their own price

esearchers from California Polytechnic State University and the University of Oregon during a recent study examined the potential benefits for firms and consumers of pickyour-price (PYP) over pay-what-you-want (PWYW) and fixed pricing strategies. The study, forthcoming in the Journal of Marketing, is titled "The Control-Effort Trade-Off in Participative Pricing: How Easing Pricing Decisions Enhances Purchase Outcomes" and is authored by Cindy Wang, Joshua Beck, and Hong Yuan.

Over the past few decades, marketers have experimented with pricing strategies that delegate some or all of the price determination to consumers. Their goal is to engage consumers, boost sales, enhance brand loyalty, and contribute to a sellers' overall competitive position. However, in recent years many firms, including Priceline. com, Panera Bread, and the Metropolitan Museum of Art in New York, have abandoned their once-famous use of participative pricing and reverted to fixed prices.

The research team pins down and theorizes a tension that consumers experience when they evaluate a purchase that involves participative pricing. On one hand, consumers are attracted to the economically advantageous pricing terms (i.e., pay anything, including \$0) that permit them to maximize their utility. On the other hand, consumers must decide the final price, which takes effort. Building on this control-effort proposition, the researchers predict an overall negative effect of a pay-what-you-want (PWYW) pricing strategy because of the high effort involved in deciding the final price. They also predict an overall positive effect of a novel pick your price (PYP) strat-



price from a set of options.

PWYW and PYP both enhance feelings of pricing control, but PYP does not increase pricing effort since consumers find it relatively easy to make constrained choices. The study investigates the effects of PWYW and PYP with five studies in a variety of contexts (e.g., retail food, health services, financial services, entertainment, and household products). Some primary results from a field study that involves actual purchases and profit outlines establish the strong performance of PYP relative to fixed prices and PWYW. Findings from lab experiments further validate that compared to a fixed price, PWYW decreases purchase intentions because of the high pricing effort, even though it confers full pricing control.

of pricing control but not pricing effort, it consequently increases purchase intentions. These effects hold regardless of the price level (high vs. low). Additionally, shopping motives (to save money or time) influence the effects of PWYW and PYP on purchase intentions. As Wang explains, When consumers are motivated to save money, the advantages of pricing control are amplified and the costs of pricing effort are minimized; thus, both PWYW and PYP increase purchase intentions relative to a fixed price. Alternatively, when consumers are motivated to save time, the disadvantages of pricing effort are enhanced and the advantages of pricing control are attenuated. Hence, under such conditions, PWYW performs worse than fixed price and PYP and fixed price's performance are

Also, single (vs. multiple) purchase decisions serve as a crucial factor, such that the positive effect of PYP on purchase choice attenuates over multiple purchase decisions because they require a great deal of effort. Lastly, in a parallel investigation in donation contexts, both PWYW and PYP perform significantly better than a fixed price strategy. By adopting a consumer perspective on participative pricing, this study explains why PWYW might decrease purchases and specifies when PWYW and PYP will be more or less effective.

Beck says that "Managers can selectively implement PWYW and PYP to enhance their pricing performance. Adopting PWYW strategies requires careful consideration, and even if marketing research were to indicate that consumers favour higher pricing control, the execution might fail due to consumers' reluctance to expend effort to determine their own prices. Alternatively, firms might benefit more generally from adopting PYP strategies." Consumers' willingness to exert pricing effort also varies across shopping contexts. For example, the research suggests PWYW is more effective when consumers are motivated to save money, such as during the holiday season. Yet PWYW likely is less effective for busy consumers just seeking to get their holiday shopping done quickly.

For online stores that emphasize monetary savings, both PYP and PWYW could be more effective than conventional fixed prices. Contexts that involve donations are another scenario for which participative pricing, especially PWYW, promises benefits; consumers already expect to expend effort for the benefit of others.

### APHC CHAIRMAN ESCAPES BID ON LIFE

SRINAGAR - The chairman of the Hurriyat Conference, Prof Abdul Ghani Bhat and about 10 of his colleagues had providential escape at Tarzoo today when residents spotted a grenade tied to the footboard of their vehicle just as the APHC delegation was about to drive off from the village.

Prof Bhat had addressed a public gathering outside the local mosque, and he and the rest of the delegation, which among others Included Qazi Manzoor, Gbulam Nabi Zaki, Syed Iftikher Hussain Jalali, Mukhtar Ahmad Naqshbandi, Iftikhar Geelani, Sheikh Abdul Hameed, had boarded their Tata Sumo at about 3:30 p m when someone from the surrounding crowd shouted in alarm.

There is a grenade tied to the vehicle! Get down, "the crowd shouted," Prof Bhat told Kashmir Observer.

The grenade, found tied to the rod that serves as the footboard of the Sumo (JKOIB 7032) was detached by our of Prof Bhat's personal security guards.
"The grenade pin had been pulled half-way out of the sock-

et; the bumpy ride and the vehicle's vibrations would have done the rest", Prof Bhat said. Whether or not it would have killed us, but the grenade would certainly have exploded once we were on our way'.

In all probability the grenade had been planted on the vehicle at the spot when it had been left parked in Taarzoo, Prof Bhat said. The grenade was handed over to police guard on duty at the local branch of the JK Bank, as, according to Prof Bhat, there were no policemen around in the vicinity.

We didn't encounter a single policemen, even when the public raised an outcry against the attempt', he said. In fact, it was from the local bank that the SHO Sopore was informed.

It is a wild and tendentious assertion on part of the police to claim that they recovered the grenade. There were absolutely no policemen around". The attack was probably in honour of the three-month ex-

tension of the cease-fire. Evidently, a big morsel was required". Apart from Bhat, nearly 10 of his colleagues had boarded the Sumo when the alarm was raised. He said he would not like to apportion blame, but that he

found the police statement shocking. The Hurriyat chairman said Taarzoo had not been on their itin-

### **Pak-American Gets 12-Year** In Jail For Illegal Funding To US Politicians

WASHINGTON/ISLAMABAD: A Pakistani-American venture capitalist has been sentenced to

12 years in prison and fined USD 1.75 million for falsifying records to hide his work as an unregistered foreign agent while lobbying high-level US officials.

by US District Judge Virginia A Phillips, who also ordered him to pay USD 15,705,080 in restitution and a criminal fine of USD 1.75 million, the US Department of Justice (DoJ) said in a statement.

"Zuberi turned acting as an foreign money to fund illegal campaign contributions that bought him political influence, FBI's Los Angeles Field Office. and used that influence to lobby US officials for policy changes on behalf of numerous foreign able by the United States govtorney General for National Security John C Demers.

"He not only concealed his lucrative agreements with those as a foreign agent while lobbying foreign principals but also made high-level US government offalse statements about them in ficials, evading the payment of a Foreign Agents Registration millions of dollars in taxes, mak-

In November 2019, Zuberi pleaded guilty to a three-count information charging him with violating the FARA by making false statements on a FARA filing, tax evasion, and making illegal campaign contributions. In June 2020, he pleaded guilty in a separate case to one count of obstruction of justice, Pakistani newspaper "The News" reported on Sunday.

"Zuberi flouted federal laws that restrict foreign influences upon our government and prohibit injecting foreign money into our political campaigns. He enriched himself by defrauding Imaad Shah Zuberi, 50, a Cali-fornia resident, was sentenced by US Dietrick Indee Viction A Attorney Tracy L Wilkison for the Central District of California.

## Pakistani Female Aid **Workers Shot Dead By Assailants**

ISLAMABAD, PAKISTAN - At least four female development workers have been killed in a targeted attack in the northwestern Pakistani district of North Waziristan, police say, the latest attack in an escalation of violence in an area that was once the headquarters of the Pakistani Taliban.

The attack took place at 9:30am (04:30 GMT) on Monday near the village of Ippi, a few kilometres east of the town of Mir Ali, senior police official Shafiullah Gandapur told Al Jazeera by telephone.

The workers' vehicle was fired upon by unidentified assailants who then fled the scene, he said. The driver of the vehicle was wounded and is being treated at a local hospital.

This is a militancy-stricken district, the threat is here everywhere," said Gandapur, when asked if there was a specific threat against development workers in the area.

## "Mother, Get Up": Video Of Bloodied Kids After Kabul **Blast Sparks Outrage**

KABUL: A gruesome video of a Kabul blast site Sunday, showing bloodied children standing over an unconscious woman, quickly went viral and sparked fresh outrage in an already war-weary Afghanistan.

At least two people were killed and five others wounded in the explosion, which appeared to target security forces in the Afghan capital, said Kabul police spokesman Ferdaws Faramarz.

The video, taken in the immediate aftermath, showed bodies bloodied and blackened lying on the asphalt, while two small children can be seen crying over an unconscious woman.

The two children -- one of them covered in blood -- can be heard screaming. At one point, one says, "Mother, get up!"

The man filming the video can be heard telling the children to on an almost daily basis amid "calm down" as the woman is carried away.

Reaction to the video was immediate, with social media users in Afghanistan expressing horror over the images. The hashtag "Mother get up!" in the Dari language quickly started trending.

"Unbearable to watch this mother & her children like this," wrote one Twitter user, Ejaz Malikzada.

"How could those who commit this justifies their action to their own souls while you see kids crying for their injured mother? This needs to STOP," said Fawzia Koofi, a member of



### Talks needed

r Farooq Abdullah and Mehbooba Mufti, both former Chief Ministers of J&K, have advocated dialogue with Pakistan to end violence in Kashmir, saying the friendship between the neighbours holds key to the development in the region. Abdullah said the militancy in Kashmir was continuing contrary to the claim by the BJP that the normalcy had been restored in the former state. Similarly Mufti called for India-Pakistan talks to resolve Kashmir saying neither war nor gun are the solution. She also asked the centre to engage the people of Jammu and Kashmir in dialogue process.

However, it is unlikely that there will be a dialogue between India and Pakistan in near to medium term. Instead, there are more chances that the relations between the two will worsen going forward. The reason for this is the ongoing situation in Kashmir, which, if recent killings of police men is anything to go by, is not changing for the better. The two countries have also been engaging in intermittent skirmishes along the Line of Control. The killings of soldiers and civilians as a result has become an addictive bloody ritual. This gives a cathartic vent to a long entrenched pathological animosity, which is now pursued for its own sake. And there's no way it can be addressed unless the two counties arrive at a fundamental understanding that addresses the core issues at the root of their lingering estrangement. But that prospect appears now farther off than ever before.

More so, after the revocation of Article 370 in August 2019 that has further drifted the neighbours apart. Pakistan sees India's withdrawal of Kashmir's special status enshrined in Article 370 as a dilution of what it sees as the disputed status of the region. But New Delhi sees the changes to the constitutional position of J&K as its internal matter. Two positions look all but irreconcilable. But for a durable peace in the region, the two countries have to find a way to get along. This requires statesmanship on both sides. And this will only be possible if there's willingness on the part of the neighbors to resolve their issues. But if nothing is done, the situation looks set to go further downhill from hereon. That is, if the leadership of the two countries doesn't step back and seek to put their relationship back on rails.

Given the prevailing situation, it will also be interesting to see whether the new US administration will play any role in improving the India-Pakistan ties. The two countries need some serious prodding by the world's only super power to re-engage and sort out their differences. Things, however, will be clear in the weeks and months ahead.

## Keep a watchful eye

fter the smooth completion of the disenbanks of Pangong Lake in Eastern Ladakh, India and China have begun discussions on the next phase of disengagement. The disengagement took nine days, and by agreement, was monitored and verified at each step. There should be relief on both sides that it was incident free. After troops and equipment began to be withdrawn from their eyeball-to-eyeball positions last week, China acknowledged losing five soldiers during last July's disengagement process at Galwan, in which 20 Indian soldiers including the unit commander were killed. An official statement of the 10th round of military commanders — held on Saturday as scheduled, 48 hours after the completion of the first phase — is awaited, but reportedly the Indian side's focus was to push for a Chinese withdrawal from other friction points, namely patrolling points in Depsang and at Gogra and Hot Springs, Reportedly, the Special Representatives of the two sides — National Security Adviser A K Doval and Foreign Minister Wang Yi — will also meet soon.

Questions persist about why India had to give up occupation of the heights on Kailash Range on the south bank of the lake, on the Indian side of the claim line, in exchange for China's withdrawal from an area into which it had ingressed last year on the north bank. In an interview to this newspaper, Lt Gen Y K Joshi said that the occupation of the Kailash Range heights was not an "advantage in perpetuity", and that vacating them was necessary as both sides had to return to status quo ante. That begs the question to which there is as yet no convincing answer: What advantage does India have to negotiate a Chinese withdrawal from the remaining friction points?

China's aggression last April in that region was unexpected. Why the PLA decided to push into Indian territory at that precise time last year during the COVID-19 crisis, and why it has agreed to pull back now, when the harshest part of the Ladakh winter is already over, are the other mysteries of this standoff. Common sense says India and China should be able to move on repairing their bilateral relations on the basis of the disengagement process. But it may not be that easy, considering that the PLA so easily abandoned a full decade of diplomatic slog on "peace and tranquility" agreements, taking the two sides to the "brink of war" as Gen Joshi revealed, and pushing trust levels back by decades. India cannot afford to let down its guard.

## **State Finances**

J&K Economy from the rear view-Part II

This is the second piece in a Four-part series that outlines the processes of change in J&K Economy since 1996-97

f there is one thing that economic policy makers have been consistent in, it's in their ineffectiveness of forecasting correctly. By virtue of its nature, all policies have to be formulated based on a set of futuristic assumptions. The success or failure of such plans, therefore, depends to a great extent on the synchronous unfolding of realities with the predictions envisaged by the policy makers. As a matter of fact, not all economic policies achieve their stated objectives perfectly and sometimes the quantum of failure is so large that policy changes like those adopted by Russia in the form of New Economic Policy in 1922 or by India in the form of liberalization in 1991, become a necessity. Reforms of this scale are rare. Most of the time, however, Government often tries short term monetary and fiscal tactics to keep the engines running. Whenever you see Government bullying consumers, households and businesses with tactical moves like aggressive taxes, duties and expenditure cuts, you know that the Government's economic policy is showing signs of failure. Despite this persistent inability to forecast accurately, testing the effectiveness of previous economic policies, with the benefit of hindsight, does remain an interesting and value adding field of study.

Besides other supplementary policies, the two central levers of the Government's economic strategy comprise of the Annual Fiscal Policy and the more frequently announced - The Monetary Policy. Unlike the latter, which is the sole domain of the Central Government (through banking regulator) and majorly regulates the flow and cost of money in the system, Fiscal policy is much more significant strategically in determining the economic progress of the country. Fiscal policy in India works through a two tier architecture comprising an annual Union Government Budget and more customized region specific tax and expenditure policies formulated by the respective State Governments in the form of state budgets.

Continuing with the endeavour of outlining the changes in J&K Economy since 1996-97, this column shall analyse the effectiveness of GoJK's fiscal policies in improving the region's economic output and income levels. Although there are hundreds of variables in a typical state budget which can be analysed, however, in order to keep things simple and somewhat relevant to what directly affects a common man, we shall highlight only a few of them.

Tracking movement of variables like state's own tax collections, debt levels & asset creation through state's contribution towards developmental expenditure and pitching these numbers against the growth in income or rate of GDP shall throw some interesting insights.

In this analysis, the time frame has been classified into 4 segments of six years. It has been aligned with the changes in political representatives holding the highest Government offices because economic policies like tax structure and spending priorities tend to change every time a new dispensation takes over.


### Growth in State Government's Own Tax collections (nominal values):

From Rs. 289.27 crore in financial year (FY) 1996-97 to Rs. 10387.28 crore in FY 2019-20 J&K's own tax collections have come a long way. Growing at an average rate of 17.19%, the pattern of movement has been anything but smooth. From a high annual growth of 32.30% in FY 1999-2000 to a nose diving slump of -7.21% in 2019-20, the tax collections have been highly volatile.

Inheriting a very low tax base and a highly informal economy of the 90's, the elected Government led by the then Chief Minister Farooq Abdullah registered an average growth of 24.46% from FY 1996-97 to FY 2001-02. Then, during the Peoples Democratic Party-Congress coalition Government. i.e. between 2002-03 and 2007-08, the tax base continued to grow but the average rate of growth slowed down substantially to 17.14%. This slow down is despite the period being comparatively peaceful than other time frames. This can be attributed to relaxed taxes and other sops complimenting the larger picture of confidence building measures on the political front during this regime. Tax collections in the third segment, i.e. between 2008-09 and 2013-14, again registered acceleration at an average growth of 20.52%. A part of this growth can be attributed to high inflation during this period which at an average was around 10.06% compared to 7.01%, 4.72% and 5.37% inflation in the first, second and fourth time frames respectively. However, the tax base did see improvements in terms of tax effort and tax buoyancy during this period.

The smallest and the ugliest tower in the graph i.e. the period between 2014-15 and 2019-20 is the worst performing among the time frames with an average growth rate in state's own tax collections nose diving to a mere 7.84%. To put things into perspective, the average inflation during this period was 5.37%. This shows that the tax base in real terms has barely moved 247 basis points. This period saw volatile political disruptions and the state witnessed 2 chief ministers, 2 Governors and 2 lieutenant Governors in

a span of only 6 years. The phase was marred with mammoth systemic shocks. Besides the dent in the state's own tax collections on account of surrendering indirect taxes to the GST council, the period witnessed demonetization, bloody political unrest of 2016, down gradation & bifurcation of state into UTs and a lethal pandemic. Business, trade, tourism, consumer spending and investment, everything got bulldozed and consequently tax collections dried up. This was a perfect cocktail for an economic emergency leaving state exchequer gasping for new sources of income. The distress was also reflected in the direct tax collections from J&K (comprising income tax and corporate tax). It registered a contraction of over 10% during this period depicting job losses, income contraction and stressed businesses. This is why GoJK can be seen running from pillar to post to create new tax routes like introduction of the property tax and inflating VAT on the petroleum products.



Is J&K sufficiently taxed when compared to other states? This can be gauged by comparing J&K's own tax collections with the size of its GDP. In case of J&K, the ratio is about 6.2% (2014-15 to 2019-20) which is better than 13 Indian states including Gujarat (5.6%), Bihar (5.7%), Delhi (5.1%), West Bengal (5.2%), Himachal Pradesh (5.1%) and other north eastern states for the same phase. In terms of its tax payments, people of J&K are therefore paying proportionally better than economically most vibrant states of India. This is despite J&K falling in the bottom 20 percentile states in terms of the per capita income.

### Growth in Government Debt:

Every time the expenditure side exceeds the revenue side in the budget, the budget has to deal with a fiscal deficit. Having a fiscal deficit within the prescribed norms is quite normal. To fund this gap, the Government normally relies on borrowing. There are a number of routes through which a Government can for example, by issuing bonds in the markets through the Reserve Bank of India, by borrowing from the Central Government, or from Provident fund accounts, pension funds, small savings etc. This leads to creation of a debt obligation over a period of time. If the speed with which the debt grows exceeds the state's revenue growth, the state gets trapped in a vicious circle of repayments and interest servicing. Pertinently, GoJK has one of the highest debt to GSDP ratios (around 50%) in India. It is almost double than the national average. To make things worse, the compensation on account of GST, which states were supposed to receive from the centre too, has been delayed and in some quarters totally denied. This is resulting in GoJK raising even more debt. It is therefore expected that the coming budget will surely have a much larger debt to GSDP ratio compared to the previous year. This creates a costly and recurring leakage in the form of interest servicing and loan repayments. On an average, more than 42% of the revenue receipts in GoJK's annual budget are consumed in debt servicing. All India average for all the states combined is only 23%. This is how costly J&K's debt is getting and how this leads to shrinking elbow room for the already starved developmental expenditure




From total outstanding liabilities of Rs. 8760 crore in FY 2000-01 to Rs. 78,766 crore in FY 2018-19, J&K's debt has grown at an average annual growth of 13.20%, doubling every 5.45 years in the last two decades (The first four years of data from 1996-97 till 1999-00 is not available). In the last two years of the first time frame, the debt grew at a rate of 10.82%. Then during Congress-PDP rule i.e. from FY 2002-03 to 2007-08, the debt grew much rapidly and accelerated to 15.22%. In the third time frame led by Omar Abdullah's coalition Govt, it slowed down to 12.58%

and in the last period i.e. from 2014-15 to 2018-19, the growth in outstanding liabilities kept on hovering around 12%. As the level of debt has gone sharply up on account of dried up tax revenues, GST compensation and Covid related lockdown, this 12% number is surely going to take a negative hit once the debt for FY 2019-20 is fed into the equation.

### **Developmental Expenditure trend:**

Since J&K's own tax collection to GSDP ratio is better than 13 other states (almost at par with the national average) and the amount of debt too is way ahead when compared to other states, it shall be interesting to see whether these costly resources have culminated into development & creation of public assets. To understand this, analysing the state's expenditure trend on development will be quite enlightening. A developmental expenditure helps in increasing the production and productivity of a state's economy. It involves both revenue expenditure and capital outlay and consists of: (i) social services, which includes expenditure on education, health, water supply and sanitation, housing, urban development, and welfare of backward communities, and (ii) economic services, which includes expenditure on agriculture and allied activities, rural development, irrigation, energy, and transportation infrastructure.



The development expenditure has moved at an average annual growth of 13.29% in the last 24 years which is almost in line with the growth of rate in debt. In terms of time frames, the period between 2002-03 and 2007-08 i.e. The PDP-Congress coalition Government led by Late Mufti Sayad and Ghulam Nabi Azad witnessed the highest average annual growth of almost 25% in the developmental allocation. Pertinently, the period also witnessed the highest rate of borrowing by the state Government. Contrastingly, the six years period following this spur, that is till 2013-14, developmental expenditure maintained a timid status quo, registering a negative average growth of -0.10%. In the last period i.e. 2014-15 to 2019-20, the developmental expenditure expanded with an average growth of 16.43%. During this period, compared to other states of India which have a developmental budget to total budget average ratio of 63%, GoJK spent only 53% of its total budget on developmental activities. It's the 4th worst developmental expenditure ratio in the entire country.

The last 24 years have witnessed a steady growth in taxes, with J&K's tax to GSDP ratio beating some of the economically best Indian states. The state/UT has also seen bulging levels of debt, with one of the wors: debt to GSDP ratio in the country. However, it seems that both the resource streams have not culminated into enhancement of the region's social and economic infrastructure, as is being reflected in the ranking of worst development expenditure to total budget ratio. Neither has there been an equally proportionate growth in the UT's economic output or per capita income. The findings are only pointing towards inefficient fiscal management and miserably failing economic policies. The fourth time frame in particular i.e. the period from FY 2014-15 to FY 2019-20 has been the least performing in the last 24 years. A cacophony of political, fiscal and administrative disruptions collapsed the system on all fronts leaving the essential segments of the economy beyond repair. Revenue leakages on the other hand on account of the bloated salary & pension bill, loan repayments & debt servicing and power purchases continue to make sure that the people continue to face new taxes. State continues to bury itself under more debt and compromise while the much needed developmental front continues to throttle growth and individual income.

t's a cold Thursday afternoon in New York City. A tall Black man, in a black jacket, black track pants and black sneakers enters the Malcolm Shabazz Mosque on 116th Street in Harlem. He looks around before approaching the older man hunched over the reception desk.

"Is this the Malcolm X Masjid, brother ... can I make salah, here?" he asks softly, removing the black hoodie from over his head.

You sure can, just sign the register," the man behind the counter says, pointing at a handwritten directory and then at the narrow passage adjacent to him. "Go that way. Are you from out of town?"

"I am from South Carolina." the young man says. "My name is Malcolm," he says with a smile, before

### disappearing to perform the late afternoon prayers.

### 'We couldn't see him, but we could hear him'

Sister Aisha al-Adawiya still remembers the first time she heard Malcolm X speak.

"I don't think I have the words to describe the atmosphere. It wasn't a religious setting as much as a political awakening. People were hearing - often for the first time, about their history and who they were before enslavement. It was like a shot of pride just running like an electric current through the people.

'I was in my early twenties. The auditorium was packed. We were patted down. There were so many people in one room. We couldn't even see him, but we could hear him speak ... it was simply mesmerising."

The 74-year-old says people walked out of his lectures feeling empowered to make a difference in their life right then and there. She said she was personally taken by his social critique and his allusion to the struggles of others around the world.

This was the early sixties. Everybody would come. People were struggling in life. So many drugs. So many problems. They were transformed overnight. It was incredible to be in his presence," al-Adawiya, a long-time community organiser and scholarship officer at the Schomburg Center for Research in Black Culture, says

Malcolm X, also known as el-Hajj el-Malik Shabazz, was born as Malcolm Little in 1925. After losing his father in 1931 and being placed in foster care due to the illness of his mother, Malcolm entered a world of crime and was imprisoned for robbery in 1946.

In prison, he was introduced to the Nation of Islam (NOI), a radical Black Muslim movement and became in-

fluenced by the teachings of its leader Elijah Muhammad. The Nation preached separatism and economic selfsufficiency for the Black community. Malcolm embraced the group's ideology, and spent his time in prison studying English, Latin, and the dictionary prodigiously. He also joined the debating team where he thrived.

When he was subsequently released, he met with Muhammed, who was so impressed with Malcolm's oratory brilliance that he made him a minister and na-

tional spokesperson for the group.

Malcolm quickly became known as a fiery speaker with an ability to stand tall and call out white supremacy at a time when the wider movement for Black civil rights was still fighting for traction.

Within a few years, he had helped to put the Nation on the map, with the organisation opening up temples all across the country and drawing thousands to join their ranks. Malcolm pushed the "separatist" agenda of the Nation as well as spouting its belief that "the white man is the devil".

After 12 years, he broke with the Nation of Islam in 1964, over a series of differences concerning the direction of the group and his role within it. He was also shocked and disillusioned by Elijah Muhammad's infidelity.

'He was a staunch nationalist and anti-integrationist, but after the Hajj, you can see his approach was more about systems and it was internationalised," Richard Benson, an associate professor at the Spelman College in Atlanta, Georgia, told Middle East Eye.

His departure from the Nation heralded in a new era of Malcolm. He had embarked on the Hajj, or pilgrimage to Mecca, in April 1964 and the experience proved to be transformative.

In a letter sent from Mecca were tens of thousands of pilgrims, from all over the world. They were of all colours, from blue-eyed blondes to blackskinned Africans. But we were all participating in the same ritual, displaying a spirit of unity and brotherhood that my experiences in America had led me to believe never could exist between the white and the non-white.

'You may be shocked by these words coming from me. But on this pilgrimage, what I have seen, and experienced, has forced me to rearrange much of my thought patterns previously held, and to toss aside some of my previous conclusions.

His call for Black empowerment veered into larger, wider critiques of American imperialism and capitalism.

He was also open to alliances. In speeches in Accra, Ghana, on 13 May 1964 and later at Oxford University on 3 December 1964, he articulated his belief in the need for a radical transformation of the world's economy, and why he believed that violence was justified to thwart oppression.

"I don't believe in any form of unjustified extremism. But I believe that when a man is exercising extremism, a human being is exercising extremism in defence of liberty for human beings, it's no vice. And when one is moderate in the pursuit of justice for human beings, I say he is a sinner," Malcolm said during the debate at Oxford.

'People think that his willingness to make alliances meant that he was succumbing to ["integration"] but he just meant that he wouldn't hold blanket prejudice on all people of European descent ... he wanted to dismantle systems of oppression," says Benson, the author of a book on Malcolm X's influence on student movements in the 60s and 70s.

Alden Young, director of the Africana Institute at Drexel University in Philadelphia, said the idea that Malcolm was moving towards a facile notion of "integration" is false. "If he was moving towards Martin Luther King Jr., it's because they were both merging against imperialism.

'I think he believed that it would be through closer connections between African Americans and Africans abroad that you would see economic development."

Malcolm travelled to Kenya, Egypt, Tanganyika (now Tanzania), Uganda, Guinea and even to Palestine (Gaza) where he met with the Palestine Liberation Organisation (PLO).

And given that these words were spoken during a time when so many African nations were also staring at the dawn of their own political independence, his words not only resonated with Black America. They reverberated across the oceans, too.

"We knew we were in the presence of something special. And if we missed his lectures, we were reading his 'Muhammed speaks' [a publication of the Nation] which he pretty much wrote on his kitchen table. It was all like a classroom," al-Adawiya says.

In the early 70s, al-Adawiya can't remember the precise date, she converted to Islam. "As I got more in-

volved, things just started changing for me. I changed my diet. My dresses started getting longer. I started covering my hair. I stopped smoking cigarettes and drinking wine, and then I took the Shahada (the Tes-

"And when I was asked why I became Muslim, I found myself saying: "Well, I am just following Malcolm."

### 'Islam in America as we know it wouldn't exist without Malcolm'

"It bothers me when Malcolm X is not properly honoured," says Palestinian-American Imam Omar Suleiman.

The 33-year-old Suleiman, based in Dallas, known for his civil rights activism, says a lot of Muslims like to prove how deep-rooted Islam is in America by pointing out that many slaves who had come to America had been Muslim.

"But they forget that Islam in America as we know it, wouldn't exist if it wasn't for Malcolm.

"Malcolm was the biggest reason for the growth of the Nation of Islam and the biggest reason for the continuation of Islam in the African-American community ... [The legendary boxer Muhammad] Ali said he probably wouldn't have been Muslim if it hadn't been for Malcolm," says Suleiman, who also teaches "Islam and the American Civil Rights Movement" at the Southern Methodist University in Dallas.

Following the death of the leader of the Nation of Islam, Elijah Muhammad, in 1975, his son Imam Warith Deen Muhammad followed Malcolm's lead and integrated the Nation into mainstream Sunni Islam, taking most of Nation's followers with him. Though the Nation still exists today, it is little more than a fringe group, with no theological legitimacy within orthodox Islam.

The Malcolm Shabazz mosque in Harlem, built in 1946 by the Nation, was initially known as Temple No. 7 and later Mosque no. 7. This is where Malcolm X spent much of his preaching as a Minister of the Nation.

It was bombed in 1965, following Malcolm's assassination, and the Nation moved it to another part of town and Mosque 7 was rebuilt. In 1976, Imam Warith Deen Muhammad decided to honour Malcolm by renaming it the Malcolm Shabazz Mosque.

Almost 50 percent of Black Muslims are said to

In 2017, a survey conducted by the Institute of Social Policy and Understanding found that 66 percent of Muslims support the Black Lives Matter movement.

But Suleiman said he was unsure if Muslims fully understand what that support actually entails.

Over the past year, he has been conducting a country-wide seminar-series called "Malcolm X after Mecca". The seminar typically focuses on the last year of Malcolm's life, documenting his transformation as a father and husband, a Muslim, and Black leader, whose legacy continues to grow, despite attempts to quash it.

Every seminar has drawn sell-out crowds, most of whom are of South Asian or Arab descent.

"When I chose this subject and decided to teach it on this particular platform, I did that knowing that I would get to speak to a majority non-Black Muslim crowd and connect them to someone that they owe a great deal to.

"I make a point in my class that it is not enough to connect with the great Black Muslim pioneers who have passed on. One needs to connect with the community as it exists today, particularly the community of Imam Warith Deen Muhammad [because] Muslims need to forge meaningful relationships," said Suleiman.

"If you want to celebrate Malcolm, you need to bear his burden. And that means amplifying the causes that were sacred to him. You know his wife Betty asked: When will Muslims claim Malcolm? He was a believer."

### **Ballroom for rent**

Malcolm X was 39 years old when he was assassinated. His murder took place just as he began to address a group of people at the Audubon Ballroom in the Washington Heights neighbourhood of New York City. Three men, linked to the Nation of Islam, opened fire on him, in front of a crowd of hundreds who gathered to hear him speak. His wife Betty, pregnant with twins at the time, and their four daughters were also in attendance.

"Malcolm was said to have been standing to the right of the podium," Ruby, the elderly woman, who now looks after the building, which today is known as the Malcolm X and Dr. Betty Shabazz Memorial and Educational Center.

"He was carried down these stairs, and you see

have converted during the course of their life.It is estimated that there are around 3.5 million Muslims in America today, making up 1.1 percent of the population. Muslims are diverse with no one race group dominating the faith. One in four Muslims in America today are African American, with Arabs and Asians and whites making up the rest.

Atiya Husain, an assistant professor at University of Richmond, whose research explores how the figure of Muslims in the post-9/11 era reinforces ideas of blackness and whiteness, said there was no doubt that Malcolm had played a leading role in persuading

"Most of the people I interviewed - whether white or Black - said they converted after they had read his autobiography. Second on the list was the Quran. But mostly the autobiography," Husain told MEE.

Likewise, Edward E Curtis IV, a professor of religious studies at Indiana University, in Indianapolis, said that Malcolm's work and the memories of him had become a key factor in the association of Islam with Black freedom in the United States

"He has been as important and if not more important than any other figure [but] it is always dangerous to attribute one person's conversion to the charisma and authority of a single individual as opposed to a complex social, political, and cultural context," Curtis said.

Curtis added that while Malcolm X had been deeply embraced by Muslim Americans from a variety of racial and ethnic backgrounds, they sometimes forget the fact that he was a Black radical freedom fighter until the day he died.

"To some Muslim Americans, he is seen only as the man who embraced racial harmony on the Hajj, and that's his legacy," Curtis said.

The reluctance to claim Malcolm in his full identity as a Black radical pushing for Black people's liberation left Malcolm disappointed with the larger Muslim world in the sixties.

"Malcolm argued that non-Black Muslims should fight for liberation of Black Muslims because the Quran is pro-human... and stand up for justice no matter who it's for. This was Malcolm's contention with the Muslim world," said Suleiman.

where the toilets are now? There was an exit there, and they took him to the hospital," Ruby, who doesn't offer a last name, says.

Malcolm X was pronounced dead 15 minutes later. The cultural centre, home to the final moments of Malcolm X's life, is analogous to the proud, loud and vibrant personality of the man. The centre is like a mausoleum without a burial chamber. It is quiet. Even the bold, colourful mural in the ballroom cannot cut through the gloomy silence. The multimedia screens in which stories are meant to come to life are not working.

Ruby, herself new to the centre and short of information, says she is curious to see the information on the screens herself. The statue of the Malcolm standing tall and vehemently on the staircase is coarse with dust.

The large plastic banners that spout bite-sized historical insights into Malcolm X are frail and tearing at the edges. Here, his legacy is silenced.

"If you want to host an event here, you can call this number, they are looking to rent the ballroom out," Ruby says as I head out.

### 'Treated like a pariah'

Randi Gill-Sadler cannot recall having an in-depth conversation about Malcolm X outside of her home.

The 31-year-old assistant professor at the Department of English at Lafayette College, Easton, Pennsylvania, says as a teenager, most of whatever she learned about the man, happened at home. If he was mentioned at school, it was always as a foil to someone else

"Even at high school, Malcolm was treated like a pariah. He was someone who was just mentioned in the overall coverage when it came to civil rights movement. But certainly not a leading figure," says Gill-Sadler, whose doctoral dissertation focused on representations of American imperialism and Black women in US and Caribbean literature.

"I think civil rights history at school level is al-

most set up to disregard Malcolm."

"Either his strategies were too radical. Or his approach to race was too abrasive. I think for me, the [Spike Lee] film gave me an alternate way to see this person and not as the opposite to Martin Luther King Jr.

Sister Aisha al-Adawiya, from the Schomburg Cen-

ter, says those who want to continue Malcolm's teachings and advance his legacy are forever battling with "the system" and its attempt to whitewash his memory.

"The more radical elements, even when it comes to Martin Luther King Jr., are often left out," she says. "And yes, you can walk outside and you talk to a kid and ask them who Malcolm was, and they may not know. It can be shocking.'

But Malcolm's legacy has always been difficult to

"It's not clear how popular he was after he was ostracised by the Nation and at the time of death," said Alden Young, the economic historian from Philadel-

"Malcolm has a weird legacy, in the US. He had a revival in the 90s with the film and the rise of hip hop. And many claim him today but I am not sure how many of us are actually reading him or have listened to what was actually said."

Malcolm has his fair share of critics as well, especially among Black feminist historians, with Gill-Sadler pointing out that his views on homosexuality would be considered homophobic today.

"I don't think people have dealt [enough] with gender politics around Malcolm. I think they assume that it was an area in which he was limited.'

Malcolm's views and his relationship with women evolved as his political understanding evolved, too.

One of issues that led to his break with the Nation was the sexual exploitation of women by its leader Elijah Muhammad. And this break came at a heavy cost; it cost him his relationship with other members of the Nation who he held in high regard, including Muhammad Ali. It also led to further antagonism with the Nation.

Gill-Sadler said this level of personal sacrifice has resonance with today's #MeToo movement.

"I think it's important to bring this back into the discussion as to who Malcolm was and what he actually stood for," she said.

Malcolm has also been criticised for creating a distinction between 'house Negroes' and 'field Negroes' in which he valorises slaves working in the field and taunts those who worked in the house. "He ['the house Negro'] loved the master more than the master loved

"And the house Negro always looked out for his master. When the field Negroes got too much out of line, he held them back in check. He put 'em back on the plantation. The house Negro could afford to do that because he lived better than the field Negro.

Black feminist historians contend that the analogy

"It obscures the kind of violence and sexual violence enslaved people who worked in the house - which were usually Black women - would have experienced as a result of their proximity to their 'master'," Gill-Sadler says.

"But what Malcolm was really trying to point to and it's important to talk about it today - was the way in which the US government and white supremacy will incorporate selected Black people to further its agenda."

We have had Black people occupy some of the highest political positions - but we see racism on the rise. I won't use his analogy - but his point was prophetic in some ways."

### 'White supremacy is global'

Atiya Husain, an assistant professor at the Department of Sociology and Anthropology at University of Richmond, says teaching "The life and times of Malcolm X" has been more rewarding and fruitful than anything she could have imagined.

Given the dimensions of Malcolm's life, his philosophies, his appeal to so many different groups - be it Black radicals, Muslims, leftists, anti-imperialists, Black conservatives, amongst others - Husain was concerned that she would have to string together a course that would deal with "everything".

"Malcolm was involved somehow, however briefly, in just about every major event that happened during his lifetime. He had some relationship to everything I wanted to teach - colonialism, race, capitalism, religion, social movements, gender, sexuality - and his life and legacy brings all these things together in ways that we need to explore more today," said the 32-year-old.

Husain is one of many young scholars and academics who are bringing Malcolm into the classroom more than ever before. She says that most of the 23 students in her class are persons of colour - unusual for a university that is predominantly white.

"Black students can relate with what he is talking about - it does not need to be explained. They feel it," she said.

"I am hoping that students get a better sense of mid-20th century movements, a better understanding of religion. One of the bigger ambitions is to get them to see race as a global phenomenon - that white supremacy is global."

There have also been an increase in annual events in NYC marking the life of Malcolm. Both the Schomburg and The People's Forum will host seminars this week marking the death of the icon.

In mid-2018, the Schomburg acquired important manuscripts related to Malcolm's autobiography, including an unpublished chapter from the book. These sources, the Schomburg says, will provide researchers with new insight into the man and his thinking.

"There is a still lot of work to do. But Malcolm lives. He is more powerful now, in death, than he was walking among us.'

### 'Malcolm was ahead of his time'

The young man in the black jacket, black track pants and black sneakers, returns from his late-afternoon prayers. We walk outside the Malcolm Shabazz Mosque and settle on a space on the sidewalk between the entrance of the mosque and a barbershop. His full name is Malcolm Bey.

"My parents named me after Malcolm X. I must have been around seven-years-old when I watched [Spike Lee's] movie "Malcolm X" and understood where it had come from.

"I just remember thinking for someone to come from the hells and bowels of North America and then be one of the most powerful men in the world - it inspired me - to be something more than what people thought of the average African American," says Bey, who now works in New York City on blockchain currency.

He says reading Malcolm X in his teens made him understand that he alone was the "master and slave of

"It's not the sixties no more, conditions for Black people haven't changed. It's just the packaging of racism has changed... you have the United Nations some blocks away but [look at the] conditions here, or uptown in the Bronx - some people don't even have hot water.'

"They living here in subhuman conditions in New York City, bro. And it's not just Black people. It's Latinos also. Anyone who is not white ... Malcolm was ahead of his time.

"That's why I came by to this mosque. His spirit is here," the 32-year-old says.

# Study reveals real-time dialogue with a dreaming person is possible

an anyone perceive questions and provide answers in the midst of a vivid dream? It is possible, say researchers.

The findings indicate that it is possible for people while dreaming to follow instructions, do simple math, answer yes-orno questions, or tell the difference between different sensory stimuli "We found that individuals in REM sleep can interact with an experimenter and engage in real-time communication," said researcher Ken Paller from the Northwestern University in the US.

According to the researcher, dreamers are capable of comprehending questions, engaging in working-memory operations and producing answers.

"Most people might predict that this would not be possible that people would either wake up when asked a question or fail to answer, and certainly not comprehend a question without misconstruing it," Paller said.

For the study, published in the journal Current Biology, the researchers evaluated 36 people who aimed to have a lucid dream, in which a person is aware they're dreaming.

The team said that people in dreams could respond using eye movements or by contracting fa-

The researchers refer to it as "interactive dreaming." The researchers said that future studies of dreaming could use these same methods to assess cognitive abilities during dreams versus wake.

Outside of the laboratory, the methods could be used to help people in various ways, such as solving problems during sleep or offering nightmare sufferers novel ways to cope, the team noted.



# Psychotherapy boosts positive effects in panic disorder patients

sychotherapy appears to be beneficial in the longer run for people suffering from panic disorder, a new study suggests.

The findings, published in the journal Psychotherapy and Psychosomatics, indicated that 70 per cent of the patients clearly improved and 45 per cent were remitted two years after treatment.

Psychotherapy is a general term for treating mental health problems by talking with a psychiatrist, psychologist or other mental health providers.

"Many people adapt to their panic disorder by various restrictions in

their daily living," said researcher Thomas Nilsson from Lund University in Sweden.

"Treatment is crucial as the disorder often leads to a downward spiral in which the margin for everyday life activities becomes increasingly

narrow," Nilsson added.

For the study, the team included 221 participants and studied not only the short and long-term effects of therapy but also how treatment outcome was affected by offering the pa-

tients to choose their treatment.

The options were two forms of therapy, specifically designed to treat panic disorder—a psychodynamic psychotherapy (PDT) and a cognitive behavioural therapy

(CBT)

One half of the patients were allowed to choose their form of therapy and the other half were randomly assigned to one or the other.

The researchers' hypothesis was that the patients offered a choice between two validated treatments would benefit from receiving their chosen form of therapy.

In previous research this has been the case, and psychologists generally take patient preferences into account in treatment decisions.

Therefore, the researchers were surprised by the result—patients who had chosen PDT tended to have better outcomes than those who were randomly assigned to the same treatment.

# 3D biopsies to better understand brain tumours

Agencies

esearchers have obtained a highly accurate recreation of human glioblastoma's features using a novel 3D microscopy analysis.

The study, published in the jour-

nal Acta Neuropathologica Communications, provides new information to help with the diagnose, by finding therapeutical targets and designing immunotherapeutic strategies.

This new analysis of 3D images and quantitative data "will help to an

and quantitative data "will help to appreciate from within how the tumour is built in its full dimensionality, and to identify where different cell types are located," explained researcher George Paul Cribaro from the Universitat AutAnoma de Barcelona.

"It provides more complete information than the usual 2D analyses performed for neuropathological diagnosis," Cribaro added.

With this new approach, the research team showed the alterations in tumour blood vessels, and that these vascular wall abnormalities do not hinder the entrance of lymphocytes T (potential defence against tumoral cells), which is relevant for



the design and use of immunotherapies targeting malignant cells.

Moreover, the images allow the tumour to be differentiated into two areas, the tumour tissue properly speaking, and the stroma, which gives support to the tumour, in which there are different immunological microenvironments, the team said.

The work provides a set of resource images that will facilitate the understanding of the complexity of this tumour, showing some aspects to be considered when designing new therapeutic approaches.

### **NORTHEAST DELHI RIOTS**

## A Year On, Kin Of Many Victims Remain **Oblivious About Status Of Probe**

New Delhi: A year on, scars of the communal violence that convulsed northeast Delhi last February continue to haunt the kin of victims, many of whom say they remain unaware of the status of police investigations relating to their cases.

The police, however, say they are taking forward over 750 cases registered in connection with the conflagration.

The riots had erupted in northeast Delhi on February 24 last year after clashes between citizenship law supporters and protesters spiralled, leaving at least 53 people dead, around 200 injured and also led to extensive destruction of property, including houses, shops, schools as well as religious places.

As northeast Delhi became the epicentre of violence, clashes also broke out at Jaffrabad, Maujpur, Chandbagh, Khureji Khas, Bhajanpura, Dayalpur, Gokalpuri and other areas.

Nizamuddin, whose younger brother Jamaluddin was killed by a mob in Shiv Vihar, says he has no idea about what is happening in his case.

"They killed my brother near our home in Shiv Vihar. Officials of Delhi Police's Crime Branch call us regarding the investigation, but I have no idea what is happening in the case," Nizamuddin said.

He said he also got injured during the attack and had to be treated with metal plates in his broken hands.

Twenty-year old Salim, a scrap collector, is caught up with the police work related to his elder brother Jameel's killing during the riots and is also taking care of his parents.

"In Jameel's case, police call us to Daryagani for identification. Apart from this, we have no idea what is happening in our case. After his death, our financial condition has also become very bad," he said.

Trying to control her trembling voice, his mother Noor Jahan says she misses her son everyday.

Jameel (26), who used to work as a labourer, went missing when he had gone out to buy milk. Later, the family got a call from GTB hospital, which said his body was kept there.

Living in Uttarakhand's Paudi Gadhwal, Devender Negi whose brother Dibar Negi's body was disfigured and burnt in Shiv Vihar, is concerned about the poor financial condition of his family.

"The Crime Branch of Delhi Police had called me once but due to the poor financial condition of my family, I could not reach Delhi. Since then, no one has called me or communicated with me. We have less hope in connection with the case as nothing has happened in one year," Negi said.

Negi said he is worried about the poor health of his parents and was looking for an odd job. Another victim of the riots was IB staffer Ankur Sharma whose body was fished out from a drain close to his house in Chandbagh area.

His brother Ankur Singh said the family has shifted to Ghaziabad now.

"Six months back, we shifted to Ghaziabad as we missed Ankit a lot in that house," he said.

He felt investigation into his brother's murder was progressing "slowly" but expressed faith

"The government has announced that they will name a road in my brother's name at our village in UP's Muzaffarnagar. They will also install a statue of my brother and a gate with his name inscribed in it. The work of

road has started," Ankur stated. He recalled his brother as a frank man having both Hindus and Muslims as friends.

Among those who lost their lives also include a 42-yearold Delhi Police head constable Ratan Lal. He sustained injury during stone pelting at Gokalpuri and succumbed to injuries.

then Commissioner of Police (DCP), Shahdara, Amit Sharma and then ACP (Gokalpuri) Anuj Kumar were also severely injured while trying to quell the protests.

Delhi Police Commissioner S N Shrivastava last week said 755 FIRs were registered in connection with the riots and his force ensured a "free and fair" investigation.

'You are aware of the riots which led to 53 deaths and 581 injuries. Riots reached its peak on February 24 and 25 last year. We made it a point that no one had a grievance that their complaint was not acknowledged.' he said.

Delhi Police formed three SITs in its Crime Branch to probe 62 important cases, including 53 cases of murder and rioting.

A separate case was registered to unearth the conspiracy behind the riots, which was investigated by the Special Cell of the Delhi Police while the remaining 692 cases were investigated by northeast district police, police officers said.

"To ensure a free and fair investigation, technology was extensively used and the evidences which are based on science and technology cannot be refuted," the Delhi Police chief had said.

According to the police, overall, 1,818 people have been arrested so far in 400 cases in connection with the riots. They said 342 charge sheets have been filed by Delhi Police by the end of 2020, out of which the trial court has taken cognizance 250 cases.

Of the 1,754 accused arrested, 1,553 have been charge sheeted already, they said.

### Jamia Students Stage Protest; **Demand Reopening Of Campus,** Resumption Of Physical Classes

NEW DELHI: A group of Jamia Millia Islamia students staged a protest outside the campus here on Monday demanding the reopening of the university which has been closed since last year in view of the COVID-19 pandemic.

The varsity administration, however, maintained that a decision in this regard will be taken by the Executive Council (EC) after consultations with all stakeholders. The students raised slogans demanding that the varsity should proceed with phase-wise reopening like the Delhi University and the Jawaharlal Nehru University.

A larger group of students had staged a protest last week questioning the university's decision to keep the campus shut when other educational institutions were reopening with COVID-19 protocols. A senior Delhi Police

official said a group of around 20 students gathered outside the JMI campus demanding reopening of the varsity.

"They wanted the university administration to resume classes, canteen and library. They staged a protest and left after a while. Nobody was detained," he said.

According to the university spokesperson, "Views of all stakeholders, including students and parents, will be taken into consideration before a decision on reopening the campus is taken by the EC, the highest decision making body of the varsity".

"A large number of students and parents already wrote to the university administration, saying online teaching should continue as the environment is still not conducive for offline classes considering the COVID-19 cases and discovery of the South African and Brazilian mutant strains of coronavirus in the country" he said.

## Toolkit case: Police grills Nikita and Shantanu, gets one-day custody of Disha Ravi to confront her with duo

### 'A Test Batsman Must Be **Able To Handle All Kinds Of Conditions,' Feels Ben Stokes**

AHMEDABAD: Brushing aside the incessant talk around spinfriendly pitches in India, bighitting England all-rounder Ben Stokes has said that Test players should be proficient in handling all kinds of conditions.

Ahead of the day/night Test here starting Wednesday, Stokes wondered how the newly-refurbished Motera strip would behave but at the same time. stressed that top-flight cricketers should be able to deal with whatone and draw another to make it, England will have to triumph in both the remaining games. Stokes said nobody has the slightest clue how the track would behave.

"Generally around the world whenever these pink ball games are played there is always a period when the ball starts doing a bit under lights and it brings the seamers right into the game, Stokes wrote.

"For us out here that will be massive. And at a brand new ground that looks pretty impressive no-one will know just how it



ever they are faced with.

"The thing about being a Test batsman is that you need to be able to handle all types of conditions. India is one of the places where it is a lot tougher for overseas batsmen to come and be successful, but then so too is England," he wrote in a column for the 'Daily Mirror'.

"And that is part of the game, the challenges and why we love it," he said

The turning tracks in India became a talking point during the ongoing series when some former England players such as Michael Vaughan asked whether such strips were ideal for Test cricket.

The series is tied at 1-1 after India's brilliant 317-run triumph in the second Test in Chennai. Stokes' bowling quota of just two overs in that game raised a few eyebrows but he said it was about.

"Don't read too much into the fact that I didn't bowl a huge amount in the second game, I'm sure if it was a green seamer I would have bowled a lot more overs.

"I think there may be more reason for me to bowl under lights in the next game if it will help the team."

A lot is at stake for both India nd England in the four-match series as the World Test Championship final spot is still up for grabs. While India need to win will react.

"We've got a good spin department, but hopefully with conditions that suit, we've certainly got a seam department to back them up strongly.

Stokes said the Test triumph of the English team that toured in 2012 has been an inspiration for the current side.

"There aren't too many teams who come away from India with a series win.

The lads from 2012 are rightly proud of their achievement and the rest of us want to join Rooty, Jonny, Jimmy and Broady in achieving it for ourselves, and what a chance we've got," the 29-year-old said.

The outcome of the first two Test was pretty much decided by the team batting first and posting a massive total. If it was England in first Test, India did the same in the second. Stokes acknowledged the "scoreboard pressure".

"Scoreboard pressure in Test cricket is probably at its most prominent in the sub-continent. and plays a massive part in trying to win the game.

"The good thing is we know what it takes to win out here, so it once more, learning what we can from the second Test and delivering this week," he wrote.

### Air India Dismisses Bhaker's **Harassment Allegations, Says It Has CCTV Footage To Prove**

NEW DELHI: State-owned Air India has denied allegation of "harassment" of Tokyo Olympic prospect Manu Bhaker by two of the airline's staff at Delhi airport.

In a statement on Sunday, the flag carrier claimed that "legitimate" documents were asked for from Bhaker when she was boarding its flight along with her mother for Bhopal from Delhi on February 19, contrary to the allegations made by her against the airline. The 19-year-old Commonwealth Games and Youth Olympics gold medallist pistol shooter had sought action against two employees of the airline, for alleged 'harassment" and "insulting" her.

She had alleged that she had to go through the "ordeal" despite carrying all valid documents and clearance from the Directorate General of Civil Aviation (DGCA) for travelling with her weapons and ammunition.

Stating that as a responsible airine, it always "adheres" to the rules and regulations governing operations, it said that "in this case also, Air India was only following the protocol regarding such a sensitive activity like the carriage of arms on board".

"Our employee Manoj Gupta was at the counter throughout and had, at no point, communicated directly with Bhaker. This is also

corroborated by the CCTV footage. Hence, the allegation of misbehaviour by him simply does not arise," Air India said in the statement.

The CCTV footage also nullifies the passenger's allegation of bribes being asked for and snatching of mobile phone, it said. According to Air India, during check-in at the Delhi airport counter, Bhaker told its check-in employees that she was carrying an Air Pistol and a 0.22-bore gun.

"She was advised by our counter personnel to get the documents, mandatory to carry arms and ammunition, verified by Air India security officials," said the statement.

After verification of documents shown by Bhaker, the security officials informed her that the document required for exemption of payment of handling charge for carriage of arms, as per laid down norms, is not there. And, they said fixed charges for the carriage of arms would have to be paid, the airline clarified in the statement. It was explained to Bhaker that the document for exemption shown by her was not "valid" as it was signed only by the assistant secretary of the National Rifle Association. As per rules, details of which are available on the Air India website, signature of only the secretary or president of a bonafide association is recognised for waiver of the charges, Air India said.

### **Conway Powers New Zealand To T20 Victory Over Australia**

CHRISTCHURCH: Devon Conway made 99 not out from 59 balls to lead New Zealand to a 53-run win over Australia on Monday in the first of five T20 internationals.

The South African-born Conway

improved on his previous high score of 65 in T20 internationals, coming to the crease when New Zealand was 11-2 and leaving unbeaten when it was 184-5 after winning the toss and batting first. Australia was all out for 131 in reply.

Conway came to the last over of New Zealand's innings 87 not out, took a single, hit a four and a six and was 98 facing the last ball of the innings but could only manage a single to be left just short of a maiden century.

New Zealand struggled early against Australia pacemen Daniel Sams, Jhye Richardson and Kane Richardson before Conway led a concerted rival. Sams dismissed New Zealand

opener Martin Guptill with the third ball of the innings, then removed captain Kane Williamson (12) while Jhye Richardson bowled Tim Seifert (1) to leave the hosts 19-3.

Conway rebuilt the innings in partnerships of 74 for the fourth wicket with Glenn Phillips (30), 47 for the fifth with Jimmy Neesham (26), and 44 with Mitchell Santner (7).

"The wicket was a bit sticky at first but it got better and better as time went on and there were some good partnerships near the end there,"



said Conway. "The key was just try-

ing to stay positive throughout." "When I'm positive that's when I'm at my best. It was a matter of not trying to think too far ahead, just try to build good partnerships at the end." he said.

Australia also was in trouble early, losing captain Aaron Finch in the first over and Josh Philippe, on debut, in the next over to be 8-2. Both fell to catches by Conway. The New Zealand new ball pair of Tim Southee and Trent Boult were able to swing the ball under the floodlights at Hagley Oval - something the Australian bowlers couldn't do - and also captured the wicket of Matthew Wade to leave Australia 16-3.

When Neesham dismissed Glenn Maxwell (1), Australia were

MELBOURNE: It didn't take long for Novak Djokovic to make his intentions clear: All that matters to him from here on out is catching Roger Federer and Rafael Nadal in the Grand Slam standings.

Forget about winning other, run-of-the-mill tournaments or playing enough to retain the No. 1 ranking. There is one, primary goal for the 33-year-old from Serbia. He wants to keep adding to his 18 major championships he reached that number with No. 9 at the Australian Open on Sunday until he no longer trails Federer and Nadal. who share the men's record of 20. "They've made history already.

They made a tremendous mark in our sport, Djokovic said. "Whether I think about winning more Slams and breaking records? Of course, I do. And most of my at-

tention and my energy from this day forward, until I retire from tennis, is going to be directed (at) majors, trying to win more major trophies." Which is perfectly fine. There is no need for pretense. And there is absolutely no requirement that he show up to

It bears repeating that until Federer. Nadal and Diokovic came along, no man had won more than Pete Sampras' 14 Grand Slam titles. Here we are, less than 20 years after Sampras retired, and he's been surpassed by a trio of men, and by a lot of majors.

"We are talking about some Cyborgs of tennis, in a good way," Medvedev said, referring to the longevity and unprecedented success of the guys known as the Big Three. "They're just unbelievable." Diokovic's coach, 2001 Wim-

bledon champion Goran Ivanisevic, predicted Nadal will claim "one more, maybe two championships at the French Open, where he collected a 13th last October. That is the only instance of a man owning more singles titles

from one major than Djokovic's haul in Australia. Federer's high is eight at Wimbledon. All have career Grand Slams.

"Roger and Rafa inspire me. That's something that I've said before. I'll say it again. I mean, I think as

long as they go, I'll go," Djokovic said. "In a way, it's like a race (of)

### "When Crowds Gather, **Governments Get Changed", Says Farmer Leader**

SONIPAT: Farmer leader Rakesh Tikait took a dig at Union Minister Narendra Singh Tomar's remark that a mere gathering of crowd does not lead to revocation of laws, saying when people gather governments get changed.

The Bharatiya Kisan Union (BKU) leader, who has held a series of "kisan mahapanchayats" in Haryana this month, also warned that the government could find it difficult to stay in power if the new agri-marketing laws are not repealed.

The farmers' protest against the laws will continue till the time the Centre accepts their demands of repealing the legislations, Mr Tikait said while addressing a "mahapanchayat" at Kharkhoda in Harayana's Sonipat district.

On Sunday, Union agriculture minister Tomar in Gwalior said the Centre was ready to talk to the farmers protesting against the new laws, and that mere gathering of crowd does not lead to revocation of legislations.

He had urged the agitating farm unions to tell the government which provisions in these new laws they find anti-farmer.

Hitting back at Mr Tomar for his remark, Mr Tikait said: "The minister says that mere gathering of crowd does not lead to revocation of legislations. They have lost their mind. When crowds gather governments get changed.

Farmers, mostly from Haryana, Punjab and Uttar Pradesh, have been protesting at Delhi's borders since November 28 last year demanding rollback of the laws.

"They (the government) should know if farmers can destroy their own produce, then you are nothing before them," Mr Tikait said.

"There are many questions, it is not only the farm laws, but the electricity (amendment) bill, the seed bill... what kind of laws do they want to bring?" he asked and slammed the government for rise

in prices of diesel and petrol. Mr Tikait said that this agitation is not just of farmers, but also of

the poor, daily wagers and other sections. "These laws will destroy the poor. This is not just one law, many more laws like these will come," he said.

Referring to the farmer leaders spearheading the agitation, the BKU leader also reiterated that the government will have to talk to the same committee of 40 members.

The government has held 11 rounds of negotiation with protesting unions and these have remained inconclusive with regard to rollback of the laws. The agitation against the laws at Delhi's borders with Haryana and Uttar Pradesh is being led by the Sanyukt Kisan Morcha, which is an umbrella body of 40 farmer unions.

Mr Tikait said this stir will go on and farmers will work in their fields simultaneously.

Demanding a law on minimum support price (MSP) for farmers, he said. "When a law on MSP will be framed, farmers will be protected. This stir is about that, this is about rights of farmers."

Mr Tikait had recently said farmers will not return home till the farm laws are repealed and had added that farmers should be ready to sacrifice their standing crop for it.

The unions are protesting against the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020, the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020 and the Essential Commodities (Amendment) Act, 2020.

The three farm laws, enacted in September last year, have been projected by the government as major reforms in the agriculture sector that will remove middlemen and allow farmers to sell anywhere in the country.

However, the protesting farmers have expressed apprehension that the new laws would pave the way for eliminating the safety cushion of MSP and do away with the mandis, leaving them at the mercy of big corporates. The Centre has repeatedly asserted that these mechanisms will remain.

### **UP Budget Proposes At Least ₹ 640 Crore To** Develop, Beautify Ayodhya



LUCKNOW: The Uttar Pradesh budget tabled in the state assembly on Monday has proposed a sum of at least `640 crore for the development and beautification of Ayodhya.

The budgetary provisions for fiscal 2021-22 include a sum of w 300 crore for the construction of an approach road to Shri Ram Janmabhoomi temple, Ayodhya Dham.

The budget has also proposed a sum of ₹ 140 crore for the all-round growth of the city, including the development of Suryakund there.

Another sum of 100 crore has been provided for the development and beautification of other tourism facilities in Ayodhya.

The budget has also made a provision of ₹ 101 crore for the development of the Ayodhya airport, to be named Maryada Purshotam Shriram Airport.

To attract tourists elsewhere in the state, the budget provides ₹100 crore and `200 crore respectively for the development and beautification of tourism facilities in Varanasi and Chitrakoot. A provision of `200 crore has also been made for the Chief Minister Tourism Fiscal Scheme.

All developmental projects in the state will be executed in accordance with the mythological significance of various cities, an official spokesman said.

The budget has also provided a sum of `15 crore for the year-long commemoration of the Chauri-Chaura incident centenary.

The budget has also proposed ₹ 8 crore and ₹ 4 crore respectively for the construction of a tribal museum in Lucknow and a freedom fighters" gallery in Shahjahanpur.

In its budget, the state government has also decided to confer "Uttar Pradesh Gaurav Samman" on eminent writers and artists who have not been given any other award by the state.

Under this scheme, a maximum of five people will be honoured and given a sum of ₹ 11 lakh each every year.

## Mukesh Ambani's \$3.4 **Billion Deal With Future Stalled By Supreme Court**

upreme Court stopped regulatory approval for the Future Group's \$3.4 billion asset sale to Reliance Industries Ltd., delaying the deal in a boost for Amazon.com Inc., which wants to scuttle the transaction in its bid to dominate the country's retail sector. Agreeing with the American e-

commerce giant's petition, the top court on Monday overturned a lower court's ruling and said the company tribunal can continue hearing the case but must not give a final nod till further orders. The court also sought written statements from Future Retail Ltd. and said it will hear the case after five weeks. Future's stocks and bonds fell.

The latest verdict restores the legal advantage for Jeff Bezosfounded Amazon that secured an interim stay on the deal from a Singapore arbitration tribunal in October. It accused the Future Group of violating a partnership contract when it agreed to sell assets to billionaire Mukesh Ambani's conglomerate last year. The Monday order, however, endangers Future Retail, which is struggling to pay debt and has warned of insolvency.



Future Retail's stock fell as much as 10% and its dollar bond maturing in 2025 dropped 3.8 cents on the dollar after the court order Monday, Bloomberg-compiled prices show. Reliance Industries also slipped as much as 2.8%. Representatives for Amazon

India, Future and Reliance Industries didn't immediately respond to requests for comment. Future Retail can move the

Singapore arbitration tribunal to lift the interim stay the emergency arbitrator had imposed, that has formed the basis of Supreme Court's order.

The cash strapped Indian retailer, which says it would collapse should the deal with Reliance fail, is caught between two compete for dominance in India's estimated \$1 trillion consumer retail market. ### IMA 'Shocked' Over Pataniali's Claim On Coronil: **Demands Explanation From Harsh Vardhan**



he IMA, on Monday, expressed shock over the "blatant lie of WHO certification" for Patanjali's Coronil tablet, which the company claims is an evidence-based medicine to fight COVID-19, and demanded an explanation from Union Health Minister Harsh Vardhan in whose presence the medicine was launched.

This comes in the wake of global health body, WHO, clarifying that it has not reviewed or certified the effectiveness of any traditional medicine for the treatment of COVID-19.

Yoga guru Ramdev's Patanjali Ayurved had, on February 19, said the Coronil tablet had received certification from the Ayush Ministry as a medicine supporting COVID-19 treatment as per the World Health Organisation's certification scheme. However, Patanjali's manag-

ing director Acharya Balkrishna later made a clarification about the certification through a tweet saying, "We want to clarify to avoid confusion that our WHO GMP compliant COPP certificate to Coronil is issued by DCGI, Government of India. It is clear that WHO do not approve or disapprove any drugs. WHO works for building a better, healthier future for people all over the world (sic)."



In a statement issued on Monday, the Indian Medical Association (IMA) said, "Being Health Minister of the country, how justified is it to release such falsely fabricated unscientific product to people of the whole country...can you clarify the time frame, time line for the so-called clinical trial of this said anti-corona product?" "The country needs an expla-

nation from the minister. The Indian Medical Association will also write to National Medical Commission for seeking suo moto explanation for his blatant disrespect to the code of conduct of Medical Council of India, the IMA said.

"Indian Medical Association is shocked to note the blatant lie Haridwar-based

of WHO certification...," it said. Patanjali Ayurved had also released what it claimed was research work supporting Coronil's efficacy in COVID-19 treatment.

The announcement regarding the Ayush certification for Coronil and release of a research paper calling it the "first evidencebased medicine for COVID-19 by Patanjali" was done at an event here attended by Vardhan.

In a statement, Patanjali had said, "Coronil has received the Certificate of Pharmaceutical Product (CoPP) from the Ayush section of Central Drugs Standard Control Organisation as per the WHO certification scheme." However, WHO South-East

Asia in a tweet said: "@WHO has not reviewed or certified the effectiveness of any traditional medicine for the treatment #COVID19."

Patanjali had introduced Ayurveda-based Coronil on June 23 last year, when the pandemic was at its peak. It had to face severe criticism as it lacked scientific evidence regarding its efficacy.

# FIR Against Barkha Dutt's 'Mojo Story', 7 Twitter Handles For Spreading 'Fake News'

n FIR has been lodged against eight Twitter handles for alleg-Ledly propagating fake news in connection with the death of two girls here last week, police said on Monday.

The Twitter handles include news portal 'Mojo Story', led by senior journalist Barkha Dutt who termed the FIR a case of brazen "harassment and bullying". The case was registered at the Sa-

dar Kotwali police station area in Unnao on Sunday against seven more Twitter accounts: Janjagran Live, Aazad Samai Party spokespersor Suraj Kumar Boudh, Nilim Dutta, Vijay Ambedkar, Abhay Kumar Azad, Rahul Diwakar, Nawab Satpal Tanwar.

The FIR has been lodged for propagating "fake and misleading news" regarding the incident, Assistant Superintendent of Police Vinod Kumar Pandey said on Monday.

Reacting to the FIR, Ms. Dutt said, "We've followed journalistic principles by reporting all sides of an evolving story. To use IPC sections that are punishable with prison is pure intimidation. I am very ready to fight it and face it in court." The 'Mojo Story' editor alleged that the Unnao Police had refused to even give a copy of the FIR without which one cannot appeal for judicial intervention.

"Brazen Harassment and bullying," she said. "Even more suspicious is how Unnao Police has clubbed us with a bunch of politicians." Three girls, aged 16, 15 and 14, had left home to bring fodder for cattle on Wednesday night. They were found lying in an agriculture field when they did not return home

Local residents had rushed them to a hospital where two of them were declared brought dead. The third girl is presently undergoing treatment at a hospital in Kanpur, police said.

The last rites of the deceased girls were performed on Friday morning amid tight security arrangements.

The Unnao Police has held two people in this connection, accusing them of murder over one-sided love.
