Two Militants Killed In Anantnag Encounter: Police

SRINAGAR: Police on Wednesday claimed to have killed two unidentified gunmen in an encounter in a forest area in south Kashmir's Anantnag district.

Acting on a specific in-put about the presence of militants, police and army's 3RR carried out a cordon and search operation (CASO) in Shalgul forest area of Srigufwara on Wednesday morning, a police spokesperson said. During the search operation, he said, the militants were given an opportunity by the joint team to lay down their arms and surrender.

"However, they fired indiscriminately upon the joint search party, which was retaliated leading to an encounter. In the ensuing encounter, two unidentified militants were killed and their bodies were retrieved," the police spokesperson said.

Scientists decode how Mars may have lost its atmosphere

olar winds may have led to Mars losing its atmosphere, according to a computer simulation study which confirms the long held belief that planets need a protective magnetic field to block such harmful radiations in order to sustain life.

While factors like the existence of a moderately warm, moist atmosphere and liquid water determine whether a planet can host life, the study, published in the Monthly Notices of the Royal Astronomical Society, noted that the ability of planets to generate magnetic fields around them is an overlooked aspect.

According to the scientists, Arnab Basak and Dibvendu Nandi from the Indian Institutes of Science Education and Research (IISER) Kolkata, these magnetic fields enveloping planets can act like a protective umbrella. shielding the atmosphere from the superfast plasma winds of the Sun.

On the Earth, they said a geo-dynamo mechanism generates the planet's protective magnetosphere an invisible shield that stops the solar wind from eroding away our atmosphere.

In the current study. the scientists simulated two scenarios of the Red



In the current study, the scientists simulated two scenarios of the Red Planet—one considering a young Mars with its magnetosphere intact, and the other with the planet without this force field.

Planet—one considering a young Mars with its magnetosphere intact, and the other with the planet without this force field.

The simulations revealed that in the young Mars, the magnetosphere may have acted as a shield stopping the solar wind from coming too close to the planet's atmosphere

thus protecting it. Without an intrinsic

magnetosphere, the researchers said the solar wind magnetic field may have first draped around, and slipped past Mars, carrying bits of the planet's atmosphere away, eventu-

ally eroding it completely. They said the findings confirm the belief that the magnetospheres around planets play a crucial role in determining their ability to sustain life.

Alternatively, planets that lose their magnetic field eventually become inhospitable with loss of their atmosphere, the scientists added.

The researchers believe the study has important implications for the search for habitable exoplanets via initiatives like NASA's James Webb Space Telescope and IS-RO's ExoWorlds mission.

Dir SKIMS Specifies Five S's As Cause Of Heart Attacks

SRINAGAR: Director SKIMS also a famed cardiologist Dr. AG Ahangar Wednesday pointed to five S's as reasons for growing heart attacks in the Kashmir valley.

Speaking to newsgathering agency Kashmir News Service Dr. Ahangar said, "The heartbeat or the Cardio activity is the centre of the existence of the human body. The heart pumps the blood in the body. Heartbeat varies with the age.'

The reason for sudden cardiac deaths is advanced coronary artery disease wherein the blood vessel supplying blood to the heart is diseased beyond a certain level. "A person can die of sudden cardiac arrest when the circulation of a major part of heart gets affected. The heart can also have the disease of its muscle itself."

TRUCE EXTENDED FOR THREE MONTHS

NEW DELHI - India extended its cease-fire against mujahideen in Kashmir for three months, but warned it would take firm action against any group that con-tinued with violence.

Prim e Minister Atal Behari Vapayee told parliament, the ceasefire, due to expire on Monday would now be extended until the end of May. "Having exam-ined all as-pects of the question in its totality the government has decided to further extend the period up till the end of May, said Vajpayee today

Shiv Sena MPs, including three ministers, boycotted the Lok Sabha when prime min-ister Atal Bihari Vajpayee made the statement.

A bullet for a bullet should be our policy, party leader in the Lok sabha Anant Geete, said adding the extension of the cease-fire would result in in-creased threat to country's se-curity. Our demand is that the cease-fire be immediately scrapped, he said

National Security advisor and principal secretary to Vajpayee, Brajesh Mishrasaid the exten-sion of cease-fire should not be construed as a sign of weak-ness and indecisiveness. We look far friendship and peace with neighbours, but at no time

should it be seen as weakness or indecisiveness, Mishra said during an interactive session with the media and academics of the Jawahar Lai Nehru University after releasing a book Kargil and after, challenges for India here.

Mishra said there was strong evidence that showed that Pakistan could control the level of violence in Jammu and Kashmir. What Pakistan has done is stop shelling across the border, but it has continued to support materially and otherwise the militant acts in Jammu and Kashmir. Mishra ruled out any third party mediation on the Kashmir issue is spite of growing favourable international opinion on India's

stand on Kashmir. Meanwhile, Shiv Sena supremo Bal Thackeray, a known critic of unilateral cease-fire, has expressed concern over the growing violence in Jammu and Kashmir and dismissed as a foolish idea any possible talks between Vajpayee and Pakistani military ruler

According to people, it is a foolish idea. What is to discuss when they have a categorical demand for Kashmir... It is not your personal properly, it is not a birth day cake. My country is not a birthday cake so you can cut your piece and eat, Thackeray told CNN in an interview. 'Not under pressure'

Defence min-ister George Fernandes said the decision had not been taken under any pressure. It was taken in view of the challenges before the nation and also in consideration of the situation in Jammu and Kashmir, he told report-ers. Be said India ex-tended the cease-

Myanmar Faces More Protests As Indonesian Diplomatic Efforts Falter

yanmar was set for more street protests on Wednes-▲ day against military rule while Indonesia's efforts steer a path out of the crisis with the help of other Southeast Asian countries appeared to falter with a proposed diplomatic visit scrapped.

This week saw huge rallies and a general strike on Monday to denounce the military's Feb. 1 coup and demand the release of elected leader Aung San Suu Kyi, despite a warning from authorities that confrontation could get people killed.

On Tuesday, gatherings were smaller overall but a rally by members of members of different ethnic minorities was taking place in the commercial hub of Yangon, with civil servants from the energy ministry joining in.

We ethnic minority people haven't had the chance to demand our rights but now we do," said San Aung Li, 26, a member of the Kachin minority.

"So I'm supporting the protest as all ethnic people are, with one voice."

With the protest and a civil disobedience movement paralysing life in Myanmar, Indonesia has been trying to find a way out.

Sources said it proposed a plan centred on members of the Association of South East Asian Nations (ASEAN) sending monitors to ensure the generals stick to their promise to hold fair elections.

Military chief General Min Aung Hlaing has called for state spending and imports to be cut and exports increased to revive what he called an ailing economy.

He did not link the protests to economic problems but said the authorities were following a democratic path in dealing with them and police were using minimal force, such as rubber bullets, state media reported.

Security forces have shown more restraint compared with earlier crackdowns against people who had pushed for democracy during almost half a century of direct military rule.

Nepal PM Oli Will Not Step Down Despite Court Defeat, Aide Says

KATHMANDU: Nepal's embattled prime minister, K.P. Sharma Oli, will not resign but let parliament decide his fate instead, an aide said on Wednesday, a day after the Supreme Court rejected his decision to dissolve the legislature and call early elections.

The Himalayan nation has been in political turmoil since December, when Oli suddenly dissolved parliament and announced the elections, citing a lack of cooperation on key policy issues by leaders of a rival faction of his ruling party.

Oli, 69, has begun meeting allies in the Nepal Communist Party (NCP) to review the situation after the court held parliament's abrupt dissolution unconstitutional and ordered it to be called into session before March 8.

'The prime minister will not resign now. There is no question about that," Surya Thapa, the aide, told Reuters.

"He will face parliament," Thapa added, but did not elaborate.

Thousands of people opposing Oli waved red and white flags bearing the Communist hammer and sickle as they took to the streets in the capital, Kathmandu, for a rally to celebrate the court decision and press the prime minister to resign.

Malaysia Court: Stop Deporting Remaining 114 Myanmar Nationals were all Myanmar nationals

The High Court of Kuala Lumpur has issued an order to stay the deportation of 114 Myanmar migrants, the only ones left of a group of 1,200 people the Malaysian government sent back to Myanmar in defiance of an earlier ruling.

The court's decision on Wednesday was welcomed by the rights groups Amnesty International and Asylum Access Malaysia, which condemned the move by the government of Prime Minister Muhyiddin Yassin as a violation of the principle of international human rights.

"We believe the government owes an explanation to the people of Malaysia as to why they chose to defy the court order, and on the identity and status of all 1200 people," said Katrina Jorene Maliamauv, executive director of Amnesty to Myanmar's navy. International Malaysia.

India 'Cow Science' Exam Put Off Amid 'Controversy Over Syllabus'

nationwide examination on "cow science" in India has been postponed indefinitely after widespread criticism over the propagation of unscientific claims about the animal, which is considered sacred by the country's Hindu majority. The Rashtriya Kamdhenu Aayog (RKA) or National Cow Commission, set up by the ruling Hindu nationalist

government, was to organise the online exam on Thursday. The syllabus for the exam sparked controversy, with media reporting that it contained unscientific claims such as

that cow milk has traces of gold in it and earthquakes occur due to cow slaughter. 'The government's animal husbandry department, under which the commission functions, shelved the exam because of the controversy and furore over the syllabus," an official at the commission said, requesting anonymity. "The exam was the brainchild of RKA Chairman Vallabhbhai Kathiria whose term ended on February 20. The department will supervise the commission till a new chairman is appointed," he added. The Hindu newspaper reported that the department had disowned the exam which promoted fake claims and pseudoscience.

The commission had "no mandate" to conduct such an examination and any future awareness programme would be conducted on a "scientific basis," the report said, citing department officials.

Chinese Court Orders Man To Pay Ex-Wife \$7,700 For 5 Years Of Housework

BEIJING: A Chinese court has ordered a man to pay his former wife 50,000 yuan (\$7,700) as compensation for housework she did during their five-year marriage, state media reported on Wednesday. Under a landmark civil code that seeks to better protect the rights of individuals, spouses can seek compensation from their partners in a divorce if they have shouldered more responsibilities - including housework. The woman, who did not work outside the home during the marriage, sought compensation for housework she had done after her

husband filed for divorce at a district court in Beijing last year. The judge ruled in her favour, telling the man to pay 50,000 yuan for her labour, according to state television. He must also pay 2,000 yuan a month to support their child, with other assets such as property to be divided equally. The award of compensation for housework sparked debate on Chinese social media, with many netizens saying the amount was too little.

SRINAGAR: The cases of Avian Influenza (H5N8), popularly known as Bird flu have been reported in 10 districts of Jammu and Kashmir, however, no case has been reported among poultry birds as of now.

Officials said that the first cases of bird flu among dead crows were reported from Anantnag, Pulwama, Kulgam and Budgam on 22 January.

They said that on 31st January, cases of avian influenza were reported among domestic birds in Udhampur district.

Talks with Taliban

Intra-Afghan talks between the Taliban and the Afghan government have resumed in Doha, the first time after assumption of office by Joe Biden in the US. The recent weeks have witnessed an escalating graph of violence in the war-torn country. Biden administration has sought to review the agreement reached between the Trump administration and Taliban in February last year. There is an emerging consensus about the delay in withdrawal deadline. The US is also toying with the idea of leaving behind an intelligence-based force that would focus on 'counterterrorism' and the ISIS affiliate in eastern Afghanistan.

But Taliban wants the US to stick to the agreement. Last week, the Taliban in an open letter called on the US to abide by the Doha agreement and assured it of its commitment to securing US security interests in the country. The Taliban have also opposed even a brief extension of withdrawal deadline.

There are 10,000 foreign troops in Afghanistan including 2500 US troops. In the weeks ahead, it will be important to see how the US will review the Doha accord. It is, however, unlikely that the Biden administration will depart in any conspicuous way from the accord. Already, the US has retained the diplomat Zalmay Khalilzad, who negotiated the US agreement with the Taliban. At the same time, the US has also reached out to Pakistani and its Army Chief General Qamar Javed Bajwa. Pakistan's participation is seen as critical to the success of the Doha accord and consequent peace in Afghanistan. As of now, the US wants a drastic reduction of violence and the Taliban agreeing to a ceasefire.

However, if will be a while before the the US-Taliban and the Taliban-Afghan government reaches its logical conclusion and peace returns to the country. Eventually the stability in Afghanistan will have to be the responsibility of the regional powers. The conflict in Afghanistan is now so much enmeshed with the regional rivalries and the issues that it appears improbable that there would be long term stability in Kabul unless steps are taken to get the regional countries cooperate to end the forty year long bloodshed in the country. The deeply challenging project of a peaceful Afghanistan, therefore, demands a broader regional cooperation, more so, between India and Pakistan. It is only hoped that New Delhi and Islamabad realizing the momentous changes sweeping through region will cooperate to not only steer the region through the fraught transition of a post-US Afghanistan but also take concrete steps to address their lingering differences which alone will be the guarantee for a sustainably peaceful South Asia and the broader region.

Petrol@100

n several parts of the country, petrol prices have either touched or are nearing a record high of Rs 100 per litre. While the recent rise can be traced in part to the firming up of global crude oil prices — the Indian crude oil price basket has risen from \$40.66/bbl in October last year to \$54.79 in January — this hardening of prices is amplified by the inordinately high fuel taxes imposed by governments. With global demand firming up — a quick rollout of the COVID vaccine could provide a fillip — crude oil prices may well harden further, leading to higher retail prices, unless the high levels of indirect taxes are rolled back by central and state governments in a calibrated manner.

While numbers vary across states, a significant part of the retail fuel cost is attributable to the levy of taxes by both central and state governments. Take Delhi, for instance, According to data from the Indian Oil Corporation, the retail price on February 16 stood at Rs 89.29 per litre. Of this, the basic fuel cost is Rs 31.82, while Rs 32 is on account of excise duty and Rs 20.61 is due to the levy of a value added tax. This implies that roughly 60 per cent (37 per cent on account of excise duty and 23 per cent on account of VAT) of the total retail price of petrol is due to central and state taxes. A consequence of such high fuel taxes is that income from the petroleum sector now accounts for a significant source of revenue for both central and state governments. According to data from the Petroleum Planning & Analysis Cell, the total contribution of the petroleum sector to central government coffers has risen from Rs 1.72 lakh crore in 2014-15 to Rs 3.34 lakh crore in 2019-20, while for state governments, it has risen Rs 1.6 lakh crore in 2014-15 to Rs 2.21 lakh crore in 2019-20.

Notwithstanding that high fuel prices reduce households' discretionary spending and are inflationary — the monetary policy committee noted that unwinding the taxes on petroleum products by both Centre and states would ease cost push pressures — the excessive reliance on higher fuel taxes to shore up revenue also underlines the limited ability of the government to raise money through other sources. According to the 15th Finance Commission, buoyancy in direct taxes fell to 1.1 during 2011-12 to 2018-19, from 1.8 in the previous decade. Collections through the goods and services tax have also been lacklustre — according to the Finance Commission, the gap between potential GST revenue and current realisation.


— according to the Finance Commission, the gap between potential GST revenue and current realisations is around 2 per cent of GDP. If crude oil prices firm up further, the limits of this strategy of extracting more revenue from an already overtaxed fuel sector will be tested. A more prudent alternative would be for the government to focus on increasing revenue through better direct tax and GST compliance.

Liberal democracy is on a perilous path

Many Americans have lost confidence in the political leadership and democratic system. But mere populist slogans or violence won't address complex political, economic, and social problems. The best hope is a revival of the original promise of liberal democracy, where working people feel part of the system. A refreshed commitment towards a fairer society, human rights, and justice.



s matters calm down after the bloody events preceding the transfer of power in Washington, one conclusion is palpably evident. Many Americans have lost confidence in the political leadership and democratic system. Their disenchantment with liberal democracy poses a deadly threat. It has created fertile ground for populist demagogues to tap into deep-seated grievances.

A most alarming development is that a minority of extremists have resorted to mob violence to overturn the verified results of free and fair elections. Their crude attempts to subvert the rule of law have created a volatile environment. Those individuals and organizations involved in unlawful activities must face the full force of the law.

The spectacle of the ransacking of the bastion of American democracy by anti-democratic forces will linger for some time. America's claims of being a model democracy are in tatters. It is a disturbing development for pro-democratic forces throughout the world.

But mere populist slogans or violence won't address complex political, economic, and social problems. These problems need sober analysis and concrete actions.

According to a report in 2020 from the University of Cambridge Center for the Future of Democracy, 55% of Americans are dissatisfied with the system of government. The report suggests that the deep democratic malaise is due to the government's failure to manage financial crises and growing inequality.

Partisanship and gridlock in Washington add to democracy's woes. Convincing Americans who feel that democracy is a luxury that they are on the wrong path is increasingly difficult. Politics divided by left and right extremes, unable to find common ground, just isn't working. But the alternatives are authoritarianism and autocracy, a slippery slope to disaster.

It's not surprising that economic issues drive the growing disillusion-

ment with the political system. As an example, participants in focus groups organized in the US and UK by the Pew Research Center in 2019 felt "left behind". They blamed the forces of globalization for closing industries, causing people to abandon their homes and harming them economically.

Since the 1990s, the globalization of manufacturing jobs has hit some key areas and industries in the US and other western democracies. The primary reason is that multinational corporations, eyeing increased profits, moved operations to lesser developed countries.

Globalization is blamed for stagnating incomes and job losses in developed economies. It has left an insecure workforce and caused deep divisions in society between the winners and losers. They include rural and urban voters in the US spread across generations.

The losers see globalization as a big win for multinational businesses and their shareholders, the Wall Street fat cats. A large group of voters blames Washington politicians for unfair trade deals and their reduced standard of living. As income inequalities rise, these dis-grunted voters support politicians who advocate a return to protectionism and imposing curbs on immigration.

Advocates pitched globalization as a win-win strategy for both rich and poorer countries. That consumers in rich countries could access inexpensive products made by workers in developing countries at a lower cost. And as trade barriers dropped, economic expansion and global political cooperation would ensue.

There's no doubt that globalization has helped lesser-developed countries to export low-cost products to new markets. The downside is the exploitation of cheap labor and abysmal working conditions in many developing countries.

But many working people in rich countries, long pampered by consumer capitalism, have lost out. They see globalization as a negative wealth transfer and fear for the future for themselves and their families. This crisis of confidence is hard to manage in a democracy as economic issues

impact voting decisions.

While it is too late to stop globalization, it is possible to mitigate its excesses through fair trade agreements and competition, and more innovation. Another way to lessen its impact is the partial reinvestment of corporate profits earned through globalization. Such investments can help in the revitalization of industries, leading to the creation of new jobs, in affected areas in the US.

At the same time, the hardening of the social and class divide is another crucial challenge to liberal democracy. It is not just less well-off Americans, losing out to globalization, who are questioning the value of democracy. Richer Americans, fearing policies that favor a redistribution of wealth, are growing increasingly impatient with democratic institutions.

There is no simple way out of the mess that liberal democracy finds itself in the US and elsewhere. Unlike dictatorships, democracies can't force unity at gunpoint to counter alienation. Visionary leadership, Democrat and Republican are needed to bring around angry voters. Americans need a powerful message of renewal in the shared purpose and common destiny in the liberal democratic system.

Most importantly, the pillars of American democracy: an independent judiciary, freedom of the press, the rule of law, and civil associations (secular and religious) need safeguards. It would be a grave mistake if America allows the erosions of these vital democratic institutions.

The best hope is a revival of the original promise of liberal democracy, where working people feel part of the system. A refreshed commitment towards a fairer society, human rights, and justice. Otherwise, liberal democracy, unable to deal with political, economic, and social challenges, faces a perilous future.

Qaleen Bafi: The Wilting Art of Kashmir

aleen is a type of hand knotted pile carpet. Sultan Zain-ul-Abidin introduced Qaleen making craft from Persia to Kashmir in the loth century. The Sultan brought carpet weavers from Persia and Central Asia into Kashmir to train the local inhabitants. The art of Qaleen making of Kashmir is famous worldwide but it is now dying.

The craft of weaving Qaleens is practiced mostly by people in rural areas. The carpets are woven on a large wooden loom having two logs fixed horizontally. White threads are carefully tied on these legs which form the base of the carpet. In Kashmir, either cotton or silk threads are used as the base of the carpet. The deadline for weaving a carpet is fixed by the middleman who buys the carpets from the artisans. The price depends upon the material used in the carpets. The carpets are made of three types: silk on silk, silk on cotton and art silk on cotton. The carpet trade is Rs 650 crore strong with a majority of products worth Rs 412.45 crores exported to United States, Germany, France, United

Kingdom and Gulf countries. However these huge prices haven't changed the lives of the artisans.

Due to less returns, many artisans are switching their profession and the children of artisans are pursuing different professions. Another factor which has contributed to the decline in the art of weaving Qaleens is the decrease in the production of world renowned Kashmiri silk which has forced the dealers and government to import silk from outside. The carpet industry is not regulated by the state

government which means the artisans don't benefit from the rising price of Qaleens. Adding to this, educational backwardness of artisans often exposes them to being overexploited by middlemen. Their wages depend on how kind their middlemen are. So, the government needs to come up with policies to save the legacy of this art.

She insists for a unique feel which could present to her something different than what she has already felt in her previous travels. In the sphere of tourism, destinations across the globe are coming up with effective strategies to

rope in more number of tourists. For instance, Japan is seeing a surge in the number of its inbound tourists due to its advances in robotics. The Commuter's Paradox

There's something to gain in the space between home and work

or many of us, one of the upsides of 2020 was being freed from the grind of the daily commute. For the 40% of the workforce able to "telecommute", COVID-19 social distancing measures saved us an average

for those of us living in the outer suburbs Studies show the morning commute is the least favourite part of the day, and the commute home the third-least favourite

of about an hour a day - and much more

(working is the second-least favourite). Congestion, crowding and unpredictability increase stress and dissatisfaction. The longer it takes, and the more we have to do in the company of others, the more we dislike it.


But it's also possible to miss aspects of that enforced time between work and home. For all its downsides, the daily commute does have some positives, acting as both a starter button and circuit breaker to differentiate work from

home life. As life returns to "normal" and employers ask us to return to the workplace, thinking consciously about those benefits can help make the most of your commute.

A commuting constant

Though we think of commuting as a modern phenomenon, spending time getting to and from work is as old as humanity. Hunting and gathering (going back 200,000 years), farming (about 10,000 years), and living in cities (about 5,000 years) all involved leaving and returning home. These routines seem to have ingrained in us an idea of acceptable travel times.

In 1994 an Italian physicist, Cesare Marchetti, wrote a paper, Anthropological Invariants in Travel Behaviour, on the "quintessential unity of travelling in-

stincts around the world, above culture, race and religion"

Drawing on the work of Israeli transport analyst Yacov Zahavi, Marchetti proposed humans had always been willing to spend about an hour a day travelling from and to home.

This idea of commuting time being 30 minutes each way has become known as Marchetti's Constant. In a 2001 paper, travel researchers Lothlorien Redmond and Patricia Mokhtarian found most people's ideal commute time was, in fact, less – an average of 16 minutes – but their results also confirmed the dislike of any commute longer than 35 minutes.

A psychological buffer

The longer the commute times, the more stressed and dissatisfied we feel. Yet without time between home and

work, there's also a downside. As Mar-

chetti wrote: "Even people in prison for a life sentence, having nothing to do and nowhere to go, walk around for one hour a day, in the open."

Commuting can be a ritual that helps us psychologically separate home life and work - switching off from personal concerns in the morning, and then detaching from work worries in the evening. A huge body of research over the past four decades show this "psychological distance'

is crucial to well-being.

Research also shows that switching from our home to work "identities" carries cognitive demands. A buffer between the two can help make this transition.

It is possible to achieve this psychological distancing without a commute, of course - by going for a morning walk and changing into work clothes - but the demands of both family and work responsibilities often mean we don't make that time.

Making the most of your commute

So we shouldn't necessarily spurn the return to the daily commute. Yes, there are downsides, but being conscious of the psychological benefits enables you to maximise its benefits.

Rather than thinking of it as dead time, think of it as "me" time.

In the morning, use your commute to plan your day. Research has found this increases satisfaction at work and makes longer commutes more palatable. Maintaining small routines on the way has also been found to help.

In the evening, use the time to unwind with pleasurable activities such as reading, playing mobile games, calling a friend or family member, listening to music or a podcast. These are activities you won't necessarily have time for once you get home.

Doing nothing is good too. Many of us have little time for idle thoughts. Here's a chance to let your mind wander. Free thought time helps to solve problems and inspire creativity.

And, of course, switch to walking or cycling if you can. Along with the "alone" time it gives you, physical activity is strongly associated with higher overall happiness.

You can't necessarily control the amount of time you spend commuting, but you can control what you get out of it.

Positive encouragement may up academic outcomes in school kids

ffering dents more positive encouragement not only reduces disruptive classroom behaviour, but can improve students' academic and social outcomes, say researchers.

The findings, published in the Journal of Educational Psychology, indicated that a behaviour management intervention helped increase student engagement and boosted the teachers' confidence in their ability to manage disruptive behaviour.

"As educators, we

often focus on communicating what we don't want our students to be doing in class, but we have found that just doesn't work " said researcher Keith Herman from the University of Missouri in the US.

"Instead, we need to be setting clear expectations of what behaviours we do want to be seeing," Herman added.

For the study, the researchers implemented CHAMPS, a classroom behaviour management training intervention, into a school classroom over the course of five years.

The intervention not only decreased disruptive classroom be-

concentration problems, but also improved both completed class work and standardized test scores, as well as increased the amount of time students remained on task with classroom assignments.

"The intervention is based off principles and practices research has shown to be helpful in creating successful classroom management, such as communicating clear expectations to students, giving more positive encouragement compared to negative reprimands and moving around the classroom to monitor student

behaviour." Herman said.



Young drivers find music is a must as more stimulus helps their driving ability

riving is "absolutely impossible" without music, suggested the findings of a new study led by

Negev (BGU) researchers. The novel study was published in the journal Psychomusicology: Music, Mind, and

Ben-Gurion University of the

Brain. "To young drivers 18-29. music in the car isn't just entertainment, it's part of their autosphere whether they're alone or not," said Prof. Warren Brodsky, director of the BGU Music Science Lab in the Department of the Arts

"They are so used to constant stimulation and absorbing great amounts of information throughout the day, that they don't question how the type of tunes they play might affect

concentration, induce aggressive behaviour, or cause them to miscalculate risky situations," added Brod-

"As the fastest growing research university in Israel, BGU provides studies that give us great insight

into the causes and effects of human to a 67-item questionnaire explorbehavior," said Doug Seserman, chief executive officer, American Associates, Ben-Gurion University of the Negev.



"Music is an essential, universal language which we can all appreciate. Undoubtedly, though, the concerns that stem from the results of this study are worth considering,' added Seserman.

According to the study published, 140 young adults responded ing how drivers engage with music while driving. Ironically, most of the respondents (80 per cent) claimed it was not only "difficult," but some-

times "near impossible" to concentrate on traffic and road conditions without music playing. And once they arrive, most of the respondents will stay in their car at their destination until the song ends.

Almost all drivers (97 per cent), report listening to many short songs on long trips, and 65 per cent played "fast-paced" music while driving to work. More than two-thirds (76 per cent) play "liberating" dance songs when on vacation or a holiday outing, 90 per cent play "upbeat" dance music on the way to a party.

"These young drivers believe that more stimulus actually helps their driving abilities," Brodsky said. "This could become more of an issue in the future, when it becomes critical to disengage from music and assume control in an autonomous

ight-intensity physical activity, including gardening, shopping or a casual walk may protect mobility in older women, suggests a new study. The study indicated that women who did not have a mobility disability at the start of the study, and who spent the most amount of time doing light-intensity activities, were 40 per cent less likely to experience loss of mobility over a six-year period.

"Older adults who want to maintain their mobility should know that all movement, not just moderate-to-vigorous physical activity, counts," said researcher Andrea LaCroix from the University of California - San Diego.

"We found that, among older women, light-intensity physical activity preserves mobility later in life," La-Croix added. According to the researchers, one in four women over age 65 is unable to walk two blocks or climb a flight of stairs. Known as a mobility disability, it is the leading type of incapacity in the US and a key contributor to a person's loss of independence.

For the study, published in the journal JAMA Network Open, the team involved 5,735 women age 63 and older. Participants wore a research-grade accelerometer for seven days to obtain accurate measures of their physical activity. The mean time spent in light physical activity was 4.8 hours per day.

Researchers found that women who spent the most time performing light-intensity physical activity had a 46 per cent lower risk of mobility loss compared to women who participated in lower levels of physical activity.

GDC Dooru Students Rue Lack Of Staff, Infrastructure

Agenceis

DOORU: The lack of staff and infrastructure at Government Degree College (GDC), Dooru, Anantnag is painting a grim picture of the education sector as the students continue to suffer while the authorities concerned are acting as mute spectators as they have failed to take any action in this regard.

The students and the staff said that they are facing immense hardships due to lack of proper infrastructure and teaching staff.

"The educational institution was established in 2005 during the Congress-PDP government in Jammu and Kashmir. At least 1300 boys and girls are currently enrolled in this College," they said.

Muzamil Deva, a 3rd Semester student said that six teachers were transferred two months back but new teachers

have not yet been deputed in

"The college lacks teachers for many subjects includ-ing Chemistry, Biochemistry, English and Economics. The college also lacks Physics and Psychology subjects' lecturers for the past one year," he said, adding that there is only one political science lecturer at the College, which is inadequate for a large number of students enrolled there.

Both the students and the staff rue poor infrastructure including lack of space for holding classes. "Five years after the college was established, the college infrastructure is yet to be enhanced," the employees in the college said.

They said that the construction of the Science block for the College has been approved two years ago and an allocation of Rs 8.85 Crore was made, but the construction work is still on hold due to

some issues between the contractor and the public works department.

The department has so far de-notified tenders five times for the construction of the block and the matter is currently pending in court, they added.

The IGNOU study centre was introduced in the college three years ago, but for unknown reasons, the centre has also been closed, they informed.

Javed Ahmed, President of Shahabad Citizen Forum said that the students from Dooru, Verinag, Kaparan, Qazigund and Banihal are studying at the College but are facing inconvenience due to the lack of adequate facilities.

appealed to the He Lieutenant Governor Manoj Sinha to look into the matter and resolve the issues at an earliest.

Executive Engineer R&B, Qazigund Riyaz Ahmad said that keeping in view the scarcity of space in the college, the department had invited tenders for construction of twostorey Science block for which funds were also allocated but the papers of the contractor, in whose favour the work was allotted, were not found in the Circle Office as per the rules due to which the tender had to be cancelled.

However, the contractor has now taken the matter to the court and he is expected to get a decision from the Court

An official in the education department said that the government had decided to engage guest faculties in the Colleges instead of academic arrangements.

"The guest faculty will attend the colleges on a need basis. This is being done to overcome the deficiency of teaching staff in the colleges," he said—(KNO)

Saugat Biswas, Deputy Commissioner Ganderbal, Deputy Commissioner Kargil, Chief Engineer BRO, officials from NIDCL and SSPs of district Ganderbal and Kargil joined the meeting through Video Conferencing.

"To ensure mobile connectivity for travellers along the highway in case of any emergency, Div Com directed the BRO to provide logistic support to BSNL and Jio networks to resume the cellular connectivity," he added.

As per the official spokesperson, Pole also directed the CE, BRO to provide different kinds assistance including accomodation, food, petrol etc to the travellers during emergency along the highway.

"Besides, he directed the DC Kargil, and CE, MED to place recovery vans on road as per the past practice. The Div Com directed for close coordination among the Dy. SPs and Collectors on both sides of the pass to ensure hassle free movement of vehicles," he added

Qazigund-Banihal Tunnel

Oazigund-Banihal along the Srinagar-Jammu National Highway to reduce travel distance and make it an all season motorable road.

However, the 10.5 km Chenani-Nashri tunnel was thrown open by the end of 2018 but the 8.5

km Qazigund-Banihal is awaiting completion. The tunnel with two parallel tubes is being constructed by Indian infrastructure major Navayuga Engineering Co (NEC) at a cost of

around Rs 2000 crore. Muneeb Tak, Chief Manager, Navayuga Engineering Company said that Qazigund-Banihal tunnel would reduce the distance between two sides by over 16 km.

He said that it is a double tube tunnel and each tube will be seven meters (23 ft) wide and will bypass the spots where there remains obstruction in vehicular movement on the highway during winters like Jawahar Tunnel and Shaitan Nallah.

Officials said that this project has been completed on the Austrian tunnelling method and over one hundred jet fans, over 200 CCTV cameras and fire fighting systems are being established in both tubes of the tunnel.

They said that Qazigund-Banihal tunnel is 8.5 km long at an elevation of 1,790 m (5,870 ft) in Pir Panjal range in J&K.

Officials said that it is a double tube tunnel consisting of two parallel tunnels -one for each direction of travel and two tunnels are interconnected by a passage every 500 m (1,600 ft) for maintenance and emergency evacuation,

"The tunnel will have forced ventilation for extracting smoke and stale air and infusing fresh air and it will have state of the art moni toring and control systems for security," they said-(KNO)

"Whoever goes to the government centre will be administered vaccine free of cost. Indian government will pay for them. The government will purchase the necessary doses and will send them to all the states."

Javadekar said those who want to get vaccination from private hospitals will have to pay, but the amount will be decided by the health ministry within the next three-four days as they are in discussions with manufacturers as well as hospitals.

Asked if people will have a choice of vaccine, Covishield or COVAXIN, Javadekar said India is proud to have two vaccines which are both efective with proven efficacy.

According to the Rules, the reserve list shall be valid for a period of one year from the date of recommendation of the first list by the Commission.

Since 2002, the Union Public Service Commission also maintains a confidential consolidated reserve list that includes candidates from general and reserved categories ranking in order of merit below the last recommended candidate under each category in Civil Service Examination (CSE).

According to the Rules, reservation will also be made for candidates belonging to International Border (IB), Economically Weaker Section (EWS), Pahari Speaking People (PSP) in respect of vacancies as may be fixed by the government.

Already, candidates belonging to the Scheduled Castes, Scheduled Tribes, RBA/Social Castes/ALC and Physically Challenged categories are eligible for reservation.

Under the new rules, a candidate must be domicile of Jammu & Kashmir Union Territory to compete for the examination, for which only permanent residents of Jammu & Kashmir were eligible before re-organisation of erstwhile state of Jammu & Kashmir—(KNO)

As he made his way into the ground after England opted to bat, captain Virat Kohli's men lined up to honour his longevity and service to Indian cricket.

In his landmark game, Ishant provided the home team a perfect start as he removed Dominic Sibley in the third over.

Though he has had many memorable moments in his career so far that has nearly spanned a decade and a half, Ishant struggled to name one while speaking to reporters ahead of the game.

"If your career is 14 years long and you are still playing, you cannot name just one highlight. It is difficult to pinpoint just one highlight, every sportsperson has the graph going up and down," Ishant said.

During the first Test against England earlier this month in Chennai, Ishant became the sixth Indian and third pacer from the country to take 300 wickets in Test cricket, joining legendary former captains Kapil and Anil Kumble.

Ishant, who has 11 five-wicket hauls and picked up 10 wickets in a match once, made his Test debut back in 2007 against Bangladesh.

Prior to the start of the match, Ishant was hailed by the likes of Kohli, Sachin Tendulkar, Virender Sehwag and Ashish Nehra.

England All Out For 112 As Axar Patel Takes 6 Wickets

AHMEDABAD: Indian spinners shot England out for just 112 inside two sessions with Ravichandran Ashwin and Axar Patel sharing the spoils after pacer Ishant Sharma opened the floodgates in his milestone 100th match on the opening day of the day-night third Test in Ahmedabad on Wednesday.

England were all out for 112 in 48.4 overs in the second session on a spin-friendly Motera pitch with Patel (21.4-6-38-6) grabbing his second five-for in his second Test while Ashwin (16-6-26-3) took three.

Openers Rohit Sharma (5 batting) and Shubman Gill (0 batting) negotiated five overs to take India to five for no loss at the dinner break.

Gill, however, survived after TV umpire ruled him not out in the third over after England claimed for a catch.

Ishant, only the second Indian fast bowler after Kapil Dev to play in 100 Tests, fittingly took India's first wicket in the third over as he dismissed opener Dominic Sibley for nought.

Thereafter, it was all Ashwin and Patel show as the duo bamboozled the England batsmen to complete the submission, except for the other opener Zak Crawley, who hit an eminently delectable half-century. Six English wickets fell in the second session.

England did not have any substantial partnership with the 47-run stand for the third wicket being the highest. They lost their last seven wickets for just 38 runs.

Crawley's brilliance was, however, neutralised by the Indian spinners as England were left reeling at 81 for 4 going into tea after an exciting opening session in the pink ball Test.

Two wickets fell in as many overs after the resumption of the second session, with Ashwin and

Patel taking one each, to reduce England to 81 for 6.

Ashwin sent Ollie Pope's (1) off-stump cart-wheeling with a beauty of a delivery, bowling round the wicket, before Patel trapped Ben Stokes (6) LBW in the next over with a ball that spun in.

Jofra Archer (11) did a tad better as he hit a four in the second ball he faced and another boundary off Ashwin. But, Patel had him soon, cleaning up his off-stump to send England innings into a mess.

England's rapid slide continued with Jack Leach edging one to the gully where Cheteshwar Pujara took a low catch off Ashwin, though the TV umpire took time to confirm the decision.

Crawley's effort was the only silver lining for England. Having missed the first two Tests due to a freak wrist injury, the stylish right-hander's driving was elegance personified as he hit 10 boundaries during his 84-ball 53.

Earlier, playing his landmark 100th Test, Ishant couldn't have hoped for a better start when he got a delivery to hold its line and bounce a shade extra, which Sibley edged to Rohit Sharma at second slip.

Axar, brought in as early as in the seventh over, struck with a delivery that came in with the arm and Jonny Bairstow (0) was adjudged leg before, leaving England at 27 for 2.

However, Crawley was in no mood to play the defensive game and made most of what always is the best time for batting in a pink ball Test. His half-century had 10 boundaries and came off 68 balls.

Captain Joe Root was the second highest scorer with a 58-ball 17 before Ashwin got his crucial wicket with a delivery that turned a shade.

Crawley, who had tried the reverse sweep without much success, was accounted for by Axar when he played for the away turn.

AHMEDABAD: President Ram Nath Kovind on Wednesday inaugurated the world's largest cricket arena -- the refurbished Sardar Patel Stadium in Motera -- a state-of-the-art facility which can accommodate an awe-inspiring 1.32 lakh spectators.

The President inaugurated the stadium in the presence of Home Minister Amit Shah and Sports Minister Kiren Rijiju among a host of other dignitaries. It opens with the third Test between India and England, a day-night game from Wednesday, and will also host the fourth and final game of the series from March 4.

The stadium, which was earlier named after India's first deputy prime minister Sardar Vallabhbhai Patel, has been renamed after current prime minister Narendra Modi and will henceforth be known as the Narendra Modi Stadium. Spread over 63 acres, the stadium has been built at an estimated cost of 800 crore and with a seating capacity for 1,32,000 spectators, it has surpassed the hallowed Melbourne Cricket Ground which can accommodate 90,000.

At least 62 Killed In **Ecuadorean Prison Gang Riots**

QUITO: At least 62 people have died in simultaneous violent riots in three Ecuadorean prisons on Tuesday that the government described as a concerted action by criminal organizations.

President Lenin Moreno has sought to control prison violence in the Andean country, declaring the prison system in a temporary state of emergency, because of the frequent confrontations between criminal gangs.

These were two groups vying for criminal leadership within the detention centers," said Edmundo Moncayo, director of Ecuador's prison agency.

The toll had risen to 62 confirmed deaths, Moncayo said. With the help of an additional 800 police officers, Moncayo said, authorities have been able 'to control and restore order within the detention centers."

The violence erupted in prisons in Guayas, Azuay and Cotopaxi provinces, which hold about 70% of Ecuador's total prison popula-

tion according to official statistics. The government said there were wounded police officers, without giving further details. Prison officials managed to evacuate during the riots.

Moreno said on his Twitter account that he ordered the Armed Forces to "strictly control" arms, ammunition and explosives in the outer perimeters of Ecuador's prisons.

Ecuador has about 53 detention centers, including those for juvenile offenders, with a prison population of some 37,500 people, according to official data.

19 Arrested, 25 Firs Lodged For R-Day Violence, Centre Tells Delhi High Court

NEW DELHI: As many as 19 people have been arrested and 25 FIRs lodged in connection with the Republic Day violence in the national capital during the farmers' tractor rally in protest against the three new agri laws, the Centre informed the Delhi High Court on Wednesday.

Additional Solicitor General Chetan Sharma and central government standing counsel Ajay Digpaul further told the high court that as many as 50 people have been detained and an investigation was going on into the incident.

They also submitted that adequate security personnel have been deployed at the Red Fort for its safety and security.

Taking note of the government submissions, a bench of Chief Justice D N Patel and Justice Jasmeet Singh sought to know whether any similar matter has been already filed in or was pending before or disposed of by the Supreme Court.

ment to give it details of any similar matter in the apex court and listed the petition by a Delhi resident, Dhananjai Jain.

The petition has sought the removal of people squatting under the garb of farmers agitation and clear all the roads and public places. It has also sought a direction

The tractor rally on January 26 that was to highlight the demands of farmer unions to repeal three new agri laws dissolved into anarchy on the streets of the national capital as thousands of protesters broke through barriers, fought with the police, overturned vehicles and hoisted a religious flag from the ramparts of the iconic Red Fort.

The petition has also sought a direction to the Centre to put adequate paramilitary forces to protect important monuments and to ensure the safety of life and property of citizens of Delhi and restore the feeling of confidence and security amongst them.

On January 12, the Supreme Court had stayed the implementation of the contentious new farm laws till further orders and constituted a four-member committee to make recommendations to resolve the impasse over them between the Centre and farmers' unions protesting at Delhi borders

Thousands of farmers, mainly from Punjab, Haryana and western Uttar Pradesh, are protesting at various border points of Delhi for over two months now against the three laws-the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, the Essential Commodities (Amendment) Act, and the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act.

Slightly High Fare Of Short Distance Trains To Discourage **Unnecessary Travel: Railways**

NEW DELHI: After concerns were raised over a rise in the ticket fares of shortdistance passenger trains, the railways on Wednesday said the "slightly high fares" are only to discourage unnecessary travel. Since the coronavirus-triggered lock-

down was eased, the railways is running only special trains. It started with longdistance trains and now, even short-distance passenger trains are being run as special trains. As a special provision in view of the

COVID-19 pandemic, the fares of these trains have been fixed at par with the price of unreserved tickets of mail and express trains for the same distance, a statement from the Railway Ministry said.

The railways, which has now started operating passenger or local train services, has come under fire from daily commuters, who are feeling the pinch of the rise in the fares.

For example, a ticket from Amritsar to Pathankot costs Rs 55 now. Earlier, it was priced at Rs 25. Similarly, a ticket of a passenger DMU between the Jalandhar City railway station and Ferozpur costs Rs 60 now, while it used to cost Rs 30 earlier.

"Railways would like to inform that these slightly higher fares for passenger and other short distance trains had been introduced to discourage people from avoidable travels and those which are not most necessary.

"Covid is still around and in fact, worsening in some states. Visitors from many states are being subjected to screening in other areas and discouraged to travel. Little higher price is to be seen as a pro-active measure of Railways to prevent crowding in trains and stop Covid from spreading," the statement said.

It may be recalled that the Indian Railways stopped regular train operations on March 22, 2020 as a measure to curb the spread of the coronavirus and a nationwide lockdown was announced on March 24, which came into force from the next day.

The railways is constantly increasing the number of passenger-carrying trains in a graded manner. Full restoration of the regular services of passenger trains to the pre-COVID times is to be considered keeping in view a range of factors and operational circumstances.

Currently, the railways has operationalised almost 65 per cent of the mail and express trains and over 90 per cent of the suburban services as compared to the pre-lockdown times.

On an average, 1,250 mail and express trains, 5,350 suburban services and more than 326 passenger trains are presently in operation on a daily basis.

The statement from the ministry said the short-distance passenger trains account for less than three per cent of the total number of trains being operated.
