Diet high in poor quality carbohydrates linked to heart attacks, death risk

new study has found that consuming a diet high in poor quality carbohydrates has many ill effects ranging from a higher risk of heart attacks to strokes, and even death. The findings of the study were published in the New England Journal of Medicine. The global study focused on people living in five continents and concluded that a diet high in poor quality carbohydrates leads to a higher risk of heart attacks, strokes, and death.

The higher risks of a diet high in poor quality carbohydrates, called a high glycemic diet, were similar to whether people had previous cardiovascular disease or not. A total of 137,851 people aged 35 to 70 years old were followed for a median of 9.5 years through the Population Urban and

Rural Epidemiology (PURE) study run by the Population Health Research Institute (PHRI) of McMaster University and Hamilton Health Sciences.

The research team used food questionnaires to measure the long-term dietary intake of participants and estimate the glycemic index (the ranking of food based on their effect on blood sugar levels) and glycemic load (the amount of carbohydrates in food times its glycemic index) of diets. There were 8,780 deaths and 8,252 major cardiovascular events recorded among the participants during the followup period.

The investigators categorised dietary intake of carbohydrates depending on whether specific types of carbohydrates increased blood sugars more than others (high glycemic index) and compared this index to the occurrence of cardiovascular disease or death.

Those people consuming a diet in the highest 20 per cent of the glycemic index were 50 per cent more likely to have a cardiovascular attack, stroke, or death if they had a pre-existing heart condition, or 20 per cent more likely to have an event if they did not have a preexisting condition.

These risks were also higher among those people who were obese

"I have been studying the impact of high glycemic diets for many decades, and this study ratifies that the consumption of high amounts of poor quality carbohydrates is an issue worldwide," said first author David Jenkins, professor of nutritional sciences and medicine at the University of Toronto's Temerty Faculty

of Medicine, who is also a scientist in the Li Ka Shing Knowledge Institute of St. Michael's Hospital, Unity Health Toronto.

"PURE study papers have already indicated that not all carbohydrate foods are the same. Diets high in poor quality carbohydrates are associated with reduced longevity, while diets rich in high-quality carbohydrates such as fruit, vegetables, and legumes have beneficial effects," he said.

PHRI research investigator Mahshid Dehghan added, "This study also makes it clear that among a diverse population, a diet low in both its glycemic index and load has a lower risk of cardiovascular disease and death.

Most fruits, vegetables, beans, and intact whole grains have a low glycemic index, while white bread, rice, and potatoes have a high glycemic index.





US Report On Khashoggi Murder Critical For Justice: UN Expert

cial rapporteur on extrajudicial, summary or arbitrary executions, said the report by the Office of the Director of National Intelligence (DNI) is expected to provide information on who was responsible for the October 2018 killing.

"Once we have further evidence, it will be really impossible for the rest of the world to ignore whatever information will be provided," Callamard said late on Wednesday during a panel discussion hosted by the Knight First Amendment Institute at Columbia University.

Khashoggi, a Washington Post newspaper columnist and prominent critic of Saudi Crown Prince Mohammed bin Salman, was killed at the Saudi consulate in Istanbul, where he had gone to retrieve documents for his upcoming marriage.

His murder sent shockwaves around the world and spurred demands from human rights advocates, press freedom organisations, UN experts and legislators for the perpetrators to be held accountable.

"For the sake of accountability and for the sake of American democracy, the DNI report must be released." Callamard said. Unclassified report



In an interview with broadcaster CBS's programme 60 Minutes in 2019, the crown prince was asked if he ordered Khashoggi's murder. "Absolutely not," he answered. adding however that he said he took "full responsibility" as a Saudi leader for the "heinous crime".

Amid global calls for a thorough and transparent investigation into what happened, the US Congress passed a defence bill in December 2019 that included a provision requiring the DNI to release within 30 days an unclassified report on the murder.

BEIJING: President Xi Jinping on Thursday declared that China has scored a "complete victory" in its fight against poverty by lifting over 770 million people out of it in the last four decades, calling it another "miracle" created by the country that will go down in history.

Absolute poverty has been eradicated in the world's most populous country, Xi announced while addressing a gathering held here to mark the country's accomplishments in poverty alleviation and honour its model poverty fighters.

China has a population of around 1.4 billion. Xi said that all poor people in rural areas

Complete eradication of poverty in China was the main goal announced by Xi when he came to power towards the end of 2012. At that time, China had about 100 million poor people, mostly living in remote areas.

Khan's talks offer

In one more indication of Pakistan seeking to mend ties with India, Pakistan Prime Minister Imran Khan said on Wednesday that India and Pakistan can resolve Kashmir through dialogue. Khan said Kashmir was the only dispute between the two countries and "the way forward for the subcontinent is to resolve our differences through dialogue". Khan reiterated how soon after taking over as the Prime Minister, he had approached India for dialogue but hadn't succeeded. "I am optimistic that eventually sense will prevail," he said while addressing the Sri Lanka-Pakistan Trade and Investment Conference.

Earlier last month, Pakistan Army chief General Qamar Javed Bajwa had called for resolving the Kashmir issue in a "dignified and peaceful manner" between India and Pakistan, saying it was "time to extend a hand of peace in all directions". He had said that Pakistan stands "firmly committed to the ideal of mutual respect and peaceful co-existence. Significantly, General Bajwa didn't talk about a third party mediation but about a bilateral resolution of Kashmir issue.

Now Khan has made a similar statement in a third country. These statements are coming at a time when the relations between the neighbours have plunged to their lowest low in the wake of the revocation of Article 370 in August 2019. It has now been years since there has been no formal dialogue between the two countries. And there's little hope of such a dialogue in near future. Earlier, Khan has said that there will be no dialogue between the two nations as long as India doesn't reverse the withdrawal of Kashmir's autonomy. But first General Bajwa's and Khan's statement reveals a certain change of heart in Pakistan on engagement with India.

Whether, it's only a one-off statement will be known in the weeks and months ahead. In India, there has been no indication over the past two years that the government wants to reach out to Pakistan. Nor has Pakistan made any such effort. The reason for this is that the repeal of Article 370 has irrevocably altered the paradigm under which the two countries engaged. By integrating Kashmir, New Delhi has signalled that it no longer considers this side of Kashmir as disputed. Pakistan sees India's withdrawal of Kashmir's special status enshrined in Article 370 as a dilution of what it sees as the disputed status of the region. But New Delhi sees the changes to the constitutional position of J&K as its internal matter. Two positions look all but irreconcilable. But for a durable peace in the region, the two countries have to find a way to get together. This requires statesmanship on both sides. And this will only be possible if there's willingness on the part of the neighbors to resolve their issues. Earlier this month, India said it desires normal neighbourly relations with Pakistan in an environment free of terror, hostility and violence. Here's hoping that the two countries find some common ground to get back to dialogue.

travelling around hile Maharashtra last year in January I saw concrete roads being constructed around Vidarbha region particularly in the districts of Nagpur, Bhandara and Gondia. I remember around 1999 when I was a college student and happened to go to Mumbai, I saw cement concrete being used in road construction. Initially, I could not believe that the construction workers were using cement for road construction but after visualizing it myself on famous Cadell Road, it made me believe that cement concrete can be used for laying roads. For more than 20 years, a question would always come to my mind as to why the Jammu & Kashmir Government was not using cement concrete for road construction as the traditional Bitumen roads get damaged every year during winter snowfall with the subzero temperature?

PMGSY Road in Budgam

Last year, a 9 1/2 km road stretch from Bonyar to Goggee Pathri via Bonen Kutbal in Surasyar block of district Budgam was constructed under the Pradhan Mantri Gramin Sadak Yojna (PMGSY). Locals told me it was a Rs 14 crore project. I could not cross check this as PMGSY J&K has no official website nor are there Detailed Project Reports (DPR's) of roads available on the respective district websites in J&K. I had already taken up the issue with Lt Governor during my January 18th meeting with him and the Government has subsequently constituted a committee under Secretary IT to ensure continuous updating of websites. I had written a detailed piece on this issue

and repaired again and again almost every year after the winter season or post monsoon season across India owing to the damages incurred during the season, but cement concrete roads last longer than upto 30 to 40 years.

Scarifying the road surface

It has now become a trend to blacktop road surfaces without even scarifying the surface. This has destroyed the road landscape in almost all the areas of Srinagar and major towns. The boundary walls around residential houses located on main roads look short and shabby now as continuous bitumen layers have elevated most of the road surfaces. Scarifying is breaking up hard or compacted materials to create enough space for material

On the basis of initial cost of pavement the Concrete Roads are reported to be around 15 to 16 % costlier than the Bituminous Roads. However, on life cycle cost basis, the cement concrete roads due to their long life of 35 to 40 years and better durability to this concrete (cement) is produced from abundantly available limestone. Cement factories also lead to air pollution, but in comparison researchers say that concrete material is still better than bitumen.

Taking on board Hot mix Plant owners

On the basis of initial cost of pavement the Concrete Roads are reported to be around 15 to 16 % costlier than the Bituminous Roads. However, on life cycle cost basis, the cement concrete roads due to their long life of 35 to 40 vears and better durability are estimated to be around 25-30% cheaper when compared with Bitumen roads. On the long term basis, cement concrete roads are actually more economical. To compensate the hot-mix plant owners who have invested a lot in setting up of these plants in J&K, the Government must involve them in construction of cement concrete roads so that their economic interests are also safeguarded.

Gadkari on concrete roads

Union Minister for Road Transport and Highways Nitin Gadkari in 2017 said all the roads in the country would be converted into cement-concrete to ensure their stability and durability. During a function he had said that cement concrete roads built 20 years ago in Mumbai are still in good shape but some political leaders, bureaucrats and contractors were against concrete roads. Gadkari said that cement concrete roads would last for 200 years. The minister was speaking while inaugurating 'Prawaas 2017'-India International Bus and Car Travel Show in Mumbai on July 29th 2017. In-fact Gadkari has ensured construction of concrete roads in nook and corner of Nagpur as he seems to be the biggest proponent of these roads.

he Bombay High Court decision to grant conditional bail to Varavara Rao, an accused in the Elgar Parishad case, is welcome, even if it seems belated. The 82-year-old poet-activist has been in judicial custody awaiting trial since August 2018. He has been hospitalised for various ailments — he also contracted COVID-19 while in jail in July — and his family had pleaded for bail citing his ill health. An NIA court earlier denied interim bail but the HC has accepted Rao's submission that invoked Article 21 of the Constitution to press his right to health. As the Supreme Court has said several times, bail must be the norm and jail the exception. Dishearteningly, this principle is not being faithfully or consistently upheld.

In Rao's case, the HC pointed out that the NIA court was yet to frame the charges and nobody was in a position to tell within how much time the trial would be completed. The court observed: "The question is as to whether they (under trials) can be forced to live a subhuman existence behind bars only because they stand accused of serious offences." The HC has insisted on stringent bail conditions, including prohibiting Rao, a resident of Hyderabad. from leaving Mumbai: "We feel that although the material on record does show that the health condition of the undertrial is precarious, sending the undertrial back to where he belongs, is fraught with the risk of his presence being used by those allegedly associated with him to seek to revive the nefarious activities." The disquieting fact is that cases such as this one seem to confirm a pattern, wherein the courts are seen to be weighing excessively in favour of the state, especially when draconian legal provisions are invoked against the individual, who may be protesting or expressing dissent. In recent times, all too often, the courts have been seen to take the government's claims at face value, when charges are pressed under exceptional laws such as UAPA and sedition, where the judicial bar must be set especially high.

The courts need to ask tougher questions to agencies that seek to keep the accused in custody for extended periods of time pending trial. Justice D Y Chandrachud's soaring defence of bail in the Arnab Goswami case in November last year could serve as a guide: "Our courts must ensure that they continue to remain the first line of defence against deprivation of the liberty of citizens. Deprivation of liberty even for a single day is one day too many." *The Indian Express* last week. Residents of Bonyar , Bonen , Kuta-

bal and other villages around Surasyar Budgam were overwhelmed when they saw Bitumen layers being spread on this PMGSY road stretch. Blacktopping of a road surface was happening for the first time on this link road. When the work was completed, people enjoyed the ride on the road surface for several months. This was only a short-lived enjoyment as the January snowfall damaged the road surface. The use of Bull-Dozer (JCB) to clear the snow from the road, further damaged it as it created fissures and cracks on the road surface. Had the Government invested Rs 30 crore or more on this project, that would have ensured better durability of the road. With bitumen roads, there occurs a lot of water logging, while with cement concrete roads, the management of water logging is much better. The Bitumen roads are to be laid

to settle down. Just placing Bitumen filling material on a damaged road surface to fill the ruts and potholes is a temporary fix. The bitumen material does not bind in the ruts and potholes. This only increases the height of the road and makes the surrounding landscape shabby. The proper way to reshape the damaged road is to scarify the surface to the depth of the depressions. This breaks up all the compacted surrounding surface materials. After scarifying the material, the Bitumen can settle down properly. Cement concrete roads cannot be built at all unless the road surface is not scarified 2 to 3 feet deep. Thus, concrete roads have this advantage. In J&K we can restore the lost glory of roads and surrounding

not require frequent repairs or patching work like macadamized roads. The vehicles that run over a concrete road. consume 15-20 per cent less fuel as compared to roads made of asphalt -bitumen. This is because of the fact that a concrete road does not get deflected under the wheels of loaded heavy vehicles. During the processing of bitumen lots of toxic gases are emitted from these plants and subsequent less fuel consumption by the vehicle operating on a concrete road leads to little pollution as well. Bitumen is made from imported petroleum products which is the non -renewable source of energy. If we constantly use these products a day will come when these natural resources will be finished. Shrinking of Wular Lake

ular lake, the second largest natural freshwater lake in Asia, is situated in Bandipora district of Kashmir. The size of the lake is 16 km long and 10 km wide, but varies according to season due to varying water levels. The area of the lake has reduced from 157 sq. km to 86 sq km in three decades. Wular lake is located 50 km from the main Srinagar city. The lake lies at an altitude of 1,580

m. Its maximum depth is 14 metres.

The lake basin was formed as a result of tectonic activity and the main source of water is Jhelum river.

It plays a significant role in the hydrographic system of the Kashmir Valley by

acting as a huge absorption basin for annual floodwater. The lake with its associated wetlands is an important habitat for migratory water birds and supports rich biodiversity. Livelihoods of lakeshore communities are primarily dependent on lake resources, including fish and aquat-

f ic vegetation.

According to the action plan of Wular lake (2007), the area of the lake was 217 sq km in 1911 which includes 58 sq km of associated marshes. Lake has shrunk to nearly half of its original area. The lake area has reduced mainly due to conversion for agriculture, plantation and encroachment on its shores. One fifth of the water holding capacity has been lost over the last three decades due to siltation.

Lack of understanding of the values and functions of Wular Lake, wetlands

have led to conversion of its large area. Agriculture settlements, willow plantations and government sponsored programmes have led to shrinkage of the lake area. There is a need to adopt new guidelines of management and planning. Conservation measures should be taken as the lake is fast losing its aesthetic beauty.

s a culture, we've come to value growth and productivity, making paid work not only a necessity, but a central concern in peoples' lives. Yet this attitude towards work is harming us more than it's helping, with research showing that workaholism (also known as work addiction) is a growing problem in the industrialised world. And according to the findings of a recent study, work addiction is linked with poorer mental health.

Work addiction is a clinical condition characterised by an obsessive and compulsive interest in work. People usually work more than they're required to, either by the workplace or because of financial need. Other characteristics include being concerned about their performance at work, rigid thinking and perfectionism, which is often projected onto others.

People with work addiction are driven to work excessively, despite the detrimental impacts this has on their personal health and wellbeing, and relationships. People at risk of developing work addiction often have low self esteem, experience doubt about their performance at work, or have obsessive compulsive personality traits.

Numerous studies have shown the negative impact of work addiction on mental health. But a recent study on workers in France investigated why work addiction happens to better understand the impact it has on mental and physical health.

The researchers looked at a total of 187 workers from a range of different occupations and demographics, who were asked to answer four different questionnaires. They found that high work demands and people who worked in high pressure roles - for example managers with greater responsibilities - were the most significant factors contributing to the risk of work addiction.

Where this was accompanied by working longer hours than required and having an obsessive approach to work, there was an even greater risk of developing work addiction. Women were also shown to be more predisposed to developing work addiction than men. Although it's not entirely clear why women were



more likely to develop work addiction, other research has had similar findings.

Workers with depression were twice as likely to develop work addiction compared to those without a mental health issue. Poor quality of sleep, high levels of stress and low levels of overall wellbeing were also identified as high risk factors.

Although this study's sample size was small, previous research has also shown that work addiction is associated with depression, stress, sleep disorders and lower mental health. Burnout and exhaustion were also reported.

Mental health

Work addiction is more common in industrialised countries where work performance is a measure of success. This suggests that neoliberal ideas about work are influential in increasing the risk of work addiction. These ideas place pressure on intensifying

workloads and performance at work in order to promote economic growth. They also focus on increasing a person's responsibilities at work.

Given the harms of work addiction, radical changes in both workplaces and society will be necessary. As I have argued before, this would require society to stop viewing work as a pivotal tool of performance and growth, and instead place greater value and importance on the health and wellbeing of the worker, both individually and collectively.

Support and change can actually happen in the workplace itself, which is why it's important for employers to recognise and address work demands in a positive way. For example, one study has found that increasing job security and opportunities for development lowered the risk of work addiction.

Other studies have suggested that work-life balance interventions could

reduce working hours in order to give employees a chance to spend more time with their family, it can actually result in better work performance. And, fewer working hours may also reduce family conflict for workers, as employees are able to engage in family time more meaningfully.

Promoting work-life balance has also been shown to increase both physical and psychological health, and personal resilience for workers. Balancing time and energy used on work and personal life helps people feel better - subsequently both improving mental and physical health.

All this suggests that workplaces should develop work-life balance initiatives, provide opportunities for career development and increase job security to prevent work addiction from happening. These changes may also lower stress and absenteeism while improving performance.

But not all workplaces have these kind of strategies in place - and they can be hard to implement because of our culture's focus on performance and economic growth. If you're concerned you have or are developing work addiction, address the problem now if possible.

Seek support at work by talking to managers and peers if you can, ask for performance feedback, or even see if there is a way you can work to reduce some of your working hours. Speaking to mental health and wellbeing services can also help. If you don't have support in your workplace, try talking with friends and family, and ask for their help in refocusing your time – such as having them remind you to take breaks from work.

Of course, better work-life balance will help, but this can be a very hard thing to do as it requires adjusting daily patterns and changing how you think and feel. But if you're able to balance work with other activities - such as seeing family and friends, exercising, or enjoying hobbies - your mental health and wellbeing will improve.

Study suggests changes in writing style provide clues to group identity

mall changes to people's writing style can reveal which social group they 'belong to" at a given moment, new research showed.

Groups are central to human identity, and most people are part of multiple groups based on shared interests or characteristics - ranging from local clubs to national identity.

When one of these group memberships becomes relevant in a particular situation, behaviour tends to follow the norms of this group so that people behave "appropriately".

The new study - by the University of Exeter, Imperial College London, University College London, and Lancaster University - demonstrated that group normative behaviour is reflected in a person's writing style.

It also showed that assessing writing

style can reveal - with an accuracy of about 70 per cent - which of two groups affected a person while they were writing a particular piece of text.

To demonstrate their method, researchers studied how people who are parents and feminists change their writing style when they move from one identity to another on anonymous online forums such as Reddit, Mumsnet, and Netmums.

"People are not just one thing - we change who we are, our identity, from situation to situation," said Dr Miriam Koschate-Reis, of the Department of Psychology and the Institute for Data Science and Artificial Intelligence, both at the University of Exeter.

"In the current situation, many people will need to switch between being a parent and being an employee as they are trying to manage homeschooling, childcare, and work commitments," added Dr Koschate-Reis.



Dr Koschate-Reis further said, "Switches between identities influence behaviour in multiple ways, and in our study we tracked which identity was active by focussing on language.

"We found that people not only change their writing style to impress their audience - they change it based on the group identity that is influencing them at the time. So, when we asked people in an experiment to think about themselves as a parent, their language patterns reflected this," Dr Koschate-Reis said.

The study avoided "content" words (a parent might mention "childcare" for example) and focussed on stylistic patterns including the use of pronouns, "intellectual" words, and words expressing emotions.

Commenting on the possible uses of the new method, Dr Koschate-Reis said, "We are currently focussing on mental health. It is the first method that lets us study how people access different group identities outside the laboratory on a large scale, in a quantified way.

Dr Koschate-Reis added, "For example, it gives us the opportunity to understand how people acquire new identities, such as becoming a first-time parent, and whether difficulties 'getting into' this identity may be linked to postnatal depression and anxiety."

"Our method could help to inform policies and interventions in this area, and in many others," Dr Koschate-Reis noted.

Group identities have been found to affect thoughts, emotions, and behaviour in many settings - from work contexts to education to political activism. Research is ongoing to understand how much control we have over switches between different identities most of which are thought to be triggered by the social context.

Dr Koschate-Reis said it might be possible to manipulate the cues that trigger an identity switch by going to a location associated with the identity. For example, students might find it easier to write in an "academic style" when they are in the library rather than the local coffee shop

Researchers reveal 'good bacteria' in breast milk changes over time

he cocktail of beneficial bacteria passed from mother to infant through breast milk changes significantly over time and could act as a daily booster shot for infant immunity and metabolism, according to the findings of new research.

The research, conducted by scientists from Montreal and Guatemala and published in Frontiers in Microbiology, has important implications for infant development and health.

Researchers discovered a range of microbiome species never before identified in human milk. Until now, relatively little was known about the role microbiome bacteria play in breast milk. These bacteria are thought to protect the infant gastrointestinal tract and improve aspects of long-term health, such as allergy prevention.

Some bacterial species we observed in our sample breast milk had a common function in destroying foreign substances or xenobiotics and could play a role in protection against toxins and pollutants," says co-author Emmanuel Gonzalez, a bioinformatics specialist at McGill University. The discovery sheds light on how mothers help lay the foundation for infant immunity.

To learn more about the human milk microbiome, the scientists analysed breast milk samples using



high-resolution imaging technology, originally pioneered by McGill University and the University of Montreal to detect bacteria on the International Space Station.

They analysed breast milk samples of Mam-Mayan mothers living in eight remote rural communities in the Western Highlands of Guatemala. This gave them a unique window to observe the human milk microbiome over time, specifically between early and late lactation (6-46 days versus 109-184 days).

Unlike most mothers in North America, nearly all Mam-Mayan mothers breastfeed for the World Health Organisation's (WHO) recommended period of six months. In North America, only 26 per cent of mothers do so. "This longer feeding time allowed us to observe important during early development

changes in the bacteria provided to infants over time, which could impact long-term health." says Gonzalez.

The genomic technology used by the scientists revealed a range of microbiome species shared among Mam-Mayan mothers, providing a glimpse of a diverse community of bacteria being passed on to infants.

"Studying microbiomes of diverse communities is important in order to understand the variation present in humans," says co-author Kristine Koski, an Associate Professor in the School of Human Nutrition at McGill "Most human milk microbiome stud ies have been conducted with mothers from high-income countries, generating an incomplete picture of the important bacteria passed to infants

Nirav Modi Can Be Extradited To India, Says UK Court

LONDON: Jeweller Nirav Modi, wanted for fraud and money

laundering in the 14,000-crore Punjab National Bank (PNB) loan scam, can be extradited to India, a UK judge ruled today, dismissing arguments like his mental health worsening during the pandemic and poor Indian prisdeemed a flight risk.

"I am satisfied that Nirav Modi's extradition to India is in of criminal proceedings; the CBI compliance per human rights," said District Judge Samuel Goozee, adding that he had the right to appeal the order.

While today's order takes Nirav Modi a step closer to extradition, it may take months yet to wade through appeals, as it has been seen in the case of another high-profile accused, liquor baron Vijay Mallya.

There is no evidence that if extradited Nirav Modi will not get justice," the judge said, agreeing with India's submissions.

He made it clear that he felt the case for the jeweller to face trial in India was strong and that Nirav Modi had clear links with "other connivers" including bank officials in faked Letters of Undertaking that facilitated huge unpaid loans.

"Mr Modi personally subsequently wrote to PNB acknowledging the debt and promising to repay. The CBI is investigating that Nirav Modi firms were dummy partners," the judge noted. These companies were shadow companies operated by Nirav Modi, he said.

Modi was involved in legitimate business. I find no genuine actions met the legal threshtransactions and believe there old of perverting the course of is a process of dishonesty."

The manner in which Letters of Undertaking were obtained, "the combination as a whole, takes us to the conclusion that Nirav Modi and co were fraudulently operating",

the judge said. 'Many of these are a matter for trial in India. I am satisfied again that there is evidence he could be convicted. Prima facie there is a case of money laundering."

The order will be sent back to UK Home Secretary Priti Pa-Nirav Modi, 49, appeared

via video conferencing from Wandsworth Prison in southwest London at the Westminster Magistrates' Court.

He was arrested in 2019 from a metro station in London on an extradition warrant. His multiple attempts at securing bail were repeatedly turned down as he was

Nirav Modi is facing two sets case relating to illegal letters of undertaking or loan agreements used to clear crores in loan to the jeweller, and the Enforcement Directorate (ED) case relating to the laundering of the proceeds of that fraud. He also faces two additional charges of evidence tampering and intimidating witnesses, which were added to the CBI case.

The Crown Prosecution Service (CPS), representing the Indian government, alleged that Nirav Modi used his firms - Diamonds R Us, Solar Exports and Stellar Diamonds - to make fraudulent use of PNB's LoUs in a conspiracy with banking officials.

They also played videos in court as proof of Nirav Modi's involvement in intimidating dummy officers of his companies to remain out of the reach of Indian investigating authorities.

Nirav Modi's defence team, led by barrister Clare Montgomery, claimed the case was that of a commercial dispute involving "authorised though ill-advised lending" that took "I do not accept that Nirav place in "broad daylight". It is also claimed that none of his justice or amounted to fraud.

Sensex Jumps 258 Points; Nifty Reclaims 15,000 Level



MUMBAI: Equity benchmark Sensex rallied 258 points and the Nifty reclaimed the 15,000 mark on Thursday, tracking gains in Reliance Industries, Axis Bank and TCS amid a positive trend in global markets. The 30-share BSE index ended 257.62 points or 0.51 per cent higher at 51,039.31. Similarly, the broader NSE Nifty rose 115.35 points or 0.77 per cent to 15,097.35.

ONGC was the top gainer in the Sensex pack, rallying around 5 per cent, followed by NTPC, Reliance Industries, IndusInd Bank, Axis Bank and PowerGrid. On the

other hand, ICICI Bank, Nestle India, L&T, Kotak Bank and Titan were among the laggards. "Domestic equities rebounded for the third consecutive day with Nifty crossing 15,000 levels again. A strong cue from global equities followed by favourable comments from Fed Chairman Powell in his second day testimony supported market rally," said Binod Modi, Head Strategy at Reliance Securities.

Barring FMCG, all key sectoral indices ended in green with metal index remaining an outlier. Financials, auto and pharma indices recorded gains to the tune of 1 per cent. Notably, midcap and smallcap stocks outperformed broader indices sharply as improved visibility of earnings recovery attracted investors to this space, he said. Elsewhere in Asia, bourses in Shanghai, Hong Kong, Seoul and Tokyo ended with significant gains. Stock exchanges in Europe were largely trading on a positive note in mid-session deals.

Meanwhile, the global oil benchmark Brent crude was trading 0.50 per cent higher at USD 66.51 per barrel. PTI

Moody's Projects 13.7 Per Cent Growth In Fy'22, **Expects 7 Per Cent Contraction This Fiscal**



NEW DELHI: Moody's on Thursday upped India's growth projection for the next financial year beginning April 1, to 13.7 per cent, from 10.8 per cent estimated earlier, on the back of normalisation of activity and growing confidence in the market with the rollout of COVID-19 vaccine. For current fiscal, the US-based rating agency expects the economy to contract 7

per cent, lower than its previous estimate of 10.6 per cent contraction.

Moody's Investors Service Associate Managing Director (Sovereign Risk) Gene Fang said "our current expectation is that in the current fiscal ending March 2021, the economy would contract 7 per cent. We expect a rebound of 13.7 per cent growth in the next fiscal on normalisation of activity and base effects."

The very large rebound incorporates the view that recovery in activity will continue, with the rollout of vaccines and growing confidence in the market that activities are coming back to normal, Fang said in an online conference on India Credit Outlook 2021 organised by Moody's and its India affiliate ICRA.

ICRA Principal Economist Aditi Nayar said it expects 0.3 per cent growth in the third quarter (October-December) of current fiscal.

ICRA expects Indian economy to contract 7 per cent in current fiscal and growth to rebound to 10.5 per cent in the next fiscal beginning April 1.

"Recession in India has ended," she said, adding there could be upside to growth in FY'22 if government's capital expenditure increases, budget announcements are implemented and vaccination drives are carried out. PTI

"But it was a verbal agreement between the two sides which lasted till 2012," Hooda said.

The ceasefire was violated on January 8, 2013 when New Delhi alleged that a Pakistani Border Action Team (BAT) ambushed an Indian Army patrol and killed two soldiers.

Since then, the LoC only became the raging battlefield for the two nuke-armed neighbours. Frontier guns even refused to thaw amid pandemic-with Defence Minister Rajnath Singh lately informing Rajya Sabha that Pakistan resorted to 5,133 incidents of ceasefire violations in 2020 in which 46 government force personnel were killed.

But with the revival of the LoC ceasefire, many say, premier Narendra Modi has only followed the footsteps of the poet prime minister of India.

A Surrender?

However, those who understand the pulse of South Asian politics call it a "two-pronged thaw" bereft of the bearings on the altered landscape's lingering fate.

There's a patent paranoia that the silent guns at the bloody line with the fresh Delhi-Islamabad pact might only perpetuate another transient period of bonhomie before bofors would once again fire on the bodies of Kashmiris on the either side of the divided line.

With beleaguered unionist and separatist camp univocally calling it a "peace move", the K-watchers term the LoC quiet as the step towards the normalization of post-August 5, 2019 Kashmir.

"If this thaw is limited as it seems," senior scribe Muzamil Jaleel said, "it is nothing but a move towards normalisation of the changed facts on ground."

Peace is important, he added, but if this cessation of hostilities don't change situation in Kashmir positively, it will only result in making unilaterally changed goal posts on ground a permanent feature.

"In that case," Jaleel believes, "it must be called what it is - a surrender. And if these bilaterally tactics of war and peace don't bring relief to us, we must think about us.... think why we are always.'

Reacting to his social media take, another senior Kashmiri journalist, Khursheed Wani said,"Yes....we [Kashmiris] are dispensable."

Incidentally, Wani said, it happened on a day "when our 'lion' had humiliatingly surrendered decades ago ... " To which, Jaleel replied, "it is no longer only about the

lion...such surrenders are happening again and again." Meanwhile, calling the LoC ceasefire as a fresh phase

of peace posturing, journalist Peerzada Ashiq asked: "Will this engagement pan out just like post 1953, where all post-August 9 and post Sheikh-era measures were normalised?"

However, Srinagar-based editor Najeeb Mubarki believes that a sense of desperation and anger in Kashmir will only grow with this move.

"Surprising," Mubarki wrote on social media, "this seemingly sudden development of potential talks: primarily as India has left nothing very much to talk about. In fact, has always used the idea of talks, or talks as leading to more talks, as a holding measure while it furthers grabbing Kashmir even more."

Virtual Flare

The move already set the twitter in tizzy with many users hailing it.

"Good that 2 NSA's talked," tweeted journalist Mariana Baabar. "Pakistan should display humility and stop gloating that it brought India to agree to ceasefire at LoC. Pakistanis happy that there will be no body bags. Let Pak not rock the boat. There are no winners at LoC."

Peace and stability at borders are must for nation's prosperity and progress, said netizen Komal Mahajan."It is a big and positive development."

BJP member Gautam Aggarwal termed the development as the second India-Pakistan joint statement since the Pulwama attack.

This development will be beneficial for the region and the civilian population residing in the area, said netizen Saima Iqbal."Largely, it is an attempt to bring down violence level along the LoC."

However, summing up the debate, a social media user said. "Waiting for the next moves that might happen within next few weeks.... It will be interesting to see what and all has been negotiated in backchannel

Reddy said a total of 10,752 cases of ceasefire violations have taken place along India's border with Pakistan in the last three years, in which 72 security personnel and 70 civilians were killed.

He said 364 security personnel and 341 civilians were injured in cross-border firings along the International Border and the Line of Control in Jammu and Kashmir in 2018, 2019 and 2020.

With troops remain deployed along the Line of Actual Control in eastern Ladakh, the officials said that the situation along the northern borders has no bearing on the decisions along the LoC and the western front.

Last week, the armies of India and China which have been engaged in a border standoff in eastern Ladakh completed withdrawal of troops and weapons from north and south banks of Pangong Tso in the high-altitude region.

The disengagement of armies of India and China from north and south banks of Pangong Tso is a "very good end result" and a win-win situation for both the sides. Gen Naravane said on Wednesday but stressed that there is a long way to go and the next steps towards it are de-escalation and de-induction of troops.

needed to make social media and OTT companies accountable for "misuse and abuse"

Social media firms should be "more responsible and accountable." he said.

The new guidelines follow the government's spat with Twitter over allegedly inflammatory tweets and hashtags supporting farmer protests, with the microblogging service initially refusing to comply with orders to take down about 1,500 such posts and accounts. Twitter complied after it was threatened with the penal action.

Separately, an Amazon Prime Video original series 'Tandav' was ordered by authorities to be re-edited following protests over its depiction of Hindu gods and goddesses. Freedom-of-speech activists and technology trade groups had previously criticised the draft version of the new rules, which replace a previous code from 2011, saying they would result in increased censorship and reduced user privacy.

The new rules take effect immediately, though significant social-media providers (based on number of users) will get three months before they need to start complying. Prasad said concerns have been raised over the rampant abuse of social media platforms and the spread of fake news.

"Social media companies are welcome to do business in India and empower Indians. We welcome criticism and dissent but it is important that users of social media are given a proper forum for the resolution of their grievances in a time-bound manner." he said.

India is a large market for digital and social media companies and is witnessing strong growth on the back of booming smartphone sales and the availability of dirt-cheap data.

The country has 53 crore WhatsApp users, 44.8 crore YouTube users, 41 crore Facebook users, 21 crore use Instagram and 1.75 crore are on Twitter.

Thursday's announcement on holding truce along the LoC comes almost three years after a similar pact was inked in 2018 to uphold 2003 ceasefire agreement signed between the two nuclear countries.

The report quoted officials as saving that Thursday's joint statement could be the first of the many steps that the two countries may take over the next few months to normalise relations, one step at a time.

The report also quoted National security planners as saying there were five developments over the last month or so that indicated a nuanced shift. The first sign of back-channel talks, the report said came earlier this month when Pak army chief Qamar Javed Bajwa spoke of Islamabad's commitment to what he called the ideal of mutual respect and peaceful co-existence and said: "it is time to extend a hand of peace in all directions".

The second development, the report said, was the toned-down statements that emerged from Islamabad three days later, on February 5 which is observed by the Pakistani establishment as Kashmir Solidarity Day. Simultaneously, there was a decline in the ceasefire violations along the border in Jammu and Kashmir in recent weeks, an official said.

"The fourth sign of a possible thaw in the relations was Pakistan steering clear of the Kashmir issue at last week's Saarc meeting convened by Prime Minister Narendra Modi on the Covid-19 pandemic," the report said.

The fifth indicator, the report said was allowing Imran Khan's special aircraft to use the Indian airspace en route to Sri Lanka on Tuesday

Interestingly, Pak had denied use of its airspace in 2019 by three Indian VVIP flights, including that of President Ram Nath Kovind to Europe, and another flight in which Prime Minister Narendra Modi travelled to US to attend the UN General Assembly session. "On relations with Pakistan, as we have said earlier, India desires normal neighbourly relations with Pakistan. We have always maintained we are committed to addressing issues if any in a peaceful and bilateral manner." the spokesperson asserted.

Indian Army officials maintained that there will be no let-up in the troop deployment as well its operations along Pakistan borders against militancy and infiltration.

The ceasefire, they said, does not mean that the army's fight against militancy has come to a halt and its alertness and vigil will not be lowered. They said they are "cautiously optimistic" on the ceasefire.

India and Pakistan signed a ceasefire agreement in 2003, but it has hardly been followed in letter and spirit over past several years with more violations than observance of the pact.

The officials said acts of militancy in the past have led to "deep distrust" between the two sides.

"There have been contacts between India and Pakistan on a hotline level since 1987. Frequently, the DGMOs of both countries stay in contact through this established mechanism," Pakistani army spokesman Maj Gen Babar Iftikhar was quoted as saving by Dawn newspaper.

He said that from 2014 there was a spike in ceasefire violations along the LoC.

"Both the DGMOs have agreed that the existing 2003 understanding should be implemented in letter and spirit," he said.

Both officials have agreed on making it sustainable and have expressed the intention to act on it, he added. according to the newspaper.

The latest development is seen as a thaw after years of tensions between the two nuclear-armed neighbours, the paper said.

Army chief Gen M M Naravane on Wednesday had hinted at some development on the Pakistan front.

In a webinar, Naravane had exuded confidence that with continued engagement with Pakistan, there could be "some sort of an understanding because unsettled borders and violence on the borders help no one".

"We are always wanting peace and tranguillity in our border areas, whether it be the western front or the northern front and the LAC (Line of Actual Control). Or whether it is on the Indo-Myanmar border, we are always looking for peace and tranquillity and our role is to ensure that so as to the rest of the nation can develop," Naravane said.

In written response to a question in Lok Sabha earlier this month, Union Minister of State for Home G Kishan to verify their accounts should be given an appropriate mechanism to do so and be accorded a visible mark of verification. On rules related to over-the-top (OTT) and digital media, the government said, guidelines have been framed keeping in mind the difference between viewership in a theatre and television, as compared to watching it on the internet. A Code of Ethics and three-tier grievance redressal mechanism would be applicable for news publishers. OTT platforms and digital media.

OTT platforms would have to self-classify the content into five age-based categories - U (Universal), U/A 7+ (years), U/A 13+, U/A 16+, and A (Adult).

Information and Broadcasting (I&B) Minister Prakash Javadekar said such platforms would be required to implement parental locks for content classified as U/A 13+ or higher, and reliable age-verification mechanisms for content classified as 'A'.

The publishers of online curated content will also have to prominently display the classification rating specific to a programme together with a content descriptor, he added.

Publishers of news on digital media would be required to observe Norms of Journalistic Conduct of the Press Council of India and the Programme Code under the Cable Television Networks Regulation Act, providing a level-playing field between the offline (print, TV) and digital media, an official statement said

"Digital media portals have no right to spread rumour. The media's freedom is absolute but with reasonable restrictions. Content matter, especially media, OTT and digital media will be administered by I&B ministry. Intermediary platforms monitoring will be done by the IT ministry in the manner they have been doing it," he said

For Jammu and Kashmir, Mujtaba Yousuf and Aquib Nabi took 2 wickets each while Captain Parvez Rasool took 1 wicket. In response, the Jammu and Kashmir's top order batsmen struggled to make any meaningful contribution. Suryansh Raina (2), Vivrant Sharma (1), Shubham Khajuria (9) and Shubham Pundir (4) were all back in the pavilion while the score read 48 for the loss of 4 wickets.

Parvez Rasool (81) played a captain's innings to give his team a sense of hope. Lower order players, Bandeep Singh (51), Abid Mushtaq (46) and Mujtaba Yousuf (32), all contributed to take Jammu and Kashmir closer and closer to Haryana's score. In the end, Haryana proved too strong for Jammu and Kashmir, bowling them out for 295 runs, with 5 balls to spare.

Jammu and Kashmir's second loss of their Vijay Hazare campaign leaves them in a precarious position in the points table of Elite Group E. They next play Bengal on February 27.

New Zealand Pip Australia By 4 Runs In 2nd T20 Match Agencies

DUNEDIN: Martin Guptill made a spectacular return to form, hitting eight sixes in a 50-ball innings of 97 which lifted New Zealand to a thrilling win over Australia by four runs in the second Twenty20 cricket international.

Guptill led New Zealand to 219-7 as it batted first after losing the toss Thursday and Australia seemed out of the match when it slumped to 113-6 after 13 overs.

But Marcus Stoinis made 78 from 37 balls and shared a partnership of 92 in 6.1 overs with Daniel Sams, who scored 41 from 15 balls, to get Australia within a shot of an incredible victory. Australia went into the last over in a strong position, needing 15 runs with four wickets in hand.

New Zealand turned to Jimmy Neesham, who hadn't bowled in the match, and it proved an inspired decision; he removed Sams with the first ball of the over, tipping the match in New Zealand's favor. Stoinis couldn't score from the next two balls but clubbed a six from the fourth ball of the over, leaving Australia needing nine runs from two deliveries. Hitting out, Stoinis skied a ball high into the leg side and Tim Southee, with icy nerves, stood under the ball and claimed the catch which sealed the win and gave New Zealand a 2-0 lead in the five-match series. "We got back into a great position," Australia captain

Aaron Finch said.

"That partnership between Stoinis and Daniel Sams produced some extraordinary hitting, like the first innings as well.

"It was a great game of cricket, good to be a part of, unfortunately we didn't come out on the right side."

Guptill, 34 and New Zealand's most-prolific T20 batsman, had been under pressure to hold his spot in a strong Black Caps lineup as he endured a long form slump and new players emerged from domestic cricket to challenge him for his opening role.

On Thursday he provided a sharp reminder of his proficiency in the short format and set the tone for New Zealand's innings, exploiting the short boundaries at the University Oval which was hosting a T20 intern

India Wins 3rd Test Against England By Ten Wickets, Inch Closer To WTC Final

AHMEDABAD: Left-arm spinner Axar Patel created an illusion of turn with 11 straighter deliveries that put India on the brink of the World Test Championship final with a 10-wicket demolition of England inside two days in the day-night third Test here on Thursday.

In only his second Test, Patel (15-0-32-5), with a match-haul of 11/70, relentlessly hit the good length area and hoodwinked England batsmen, who played for turn only to find that there was none on offer from him.

The result was their lowest total against India -- 81 all out in 30.4 overs leaving the hosts with a target of 49 which they achieved with minimum fuss taking a 2-1 lead in the fourmatch series. The visitors were also knocked out of contention from the WTC final.

Off-spinner Ravichandran Ashwin (15-3-48-4) proved to be an ideal foil for Patel, becoming the fourth Indian bowler and second fastest in the world to complete a commendable milestone of 400 Test wickets with the dismissal of Jofra Archer.

Incidentally, after Afghanistan's debut Test in 2018 in Bengaluru, this was the second time that India won a Test match, well inside two days.

This was after England skipper Joe Root's fabulous career-best spell of 6.2-3-8-5 resulted in India's dramatic collapse from 114 for 3 to 145 all out.

"The result went our way but I don't think the quality of batting was good from either of the two teams. It was a very good batting wicket. Below-par batting by both teams but our bowlers were more effective," said Kohli in the post-match presentation.

"(Jasprit) Bumrah said I am getting work load management while playing," he quipped when asked about the finish inside two days.

India lost as many as seven wickets for only 31 runs after looking solid at 114 for 3 at one stage in the game but England lost all 10 in an entire session in which no pacer was seen in action.

Ironically, it was the non-turning deliveries from Patel that had the England's rank and file pressing the panic button as they pre-empted away turn every time.

Whether it was Zak Crawley, Jonny Bairstow or skipper Root, everyone lost the mind-game as Ashwin also joined the fun with records tumbling one after another. 'We were 70 for 2. But we didn't really

capitalise on it. 250 on that wicket would have made it different. We will come back using this hurt and come back as a better

team," a disappointed but resolute Root said. When Patel sent back Ben Foakes, he became the first spinner to get 11 wickets in a pink ball Test match.

Following the two-day finish, ICC will be watching the Motera track with a "Hawk Eye" even though the debate can continue for ages whether it was the turn that did the batsmen in or the lack of it.

The turn on offer was standard for any sub-continental track and no deliveries misbehaved. However, all eves will now be on ICC match referee Javagal Srinath from India and his assessment of the 22-yard strip.

A case in point would be the wickets taken by the two left-arm spinners -- Patel and lack Leach.

They bowled deliveries at a speed between 88 kmph and 92 kmph with a round arm action and pitched them on good length leaving batsmen in two minds -whether to play forward or go backwards.

While a bowler might end up getting the man of the match, Rohit Sharma's 66 off 96 balls in the first essay was 24-carat gold given that other batsmen looked like sitting ducks. Deservedly, he walked away with the "game-changer of the match honours".

But Indian batsmen save Rohit did have a torrid time during an afternoon session when Root and Leach made their lives miserable.

Ajinkya Rahane, who has never had much success against slow left arm bowlers, was

rapped on the pads as Leach fired one in and it was not much of an issue for umpire Nitin Menon to adjudge him leg before.

Suddenly, a pitch, on which India looked way more comfortable, started to challenge and just like England in the second session on the first evening, the Indians wilted under pressure.

Rohit missed a sweep off Leach and Menon's decision was retained as per Umpires' Call.

Once Rohit was gone, it was time for Root to enter the scene and do a Michael Clarke (6/9 with his left arm orthodox in Mumbai 2004) as Rishabh Pant (1), Washington Sundar (0) and Patel (0) were accounted for in quick succession.

At one point, Root's figures were 3-3-0-3 as he exploited the friendly conditions, repeatedly hitting the rough which helped him dismiss three left-handers in succession.

Root's superb effort led to a cheeky tweet from former England captain Michael Vaughan, "Indian batsman can't play off spinners from Yorkshire.'

He was referring to the green top strips that are always on offer at the Leeds.

Ravichandran Ashwin (17) and Ishant Sharma (10 not out), who hit his first ever six in his 100th Test appearance, scored a few which proved to be priceless in the end.

India need to win the fourth and final Test at the same venue from March 4 to seal the WTC final spot.

'Modern Day Legend' Ashwin Becomes 4th Indian To Take 400 Test Wickets

AHMEDABAD: Ravichandran Ashwin on Thursday became only the fourth Indian and sixth spinner in the world to take 400 Test wickets, a feat which was nothing short of a "fairytale" for the seasoned pro who was called a "modern day legend" by skipper Virat Kohli. Ashwin reached the landmark in the day-night third Test against England here when he dismissed Jofra Archer in England's second innings. He ended the match with seven scalps, which took his overall tally to 401. The 34-year-old off-spinner, playing



Unhappy With Umpiring Decisions, England Take Up Matter With Match Referee

AHMEDABAD: England skipper Joe Root and head coach Chris Silverwood sought umpiring "consistency" in the ongoing day-night Test against India by taking up the matter with match referee Javagal Srinath, "who said that the captain was asking the right questions" of the on-field officials.

England were unhappy with two decisions made by third umpire C Shamshuddin on the opening day of the match on Wednesday. While India opener Shubman Gill survived a low slip catch appeal by Ben Stokes in the second over, Rohit Sharma's close stumping appeal by Ben Foakes was turned down late in the day.

"The England captain and head coach spoke with the match referee after play," an England and Wales Cricket Board (ECB) spokesperson said in a statement.

"The captain and head coach acknowledged the challenges the umpires faced and asked respectfully that in making any decisions there was consistency in the process. The match referee said the captain was asking the right questions of the umpires."

While Gill's dismissal was overturned after looking at several angles, the third umpire did not take much time to declare Rohit not out.

After Rohit was let off, Root was heard saying "we just want consistency" to on-field umpire Nitin Menon.

While the ball seemed to have touched the ground while Stokes attempted the catch off Gill, the second decision was a close one as Sharma's foot seemed to be in the air very close to the time when the bails were dislodged.

England opener Zak Crawley, who top-scored with a 84-ball 53, made the team's frustration clear in the postplay press conference.

"When we batted, Jack had one where it didn't quite carry and it seemed like they looked at it from five or six different angles. When we were fielding it seemed like they looked at it from one angle. That's where the frustrations lie," he added.

"I can't say whether they were out or not out, but I think the frustrations lie with not checking more thoroughly."

Josh Philippe tried to set the foundation on which a successful chase could be built, making 45 from 32 balls. But he had little support from the Australian top order; Finch made only 12, continuing his poor form from the Big Bash League, and Matthew Wade made 24.

Phillippe fell at 112-4, the first of three wickets from four balls for Santner, who also dismissed Ashton Agar and Mitch Marsh for first ball ducks and left Australia 113-6.

Stoinis led Australia's extraordinary rally, reaching his half century from only 22 balls. He hit seven fours and five of the 13 sixes the Australian innings contained.

Sams was the perfect partner, striking the ball cleanly and hitting two fours and four sixes before falling to a knee high full toss in the final over.

in his 77th Test, is the 16th bowler in the world to have taken 400 Test wickets.

"It feels amazing actually (to reach 400 Test wickets). The entire stadium stood up and clapped for me. Pleased it happened in the winning cause. I can't really get a grip of what has happened in the last 2-3 months. It has been a dreamy run and a fairytale," Ashwin, who took seven wickets in the match to tally 431 victims from 77 Tests, said.

Skipper Kohli was effusive in his praise, saving, "I think we need to stand up and take notice of what Ashwin has done. In Tests, he is a modern day legend." Ashwin credited his self-belief for

reaching where he has. "It has been all about self belief. At the start of the Australian tour, I didn't think I would be starting, but then (Ravindra) Jadeja broke down and it might have had

to happen," said Ashwin, who played a big role in India's historic Test series win last month.

Former captain Anil Kumble (619), Kapil Dev, (434), and Harbhajan Singh (417) are the other Indians who have 400Test wickets to their credit.

Ashwin also became the second fastest to reach the milestone after Sri Lankan great Muttiah Muralitharan, who made it in his 72nd Test

The veteran came into the match six short of the landmark and took three England wickets in the first innings.

Talking about the match, he said, "We were worried after getting bowled out for 145, didn't think we didn't have many runs on the board. But we then bowled beautifully on a wicket assisting us.

"I don't know if I'm ageing, but it's incredibly hard to watch the game. To come back (after losing first Test) and win it is even more special."

Asked this was his best as a bowler, Ashwin said. "In 2015-16 everyone asked me (if I'm bowling at my best), the same in 2016-17. One thing is sure I've always wanted to improve. I won't be surprised if I improve further in the future."

He said both captain Virat Kohli and head coach Ravi Shastri had a conversation with him in Australia about his batting and they saw something special in his bowling.

"I think my bowling was coming along beautifully in the IPL too. I lost about 7-8 kgs in the lockdown and everything looked upwards for me."

"With International sports having shut down owing to the pandemic situation, I am aware as to how difficult it is to arrange matches under the current scenario," he added.

The Blue Tigers last played at the international arena -in the 2022 FIFA World Cup Qualifiers against Afghanistan (in Tajikistan) and Oman (in Muscat) in November 2019.

Sandhu feels it will be a big boost as the players will head to the camp straight after the Indian Super League and will have momentum on their side.

"The two friendlies happening straight after the Indian Super League will be a big boost. Most of the boys will be in momentum and heading straight to the national camp.

'That's what the players always love – to have that continuity heading into International Football. We are all looking forward to the boys going out and giving their best."

Central defender Sandesh Jhingan dubbed the forthcoming two matches as "massive".

"It's a great piece of news which the entire nation was waiting for. It's massive for the fans, and for us players as well as we haven't played an International match in the last one and half years," he said.

"It's important for us to get back into the system of Igor Stimac, start training and improving," he added.

As part of the preparation for the two matches against Oman and UAE, the national team will assemble in a preparatory camp in Dubai from March 15 onwards.

"There are crucial games coming up in June which would be followed by the Qualifiers of the Asian Cup China 2023. The camp in March are just extra days to train and improve together as a team. I am extremely happy," Jhingan said.

ICC Signs Deal With IMG To Live Stream 541 **Cricket Matches Across Three World Cups**

age at an ICC event for the first time ever.'

The coverage will capture performance of new teams including Hungary, Romania and Serbia, who are competing for the first time in the men's T20 World Cup qualification and Finland playing host to an ICC event for the very first time.

"In the Women's T20 World Cup 2023 pathway, eight teams: Bhutan, Botswana, Cameroon, France, Malawi, Myanmar, Philippines, and Turkey will be making their debuts in international ICC Women's events," the ICC said.

India Hockey Nationals To Begin In March After A Year's Break Due To COVID Pandemic

NEW DELHI: The restructured Hockey India National Championships will restart in March after a hiatus of one year following the cancellation of last year's events due to the COVID-19 pandemic.

The domestic competitions will resume in a new, restructured format this year, as HI looks to maximise athlete participation and develop the game in the states, union territories, institutional units and academies.

The season will kick-start with the 11th Hockey India Sub Junior Women National Championship 2021 to be held in Simdega, Jharkhand from March 10 March to 18, followed by 11th Hockey India Sub Junior Men National Championship 2021 scheduled to be organised in Narwana district of Haryana from March 17 to 25.

The inaugural edition of the first Hockey India Junior Women Academy National Championship 2021 will be held from March 17 to 26. The women's event in this category will run simultaneously from March 17 to 24. Both the competitions will be played at the Kalinga Hockey Stadium in Bhubaneswar. This will be followed by the

11th Hockey India Junior Women National Championship at Simdega, Jharkhand from April 3 to 12. Last year, only the 10th Hockey India Senior Men and Senior Women Championship 2020 (A Division) as well as the 10th Hockey India Senior Women National Championship 2020 (B Division) were held in January and February before the pandemic wreaked havoc worldwide. "We are very happy to resume the domestic calendar after the pandemic halted all the sporting events last year," HI president Gyanendro

Ningombam said in a statement. "The season will begin in an allnew avatar with the restructuring of events for sub-junior, junior and senior national championships for both men and women as well as Hockey India registered State Member Units, Public Sector Units/ Departmental Units and Academy Member Units respectively," he added.

Not Making Tea No Provocation For Husband To Assault Wife: Bombay High Court

MUMBAI: Upholding a 35-year-old man's conviction for assaulting his wife, the Bombay High Court has said the wife's refusal to make tea for husband could not be accepted as a provocation for him to assault her and observed that wife is "not a chattel or an object".

In an order passed earlier this month, Justice Revati Mohite Dere said "marriage, ideally, is a partnership based on equality". But, notions of patriarchy and the idea that the woman is a man's property still prevail in society, leading a man to think that his wife is his "chattel", the court observed.

The HC also said the testimony of the couple's 6-year-old daughter inspires confidence and cannot be disbelieved.

The court upheld the conviction and 10 years' imprisonment awarded to Santosh Atkar (35), a resident of Pandharpur in Solapur district, by a local court in 2016.

He was found guilty on the charge of culpable homicide not amounting to murder. As per the order, Atkar and his wife had been having disputes for some time.

On the day of the incident in December 2013, his wife insisted on going out without making a cup of tea for him. The man then struck her with a hammer, injuring her grievously. As per the case details and testimony of the couple's daughter, Atkar then cleaned the spot of the crime, bathed his wife and took her to hospital.

She succumbed to her injuries after being in the hospital for about a week. The defence argued that Atkar had been provoked into committing the crime because his wife refused to make tea.

The HC, however, rejected the argument and held that there existed adequate evidence, including the testimony of the man's daughter, to prove the charges against him.

"The deceased, by refusing to make tea for the appellant (Atkar), by no stretch of imagination, can be said to have offered grave and sudden provocation for the appellant to assault her, much less, such a brutal assault," it said.

"It would not be out of place to observe that a wife is not a chattel or an object," the HC said.

Such cases reflect the imbalance of gender and skewed patriarchy, the socio-cultural milieu one has grown up in, which often seeps into a marital relationship, it said.

The court said an imbalance of gender roles exists in society, where the wife is expected to do all the household chores.
