

KASHMIR In Capital: Carpet Chronicle Of 'Russian King'

mer Hameed came to Delhi as a fledgling and fresh-faced merchant in 1993, when his hometown was caught in a searing strife. He had arrived to secure his late father's legendary legacy in Delhi

Almost three decades later, and at the age of 52, the Lalbazar man has not only secured his father's legacy, but also rose to become a carpet czar in the capital.

"By 1989, as the situation turned explosive back home, my father became anxious about me and our family business," said Umar while recollecting an era when aged fathers in Kashmir had started shouldering their young sons' dead bodies.

"Being the lone son, I was supposed to address my father's growing concerns about me and our nosedived business." But it wasn't a walkover for him.

Kashmir was changing, so was the idea of normalcy when the young and restless started campaigning for the armed resolution. Social hangouts and public places soon came under a lock and key. Migrations and massacres only escalated the crisis. The surplus sorties flown on a war-footing and reinforcement in every nook and cranny of the valley rang war alarms. And in an ensured militant-military combat, big businesses became shut shops.

But before the situation turned tense in Kashmir, Umer's date of destiny had come in that momentous year-1989-of the massive upheaval itself. Then appearing in his MBBS entrance exam, he came out dejected.

"The moment I saw everyone cheating inside the examination hall, I tore my question paper and made my decision to move out," he recalled.

Such curt decisions based on merit would later give him an edge over his contemporaries and competitors in the capital.

"Being ethical and upright was my father's way of doing things," he said. "And as his heir-apparent, I had to demonstrate his DNA in my demeanour."

His father, who had already worked with East India Carpet Company, had attached a great value to his name because of his enterprising and welfare work in Kashmir.

'Even today, whenever I visit the valley, carpet weavers and sellers often tell me: 'While the floor is ours, the roof over it is all because of your father!' The great man touched many lives during his lifetime with his principled professional conduct.

Umer's father worked for around 50

years and played a crucial role in establishing the carpet industry in Kashmir.

"Even CIE [Cottage Industries Exposition, one of the biggest Kashmiri Carpet brands] used to consult my late father regularly for his expert take and trade tips," the son said. But unlike his father, the journey to

Everest wasn't a fairy-tale for Umer.

The rug stalwart started his business initially from a rented apartment in Jungpura, before moving to Lajpat Nagar, the place where he now sits comfortably. "It was harsh win-

ters back then. I came here by road and started selling carpets from my rented /lore On P10

Smartphones, often blamed for eye strains and other problems, can also come to your aid as researchers have found that these devices could be used to scan people's eyes for early-warning signs of glaucoma, helping to prevent severe ocular diseases and blindness.

Glaucoma is a disease of the optic nerve which is estimated to affect 79.6 million people worldwide and, if left untreated, causes irreversible damage.

In most cases, blindness can be prevented with appropriate control and treatment.

Glaucoma is associated with elevated levels of intraocular pressure (IOP) and an accurate, non-invasive way of monitoring an individual's IOP over an extended period would help to significantly increase their chances of maintaining their vision.

Soundwaves used as a mobile measurement method would detect increasing values of IOP, prompting early diagnosis and treatment. The study published in the

Pak asks India to allow Hurriyat visit

SLAMABAD - Pakistan has again demanded India respond to its long standing invitation to allow Kashmiri leaders to visit Islamabad for talks to kickstart a formal peace dia¬logue

Reiterating Pakistan's dismissal of India's latest extension of its so-called ceasefire in Kashmir. Foreign Secretary Inam-ul Haq said Pakistan's invitation to the Hurriyat lead-ers was still on the table

"I am not sure what these talks will begin, but a long as long as Kashmir dispute is not resolved according to the wishes of Kashmiris people, this region will and it difficult to have a durable peace," he said in a speech at the Institute of Stra¬tegic Studies.

Pakistan has responded to the ceasefire by offering; "minimum restraint" along the Line of Control and withdrawal of some of its troops from the area.

In November it also invited India-based Kashmiri separa¬tist leaders from the All Party Hurriyat Conference for talks in Islamabad

New Delhi has not opposed the idea but so far it has not is-sued the necessary travel docu-ments to the Hurriyat leaders.

'India has not made any headway to conduct tripartite talks" involving Pakistan. India and the Hurriyat, a government spokesman said

A team of US congressmen currently in Pakistan, having visited India earlier in the week has also urged India to allow the Hurriyat to travel lo Islamabad.

Haq reminded India and the international community that it was the Hizbul Mujahideen, one of the most powerful militant outfits fighting to oust the Indi-ans from Kashmir, who offered the first ceasefire

He said the Hizb's two-week ceasefire, which ended in Au-gust, was short-lived "because of Indian attempts to divide the Kashmiri people'

The Hizb has stuck by its demand for three-way talks in¬cluding India. Pakistan and the Kashmir as well as an Indian troop reduction in the Muslim majority state

Khashoggi Fiancee Says Saudi Crown Prince **Should Be Punished**

RIYADH: The fiancée of slain Saudi journalist Jamal Khashoggi is calling for Crown Prince Mohammed bin Salman to be punished after a US intelligence report found that the kingdom's de facto ruler played a role in the murder of the journalist in 2018.

Khashoggi, a columnist for the Washington Post newspaper who was critical of Saudi policies under bin Salman, was killed and dismembered by a hit squad in the Saudi consulate in Istanbul.

"It is essential that the crown prince... should be punished without delay," Hatice Cengiz said on Twitter.

"If the crown prince is not punished, it will forever signal that the main culprit can get away with murder which will endanger us all and be a stain on our humanity."

The US intelligence report on Friday found that the prince, popularly known as MBS, had approved the operation that led to the killing of Khashoggi. Former US President Donald Trump's administration had held back the long-awaited report.

The report also cited MBS's "support for violent measures to silence dissidents abroad, including Khashoggi" among the factors the assessment was based on.

"Since 2017, the Crown Prince has had absolute control of the Kingdom's security and intelligence organizations, making it highly unlikely that Saudi officials would have carried out an operation of this nature without the Crown Prince's authorization," the report said.

The four-page report names 21 individuals who participated in or were otherwise complicit in Khashoggi's murder.

Washington has imposed sanctions on some of those involved, but not Prince Mohammed himself. The Saudi government, which

has denied any involvement by

the crown prince, rejected the report's findings.

US President Joe Biden's administration on Friday imposed a visa ban on some Saudi officials believed to be involved in Khashoggi's killing and placed sanctions on others that would freeze their US assets and generally bar Ameri-

cans from dealing with them. Asked about criticism of Washington for not sanctioning MBS directly, Biden said an announcement would be made on Monday but did not provide details, while a White House official suggested no new steps were expected.

Last month, the US ended its support to Saudi's devastating war in Yemen as part of new Biden administration's efforts to hold Saudi Arabia accountable for its human rights violations.

In his first call since becoming president, Biden spoke to Saudi King Salman last week during which he "affirmed the importance the United States places on universal human rights and the rule of law".

"Starting with the Biden administration, it is vital for all world leaders to ask themselves if they are prepared to shake hands with a person whose culpability as a murderer has been proven," said Cengiz, who has been campaigning to

get justice for her slain fiancé. The Saudi government, which initially said it had no information on Khashoggi, later accepted responsibility for the killing but said it was a rogue operation that did

not involve the prince. Cengiz said that "following this report, there is no longer any political legitimacy for the crown prince". "The truth – that was already known - has been revealed one more time, and it is now confirmed."

But she said the US report did not go far enough. "Yet this is not enough," she

warned, "since the truth can only be meaningful when it serves justice being achieved."

Not A Good Idea: **Experts Concerned About Pope Trip To Iraq**

VATICAN CITY: Infectious disease experts are expressing concern about Pope Francis' upcoming trip to Iraq, given a sharp rise in coronavirus infections there, a fragile health care system and the unavoidable likelihood that Iragis will crowd to see him.

No one wants to tell Francis to call it off, and the Iraqi government as every interest in showing off its relative stability by welcoming the first pope to the birthplace of Abraham. The March 5-8 trip will provide a sorely-needed spiritual boost to Iraq's beleaguered Christians while furthering the Vatican's bridge-building efforts with the Muslim world. But from a purely epidemiological standpoint, as well as the public health message it sends, a papal trip to Iraq amid a global pandemic is not advisable, health experts say. They note that wars, economic crises and an exodus of Iraqi professionals have devastated the country's hospital system, while studies show most of Iraq's new COVID-19 infections are the highly-contagious

variant first identified in Britain. "I just don't think it's a good idea," said Dr. Navid Madani, virol-

ogist and founding director of the Center for Science Health Education in the Middle East and North Africa at Harvard Medical School's Dana-Farber Cancer Institute. The Iranian-born Madani co-

Amid Border Standoff, **Chinese Hackers Targeted India's Power: US Firm Report**

WASHINGTON: Amidst the tense border tension between India and China, a Chinese governmentlinked group of hackers targeted India's critical power grid system through malware, a US company has said in its latest study, raising suspicion whether last year's massive power outage in Mumbai as a result of the online intrusion.

Recorded Future, a Massachusetts-based company that studies the use of the internet by state actors, in its recent report details the campaign conducted by a Chinalinked threat activity group RedEcho targeting the Indian power sector.

The activity was identified through a combination of largescale automated network traffic analytics and expert analysis. Data sources include the Re-

corded Future Platform, Security-Trails, Spur, Farsight and common open-source tools and techniques. the report said.

On October 12, a grid failure in Mumbai resulted in massive power outages, stopping trains on tracks, hampering those working from home amidst the COVID-19 pandemic and hitting the stuttering economic activity hard.

It took two hours for the power supply to resume for essential services, prompting Chief Minister Uddhav Thackeray to order an enquiry into the incident.

In its report, Recorded Future notified the appropriate Indian government departments prior to publication of the suspected intrusions to support incident response and remediation investigations within the impacted organisations.

There was no immediate response from the Indian government on the study by the US company. Since early 2020, Recorded Fu-

ture's Insikt Group observed a large increase in suspected targeted intrusion activity against Indian organisations from the Chinese statesponsored group.

The New York Times, in a report, said that the discovery raises the question about whether the Mumbai outage was meant as a message from Beijing about what might happen if India pushed its border claims too vigorously.

Chinese Foreign Ministry spokesman Wang Wenbin on Monday re-

jected the criticism about China's involvement in the hacking of India's power grid, saying it is "irresponsible and ill-intentioned' to make allegations without proof.

"China is a staunch upholder of cybersecurity. We firmly oppose and fight any kind of cyber-attacks," he said, replying to a question on the report of the cyber-attack on the Indian power grid.

"It is hard to track the origin of the cyber-attacks. You cannot make wanton guesses or smear a specific country without any proof. This is irresponsible and ill-intentioned. China firmly opposes such behaviour," he said in Beijing.

According to the Recorded Future report, from mid-2020 onwards, Recorded Future's midpoint collection revealed a steep rise in the use of infrastructure tracked as AXIOMATI-CASYMPTOTE, which encompasses ShadowPad command and control (C2) servers, to target a large swathe of India's power sector.

Ten distinct Indian power sector organisations, including four of the five Regional Load Despatch Centres responsible for operation of the power grid through balancing electricity supply and demand, have been identified as targets in a concerted campaign against India's critical infrastructure.

Other targets identified included two Indian seaports, it said, adding the targeting of Indian critical infrastructure offers limited economic espionage opportunities.

However, we assess they pose significant concerns over potential pre-positioning of network access to support Chinese strategic objectives. "Pre-positioning on energy assets may support several potential outcomes, including geostrategic signalling during heightened bilat-

dence of wider targeting in Recorded Future's network telemetry," it said. Recorded Future said in the lead-up to the May 2020 border skirmishes, it observed a noticeable increase in the provisioning of

PlugX malware C2 infrastructure, much of which was subsequently used in intrusion activity targeting Indian organisations. "The PlugX activity included the targeting of multiple Indian government, public sector and defence

organisations from at least May 2020." it said. While not unique to Chinese cyber espionage activity, PlugX has been heavily used by China-nexus groups for many years.

"Throughout the remainder of 2020, we identified a heavy focus on the targeting of Indian government and private sector organisations by multiple Chinese state-sponsored threat activity groups," it said.

Recorder Future alleged that it also observed the suspected Indian statesponsored group Sidewinder target Chinese military and government entities in 2020, in activity overlapping with recent Trend Micro research.

The Massachusetts-based company's report came as the armies of the two countries began disengagement of troops locked in over eight-monthlong standoff in eastern Ladakh.

Both countries reached a mutual agreement last month for the disengagement of troops from the most contentious area of North and South banks of the Pangong Lake.

US Still Open To Nuclear Talks After Iran's Rejection: **Biden Administration**

Washington: The Biden administration said Sunday it remains open to talks with Iran over the 2015 nuclear deal despite Tehran's rejection of an EU invitation to join a meeting with the US and the other original participants in the agreement.

A senior administration official said the US was "disappointed" in the rejection but was flexible as to the timing and format of the talks and saw Iran's decision to snub the European invitation as part of the diplomatic process. The official said the US would be consulting with the other participants - Britain, China, France, Germany, Russia and the European Union – on the way forward.

The official was not authorised to discuss the matter by name and spoke on condition of anonymity. Earlier Sunday, Iran turned down the offer for talks saying the "time isn't ripe" for the meeting, at which the US would have participated as an observer. Iran had been insisting that the US lift or ease sanctions imposed on it by the Trump administration under its "maximum pressure campaign" before sitting down with the United States.

President Joe Biden has repeatedly said that the US would return to the deal that his predecessor, Donald Trump, withdrew from in 2018 only after Iran restores its full compliance with the accord.

"Considering US/E3 positions & actions, time isn't ripe for the proposed informal meeting," Iranian foreign ministry spokesman Saeed Khatibzadeh said on Twitter. He referred to the so-called E3, which comprises Britain, France and Germany.

"Remember: Trump failed to meet because of his ill-advised Max Failure," he said. "With sanctions in place, same still applies. Censuring is NOT diplomacy. It doesn't work with Iran." The Biden administration announced earlier this month that it would accept an EU invitation to participate in a meeting of deal participants and at the same time rescinded a Trump determination from the UN Security Council that Iran was in significant breach of the agreement that

all UN sanctions had be restored. The UN move had little practical effect as nearly all members of the world body had rejected Trump's determination because the US was no longer a participant in the nuclear deal.

Biden administration officials said the withdrawal of the determination was intended to show goodwill toward its partners and at the same time had eased severe restrictions on the movement of Iranian diplomats posted to the UN.

Separately on Sunday, the State Department condemned a weekend attack by Iran-backed Yemeni rebels



on Saudi Arabia, saying it damaged prospects for peace. Along with the overtures to Iran on the nuclear front, the Biden administration also reversed several late Trump administration moves against Iranianbacked rebels in Yemen.

Secretary of State Antony Blinken rescinded his predecessor's designation that the Houthi rebels were a "foreign terrorist organisation," a move that the UN and relief groups had said would make the already disastrous humanitarian situation in Yemen even worse. In addition, the Biden administration decided to halt all offensive assistance to Saudi Arabia for its military campaign against the Houthis in Yemen.

The Houthis, however, have stepped up their operations in the country, pressing ahead with an offensive in Marib province and launching attacks on Saudi Arabia.

On Saturday, Saudi authorities said they had intercepted a missile attack over their capital and reported that bomb-laden drones had targeted a southern province, the latest in a series of airborne assaults

they have blamed on the Houthis. State Department spokesman Ned Price on Sunday said the US "strongly condemns the Houthis' attacks on population centers in Saudi Arabia." He said they "threaten not only innocent civilians but also prospects for peace and stability in Yemen" and called on the Houthis "to end these egregious attacks."

"The United States remains committed to its longstanding partnership with the Kingdom of Saudi Arabia and to helping Saudi Arabia defend its territory as it faces attacks from Iranian-aligned groups," Price said.

On Friday, the Biden administration further strained ties with the Saudis when it published a declassified intelligence report finding that Saudi Arabia's crown prince had ordered an operation to capture or kill Jamal Khashoggi, a Washington Post journalist and US resident who was brutally slain at the Saudi consulate in Turkey. Saudi Arabia has forcefully rejected the report's conclusio

UK Hunts Nationwide For Missing Person With Brazil Covid-19 Strain

LONDON: Britain on Monday appealed for a person infected with a powerful Covid-19 strain from Brazil to come forward as experts fretted about its impact on new vaccines.

The public appeal came a week before England is due to start unwinding its third Covid lockdown, with progress hinging on the vaccines' ability to curtail the pandemic.

Japanese Companies Go High-Tech In Battle Against Food Waste

TOKYO: Japanese companies are ramping up the use of artificial intelligence and other advanced technology to reduce waste and cut costs in the pandemic, and looking to score some sustainability points along the way.

Disposing of Japan's more than 6 million tonnes in food waste costs the world's No.3 economy some 2 trillion yen (\$19 billion) a year, government data shows. With the highest food waste per capita in Asia, the Japanese government has enacted a new law to halve such costs from 2000 levels by 2030, pushing companies to find solutions.

Convenience store chain Lawson Inc has started using AI from U.S. firm DataRobot, which estimates how much product on shelves, from onigiri rice balls to egg and tuna sandwiches, may go unsold or fall short of demand. Lawson aims to bring down overstock by 30% in places where it has been rolled out, and wants to halve food waste at all of its stores in 2030 compared with 2018. Disposal of food waste is the biggest cost for Lawson's franchise owners after labour costs.

Drinks maker Suntory Beverage

& Food Ltd is experimenting with that, or when the contents themselves have been damaged and need to be returned. Suntory aims to reduce the return of goods by 30-50% and cut the cost of food waste and develop a common standard system that can be shared by other food makers and shipping firms.

Japan's notoriously fussy shoppers are showing signs of getting on board, especially as the coronavirus pandemic hits incomes.

Tatsuya Sekito launched Kuradashi, an e-commerce firm dealing in unsold foods at a discount, in 2014 after seeing massive amounts of waste from food processors while working for a Japanese trading firm in China.

The online business is now thriving due partly to a jump in demand for low-priced unsold foods as consumers became more cost conscious amid the COVID-19 pandemic.

US Children Could Receive Covid Vaccine By Year-End: Top Expert

WASHINGTON: The United States could start vaccinating older children against Covid-19 by the fall and younger ones by year-end or early 2022, the White House's top pandemic advisor Anthony Fauci said Sunday.

The mass vaccination of school-age children will allow millions of children to return sooner to in-person learning and ease the burden on millions of parents now caring for their offspring at home.

School reopenings, an intensely debated matter, have varied sharply across the country, with some private and religious schools opening before public schools and teachers in some areas protesting any early return.

But the decision Saturday by the US Food and Drug Administration to grant emergency use authorization to a new single-dose vaccine from Johnson & Johnson has boosted the prospects for earlier reopenings.

"We now have three really efficacious vaccines," Fauci said on ABC's "This Week."

For now, none of the three authorized vaccines in the US (also including Pfizer/BioNTech and Moderna) has been cleared for children under 16, but trials on children are under way

Children in high school -roughly ages 14-18 in the United States -- should be able to get the vaccine "sometime this fall," Fauci told NBC's "Meet the Press."

"I'm not sure it'll exactly be on the first day that school opens, but pretty close to that," he added. Data are still being compiled on the vaccines' safety and ef-

ficacy for children in elementary or middle school -- usually aged between five and 13 years old in the United States -- so "realistically" they may not be able to receive the vaccine until late 2021 or early 2022, Fauci said.

Speaking Sunday evening at the Conservative Political Action Conference in Orlando, Florida, former president Donald Trump urged the new administration to reopen schools.

"On behalf of the moms, dads and children of America, I call on Joe Biden to get the schools open and get them open now," said Trump.

Although the federal government issues guidelines on public health, it largely up to locally elected school boards when to reopen classrooms, not the president.

Children and adolescents are less commonly infected with the virus than adults, and in-person learning in schools has not been associated with substantial community transmission.

With Covid-19 still ravaging the US, the worst-hit country in the world, roughly half of students are currently attending school in person, the New York Times reported recently.

Earlier this month the US Centers for Disease Control and Prevention (CDC) issued new guidelines urging schools to reopen safely and as soon as possible.

The strategy emphasizes universal masking, hand-washing and disinfection, as well as contact tracing.

The CDC recommends vaccination for teachers and staff as soon as supply is available, and calls for different approaches depending on the level of community transmission in a given area.

Azad bats for statehood

Sabha term, senior Congress leader Ghulam Nabi Azad called for restoration of statehood for J&K, lamenting that once India's only globally known state had been reduced to the level of a district. He said all J&K parties including the RSS wanted it. Significantly, Azad was accompanied by other national level Congress leaders like Bhupinder Singh Hooda, Kapil Sibal, Raj Babbar, Anand Sharma, Vivek Tankha and Manish Tewari, who all form part of the G-23, a group of Congress dissenters seeking organisational reforms in the party. Azad also pointed out how in Ladakh only Leh demanded union territory status and Kargil opposed it.

Azad, who has been the former J&K Chief Minister also attacked the J&K administration saying that they had taxed everything other than the clothes worn by the people. He also called for the land and jobs to be protected for the locals only underlining how Jammu and Leh would suffer more than Kashmir and Ladakh in the absence of such a protection.

These are the issues which resonate not only in Jammu but also in Kashmir Valley. And by playing to these Azad has struck a chord in the former state. He is a leader who has always enjoyed a reasonable public support in Kashmir and Jammu. He has also built a degree of acceptability across the parties, something that was examplified recently when Prime Minister Narendra Modi broke down while praising the Congress leader in parliament.

So, it was significant when Azad didn't seek the restoration of Article 370 in his Jammu speech. When the article was revoked on August 5, 2019, it was Azad who had stoutly defended J&K's special status in parliament.

The Congress leader's visit to Jammu had another political sub-text: he was accompanied by members of G-23 who are currently at loggerheads with Congress high command and want the party to re-invent itself as an effective opposition to the BJP. So, J&K Congress president G A Mir was conspicuous by his absence.

That said, Azad's demand for restoration of statehood needs to be heeded by the union government. Here's hoping that the union government does take steps to restore J&K's statehood at the earliest. On February 5 the government restored the high speed mobile internet in the union territory after eighteen months. Home minister Amit Shah recently gave an assurance in parliament that the Centre will grant full statehood to Jammu and Kashmir at "an appropriate time". And this appropriate time is now. Over the last 18 months Kashmir has largely been peaceful and, if anything, this should be the overriding criteria in deciding in favour of a statehood for J&K.

India-Pakistan Ceasefire Back to Dialogue?

By re-affirming LoC ceasefire, New Delhi has agreed to respect the sanctity of the LoC,

ne reaffirmation of the 2003 LoC agreement between India and Pakistan has taken everyone by surprise. This has happened at a time when the relations between the two countries have plunged to their lowest low following the revocation of Article 370 in August 2019. Also, there was nothing in the recent political discourse in India and Pakistan that seemed to suggest that India and Pakistan were working towards normalization of their ties. True, some statements did emerge from Pakistan in recent past that were conciliatory towards India. First of them came from Pakistan Army Chief General Bajwa in February.

A day ahead of the LoC agreement, Pakistan Prime Minister Imran Khan during his visit to Sri Lanka said India and Pakistan can resolve Kashmir through dialogue. His foreign minister Mahmood Qureshi said that Pakistan's strategic priorities have "shifted from geo-political to geo-economic," a statement that is of profound import as far as Pakistan's policy with regard to the ongoing situation in Kashmir. It means that Islamabad's policies would now largely be geared towards promoting economic development at home and bolstering trade relations with its neighbour

Defence Minister Rajnath Singh, there were a total of 4,649 ceasefire violations on the LoC in 2020. This has resulted in loss of lives on both sides besides causing untold misery to the people living alongside the border. But this perennial state of conflict along the LAC and LoC has stretched New Delhi and this state of affairs is unsustainable in the long term.

Then there is war in Afghanistan. The unfolding situation in Kabul, where the Taliban are now being considered as a part of the political solution, has suddenly reduced India's capacity to influence the outcome in the war-torm country. Accordingly, Pakistan is suddenly in a greater position of leverage. On the other hand, Pakistan would benefit from a friendly India to ensure continued stability on its eastern flank.

The LoC agreement is also traced to the US nudging the two countries from behind the scenes. The US involvement in the relationship between India and Pakistan is a fairly complex affair. New Delhi wants the US to intervene to sort out the terror problem in Pakistan but it brooks no meddling in Kashmir.

Similarly, Islamabad wants US intervention on Kashmir but wouldn't like Washington to speak on behalf of India on terror More lowing withdrawal of Article 370, Hurrivat has been obliterated from the scene. Pakistan is no longer bolstered by the strategic depth of Afghanistan or leveraged by an allencompassing militant struggle in Kashmir. This has brought in a considerable inequality between the parties which no amount of rhetoric in Kashmir and Islamabad can hide. And this inequality - accentuated further by a stronger India — is likely to leave a deep imprint on the content of a future dialogue. And of course, on the outcome of it too, if the dialogue is sustainably held. It will be an outcome that will not be completely satisfying of the expectations of the weaker parties. Or else, the logjam that has persisted for the past seven decades will linger on.

Former Pakistan president Musharraf was the first to recognize new realities. His four point proposals on Kashmir envisaged a solution that would be a drastic climb down from Islamabad's traditional stand on J&K. This solution was about some minor political and administrative adjustments, more phraseological than substantive in their nature. With moderate Hurriyat playing along, these proposals almost got the two countries to agree to a radical new solution for Kashmir, if the lawvers' agitation in Pakistan hadn' forced the sudden exit of Musharraf, this solution would potentially have resolved Kashmir. There's a possibility that the two countries could return to the formula. And the fresh effort has to be guided by the realization that ultimately India and Pakistan will have to solve their problems themselves for a peaceful sub-continent. Only such a dialogue can be hoped to lead us towards a positive outcome. The sub-continent needs the two countries to resolve their issues to usher in a true era of peace.

Turning the corner

The Indian economy appears to have turned the corner. After two consecutive quarters of contraction, it grew by 0.4 per cent in the third quarter of the current financial year, according to the second advance estimates released by the National Statistical Office. While these estimates do indicate a marginal contraction in the fourth quarter, it is likely to be statistical aberration, driven perhaps by the back-ended release of the Centre's subsidy expenditure as detailed in the Union budget. Gross value added by the economy, which excludes these payouts, is expected to grow by 2.5 per cent in the January-March quarter, up from 1 per cent in the October-December quarter, signalling a return to pre-pandemic levels in the second half of the financial year, after an almost 15 per cent contraction in the first half.

The sector wise disaggregated data shows that the agricultural sector continues to exhibit healthy growth. It grew by 3.9 per cent in the fourth quarter, and growth for the full year is expected to touch 3 per cent — it's the only sector, barring electricity, gas and water supply, to register positive growth for the full year. Within the industrial sector, both manufacturing and construction have witnessed an uptick, the latter rebounding stronger. But this is likely to have been driven by the larger firms, with the smaller ones continuing to struggle - indicative of the heavily lopsided nature of the recovery. Moreover, as the index of industrial production suggests, volume growth continues to remain muted. Within the services sector too, the pace of recovery remains uneven. While the financial, real estate and professional services segment has rebounded strongly, the labour intensive trade, hotels, transport and communi cation parts of the economy continue to contract. Though the pace of contraction has moderated, it is indicative of continuing challenges faced by contact intensive segments. Household spending remained constrained, notwithstand ing the pick up during the festive season, reflective of job and income losses. Investment activity, though, appears to have fared better, despite subdued private activity. After contracting by 27.5 per cent in the first half of the year, investment activity is expected to rebound in the second half, growing by 2.7 per cent. The uptick appears to be driven by government spending - capital expenditure by the Centre more than doubled in the third quarter.

But there are several areas of concern. For one, as these numbers do not adequately reflect the stress in the informal economy — it is likely to have fared worse than the formal sector — it is difficult to know the extent of recovery in that part of the economy. Two, an uptick in COVID-19 cases in the past few weeks in some parts of the country has raised fears of localised lockdowns impacting economic activity. Much will depend on how quickly the vaccination programme is rolled out. Three, one must also be cautious in interpreting the growth numbers in the coming quarters, especially the first half of next year, as they are likely to be distorted due to the base-effect. Beyond that, uncertainty persists over the medium term economic outlook. *The Indian Express* tions with its heighbours.

But this still doesn't explain the change of heart in India towards Pakistan. By agreeing to LoC ceasefire, New Delhi has agreed to respect the sanctity of the LoC, which until last year it threatened to breach to take back Pakistan Administered Kashmir.

There are several factors at play in the renewed attempt at fresh engagement. One is the unfolding geo-politics of the region. Over the past ten months, India has been engaged in a tense standoff with China along the Line of Actual Control. In April last year, China staged incursions at four points - forcing India to mass its troops along the border to deter further ingress by the PLA.

Similarly, India has also been at daggers drawn with Pakistan. According to the information revealed to the parliament by the so, at a time when the US is seen as partial towards India. This contradiction hardly makes the US an ideal mediator between the two countries. The starkness of this reality leaves India and Pakistan no choice but to engage and confront their problems themselves. And confront, they must.

But here again the two countries have exhibited a singular inability to talk sustainably. The suspension of the dialogue over the last decade is enlightening on this score. This makes it incumbent for the two countries to first make serious efforts, preferably through back channels, to accommodate each other's positions and thereby reduce some trust deficit.

News Scoop from Social Media?

When we choose to get

Google and Facebook dominate the news ecosystem without creating content themselves igital platforms like Facebook and Google give us easy access to media and information. But our collective dependence on these tech giants could in the long run reduce the quality of journalism, making us all worse off.

The tension between convenience for readers and funding for journalism has been highlighted by Facebook's recent move to block news in Australia rather than pay media companies under new regulations.

Situations like this, where each individual acts in their own best interest but everybody still somehow loses, are surprisingly common in life. Economists see them through the lens of the "prisoner's dilemma", a famous fable from game theory that might well illustrate our digital platforms ecosystem.

What is the prisoner's dilemma?

Imagine two prisoners being interrogated in separate rooms about a crime they've committed. Each is offered a reduced sentence if they provide evidence of the crime.

Hear directly from the scientists on the latest research.

If both prisoners provide evidence, they are both convicted of the crime. If only one does, he or she gets a reduced sentence, while the other gets the harshest of sentences. If neither supplies evidence, the investigator can only convict them of a minor crime.

Now put yourself in either criminal's shoes: whatever your co-conspirator does, it is always in your own self-interest to provide evidence. If your coconspirator doesn't, you get off with a light sentence. If your co-conspirator does too, you are both convicted, but you would have received an even harsher sentence if you didn't provide evidence yourself.

By this logic, both prisoners would give evidence (it is a "dominant strategy" for each of them) — but both would end up worse off than if they had both stayed silent.

This fable is one of the most famous and successful models of game theory — it has been widely used to study nuclear arms races, climate change, the evolution of cooperation, doping in sports, and many other phenomena.

Do digital platforms present a prisoner's dilemma?

Digital platforms make it easy for users to access news and information by integrating them into the rest of their services. Seeking out news directly from providers would be less convenient.

When we choose to get news and information on these platforms, we individually value the convenience, but not the effect on news quality in the long run.

Google and Facebook dominate the news ecosystem without creating content themselves. We generate value when we use the platforms — but the quality of the news and information we get will depend on how much of that value ultimately goes to the journalists and newsrooms who produce the content in the first place.

If very little value goes to content providers, they may have little incentive to develop high-



quality content. This is the classical prisoners' dilemma outcome, where we are all worse off.

Alternatively, if digital platforms pass a lot of the value to content providers, we might all benefit from both high-quality content and ease of access.

Who captures the value of news and information?

Digital platforms capture enormous value by monetising the time and attention we spend on them, and the data we generate.

There are good reasons to think digital platforms bring significant value for news and content providers, but it's hard to determine how much.

If easy access to news means people read more news than they would otherwise, then the digital platforms are creating value overall, and some of that would benefit the content providers.

On the other hand, there are also good reasons to think very little of that value ultimately goes to news and content production.

Platforms have a very strong bargaining position in negotiations with providers over how much to pay for news. In part this is because platforms can easily substitute one news provider for another. An article from the Sydney Morning Herald and one from the Australian Financial Review on the same topic are likely to be very similar, apart from some nuance.

But a news provider can't easily substitute Facebook for Twitter or Google for Bing, because the alternatives have much smaller audiences. So the news providers have a lot less power to negotiate, because they are more replaceable than the platform itself.

What makes digital platforms so irreplaceable?

Facebook and Google are as big as they are today thanks to network effects. When many people use a digital platform, the platform can attract even more users and create economies of scale. It can collect more and better data, and target advertising more effectively.

Markets with such network effects tend to be dominated by a few very large firms in the long run. Digital platforms monetise their dominance of social media and search by selling advertising throughout their entire range of products and indirectly selling data about their users. The time and attention that we spend on digital platforms has enormous value, contrary to what Google Australia might want to claim.

What comes next?

Facebook turned off news content on its social media platform, in response to the Australian government's proposed media bargaining code. Google has taken a more conciliatory approach, striking multimillion-dollar deals with several media companies.

Might we be better off this way in the long run? What if we did not consume our news and information on Facebook?

If platforms like Facebook do leave the news and information "market" in Australia, something else will fill the vacuum. People will not simply stop reading news. Rather, they would find alternative channels, or other platforms would step in to aggregate news.

The cooperative solution to the prisoner's dilemma of news and information requires that we as a society consume news in a way that incentivises journalists to produce high-quality content. This could come about if we all individually choose to get our news content directly from those who produce it, or from platforms that pass more value to producers.

Ideally one might imagine a world with multiple platforms that aggregate news and provide convenient access to journalism. Because news and information are public goods, we might even imagine a non-profit platform which seeks to maximise informed-ness and digital well-being, rather than maximising the profit from eyeballs and user engagement.

Health App Usage By Diabetes **Patients May Improve Health, Lower Medical Costs**

ealth apps have become a popular tool among teens and adults to track fitness, weight loss, sleep, and even menstrual cycles. But did you know mobile health applications could also benefit diabetes patients? A new study has found out

that the use of health apps by diabetes patients could improve health outcomes and lower medical costs. The findings of the study will be published in the journal 'MIS Quarterly', a publication of the Management Information Systems Research Center.

Emerging smart mobile health or mHealth technologies are changing the way patients track information related to diagnosed conditions. This study examined the health and economic impacts of mHealth technologies on the outcomes of diabetes patients in Asia.

The study concluded that compared to patients who did not use mHealth applications, patients who used the apps had better health outcomes and were able to regulate their health behaviour more effectively. They also had fewer hospital visits and lower medical costs.

The study was conducted by researchers at Carnegie Mellon University (CMU) and New York University (NYU). "Given the importance of health behaviors to well-being, health outcomes, and disease processes, mHealth technologies offer significant potential to facilitate patients' lifestyle and behavior modification through patient education, improved autonomous self-regulation, and perceived competence," explained Beibei Li, professor of information systems and management at CMU's Heinz College, who coauthored the study.

The relatively new area of mHealth includes mobile computing, medical sensor, and communications technologies used for health care services (for example managing chronic diseases).

Mobile health applications can operate on smartphones, tablets, sensors, and cloud-based computing systems, all of which collect health data on individuals. The global mHealth market was estimated to have reached USD 49 billion by the end of 2020. Yet few studies have assessed the technologv's effectiveness in changing patients' behaviors and outcomes.

In this study, researchers sought to determine how mHealth applications persuade individuals to modify their behavior to comply with recommended approaches to obtain certain health goals.


The researchers measured compliance by looking at detailed patient activities (for example daily walking steps, exercise time, ening nattern food intake) as measured by the app, as well as general health outcomes, hospital visits, and medical expenses. The researchers partnered with a top mHealth firm that provides one of the largest mobile health platforms in Asia specializing in diabetes care. The study randomly assigned 1,070 adult patients to different groups for three months: Some patients used the mHealth app, some did not, and some used a web-based version of the app. Among the patients in the group that used the mHealth app, some received personalized text message reminders, while others received

non-personalized text messages. Researchers interviewed all participants before the study began and five months after it ended. Among the questions asked were those about demographics, medication and medical history, blood glucose and hemoglobin levels, frequency of hospital visits, and medical costs.

The study found that patients who used the mHealth app reduced their blood glucose and hemoglobin levels, even after controlling for individual-level fixed effects. Patients who used the app also exercised more, slept more, and ate healthier food. And they had fewer hospital visits and lower medical expenses.


The authors suggested that patients' adoption of and use of the mHealth app was associated with significant behavioral modifications toward a healthier diet and lifestyle. In this way, users became more autonomously self-regulated with their health behavior, and this increasing intrinsic motivation helped them become more engaged, persistent, and stable in their behavior, which led to improved health outcomes. The mHealth platform also facilitated an increased usage of telemedicine, which in turn led to reduced hospital visits and medical expenses for the patients.

The study also found that the



mHealth platform was more effective in improving patients' health outcomes than a web-based (PC) version of the same app. And non-personalized text messages tended to be more effective in changing patients' behavior than personalized messages, possibly because personalized messages can be viewed as intrusive, coer-

cive, and annoying. Among the study's limitations, the authors note that this study focused mainly on participants with Type II diabetes which, different from Type I diabetes or Gestational diabetes, is directly tied to dietary or lifestyle self-management. Hence, the research is not necessarily applicable to patients with other types of diabeter "Our findings provide important insights on the design of mHealth apps through a better understanding of patients' health behavior and interactions with the platform," suggested Anindya Ghose, professor of business at NYU's Stern School of Business, who co-authored the study.



Hesitation While Replying Leads To Decreased **Perceived Sincerity**

The findings of a recent study conducted by the American . Psychological Association suggested that while communicating, the longer the hesitation, the less sincere the response appears. The study claimed that when

people pause before replying to a question, even for just a few seconds, their answers are perceived to be less sincere and credible than if they had replied immediately. The research was published in

'Journal of Personality and Social Psychology' "Evaluating other people's sincerity is a ubiquitous and important part of social interactions,"

said lead author Ignazio Ziano, PhD, of Grenoble Ecole de Management. "Our research shows that response speed is an important cue on which people base their sincerity inferences." added Dr Ziano. Researchers conducted a series of experiments involving more

than 7,500 individuals from the United States, the United Kingdom, and France. Participants either listened to an audio snippet, viewed a video, or read an account of a person responding to a simple question (example: did they like a cake a friend made or had they

stolen money from work). In each scenario, the response time varied from immediate to a 10-second delay. Participants then rated the sincerity of the response on a sliding scale.

Across all 14 experiments, participants consistently rated delayed responses as less sincere regardless of the question, whether it was a harmless one about cake or a more serious one about committing a crime.

A few conditions reduced this effect, the researchers found. For example, if the answer was considered socially undesirable, such as saying, "No, I don't like it" when a friend asks if you like their cake, response speed did not

seem to matter much; the answer was considered sincere whether it was fast or slow.

The researchers also found that if people thought a slower response was due to mental effort (for instance, having to think back if you had stolen candy 10 years ago), response speed had a smaller effect.

The findings have wide implications, according to Dr Ziano. "Whenever people are interacting, they are judging each other's sincerity. These results can be applied to a wide range of interactions, going from workplace chit-chat to couples and friends bickering," he said.

"Further, in job interviews and in court hearings and trials, people are often tasked with judgments of sincerity. Here, too, response speed could play a part."

For example, he said, imagine a hiring manager asking two job candidates, named Ann and Barb, whether they really know

Study Discusses Correlation Between Allergy Seasons, Pollens

esearchers in Munich during a recent study discovered Nhow the length of allergy seasons in Germany are affected by pollen travelling far distances. Allergy sufferers are no strang-

ers to problems with pollen. But now - due to climate change - the pollen season is lasting longer and starting earlier than ever before, meaning more days of itchy eyes and runny noses. Warmer temperatures cause flowers to bloom earlier, while higher CO2 levels cause more pollen to be produced.

The effects of climate change on the pollen season have been studied at length, and according to some scientists, has grown by as much as 20 days in the past 30 years, at least in the US and Canada. But one important element is often overlooked - "Pollen is meant to fly," said Dr Annette Menzel, Professor of ecoclimatology at the Technical University of Munich. "Transport phenomena have to be taken into account."

Along with her colleagues, she studied the transport of pollen in Bavaria, Germany, in order to better understand how the pollen season has changed over time. "The transport of pollen has important implications for the length, timing, and severity of the allergenic pollen season," said Dr Ye Yuan, a coauthor on the study. Menzel and her team focused

on Bavaria - a state in southeast Germany - and used six pollen monitoring stations scattered around the region to analyse data. Their results were recently published in Frontiers in Allergy. They found that certain species of pollen, such as hazel shrubs and alder trees, advanced the start of their seasons by up to 2 days per year, over a period of 30 years (between 1987 and 2017). Other species, which tend to bloom later in the vear, such as birch and ash trees, moved their seasons 0.5 days earlier on average each year, across that same time period. Pollen can travel hundreds of kilometres and, with changing

weather patterns and altered species distributions, it's possible that people are becoming exposed to "new" pollen species - meaning pollen that our bodies are unaccustomed to encountering each year.

While it can sometimes be difficult to differentiate between local and transported pollen, the researchers focused on pre-season transports. So, for example, if pollen from birch trees was present at the monitoring station, but local birch trees would not flower for at least another 10 days, that pollen was considered to be transported from far away.

"We were surprised that preseason pollen transport is a quite common phenomenon being observed in two-thirds of the cases," said Menzel. As for why it's important to understand how much pollen is from far away, Yuan said that: "Especially for light-weight allergenic [pollen], long-distance transport could seriously influence local human health."

By examining another element besides simple pollen concentration, scientists can delve deeper into how exactly the pollen season is being affected by climate change. For example, Menzel said that the pollen season maybe even longer than estimated based on flowering observations by "taking into account pollen transport, as it has been done in our current study."

While the Munich study did not track how far pollen was transported, and only differentiated between local and long-range transport (meaning pollen coming from outside Bavaria), it provides a crucial key in our understanding of annual pollen patterns. Yuan said that future studies should account for "climate change scenarios [and] land use/land cover changes." He also added that citizen scientists may be able to contribute to pollen studies, who can help collect local observations and contribute to data collection.

New Twitter Tool To Let Users Block, Mute **Abusive Accounts**

witter is planning a new tool to let users automatically block and mute abusive accounts. With the new safety mode, the micro-blogging platform will automatically detect accounts that "might be acting abusive or spammy." The company will limit how those accounts can engage with your content for seven days. During its virtual Analyst Day on Thursday, the company showed a presentation where a slide revealed that the feature will be a toggle in the new safety mode.

"Automatically block accounts that appear to b Twitter Rules, and mute accounts that might be using insults, name-calling, strong language, or hateful remarks," the description read. Currently, not many Twitter users in India are aware of how to report abuse or harassment they face on the open communication platform, opting for the wrong way of posting an abusive photo or tweet and then requesting us to take action. At the moment, users can report abusive behaviour directly from a Tweet, profile or Direct Message. Multiple Tweets can be included in the same report to help Twitter gain better context while investigating the issues to get those resolved faster. "We have given additional tools to users to help them navigate through the service and keep themselves secure. "There are additional ways to navigate to see tools and settings around notifications before you can mute a keyword or a conversation. You can report fake accounts or impersonation to us," Twitter said recently.

'US Owes India \$216 **Billion As American Debt** Soars To \$29 Trillion'

WASHINGTON: The US, the world's largest economy, owes India \$216 billion in loan as the country's debt grows to a record \$29 trillion, an American lawmaker has said, cautioning the leadership against galloping foreign debt, the largest of which comes from China and Japan.

In 2020, the US national debt was \$23.4 trillion, that was \$72,309 in debt per person.

"We are going to grow our debt to \$29 trillion. That is even more debt owed per citizen. There is a lot of misinformation about where the debt is going. The top two countries we owe the debt to are China and Japan, not actually our friends," Congressman Alex Mooney said.

"We are at global competition with China all the time. They are holding a lot of the debt. We owe China over \$1 trillion and we owe Japan over \$1 trillion," the Republican Senator from West Virginia said on the floor of the US House of Representatives as he and others opposed the latest stimulus package of \$2 trillion.

In January, US President Joe Biden announced a \$1.9 trillion coronavirus relief package to tackle the economic fallout from the pandemic, including direct financial aid to average Americans, support to businesses and to provide a boost to the national vaccination programme.

"The people who are loaning us the money we have to pay back are not necessarily people who

have our best interest at heart. Brazil, we owe \$258 billion. India, we owe \$216 billion. And the list goes on the debt that is owed to foreign countries," Congressman Moonev said.

NEW DELHI: If edtech and e-commerce had the eye of investors last year, verticals such as software-as-aservice, agri-tech, and health tech are now giving them a run for their money. This week saw start-ups raising over \$500 million funding and the birth of two new unicorns-healthtech firm Innovaccer Inc and realty technology start-up Infra market.

Chinese Hackers Target Indian Vaccine Makers SII, Bharat **Biotech, Says Security Firm**

NEW DELHI : A Chinese statebacked hacking group has in recent weeks targeted the IT systems of two Indian vaccine makers whose coronavirus shots are being used in the country's immunisation campaign, cyber intelligence firm Cyfirma told Reuters. Rivals China and India have

both sold or gifted COVID-19 shots to many countries. India produces more than 60% of all vaccines sold in the world.

Goldman Sachs-backed Cyfirma, based in Singapore and Tokyo, said Chinese hacking group APT10, also known as Stone Panda, had identified gaps and vulnerabilities in the IT infrastructure and supply chain software of Bharat Biotech and the Serum Institute of India (SII), the world's largest vaccine maker.

'The real motivation here is actually exfiltrating intellectual property and getting competitive advantage over Indian pharmaceutical companies," said Cyfirma Chief Executive Kumar Ritesh, formerly a top cyber official with British foreign intelligence agency MI6. He said APT10 was actively targeting SII, which is making the AstraZeneca vaccine for many countries and will soon start bulkmanufacturing Novavax shots.

"In the case of Serum Institute, they have found a number of their public servers running weak web servers, these are vulnerable web servers," Ritesh said, referring to the hackers.

They have spoken about weak web application, they are also talking about weak content-management system. It's quite alarming." China's foreign ministry did not reply to a request for comment. But responding to a question on whether Chinese hackers had a role in attacking India's

power grid which caused a blackout in Mumbai last year, the ministry said it was a staunch defender of cyber security.

"China firmly opposes and cracks down on all forms of cyber attacks," its embassy in New Delhi said on Twitter, quoting the foreign ministry. "Speculation and fabrication have no role to play on the issue of cyber attacks."

SII and Bharat Biotech declined to comment. The office of the director-general of the staterun Indian Computer Emergency Response Team (CERT) said the matter had been handed to its operations director, S.S. Sarma.

Sarma told Reuters CERT was a "legal agency and we can't confirm this thing to media".

Cyfirma said in a statement it had informed CERT authorities and that they had acknowledged the threat.

The U.S. Department of Justice said here in 2018 that APT10 had acted in association with the Chinese Ministry of State Security.

Microsoft said here in November that it had detected cyber attacks from Russia and North Korea targeting vaccine companies in India, Canada, France, South Korea and the United States. North Korean hackers also tried to break into the systems of British drugmaker AstraZeneca, Reuters here has reported.

Ritesh, whose firm follows the activities of some 750 cyber criminals and monitors nearly 2,000 hacking campaigns using a tool called DeCYFIR, said it was not yet clear what information APT10 may have accessed from the Indian companies.

Relations between nucleararmed neighbours China and India soured last June when 20 Indian and four Chinese soldiers were killed in a Himalayan border fight. Recent talks have eased tension.

Indian Mobile Retailers Seek Amazon Probe, Cap On Online Smartphone Sales

n Indian trade group representing 150,000 mobile phone stores on Mon-Aday urged Prime Minister Narendra Modi to investigate Amazon's business practices in the country and impose a daily cap on a single seller's online smartphone sales. In a letter sent to Modi, the group cited a

Reuters special report published last month that revealed Amazon has for years given preferential treatment to a small group of sellers on its Indian platform, using them to circumvent the country's strict foreign investment regulations.

The report was based on internal Amazon documents dated between 2012 and 2019.

"We were already aware of Amazon's thought process and strategy," the All India Mobile Retailers Association (AIMRA) wrote in the letter. The documents, the letter said, "have revealed that Amazon is doing business in India with the strategy of deftly dodging the regulators and politicians".

AIMRA urged the government to "suspend all Amazon activities in India" until there is an investigation into the company's practices.

Amazon says it doesn't give preferential treatment to any seller on its marketplace and has always complied with Indian law.

Amazon and Modi's office did not immediately respond to a request for comment on Monday. Indian retailers, a crucial part of Modi's support base, have long alleged that Amazon and Walmart's Flipkart flout federal regulations and that their business practices hurt small traders. The companies, which run the two biggest e-commerce platforms in India, deny the allegations.

The Amazon documents reviewed by Reuters showed the company helped a small number of sellers prosper on its website, discounted their fees and helped one cut special deals with big tech manufacturers such as Apple Inc. Some 35 of Amazon's more than 400,000 sellers in India in early 2019 accounted for around two-thirds of its online sales, the documents also showed.

Economic Activity Gathering Steam, But Private Investment Missing: RBI

NEW DELHI: The Reserve Bank of India (RBI) on Monday, March 1, said India's economic activity is gaining momentum on COVID-19 vaccination roll out and decrease in infections. but private investment is missing.

The vaccination programme has released pent-up optimism and "there is little doubt today that a recovery based on a revival of consumption is underway," RBI said.

"All engines of aggregate demand are starting to fire; only private investment is missing in action and the time is apposite for it to come alive. Broader measures of liquidity reflect easing of monetary and financial conditions in the system," the central bank said in its monthly bulletin for February.

India's GDP growth returned to positive territory in October-December after contracting for two consecutive quarters due to the COVID-19 pandemic and related disruptions. As per government data, India's GDP increased 0.4 per cent during the third quarter ended December 31, 2020, as against a 24.4 per cent contraction in April-June and a 7.3 per cent de-growth in July-September.

The RBI expects the Indian econ-omy to grow by 10.5 per cent in the financial year 2021-22.

"In terms of nominal GDP, 96 per cent of prepandemic economic activity has been restored, assuming that the National Statistical Office's first advance estimates hold." the RBI said.

'Sticky Bombs'

on high alert with an assumption that some of the IEDs could have already found their way to the Kashmir valley, the officials said.

According to the officials, the dronedropped consignment had six pistols and 14 Improvised Explosive Devices (IEDs) with inbuilt magnets, which could be used as "sticky bombs" by sticking them on vehicles and controlling them using a timer and a remotely-held device.

The consignment was meant for The Resistance Force (TRF), believed to be a shadow outfit of banned Lashker-e-Taiba militant group, they said.

This definitely was the first such recovery of "sticky bombs" which has found much use in Afghanistan and Iraq. In India, it was used by suspected Iranian militants in February 2012 by sticking a bomb on the car of an Israeli diplomat resulting in injury to his wife.

The recovery is a cause of concern in Kashmir and the standard operating procedures for the movement of security forces" convoys need to be revised to eliminate this kind of a threat, a senior official said.

The development comes two years after a Jaish-e-Mohammed militant carried out a sensational attack when he rammed an explosive-laden vehicle into a bus carrying security forces that left 40 CRPF personnel dead in 2019.

In response, India had carried out an air strike on militant camps located across the border.

"But, if they have done this (ceasefire agreement), then we will slowly disincentivise them from doing other things as well," he added.

To a question about the reports of Taliban-style "sticky bombs", the Army officer said "inducting anything new available is an ongoing process in the valley and we will adopt a proper strategy to do our job".

The XV Corps Commander said the Army reduced its footprints in north Kashmir last year and it is an ongoing process.

"When the violence goes down, the methodology changes," he said.

Asked about the emergence of new militant outfits, the GoC said "a militant is a militant" and the name of the outfit does not matter.

"We are doing a lot of good work to stop recruitment even as there is continuous social media-based propaganda from the other side," he said.

Nonetheless, it's quite hard to take the Kashmiri Carpets to their days of glory as now the material used in its making is 'the recycled silk' procured from Sari mills in Karnataka.

In his own words, Umer narrated how he told the same to the then Union Minister of Textiles, Smriti Irani, when she was planning to promote Kashmiri carpets on a global level.

"All the stakeholders were called by her in the meeting and the moment the union minister mentioned her plan, I intervened and asked her 'what rubbish are you going to promote?' The maximum life of today's Kashmiri carpet is not more than three years. You can't promote anything nonsense.'

Even after tons of such problematic conditions, Umer never bowed to the trouble and is still popular across the region for the finest and premium quality Kashmiri carpets, which is, nowadays, a rare sight to see.

"I have the best carpet in the world right now," said Umer while showing me one piece out of his premium and flagship collection which contains 6,400 knots per square inch, allegedly the highest in the world.

"It took four and a half years to complete it and the woman who made it gave birth to two kids during that period. It was a once in a lifetime watch and I'm blessed to have the legacy of holding it." he added Nevertheless, dedicating all his life to creating a stronghold of royal Kashmiri carpets in Delhi and earning the fame that other dream for, Umer still addresses himself as a tourist intending to go back to his homeland once call for the same is made by his heart. "The peace of life is missing here," the mountain man said. "I am enjoying my stay here but it's not permanent. The moment I would realize that my time has come, I'll quietly move back to my Kashmir."

While building his brand, he was mindful how the carpet industry of Kashmir had seen many challenges and changes over the last 50 years. The industry renowned for its woollen items started producing silk carpets in the late 1970s.

At that time, it was unrivalled across India. "The least quality of Kashmiri carpets used to have 324 knots per square inch," he informed."Now, tell me how a carpet from the rest of India, which usually has less than 100 knots, can match the Kashmiri carpets?"

Following the arrival of silk in the 80s. the boom in the entire carpet industry in Kashmir was so massive that, according to Umer, the weavers in Kashmir used to smoke a hookah of milk instead of water.

Half an hour into the conversation, he went to offer prayers and came back with two cup of tea and a variety of snacks.

"There is a stark difference in the work culture," he resumed the conversation by drawing parallels between Kashmir and Delhi.

"Working in the valley is working at home, in an aesthetic and peaceful environment. Plus, one can go for a routine checkup, like what my dad did."



Washington: Amidst the tense border situation between India and China, a Chinese governmentlinked group of hackers targeted India's critical power grid system through malware, a US company has said in its latest study, raising suspicion whether last year's massive power outage in Mumbai was a result of the online intrusion.

Recorded Future, a Massachusetts-based company which studies the use of the internet by state actors, in its recent report details the campaign conducted by a Chinalinked threat activity group RedEcho targeting the Indian power sector. The activity was identified

through a combination of largescale automated network traffic analytics and expert analysis.

Data sources include the Recorded Future Platform, SecurityTrails, Spur, Farsight and common open-source tools and techniques, the report said. In New Delhi, the Ministry of

Power on Monday said there is no impact on operations of Power System Operation Corporation (POSOCO) due to any malware attack and that prompt actions are taken on advisories issued against such threats.

Responding on the findings of the study, the ministry said, "There is no impact on any of the functionalities carried out by POSOCO due to the referred threat. No data breach/ data loss has been detected due to these incidents."

It further said, "Prompt actions are being taken by the CISOs (chief information security officers) at all these control centres under operation by POSOCO for any incident/advisory received from various agencies like CERT-in, NCIIPC, CERT-Trans etc."

The CERT-in (Indian Computer Emergency Response Team) is the nodal agency to deal with cyber security threats like hacking and phishing. However, the ministry did not

However, the ministry did not mention about the Mumbai outage in its statement.

On October 12, a grid failure in Mumbai resulted in massive power outages, stopping trains on tracks, hampering those working from home amidst the COVID-19 pandemic and hitting the economic activity hard.

In its report, Recorded Future notified the appropriate Indian government departments prior to publication of the suspected intrusions to support incident response and remediation investigations within the impacted organisations.

Since early 2020, Recorded Future's Insikt Group observed a large increase in suspected targeted intrusion activity against Indian organisations from the Chinese statesponsored group.

The New York Times, in a report, said the discovery raises the ques-

tion about whether the Mumbai outage was meant as a message from Beijing about what might happen if India pushed its border claims too vigorously.

In response to the US firm's allegation, Chinese Foreign Ministry spokesman Wang Wenbin on Monday rejected the criticism about China's involvement in the hacking of India's power grid, saying it is "irresponsible and illintentioned" practice.

"As a staunch defender of cyber security, China firmly opposes and cracks down on all forms of cyber attacks. Speculation and fabrication have no role to play on the issue of cyber attacks, as it is very difficult to trace the origin of a cyber attack.

"It is highly irresponsible to accuse a particular party when there is no sufficient evidence around. China is firmly opposed to such irresponsible and ill-intentioned practice," Wang said in Beijing.

According to the Recorded Future report, from mid-2020 onwards, Recorded Future's midpoint collection revealed a steep rise in the use of infrastructure tracked as AXIOMATI-CASYMPTOTE, which encompasses ShadowPad command and control (C2) servers, to target a large swathe of India's power sector.

Ten distinct Indian power sector organisations, including four of the five Regional Load Despatch Centres responsible for operation of the power grid through balancing electricity supply and demand, have been identified as targets in a concerted campaign against India's critical infrastructure.

Other targets identified included two Indian seaports, it said, adding the targeting of Indian critical infrastructure offers limited economic espionage opportunities.

"However, we assess they pose significant concerns over potential pre-positioning of network access to support Chinese strategic objectives. "Pre-positioning on energy as-

sets may support several potential outcomes, including geostrategic signalling during heightened bilateral tensions, supporting influence operations, or as a precursor to kinetic escalation," it said.

RedEcho has strong infrastructure and victimology overlaps with Chinese groups APT41/Barium and Tonto Team, while ShadowPad is used by at least five distinct Chinese groups, it said.

Recorded Future said in the leadup to the May 2020 border skirmishes, it observed a noticeable increase in the provisioning of PlugX malware C2 infrastructure, much of which was subsequently used in intrusion activity targeting Indian organisations. "The PlugX activity included the tar-

"The PlugX activity included the targeting of multiple Indian government, public sector and defence organisations from at least May 2020," it said.



Saudi Arabia Maintains Neutrality Over Kashmir Issue

NEW DELHI: Much to Pakistan's dismay and India's delight, Saudi Arabia maintained neutrality over the Kashmir issue, even when Islamabad is making all efforts to mend its relations with the Gulf country and is wooing it to change its stance.

Since Prime Minister Narendra Modi came to power in 2014, his government has had good relations with Saudi Arabia. After the Indian Prime Minister's visit to Riyadh in October 2019, Saudi Arabia has maintained neutrality over Kashmir and backed India on cross-border terrorism, said Abhinav Pandya, a strategic analyst and the CEO of

Usanas Foundation, an India based think tank, told The Epoch Times. The Saudis have had ambiguous stands on Kashmir on various

global diplomatic forums--many times they supported Pakistan's stance before they recently took to neutrality in India's favour.

"Three events of 1979 had a direct impact on Kashmir [seizure of the Grand Mosque in Mecca, the Islamic Revolution of Iran, and the Soviet invasion of Afghanistan]," said Pandya.

"After 1979, the Saudis sponsored Wahhabism across the globe." Muslim majority Kashmir became a "natural choice for Wahhabi proselytization" because of the deep penetration of Pakistan, which had historically close relations with the Saudis added Pandva

"When we are fighting, it is brother Tejashwi who is also fighting, we are together," Banerjee said.

BHIMA KOREGAON CASE Supreme Court To Hear Bail Plea Of Activist Gautam Navlakha On Wednesday

NEW DELHI: The Supreme Court is scheduled to hear on Wednesday the bail plea of activist Gautam Navlakha in the alleged Elgar Parishad-Maoist link case.

The activist, on February 19, had moved the top court against the Bombay High Court order of February 8 dismissing his bail plea. The high court had said that "it

sees no reason to interfere with a special court's order which earlier rejected his bail plea".

A three-judge bench of the top court comprising justices U U Lalit, Indira Banerjee, and K M Joseph would take up the appeal of Gautam Navlakha for hearing on March 3 against the high court's order.

According to police, some activists allegedly made inflammatory speeches and provocative statements at the Elgar Parishad meet in Pune on December 31, 2017, which triggered violence at Koregaon Bhima in the district the next day.

Police also alleged that the event was backed by some Maoist groups. The National Investigation Agency (NIA) is conducting a probe into the case.

Gautam Navlakha had approached the high court last year, challenging the special NIA court's order of July 12, 2020, that rejected his plea for statutory bail.

On December 16 last year, the high court bench reserved its verdict on the plea filed by Gautam Navlakha, seeking statutory or default bail on grounds that he had been in custody for over 90 days, but the prosecution failed to file a charge sheet in the case within this period. The NIA had argued that his

Moreover, the Chinese equation with Pakistan has complicated the situation, and MBS, according to Bahrami, is sending a warning to

The special court had then ac-

cepted NIA's plea seeking an extension of 90 to 180 days to file the charge sheet against Gautam Navlakha and his co-accused, activist Dr Anand Teltumbde.

Gautam Navlakha's counsel had told the high court that the NIA was granted the extension to file its charge sheet.

Senior advocate Kapil Sibal had said Gautam Navlakha had already spent 93 days in custody, including 34 days of house arrest, and that the high court must count house arrest as a period of custody.

While he was under house arrest, Gautam Navlakha's personal liberties remained curtailed, Kapil Sibal had said. However, Additional Solicitor General SV Raju, who appeared for the NIA, had argued that Gautam Navlakha's house arrest could not be included in the time spent in the custody of police or NIA, or under judicial custody.

SV Raju argued that the Pune police arrested Gautam Navlakha in August 2018, but had not taken him into custody. He said the accused remained under house arrest, and the Delhi High Court quashed his arrest and remand order in October 2018.

The FIR against him was re-registered in January 2020, and Gautam Navlakha surrendered before the NIA on April 14.

He spent 11 days in the NIA's custody till April 25 and since then he in judicial custody in the Taloja jail in neighbouring Navi Mumbai. SV Raju had argued that if the court "looked from the other angle, it would

"looked from the other angle, it would see that if he (Gautam Navlakha) was arrested on August 28, 2018, he should have been enlarged on bail."

"He was a free man till April 2020. He was neither on bail nor in custody. There cannot be a gap in the custody and detention period," SV Raju had said.

Are You Willing To Marry Her, SC Asks Man Accused Of Raping Girl, Grants Protection From Arrest

NEW DELHI: "Are you willing to marry her," was the question posed to a public servant, who is accused of repeatedly raping a minor girl but when the Supreme Court on Monday was told that he is already married he was asked to seek regular bail from the concerned court.

A Bench headed by Chief Justice SA Bobde was hearing a plea filed by the accused who is serving as a technician in Maharashtra State Electricity Production Company Ltd and has moved the apex court against the Bombay High Court February 5 order which had cancelled the anticipatory bail granted to him in the case.

When the hearing commenced, the Bench also comprising Justices AS Bopanna and V Ramasubramanian, asked the accused "Are you willing to marry her?"

"If you are willing to marry her



then we can consider it, otherwise you will go to jail," observed the Bench adding "we are not forcing you to marry".

After taking instructions on Be the query posed by the Bench, the counsel appearing for the petitioner, said the accused was initially willing to marry the girl but

he she had refused and now he was married to someone else. App As the counsel said that the accused is a public servant, the Bench said, "You should have thought this before seducing and raping the girl. You knew that you are a government servant." un

The counsel said charges in the

case are yet to be framed. "You apply for regular bail. We will stay arrest," the Bench said.

The apex court granted the accused protection from arrest for four weeks. The top court was hearing a plea filed by the accused against the Bombay High Court's February 5 order cancelling the anticipatory bail granted to him by the trial court in January last year. He has also been accused of of-

fences punishable under the Protection of Children from Sexual Offences (POCSO) Act.

In his plea filed in the top court, he has referred to the Maharashtra Civil Services (Discipline and Appeal) Rules 1979 and said it pointed out that if a government servant is detained in police custody under criminal charges for a period of 48 hours, then he shall be deemed to have been placed under suspension by an order of appointing authority.

Above Normal Summer Temperatures Likely Across Country: IMD

NEW DELHI: Day temperatures are likely to be above normal in north, northeast, parts of east and west India, the India Meteorological Department said on Monday in its summer forecast for March to May. However, it has forecast a likelihood of below normal temperatures in south and adjoining central India.

"During the upcoming hot weather season (March to May),



above normal seasonal maximum temperatures are likely over most of the subdivisions of north, northwest and northeast India, few subdivisions from eastern and western parts of central India and few coastal subdivisions of north peninsular India. "However, below normal seasonal maximum temperatures are likely over most of the subdivisions of south peninsula and adjoining central India," it added. PTI
