Imran Khan Tests Covid-19 Positive

Modi Wishes Him Speedy Recovery

ISLAMABAD: Pakistan Prime Minister Imran Khan on Saturday tested positive for the COVID-19 and is self-isolating at home, his top aide on health announced, two days after he got the first shot of a vaccine.

Special Assistant to the Prime Minister on National Health Services, Regulations and Coordination Dr Faisal Sultan took to Twitter to confirm that Khan, 68, has contracted the coronavirus on a day when the country registered the highest number of COVID-19 cases since July last year. Khan was vaccinated on Thursday as part of the nationwide anti-coronavirus vaccination campaign which is underway in its first phase.

Khan is reported to have received the first shot of the Chinese-produced Sinopharm vaccine, the only anti-COVID jab available in Pakistan. PM Imran Khan has tested >> More On P6



Inside Kashmir's Child Trafficking Network

ohan was brought to Kashmir with the promise of a high paying job. But little did he know that he would end up as a household worker in southern Kashmir's Pulwama area.

Before his unwitting valley visit, the minor was living in an ashram in Assam, where he used to work at weddings to earn his livelihood.

One day while returning from a wedding at night, he met a person who asked him if he wanted to earn more money. Rohan who had no one in his family except his little sister decided to go with the man in search of work.

Exhausted by the work, he slept

he woke up he was on his way to "Rohan was brought to Pulwama

through a consultancy firm who told us that he was an adult," said Tawseef Ahmad Ganai, a member of Child Welfare Committee (CWC), Pulwama.

on the train, unknown of the place

the man was taking him. When

When Ganai got information about Rohan, he alerted the District Child Protection Unit (DCPO) who gave the boy's custody to the CWC.

On examination, it was found out that Rohan was a student of 8th class, when brought to Kashmir-"meaning that he was around 13 years old," said Ganai.

The consultancy firm was given a

warning and since then it is under the scanner of the CWC, Ganai told Kashmir Observer.

People believe that there is no human trafficking in Jammu & Kashmir, but they're wrong, said Mohammad Sharif Bhat, J&K and Ladakh head of NGO, Save the Children."I've seen many people having minor non-Kashmiri ser-

vants in their homes," he said. Three years ago, Bhat came across a minor girl from Kolkata who was found on a farm in northern Kashmir's Kupwara district. Alerted by the Information District Social Welfare Officer, the NGO soon rescued the traumatized kid.

ri Lanka has grabbed global headlines after its public security Minister Weerrasekera announced in the parliament that he had signed a paper proposing a ban on wearing burqas in public places and shutting down some 1000 madras to eradicate religious extremism in the nation. This bill. if proposed, by the government will most likely be implemented since the Mahindra Rajapaksa government enjoys a two-thirds majority in the parliament.

statement Weerasekara's has perturbed and outraged Muslim community who perceive it as an attempt to further marginalize the country's Muslims who constitute 10% of the 21 million population of Sri Lanka. Sri Lanka has been under the scrutiny of UNHCR for human rights violations against its minorities. The Rajapaksa government is infamous for its hostility towards Muslims and Tamils. The current government has been censured by the global watchdogs and international media outlets for forced cremation of the Muslims who died because of covid. The international fury pressurised the government to take down the compulsory cremation policy. This plan to propose a ban on the burga should be seen in this context of the harsh treatment meted out the country's Muslim populace to understand the ulterior motive behind this ban.

The public health minister Weerasakeera claims that imposing a ban on the burga is necessary to safeguard the national interest. The government is trying to justify the legality of the ban by claiming that the Quran doesn't mandate women to wear a burga, it's a cultural practice

that has evolved recently, and therefore imposing a ban on its use will not be an infringement of freedom of religion but it is an outright infringement of freedom choice.

The government has held that this ban is necessary to tackle the growing fundamentalism in the country which provides a breeding ground for terrorism. Anti-Muslim sentiment surged in the country after the Easter bombings in 2019 which was carried out by ISIS and claimed the lives of about 258 people. The country's Muslim population since then has been at the receiving end of the angst and hatred, immediately after the attack, several Muslim shops and houses were gutted down. The punitive measures being taken against an entire community expose the bias and prejudice of the establishment against the Muslims.

by resorting to islamophobia, maligning Islam and Islamic practices is not an antidote for terrorism. People have to be treated with dignity. Deprivation of a safe political and social space is unjust and denies them the right to practice their religion and culture freely. The proposed ban legitimizes the unfounded hostility against burga-clad women and threatens to alienate the Muslim population and fan communal tensions. The Institutionalisation of religious intolerance does irreversible damage to a country's social fabric.

The ban is being viewed by many political analysts as an attempt to stoke communal tensions and to appease the majority Buddhists population of the country for electoral gains. The fact that the minister made this announcement from a temple makes his motive explicit. Establishing a link between Islam and terrorism is the oldest

trick in the bag to stir up xenophobia. The majority appeasement and violation of human rights poses a bigger threat to national security than a piece of clothing ever can.

The UNHCR has been critical of several European nations which have imposed a ban on wearing burgas in public spaces. Recently, Switzerland held a referendum in which 51% of the population voted in favour of outlawing the burqa in public places. UN Human Rights Council criticised the Swiss ban as "discriminatory" and "deeply regrettable".

The Office of the UN High Commissioner for Human Rights (OHCHR) said in a statement: "Vague justifications on how the wearing of face coverings would be a threat to safety, health or the rights of others cannot be considered a legitimate reason for such an invasive restriction of fundamental freedoms.'

It added that "in the w

a political publicity campaign with strong xenophobic undertones, Switzerland is joining the small number of countries where actively discriminating against Muslim women is now sanctioned by law", which is "deeply regrettable." Ironically, these democratic States have employed democratic methods to undermine individual rights The countries claim that the burqa hampers social integration and poses a threat to national security. Social integration should not mean forced assimilation, coercion to abandon religion and cultural practices will dampen this project of social integration that these democratic countries are pursuing.

Imposing a ban on wearing a burqa is bad as its compulsion. Penalizing people for their choice of clothes is an assault on human rights, it is condescending and reverses the progress made by the feminist movement.

As far as national security is concerned these states have done little to curb the gun violence which has surged rapidly in the past few years. Similar enthusiasm hasn't been shown to ban the acquisition and possession of firearms. The starkly different response towards terror attacks carried out by non-Muslims reveals blatant Islamophobia. Religion and ethnicity become irrelevant when the perpetrator of the mass shooting isn't a Muslim.

A total of 205 people were reported missing in the disaster, but so far only 74 bodies and 34 separate body parts have been recovered from the debris. Local authorities have declared

Attributing the blame for the flash flood solely or mainly to the ongoing climate crisis, however, risks obfuscating the failure of national and international agencies involved in construction projects in the region to act on the lessons learned from past disasters.

Less than 10 years ago, in 2013, flash floods left more than 5,700 people dead in Uttarakhand. Back then, experts quickly drew links between the disaster and the numerous hydropower construction projects in the high mountain valleys in Uttarakhand, arguing that these projects had exacerbated the intensity of the floods. "The disaster is a costly wake-up call," Peter Bosshard, the policy director at International Rivers, said in the aftermath of that deadly flood. "It shows that nature will strike back if we disregard the ecological limits of fragile regions like the Himalayas through reckless dam building and other infrastructure development.'

After the 2013 flash flood, the Supreme Court of India also mandated a national panel of experts to investigate the policy failures responsible for the disaster. After conducting an investigation, the panel called for hydropower development in this "disaster-prone" region to cease, arguing that it significantly amplifies the damages caused by natural disasters. It also asked for the installation of a flood warning system. Later, two Supreme Court justices noted that they "are very much concerned about the mushrooming of a large number of hydroelectric projects in Uttarakhand [...] The cumula-

tive impact of those project components like dams, tunnels, blasting, muck disposal, mining, deforestation, etc. on the ecosystem has yet to be scientifically examined."

Indian governmental agencies, however, refused to heed these warnings and continued their efforts to build dams on Himalayan rivers. Today, there are plans to build over two dozen medium and large hydropower projects in Uttarakhand alone. Dozens more are planned in other parts of the Indian Himalayas.

Environmentalists argue that the construction of the Tapovan Vishnugad hydroelectric project, one of the two damaged by the February 7 flash flood, likely increased the damage caused by the disaster. This dam was being built by India's National Thermal Power Corporation (NTPC), with the financial backing of the Asian Development Bank (ADB). Both the NTPC and ADB were undoubtedly aware of the warnings environmental groups and other agencies have been issuing about hydropower development in the area since at least 2013. Their apparent decision to ignore these warnings cost the lives of hundreds of people working on the project site on the fateful morning of February 7. Had it not been a Sunday, the number of fatalities on the site would have been significantly higher.

The second project affected by last month's flash flood, the Rishiganga Hydroelectric Project, was not merely damaged but completely swept away by the violent surge. And the disaster did not hit that construction without warning, either.

The Rishiganga project site was struck by a cloudburst, floods and landslides several times between 2008-2016. None of these incidents led to the project's suspension. In the summer of 2019, the residents of Raini village, world renowned for the role they played in the Chipko (Hug the Trees) movement of the 1970s, filed a public interest litigation (PIL) in the Uttarakhand High Court, calling on the district magistrate of Chamoli and the state government to review the environmental and social impact of the Rishiganga Hydroelectric Project site. The PIL also did not lead to any constructive action.

Those behind the hydropower projects in the Indian Himalayas long defended their efforts against criticism from environmentalists by arguing that these hydropower plants would reduce India's harmful emissions and the detrimental effects of climate change on the local population. Indeed, the construction of hydroelectric dams in the Himalayan river valleys is

part of a national plan to cut emissions linked to the energy sector. If and when these plans are fully realised, the disasterprone Indian Himalayas will have one dam every 32 kilometres.

But, as the fate of the Rishiganga project clearly demonstrated, building carbon offset projects in fragile ecologies is a dangerous and misguided endeavour. The Rishiganga project was approved under the Clean Development Mechanism (CDM) of the United Nations Framework Convention on Climate Change. It was anticipated that once fully operational, the project would deliver emission reductions equivalent to 49,585 metric tonnes of CO2 per annum. Those anticipations were washed away, quite literally, in part because of the damage that the project likely caused to the local ecology and geology.

The rapid expansion of hydropower projects in the region is not fuelled only by a desire to produce clean energy, either. The continuing "water war" between India and China is also a motivating factor behind the mushrooming of these projects in the Indian Himalayas. In November 2020, the Power Construction Corporation of China, a Chinese state-owned company, announced plans to develop a massive hydroelectric project, with production capacity of up to 60 gigawatts, on the lower reaches of the Yarlung Zangbo river. India responded by announcing plans to build a 10-gigawatt project on the Siang, the main tributary of the same river, to "offset the impact of the hydropower project by China"

Whether they are built solely to produce clean energy or in response to region-

al rivalries, the hydropower projects in the Indian Himalayas pose a significant threat to the region's ecology and the wellbeing of local communities. Despite repeated warnings from experts, local authorities and government agencies involved in these hydroelectric projects have failed to enact proper safeguards.

Even after last month's deadly flash flood, then Chief Minister of Uttarakhand Tirath Singh Rawat refused to acknowledge the role the massive hydropower projects in the region has played in bringing about this tragedy. Instead of committing to take the necessary precautions to prevent its repeat, the chief minister called the incident a "natural disaster" and reiterated his commitment to hydropower development. The central government, meanwhile, merely read out a statement announcing the number of dead and missing persons in parliament.

More than 550 hydroelectric projects are under construction or being planned throughout the Himalayas in China, India, Pakistan, Nepal and Bhutan. Without discounting the potential benefits of smallscale hydropower projects, national and international agencies active in the region should put in place ecological and social protection measures to ensure these projects do not cause more harm than good.

That such measures have not been put in place despite thousands of deaths in dozens of disasters that have struck the region over the past two decades, is a damning indictment of the failure of international and national environmental governance. International and multilateral agencies, such as the World Bank and the Asian Development Bank, and national energy corporations, must be held to account for these major lapses.

To avoid tragedies similar to the February 7 flash flood in the future, the question of climate action should be debated in tandem with the broader question of adopting an ecologically-sensitive model of development. To achieve this, we should stop attributing the blame for such disasters solely to "nature's fury", and start holding national and international agencies and policymakers accountable for their failings.

It has been observed that it is largely due to laxity in the observance of COVID appropriate behaviour by the people, especially in the crowded places," Bhalla underlined in the letter.

Keeping in view the fresh surge of cases and upcoming festivals, it will be important to ensure compliance of the guidelines and to strictly enforce COVID appropriate behaviour, such as wearing of face masks, hand hygiene and social distancing among people, he said.

"I would, therefore, urge you to take necessary measures for creating awareness among people to follow COVID appropriate behaviour and simultaneously take necessary action for its strict enforcement, so as to fully overcome the pandemic," he said, adding, Further, necessary orders/guidelines, issued by the respective Slate Governments/UT Administration in this regard, should be widely disseminated to the public and to the field functionaries for implementation.'

in each of these accredited departments. The DNB courses have been introduced in the district hospitals and new GMCs besides old GMCs and SKIMS in order to strengthen the institutions, decongest the GMCs and to address the shortage of specialists in the Union Territory, the spokesman said.

In March 2020, the District Hospital Gandhi Nagar Jammu became the first hospital in Union Territory to get six seats for DNB courses in the department of Medicine and Anesthesiology.

A total of 42 seats were granted to the institutions of Jammu and Kashmir and 21 candidates have already joined the various accredited streams, he said

Under the dynamic leadership and concerted efforts of the Financial Commissioner, Health and Medical Education Department, Atal Duloo and Mission Director, NHM, I&K, Choudhary Mohammed Yasin, eight district hospitals and all GMCs and SKIMS had applied for DNB courses to the NBE.

"A total 129 applications were submitted by the institutions, out of which 23 applications of old GMCs/SKIMS, five applications of new GMCs and two applications of District Hospitals have been approved by NBE and a total of 58 seats have been granted to the accredited departments consequent to the concerted efforts and hard work of teams of the institutions," the spokesman said.

Moreover, he said 28 more departments of District Hospitals and GMCs have been assessed by the NBE and their accreditation is awaited.

For meeting the Indian Public Health Standards (IPHS) norms in DNB districts, NHM J&K has got additional sanction of staff nurses for DNB institutions and currently 42 additional nurses have also been provided to each district hospital implementing DNB programme, the spokesman said.

He said additional beds along with the accessories and monitors have been provided to these hospitals by NHM.

The Centre has also approved establishment of eight-bedded Hybrid ICU in each DNB district hospital, the spokesman said. He said these measures are expected to drastically improve the health care services in the far-flung districts and would improve the services in the tertiary care institutions as well.

As per the records of Save the Children, a majority of minors are trafficked to Kashmir from Jharkhand. However, according to a study by National Crime Records Bureau (NCRB) in 2019, most incidents of children missing are reported from Madhya Pradesh, West Bengal, Delhi and Bihar.

The common causes of trafficking were forced marriages, child labour, domestic help and sexual exploitation, among others, mentioned the study.

As per the data of 2011 Census, India had 10.13 million child labourers, between the age of 5-14, with Uttar Pradesh, Bihar, Rajasthan, Maharashtra and Madhya Pradesh being the most affected states.

Kashmir receives many minors through consultancy firms who are employed as house

A majority of such helpers are employed in Srinagar, said Farooq Ahmad, a Srinagar CWC member. Minor girls exceed boys in the city, he added, and their number is only increasing.

Recently, Farooq came across two-three minors who were brought to the valley through consultancy agencies. One of them was a minor girl from West Bengal whose mother had died and her father, a drunkard, sold her to the agency which brought her to Kashmir, Farooq told Kashmir Observer.

Due to the pandemic, the minor girl was kept at a shelter in Srinagar for some time, before sent to the West Bengal CWC.

However, the condition in other districts of Kashmir is relatively better. According to Fahmeeda Maqbool, Chairperson CWC Ganderbal, the number of cases of non-Kashmiri minor helpers is quite less in her district.

On being asked how the CWC handles such cases. Magbool said that at first the date of birth is checked and if it does not comply with the Child Labour (Prohibition and Regulation) Act 1986, the child is taken under the care of CWC, and strict action is taken against the offender.

The Child Labour (Prohibition and Regulation) Act 1986 prohibits employing children below 14 and 15 years, but there is no procedure laid down in any law for deciding in which employment children are banned.

The Act was first amended in 2016, and then gain in 2017. The current Act prohibits th ployment of children below the age of 14, but they can work in family business/enterprises, only if they are non-hazardous. Advocate Shah Faisal, J&K director of Human

Observer that he comes across numerous cases of minors being held by people without their will. "There was this case of a child from West Bengal who wanted to go back home but the

Right Law Network (HRLN), told Kashmir

household where he was working didn't let him leave," Faisal said. "After I filed a complaint against the family to the Chief Magistrate, the child was brought immediately and proper action was taken

against the family.' Another case which the advocate recalled is of a 15-year-old Rohingya girl who was sold in Delhi at Rs 70,000 to a Kashmiri, who married

her soon after arriving in the valley. The girl's uncle contacted Faisal and a writ

petition was filed to rescue her. According to the advocate, the consultancy agencies which bring minors to Kashmir violate many norms. They provide a fake list, filled with fake numbers of parents of the minors, Faisal said. "While most of the agencies claim that the child does not have a birth certificate, they consider them above 18.'

Even the families hiring minor helpers justify themselves by saying that without their assistance the child would starve, he said.

"But money paid by the families is not paid to the minor but to their agents," asserted the advocate. "This is totally an inhuman act which should be tackled strongly."

Kashmir Sikh Body Demands Fresh Probe Into **Chattisinghpora Massacre**

SRINAGAR: All Party Sikh Coordination Committee (APSCC) Saturday, on the eve of the Chattisinghpora massacre anniversary, urged the government to conduct a fresh probe in the killings so that culprits are nabbed and justice is provided to the families of the victims.

In a statement, the chairman of APSCC Jagmohan Singh Raina urged the government to go for a fresh probe into the incident and allow the Justice Pandan Commission to further investigate the incident as Brackpura and ChattisinghPora cases are interlinked.

Raina in the statement said that even after the passing of 21 years the people of Jammu and Kashmir especially the Sikhs of the valley are waiting for justice and urged the state and central governments to nab the culprits.

He said that the Indian Government has blamed the militants for the massacre and also has claimed to have killed at least five of the men who carried out the brutal massacre. "But so far India is yet to present hard evidence backing up its claims," the Committee said in the statement.

The statement said that according to the police, nearly 20 militants carried out the massacre at Chattisinghpora and so far only



five have been caught and killed which later proved wrong.

"The killed persons which the police claimed to be 'militants' were actually innocent residents of Brakpora proved by judicial inquiry of Justice Pandan Commission," the statement added.

"Also their bodies were burnt and hastily buried in a nearby village. The drama created by the officials was fake and melodramatic that on their behalf they said that the militants were caught in a burning house during a gun battle and their bodies were charred beyond recognition," the statement

APSCC questioned whether the men killed on that day were actually involved in the Chattisingh-Pora killings or not. "So far the police have failed to produce any

hard evidence that they were involved - leaving many in Kashmir to question whether the security officials in the troubled region really knew who killed the men of Chattisinghpora.'

"So far the Committee made by the Government to find out the culprits, has failed to solve the mystery of killings of Sikhs in Kashmir. Now we urge the UT and the Central government to go for a fresh probe in the killings of Sikhs. If they fail to do so then, we will consider it as a huge injustice with the Sikhs of Kashmir."

After the massacre, the then CM Dr Farooq Abdullah publicly assured that the culprits will be soon arrested as they had some clue and assured all assistance. "But till date the promises made by the former CM have proven a hoax.'

Couple Arrested For Duping Man Of Rs 50 Lakh In Jammu

JAMMU: Crime Branch officials on Friday said that a couple was arrested for allegedly cheating a man and duping him of Rs 50 lakh under the garb of getting a franchise for opening a medical laboratory in Jammu.

According to the sources the crime branch Jammu arrested Harmohinder Singh, COO (Chief Operating Officer) SERA CUE Labs Pvt Ltd and his wife Gurpreet Kour in the duping case of Rs 50 lakh.

While divulging the details about the case, Crime Branch said that the accused were not cooperating in the investigation of the case and constantly evaded arrest by changing their locations for the last two years.

In a statement, Crime Branch said that during the investigation, it has been found that they were involved in duping and cheating many people on the same pretext for which six criminal cases stand registered against them in different states, including Crime Branch Jammu, Gurgaon, Mohali, Jalandhar Punjab, Alwar Rajasthan and Vikaspuri Delhi.

They said that a written complaint was lodged by the victim, Naman Singh, alleging therein that the accused couple visited the house of the complainant and persuaded and allured him for getting a franchise for open-



ing the lab under SERA brand at Jammu, the officials added.

"The accused couple further told the complainant that an amount of Rs 50 lakh has to be paid for appointing the complainant as franchise and opening medical laboratory under SERA Brand and an amount of Rs 35 lakh would be paid as franchise fee, which would be non-refundable and Rs 15 lakh security deposit, which would be refundable" they said.

The statement further mentioned that an agreement was executed between the company through them and the complainant, which has been duly registered by sub-registrar Jammu. That in pursuance of the said agreement, the complainant has paid an amount of Rs 50 lakh on different dates.

They were produced before the court of law and their police remand has been sought for further investigation. (CNS)

New Zealand Defeat Bangladesh By 8 Wickets In 1st ODI

DUNEDIN: New Zealand needed just over 21 overs Saturday to overtake Bangladesh's total of 131 and win the first of three one-day cricket internationals by eight wickets.

Bangladesh, recently out of managed isolation, were never comfortable in unfamiliar batting conditions at the University Oval and were bowled out by New Zealand in only 41.5 overs. Mahmudullah's 27 from 54 balls was its highest score.

After Martin Guptill crashed 38 runs from 19 balls with three fours and four sixes at the top of the order, New Zealand was always on target to win plenty of overs to spare.

Henry Nicholls made an unbeaten 49 in his 50th ODI to steer New Zealand to victory in the 22nd over, combining in a 65-run partnership for the second wicket with Devon Conway (27).

New Zealand won the toss and sent in Bangladesh in cool and overcast conditions. When Trent Boult produced a late out-swinger with the first ball of the match which surprised and beat Bangladesh captain Tamim Igbal, it was clear the tourists were in for a tough day.

"It was nice to get over the line and start the series with a win," Boult said.

"We kept them to a decent total and it was nice to chase it down with only a couple of wickets down."

Swing was short-lived but Bangladesh struggled to score freely on a pitch which was slow and holding and against a New Zealand attack which produced containing lines and lengths.

Bowling into the batsmen and pitching short of a length, the New Zealand bowlers — especially Boult who took 4-27 — cut down scoring options both square of the wicket and down the ground.

BCCI Releases IPL SOP: Bubble Tansfer For Indian And English Players, No Vaccination As Of Now

NEW DELHI: The cricketers who are part of the ongoing India versus England series, as well as the IPL, will not have to undergo mandatory seven-day hard quarantine as they will be transported from one bubble to another as per the Standard Operating Procedure (SOP) released on Saturday.

Also, the BCCI has made it clear that no individual associated with the IPL will be vaccinated as of now as the government of India has put a system in place which is currently being adhered to.

The SOP, which is in possession of PTI, states: "Players who

are coming from bubble created for India vs England series may directly join the franchise squad without serving mandatory guarantine period provided.

"After the conclusion of series, they directly move to team hotel either by bus or chartered flight...if travel arrangements are to the satisfaction of CMO, such players can directly enter team bubble without need to serve quarantine or undergo RT PCR tests," the SOP stated.

Similarly, for all franchises who are having prior camps in bio-secure bubbles, if their travel arrangements are satisfactory they will be entitled bubble-to-

However, if the CMO is not satisfied, then all those players need to undergo seven days of hard quarantine and return with three negative tests.

The SOP stated that at this point, the government has not specified anything on the vaccination of elite athletes.

"In India, the first group to get vaccinated is healthcare and frontline workers. The second group is persons above 60 years of age as of January 1, 2022 and person between 45 to 59 years with comorbid conditions. The government is vet to announce the schedule of vaccination of other groups of people including elite athletes.

3 Shooters, Including 2 From **Indian Pistol Team, Test Positive** For COVID-19 At ISSF World Cup

NEW DELHI: Three shooters, including two from the Indian pistol men's team, have tested positive for COVID-19, National Rifle Association of India (NRAI) sources said on the second competition day of the ISSF World Cup here on Saturday.

The shooters are currently self-isolating in their team hotel. Those who were sharing the rooms with the three shooters as well as their other teammates have also been isolated after undergoing COVID tests.

The results of the roommates and other team members, though, have returned negative.

A source said two among the three shooters are from the Indian contingent.

"The shooters have been sent into isolation as per protocols. Testing is being done on a daily basis and that's their results have come to light," a source close to the federation told PTI.

"Everything is being done as per the protocols laid down by the International Shooting Sport Federation (ISSF) and in consultation with its technical director.' another NRAI source said.

"The better news is that the results of the roommates and teammates have returned negative," he added.

In all, four shooters have already been afflicted by the dreaded virus since the teams started arriving for the tournament, which started on Friday at the Dr Karni Singh Shooting Range.

Countries have been allowed to field their MQS (Minimum Qualification Score) shooters in place of the ones ruled out from the main teams

owing to contracting the virus. The roommates of the three shooters will be allowed to take part in the tournament as their test results have returned negative. The name of the shooters have been withheld in line with protocols.

On Thursday, a top international shooter returned positive for COVID-19, following which he was sent to a hospital.

The shooter was first tested at the airport and then again on Thursday. He is asymptomatic and the shooter has never visited the range.

A total of 294 shooters from as many as 53 countries, including Korea, Singapore, USA, United Kingdom, Iran, Ukraine, France, Hungary, Italy, Thailand and Turkey. are participating in the tournament.

As per the ISSF guidelines, no spectator is allowed inside the range for the tournament that carries ranking points aiding in Tokyo Olympic qualifications.

PV Sindhu Falters At All England Badminton Semifinals

BIRMINGHAM: Reigning world champion P V Sindhu suffered yet another semifinal defeat at the prestigious All England Championships as she went down tamely in straight games to Pornpawee Chochuwong of Thailand in the women's singles in Birmingham on Saturday.

Sindhu, the Olympic silver medallist, couldn't match the pace, power and precision of her younger world number 11 rival Chochowong and lost 17-21 9-21 in a match that lasted 43 minutes.

The world no. 7 Indian had also lost at the semifinal at the 2018 edition as well Sindhu came into the semifinal

contest with an overwhelming 4-1 head-to-head lead over the 23-year-old Chochuwong, whom she had beaten at the HSBC BWF World Tour Finals in January.

But all that statistics didn't matter as Chochowong showed immaculate defence and played at a searing pace to outclass the Indian.

On Friday night, Sindhu, seeded fifth, had defeated Japan's third seed Akane Yamaguchi 16-21 21-16 21-19 in an intriguing quarterfinal match to make it to the last eight stage.

Sindhu had battled for an hour and 16 minutes to eke out her first win over world number five Yamaguchi in last four meetings.

"I am playing against her after quite a long time. I'm sure she would have trained very hard. The match was a good, tough long match I would say," she had said. Sindhu, who had reached the

finals at Swiss Open, played an aggressive game, matching Yamaguchi with her speed and retrieving skills but unforced errors allowed the Japanese to jump to a 11-6 lead, a deficit she couldn't erase as the Japanese pocketed the first game.

After an error-prone start to the second game, Sindhu moved to 6-2 with some superb shots. She then led 8-4 with the Japanese missing the lines twice. Sindhu got five game points and won the game easily. In the decider, Yamaguchi came

back to make it 15-15 and then grab the lead with another superb return at 18-17. Sindhu then made it 19-18

with a couple of points and then grabbed the match points with Yamaguchi going wide. The Japanese then hit the net as Sindhu won the match.

Why Sri Lanka Cricket Needs A System Overhaul To Stop Slide

COLOMBO: Once a dominant force in world cricket, Sri Lanka's slide internationally has opened debate in this island nation about whether democracy and a free hand in the administration of the sport is working.

Sri Lankans have long embraced cricket,

a colonial legacy, as their own. It's not only the country's most popular sport, but also a unifying factor. This week marked the 25th anniversary of Sri Lankan cricket's most celebrated

achievement — the World Cup triumph in 1996. But the memories of those peaks had fans and critics wondering how it all could have gone downhill so quickly. Since 2015, Sri Lanka has won just 19 and lost 31 of the 57 test matches it has contested.

Once the pace-setters in the one-day for-

brant from of the game in recent years, Sri Lanka's record is 19-47. After winning the World Cup final over Australia in 1996, Sri Lanka has twice been runner-up in the biggest ODI event. It also won the World Twenty20 title in 2014, five years after being runner-up, but hasn't qualified for the semifinals of any major tourna-

ment in the last six years. Though initial defeats were thought to be temporary in the wake of retirements to some of the biggest stars in the game, the prolonged failure has exposed a system that is no longer producing top-quality players.

Past international players and analysts blame administrators and a lopsided Sri Lanka Cricket constitution and a bloated voting system for stymieing the development of the game domestically.

Democracy "has not worked as far as Sri Lanka Cricket is concerned. There are many loopholes in the constitution which have been exploited by the administration and the clubs," cricket analysist Callistus Davy said.

Sri Lanka Cricket's constitution allows

executive positions in clubs at first-class level, increasing the potential for conflicts Davy said the government has fired the

for elected officials to simultaneously hold



elected cricket board and installed interim administrations eight times since 1999, citing corruption and mismanagement.

The running of the game has reverted to elections each time, though, because of International Cricket Council regulations which dictate democratic governance of the sport at national level.

Sri Lanka Cricket's next elections for a two-year term are set for May 20.

Analysts and past players say there are simply too many first-class clubs, which dilutes the talent pool of players but expands opportunities for officials and administrators.

There are 24 clubs playing in first-class competition in Sri Lanka, far higher than the numbers competing in larger countries such as India. Australia, which has a slightly bigger population than Sri Lanka, has six first-class teams in the men's domestic competition.

More teams also mean more votes. This year, 144 votes cast by regional associations and clubs (comprising four provincial associations, six other cricket associations such as the Defense Services Sports Board and the Sri Lanka University Sports Association, 22 district associations, 28 socalled controlling clubs and 22 affiliated clubs) will decide the office bearers for Sri Lanka Cricket.

Past and current players have for long called for the reduction of clubs to focus more on quality than quantity.

Arjuna Ranatunga, Sri Lanka's World Cupwinning captain, said the success had brought more money into the domestic game, and that made it more attractive for people to get into the administration of the sport.

"Before we won the World Cup, there was (not much) money involved . . . so many people were hesitant to come into the board," Ranatunga said.

"After '96, money started coming, that is where all these business people . . . some others with their groups got into cricket."

Ranatunga said the sports minister needed to intervene again and appoint leaders to govern the sport, and he was confident the ICC would be OK with an interim administration appointed solely for the propose of reforming domestic cricket.

"What has happened to cricket because of democracy? We have already gone down," he said.

Sri Lanka's former opening batsman and manager Brendon Kuruppu said officials were preoccupied with local infrastructure at the expense of closing the gap between domestic and international cricket.

"We have too many domestic clubs playing but we have a pool of about 75 players of international quality," Kuruppu said. "There have been proposals to bring down the clubs down to about 10 (but) it never happens with an elected body because they are looking for votes."

Muttiah Muralitharan, the all-time leading wicket taker in test cricket, is among the dozen people who've sought court intervention to reform cricket governance.

They have petitioned the Court of Appeal to appoint an independent committee to draft a new constitution, and have pointed to other countries where similar moves have worked to improve the strength of the domestic game and the national team. Sri Lanka Cricket secretary Mohan de

Silva rejected suggestions that the board encourages the high number of clubs to maintain voting blocks. "One cannot say democracy doesn't help

produce players," he said. He believes the lack of qualities coming through at school level "the cradle of Sri Lanka's cricket" is having a direct impact at senior level. De Silva said the board recognized that

there was a need to reduce the number of first-class clubs and overhaul the constitution. But, he added, the clubs needed to be encouraged or gently persuaded to take that path because a two-thirds majority is needed to make constitutional reforms.
