



22 new AIIMS including two in J&K have been approved under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) and six of them at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh are already functional.

Attention of litigants, lawyers and public in general is invited to Order No: 121 of 2021/RG dated 21.3.2021, whereby the Hon'ble Chief Justice Common High Court of J&K and Ladakh has been pleased to direct as under:-

"Entry of litigants and public into the Court Premises from the very outer gate shall continue to he prohibited. If however, any litigant on any reasonable ground is compelled to argue his case personally, he shall he allowed entry into the Court premises subject to the condition that he makes an application at least two days prior to the date of hearing through e-mail to the Registrar judicial/Presiding Officer of the Court disclosing such compelling reasons and seeking permission in that regard. If and when any such application is made by any litigant, the Registrar Judicial/Presiding Officer concerned shall consider the same and, if satisfied, may permit such litigant to enter into the Court Premises and inform the litigant of such order by return e-mail. A copy of such order shall also be sent by the Registrar Judicial/Presiding Officer concerned to the Incharge, Security at the main gate of the Court premises for necessary action."

In order to ensure strict compliance to the directions issued herein-above, the following guidelines are hereby issued for lawyers and litigants to be complied with in letter and spirit:-

All the latest SOPs of the Central and Union Territory of J&K Government regarding gathering at Public places 1. shall be followed in letter and spirit.


Ld. Advocates shall be allowed entry into the Court premises. However, the Advocates shall themselves restrict their entry in a manner that only those Advocates enter the Court building on a given day whose cases are listed on that date before any Court at District Court Complex Srinagar including Pantha-Chowk.

On entry in to the District Court Complex Srinagar, Advocates shall strictly maintain the social distancing SOFs 3. while waiting for hearing of their cases. They shall not huddle either in the well or in the gallery outside the Court Rooms. As and when their cases are finished they shall make an endeavour to leave the court premises at once.

Entry of the Advocates into the court rooms shall be regulated case wise. General entry in Court rooms shall continue to remain prohibited. Only such Advocates shall be allowed entry into a Court room as may be representing a party in a given case upto the maximum of two Advocates for each party. As and when a case is called/displayed on a Display Board fixed outside the Court Room, the appearing Advocates may enter the Court room and shall maintain a distance of six feet between themselves. In the gallery, outside the court rooms, at the most, Advocates representing the parties in other two following cases according to serial number in the cause list shall wait for their turn, again maintaining the requisite distance. As and when the advocates finish their case in the Court room and exit it, they shall immediately leave the gallery and not stand there.

5. Entry of Clerks and Agents of the Advocates into the Court rooms shall continue to be prohibited for the time being.

6. Entry of litigants and public into the court premises from the main gate shall continue to be prohibited. If, however, any litigant on any reasonable ground is compelled to argue his case personally, he shall be allowed subject to the condition that he makes an application at least two days either through his lawyer or on e-mail id: srinagar-dc@ jk.gov. in prior to the date of hearing to the concerned Court/Presiding Officer of the Court in which his case is pending disclosing such reasons and seeking permission in that regard. If and when any such application is made by any litigant, the Presiding Officer concerned shall consider the same and if satisfied, may permit such litigant to enter into the Court premises and inform die litigant of such order by return e-mail. A copy of such order shall also be sent by the Presiding Officer concerned to the Incharge, Security at the main gate of the Court premises to facilitate his entry on the given date. *EW DELHI - Senior separatist leader and chairman of the breakaway faction of Hurriyat Conference Syed Ali Shah Geelani today stayed away from the Pakistan Day for the first time since outbreak of militancy in Jammu and Kashmir. Geelani had adopted a tough posture on the eve of the Pakistan day criticising Islamabad for allowing running of the bus between Srinagar and Muzafarabad which according to him was a virtual acceptance of Line of Control as the permanent border between the two countries.

Pakistan had deputed the Deputy High Commissioner of its mission in Delhi Munawar Bahhti to placate Geelani and persuade him to attend the national day. After failing to get any positive response from him, Pakistan High Commissioner Aziz Ahmed Khan met Geelani this morning but this also did not move the pro-Pakistan leader.

Ansarullah: There's Nothing New In Riyadh's 'Peace Initiative'

e, however, said Ansarullah would continue to hold talks with Riyadh, Muscat and Washington to end the Saudiimposed war.

Riyadh has presented a 'peace initiative' which would include a nationwide ceasefire under the supervision of the UN and reopening of air and sea links.

The initiative includes reopening of Sana'a airport, and free passage for fuel and food imports through the Hudaydah port, both of which are controlled by Ansarullah.

Saudi Foreign Minister Faisal bin Farhan Al Saud said the initiative would take effect "as soon as the Houthis agree to it."

Downplaying the offer, the movement has demanded lifting of air and sea blockade, which has contributed to the world's worst humanitarian crisis in Yemen, as a main pre-condition for any deal.

Saudi Arabia and its regional allies have been in a bloody war on Yemen since 2015, using weapons supplied by the West, primarily to restore the regime of Abd Rabbuh Mansur Hadi, a move fiercely resisted by Ansarullah.

In December last year, the United Nations put the death toll in the Saudi-imposed war at 233,000, terming it "unfortunate and unacceptable.

A large number of hospitals and residential property have been destroyed in the Saudi bombardment, which has further aggravated the situation in the wake of the covid-19 pandemic.

While Saudi Arabia and its regional allies have been spearheading the war, the Western regimes have been complicit for providing weapons to them and failing to condemn their brutal

aggression.

Although the new US administration announced the end of Washington's support to the coalition, the principal US policy remains unchanged, according to Abdulsalam

"It is deplorable for America to chant the slogan of human rights and express concern over the worsening humanitarian conditions in Yemen as a result of the [Saudi-led] aggression and siege, and then make that (humanitarian issues) subject to military and political bargaining," he wrote on

his Twitter page recently. Last week, a member of Yemen's Supreme Political Council. Mohammed Ali al-Houthi, emphasized that there will be no peace in the Arab country unless the Saudi-led coalition halts attacks, lifts the crippling siege and ends the military occupation.

"We call on the US, Britain, Saudi Arabia, and the United Arab Emirates and their allies for holding a comprehensive ceasefire throughout the Republic of Yemen and remove the current blockade," he tweeted.

He also urged the realease of "all the 14 detained ships within the next forty-eight hours" as the first step to remove the current blockade.

COLORADO SHOOTING Gunman Kills 10 At US Supermarket

A t least 10 people have been killed, including a police of-ficer, in a shooting at a supermarket in the US city of Boulder, Colorado less than a week after eight people were shot dead in the US city of Atlanta.

Police arrested a suspect but did not reveal his name or any details about the shooting at an evening news conference.

Investigators had just begun sorting through evidence and witness interviews and did not have details on a motive for the shooting, said Boulder County District Attorney Michael Dougherty, adding that because families were still being notified, most of the victims' names have not been released.

"This is a tragedy and a nightmare for Boulder County, and in response, we have cooperation

and assistance from local, state and federal authorities," he added. Boulder Police chief Maris Herold later said officer Eric Talley, 51, who had arrived at the scene first, had been killed in the shooting.

The officer's father, Homer Talley, told local network KUSA it "didn't surprise me he was the first one there.'

He added the younger Talley "loved his family more than anything."

The shooting occurred at about 3pm local time (21:00 GMT) at a King Soopers supermarket in the Table Mesa area of Boulder, a city at the eastern foot of the Rockies about 45 kilometres (28 miles) northwest of Denver.

Authorities said the suspect was receiving medical treatment and there was no further threat to the public. Video footage from the scene broadcast earlier by television stations showed a shirtless, bearded man in boxer shorts being led away from the shop in handcuffs, before he was placed on a stretcher and loaded into an ambulance. The man in custody appeared to have a bloody leg and was limping as he walked. Commander Kerry

Donald Trump plans to return to social media soon, using "his own platform" after being banned from Twitter and other outlets, a former advisor said on Sunday.

"I do think that we're going to see president Trump returning to social media in probably about two or three months," Jason Miller told Fox News.

"It's going to completely redefine the game, and everybody is going to be waiting and watching to see what exactly president Trump does, but it will be his own platform," said Miller, who held senior posts in both of Trump's presidential campaigns.

Trump's provocative use of social media was a defining feature of his presidency, as he drew 88 million followers to Twitter and often used tweets to slam his critics or to announce personnel changes or significant policy shifts.

But Twitter permanently suspended his @realDonaldTrump account after he used it to encourage people to take part in the rally that turned into the violent storming of the US Capitol on January 6.

Trump was also banned, temporarily or permanently, by other major platforms including Facebook, Instagram, YouTube and Snapchat.

Since leaving Washington and returning to his Mar-a-Lago resort home in Florida, the former president has kept a relatively low profile, largely relegated to issuing occasional news releases

Budgam Village's Middle School Has Just One **Teacher For 38 Students**

SRINAGAR: The Locals of Arath village of Central Kashmir's Budgam, District on Tuesday rued that the only government middle school in the village continues to operate with just one teacher for 38 students.

"It is very difficult for a single teacher to engage all classes simultaneously under a single roof. It is injustice with the students who come to the school in the hope of learning. How can the said teacher concentrate properly on all students," the locals asked?

The locals said that they have conveyed the problem to the concerned authorities several times, but all in vain. "No other teacher has joined the school yet," they complained.

Meanwhile, ZEO Soibugh said that they had already recommended the transfer of teachers from the institutions possessing more than required staff to the institutions having dearth of staff members. As per ZEO the transfer order has been kept in abeyance by authorities. He further said there are at least five teachers working as two schools have been clubbed and are working from the same

institution. "I have told the said

headmaster to direct the teachers of another institution which has been clubbed in to take classes of his institution too, adding that he will still look into matter." Severe staff crunch has affected the educational activities badly in the school. (KDC)



ess than a month after India and Pakistan dramatically re-affirmed the 2003 ceasefire agreement along the Line of Control. the neighbours on Tuesday began discussing their water issues, signalling a return to bilateral dialogue following a gap of many years. The talks assume more importance in view of the situation of the last two years during which the relations between the two countries plunged to their lowest. Pakistan had drastically downgraded its relationship with India following the latter's withdrawal of Kashmir's autonomy in August 2019. Given the consequent state of their relationship, it had appeared unlikely that a dialogue between them could resume anytime soon. But the unthinkable has happened: first with reiteration of the ceasefire agreement and now with resumption of dialogue. In between, the neighbours also restored their sporting ties. Pakistan's lone skeet shooter Usman Chand recently got a visa to travel to India to compete in the New Delhi World Cup.

Nobody could have imagined things will move so fast. It appears now a matter of time before the two countries resume a formal dialogue on a broad range of issues including on the issue of Kashmir. Earlier, Islamabad had insisted that there will be no talks with New Delhi untill latter reverses the decision to repeal Kashmir's autonomy. Now this condition seems to have been given up just as New Delhi seems to have overlooked its demand that for the dialogue to resume, Pakistan will have to end cross-border terrorism. Where the anticipated new engagement would lead, only time will tell. Indo-Pak engagement has traditionally been tough to sustain. Even before things could settle down and move towards resolution of the issues, the dialogue is cut short either by a terrorist attack or due to some political reason. This has happened so often that it is difficult to attach any hope to a fresh peace process.

But with statesmanship and the political will, the leaders of the two countries could make it happen this time. On Pakistan side, it seems both the civilian government and the Army are on the same page as far as talks with India. And in New Delhi, we have an absolute majority government in power which has shown it is willing to depart from the status quo to fulfill its political goals. A similar approach to resolution of the issues with Pakistan has the potential to put the subcontinent on the road to peace. Here's hoping that the dialogue this time not only sustains but reaches it logical conclusion.

Supply Of Unhygienic Water From Doodh Ganga

OODH GANGA, a small river which originates from the glaciers of Pir Panjaal mountains is the drinking water source for a huge population in Srinagar and some parts of Budgam. I have constantly been highlighting the pitiful and pathetic condition of Doodh Ganga as a large number of people are made to drink unhygienic water for the last many years. In addition to writing columns or issuing press statements. I have been highlighting this problem by posting photos and videos of Doodh Ganga on social media. I every now and then appeal to the Government and people to preserve and protect this water body.

We can't only blame the Public Health Engineering (PHE) department (Jal Shakti) which supplies the unhygienic water, but instead J&K Pollution Control Board (PCB) and District Administration Budgam are supposed to be blamed for this messy state of affairs. PCB as well as District Administration Budgam have failed to make sure people get clean drinking water. Around the year 2018, I even moved a petition before the erstwhile J&K State Human Rights Commission (SHRC). I urged upon the commission to intervene as supply of unclean drinking water to people was a violation of basic human rights. SHRC took the issue very seriously but when the case reached its logical conclusion, the SHRC was shut down in view of abrogation of article 370. In September last y the Right to Information (RTI) Act to seek information from the J&K Pollution Control Board (PCB) about various studies taken up regarding Water Pollution caused by fecal matter and liquid waste getting drained into Doodh Ganga river. I also asked PCB the exact number of lavatories and drains going into the river from Branwar to Barzulla via Chadoora, Wathoora areas of District Budgam and action taken vis a vis water pollution in Doodh Ganga by way of dumping of solid and liquid waste? Through my RTI application I also sought similar details pertaining to river Jhelum from Khanabal to Baramulla. The in-charge officer water laboratory Srinagar operating under the J&K Pollution Control Board (PCB) in his response dated 17.9.2020 seemed ignorant about the water pollution in Doodh Ganga which is one of the major drinking water source for Srinagar uptown areas like Hyderpora, Rawalpora, Barzulla, Solina, Jawahar Nagar, Batmaloo and many areas. The reply from PCB reply made it clear that no study had been undertaken by Water lab PCB Srinagar. To another query about the study undertaken by PCB vis a vis fecal matter and liquid waste being drained into River Jhelum from Khanabal to Baramulla, the response was cryptic. The reply reads as : "An exercise has been under-

taken by J&K PCB with allied departments of respective district administration to locate the toilets and drains that empty into River Jhelum from Khanabal to Baramulla. A survey to river Jhelum was conducted in the year 2019 to find out the point source and diffuse sources of pollution. The observations made in the study were submitted to the High Court in a case titled Javid Ahmad Zargar VS State and others based on the report submitted by PCB many toilets have been demolished by the concerned agency,"

This study was never made public by PCB through its website as the information falls under section 4 of RTI Act 2005. In January this year, I sought details from Deputy Commissioner office Budgam about meetings held on cleaning of Doodh Ganga from September 1st to December 31st in response to J&K High Court's direction on the pathetic condition of Doodh Ganga and supply of unclean drinking water ? I asked copies of the minutes of these meetings as well. Till date DC office Budgam has not supplied any information to me. I am now filing an appeal against PIO DC office Budgam.

Clean water and SDG

Clean water and sanitation is one of the important constituents of 17 Sustainable Development Goals (SDGs). This figures at serial 6 of SDGs. In-fact, access to safe water and sanitation are included in human rights, as recognized in 2010 by the UN General Assembly

onwards the matter could not be listed for several months. On October 30th 2019 J&K High Court issued notice to Government especially to Divisional Commissioner Kashmir and Deputy Commissioner Budgam. As mentioned above I sought updates from DC Budgam on the issue under RTI on January 18th 2021 and meetings held in this regard. Till date no response has been provided. Even the Govt has not started river clean up drive. The matter is now listed on April 4th 2021.

The solid and liquid waste continues to pollute Doodh Ganga. Most of the pollution takes place in Chadoora where large quantities of liquid waste gets drained into Doodh Ganga. Unfortunately, the same water is lifted by PHE (Jal Shakti) at Karlpora water supply plant which is located 6 kms down stream. A garbage dump has been created by Srinagar Municipal Corporation (SMC) near the banks of Doodh Ganga at Bagh e Mehtab area near Railway bridge. This is a public place / bus stop on Srinagar-Chadoora road. I tried my best to bring the issue into notice of Govt but authorities don't even want to listen. District Administration Srinagar assured me several times that the garbage dump at Bagh e Mehtab would be shifted and a public park or open gym would be set up at the site, but the promises were never fulfilled till date?

Conclusion

Is the Pollution Control oard's (PCB's) role only limited to inspect small scale industrial units ? If PCB can't check liquid and solid waste entering into Doodh Ganga or any other drinking water source, who else will do this iob? District Administration Budgam could also have utilized funds available under Swachh Bharat Mission Gramin for solid liquid waste management but not even a single penny has been utilized in Budgam. This was also revealed under RTI by District Panchayat Officer (DPO) Budgam recently. Under SBM Gramin the money is very much available for rural waste management but due to official negligence the work hasn't been executed on ground zero during the last more than 6 years. Let us hope that the High Court issues some meaningful orders in the coming months so that the Govt is made to act and pollution in Doodh Ganga gets reduced so that people are supplied safe drinking water. This is my message on this World Water Day.

The PM issues a warning

n Wednesday, Prime Minister Narendra Modi held a virtual meeting with chief ministers to urgently deal what he called the "emerging second peak" of Covid-19 in the country. He discussed a worrying spike in infections in several states and said that "quick and decisive steps" are needed to combat another pan-Indian outbreak. A few hours later, when the day's new Covid-19 cases were tallied from all states, the total came to 35,836 new infections — the highest number of single-day cases in the country in more than 100 days. In India's worst-hit state, Maharashtra, Wednesday's case toll (23,179) was the highest single-day rise since September 17, 2020 — that was a time when the country's first Covid-19 wave was raging at its peak. Like in the first wave, the western state is again the first major hot spot region, and if things don't change soon, it will be the first of many

Coaxed into a sense of false security due to six months of declining cases, and a high degree of fatigue (for both people as well as governments) against the disease, there is an alarming degree of laxity at all levels. Testing numbers have been steadily dropping; the concept of contact-tracing has been reduced to just getting immediate family members of positive cases tested; and mask etiquette, as well as enforcement of social distancing norms, are near non-existent even in metros, leave alone smaller cities or rural areas.

It is now nearly a year since a nationwide lockdown was introduced on March 24, 2020 to fight the disease. Neither the economy nor citizens can cope with such strict measures again. The best way to fight the second wave, apart from strictly instituting Covid-19 management protocols, is to use the one advantage that the country did not have a year ago — vaccines

I can't blame only the locals as the Govt has provided no alternative for collection and disposal of solid waste in rural areas. In spite of the fact that Swachh Bharat Mission (SBM-Gramin) has a well defined programme for rural waste management under Solid Liquid Resource Management (SLRM) but District Administration Budgam has failed to implement this scheme on ground. During Back to Village programmes, this issue was highlighted by me before the visiting officer Mr Sarmad Hafiz IAS, but the District Administration could not execute the plan. The photos of the Back-to-Village continue to be highlighted on the official website of District Budgam but who will tell the visitors surfing this website that all the promises made during this meeting were never fulfilled.

mittee on Home Affairs has recommended that the Home Ministry advise states and union territories to conduct sensitization and briefings of ground-level officials dealing with the PWDV Act so that women facing domestic violence could be better equipped to access justice. The

In the Throes of **Overlooked Parvo Virus**

Government refuses to even acknowledge this viral epidemic. While they were quick to strangle and burn millions of birds during the Bird Flu epidemic, because they thought it would affect humans, they have completely ignored the Parvo Virus one – probably because they think it will not affect humans.

ndia is in the throes of a terrible viral epidemic. Much worse than the Bird Flu, much worse than swine flu. It has 91% mortality and, while it is mainly dogs, it can spread to cats of all kinds as well and God knows which other animals. The killer is the deadly Canine Parvo Virus (CPV).

Outbreaks have been reported from all over India. Thousands of pups have died. My own People For Animals shelters have several thousand cases admitted. Shelters from Mangalore to Siliguri have shut down and refused to admit normal accident cases as they are full of parvo afflicted, dying, animals. Each shelter is a war zone with makeshift drip stands, or volunteers patiently holding IV fluids while they go slowly into small dying bodies.

Government refuses to even acknowledge this viral epidemic. While they were quick to strangle and burn millions of birds during the Bird Flu epidemic, because they thought it would affect humans, they have completely ignored the Parvo Virus one - probably because they think it will not affect humans.

So, government refuses to give vaccines to poor people and to street animals, and government hospitals do not treat parvo cases because they say they do not have the budget for drips and antibiotics. 80% of all Indian vets are employed by the government and they sit idly in government clinics which open at 10 am and close at 2 pm - while lakhs of animals fall dead, untreated. If you ask the same vets to go and strangle chickens they will happily do so.

There are two prominent strains of the canine parvovirus (CPV-2a and CPV-2b) from the genus family of Parvoviridae. It spreads through infected faeces, vomit. blood, touch, surfaces, clothing etc. Shelters, kennels, clinics, public parks are prime locations where the virus lurks. It's favourite victim is the young pup, but unvaccinated dogs in general are vulnerable. Undetected or diagnosed at a later stage, it is almost always fatal within 48 - 72 hours.

There is a silent massacre going on, but government municipalities, health authorities, animal husbandry departments in every state refuse to respond with either short or long term measures. In one district only - Uttar Dinajpur - one parvo vaccination camp was held after the government dispensary received 342 cases in a week with 100% mortality, as there were no drip stands or IV fluids available ! Across the country veterinary government clinics are unable to handle even this basic treatment, for lack of supplies, infrastructure, manpower and, sometimes, even basic facilities such as water supply and electricity.

Dissemination of mass public messages, to spread awareness about the disease, should have been undertaken. While we have any amount of information – and a lot of it is total rubbish - being spread about bird flu, the government is completely silent about this deadly virus – which may also prove to be zoonotic in time.

There is absolutely no Government Policy in any State for mandatory vaccination of all dogs for CPV. In contrast, there exists a mandate for vaccination of dogs against rabies under the Animal Birth Control (Dogs) Rules, 2001 promulgated under The Prevention of Cruelty to Animals Act, 1960. Protocols under the ABC Program make it mandatory to vaccinate sterilized dogs against rabies before releasing them. This is also the



reason as to why the rabies vaccine for both human and animal consumption is subsidized by the government. The CPV vaccine is 14 times more costly than the anti rabies vaccine, but both the diseases are deadly. Inspite of the epidemic that is raging throughout India, CPV is a disease that has been omitted from Government budgets entirely.

But it has lethal ramifications on wildlife conservation. The mass die-off of lions, at Serengeti National Park in Tanzania in 1994, was attributed to CPV and its equally potent cousin, the Canine Distemper Virus (CDV). In 2018, Asiatic Lions at Gir National Park were afflicted by both CPV and CDV, leading to the loss of irreplaceable Protected Schedule I Animals, and shrinking their gene pool even more. Dwindling habitats and the blurring of boundaries, between urban areas and forest land, have brought wild animals in increasing proximity to domesticated and free ranging dog populations.

The National Tiger Conservation Authority has asked for a sterilization program for dogs around tiger reserves. It states the creation of 'immunization buffers' in buffer zones of the reserve, and encompasses vaccination against canine distemper along with rabies. Canine Parvo Virus is not included within its ambit. But even their original demand has not been complied with.

The vaccines are effective and immunoglobulin serum (given to CPV afflicted animals at the time of treatment) can help fight the virus. But vaccination interventions have their own set of challenges. Maintenance of cold chain supply and storage, especially during transportation, is always inadequate. The parvo virus mutates regularly, and vaccine makers often cheat in supplying old strains. So the vaccination is a mismatch between outbreak strain of CPV and the vaccine strain.

Viral strains used in vaccines are not disclosed by manufacturers. The relevance of a comprehensive vaccination policy must be based on adequately addressing these challenges.

Efforts to vaccinate street and community dogs in India are largely dependent upon the goodwill of volunteers feeding animals or on non-profit animal welfare organizations. Vaccination drives against CPV, funded by the Government (Veterinary Department/ Animal Husbandry Department/ Municipal Administration) would pave the way for ensuring a healthy dog population.

A compelling case may be derived from the One Health Approach - a policy that recognises the interconnectedness between public health, animal health, and ecosystem health of our shared environment. The approach has been endorsed by the One Health Platform Initiative, represented by leading experts from Who Health Organization (WHO), United Nations Food and Agricultural Organization (UNFAO), United States Centre For Disease Control & Prevention (CDC) and World Organization for Animal Welfare (OIE).

The time has come when the world is going to lurch from one viral epidemic to another. It is time for the government to plan sensibly on how it is going to deal with each virus. In the meantime, can we please have some state dealing with this one ?

Many fabulous attributes



Your hunger affects your monetary decisions, says new study

igher levels of the stomach-derived hormone ghrelin, which stimulates appetite, predict a greater preference for smaller immediate monetary rewards over larger delayed financial rewards, a new study finds.

The study results will be presented at ENDO 2021, the Endocrine Society's annual meeting.

This research presents novel evidence in humans that ghrelin, the so-called "hunger hormone," affects monetary decision making

said co-investigator Franziska Plessow, PhD, assistant professor of medicine at Massachusetts General Hospital and Harvard Medical School, Boston. She said recent research findings in rodents suggested that ghrelin may play a part in impulsive choices and behaviours.

"Our results indicate that ghrelin might play a broader role than previously acknowledged in human reward-related behaviour and decision making, such as monetary choices." Plessow said. "This will hopefully inspire

future research into its role in food-independent human perception and behaviour."

Ghrelin signals the brain for the need to eat and may modulate brain pathways that control reward processing. Levels of ghrelin fluctuate throughout the day, depending on food intake and individual metabolism.

This study included 84 female participants ages 10 to 22 years: 50 with a lowweight eating disorder, such as anorexia nervosa, and 34 healthy control participants. Plessow's research team

tested blood levels of total ghrelin before and after a standardized meal that was the same for all participants, who had fasted beforehand. After the meal, participants took a test of hypothetical financial decisions, called the delay discounting task. They were asked to make a series of choices to indicate their preference for a smaller immediate monetary reward or a larger delayed amount of money, for instance, USD 20 today or USD 80 in 14 days.

Healthy girls and young women with higher ghrelin

levels were more likely to choose the immediate but smaller monetary reward rather than waiting for a larger amount of money, the researchers reported. This preference indicates more impulsive choices, Plessow said. The relationship between

ghrelin level and monetary choices was absent in agematched participants with a low-weight eating disorder. People with this eating disorder are known to have ghrelin resistance, and Plessow said their finding might be another indicator of a disconnect be-

Strong coffee before exercise ups fat-burning in men: Study

Caffeine-about 3 milligrams per kilogram (mg/kg), the equivalent of a strong coffee-ingested half an hour before aerobic exercise significantly increases the rate of fat-burning, suggests a new study. The study, published in Jour-

nal of the International Society of Sports Nutrition, also found that if the exercise is performed in the afternoon, the effects of the caffeine are more marked than in the morning.

"The results of our study showed that acute caffeine ingestion 30 minutes before performing

an aerobic exercise test increased maximum fat oxidation during exercise regardless of the time of day," said lead researcher Francisco Jose Amaro-Gahete from the University of Granada in Spain.

For the study, the researchers aimed to determine whether caffeine-one of the most commonlyconsumed ergogenic substances in the world to improve sports performance-actually does increase oxidation or "burning" of fat during exercise.

A group of men with a mean age of 32 participated in the research, completing an exercise test four times at seven-day intervals. Subjects ingested 3 mg/kg of caffeine or a placebo at 8 am and 5 pm (each subject completed the tests in all four conditions in a random order).

The conditions prior to each exercise test (hours elapsed since last meal, physical exercise, or consumption of stimulant substances) were strictly standardized, and fat oxidation during exercise was calculated accordingly.

In summary, the findings of this study suggest that the combination of acute caffeine intake and aerobic exercise performed at moderate intensity in the afternoon provides the optimal scenario for people seeking to increase fat-burning during physical exercise

Business Activity In India Dips As Second Čovid Wave Impacts Mobility: Nomura

NEW DELHI: Business activity in India has declined as the second wave of the pandemic, which is spreading beyond Maharashtra, has started to impact mobility levels, according to Nomura. The Nomura India Business Resumption Index (NIBRI) dipped to 95.1 for the week ended March 21, from 95.4 in the prior week, the Japanese brokerage said on Monday.

"The pandemic's second wave is now spreading to states outside Maharashtra and is starting to impact mobility. This second wave is likely to result in a shortterm growth bump to what is otherwise an uptrend," it said. As of mid-March, Google workplace and retail and recreation mobility fell by 3.7 percentage points on a week-on-week basis and 0.3 percentage points, respectively, while the more updated Apple driving index fell by 2.6 percentage points.

However, power demand improved by 2.6 per cent week-onweek after a 0.6 per cent decline the prior week, while the labour participation rate inched up to 40.6 per cent from 39.5 per cent. The knock-on effect of the second wave on mobility suggests a likely sequential dip in contact-based services and a near-term delay of normalisation.

However, the brokerage said, it expects the impact to be "more transitory and muted" (than in Q2 2020), as factory operations remain uninterrupted; consumers and businesses have adapted to the new normal with the latter overhauling their supply and sales chains to become more resilient. Besides, medium-term tailwinds like vaccinations, global growth, and continued easy financial conditions will support real GDP growth of 13.5 per cent in FY22, up from a contraction of 7.4 per cent in FY21, Nomura said.

280 Companies Declared **Bankrupt** Amid Pandemic

NEW DELHI: National Company Law Tribunals (NCLT) across the country admitted a total of 283 companies into insolvency amid the pandemic after the announcement of the nationwide lockdown last year.

In a written reply to the Lok Sabha, the Minister of State for Corporate Affairs, Anurag Thakur, also said that during the period of April 1, 2020 and December 31, 2020, a total of 76 corporate insolvency resolution processes (CIRP) ended in resolution, 128 CIRPs were closed due to withdrawal or appeal or settlement and 189 com-

panies went into liquidation. Further, the government temporarily suspended the initiation of CIRP under Section 7, 9 and 10 of the Code for a period of six months

ing one year from March 25, 2020.

The benefit of the suspension is applicable to all those defaults of the corporate debtor that occur from March 25, 2020 and till the end of period of suspension.

Such defaults arising from March 25, 2020 and till completion of suspension period will remain as 'non rest' for the purpose of initiation of CIRP under the code as permanent carve out.

The 283 bankruptcies declared the pandemic pertain to defaults made before March 25, 2020.

> **India Files Appeal Against Cairn Arbitration Award**

NEW DELHI: India is believed to have challenged in a court in The Hague an arbitration tribunal verdict that overturned its demand for Rs 10.247 crore in back taxes from Cairn Energy Plc-the second time in three months that it has refused to accept an international award against retrospective tax. The appeal was filed on Monday, a source with knowledge of the matter said. The Finance Ministry spokesperson did not immediately respond to an e-mail sent for comments. The appeal against a threemember tribunal at the Permanent Court of Arbitration at The Hague invalidating India's Rs 10,247 crore tax claim on Cairn Energy and ordering the government to return the value of shares it had sold, dividends seized and tax refunds withheld, comes weeks before UK Prime Minister Boris Johnson's visit to India. The British Prime Minister is widely expected to broach India honouring international arbitration awards during his April 26 visit, another source said. In December, the government had challenged in a Singapore court an international arbitration tribunal verdict that overturned its demand for Rs 22.100 crore in back taxes from Vodafone Group Plc.

No Compound, Penal **Interest Be Charged From Borrowers During Loan Moratorium Period: SC**

NEW DELHI: In a relief to borrowers, the Supreme Court Tuesday directed that no compound or penal interest be charged during the six-month loan moratorium period announced last year amid the COVID-19 pandemic and the amount already charged shall be refunded, credited or adjusted. The apex court refused to inter-

fere with the Centre's and the Reserve Bank of India (RBI's) decision to not extend the loan moratorium bevond August 31 last year, saying it is a policy decision.

A bench headed by Justice Ashok Bhushan said that the top court cannot do judicial review of the Centre's financial policy decision unless it is malafide and arbitrary. The apex court said it cannot

interfere with the government's decision to fix priorities for relief during the pandemic which has affected all across the country and the government has been under severe financial constraints.

The bench said this in its verdict on a batch of pleas filed by various trade associations, including from real estate and power sectors, seeking extension of loan moratorium and other reliefs in view of the pandemic.

The RBI had on March 27 last year issued the circular which allowed lending institutions to grant a moratorium on payment of instalments of term loans falling due between March 1, 2020 and May 31, 2020, due to the pandemic. Later, the moratorium was extended till August 31 last year.

In its verdict, the top court said that from various steps taken by the government, it cannot be said that the Centre and the RBI have not con-

sidered the relief for the borrowers. The bench said it cannot strike down a policy decision merely at the behest of petitioners on grounds that the other view is possible and the other decision could be more beneficial.

While refusing to go into the financial policy decision taken by the government, the bench said it is not open for the court to embark upon judicial review of policy decision

merely at the behest of petitioners. It said that complete waiver of interest is not possible as it will have huge financial implications. The apex court had reserved its judgement on the batch of pleas on December 17 last year.

The Centre had earlier submitted before the top court that if it were to consider waiving interest on all the loans and advances to



all categories of borrowers for the six-month moratorium period announced by RBI, then the amount foregone would be more than Rs 6 lakh crore.

If the banks were to bear this burden, then it would necessarily wipe out a substantial and a major part of their net worth, rendering most of the lenders unviable and raising a very serious question mark over their very survival, it had said.

The government had said this was a main reason as to why waiver of interest was not even contemplated and only payment of instalments was deferred.

Giving an illustration, it had said that in case of State Bank of India alone, waiver of six months' interest would completely wipe out over half of the bank's net worth which has accumulated over nearly 65 years of its existence.

It had pointed out the sectorspecific relief measures taken by the government for the small and mid-sized business/MSMEs including from sectors such as restaurants and hotels.

The Centre has promulgated emergency credit-linked guarantee scheme (ECLGS) of Rs 3 lakh crore providing additional credit at lower rate of interest, with 100 per cent government guarantee and no fresh collateral, it had said.

The scheme has been extended with higher financial limits to twenty seven COVID-19 impacted sectors including restaurant and hotel sectors, it had said.

Adani Green Energy Shares Hit Upper Circuit After The **Company Adds Two Renewable Energy Projects To Its Kitty**

NEW DELHI: Adani Green Energy shares have resumed their upward journey after the company added two new renewable energy projects to its kitty. The two projects together add 350-megawatt to the company's power generation capacity, taking the total capacity to 15,165 megawatts.

Shares of Adani Green Energy were locked in the upper circuit at 1,252 per share, gaining 59.60 over the previous closing price. This translates to a gain of 5%.

Upper circuit refers to the maximum price that a stock is allowed to move upward in a day.

Adani Green Energy's shares have jumped over 67% since October, 2020. While this rally is impressive, it pales in comparison to the steep 700% jump over the last one year.

In the same time, the benchmark Nifty50 index rose by a mere 93%.

Adani Green Energy has added a total of 350-megawatt renewable energy capacity recently. The first one was due to the acquisition of 100% stake in Toronto-based Sky-Power Global's 50-megawatt solar power project.

Apart from this, the company also won a 300-megawatt wind

power project from Solar Energy Corporation of India (SECI). The project term is 25 years and the price has been fixed at 2.77 per kilo-watt hour.

Thanks to the addition of 350-megawatt projects, Adani Green Energy's total renewable energy capacity now stands at 15,165 megawatts. Of this, projects of 3,395-megawatt capacity are already operational while the remaining 11,770-megawatt projects are under implementation, according to the company's press release. According to a report by Mac-

quarie Research, Adani Green Energy has more than tripled its operational capacity over the past four years - from a little under 1 gigawatts to nearly 3.4 gigawatts. The company has announced plans to boost this capacity to 6.3 gigawatts by financial year 2022, and to 25 gigawatts by financial year 2025. 1 gigawatt equals 1,000 megawatts. "Given the government's am-

bitious target to reach 175GW of renewable capacity by 2022 and 400GW by 2030, AGEL (Adani Green Energy Ltd) is favourably placed to tap into this mega opportunity," stated a report by Edelweiss Research, highlighting the favourable position of the company.

The registration of the award is the first step towards its enforcement in the event of the government not paying the firm.

to hike FDI to 74 per cent passed in Parliament

NEW DELHI: The Lok Sabha on Monday passed the Insurance Amendment Bill, which seeks to hike the foreign direct investment (FDI) limit from 49 per cent to 74 per cent, with Union Minister for Finance Nirmala Sitharaman saying that the measure was necessary to allow the insurance companies to access growth capital.

The Bill has already been passed by the Rajya Sabha. Sitharaman, speaking in the Parliament, pointed out that there is significant stress in the insurance sector, with three out of the seven public sector insurers below the solvency margin. Many of the insurance companies are hard pressed to maintain solvency ratio of 150 per cent as per the norms, she said. Solvency margin is the ratio of assets to liabilities.

The minister also pointed out that the government will provide funds to public sector insurance

companies but private players will have to raise capital on their own. The Bill provides them headroom to raise capital, she said.

"If growth capital is hard to come by, there will be a stress situation. In order that the stress situation is not left unattended, we need to raise the FDI limit," Sitharaman pointed out, adding that the pandemic has worsened the woes of insurance companies.

"There is definitely a financial stress for raising money, especially for private sector insurance companies, which needs to maintain that solvency ratio," she said. The minister also observed that the FDI limit was being raised on the recommendation ofsector regulator Insurance Regulatory and Development Authority of India after extensive consultations.FDI will not only bring in capital, but will also bring in greater competition, efficiency, better technology and enhance job opportunity, she said.

come days before Foreign Minister Shah Mahmood Qureshi will attend Heart of Asia – a meeting that among others would be attended by India's External Affairs Minister S. Jaishankar – in Dushanbe, Tajikistan.

The meeting provides a platform for regional cooperation with Kabul at its centre and with the recognition by the participants that a secure and stable Afghanistan is vital to the prosperity of the region.

The statement coincides with India and Pakistan holding in three years the first meeting of a commission that deals with water rights on the Indus River on Tuesday, illustrating a broader resumption of diplomatic ties.

The Permanent Indus Commission, set up under the Indus Waters Treaty of 1960, is set to meet in New Delhi on March 23 (today) to 24, said two Indian officials that deal in bilateral water issues.

At the talks, Pakistan will raise its objections to the technical designs of India's Pakal Dul and Lower Kalnai hydroelectric plants.

The talks represent a thawing in bilateral ties, which have been frozen since a 2019 suicide bombing in Kashmir blamed on Pakistan and India's decision later that year to strip the disputed region's autonomous status in order to bind it closer to India.

But over the past few weeks, the two governments have made tentative efforts to re-engage and calm the borders as they struggle to extricate their countries from the worst economic downturn ever amid the Covid-19 pandemic.

About a month after the armies of Pakistan and India agreed to observe a ceasefire along the Line of Control (LoC), Bloomberg revealed the months-long talks that preceded the landmark announcement were brokered by the United Arab Emirates (UAE).

The cease-fire, the report which cited sources said, is only the beginning of a larger roadmap to forge a lasting peace between the arch-rival neighbours.

The next step in the process involves both sides reinstating high commissioners in New Delhi and Islamabad, who were pulled in August 2019 after Pakistan protested India's move to revoke the semiautonomous status of Kashmir.

The reinstatement of the envoys will be followed by the hard part: Talks on resuming trade and a lasting resolution on Kashmir.

Last Thursday, addressing a gathering of scholars and experts discussing national security at the Islamabad Security Dialogue, Army Chief Gen Qamar Javed Bajwa, in a rare conciliatory call, urged for a peaceful resolution in Kashmir and for peace talks with India.

He had also called for burying the past and moving forward, saying that Kashmir holds the key to peace in all of South Asia, a region that is home to a quarter of the world's population.

"It is important to understand that without the resolution of the Kashmir dispute through peaceful means, the process of sub-continental rapprochement will always remain susceptible to a derailment," the army chief had observed.

However, there was no official confirmation from New Delhi on whether Jaishankar will travel to Tajikistan for the conference or about the possible meeting with his Pakistani counterpart. The Ninth Ministerial Conference of the Heart of Asia

- Istanbul Process is scheduled to take place on the 30th of March 2021 in Dushanbe, the capital of Tajikistan.

Dawn newspaper reported that the participation of Jaishankar and Qureshi in the March 30th event, in the backdrop of the recent developments, has led to speculation that they could meet.

"In view of recent events, we cannot say it's impossible," an official was quoted by the newspaper as saying.

The militaries of India and Pakistan on February 25 announced that they have agreed to strictly observe all agreements on ceasefire along the Line of Control in Jammu and Kashmir and other sectors.

On March 18, Pakistan's powerful Army chief Gen Qamar Javed Bajwa said it was time for India and Pakistan to "bury the past and move forward".

Addressing a session of the first-ever Islamabad Security Dialogue here. Gen Baiwa also said that the potential for regional peace and development always remained hostage to the disputes and issues between Pakistan and India - the two "nuclear-armed neighbours".

"We feel it is time to bury the past and move forward," he said, adding that the responsibility for a meaningful dialogue rested with India.

India last month said it desires normal neighbour-

"Many people distorted the message of Islam and apart from Maulana Wahiduddin Khan, there are many clerics and khatibs who raised voice against deliberate distortion and misinterpretation of the selected portion of Islamic texts. There is a need to check propagation and wrong interpretation of texts from holy books, besides realizing our responsibilities to show the right way and direction to the one who is treading a wrong path," he added

The official spokesperson further said that the LG termed Jammu and Kashmir as an ocean of spirituality where the values of humanity and tolerance emanating from the united culture of Shavisim, Buddhism and Sufism have always flourished over the centuries. The LG, he said, made special mention of Sufi saint Farid and Adi Shankaracharya and asked the people to spread their message of humanity and love.

'If you see any religion of the world, it teaches us only two paths - the paths of meditation and love. The problem arises when the original values of the religion are ignored and the spirit of love, kindness, compas-sion, renunciation which develops the 'Sarva Dharma Sama Bhava' and communal harmony is harmed. It is our responsibility to correct the wrong rhetoric and misinterpretation to preserve the feeling of love and harmony," Sinha, as per official spokesperson said.

"Many cases have come up in which even a very educated person gets radicalized. We need to counter radicalization through Sufi tradition, religious heads and Mothers and sisters without any particular sect," he added.

Speaking on the immense talent and potential possessed by the youth of J&K, the LG, as per official spokesperson said that under the guidance of the Prime Minister, the Union Territory administration was putting in all out efforts to provide them with rightful opportunities.

He said that the LG highlighted the reformative measures being taken in the education sector by the government and said that from this session, education will be imparted in all 5 official languages.

'Translation of local folklores and those of other states for cultural exchange and understanding is being done to promote the spirit of "Ek Bharat, Shreshtha Bharat". The stories of courage and sacrifice of our role models like Brigadier Rajinder Singh, Magbool Sherwani and Women Self Defense Corps, would be told in schools," Sinha said, as per official spokesperson.

Apart from this, vocational training is being provided to 44,351 children in 715 schools under the Samagra Shiksha Abhiyan.

The Meteorological (MeT) Office said widespread moderate to heavy rain/snow is most likely to prevail on Tuesday, but significant improvement in the weather was likely to take place from Wednesday.

The Jawahar Tunnel the gateway to Kashmir experienced snowfall this morning following which traffic was suspended between Banihal and Qazigund townships, the officials said.

They said incessant rains also lashed most parts of the highway, the only all-weather road linking Kashmir with rest of the country, for the third day on Tuesday, triggering landslides and shooting of stones from hillocks overlooking the highway at nearly a dozen places between Banihal and Chanderkote.

Deputy Superintendent of Police Traffic (National Highway Ramban), Parul Bhardwaj said a few hundred vehicles were stranded on the highway between Nashri and Chanderkote since Monday night.

Despite incessant rains and the lurking threat of shooting stones, the men and machinery kept the highway open and the majority of the stranded vehicles in Ramban were cleared last night itself, he said. He said a major landslide had struck the highway

overnight at Cafeteria Morh, while the road is also closed by debris at many places including Maroog, Monkey Morh, Panthiyal, Digdole, Sherbibi, Shabinbas.

Once the weather improves, all out efforts would be made to ensure early restoration of the highway, the officer said. Officials said reports of snowfall were also received from other high altitude areas including Peer Ki Gali along Mughal Road connecting the twin districts of Rajouri and Poonch in Jammu region with Shopian in south Kashmir.

The Mughal road was closed for traffic in December and is expected to be thrown open on completion of the snow clearance operation in the first or second week of next month, they said.

They said snowfall was also recorded in the upper reaches of Ramban, Doda and Kishtwar districts, while Jammu city was lashed by overnight rains, resulting in a drop in the temperature.

The minimum temperature in Jammu city settled at 14.9 degrees Celsius against the 16.2 degrees Celsius the previous night, a spokesman of the Meteorological department said. (PTI)

Accordingly, the court appointed Justice Syed Bashir-ud-din (retired) as the Ombudsman. Besides, the Division Bench appointed Ashiq Hussain Bukhari (IPS), former DIG, as Chief Executive Officer to assist the CAA to manage the affairs of the Association.

Consequently, the CAA drafted Memorandum of Association and Rules and Regulations. Among others, the CAA, as argued by one of the litigating parties before the court, among others ended the monopoly of a few Clubs and replaced them with District Associations to adopt the policy of 'territorial representation' for the formation of the Association and ended the earlier practice of denial of representation to each and every territory of Jammu and Kashmir in the JKCA.

After hearing all the litigating parties, the court observed that it has been "in essence called upon to determine as to whether the newly drafted Memorandum of Association and Rules and Regulations by the CAA of the JKCA is in accordance with the mandate of the Lodha Committee, as approved by the Supreme Court."

"Having gone through the rival stands adopted by the learned appearing counsel for the parties concerned along-with connected matters coupled with the facts giving rise to the instant litigation; as also keeping in view the directions passed by the Supreme Court from time to time; and the overall object of promoting the game of cricket in Jammu and Kashmir, we are of the view that it shall not be appropriate for this Court to go into the question of ascertaining whether the Memorandum of Association and Rules of Regulations so framed by the CAA of the IKCA are in tune with the recommendations of the Lodha Committee," the division Bench of Justices Ali Mohammad Magrey and Puneet Gupta said.

"Instead, in our opinion, now that the BCCI, which is tasked with the overall governing/ controlling of the activities of the game of cricket in India and of which the IKCA is an affiliate member, is in position with its newly approved Constitution, it is the said body which shall be the appropriate authority to answer the above-formulated question in the light of its newly approved Constitution."

The BCCI, the court said, is expected to have all expertise required for answering the question being the apex body for managing and controlling the activities of the game of cricket in India, including the Jammu and Kashmir.

"Besides, the BCCI has also filed an application for handing over the affairs of the JKCA to it till such time the elections of the office bearers of the JKCA are conducted under its supervision."

Subsequently, the Division Bench while appreciating the effort and endeavour made by the CAA as well as the CEO, said that it feel that there was no further need of their continuation. "As such, the CAA and the CEO of the JKCA appointed by this Court shall stand discontinued." the court said:

The BCCI shall, as an interim measure and till a new body of the JKCA is elected under its supervision, run the management, control and administration of the JKCA immediately upon being handed over the same by the CAA, the court said in another direction.

"The BCCI shall, while finalizing the amendment, if any, in the Constitution of the JKCA, in conformity with the recommendations made by the Lodha Committee as approved by the Supreme Court, consult all the stakeholders, including the parties litigating before this Court, i.e., the representatives of the erstwhile clubs of the IKCA as also of the District Cricket Associations now formed by the CAA.'

The BCCI, the court said, shall ensure promoting of cricketing activities in Jammu and Kashmir as well as in Ladakh in tune with its approved Constitution and at par with other affiliated Associations from various States and Union Territories of the country.

"The BCCI shall ensure that the required infrastructure on ground is improved and made available to the cricketers of Jammu and Kashmir and Ladakh without waiting for any audit report."

The BCCI, the court also directed, shall make every endeavour to ensure that the boys and girls playing the cricket in Jammu and Kashmir and Ladakh, from different age groups, are provided all facilities to excel in the game of cricket not only on national, but also at international level.

"The BCCI, given the task assigned to it as indicated above, shall be authorized to appoint Committee/ sub-Committee to run, administer, control and supervise the affairs of the JKCA till the elections are held and a body of the JKCA is elected under its supervision, whereafter the administration, control and supervision of the JKCA shall be handed over to the newly elected office bearers of the Association." the court said, adding, "Deputy Commissioner of Jammu as well of Srinagar shall cooperate with the BCCI for ensuring implementation of the aforesaid directions passed in this judgment for any requisitioned assistance. They shall ensure preparation of inventory of movable and immovable property of the JKCA and furnishing the same, alongwith the list of assets and liabilities of JKCA as existing on the date of this judgment, to the BCCI during the course of this week."

"The projects having national importance must be completed as per the fixed timelines, these projects are being regularly monitored by the Union Ministry of Power so all these projects need to be prioritized," Kansal added.

The official spokesperson further said that thorough discussions were also held on Capex Budget for the year 2021-22 and it was directed to the Chief Engineers to prepare a work plan of the proposed works in the next financial year as per their priority.

"The Principal Secretary emphasized that that the department's immediate goal is to provide regular and quality power supply during summer season in Jammu division. He directed the MD and Chief Engineer JPDCL for having action plan ready with them to deal with the any situation during the summers," he said.

He further added that Kansal directed buffer stock of transformers to be made available and the same should be distributed to all the divisions in advance along with all associated material.

Within the demarcated containment zones, containment measures, as prescribed by MoHFW, shall be scrupulously followed, which include strict perimeter control, intensive house-to-house surveillance, contact tracing, surveillance for ILI/ SARI cases etc.

Local district, police and municipal authorities shall be responsible to ensure that the prescribed Containment measures are strictly followed and State/ UT Governments shall ensure the accountability of the officers concerned in this regard, it further adds. COVID appropriate behaviour

The two-day meeting which started on Tuesday is taking place after a gap of over two years. The last meeting took place in Lahore in August 2018.

The Indian delegation was led by PK Saxena, India's Indus Commissioner, and his team from the Central Water Commission, the Central Electricity Authority and the National Hydroelectric Power Corporation.

The Pakistani delegation was led by its Indus Commissioner Syed Muhammad Meher Ali Shah. The delegation arrived here on Monday evening.

This year's meeting is the first between the two commissioners after the August 2019 nullification of the provisions of Article 370 of the Constitution that gave special status to the state of Jammu and Kashmir.

The meeting also assumes significance as this is the first important engagement between India and Pakistan after militaries of the two countries had announced last month that they would strictly observe a ceasefire along the Line of Control and other sectors. In 2019, the erstwhile state of Jammu and Kashmir

was also bifurcated into union territories -- Ladakh and Jammu and Kashmir.

India has since cleared several hydropower projects for the region.

Of these, Durbuk Shyok (19 MW), Shankoo (18.5 MW), Nimu Chilling (24 MW), Rongdo (12 MW), Ratan Nag (10.5 MW) are in Leh; and Mangdum Sangra (19 MW), Kargil Hunderman (25 MW) and Tamasha (12 MW) are Kargil. Both Leh and Kargil fall in Ladakh.

Pakistan has sought information on these projects, sources added.

The Indus Waters Treaty (IWT) warrants the two commissioners to meet at least once a year, alternatelv in India and Pakistan.

However, last year's meeting scheduled to be held in New Delhi in March was cancelled, a first since the treaty came into being, in view of the coronavirus pandemic.

In July 2020, India had proposed to Pakistan that the meeting for discussing pending issues pertaining to Indus Waters Treaty (IWT) be held virtually in the wake of the coronavirus pandemic, but Pakistan insisted on holding talks at the Attari border checkpost.

However, in response, India said it is not conducive to hold the meeting at the Attari Joint Check Post due to the pandemic. With the improvement in situation, this mandatory meeting is being held following all COVID-19-related protocols.

Under the provisions of Indus Waters Treaty, signed between India and Pakistan in 1960, all the water of the eastern rivers -- Sutlei, Beas, and Ravi -- amounting to around 33 million acre feet (MAF) annually is allocated to India for unrestricted use. The waters of western rivers -- Indus, Jhelum, and Chenab amounting to around 135 MAF annually has been assigned largely to Pakistan.

According to the treaty, India has been given the right to generate hydroelectricity through run-of-theriver projects on the western rivers subject to specific criteria for design and operation. The treaty also gives right to Pakistan to raise objections on design of Indian hydroelectric projects on the western rivers.

A Year Of Disruptions: How Indian Sports Adapted To COVID Conundrum

NEW DELHI: The fans have largely gone missing, the training protocols have undergone a sea change and bio-bubbles have become the new normal despite the growing concerns over the mental toll they are taking.

It is exactly one year since India's sporting landscape, along with the rest of the world, lost most of its vibrancy thanks to the COVID-19 pandemic.

The beginning of it all was with a sudden closure for a few months, athletes locked in hostel rooms or their homes, without any practice or supervision of national coaches. But as they adapted to the fear

and uncertainty, a tentative resumption followed on global cues. That has continued despite relatively minor glitches cropping up both on and off the field of play.

Cricket was the first to hit the restart button in Indian sports with the IPL, albeit on foreign shores of UAE, in a strict bio-secure bubble. A few COVID cases caused a

flutter before it began but once the tournament-proper started rolling, it set a new benchmark on how to conduct an event amid a raging pandemic.

But the rules of engagement changed. So no saliva to shine the ball, no handshakes at toss, no moving out of the hotels during series, and mostly no fans to egg them on.

It was welcomed to start with as players were just desperate to compete again but the murmurs have grown louder by the day about the impact such isolation is having on the mental health of

those competing. India skipper Virat Kohli was upfront on the challenging situa-

After Record-Breaking 50 On Debut, Krunal Pandya Breaks **Down Remembering Late Father**

PUNE: India batsman Krunal Pandya smashed the fastest fifty by an ODI debutant during the first match against England here on Tuesday and broke down remembering his father who died in January this year after suffering a heart attack.

PUNE: India outplayed world champions England by 66 runs in the opening ODI here on Tuesday to take a 1-0 lead in the threematch series.

Chasing a steep 317-run target for victory, England folded for 251 in 42.1 overs despite making a dazzling start.
