SRINACAR. Asia's largest tulin garden, overlooking the famous Dal Lake here, will be thrown open to the public on Thursday, marking the beginning of new tourism season in Kashmir.

Formerly known as Siraj Bagh, the Indira Gandhi Memorial Tulip Garden was opened in 2008 by the then chief minister Ghulam Nabi Azad.

The idea of the garden, spread over 30 hectares in the foothills of snow-clad Zabarwan Range, was conceived to advance the tourism season in the Valley by two months.

The garden will be thrown open for public on Thursday," Tulip Garden incharge Inam Rehman Sofi said.

Missing Soldier's Case Creating Grave Hunt In Kashmir

RESHIPORA, Shopian – Surrounded by sighing and solidarity-spirited simpletons, Manzoor Wagay, 54, is dragging hookah in a manic manner.

The grief, it seems, has only become a festering wound for a distraught father whose summer search for his son has already passed through the harsh winter, before getting renewed by the spring statement of Jammu and Kashmir's Police Chief, Dilbagh Singh.

Talking to reporters on the sidelines of the inauguration of U-19 cricket tournament at SK Stadium Srinagar on March 20, 2021, DGP Singh said that there is no clue of the missing Territorial Army soldier from Shopian, who went missing last August.



"Police have not closed the case and investigations are on," Singh said. "It's not clear where he was buried by the



militants. Whenever we get any information, his family will accordingly be informed."



But back home, Wagay is spearheading his own teeming search campaign. Since last summer when his visiting

son vanished into thin air, the father has been digging orchards and paddy fields with shovels. He even rented a bulldozer and dug deep into the soft earth near a bridge in Landoora village in search of his son's body. He even stormed the shelters of suspects, and exhausted his savings to travel to places in identifying the unknown bodies.

"Marnie' ky'ss damastaa'mt chandaei' bei' pan'nis nich'aeivs y'einzlaa'sh (I'll search the body of my son till me last breath)," Wagay said, as all eyes in the room stared him through the smokescreen created by his manic

hookah-dragging. "I know he has been buried closer to home. I know that. I will find him one

day. Sooner or later.' Villagers of Reshipora are equally

throwing their weight behind Wagay's search campaign. They call the missing soldier as "one of their own".

"For over the first 40 days of his disappearance, more than 400 people from this village joined me to locate the body but till date I didn't find any clue," Wagay, a farmer, rued.

As the distraught father completed two rounds of smoking pot within 20 minutes, the room full of villagers started lauding his courage. These home audiences have now become esprit de corps for the family of the missing village boy -whose soldier shift couldn't eclipse his Samaritan nature in the raging reality of the southern



'Stronger brain activity after writing on paper than smartphone'

physical paper can lead to more brain activity when remembering the information an hour later, suggest the findings of a recent study led by Japanese university students and recent graduates.

Researchers say that the unique, complex, spatial and tactile information associated with writing by hand on physical paper is likely what leads to im-

proved memory.
"Actually, the paper is more advanced and useful compared to electronic documents because paper contains more oneof-a-kind information for stronger memory recall," said Professor Kuniyoshi L. Sakai, a neuroscientist at the University of Tokyo and corresponding author of the research recently published in Frontiers in Behavioral Neuroscience. The research was completed with collaborators from the NTT Data Institute of Management Consulting.

Contrary to the popular belief that digital tools increase efficiency, volunteers who used paper completed the note-taking task about 25 per cent faster than those who used digital tablets or smartphones.

Although volunteers wrote by hand both with pen and paper or stylus and digital tablet, researchers say paper notebooks contain more complex spatial information than digital paper. Physical paper allows for tangible permanence, irregular strokes, and uneven shape, like folded corners. In contrast, the digital paper is uniform, has no fixed position when scrolling, and disappears when you close the app.

"Our take-home message is to use paper notebooks for information we need to learn or memorize," said Sakai.

In the study, a total of 48 volunteers read a fictional conversation between characters discussing their plans for two months in the near future, including

14 different class times, assignment due dates and appointments. personal Researchers performed pre-test analyses to ensure that the volunteers, all 18-29 years old and recruited from university campuses or NTT offices, were equally sorted into three groups based on memory skills, personal preference for digital or analog methods, gen-

der, age and other aspects.

served in a specific region of the brain is a sign of increased neuronal activity in that area.

Participants who used a paper datebook filled in the calendar within about 11 minutes. Tablet users took 14 minutes and smartphone users took about 16 minutes. Volunteers who used analog methods in their personal life were just as slow at using the devices textbook printed on paper, you can close your eyes and visualize the photo onethird of the way down on the left-side page, as well as the notes you added in the bottom margin," Sakai explained.

Researchers say that personalizing digital docu-ments by highlighting, underlining, circling, drawing arrows, handwriting colour-coded notes in the



Volunteers then recorded the fictional schedule using a paper datebook and pen, a calendar app on a digital tablet and a stylus, or a calendar app on a large smartphone and a touchscreen keyboard. There was no time limit and volunteers were asked to record the fictional events in the same way as they would for their real-life schedules, without spending extra time to memorize the schedule.

After one hour, including a break and an interference task to distract them from thinking about the calendar, volunteers answered a range of simple (When is the assignment due?) and complex (Which is the earlier due date for the assignments?) multiple choice questions to test their memory of the schedule. While they completed the test, volunteers were inside a magnetic resonance imaging (MRI) scanner, which measures blood flow around the brain. This is a technique called functional MRI (fMRI), and increased blood flow obas volunteers who regularly use digital tools, so researchers are confident that the difference in speed was related to memorization or associated encoding in the brain, not just differences in the habitual use of the tools.

Volunteers who used analog methods scored better than other volunteers only on simple test questions. However, researchers say that the brain activation data revealed significant differences. Volunteers who used

paper had more brain activity in areas associated with language, imaginary visualization, and in the hippocampus -- an area known to be important for memory and navigation. Researchers say that the activation of the hippocampus indi-cates that analog methods contain richer spatial details that can be recalled and navigated in the mind's

"Digital tools have uniform scrolling up and down and standardized arrangement of text and picture size, like on a webpage. But if you remember a physical

margins, adding virtual sticky notes, or other types of unique mark-ups can mimic analog-style spatial enrichment that may en-

hance memory.
Although they have no data from younger volunteers, researchers suspect that the difference in brain activation between analog and digital methods is likely to be stronger in younger

"High school students' brains are still developing and are so much more sensitive than adult brains,' said Sakai.

Although the current research focused on learning and memorization, the researchers encourage using paper for creative pursuits as well. "It is reasonable that

one's creativity will likely become more fruitful if prior knowledge is stored with stronger learning and more precisely retrieved from memory. For art, composing music, or other creative works, I would emphasize the use of paper instead of digital methods," said



Upcoming 4 Drainage Projects to Mitigate Flood Threat in Srinagar

Srinagar: To strengthen the urban flood management infrastructure across the flood-prone areas of Srinagar, four mega drainage projected are being constructed under Jhelum Tawi Flood Recovery Project financed by the World Bank.

A senior official of the Jammu and Kashmir Economic Reconstruction Agency (JK ERA) said, that all four drainage projects have witnessed substantial progress and are set to get complete by the end of this year.

An official said that the construction of these four mega projects will give relief to lakhs of people in Srinagar who are vulnerable to flood due to the lack of a drainage system.

The four mega projects include missing link zone-1 stormwater drainage scheme, Bonapora-Padshahi Bagh stormwater drainage subproject, Nadroo stormwater drainage scheme and missing links zone 2 stormwater drainage scheme.

Official said the missing links zone-1 stormwater drainage scheme is being constructed at an estimated cost of Rs 54.7 crore and its length will be around 41 km including 33 km pipe drain, 5 km pipe drain

line of December 2021 will be served by the pumping stations constructed by J&K ERA under

the earlier drainage projects. An official said that it will benefit over lakh souls living in 40 residential colonies and will provide the mechanism for the scientific disposal of stormwater, thereby reducing the vulnerability to varitering from the concerned areas if a flood hits the city again.

"The pumps are equipped with the latest electro-mechanical equipment, submersible pumps, DG sets and transformers which will work automatically when the water level increases in the area," an official told said.

Bagh Bonapora-Padshahi stormwater drainage will be around 13 km long and is being constructed at an estimated cost of Rs 28.74 crore and will also benefit thousands of people.

Nadroo stormwater drainage scheme will be six-kilometre long and is being constructed at an estimated cost of Rs 12.8 crore and missing links zone 2 projects catering mostly downtown area with a length of 21 kilometres is being constructed at Rs 37.39 crore, an official said.

An official said that 82 dewatering pumps are also being installed in the city so that these The project which has a dead- pumps will work to help in dewaing stations have control rooms and backup control rooms so that any pump can be operated from the room if a person cannot reach to the spot.

'The scheme costs Rs 103 crore funded by the World bank and implementing by Jammu and Kashmir Economic Reconstruction Agency and the deadline for this project is next one year," he said.

Officials said scientific studies are also going on both Jhelum and Tavi along with radar surveys to furnish flood mitigation measures for the people of J&K.

"The work on all the projects ikely to be completed by end of this year," an official said—(KNO)

UN: Boom In Innovation For

Overcoming Disabilities

Agenceis

nnovations aimed at helping people overcome mobil-Lity, sight and other disabilities have exploded in recent years, and are becoming ever more integrated in regular consumer goods, the United Nations said on Tuesday.

More than one billion people worldwide currently need technology-based assistance to overcome a disability -- a figure expected to double in the next decade as populations age, UN data shows.

Meanwhile, only one in 10 people globally currently have access to the assistive products they need.

To meet the growing demand, innovations in new assistive products have shown double-digit growth in recent years, according to a fresh report from UN's World

2020. More than 15,500 of those filings were for so-called emerging assistive technologies, like assistive robots, smart home applications, wearables for visually impaired people and smart glasses.

That was eight times fewer than the 117,000-plus patents filed for conventional technologies for well-established products like wheelchair seats or Brailleenabled devices.

But Wipo pointed out that filings for new assistive technologies were growing 17% on average each vear -- three times faster than the growth rate for conventional technology filings.

The report found that China, the United States, Germany, Japan and South Korea were the countries where most innovation in assistive technology was taking place.

"People living with impairments have long relied on new technologies for increased independence and fuller interaction with their world," Wipo Chief Daren Tang said in the foreword to the report.

"From the invention of the crutch in ancient Egypt through the simple prosthetics of the Middle Ages to our latter-day Braille tablets, we are now on the cusp of a future where autonomous wheelchairs, mind-controlled hearing aids and wearables monitoring health and emotion alleviate the impact of human limitations."

A key finding in the report, he said, is "the evolution toward mass use of assistive tech."

Using patent and other data, the report found that more than 130,000 patents were filed for conventional and emerging assistive technologies between 1998 and

Universities and public research organisations are the most prominent when it comes to filing patent applications for emerging assistive technologies.

Wipo experts hailed how assistive technologies were rapidly converging with mainstream consumer electronics, paving the way for a greater commercialisation and lower prices.

Going mainstream

Marco Aleman, a Wipo assistant director general who leads the agency's IP and Innovation Ecosystems Sector, pointed to the swelling interest in enabling technologies like brain-machine interfaces.

As a result, big tech companies, like IBM, Google and Microsoft, and consumer product companies like Samsung and Panasonic were eagerly entering a market once dominated by specialised assistive technology companies, like WS Audiology and Second Sight.

he United Nations Human Rights Council (UNHRC) on Tuesday adopted a resolution titled 'Promotion of Reconciliation Accountability and Human Rights in Sri Lanka' after 22 members out of 47-member Council voted in favour of it.

While India abstained from voting it urged Colombo to fulfil its commitments on the devolution of political authority, to carry forward the process of reconciliation and address the aspirations of the Tamil community in the island nation.

The UK, Canada, Germany and eight other member nations voted against the resolution. Apart from India. 13 other nations abstained from voting. Ahead of the voting, India said that as an immediate neighbour, it has contributed to the relief, resettlement, rehabilitation and reconstruction process in Sri Lanka after 2009.

India's approach to the question of human rights in Sri Lanka is guided by two fundamental considerations, Pawankumar Badhe, First Secretary, Permanent Mission of India in Geneva said in a statement.

"One is our support to the Tamils of Sri Lanka for equality, justice, dignity and peace. The other is in ensuring the unity, stability and territorial integrity of Sri Lanka.

"We have always believed that hese two goals are mutually supportive and Sri Lanka's progress is best assured by simultaneously addressing both objectives," Bad-

"We would urge that the Government of Sri Lanka to carry forward the process of reconciliation, address the aspirations of the Tamil community and continue to engage constructively with the international community to ensure that the fundamental freedoms and human rights of all its citizens are fully protected," he said.

He said India supports the call by the international community for the Government of Sri Lanka to fulfill its commitments on the devolution of political authority, including through the early holding of elections for Provincial Councils and to ensure that all Provincial Councils are able to operate effectively, in accordance with the 13th Amendment to the Sri Lankan Constitution.

Netanyahu's Future Unclear As Exit Polls Forecast Stalemate In Israel's Election

rime Minister Benjamin Netanyahu's prospects for retaining power were uncertain on Wednesday after exit polls in Israel's fourth national election in two years projected yet another stalemate.

With final results not due until later in the week, the forecasts indicated that even Netanyahu's stewardship of a world-beating Covid-19 vaccination rollout - a showcase of his campaign - may not have been enough to propel

Confront Your Colonial Past, Council Of Europe Tells Portugal

■urope's top human rights group said on Wednesday that ■Portugal must do more to confront its colonial past and role in the transatlantic slave trade in order to help fight racism and discrimination

The comments by the Council of Europe come as debate in Portugal over how to remember its history heated up in recent months as the country prepares to unveil its first memorial to victims of slavery, in Lisbon.

The memorial – rows of palm trees painted in black - was designed by Angolan artist Kiluanji Kia Henda and funded by the Lisbon council. It will stand in the centre of the city. From the 15th to the 19th cen-

tury, Portuguese vessels carried close to six million enslaved Africans across the Atlantic, more than any other nation, but up to now Portugal has rarely commented on its past actions and little is taught about its role in slavery in schools. Rather, Portugal's colonial era,

which saw countries including Angola, Mozambique, Brazil, Cape Verde and East Timor, as well as

parts of India, subjected to Portuguese rule, is often perceived as a source of pride.

"Further efforts are necessary for Portugal to come to terms with past human rights violations to tackle racist biases against people of African descent inherited from a colonial past and historical slave trade," the Council of Europe said in its yearly report on Portugal, urging Lisbon to rethink how it teaches its colonial history.

Complaints of racial discrimination increased 50 percent to 655 in 2020 but the figure is likely far below the actual rate of racist incidents, said Portugal's Secretary of State for Equality Rosa Monteiro.

"Our historical narrative is like a very serious wound that has not been properly treated. And to heal it, we have to talk about what happened," Monteiro told Reuters, adding the government was preparing a nationwide plan to combat racism.

Recent racially-motivated crimes include a KKK-style torchlight rally, the fatal shooting of a Black actor by a white man on the street and emailed threats to Black legislators.

First historic Mars helicopter flight on April 8: NASA

WASHINGTON: NASA will attempt to fly Ingenuity mini-helicopter, currently attached to the belly of Perseverance rover, on Mars on April 8, in first such attempt on another planet.

However, before the 1.8- kg rotorcraft attempts its first controlled flight, both it and its team back home must meet a series of daunting milestones.

"When NASA's Sojourner rover landed on Mars in 1997, it proved that roving the Red Planet was possible and completely redefined our approach to how we explore Mars. Similarly, we want to learn about the potential Ingenuity has for the future of science research." said Lori Glaze, director of the Planetary Science Division at NASA Headquarters.

"Ingenuity is a technology demonstration that aims to be the first powered flight on another world and, if



successful, could further expand our horizons and broaden the scope of what is possible with Mars exploration," Glaze said in a statement on Wednesday.

On March 21, the rover deployed the guitar case-shaped graphite composite debris shield that protected Ingenuity during landing.

The rover currently is in transit to the "airfield" where Ingenuity will attempt to fly. Once deployed, Ingenuity will have 30 Martian days, or sols, (31 Earth days) to conduct its test flight campaign.

Flying in a controlled manner on Mars is far more difficult than flying on Earth. The Red Planet has significant gravity (about one-third that of Earth's) but its atmosphere is just 1 per cent as dense as Earth's at the surface. During Martian daytime, the

planet's surface receives only about half the amount of solar energy that reaches Earth during its daytime, and night-time temperatures can drop as low as minus 90 degrees Celsius, which can freeze and crack unprotected electrical components. To survive the frigid Martian

nights, it must have enough energy to power internal heaters. "Every step we have taken since

this journey began six years ago has been uncharted territory in the history of aircraft," said Bob Balaram, Mars Helicopter chief engineer at JPL. "While getting deployed to the

surface will be a big challenge, surviving that first night on Mars alone, without the rover protecting it and keeping it powered, will be an even bigger one," Balaram added.

Prices Of Essential Commodities Skyrocket As Kashmir Highway Remains Shut

SRINAGAR: Intermittent snowfall in upper areas and torrential rains in plains over the last four days in Kashmir Valley have affected daily life.

Meanwhile, the overnight heavy rainfall in most parts of the Valley brought the mercury further down while some parts of the higher reaches continued to receive snowfall for the second consecutive day on Wednesday.

However, the MeT sources have predicted significant improvement in weather conditions from Wednesday afternoon and said that the overall improvement in

the weather conditions would be witnessed from Thursday.

The closure of Srinagar-Jammu highway has added the problems of the common people with the shortage of essential commodities. Heavy rains have also submerged dozens of localities in Srinagar city including many by lanes and connecting roads.

However, the vegetable vendors said that they were getting supplies at higher rates. "Before the rainfall, the prices had stabilized to some extent, but since the closure of the highway we are getting vegetables at higher prices from wholesale mandis," Abudul Majeed, a vendor at Lalchowk said.

Some consumers from Hazratbal said that the shopkeepers were selling vegetables at much higher prices.

Meanwhile, the extended closure of the highway has depleted the stock of vegetables and fruits in the Valley for which the highway is the only all weather surface link with the rest of India.

Emphasising upon the need for the administration to reconsider and intervene to stop the skyrocketing prices of essential commodities, the general public has appealed concerned administration to take the cognisance of matter and solve it on priority basis. (CNS)

JAMMU: The Chief Secretary, B V R Subrahmanyam, Wednesday chaired a meeting to apprise the Deputy Commissioners and District Superintendents who have taken charge after the recent reshuffle in I&K's administration; on the priorities of the Government and procedures for regular monitoring of ongoing projects for their timely completion.

The meeting defined the major contours of good governance for the district administrations achievable through strengthened coordination and convergence. It was impressed upon the participants that the functioning of government machinery needs to be efficient, accessib transparent, and accountable with a special focus on grievance redressal and public outreach. The meeting reviewed the progress of various sectors and laid down the districtlevel framework for time-bound, door-step delivery of Government services; and completion of projects.

Under the Education sector, officers from School Education Department were directed to ensure sufficient arrangements for safe drinking water and toilets across the hierarchy of schools both in government and private sectors, besides ensuring the functioning of the existing infrastructure. It was advised that shortages, if any, can be augmented through the Jal Jeevan Mission and the Swachh Bharat Mission, respectively. Higher Education Department along with Revenue Department was asked to expedite construction of infrastructure for the 51 newly sanctioned Degree Colleges across Jammu & Kashmir.

On the scholarship front, strict directions were issued to the departments of School Education, Higher Education, Social Welfare and Tribal Affairs to ramp up coordination for ensuring universal coverage of all eligible students within the stipulated timelines under respective schemes of the Central and State governments.

Further, Social Welfare Department was asked to ensure universal coverage and timely disbursement of financial assistance under various pension schemes including National Social Assistance Programme, Integrated Social Security Scheme; and PM Matritva Vandana Yojana, with

a renewed focus on monitoring of

services under Poshan Abhiyan and

one-stop centres for women.

For providing affordable housing and a clean environment, Housing & Urban Development (H&UDD) and Rural Development (RDD) departments were directed to ensure timely completion of housing projects under Pradhan Mantri Awas Yojana-Urban and Rural, respectively, and gradual reduction and elimination of the 'single-use plastics'. RDD was additionally asked to make MGNREGA wage payments within 15 days of work completion, and to proactively engage with

youth under UMEED and self-help

groups under the NRLM scheme. For efficient implementation of the Forest Rights Act, directions were given to the departments of Forest, Rural Development, Tribal Affairs and Revenue to work in tandem and vest forest rights on the eligible scheduled tribes and traditional forest dwellers through forest rights committees, sub-divisional committees, and district-level committees. The district administrations were asked to implement respective district environment plans with a renewed focus on restoration and conservation of water bodies. The Chief Secretary asked Jal Shakti Department to provide functional tap water connections to all households in Jammu and Kashmir by 30th September 2022 under the Jal Jeevan Mission- 'Har Ghar Nal se Jal'. Under the recently launched Jal Shakti Abhivan- 'Catch the Rain', it was urged that degraded eco-systems must be revived through watershed conservation programmes, and rainwater harvesting techniques that can be taken up in convergence between line departments

To provide all-weather, potholefree, and secure connectivity, the district administrations were asked to prioritize PMGSY projects by ensuring availability of requisite raw material, timely resolution of land issues, and provisions for issuing mandatory clearances in a timebound manner. They were advised to identify and recommend new projects under NABARD well in time to ensure that works on the projects commence in the 1st quarter of the financial year, 2021-22.

The Chief Secretary directed the Power Development Department to actively monitor the reported failures of power distribution & transmission channels, timely repairs, and replacement of the damaged equipment to ensure uninterrupted power supply during the upcoming summer months, besides securing the existing electrical infrastructure against the extreme weather vagaries.

The Agriculture & Farmers' Welfare Department was asked to monitor payment of benefits under PM KISAN Yojana, enhance enrolment under KCCs, and establish forward linkages with the industrial sector in its efforts to double

the farmer's income. The Chief Secretary asked Health & Medical Education Department to universally enroll residents of Jammu and Kashmir under Ayushman Bharat-Sehat scheme for free of cost and cashless healthcare coverage by 31st May 2021. Regarding control measures for COVID-19 case surges, the Department and district administrations were directed to enhance testing, contact tracing, roll out of micro containment strategies, besides, ramping up vaccination drives on a mission mode.

To ensure that the Government services are provided in an equitable and hassle-free manner and identified projects get completed within their timelines, the Divisional Commissioners of Kashmir and Jammu were directed to coordinate, monitor, and review district-wise progress.

Tulips beckon tourists

rime Minister Narendra Modi took to Twitter on Wednesday to urge people in India to visit Kashmir to witness 1.5 million flowers in bloom in Srinagar's famous tulip garden which is being thrown open today. The PM also attached the picture of the garden to his tweet. Spread over an area of about 30 hectares the garden which is located in Zabarwan foothills was opened in 2007, to boost tourism in the Kashmir Valley by then chief minister Ghulam Nabi Azad.

Ever since thousands of tourists visit the garden during the limited period of bloom of tulips. Last year, no one could visit due to the Covid-19 lockdown which brought number of outside tourists to zero during April, May and June. This spring, there is an expectation of a bumper tourist season following a large tourist footfall in winter. In a recent statement to parliament, Tourism Minister Prahlad Singh Patel said the number of tourists who visited in Jammu and Kashmir this year so far has been the highest in last 16 years.

This is a great news for the sector that has been devastated over the last two years. According to official data 8,42,202 tourists visited the valley in 2018, 4,99,582 in 2019, and only 28030 in 2020.

Since the end of last year, the tourism department has been trying hard to bring more visitors to the Valley by organizing tourism promotion programmes. And to this end, the tour and travel operators from Maharashtra were brought to initiate an 'Unlock Kashmir Tourism Campaign'. Similarly, after a long drawn effort by the successive J&K Governments to bring Bollywood back to Kashmir, the exercise is finally paying off. Tinsel town is showing signs of shrugging off its Kashmir scare and finding its lost paradise again.

But would tourists come in spring too just as they did in winter? Depends on how the situation evolves. Covid-19 pandemic remains a dampener though. With the country bracing for a second wave of infection, the situation could go back to square one. But there's one good possibility though. International travel will take a long way to return to normal. This, in a sense, offers tourist places like Kashmir some hope. Indian tourists who can't visit abroad, can visit the Kashmir within the country.

Tourism sector forms 6.8 percent of Kashmir's GDP and employs 2 million people. But the seven month siege following erasure of the region's autonomy followed by Covid-19 pandemic, the sector is in bad shape. A significant number of people associated with it have either been laid off or are in the process of losing their jobs. Here's hoping that this spring and summer, the tourism picks up. This will go a long way to shore up the Valley's battered economy.

One year of the lockdown

xactly a year ago, on March 24 at 8 pm, Prime Minister Narendra Modi announced that to battle Covid-19, India would lock itself up. Flights in and out of the country had already been stopped earlier, and now, all movement — except for essential workers — was halted. Citizens were told to stay home, maintain social distancing, avoid all contact with the external world, follow Covid-19 protocols, and aid the nation in helping break — or slow down — the chain of transmission, even as India was to use the period to build up its health infrastructure to cope with the most devastating pandemic in a century. While there were different phases of slowly unlocking the country, for 68 days, there was a lockdown. A year later, there are lessons and cautionary notes which are still relevant.

Based on the scientific evidence available at the time, global trends, an assessment of India's health infrastructure deficits, and the possibility of rapid transmission given the population and its density, a lockdown was necessary. India did well in using the period to ramp up testing and medical management facilities. But, at the same time, the lockdown was brutal, especially for the poor. The sight of migrant workers walking home will remain the abiding image of the lockdown, as will the unprecedented economic contraction. Supply chains were disrupted, demand plummeted, incomes dipped, jobs were lost, and the social welfare initiatives of the government were not enough to tackle the distress. The disease, too, continued to spiral — though India was fortunate in having a low fatality rate.

PAGD at a Dead-End

t has now been months since the People's Alliance for Gupkar Declaration (PAGD) - now reduced to five parties following Sajad Lone's exit - has met. It didn't even meet to celebrate the winning of a predominant majority of seats in the Valley in recent District Development Council polls. Nor does it look likely that the alliance will meet in near future. What is more, the PAGD hasn't even issued a public statement on the evolving situation. Instead, each party has acted and spoken only as an individual entity. And the divergence among the constituents, particularly between the National Conference and the PDP, the largest parties in the grouping, has only grown by the day.

In hindsight, the grouping seems to have been destined to fall apart or at least become deactivated as it has now. The reasons for it are many but primarily it is about the centre's move to disproportionately raise the cost for the constituents for pursuing a united struggle for the restoration of Article 370. The leaders have been sent to jail, more of them from the People's Democratic Party. One of the leaders has quit the party following his recurrent incarceration. The administration has also reopened the J&K Cricket Association case against Dr Faroog Abdullah, the PAGD president, and attached his property worth over Rs 11 crores. The PDP president Mehbooba Mufti has been summoned by the National Investigation Agency. The cost seems to be directly proportional to pro-Article 370 noise by the alliance: stronger its pitch for the restoration of J&K autonomy, greater the punishment for the leaders.

This state of affairs has been alien to mainstream leaders over the last seventy years. Their politics has largely been about the pursuit of power than of a cause. True, the National Conference and the PDP have always sought strengthening of Kashmir's autonomy but this demand has been more in the nature of a political slogan than a goal they actively pursued and sacrificed for. More often than not, the mainstream politics in J&K - more so, in the Valley - has been a cringing and unedifying spectacle of the

enjoyment of power, albeit largely divested of the space to exercise it. The BJP has now demanded and got the local establishment leaders to become subservient, if not completely identify with its own political stance on Kashmir. It has tried to forcibly hone them to its nationalist straitjacket, thereby rendering them stultifying figures whose statements struggle to carry conviction in Kashmir.

The BJP government has also raised heavy costs for what has essentially been an innocuous Kashmir-centric politics: a demand Gupkar alliance where his party would only get to contest from the two Assembly seats from where his candidates had won last time. And if the DDC election is anything to go by, even here his candidates would have had to contend with the proxies from the other parties.

The NC, PDP and the other parties would face a similar situation. In fact, many leaders in the NC are sore that by forming the PAGD they have given a new lease of life to the PDP and the PC which had largely lost the public confidence following their alliance with the BJP.

More often than not, the mainstream politics in J&K - more so, in the Valley - has been a cringing and unedifying spectacle of the enjoyment of power, albeit largely divested of the space to exercise it.

by Kashmiri leaders, much of it perfunctory in nature, for the protection of political rights of Kashmiris. And the saffron party knows that the mainstream leaders are unlikely to be ready to sacrifice beyond a point, with a few exceptions, of course. The strategy has paid off. The PAGD is in paralysis within months after its formation. The alliance has, more or less, stopped pursuing the goal for which it was created. And the grouping itself is on the brink of coming apart.

Sure, there are other reasons too for the PAGD to cease to carry out its professed role: the survival and expansion of the individual parties - particularly that of the NC, the PDP and the PC - which depends on the corresponding decline in the footprint of the other parties. For example, the NC can't retain its traditional standing as a dominant party without encroaching into the constituencies of the PDP or the PC. Ditto for the latter two which cannot hope to grow without doing the same to other parties. After exiting the PAGD, Sajad Lone has broken free. He is luring the former PDP and the NC leaders into his party and trying to expand his party's base in north Kashmir. This would have been impossible for him to do being a member of the

And some PDP leaders, on the other hand, think that the NC has gone quiet over the demand for Article 370 after the Enforcement Directorate notice to Farooq Abdullah, with one leader accusing senior Abdullah and the son Omar Abdullah of "depoliticizing their narrative". This mutual suspicion and the necessity for survival and growth as individual entities leaves little scope for an alliance that freezes their political standing in line with their last electoral performance.

As things stand, there's thus

As things stand, there's thus little that gives the parties in the PAGD a cause to stay united. In fact, there are more reasons for them to strike on their own and pursue individual political ambitions. As for the struggle for Article 370, it can hardly be pursued within the paradigm of the power politics. More so, when such a struggle will not only be a drawn one with little chance of its success but will also call for sacrifices by the leaders and the parties.

On Writing Flawed and Inconsistent Afghan Characters

n a Facebook book club for physicians, a member asked for historical fiction recommendations to better understand the history of the US-Afghanistan relations. As an Afghan American writer, the post caught my eye. One person suggested Ken Follett's Lie Down with Lions. I was unfamiliar but intrigued, so I downloaded the audiobook.

Published in the 80s, the book took me back in time to my childhood. No, I was not transported to a remote village set against jagged mountains; rather, Follett's tale of espionage and Cold War tensions took me back to our wood-paneled living room in suburban New Jersey, with the television aglow in the corner.

In that room, I'd taken in the only images of Afghanistan that were available at the time. Afghanistan graced the screen so rarely that my father made every effort to record those occasions on VHS tapes. More times than I can count, we watched Rambo thunder across Afghanistan's plains on the back of a black stallion to come to the mujahideen's aid. We had that one MacGyver episode as well, though he used more invention than ammunition. Peter Jennings and the other evening news anchors reported over similar but hazier images of a country swirled in dust, people's faces obscured by clouds of artillery smoke.

In Follett's story, among many cringeworthy moments were his repeated references to the way "all Afghans" dressed or behaved. Just like the suburban television screen of my childhood, the book portrayed Afghans as bearded warriors fighting off the Russians from mountain perches. The women were exotic when they weren't invisible. These narratives relied heavily on stereotypes about tribal (in their gaze, "primitive") cultures. In other words, these stories were not really about Afghans. They were a canvas upon which a white reader or viewer could project their own ideas about Afghans onto the screen.

In 2009, I began writing the kinds of stories that I'd once longed to encounter in bookstores and libraries. I set out to reflect a universal point of friction—women struggling for agency within a home, for free will within her own head, for a place within history—but within an Afghan context.

To write these stories with any authenticity is to write with abandon. I write characters who bear traits I've seen in vivo: flawed, inconsistent, forgivable, inspiring, damaged, human. I summon the granular stories told and re-told in our family, the spectrum of glorious and devastating experiences. The time my mischievous uncle swiped the best pieces of meat from the serving dish. The day my aunt walked away from medical school to study the humanities. The bright taste of oranges from Jalalabad in winter. The time several family members were lost in a round of political arrests and murders. The hours hungry women spent cooking delicacies in the month of Ramadan.

But it was not until my books reached an audience that I understood the pitfalls of being a writer of color and pushing against inaccurate narratives about my culture.

At times, my stories have become hooks from which readers hang their

preconceived notions. In my first novel, a wife of a warlord held a seat in parliament, taking advantage of the female quota requirements and turned into a puppet by her husband. She meets other female parliamentarians, characters I modeled on real women, who are some of the most fiery and brave politicians to walk the earth. I wrote these women into the story deliberately, as they are largely unseen. And yet, in more book club discussions than I can count, people have shaken their heads at how horrible it is that women politicians are controlled by male puppet-masters.

There is no way for a single character to represent a body of people and yet much is extracted from individual characters. (I doubt Paula Hawkins worried about the assumptions people would make about women commuters while she was writing The Girl on the Train.)

I have been asked surprising questions. No, my marriage was not arranged. My mother-in-law does not terrorize me. And, no, I have not received threats from angry Afghan men. I don't mind the questions. I glean from them where the gaps are and how I can start to fill them in with another story.

Sparks Like Stars was partly inspired by the surprise that meets me when I talk about my mother graduating from Kabul University with an engineering degree or when I talk about the American presence in Afghanistan in the 60s and 70s.

In 2009, I came upon a newspaper article about the coup of 1978 and the mystery of where the president and his family's remains were buried. I kept the articled pinned to an idea board, returning to it two years ago. In the late 1970s, Kabul hosted visitors from around the world. The home of my parents' youth, the city that thrummed with music and fashion shows.

The details were mesmerizing. In interviews, American foreign service officers stationed in Kabul in the late 70s called it a party post. They hosted cocktail parties with an international crowd. Travel guides for hippies expending their wanderlust energies described how to avoid the camel scam when crossing the desert and gave other priceless bits of advice like, "Get stoned but don't make a public affair of it."

I started plucking away at characters. My first draft of Sparks Like Stars had two narrators: Sitara, an Afghan girl who survived a brutal coup, and an American foreign service officer who saw events in Kabul through her American lens.Like the reader in the Facebook group, I'd been wanting to see a book that explored the history of the relationship between the United States and Afghanistan. I wanted to expand the narrative not only of Afghan women, but of the relationship between Americans and Afghanistan. There was much to dissectcolonialism, plundered antiquities, and the creation of the Third World by the Cold War.

Several chapters in, I realized I wasn't just trying to dismantle stereotypes about Afghan women. Rambo epitomized the American savior trope. At a time when the United States has been planning an exit from its longest war, it felt important to revisit the early days of the US-Afghanistan relationship. Sparks Like Stars is meant to echo that complex dynamic in miniature form.

Stereotypes aren't dismantled by a single book. But expanding the corpus of Afghan stories and including authentic voices moves us closer to restoring Afghan women to their full height and decolonizes Afghan history.

ore than 82 per cent of laptop distresses are hardware-related compared to just 18 per cent of software related, according

The over usage of laptops and not being aware of how to correctly maintain them has led to a spike in the number of laptop problems reported by consumers. Within hardware, while display and keyboard related problems were expected to be the topmost, surprisingly Wi-Fi connectivity emerged as the highest that stood at 27 per cent of all laptop service requests.

As many as 18 per cent accounted for keyboard and the trackpad related issues followed by display at 15 per cent and battery and charging related glitches at 8 per cent.

All other hindrances, such as audio, bluetooth, exhaust fans, hard disk, overheating, physical damage, power button, and webcam, accounted for around just 2 per cent of laptops serviced.

In the software category, the primary concerns are around resource-hungry applications that accounted almost half (50 per cent) of all laptop service requests.

This is followed by whopping 41 per cent reporting their laptop getting hung in the middle of their usage due to inefficient background apps, malware or viruses and

lastly the issues faced due to windows updates stood at a minimal 4 per cent.

But getting a laptop priced above Rs 50,000 can cost anywhere between 40 per cent and 90 per cent of the laptop's price.

The report also finds that typically, customers spending more than Rs 50,000 tend to opt for laptops from Apple, and if opting for laptops below Rs 50,000, they prefer laptops sold by Acer, ASUS, Dell, HP, and Lenovo.

Study links eating processed meat to increased dementia risk

ou may want to cut down on the intake of processed meat such as bacon which could dramatically increase the risk of getting dementia. A new study found that eating just one rash of bacon a day could increase your chances of developing the disease by 44 per cent. The findings of the study, titled 'Meat consumption and risk of incident dementia: a cohort study of 493888 UK Biobank participants, were published in the American Journal of Clinical Nutrition. Scientists from the University of Leeds's Nutritional Epidemiology Group used data from 500.000 people, discovering that consuming a 25g serving of processed meat a day, the equivalent to one rasher of bacon, is associated with a 44 per cent increased risk of developing the disease.

However, meat-lovers need not despair, as their findings also showed that eating some unprocessed red meat, such as beef, pork, or yeal, could be protective. as people who consumed 50g a day were 19 per cent less likely to develop dementia. The researchers were exploring a potential link between consumption of meat and the development of dementia, a health condition that affects 5 per cent to 8 per cent of over 60s worldwide.

Lead researcher Huifeng Zhang, a PhD student from the University of Leeds' School of Food Science and Nutrition, "Worldwide, the preva-



lence of dementia is increasing and diet as a modifiable factor could play a role. Our research adds to the growing body of evidence linking processed meat consumption, to increased risk of a range of non-transmissible diseases." The research was supervised by Professor Janet Cade and Professor Laura Hardie, both at Leeds.

The team studied data provided by UK Biobank, a database containing in-depth genetic and health information from half a million UK participants aged 40 to 69, to investigate associations between consuming different types of meat and the risk of developing dementia. The data included how often participants consumed different kinds of meat, with six options from never to once or more daily, collected in 2006-2010 by the

UK Biobank. The study did not specifically assess the impact of a vegetarian or vegan diet on dementia risk, but it included data from people who said they did not eat red meat.

Among the participants, 2,896 cases of dementia emerged over an average of eight years of follow-up. These people were generally older, more economically deprived, less educated, more likely to smoke, less physically active, more likely to have stroke history and family dementia history, and more likely to be carriers of a gene that is highly associated with dementia. More men than women were diagnosed with dementia in the study population. Some people were three to six times more likely to develop dementia due to well-established genetic factors, but the findings suggest the risks from eating processed meat were the same whether or not a person was genetically predisposed to developing the disease.

Those who consumed higher amounts of processed meat were more likely to be male, less educated, smokers, overweight or hese had lower intakes of tables and fruits and had higher intakes of energy, protein, and fat (including saturated fat). Meat consumption has previously been associated with dementia risk, but this is believed to be the first large-scale study of participants over time to examine a link between specific meat types and amounts, and the risk of developing the disease.

There are around 50 million dementia cases globally, with around 10 million new cases diagnosed every year. Alzheimer's Disease makes up 50 per cent to 70 per cent of cases, and vascular dementia around 25 per cent. Its development and progression are associated with both genetic and environmental factors, including diet and lifestyle.

Zhang said, "Further confirmation is needed, but the direction of effect is linked to current healthy eating guidelines suggesting lower intakes of unprocessed red meat could be beneficial for health.'

Professor Cade said, "Anything we can do to explore potential risk factors for dementia may help us to reduce rates of this debilitating condition. This analysis is a first step towards understanding whether what we eat could influence that risk.'

Study uncovers language in which babies prefer to talk

study led by the University of California has found that babies who were exposed Lto two languages had a greater interest in an infant-directed speech that is, an adult speaking like a baby than adult-directed speech.

It can be hard to resist lansin into an exaggerated, singsong tone when you talk to a cute baby. And that's with good reason. Babies will pay more attention to baby talk than regular speech, regardless of which languages they're used to hearing, according to a study by UCLA's Language Acquisition Lab and 16 other labs around the globe.

Some parents worry that teaching two languages could mean an infant won't learn to speak on time, but the new study shows bilingual babies are developmentally right on track. The peer-reviewed study, published today by Advances in Methods and Practices in Psychological Science, found bilingual babies became interested in a baby talk at the same age as those learning one language.

"Crucially for parents, we found that development of learning and attention is similar in infants, whether they're learning one or two language es," said Megha Sundara, a UCLA linguistics professor and director of the Language Acquisition Lab. "And, of course, learning a language earlier helps you learn it better, so bilingualism is a win-win.'

In the study, which took place at 17 labs on four continents, researchers observed 333 bilingual babies and 384 monolingual babies, ranging in age from 6 to 9 months and 12 to 15 months. UCLA's lab was the only one to provide data on bilingual babies who grew up hearing both English and Spanish. Sundara and Victoria Mateu, a UCLA assistant professor of Spanish and Portuguese, observed babies who were 12 to 15 months old.

Each baby would sit on a parent's lap while recordings of an Englishspeaking mother, using either infantdirected speech or adult-directed speech, played from speakers on the left or the right. Computer tracking measured how long each baby looked in the direction of each sound.

"The longer they looked, the stronger their preference," Mateu said. "Babies tend to pay more attention to the exaggerated sounds of infant-directed speech.'

Infants' interest in English baby talk was very fine-tuned, the study

noted. Bilingual parents indicated the percent of time English was spoken at home compared to Spanish. The more English the bilingual babies had been exposed to, the stronger their preference for infant-directed speech compared to adult-directed speech. However, even babies with no exposure to English preferred the English baby talk to the grown-up talk, Mateu said.

Baby talk is found across most languages and cultures, but English has one of the most exaggerated forms, Sundara said.

"Baby talk has a slower rate of



speech across all languages, with more variable pitch, and it's more animated and happy," she said. "It varies mainly in how exaggerated it is."

Led by Krista Byers-Heinlein, a psychology professor at Concordia University in Montreal, the study involved labs in the United States, Canada, Europe, Australia and Singapore. The study's global reach strengthened the results, Sundara said.

'When you do language research, you want to know that the results aren't just some quirk of the language you're studying," she said.

According to the study, 6- to 9-month-old babies who had mothers with higher levels of education preferred baby talk more than babies whose mothers had less education.

"We suspect that perhaps the mothers with higher education levels spoke more to the babies and used infant-directed speech more often, Mateu said.

This study is one of the first published by the ManyBabies Consortium, a multi-lab group of researchers. Byers-Heinlein believes the unusual international, multilingual collaboration creates a model for future studies that include a similar breadth of languages and cultures.

Flu shot linked to fewer, less severe Covid cases

eople who received a flu shot last flu season were significantly less likely to test positive for a Covid-19 infection when the pandemic hit, according to a new study.

The study, published in the American Journal of Infection Control, also indicated that those who did test positive for Covid-19 had fewer complications if they

received their flu shot.

"It's particularly relevant for vaccine hesitance, and maybe taking the flu shot this year can ease some angst about the new Covid-19 vaccine," said researcher Hofmann, Associate Professor at the University of Michigan.

For the study, the research team included more than 27,000 patients who were tested for a Covid-19 infection in mid-July of 2020.

Of the nearly 13,000 who got a flu shot in the previous year,

4 per cent tested positive for Covid-19. Of the 14,000 who hadn't gotten a flu shot, nearly 5 per cent tested positive for Covid-19.

The association remained significant after controlling for other variables including ethnicity, race, gender, age, BMI, smoking status and many comorbid conditions.

The researchers found that people who received their flu shot were also significantly less likely to require hospitalisation, although the researchers didn't find a significant difference in mortality between the two groups.

"It is possible that patients who receive their flu vaccine are also people who are practicing more social distancing and following CDC guidelines. However, it is also plausible that there could be a direct biological effect of the flu vaccine on the immune system relevant for the fight against SARS-CoV-2 virus," the

Don't See Rating Downgrade For India: FM Nirmala Sitharaman

igher spending by the government will not result in a rating downgrade for India, which currently has an investment grade rating, Finance Minister Nirmala Sitharaman said on Wednesday.

Replying to a debate on Finance Bill 2021 in the Rajya Sabha, Sitharaman attacked the Congress-led UPA government for mismanaging

the economy. In her Budget speech, the finance minister had pegged India's fiscal deficit at 9.5 per cent in FY21 and 6.8 per cent in FY22. Hit by the coronavirus pandemic, India's gross domestic product (GDP) is likely to contract 8 per cent in FY21 before rebounding to a double-digit growth in FY22, albeit on a

Sitharaman said that under the Modi government, Indian economy has seen lower inflation, higher GDP growth, record foreign investments and lower fiscal deficit.

The measures taken in response to the 2008 global financial crisis by the UPA led to high inflation and 'taper tantrums', she said.

Comparing the GDP growth between the NDA and UPA governments, she said India's average GDP growth was 7.5 per cent between 2014-2019 as against 6.7 per cent during 2009-2014. Similarly, average inflation fell from 10.3 per cent under five years of UPA government to 4.8 per cent under the first five years of NDA

government, she said. Fiscal deficit has also been contained at 3.65 per cent of the GDP during 2014-19 as compared to 5.3 per cent in the previous five years, she said, adding current account deficit has also improved from (-)3.34 per cent to (-)1.43 per cent.

Foreign exchange reserves, the finance minister said, have grown from USD 303 billion in 2014 to USD 411.9 billion, while NPAs declined to Rs 8.99 lakh crore as of

Petrol, Diesel Can't Be Brought Under GST For Next 8-10 Years, **BJP MP Tells Parliament**

NEW DELHI: BJP leader Sushil Kumar Modi on Wednesday said it is not possible to bring petrol and diesel under the GST regime for the next eight to 10 years as it would cause an annual revenue loss of Rs 2 lakh crore to all states. tHE Centre and states collectively collect over Rs 5 lakh crore tax on petroleum products, Modi told the Rajya Sabha while participating in a discussion on the Finance Bill 2021. The statement assumes significance in view of the rise in petrol price for the past over one year which even touched Rs 100 per litre in some states.

In the first reduction in rates in over a year, petrol price on Wednesday was cut by 18 paise per litre and diesel by 17 paise a litre as international oil prices tumbled to the lowest since early February. Petrol price was cut to Rs 90.99 a litre in Delhi from Rs 91.17 per litre. Diesel now comes for Rs 81.30 a litre in the national capital, down from Rs 81.47 previously. Rates have been reduced across the country and vary from stateto-state depending on the local incidence of taxation (VAT). This is the first reduction in fuel prices in over a year. The prices were last

reduced on March 16, 2020. "It is not possible to bring petrol and diesel under GST regime in the next eight to 10 years because states would not be ready for an annual revenue loss of Rs 2 lakh crore (collectively by all states)," Modi told the House. "If petrol or diesel would be brought under the Goods and Services Tax



loss of Rs 2 lakh crore revenue to states be recovered. The Centre and states together earn over Rs 5 lakh crore from tax on petroleum products," he said.

He explained that if petroleum products are brought under the GST, 28 per cent tax would be collected on them as that is the highest slab in the tax regime. "Presently, 60 per cent tax is being collected on petroleum products. This would result in shortfall of Rs 2 lakh crore to 2.5 lakh crore (to both Centre and states)," he explained in the House. "If we collect 28 per cent tax on petroleum products, then only Rs 14 would be collected (per litre) against Rs 60 at present," he pointed out. "If petrol or diesel price is Rs 100 (per litre) then the tax component is Rs 60 which includes Rs 35 for Centre and Rs 25 for respective states. Besides out of the Rs 35 tax per litre, 42 per cent goes to states." Modi added

Taxes From Petrol, Diesel Matter

He also stated,"It is said that tax collected on petrol, diesel goes into the pocket of government. There is no separate pocket of government. From where the money will come for providing electricity and tap water to all households. The spending of tax collection on welfare of country is being challenged."

Reacting to remarks against the GST regime, he said,"Some people also said that this is Gabbar Singh Tax. No state has opposed the tax structure of GST in any GST Council meeting. You can see the proceedings of the council (to verify that)," he said. He stressed that only the government under the leadership of Prime Minister Narendra Modi had the guts to implement the GST regime in the country.

India Antitrust Watchdog Orders Probe Into Whatsapp's New Privacy Policy

NEW DELHI: India's competition watchdog on Wednesday ordered a probe into a privacy policy update announced by Facebookowned WhatsApp, saying the messaging service breached antitrust

WhatsApp said in January it was updating its privacy policy to allow it to share some user data with parent Facebook and other companies in the group, prompt-

ing a global back- lash against the messaging app, including in India, its biggest market, with more than 500 million users.

The antitrust order also comes as WhatsApp sets out to expand its digital payment services to millions of Indians.

The Competition Commission of India (CCI) said WhatsApp had violated competition laws "through its

exploitative and exclusionary conduct ... in the garb of policy update."

The 21-page order also asked its investigation unit to conduct the probe and submit a report within 60 days. Such probes typically take several months.

WhatsApp's conduct in sharing users' data with other Facebook firms, in a way that is "neither fully transparent nor based voluntary and specific user consent", appears unfair to users, the watchdog added.

The CCI said WhatsApp had told the antitrust body that the policy update, which becomes effective in May, raised no competition law concerns.

WhatsApp did not immediately respond to a request for comment on Wednesday.

In India, users concerned about privacy have downloaded rival apps such as Signal and Telegram, according to data from research firms.

Centre Blames Economic Failures On Covid-19 Pandemic: **Deepender Singh Hooda In RS**

NEW DELHI: Participating in a debate on the Finance Bill 2021 in the Rajya Sabha on Wednesday, Deepender Singh Hooda, the Congress MP from Haryana, targeted the economic policies of the Central government and said the Centred had pinned the blame of economic failures on Covid-19 pandemic.

Hooda alleged the economy has derailed due to the wrong policies of the Central government. Mismanagement during of demonetisation, Goods and Services Tax (GST) and Covid-19 has forced the economy to be put on ventilator support. India was the among the countries with the highest decline in GDP due to Covid-19.

Hooda said,"What was the pace of the economy during the United Progressive Alliance (UPA) rule and what is it now during the National Democratic Alliance (NDA) dispensation? The 10-year average GDP growth during the UPA government was 7.8 per cent. If we were to consider the base year of calculating GDP today, it would be 11 per cent. While the six-year precovid period from 2014 to 2020 had witnessed a GDP growth rate of 6.8 per cent. This means that the growth rate has reduced rather than increase."

The son of former Harvana Chief Minister Bhupinder Singh Hooda said that any economy stands on four legs - consump-

tion and demand, investment, export and government expenditure. Comparing these four indicators, the economy's condition during the UPA and NDA regimes becomes clear.

Hooda further said,"If you compare the 10-year UPA dispensation and six years of NDA rule the industrial investment growth rate at the time of UPA was 14 per cent, today it has come drastically down to only two per cent. The rate of credit and bank loans was 13 per cent at the time of UPA, it has come down now to four per cent. The private consumption growth ie demand, which was 24 per cent at the time of UPA, has now come down to nine per cent. The corporate sales growth rate was 12 per cent at the time of the UPA, today it has halted at just three per cent in the last six years."

The Congress MP said that since demonetisation, the economy started derailing, GST broke the backbone of the economy but mismanagement during the Coronavirus pandemic has led the economy to the intensive care unit.

Hooda said Arvind Subramanian, who was the Chief Economic Advisor to the Modi government, had said in 2020 that the economic slump was not a common situation. "Since the last 30 years, the country has not witnessed such a slowdown. However, the Central government deliberately attempted to blame the economic failures on Covid-19 pandemic."

Fuel Prices Fall On Sharp Decline In Global Rates

NEW DELHI: Consumers can heave a sigh of relief as oil marketing companies (OMCs) have finally relented and reduced the retail price of petrol and diesel after keeping them steady for the past 24 days.

This is the first reduction in petrol and diesel prices in 2021.

Petrol price fell by 18 paise per litre and diesel by 17 paise per litre in Delhi on Wednesday. This has brought down the retail price of petrol to Rs 90.99 and diesel to Rs 81.47 a litre, respectively in the capital.

Across the country as well, the petrol and diesel price fell with the quantum varying on the level of local levies on respective states.

In Mumbai and Kolkata, the retail price of petrol fell by 17 paise per litre each and in Chennai by 16 paise per litre on Wednesday. For diesel, the prices fell by 16 paise, 17 paise and 18 paise per litre respectively in Chennai, Kolkata and Mumbai.

In Mumbai, petrol is now priced at Rs 97.40 a litre from previous days price of Rs 97.57 and diesel in the city is now priced at Rs 88.42 a litre from the previous price of Rs 88.60 a litre.

Premium petrol, however, continues to remain over Rs 100 a litre in the city as is the case with several cities across the country.

Petrol and diesel prices were last revised upwards on February 27 and ever since then, retail prices remained unchanged even though during the period, crude jumped to over \$70 a barrel only to start falling and touching close to \$60 a barrel now.

Sources said that oil companies took time to revise petrol and diesel prices downwards as they were covering up for losses incurred on its sale when crude was high and retail prices remained static. Some indications suggest that there was a loss of Rs 4 and Rs 2 per litre on sale of diesel and petrol, respectively earlier that had now been more or less covered.

The current reduction in retail prices has not helped in bringing down fuel prices that have crossed Rs 100 per litre-mark in several parts of the country and continue to remain above the levels even now.

Since the beginning of February crude has gained more than \$7 per barrel that pushed OMCs to increase fuel prices on 14 occasions raising the prices by Rs 4.2 per litre for petrol and by Rs 4.34 a litre for diesel in Delhi.

Crude has now slipped around 10 per cent in the last eight days and is now sitting a tab lower around \$60 a barrel on the back of rising US inventory and concerns on demand squeeze over a new wave of the pandemic

The petrol and diesel prices have increased 26 times in 2021 with the two auto fuels increasing by Rs 7.46 and Rs 7.60 per litre, respectively so far this year. This is for the first time it has fallen this year.

Officials in public sector oil companies said that retail prices may rise again if crude and product prices increase but for now it will fall over the next few days.

Amazon Names Former Exec Adam Selipsky As The New Head of AWS

Amazon has named Salesforce executive Adam Selipsky as the replacement for Andy Jassy, the longtime chief of Amazon Web Services (AWS) and the company's next CEO when founder Jeff Bezos steps down later this year. Selipsky worked at AWS for more than 10 years, raising to the rank of vice president of sales and marketing, before running the startup Tableau, which is now part of Salesforce. Selipsky's hiring was first reported by CNBC, which published a memo Jassy sent to Amazon employees on Wednesday announcing the news.

"Adam brings strong judgment, customer obsession, team building, demand generation, and CEO experience to an already very strong AWS leadership team. And, having been in such a senior role at AWS for 11 years, he knows our culture and business well," Jassy wrote in the memo. Selipsky joined Salesforce when the cloud computing giant acquired Tableau in a monstrous \$15.7 billion



team since as Tableau's acting CEO.

There was speculation as to whether Amazon would promote an existing AWS executive to take over Jassy's role. Eyes were on Matt Garman, who was promoted to the top sales role last year, and Peter DeSantis, the general manager of AWS's EC2

business, as potential candidates. Ultimately, it looks like Jassy turned to a former colleague - and someone with a pretty stunning track record helping to push a midsized software company toward a \$15 billion acquisition — as the top choice for his replacement to run AWS. Selipsky will rejoin Amazon in May, when he and Jassy will be "transitioning together" into their new roles in the lead-up to Bezos' move to executive chairman of the board. "With a \$51B revenue run rate

that's growing 28% YoY (these were the Q4 2020 numbers we last publicly shared), it's easy to forget that AWS is still in the very early stages of what's possible," Jassy wrote in the memo, referencing the less than 5 percent of global IT spend occurring in the cloud computing market. "We have a lot more to invent for customers, and we have a very strong leadership team and group of builders to go make it happen."

After Smartphones, Smartwatch, Oneplus Gears Up To Launch Office Devices Agenceis

nePlus is not settling after the launch of the new smartphone series and the first smartwatch. The brand is now making investments to launch devices in new categories including in the smart office space, a top company executive has said.

Indus Commissioners" Meet Concludes; Pak Raises **Objection To Designs Of Hydropower Projects in J-K**

NEW DELHI: The two-day meeting between India and Pakistan under the Indus Waters Treaty concluded here on Wednesday, during which Islamabad raised objections to the designs of Pakal Dul and Lower Kalnai hydropower projects in Jammu and Kashmir.

Sources said Pakistan also sought additional information on hydropower projects in Ladakh sanctioned by India after the nullification of special provisions of Article 370 which gave special status to Jammu and Kashmir.

On its part, India justified its stand on the designs of Pakal Dul and Lower Kalnai hydropower projects.

The meeting took place here after a gap of over two years. The last meeting had taken place in Lahore in August 2018.

The Indian delegation was led by P K Saxena, India's Indus Commissioner,

and his team included officials from the Central Water Commission, the Central Electricity Authority and the National Hydroelectric Power Corporation.

The Pakistani delegation was led by its Indus Commissioner Syed Muhammad Meher Ali Shah. The delegation arrived here on Monday evening.

The waters of the Indus river and its tributaries are crucial to India and Pakistan and serve as a lifeline for millions of people of the two nations.

This year's meeting is the first between the two commissioners after the August 2019 nullification of the provisions of Article 370 of the Constitution that gave special status to the state of Jammu and Kashmir.

The meeting also assumes significance as this is the first important engagement between India and Pakistan after militaries of the two countries had announced last month that they would strictly observe a ceasefire along the Line of Control and other sectors.

In 2019, the erstwhile state of Jammu and Kashmir was also bifurcated into union territories -- Ladakh

and Jammu and Kashmir. India has since cleared several hydropower projects for the region.

Hydropower projects in Chilling (24 MW), Rongdo (12 MW) and Ratan Nag (10.5 MW) are in Leh; while Mangdum Sangra (19 MW), Kargil Hunderman (25 MW) and Tamasha

(12 MW) are in Kargil. Both Leh and Kargil fall in the Union Territory of Ladakh.

Pakistan has sought information on these projects, sources added.

The Indus Waters Treaty (IWT) warrants the two commissioners to meet at least once a year, alternately in India and Pakistan.

Last year's meeting scheduled to be

held in New Delhi in March was cancelled, a first since the treaty came into being, in view of the coronavirus

In July 2020, India had proposed to Pakistan that the meeting for discussing pending issues pertaining to the Indus Waters Treaty be held virtually in view of the coronavirus pandemic, but Pakistan insisted on holding talks at the Attari border checkpost.

However, India said it was not conducive to hold the meeting at Attari due to the pandemic. With the improvement in the pandemic situation, the meeting was held following all COVID-19-related protocols.

Under the Indus Waters Treaty signed between India and Pakistan in 1960, all the waters of the eastern rivers -- Sutlej, Beas, and Ravi -amounting to around 33 million acre feet (MAF) annually is allocated to India for unrestricted use.

Dates For Re-Poll In Two DDC Constituencies Of North Kashmir Soon: Election Officer

JAMMU: Jammu and Kashmir State Election Commissioner (SEC) K K Sharma on Wednesday said the dates for re-polls in the two DDC constituencies of Dragmulla and Hajin-A in north Kashmir will be announced shortly.

Sharma was speaking at a review meeting convened here to discuss the re-poll in the two District Development Council (DDC) constituencies, where the counting was earlier kept in abeyance to clear the citizenship issues of two of the contesting candidates in December last year.

The meeting was held at the Nirvachan Bhawan and was attended by the divisional commissioner of Kashmir and the deputy commissioners of Kupwara and Bandipora through video-conferencing and other senior officers of State Election Commission, an official spokesperson said.

"At the very outset, the meeting was briefed about the commission's order, whereby the poll process for these two constituencies, Dragmulla in Kupwara district and Hajin-A in Bandipora district, has been extended up to March 31. The comments of the participants regarding issues (if any) pertaining to the conduct of re-poll in these two DDC constituencies were also invited and discussed," he said.

He said the divisional commissioner of Kashmir and the deputy commissioners of both the districts invited attention of the SEC towards the prevailing weather conditions in the valley.

The SEC, while appreciating the inputs of participants, asked them to take all the preliminary steps needed for the upcoming re-polls for which the commission would shortly announce dates, the spokesman said.

The maiden DDC elections to 280 seats -- 14 each in 20 districts -- were held in November-December last year and the results declared for 278 seats.

Section 50 of the PMLA empowers the authority, that is, officers of the ED, to summon any person to give evidence or produce records. Persons summoned are bound to answer the questions put to them and to produce documents as required by the ED officers, failing which they can be penalised under the PMLA.

The PDP leader had said, "I state that I am not in a position to attend the summon on 22nd March as I have prior commitments that cannot be cancelled at such short notice".

"If however you insist we must do it sooner, I am ready and willing to be questioned in Srinagar, preferably at my residence or through video conference from Srinagar," Mufti had said in her letter. (PTI)

Missing Soldier's

"I would have long died." The unending mystery and unthinkable search stemmed on August 2, 2020, when Wagay's son, Shakir Manzoor, 24, a rifleman with the 162 Battalion of Indian Army's Territorial Army unit, had come home to cel-

ebrate Eid. Later, driving back in his car to his base camp in Balapora Shopian, he was cut short and allegedly abducted by militants.

Wagay later found Shakir's TaTa Brezza torched in Rambhama area of neighbouring Kulgam district.

"Ī knew the militants who abducted him," Wagay continued. "I even went to their families but it never helped." However, the only clue apparently sealing the fake of Wagay's soldier son was an unveri-

fied audio surfacing on social media a week after the abduction. A person, suspected to be a militant, can be heard claiming to have killed the abducted

"We can understand his family's pain but we can't return his body to them because of coronavirus — so that a lot of people don't gather for his funeral, in the same way that the army hides and buries the bodies of dead Mujahideen

in unmarked graves," the voice said. Earlier, as contagion enforced another lo down in the valley, the police started denying bodies of local militants to their families on the ground of "maintaining strict Covid protocol". In a video appeal, Wagay made fervent appeals to militants to handover the body of his

"If he has died, please return his body. That is our right. My son was in the Army. It is your job to fight them (Army). I have no complaints against you if you have killed him, but I will have a complaint if his body is not returned."

Following this, the villagers found Shakir's ripped and blood-stained clothes at three different places in an orchard near his home.

"With that, we lost the hope of Shakir being alive," said Nazir Ahmad, the missing soldier's

"Our only wish was to see him one last time, but we don't see that happening.' Even Shakir's mother, said Wagay, has do-

nated her gold to faith-healers for the farewell A day after Shakir's disappearance, army tweeted a statement, saying that they suspected that the soldier had been abducted by

militants and his burnt car was found. Later, on August 28, 2020, Kashmir police chief, IGP Kashmir Vijay Kumar said that two militants, Shakoor Parray, and his associate Suhail Bhat, "who were involved in Shakir's abduction", were killed in a joint operation of government forces.

"As of now," Amritpal Singh, SSP Shopian, told Kashmir Observer, "we're interrogating all possible persons who may have any knowledge about Shakir Manzoor. We're doing whatever is possible to crack this case."

Back home, Wagay recalled his son's army stint over incessant smoking drags. After joining army in 2016, Shakir was posted

to his home district.

On the fateful day, Wagay had warned him not to visit home frequently, as he had apprehensions that he might be killed. "But he was fearless," the father said. "He

Virat Kohli, Rohit Sharma Move Up In ICC T20 Rankings

DUBAI: India captain Virat Kohli moved up a place to fourth in the ICC T20 rankings for batsmen, while his deputy Rohit Sharma climbed three spots to 14th in the latest list issued on Wednesday.

Kohli, who slammed an unbeaten 80 off 52 balls coming in as an opener in the series against England, is now the highest-ranked from India ahead of K L Rahul.

Rohit's 34-ball 64 in that match has helped him move up three places to 14th in the weekly update which took into account the three-match Afghanistan-Zimbabwe series in Abu Dhabi apart from the last two matches of the India-England series, the ICC stated.

In other gains for India's batsmen, Shreyas Iyer has moved up five places to a career-best 26th position while rookie Suryakumar Yadav and wicketkeeper-batsman Rishabh Pant too have made rapid progress.

Yadav, who debuted in the second match of the series but could not garner any points as he did not get to bat, has pushed up from the bottom to 66th position after scores of 57 and 32 while Pant has moved up 11 places to 69th in the rankings. Seam bowler Bhuvneshwar Kumar, player of the match in the last game for his spell of two for 15, has moved up 21 places to 24th while Hardik Pandya has advanced 47 places to 78th.

For England, Dawid Malan maintains a healthy lead at the top of the rankings after his 68 in the final match while Jos Buttler has inched up one place to 18th.

Leg-spinner Adil Rashid (up one place to fourth) and fast bowlers Jofra Archer (up 12 places to 22nd) and Mark Wood (up 12 places to 27th) have advanced in the bowlers' list.

In the ODI rankings, Jonny Bairstow is up four places to a careerbest seventh position after his knock of 94 in the opening match of the series against India in Pune on Tuesday.

Lahiru Thirimanne and Oshada Fernando kept up Sri Lanka's concerted fight back on Tuesday, batting the tourists into a strong position at 170-1. Thirimanne made 76 to follow his 70 in Sri Lanka's first innings and Fernando made 91 in a partnership of 162 for the second wicket from 301 balls.

Kyle Mayers then struck back for the West Indies, dismissing Fernando for his first wicket in tests, then adding the wicket of the out-of-form Dinesh Chandimal (4), both caught by wicketkeeper Joshua Da Silva.

When Kemar Roach bowled Thirimanne, Sri Lanka was 189-4, 87 ahead, after having lost three quick wickets for 19 runs.

Dhananjaya de Silva and Pathum Nissanka then rallied Sri Lanka agair putting on 66 in an unbroken fifth wicket partnership by stumps. De Silva was 46 and Nissanka 21 at close of play.

'Got Dad's Bag To Dressing Room To Keep Him Close,' **Reveals Krunal Pandya**

PUNE: India all-rounder Krunal Pandya had his late father Himanshu's travel bag in the dressing room as he tried to keep him close ahead of his outstanding ODI debut in which he smashed the fastest 50 by a debutant.

Celebrating his 30th birthday on Wednesday, Krunal and his younger brother and star all-rounder Hardik Pandya spoke about the close relationship they shared with the Senior Pandya, who died of a heart attack in January.

"So basically the thing is, he passed away on 16th morning and I was playing Syed Mushtaq Ali on that day. He had a habit of keeping his clothes ready in the night, his shoes, his pant, his shirt, hat as well.

"So what I did was just before the game, I got his bag from Baroda here, and I thought, I know he is not with us, but those clothes, which he was supposed to wear in that game, I thought I'll bring that and keep in the dressing room," Krunal revealed on BCCI's official website.

Apart from his 58-run knock, Krunal also picked up a wicket in the game, against England, which India won by 66 runs to take a 1-0 lead in the three-match series. He broke down while speaking to the host broadcaster after the match and was comforted by his brother.

"Obviously, I worked so hard to be here...not just in cricket, but in terms of everything, taking care of my diet to fitness, to everything and again this is all dedicated to the old man...his blessings are there with us, and obviously it was very emotional for you and me, both of us, and again getting a

cap from you," Krunal told Hardik. Kruna has gone through a lot in the past few months. After being dropped from the Indian T20 team, he was caught in a spat with all-rounder Deepak Hooda before losing his father, who had played a key role in making him a cricketer.

India captain Smriti Mandhana credited the third match win to team effort.

"It was a good show overall. The bowlers did exceptionally well, and Shafali then just stole the show. This victory belongs to the bowlers," Mandhana, who carried her bat with an unbeaten 48 off 28 balls, said.

Asked if toss, which India won on Tuesday, was too important, she said. "Definitely not. We were pretty much in the game yesterday (second match) till the very end.

After Winning Gold, Chinky Yadav Says, 'Sometimes, I Feel Pressure'

NEW DELHI: She is an Olympic quota holder but the occasional thought about whether she would compete in the Tokyo Games leaves Chinky Yaday worried, thanks to the incredible depth of talent in Indian shooting.

While a quota definitely puts a shooter at an advantage, it need not necessarily mean a ticket to the Olympics for everyone. As per the selection policy of National Rifle Association of India (NRAI), few shooters are picked based on their scores in trials and competitions leading up to the showpiece.

"Sometimes I think about Olympic selection and I feel under pressure, but I also tell myself that whatever happens I will see, I will try my best," Yadav said.

The Olympics will be held from July 23 to August 8.

On Wednesday, Yadav strengthened her case for selection with a gold medal in the women's 25m pistol ahead of Rahi Sarnobat and Manu Bhaker in the ISSF World Cup.

"I hope I am picked in the team." Working with a psychologist has helped Yadav immensely.

By her own admission, she was under the pump and was sweating, as she got locked in a tussle with the experienced Sarnobat for the gold. The 23-year-old, though, held her

nerves to prevail in a shoot-off. "Besides my coaches, we also have a psychologist ma'am working with us and she supports us a lot.



"The mental thoughts are controlled through meditation."

The shooter from Bhopal, who began her tryst with the sport when she was 12, secured an Olympic quota at the 14th Asian Championships in Doha in 2019.

Speaking about the Wednesday's final, she said, "I have trained in advance for tie shoots in final, I just had to do my best, not think who is in competition with me and which level they are in.

"Also, whenever I shot badly I forget that and look for a fresh start, I am very happy to win my first individual senior world cup medal.

"I have been told by the coaches and psychologist that I have got to trust in my own abilities."

Yadav, who switched to 25m pistol in 2013 after starting with 10m, ad-

"I was under a lot of pressure, I was sweating, there was vibration in my body, but I focussed on my technique,

and to control the vibration I focussed on my breathing sequence. Pressure is there in every competition but it is more when we expect too much."

Asked about the beginning of her journey, she said, "It started in 2012, my father lives in a sports campus in Bhopal, 21 to 25 sports are played in that academy and I came to know that shooting is also there.

"In 2013, I moved to 25m and within one year. I was in the squad and from next year I started participating in competitions. So I have been a part of the junior team for a few years and then when I graduated to senior I had a one year break, during which I did training."

DUBAI: Indian football team head coach Igor Stimac on Wednesday revealed that he was in tears after watching the footage of his side's defeat to Oman despite leading till the 82nd minute of their opening World Cup Qualifier in 2019.

India were leading 1-0 through a 24th minute strike from talismanic Sunil Chhetri in the first match of the 2022 World Cup Qualifiers against Oman in Guwahati in September 2019, but the Gulf country scored two late goals to emerge winners.

"When I looked back at earlier matches, I cried a few times. That first match (against Oman) was crucial, that match was going to determine whether we are going to fight for first two positions in group (and qualify for next round)," Stimac said at a virtual press conference.

"As it happened, with bad luck or inexperience (of players) in such important games, we fell down and that was something I always cry about.

"I felt sorry, not for myself because I have faced similar situations during my career, but for the players," he said ahead of In-



Oman here on Thursday.

Stimac said that there is no "good quality" players currently playing in the I-League who could be picked for the national team. All the players in the 27-member squad are from the teams of the Indian Super League which has become the toptier event in the country.

"At the moment there is no such player (in I-League) who has quality to be able to join the national team. There is nothing to hide about it. All the best players from I-League are supposed to become part of ISL because they are all followed by ISL clubs scouting.

"Venkatesh from my staff is following all the players of the I-League. But the door is open and according to the feedback from the I-League scouting system we are going to act," he added.

Stimac said the team was starting from the scratch after disruption by COVID-19 pandemic and added that he would not expect much from them in the two matches. India play UAE in the second friendly on Monday.

"We were planning a lot of things last year like change in scheduling of season, more games, Super Cup etc but the pandemic has destroyed everything. The

team also has to start from the scratch though the players have played in ISL. International matches are altogether different.

"We wanted to give them the experience of playing stronger teams, that will give them more confidence and fearlessness in future. I have told them there should not be any pressure on them." Talking about Oman, Stimac

said, "I have seen their match against Jordan. They are a really physical side, well organised and really patient. We also have worked hard and we expect a good game tomorrow.

Oman are coming into Thursday's match after playing out a 0-0 draw against Jordan on March 20.

Senior player and key defender Sandesh Jhingan said the respect other Asian teams have for the current Indian side was not there 10-15 years back.

CBSE Launches Competency Based Assessment Framework Aligned With NEP For Classes 6 to 10

NEW DELHI: The Central Board of Secondary Education (CBSE) on Wednesday launched a competency-based assessment framework for classes 6-10 for three subjects-English (reading), Science, and Maths.

The framework is a part of the CBSE Competency Based Education Project that aims to replace the existing rote learning model as directed in the new National Education Policy (NEP) over the next 2-3 years.

"The nev policy 2020 envisages a significant shift in the education ecosystem in India. It aims at preparing students for the 21st century and lays emphasis on competency-based education rather than an education which tests rote learning.

"The CBSE has had a collaboration with British Council and three UK agencies, Cambridge, NARIC and Alphaplus who are helping CBSE in attaining this objective. The work has already started, and significant progress has been made and we do look forward to this co-operation and working with British Council in the future," CBSE Chairman Manoj

Ahuia said. The framework is the basis for a larger project exercise currently underway where 40 assessment designers, 180 test item writers and 360 master trainer mentors are being trained in using this framework to create model question bank and collection of ideal lesson plans.



In the first phase selected Kendriya Vidyalayas, Navodaya Vidyalayas, UT Chandigarh and private schools the programme which will be rolled out to all 25,000 CBSE schools in India by 2024.

Barbara Wickham OBE, Director India, British Council, said "Education and research collaboration is central to the India-UK relationship. The reformed assessment framework will support high quality teaching for both an improved learning experience and outcomes for all students in CBSE schools".



Centre Allays Concerns on Covishield; Says Both COVID-19 Vaccines In India Effective Against UK and Brazilian Variants

NEW DELHI: Covishield is safe and there is "no signal of concern" regarding it as of now, the Centre asserted on Wednesday amid reports of possible side-effects of the Oxford-AstraZeneca's COVID-19 vaccine and its suspension in some European countries.

The AEFI committee which closely keeps track and records adverse events following immunisations has "concluded that thrombosis events due to Covishield in India is not a problem".

"There is no signal whatsoever for this concern. Covishield is safe, please proceed with its scale-up and uptake. We want to assure that there is no risk of blood clotting-related complications that were suspected in some nations with Covishield," NITI Aayog member (Health) Dr V K Paul said in response to a query at a press conference.

ICMR Director General Dr Balram Bhargava said that both Covishield and Covaxin are ef-



fective against the UK and the Brazilian variants.

He was asked if the vaccines that are being used right now in India are effective against the three new variants of concernthe UK variant, South African variant and the Brazilian variant. "It is well established by

research studies in published literature that the vaccines available in our country-both Covishield and Covaxin—are effective against the UK and the "The research work regarding

the South African variant is ongoing at the moment," he added. Paul urged the people not to doubt the efficacy of the vaccines.

"Please don't spread doubt. As of today, these vaccines work on the good old virus as well as the new variants," he said.

He appealed to people to follow COVID-appropriate behaviour and use vaccination as a tool to battle this second peak. — PTI

The Delhi Cabinet Wednesday approved the doorstep delivery of a ration scheme to be rolled out without any name after objections by the Centre of its naming as Mukhyamantri Ghar Ghar Ration Yojana. "The original name of the

scheme, Mukhyamantri Ghar Ghar Ration Yojana, which was expected to be rolled out on March 25, will not have any name due to the obstruction by the Centre. Under the new scheme, wheat flour atta, rice, and sugar will be delivered to homes in packed bags," an official statement by the Delhi government said.

Following the objections raised by Centre, Chief Minister Arvind Kejriwal had announced on Saturday, "This scheme will have no name. The central government sends the ration which gets distributed through the ration shops and now we will send the ration to the homes of the individuals. We do not want any kind of credit for this scheme and that is why the name



of the scheme will be removed."

"No mention of Mukhyamantri will be there. We have called a cabinet meeting in the coming week where this idea will be passed. This will not be any new scheme and this will not have any name. After the cabinet nod, we will send the decision to the central government and I am very hopeful that this time they will approve our decision." he had said.

Now, taking ration at subsidised rates from a Public Distribution System (PDS) shop will become optional.

Indian National Sentenced To 2 Years For Deleting Company's 1200 Users Accounts

n Indian national has been sentenced by a US court in California to two years in prison, who after being fired by his company accessed its server and deleted over 1,200 Microsoft user accounts, according to a statement. Deepanshu Kher was arrested

when he flew from India to the United States on January 11, 2021, unaware of the outstanding warrant for his arrest. This act of sabotage was destructive for this company, said Acting US Attor-

ney Randy Grossman on Tuesday. In pronouncing the sentence, US District Court Judge Marilyn Huff noted that Kher perpetrated a significant and sophisticated attack on the company, an attack which was planned and clearly intended as revenge.

In addition to the two years in custody, Judge Huff sentenced Kher to three years' supervised release and restitution to the Company of



\$567,084, the amount that the Company paid to fix the problems which Kher caused. According to court documents, Kher was employed by an information technology consulting firm from 2017 through May 2018. In 2017,

the consulting firm was hired by the Carlsbad Company to assist with its migration to a Microsoft Office 365 (MS O365) environment. In response. the consulting firm sent its employee. Kher, to the company's Carlsbad head-

The company was dissatisfied with Kher's work and relayed their dissatisfaction to the consulting firm soon after Kher's arrival. In January 2018, the consulting firm pulled Kher from the company's employees and completely shut down the company for

As the company's Vice President of Information Technology (IT) ex-

Give 3-day Notice To Arnab In Case Of His Arrest: HC to Police

MUMBAI: The Bombay High Court on Wednesday directed the Mumbai Police to give the advance notice of three days to Republic TV's editor-in-chief Arnab Goswami if it wanted to arrest him in the Television Rat-

ing Point (TRP) scam case. A bench of Justices SS Shinde and Manish Pitale also dismissed the submission of state counsel Deepak Thakre that Goswami had to face the investigation and could not claim any special status.

The bench noted the police had been investigating the case for three months now and was yet to name Goswami as an accused Goswami is named as a suspect in the

charge sheet, and therefore, the "sword" of

impending arrest is left hanging over his

head, it said. Goswami's counsel Ashok Mundargi had argued that the criminal law in the country did not provide for the police to name someone merely as a suspect and not name him or her as an accused in the charge sheet.



He had said the probe by the police against Goswami and other employees of ARG Outlier Media, which runs all Republic TV channels, was malafide.

In the charge sheet, the police had named Goswami and all owners, managers, and all persons associated with Republic TV or ARG media under the category of "suspects", Mundargi had said.

Without naming specific employees (in

the charge sheet) but saying that anyone associated with Republic TV or ARG media is a suspect gave very wide scope to the police to continue to "harass" the petitioners, even when there was no evidence against them. Mundargi said the police had reopened a 2018 (Anvay Naik) suicide case in which Goswami had been named as an accused and arrested him last year.

Goswami was released on bail by the Supreme Court, Mundargi said. The high court took note of this submission while granting relief to Goswami.

"This interim order is granted in the peculiar facts and circumstances of this case, keeping in view the serious malafide alleged by the Petitioners (Goswami and ARG media) against respondents (state government and the Mumbai police) and also keeping in view earlier actions taken by Respondent-State and its officials against the Petitioner No.2 (Goswami).

"If during the course of the investigation, you come across something and you want to take coercive action against petitioner number 2, then you will give 72 hours prior notice (to Goswami)," the bench said.

The HC, however, said Mundargi's request

for a stay on the investigation could not be granted as there was "no clarity on who was the accused and who was not".

Citing the material on record, the HC felt that the police did not have anything substantial against Goswami in the case.

The HC also accepted the Maharashtra government's statement that the probe against Republic TV and other employees of ARG Outlier Media will be completed within 12 weeks. The court was hearing a bunch of pleas filed by Goswami and ARG media challenging the probe and seeking several reliefs in the TRP scam case.

On Wednesday, the HC admitted the pleas and issued notices to the state and the Mum-

The bench said it will consider in the hearings, if the prayers made in the plea for quashing of the FIR, and a transfer of probe to the CBI could be entertained given that the petitioners were only suspects and not accused, "and if the police could continue investigating the case without naming Goswami and the others as accused".

The HC will hear the matter on June 28.

12-Year-Old Kerala Boy Dies Aping Hair-Straightening Act In Social Media

THIRUVANANTHAPURAM: 12-year-old boy died of burns he sustained while reportedly trying to imitate a hair-straightening act shown in the social media, police said on Wednesday.
