# Shuja Hussain: A Perfect Gentleman

Taking turns to recall the legend of the departed engineer, a multitude of masked mourners are endlessly detailing their own encounters with Syed Shuja Hussain who would always wear his dapper looks and diligence on his sleeves.

The solemn footfall is gathering mass and momentum inside a heritage house shadowed by a nearby paramilitary barrack in one of the peaceful pockets of plush Rajbagh locality of Srinagar.

A pitched tent in the middle of a manicured lawn is housing the mourners - who call the departed 'a longtime friend' and 'the gentleman they don't make anymore'.

"Engineer Shuja Hussain was a land-

mark man," says an elder inside the tent.

"His expert touches are visible in the major city and countryside signposts. The man's service is a shining example of a legacy one should leave behind as a professional."

While there seems no dispute on the departed engineer's robust legacy, his own tribe members are idolizing his methods and mentorship as part of their farewell speech. "An engineer of his own repute," says Er

Manzoor Nawchoo. "A great human being who helped everyone," says Gazi Ahmad, a government official. "A life so beautifully lived deserves to be beautifully remembered," says Nisar Gilani. "A great personality, very charming and always dapper," says Muzzafar Shah of ANC.

Amid this torrent of tributes, Er Shuja Hussain's lawyer son, Syed Zulfikar Hussain, is swarmed by black coats in the lawn.

After his grandfather Syed Nisar erstwhile Hussain—the Wazire-Wazarat-retired as Financial Commissioner, Zulfikar says his father sustained the family's service culture as an engineer.

"Growing up, we had this impression that the Hazratbal shrine was constructed by our father only," Zulfikar says.

"We learned it much later that he had only finished the project. But such was his sway that his name became synonymous with the shrine project."

Today, that shimmering white marvel on the banks of Dal Lake remains one of the major engineering feats of his career. However, the celebrated civil engineer, Zulfikar says, was equally adept in bridges and buildings.

"During his lifetime only, his workmanship never went unnoticed," the son savs.

"I remember during his posting in Anantnag, Mufti Mohammad Sayeed said that my father was his favourite engineer. Even during the Sheikh Mohammad Abdullah's • More On P10

# 5,972 People Illegally Occupy 10,000 **Kanals Of Govt Land In Srinagar: Admin**

Srinagar: The Provincial Commissioner Kashmir Saturday published the names of those who have occupied government land in the Srinagar district. These include government employees, farmers, traders, and others.

Following the directions of the Jammu and Kashmir High Court, the administration started compiling a list of beneficiaries of the Roshni

Act. The list also includes former ministers, businessmen, and bureaucrats.

A senior administration official said that the Revenue Department has already ruled out a move in the matter. "We are currently compiling a list of beneficiaries, which will be published later on the website,"

"So far we have collected the details of more than 15,000 people and more details are being collected," he added.

"After this operation, government land worth crores of rupees will be recovered," he said.

He said that under the Roshni Act, about 348,200 kanals of land have been given to the people. The Srinagar district administration has included the names of a former minister, a Congress leader and a businessman in its list in the Roshni Act case, he claimed.

According to sources privy to the developments, Former

Finance Minister Haseeb Drabu and his three relatives namely Shahzada Bano, Ejaz Drabu and Iftikhar Drabu have been named in the list.

# Pak support to Kashmiris dwindling: Geelani

EW DELHI - Observing that Islamabad's support to "Kashmiris' movement" had diluted lately, chairman of Hurriyat Conference (G) Syed Ali Shah Geelani today was Non-committal about his meeting with President Pervez Musharraf when he visits India next month. "I will think about it when I get an invitation." the hardline

leader was quoted as saying by PTI here when asked whether he would meet Musharraf considering that he boycotted Pakistan Day function at the Pakistan High Commission here on Wednesday.

"I will discuss it with my colleagues. The Majlis-e-Shura (highest decision-making body of his Tehreek-e-Hurriyat conglomerate) will take a decision on it." Geelani said.

All Pakistani leaders visiting India make it a point to meet separatist leaders. Pakistan Prime Minister Shaukat Aziz, during his visit here in November, held four hour-long talks with the separatist leaders, trying to forge unity among them.

When referred to his boycott of Pakistan Day function. Geelani said it was to "register token protest" against Islamabad's decision to go ahead with the Srinagar-Muzaffarabad bus service. The separatist leader, however, maintained that he did

not wish to have "confrontation" with Pakistan, as the country has been "supporting our cause for the last 57 years." Geelani said the protest was to "give Pakistan a feeling that they have to continue providing moral and diplomatic support to Kashmiris' movement. It is their obligation." Asked whether he felt that this support had diluted lately. Geelani replied in affirmative. "It may not be reflected in the statements but it is clear by

actions (of Pakistan), he said. He claimed that plying of the bus service was "not favourable to our movement".

When that Pakistan pointed out to him was going ahead with the bus service despite his "token protest". Geelani said "governments cannot be stopped from its work. Has government of India been stopped from indulging in atrocities in Kashmir?" A vocal supporter of Pakistan, Geelani on Tuesday had lashed out at Islamabad, accusing it of "rubbing salt into wounds" of Kashmiris by deciding to run the bus service.

# **64 Protesters Killed In** Myanmar On 'Day Of Shame For Armed Forces'

yanmar's security forces shot and killed at least 64 people, including a young boy, on Saturday, news reports and witnesses said, even as the ruling junta's leader said the military would protect the people and strive for democracy.

Protesters against the February 1 military coup came out on the streets of Yangon, Mandalay and other towns, defying a warning that they could be shot "in the head and back", while the country's generals celebrated Armed Forces Day.

"Today is a day of shame for the armed forces," Dr. Sasa, a spokesman for CRPH, an anti-junta group set up by deposed lawmakers, told an online forum.

The deaths on Saturday, one of the bloodiest days since the coup, would take the number of civilians reported killed to nearly 400. Tens of thousands of people demonstrated in parts of Myanmar on Saturday.

A boy reported by local media to be as young as five was among at least 13 people killed in Myanmar's second city of Mandalay. The Myanmar Now news portal said 64 people had been killed in total across the country by 2.30 p.m. (0800 GMT).

Three people, including a man who plays in a local under-21 football team, were killed in a protest in the Insein district of Myanmar's biggest city Yangon, a neighbour told Reuters.

"They are killing us like birds or chickens, even in our homes," said Thu Ya Zaw in the central town of Myingyan, where at least two protesters were killed. "We will keep protesting regardless... We must fight until the junta falls." Deaths were reported from the central Sagaing region, Lashio in the east, in the Bago region, near Yangon, and elsewhere. A one year-old baby was hit in the eye with a rubber bullet.

Meanwhile, one of Myanmar's two dozen ethnic armed groups, the Karen National Union, said it had overrun an army post near the Thai border, killing 10 people -- including a lieutenant colonel -- and losing one of its own fighters.

Myanmar's ethnic armed factions will not stand by and allow more killings, the leader of one of the main armed groups said on Saturday.



A military spokesman did not respond to calls seeking comment on the killings by security forces or the insurgent attack on its post.

After presiding over a military parade in the capital Naypyitaw to mark Armed Forces Day, Senior General Min Aung Hlaing reiterated a promise to hold elections after overthrowing elected leader Aung San Suu Kyi, without giving any time-frame.

"The army seeks to join hands with the entire nation to safeguard democracy," the general said in a live broadcast on state television, adding that authorities also sought to protect the people and restore peace across the country.

"Violent acts that affect stability and security in order to make demands are inappropriate." SHOTS TO HEAD

In a warning on Friday evening, state television said protesters were "in danger of getting shot to the head and back". The warning did not specifically say security forces had been given shoot-to-kill orders and the junta has previously suggested some fatal shootings have come from within the crowds.

But it showed the military's determination to prevent any disruptions around Armed Forces Day, which commemorates the start of the resistance to Japanese occupation in 1945 that was orchestrated by Suu Kyi's father, the founder of the military.

Suu Kvi, Myanmar's most popular civilian politician, remains in detention at an undisclosed location. Many other figures in her party are also being held in custody.

In a week that saw international pressure on the junta ramped up with new U.S. and European sanctions, Russia's deputy defence minister Alexander Fomin attended the parade in Naypyitaw, having met senior junta leaders a day earlier.

"Russia is a true friend," Min Aung Hlaing said. There were no signs of other diplomats at an event that is usually attended by scores of officials from foreign nations.

Support from Russia and China, which has also refrained from criticism, is important for the junta as they are permanent members of the United Nations Security Council and can block potential U.N. actions.

Gunshots hit the U.S. cultural centre in Yangon on Saturday, but nobody was hurt and the incident was being investigated, U.S. embassy spokesperson Aryani Manring said. The United States has led criticism of the killings of protesters.

Protesters have taken to the streets almost daily since the coup that derailed Myanmar's slow transition to democracy, despite the mounting toll.

"The Myanmar Armed Forces Day isn't an armed forces day, it's more like the day they killed people," General Yawd Serk, chair of the Restoration Council of Shan State/Shan State Army - South, told Reuters in neighbouring Thailand.

"If they continue to shoot at protesters and bully the people, I think all the ethnic groups would not just stand by and do nothing."

Author and historian Thant Myint-U wrote on Twitter: "A failed state in Myanmar has the potential to draw in all the big powers - including the US, China, India, Russia, and Japan - in a way that could lead to a serious international crisis (as well as an even greater catastrophe in Myanmar itself)".

# **Over 180 People Trapped In Mozambique Hotel After ISIL Attack**

 ore than 180 people including foreign work-Lers are trapped inside a hotel in a northern Mozambique town under siege for three days by fighters linked to the ISIL (ISIS) group, workers and security sources said Friday.

Several people were dead, according to witnesses and a rights group, after the attack in Palma near a liquified natural gas (LNG) site in Cabo Delgado province.

French oil giant Total is the principal investor in the \$20bn project - Africa's largest - with six other international firms including ExxonMobil involved in the area.

ISIL-linked fighters began a raid on the coastal town on Wednesday afternoon, forcing terrified residents to flee into the surrounding forest as LNG and government workers sought shel-

South African news website News24 reported that one South African national had died during

the attack. Another worker from a company subcontracted by Total said helicopters flew over the hotel earlier on Friday trying to find "a corridor to rescue the approximately 180

people trapped in the hotel". "But until nightfall, many people remained on the premises while militants tried to advance towards the hotel," he said.

In an unverified short video clip shared on social media, an unidentified man filmed the hotel lobby showing several people milling around the patio.

With the buzzing sound of a chopper in the background, he described the situation in Palma as "critical"

"We don't know if we will be rescued," he said, adding the hotel had run out of food but still had water.



ter at the Amarula Palma hotel. "Almost the entire town was destroyed. Many people are dead," said a worker on the LNG site speaking on the phone Friday evening after he was evacuated to Afungi.

"As locals fled to the bush, workers from LNG companies, including foreigners, took refuge in hotel Amarula where they are waiting to be rescued," he said. asking not to be named

#### 'Bodies on the streets'

Human Rights Watch said the attackers are linked to a group known locally as al-Shabab, which has no known direct link to the Somali armed group with a similar name.

"Several witnesses told Human Rights Watch that they saw bodies on the streets and residents fleeing after the Al-Shabab fighters fired indiscriminately at people and buildings," the rights group said in a statement on Friday.

The Mozambique government on Thursday confirmed the attack on the town and said soldiers had launched an offensive to evict the fighters from the town, the hub of the giant gas project.

The fresh round of attacks be-

gan on Wednesday hours after Total announced a gradual resumption of work at the LNG project, which had been hampered by the continuing rebellion in the region.

Armed fighters affiliated with ISIL have raided villages and towns across the province, causing nearly 700,000 to flee their homes.

The violence has left at least 2,600 people dead, half of them civilians, according to the USbased data collecting agency Armed Conflict Location and Event Data (ACLED).

In a statement Friday, the US embassy in Maputo condemned the attack on Palma, pledging its commitment "to working with the government of Mozambique to counter violent extremism".

# **Plan Made To Refloat Ship**

**SUEZ:** The company that owns the giant container ship stuck sideways across the Suez Canal said an attempt will be made to refloat the vessel by taking advantage of tidal movements later Saturday.

The Ever Given, owned by Japanese firm Shoei Kisen KK, got wedged Tuesday in a single-lane stretch of the canal, about 6 kilometers north of the southern entrance, near the city of Suez.

At a news conference Friday night at company headquarters in Imabari, western Japan, Shoei Kisen President Yukito Higaki said 10 tugboats were deployed and workers were dredging the banks and sea floor near the vessel's bow to try to get it afloat again as the high tide starts to go out.

"We apologise for blocking the traffic and causing the tremendous trouble and worry to many people, including the involved parties," he said.

Shoei Kisen, in a statement on Saturday, said that the company has considered removing its containers to get the weight off the vessel, but it is a very difficult operation, physically speaking. The company said it may still consider that option if the ongoing refloating efforts fail.

A team from Boskalis, a Dutch firm specializing in salvaging, was working with the canal authority using tugboats and a specialized suction dredger at the port side of the cargo ship's bow. Egyptian authorities have prohibited media access to the site.

"It's a complex technical operation" that will require several attempts to free the vessel. Lt Gen Osama Rabei, head of the Suez Canal Authority, said in a statement.

Attempts earlier on Friday to free it failed, said Bernhard Schulte Shipmanagement, the technical manager of the Ever Given.

The Suez Canal Authority has said it welcomed international assistance. The White House said it has offered to help Egypt reopen the canal. "We have equipment and capacity that most countries don't have and we're seeing what we can do and what help we can be, US President Joe Biden told reporters.

**Blocking Suez Canal Using Tide** 

An initial investigation showed the vessel ran aground due to strong winds and ruled out mechanical or engine failure, the company said, GAC, a global shipping and logistics company, had previously said the ship had experienced a power blackout, but it did not elaborate.

Bernhard Schulte said two canal pilots had been aboard when the ship got stuck. Such an arrangement is customary, but the ship's captain retains ultimate authority over the vessel, according to experts.

In addition to the over 200 vessels waiting near the canal, more than 100 ships were en route to the waterway, according to the data firm Refinitiv.

Apparently anticipating long delays, the owners of the stuck vessel diverted a sister ship, the Ever Greet, to head around Africa instead, according to satellite data.

Others also are being diverted. The liquid natural gas carrier Pan Americas changed course in the mid-Atlantic, now aiming south to go around the southern tip of Africa, according to satellite data from MarineTraffic.com.

About 10% of world trade flows through the canal, which is particularly crucial for transporting oil. The closure also could affect oil and gas shipments to Europe from the Middle East. Oil markets are absorbing the disruption for now, said analyst Toril Bosoni.

"Oil inventories have been coming down but they are still relatively ample," he told The Associated Press, adding that he believes the impact might be more pronounced in the tanker sector than in the oil industry.

"We are not losing any oil supply but it will tie up tankers for longer if they have to go around" the tip of Africa, he said, which is roughly an additional two-week trip.

# China Signs 25-Year Deal With Iran, Poses A Challenge To Biden's Administration

Thina and Iran signed an overarching deal aimed at charting the course of their economic, political and trade relations over the next 25 years, Iranian state TV reported, in a challenge to the Biden administration.

The "Comprehensive Strategic Partnership" agreement, signed in Tehran on Saturday by Iranian Foreign Minister Mohammad Javad Zarif and his Chinese counterpart, Wang Yi, has been in the works since 2016, when President Xi Jinping became the first Chinese leader to visit the Iranian capital in over a decade.

"The document can elevate bilateral ties to a new strategic level," Foreign Ministry Spokesman Saeed Khatibzadeh said in a televised interview. The deal focuses on boosting private-sector collaboration and the Islamic Republic's role in Xi's flagship infrastructure and investment program, the Belt and Road Initiative, he said.

A draft copy of the outlines of the accord that surfaced on media last year showed plans for longterm supply of Iranian crude to China as well as investment in oil,



gas, petrochemical, renewables and nuclear energy infrastructure.

The alliance between Beijing and Tehran is a challenge to U.S. President loe Biden's administration as it sets about trying to rally allies against China, which Secretary of State Antony Blinken has said is the world's "greatest geopolitical test."

The China pact comes as efforts to revive the Iran nuclear accord with world powers are stalled. The Biden administration has indicated that it is open to reengaging with Iran after then-President Donald Trump abandoned the deal nearly three years

ago and reimposed economic sanctions, but the two sides have yet to even agree to meet.

Iran's closer integration with China may help shore up its economy against the impact of the U.S. penalties, while sending a clear signal to the Biden administration of Tehran's intentions. Wang Yi, who arrived in Tehran on Friday, also met with President Hassan Rouhani to discuss the nuclear deal.

In a televised speech, Rouhani reiterated his view on the prospect for the easing of restrictions before the end of his second and final term as president in early August.

# NEWS MAKERS US-China Rivalry Risks 'Catastrophic' Conflict, Kissinger Warns

Tormer US Secretary of State → Henry Kissinger has warned that the United States and China must come to an understanding on international affairs or there will be a risk of "catastrophic" conflict similar

to the one before the First World War. Speaking online at a Chatham House event in London, Kissinger said "endless" competition between the world's two largest economies risks unforeseen escalation and subsequent conflict, and that the ultimate question was whether or not the United States and its Western allies could develop an understanding with China about a new global order.

"It is infinitely more dangerous now than it was then." Kissinger

added, stressing that the high-tech weaponry on both sides could lead to a very grave conflict.

"A conflict between countries possessing high technology with weapons that can target themselves and that can start the conflict by themselves without some agreement of some kind of restraint cannot end well," the former US diplomat said. "And that's an understatement."

Kissenger served as Secretary of State and National Security Advisor under President Richard Nixon, making two trips to China in 1971, the first of which was in secret, to establish rapprochement between Washington and Beijing.

Kissinger met Chinese officials on behalf of Nixon at that time without telling George H.W. Bush, who was then Washington's ambassador to the United Nations, about the talks. The US and China have been engaged in a trade conflict for the past

two years and have imposed billions of dollars of tariffs on each other's goods. Since early 2018, the US adminis-

tration has pursued a deliberate policy of attempting to hurt China's economy in response to concerns about the shifting balance of economic power and unfair trade practices. Washington and Beijing are also

engaged in a number of other disputes, including US naval operations in the South China Sea, the US relationship with Taiwan, the Xinjiang issue and US Congress support for protesters in Hong Kong.

Citing an admission by a former US senior official, Chinese Foreign

Ministry spokesperson Hua Chunying said on Friday that allegations of human rights violations against the Muslim Uighur minority in the western state of Xinjiang was nothing but a strategic US plot to destabilize China from the inside.

Hua made the comments after showing journalists at the ministry's regular press conference a video of Lawrence Wilkerson, a retired US Army Colonel and former chief of staff to US Secretary of State Colin Powell, giving a speech in August 2018.

The video showed Wilkerson saying if the CIA wanted to destabilize China, that would be best to form unrest and join with Uighurs in putting pressure on China internally rather than from outside.

"It's time to end the 'drama' from

the US side," Hua said, adding that the footage showed the unseemly role played by the US and some of its allies and a few media outlets when they attack China on the issue of Uighurs in Xinjiang.

The Chinese Foreign Ministry spokesperson also said the US and its western allies colluded with anti-China forces and accused Beijing of committing "crimes" including forced labor, forced sterilization and even genocide and subsequently imposed sanctions on Chinese institutions and personnel.

The official also underlined that the US cooked up the so-called "Xinjiang problem" not because it cares about the Muslim Uighur minority but to undermine China's security and stability, and to hinder its development and growth.

on having the bribe amount because of which she has also kept the file with her and has granted him 3-4 days time to arrange the money. As the complainant don't want to give the amount of Rs. 20,000/- as bribe to the JE Sushma Parihar, he approached the ACB to take immediate necessary action under law.

The ACB said that on the receipt of this complaint a pre trap verification was conducted and as per complaint and report of verifying officer, prime facie, offence U/s 7 of Prevention of Corruption (Amendment) Act, 2018 was found made out against Parihar, Junior Engineer of Jammu

Power Distribution Corporation Ltd, as such, case FIR No. 04/2021 was registered in Police Station ACB Central Jammu.

It said thereafter, a trap team was constituted and independent witnesses including lady officer and magistrate were associated with the same. The trap team laid a successful trap and caught the accused red handed while demanding and accepting the bribe from the complainant. # The Absent Voices of Development Economics

The long-standing problem of underrepresentation is being amplified by the growing use of randomized controlled trials (RCTs) to test the effectiveness of specific poverty-reduction interventions in lowincome countries. Although the RCT movement deserves immense credit for highlighting the need for evidentiary rigor in development economics, it has had exclusionary consequences

EW DELHI – The lack of representation of marginalized groups in the corridors of power – political, financial, and cultural – is a growing source of global concern. Knowledge confers power, so who creates it matters. As the Nobel laureate economist Paul Samuelson famously said, "I don't care who writes a nation's laws...if I can write its textbooks."

Development economics focuses on improving the well-being of billions of people in low-income countries, but the Global South is severely underrepresented in the field. Unfortunately, a small number of rich-country institutions have appropriated it, with serious consequences. And the problem appears to be getting worse.

Consider the Journal of Development Economics, a leading outlet for research papers in the field. Neither the journal's editor nor any of its ten co-editors are based in a developing country. Just two of its 69 associate editors are, with Africa and Asia completely unrepresented.

Then there is the World Bank's prestigious Annual Bank Conference on Development Economics (ABCDE). The 2019 event celebrated the 75th anniversary of the Bretton Woods conference that established the World Bank and the International Monetary Fund, but none of the 77 participants were from an institution located in a developing country. And our analysis of the ABCDE's three-decade history shows that just 7% of those authoring conference papers have been from developing-world institutions.

The long-standing problem of underrepresentation is being amplified by the growing use of randomized controlled trials (RCTs) to test the effectiveness of specific poverty-reduction interventions in low-income countries. Although the RCT movement deserves immense credit for highlighting the need for evidentiary rigor in development economics, it has had exclusionary consequences.

By virtue of their well-deserved academic reputations, RCT-oriented economists now work at the world's most prestigious universities and research institutions and serve on the editorial boards of top economics journals. This crucial gatekeeping role gives them agenda-setting power. Two decades ago, for example, there were virtually no RCT-based papers in development economics; in 2020, accord-



ing to our analysis, they accounted for about 40% of the articles in the leading journals.

And exclusion characterizes the RCT movement itself. At the Abdul Latif Jameel Poverty Action Lab (J-PAL), the most influential global center for development-related RCT research, about 5% of the nearly 225 affiliated professors are based in developing countries, with no representation from institutions in East Asia. Moreover, conducting RCTs is expensive, which means that poverty-reduction research – and funding for it – is increasingly concentrated in the richest universities (J-PAL was established at MIT).

Indeed, the cost of carrying out RCTs can run into millions of dollars per paper, making it difficult for de veloping-country researchers to study their own countries without genuflecting to wealthy institutions' academic orthodoxies. If these researchers cannot do RCT-based studies, they have little chance of getting published in leading journals, and risk being consigned to second-class status. Even on a generous interpretation of authorship, our analysis suggests that developingcountry institutions accounted for less than 10% of RCT-based papers in the top six economics journals in 2020.

A subtler cost concerns prioritization of research. There is an inherent power imbalance between relatively weak developing-country governments and reputationally and financially powerful researchers, as well as tension between what policymakers in lower-income economies consider important and what academics deem worthy of publication in top journals. These factors surely privilege research that yields high private returns to researchers based in rich countries but meager public returns to developing-country decision-makers.

True, scholars from developing countries in these elite institutions make important contributions to development economics. But the incentives and priorities of the institutional cultures they inhabit play a powerful role.

The final cost relates to the type of knowledge that is ignored. Several highly successful economies - including South Korea, Taiwan, China, Vietnam, Mauritius, and Botswana - did not rely on RCTs to change their destinies and lift their large populations out of poverty. Yet, academics from these countries generally do not sit on the editorial boards of major journals or participate prominently in development economists' conferences and seminars - an omission that is particularly telling in the case of China, with its historically unprecedented economic transformation. It is as if these countries' development successes have no lessons to offer.

To preempt the Global North's monopoly of knowledge creation in development economics requires, first,

recognizing that the Global South has ceded dominance as much as the North's elite institutions have appropriated it. Many developing countries have severely undermined their own universities and knowledge-production systems both through lack of funding and political interference, with the latter being especially pernicious in the social sciences. Unless they remedy this, they will continue to suffer the consequences of the global imbalance.

We also must heed the novelist Kazuo Ishiguro's 2017 Nobel lecture, in which he urged a broadening of "our common literary world to include many more voices from beyond our comfort zones of the elite first-world cultures." That means searching "more energetically to discover the gems from what remain today unknown literary cultures, whether the writers live in far-away countries or within our own communities," while taking "great care not to set too narrowly or conservatively our definitions of what constitutes good literature."

Substitute "development economics" for "literature," and Ishiguro's injunction yields a constructive agenda of corrective action for intellectuals in the Global North. It also suggests that diversity and broader representation are the best safeguards against intellectual narrowness resulting from elite capture.

# **Broken heart and** stressed brain are connected, says new study

eightened activity in the brain, caused by stressful events, is linked to the risk of developing a rare and sometimes fatal heart condition called Takotsubo syndrome (TTS), also known as 'broken heart' syndrome, according to new research drove by European Society of Cardiology.

The research was published in the European Heart Journal.

The study found the greater the activity in nerve cells in the amygdala region of the brain, the sooner the condition known as Takotsubo syndrome (TTS) can develop. The researchers suggest that interventions to lower this stress-related brain activity could help to reduce the risk of developing TTS; these could include drug treatments or techniques for lowering stress.

TTS, also known as "broken heart" syndrome, is characterised by a sudden temporary weakening of the heart muscles that causes the left ventricle of the heart to balloon out at the bottom while the neck remains narrow, creating a shape resembling a Japanese octopus trap, from which it gets its name.

Since this relatively rare condition was first described in 1990, evidence has

suggested that it is typically triggered by episodes of severe emotional distress, such as grief, anger or fear, or reactions to happy or joyful events. Patients develop chest pains and breathlessness, and it can lead to heart attacks and death. TTS is more common in women with only 10% of cases occurring in men.\*

The amygdala is the part of the brain that controls emotions, motivation, learning and memory. It is also involved in the control of the autonomic nervous system and regulating heart function.

"The study suggests that the increased stress-associated neurobiological activity in the amygdala, which is present years before TTS occurs, may play an important role in its development and may predict the timing of the syndrome.

It may prime an individual for a heightened acute stress response that culminates in TTS," said Dr Ahmed Tawakol, co-director of the Cardiovascular Imaging Research Center at Massachusetts General Hospital and Harvard Medical School (Boston, USA), who led the study.

"We also identified a significant relationship between stress-associated brain activity and bone marrow activity in these individuals. Together, the findings provide insights into a potential mechanism that may contribute to the 'heart-brain connection'.'

In the first study to look at brain scans using F-fluorodeoxyglucose positron emission tomography/computed tomography (PET-CT) to assess brain activity before TTS develops. Dr Tawakol and colleagues analysed data on 104 people with an average age of 68 years, 72% of whom were women.

The patients had undergone scans at Massachusetts General Hospital (Boston, USA) between 2005 and 2019. Most of them had the scans to see if they had cancer and the scans also assessed the activity of blood cells in bone marrow. The researchers matched 41 people who went on to develop TTS between six months and five years after the scan with 63 who did not. The interval between the scan, the onset of TTs, last follow-up or death was an average (median) of 2.5 years for the 104 patients.

Dr Tawakol said: "Areas of the brain that have higher metabolic activity tend to be in greater use. Hence, higher activity in the stress-associated tissues of the brain suggests that the individual has a more active response to stress. Similarly, higher activity in the bone marrow reflects greater bone marrow metabolism. The PET/CT scans produce images that reflect the distribution of glucose metabolism. The brain images thereby yield a map of brain metabolic activity: the higher the values, the greater the activity in those brain regions."

The researchers found that people who went on to develop TTS had higher stressrelated amygdalar activity on initial scanning (measured as a ratio of amygdalar activity to activity of brain regions that counter stress) compared to individuals who did not subsequently develop TTS.

Further, the higher the amygdalar signal, the greater the risk of developing TTS. Among the 41 patients who developed TTS. the average interval between the scan and TTS was 0.9 months, whereas among the control group of 63 patients, the average interval between the scan and last followup or death was 2.9 years.

"It was notable that among the 41 patients who developed TTS, the top 15% with the very highest amygdalar activity developed TTS within a year of imaging, while those with less elevated activity developed TTS several years later," said Dr Tawakol.

He said future studies should investigate whether reducing stress-related brain activity could decrease the chances of TTS recurring among patients who have experienced TTS previously.

"These findings add to evidence of the adverse effect of stress-related biology on the cardiovascular system. Findings such

as these underscore the need for more study into the impact of stress reduction or drug interventions targeting these brain regions on heart health.

In the meantime, when encountering a patient with high chronic stress, clinicians could reasonably consider the possibility that alleviation of stress might result in benefits to the cardiovascular system."

The process by which stress induces TTS is not well understood but may involve a multi-organ mechanism starting with activation of the stress-sensitive tissues of the brain. This brain activity in turn triggers several further events, including release of stress hormones, activation of the sympathetic nervous system and release of inflammatory cells, each of which can contribute to the development of TTS.

Limitations of the study include that it was a single-centre, retrospective study that consisted mainly of patients with a diagnosis of cancer, a known TTS risk factor, which may limit the generalisability of the findings.

The researchers were unable to measure instantaneous changes in brain activity in response to a stressful event that led to TTS and so cannot directly show a causal relationship. Nor were they able to measure changes in activity in other regions of the brain, which could also play a role

# Narcissism is driven by insecurity: Study

ver thought what motivates narcissism? It is driven by insecurity and not an flated sense of self finds a new study.

The findings suggest that genuine narcissists are insecure and are best described by the vulnerable narcissism subtype, whereas grandiose narcissism might be better understood as a manifestation of psychopathy.

"More specifically, the results suggest that narcissism is better understood as a compensatory adaptation to overcome and cover up low self-worth," said lead author Mary Kowalchyk from the New York University.

"Narcissists are insecure, and they cope with these insecurities by flexing. This makes others like

them less in the long run, thus further aggravating their insecurities, which then leads to a vicious cycle of flexing behaviours," Kowalchyk added

For the study, published in the journal Personality and Individual Differences, the team surveyed nearly 300 participants. They examined Narcissistic Personality Disorder (NPD), conceptualised as excessive self-love and consisting of two subtypes, known as grandiose and vulnerable narcissism.

A related affliction, psychopathy, is also characterized by a grandiose sense of self. They sought to refine the understanding of how these conditions relate.

To do so, they designed a novel measure, called PRISN (Performative Refinement to soothe Insecurities about SophisticatioN), which

produced FLEX (perFormative seLf-Elevation indeX). FLEX captures insecurity-driven self-conceptualizations that are manifested as impression management, leading to self-elevating tendencies.

The PRISN scale includes commonly used measures to investigate social desirability ("No matter who I am talking to I am a good listener"), self-esteem ("On the whole, I am satisfied with myself"), and psychopathy ("I tend to lack remorse").

FLEX was shown to be made up of four components: impression management ("I am likely to show off if I get the chance"), the need for social validation ("It matters that I am seen at important events"), self-elevation ("I have exquisite taste"), and social dominance ("I like knowing more than other people").

litre, respectively on Saturday. Diesel prices in Delhi, Mumbai, Chennai and Kolkata were at Rs 81.10, Rs 88.20, Rs 86.10 and Rs

83.98 per litre, respectively. Fuel prices which impact the common man's budget to a great extent have been largely unchanged

ahead of the state elections. In fact, prices declined on Wednesday and Thursday after a long time amid the pandemic.

Oil marketing companies have

been maintaining restraint off late despite surging crude oil prices. The May contract of Brent crude on the Intercontinental Exchange is around \$64.5 per barrel.

Retail fuel prices although have not been increased for around a month now, they are already around record high levels making a hole in the pockets of the com-

The petrol and diesel prices have increased 26 times in 2021 with the two auto fuels increasing by Rs 7.46 and Rs 7.60 per litre respectively so far this year.

Officials in public sector oil companies said that retail prices may rise again if crude and product prices pick up.

# **Facebook Services Restricted In Bangladesh Amid Pm Modi's Visit**

ocial network Facebook and its messaging app have been down in Bangladesh since Friday, the U.S. tech giant said on Saturday, as protesters oppose Indian Prime Minister Narendra Modi's two day visit to the country.

Four people were killed on Friday after police opened fire after protesters allegedly attacked a police station in the Bangladeshi city of Chittagong during a demonstration against Modi's visit.

"We're aware that our services have been restricted in Bangladesh," Facebook said in a statement. "We're working to understand more and hope to have full access restored as soon as possible.

The government of Prime Minister Sheikh Hasina did not comment if it had blocked Facebook and its messenger, but it has previously used internet shutdowns as a

tool to curb the spread of protests. Facebook also said it had serious concerns about the manner in which it was being restricted in Bangladesh at a time when effective communication was necessary to tackle the coronavirus pandemic.

Local hardline group Hefazate-Islam, meaning protection of Islam, has called for a nationwide strike on Sunday to protest the Chittagong killings. Hefazat and its supporters accuse Modi of alienat-

ing minority Muslims in India. Modi landed in Dhaka on Friday for a two-day visit, his first international trip since the outbreak of the coronavirus pandemic last year, to celebrate the 50th anniversary of the nation's independence.

He is due to hold formal talks with Hasina on Saturday.

# "Technical Or Human Errors" Likely Behind Suez Canal Blockage: Official

SUEZ: Egypt's Suez Canal Authority chief said Saturday that strong wind was not the main reason for the grounding of the MV Ever Given cargo ship in the waterway.

'Strong winds and weather factors were not the main reasons for the ship's grounding, there may have been technical or human errors," Osama Rabie said at a press conference in Suez.

"All of these factors will become apparent in the investigation," he added.

Asked when the ship could be afloat again, he suggested it was possible "today or tomorrow, depending on the ship's responsiveness to the tides."

The MV Ever Given, which is

longer than four football fields, has been wedged diagonally across the canal since Tuesday, blocking one of the world's most vital waterways in both directions.

The canal authority chief said over 300 vessels are now treading water at either end of the canal, which links the Mediterranean and

Addressing journalists in Suez, Rabie outlined Egypt's efforts with tugboats and excavators to free the bow and propellers of mega-ship in order to reopen the canal.

Rabie noted that on 10.30 pm Friday the propellers had been able to spin, although not at full speed.

However they were jammed again due to the changing tide, he said, adding that rescuers had had to

resort to excavators again overnight to continue the dredging process. "The type of soil we're dealing with

is very difficult to manage, as are the tides which affect the vessel due to its size and its cargo load," he added. Rabie also noted that the blockage

had caused "no fatalities or pollution".

The ship's grounding is holding up some \$9.6 billion worth of cargo each day between Asia and Europe, according to Lloyd's List data.

Rabie estimated that Egypt is losing some \$12-14 million in revenue from the canal for each day it is closed. The United States also said it was ready to send support, including a team of US Navy experts.

Rabie thanked the US for its support along with China and the United Arab Emirates.

# **US Proposes Action Against India's Equalisation Levy**

**NEW DELHI:** The other counties under investigation included Italy, Turkey, UK, Spain and Austria.

A statement from the office of the USTR said that in January it was found that digital service taxes (DST) adopted by Austria, India, Italy, Spain, Turkey, and the United Kingdom were subject to action under Section 301 because they discriminated against US digital companies, were inconsistent with the principles of international taxation, and burdened US companies.

USTR is proceeding with the public notice and comment process on possible trade actions to preserve procedural options before the conclusion of the statutory oneyear time period for completing the investigations.

"The United States is committed to working with its trading partners to resolve its concerns with digital services taxes, and to addressing broader issues of international taxation," said Ambassador Katherine Tai.

"The United States remains committed to reaching an international consensus through the OECD process on international tax issues. However, until such a consensus is reached, we will maintain our options under the Section 301 process, including, if necessary, the imposition of tariffs."

Among the proposed actions, the Ioe Biden administration has proposed to impose retaliatory tariffs up to 25 per cent on around 40

Indian products including shrimps, basmati rice, gold and silver items.

The Government of India will examine the proposed action with the stakeholders concerned and would take suitable measures keeping its trade and commercial interest of the country and overall interest of its people, according to official sources.

With regard to India, the investigation was targeted on the 2 per cent equalisation levy (EL)levied by India on e-commerce supply of services. The investigation included whether the EL discriminated against US companies, was applied retrospectively, and diverged from U.S or international tax norms due to its applicability on entities not

resident in India. The U.S. requested for bilateral consultations in this matter, and India submitted its comments to the USTR on 15 July 2020, participated in the bilateral consultation held on 5 Nov 2020.

India made a strong case that the levy is not discriminatory and only seeks to ensure a level-playing field with respect to e-commerce activities undertaken by entities with permanent establishment in India.

It also clarified that the equalisation levy was applied only prospectively, and has no extra-territorial application, since it is based on sales occurring in the territory of India through digital means.

India based e-commerce operators are already subject to taxes in India for revenue generated from Indian market. However, in the absence of the levy, non-resident ecommerce operators, not having any permanent establishment in India but with significant economic presence, are not required to pay taxes in respect of the consideration received in the e-commerce supply or services made in the Indian market.

# **CBI In Court To Get Niray's Brother Extradited** From US in PNB case

MUMBAI: After a UK court gave its nod to the extradition of fugitive diamond merchant Nirav Modi, the Indian government will seek to extradite his brother Nehal Modi from the US to face legal proceedings in the Rs 6,498 crore alleged Punjab National Bank (PNB) fraud case.

The CBI on Friday initiated proceedings before the special court submitting that Nehal, a Belgian national, was arrested in December in the US for his alleged involvement in another criminal case there. The investigating agency submitted an "affidavit of extradition request of the Government of the Republic of India to the Government of the United States of America for the extradition of Nehal Modi" before special CBI judge VC Barde.



The CBI said that Nehal did not join the probe despite summons and a non-bailable warrant issued against him. The Enforcement Directorate (ED) had requested the Interpol to issue a Red Corner Notice against Nehal.

# **AEPC Urges Government To Put Restrictions On Cotton Yarn Exports**



**NEW DELHI:** The Apparel Export Promotion Council (AEPC) on Saturday urged the government to impose restrictions on exports of cotton yarn in order to curb prices and increase supply for domestic manufacturers.

AEPC chairman A Sakthivel said despite several efforts by the government to reduce the price of cotton yarn, it has consistently increased in the last four months and was affecting the entire value chain.

"We request immediate intervention to increase the supply of yarn to domestic manufacturers. We suggest that quantitative restrictions should be imposed on exports of cotton yarn, specifically on cotton yarn of 26 counts and above," he said.

Sakthivel further said the Cotton Corporation of India (CCI) has reuced the price of cotton for small mill owners but this did not result in reduction of cotton yarn prices.

"The rate of increase in yarn prices far exceeds that of cotton prices. The steep increase in prices and unpredictability in availability of yarn means that garment exporters cannot honour commitments they made to their customers.

"This has also affected handloom and powerloom weavers badly. Looms have stopped production. Due to this, the domestic industry has also got affected adversely," he added.

The AEPC chairman said the sector would be hit hard if yarn is exported at the cost of domestic and export-oriented manufacturing industry.

"We also suggest that export duty should be levied on exports of cotton varn. This will result in a sharp decline in domestic yarn prices and an increase in value addition and employment in the country.

"This will also help in increasing garment exports. And, it will result in only normal profits accruing to yarn spinners, not the super normal profit owing to the profiteering currently happening," Sakthivel said.

# **Curtains Not Down On Tata-Mistry Feud Yet**

The thumb rule in bargaining is to start the bid at half the asking price. Most Indians excel at it, but sparring partners Tata Sons and Shapoorji Pallonji Group are about to find themselves in a similar situation. On the block is SP Group's contentious 18.4 per cent stake in Tata Sons, which it values at Rs 1.75 lakh crore.

However, the Tatas peg it at less than half at Rs 70,000-80,000 crore. Both parties are now expected to start negotiations, but the manner in which they'll arrive at a mutually-acceptable price will be closely watched.

The stake sale is critical for both companies to reduce debt. While SP Group with a debt of about Rs 23,000 crore has been scouting for funds since last year, Tata Sons with a debt of Rs 1.96 lakh crore (all group firms) must put the matter to rest to focus on

The Supreme Court's (SC) verdict on Friday was in favour of Tata Sons on all counts (including upholding Tata Sons' decision sacking Cyrus Mistry as its Chairman and Executive Director), the 3-judge bench led by Chief Justice S A Bobde, however, decided not to adjudicate on the issue of shares and instead suggested legal route to resolve the matter.

"The valuation of the shares of SP Group depends upon the value of the stake of Tata Sons in listed equities, unlisted equities, immovable assets etc., and also perhaps the funds raised by SP Group on the security/pledge of these shares. Therefore at this stage and in this Court, we cannot adjudicate on the fair compensation. We will leave it to the parties to take the Article 75 route or any other legally available route in this regard," the SC ruled.

Trouble is, Article 75 was the very provision that the SP Group had objected to, saying it ignores "constitutionally valid safeguards in company law," with respect to minority shareholders. It mandates minority shareholders to approach the Tata Sons board with an offer and also grants the board the power of right of first refusal to either buy the stake, or get investors.

In essence, attempts to offload stake could be either long-drawn or see a deadend given that the list of investors with billions of dollars to spare is usually limited.While the verdict does bring finality to the long-drawn corporate boardroom battle, much depends on whether the sparring partners can find a middle path.



This week, Amazon workers and union advocates, including Vermont Sen. Bernie Sanders, made a last-minute push as voting comes to a close in the high-stakes union battle. If organizers are successful, it could lead to



organizers hoping to win a rare labor victory in the Deep South.

Amazon is fighting the union. The company argues the warehouse created thousands of jobs with an average pay of \$15.30 per hour — more than twice the minimum wage in Alabama. Workers also get benefits including health care, vision and dental insurance without paying union dues, the company said.

Sanders spoke at a union rally in Birmingham on Friday, saying a labor victory against the tech and retail giant owned by the richest person in world – and in a historically anti-union state would resonate across the country.

"What you are doing here is historical, historical, because all over this country people are sick and tired of being exploited, sick and tired of not having the dignity that they deserve. And your message to people all over this country is stand up and fight back," Sanders said.

"This country belongs to all of us, not just a handful of billionaires," the former Democratic presidential candidate said. Ahead of Sanders' visit, Ama-

zon CEO Dave Clark tweeted that they "actually deliver" a progressive workplace with a \$15 hourly minimum wage and good health benefits that Sanders said he supports. "So, if you want to hear about \$15

an hour and health care, Senator Sanders will be speaking downtown. But if you would like to make at least \$15 an hour and have good health care, Amazon is hiring," Clark tweeted. Burns and Harvey Wilson, a

41-year-old who works as a "picker" at Amazon, both said they're supporting the union because of poor working conditions at the warehouse. Employees face relentless quotas and the mammoth size of the facility makes it nearly impossible to get to the bathroom and back to your station during

a workers' break time, they said. "How could you work for somebody who is trillion, billion whatever you want to call it, how can you work for them and they don't want you to go to the bathroom?" Burns said. Wilson said he is unsure how the

younger workers are fearful they could lose benefits. "A lot of people are scared to vote because they are afraid they are going to lose their jobs," Wilson said.

"The registration will start from April 1 for both the routes through 446 designated bank branches of the Punjab National Bank (316), the Jammu and Kashmir Bank (90) and the YES Bank (40), all over the country," Chief Executive Officer (CEO) of the Sri Amarnathji Shrine Board (SASB) Nitishwar Kumar

He said that details about the procedure for registration, application form and state-wise list of bank branches with complete addresses are available on the board's website.

The CEO said that only health certificates that are issued by doctors or medical institutes authorised by state governments or union territory administrations will be accepted at the registered bank branches.

The certificates are mandatory as the shrine is at a very high-altitude and the journey is arduous.

"For the Yatra-2021, only those health certificates which have been issued after March 15 shall be valid. The steps which vatris (pilgrims) need to follow in order to register for the yatra (pilgrimage), have been put on the board's websitewww.shriamarnathjishrine.com," Kumar said.

He added that it also contains relevant information on how to reach the base camps, fee for registration, tariff for ponies, palanguin and porters.

Kumar said people under the age of 13 years or above the age of 75 years and women who are more than six weeks pregnant would not be registered for this year's yatra as per COVID-19 norms.

He said permits for the yatra would be different for each day of the week and routes.

Different colour code for each day will be used to facilitate police personnel deployed at the access control gates at Baltal in Ganderbal district and Chandanwari-Pahalgam in Anantnag district to regulate the yatra for the relevant date and route, the CEO said.

In this context, he cautioned pilgrims against undertaking this arduous yatra without securing a permit and the required compulsory health certificate.

Kumar stressed that, for ensuring effective security arrangements along the difficult tracks, only those yatris who are in possession of a permit which is valid for a specified date and route, will be allowed to proceed beyond the base camps, and cross the entry gates.

He appealed to pilgrims to complete necessary formalities for registration in advance and obtain a permit so that they do not face any inconvenience.

Pilgrims who propose to travel by helicopter do not require advance registration as their tickets will suffice for this purpose, Kumar said.

However, Kumar said they would be required to produce the compulsory health certificate issued by an authorised doctor in the prescribed format before they are allowed to travel by helicopter.

All these FIRs pertain to the year 2016, whereas order impugned has been passed on 6th August 2019. Thus there is a delay of three years in passing the detention order," a bench of Justice Rajesh Oswal said.

### **CAG Raps J&K**

indicates a lack of adequate response from the government departments to the audit.

The report, recently submitted in Parliament, said in the last few years, the audit has pointed out several significant deficiencies in the implementation of various programmes or activities as well as on the quality of internal-control measures in certain departments, which have a negative impact on the success of the programmes and the functioning of the departments.

"The government may look into this matter and revamp the system to ensure a proper response to the audit observations from the departments in a time-bound manner," it said.

During 2018-19, the CAG said a compliance audit of 727 drawing and disbursing officers and 74 units of 25 autonomous bodies was conducted by the office of the Principal Accountant General (Audit), Jammu and Kashmir.

"The focus was on auditing specific programmes/schemes in order to offer suitable recommendations to the executive for taking corrective action and improving service delivery to the citizens

"Twenty-three paragraphs were sent to the Principal Secretaries/Secretaries of the respective departments. Replies in respect of nine paragraphs included in this report were not received (September 2020)," it said.

The report said the handbook of instructions for a speedy settlement of audit observations or inspection reports (IRs) issued by the government (finance department) provides for a prompt response by the executive to the IRs issued by the Principal Accountant General (Audit) to ensure remedial or rectification action in compliance with the prescribed rules

The heads of offices and the next higher authorities are reguired to comply with the observations contained in the IRs. rectify the defects and report their compliance to the Principal Accountant General (Audit), it said, adding that based on the results of the test audit, 49,523 audit observations contained

in 11,531 IRs were outstanding as on March 31, 2019. "The pendency of a large number of paragraphs indicates a lack of adequate response of the government departments to the audit," the CAG observed.

Further, only two Audit Committee meetings were held during 2018-19, in which 28 audit paragraphs were settled, which account for 0.06 per cent of the pending objections as of March 2019, the report said, urging the respective departments to constitute audit committees and monitor the progress of the settlement of paragraphs.

To ensure accountability of the executive to issues dealt with in various audit reports, the government (finance department) issued instructions in June 1997 to the administrative departments to furnish suo-motu action-taken notes (ATNs) to the Public Accounts Committee (PAC) or the Committee on Public Undertakings (COPU) on all the audit paragraphs featuring in the audit reports, irrespective of whether those are taken up for discussion by these panels or not.

"These ATNs are to be submitted to these committees, duly vetted by the Principal Accountant General (Audit) within a period of three months from the date of presentation of audit reports in the state legislature. It was, however, noticed that out of the 495 audit paragraphs featuring in the civil chapters of the audit reports from 2000-01 to 2015-16, the suomotu ATNs in respect of 146 audit paragraphs had not been received up to September 30, 2020," it said.

The report said the ATNs, duly vetted by the Principal Accountant General (Audit) on the observations or recommendations made by the PAC or the COPU in respect of the audit paragraphs discussed by them are to be furnished to these committees within six months from the date of such observations or recommendations.

"Out of 495 audit paragraphs featuring in the civil chapters of audit reports for the years from 2000-01 to 2015-16, only 245 audit paragraphs have been discussed by the PAC up to March 31, 2020. Recommendations in respect of 223 audit paragraphs have been made by the PAC. However, ATNs on the recommendations of the committees are pending from the government of Jammu and Kashmir and Ladakh in respect of 165 paragraphs," it said.

In all there are 42 PSUs, 33 of them are working. The PSUs were established to carry out activities of commercial nature keeping in view the welfare of people and occupy an important place in the economy of the I&K, the CAG said.

The PSUs consist of State Government Companies and Statutory Corporations. As on 31 March 2019, there were 421 PSUs (six in Power Sector and 36 in Sectors other than Power Sector), including three Statutory Corporations under the audit jurisdiction of the CAG.

The 33 working PSUs, the CAG said, registered an annual turnover of Rs 9,784.90 crore and earned an aggregate profit of Rs 448.02 crore as of 30 September 2019 as per their latest finalized accounts. "This turnover was equal to 6.33 per cent of Gross State Domestic Product (GSDP), which was rs 1,54,441 crore (at current prices) for the State for 2018-19."

One PSU, Jammu and Kashmir Bank Limited, having a total paid-up equity of Rs 55.70 crore is listed on the stock exchange since July 1998. "This paid-up equity of Rs 55.70 crore of the Bank is held partly by the State Government (59.23 per cent ) and the remaining part by Foreign Institutional Investors, Resident Individuals and others (40.77 per cent).

"During the year 2018-19, six PSUs were incorporated and no PSU was closed down. There are two power generation Companies, Jammu and Kashmir State Power Development Corporation Limited (JKSPDC) and Chenab Valley Power Project Private Limited (CVPPP)," the CAG said in the report.

"The Chenab Valley Power Project Private Limited (CVPPP) which is a joint venture Company, has an investment of Rs 1,439.18 crore as of March 2019 (JKSPDC: Rs 687.55 crore, NHPC: Rs 747.55 crore and PTC: Rs 4.08 crore."

As a consequence of the unbundling of the Power Sector, one power transmission Company- Jammu and Kashmir Power Transmission Company Limited, two power distribution companies— Jammu Power Distribution Company Limited and Kashmir Power Distribution Company Limited (June 2013) and one Company— Jammu and Kashmir Power Trading Company Limited— exclusively to conduct trading activities in power were incorporated on behalf of the State Government. "However, these Companies which have been incorporated between March 2013 and June 2013, are yet to start their commercial operations as of March 2019," the CAG noted. "In the absence of commercial operations by these companies, the power transmission and distribution activities continue to be carried out by the Power Development Department of Jammu & Kashmir Government." (GNS)

board and state legal service authority are also pending for many years, the CAG said.

The CAG, in its report on social, general and economic (non-PSUs) in the erstwhile state of Jammu and Kashmir for the year ending 31 March, 2019, submitted in the parliament recently, said 10 autonomous bodies, including LAHDC, Leh and LAHDC Kargil required to be audited had not furnished the annual accounts.

Jammu and Kashmir was bifurcated into two Union territories of I&K and Ladakh in August 2019.

"The LAHDC, Leh has failed to submit accounts for audit since its inception (1995-96) although substantial funds are being released to the Council and unspent balances at the end of the year remain credited in a non-lapsable fund in the Public Account of the State," the CAG said.

"The position in respect of LAHDC. Kargil which came into existence in the year 2004-05 is similar and the accounts are in arrears since its inception. Non-submission/delay in submission of accounts by these bodies receiving substantial funding from the State budget is a serious financial irregularity persisting for years," it said.

It said the LAHDC received a grant of Rs 546.24 crore in 2018-19, while the LAHDC Kargil got Rs 597.95 crore during the same financial year.

"In view of this non-compliance, the audited accounts of these statutory bodies have not so far been presented to the State Legislature as required under the Statutes under which these bodies were created. This has deprived the State Legislature of the opportunity to assess their activities and financial performance," the report said.

The Compensatory Afforestation Management and Planning Authority (J&K), which had not received any grants in 2018-19, had failed to submit its accounts for audit for the last 10 years.

The accounts for audit of SKUAST (Kashmir) is pending for nine years though it received a grant of Rs 228.60 crore in 2018-19 and similarly, the SKUAST (Jammu) which had got a grant of Rs 101 crore in 2018-19, has failed to submit its account for three years, the report said.

The CAG said the State Legal Service Authority received a grant of Rs 12.48 crore in 2018-19, but failed to submit its accounts for audit, while Khadi and Village Industries Board got Rs 23 crore grants in 2018-19 and its account details are pending for four years.

Other bodies which have not submitted their accounts for audit include Iammu and Kashmir State Housing Board (seven years). Building and other Construction Workers Welfare Board (six years) and Employees Provident Fund Board, Srinagar (four years), the report said, adding that none of these have received any grants during 2018-19.

field for grazing, where he felt dizziness and went to fetch some water from a house.

During the course of time, he felt unconscious and was removed to a nearby hospital. However the doctors there declared him dead on arrival, he said.

Besides the "strong advice" given by the Centre for a significant increase of testing in all districts in line with their positivity rate, the strategy to be adopted included effective isolation and contact tracing of those infected, Re-invigoration of Public and Private Healthcare resources, ensuring of COVID Appropriate Behaviour and targeted approach to vaccination in districts reporting large numbers.

The strategy was finalised after a high-level review meeting chaired by Union Health Secretary Rajesh Bhushan with top officials of the 12 states and the UTs and Municipal Commissioners and District Collectors of the 46 districts that are the most affected by rising COVID cases and rising mortality, according to a statement by the Ministry of Health and

The states and UTs are Maharashtra, Gujarat, Haryana, Tamil Nadu, Chhattisgarh, Madhya Pradesh, West Bengal, Delhi, Jammu and Kashmir, Karnataka, Punjab and Bihar.

"Through a detailed presentation, the states were informed that the country has seen the sharpest rise in weekly COVID cases and fatalities since May 2020 (7.7% and 5.1% respectively)," the statement said.

The focus was on 46 districts that have contributed 71 per cent of the cases and 69 per cent of the deaths this month. Of the total 36 districts in Maharashtra, 25 are most affect-

ed that account for 59.8 per cent of the cases reported in the country during the past one week, the statement said. A granular analysis of affected districts in these states and

UTs along with some key statistics was presented at the meeting, it added. Almost 90 per cent of the COVID deaths continue to be in the category of those aged above 45 years. Findings of studies were highlighted which depicted that while 90 per cent

people are aware, only 44 per cent actually wear face masks, the statement said. "One infected person could spread COVID-19 to an average of 406 other individuals in a 30-day window without restrictions which could be reduced to just 15 by decreasing physical exposure to 50 per cent and to a further 2.5 (average) by

decreasing physical exposure to 75 per cent." It was also highlighted that the concept of 'second wave' reflected more the laxity among everyone regarding COVIDappropriate behaviour and virus containment and management strategy at the ground level.

Struggling to contain the fresh surge, the Maharashtra government said that holding of social, cultural, political and religious gatherings in the state is being banned completely.

Auditoriums or drama theatres should not allow their property to be used for such events, said an official order issued in Mumbai. The government also ordered that restaurants, gardens and

malls will remain shut between 8 pm and 7 am beginning Saturday night. People will also not be allowed to visit beaches during 8 pm to 7 am, the order said. Drama theatres will also remain shut from Saturday night.

However, the government has exempted delivery of food in night hours in its new set of guidelines. "Gatherings of more than five people will not be allowed

from 8 pm to 7 am effective from midnight on 27th March. Violation will attract penalty of Rs 1,000 per person on "All public places including gardens and beaches will remain closed during the same period and violators will be

fined with Rs 1,000 per person. Not wearing of face mask will attract Rs 500 fine while the same is Rs 1,000 for public spitting," the order said. In Delhi, the Delhi Disaster Management Authority(DDMA) ordered that not more than 200 guests will be allowed in open-air venues and there will be a cap of 100 in weddings at

banquet halls following a rise in COVID cases. Delhi reported over 1,500 cases for the third day on the trot on Saturday, while 10 more people, highest in around

two-and-a-half months, succumbed to the disease, the health department said. The national capital has registered 1,558 new infections which pushed the tally to 6,55,834, while over 6.38 lakh pa-

# "Supplied More Vaccines **Globally Than Vaccinated** Our Own," India Tells UN

**UNITED NATIONS:** India has supplied more COVID-19 vaccines globally than vaccinated its own people, the country has told the UN General Assembly and cautioned that vaccine inequity will defeat the collective global resolve to contain the coronavirus as the disparity in the accessibility of vaccines will affect the poorest nations the most.

India was one of the initiators of the 'Political Declaration on Equitable Global Access to COVID-19 Vaccines" that garnered the support of more than 180 UN mem-

India's Deputy Permanent Representative to the UN Ambassador K. Nagaraj Naidu said at the General Assembly informal meeting on Friday that while the COVID-19 pandemic continues to persist, the year 2021 began on a positive note with the global scientific community coming up with multiple vaccines to contain the

"While the vaccine challenge has been resolved, we are now confronted with ensuring the availability, accessibility, affordability, and distribution of CO-VID-19 vaccines. Lack of global cooperation and disparity in the accessibility of vaccines will affect the poorest nations the most," Mr Naidu said.

India has been at the forefront of the global fight against COV-ID-19. Mr Naidu told the General Assembly that India will not only be vaccinating 300 million of its own frontline workers over the next six months but in the process has also supplied vaccines to over 70 nations.

"In fact, as of today we have supplied more vaccines globally than have vaccinated our own people," Mr Naidu said.

Two of India"s vaccines, including the indigenously developed Covaxin, have already been granted emergency authorization, Mr Naidu said, adding that 30 more vaccine candidates are at various phases of clinical trials.

The vaccine Covishield is the version of the AstraZeneca/Oxford vaccine produced by the Serum Institute of India. Covaxin is the indigenously developed vaccine by pharma company Bharat Biotech.

The Political Declaration states that equitable and affordable access to safe and effective COVID19 vaccines must be ensured to have a speedy recovery and contribute

to putting an end to the pandemic. The declaration also expresses deep concern that despite international agreements and initiatives, the distribution of COVID-19 vaccines is still uneven worldwide, both among and within countries.

"Therefore, we express our deep concern that a considerable number of countries have not yet had access to COVID-19 vaccines, and stress the need for global solidarity and multilateral cooperation to increase vaccine production and distribution, on regional and global levels.

Mr Naidu said that as highlighted by the declaration equity in access to the vaccine is important for mitigating the impact of the pandemic.

"Vaccine inequity will defeat our collective resolve to contain the virus. The current disparity calls for solidarity and cooperation within the international frame-

works such as COVAX," he said. India, a significant source of supply to Gavi's COVAX facility, has contributed 20 million doses to the facility last month. India had also announced a gift of 200,000 COVID-19 vaccine doses for UN peacekeepers.

The shipment of vaccines for peacekeepers left Mumbai in the early hours of Saturday and will land in Denmark soon, Mr Naidu said.

India also underlined the need to collaborate on genomic surveillance to track virus mutations and variants and exchange information in a timely fashion.

"Vaccine hesitancy should also be countered with science and public health infrastructure and capacities of health workers in vaccine delivery needs to be strengthened globally," he said.

Mr Naidu highlighted the need for the international community to collectively work towards supporting initiatives that ensure speedy and equitable distribution of vaccines and therapeutics to the most disadvantaged populations.

"Affordability, access, and logistical issues should in no way become a hindrance in our fight against one of the biggest chal-

lenges facing humanity," he said. Mr Naidu added that India is working actively with Gavi, the World Health Organisation and ACT Accelerator.

"India and South-Africa have also called for WTO (World Trade Organisation) to suspend intellectual property rights related to COVID-19 for a limited period of time, to ensure rapid scaling-up of manufacturing of vaccines and ensuring accessibility and afford-

ability of vaccines for all," he said. He also stressed the importance of ensuring that ongoing global immunisation programmes pertaining to polio, diphtheria and other diseases do not get impacted as that will lead to the resurgence of other deadly diseases.

World Health Organisation chief Tedros Adhanom Ghebreyesus has called for countries to work together so that all States could begin vaccinating within the first 100 days of 2021. He said 177 countries and economies have started vaccination and added that with just 15 days left before the 100 days are up, 36 countries are still waiting for vaccines so they can start inoculating

health workers and older people. President of the 75th session of the UN General Assembly Volkan Bozkir said at the meeting that the world, which went into the COVID-19 pandemic together, can

emerge from it together as well. "But that depends on fair and equitable access to vaccines. From the health worker in a small island developing state, to a teacher in a refugee camp, to the elderly in care facilities across our countries, we must all be covered," Mr Bozkir said.

He stressed that the most vulnerable groups - people on the move, in conflict zones, and those already marginalised - must be

poradic incidents of violence were reported from various places that went to polls on Saturday during the first phase of Bengal assembly polls, even as the overall poll situation was largely peaceful with 79.79 per cent turnout recorded till 5 pm, an official said.

Voting was held in 30 seats - several of them part of the once-Naxal-hit Jangalmahal region-amid tight security and strict adherence to COVID-19 guidelines, the Election Commission (EC) official said.

In some booths, voters were provided with masks, sanitisers and polythene gloves. Of the 30 seats that went to

polls-nine are in Purulia, four each in Bankura and Jhargram, six in Paschim Medinipur, and seven in highstakes Purba Medinipur district.

"Till 5 pm, 79.79 per cent polling has been recorded in the state. By and large, elections were held peacefully," the EC official said.

Purba Medinipur recorded the highest turnout at 82.51 per cent, followed by Jhargram at 80.56, Paschim Medinipur at 80.12 per cent, Bankura at 79.90 per cent and Purulia at 77.07 per cent. Violence and scuffle. however, marred the polling process is some areas.

In Kanthi Dakshin seat of Purba Medinipur district, voters staged protests outside a polling booth over alleged malfunctioning of an electronic voting machine.

In Paschim Medinipur's Salboni seat, CPI(M) candidate Susanta Ghosh was heckled, and stones were hurled at his car, allegedly by TMC supporters. Police personnel posted in the area escorted him to safety.

According to reports, a few journalists who were covering the incident were also manhandled.

An EC official said three persons were arrested in connection with the attack. The TMC, however, denied any involvement.

Long queues were seen outside most booths during the morning hours, with people stepping out early in the day to avoid the sweltering heat, and violence or protests, if any. In several areas, including Egra, voters complained of intimidation by central forces.

A few EVMs, found non-functional during the voting process, were either replaced or restored, the EC official said, adding that the polling wasn't affected due to it.

On Friday, Modi attended the celebrations of the golden jubilee of the country's independence, the birth centenary of Bangabandhu' in Dhaka.



# BJP MLA Thrashed By Farmers In Punjab, **Chief Minister Condemns Attack**

CHANDIGARH: A BJP MLA in Punjab was allegedly thrashed and his clothes torn by a group of farmers at Malout in Muktsar district on Saturday, police said.

When Abohar legislator Arun Narang reached Malout along with local leaders to address a press conference, they got surrounded by a group of protesting farmers and black ink was thrown at them, officials said.

Some police personnel took the MLA and local leaders to a shop. But later when they came out of it, the protesters allegedly thrashed them and tore Narang"s clothes, police said.

Mr Narang was later escorted to a safer place by the police, officials said. Deputy Superintendent of Po-

lice (Malout) Jaspal Singh said the protesters were adamant that they would not allow the BJP legislators to hold the press conference. A police official sustained a minor injury in the incident, he said.

Punjab Chief Minister Amarinder Singh has condemned the attack and warned strict action against "anyone disturbing state's peace". A video has surfaced on social media, purportedly showing the MLA in torn clothes being shifted to a safer place by the police.

Later, Mr Narang told PTI that he was "punched" by some people. "I was punched a lot and my

clothes were also torn off," he alleged. The BJP legislator said he had gone to Malout to address a press conference but the protesters did not allow it. They got violent and surrounded

him, the MLA claimed. Asked whether he has lodged a complaint in this matter, Narang said he will talk to the party leadership over this issue.

Darshan Pal, the leader of Samvukta Kisan Morcha, an umbrella body of farmers" union, spearheading the agitation against the central agri laws, said, "Today, farmers protested against BIP MLA from Abohar. Under adverse circumstances, it turned violent and the MLA was physically assaulted.

"It is a matter of regret that an elected representative was treated this way. We do not encourage such behaviour. We strongly condemn this act." he said in a statement.

Pal also said the Samyukta Kisan Morcha appeals to all protesters to remain peaceful and disciplined. The ruling Congress in Punjab, the BJP, as well as the Shiromani Akali Dal (SAD) condemned the incident. Such "unlawful behaviour" has

no place in a democracy and the farmers" protest will be weakened by these incidents, State Congress chief Sunil Jakhar said.

While terming the attack "highly unfortunate", he said everyone should be allowed to present his views and every citizen should respect each other"s right to speak. No one should be allowed to take law and order in their own hands, the state Congress chief said. BJP national general secretary

Tarun Chugh slammed the Amarinder Singh-led government over the incident and claimed that it has "exposed the complete collapse of law and order in the state".
