

**SRINAGAR:** In what seems to be an alarming trend, Jammu and Kashmir reported on Tuesday 359 new cases of coronavirus, even as one death due to Covid-19 was also reported from the Union Territory during the last 24 hours. According to the officials, the cases witnessed over 100 percent jump since last week when 157 had tested positive

for the infection. Also, this is for the second time that single-day cases breached 300-mark in Jammu and Kashmir. In all, nearly 2900 cases were added to the tally in the last fortnight, officials said.

Also, one death due to the virus was reported in the last 24 hours, taking the J&K's fatality count to 1990—735 in Jammu and 1255 in Kashmir.

# 'Immune system harmed by preservative used in popular processed foods'

food preservative that is used to prolong the shelf life of Pop-Tarts, Rice Krispies Treats. Cheez-Its and almost 1,250 other popular processed foods might cause harm to the immune system, suggest the findings of a new peer-reviewed study by Environmental Working Group.

For the study, published this week in the International Journal of Environmental Research and Public Health, EWG researchers used data from the Environmental Protection Agency's Toxicity Forecaster, or ToxCast, to assess the health hazards of the most common chemicals added to food, as well as the "forever chemicals" known as PFAS, which can migrate to food from packaging.

EWG's analysis of Tox-Cast data showed that the preservative tert-butylhydroquinone, or TBHQ, has been found to harm the immune system both in both animal tests and in non-animal tests known as high-throughput in vitro toxicology testing. This finding is of particular concern during the coronavirus pandemic.

"The pandemic has focused public and scientific attention on environmental factors that can impact the immune system," said Olga Naidenko, Ph.D., EWG vice president for science investigations and lead author of the new

fore the pandemic, chemicals that may harm the immune system's defense against infection or cancer did not receive sufficient attention from public health agencies. To protect public health, this must change."

TBHQ is a preservative that is pervasive in processed foods. It has been used in foods for many decades and serves no function besides increasing a product's shelf life. Using new non-animal test results from ToxCast, EWG found that TBHQ affected immune cell proteins at doses similar to those that cause harm in traditional studies. Earlier studies have found that TBHQ might influence how well flu vaccines work and may be linked to a rise in food allergies.

Using ToxCast, EWG analysed all publicly available studies that show how PFAS migrate to food from packaging materials or processing equipment. This is the first known compilation of available re-

processed foods manufactured in the U.S. Last year, EWG published Food Additives State of the Science, which highlighted additives known to increase the risk of cancer, harm the nervous system, and disrupt the body's hormonal balance.

Chemicals linked to health harms can be legally added to packaged foods because the FDA frequently allows food manufacturers to determine which chemicals are safe. Additives like TBHQ were approved by the FDA decades ago, and the agency does not consider new science to reassess the safety of food chemicals.

"Food manufacturers have no incentive to change their formulas." said Scott Faber, senior vice president for government affairs at EWG.

Faber added, "Too often, the FDA allows the food and chemical industry to determine which ingredients are safe for consumption. Our research shows how important it is that the FDA take a second look at these ingredients and test all food chemicals for safety.

Less Toxic Food Preservatives Processed foods can be

made without these potentially harmful ingredients, so shoppers should read labels carefully. TBHQ is often, though not always, listed on the ingredient label. It will be listed if it has been added to the product during manufacturing. But it can also be used in food packaging, particularly plastic packaging, in which case it may migrate to food.

NEW DELHI - A Pakistani theatre group is set to blitz, the Indian capital today with an explosive satire that debunks cricket mania, the pretensions of the American empire and the clichés of official diplomacy.

Lines Out Of Control, scripted by Imran Aslam and directed by Yasmin Ismail of the Karachi-based Grips Theatre Group, parodies official postures and foibles of the men who presume to run affairs of the world.

\* Besides the situation in Iran. Iraq and India-Pakistan relations, the US also comes in for some irreverent swipes in the play that exposes the contradictions in its involvement in the Iraq war. The play, to be staged at the India Habitat Centre here on

Sunday, has attracted huge interest with most of the tickets for two shows of the play already sold The play's hard-hitting lines cut through the thicket of

jargon, so much a part of pronouncements of the powerful. This laugh fest coming as it does a .day after Holi should iniect a healthy dose of playfulness in the growing rela-tions between ordinary people of India and Pakistan.

Imran Aslam is known in Pakistan for his racy political satires that penetrate the core of social problems and hypocrisies and are refreshingly free of preaching. Says Aslam; "We love to laugh at the inanities of the establishment. That's why people love our brand of satire."

Aslam, the editor of the prominent Pakistan daily The News, believes in the redemptive power of laughter to keep us sane. A hearty laughter is worth more than a thousand official pronounce-ments is the credo that powers more than 30 plays he has penned over the years.

Like Aslam, director Yasmin Ismail is a multi-faceted woman who has kept hopes alive for Pakistani theatre through shifting ideologies and changing regimes. She has carved a niche for her sensitive direction of children's plays. Faiza Kazi, a teacher by profession, has a starring role in

the play and is now the chief mentor of Grips. Brought to India by Routes 2 Roots, an NGO that promotes cultural ties between South Asian countries. Grips Theatre has been in the business of cleansing society - through laughter for

the last two decades. Cultural contacts between the two countries are growing with scores of intellectuals, artistes and academics traversing across the border regularly, and forging new connections of the heart.

# Over 500 Killed In Myanmar Military's Crackdown On Protesters

MYANMAR: The deaths in the Myanmar military's crackdown on protesters has passed 500, as armed rebel groups on Tuesday threatened the junta with retaliation if the bloodshed does not stop.

World powers have ramped up their condemnation of the military's campaign against the anticoup movement that is demanding the restoration of the elected government and the release of civilian leader Aung San Suu Kyi.

Washington suspended a trade pact with Myanmar and UN chief Antonio Guterres called for a united global front to pressure the junta after more than 100 protesters were killed in a bloody weekend.

Adding to that pressure campaign, a trio of ethnic rebel groups on Tuesday condemned the crackdown and threatened to fight alongside protesters unless the military reined in its violence.

Daily rallies across Myanmar by unarmed demonstrators have been met with tear gas, rubber bullets and live rounds.

The Assistance Association for Political Prisoners (AAPP) said it had confirmed a total of 510 civilian deaths but warned the true toll was probably significantly higher.

On Tuesday, protesters in Yangon emptied rubbish bags in the streets as part of the latest action, while in the town of Muse in Shan state a 35-year-old protester was

Three of the country's myriad armed ethnic insurgent groups -- the Ta'ang National Liberation Army, the Myanmar Nationalities Democratic Alliance Army and the Arakan Army (AA) -- issued a joint statement threatening retaliation.

"If they do not stop, and continue to kill the people, we will cooperate with the protesters and fight back," the statement said.

If such groups take up arms, Debbie Stothard at the International Federation for Human Rights (FIDH) warned that the situation could degenerate into civil war.

Two dozen ethnic minority rebellions have flared in Myanmar since independence from British colonial rule in 1948, fighting over autonomy, identity, drugs and natural resources.

The military has sought to cut deals with some armed groups and earlier this month took the AA off the list of terrorist organisations.

But over the weekend it launched air strikes in eastern Karen state -- the first such strikes in 20 years -- targeting the Fifth Brigade of the Karen National Union (KNU) after

# Suez Canal Reopens After Nearly A Week As Stuck Cargo Ship Is Freed

SUEZ: Salvage teams on Monday finally freed the colossal container ship stuck for nearly a week in the Suez Canal, ending a crisis that had clogged one of the world's most vital waterways and halted billions of dollars a day in maritime commerce.

A flotilla of tugboats, helped by the tides, wrenched the bulbous bow of the skyscraper-sized Ever Given from the canal's sandy bank, where it had been firmly lodged since March 23.

The tugs blared their horns in jubilation as they guided the Ever Given through the water after days of futility that had captivated the world, drawing scrutiny and social media ridicule.

"We pulled it off!" said Peter Berdowski, CEO of Boskalis, the salvage firm hired to extract the Ever Given.

"I am excited to announce that our team of experts, working in close collaboration with the Suez Canal Authority, successfully refloated the Ever Given, thereby making free passage through the Suez Canal possible again."

Navigation in the canal resumed at 6 p.m. local time (1600 GMT, noon EDT) said Lt. Gen.Osama Rabei, head of the Suez Canal Authority, adding that the first ships that were moving carried livestock.

From the city of Suez, ships stacked with containers could be seen exiting the canal into the Red Sea.

At least 113 of over 420 vessels that had waited for Ever Given to be freed are expected to cross the canal by Tuesday morning, Rabei added at a news conference.

The Ever Given sailed to the Great Bitter Lake, a wide stretch of water halfway between the north and south ends of the canal, for inspection, said Evergreen Marine Corp., a Taiwan-based shipping company that operates the ship.

Buffeted by a sandstorm, the Ever Given had crashed into a bank of a single-lane stretch of the canal about 6 kilometers (3.7 miles) north of the southern entrance, near the city of Suez.

That created a massive traffic jam that held up \$9 billion a day in global trade and strained supply chains already burdened by the coronavirus pandemic.

Rabei said an investigation would determine why the Ever Given got stuck, and he estimated daily losses to the canal of between \$12 million to \$15 million.

"The Suez Canal is not guilty of what happened. We are the ones who suffered damage," he said.

At least 367 vessels, carrying everything from crude oil to cattle, had backed up to wait to traverse the canal. Dozens of others have taken the long, alternate route around the Cape of Good Hope at Africa's southern tip, a 5,000-kilometer (3,100-mile) detour that costs ships hundreds of thousands of dollars in fuel and other costs.

The canal is a source of national pride and crucial revenue for Egypt, and President Abdel Fattah el-Sissi praised Monday's events after days of silence about the blockage.

"Egyptians have succeeded in ending the crisis," he wrote on Facebook, "despite the massive technical complexity.

While the Ever Given was stuck the rising and falling tides put stress on the vessel, which is 400 meters (a quarter mile) long, raising concerns it could crack.

Rabei praised the team, saying they "achieved a very difficult mission in record time," without damaging the vessel or its cargo.

Berdowski told Dutch radio station NPO 1 the company had always believed it would be the two powerful tugboats it sent that would free the ship. Monday's strong tide "helped push the ship at the top while we pulled at the bottom and luckily it shot free," he said.

"We were helped enormously by the strong falling tide we had this afternoon. In effect, you have the forces of nature pushing hard with you and they pushed harder than the two sea tugs could pull." Berdowski added.

## **Female Polio Vaccination Workers Shot Dead In Afghanistan: Report**



unmen have killed three female polio vaccination health workers in the eastern Afghan city of Jalalabad, two government sources have told the Reuters news agency.

It was not immediately clear who carried out the two separate shootings, a provincial government official said on Tuesday. A central government source confirmed the shootings, Reuters said.

The killings came on the second day of a new five-day doorto-door anti-polio vaccination drive launched in Afghanistan and neighbouring Pakistan on Monday to vaccinate millions of children despite the risks posed by the coronavirus.

In Afghanistan, the campaign intends to inoculate about 9.6 million children in 32 out of the country's 34 provinces, a health official said.

In the second anti-polio vaccination campaign this year, more than 55,000 workers would implement the vaccination for five days, according to the Afghan Health Ministry's polio coordinator, Mir Jan Rasikh.

However, there remains a big stumbling block in the Afghan polio drive. The Taliban, like in previous years, would not allow the home-to-home campaign in areas under their control.

According to Taliban spokesman Zabiullah Mujahid, the group is still in talks with the World Health Organization or WHO to reach an agreement about the programme in which workers go from door to door to carry out the inoculations.

In areas under Taliban control. the process is delayed because of security reasons, according to Mujahid. About three million children were deprived of the polio vaccine in the past three years, according to the Afghan health ministry.

So far this year, there have been about two dozen polio cases in the country, the ministry said.

In Pakistan, the five-day antipolio vaccination campaign that started on Monday will target more than 40 million children under the age of five.

Approximately 285,000 frontline workers will span out across Pakistan's 156 districts to administer the oral drops while following COVID-19 safety protocols.

"COVID-19 continues to challenge us but we are committed to ensuring continuity of the essential public health services during these difficult times," the Special Assistant to the Prime Minister on Health, Dr Faisal Sultan, said in a statement.

Pakistan and Afghanistan are the only two remaining countries in the world where polio is endemic, after Nigeria was declared

free of the wild poliovirus last year. Pakistan came very close to eliminating polio, but recorded 147 cases, a five-year high in 2019, amid vaccine boycotts and attacks on health workers.

Pakistan started a polio programme in 1994 but the work of the health workers was repeatedly hampered by violent attacks.

The United Nations-funded drive to vaccinate children under the age of five faces opposition from religious conservatives, who believe the vaccine, administered in multiple rounds, is intended to make Muslim children sterile.Pakistani armed groups also regularly stage attacks on polio teams and police escorting them, claiming the anti-polio drive is part of a Western conspiracy to collect intelligence.

These attacks increased after it was revealed that a fake hepatitis vaccination campaign was used as a ruse by the CIA in the hunt for al-Qaeda leader Osama bin Laden, who was killed by US commandos in 2011 in Pakistan.

Pakistan's second polio vaccination drive of the year comes as the country battles to bring down steadily rising daily infections of coronavirus, currently at more than 4,000 per day, amid a third wave of the pandemic.

On Monday, Pakistan put virus hotspots in more than two dozen cities with higher infection rates under lockdown and started the process of vaccinating people aged 50 and above.

But the vaccination campaign, which started last month so far received a lukewarm response. Pakistan has registered more than 659,000 coronavirus cases and 14,256 deaths.

Google, an Alphabet Inc unit, said the feature would launch later this year in the US and eventually reach other countries as part of its commitment to help combat climate change through its services.

Unless users opt out, the default route will be the "eco-friendly" one if comparable options take about the same time, Google said. When alternatives are significantly faster, Google will offer choices and let users compare estimated emissions.

"What we are seeing is for around



half of routes, we are able to find an option more eco-friendly with minimal or no time-cost tradeoff," Russell Dicker, a director of product at Google, told reporters on Monday.

Google said it derives emissions

relative estimates by testing across different types of vehicles and road types, drawing on insights from the US government's National Renewable Energy Lab (NREL). Road grade data comes from its Street View cars

as well as aerial and satellite imagery. The potential effect on emissions from the feature is unclear. But in a study of 20 people at California State University, Long Beach, university researchers last year found participants were more inclined to consider carbon emissions in route selection after testing an app that showed estimates.

Google's announcement included additional climate-focused changes. From June, it will start warning drivers about to travel through low emissions zones where some vehicles are restricted in Germany, France, the Netherlands, Spain and the UK.

In the coming months, Maps app users will be able to compare car, biking, public transit and other travel options in one place instead of toggling between different sections.

#### Nike Sues Company Over 'Satan Shoes' **Agenceis**

thletic shoemaker Nike Inc has sued a New York-based Company that produced "Satan Shoes" purported to contain a drop of human blood as part of a collaboration with rapper Lil Nas X.

Nike said in the lawsuit on Monday that the company, MSCHF Product Studio Inc, infringed on and diluted its trademark with the black-and-red, devil-themed shoes, which went on sale online that day. Lil Nas X is not named as a defendant in the suit.

The shoes are customised Nike Air Max 97 sneakers that contain red ink and "one drop of human blood" in the sole, according to a website describing the 666 pairs of limited-edition shoes. The back



of one shoe says "MSCHF" and the other says "Lil Nas X."

Several media outlets reported that the shoes sold out in less than one minute at a cost of \$1,018 per pair. Lil Nas X said on Twitter he would choose the recipient of the 666th pair from among social media users who circulated one of his tweets.

Nike, in its lawsuit filed in federal court in New York, said the shoes were produced "without Nike's approval and authorisation,"

and the company was "in no way connected with this project." "There is already evidence of sig-

nificant confusion and dilution occurring in the marketplace, including calls to boycott Nike in response to the launch of MSCHF's Satan Shoes based on the mistaken belief that Nike has authorised or approved this product," the lawsuit said. Nike asked the court to imme-

diately stop MSCHF from fulfilling orders for the shoes and requested a jury trial to seek damages. Representatives for Lil Nas X

and MSCHF did not immediately respond to requests for comment. The Grammy-winning rapper, 21

Addressing a press conference after the protest, Kashmir Economic Alliance co-chairman Farooq Ahmed Dar said that if the government was taking steps to curb crime then they cannot interfere, but the jobs of those involved in the business must be protected.

He said that the taxes of vehicles exported to the valley from outside the states have already been paid, and they have to go through the initial stages again during their re-registration.

# **J&K Congress Chief, Workers Briefly Detained In Rajouri**

JAMMU: Jammu and Kashmir Pradesh Congress Committee (JK-PCC) president G A Mir was detained on Tuesday along with senior party leaders and workers during a protest against the hike in prices of petrol and other essential commodities in Rajouri district, a party spokesman said.

Prominent among those taken into preventive custody included JKPCC vice president Raman Bhalla, former legislators Ravinder Sharma and Ashok Sharma, former minister and District Development Council (DDC) vice chairman Shabir Khan, the spokesman said.

An official said dozens of Congress activists, including Mir, were detained briefly to maintain law and order.

IKPCC chief spokesman Ravin Sharma said a contingent of police personnel stopped the Congress activists led by Mir from marching towards the office of Deputy Commissioner, Rajouri and later the top leadership along with hundreds of workers were arrested.

Earlier addressing the protesters, Mir said the BJP's claim of providing 'pro-people' governance stands exposed as the central government has allegedly failed miserably to address

the issues affecting the public. The common man is going through the worst sufferings under the current dispensation, which has sold its soul to few businessmen, ignoring the agonies of the country-

men, he alleged. The Congress leader said the country is presently going through a state of crisis.

The graph of the inflation is on a constant rise, the fuel prices have touched the sky, and lakhs of farmers across the country are protesting for repeal of three farm laws aiming to snatch their right over their own lands.

He was also found in possession of FDRs Bank Balances/Insurance Policies etc. The accused spent huge money on purchase of gold, marriage of children and renovation of house.

The statement said the assets have been found disproportionate to his known sources of income, therefore constituting commission of offences punishable under section 5(1) (e), r/w 5(2) J&K P.C Act Svt. 2006

It said a case under FIR No. 05/2021 P/S ACB(SBG) was registered against Bashir Ahmad Mir, son of Abdul Aziz, a resident of Pati Vethpora Pandrethan at present 9-Hill View Colony Rawalpora, Wanbal Rangreth, Srinagar presently posted as AEE JKPCC Ltd Unit 5th Anantnag. "Searches were also conducted in the residential house of accused AEE after obtaining proper search warrants from the Court." Further Investigation in the case is going on.

**SRINAGAR:** Questioning the government's announcement to open the doors of construction and development in the Valley, the valley based contractors Tuesday said that the pending liabilities were not paid even at the end of the financial year.

Addressing a press conference at his office in Srinagar, Farooq Ahmad Dar, General Secretary of the Central Contractors Coordination Committee expressed anguish and said that the government has forgotten contractors even at the end of the financial year after the announcement of the budget.

He said Government expressed silence in the budget on the payment of dues and now at the end of the financial year the same approach was adopted.

Dar said that even during covid-19 period, contractors risked their lives to carry out emergency work, but the government forgot them. Dar said that while Rs 900 crore were reportedly released on Macadamisation, others were forgotten.

He claimed that in fact it seems that the former engineers hatched a conspiracy and kept a close eye on Macadamisation and forgot about the small contractors.

Dar also expressed concern over the unavailability of construction materials and the alarming increase in rates adding that the ban on mining should be lifted immediately.

# Vaccine not lockdown

s the coronavirus cases surge in Kashmir and across the country, there's again talk of fresh lockdown, albeit, the government both at the centre and in J&K are not in a hurry to impose one. This is because, the lockdowns have proved disastrous in their fallout on the economy. India's economy last year plunged by one-fourth. As the example around the world would have us believe, lockdown has only reduced the infections not controlled them. In J&K, the lockdown also crushed the economy, leaving thousands of people unemployed. It stopped the circulation of money and hit the marginalized sections very hard. In fact, the fallout of the lockdown has been far worse than that of the pandemic and on a much bigger scale. What was billed as a cure has turned out to be worse than the disease.

As things stand, we have moved past the stage where recourse to a lockdown is even an option. What the government can focus on instead is to strictly enforce the social distancing norms in public. And it can do so, considering the smaller population of Kashmir makes the infections more manageable than the densely populated states across India.

Kashmir economy is looking forward to a post-Coronavirus period and hopes it remains peaceful. The region has been through a long period of disruption. We can only hope that the world is able to get a handle on this deadly virus and get back to a normal life.

Meanwhile, the only thing that can defeat the pandemic is the vaccination. The urgency of administering jabs to people can't be over-emphasised. We can hardly afford the steep spike in the cases that could force the government to go for yet another lockdown. So the vaccination has to pick up in right earnest. In Kashmir too, there's a dire need that more and more people get shots. On Monday, the former Chief Minister Dr Farooq Abdullah also tested positive. J&K recorded 235 new positive COVID-19 cases, taking the infection tally to 1,30,228, even as no fresh death due to the disease was reported in the Union territory. A day earlier, on Sunday, the region had recorded 309 coronavirus cases, in the year's highest daily count. The death toll has reached 1,989 with four new fatalities in Kashmir. But the vaccination is not yet commensurate with the spread of the infection. It is time that the government speeds up the inoculation drive and sets up more vaccination centres. The Valley needs to be Covid-free for the businesses to return to normal and tourism to pick up in the warmer seasons ahead.

# The China-Iran Axis

he latest sign is the weekend's pact between China and Iran, an example of U.S. adversaries uniting to advance their strategic ambitions.

The two sides signed what they described as a 25-year "strategic partnership" that amounts to a significant deepening of ties. China will invest several hundred million dollars in a variety of Iranian projects, including nuclear power, ports, and oil and gas development. In return China will get a steady supply of Iranian oil. The two will also deepen their defense cooperation as China will transfer some military technology.

Apologists for the 2015 Iran nuclear deal are saying this doesn't add up to more than the status quo, and thus shouldn't interfere with renewed U.S. courtship of Iran. Don't believe them. This is a big deal that advances the strategic interests of both sides—at the expense of the U.S. and stability in the Middle East.

The deal helps Iran dodge American sanctions, and the cash infusion will ease economic pressure on the Islamic Republuc. Iran will have a long-time buyer for its oil exports that were reduced by U.S. sanctions. The foreign-exchange income, if that's how the payments are made, will finance the Islamic Revolutionary Guard Corps and its proxy forces in Yemen, Syria and Iraq.

The countries will also form a Chinese-Iranian bank with the aim of evading the U.S. dollar dominance in world trade that gives U.S. sanctions their bite. Breaking the dollar's hold on global trade and finance is a major goal of Russia, China and Iran. China believes that U.S. fiscal profligacy is putting the dollar's role as the world's reserve currency at risk, and they want the Chinese yuan to replace it.

The China-Iran tie also complicates U.S. strategic interests. President Biden and Europe want Iran to rejoin the 2015 nuclear deal, but an Iran backed by China is under less pressure to do so. The same goes for aiding their Houthi's who want to take over Yemen. China and Russia can block any attempt to put more global pressure on Iran through the United Nations.

The deal expands China's influence in the Middle East, which it wants for access to energy and raw materials as well as to increase its economic sway. China has also been courting the Saudis and Gulf states with economic lures. As the shale revolution has made the U.S. less dependent on Middle Eastern oil, those oil exporters need access to the China market. If the U.S. is seen as unreliable, these countries can hedge their bets with China. American influence in the Persian Gulf is not a birthright.

# A Dialogue for Us?

No one in the region or the world is more concerned about the outcome of India, Pakistan talks than Kashmiris

he surprise thaw in India, Pakistan relations has become a major talking point in Kashmir: it figures in everyday social interactions, social media threads and whatsapp groups. People are curious to know what led to the sudden re-engagement between the two estranged countries, where could it lead to and more importantly whether it could usher in any change in Kashmir.

As for what led to the detente, it is anybody's guess. For clues, we need to look at the evolving geopolitical environment. China's incursions in Ladakh, the endgame in Afghanistan war and the emerging cold war between the US and China are redrawing geopolitics of the region. This has drawn the US closer to India and China to Pakistan.

In fact, Washington's priorities with India are no longer regional in their nature but their scope is the larger geo-politics. In recent years, the US-India engagement has been a direct outcome of the remaking of the global power equation with India not only being recognized as a global power in its own right but also as a countervailing force to China, the world's No 2 power. It goes without saying that India's 1.3 billion population with a value addition of a burgeoning middle class has become an ultimate attraction for the west.

On the other hand, the alliance between China and Pakistan has deepened. More so, at a time when China is staying put at the three friction points in Ladakh after sorting out Pangong Tso. While US and Pakistan are still reasonably good friends, it is the mutual expedience that keeps them tied together. The relationship will snap at the first opportunity the US outgrows the need to seek Pakistan's assistance in securing geo-strategic objective in the region. And this can happen sooner than later. Pakistan is already apprehensive about once again losing its leverage with the US following the latter's exit from Afghanistan. Things are likely to become more difficult, if the west sees Islamabad as an ally of China at a time when a new cold war is breaking out, now between the US and the China.

India's situation is also difficult: The power differential between India and China is growing. Over the last three decades, China has become a far bigger power than India, both economically and militarily. So much so that China is now seen as a credible rival to the US which has otherwise been the sole superpower since the break-up of the USSR in 1989. India's choices are thus stark: It has to either co-operate with China in a subservient position. Or try standing up to Beijing

the longstanding conflicts. Deferring the resolution is certain to aggravate the rivalries, especially the one between India and Pakistan.

So far there has hardly been a regional effort that works to resolve issues in a cooperative framework. Each country is looking to secure their respective interests rather than work together for a solution.

Is the recent disengagement with China at Pangong Tso and the talks Pakistan a step in this direction? We frankly don't know. All we know both the developments took place almost simultaneously. But

by entering into a formal alliance with the US and becoming an active member of Quadrilateral Security Dialogue - a grouping comprising the US, Japan, Australia and India also called Asian NATO. Both choices have their consequences, more detrimental than favourable to India. So, New Delhi has so far been chary of committing itself to either side so as to maintain its strategic autonomy. This would involve negotiating its relations with Beijing and also engage with the US.

But this leaves out Pakistan. The long running estranged relationship between India and Pakistan has been the singlemost factor that has been complicating the matters in the region. The relationship plunged to its nadir after the withdrawal of J&K autonomy. So, if there has to be a stable South Asia, it will involve a broad reconciliation among the three major powers of the region: China, India and Pakistan. And this would need resolving the existing differences and reconciling the contending interests of the three countries which essentially keep the region destabilized.

Need is for a broader regional approach to reconcile the competing interests of the three countries and to work for an integrated solution to

there are the other explanations too, as the reports and analyses in the media in India, Pakistan and the other international publications would have us believe And it hardly matters what led to the engagement as long as it delivers to the benefit of all. If the history is any guide, such hopes have invariably been belied. The issues underlying the lingering distrust among the powers in the region, especially between India and Pakistan, are not amenable to a solution unless the countries are not only ready to stay the course but also willing to mutually concede.

No one in the region or the world is more concerned about the outcome of these talks than Kashmiris. For over seventy years, the region has been turned into an unremitting battleground for competing nation-hoods of India and Pakistan. And with every passing day, this conflict is getting messier and bloodier, something that has turned the lives of Kashmiris into a living hell.

# 7 Simple Habits to Protect Your Mental Health

Lifestyle changes to improve and prevent symptoms of depression and anxiety.

A disposition that tends towards self-critical, or perfectionistic, can be a risk factor for anxiety and depression. This can include feeling like you must be perfect to be accepted, an inability to accept flaws within yourself, intense selfscrutiny, or an unrealistic sense of others' expectations and your capacity to meet them.

hen a patient came to see me for long-standing symptoms of depression and anxiety (they often co-occur), he was hesitant at best. He wanted to feel better, but "getting treatment" didn't fit with his narrative for what he was "supposed to be doing as a grown man" in his culture. He had a decent, consistent job, but felt his life lacked meaning and joy. He was so hard on himself and avoided others for fear of judgment.

I knew he'd run the other way if I jumped too quickly into a medical referral or diagnosis, so we started with the most human approaches — connecting about what was really going on for him, and exploring readily available lifestyle changes that aligned with his interest, motivation, and values.

Within weeks, his spark started to come back, and within months he felt he had a new lease on life. He wasn't suddenly happy all the time. But he felt a new sense of his capacity to take charge of his mental health.

Will everyone have an outcome like that patient of mine from lifestyle changes? Definitely not — anxiety and depression are complex conditions with tremendous individual variation, varied underlying causes, and varied levels of severity.

But can everyone benefit from learning the foundation for how to care for their mind either separately or as an adjunct to professional treatment? I believe so.

The following seven health behaviors are key ones linked to prevention or symptom improvement of anxiety and depression.

While everything on this list is simple, it's far from easy. Change is hard. And if you currently have depression or anxiety, it can be especially challenging. That's why one of the key behaviors is being kind to yourself

If moved to do so, choose one area to work on at a time, perhaps an area you feel especially motivated or confident to address, or an area that feels aligned with your most important values. Then take it one step at a time. The funny thing about change is we often don't know it's happening, we just keep rowing in the right direction, and usually after a few, or a few thousand, twists and turns, we look back in awe at how far we've come.

#### 1. Sleep

While 10-18% of adults in the U.S. experience chronic sleep issues, this number jumps to 65-90% of those with depression, and over 50% of those with generalized anxiety disorder. Of those with depression. 65% had sleep issues first.

Addressing sleep issues can alleviate symptoms of mental health conditions, and given sleep problems are a risk factor for mental health conditions, can also help protect your mental health.

#### 2. Self-Compassion

A disposition that tends towards self-critical, or perfectionistic, can be a risk factor for anxiety and depression. This can include feeling like you must be perfect to be accepted, an inability to accept flaws within yourself, intense self-scrutiny, or an unrealistic sense of others' expectations and your capacity to meet them.

Despite the fear of many who have this characteristic, the antidote to perfectionism isn't letting it all go, or saying goodbye to standards – it's self-compassion.

According to researcher Kristen Neff self-com-

According to researcher Kristen Neff, self-compassion has three components: self-kindness vs. self-judgment, common humanity vs. isolation, mindfulness vs. overidentification.

How we treat ourselves through the ups and downs of life can have a tremendous impact on health and mental health.

#### 3. Social Connection

From the time we are born, we need social connection in order to thrive.



A recent study lead by researchers at Harvard sought to understand what could most protect us from depression that is within our control. After analyzing over 100 potential factors, they found that social connection was by far the most important protective factor.

It's been a lonely year for many. And many are anxious at the prospect of going back to normal. But connection doesn't mean a big party or bustling office. It can be confiding in one trusted person about how you're really doing, listening to how someone else is really doing, giving a meaningful thank you, or having a (safe) visit with any family member or friend.

If this feels out of reach, try making a short list of people who at any point have given you a sense of belonging. Other studies have shown that just calling positive relationships to mind can have a positive impact on our capacity to tolerate stress.

#### 4. Exercise

Exercise can be important for preventing depression since having a sedentary lifestyle is a risk factor. One study found that 15 minutes a day of vigorous exercise significantly prevents depression. Another study found that 12 weeks of vigorous exercise at 30 minutes, three to five times per week reduced symptoms by 47%.

For co-existing anxiety and depression, a 2020 study led by James Blumenthal, professor of psychiatry at Duke University, exercise was most effective when combined with medication. Otherwise, a high level of anxiety seemed to dull the effects of exercise for reducing depression.

What about anxiety? Research shows exercise can be a positive distraction, that higher levels of activity can protect against symptoms, and that a single session of exercise can have immediate benefits for reducing stress and worry.

#### 5. Nutrition

A lot has been written on the link between food and mood. We have so many neurons and neurotransmitters in our gut that it's been dubbed "the second brain." In fact, 95% of the serotonin we produce is from neurotransmitters in the gut.

Traditional diets (like the Mediterranean diet) high in vegetables, whole grains, and good-for-your-brain fats are associated with a 25-35% reduced risk of depression compared to the typical western diet

which is higher in sugar, processed foods, and dairy.

Although we typically think of positive nutrition as a prevention habit, a 2020 study found significant reductions in depression symptoms, as well as co-occurring anxiety symptoms, after a 12-week intervention that offered nutritionist support to follow a modified Mediterranean diet. These findings suggest that nutrition therapy is a useful adjunct to treatment, and may one day be validated as a treatment in and of itself.

#### 6. Meaning and Purpose

No list could be complete without a nudge to meaning and purpose. If we struggle with mood and negative emotions, it may be especially important to define happiness for ourselves. As Victor Frankl wrote in Man's Search for Meaning: "For success, like happiness, cannot be pursued; it must ensue."

It's hard to control "happy." It's much easier to trol "meaning."

#### 7. Mindfulness

Through mindfulness, you can shift how you relate to difficult thoughts and feelings. Many find that with continued practice, they still have difficult thoughts and feelings but they can observe them with a little more distance and a little less believing them as fact.

One study found that after eight weeks of mindfulness practice, practitioners showed increased grey matter concentration, which is associated with emotional regulation, among other benefits. Mindfulness is not a cure-all, but it can be quite a helpful tool for shifting how you experience challenges.

Which of these habits is most effective? Well, that really depends on what works for you! If someone tells you mindfulness is "the only way," let that notion drift away like leaves on a river. As a 2021 review from the University of Cambridge found, for instance, mindfulness is helpful in most clinical settings but not necessarily more so than other wellness approaches, like exercise.

So really the best approach is: Get whatever support is in reach (for clinical levels of anxiety and depression, professional therapy and medical evaluation is the gold standard) and care for your mind based on what works for you.

# Are You a Lucky Person?

Whether you believe you are lucky or not may depend on your personality.

ortuna, the Roman goddess of luck, is often depicted blindfolded and steering a ship. She is steering our lives, and she is doing so blindly.

Luck is a crucial component in our lives. Being born in either the right or the wrong side of the tracks, carrying these or the other genes in our chromosomes, or indeed taking this or the other turn on a seemingly unimportant day, will determine our future. Not everyone agrees: "When it comes to luck, you make your own," said Bruce Springsteen. True to some extent, and yet I strongly suspect that there are countless hardworking potential rock stars out there whose talent remains undiscovered because they have never been in the right place at the right time. A creative gift and hard work play crucial parts in any success story, but sheer luck is equally critical.

Having accepted that there is such a thing as luck, there are two ways of assessing how lucky one is as a person. The first one is to consider how much luck one has had in life up to the present point. I, for instance, consider myself pretty lucky. I don't delude myself into thinking that the good stuff I see in my life would have happened regardless of luck. To give an example, I was fortunate enough to find my life companion in a strange city in a foreign country, and it happened by chance. I had landed in that city after applying for the first job I saw advertised in a medical publication that week. I became the trainee doctor in a ward where she worked as a nurse. A different ad on a different magazine, or on a different week, would have taken me to an un-



doubtedly worse destiny. At the same time, there have been instances in my biography in which I was spectacularly unlucky, but they are too painful to recall. All of us have been both lucky and unlucky at different times, but I have no doubt that general

"luckiness" in life could be represented by a normal distribution graph, in which the bulk of us would be found around the middle, blessed with a more or

less average amount of luck.

A second way of assessing luck is the belief in

"trait" luckiness; in other words, good luck as a personal attribute that not only has influenced events in one's past, but that will also continue to determine events in one's future. People who believe in luck as a general factor in life and those who believe that they are personally lucky tend to have very different personalities. Essentially, the former tend to be more neurotic and less happy than the latter. It is a good thing therefore to believe on one's luckiness, but it is also absurd, as the following example illustrates.

Random is capricious and continues to operate randomly, whatever may have happened up to a given point. A roulette player may think that after five consecutive reds, the next spin must surely fall on black, following what has been named the "Monte Carlo Fallacy." Of course, the odds for black will remain precisely 50% in every single spin, however many consecutive times the ball has landed either on red or on black. On August 18, 1913, the ball fell on black 26 successive times at the Monte Carlo Casino (hence the name of the fallacy). The odds of this happening were ridiculously low, so perhaps not surprisingly, gamblers in the casino bet heavily against the ball landing on black during this streak, some losing fortunes in the process.

I would argue that seeing yourself as a lucky person is itself lucky, as feeling confident that you will land on your feet whatever life throws at you must be very comforting. "Luck is believing you're lucky," said Tennessee Williams. I, like many others, prefer to stay on the good side of Fortuna and not tempt luck too much, lest I displease her.

# Study reveals differences between men's and women's brains

ow different are men's and women's brains? The question has been explored for decades, but a new study by researchers at Rosalind Franklin University of Medicine and Science coalesced this wide-ranging research into a single mega-synthesis. And the answer is: hardly at all.

"Men and women's brains do differ slightly, but the key finding is that these distinctions are due to brain size, not sex or gender," Dr. Eliot said. "Sex differences in the brain are tiny and inconsistent, once individuals' head size is accounted for.'

The unusually large study of studies, "Dump the 'dimorphism': Comprehensive synthesis of human brain studies reveals few male-female differences beyond size," published in Neuroscience and Biobehavioral Reviews, finds that size is the only clear-cut difference between male and female brains.

Women's brains are about 11% smaller than men's, in proportion to their body size. Smaller brains allow certain features, such as a slightly higher ratio of grey matter to white matter, and a higher ratio of connections between, versus within, cerebral hemispheres.

"This means that the brain differences between large- and small-headed men are as great as the brain differences between the average man and woman," Dr. Eliot said. "And importantly, none of these size-related differences can account for familiar behavioral differences between men and women, such as empathy or spatial skills.'

This is not the story typically publicized about sex differences in the human brain.

"Since the dawn of MRI, studies finding statistically significant sex differences have received outsized attention by scientists and the media," said Dr. Eliot, whose books include "Pink Brain, Blue Brain: How Small Differences Grow Into Troublesome Gaps."

"Researchers have been quietly accumulating massive amounts of data comparing male and female brains, but it's only the differences that get hyped," Dr. Eliot continued. "Unlike other areas of health research, women have been equally included in brain imaging from the outset."

Dr. Eliot and her collaborators -- fourthyear Chicago Medical School students Adnan Ahmed, Hiba Khan and Julie Patel -conducted a meta-synthesis of three decades of research, assimilating hundreds of the largest and most highly-cited brain imaging studies addressing 13 distinct measures of alleged sex difference.

For nearly every measure, they found almost no differences that were widely reproduced across studies, even those involving thousands of participants. For example, the volume or thickness of specific regions in the cerebral cortex is often reported to differ between men and women. However, the meta-synthesis shows that the regions identified differ enormously between studies.

Male-female brain differences are also poorly replicated between diverse populations, such as Chinese versus American. meaning there is no universal marker that distinguishes men and women's brains



across the human species.

"The handful of features that do differ most reliably are quite small in magnitude," Dr. Eliot said. "The volume of the amygdala, an olive-sized part of the temporal lobe that is important for social-emotional behaviors, is a mere 1% larger in men across studies."

The study also rebuts a longstanding view that men's brains are more lateralized, meaning each hemisphere acts independently, whereas women's two hemispheres are said to be better connected and to operate more in sync with each other. Such a difference could make males more vulnerable to disability following brain injury such as stroke.

Here again, the consensus of many studies shows that the difference is extremely small, accounting for even less than 1% of the range of left-right connectivity across the population. This finding does agree with large datasets that have found no gender difference in aphasia, or the loss of language,

following a stroke in the left hemisphere, contrary to long belief.

A last focus of the new study is on functional MRI. This method allows neuroscientists to see areas that "light up" during particular mental tasks and has been widely used to look for male-female differences during language, spatial and emotional tasks.

Across hundreds of such studies, Dr. Eliot's team found extremely poor reliability in sex difference findings -- nearly all specific brain areas that differed in activity between men and women were not repeated across studies. Such poor reproducibility agrees with recent research out of Stanford University demonstrating "false discovery," or the over-publication of false-positive findings in the scientific literature on functional MRI sex difference

"Sex comparisons are super easy for researchers to conduct after an experiment is already done. If they find something, it gets another publication. If not, it gets ignored," Dr. Eliot said. Publication bias is common in sex-difference research, she added, because the topic garners high interest.

"Sex differences are sexy, but this false impression that there is such a thing as a 'male brain' and a 'female brain' has had wide impact on how we treat boys and girls, men and women," Dr. Eliot said.

"The truth is that there are no universal, species-wide brain features that differ between the sexes. Rather, the brain is like other organs, such as the heart and kidneys. which are similar enough to be transplanted between women and men quite successfully."

# 'COVID might boost social inequality in society'

# Coffee waste can boost forest recovery: Study

offee pulp, a waste product of coffee production, could be used to speed up tropical forest recovery on post agricultural land, suggests a new study. In the study published in the journal 'Ecological Solutions and

Evidence', the team spread 30 dump truck loads of coffee pulp on a 35-40m area of degraded land and marked out a similar sized area without coffee pulp as a control.

"The results were dramatic," said lead researcher Rebecca Cole from the University of Hawai'i in

"The area treated with a thick

layer of coffee pulp turned into a small forest in only two years while the control plot remained dominated by non-native pasture grasses," Cole added.

After only two years, the coffee pulp treated area had 80 per cent canopy cover compared to 20 per cent in the control area. The canopy in the coffee pulp area was also four times taller than that of the control area.

The addition of the half metre thick layer of coffee pulp eliminated the invasive pasture grasses which dominated the land

These grasses are often a barrier to forest succession and their removal allowed native and pioneer tree species, that arrived as seeds through wind and animal dispersal, to recolonise the area quickly.

The researchers also found that after two years, nutrients, including carbon, nitrogen and phosphorous, were significantly elevated in the coffee pulp treated area compared to the control.

For the study, the researchers analysed soil samples for nutrients immediately prior to the application of the coffee pulp and again two

They also recorded the species present, the size of woody stems, percentage of forest ground cover and used drones to record canopy cover.


# **Petrol Price Cut By 22** Paise, Diesel By 23 Paise

#### **India Blocks Two Bank Accounts Of China's Bytedance** In Tax Case: Report

ndian authorities have blocked bank accounts of ByteDance in Lthe country for alleged tax evasion and the company has asked a court to quash the directive which it fears will hit its operations hard, two sources with direct knowledge told Reuters.

ByteDance in January cut its India workforce after New Delhi decided to retain a ban on its popular video app TikTok, first prohibited last year following a border clash between India and China. China has repeatedly criticized India's move and said it suspected it was against WTO rules.

ByteDance still has around 1,300 employees in India, most of whom service its overseas operations, including work on activities such as content moderation.

In mid-March, two of Byte-Dance India's bank accounts in Citibank and HSBC were ordered blocked by authorities for alleged evasion of certain taxes in online advertising dealings between the ByteDance unit in India and its parent entity in Singapore, TikTok Pte Ltd, the two sources said.

Other than the two accounts, he authorities also directed Citibank and HSBC to not allow ByteDance India to withdraw funds from any other bank accounts linked to its tax identification number, the first source said.

In a court filing which is due to be heard soon at a High Court in the financial capital Mumbai -ByteDance India has argued that while it had only about \$10 million in its accounts, the blocking decision was an abuse of the legal process and will make it hard for it to pay salaries and taxes, the source added.

Both the sources declined to be identified as the details of the bank freeze or company's court challenge were not public.

ByteDance India, as well as HSBC, Citibank and India's finance ministry, did not immediately re-



spond to a request for comment.

The TikTok app ban - part of dozens of other Chinese apps which were banned last year - in what India said was in interests of national security and sovereignty. The move was widely seen as India's broader pushback against Chinese businesses after clashes at a disputed Himalayan border site left 20 Indian soldiers dead.

The directive to freeze Byte-Dance India's bank accounts came after tax authorities last year inspected documents at the company's office, scrutinized documents and questioned some executives in relation to the advertising and other transactions with its parent entity, the first

In its court document, which the source was privy to, ByteDance India has argued that its entire business had come to a standstill because of the bank freeze and that such an action violates its rights "to carry free trade and business".

"The company was already struggling with the India ban. This can hit employee salaries, vendor payments," the second source said.

TikTok had come under scrutiny around the world. During former U.S. president Donald Trump's administration, which alleged that the app posed national security concerns as personal data of U.S. users could be obtained by China's government, an allegation the company denied.

U.S. President Joe Biden's new administration has paused a government lawsuit that could have resulted in a de facto ban on Tik-Tok's use in the United States.

### FTSE Puts India, Saudi On **Watchlist For Inclusion In Its Bond Index Agenceis**

India's efforts to include its bonds in global bond indices could fructify soon with FTSE Russell placing Indian and Saudi Arabian government bond markets on the watchlist for possible inclusion in its FTSE Emerging Government Bond Index.

FTSE Russell's semi-annual country classification review released on Monday said the market accessibility level of Indian and Saudi Arabian bonds will be considered for reclassification to 1 from 0.

Global index users have shown interest in Indian government securities issued through the Fully Accessibility Route (FAR), FTSE said, adding that it will start a version of its FTSE Indian Government Bond Index that tracks these securities in coming weeks.

The government and the Reserve Bank of India (RBI) has included a number of bonds that would qualify for the FAR route where foreign investors can invest without any limit. The government first notified this in the Budget for FY20-21, and the central bank subsequently in April notified five securities to be eligible for the list. Together, they had an outstanding of Rs 4.2 trillion. Since then, "all new issuances of government securities of 5-year, 10-year, and 30-year tenors from the financial year 2020-21" were eligible as "specified securities" where foreign investors can take full exposure without any limit, along with resident individuals.

Technically, these securities are over and above the FPI investment

limit in the domestic market. The RBI in April raised the FPI limits for corporate bonds to 15 per cent, from 9 per cent, for 2020-21. However, the overall FPI limit in government securities remained unchanged at 6 per cent.

If the bonds get included in the global bond index, foreign investors could pour in huge amounts of money in the Indian markets considering the high yields on offer, with relatively stable political stability and a strong repayment track record.

"This is a very welcome first step. If the bonds are included in the FTSE index, other well-known indices will be inclined to include India and this would attract healthy FII participation in Indian bonds," said Jayesh Mehta, Head of Treasury at Bank of America, India.

When a sovereign bond is included in a global index, the inflow in that country increases manifold. It could mean opening up avenues for at least \$50 billion of fresh investment in the country, as some fund houses are not allowed to invest in any bonds that are not included in bond indices. Those funds can be readily tapped if the bonds are included.

The Indian government is closely engaged with IP Morgan and Bloomberg-Barclays for inclusion of Indian bonds, but the indices need a minimum guaranteed investment limit of 15-20 per cent of the outstanding stock for foreign investors, which is not the case now. However, with new bonds getting included in the specified securities list, the inclusion could be just a matter of time, experts say.

#### **Asian Countries Seek Vaccine Supplies After India Export Curbs Hit COVAX**

everal Asian countries sought alternative sources for CO-VID-19 inoculations on Tuesday after export restrictions by manufacturer India left a World Health Organization-backed global vaccine sharing programme short of supplies.

The export curb deepens the problems facing the COVAX scheme, relied on by 64 poorer countries, and adds to previous setbacks that include production glitches and a lack of funding contribution from wealthy nations.

The shortage could leave poor countries further behind in inoculations, increasing the vaccine inequity, complicating global efforts to tame the coronavirus including more infectious variants, and exposing fresh pleas for a global treaty on pandemics as rather hollow.

South Korea, Indonesia, the Philippines and Vietnam are among countries to be hit by shipment delays to vaccines they have been promised under the COVAX programme, which was created mainly to ensure supplies for poorer countries.

"Our planned increase in daily vaccinations will be affected," Carlito Galvez, Philippines' vaccination chief, told reporters.

India, the world's biggest vaccine maker, put a temporary hold on exports of AstraZeneca's vaccine being manufactured by the Serum Institute of India (SII), as officials focus on meeting rising domestic demand.

The Serum Insitute was due to deliver 90 million vaccine doses

to COVAX over March and April and, while it was not immediately clear how many would be diverted for domestic use, programme facilitators warned that shipment delays were inevitable.

In Indonesia, health ministry official Siti Nadia Tarmizi told Reuters that 10.3 million doses from CO-VAX were likely delayed until May.

South Korea confirmed it would only receive 432,000 doses of the 690,000 it had been promised and delivery of those would be delayed until around the third week of April.

"There's uncertainty over global vaccine supplies but we're working on a plan to ensure no disruptions in the second quarter and making efforts to secure more vaccines," Kim Ki-nam, head of South Korea's COVID-19 vaccination task force team. Officials said they were in talks with AstraZeneca to accelerate shipments pro-

cured through a separate deal. Philippines President Rodrigo Duterte loosened government restrictions on private sector imports of vaccines, pleading with companies to obtain supplies no matter the cost, as his country bat-

tles a resurgence of the pandemic. In Vietnam, officials have similarly asked the private sector to step in after their COVAX supplies were slashed by 40% to 811,200 doses and shipments were pushed back by weeks. India has not provided details on the length of its export curb but UNICEF, a distributing partner of COVAX, said at the weekend that deliveries are expected to resume by May.

#### NEWS MAKERS Tata tussle: 'My conscience is clear,' says Cyrus Mistry on SC verdict

yrus P Mistry, former Tata Group chairman who lost a long-drawn legal battle in Supreme Court last week, on Tuesday said though he is personally disappointed with the ruling, his "conscience is clear" as he still believes the direction that he took to take the group to was with full conviction and sans any malafide inten-

In a statement Mistry, who served as chairman of the salt-to-software conglomerate from December 27, 2012, to October 24, 2016, when he was unceremoniously sacked in a board room coup, said his conscience was clear and he sleeps with a clear conscience.

"Over the past four years, I've had the opportunity to reflect on my actions and on whether I could have handled the generational change in leadership better.

"In hindsight, while I may have had many imperfections, I have no doubt or erosion of conviction about the direction I chose, the integrity behind my actions and their consequences," he continued in the statement which did not mention his next move on

exiting his 18.37 per cent stake in the group. He said, although personally as a minority shareholder in the group, he is disappointed with the outcome of the case, he is grateful



for the opportunity to sever the Tata Group as

Thanking his team members "who all were bound together by the common value system embedded by the founders into the Tata Group," he said he will be eternally grateful for the fact that he got an opportunity to serve as the chairman of the iconic

He said his effort from day one was to ensure that the group, that was undergoing a generational change in leadership, had "a robust board-driven system of decision making and governance that is larger than any one individual... to enable directors on various boards to discharge their fiduciary duties without fear or favour, while still ensuring that shareholder views are reflected in strategy and actions." It continues to be my belief that it is by such a model, that one would protect value for all stakeholders in Tata Sons and its various group companies,

Admitting that he will no longer be able to influence the direction of governance of the group directly (having resigned from the board during the pendency of the case), I hope that the issues I have raised will cause deeper reflection and influence individuals concerned to catalyse change

On March 26, the apex court set aside the National Company Law Appellate Tribunal (NCLAT) order restoring Mistry as the Tata Group chairman ending the over fouryear long legal battle. The apex court bench led by Chief Justice Sharad Arvind Bobde, justices AS Bopanna and V Ramasubramanian, also dismissed a plea of the Shapoorji Pallonji (SP) Group seeking separation of ownership interests in Tata Sons in which they hold 18.37 per cent stake now.

The top court had, on January 10, 2020, granted interim relief to the Tata Group by staying NCLAT order of December 18, 2019, by which Mistry was restored as the chairman of the conglomerate. The SP Group had earlier valued its holding in the Tatas at Rs 1.75 lakh crore. However, during the hearing before the apex court, the Tatas had, on December 8, said the valuation of the 18.37 per cent shares of the SP Group in Tata Sons was between Rs 70,000 crore and Rs 80,000 crore.

# **TATA Stocks Raise After Supreme Court Verdict**

Tata Group stocks gained sharply, rising between 2 to 6 per cent after a favourable Supreme Court verdict in the matter of National Company Law Appellate Tribunal (NCLAT) reinstating Cyrus Mistry as chairman of Tata Group.

As the Supreme Court upheld Tata Sons' decision to remove Cyrus Mistry as the chairman of Tata Sons, shares of Tata Group companies started gaining.

Almost all listed companies shares closed in the green on NSE and BSE, the top gainers included Tata Steel (6.04 per cent),

Indian Hotel (5.29 per cent), Tata Power (4.87 per cent), Tata Communications (4.24 per cent), Tata Motors (3.8 per cent), Titan Company (3.79 per cent), Voltas (2.18 per cent), Tata Steel BSL (earlier Bhusan Steel) (4.96 per cent), Nelco(3.76 per cent).

Other gainers included Tata Investment Corporation (2.76 per cent), Tata Chemicals (1.79 per cent), Tata Consumer (2.19 per cent), and Tata Metaliks (3.26 per cent). Rallis India and Trent closed flat on profit-taking, Tata Group's flagship company Tata Consultancy Services shares also rose to a high of Rs 3118 after the news break but later saw profittaking and closed flat at Rs 3,068.15 on BSE.

section  $\overline{6}(2)(c)$  of the Passports Act.

Under this section, a passport is rejected by authorities if they feel that the applicant may engage outside India in activities prejudicial to the sovereignty and integrity of India or the departure of the applicant from India may, or is likely to, be detrimental to the security of the country.

A passport can also be rejected, under the section, if the presence of the applicant outside India may, or is likely to, prejudice the friendly relations of India with

This section can also reject an application if the central government is of the opinion that issuing a passport or a travel document to the applicant will not be in public interest

There are other reasons in this section which bars processing any application where an applicant has been convicted or is facing criminal proceedings or has a pending summon, according to the Act. But this is not attracted in the case of Nazir, whose husband Mohammed Saveed had served as Union home minister in the 1990s and later as chief minister twice of the erstwhile state of Jammu and Kashmir.

"...your application for issuance of passport is refused," said the letter issued by the passport officer to

Mehbooba, a former Jammu and Kashmir chief minister, tweeted that the passport office has rejected her mother's passport application.

"CID (Criminal Investigation Department) claims that my mother who is well into her seventies is a "threat to national security" and therefore doesn't deserve a passport. GoI (Government of India) is employing absurd methods to harass and punish me for not toeing their

Mehbooba's passport was also rejected under the same section of the Act and her petition in the Jammu and Kashmir High Court was also dismissed.

Dismissing the petition, Justice Ali Mohammad Magray had observed that Mehbooba's application for a passport was rejected by the passport officer, Srinagar, as the police verification report recommended against the issuance of the document to her.

"In such circumstances, I am of the considered view that no direction can be issued by this court for issuance of passport in favour of the petitioner," the judge said

"Even otherwise, the scope of this court in the matter of grant or otherwise of passport in favour of an individual is very limited in as much as the court, in this behalf, can only direct the concerned authorities to expeditiously consider the case of an individual in the light of the mandate of the scheme of law governing the subject," the order read.

In a letter to Mehbooba, the Regional Passport Office here had informed the PDP president on March 26 that her application for a passport was rejected on the basis of the "adverse" police verification report.

The passport officer also informed her that the CID of the Union Territory had recommended against granting a passport to her.

The letter said Mehbooba can appeal against the decision at a higher forum provided by the Ministry of External Affairs (MEA).

Commenting on the rejection of her application, the PDP president had said it shows the level of normalcy achieved in Kashmir.

"The Passport Office refused to issue my passport based on CID"s report citing it as "detrimental" to the security of India. This is the level of normalcy achieved in Kashmir since Aug 2019 that an ex-chief minister holding a passport is a threat to the sovereignty of a mighty nation," she had tweeted.

including the one used for "Lawaypora attack." "That's why RTO has issued an order making it mandatory for vehicles with outside registration to register the same within 15 days," IGP Kumar said, adding that police will plug the loopholes in the days ahead and also conduct short-refresher courses for the PSOs.

"It was also decided that a proper SOP regarding security of protected persons/vulnerable persons containing DOs/DON'Ts shall be formulated and issued shortly.'

# 'Rohit Sharma-Shikhar Dhawan Best Option For T20 World Cup,' Says Former Selector

**NEW DELHI:** India should stick to the experienced opening combination of Rohit Sharma and Shikhar Dhawan in the T20 World Cup, feels former selector Sarandeep Singh, calling the duo the "best option" despite skipper Virat Kohli's recent interest in the slot.

Sarandeep, whose term ended with India's historic win in Australia earlier this year, also gave his take on split captaincy, asserting the issue was never even discussed in his time as Kohli performed in all three formats.

After the T20 series win against England, Kohli had said he will open in the IPL raising the possibility of him opening with Rohit in the World Cup. Dhawan was dropped after the opening game of the series and Ishan Kishan was picked ahead of him in one of the games. Kohli and Rohit opened in the final T20.

"It was surprising. He (Dhawan) did well in the IPL, he did well in Australia. Whenever he plays he performs. He is mentally very strong. May be they want to try out options but in my view the left-hand righthand combination of Rohit and Dhawan is the best option for the India at

World Cup," Sarandeep told PTI. 'You can't judge him on basis one match. He did well in ODIs after that. The IPL will decide a lot of the team. There are no easy places in the team. Ishan Kishan too will need to do exceptionally well to make the team," he added.

He also said that K L Rahul should continue keeping in the ODIs and the in-form Rishabh Pant will have to wait for his turn when Shreyas Iyer returns.

The IPL beginning April 9 will decided bulk of the spots for the World Cup squad and Sarandeep feels Yuzvendra Chahal and Kuldeep Yadav, who became India's go to pair in the middle overs after the 2017 Champions Trophy, are no more sure starters in the T20 or ODI format. Kuldeep has also lost his place in the T20 squad.

The two spinners can still do the job. They are proper spinners. Once Ravindra Jadeja is back from injury,



the trio remains the best option in limited overs format," Sarandeep said.

'Kuldeep, for example, has not got a lot of opportunities and seems down on confidence. He needs to be backed. Chahal was also replaced in the recent T20s against England by Rahul Chahar and did not play the following ODIs.

"Though there is a lot of competition. Chahal and Kuldeep should play together. They have still have a lot of potential," said Sarandeep, who played three Tests and five ODIs for India.

Pant has surpassed Wriddhiman that as the number one keeper in Tests and has also become the preferred option in T20s following his stellar success in all three formats in the last four months.

"No praise will be enough for Pant. He had some fitness issues, worked on that and worked on his shot selection. If you expect a 21-year-old to play like a 30-yearold, it is tough to start with. You see Hardik (Pandya), the way he bats now with experience, same thing has been seen in Pant now in the last six months or so.

"He was out of the team which was good for him. There is a right time and right ball to hit. The way he played in Australia, it shows he has gained a lot of experience. He is picking and choosing.

"He can give you 10 years in Test cricket, Saha cannot and has become the number one choice. In

ODIs, Shreyas got injured so Rishabh played. When he is back, KL should be the wicketkeeper because he has been keeping wickets for a long time and is doing a fine job.'

Sarandeep also believes there is no place for Krunal Pandya in the ODI team if Hardik is not bowling. "If we talk about ODIs, if Hardik

is not bowling, Krunal can't be your fifth bowler. He batted beautifully but Krunal can't give you 10 overs, he is a good T20 player but when it comes to ODIs, he doesn't have the skill to challenge the batsmen.

"So if Krunal plays Hardik p to bowl. If one bowler is hit or injured there is no extra option if Hardik doesn't bowl. His workload has to be managed too but you have to play proper bowlers," said the 41-year-old former off-spinner.

On the issue of spilt captaincy, Sarandeep said the it was not even discussed in his tenure.

"Spilt captaincy is needed when your captain is not performing but he (Kohli) is the only player to average more than 50 in all formats. If he isn't performing in one format you can take the leadership pressure off him and give it to someone else.

"Just because he has not won an IPL you can't remove him from India captaincy. He is also the fittest player and captain. Rohit is there to lead the side in his absence but there is no reason to replace Virat."

## **Japan Routs Mongolia** 14-0 In World Cup **Qualifying Fixture**

#### PCB CEO Wasim Khan Seeks One Year Extension, According To Reports A reliable source said Wasim Khan

KARACHI: Pakistan Cricket Board CEO Wasim Khan has sought a oneyear extension in his contract which ends in February next year.

According to a report in the "Daily Dawn" newspaper, the PCB Board of Governors at its meeting held in Karachi earlier this month discussed and reviewed Wasim Khan's move for a one-year extension in his original three-year contract.

The report said that the BOG are in favor of giving the extension but put off any final decision or announcement, till patron-in-chief Prime Minister Imran Khan decides about PCB chairman Ehsan Mani's future whether to extend his three-year tenure ending in September this year.

According to the contract signed with Wasim, the PCB can extend his tenure by one year before the end of his first tenure which ends in February 2022.

awkward situation in the board. The report said that BOG members felt it will not look appropriate if Mani gives the extension to Wasim while the former himself cannot get extension as PCB chairman after September 2021.

"I have almost achieved the targets which I set in September 2018 and if I am asked to continue [as PCB chief], I will think about it and will then decide." Mani had said when recently asked about his future plans.

"I will have to see if I can contribute anything further or not as I don't eye the seat."

apparently wanted an extension as in 2021, 22 and 23 Pakistan has invited top teams like England, Australia and New Zealand to tour the country for a full series in the next two years and the CEO wants to be there to oversee this achievement. England has not visited Pakistan

since 2006 while Australia's last visit to Pakistan was in 1998.

Mani and Wasim, who is presently said to be visiting his family in the UK, are also awaiting an inquiry report from two top infectious disease specialists on Wednesday after the abrupt postponement of the PSL 6 on March 2 due to rising cases of Covid-19 among the franchise players and officials in Karachi. All eyes are on the PCB bigwigs

to see what action they take on the inquiry report as many believe that Pakistan cricket faced embarrassment due to the PSL 6 postponement because of the negligence of some officials in enforcing the bio-cure bubble properly.
