Machine Supremacy Crippling Kashmir's Celebrated Golden Hands

hen Shameem Magray was young he happily chose workshop over school. He along with his bunch of friends learned embroidery at his neighbor's house. Since then Magray has been working in this field and is a master of all handmade embroidery techniques.

"You tell me what you want and I will make it," says the confident artisan who has been in the field for 35 years. "It may take some time but the product will be everlasting."

But while he put in a lot of hard work in the work, he only earns about Rs. 500 per day for



his 12-hour work.

Kashmir's embroidery popularly known as Kashida embroidery is one of the most popular needleworks from the subcontinent. Be it Pashmina shawls with

exotic Sozni embroidery designs,

or the crewel embroidered curtain in Kashmiri houseboats, or the embroidered rugs or the chain stitch cushions, all these

embroideries techniques have been followed by Kashmiri people for a long time.

For summers, the base material

used for Kashida is light-colored wool or cotton cloth. It's a thickblack wool cloth for winters.

Birds, animals, trees, leaves, and many other motifs are embroidered with colorful threads and beads on the cloth by artisans. Kashmir was ruled by different regimes for centuries, whose influence can be seen on Kashmiri textiles.

During 1420-70 AD, a paper by Deborah Emmet notes, Zain-Ul-Abidin, the eighth sultan of Kashmir, brought shawl and carpet weavers to the valley from Turkestan and Samarkand respectively. It is believed that crewel and chain stitch embroidery was introduced in the valley during his reign. The world-famous Kashmiri

Pashmina shawl industry came into existence in the late sixteenth-century under the rule of Mirza Haider Dughlat, claims the paper.

"A patron of the arts of Kashmir," the paper mentions," he [Dughlat] is said to have introduced the concept of using pashm from Ladakh to be woven into shawls by the expert craftsmen of Kashmir who had previously used sheep's wool.'

Study reveals experimental hearing implant succeeds in registering brain waves

A team of researchers has succeeded for the first time in measuring brain waves directly via a cochlear implant. These brainwaves indicate in an objective way how good or bad a person's hearing is.

The research results are important for the further development of smart hearing aids. The findings of the study, led by scientists at KU Leuven (Belgium), were published in the journal Scientific Reports.

A cochlear implant enables people with severe hearing loss to hear again. An audiologist adjusts the device based on the user's input, but this is not always easy. Think of children who are born deaf or elderly people with dementia. They have more difficulty assessing and communicating how well they hear the sounds, resulting in an implant that is not optimally tuned to their situation.

A possible solution is to adjust the implant based on brain waves, which contain information about how the person processes the sounds that they hear. This kind of objective measurement can be made with an electroencephalogram (EEG), whereby electrodes are placed on the head. However, it would be more efficient if the implant itself could record the brain waves to measure hearing quality

Experimental implant

Research by KU Leuven and manufacturer Cochlear on a few human test subjects has shown for the first time that this is possible. "We used an experimental implant that works exactly the same way as a normal implant, but with easier access to the electronics," said postdoctoral researcher Ben Somers



from the Experimental Oto-rhinolaryngology unit.

"A cochlear implant contains electrodes that stimulate the auditory nerve. This is how sound signals are transmitted to the brain. In our research, we have succeeded in using these implanted electrodes to record the brain waves that arise in response to sound. That is a first. An additional advantage is that by carefully choosing the right measuring electrodes, we can measure larger brain responses than the classical EEG with electrodes on the head," added Somers.

Self-tuning device

An implant that can register brain waves and measure hearing quality on its own has various advantages, added co-author Professor Tom Francart.

"Firstly, we get an objective measurement that does not depend on the user's input. In addition, you could measure a person's hearing in everyday life and monitor it better. So, in the long run, the user would no longer have to undergo testing at the hospital. An audiologist could consult the data remotely and adjust the implant where necessary," Francart noted.

Francart further said, "In the future, it should even be possible for the hearing implant to adjust itself autonomously based on the recorded brain waves. We have a long way to go before that, but this study is a necessary first step. Based on our findings, manufacturers can now move forward with developing smart hearing devices that improve the quality of life of the people that use them.

He added, "Besides audiological applications, there are numerous other possibilities that come with measuring brain waves. Think of monitoring sleep, attention span or epilepsy, but also, for example, so-called brain-computer interfaces that allow you to control other devices with brainwayes.

UK Says 25 New Cases Of Rare Blood Clots Linked To AstraZeneca Vaccine

he U.K. reported 25 new cases of rare blood clots possibly linked to AstraZeneca Plc's Covid-19 vaccine, adding to the numbers that have caused some European countries to adopt precautionary measures.

The fresh reports lift the total number of cases to 30 as of March 24, the Medicines and Healthcare Products Regulatory Agency said in a statement Thursday. The benefits of the shot continue to outweigh the risks, the regulator said. AstraZeneca's vaccine, devel-

oped with the University of Ox-

cine when invited to do so," the MHRA said. The AstraZeneca and Pfizer vaccines have shown "very high levels of protection" against Covid-19, the agency said, adding that "all vaccines and medicines have some side effects." U.K. Program

The U.K. has one of the world's fastest-moving vaccine programs, administering shots to more than half of all adults by late March. New daily Covid cases and deaths have fallen to the lowest levels since September, even as infections surge anew across much of the European Union, where immunizations have lagged.



ford, is under mounting scrutiny and has faced dwindling support in Europe. Still, countries are counting on the shot to help them exit the pandemic, and millions of doses have been administered across the region.

The U.K. agency said that the 30 incidents were out of 18.1 million doses of AstraZeneca vaccine given by March 24. Prior to that, the agency disclosed five cases on March 18, out of 11 million shots.

With the new reports, the rate of incidents with the AstraZeneca shot in the U.K. is about 1 in 600,000. There were no reports of the same reactions to the vaccine from Pfizer Inc. and BioNTech SE, which is also being used in Britain.

"On the basis of this ongoing review, the benefits of the vaccines against Covid-19 continue to outweigh any risks and you should continue to get your vac-

Earlier this week, the EU drugs regulator said a link between the AstraZeneca vaccine and a rare type of blood clot is possible, identifying at least 62 cases of the condition. The European Medicines Agency said its safety committee will probably issue an updated recommendation next week. Germany has restricted younger people from taking the AstraZeneca vaccine amid growing concerns about side effects. That followed reports of 31 cases of the rare clots, mostly in women.

Norway and Denmark extended suspensions on the use of the shot, which has also been the subject of a tussle over supplies between the EU, the U.K., and others.

On Friday, Australia reported one case of clotting disorders following inoculation with the AstraZeneca vaccine and is investigating, according to a joint statement by government agencies.

"Regardless of location, any religious service should be held outdoors wherever possible or be

limited in size and duration, with physical distancing, ventilation, hand hygiene and mask use, as appropriate," it added.

Better would be for people to mark the festivals with those they lived with and avoid meeting others -- especially if feeling unwell or in isolation or quarantine, it said.

Experts are worried that some people may drop their guard while celebrating religious festivals, just as many countries are imposing restrictions to try to slow rising numbers of Covid-19 infections. In the coming days, Christians celebrate Easter. while Muslims begin the fasting month of Ramadan on April 13.

Saudi FM: Deal With Israel Will Be 'Extremely Helpful' For Region

normalisation deal between Saudi Arabia and Israel would benefit the region, the kingdom's foreign minister has said, adding that a potential deal "depends to a large extent on the progress of the peace process".

Saudi Arabia's Foreign Minister Faisal bin Farhan Al Saud, during an interview on Thursday, added that "the normalisation of Israel's status within the region would bring tremendous benefits to the region as a whole"

"It would be extremely helpful economically, socially and from a security perspective," he said in the interview with CNN, adding that it would be possible only if a Palestinian state within 1967 borders was delivered.

Saudi Arabia has previously made similar comments, saying it would only normalise ties with Israel within a plan that would deliver a sovereign state to Palestinians.

"What we need to make happen is a peace deal that delivers a Palestinian state with dignity and with a workable sovereignty that Palestinians can accept," Prince Faisal had said in December last year.

He added at the time that the normalisation of ties with Israel has long been part of Saudi Arabia's



vision, saying that the kingdom envisaged a move in exchange for the creation of a Palestinian state within the 1967 borderlines.

In September last year, the United Arab Emirates and Bahrain signed the so-called Abraham Accords to normalise ties with Israel. Sudan and Morocco have since followed suit. The deals were the first since Israel's recognition by Egypt in 1979 and Jordan in 1994.

Last year's agreements, brokered by former US President Donald Trump's administration, included a freeze by Israel on planned annexation of Palestinian land.

Palestinian officials condemned the normalisation as "a stab in the

back of the Palestinian cause and the Palestinian people".

A two-state solution to the Palestinian-Israeli conflict closely reflects the Arab Peace Initiative, which was proposed by Saudi Arabia in 2002. The initiative called for normalised relations between Israel and other Arab states in exchange for a full withdrawal by Israel from lands it occupied in the 1967 war, including the occupied regions: Golan Heights, East Jerusalem and the West Bank.

The initiative was re-endorsed over the years by the Arab League but never implemented, as Israel continued its occupation and settlement expansion in the West Bank.

New Zealand Increases Minimum Wage, Increases Taxes On Rich

Tew Zealand will raise its minimum wage to NZ \$20 (\$14) an hour, in order to protect the financially vulnerable and increase the top tax rate for the highest earners to 39 per cent.

The change will be effective Thursday onwards. This also includes small increases in unemployment and sickness benefits. The raise in minimum wage will benefit up to 175,000 workers. The new tax rate would be applicable to those earning more than NZ \$180,000 (approx. \$125,960) a year and will bring in an additional NZ \$550m (approx. \$384 million) in revenue this year. According to data from Organisation for Economic Co-operation and Development, New Zealand's minimum wage of NZ\$18.90 an hour was already among the five highest in the world.

sentiment was echoed by the Ministry of Business, Innovation and Employment. The ministry also suggested in cutting the minimum wage by 25 cents in order to cushion economy from the uncertainties caused by COVID-19.

In 2020, labour unions had called for an increase to the living wage, \$22.10, for those on the front lines.

Prime Minister, Jacinda Ardern, told The Guardian they fulfilled a pre-election promise and represent "real and long-overdue improvements to the support we provide our most vulnerable".

"There is still much more to do, including building more homes, improving our health system, investing in education, training and job opportunities," Ardern said.

"Sharply increasing the minimum wage during a period of extreme uncertainty for small businesses is economic vandalism," workplace relations spokesman of the opposition National Party, Scott Simpson said.

Myanmar Protesters Urge 'Guerrilla Strikes' As Internet Blackout Widens

yanmar activists held protests candle-lit overnight and scrambled to find workarounds for a new internet shutdown on Friday, as opponents to the military's bloody crackdown on dissent vowed no letup in efforts to unseat the ruling generals.

Anti-coup groups shared radio frequencies, offline internet resources and providers of text message news alerts to try to circumvent new curbs on the internet, which now limit Web access to fixed-line services only.

The military did not announce or explain its order to telecom firms to cut wireless broadband, which adds to a ban on mobile data through which a nationwide movement has mobilised on social media and spread images of the junta's lethal suppression of mostly youth-led protests.

Nearly 50 Injured As Devotees Clash With Police At Pakistan Shrine Closed Due To COVID-19

KARACHI: Overnight clashes between devotees and law enforcement personnel at a shrine closed due to coronavirus restrictions left nearly 50 people, including policemen, injured in Pakistan's Sindh province, prompting authorities to deploy paramilitary troops on Friday morning.

The incident at the Lal Shahbaz Qalandar in Sehwan on Thursday night took place after the provincial Policemen on duty tried to push

the devotees which led to clashes in which some 40 devotees and seven policemen were injured and taken to hospital.

"Many of the devotees had come from outside of Sindh and were staying in and around Sehwan and were perhaps not aware of the government orders when they started gathering at the shrine," Jamshoro Deputy Commissioner, Capt (retd) Fareeduddin Mustafa said.



government announced the closure of all shrines to curb the spread of the coronavirus pandemic.

The clashes took place after hundreds of devotees, who had gathered in Sehwan for the annual Urs. defied government orders and tried to enter the shrine.

An official at the shrine said that the devotees had gathered at the shrine for the 769th Urs (death anniversary) of Lal Shahbaz Qalander,

Mustafa said the paramilitary rangers were deputed at the Lal Shahbaz Qalander shrine on Friday after the clashes. In 2017, a suicide bomb attack inside the shrine had killed 90 people and left around 300 injured after which the government has upped security measures at the shrine.

Kyoto's Earliest Cherry Blooms In 1,200 Years Point To Climate Change

The famous pink cherry blossoms of Kyoto reached full bloom this year on March 26, the earliest date in the 12 centuries since records began, according to a Japanese university.

The earlier flowering indicates climate change, said Yasuyuki Aono, a professor of environmental science at Osaka Prefectural University, who has compiled a database of records

of the full blooms over the centuries. Global temperatures in 2020 were among the highest on record and rivaled 2016 as the hottest year ever, according to international data com-



piled by the World Meteorological Organization and released in January

"As the temperatures rise the onset of flowering is earlier," Aono told Reuters in a Zoom interview.

Osaka University records include court documents from Imperial Kyoto, the ancient capital of Japan, as well as medieval diaries. Cherry blossoms have long historical and cultural roots in Japan, heralding spring and inspiring artists and poets through the centuries.

In modern times, people gather under the cherry blooms every spring for hanami (blossom-viewing) parties that are often well lubricated with sake and can last for days.

With a state of emergency to curb coronavirus infections lifted across all areas of the country many people flocked to popular viewing locations last weekend, although the numbers were lower than in normal years.

Kyoto, no longer the Japanese capital but a beacon of Japanese culture and manners, has long been famous for its temples and blossoms. which been a valuable tool for observing long-term changes in mean

Scientists have often pointed to the earlier flowering times of species such as cherry blossoms as indicators of global warming. The Kyoto record is described in one study as "probably the longest annual record" of biological life cycles from anywhere in the world.

UK's Richest Woman Gets \$648 Million Pay From Betting Empire

The 53-year-old founder and chief executive officer of Bet365 Group Ltd. pocketed 468.9 million pounds (\$648 million) in pay and dividends, almost 50% more than a year earlier, according to

a filing from the online bookmaker. Her salary of 421.2 million pounds from the closely held British firm makes her one of the world's best-paid bosses. It also strengthens her status as the UK's richest woman, adding to a fortune already among the world's 500 largest, according to the Bloomberg Billionaires Index. Coates has

earned more than \$1.5 billion over the past decade, according to data compiled by Bloomberg.

Founded about two decades ago, Bet365's business has benefited from the growing popularity of online sports betting. The Stoke-on-Trent. England-based company posted revenue of 2.8 billion pounds for the financial year ended March 29, 2020, an 8% drop from a year earlier as the Covid-19 pandemic curbed sports wagering. Operating profit fell by more than half to 194.7 million pounds, partly due to Coates's salary increasing from 276.6 million pounds. A representative for Coates didn't immediately respond to a request for comment.

After graduating from Sheffield University with a degree in econometrics, Coates trained to become an accountant and took over a small chain of betting shops her father owned on the side. She became managing director of the business at age 22, according to a Staffordshire University release, and expanded the number of shops before deciding to shift the business online. Along with Bet365, Coates and her family also own Stoke City Football Club. Coates is the only woman among 17 U.K. billionaires on Bloomberg's wealth index, which includes Virgin Group founder Richard Branson and Joe Lewis, owner of Tottenham Hotspur Football Club.

Owner Moves Court As Cops Reject Vehicle Papers In Digital Mode

SRINAGAR: A private vehicle owner in Srinagar moved to court after police allegedly refused to accept his vehicle documents through government-recognised mparivahaan, mobile application.

The Union Transport ministry in December 2019 had asked States to facilitate acceptance of driving license and other documents like vehicle registration certificates in electronic format by enforcement agencies.

"Vehicle owners can also show their documents like driving license, RCs and insurance certificates through mobile apps like Digilocker and mParivahan app," the Road Transport and Highways Ministry had said.

However, as soon as Showkat Ahmad, a resident of HMT Srinagar was stopped by the police for vehicle and document checking near Parimpora area of Srinagar, he said that he provided the documents to the authorities in a digital format through mparivahaan, a designated mobile application.

Ahmad said that the officials present on the checking point refused to accept his documents through the application and claimed that they will not accept the documents through the mobile application.

He said after refusing to accept



the document, his vehicle was seized by the concerned police station and provided him a court challan.

Soon after the incident took place, the commuter moved to the court to challenge the action against him.

"I have filed my case in the court now to see how and why my vehicle was seized despite following the government procedure," he said, adding that he has every document of his vehicle and also a driving license, but it is unfortunate that his vehicle has been seized despite carrying the documents.

Meanwhile, Station House Officer (SHO) Parimpora, Parvaiz Ahmad said that the polcie did not refuse to accept the documents through the government designated mobile application, but the fact is when someone is violating the law and has no hard copy of documents available, the vehicle has to be seized.

"If someone is carrying a hard copy of documents with him/her and has violated the traffic norm like not wearing a seatbelt and using mobile phones while driving, we can provide him/her a challan on that particular document. But, when a commuter is carrying a mobile application with him, there is no other option else than seizing the vehicle," he said—(KNO)

Poor Representation of women in J & K Elections

This percentage of elected women in parliaments has been steadily rising over the years, globally as well as in India. Unfortunately, for Jammu and Kashmir, it has decreased over the years. The highest number of women its assembly ever saw was in 1972 when 4 women were elected to the state assembly of 75 members

ince 1967, the erstwhile state of Jammu and Kashmir has sent a total of 82 MPs to Lok Sabha. Women have been represented only five times. Akbar Jahan Begam of J&K National Conference (JKNC) first represented the Srinagar constituency in 1977 and then Anantnag constituency in 1984. Parvati Devi of the Indian National Congress (INC) represented Ladakh in 1977 while Mehbooba Mufti of J&K Peoples Democratic Party (JKPDP) represented Anantnag constituency first in 2004 and then in 2014. In the Jammu region, no constituency has ever been represented by a woman in Lok Sabha. As far as J&K State Legislative Assembly is concerned, there have been a total of 822 members since 1962 and women have been represented only 15 times. In the last three state assembly elections held in 2002, 2008 and 2014, there have been two, three and two women MLAs respectively out of a total of 87 for each assembly. This data paints a dismal picture of women representation in the elected bodies of the erstwhile state of Jammu and Kashmir. Almost half of the population of the state is not represented properly in elected bodies.

Looking at the distribution of tickets by main parties in Jammu and Kashmir, it appears that they give very few tickets to women candidates as a token gesture. The total number of women that have contested Lok Sabha polls since 1967 from the state is 36. More than half, 19, were independents. Major parties like JKNC, JKPDP, INC and BJP, have given a total of 1-3 tickets to women in all these years. In State Assembly elections, a total of 173 women have contested elections since 1962 of all the 5850 candidates. 59 women were independents. No major party has given more than twenty tickets to women.

In 2008 elections alone, 67 women



contested of whom 21 were independent. Three women won in 2008, two from JKNC and one from JKPDP. Only two women from JKNC had contested the election and they both won while JKPDP had fielded 9 women candidates. Meanwhile, all but two women candidates who have ever contested the assembly elections independently lost their deposits. Further, half of the total of JKNC's (7) and JKPDP's (5) women candidates have lost their deposits. For JKPDP, all the women who lost deposits are from the Jammu region and none from Kashmir. In the 2008 elections, JKPDP fielded a total of 9 women candidates of whom all the 5 candidates who contested in the Jammu region lost their deposits. In 2014, JKNC fielded 6 women candidates in total, two from Kashmir and four from Jammu. Just like PDP in 2008, all its women candidates who contested in the Jammu region lost their deposits.

According to Inter-Parliamentary Union, the average percentage of women in national parliaments

across the globe for the month of January 2021 was 25.5%. For Asia, this figure stood at 20.4%. As far as India is concerned, there are currently 78 elected women MPS in Lok Sabha out of the total of 540 (14.4%) and Rajya Sabha has 27 women members out of the total of 241 (11.2%). This percentage of elected women in parliaments has been steadily rising over the vears, globally as well as in India, Unfortunately, for Jammu and Kashmir, it has decreased over the years. The highest number of women its assembly ever saw was in 1972 when 4 women were elected to the state assembly of 75 members. A total of 6 women had contested the elections- two independents and four from INC. All the four INC women candidates had won.

Participation of women in policy-making decisions in parliaments and state assemblies is necessary because it gives women the opportunity to be heard. This also improves the quality of decision making by bringing different perspectives to the table

on the basis of different gendered experiences. Further, several studies prove women tend to legislate differently than men because they focus on and care about different issues than those of their male counterparts. Such issues often include health care, social welfare and services, gender discrimination, and women, family, environment, and children's issues.

For political institutions to be democratically legitimate and responsive, their composition must mirror the diversity in their societies. They must be inclusive of the plurality of the groups that exist in their populations. Since women make up half of the population, their gendered experiences and voices should not remain unheard and unrepresented in the decision making. It is still unknown as to when the elections will be held to the legislative assembly of Jammu and Kashmir Union Territory but whenever the elections are held, parties and the general population should make sure that women get proportional representation in the assembly. As a state, we flirted with all-male assemblies and had enough experience with men's law-making process. It is now time to change for the better and give women's experience a chance to be represented in elected bodies. Given the complicated nature of politics in J&K, there are several other representations that go beyond elections and legislative bodies. However, this article is limited to the representation of women in elections and elected bodies that have a state sanction.

The Biden administration's new proposal does very little to dispel these notions.

Afghanistan has come a long way since the Bonn conference in 2001. The Afghan civil society has flourished significantly in the last 20 years, and showed that it has the potential to craft a better future for the country if it is provided with the right tools and opportunities. Despite endless statements to the contrary, however, the Afghan people have never been given the opportunity to fully take control of their future.

The US and regional powers have long been claiming that only an "Afghan-led and Afghan-owned" process can be successful in bringing sustainable peace and stability to Afghanistan. However, these claims appear to be little more than lip service - over the years, all external players who have a stake in Afghanistan have tried to impose their own version of peace on the country, driven by their agendas and priorities, without considering the

will of the Afghan people. The new proposal signals that under the Biden administration's leadership, external actors will continue to try and impose their

will on the people of Afghanistan. Another problem with the new US proposal is its apparent insistence on putting the burden of achieving peace solely on the Afghan government. Peace talks can succeed only if all involved parties act in good faith, and demonstrate their commitment to peace not only with their words but also their actions on the ground. However, target killings, bomb blasts and violence continued unabated since the beginning of the Afghan peace process. The Taliban did not stop using violence as a tool to maintain

and expand its influence over the country. The Taliban is unwilling to turn the page on violence because it is the group's defining feature. Despite this, the new US proposal, like others before it, expects the Afghan government to assume responsibility for the stalling of peace talks, and make concessions to an inherently violent group that continues to kill innocent Afghan civilians on a daily basis.

Another fundamental issue with the new US proposal is that it fails to address the complicated relationship Afghanistan's neighbours, chiefly its eastern neighbour Pakistan, have with the Taliban.

Over the years, Pakistan has carried out several military operations against armed groups, including the Taliban in the former Federally Administered Tribal Areas (FATA). The region, which has been

merged with the province of Khyber Pakhtunkhwa in 2018, has long been used as a base by the Taliban, the Haqqani network and other local and international armed groups, including al-Qaeda.

While the state of Pakistan claims that it has been successful in its military operations, the region remains volatile as groups allied with the Taliban continue to

not only exist and operate in these areas within Pakistan, but also carry out operations like before across the border in Afghanistan.

Pakistan's preference to turn a blind eye to, and at times tacitly support, certain actions of the Taliban in an effort to expand its influence in Afghanistan and the wider region is a very well-established and

documented fact, commonly referred to as Pakistan's "strategic depth policy". Pakistan's military has said that it has shifted its policy on Afghanistan, and is no longer following the "strategic depth policy", but there has not been much indication of this on the ground. The Quetta Shura, the Haggani network, and other important forums of the Taliban continue to be based in Pakistan. Despite all this, the international community, including the US, continues to give Pakistan a significant role to play in Afghanistan.

This has come at a cost mostly for the Pashtuns who live in Pakistan, especially for the Pashtuns of the former FATA region who have suffered greatly due to the actions of the Taliban and the Pakistani government over the decades. They have witnessed violence, similar to the levels experienced by Afghans, at the hands of the Taliban. Many members of Pakistan's security forces have also fallen victim to armed groups affiliated with the Taliban that are active in the former FATA region. The state of Pakistan, which is supposed to protect its citizens, however, has looked the other way, accepting the loss of innocent lives in the thousands as necessary collateral damage.

It would be essential for any proposed framework for peace in Afghanistan to address the significant issue of dismantling the vast infrastructure and bases of the Taliban in Pakistan. As long as the Taliban continues to be used by Afghanistan's neighbours and some of the regional powers to further their own interests, sustainable peace will be difficult to achieve. The will of the people of Afghanistan and the sovereignty of the state will not only need to be taken into account but will need to be respected for any hopes of embarking on a meaningful struggle for peace – for Afghanistan as well as the region.

Want To Reduce Your COVID-19 Risk? Get Some More Sleep.

A new study found every extra hour of sleep at night was associated with 12% lower odds of a coronavirus infection.

An analysis of sleep studies found sleep problems affected approximately 40% of people in the pandemic — and those who caught COVID-19 appeared to have a higher prevalence of sleep problems.

If there's one thing that's become clear as the pandemic has stretched on, it's that there's a lot to be explored in the relationship between COVID-19 and poor sleep.

We already knew the two were linked. An analysis of sleep studies found sleep problems affected approximately 40% of people in the pandemic – and those who caught COVID-19 appeared to have a higher prevalence of sleep problems.

Now, a study suggests if you had sleep problems prior to getting coronavirus, or suffered daily burnout, you have a heightened risk of not only becoming infected with the virus, but also having more severe disease.

Every one-hour increase in the amount of time spent asleep at night was associated with 12% lower odds of becoming infected with COVID-19, according to the study published in the online journal BMJ Nutrition Prevention & Health.

What happened in the study?

Disrupted sleep and work burnout have historically been linked to a heightened risk of viral and bacterial infections, which is why researchers wanted to explore whether there was a link between COVID-19 and sleep issues, as well as stress.

For the study, researchers drew on responses to an online survey for healthcare workers repeatedly exposed to patients with COVID-19 infection. The survey ran from July to September 2020, and was open to workers in France, Germany, Italy, Spain, the UK and the United States. Some 2,884 healthcare workers responded, 568 of whom caught the virus.

Personal details that were shared included: lifestyle, health, use of prescription medication and dietary supplements, plus information on how much sleep they got at night and



in naps over the preceding year; any sleep problems; burnout from work; and workplace exposure to coronavi-

Infection severity was defined as:very mild - no or hardly any symptoms;

- mild fever with or without cough, requiring no treatment:
- moderate fever, respiratory symptoms and/or pneumonia;
- severe breathing difficulties and low oxygen saturation;
- critical respiratory failure requiring mechanical assistance and intensive care.

What did researchers find?

On average, respondents were getting between six and seven hours sleep a night. Around one in four of those who'd tested positive for CO-VID-19 reported difficulties sleeping at night compared with around one in five of those without the infection.

One in 20 (5%) of those with CO-VID-19 said they had three or more sleep problems, including difficulties falling asleep, staying asleep, or needing to use sleeping pills on three or more nights of the week, compared with 3% of those without the infection.

Compared with those who had no sleep problems, those with three sleep issues had 88% greater odds of COVID-19 infection. Every extra hour of sleep at night was associated with 12% lower odds of COVID-19 infection.

Workers with daily burnout were around three times as likely to say that their COVID infection was severe and that they needed a longer recovery period.

The study was observational so can't establish a cause – and there were a few limitations to it, including that assessment of exposure levels, sleep issues, and infection severity, were all subjective (so might've been misremembered) and the sample only included cases of very mild to moder-

ately severe COVID-19.

Why might lack of sleep be linked to

It's not clear why insomnia and burnout are linked to increased CO-VID severity, however researchers hypothesized that lack of sleep and sleep disorders may adversely influence the immune system by increasing pro-inflammatory cytokines and histamines, which could in turn increase disease severity.

They also pointed to studies linking burnout to a heightened risk of colds and flu as well as long term conditions, such as diabetes, cardiovascular disease, musculoskeletal disease and death from all causes. Such studies have suggested that burnout may directly or indirectly predict illnesses by occupational stress impairing the immune system and changing cortisol levels.

Minha Rajput-Ray, medical director of NNEdPro Global Centre for Nutrition & Health, which co-owns the journal Nutrition Prevention & Health with BMJ, said: "This study spotlights an often neglected area of wellbeing: the need for quality sleep and re-charge time to prevent burnout and its consequences.

"A better understanding of the effects of shift work and sleep is essential for the well-being of healthcare staff and other key workers.

"Disruptions to the sleep-wake cycle can affect metabolic, immune and even psychological health. And sleep deprivation can make calorie dense foods, higher in fat, sugar and salt, more appealing, particularly during times of stress and/or difficult shift patterns, all of which takes a toll on overall health and well-being."

How do we know the COVID vaccine won't have long-term side-effects?

s Australia's COVID-19 vaccine rollout begins this week, many people still have questions about the safety of COVID-19 vaccines, both in the short and long term.

As vaccine experts, we hear these concerns all the time, and it's normal to have questions about a vaccine.

The good news is that scientists have already been testing COVID-19 vaccines for months. For starters, serious side-effects are very, very rare. And, together with what we know about previous vaccines, if side-effects are going to occur, they usually happen within a few months after getting a vaccine. This is why international medical regulators, including Australia's Therapeutic Goods Administration (TGA), require the first few months of safety data before approving new vaccines. This, plus information coming from vaccine recipients in the northern hemisphere, gives us confidence that COVID-19 vaccines are safe.

In fact, most side-effects occur within the first one or two days. And most of these are minor, such as pain at the injection site, fatigue or fever — which are signs your immune system is building a response against the thing you've been vaccinated against.

What do we know about long-term side effects?

Since December, more than 200 million people have received at least one dose of a COVID-19 vaccine worldwide — more than the total number of people who have been infected with the virus (112 million).

Given the sheer number of vaccines administered to date, common, uncommon and rare side-effects would have been detected by now. What's more, we've been testing these vaccines in clinical trials since mid-2020, and both the Pfizer and AstraZeneca vaccines have shown excellent safety results.

This gives us confidence the vaccines that'll be used around Australia are safe.

We've also seen some people raise concerns online about mRNA vaccines, such as the Pfizer-BioN-Tech vaccine, being a "new" technology. mRNA (or "messenger" RNA) is found in all living cells. mRNA is a message that tells cells how to make proteins that trigger the immune response inside the body. That immune response is what protects against infection if an individual is exposed to the virus. mRNA is not the same as DNA (your genes), and it cannot combine with our DNA to change our genetic code. mRNA vaccines do not affect or interact with DNA in any way. So we can be assured there'll be no long-term DNA altering effects from these vaccines.

What's more, checking the safety of the vaccines doesn't just stop after they've been registered for use. Once a vaccine has been introduced, ongoing monitoring of its safety is a crucial part of the vaccine de-

velopment process.

Australia has a robust system for this ongoing

monitoring. The system was established to detect any unexpected side-effects from vaccines (if they occur) and ensure they're investigated promptly. This type of monitoring is standard practise in Australia for vaccines. The data about COVID-19 vaccination collected in these surveillance systems will be published weekly on the TGA website. This should reassure Australians that if there's a new serious side-effect, we will know about it, communicate it, and act on it quickly.

Withdrawal of vaccines after introduction to the general population is a very rare event. In the United States, a rotavirus vaccine called Rotashield led to a small increase in the number of small intestinal blockages. This prompted its withdrawal in the late 1990s. In Australia, an increased risk of febrile seizures in young children following a specific influenza vaccine was identified in 2010. It was subsequently withdrawn from use in that age group, and we now vaccinate with a different, safer flu vaccine. This vaccine is no longer available in Australia, and has been subsequently reformulated.

Both of these side-effects were observed within weeks of vaccination.

We now have improved monitoring systems in Australia to detect such serious side-effects even sooner, in the general population after clinical trials, than we did a decade ago.

But what about short-term side-effects? Pfizer-BioNTech COVID-19 vaccine

The expected side-effects of the Pfizer vaccine have been reported from trials involving roughly 43,000 participants aged 16 years and older from the US, Argentina, Brazil and South Africa. Half of the participants received the Pfizer vaccine and half received a placebo. And as part of COVID-19 vaccine rollouts around the world, millions of people have already been given this vaccine since December, meaning we have safety data now from both clinical trials and two months of "real world" vaccination.

For those receiving this vaccine in the large clinical trials which started in July 2020, about 80% have reported pain at the injection site. Other common side-effects included fatigue, headache, muscle pain, chills, joint pain and fever.

These were most often reported one or two days after the day of vaccination, and typically only lasted about one day. While some vaccine recipients may need a day off work due to some of these side-effects, this does not indicate the vaccine is unsafe.

In trials, no difference was seen in the rate of severe side-effects between the Pfizer vaccine and placebo. Early in the US program, 21 cases of anaphylaxis were reported. It's estimated anaphylaxis occurs at a rate of 11 in every one million recipients (0.0011%) of the Pfizer COVID-19 vaccine. Most occurred within 15 minutes, and all patients recovered. This is why it's a good idea though to remain at the vaccine clinic for up to 15 minutes after vaccination so that treatment and care can be provided if necessary.

A further concern was raised in January, after the death of 30 very frail elderly patients in Norway after receiving the Pfizer-BioNTech COVID-19 vaccine. But investigation by the European regulator concluded these weren't related to the vaccine, but rather to underlying conditions present before vaccinetion.

Oxford-AstraZeneca COVID-19 vaccine

This vaccine has been tested in ongoing trials with around 55,000 participants from the United Kingdom, Brazil, South Africa and the US. About half received the Oxford-AstraZeneca vaccine and half a placebo. Millions of doses have been already been administered among the general population, particularly in the UK.

Data from four clinical trials which commenced in April 2020 in the UK, Brazil and South Africa, show the most common side-effects were pain at the injection site, fatigue, headache and muscle pain. Similar to the Pfizer vaccine, there was no difference in the rate of reported severe side-effects for the vaccine compared with the placebo.

Just 0.7% of participants (79 people) from the four clinical trials who received the Oxford-AstraZeneca vaccine reported a serious side-effect after receiving at least one dose, compared with 0.8% (89 people) of those in the placebo group. No additional safety concerns have been identified since the vaccination program began in the UK.

If recommended a COVID-19 vaccine, take it

Climate change cut global farming productivity 21% since 1960s

espite important agricultural advancements to feed the world in the last 60 years, a new study shows that global farming productivity is 21 per cent lower than it could have been without climate change

According to the researchers, this is equivalent to losing about seven years of farm productivity increases since the 1960s.

The future potential impacts of climate change on glob-

al crop production has been quantified in many scientific reports, but the historic influence of anthropogenic climate change on the agricultural sector had yet to be modelled.

"We find that climate change has basically wiped out about seven years of improvements in agricultural productivity over the past 60 years," said researcher Ariel Ortiz-Bobea from Cornell University.

"It is equivalent to pressing the pause button on productivity growth back in 2013 and ex-

periencing no improvements since then. Anthropogenic climate change is already slowing us down." Ortiz-Bobea added.

For the study, published in the journal Nature Climate Change, the team developed an all-encompassing econometric model linking year-toyear changes in weather and productivity measures with output from the latest climate models over six decades.

The researcher said they considered more than 200 systematic variations of the econometric model, and the results remained largely consistent.

"When we zoom into different parts of the world, we find that the historical impacts of climate change have been larger in areas already warmer, including parts of Africa, Latin America and Asia," he said.

Humans have already al tered the climate system, the researcher said, as climate science indicates the globe is about 1 degree Celsius warmer than without atmospheric greenhouse gases.

Signal is fastest growing app as WhatsApp privacy policy inches closer



mid the brouhaha over new and controversial WhatsApp privacy policy Lat is set to come into force from May 15, privacy-focused messaging app Signal became the fastest-growing app globally, including in India, both in downloads and monthly active users (MAUs) in the first quarter last year, according to a new report.

Another encrypted messaging app Telegram was at the third spot in downloads and number two in MAUs, according to data provided by app analytics firm App Annie.

Signal is gaining immense popularity owing to its simplicity and focus on privacy.

People are switching to Signal in record numbers because companies who sell ads have a harder time focusing on the things that users actually want.



The upcoming WhatsApp privacy policy has actually helped Signal and Telegram grow their user base. Facing a backlash in February, WhatsApp deferred its new data privacy policy by three months that is reported to be sharing users' data with Facebook (which the company

has denied).

According to App Annie, the top apps by downloads, consumer spend and MAU across Apple App Store and Google Play were TikTok, You-Tube and Facebook in the January-March quarter.

Homegrown app MX Takatak, a local alternative to TikTok, was also seen as the fastest growing app by downloads in the quarter.

TikTok led the top downloads chart, followed by Facebook and In-

Today, from Edward Snowden to the Black Lives Matter Foundation to Melania Trump, all use Signal. Activists use Signal to coordinate protests, finance professionals to exchange sensitive information, journalists to communicate with sources, etc.

Telegram recently claimed it gained 100 million new users who weren't happy with WhatsApp's upcoming privacy changes in May.

Government Withdraws Cut In Rate On Small Savings Schemes

NEW DELHI: In a relief to savers, Finance Minister Nirmala Sitharaman on Thursday said the government will withdraw orders to cut interest rate on small savings schemes and assured to restore the rates to last quarter of the financial year ending on March 31.

In a jolt to savers, the Finance Ministry on Wednesday had reduced interest rate by up to 1.1 per cent across various small savings schemes, including the National Savings Certificates (NSC) and Public Provident Fund (PPF).

"Interest rates of small savings schemes of GoI shall continue to be at the rates which existed in the last quarter of 2020-2021, ie, rates that prevailed as of March 2021. Orders issued by oversight shall be withdrawn," Sitharaman said in a early morning tweet.

Interest rate on Public Provident Fund (PPF) was reduced by 0.7 per cent to 6.4 per cent, while National Savings Certificate (NSC) was to earn 0.9 per cent less at 5.9 per cent.

The steepest fall of 1.1 per cent was effected in the one-year term deposit. The new rate was brought down to 4.4 per cent as compared to 5.5 per cent. Interest rates for small savings schemes are notified on a quarterly basis.

India Holds World Record For Fastest Road Construction: Nitin Gadkari

LUCKNOW: With the construction of a 2.5 km 4-lane concrete road and a 1-lane 25-km bitumen Solapur-Bijapur road within 24 hours, India has made three world records, said Union minister for road transport and highways Nitin Gadkari on Friday.

"We made three world records this month. India now holds the world record for the fastest road construction. We made it to the Guinness World Records by building a 2.5 km 4-lane concrete road within 24 hours and a 1-lane 25-km bitumen Solapur-Bijapur road within 24 hours," Gadkari said while inaugurating the Tedhi Pulia flyover and laying the foundation stone for the Khuram Nagar flyover in Lucknow.

He further said that the politics of the 21st century is that of progress and the government will build infrastructure worth Rs 111 lakh crore in the next five years.

"21st-century politics is that of progress. Prime Minister Narendra Modi has resolved to make an 'Atmanirbhar Bharat'. He gave us a mission to make self-reliant India have a \$5 trillion economy. We have to build an infrastructure of Rs 111 Lakh crores in 5 yrs and I have the responsibility of the road sector." he said.

Earlier on Thursday, the ministry of road, transport and highways (MoRTH) in a statement



informed that the construction of National Highways had touched a record 37 kilometres per day in the year 2020-21.

"The ministry has achieved the record-breaking milestone of constructing 37 kilometres highways per day in the year 2020-21, which is unprecedented," it said.

It further said that over the last seven years, the length of National Highways has gone up by 50 per cent from 91,287 km as of April 2014 to 1,37,625 km as on March 20, 2021.

"This would not have been possible without the dedication and teamwork of the officials and other stakeholders. These achievements are unprecedented and have no parallel in any other country in the world," Gadkari had said

India Asks State Refiners To Review Oil Import Contracts With Saudi Arabia

NEW DELHI: Amid tensions with Saudi Arabia over oil production cuts, India has asked its state refiners to review contracts they enter into for buying crude oil from the Middle East nation and negotiate more favourable terms, a top official said.

Keen to break producers cartel dictating pricing and contractual terms, the government has told Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) to look for oil supplies from outside the Middle East region and use collective bargaining power to get favourable terms.

India imports 85 per cent of its oil needs and is often vulnerable to global supply and price shocks.

When oil prices started to rise in February, it wanted Saudi Arabia to relax output controls but the Kindgom ignored its calls.

This has led to the Indian government now pressing for diversification of the supply base.

"Traditionally, Saudi Arabia and other OPEC producers have been our mainstay suppliers of crude oil. But their terms have often been

loaded against the buyer," the of-

ficial with direct knowledge of the discussions said. For one, Indian firms buy twothird of their purchases on term or

third of their purchases on term or fixed annual contracts. These term contracts provide assured supplies of the contracted quan-

tity but the pricing and other terms favour only the supplier, he said. "While buyers have an obligation to lift all of the contracted quantity, Saudi and other producers have the option to reduce supplies in case

artificially lower to boost prices.
Why should the consumer have to pay for decisions of OPEC? If we commit to offtake, they should also supply no matter what," he said.

More importantly, the buyer has

OPEC decides to keep production

to indicate at least six weeks in advance of their intention to lift quantity out of the annual term contract in any month and has to pay an average official price announced by the producer.

"In an ideal market, the pricing should be of the day when the loading is taking place. That way we can get the advantage of any drop in international oil rates. But that is not the case. They (Saudi and other OPEC sup-

pliers) insist on selling at their official selling price only," the official said. To begin with, Indian refiners

will look to reduce the quantity they buy through term contracts and instead buy more from the spot or current market. Buying from the spot market

would ensure that India can take advantage of any fall in prices on any day and book quantities.

"It's like stock market, You would

want to buy shares on a day or time when the prices are low. So is the case with crude oil - we would want to buy when we see there is a drop. Term contracts devoid us of that flexibility," he said.

Indian refiners have raised spot purchases from 20 per cent a decade back to 30-35 per cent of the total oil bought now.

"We want pricing flexibility as well as the certainty of supply even during times when production falls due to any reason," the official said adding state-owned refineries have been asked to coordinate buying and also explore joint strategy with private refiners such as Reliance Industries and Nayara Energy.

India will buy oil when it gets favourable term, he said.

"Choice of time of supply, flexibility on quantity (ability to reduce or increase) and surety of supplies is what we are looking at." Oil producers cartel OPEC output cut to boost oil prices has been at the heart of recent tensions between India and Saudi Arabia.

Saudi and its allies ignored India's call to increase supply last month, prompting Indian state refiners to discuss the possibility of taking less oil in May.

Purchase contracts with Saudi permit refiners to vary volumes by month but the overall annual commitment must be honoured.

India, the world's third-largest consumer of oil, hopes to use the might of its market to change the terms of en-

gagement with big suppliers.

The Middle East accounts for 60 per cent of all oil bought by India while Latin America and Africa are the other big supplier blocks.

In recent months, India has bought more oil from the US and from newer sources such as Guyana, which has a large Indian diaspora.

Due to its geographical proximity, the Middle East can, however, supply cargoes in less time and at low freight rates.

GST Collection Rises To All-Time High Of Rs1.23 Lakh Cr In March

NEW DELHI: GST collection remained above the Rs 1 lakh croremark for the sixth month in a row in March, rising 27% annually to record Rs 1.23 lakh crore, the Finance Ministry said on Thursday.

The ministry said the steep increasing trend in goods and services tax is a clear indication of rapid economic recovery post pandemic.

Closer monitoring against fakebilling, deep data analytics using data from multiple sources including GST, income tax and customs IT systems and effective tax administration have also contributed to the steady increase in tax revenue over past few months, it added.

The gross GST revenue collected in March stood at Rs 1,23,902 crore. Of this, central GST was Rs 22,973 crore, state GST Rs 29,329 crore, integrated GST Rs 62,842 crore and cess Rs 8,757 crore (including Rs 935 crore collected on import of goods). — PTI

6 Out Of 10 People May Lose Jobs To Machines By 2025: Report

Geneva: At least 6 out of 10 people worldwide are likely to lose their jobs by 2025 as humans and machines are probably to spend equal amounts of time at work, reveals a new report published by the World Economic Forum (WEF).

The report was based on a survey of 32,000 workers conducted by the consulting giant PwC across 19 countries, Xinhua reported.

While nearly 40 per cent of workers globally think they would lose their jobs in five years, 56 per cent feel that fewer people would obtain long-term employment in the future, the survey showed.

More than 60 per cent demanded that governments must work to protect their jobs.

The survey also showed that 40 per cent of workers used the Covid-induced lockdown in 2020 to hone their digital skills, while 77 per cent were ready to learn new skills or to retrain.

Further, 80 per cent were confident in their ability to adapt to new technologies.

According to a previous WEF report, the growing reliance on machines and artificial intelligence have increased the risk of loss of 85 million jobs. At the same time, they are also likely to generate 97 million new jobs in such a scenario.

Former RBI Deputy Governor KC Chakrabarty Passes Away

MUMBAI: Former Reserve Bank of India (RBI) Deputy Governor Kamalesh Chandra Chakrabarty passed away in Mumbai last Friday morning following a heart attack.

Chakrabarty, 68 years old, was the Deputy Governor of the central bank between June 15, 2009 and April 25, 2014. He left office three months before his tenure ended. He also served as the Chairman and Managing Director of Punjab National Bank (2007-2009) and CMD of Indian Bank (2005-2007).

Chakrabarty was candid in his views on various issues related to the banking sector and often dif-

fered from the official stance of the central bank. He was highly critical of the unethical practices and poor risk management systems in Indian banks. He was in the RBI during the governorship of D Subbarao and Raghuram Rajan.

He was noted for his contributions to advancing financial inclusion and financial literacy during his time at the central bank.

He served as the Chairman and Managing Director of Punjab National Bank (2007-2009) and CMD of Indian Bank (2005-2007). He started his career as a banker with the Bank of Baroda where his last assignment was to head the UK operations of the bank between 2001 and 2004.

SBI Internet Banking, YONO App Shut For Maintenance

NEW DELHI: Customers of the country's largest bank, State Bank of India (SBI), were facing issues with online transactions on Thursday.

With more users taking to social media to report the issues with logging into the bank's flagship mobile app YONO and some unable to transact using the Unified Payments Interface (UPI), the lender has issued a notice on Twitter.

"We are undertaking maintenance activities between 2:10 p.m. and 5:40 p.m. on 1st April 2021 to provide a better digital banking experience. During this period, Internet banking, Yono lite, Yono and UPI will be unavailable. We regret the inconvenience caused and request you to bear with us," SBI said on Twitter.

However, it did not account for the outage

faced in the first half of the day.

According to Down Detector, a website

that tracks internet outage, said user reports related to issues with the SBI platform spiked at around 11 a.m. There were over 200 reports at around 12:21 p.m.

This is, however, not the first time that the customers of the bank have faced service outage. In December last year, SBI's digital banking platform 'YONO' witnessed a technical glitch. Users took to social media platforms to complain about not being able to open the app/login.

Taking note of the repeated glitches by both public and private banks, Reserve Bank Governor Shaktikanta Das had in the past said that there is an urgent need to banks and financial institutions to invest more in their IT system.

The regulator has temporarily barred HDFC Bank from launching new digital banking initiatives after taking a serious view of service outages since 2018.

"Police pursued a lead and arrested an OGW (over ground worker) Ishfaq Ahmed, who provided names of two more persons. We arrested both of them as well. "That is why the operation got delayed. We took the hostages out and then the encounter started in which three militants were killed. All district magistrates / District Disaster Management Authorities' chairmen in J&K shall take a call on the continuation of academic activities i.e. physical classes or online classes in their respective jurisdictions, keeping in view the safety of students and present trend of Covid-19 pandemic in different districts, a government order said on Friday.

The order, issued by Deputy Secretary Umesh Sharma of the School Education Department, said the chief education officer and other authorities would assist district magistrates in taking such decisions.

The order referred to the earlier government orders and guidelines on Covid-19 containment measures and said it has been observed that the surge of

the pandemic has wide variation among districts.

Fast Track Vaccination

the Cabinet Secretary, Rajiv Gauba with the Chief Secretaries of the states and Union Territories in which they were directed to strictly implement test. trace, treat strategy, Covid appropriate behaviour and vaccination to address the challenging situation of sharp rise in the number of cases, an official spokesperson said.

According to the official spokesperson, the Chief Secretary informed in the meeting that the government of Jammu and Kashmir would be carrying out a fast-track vaccination drive to cover all persons in the eligible age groups in four districts including Jammu, Srinagar, Budgam and Baramulla showing maximum number of Covid cases.

He further said that Subrahmanyam added that through concerted efforts the Government is consistently monitoring the Covid trajectory among its local population with a special focus on districts with an increased tourist footfall.

While reviewing the situation, the Cabinet Secretary, as per the official spokesperson said that the country over the past few weeks has witnessed a

sharp rise in cases. "There has been almost a ten-fold increase in the number of new cases reported in February earlier this year and now," Gauba said.

"Considering the deterioration in the COVID scenario, the Cabinet Secretary emphasised that it is time once again a comprehensive approach of the Governments in the States/UTs is adopted to meet the challenge. Attributing the sudden rise in cases to complacency in the community as a result of slight improvement in the numbers ending 2020, the Cabinet Secretary informed that certain states have already crossed their previously reported peaks in the number of cases," he added.

The official spokesperson said that the Cabinet Secretary reiterated that vaccination alone is no panacea to the problem but needs strictly to go hand-inhand with testing, tracing, containment and enforcement of COVID appropriate behaviour.

"a clear message needs to go from top level to the entire state machinery that all weapons in the armoury are required to be utilized along with vaccination to deal with the problem," Gauba said, as per the official spokesperson.

He further said that the Cabinet Secretary urged the States/UTs to ensure a multi-sectoral response in addition to swift vaccination drives to cover maximum population of the target age groups to prevent subsequent waves of infection especially in the wake of emergence of mutant strains of the virus.

"He advised the States/UTs to ardently promote COVID appropriate behaviour, improve the rate of testing especially in districts that are falling short of target quotas, increase the share of RTPCR tests viza-viz RATs, adopt refocused & stringent containment strategies and undertake priority vaccination with provisions of geographically targeted vaccination in clusters witnessing a surge in COVID cases," he added. He further said that in a brief presentation dur-

ing the meeting the Health Secretary informed that there has been a sharp growth in the daily reported cases and the average daily deaths across the country since June last year, it was told that 11 states including Maharashtra, Gujarat, Delhi, Punjab, Chhattisgarh etc., are contributing maximum number of cases and deaths due to COVID-19 in the country.

"Besides, testing, contact tracing, and containment the presentation also focused on strengthening of public private healthcare resources including isolation beds, oxygen beds, adequate oxygen supply and strengthening of ambulance services. It also

underlined ensuring of COVID appropriate behaviour through legal and administrative provisions. Saturation vaccination of priority age groups in districts reporting surge with a help of time-bound plan

was also highlighted," the official spokesperson said. He said that the States/Union territories were advised to have the district action plans prepared and also to review hospital wise case fatality rate and then to devise a plan to address the issue.

"During the meeting I&B Secretary also gave out a communication strategy to mitigate laxity in observance of COVID-19 precautions, false sense of confidence, vaccine hesitancy and communication fatigue. Various states including Maharashtra, Punjab, Karnataka, Chhattisgarh etc, also gave a brief on assessment of the situation in their respective states during the meeting," he added.

Farooq, the former three-time Chief Minister of J&K, has challenged the action of the Authorities under the PML Act, among others on the issue of juris-diction, the applicability of PML Act to the erstwhile State as also on grounds of illegality and procedural irregularities.

The 83-year-old parliamentarian has said his ancestral and family properties in J&K have been illegally attached by ED despite the fact that it had "no iurisdiction to do the same.'

Sidharth Luthra, Senior Counsel, representing Farooq Abdullah referred to various provisions of the PMLA and submitted that Farooq can only be proceeded under the PMLA in connection with the scheduled offence as per the Schedule-A of the Act.

"The offences under Sections 406 and 409 of RPC are not the scheduled offences and merely for an offence under Section 120-B RPC, the petitioner (Farooq) is not liable to be proceeded with under the

Moreover, he said, the Schedule enlists the offence of criminal conspiracy under Section 120-B Indian Penal Code as one of the scheduled offences and does not refer to any offence under RPA muchless under Section 120-B RPC. "The order of provisional attachment does not contain any reason to believe nor does the properties inherited by him or received in gift from his ancestors or any property which has been privately acquired by him are liable to attachment as they are not "proceeds of the crime".'

The order of provisional attachment, he said, greatly undervalues the properties attached so as to attach almost all the properties of Farooq. "Therefore, the entire proceedings are without jurisdiction and are malafide.

Solicitor General in defence submitted that the PMPLA has been enacted by the Parliament in view of the political declaration adopted by the Special Session of the United Nations General Assembly calling upon the member states to adopt national money laundering legislation. "India being the member State accordingly enacted the aforesaid Act extending it to the whole of India," he said, adding, "Thus, it cannot be said that the aforesaid enactment is beyond the legislative competence of the Parliament."

manufacturing of Kashmir textiles with different embroidery techniques. When he joined the business, he started exporting the textiles.

"The integrity of handmade products is very different," admits Naqash who only works in handmade embroidery. He claims that they try to create products that are better than machine-made products and stand out in the market.

Sozni embroidery is considered to be done by the most skilled embroiderers in the valley. Earlier it was a man-dominated field but with time many women have also joined the workforce.

This embroidery technique employs a needle in which identical motifs are created on both sides of the fabric. Sometimes different colors are used for the same motif on the two sides. Two or three artisans work on one shawl and it takes any time between one month and a year to complete depending upon the design.

Since the fiber used to weave Pashmina shawls are made of a fine variant of the animal hair fiber, only

fine Sozni embroidery is suitable for them. The artisans make a stencil of the design on the cloth using "engraved wooden blocks dipped in a watery solution of charcoal powder mixed with a type of binder".

Woodworkers called 'Naquash Gurs' engrave the wood blocks with fine details. Many Sozni artisans are dependent on these blocks because of its fineness and long-lasting impressions.

Once the pattern and colors are decided, each fabric is given to a craftsman because each handwork is distinct. Mostly used motifs are abstract geometric designs, multi-colored flowers, and paisley patterns.

Batin Iqbal, who runs Batin Textiles and Handicrafts, has been working on Aari embroidery techniques for a long time. In this embroidery, a thread of varying thickness

and fineness is used and stitched with the help of a hook called Aari, explains Iqbal. The thread used for the embroidery is selected according to the Aari and fineness of the stitches. Each

craftsman makes his hook with a steel needle that is attached to a wood handle. The hook is always under the fabric on which embroidery is done. It moves along the design pattern. The stitch is done from one point. And to create an emboss effect on the fabric the stitch rotates around

the point. Crewel designs are larger than other embroideries and the most common patterns are flowers, birds, and paisley. Each flower is given a name by the crafts-

The crewel work is done mainly on drapes, cushion covers, bedspreads, shopping bags, upholsteries, and handwoven Dasooti (double twist) cloth by the hook

Two types of crochet hooks - smaller hook and larger hook are used for this embroidery. For fine quality crewel and chain stitch work, smaller hooks are used whereas for quick work, larger hooks are Emmet mentions in her paper that although the

currently many women have started working in chain stitch and crewel embroidery as men prefer to get jobs that pay them higher. "Very few embroiderers are now prepared to do

crewel embroidery field was dominated by men but

the very fine hook work. It takes a long time to complete limited meterage," notes the paper. But at the same time, says Iqbal, the supremacy of machines is also discouraging many artisans to

"Although most of the Aari work is now carried out by machines," he says, "the finish and quality is better in handmade products. But, the entrepreneur says, as the demand for pro-

duction increased, manual and computerized machines have been employed by manufacturers. "In computerized machines," Iqbal says, "one-man can-do work of 20 men."

Owing to the condition in the valley and the evolution of machine-made embroidery, many artisans working in this field are suffering a lot. When Ajaz Tramboo was 22 years old, he wanted to find a job but his father insisted that he should join

their old family business of embroidery work. As a

fresh graduate. Tramboo found the work quite interesting and started expanding the business. "We had many showrooms in Kashmir and outside the valley," says Tramboo. But with machine-made embroidery coming to the market, the handmade embroidery business started facing a crisis, laments

the 50-year-old businessman. Tramboo admits that he also started machine-

made embroidery work but he was not satisfied. "I thought I was going away from the rich Kashmiri culture in which my father has spent so much time," he says. "So I decided to stick to hand-made

embroidery." He says apart from the machine-based embroidery, the turmoil in the valley has affected the business badly. At times, he says, he's not able to send materials to his customers on time due to which they are not satisfied with his service and shows a lack of

"We had three stores in Srinagar but as the conditions in the valley deteriorated our stores were shut down," Tramboo says.

According to Aaditya Kitroo, co-founder of los&fine, when machine-made products came in the market, the hand-made products started showing a In the machine, he explains, the Aari needle fires

at a very high speed so the fabric has to be moved

quickly and the end-product does not have clean lines unlike in handmade embroidery. Kitroo recalls a conversation he had with some elder artisans who told him that in the 1990s, each day three trucks full of fabric used to go from Srinagar to Anantnag for embroidery and 1000 people used to

work on these fabrics. "If I compare the condition of handmade embroidery products in the early 90s," Kitroo says, "it is less than 20% of what it was at that time.'

Though many artisans are continuing the legacy which their forefathers have started but they are quite uncertain about the future of the legacy.

Naqash feels that after 30 years Kashmir may lose hand-made embroidery technique. He thinks that the new generation of Kashmir has less respect for the embroidery business and they are not interested in carrying it forward. He hopes that with time Kashmiris may realize that they had "something special" which should be treasured.

Unquestionably problems exist for handmade embroidery artisans in the valley but the upcoming younger generation is also working to revive the cul-

Many young people are seen wearing designer pherans with intricate embroideries and they take pride in wearing the traditional local dress. Young ntrepreneurs like Iqra Ahmad are working on the

traditional tilla embroidery technique. Gold and silver tilla threads are used for this kind of embroidery. It is a traditional Kashmiri craft used in pherans, salwar kameez, and other garments. Chinar, lotus, almond are some of the common motifs designed by tilla embroiderers.

No matter what is the financial condition of the family, each bride is supposed to have a tilla pheran or a tilla shawl in her wardrobe.

According to historians, tilla embroidery originated from a remote village of Zari in Iran and it entered Kashmir when Muslim saint-reformer Mir Sayeed Ali Hamadani came to Kashmir along with his associates, the majority of whom were craftsmen. The reformer is being credited for empowering Kashmiris through skill development and created what many call the tribe of "golden hands" in the valley.

Despite many people preferring machine-made embroidery over handmade embroidery, Kitroo believes that due to coronavirus the market has shifted towards conscious consumption and people are lookng at handmade products a bit more.

However, people may not buy products like pashmina which are costly but economical handmade products like cushion covers, handmade rugs, and bedsheets will be on their list.

'There Should Be No **International Matches During** IPL,' Says Kevin Pieterson

NEW DELHI: The cricket Boards should realise that IPL is the "the biggest show in town" and no international game should be scheduled during the course of the T20 event, former England captain Kevin Pietersen opined on Friday.

Some of the English players are reportedly in a dilemma about their participation in the Indian Premier League (IPL) as their two-Test home series against New Zealand starts on June 2, a day after the conclusion of the upcoming IPL.

If the teams they represent reach the business end of the T20 league, they either have to miss the

finale or skip the national duty. Director of the England and Wales Cricket Board, Ashley Giles has already said that the ECB will not force the English players to prefer national duty over IPL.

"Cricket boards need to realise that the @IPL is the biggest show in town. DO NOT schedule ANY international games whilst it's on. V v v simple!," Pietersen tweeted.

This year, 14 England cricketers, including white-ball skipper Eoin Morgan, Jos Buttler, Stokes, Johnny Bairstow, Moeen Ali, Sam Curran, Tom Curran, Sam Billings, Liam Livingstone and Dawid Malan are contracted to play

'Like Players, **Umpires Too Have** Form,' Says Nitin Menon

NEW DELHI: Nitin Menon, who showed remarkable accuracy in his debut series as an ICC 'Elite Panel' umpire, feels pressure situations bring the best out of him and like cricketers, he too wants to make most of this purple patch.

The 37-year-old from Indore was inducted into the ICC elite panel of umpires in the middle of the CO-VID-19 pandemic in June last year but had to wait till this February for his first major assignment.

With the pandemic forcing the ICC to appoint local umpires in a bilateral series, Menon officiated in all four Tests between India and England besides three of the five T20s and three ODIs. By the end of it, he was showered with accolades for his stellar performance.

Speaking to PTI, Menon, who is now quarantining in Chennai ahead of the IPL looked back at his gruelling assignment with fondness.

"The last two months have been great. It gives one great satisfaction when people notice and appreciate your good work. This series was always going to be a very challenging one because of the hype associated with it - a place in the World Test Championship final at stake, both teams coming back from impressive overseas wins, challenging pitches to officiate on.

"As for the white-ball series, it was between the two top-ranked teams in the world. Taking all these factors into consideration, I am pleased that we did well as an umpiring team." said only third Indian in the ICC elite panel after S Venkataraghavan and S Ravi.

As world's two top teams fought it out in the middle, Menon was an epitome of calmness. Out of the 40 referrals taken against his decisions during the series, only five were upheld. More importantly, only two decisions were overturned out of 35 referrals taken against his lbw decisions.

The DRS, especially the umpire's call, once again was a big talking point through out the series.

In a normal scenario, Menon won't get to officiate in back to back games over two months. So. how did he cope up with high pressure scenarios match after match?

"I believe umpiring is all about mental toughness. More the pressure better is the focus. If we can give our best performances when we are under pressure, that is the true reflec-

tion of how strong we are mentally. "It's not new for me to officiate in back-to-back matches, thanks to the amount of domestic cricket organised in India. On an average, we

do eight four-day first-class games on the trot in Ranji Trophy, with travel in between from one venue

"Even in the IPL, we do around 14-16 games without a break, so all this experience has really helped me in this series. Like players, umpires also have form. I always feel that when in good form, I should do the maximum number of games without any break," said Menon, who played two List A games for Madhya Pradesh and comes from a family of umpires.

With his consistent performances, Menon has got closer than ever to his dream assignment -- the Ashes -- but for that to happen, the CO-VID related restrictions have to ease.

When at home, Menon likes to watch the game on television and while he is in the middle of the action, he makes a conscious effort to enjoy it even in the tensest of situations.

"I enjoy it thoroughly (in the middle). If I don't enjoy my job as an umpire, then it will reflect on my performance. Enjoying the game is another way of releasing the pressure. We have the best seat in the house to watch the game.

"And whenever I find time, I make it a point to watch international cricket as it helps me professionally. I have particularly enjoyed watching the Ashes since the time I used to play cricket," said the softspoken official.

After two months of non-stop umpiring, Menon got only a couple of days at home before he left for Chennai ahead of the IPL, pretty much from one bio-bubble to another.

The bio-secure life has been tough on the players and Menon finds it equally challenging for the match officials.

"It is very challenging. It is tougher on off days because we cannot go out of the hotel. This is where having a good team atmosphere becomes crucial. We are like a family in the bubble. We have to look after each other, make sure our colleagues are in the right frame of mind, help them out, meet as often as possible and

the dreaded infection on March 27 and was in home isolation ever since. The batting great, who was part of India's historic World Cup win in 2011, also wished his teammates on

the 10th anniversary of the victory. "Wishing all Indians & my teammates on the 10th anniversary of



our World Cup win," he tweeted. Besides Tendulkar, former India allrounder Irfan Pathan, his elder brother Yusuf and S Badrinath — all of whom had recently participated at the Road Safety World Series Challenge — have so far announced that they have tested positive for COVID-19.

Tendulkar had led the Indian team to victory in the veteran's tournament in Raipur where crowds were allowed inside the stadiums.

Ollie Pope Reveals Virat Kohli's Spinning Tracks Warning During First Test

LONDON: England batsman Ollie Pope has revealed that India captain Virat Kohli had walked up to him during the opening Test of the four-match series and warned "this is the last of the flat wickets" his team would see on the tour.

Starting the series on a rousing note in February, England succumbed to the spin duo of Ravichandran Ashwin and Axar Patel to suffer heavy defeats in the next three Tests.

"In the second innings the pitch started spinning quite a lot," Pope said during Surrey's preseason media day at the Oval, according to ESPNcricinfo.

"I remember standing at the non-striker's end and Kohli came up to me and said 'this is the last of the flat wickets'. At that point I knew it was probably going to be quite a challenging rest of the series from a batting point of view."

Having opted to bat first in the series opener, England put up a mammoth first-innings total of 578 owing to skipper Joe Root's 228. Playing in his first Test since dislocating his left shoulder last August, Pope chipped in with 34 from 89 balls.

England won the match by 227 runs, giving little indication of the struggles that awaited them in the next three Tests.

Seasoned campaigners like Root and star all-rounder Ben Stokes felt it was one of the toughest conditions to play in, according to Pope.

"Chatting to the more experienced guys like Joe Root and Ben Stokes, those guys were pretty much saying exactly the same: these are the toughest conditions they've played in," Pope said.

"If those guys are saying it as well you know how challenging it is.

"I'm not saying (India) felt they had to produce those wickets, but the fact they've gone away from their flat wickets for three days, then spin on day four and five, which is generally the theme out there, it was quite a compliment to us in how we went about our business and a compliment to our bowlers.

"That shot us in the foot a little bit but it's a good compliment to us as a team because they obviously felt they had to change their gameplan."

Back for the pre-season training with Surrey for next week's County Championship opener against Gloucestershire at Bristol, Pope said he is relieved to be out of the bubble lifestyle.

"The Indian bubble was a pretty tough one," he said.

"They were quite business-like hotels so there's not a massive amount going on, there's no real outdoor space to get used to, have a run-around or kick a ball around or anything normal.

"So being back and strolling to go and get a coffee or anything like that, it's just that bit of normality that I think humans need, really.

"It does have its challenges and everyone deals with them in slightly different ways but it is very nice to be out of those bubbles and let free a little bit."

Injured Shreyas Iyer Set To Undergo Surgery On April 8

Stimac says he doesn't like the

word experiment, a term that has been often associated with him. He has handed out debuts to 10 players in their friendly against Oman, which took place four days before the UAE game.

"Experimenting is when you play players in positions they have never played or when you switch to a game system that you did not practice in training. Personally, I don't like the word experimentation and it doesn't fit with what we do.

"We didn't bring a single player to Dubai who didn't deserve it with his performances in the Hero Indian Super League. However, due to illness, injury or poor form we could not count on Rahul Bheke, Seriton Fernandes, Ashish Rai, Brandon Fernandes, Abdul Sahal, Udanta Singh and Sunil Chhetri.

"We gave everyone a chance to play in their natural positions -- in the same game system but against far stronger opponents than those they have in the Hero ISL. This was our only chance to see the new boys and work with them before the decisive qualifiers," he said.

The former player added, "We came to Dubai with just one goal, to get an answer to the question of how much the new guys can provide against two tough opponents and whether we will get a few new names for the remaining qualifying

matches due in June." To improve, he said the team will have to take the "difficult" and "painful" route instead of playing against easy opponents. He also believes that the side has got better results under him than his predecessor.

"In the previous 2018 WCQ India finished last in the group with seven defeats, one victory, with a total of three points and GD of -13 (minus 13). The Blue Tigers had suffered five losses in the first five games.

"Now, after five games played, with many new players in the team, we have three points and a very solid goal difference, and are on course to qualify for the AFC Asian Cup China 2023." Stimac said. "Not to forget that we held Qatar

India's Digital IDs For Land Could Exclude Poor, **Indigenous Communities**

Plans by the Indian government to assign digital identification numbers to plots of land could exclude rural and indigenous people who do not hold titles, and further marginalize those without internet access, experts said.

The 14-digit Unique Land Parcel Identification Number (UL-PIN) was launched in 10 states earlier this year and will be rolled out across the country by March 2022, authorities at the Department of Land Resources told parliament this week.

The ULPIN will be based on the latitude and longitude of each parcel of land and will rely on surveys and cadastral maps, authorities said. Individual plot

lawmakers digitalizing land records was "a game changer in reducing corruption" as well as land disputes, saying it empowered ordinary people by allowing them to access information online.

About 70% of land in developing nations is undocumented, leaving more than a quarter of the world's population vulnerable to disputes, evictions and encroachment, according to the Washington-based land rights non-profit Cadasta Foundation.

While documenting land data can lead to greater efficiency in land administration and increased prosperity, authorities may not be consulting communities, failing to secure data, or using it to evict vulnerable people, human rights groups say.

Officials have billed the program as a way to tackle corruption and land disputes, but critics warned of many potential pitfalls - from outdated land registry records to flaws in the Aadhaar database.

"It may further complicate existing tensions in creating and maintaining land records and gets particularly exclusionary when land is being used seasonally by pastoral communities or common use for forest produce or fishing," she added.

The land ID scheme is part of a push to digitalize India's land records that began in 2008 and was scheduled to be completed by the end of March this year. It will now be extended to 2024,

authorities said. Land department officials told

surveyed their land in more than a century, and experts have questioned the logic of digitalising existing records and raised concerns over data access and privacy as records are made accessible online.

Pranab Choudhury, convener at the Centre for Land Governance think-tank, said the digital ID scheme was potentially beneficial but could become ineffective "and even highly contested" if it was based on outdated records.

"Many plots have been subdivided since the last survey, yet remain as one plot in cadastral maps. Subdivisions are often not recorded to avoid transaction cost, so ULPIN should be implemented only after a complete resurvey," he said.

In addition, women, Dalits and indigenous people who are often prevented from owning land risk being shut out, he added.

"Implementing ULPIN hurriedly, without addressing legacy issues can seriously undermine citizen trust and may lead to more disputes. The poor and other disadvantaged groups may be further alienated and excluded,"

Bengal Registers Over 86 Pc Polling In Phase-2 Of Assembly Elections

KOLKATA: West Bengal has recorded a voter turnout of 86.11 per cent in the second phase of polling held in 30 assembly constituencies spread across four districts, Chief Electoral Officer Aariz Aftab said on Friday

After the second phase of polling was over on Thursday, the CEO"s office had said that 80.43 per cent of 75.94 lakh voters exercised their franchise. An updated figure was released on Friday.

The Nandigram constituency, where Chief Minister Mamata Banerjee has been locked in a fight with protege- turned-adversary Suvendu Adhikari of the BJP, polled 88.01 per cent votes,

the CEO said. Among the four districts, the highest voter turnout of 87.42 per cent was registered in Purba Medinipur, followed by Bankura (86.98 per cent), South 24 Parganas (86.74 per cent), and Paschim Medinipur (83.84 per cent). constituencies, Among

Bankura district"s Kotulpur recorded the highest polling percentage of 90 per cent, while the lowest voter turnout of 72.68 per cent was registered in Kharagpur Sadar in Paschim Medinipur district, Aftab said. Apart from a few sporadic incidents of violence, the polling was more and less peaceful in the second phase, Aftab had said on Thursday.

The state registered 84.63 per cent polling in the first phase on March 27.

The third phase of the election will be held in West Bengal on April 6. The state will see five more phases and the last one will be conducted on April 29. Votes will be counted on May 2. PTI

In Brazil, An Electric Flying Car By Embraer Hints At The Future Of Air-Taxi Transport

What will tomorrow's skies look like?

The dreams of the future were flying over the skies of Sao Paulo state in Brazil this March as Brazilian aerospace giant Embraer-a company that claims that about every 10 seconds one of its aircraft takes off somewhere in the world-showed off its working prototype of the air taxi of the future, a vertical take-off drone-like passenger flying car you can call to you with an Uber-like app.

Uber set up the specs for what the world saw take to the skies of Brazil just last month: An all-electric vehicle with cruising speed of 150-200 miles per hour, a cruising altitude of 1,000–2,000 feet, and able to make trips of up to 60 miles on a single charge.

The working prototype took to air at Embraer's headquarters in Gavião Peixoto, São Paulo, last week. The vertical take-off and landing (eVTOL) vehicle looks like an oversized drone, with 10 propellers-8 horizontal and 2 vertical-and is designed to transport passengers in what will eventually be a totally autonomous flight, said the company. Though the prototype was smaller and remote-controlled, it provided a visual of where we are headed and what the future looks like.



The vehicle's vertical take-off also means vertical travel, which means the futuristic vehicles will move along vertical towers, reaching skyports near the functional living and working spaces that give

the footprint of the building its population density. The long road to prepare it for market includes

obtaining eVTOL certification and approval of the urban air traffic management being developednavigable corridors, the technology to separate aircraft to prevent collisions while organizing and expediting the flow of traffic with data flowing to the automated vehicles.

Our existing methods of transports have reached their limits and humanity needs to find ways to get people to their destination exactly when they need to be there, travelling faster, at a lower cost, and at greater fuel efficiency with less environmental impact, that was the premise that began the long road to this day in personal aerial transport technology.

The project as a whole is part of Eve Urban Air Mobility Solutions, EmbraerX's first spin-off, which aims to develop and shape the urban mobility ecosystem. EmbraerX has been part of the Uber Elevate Network since its inception in 2016.

Since 2018 Uber has had an exclusive Space Agreement with NASA to focus on traffic management technologies and the impacts of urban air mobility. It selected India, Brazil, Australia, Japan, and France as the first countries to receive tests of the new aerial shared transport system it is developing.

Transportation models will be completely transformed in these countries, predicted Uber Elevate head Eric Allison then, touting the expected vertical takeoff and landing features of the vehicle just unveiled in Brazil.

"We see enormous potential in the use of drones,

creating a truly multimodal transportation future,' he predicted. Skyports are also being developed for Uber Air in partnership with property companies.

Uber Elevate aims to create aerial urban sharing worldwide. Embraer is its aerospace partner. Eve's aim is "to create a new frontier in transportation with intelligent, environmentally friendly, autonomousready aircraft and the associated ubiquitous support and urban air traffic management solutions," according to Embraer CEP Francisco Gomes Neto.

The city of Rio de Janeiro and the State of São Paulo, where Embraer's main global operational headquarters is located, are two of Uber's largest hubs in the world and also, coincidentally, places with large helicopter fleets that provide validation for the air travel concept, and the need for its services. Are these flying cars a realistic solution?

The unveiling in Brazil is a clear sign that thoughts of flying cars are no longer the stuff of dreams. There is a palpable reality in the works, though the functional prototype is still a remotecontrolled, small-scale version with no capacity to carry passengers. But that is the next step, a completely autonomous air taxi.
